# Chitotela's sympathisers threaten to petrol-bomb *News Diggers* offices

Sympathisers of corruption-accused Infrastructure Development Minister Ronald Chitotela have threatened to petrol-bomb News Diggers offices in Lusaka if the newspaper continues to write negative stories about him.

And News Diggers Editor-In-Chief Joseph Mwenda has reported the matter

to Lusaka Central Police where an inquiry file has been opened.

Mwenda explained that since the newspaper published the "Corruption Trail" exposé involving Chitotela on February 7, 2019, some anonymous callers have been warning him to stop 'scandalising' the minister or face serious consequences. *To page 3*

# Retired Sesheke officers did not beat PF cadres - Mweetwa

By Thomas Mulenga UPND deputy spokesperson Cornelius Mweetwa says it was mobile unit junior police officers who beat up PF cadres after they were provoked, not the senior cops who were fired. Speaking when he featured on Diamond TV's Costa programme, Monday, Mweetwa said PF cadres taunted police in Sesheke and they were armed with pistols. "I can tell you that it's a very shameful route to take and I think they are behaving like kids! This is a bad way to accommodate a loss, but I understand them, they pumped in lot of money in that election than in any byelection. They took more iron sheets, more mealie meal, more chitienges and T-shirts and they had more vehicles than they have had in any by-election. And so for them, their huge expenditure would have [been] justified [by] their win, but I sympathise with them, they are bad losers! You don't behave the way

they have behaved. Yes, police were heavy-handed, but the particular incident they are complaining about was not one where you can accuse the police of heavy-handedness where their own cadres were found with pangas and pistols. What made police officers to react was that the cadres started taunting police officers, firing pistols in the air! Waving the pangas and accusing the commanding officer, Shapa Wakunguma, that he was working with the UPND, 'twalaipaya lelo' (We shall kill them today)," Mweetwa said. "How can you have cadres threatening police officers? And the people who actually beat the hell out of them were not even those officers who have been illogically retired. The people who dealt with PF cadres were the mobile officers who were camped right behind the police station. The officers said, 'we are not those senior officers who may be looking for promotions, we are here for work, stop

insulting us!' It is the junior officers who said 'let's teach these people a lesson!" Mweetwa said police officers were in order to beat up PF cadres because they were armed and threatening. "I don't think the police had abused their powers, even if the police had done that to UPND cadres who they could have been found with pangas and pistols, I would not say that they did something beyond reasonable force. If the cadres are armed with pangas and pistols, what do you want the police to do other than using the force they used? They actually managed to get those pangas and those guns. I am a very sad person to note that the police who acted in that manner to restore order; you see a Republican President and ministers, retiring such officers," Mweetwa said. And Mweetwa charged that President Lungu's Special Advisor for Politics Kaizer Zulu led a team of PF cadres and ordered police to charge at the UPND team where they allegedly live ammunition. fired "There were only two or three incidents where PF and UPND cadres clashed! One was when UPND cadres were trying to put their flags along the street lights of Sesheke and PF cadres came to attack them with their misguided view that the UPND were removing their flags. This caused a riot because police came and started firing teargas. The second was in a ward called Maondo Ward, the entrance from Mwandi, where the UPND were having a very peaceful rally and the PF, driving a (Toyota) Land Cruiser came and indiscriminately started throwing stones and two very old women above the ages of 70 were badly injured. Those were the two notable incidences of the UPND-PF clashes; the rest were police versus the residents of Sesheke; Police versus PF. A particular incident of police versus UPND was

on a Friday when President Lungu landed in Sesheke and was having a meeting in a place called Katimamulilo Ward, 40Km from where HH and the UPND were having small meetings because the police and us, we entered into an agreement that since President Lungu is in Sesheke, we shall not allow you to enter Sesheke because it's small until President Lungu is done with his activities," Mweetwa said. "We obliged and held back out of Sesheke, but what surprised us was that whilst we were having a small meeting at our camp, police and PF cadres came to attack us, police officers were armed with guns, while PF cadres were armed with guns and pangas! The police had been there for a while ensuring that we don't proceed into Sesheke, but under the leadership of Kaizer Zulu and other PF cadres, they came and instructed police to charge at us failure to which those who were leaders of that police team were going to be fired or retired. That's how police charged at us and in the process they beat up people to an extent

that we had to evacuate them around 02:00 hours." Mweetwa said as a trained former senior police officer, he could confirm that police fired live ammunition despite Police Inspector of Police Kakoma Kanganja refuting the claim. "I wouldn't want to engage in a dispute with IG Kanganja. Personally, I was a senior, superior police officer, that's the advantage I have in understanding these issues. There is a difference, which we trained police officers know, even trained military personnel know. When a gun firing blank bullets is compared to a gun which is firing live bullets, there is a difference. There is a thump steam that comes out of a live ammunition. But I can tell you that the situation was so chaotic and for the IG to come out the way he came out, I sympathise with him, I don't even think he has an iota of understanding what actually transpired! But we do have all the video evidence. The police and PF cadres attack were on us, a lot of people were injured and we scampered in all directions," said Mweetwa.

# Chitotela's sympathisers threaten to petrol-bomb News Diggers offices

By Sipilisiwe Ncube Sympathisers of corruptionaccused Infrastructure Development Minister Ronald Chitotela have threatened to petrol-bomb News Diggers offices in Lusaka if the newspaper continues to write negative stories about him. And News Diggers Editor-In-Chief Joseph Mwenda has reported the matter to Lusaka Central Police where an inquiry file has been opened.

Mwenda explained that since the newspaper published "Corruption Trail" the exposé involving Chitotela on February 7, 2019, some anonymous callers have been warning him to stop 'scandalising' the minister or face serious consequences. "The minister's case is in court now, and we have been guided by the Honourable Magistrate in handling the case to let the prosecution take its course without any prejudice, so we cannot

repeat to the public what we published in that exposé. But what happened is that, after that exposé was published, we got some anonymous individuals, whom we believe are the minister's sympathisers, warning that we must stop scandalising Honourable Chitotela. I couldn't make any follow ups on those threats because the individual was using an unknown number. We did not understand why we would be getting such

threats because as far as we are concerned, the story on Honourable Chitotela was like any other story that we publish every day - factual!" Mwenda said. "We have nothing against him, he is a man that we talk to and he has called us before when he felt we wrote an editorial comment that was harsh on him, and we justified our position to him without any fight at all. After that "Corruption Trail" exposé, he has not called us

to complain and neither has

he written us a demand letter

claiming defamation. To our

surprise, these threats have

continued every time we

publish editorial comments

on corrupt government

officials. On Tuesday, I got

a call from a well known

PF member who, out of

good will, alerted us that

some PF youths had been

funded to petrol-bomb our

offices. He went on to give

us the names of the youths

who were mobilising others

for this operation. Within

an hour of that alert, I got

another call from a police

officer, who again out of good will, advised us to

clear valuables from our

offices because he had very

reliable intelligence that

our operating premises had

been targeted. Obviously,

this officer could not help

us any further than alerting

us for fear of victimisation."

Mwenda said he surrendered the names of the suspected

PF youths to the police. "The police informant

directed us to report the

matter to Central Police,

which we did yesterday

(Tuesday) and we have

given those names to the investigators. The police did

not take the matter casually,

they opened an inquiry file

and we are very confident

that, even if they fail to act,

they will get the facts. Now,

By Thomas Mulenga The Copperbelt University Lecturers and Allied Worker's Unions say Minister of Higher Education Professor Nkandu Luo's decision to abolishment meal allowances is illegal and can be challenged a Judicial Review. via joint statement, In а Copperbelt University Senior Administrative, Professional and Technical Staff Union (CUSATSU) Secretary General Lukanga Kapeshi, Copperbelt University Academics Union (CBUAU) Secretary General Willie Ngosa and Copperbelt University and Allied Workers Union (CBUAWU) Secretary General Fernando Fulwe, said neither Professor Luo the Higher Education nor Loans and Scholarships Board, had the power to abolish meal allowances. "Neither a Minister nor the Higher Education Loans Scholarships Board and powers to abolish has meal allowances for public universities. Meal allowances have their foundation under an Act of Parliament. This is the Higher Education Loans and Scholarships Act, 2016 which came into effect on 17th April, 2017. This is an act which establishes the

## Luo's abolishment of meal allowances illegal - CBU lecturers

Higher Education Loans and Scholarships Board, establishes the Higher Education Loans and Scholarships Fund, Provides for the granting, administration, investment, payment and recovery of loans, provides for the administration and granting of scholarsships, facilitates the mobilization of financial resources for loans and scholarsships. The Act goes further to make for other related matters. Section 5 of the Act spells out the functions of the Higher Education and Scholarships Loans Abolishing Board. meal allowances is not among those functions prescribed by the Act," read the statement. "This means the Board has no power to abolish allowances the Act provides for. Any purported exercise of such power can successfully be challenged by way of judicial review on grounds of illegality. Section 24 of the Act makes provisions for allowances to be paid for under a loan

or scholarship. It enacts as follows: "24 (1) Subject to the provision of this Act, a loan or scholarship granted to a student shall not exceed the aggregate of -(a) the fees payable to the higher education institution per academic year, (b) a prescribed sum of money per academic year to assist in defraying the cost of books and other supplies required by the student in the student's faculty or department at the higher education institution, and (c) a living allowance in the prescribed amount per academic year." The unions said the announcement of the abolishment of meal allowances was a pretext for government to further reduce funding to higher learning institutions. "Section 37 (1) of the Act empowers the Minister by statutory instrument, to make regulations for the better carrying out of the provisions of the Act. The extent to which those regulations may

go is also spelt out under section 37 (2) of the Act. The minister cannot by virtue of the powers conferred by section 37 of the Act purport to abolish a loan, allowance or scholarship prescribed by the Act. The statutory instrument the minister is empowered to make is for purposes of enhancing the provisions of the Act and not to abolish anything the parent Act has already made provision for. It is therefore illegal for the minister of Higher Education to abolish the meal allowance," read the statement. "By implication, the announcement to remove meal allowances is a pretext for government to further reduce funding higher education in Zambia. The tuition, accommodation, project and book fees paid to the universities and students are loans that will be recovered. So why limit the extent of the loans if at all they will be paid back? How will the country

develop with a government that is not willing to pay for higher education? Prof Luo should come out in the open and explain to the nation the real reasons for this unfortunate pronouncement rather than lying to the nation and media houses that government had no intention of abolishing meal allowances even when she knew that this was what she actually wanted. Why deny in the first place if the intentions were clean. Prof Luo has abrogated the law and she must rescind the decision. Only Parliament can abolish the meal allowances. Prof Luo must respect the Law. Abolishment of meal allowances can only be legally done if the Minister repeals the current act and replaces it with a new one and this require approval from Parliament and participation of key stakeholders. As it stands what the minister said is a mere pronouncement without the backing of the law which can

we wonder who is funding these youths to attack us, but we want to assure them that such threats only make us stronger. What is important to us is to make sure that we remain professional; we never abuse the power of the pen through our publication to scandalise innocent citizens or eminent persons. Even if they petrolbomb News Diggers and eliminate us all, so long the work we are doing is for the greater good of this country, another courageous group of journalists will see the need to rise up and continue from where we would have left," said Mwenda. "It is also important for those who are planning evil against us to know that what we publish is not hearsay. Our ears are on the ground and we hear a lot, but we don't just publish without making sure that we can prove what we report. If a minister demands for an expensive rolex watch, as a gift from a contractor who has won a government tender, we will not just publish that as a scandal, we first try to look around and put all the pieces together, so that we can tell a complete story. Our readers must be assured that we have only just started. The "Corruption Trail" is not the last exposé, there is plenty more to come."

be successfully challenged in the courts of law." They stated that UNZA and CBU were embroiled in huge debt due to poor provision of funding by government, adding that the removal of meal allowances would worsen the situation as vulnerable students would not be able to pay other fees. "The University of Zambia and CBU are technically insolvent with a staggering debt of about K6billion because of poor funding by government. Abolishing of meal allowances will further affect the running of the universities since most students and their families will not be able to support their school. The income will further reduce such that those universities will not be run effectively. As much as the inclusion of other Universities on the loan scheme is welcome, Prof Luo's main intention is to remove the only benefit that a poor student is entitled to. The extension of the loan to other universities is just a ploy to win public approval. It is the unions' view that the extension as reported will not even be possible as government has lamentably failed to fund the existing public universities," read the statement.

According the reports from to Sesheke, the PF cadres were not only terrorizing Sesheke residents during the by-election but also charging at police officers using all sorts of offensive weapons. For the record, Zitukule Consortium does not support any form of police brutality whether

#### such brutality is directed at PF, opposition supporters or indeed members of civil society. Political violence and police brutality are not only unlawful and a violation to citizens' constitutional and human rights, but also represent the most uncivilized way of dealing with divergent views, particularly in the political arena," Phiri stated. "As a Consortium, we disturbed deeply are by the message that the Republican President is sending to the police $\mathbf{PF}$ cadres, service, opposition supporters and the nation at large. It is difficult to reconcile how President Lungu and the police command can fire four police officers in public interest when they have failed to take the same action in the recent past on cases similar to or worse than the Sesheke incident. What happened to officer who killed Mapenzi Chibulo, a UPND supporter in cold blood in 2016? of national unity and state-building. The firing of Sesheke police officers sends a message that PF members can break the law at will and no one would dare touch them! Meanwhile, the message to those in opposition and civil society is that unless they support PF, they should not expect any protection from the police service. Meanwhile, the President and the police command have effectively taken away the little remaining professionalism in the police service as

it would be practically impossible for them to act against PF's lawlessness using their professional judgement," stated Phiri. "As Zitukule Consortium, we call upon the President to take a deep reflection on his Oath of Office to protect and defend the sanctity of the Constitution. We cannot have 'one Zambia one nation' when the application of the law is selective. As things stand now, the success or failure in maintaining public order largely depend on the Presidency."

# Lungu's stance on corruption confirms he is running a govt of thieves - Telesphore

Archbishop Telesphore Mpundu says President Edgar Lungu's refusal to fire corruption-accused Minister of Housing and Infrastructure Development Ronald Chitotela gives credence to the assertion that he is running a government of thieves, by thieves, for thieves. Archbishop Mpundu has And condemned the firing of four Sesheke police officers over allegations that they beat up PF cadres saying the law should be applied fairly, regardless of the political party which law breakers belong to. In this verbatim interview, Archbishop Mpundu insists that corruption has become endemic in Zambia and vows that he will not stop talking because he is not scared of anyone. O. One of the challenges which we have faced in this country is corruption. Recently, the minister of Infrastructure Development Ronald Chitotela was arrested by the Anti-Corruption Commission but the President said he could not fire or suspend him because he was innocent until proven guilty, what are your views on that? A. In the second statement that we made as church mother bodies, we tackled the issues of corruption. And my part of the statement tackled the issue of corruption which has become endemic in this country. It is there and it is endemic. When we had the ceremony of putting [Archbishop Alick] Banda, my successor, I mentioned the issue of corruption again in my homily. I said 'democracy is

supposed to be known as a government of the people, for the people, by the people but if we leaders, and I began with us Catholic priests, and leaders that if we stop serving people, then we become parasites. We become cannibals. Our governments here in Africa are governments of thieves, by thieves for thieves', and the President was seated there. Every single year, we have the report from the Auditor General listing horrendous abuse of public funds but how many heads roll? Very few. People who are caught, literally caught in government, what happens to them? They are dismissed and they go to use the ill-begotten money, they are just dismissed instead of being prosecuted, found guilty and put behind bars. If the President fails to discipline that person, what kind of message is he sending there? A government of thieves, for thieves, by thieves. Period! And I am not going to apologise to anybody because this is the truth, the whole truth and nothing but the truth. I won't even say help me God, I will say support me God. That's it. We have never failed to raise a strong word about endemic corruption. This country has just gone haywire when it comes to corruption. So I will say it again and again. And that's where we should have seen the leadership of the President. One is caught, [fire immediately], zero tolerance for corruption. Now what do we have? 'No, I won't dismiss him'. No, no way! In any country in the world, people will be on the streets, the whole country will be on the streets if that happened but for us, we are peaceful people, Zambians are peace loving. Jesus did not say blessed are the peace lovers or blessed are the peace keepers...you can't keep peace if there is no peace. It is blessed are the peace makers. Meaning people who are angry enough against what is going on to do something in a peaceful way to stop it. As Christians, we should be in the fore front of getting angry enough about unjust situations including theft of public funds when so many people are suffering from hunger. We need to change this peacefully and bring about peace. And we are passionate about it as Catholic Christians, no two ways about it, no one will frighten us from talking. They are just wasting their time. Q. In the just recently held by-election, we witnessed gruesome images of political violence. After the election, the PF, through its secretary general Davies Mwila complained to the Inspector General of Police that their cadres were brutalised by some officers. The police command has responded by firing senior Sesheke officers. What are your views on this, given that police officers in the past have gotten away with other serious atrocities? A. First of all, violence is not a way of doing politics. I have said it again and again that it is primitive. This didn't start yesterday, even in the one party state, there was no political dissent allowed within one party...We should be going the way of selling ideas, let the ideas fight, not physical fighting. It is primitive, it is not even stone age, it is the age of the Broken Hill man. For us, we are short of ideas so what do we do? We beat the opposition into submission. Worse, there is institutional violence, this is when a government of the day, using government institutions to frighten people. This time around, their people were on the receiving end and what happens? They say 'you didn't protect the government properly so police are fired'. But previously, the police have failed to stop violence coming from the ruling party, not just this one, before that it was the MMD, before that it was UNIP. There should be a level playing field. Whoever makes a mistake, whatever political party they come from, they should face the law, not to be discriminatory in the administration of justice, it is a shame. Q. Do you feel young people today are politically awake and willing to participate in the country's governance like it was when you were growing up? A. Young people have a future, but they are also in a hurry to live that future. You can't keep telling them 'you are the leaders of tomorrow, no they are leaders today so whatever development you are bringing, you have to look at the young people, are they getting their fair share of development benefits? This must be translated into job creation and also a policy that ensures quality education for tomorrow's leaders. But this is not coming because of poverty. Right now, as I am talking, the University of Zambia

Great East Road campus is trying to find some kind of arbitration between them and the government because as you know, they have scrapped the meal allowances. But why were we not told years ago so that those coming this year can come armed with whatever it is maybe pumpkins or whatever it is. So you cannot convince them that government is concerned about the youth. Now you can talk about political

awareness but that can be translated into fruits of political leadership and fruits of political leadership is development. If nothing is coming like that, you can talk

till kingdom come but if those things are not happening, young people will just look at you and walk away. So you have to bring the youth on board with concrete programmes to benefit them. It is very difficult for young people to believe that government doesn't have enough if the other day we were told millions are disappearing. We are not going to accept that. ### Zambia's gross reserves drop to near 10-year low

**By Stuart Lisulo** Zambia's gross international reserves have fallen below US\$1.6 billion for the first time in nearly 10 years, triggered by the need to finance the country's external massive debt servicing commitments, Bank of Zambia data reveals. But Bank of Zambia (BoZ) governor Dr Denny Kalyalya says the central bank is not sitting idle in trying to contain the country's dwindling reserves as various initiatives are underway to bolster the position. Meanwhile, the BoZ maintained has again Policy the Monetary Rate (MPR) at 9.75 per cent in a bid to induce lower interest rates and

continue supporting economic growth. According to BoZ data, Zambia's gross international reserves by the end of the fourth quarter of last year have plummeted to US \$1.57 billion, the lowest in the last nine years. International reserves are any kind of reserve funds, which central banks can pass among themselves, internationally, and they remain an acceptable payment form of these among banks. Reserves themselves can either be gold or a specific currency, such as the dollar or euro. BoZ data shows that Zambia's reserves by the end of the fourth quarter of last year hit a near

10-year low of US \$1.57 billion, representing just 1.8 months of import cover, compared to US \$1.63 billion as at September 30, 2018, representing 1.9 months of import cover. The last time the country's international gross reserves were at this decade-low was in 2009 when BoZ data revealed that reserves held were at US \$1.9 billion in December of that year. According to the BoZ, the sharp decline in the country's reserves was triggered by the need finance Zambia's to huge external debt serving commitments. "Gross international reserves declined to US \$1.57 billion (representing 1.8 months of import cover)

from US \$1.63 billion (1.9 months of import cover) recorded at end-September 2018. External debt service payments were the primary drivers of the drawdown in international reserves," BoZ data disclosed, as contained in the latest Monetary Committee Policy (MPC) statement availed, Wednesday. The decline in reserves were, however, arrested by the central bank's net purchases of foreign exchange, among key interventions. "The decline was moderated by net purchases of foreign exchange by the Bank of Zambia and Mineral Royalty Tax receipts amounting to US \$109.6 million in the fourth quarter of 2018.

### Lusaka woman sues Chingola colleague for calling her prostitute

A businesswoman of Lusaka's Kamwala South has dragged another woman of Chingola to court for allegedly calling her a prostitute and other unprintables after she refused to give the defendant money in exchange for information her husband's infidelity. on Victoria Sichone, who has sued Astridah Mukutu, is seeking compensation for defamation of character, as well as, exemplary damages for emotional turmoil. In a statement of claim filed in the Lusaka High Court, February 14, Victoria stated that sometime in 2017, Astridah called her with a view to extort money from her by making up a story that her (Victoria's) husband was in Chingola with another woman.

Victoria stated that Astridah told her that if she wanted to hear more, she was to pay for the information. She added that when she refused to pay, Astridah published an oral statement, charging that Victoria was a fool, prostitute among other unpalatable things. "The said words were understood to mean that; the plaintiff has poor judgement or intelligence, she is fond of having sexual intercourse with other men in exchange for money and that she can't be trusted," read the statement of claim. Victoria lamented that the said words had injured her character and had caused her to be ridiculed, scorned and had further diminished the esteem, respect and goodwill

with some members of the family. She stated that despite her insisting that Astridah issued an unreserved apology, the latter had blatantly refused to do so. "By reason of the publication of the said words, Victoria has been injured in her professional standing character, reputation and has suffered distress, embarrassment and has been brought into public scandal, odium, ridicule and contempt," read the statement of claim. Victoria is now claiming compensation for defamation of character, aggravated and general damages for slander, exemplary damages for emotional turmoil suffered, interest, costs and any other relief the court may deem fit.

purchases from the market for 2018 amounted to US \$346.0 million compared to US \$402.6 million in 2017," it stated. But reacting to questions from journalists, Dr Kalyalya explained that the central bank was concerned with the rapid deterioration in the country's reserves, hence some bold initiatives currently being undertaken. "Obviously, it does concern us when it is going down. We can't just remain at being concerned; you have to do something to try to augment the reserves. But also, we urge those who are drawing on it to look at their profile to see that...'is it really necessary to draw reserves at this point?' So, this is the issue of how do we rationalize the debt service that we have; does everything need to come through that window or it can be met from other sources? That's on the demand side," Dr Kalyalya said. "...But on the supply side, we are also looking at how do we augment this (reserves). We started last year in September to collect Mineral Royalties directly; it's not a whole lot. This year, we expect to do better on that particular line. We are looking at how to step up our augmentation of reserve purchases; we did buy quite a lot of resources - in excess of US \$300 million. We are equally looking at how we can add to our portfolio of assets in reserves in gold so we are in conversation with those

who produce gold so that we can add to our list of items. So, we are not sitting idle." Meanwhile, Dr Kalyalya announced that the central bank had decided to maintain the MPR at 9.75 per cent, while also keeping the Statutory Reserve Ratio (SRR) at five per cent, for the fourth successive time since last February in a bid to induce lower interest rates and continue supporting economic growth. This means that the MPR and SRR have remained at the same level for the last one year. The MPR is the benchmark lending rate the central bank sets on commercial banks to either increase or decrease interest rates on credit facilities, while the SRR is the proportion of deposits a commercial bank, by law, must keep in cash or place with the central bank. Dr Kalyalya explained that the central bank decided to maintain the MPR and SRR to continue supporting the country's economic growth, while also induce the lowering of high interest rates obtaining on the local market that increased to around 23.6 per cent in the fourth quarter last year, from 23.0 per cent by September 30. "So, we see that interest rates have remained elevated, in fact, they edged up from 23 per cent to 23.6 per cent. So, high lending rates continue to constrain the private sector's access to credit," said Dr Kalyalya in front of journalists, as he explained that private sector credit growth remained slow.

"At about 14:30hrs on that fateful Friday afternoon, Zambia Police Service officers from State House division, appeared from nowhere and, without warning, opened fire on the crowd of Maondo ward residents whom the UPND president was addressing as part of his campaign itinerary for that day. all directions in fear of their lives as the State House police officers continued to open fire with automatic weapons on the unarmed and defenceless UPND entourage and Maondo ward residents. "Even after the UPND president and his entourage had dashed into the nearby bush and abandoned their vehicles at the village, the State House police officers continued to pursue them further into the bush, were they continued to fire their automatic weapons. The UPND president and his entourage had to spend more than 8 hours holed up in the bush waiting for nightfall, before they finally made their way back to the village, at which time the state house police officers had left the scene after teargassing and vandalizing the entire Maondo village." # PF on track to realizing vision 2030 - Mwila

By Zondiwe Mbewe PF Secretary General Davies Mwila says government has been in discussions with JICA and the African Development Bank (ADB) to provide US\$350 million for the implementation of the Lusaka City Water Supply Improvement project.

And Mwila says PF government is further implementing the Lusaka Sanitation Programme which will involve among other things, construction and rehabilitation of sewer networks and provision of sanitation facilities in public

institutions.

In PF's weekly news letter to News Diggers! Mwila stated that the PF government attached strategic importance to the water and sanitation sector as a tool of economic diversification.

He cited an example of the increased national budget allocation to the sector from 1.2 percent in 2015 to 2.3 percent this year.

"In line with the 7NDP, the PF government increased national budget allocation to water and sanitation from 1.2 percent absolute share of the National Budget in 2015, to

2.3 percent share of the 2019 National Budget – the highest ever budgetary allocation for the sub-sector. This signals the strategic importance the PF government attaches to this sector as a tool of economic diversification and employment creation," Mwila stated.

He stated that the PF government was implementing numerous projects and programmes which would facilitate the achievement of the 7NDP strategic objectives; and ultimately the Vision 2030 objective. Mwila listed some of the projects implemented by government under the water and sanitation sector.

PF "The Government mobilized funds amounting to US Dollar 355 Million from the Millennium Challenge Corporation (MCC) of the United States of America to implement the Lusaka Water Supply, Sanitation and Drainage Project. The project involves the improvement of water supply, sanitation and drainage systems in selected townships of Lusaka city and strengthening the institutional capacity of Water

Utility companies. The project will benefit more than 1.2 million people," he stated.

"Also, government is implementing the "Integrated Small Towns Water Supply and Sanitation Programme" in Northern, Muchinga, Luapula and Western Provinces targeting 12 districts in these provinces, namely: Mbala, Kasama, Mpika, Nakonde, Samfya, Kawambwa, Mwense, Mansa, Kaoma, Mongu, Senanga and Sesheke. This is a 48-months project, costing US\$150 Million - with government counterpart funding and a US\$1.6 Million Grant from MIC TAF. This Project aims at increasing access to quality, safe and reliable water supply and sanitation for people in the areas. This Programme shall improve the livelihoods and health of over 930,000 people

in the targeted districts." And Mwila stated that government had been discussing with JICA and ADB to provide US\$350 Million for the implementation of the Lusaka City Water Supply Improvement project due to increasing demands for water supply in the city.

"Due to increasing demand for water supply in Lusaka city as outlined in the Lusaka Water Supply Masterplan, the PF Government has been discussing with JICA and the African Development Bank to provide US Dollar 350 Million for the implementation of the Lusaka City Water Supply Improvement Project. The project is expected to commence by April 2020. The project will involve the construction of: intake

transmission pipeline, treated water booster pump stations at the Water Treatment Plant, a treated water transmission pipeline from Kafue to Lusaka, Water Treatment Plant, and expansion of the water distribution network in selected areas," Mwila stated. He further stated that the PF government was also implementing the Lusaka Sanitation Programme having mobilized funds amounting to US\$300 Million from the World Bank, African Development Bank, European Union and kfW.

Mwila stated that the programme would involve: construction and rehabilitation of sewer networks, pump stations and treatment plants; provision of sanitation facilities in public institutions;among other things.

"The PF Government is also implementing the Lusaka Sanitation Programme, having mobilized funds amounting to US Dollar 300 Million from the World Bank, African Development Bank, European Union and kfW. The programme will involve: construction and rehabilitation of sewer networks, pump stations and treatment plants; provision of sanitation facilities in public institutions; construction of faecal sludge management systems; strengthening of Lusaka Water and Sewerage Company's (LWSC) operation and maintenance of sewers; enhancing the capacity of LWSC, Lusaka City Council, the responsible Ministry for water and sanitation, and other stakeholders," stated Mwila.

# Zambia's political climate has been toxic – Finland

has declined dramatically since then. In 2018, Finland allocated just 4.3 million euros to bilateral aid for Zambia and this year the amount will be even less, at 3.5 million. Next vear, it will be an estimated two million, eventually drying up by 2023. Austerity sees development aid cuts 'You could say that Zambia has been a disappointment during the last few years. The country has lagged behind in a number of metrics and the political climate has been particularly toxic. Zambia is becoming indebted at a rapid rate - you could say unsustainably - and relations with the International Monetary Fund are poor," noted Juha Savolainen, head of the ministry's Southern and West African unit. Last September the IMF

y announced that it would no d longer extend additional credit s to Zambia.

"Corruption scandals have become more widespread. Leading politicians have either been sacked or they have left the government because of these suspicions," Savolainen added "We are following the situation with some concern and are in active dialogue with Zambia," he continued. The ministry official admitted however, that the decision to terminate development aid was made in rather different circumstances. From 2010, the Zambian economy posted growth of up to 10 percent annually, slowing to about three percent per annum in recent years.

implemented an austerity programme that included deep cuts to development assistance, starting in 2016. In addition, recent revelations of misuse of development funds in Zambia have resulted in projects being frozen or wrapped up and only served to accelerate Finland's move to wind down the programme. 20 cases of suspected wrongdoing Yle's A-studio discussion programme requested reports on suspected abuse of all development aid spending between 2015 and 2018. foreign The ministry handed over information about 20 suspected cases of development aid misuse, 11 of which involved Zambia and seven of which involved calls to repay funds contributed. # **PF has hijacked Police**, it's total State capture

Esther Katongo's message is a sugarcoated understatement. Even though she released a statement yesterday claiming that we misquoted her because police officers are not crying foul, she knows that her heart is not agreeing with her mouth. Let's face it, the Police Command is finished. Our men and women in uniform, including madam Esther Katongo, have been reduced to nonentities. They are even worse than G4 security officers with no power, no job security and no direction. Their zeal to work has completely been shuttered.

Nothing is nice about working in the police today, because their operating manual has been replaced with the PF's panga doctrine. This is the situation with all the officers, regardless of their ranks. Police officers

report for work already wondering terrified, whether they will make it through the day without offending the PF leadership. It is no longer about law enforcement; it is about pleasing the PF to stay in the job.

But this has got nothing to do with the fact that police cannot use force in their policing methods, as madam Esther Katongo is putting it. If anything, the opposite is true, and it is the same force which they used to sort out provocative PF thugs that has led to the retirement of the "Sesheke Four".

So, it is not expected that police officers can discipline PF cadres. The Service is now a tool for those in power to brutalise and oppress opposition parties.

Today, when a PF cadre wearing green regalia slaps a police officer, that officer must not only turn the other cheek, but also salute and say "thank you sir!" But if a UPND cadre points a finger at an officer, and that officer walks away without a 'fight', they will be accused of supporting the opposition and a retirement in national interest follows, instantly.

This may sound too exaggerated, but it is a reality in the Police Service. Officers, with

all the ranks on their shoulders, are nothing more than school cadets in the eyes of the Patriotic Front. Ruling party youths can even commandeer a police vehicle if they so wish; and at the rate we are going, soon they will be at liberty to borrow police guns in order to fight their battles with UPND.

How can this be happening in a normal country with a President who is a lawyer? Surely, those who say Mr Edgar Lungu is not in charge of the State have a point. This is what happens under State Capture. When a President is asleep, bad elements wake up to steal his ballpoint pen and authorize all sorts of atrocities. A President, especially one who understands law, justice and order, cannot fire police officers at will in this manner, without paying any consideration

to facts. This is a State capture and nothing else. Criminals are controlling and abusing our very critical security wings using the name of the President.

Clearly, apart from the Inspector General, his deputy and Commissioners of Police who are enjoying their gratuities with the PF in power, the rest of the police officers are not happy. Two prominent Roman Catholic Church cardinals have urged an end of what they call "the plague of the homosexual agenda", telling bishops to break their complicity over cases of sexual abuse.

In an open letter, Cardinals Burke and Brandmüller say the Church has wrongly blamed the abuse of power by clergy as the main cause of the scandals.

Instead, they say the cases involve priests who have "gone away from the truth of the Gospel".

They also openly criticise the Pope.

Stories of sexual abuse of minors have emerged across the world and the Church has been accused of covering up crimes committed by priests. Their letter comes on the eve of an extraordinary summit of bishops in Rome called by Pope Francis as an effort to deal with the scandals rocking the Church.

What are the cardinals saying about sex abuse?

Cardinals Raymond Burke, from the US, and Walter Brandmüller, from Germany, reject that the cases of abuse are a result of "clericalism" - a group of men abusing their power, and protecting each other.

The cardinals belong to the traditionalist wing of the Church, where many believe homosexuality is a root cause of the clerical abuse, and are both outspoken critics of Pope Francis.

"The plague of the homosexual agenda has been

spread within the Church, promoted by organized networks and protected by a climate of complicity and a conspiracy of silence," they said.

"Sexual abuse is blamed on clericalism. But the first and primary fault of the clergy does not rest in the abuse of power but in having gone away from the truth of the Gospel.

In the Catholic hierarchy, cardinals are second in importance only to the pontiff, and there are currently 223 of them.

Cardinal Burke has links to former Trump White House adviser Steve Bannon, who will reportedly be in Rome during the summit.

Mr Burke is president of the the advisory board of the right-wing Dignitatis Humanae Institute, which is setting up a leadership course with Mr Bannon's help.

Meanwhile, Cardinal Brandmüller caused controversy last month when he blamed homosexuality for the cases of sexual abuse at the Church.

Why do they criticise the Pope?

The cardinals accuse the Pope of failing to answer questions related to whether the Church should allow divorced and remarried Catholics to receive Holy Communion - they are currently barred.

The issue, raised in 2016 by four cardinals including Burke and Brandmüller, has caused controversy in the Church, prompting many clerics to question the Pope's leadership.

The mention of this point completely unrelated to

Thursday's summit, and the challenge to the Pope's authority, shows that clerics who are unhappy with Pope Francis are growing more

confident, observers say. What's the summit about? The summit is to be attended by the heads of all national bishops' conferences from more than 130 countries, who will discuss the most pressing crisis facing the modern Church.



### Climate change-ravaged rodent ' extinct'

It was described in 2016 as the first mammalian extinction caused by human-induced climate change.

Now the eradication of the Bramble Cay melomys has been officially recognised by Australia, its only known home.

The rodent lived solely on a tiny sand island in the Torres Strait, near the coast of Papua New Guinea (PNG). The species has not been seen since 2009.

Scientists say there is a chance that an identical or similar species could vet be discovered in PNG.

But they're uncertain because PNG's nearby Key River region has been little documented by research.

Australia has one world's highest rates of animal extinction, says the International Union for Conservation of Nature. 'Our little brown rat'

The Australian government's decision to list the species as extinct comes after the Queensland state government made an identical determination in 2016.

A state government report said it was almost certainly caused by "ocean inundation of the low-lying cay, very likely on multiple occasions, during the last decade, causing dramatic habitat loss and perhaps also direct mortality of individuals". It added: "Significantly, this probably represents the



first recorded mammalian extinction due to anthropogenic climate change." The loss of an animal that was hardly known in the public mind has generated sadness in Australia and abroad.

"The Bramble Cay melomys was a little brown rat," said Tim Beshara, a spokesman for advocacy group The

Wilderness Society. "But it was our little brown rat and it was our responsibility to make sure it persisted. And we failed."

### Conservation efforts

The Sydney Morning Herald reported that Australian scientists had found no trace of the animal in recent surveys of Bramble Cay, an island of just five hectares.

A 2008 "recovery plan" had downplayed the risks to its survival, the newspaper

#### reported.

The current government, in office since 2013, has frequently defended its environmental efforts - citing a A\$425m (£233m; \$300m) investment in threatened species programmes, among other efforts.

But it has also been heavily criticised by conservation groups for not providing greater funding, or additional policies.

Australia is rare among developed countries because it is described as megadiverse, but experts warn that biodiversity is under threat from environmental upheaval. The nation is not on track to meet its commitment of reducing emissions by 26-28% on 2005 levels by 2030, according to the most recent government data.**BBC**

# Ibrahimovic on his Man Utd spell and how he ended the bullsh\*t

Zlatan Ibrahimovic says it took just three months for him to turn his "haters" into "fans" and eradicate the "bullsh\*t" talk that he was not good enough for Manchester United.

The Swedish striker spent almost two years with the Premier League side before leaving to join the LA Galaxy last March.

The Red Devils may not have been able to get back on top of the English top flight during Ibrahimovic's time at Old Trafford, but he helped guide them to an EFL Cup win in 2017. He also played a key role in their triumphant Europa League campaign until suffering a serious knee injury in the quarter-final against Anderlecht.

The former Juventus, Inter and Barcelona star scored 29 times in 53 appearances in all competitions for United and he believes he did enough to cement his status as a favourite in England.

"I worked, tried to do my thing, still adapt to the team, adapt to the coach's philosophy and to the club, and I had no issues with those things because I'm professional," he told the club's official website. "I like to work, I take instructions, at the same time I like to do my things that I think – I know – I'm good at, and I try to help the team in the best way.

"Still, everybody was talking, thinking they knew



everything. My challenge was, at the age I was, coming to England, where I had years of everybody was saying I wasn't good enough and all this bullsh\*t.

"I like those things because they trigger me. They give me adrenaline. After three months, all of them were eating their own words. I needed new haters because all the old ones became my new fans!"

Imagine if you played in empty stadiums... you would not play. In Old Trafford it was always full. Always. In every away game they always showed up, always supported."

The ex-Sweden international hitman has been in fine form since moving to MLS, scoring 22 times in 27 matches, but he still remembers his days of conquering United fondly.

"That whole first season at United was fantastic. Everything was. I really enjoyed it. The family was happy, everybody was happy, the club took care of me and made it really easy for me. I just needed to turn up, put on my football boots and perform," he added.

"When I was a boy, I had a vision of what I wanted in my life. You never know what will happen, but I had my dreams, I had my will and my life became what it became. Philippine boxing legend Manny Pacquiao said Wednesday he has urged his eldest son to stay out of the ring after the 19-year-old's forays into fighting made the young man's mother cry. Pacquiao, the only fighter to win world titles in eight different weight divisions, said he and his wife have even made a point not to have gloves and equipment at home. The boxer, known for his rags-to-riches

The boxer, known for his rags-to-riches climb from the street, has tried to push his son Emmanuel Jr, who is known Jimuel, to choose another path.

"It pains me that he is boxing because I know how hard it is. I told him, 'Daddy only went into boxing because of poverty... You, you don't need to box'," Pacquiao said on broadcaster ABS-CBN. "But he said: 'Daddy, like you boxing is my passion also. I want to be a representative of this country as an athlete'," Pacquiao added.

Pacquiao made the comments after a video of Jimuel sparring during an exhibition match was posted on Facebook.

"His mommy had cried several times telling him, 'Don't go into boxing, son'," Pacquiao said of his wife, Jinkee, who had also urged the 40-year-old boxer to retire. "He really wants to do it," he added. The younger Pacquiao wouldn't be the first son of a high-profile boxer to follow dad's lead. The sons of British boxers Nigel Benn and Chris Eubank, as well as American slugger Joe Frazier became fighters.

The Facebook footage shows the younger Pacquiao sending his opponent to his knees with aggressive moves reminiscent of his father. Jimuel was wearing gloves and gear branded "Pacman", his dad's nickname.

The elder Pacquiao was watching the match through a video call and was seen talking to his son before it started.

An aide for Pacquiao told AFP Jimuel took up boxing only in December, a month before his father easily defeated Adrien Broner in Las Vegas.

As for his own career, Pacquiao said he was still eager for a rematch with Floyd Mayweather but had yet to discuss his next fight with adviser Al Haymon. Pacquiao in October signed with Haymon's Premier Boxing Champions group after being promoted by Top Rank's Bob Arum for the past 14 years. Zambia's 2018 best performing player Jacob Mulenga has signed a one-year contract extension that will see him at Chinese side Liaoning Kaixin until December 2020.

The 35-year-old Zambian Footballer was also handed the captaincy in October last year after becoming a regular scorer at the club.

By Decemnber 2018 Mulenga had scored 13 goals in just 21 appearances in the Chinese Soccer league.

He retired from international football in 2015 after missing out on playing for the national side due to a series of injuries.

His last game for Zambia National Soccer team was against Togo in 2014. Mulenga spent 10 years playing in Europe; firstly campaigning in France for FC Chateauroux in the French Ligue 2 before a short spell with Ligue 1 outfit Strasbourg.

His last European club, Utrecht, denied him a contract extension, a move that forced the former Zambian international to move to China for greener pastures.

His career has long been plagued with injuries which sidelined him for many months at Utrecht and forced him to miss important Zambia fixtures.
