Mushimba blocks critics on Twitter after failing to justify SA medical bill

By Mukosha Funga Minister of Transport and Communications Brian Mushimba has blocked critics on Twitter after they demanded justification for his decision to get his broken arm treated in South Africa, where he staved for over a month. Mushimba was involved in a road traffic accident on the night of January 18, 2019 after a Toyota Land Cruiser he was driving overturned on Thabo Mbeki Road in Lusaka. His counterpart at the Ministry of Health, Dr Chitalu Chilufya, told journalists the following day that Mushimba had "sustained injuries to his right forearm, underwent surgery in the early hours of this morning and is stable". He was, however, evacuated to South Africa where he was hospitalised for weeks at Arwyp Medical Centre, an expensive private hospital in Kempton Park, Gauteng Province. The minister was only discharged from hospital on Sunday and immediately took to Twitter to rejoice. "So thankful to be going home today after an extended stay at the hospital repairing my injured right arm. Thank you for best wishes and prayers", he tweeted, along with an image of himself and three medical officers at Arwyp Medical Centre. The immediately tweet invited furious responses from many taxpayers. Civic rights campaigner and Alliance for Community Action Executive Director Laura Miti led the onslaught when she tweeted, "Govt cannot pay for the university education of brilliant underprivileged students but has money to send a Minister abroad for a broken arm for weeks at astronomical cost. He poses for pictures to show us the medical care leaders enjoy. Alright Minister Mushimba, we have seen". Another twitter user Marcos wrote "Everyday we wake up to something shameful by these looters. When will we wake up to hear the working class' lives have been improved, the under privileged have been better placed? ¢everyMourning4Zambia". Satirical singer Fuma Chamba alias Pilato tweeted "Hey world, this is a cabinet minister in Zambia who broke his arm and rushed to South Africa for treatment. His government runs hospitals in the country but he

It was the tweet from political commentator and columnist Sishuwa Sishuwa that first prompted the minister to respond. "An injured arm, you say? Do you have such little trust in the hospitals in our own country that for a minor complaint you were flown to South Africa? Are you mocking Zambians? And who paid for your medical bills, we the taxpayers? Or perhaps you paid out of your own pocket?" This reply infuriated Zambian netizens, who returned with more biting tweets. "You are the one who made your 'medical file' public, not me. And you did so from your official Twitter account. Was your treatment paid [for] by taxpayers? If so, then taxpayers have a right to know & to be outraged at waste of money that could be used to improve healthcare in Zambia", Sishuwa wrote. Economist and academic Dr Grieve Chelwa joined the discussion. "WE paid for this Mr. Mushimba. WE have every right

How is the irony lost on you!" Peter Mubanga Cheuka wrote, "You need to avoid using this cheap way of responding to questions raised by the people. People want to know why you were not treated in Zambia. Million other Zambians are being treated in our local hospitals. Don't just expect praise, but questions as well from people you lead." Luke Mulenga followed suit: "Please stop the operatic histrionics. It's a simple inquiry requiring a simple answer. It would be an absolute disgrace if you used tax payer funds to pay for treatment that would have been done in one of our local hospitals." Wika Kawina agreed: "I agree. I personally feel mocked that people that are in charge of

improving my well-being are in the forefront in getting evacuated to other countries for health care. What does that say about the services we have here in Zambia? Highly disgraceful." Maloza wrote: "Awryp Hospital charges minimum admission fee K30,000 per day X 30 days = over K1,000,000 for a drunken driver's broken arm. That's excluding tests, emergency call, surgery, medication, relatives escorting etc. Yet PF Govt claims there's no money for student meal allowances. Misplaced priorities. what a wasteful regime. The pipo who keep voting/rigging for this regime need to be detained at Chainama mental Hospital." A few netizens, however, empathized with the minister. "Impressed by the fact that you kept working [while you were in hospital], tweeted Kabwe JMusonda while Muloongo Muchelemba wished the minister well, tweeting " Get well soon Honorable", a message that was echoed by others. David Kabaso offered a conclusion: "Hope you copied all the machines they used so you come and urge your government to buy them to avoid traveling back to other countries for treatment. It's a shame" Meanwhile, those who criticised the Minister later complained that he had blocked them from accessing his account. Sishuwa, posting a screenshot of the blockade, wrote "Last week, l agreed with #Zambia's Minister of Communications Brian Mushimba's tweet on the need to support ZAMTEL. He heaped praise on me. Today, l asked him if his medical treatment in SA was funded by taxpayers, noting that we need to improve our own healthcare. He BLOCKED me." Many others such as Dr Chelwa and Mona Lisa registered similar complaints. "He has blocked me

DEC asks court to dismiss matter in which Chita Lodge sued it over property

By Zondiwe Mbewe The Drug Enforcement Commission has asked the Lusaka High Court to dismiss with costs, the matter in which Chita Lodge Limited sued the commission for allegedly seizing its property in Lusaka's Ibex Hill on the premise that its owned by former Zambia Air Force Commander, Lieutenant General Eric Chimese. In this matter, Chita Lodge Limited through its managing director James Chungu, who is jointly charged with Chimese on charges of concealing

property, had sued the Attorney General as the first respondent and the Drug Enforcement Commission as second, saying the seizure itself was irregular, illegal, unfair and unreasonable because the said premises had never belonged to Chimese. However, DEC Chief Investigations Officer Mukelebai Kwaleyela has raised preliminary issues, stating that the court should determine whether Chungu was in order to bring to court, matters that were subject

of criminal proceedings scheduled for March 11, 2019 before the chief resident magistrate of the Subordinate Court. He further asked the court to determine whether had it jurisdiction to entertain Chungu's application even if it was out of time. Kwaleyela argued that, Chungu through Chita Lodge Limited had devised a ploy to defeat the cause of criminal Justice in the matter where he has been arrested and charged, by abusing court with his application

Choose Zambia over HH, Sunday tells UPND MPs

PF media director Sunday Chanda has appealed to UPND members of parliament to choose Zambia over their party leader Hakainde Hichilema by supporting the Constitution amendment process earmarked for presentation to Parliament this session. Monday, Hichilema On instructed his members of parliament to shoot down the motion to amend the Constitution by Justice Minister Given Lubinda saying the process could not go on before dialogue. But in a statement, Chanda advised the UPND members of parliament to "choose right" by representing the interests of Zambians, which is what they were elected to for. "We want to ask the UPND members of parliament to choose Zambia over Mr Hakainde Hichilema. We are asking the UPND members of parliament to choose the country over Mr Hakainde Hichilema. We are asking very simple questions to the UPND members of parliament, who will you serve between HH and mother Zambia? If it seems right for you to choose HH above Zambia, do it. But posterity will judge you harshly. On Sunday, we learnt that Mr Hakainde Hichilema had asked Maj Kachingwe to choose him over his son's life and vesterday (Monday) HH was telling UPND members of parliament to choose him over national interest. In 2011, HH directed his members of parliament to vote against the Constitution Amendment Bill of that time because he wanted MMD to lose power so that he become President. He never became President, he has not become President, he has continued losing elections since and we can confidently say that it is by God's providence that Mr Hakainde Hichilema is not President

of Zambia," Chanda stated. Chanda stated that Hichilema always campaigned against progressive bills meant to improve the lives of Zambians. "In 2016, Mr Hakainde Hichilema campaigned against the Bill of Rights, denying Zambians far and better rights and today the UPND and Mr Hakainde Hichilema cry the loudest about better rights. Members of parliament have a solemn duty to make laws. They are elected to office to make laws; they are paid allowances to make laws; they receive their gratuities for making laws. Lungu warns 'get rich quick' accountants

President Edgar Lungu says some accountants have now become enemies of the people because they have involved themselves in financial transgressions to quickly amass wealth at the expense of Zambians. Speaking when he officiated at the East and Southern African Association of Accountant Generals (ESAAG) annual General Conference at Avani Hotel in Livingstone, President Lungu said accountants played a cardinal role in the transformation of Africa into a prosperous and fast-growing continent. But he observed that some accountants had now become enemies of the people because they involved themselves in financial transgressions in order to quickly amass wealth at the expense of Zambians. He bemoaned that most accountants failed to serve according to expectation because they focused on personal interestat the expense of serving the public. "The role of accountants is cardinal in transforming Africa into a prosperous and fast-growing continent, the Africa we want. For us to achieve this vision, we need to build and put in place the right systems and perform our functions

with integrity, professionalism and hard work. I wish to note that failure from most of our accountants to serve the people is not due to lack of knowledge, skill or competence. But it's because of tided focus on personal interest at the expense of public interests. It is, indeed, disheartening that some accountants have become enemies of the people by involving themselves in financial transgressions in order to quickly amass wealth at the expense of our citizens. Our citizens want to see the taxes that they give to government to be used in national development, which will positively impact on their quality of life," President Lungu said. "Our citizens demand good schools, good health facilities, good roads, safe water and sanitation and access to electricity; among other basic human needs. As people responsible for public finances, how do you, therefore, become a force for the good of our people? There is no doubt that you need to become accountable and transparent. You need to ensure that public resources are targeted towards delivery of public goods and services to benefit the people in your respective countries. It is not enough for you accountants to produce

financial reports, which our citizens cannot understand. Let us, therefore, endeavour to produce simplified financial reports where citizens can appreciate the link between the taxes paid and the goods and services provided by your respective governments." said the PF Не government attached great importance to management. public finance "The theme of the conference if not only appropriate, but also consistent with the public financial management reforms being undertaken in the region. My government attaches great importance to public finance management and the contribution of the East and Southern African Association of Accountants Generals, this is because of its role in enhancing accountability and management of public resources in the region. It is gratifying that Zambia has yet again been privileged to host this very important annual conference after the maiden one that was held in 2010, which was held here at the same venue," he said. The Head of State also implored accountants to raise awareness among citizens to take an interest in financial reports to enable them know

how resources were being utilised. "You need to realise that the manner in which your government uses public resources has an impact on development, iob creation and indeed production. The Zambian government attaches great importance to public financial management to support our national agenda which is the Vision 2030, we have been implementing a special financial public management programme, which is aimed at strengthening the planning and budgeting process. doesn't allow them to be actively involved in partisan politics is because they are supposed to work for all citizens regardless of their political affiliation. Now PF want civil servants to be leaving their offices to go and campaign for them or they would fire them, what kind of reasoning is that? How can you continue disregarding the law in such a manner? Chilangwa was abusing his authority to bully civil servants and it's just a matter of time before such people are held to account for their actions. This is the reason you find that they leave well qualified people and employ PF cadres so that they should be puppets and use public resources for party activities. In Sesheke, there were a lot of Civil Servants; District Commissioners and others,

who instead of being in offices to serve people, they were busy campaigning for PF. But despite using civil servants and state resources, they lost terribly because the people now know what they want," Mucheleka said. He wondered how government could fire Sesheke police officers for allegedly being partisan when the ruling party was encouraging civil servants to be involved in politics. "The law is very clear, it does not allow civil servants to actively engage in partisan politics. However, under the PF, there is serious breakdown of the rule of law and we have reached a level where the PF are breaking the law with impunity. What they don't understand is that sooner than later, there will be consequences for those civil servants who are encouraged to participate in politics. You have seen how they have gone ahead to retire in public interest, national interest, innocent people they perceive to be supporters of the opposition, especially the UPND but themselves are encouraging civil servants to be partisan," Mucheleka said. "But then we have the electoral commission of Zambia which is expected to enforce the electoral code of conduct which is very clear and it completely bars civil servants from participating in active politics, but because we have a useless, a moribund, good for nothing ECZ, it is allowed and we have seen how the PF through minister of home affairs have hijacked the responsibility of running

elections. They have put in the ECZ, commissioners who are PF cadres and some of them are foreigners, how can they enforce the electoral code of conduct?" And Mucheleka said it was laughable for Mwila to claim that Bahati constituency was a PF stronghold. "It is laughable to hear Davies Mwila claiming that Bahati Constitutency is a PF stronghold, which stronghold? In case some people don't know, Bahati shares its boundary with Chipili constituency where Davies Mwila lost an election to an independent candidate, honourable Javis Chabi. He was walloped hands down despite having been a serving minister of home affairs. He failed to convince the people to vote for him despite all the resources and influence, how

then can Davies Mwila be the one to claim that Bahati is the PF stronghold when the constituency neighbouring Bahati rejected him? How can he claim that the PF is popular in Luapula when he was rejected himself by the people there, and he is now secretary general of the PF?" asked Mucheleka. "They are claiming that they love Luapula and that it's their stronghold, how can you claim to love a place as a government with such a high poverty rate? Luapula Province is one of the poorest provinces with the poverty rate at about 80%. Look at the performance of pupils at grade 12, Luapula was the worst performing province last year with 53%, they were at the tail end on number ten. Southern Province was the highest at about 75% pass rate. So how can PF claim that they love Luapula and it's their strong hold, without working towards improving the living standards of the people? And if you check, you will observe that most ministers, former high ranking army officers who have been arrested for stealing state resources are from Luapula, they only care about themselves, they forget the suffering of the people."

We only import cadres to by-elections when PF starts beating us - Mwaliteta

By Mirriam Chabala Lusaka Province UPND chairman Obvious Mwaliteta says Stephen Kampyongo should not share the blame for political violence in the country with opposition parties, saying he has powers to stop political violence as Minister of Home Affairs. When he appeared on ZNBC's Sunday Interview, Kampyongo observed that importation of cadres to areas where elections were taking place was the root cause of political violence in the country, and that the UPND and PF were both guilty of the vice. But in an interview with News Diggers! Mwaliteta argued that the UPND had never incited violence, and that the party would only ferry its cadres to election areas whenever party members had been attacked by PF cadres. "Honourable Kampyongo should not even talk about the opposition! He should talk about PF and his position as Minister of Home Affairs, he's got all the powers. Honestly, if PF cadres are not being loaded with pangas going to Sesheke, why should UPND go and defend its cadres? They won't go there. But it's because PF cadres already know that their youth chairman is there so they need to go and give solidarity and show him that they can beat! So, this is why it happens. But my appeal to my brother, Hon Kampyongo; the people of Zambia have talked too much about his position; they have condemned him here and there, no one talks good about him. Some of us who are friends with him would want to advise him that for once, let him just look upright. He's got all the powers to stop the violence," Mwaliteta said.

"The violence occurring everywhere in Zambia is traumatising people. When you go to Sesheke today, people there are still traumatised with those teargases that they experienced. So, he (Kampyongo) should not go and start firefighting there. He should prevent it, prevention is better than cure. Right now, we have Bahati by-elections coming up, it's up to him to say 'no cadres from Lusaka, Copperbelt, no jerabos will be found in Bahati and no violence will be tolerated, whether from PF or UPND or from any other political party' and there won't be any violence. But the problem is that the people who are supposed to check that there is no violence, when they are asked to stop violence, they are being fired. So, I don't know which people he's going to direct to stop violence. If the violence comes from PF. then they will not do anything because they will be fired for stoping it, and when they are fired, they are being threatened with arrests. So, it calls for self-introspection serious for him as Minister of Home Affairs to ensure that this country is back to peace again." Mwaliteta regretted that UPND and PF never saw eye-to-eye when it was time for elections. "It's not supposed to be like that, we are brothers and there is a Minister of [Religious and] Affairs National Guidance, this Minister was supposed to condemn violence from the word go; starting from their own cadres and also advise the President that: 'don't fire these innocent police officers.' They were trying to fight the violence there. If violence is prevented from Lusaka, Copperbelt, then

you won't see any violence and truly it may be the political will to stop this violence. But there is no political will, these ministers when they go on TV, they only talk about violence to show the country that this is what they are saying. But deep down their hearts, they don't mean it and we are worried. But Kampyongo has got the powers to stop violence at once as Minister of Home Affairs," he observed. And Mwaliteta, the former Kafue PF member of parliament, said UPND looking forward was having violenceto free elections in Bahati. "We don't want this thing where people are just saying: we don't want violence' without action. For us, as UPND, no youth is going to go to Bahati if they don't belong there. Except for senior members who will just go to beef up the campaigns. We are not going to send any youths there. We have youths locally, we have built local structures and that's what we are going to use to do the job. But I want to appeal to Kampyongo to caution his Secretary General. He should tell Davies Mwila to withdraw those words he used that in Bahati they are going to retaliate what happened in Sesheke. And Lubinda says President Edgar Lungu will never meet his UPND counterpart Hakainde Hichilema again since the latter has accused the Head of State of plotting to assassinate him. Meanwhile, Lubinda says the International Criminal Court (ICC) has informed his office that there is no case reported against the Zambian government by one at The Hague. any Speaking during a media briefing, Tuesday, Lubinda that the announced Constitution amendment process would still go ahead even without the participation of Opposition Alliance leaders, warning that they will have missed an opportunity to fix the Public Order Act. This follows the 10-member Opposition Alliances' resolve not to be part of the Constitution amendment process without first having national dialogue. the Lubinda insisted that President Lungu would not sit on the same table with Hichilema to dialogue again. "The question I have for

Do your dialogue, but Lungu and HH will never meet again - Lubinda

fellow citizens, from vou. the President is: 'Would Mr Hakainde Hichilema sit on one table to dialogue with his assassin?' Does he really expect that people will buy the bluff that he is willing to dialogue with President Lungu, one who is attempting to assassinate him? Do the people of Zambia expect that President Edgar Lungu, who has been called an assassin, will be willing to sit with his victim? What will they talk about? Mr Chishimba Kambwili and Mr Milupi are now saying: 'dialogue, dialogue..!' Do they really expect that President Edgar Lungu will simply accept and say: 'thank you for accusing me of attempting to assassinate you, now come, we have a cup of coffee? That is expecting far too much," explained Lubinda. And the minister warned that if the opposition misses its chance to fix the Public Order Act through the Constitution amendment process, it should not complain to the PF. "The ones who have made the loudest cry about the Public

Order Act as a matter of fact, are the members of the Opposition Alliance. We are giving them an opportunity to make that law more acceptable, to make that law meet the aspirations of Zambians. If they do not want to take part, they must not blame it on anybody. We will proceed with the road map, this is the road map that is not leaving anyone behind. We have decided to approach them as individual political parties because they failed to bring any submissions as a collective body through the ZCID. We are giving them a second chance. Now, when we give them the draft Constitution amendment Bill and we give them the draft Public Order Act Bill, it is entirely up to them. There are many challenges that have been identified in the Constitution, not only by the Executive, but the three wings of government. The Judiciary identified some, the Legislature identified others, opposition political party leaders identified some, and we owe it to ourselves, we owe it to future

generations to make sure that we have a Constitution that is less problematic than the one we have, and government has a duty to do it and we will do it!" Lubinda said. "Let me make it clear that we are not in any way curtailing the so-called national dialogue. We are actually encouraging the political parties to proceed with the national dialogue, which is the dialogue for political parties, not government. I sit here as Minister of Justice, I belong to a political party. It is my political party that will be engaged in that dialogue, not me as Minister of Justice. So, government has no role to play in national dialogue, none whatsoever! President Lungu will go to that national dialogue when it is held, as president of the PF. So, we are not saying because of this road map, the national dialogue will not take place, no! We are not intending to replace one with the other. However, we are concerned with the lack of movement on the national dialogue and we cannot hold

back government programmes because people who want to talk are not able to talk." Meanwhile, Lubinda disclosed that there was no case filed against the Zambian government at the ICC at The Hague. "You heard that in response to these allegations, His Excellency the President directed the Ministry of Justice to look into these issues as a matter of urgency. I wish to update the nation that the Ministry has since engaged with the President and the Ministry is aware that there is not a single complaint against Zambia at the ICC. Not only at the ICC, but even at the African regional court, there is no matter pending there affecting the State of Zambia. But again, you will recall that this is not the first time this is happening. You will recall that soon after the 2016 general elections, we were entertained to some drama that the ICC was coming to Zambia investigate allegations to of violence, allegations of

assassination on the part of President Edgar Lungu. The Minister of Justice again wrote to the ICC and they told us that there was not a single matter before them affecting Zambia," Lubinda revealed. And Lubinda warned that Kambwili would be committing another offence if he stopped any member of parliament from participating the Constitution in amendment process. "Yes, the Opposition Alliance may use the arrogance of the numbers that they have in Parliament; they are aware of the fact that the PF alone will not have the two thirds majority and Mr Chishimba Kambwili was speaking yesterday (Monday) at a press briefing on behalf of UPND that all UPND MPs will not participate. Let me make it clear to Mr Chishimba Kambwili that, he is leading the people wrong because there are, among UPND MPs, there are, among independent MPs, who know their duty to their constituents and to their country. And if Mr Chishimba Kambwili is going to stop any MP from participating in their constitutional duty, he will be committing yet another offence, he must be aware of that," cautioned Lubinda.

Don't give PF chance to manipulate already damaged Constitution - HH

By Zondiwe Mbewe UPND leader Hakainde Hichilema says government's threats on the opposition will not work, adding that the alliance will push ahead and report President Edgar Lungu, some high ranking PF officials and four PF cadres to the International Criminal Court (ICC). And Hichilema has charged that Zambians should not give a dishonest group of people like the PF another chance to do further damage to the Constitution through the amendment process. Recently, the Opposition Alliance announced that it had decided to report President Edgar Lungu, some high ranking PF officials and four PF cadres to the ICC for various crimes against humanity. Chairperson of the Opposition Alliance Charles Milupi at the press briefing that the alliance's investigations had revealed that the ruling party had assembled a group of youths whose sole purpose was to perpetrate violence - and went ahead to name the accused. But Special Assistant to the President for Press and Public Relations Amos Chanda said President Lungu had instructed Justice Minister Given Lubinda to invite the ICC and Amnesty International to come and examine the Opposition Alliance's criminal allegations against government and PF officials. Speaking to journalists at the Lusaka Magistrates' Court where he went to attend the case in which his supporters are accused of being in possession of offensive weapons during the Chilanga by-elections, Tuesday, Hichilema charged that government could call whoever they wanted but the process would not stop. He added that the alliance had actuallyadded more names to those who would be reported to the ICC. "The guilty are afraid. Let him call whoever he wants, it does not stop our process. Our process goes on. By the way we have a few more names we have picked from further information who we are

going to include on that list. May I take this opportunity to announce that it will not just be ICC, it will be other bodies that are even quicker that we are going to submit a report of this human rights breaches. For us whether he calls them here or not does not matter. Our process continues," he said. "But threats will not work, how many times have we been threatened? How many times have they attempted to take us out of this

world by eliminating us? But the owner of life is him upstairs. Only God gives life and takes it away." Hichilema further charged that the PF government had already manipulated the Constitution and did not deserve another chance to make things worse. "If you look at the original document or draft of the Constitution that the late President [Micheal] Sata put together, the PF are responsible for manipulating that draft. They hoodwinked bonafide and genuine members of parliament who took or accepted the PF view on face value. And PF, once they were granted the opportunity to amend the Constitution through a Constitutional amendment

bill which requires two-thirds majority, in now making specific changes to clauses, the PF manipulated the Constitution. That's why we have many lacuna lot grey areas. They only brought clauses that they believed favoured them as a political party," he said. "The lesson we learn from there is that we should never allow a dishonest group of people like the PF, another chance to do further damage to the Constitution. We will not give the keys. The key is the two-thirds majority to table the Constitutional amendment bill on the floor of the House because the PF does not have the two-thirds majority. The key is shared by us. [Given] Lubinda can do what he wants [but] he will not have the ability to table that motion in the House. They were responsible for the mess [and] they want to do further damage to the Constitution." Meanwhile, Hichilema charged that the PF government avoiding the dialogue process so that they could use the Constitutional amendment process to deceive citizens. "By the way, the Constitution is not a product of PF or UPND, it should be a product of the people of Zambia. Parliament itself is a creation of the Constitution, a creation of the people's wishes through the Constitution. So Parliament cannot be given the delegated authority to make that decision. Let the people make that decision through the dialogue process. So they are trying to circumvent the dialogue process so that they can now use Constitutional questions hoodwink journalists, to citizens. They will not have that opportunity this time, we are wiser than before," said Hichilema.

Govt calls for increased refugee funding from donors

"Critical needs range from food, shelter, as in transit centres in Makeni (Lusaka)

By Mirriam Chabala Government, through the Ministry of Home Affairs, has appealed for increased funding from humanitarian and development donor countries to support the refugees operation across the country in 2019. Commissioner for Refugees in the ministry, Abdon Mawere, said in a statement that although there had been no major influx of refugees lately, the number of refugees in Zambia had gone up in the past two years with the number of new arrivals averaging 700 asylum seekers per month, fleeing the Democratic Republic of Congo (DRC), Burundi, Somalia and other countries. Mawere stated that funding was required by the government, humanitarian and development actors like UNHCR and its partners, who include United Nations (UN) agencies as well as local and international Non-Governmental Organizations (NGOs), to provide critical humanitarian assistance to the refugees, as well as the host communities.

infrastructure, logistics, education, health and livelihoods in the newly established settlement of Mantapala - in Nchelenge, Luapula Province as well as the two old settlements of Meheba and Mayukwayukwa, plus Lusaka which also hosts over 16,000 of refugees and asylum seekers. So far, January, 2019 alone, a total of 1,162 refuges and asylum seekers have been received in Zambia comprising 1,056 from the DRC, 76 Burundi, 28 Somalis and the rest from other countries. In 2018, Zambia received a total 9,371 refugees, with the majority coming from the DRC - 7,978 and 1,036 from Burundi. The rest were from different countries," Mawere explained. "Zambia currently hosts 77,370 persons of concerns (51,371 refugees, 3,173 asylum seekers and 22,826 former refugees). The refugees and former refugees are hosted in Meheba, North-Western Province, Mayukwayukwa, in Western Province and Mantapala, in Luapula Province, as well

and Northern and Luapula Provinces. The 2019 inter-agency Refugee Response Plan (RRP) for all humanitarian actors in Zambia's Congolese response has a budget of US\$77million support up to 72,000 Congolese by the end of the year." Mawere thanked the donors for their support towards refugees in Zambia and called them to increase their funding as he called upon others to come on board. "UNHCR in Zambia has a budget of US\$30.02 million, with US\$1.14 million funded by the European Union (EU) and \$500,000 received from the Government of Japan. The Government is grateful to the two donors and appreciates the continuous support of other traditional humanitarian and development donors, but I wish to call upon them to increase their contribution to assist us to fulfill our international obligation to give asylum to those who need it" appealed Mawere.

Water - A Resource under- utilized

Global Hydropolitics

It's a notorious fact that even though 70% of the Earth surface is water,less than 1% is drinkable and globally 780million people have no access to safe drinking water.

In the new millennium many nations face problems ranging from pollution to scarcity, and the politics of water resources have become even more complicated.We should however be prepared for a new dimensions in what is now called the 'impending water crisis' and 'Water wars' also known as the 'New Oil Wars'.

According to the Atlantic Report ; By 2025, scientists predict that one in five humans will live in regions suffering from water scarcity,areas with insufficient resources to meet water usage demands. Many analysts and World leaders have predicted that pressure on water resources will spark wars in the coming years.Back in 1985, Boutros Boutros Ghali said, "The next war in the Middle East will be fought over water, not politics," Kofi Annan said in 2001: "Fierce competition for fresh water may well become a source of conflict and wars in the future."Secretary General Ban Ki Moon said in 2007: "The consequences for humanity are grave. Water scarcity threatens economic and social gains and is a potent fuel for wars and conflict."

As it is today,we are witness to tensions between Egypt and Ethiopia over the US\$4Bn Renaissance Mega Dam on the River Nile.In the Middle East Israel is restrictIng Palestine's access from the River Jordan.The India and Pakistan dispute over the Indus River system and the water riots in Cape Town-South Africa are all but examples of the 'New Oil Wars'.According to one study carried between the 1950's and the year 2000,It revealed that there were over 1,800 water related international conflicts.

Zambia - Water Resources.

Unlike many other countries in the region Zambia



to the effects of climate change.During 2006-2010, the government invested US\$ 8.95 million (in constant 2010 US\$) on average per year on waterrelated infrastructure and programmes. Over 80 percent of the government expenditure priority was channeled into water supply and sanitation (57.4 percent) and river development (24.7 percent). During the same period, official development assistance (ODA) gross disbursements amounted to US\$ 47.78 million on average per year, with priority on water supply and sanitation (68.7 percent). Over the period 2006 to 2010, the Government of Zambia's water-related investments accounted for an estimated 0.6 percent of total government expenditures. This is way below the acceptable threshold also considering that we are utilizing as a country less than 1.5% of our renewable water resources.

Zambia's Challenges - Renewable Water Sector

The Democratic Party have realized that our deficiency in developing an Renewable water resource system is as result of ; (i) the country not being able to challenge its scientists to solve some water-related developmental issues, (ii) research not receiving adequate attention and funding, which has led to policy and decision-making remaining uninformed, and (iii) research and development gaps. and drivers on the country's surface water and groundwater resources.

* Seek solutions to some existing societal challenges, including those that utilize indigenous knowledge.

What the Democratic Party will do:

The importance of managing our water resources can not be overemphasized. The very existence of mankind centers on this very important and nearly irreplaceable resource.International sales for water and ice exports by country amounted to US\$1.3 billion in 2017. The overall value of exported water and ice rose by an average 36.2% for all exporting countries since 2013 when water and ice shipments were valued at \$935.7 million.From 2016 to 2017, the value of globally exported water and ice increased by 18.7%. Among continents, Asian countries generated the highest dollar worth of exported water and ice during 2017 with shipments valued at \$746.1 million or 58.5% of the global total. In second place were European exporters at 20.3% while 12.2% of worldwide water and ice shipments originated from Oceania led by Fiji and New Zealand. North American suppliers accounted for 8%.Smaller percentages came from Latin America excluding Mexico but including the Caribbean (0.7%) then Africa (0.2%). Therein lies the great opportunity for Zambia!

has more than adequate water resources, although during the dry season water resources may be scarce, especially in the southern part of the country. The annual rainfall averages between 1400 mm in the north and gradually declines to 700 mm in the south. The country is rich in rivers, such as the transboundary Zambezi and lakes Tanganyika, Mweru and Kariba. It is estimated that only 1.5% of the annual renewable water resources are being used at present.

The water sector reforms in 1991 prioritized action in water supply and sanitation, which resulted in improved institutional setup, as well as in planning and support from the government and various partners. There is now increasing attention to development of dams and irrigation as government advances efforts to enhance food security and adapt We as the Democratic Party have further identified that there is inadequate research being undertaken in the country to:

* Determine the impact of land use changes in areas of rapidly growing populations on the country's surface- and ground-water resources.

* Assess capacities of wastewater treatment plants in the country's major cities (environmental audit of the treatment plants).

* Assess the amount of available water resources in the country, especially groundwater.

* Assess effects of climate change scenarios

As the Democratic Party,whose main agenda is to see a drastic shift from the Copper Mono-Economy,we see this as the opportunity.The Democratic Party will;(i) support research activities in the acquisition of water data through continuous monitoring, (ii) analyse and assess data and information,(iii) provide relevant feedback to decision makers and stakeholders,and (iv) Invest heavily in Research and development of this resource with a deliberate plan of making it an industry and major forex-earner.

Although the State did not object to the application for bail, it prayed that Kambwili's bail should not be in his own recognisance but cash.

"As much as the State is not objecting to the application for bail, the prayer from the State is

that the conditions which this court may impose should be such conditions that is able to secure the attendance of the accused person. Our prayer is that it (bail) shouldn't be on his own recognisance," said Mwanza.

In his ruling, magistrate Chitalu granted Kambwili K3,000 cash bail and ordered him to provide two working sureties of fixed abode and residing in Lusaka, who would be bound in the sum of K10,000, in their own recognisance.

Addressing reporters and his supporters after satisfying bail conditions, Kambwili said he was ready to die on behalf of the people of Zambia.

All I can say is that they will try to intimidate me but they will never manage. I want to tell them, you can arrest me as so many times as possible, deny [me] bail but you are dealing with the man uwakosa mukati nakunse. Ine nalishimpula mfwaya fye ukwakusha umutwe. For the sake of this country, to save this country from these kabwalas, these crooks, these failed projects, I'm ready to die just like Jesus died for the people. It is up to you the people of Zambia to know. Me, I was merely speaking for you that 'these jobs are for Zambians not for any foreigner'. Then I should be called that I'm

being racist?" he wondered. "How can you allow in a country where so many youths roam the streets, you are beating street vendors because they have no jobs, now you are getting the jobs that they are supposed to get, you are giving them to foreigners? tell you, the positions that you are enjoying are not permanent. Amos has taken over the presidency - Milupi

By Thomas Mulenga President Edgar Lungu's Special Assistant for Press and Public Relations Amos Chanda's insulting language shows that he now thinks of himself as another president of Zambia, says Alliance for Democracy and Development (ADD) leader Charles Milupi. And Milupi says Chanda was threatening to take him to court only because he wanted to shield himself from the acts of violence that occurred in Sesheke. Commenting on Chanda's move to sue Milupi over what he termed as patently false allegations involving the former's alleged involvement in the

violence that erupted in Sesheke,

Milupi, who is also chairperson of the Opposition Alliance, said it was unfortunate that a person who was representing the Head of State would insult other citizens in the manner he was doing. Milupi argued that Chanda had

now taken over the Presidency and blocked the Head of State from holding regular press conferences.

"From 1964, we have had so many people who served as presidential press aid, and they did their job the way it should be done - advise the President on issues relating to the press. But in this case, we have seen a situation where this particular person (Chanda) has taken over the role of President!

The President is even shielded from the media! So, it is him (Amos), who is President. Now, we would expect that people holding such high profile jobs will be civil in their discourse with the public. If someone did not put a name to those things said by Amos, people would think that those words were coming from us in the opposition because maybe because we are not trained in the way we do things, but those people are trained, they are supposed to be trained. He is holding public office and when he speaks, he speaks on behalf of the President of the whole nation and the international community are also listening," Milupi said in an

interview, Monday.

"To have a person representing the President with such language is most unfortunate and it shows the level of people we have in public offices and it's up to the people to judge if these people are suitable for those positions. What gives someone the audacity to use such language on fellow citizens? Is it the wealth that they have? Is it the power that they have? And if it's the wealth where is it from? If it's the power, which power are they exercising? Have they hijacked power from the President? Are they now considering themselves as presidents? These are very serious matters."

Milupi said contrary to Chanda's insults on the opposition alliance leaders, that they had brains the size of a rat, leaders were actually intelligent and restrained from insulting.

"But it's unfortunate, the people that he is saying have got rat brains, they are very intelligent people. If you look at their language in their press statements, it is very civil. We don't insult anybody, you will never hear me insult Mr Lungu or even Mr Chanda himself because we gain nothing from insulting. We shall criticise their policies, we shall criticise their action or lack of action, but in a manner that even a child will listen to us without being offended, that big people are insulting each other,"

Milupi observed.

And Milupi said Chanda only threatened to drag him to court because he wanted to shield himself from the acts of violence that occurred in Sesheke.

"The courts are there to settle disputes between or among citizens; they are not there to be used to threaten others. So, let Mr Chanda take me to court if he wants to take me alone or if he wants to take the opposition alliance members, because that statement was issued by the alliance. But it's up to him if he wants to take me as an individual, let him go ahead! And for him to react in such a manner and start issuing threats, it means that what happened in Sesheke was not good. So, even if he was not there, where does his statement of distancing himself leave those who were there? Where does it leave the President, the Political Advisor to the President (Kaizer Zulu) and other government officials who were there?" Milupi wondered.

President Edgar Chagwa Lungu has nullified the expulsion of the two Patriotic Front (PF) senior members of Petauke District in Eastern Province who were expelled by Provincial Chairperson Andrew Lubusha on Sunday for allegedly breaching the party constitution.

Lubusha expelled Emmanuel (Jay Jay) Banda and Elias Daka (Eliboma) in a letter dated February 20, 2019, alleging that the expulsion was arrived at after a central Committee meeting and instructions by party secretary general Davies Mwila. The PF secretariat however, said Lubusha's actions had no blessing of the top leadership in Lusaka.

And PF media director Sunday Chanda confirmed to News Diggers that President Lungu had decided to quash the decision to expel Banda and Daka, on grounds that the two had not been given an opportunity

to be heard.

"The two gentlemen have been accused of causing disharmony in the party and the Secretary General directed that disciplinary action be taken against the two and of course the instruction was that they needed to be suspended from the party. But what we saw was that the Provincial Chairperson decided to expel them. Considering the fact that the two colleagues deserve to be heard, the party

decided to quash the expulsion and allow the two gentlemen to exculpate themselves," said Chanda.

Meanwhile, Sources close to Daka, who is Lubusha's only challenger in the upcoming intra party elections for Eastern Province told News Diggers that the Chairman had been ordered to make a personal announcement on all local radio stations in the region, regarding the President's directive.

The reasons that are being advanced by Cabinet Ministers as grounds for the removal of four Sesheke police officers from the Service are confusing. Initially, we were told that the Police Service Commission, acting in the name of President Edgar Lungu, found it fit to retire the officers in "national interest". That's all! No reasons were advanced, and under this presidential discretion, there is no requirement for giving any reasons before retiring anyone.

So, the Commission looked into these things and made a decision to dismiss the officers."

Cannabis use in teens linked to depression

Parents should not be complacent about the risks of teenagers using cannabis, experts are warning.

UK and Canada researchers said they had found "robust" evidence showing using the drug in adolescence increased the risk of developing depression in adulthood by 37%.

They said the findings should act as a warning to families who saw cannabis use as part of the growing-up process. The team added that the developing brain was particularly susceptible.

The researchers - from University of Oxford and Montreal's McGill University - said cannabis use in the young was an "important public health issue", particularly given that cannabis available today tends to be much stronger than it was previously.

Around one in nine young adults and teenagers use the drug each year in England and Wales.

Report author Prof Andrea Cipriani conceded some parents had a relaxed attitude to the drug, but added the evidence was clear.

"This is important information for parents and teenagers. The risk is modest, but it can have a devastating impact.

How risky is cannabis? This is the first time the actual risk has been quantified in this way.

The team looked at 11 previous studies, covering more than 23,000 young people, the journal JAMA Psychiatry reported. Young people who had already shown signs of depression or had a family history of the condition were excluded.

It found cannabis use before 18 increased the chance of an individual developing depression in young adulthood - defined as before the age of 35 - by 37%.

In terms of numbers that means around one in 14 cases of depression in that age group - around 60,000 in the UK - could be attributed to drug use in the teenage years. The study also looked at whether there was an association with anxiety and suicide attempts.

There was an increased risk of anxiety developing in young adulthood, but it was not considered statistically significant.

Meanwhile, those who used cannabis in their teenage



years were three times more likely to try to kill themselves - although the data on that trend was not considered robust enough to draw a firm conclusion. So is this proof? No. The researchers were unable to prove cannabis use was definitively causing depression.

This is because of the figures they found, but also what is known about the impact cannabis has on the developing brain.

Evidence has suggested that the drug affects the parts of brain that govern rational and emotional thinking as well as serotonin levels that influence mood.

To prove the link, trials would have to be conducted on young people - something that will never be done because it is unethical.

King's College London psychiatrist Prof Sir Robin Murray said the research could not be considered conclusive, but acknowledged the findings were "probably correct".

He said the risk of developing depression was smaller than what has already been established for schizophrenialike psychosis.

He also said it was likely that any risk would be also down to the amounts of cannabis consumed and the strength - something this study was unable to unpick. BBC

The EU, US and African Union have all expressed concern about delays and logistical problems with voting on Saturday, but no independent observers have suggested fraud.

Mr Buhari, a member of the governing All Progressives Congress (APC) party, is seeking re-election but faces a strong challenge from Mr Abubakar. Each party says the other is

working with the Independent National Electoral Commission (Inec) to influence the vote, which was initially scheduled for 16 February but delayed at the last minute.

She opened her set with "Be Alright" and "Break Free." At the event, she wore an oversized sweater that read, "One Love Manchester."

During the May 2017 attack, the 25-year-old star was unharmed physically, however, she revealed that she had symptoms of PTSD after the bombing.

"I hate...yeah...admitting it but it very much is," she told British Vogue after being asked if the dizziness and anxiety she faced were signs of PTSD. "That's what everyone was telling me. It's hard to talk about because so many people have suffered such severe, tremendous loss."

The outbreak has killed 546 people since July, according to the Congolese health ministry.

Most of the cases since the start of the year have been in Katwa, which is close to the border with Uganda.

Three volunteers for the Congolese Red Cross were attacked as they helped with the burial of an Ebola victim in eastern Congo in October. Two months later, political protesters ransacked a nearby Ebola isolation center.*Reuters* She added, "But, yeah, it's a real thing. I know those families and my fans, and everyone there experienced a tremendous amount of it as well."

We're not out to kill Kepa says Sarri

Chelsea manager Maurizio Sarri said on Tuesday goalkeeper Kepa Arrizabalaga had made a big mistake refusing to be substituted during the League Cup final but he was young and the club's intention was not to "kill him".

Sarri -- speaking on the eve of their Premier League clash with third-placed Tottenham Hotspur -- reiterated the board's ruling that Kepa be fined a week's wages for the episode.

Kepa, the club's record £71 million (\$93 million) signing from Athletic Bilbao, refused to leave the field to be replaced by Willy Caballero.

Sarri then stormed off down the tunnel in anger before returning -- Chelsea eventually lost to City on penalties.

"I spoke with the goalkeeper, with Kepa, of course," he said. "Then we spoke altogether, because he said sorry to the technical staff, but it was not enough.

"Then he said sorry to his team-mates, to the club.

"I think he made a big mistake, but we need to be taller. We don't want to kill him. So there is a position from the club.



"For me the situation is finished. He is a young player (24), he made a mistake, but stop."

Sarri, though, would not confirm that Kepa would be between the goalposts against Spurs.

It is a pivotal match not only for Spurs and their battle for the title but for Sarri's side's three way tussle with Arsenal and Manchester United for the fourth and final Champions League spot.

"I have to decide, maybe yes, maybe not," said the 60-yearold Italian.
