The kwacha has depreciated against major currency convertibles to breach the K12 per dollar psychological barrier for the second time in three months. According to financial market players, the kwacha breached the K12 psychological barrier per dollar to trade above K12.00 on account of a continued imbalance of demand and supply of dollars on the local market, with correspondingly limited supply of the greenback. The local unit was seen trading at a market average of K11.99 and K12.04 by close of business, Monday, for bid and offer respectively, according to the Bank of Zambia, compared to trading below K11.90 per dollar one month ago. The last time the kwacha depreciated to hit the K12 per dollar barrier was on December 3 last year, where it traded at an average K11.77 and K12.00 for bid and offer respectively ahead of the Festive season. "Friday's trading session saw the USD/ZMW currency pair open the day trading at K12.03/K12.08 similar from the previous day. However, by noon, the currency pair was seen being quoted K11.97/K12.02. Despite the movement, most buyers were cautious as they were hoping for a rebound in the local unit. Most corporates on the buy side are still trading the currency pair

cautiously as they hope the local unit will rebound below the \$1/12.00 psychological barrier," Cavmont stated in a market report issued, Monday. "Current trends seem to indicate market activity is likely to remain on the low side should demand and supply levels remain insignificant." And FNB Zambia stated in its daily treasury newsletter released, Monday, that the local unit's performance is likely to remain weak as the first quarter comes to a close. "The local unit last weak traded on a bearish note. This trend is expected to continue, owing to an imbalance between the demand and supply of dollars. With Zambia being a net importer, demand for the greenback exceeds supply. We have not seen dollar flows coming from foreign investors, which has also contributed to the weak kwacha. We are of the view that the local unit will trade on the back foot today (Monday), most likely in the range of K12.00/12.05. There is very little event risk at the moment to drive the market in either direction," stated FNB. A check around some bureaus in Lusaka found the kwacha had breached the K12 per dollar mark by close of business. The local currency traded at K12.09 and K12.15 per dollar for bid and offer respectively at Ace-FX Bureau, while Golden Coin Bureau, Cairo Road branch, quoted the local unit at K11.92 and K12.15 for bid and offer respectively.

Mealie meal prices may still not reduce if the cost of maize from the private sector remains high, says the Millers Association of Zambia (MAZ). But the Association has welcomed government's move to lift the ban on mealie meal exports and have expressed willingness to work on ensuring the initiative is well-regulated to help the country tackle rampant smuggling of the commodity. On Sunday, Agriculture Minister Michael Katambo announced the

reduction in fuel prices last week, would eventually lead to lowering mealie meal prices, MAZ president Andrew Chintala explained that prices of the commodity may still not reduce if the cost of maize from the private sector remains high. The national average prices of the staple commodity have been stable, but have steadily increased to a one-year high, with a 25Kg breakfast bag now costing an average K93.36 per 25Kg breakfast bag by last month from K69.72 for the same quantity one year prior, according to Central Statistical Office (CSO) data. "Obviously, we are trying, as millers, to cushion that impact on the consumer. And we hope that if we can maximize the exports, we will be able to stabilize the local prices so that our consumers can pay affordable prices for the produce; we will monitor the trading activity and ensure that we keep checking and strike a balance where possible. For now, I can only say that if maize

prices will remain where they are, we can predict stable prices going forward," Chintala told News Diggers! in an interview. "But if there will be a movement in terms of maize pricing, it's a chain reaction. But for now, we can predict stable prices going forward." When asked if the enhanced accessibility of maize from grain traders, in addition to subsidized Food Reserve Agency (FRA) maize, would impact on mealie meal prices, he pointed out that maize prices from the private sector remained costly. "Yes, that is the case. But it's a very delicate and interesting transaction. You can't shy away from the fact that the price that is being offered in terms of the maize that is being offloaded from the private sector is on a higher price as compared to the maize from FRA. We are saying, there has to be some kind of leverage whereby you take the local market as a priority and then the export market is just secondary," he explained. "There was a concern and we had

to facilitate for maize to be released to millers on the Copperbelt, but a situation has moved in, even to Lusaka, some of the millers are having difficulties; this will improve the supply of the commodity, but you can't run away from the fact that there's also a price implication." But Chintala, who is also Mpongwe Milling corporate affairs manager, hailed government's lifting of the ban on mealie meal exports as a progressive measure that would help millers capitalize on the export market, especially the DRC. "In terms of the appetite to be able to participate, I must say all the millers will be well positioned to able to participate in the export market. But what would vary is the margins in terms of what you are able to buy and export. We (Mpongwe Milling) have the muscle, but there are others who would not be able to be able to do it at a larger scale," said Chintala. "We will definitely take advantage of this. The market there and is the appetite is so huge across (the Kasumbalesa Border) and we just need to scale-up. So, we are quite keen and more than ready to work with government and ensure that the export is managed properly to ensure that trade is encouraged in a rightful manner; there's been rampant exports of the commodity illegally. Now that this announcement has come, it's going to curb the illegal trade of the commodity."

interlocutory injunction against him, saying it was not necessary to restrain him from further issuing statements in relatio`n to the matter because Mumbi would not suffer any irreparable damage or injury. Kambwili further said it was not necessary for the Court to restrain him because Mumbi also defamed him. He said the words Mumbi complained of were not false and, therefore, a fair comment. But in her reply filed on February 28, Mumbi opposed to Kambwili's defence on the premise that the words complained of could not be said to be a fair comment regarding her character in the eyes of rightthinking members of society.

She stated that the damages that Kambwili had caused on her character could not match any monetary compensation. "The assassination of my character through the issuance of defamatory statements by the defendant against me cannot be adequately compensated through an award of damages. If anything, the value of my character cannot match any monetary compensation that I may receive in this case and I am advised by counsel that it is widely accepted by the Court that good reputation should always be protected through injunctive relief," argued Mumbi. Mumbi stated that she was entitled to injunctive reliefs because Kambwili had already admitted

publishing the alleged defamatory statements against her and had shown the propensity to continue with the publications based on his assumption that he was making a fair comment against her character. She added that it was in the best interest of justice for her to be granted injunctive relief in the matter, otherwise she would suffer irreparable injury to her good reputation.



11 apply for adoption on PF ticket in Roan

Eleven candidates have so far applied for adoption on the Patriotic Front ticket for the Roan parliamentary by-election. Last week, PF Secretary General Davies Mwila invited applications for the Roan parliamentary seat following Dr Patrick Matibini's declaration of Chishimba Kambwili's seat as vacant. "Applications for adoption as parliamentary candidates for Roan constituency: Applications are hereby invited from bonafide registered members of the Patriotic Front wishing to contest the Roan constituency by-election whose polling date shall be announced by the Electoral Commission of Zambia (ECZ). Applications should be submitted to the respective Constituency Committee with copies to the district and provincial committees and the secretary general. Applications should be accompanied by application fees

that should be paid to the party organs as stated below: (i) Constituency Committee K500; (ii) District Committee K500; (iii) Provincial Committee K500; and Secretariat K500," stated Mwila in the advert placed on one of the daily newspapers. Mwila had further advised the provincial committee to conduct interviews of the applicants by Tuesday and report to the Secretariat by Wednesday (today). "All applicants for Roan constituency should reach the constituency and district committee by Saturday 2nd March, 2019. The Constituency Committee shall meet to interview the candidates on Sunday 3rd March 2019 in Luanshya. The Luanshya District committee shall interview the candidates on Monday 4th March 2019 and the Copperbelt Provincial committees shall conduct interviews on Tuesday 5th March 2019 in Ndola District. The

Provincial Committee report should reach the Secretariat on Wednesday 6th March 2019," stated Mwila. And according information obtained from the PF provincial structures, 11 people, among them 10 men and one woman, had so far applied for adoption as of Monday. Those that applied include: Chenjelani Maunda, a miner at CLM Baluba, who is also PF Lumumba ward chairman in Roan constituency: Mwape Musonda; and Mumba Desire Mulewa, a councillor of Roan. I insulted Lungu because govt didn't employ me - Teacher

By Zondiwe Mbewe Lusaka magistrate Sylvia Munyinya has sentenced a 27-year-old teacher of Samfya district in Luapula Province to two years imprisonment with hard labour for defaming Lungu. President Edgar The Court has further fined the 27-year-old K4,500, in default four months simple imprisonment, for being in possession of obscene materials. In this matter, Enockson Banda was facing four counts of defamation of the President and being in possession of obscene materials. Particulars of the offence were that between April 1 and June 30 last year, Banda, with intent to bring the name of the President into ridicule, published defamatory statements. Further on the same dates, Banda had in his possession obscene materials, including pictures tending to corrupt morals. Banda had initially denied all the charges in the matter last year and trial had commenced but he had, however, changed his plea on Friday last week when he admitted all charges. The matter came up, Monday, facts and sentencing. for

Facts in this matter were that on 18 April, last year, Chanoda Ngwira, a PF sympathiser, opened his Facebook account and came across a page called 'ZNBC Top Stories' where a picture of the Republican President was attached to another picture with a skull which had faecal matter with words saying 'this is the only thing that occupies his head'. Ngwira further saw a picture of dogs and chickens having sex and words saying 'so even Edgar Chagwa Lungu f**ks dogs style'. It was at this point that Ngwira decided to report the matter to the police and Banda was later arrested. When his phone was searched, a lot of obscene materials were found. When he was asked on the insults, Banda said he was annoved because he was not employed by government as a teacher. The accused was formally arrested for the offence and the matter taken to court but in the process of trial the accused turned his plea and admitted the charges. When the court asked him whether the facts were true and correct, Banda responded in the affirmative. In mitigation through his lawyer, Banda asked for maximum

leniency saying he was of a youthful age and also a family man with a two-year-old child. He said had used the time he was in custody from June last year until November 2018 when he was granted bail, to reflect on his actions. Banda added that he had realised that what he did was wrong and promised to be a law abiding citizen. He said he was a frustrated youth who had been affected by the harsh economic times because he graduated in 2015 but had not been employed in government whereas some of his colleagues who had completed in 2017 had been employed. "To today, I'm haunted by my actions and I have imprisoned myself psychologically. I promise that I will be a law abiding citizen and will be an ambassador of peace and will respect each and every citizen," he said. However, magistrate Munyinya sentenced him to two years in imprisonment with hard labour for Defamation of the President and fined him K4,500 for being in possession of obscene materials. "I have considered the mitigation. In count one, I hereby sentence vou to two years imprisonment

with hard labour. In count two, I sentence you to two years with hard labour. In count three, I sentence you to a fine of K4,500 in default, four months simple imprisonment and the sentences will run concurrently," she ruled. Meanwhile, magistrate Munyinya has given Chilufya Tayali a benefit of doubt in the matter where he's facing seven counts of contempt of court and publishing defamatory statements against a Lusaka citizen, Edward Sichali, warning that in the next sitting she will proceed to hear the matter with or without the defence.

Tayali is alleged to have accused Sichali of being sponsored by UPND president Hakainde Hichilema to hold a protest at the University of Zambia which saw the death of a fourth year Education Student Vespers Shimuzhila last year. Tayali had pleaded not guilty to the charges in November last year but trial has not yet commenced. And when the matter came up for possible commencement of trial before magistrate Munyinya, Monday, the complainant's lawyer Mulambo Haimbe informed the court that the defence counsel

had an application to make. The defence then applied for adjournment on the premises that the lawyer who would handle the matter, Jonas indisposed. Zimba, was Magistrate Munyinya then adjourned the matter to April 1 at 12 hours, warning them that at the next sitting she would hear the matter with or without the defence. "For today I will give the defence a benefit of doubt. This is the last adjournment. Next time with or without the defence I will proceed to hear this matter," said magistrate Munyinya.

Lusaka man in court for stealing sugarcane

By Zondiwe Mbewe A 23-year-old man of Lusaka has been dragged to court for allegedly stealing sugarcane worth over K500 from Malcolm Kafue Sugar. This is a matter in which Daniel Malambo is facing one count of theft contrary to section 272 of the penal code chapter 87 of the laws of Zambia. Particulars of the offence allege that on February 14, 2019, in Lusaka, Malambo stole sugarcane valued at K560, property of Malcom Kafue Sugar. When the matter came up for allocation, Tuesday, Chief Resident Magistrate Kennedy Mulife allocated the matter to Magistrate Rachel Mwansa in the absence of the accused. And a 16-year-old juvenile has appeared in the Lusaka Magistrates' Court for stealing curtains, bed sheets, among other items. In this matter, the juvenile is charged with one count of house breaking and theft, contrary to Section 301 (a) and 272 of the Penal Code chapter 87 of the laws of Zambia. It is alleged that on February 16, this year in Lusaka, the juvenile broke into the dwelling house of Charity Mulenga and stole a laptop bag, a bucket, three curtains, bed sheets, three identity cards and K500 cash, all valued at K2,100 from the said Charity Mulenga. The matter has been allocated to Magistrate Mwaba and the accused is expected to take plea soon.

Govt in panic after supplying toxic Chinese drug to hospitals

By Mirriam Chabala The Ministry of Health is in panic mode, making frantic efforts to withdraw a Chinese manufactured drug which has turned out to be toxic on patients in various hospitals across the country. Minister Dr Chitalu Chilufya confirmed the case to News Diggers but said a full statement would be issued once the technocrats carry out a thorough investigation on the supply. His Permanent Secretary Dr Kennedy Malama has issued a circular, advising all health facilities, provincial medical administrations and district health directors to quarantine a drug called "Gentamycin Sulphate BP injection" manufactured by CSPC Ouvi Pharmaceutical Company Limited in China, after receiving reports of its devastating side effects on patients from the Zambia Medicines Regulatory


Authority (ZAMRA). ZAMRA reported that the Gentamed injection batch no. S MD180107 and 180108 led to severe headaches and vomiting in patients who were administered the drug from various health facilities across the country. "Zambia Medicines Regulatory Authority has received reports of adverse reactions [such as] severe headache and vomiting from various health facilities across the country following the administration of the above stated product. In this regard, the ministry directs all institutions to quarantine the stated batches with immediate effect, in order to allow the Authority to carry out further investigations. Institutions will be guided on the next steps after the investigations are concluded," stated Dr Malama in his letter dated March 1, 2019. Dr Chilufya declined to

take further questions from this reporter, apart from confirming that the ministry was aware of the situation and a statement would be issued. "A statement will be issued on that subject. I am not saying anything else, a statement will be issued. But for now I would rather technocrats do there work then a statement will be issued," said Dr Chilufva before hanging up the phone conversation. Meanwhile, Pharmaceutical Society of Zambia president Jerome Kanyika accused the supplier of delivering drugs which did not match with the samples presented when bidding for the supply tender. "What happens when someone is bringing their samples to be registered in this country, they bring the best of their samples. But in the long run as they win tenders or contracts, you find that they change in the way they do things.

Like where someone says 'in this tablet, there is this amount of drugs', but then as they win the tenders, they bring a tablet that does not consist the amount of drugs that they talked about when registering. So what happens once those people bring their products in the country and they are allowed to be in the Health institutions, the Zambia Medicines Regulatory Authority is mandated now to do what is called Pharmacovigilance checking. Meaning they are checking how the medicines are working, and if those medicines are giving people any side effects or not," Kanyika explained. Further, Kanyika hailed ZAMRA and the Ministry of Health for taking quick action after identifying the problem with the affected drug. "So in that process that's when ZAMRA now tells what exactly the drugs contain and that problems truly lies with the supplier of a particular drug. So in this case, the one who is liable to whatever may happen is the supplier of that medicine. And we need to

appreciate ZAMRA for being proactive in this matter and notifying everyone. As I am speaking to you right now, all our members in these government institutions have already quarantined that medicine, they are not using it on people. They are using alternative drugs because this particular one is still under investigations," said Kanyika. "ZAMRA should continue to be proactive the way they have shown to be proactive in this matter. And to the suppliers, let's make sure that they supply the drugs that they bring for testing unlike them trying to alter what they bring in when registering the medicines. As for pharmacists who are accessing this medicine, please let's quarantine everything so that we protect the general public, as our basic role is to protect the general public and every person that comes in the public health institutions. So it's kudos to ZAMRA and the Permanent Secretary for being proactive in notifying the general public within a short period of time. We need to appreciate

ourselves for that good work that has been done." In December 2019, the Zambia Pharmaceuticals Business Forum (ZPBF) raised a red flag against the Ministry of Health for exclusively awarding tenders for the supply of drugs to companies of personal interests, against the public procurement guidelines. ZPBF wrote to Ministry of Health Permanent Secretary, demanding the cancellation of tender number MoH/ SP/016/17, among others, which was not subjected to open and inclusive bidding. ZPBF listed some of the questionable tenders as: "Tender for the supply of essential medicines, tender No MoH/SP/O16/17 with an estimated value of more than US\$80 million. Tender for the supply of cancer drugs, tender No MoH/ SP/009/17 with an estimated value of more than US\$40 million and the award of a 2-year framework for Orthopedic Implants." Wina demands girl-child education impact report, as she seeks World Bank support

By Mirriam Chabala Vice-President Inonge Wina urged the Ministry has of Gender to conduct an impact evaluation exercise to determine the effectiveness of the Girls Education, Women Empowerment and Livelihoods (GEWEL) project in the country. GEWEL is a US\$65 million project supported by the World Bank from 2016 to 2021 as an inter-ministerial initiative designed to empower women through improved livelihoods of 75,000 rural women and provide secondary school bursaries to 14,000 girls who are currently not in school due to poverty; covering 51 districts through out the country. The two target groups are drawn from extremely poor households using the single registry database managed by Ministry of Community Development and Social Welfare. Under this project, the Ministry of Gender is expected to develop capacity for Monitoring and Evaluation at a cost of US\$1 million while the Ministry of General Education is expected to use about US\$28 million for keeping 14,000 girls in secondary schools. On Monday, a team of World Bank staff paid a courtesy call on Vice-President Wina over possible additional financing

towards the GEWEL Project, as the current agreement comes to an end in September, 2020. The team included World Bank Country Manager Ina-Marlene Ruthenberg, Task Team Leader for GEWEL Project Sarah Coll Black and Emma Hobson who is also working on under GEWEL. And in a statement, Permanent Secretary in the office of the Vice- President for administration Stephen Mwansa disclosed that Vice-President Wina was delighted with the World Bank's support to the country in various key sectors of the economy. "Vice President MrsInonge Mutukwa Wina has indicated willingness to support the idea of providing more finances for the continuation of the GEWEL programme so that more vulnerable women and girls could have access for livelihood support and secondary school education, respectively. She was delighted with the World Bank's support to the country in various key sectors of the economy and she urged the Ministry of Gender to conduct an impact evaluation to determine the effectiveness of the GEWEL Project. Under the current GEWEL agreement worth US\$65 million, the project is on track to achieve its project development objectives; progress towards

the PDO and implementation progress has been rated as Satisfactory for the last year. Component one of the project is support to women's livelihoods whose target is to support 75,000 women with training, a productive grant, savings and mentoring. To date, 12,748 beneficiaries have received full SWL package and 21,375 beneficiaries await the grant. An additional 45,000 women will be selected from Social Cash Transfer (SCT) households in mid-2019," stated Mwansa "Component two of the project is Keeping Girls in School (KGS) whose target is to pay school fees for 14,000 vulnerable girls from SCT households. To date school fees have been paid for 16,239 female secondary school students in 16 districts across 10 provinces. KGS is expanding to an additional 11 new districts to support 9,000 more girls. A total of 25,239 girls are expected to benefit under the project surpassing the initial project target of 14,000 girls. Further, investments have been made in payment systems, management information systems, and financial management. The GEWEL project is contributing towards Government's aim of substantially scaling up pro-poor spending to combat poverty and inequality as set out in the 7NDP."

So that picture is old. I did not break any law then in 2013. Now in 2019, I would never buy from a street vendor as it has since become illegal to do so. I do not wish to break any law and if found guilty, go to jail or pay a fine. I am a law abiding citizen."

president Daniel BUZ Mwimbe, called News Diggers to express his displeasure, adding that he had sent his union Secretary General to join other union leaders who went to demand answers from the Public Service Management Division (PSMD) at Cabinet Office yesterday.

He said it was senseless for government to only pay teachers out of the numerous civil servants in the country. "Government still hasn't paid health workers! They pay a teacher and then they forget the most critical area which is health, who does that? Nurses and other civil servants have not yet been paid. We are very much concerned as trade unions, especially under health. So, I have sent my general secretary to Cabinet at PSMD to attend meeting with other secretary generals from other trade unions to find out the position of government because they are not giving their position up to now. We want to know what is happening. We can't stay in suspense like this, people have been calling us to know when their salaries will be paid. The silence is just uncalled for!" Mwimbe said.

"We engaged Cabinet on Friday and all we were told was 'everyone will be paid'

and we didn't even know that they were going to start paying in phases like what they have done now. When we followed up on Monday they told us that they paid the teachers because they are the majority. But you cannot start paying people on majority basis, no, that is uncalled for and it doesn't even make sense!"

And Zambia Union of Nurses Organisation (ZUNO) General Secretary Fray Michelo has written to Ministry of Health Permanent Secretary in charge of administration, demanded a prompt explanation from government on why the nurses and midwives had not yet been paid their February salaries.

The Zambia Union of Nurses Organisation (ZUNO) has received huge concerns over the delayed salaries for the month of February

2019, especially that other public service workers like teachers have been paid. Nurses and midwives being among the essential service workers deserve a prompt explanation so as not to interfere with health service provision in the country, but to serve and maintain harmony among nurses and midwives," said Michelo in a statement, Tuesday.

"In view of the above, development, ZUNO demands that the Ministry of Health through your office should give an official statement on the delayed salaries as this is causing a lot of anxiety and panic among our members.

Meanwhile, speaking in a separate interview Chiyobe said the Servants and Allied Workers Union was concerned that the delayed salaries may affect service delivery among workers.

efforts as unions and after these salaries have been paid, we are not going to sit idle, but keep engaging the government to see how the salaries of civil servants should be put as a priority. It's very important to pay salaries on time. Civil servants are the engine of government and you should expect frustrations and demotivation and anger whenever their salaries are not paid on time! So, my appeal to government is to consider, as business number one, the payment of salaries to the public workers because they are the ones who are the engines of government. Let them not vent their anger on their clients because an unpaid worker is frustrated and annoyed and they may not see anyone from government to vent their anger on, except their clients," Chiyobe warned.

"From our consultations, we have assurance that all civil servants will be paid Otherwise, tomorrow. payment of the teachers is just something that was done to see how best the salaries can be paid by way of managing on the monies coming in. Even in the past you may have seen that health workers are paid first and teachers are not paid or police would be paid when others have not been paid. figure had come and it could have accommodated a smaller cluster of the sector, then it could have paid. So, this is just the approach, which is being managed according to the figure that is available," narrated Chiyobe. "But otherwise, all of them by tomorrow (Wednesday) they will be paid so that this anxiety may not go on. But if by tomorrow they are not paid, we will still come back and be able to see and inform workers that maybe there are challenges here and there and this is why they are not able to pay, because we have assurances that they are going to pay everybody by tomorrow and if not early, maybe by the close of business today. We had meeting with Cabinet and we were assured that salaries will be paid tomorrow, but if it doesn't happen tomorrow, then we will decide on the next course of action."

IBA's punishment too stiff, laments Shawa

Prime TV managing director Gerald Shawa says the decision by the Independent Broadcasting Authority (IBA) to suspend its operating licence for a month is too stiff.

And Amnesty International Regional Director for Southern Africa Deprose Muchena says the suspension of Prime TV's license is a ploy to muzzle independent voices in Zambia.

Meanwhile, NGOCC executive director Engwase Mwale has demanded the immediate lift of the ban so that Prime TV can be left to operate freely.

In an interview, Shawa lamented that he would have to refund clients who had paid for advertisement upfront; aside from paying employees.

"Of course we are not happy and we feel they didn't follow they right procedure. What they should have done was yes we will do what they are to give us some guidelines. saying."

Unless we had failed to those guidelines follow then now they should have warned us. That is what we think they should have done. But I think we would have been punished in other ways. There are other remedies for us to be punished. They should have given us some guidelines in which to operate unlike the way they have taken this move," said Shawa, adding that he would conduct an in-house training on basic journalism ethics, as advised by IBA.

"It is a must we are affected. So now we have to find money to refund those clients who paid upfront and also we need to find ways of paying back because we haven't honoured our obligation ... and also of course you know the workers also they need to be paid. We have to find a way of paying them. So those are the consequences that come with this decision. But

And according to a statement issued by Amnesty International Media Manager Robert Shivambu, Muchena said suspending independent media news stations was a ploy to muzzle autonomous voices.

"The suspension of Prime TV is a ploy to muzzle independent voices in Zambia and to undermine the right to freedom of expression and media freedom. It is clearly intended to send a chilling message that journalists need to self-censor or face dire consequences. This unlawful suspension must be immediately lifted to allow Prime TV to continue telling the Zambian story as it unfolds. Zambia can only benefit from the plurality of media voices," Muchena said. Muchena observed that the media freedom in Zambia had been under so much attack since the closure of

under attack in Zambia in recent years. In 2016, authorities sanctioned the closure of the The Post newspaper, one of the country's longest serving independent newspapers. Its owner, Fred M'embe, and news editor, Joseph Mwenda, had been previously brutalized by the police for the newspaper's critical reporting," said Muchena.

And Mwale, in a separate statement, said it was saddening that IBA could suspend an institution's license following Mwila's complaint against the TV station, asking the authority to immediate lift the suspension.

"The Non-governmental Gender Organisations Coordinating Council (NGOCC) has learnt with sadness the decision by the Independent Broadcasting Authority (IBA) to suspend the Broadcasting License for Prime Television following a complaint by the Secretary-General of the ruling Patriotic Front (PF) Mr. Davis Mwila. The Republican Constitution guarantees the freedom of expression and subsequently freedom of the press. The decision by the IBA is not only ultra vires the Republican Constitution, but is also draconian and reminiscent of totalitarian regimes. It is NGOCC's considered view that the suspension appears to be intended to intimidate and muzzle the media to instil fear in terms of independent and unbiased reporting," stated Mwale, Monday. "NGOCC wishes to reiterate

our position that the role of the media in any democracy is an important aspect of governance. Apart from entertaining and informing, the media plays a critical role in educating the masses. We therefore find the suspension of Prime Television as a serious affront against the masses that depend on this station. We demand that the IBA should immediately lift the ban and allow Prime Television to operate freely. Even the Patriotic Front (PF) Party manifesto agrees with our position on the need for greater press freedom for the greater good of the country." ActionAid Zambia's Nalucha Ziba, echoed Mwale's call in a separate statement; "Even if the provisions of the law in Section 36 of the Independent Broadcasting Authority Act dictate punishment against an erring broadcast house, for the sake of upholding key tenets of democracy, the IBA should have used other channels to address whatever grievances they, or other stakeholders, may have had against Prime TV than resorting to extreme measures that only serve to worsen the country's standing on the global scene. Action Aid Zambia believes the IBA is more than capable to handle complaints against a media house in a manner that does not stifle the muchneeded freedoms of the press. The IBA must make itself relevant by playing the role of promoting pluralism and professionalism in media than acting as a body that acts to victimise the institutions that it should protect."

Ghirardi Milling sues Chibuku manufacturer over K328,615 debt

Ghirardi Milling has dragged Nkhosi Milling Limited, a company engaged in manufacturing Chibuku Shake Shake, to court for failing to pay a balance of over K300.000.

In this matter, Ghirardi Milling (2002) Limited is demanding payment of K328,615 plus interest as well as costs and any other relief the court may deem fit. In a statement of claim filed in the Lusaka High Court, Monday, Ghirardi Milling

stated that it was a company engaged in the manufacture and sale of maize meal, among other businesses.

It added that the defendant, Nkhosi Milling, was engaged in the manufacture of opaque beer and had for a period in excess of two years been procuring maize meal from the Ghirardi Milling as a raw material for the production of the beer.

Ghirardi Milling stated that Nkhosi Milling now had an outstanding balance on account amounting to K328,615 owing to its failure

to service its account with the plaintiff. It added that the defendant had failed to settle the said balance despite numerous reminders.

"The defendant has despite numerous and repeated reminders failed and neglected to settle the outstanding amount. The defendant had on its own made several proposals on settlement, but had honoured none. As a result of the defendant's failure to pay [the balance] the plaintiff has suffered loss," read the statement of claim.

Many people have expressed shock that government has gone ahead to suspend the broadcasting licence for Lusaka-based Prime Television, but we saw it coming. In fact, we heard about plans to shut down Prime TV station about a year ago, and we remember sharing our fears with the proprietor of the media house.

So, what the Ministry of Information Permanent Secretary, Chanda Kasolo, said on Monday that they initially wanted to completely revoke the TV station licence is very true. But it is not for the "unprofessional" reasons that he gave. It is about the 2021 general elections and the PF government's fear of what that television station is capable of doing, through its coverage of opposition political parties.

From our knowledge, gained from wellplaced government sources, the longconceived PF agenda to shut down Prime TV got State House's blessings around April, 2018, when the station provided a platform for Mr Fresher Siwale and his opposition to bring colleagues President Lungu's nationality into public discourse.

that "Zambia needs an intelligent president, not a drunkard", plans were already underway to sort out the media house.

Aware that it was a target, Prime TV did not cow down, but continued to provide a platform for political discourse to President Lungu's rivals who are not covered by the State broadcaster, ZNBC. The owners of Prime TV explored media freedom without fear. Unfortunately, that determination to be a truly independent and fearless media house earned Prime TV the hate and disgust that PF Secretary General Davies Mwila demonstrated a month ago.

The PF learnt recently that Prime TV was acquiring outside broadcasting equipment that would enable it to televise live news events. including campaign activities, just like ZNBC does for the Patriotic Front. The fear for the PF has been that, if a private TV station with such resolved courage can have this nationwide ability to compete with ZNBC, then 2021 was not going to be plain sailing.

Prime TV is not alone in this struggle, what is happening to Prime TV today will happen to News Diggers! tomorrow, it will happen to any other media organization that gives the opposition a platform to provide checks and balances.

Today, PF's plans to shut down Prime TV have been openly hatched for all citizens to see. The operation is in full swing and the end game is to kill it before it becomes too big. The ruling party doesn't want Prime TV to be in operation by the time Zambians will be voting for new government leaders in 2021.

Mr Kasolo even had the boldness to lie that the IBA consulted members of the public



Ethiopian Emperor Tewodros II's stolen hair to be returned by UK

A British museum is to return a lock of hair that the Ethiopian government considers a national treasure.

It was cut from the head of Emperor Tewodros II, who killed himself rather than be taken prisoner by the British during their 1868 invasion of Ethiopia.

His seven-year-old son Prince Alemavehu was taken to the UK along with looted treasures. He became a favourite of Queen Victoria before dying aged 18. His remains are kept in Windsor Castle despite campaigns for their return.

Strands of Emperor Tewodros II's hair were given to the National Army Museum in London 60 years ago.

The museum told the BBC it had decided not to make photographs of the hair public out of respect, because the matter was "too sensitive". The remains are described as two pieces "no bigger than the size of a two-pence coin".

The National Army Museum has

now agreed to return the artefact, but says it is not returning any other items of African origin. "It's definitely not a precedent," a spokesperson for the museum told the BBC.

"That's the only one that's been requested. They have to be formal, written requests to the director with a case".

The BBC's Emmanuel Igunza in Addis Ababa says talks about the process of repatriation with the Ethiopian government are set to begin within the next few days. The move has reignited demands for the UK to return all the looted artefacts on display in British museums.

Historians say 15 elephants and 200 mules were needed to cart away all the loot from Maqdala, the emperor's northern citadel capital.

Ethiopia lodged a formal request in 2008 at various British institutions for the return of the treasures worth millions of dollars taken from the site. The announcement comes

at the end of a year-long

commemorations marking 150 years since the Battle of Maqdala. The so-called Napier expedition, often described as the largest military offensive by the British empire in Africa, saw thousands of soldiers deployed to face Emperor Tewodros II.

In the mid-19th Century Emperor Tewodros II decided to modernise his empire, Abyssinia, by opening up relations with the UK

But things deteriorated after requests for military assistance were ignored

In protest the emperor detained the British consul and other foreigners

Britain reacted by sending an army to the emperor's fortress in Maqdala in 1868

Rather than become a prisoner, Emperor Tewodros II took his own life

son was also taken to Britain and then educated at Rugby School: He died of pleurisy at 18 and is buried at Windsor Castle

Several African countries have requested the return of artefacts taken by European powers. Some years after Benin first

made its official request, France has agreed to return 26 thrones and statues taken in the colonial era.

A recent report commissioned by French President Emmanuel Macron recommended that African treasures in French museums be returned to their countries of origin. It states most of the Africa collection in the Quai Branly museum in Paris - approximately 46,000 pieces was acquired with some degree of duress.

"We've read it and we consider it's a positive report - it's legitimate and follows the course of history", Senegal's Culture Minister Abdou Latif Coulibaly told the BBC in November.

Senegal said it had asked France to return more than 100 artefacts.BBC

Bird extinctions 'driven' by global food trade

About 100 bird species are predicted to go extinct based on current farming and forestry practices, according to a new global analysis.

This number has increased by 7% over the first ten years of this century alone, say scientists.

They say the biggest factor is cattle farming, but the impact of oil seed crops like palm and soy is growing fast.

By comparison, an estimated 140 birds have been lost over the past 400 years.

International researchers used bird extinction as a measure of the loss of biodiversity - the variety of plant and animal life in the world or in a particular habitat - linked with international trade in food and timber.

The research, published in the journal, Nature Ecology Evolution, shows that & international trade can drive threats to animal species far

from the countries where the goods are consumed.

In 2011, about a third of biodiversity impacts in Central and South America, and a quarter in Africa were driven by the consumption of goods in other parts of the world, says the team.

The issue of biodiversity loss cannot be addressed without adding remote responsibility, i.e. people taking responsibility for the goods they buy at the supermarket, said coresearcher, Prof Henrique Pereira of the German Centre for Integrative Biodiversity Research (iDiv) in Leipzig, Germany.

"We have to provide more information for consumers on that - so that they know what they are buying," he told BBC News.

Co-researcher Alexandra Marques added: "We must address unsustainable patterns of consumption driven by

economic growth. Our choices here will have consequences elsewhere."

The researchers estimated the number of bird species at risk of extinction due to the conversion of natural habitat to land for agriculture and forestry between 2000 and 2011.

They came up with a figure of as many as 121 bird species predicted to go extinct in the future if there is no change to current land use.

(By comparison, an estimated 140 bird species have been lost globally since the beginning of the 16th century).

Ariel Brunner of conservation group, BirdLife Europe, said the study adds to a growing body of evidence showing that unsustainable food and farming system is "at the very heart of the ecological crisis - both in terms of driving the collapse of biodiversity and contributing to climate change". UK man 'free' of HIV th new stem cells

A UK patient's HIV has "undetectable" become following a stem cell transplant - in only the second case of its kind,

doctors report in Nature. The London patient, who was being treated for cancer, has now been in remission from HIV for 18 months and is no longer taking HIV drugs.

The researchers say it's too early to say the patient is "cured" of HIV.

Experts say the approach is not practical for healthy people with HIV but it may

ultimately help find a cure.

The male London patient,

who has not been named,

This is the second time a patient treated this way has ended up in remission from HIV.

Ten years ago, another patient in Berlin received a bone-marrow transplant from a donor with natural immunity to the virus.

Timothy Brown, said to be the first person to "beat" HIV/Aids, was given two transplants and total body irradiation (radiotherapy) for leukaemia - a much more aggressive treatment. "By achieving remission in a second patient using a similar approach, we have shown that the Berlin patient was not an anomaly and that it really was the treatment approaches that eliminated HIV in these two people," said lead study author Prof Ravindra Gupta, from UCL. ProfEduardo Olavarria, also involved in the research, from Imperial College London, said the success of stem cell transplantation offered "hope in the search for a long-awaited cure for HIV/Aids".**BBC**

The revelations caused public outcry among Zambians, many who questioned whether the ACC was aware that Mwamelo was being investigated. The ACC has however expressed ignorance that being Mwamelo was

investigated by FIFA and only mentioned in a statement had that investigations been instituted against him following the revelations.



The erratic and poor salary structure is believed to have contributed to high profile exits from Football House. Although some employees have left in frustration of the ma-administration, at Football House but hold back because the heavy-handed nature with which FIFA frowns at what it sees as interference.

Among those that have left Football House are Technical Director Moses Sichone, Licencing Manager Erick Mwanza, Referees Manager Kenneth Chichenga, Registrar Elton Thawe, Communications Manager Desmond Katongo.

Another employee operating in the Registrar's Office recently left in frustration.

Pressure has been piling on FAZ to pay dues to the officials that resigned but nothing has been forthcoming. A Ministry of Sport official says information reaching the government office suggests that Kamanga has ordered that employees contracts be suspended.

"We don't know the contract for employees are being suspended but "FIFA has allocated some good amounts like the president announced but we don't know what is happening in that respect. Remember this was announced by the FAZ president himself," added the official.

On February 4, 2019, FAZ announced that FIFA had allocated \$1 million, double the grant it received in 2018, operational and football development expenditure and an additional \$2 million for infrastructure development.

Meanwhile, the under-23 camp at Eastern Moon Lodge behind Kafue Road Shoprite was issued an ultimatum to pay or face eviction. Management at the lodge sent a Communications

Mwazipeza Chanda refuted all the claims saying the association does not owe any employee monthly remunerations adding that FAZ has instead endeavoured to ensure that members of staff are paid on time. She however confirmed that the association owed a named lodge some lodging fees but denied claims that the U23 national side was given an eviction notice or an ultimatum to pay the money.

"Its unfortunate that there are those kinds of reports. I have been in the office for just under five months and I know that there are some institutional debts that are there so when it comes to matters regarding probably emoluments and retirement packages, previously there have been issues regarding that, I am aware. But when it comes to the month-tomonth payment of salaries, I think

money," Chanda said.

"So yes of course there have been occasions where salaries have been delayed, but to say that people have gone more that three months without a salary I don't think that is true. Its false. As far as I am aware, if there are probably lapses in the payments its probably in allowances and overtime, issues like that, otherwise people are paid. That's not correct, I think at the time they were leaving camp, that story had started. But it's not correct. It's not all wrong it might have some inaccurate facts. You know we do have a situation like I have mentioned where funding does not come through on time but I don't think it's a situation where they were being evicted from the camp house where they were lodging. I'm saying there might be a legitimate claim that the lodge was owed money but no one was evicted," she said.
