Given Iustice Minister Lubinda says the Constitution amendment process will finally allow politicians to dialogue because the ZCID route has proven difficult. Meanwhile, Lubinda says electing a council chairperson is currently more expensive than electing a member of parliament, something which could be rectified through refinement process. the Speaking when he featured on Hot FM's Hot Seat programme, Thursday, Lubinda said he would present a Bill to Parliament on Tuesday that would cloth the constitution amendment with legality. process Lubinda said in order to attract the participation stakeholders, of all kev ZCID would be kept far away from the constitution amendment process. "We are determined to finish the constitution refinement process by July 2019. Let me just let out the cat from the bag, yesterday (Wednesday), Cabinet approved a bill that I will be presenting in Parliament on Tuesday, this is a bill that is going to cloth the whole road map that I presented with legality. The road map I presented was an administrative road map. Now we have decided 'let's go to Parliament, let's legislate' so that this road map is now a legally binding process... when I presented the road map, the only complaint I heard [from the opposition] is that 'we will not make submissions because we haven't been allowed to dialogue'. But the position I take is that the road map itself is that

the process to allow people to dialogue on specific issues. So we are going to build on that and bring the political parties together to discuss, together with all those that made submissions," Lubinda said. "We will not bring them under ZCID because the ZCID route has proved difficult. Now we will bring them as individual political parties. Nashala neka (one man) parties are welcome, Chishimba Kambwili's NDC is welcome, Mwenya Musenge's NDC party is welcome, UPND is welcome, FDD... all political parties, whether they have presence in Parliament or not they are all to come to this meeting. On top of that, the Churches that did not make submissions for whatever reason, they should also come and make fresh submissions... Don't get bogged down by this ZCID dialogue process, bring your views straight and we shall sit together. The issue of who is going to chair that centre is a matter that is going to be agreed upon by all the people who are going to come to that meeting. And because it will be based on consensus, our belief is that Chairperson shall receive the support of the majority of the people attending. We are hoping that this way, we can attract the participation of all those that are genuinely interested."

"Even now when I hear [the media] quoting Mr Hakainde Hichilema saying he's not going to take part in the refinement process, I think that for now all I can say is that I am sure they are going to take part. Chalimbana River Headwaters Conservation Trust and nine traditional leaders of the Soli people have sued Zambia Airforce Projects, Kingsland City Investment and three other construction companies in the Lusaka High Court, for carrying out construction works on Forest Reserve No.27 along Twinpalm Road. The plaintiffs are seeking an injunction restraining the defendants from continuing with the construction of the Kingsland City Project in the area, and an order declaring that the developments are a threat not only to the Chalimbana River Catchment but the greater Lusaka Aquifer system. Chieftainess Senior Nkomeshya Mukamambo and headmen Maoma, Mwampekakanya, Kapamangoma, Mukankaulwa, Kayombo, Kapuka, headwoman Kabeleka, princess Cholwe everybody. The Public Order Act particularly is one piece of legislation that has been criticized left, right and centre by politicians. So now we are saying, please politicians here is the law, come and dissect it, rebuild it to suit everybody. Surely for a person to say 'no I don't want to take part in that process' and yet that law is affecting me, for me it's not believable and I don't think anyone would do that. I think that all political parties will come on board," Lubinda said. "So I don't think there would be any politician worth being called a leader who would refuse to participate in a process that makes it easy for them to engage in their political activities that makes it easy for Zambians to engage in national affairs. One

such person who does that in my eyes does not qualify at all to be referred to as a leader of any kind, not a political leader, not an economic leader, not a business leader... such a person is a person that you want to put in a corner and leave them there to rot because they don't add value to the nation." Meanwhile, Lubinda said electing a council chairperson was currently more expensive than electing a member of parliament, something which could be rectified through the refinement process. "Issues like by-elections are issues that must be looked upon. At the risk of preempting what submissions we received, I just want to reflect on the issue of council by-elections. The people who drafted our

constitution locked in the Presidency with regard to elections in the event that there is a vacancy at Presidency. But while doing that for one office, they forgot the many Council Chairperson offices. When we had a by-election in Lusaka, that was a mini national election. The cost is colossal and then we went into Chilanga and now we are going into Kafue for Council Chairpersons. In many places, electing a council Chairperson is even more costly than electing a member of parliament. These are things that we have an opportunity now to reflect upon and ask if can refine this constitution so that it is responsive to the day and be the one that meets the wishes and desires of people," said Lubinda.

Nkomeshya sues ZAF, Kingsland **City for destroying forest reserve**

Nkomeshya of the Soli people and Chalimbana River Conservation Headwaters Trust have sued Zambia Airforce Projects, Kingsland City Investment, Drimtown Investments Limited, Shangrila Investments Limited and Datong Construction Limited. In a statement of claim filed in the Lusaka High Court, Wednesday, the plaintiffs stated that they were at all material times, members of the Busoli Roval Establishment Chiefdom Lands Committee, as well as, headmen and headwomen in various villages of Soli people under the Busoli Royal Establishment in Lusaka, and relied on the Chalimbana river. The plaintiffs explained that Lusaka City's public and private water was predominately sourced from its underground aquifer system unlike other areas in Zambia that relied on free flowing surface water. They stated that without the protection and preservation of water recharge areas, the aquifer faces the risk of depletion and that Lusaka City, with its growing population would face major water shortage. The plaintiffs stated that their suit concerned an area known as 'Forest Reserve No.27',

Reserves were created and gazetted as protected Forest Reserves which included Forest Reserve No. 27 through various Statutory Instruments. The plaintiffs stated that despite the fact that only a portion of 'Forest Reserve No.27' was demarcated for the Zambia Air Force, the entire 'Forest Reserve No.27' was de-gazetted and this led to unwarranted land grabbing and allocation of plots on the de-gazetted Forest Reserve. They further stated that the uncontrolled activities in the area caused environmental destruction and the Chalimbana River slowly began drying up and the water table drastically lowered. adding that the President at the time, President Chiluba, ordered that 'Forest Reserve No.27' be re-gazetted as a local Forest Reserve. They stated that despite this background and the environmental sensitivity of 'Forest Reserve No.27', a number of construction projects had recently been commissioned in the area and the main one was known as 'the Kingsland City Project'. "The first and second defendants (Zambia Airforce Projects and Kingsland City

Limited) carrying construction works in the area through an agreement with with the Zambia Air Force Projects Limited' read the statement of claim. The plaintiffs stated that defendants did the not comply with the law regarding Environmental Impact Assessments prior to the commencement of the developments as no public hearings were held as required by the law. They stated that as a result of this, the Zambia Environmental Management Agency (ZEMA) issued a Protection Order, ordering Drimtown Investments Limited, Shangrila Investments Limited and Datong Construction Limited to stop construction works and restore the area to its previous state. The plaintiffs stated that despite the issuance of the Protection Order, the defendants had never complied and continued to carry out constriction works on the environmentally sensitive area. They now claim for an injunction restraining the defendants from continuing with construction works in the area, an order that the defendants should obey the Protection Order, an order declaring that the developments are a threat not only to the Chalimbana River Catchment but the greater Lusaka Aquifer system, costs and any other reliefs.

1,750 000 Zambians have benefitted from social protection programme - Lizzy

By Sipilisiwe Ncube Gender Minister Elizabeth Phiri says government has put up significant interventions to eliminate all forms of gender imbalances in the country. Speaking when she delivered her speech during the launch of the 63rd United Nations Commission on the Status of Women (CSW) in New York, Phiri said 1,750 000 Zambians had so far benefitted from the social programmes. protection She stressed the need for governments to break the gender stereotypes and exclusions in global economic and social progression programmes. This is according to a statement issued by First Secretary for Press at the Zambian Permanent Mission at the United Nations Wallen Simwaka.

Phiri told the UN that government, in its desire to create equal social and economic opportunities among its women citizens, had been implementing social protection systems targeted at improving the livelihood and social status of the poor and vulnerable households in rural and communities. remote "In the recent past, Zambia has focused on improving access to critical social services and infrastructure such as housing, roads, water and sanitation both in urban and rural communities. This Government believes will help facilitate the desired levels of economic transformation and leverage private investment. It is anticipated that economic infrastructure will open up opportunities for women living in rural areas to

venture in economic activities," Phiri said. She told Member States that Zambia was promoting and facilitating the establishment of multifacility economic zones and industrial clusters

across different sectors in an effort to bridge the infrastructure gap. And United Nations (UN) Secretary General António Guterres said gender equality was a fundamental question of power in a

male-dominated world. Guterres said the world needed to attain gender parity in order to change power relations in societies if gender equality has to become a global reality. He noted that the world

was still witnessing a pushback on women's rights something which contributed to increase in violence against women especially human rights defenders and women running for political office.

Kambwili's blood is PF, we can't wait to have him back - Musukwa

By Sipilisiwe Ncube If you cut Chishimba Kambwili's hand, the blood that comes out of him is PF, he is a brother who just failed to managed his ambitions, says Roan PF campaign manager Richard Musukwa. And Musukwa says NDC is crying of being blocked from

nominating their candidate in Roan because it has no identity of its own but is rather established and composed of undisciplined PF members. Meanwhile, Musukwa says UPND will be ruined if it goes into a by-election partnership to support the NDC candidate in Roan. On Wednesday, the UPND and NDC charged that they were aware that PF was making efforts to disqualify the alliance members from the Roan parliamentary race, so that the ruling party can go through unopposed. But in an interview with News Diggers! Musukwa who is also Mines Minister said PF had no other intentions apart from teaching its prodigal sons in NDC a lesson. Asked if it was true that PF was trying to block NDC and other political parties from contesting the Roan seat, Musukwa said his party only wanted to teach NDC a lesson. "No we are not blocking anyone. How can we block them? We just want to teach them a lesson that as an undisciplined son with his followers that we will defeat them and they should come

back to PF because that is their party. We will defeat them as individuals [and] we will also defeat them as an alliance. And we have told you that if you open in the hearts of NDC, they are PF members. So I want to advise our colleagues in the UPND to be careful with NDC because those are our members. If you cut the hand for Chishimba Kambwili, the blood that comes out of him is PF. He is our brother, he is a founding member, he just can't manage his ambition," Musukwa said. Kambwili is our prodigal son and we are waiting for him to finish everything, we know he is coming back. Those members who are following him will be shocked. I am surprised at the politics of the UPND [and I think] that is why the UPND is going nowhere. How can they go in an alliance with our children? So the UPND does not know how to do politics. So we will defeat them as individuals and we will defeat them as a consortium," Musukwa said. He charged that NDC was a group of undisciplined PF members. "Zambia is a democratic dispensation and in that democratic dispensation, we expect competitors, whether they are weak or strong [but] we expect competitors. PF is not in any way having any manoeuvres to ensure that no one competes. They are all welcome [and] we will defeat them at their hands. Those complaints are as a result of conceding defeat already. Instead of crying out loud, they should just come in the open and compete. And they should know that NDC is a product of undisciplined PF members. They are our prodigal children [and] we have been waiting for them to come back to our party because that is where they belong. That is why you are hearing them crying because they have no identity of their own, their identity is PF, that is where they belong," Musukwa said. "So ba NDC are our prodical

children and PF has always been waiting for them and even today we are still waiting for them. In fact we have been waiting for them to disband their party and come back to PF because that is where they belong. It is laughable that UPND and NDC [with] our own founding members can go and postulate that they are working with UPND. Those who work with UPND are just dramatising. And I want to warn UPND that those (NDC) are our children who are just dramatising. In fact they are aspersing UPND. Those are our founding members and we are waiting for them to disband their party and come back to where they belong." He added that PF and NDC squabbles were a family issue which needed no intruder. "Our focus in Roan is development in terms of job creation on the mine platform, development in terms of road infrastructure, water and also empowerment of our youths and our women. We don't want politics of appeasement. We want politics that is going to sustain the lives of our people of Roan. As you know for a long time, their MP has been on the run in terms of pursuing [his] presidential ambitions. So they need a member that will be doing local politics and locally based, that one graduated to presidential So this fight we have is a family fight," said Musukwa. "For us we would like to ensure that any formation from the opposition will be defeated because we are conducting issue based campaign based on development, and that is our message. And I want to assure the people of Roan and Luanshya and Zambia at large that PF will conduct issue based campaigns in Roan and anchored on the none violence principle because we believe in talking to our people who vested their interest in the PF and His Excellency the President Edgar Chagwa Lungu.

Prime TV closure an act of abuse of office by Kasolo - Sacika

Former Secretary to the Cabinet Dr Sketchely Sacika says he is shocked that a person like Ministry of Information Permanent Secretary Chanda Kasolo could oversee a process of clumping down on private media in Zambia. In an interview, Thursday, Sacika said the closure of Prime TV was an act of abuse of office by Chanda, warning that he should prepare to face prosecution after he leaves office. "Listening to Chanda Kasolo and how he wants to control the news media, I was surprised that a man in his position could think that way. Zambia is a constitutional democracy, our Bill of Rights guarantees freedom of conscious and expression. It is Kasolo's responsibility as a government official to see to it that the objectives of our Constitution are fully realised, not to use

his position to pursue his personal interests. Kasolo's decision to close Prime TV was abuse of authority of office for which he must prepare to face criminal prosecution when there is change of government. If Kasolo wants journalists to improve their skills, he must give them more freedom to operate. Let our journalists make mistakes, after all making mistakes is an essential part of the process of learning. You cannot force people to be responsible. People have to learn to be responsible on their own through the awakening of their consciousness," Dr Sacika said. "If Kasolo wants our country to develop into a viable democracy, he must give our people more democratic freedoms. Only in this way will our people learn the true value of democracy and protect it. The government is not a private enterprise the public space

and time has come for our politicians to depersonalise the government and be faithful to the objectives of our Constitution. It is a betrayal of the people for politicians to hijack the country's political system and use it to achieve their personal gains." Dr Sacika begged the government to give the governance of the country back to the people. "Too much government is not good for the people. Our rulers and our politicians must learn from the experiences of others. Our people need to be freed from too much governance. The country needs to be handed back to the people. Zambians should not be asking what the country will do for them but they should be asking what they can do for their country. Everywhere you go in Zambia today, people are saying 'boma iyanganepo', but that is not healthy for our country," said Dr Sacika.

to manage the construction of the National House of Prayer. The work which the Board was doing, now it's the task force. We are not calling it a board. So just do me a favour and wait a little bit," Rev Sumaili told this reporter. In December 2015, President Lungu appointed Northmead Assemblies of God overseer Bishop, Joshua Banda to lead a team of clergy on the House of Prayer Board. Others who were appointed alongside Bishop Banda were Evangelical Fellowship of Zambia Executive Director Reverend Pukuta Mwanza, Fr Charles Chilinda from the Zambia Episcopal Conference, Father Robert

Sihubwa of the Council of Churches in Zambia BIGOCA Overseer and Apostle Peter Ndhlovu. Others on the board were Reverend Akushanga Muyenge Praise from Christian Centre, Rev Mpundu Mutala and Apostle Elizabeth Chishimba from God of All Dominions, Brigadier General Vincent Mwenya, Chaplain General of the Defence Forces, Naiboth Church Overseer Apostle Bishop Dr Timothy Kazembe, Dr Edwin Zulu from Reformed Church in Zambia and Lubinda Mukelebai of the United Church of Zambia. Government sources tipped News Diggers that

there were some financial misunderstandings that led to the dissolution of the board, though government hopped to keep the issue out of public discourse. "Yes it's true the board was dissolved sometime last year I think, so there is a new team from government that is running around for that now. The last activities for the advisory board must have been that fundraising auction. warned President Edgar Lungu to be prepared. "There is no one under this world who can be clever than the people. This is the beginning of the revolution. we are judged fairly by people going through exactly what we have done with that TV station, from over a year ago, and then people can make informed judgment. I can assure you, we did everything to the book. To founders of this (FPI), I can assure you that the free press is a prerequisite to functioning democracy because of the role that the media plays in society. We will consult with you very closely whilst we are trying to put regulations for media and journalists into place. We have only started writing this, but we need as many professional journalists as possible to put input into this because this is your legislation," said Kasolo. "The IBA is there to help you stay within the law. I know one TV station such as Diamond TV, they continuously consult IBA and therefore it is very unlikely to get on the wrong side of the law. But the vast

stations, they don't even consult, they just go ahead and broadcast, they even forget what they signed up for when applying for their licenses. So with your coming FPI, you are going to add value to what you are doing, so I really welcome your coming." And Chirwa said her organisation would champion freedom of the press and professionalism through dialogue, adding that FPI would also be offering refresher courses to serving journalists in order to remind them of professional ethics. "The FPI is committed to finding new means of engaging government whenever concerns are raised affecting journalists. Uncontrolled appetite for road construction has contributed to debt distress - Saasa

By Thomas Mulenga Economist Professor Oliver Saasa says there is nothing that government is doing to address the swelling external debt that now stands at US\$10.05 billion.

And Professor Saasa says government's failure to get the IMF bailout deal has contributed to the country's current debt distress.

In an interview, Wednesday, Professor Saasa said money meant for social sectors such as Education and Health was being used to service the debt. hence the delay in the payment of salaries for civil servants. "If there is a recognition that there is a problem, we need to do something about it. I don't believe we are doing something about it and that's

really explaining where we are now and unless we reduce our appetite for construction of roads we are going to have a big problem. What we are seeing now is that we haven't defaulted on debt payment but what's happening now is that we are using social sector spending. You recall the minster came midyear last year, re-arranging and picking



from the Social sector, Health, Education and the like, to put into debt servicing. So you may not have defaulted at external debt obligation but you have defaulted on paying social service delivery. You can't be surprised now when you see government unable to pay salaries, especially in the social sector of education, paying for drugs when you go to hospital. That's what we have been advising government that it will translate into social welfare provision which will be affected and that's where we are," Professor Saasa said. "I think at the end of the day

one has to accept that the level of debt presently is a product of policy lapses at the level of not only the current minster but over a period of time. One would also accept that Honourable Mutati (Felix) tried to make his mark on addressing these challenges but he didn't get significant support from his colleagues in cabinet, so it would appear. So Honourable Mwanakatwe come in and finds a problem that initially if you recall she was in a state of denial, was not very open about the existence of the problem. When she was advised about it, she sort of like she would rather look warm in addressing what everybody

happening, was worried about the fact that we were heading towards the debt distress." Professor said Sasa

government was hiding its Debt Sustainability Analysis from members of the public to avoid embarrassment.

"For the first time they come out and acknowledged that there is a stress and we have to address it. But you realise that that was after the Debt Sustainability Analysis was released and then they decided to hide it. Which might suggest to many and including myself that perhaps the results of DSA were severely shocking and revealed very serious issues that everybody was concerned about. But having been denying for a long time, they thought it was going to be embarrassing to openly admit that the opposition and professional bodies were actually correct," he said.

He said the debt stress was mainly caused due to the accumulation of foreign debt for road construction.

"I think now we have reached a stage where there is acceptance, which is good because if you want to cure

a disease you must first diagnose it correctly. So the minister accepted that there was a challenge and that's how mainly in the Road sector that were less than 80% completed, and other things including restructuring of the debt and the like. We are still waiting for figures but up to now I haven't seen figures that translate that policy into action," Professor Saasa said.

"Now government has recognised that there is a problem, they must also recognise that much of the accumulation can be associated with the appetite for contracting debt through construction, mainly the road infrastructure. And much of this debt in the last three years has been mainly sourced from China but again it was the Chinese that the President was addressing within a week that the minister released the statement that don't worry you are not going to be affected by this, and yet for the last three years it has mainly been the Chinese debt. So there was some element of contradiction in that."

Meanwhile, Professor Saasa said the failed IMF deal had contributed to the debt stress. "And for me, that's how we got where we are. Had the government listened to professional advice and their own Debt Sustainability Analysis, probably things could not have been the same. But most importantly because we don't have a program with the IMF. One of their concerns is whether we have any Debt Sustainability Program that would show that we are serious about it. And we are not yet ready to have the IMF come in because they are reluctant. When you have a program with the IMF it's not just about the money, you can get that \$1.3billion even from the Chinese, but the IMF program is more than just money. It looks at structural reforms, the expenditure pattern and the programs you have to reduce poverty, that's

when they can commit to a

Kabwe council in 3 months salary arrears - TC

By Joseph Mwenya in Kabwe Kabwe Town Clerk Ronald Daka has disclosed that the municipality is in three months' salary arrears while those in top management have not been paid for five months.

Speaking, Wednesday, when senior citizens of Natuseko Small Holding in Kaputula ward, Kabwe Central constituency engaged the Central Province Permanent Secretary to intervene in the problem of lack of access roads in the farming bloc, Daka lamented that the Local Authority had no money to come up with access roads in the area.

'We would like to provide access roads except that we don't have the money to do so right now. We even have salary arrears now. For the majority of workers its three months while for the top management its 6 months," Daka said.

The Town Clerk described the past two years as torrid because of mostly the court cases that the municipality had been battling with.

He said the challenges that the Local Authority went through had taken a toll on the municipality making it difficult to provide services effectively. "I will be very honest PS, the past few

year have just been horrible because we were doing nothing other than appearing in court. So how do you raise revenue like that? And in June 2017, our land agency was suspended. I will of course, check from my predecessors records to see what sort of development charges were paid because that's the money that should be used to attend to such issues," said Daka.

Central Province Permanent Secretary Bernard Chomba, however, assured the farmers in Natuseko Small Holding that their concerns would be addressed. Chomba said he would engage Kabwe Central Constituency Member of

Parliament, Tutwa Ngulube to find a lasting solution to the problem. He directed the Local Authority to get to the site to ascertain what would be required to come up with access roads. "Government values the contribution of small scale farmers to the economy and remains committed to addressing any challenges that you may be facing. I shall engage the area MP to see how best this matter can be resolved," said Chomba.

Natuseko Small Holding has about 53 farmers who are crying for access roads to be constructed for easy access to markets



ENVIROMENTAL SUSTAINABILITY & CLIMATE CHANGE – PART 1

The PAC government will be lean, green and productive. Being a party driven by a new generation of leaders, the PAC are consumed with the passion to ensure that the environment is sustained and not degraded in the present to the detriment of future generations. The sustainable use of the environment is an integral part of our environmental outlook.

The over-arching purpose of the PAC's environmental policy is to promote sustainable natural resource management and to target appropriate development interventions whilst simultaneously addressing the causes of and mitigating the effects of climate change.

As PAC we are aware that our nation is blessed with a rich variety of ecosystems. However, there are multiple and considerable natural and manmade threats to their sustenance. Zambia's ecosystems are home to an extensive variety of fauna and flora species - a significant number of which are unique to Zambia. For instance, Black Lechwes are only found in Zambia.

Added to these endowments are the diverse physical features in the form of different landscape formations ranging from mountains escarpments and plateaus to, rivers, lakes, swamps, valleys. Their scenic value also presents enhanced eco-tourism opportunities.

Top on the PAC's agenda is the protection of Zambia's biodiversity which as alluded to earlier faces a number of challenges and threats. Our Wildlife faces the very real threat of extinction and depletion through poaching and illegal wildlife trade. On the other hand, our forests face the challenge of deforestation as a result of land use such as agriculture and human settlements. With increased power rationing by ZESCO, charcoal burning has increasingly become a source of energy for both the rural and urban population. This has exacerbated demand for charcoal which has in turn aggravated deforestation to alarming levels.

The PAC is cognisant of the numerous environmental policies, laws, management plans, guidelines, and planning documents Zambia has formulated. We are also aware that Zambia is a party to many conventions of international importance. This includes the Convention on International Trade in Endangered Species of Wild Flora and Fauna (CITES) the Ramsar Convention, the African Convention, and the Convention on Biological Diversity. However in spite of the foregoing, successive and current government's commitment to environmental policies has remained abstract, academic and disjointed. This is compounded by the fact that most policies and laws are sector-based and therefore somewhat fragmented. There is need for political will and implementation of a more all-encompassing legal and policy framework so that integrated management frameworks are fully realized. This will be a key priority for the PAC government; to harmonise the policy and legal framework that will ease implementation. The PAC has also observed that lot of tax payers' money and donor funds have been misused by successive government on elaborate environmental workshops and seminars at plush lodges and hotels. These events have become mere talk shows with little to show for. Many of these workshops and seminars are for the most part abstract and academic and are not taken seriously. It has been frequently observed that there is more attention paid to the pomp and splendour of these seminars and workshops than there is to the cause of the environment. Zambia needs a complete overhaul in the way we deal with matters of environmental sustainability. It should begin with mind-set change and a conscientious work ethic. The PAC will provide that Change.



The sustainable use of arable land is an integral part of environmental sustainability. The PAC are consumed with the passion to ensure that the environment is not degraded in the present to the detriment of future generations. Successive and current government policies have also contributed to environmental degradation by not discouraging cultivation of marginal lands or providing subsidies for heavy maintenance crops such as maize.

For long term sustainability and for the sake of posterity, Zambia led by a PAC government will revisit, reconcile and harmonise the heavily subsidized fertilizer support programmes with the need to sustain the long term arability and integrity of our soils in the long run. Small-scale farmers have continued to focus their attention on maize production and have in effect become dependent on a mono-crop system. Maize in particular tends to rapidly mine out select nutrients in the soil. This is because the continuous use of synthetic fertilizers eventually leads to lower soil fertility and high pH levels.

The PAC government will thus ensure that future development strategies are realistic, and closely related to the availability and use of natural resources. Toward that end, the following have been identified by the PAC as key issues for Zambia's environment: Throughout Zambia, small-scale agriculture is characterized by low or stagnant productivity and extractive farming systems that depend to a large extent on mining the natural resource base upon which farmers depend upon for their livelihoods (due to traditional cropping practices). One of the main factors to be considered in relation to agro-ecological sustainability is the soil, as it is the basis for food production in Zambia Therefore, an effort has to be made to minimize soil erosion so

that soil is not transported by runoff to rivers, lakes or ponds, and to ensure sustainability of food production (Hailu and Runge-Metzger 1993).Such examples can be found not only in Zambia but worldwide. Rapid depletion of soil fertility and non-sustainable land use-particularly in developing countries-is both the cause and the consequence of widespread poverty. It is therefore necessary to change actual soil-degrading agricultural systems based on intensive soil preparation (which leave the soil bare and unprotected), to sustainable production systems based on permanent soil cover with plant residues and mulch. Soil is a non-renewable resource and it is available only in limited quantities. Conventional soil tillage as it is practiced leaves the surface of the soil bare, and is one of the major causes of the occurrence of erosion on agricultural land. The PAC will encourage the adoption of the Food and Agricultural Organisation (FAO) tried and tested concept of Conservation farming as a resource saving agricultural crop production to strive and to achieve acceptable profits together with high and sustained production levels while concurrently conserving the environment (FAO 2007). Conservation farming employs minimal tillage. Unlike traditional methods of burning plant residues, in conservation farming residue from crops are left on the land to minimize erosion and provide organic material. This reduces the need for expensive chemical fertilizers and furrows are created just deep enough to avoid turning up the earth in turn keeping nutrients in the soil and retaining moisture.

- (i) Unsustainable Agricultural Practices
- (ii) Climate Change adaptation and mitigation

(i) Unsustainable Agricultural Practices About 80% of the rural population make a living through subsistence farming on customary land (USAID 2008). Agriculture contributes to around almost a quarter of Zambia's GDP with 34% of Zambia's total land dedicated to large and small-scale agriculture (WB 2010, FAO 2009). Small-scale agriculture is by far the most common source of livelihoods and income options for rural dwellers in Zambia and as such, agriculture has been cited in past assessments (USAID 2007) and continues to have a significant impact on the environment.

Does Zambia need nuclear power?

The Secretary General of the PF Davies Mwila recently asked the media to "help to demystify nuclear science because "there is a wrong, yet deeply entrenched perception, that all things nuclear are bad and dangerous." This is a challenge to all of us Zambians to get informed about nuclear energy. The International Atomic Energy Agency (IAEA) - an organisation that promotes the peaceful use of nuclear technology - in a publication "Is Africa Ready for Nuclear Energy?" notes a third of almost 30 countries currently considering nuclear power are in Africa. Egypt, Ghana, Kenya, Morocco, Niger, Nigeria and Sudan have engaged with IAEA to assess their readiness to embark on a nuclear programme. South Africa is currently the only country in Africa with an operational nuclear power plant.

According to the Zambia Development Agency Energy profile (2013), Zambia has about 6000 MW unutilised hydropower potential. While gas and renewable energy is getting cheaper, the price of nuclear power only rises. The decision to move to nuclear power at a time when most nations are moving away from it needs to be seriously questioned.

Zambia last year signed a memorandum of understanding with Russia's nuclear agency ROSATOM that includes building a nuclear plant. At what cost?

University of Johannesburg Professor of Chemist Hartmut Winkler in an article 'Why nuclear power for African countries does not make sense' warned the country receiving the nuclear plant "initially pays very little", but when the repayments kick in "consumers are suddenly faced with a massive burden that most African economies will never be able to meet." Figures on cost are not readily available, but he points out that "Zambia is eyeing a nuclear plant on the scale of Bangladesh's Rooppur 2.4GW. The plant is expected to cost US\$ 30 billion. Given Zambia's total annual budget is US\$ 7.2 billion this is clearly unaffordable."

Furthermore, nuclear energy creates radioactive waste which can remain radioactive and a danger to human health and the environment for many years.

Look at what is happening in South Africa where proposals to boost supply from nuclear plants have been dropped. According to a Business Tech article, Energy Minister Jeff Radebe last year announced there would be a study to determine if more nuclear is needed after 2030. "But until then, there is no increase in nuclear generation envisaged." The plant produces 1,860MW of power - 4 % of South Africa's power capacity - but is being challenged on its implications for national debt.

According to the head of the IAEA Nuclear Infrastructure Development Section, Miko Kovachev, a successful nuclear power programme requires political and popular support

Over 90 subjects of Senior Chieftainess Nkomeshya Mukamambo II have dragged her royal highness to court for allegedly claiming ownership of their land so that some international investors could build a shopping mall there. The subjects claim that Chieftainess Nkomeshya, acting through her agents, has continued to harass and intimidate them, including and national commitment of at least 100 years. This includes committing to the entire life cycle of a power plant, from construction through electricity generation and finally decommissioning. On financing nuclear energy Kovachev noted few countries in Africa have sufficient installed grid capacity to accommodate the recommended capacity for planned conventional, large nuclear power plant. "For example, a country should have a capacity of 10,000 megawatts already in place to generate 1,000 megawatts from nuclear power." The Energy Regulation Board Energy Sector Report 2017 puts Zambia's installed electricity generation at 2897 MW showing that Zambia's power capacity falls short of the recommended level.

Three companies which account for more than half of all nuclear power generation worldwide are facing financial challenges. In 2017 Pittsburgh based Westinghouse - for many decades the world's largest provider of nuclear technologyfiled for bankruptcy. The Japanese nuclear engineering giant, Toshiba, is also in financial problems and there are doubts about it continuing as a going concern. Europe's biggest builder and operator of nuclear power plants, France's stateowned Electricité de France (EDF) is deep in debt. The increasing costs in part are due to addressing safety concerns linked to past reactor disasters like Chernobyl in Ukraine and Fukushima in Japan; and to companies factoring in the costs of decommissioning their aging reactors. Here are some examples of nuclear power plant accidents and their impact.

In the 1979 Three Mile Island accident, in 1. Pennsylvania U.S.A., there was a partial meltdown of the nuclear reactor due to a series of mechanical and human errors at the site of the nuclear power plant causing the worst commercial nuclear accident in US history. Nobody died or was injured in the initial incident, but the meltdown released dangerous gases into the atmosphere which scientific studies have linked to an increase in cancer cases.

2. The 1986 Chernobyl disaster in Ukraine happened after an experiment was being conducted causing one of four reactors to explode and catch fire. Approximately 116,000 people had to be evacuated, and a large area surrounding the plant received fallout so great that it could not be farmed or pastured as a result of this accident. Significant levels of radiation were detected as far north as Scandinavia and as far west as Switzerland. In September 2005 the Chernobyl Forum, comprising seven United Nations organizations and programs, the World Bank, and the governments of Belarus, Russia, and Ukraine, published a three-volume, 600-page report assessing the impact of the accident on public health. Approximately 50 emergency workers had died of acute radiation sickness shortly after the accident, and 9 children

had died from thyroid cancer because of radiation exposure. From among the 200,000 emergency workers who were present at the site in the first year following the accident, the people who were evacuated, and the 270,000 residents of the most heavily contaminated areas, an additional 3,940 people were likely to die from cancer during a prolonged period after the accident.

3. In the 2011 Fukushima Daiichi accident in Japan the plant was not designed to handle the tsunami that struck the area after an earthquake. The large-scale release of radioactivity resulted in people being evacuated from a 20 km exclusion zone set up around the power plant, similar to the 30 km radius Chernobyl Exclusion Zone which is still in effect more than 30 years after the accident. The plant's operator had no way of paying the cleanup bill, estimated at \$180 million and is being propped up by the Japanese government. After the accident, Japan, which relied on nuclear power for 30% of its electricity, shut all its 48 operational reactors for safety checks and seven years later only five are back online. After Fukushima, the previously pro-nuclear Chancellor Angela Merkel of Germany set a deadline of 2022 for shutting down the country's reactors which at the time generated 22% of German electricity. The French president committed to cutting nuclear's share of energy generation from 75% to 50% by 2025 with the gap to be filled by renewables. In conclusion, we should not rush into nuclear power without a full public discussion. Developed countries are getting out of it or scaling down. Decommissioning a nuclear plant is very expensive, and how to dispose of radioactive material is a nightmare. This will leave a huge debt for future generations. Some say radioactive waste will be a problem for 30 years, others say a hundred, but the point is you have to factor this in before you do anything. Zambia should be looking at selling uranium and using the proceeds to invest in more environment friendly power plants like hydro, solar, wind technology. Listen to Louis Armstrong's song about the "wonderful world" which we must not destroy, let alone Zambia!

In a statement of claim filed in the Lusaka High Court, Wednesday, the plaintiffs stated that they were subjects of Chieftainess Nkomeshya's chiefdom in Chongwe district.

They added that they were legal owners of pieces of land in the chiefdom and had been in possession of the land for periods exceeding 20 years.

"The plaintiffs have collectively used the land for subsistence agricultural activities to sustain their livelihood," read the statement of claim. The plaintiffs stated that in or about 2003, government wished to construct a state of the art sports

They stated that as the result of their removal, the first plaintiff, Mungalaba, offered part of her field as alternative trading space to those who were displaced.

The plaintiffs stated that they were reliably informed that Chieftainess Nkomeshya wished to displace them in preference to prospective international investors who were interested in building a shopping mall for her sole benefit.

"The plaintiffs will aver at trial that the defendant (Chieftainess On January 29, 2019, Konkola Copper Mines, through its Corporate Affairs General Manager Eugene Chungu, released a very suspicious statement which puzzled us. It puzzled us because it was on government headed paper with a superimposed KCM logo. It contained an assuring message to government and citizens at large that the mining giant was not going to lay off any single employee as a result of the new mining tax policy.

Below is what we were told, that the KCM acting Chief Executive Officer Venkatesan Giridhar promised miners who work for Konkola Copper Mines and its contractors in Chingola, Chililabombwe, Kitwe and Nampundwe:

KCM Boss: "I wish to confirm, therefore, that THERE WILL BE NO LOSS OF JOBS AT OUR SITES as a result of the new tax regime. As KCM, we undertake to constructively engage key stakeholders such as the Government, trade unions, the media, local communities, and our shareholders, in a respectful manner to ensure that we contribute to the growth of the economy on a sustained basis."

What was mindabout boggling this statement was that it was coming from the Ministry of Finance and not the mining company. It was not Mr Chungu from KCM who issued the statement, but the Ministry spokesperson Mr Chileshe Kandeta. There was no audio supporting the words spoken by Mr Venkatesan Giridhar.

We wondered why the words "THERE WILL BE NO LOSS OF JOBS AT OUR SITES" were

in capital letters on the statement; did the KCM boss shout out these words louder than everything else he said for the ministry to cap them? Or was the ministry trying to emphasise the impossibility of KCM and it's contractors laying off workers? We had serious suspicions.

But of course, we had no reason to doubt the authenticity of a press statement that comes through the official communication channels of the most sensitive government ministry. So we published the story quoting the assurances from the mine and government officials. But at the back of our minds, we suspected that there must have been some arm-twisting involved. We felt that the statement was attuned to give an impression that KCM was very supporting of the new mining tax regime, and it was capable of keeping it's mining operations in full swing without any need to scale back production and workforce.

Today, our suspicions have been proved right. Barely two months later, KCM contractors have released their own sincere statement, giving a real picture of the situation on the Copperbelt.

"We wish to inform all our employees that in the last few months, KCM has not been able to pay Master Mine Services according to the conditions of the contract. As a result, KCM is owing the company huge amounts of money. Thus, it has become difficult for the company to continue running the project. The company is not able to source any more funds to sustain the project. Therefore, operations at Master Mine Service-KCM project have been suspended

until further notice. Only selected employees for care and maintenance will continue reporting for work. During this period, employees will proceed on leave according to the accrued leave days. Upon exhausting the accrued *leave days, an employee will* automatically be placed on forced leave (unpaid leave) *in the event that operations* do not resume," read the statement signed by Master Mine Service project manager Ma Yun Liang

For those who have difficulties understanding the link between KCM and this company called Master Mine Services; this is a Chinese run mining contractor that is contracted to mine KCM's No.1 Shaft also called No.4 Shaft Complex. These companies mine copper on behalf of KCM, and KCM pays them to pay the miners. These

are the workers who have been declared redundant in essence, because KCM has been unable to pay its contractor.

In simpler English, the KCM contractor is announcing a lay off process to these miners who were assured by the Ministry of Finance that there would be nothing of that sort under the new mining tax regime. Government and KCM can come up with various complicated explanations to distance themselves from this development, but the simple truth is that jobs have been lost at KCM in Chililabombwe, one of the sites that were declared job secure.

We feel, for every job that is lost on the mines under such circumstances, government must take responsibility. If mining stakeholders agreed that they would not lay off any employee, then the Ministry

of Finance must issue an explanation why this is happening. They must face the laid off workers and give them reasons why they should have confidence in this government.

We are not writing this to eulogize KCM or to portray them as victims. We know that the mining company is also a master at manipulating workers, and arm-twisting government. We know, for example that KCM has been importing unprecedented quantities of ore from DRC to process in its smelter. They have increased this cheap import and stopped investing in mine capital development. Thus, they are focusing more on being a processing company instead of being a mining company as per its primary license.

So, there is no doubt that KCM problems go beyond the new mining tax regime. But our concern is that government is failing to secure mining jobs, beyond just issuing statements. They want people to believe that government will be there to provide job security, when in fact they don't have ground presence to monitor accountability.

One thing the PF must know is that for every job that is lost, there are hundreds of extended family beneficiaries who get affected. Today its just one mining shaft at KCM that has been shut down, tomorrow it will be two and three. Before we know it, other mining companies will follow suit and start kicking out workers. In the end, it's the poor struggling families that suffer while those who were issuing meaningless statements continue to drink mineral water in air-conditioned offices. What a shame!

Facebook and Instagram suffer most severe outage ever

Facebook appears to be recovering from a more than 14-hour disruption to all of its products that left them mostly inaccessible across the world.

The company's main social network, its two messaging apps and image-sharing site Instagram were all affected.

Facebook has yet to offer an explanation for the outage.

The last time Facebook had a disruption of this magnitude was in 2008, when the site had 150m users - compared with around 2.3bn monthly users today.

The problems began yesterday afternoon, and only showed real signs of recovery this morning. They meant core platforms many people rely on every day to communicate were rendered mostly useless.

"We're aware that some people are currently having trouble accessing the Facebook family of apps," Facebook said in a statement, posted on Twitter.

"We're working to resolve the issue as soon as possible."

Facebook's apps seemed to be recovering on Thursday morning, with Instagram announcing it was back

In response to rumours posted on other social networks, the company said the outages were not a result of a Distributed Denial of Service attack, known as DDoS - a type of cyber-attack that involves flooding a target service with extremely high volumes of traffic.

An NBC News broadcaster reported the cause was related to "overloaded" databases.

How widespread was the problem? Estimates suggest the issue began around 16:00 GMT on Wednesday.

While Facebook's main service appeared to load, users reported not being able to post.

Those on Instagram were not able to refresh feeds or post new material. Facebook Messenger's desktop version did not load - but the mobile app appeared to allow the sending of some messages; however, users reported glitches with other kinds of content, such as images. WhatsApp, Facebook's other messaging app, had similar problems.

A third-party outage map suggested the problem was global - DownDetector monitors posts on other social networks for users mentioning a loss of service elsewhere. According to the site, areas of Europe and Asia are still reporting problems as of Thursday

Black actors call on Hollywood to hire stylists who understand natural hair

When actors arrive on a movie or television set, there's almost always a beauty team ready to do their makeup and style their hair before filming begins.

But for many black actors, the hairstyling process can often be more complicated. The stylists on set aren't trained to work with natural hair textures, which can mean that actors of color end up styling their own hair. Actors have been sharing these frustrating experiences on Twitter under the trending hashtag #ActingWhileBlack, and many of them have similar stories.

Yvette Nicole Brown, who starred in NBC's "Community," shared on Twitter that many black actresses, including herself, come to set with their hair already done so they can ensure it's styled properly.

She added that many black actresses also bring their own makeup to set because there aren't always foundations available that match their skin tone.

"Aquaman" star Yahya Abdul-Mateen II also weighed in, saying this has long been an issue for black actors in film and TV.

"Empire" star Gabby Sidibe also echoed these messages.

She revealed her strategy for dealing with her hair when there's no trained stylist on set.

"Being Mary Jane" star Gabrielle Union also weighed in. She opened up about what it can be like for a black actress to be styled by someone who doesn't understand her hair texture.

"Timeless" actor Malcolm Barrett chimed in, too,

saying that in his experience, "most Black actors get their hair cut or styled outside of set, often at their own expense."

"Hollywood hairstylists are one size fit all and that 'all' does not include Black hair," he wrote on Twitter. "This has been my experience for the last 20 years in the business and it hasn't changed at all."

This issue extends to the fashion industry as well. Model Olivia Anakwe, who has walked the runway for labels including Oscar de la Renta, Miu Miu and Marc Jacobs, recently wrote a viral Instagram post describing the discrimination she has faced on set because of her hair texture.

She described one incident during Paris Fashion Week when nobody on set knew how to work with her natural hair.

"I arrived backstage where they planned to do cornrows, but not one person on the team knew how to do them without admitting so," she wrote on Instagram. "After one lady attempted and pulled my edges relentlessly, I stood up to find a model who could possibly do it. After asking two models and then the lead/only nail stylist, she was then taken away from her job to do my hair."

Even Tyra Banks dealt with this issue when she was an up-and-coming model. While she hasn't weighed in on the recent discussion on Twitter, the supermodel previously shared that she almost lost her careerdefining Victoria's Secret gig because the stylist on set didn't know how to do her hair. euronews

Eating healthily and exercising can avoid diabetes and erectile dysfunction, say experts

Adopting a healthier lifestyle to avoid becoming diabetic may help men beat erectile dysfunction, a new study suggests. Being predisposed to type 2 diabetes – linked to unhealthy diets and a lack of exercise - could be behind the condition, research has found. Scientists looked at data on more than 220,000 men, 6,000 of whom experienced erectile dysfunction

Using cutting-edge genetic analysis, the team found that having a genetic predisposition to type 2 diabetes was linked with erectile dysfunction, which they said provided evidence that the two are linked.

Co-lead author Dr Anna Murray, of the University of Exeter Medical School, said:

"Erectile dysfunction affects at least one in five men over 60, vet up until now little has been known about its cause.

"Our paper echoes recent findings that the cause can be genetic, and it goes further. We found that a genetic predisposition to type 2 diabetes is linked to erectile dysfunction. "That may mean that if people can reduce their risk of diabetes through healthier lifestyles, they may also avoid developing erectile dysfunction."

Co-lead author Professor Michael Holmes, of the University of Oxford, said: "Our finding is important as diabetes is preventable and indeed one can now achieve 'remission' from diabetes with weight loss, as illustrated in recent clinical

trials.

"This goes beyond finding a genetic link to erectile dysfunction to a message that is of widespread relevance to the general public, especially considering the burgeoning prevalence of diabetes."

Diabetes UK recommends eating lots of fruit and veg and taking exercise to stave off diabetes. Co-first author Dr Jonas Bovijn, also from the University of Oxford, said: "We know that there is observational evidence linking erectile dysfunction and type 2 diabetes, but until now there has not been definitive evidence to show that predisposition to type 2 diabetes causes erectile dysfunction."American Journal of Human Genetics

Federer, seeking a record sixth title in the California desert, needed just 64 minutes to get past Britain's Kyle Edmund 6-1.6-4.

Nadal said his performance on a windy stadium court wasn't as good as his 6-3, 6-1 thirdround win over Argentine Diego Schwartzman.

But he was more than a match for 113th-ranked Krajinovic, breaking him early in each set and saving the only break point he faced.

Nadal, who lifted the Indian Wells trophy in 2007, 2008 and 2013, is in the last eight for the first time in three years after missing last year's edition, skipping both Indian Wells and the Miami Masters with a



hip injury. He next will take on 13thranked Russian Karen Khachanov, who beat world number nine John Isner 6-4, 7-6 (7/1). Khachanov produced just

one ace to the big-serving American's 12 but stretched his record over Isner to 4-0. Fourth-seeded Federer, fresh off his 100th career title, looked poised to finish off Edmund in less than an hour. But the Swiss great had to fight off three break points as he served for the match, just a small speed bump in a match

Juve slipped past Atletico Madrid in Tuesday's second leg, with Cristiano Ronaldo scoring two headers and a penalty to see the Italian club overturn a 2-0 first-leg loss and leaving the Barca star to marvel at the exploits of his former Real Madrid rival. "Cristiano and Juventus were awesome," he told Movistar + following Wednesday's win over Lyon. "It was a big surprise because I thought Atletico would be stronger.

"But Juventus overcame them and Cristiano had a magical night with three goals."

Messi and Barcelona must now wait until Friday's draw to see who they will face in the quarter-finals, but the 31-year-old doesn't see a preferred opponent in the last eight.

"All rivals are difficult, we can't choose," he said. "We have to wait for the draw and see who will be our rival.

"City, Juventus, Ajax, all are really good. Liverpool have offensive success and they showed at Munich. All of them will be complicated."

Sane's new City contract held up by his mother

Leroy Sane's proposed Manchester City contract extension has been held up by his mother, Goal understands.

City have been trying to sign Sane to a new deal since last summer but have so far been frustrated in their attempts to close negotiations.

The Premier League champions still believe the Germany winger will eventually commit his future to the club beyond 2021, when his current deal expires.

But as it stands they have been unable to make serious headway because the 23-year-old's mother, Regina Weber, has proven to be 'difficult' during the course of recent talks, sources close to the situation have told Goal.

Weber won a bronze medal for Germany at the 1984 Olympics for individual rhythmic gymnastics and has been involved in negotiations alongside Sane's father, Souleyman Sane, a former footballer who represented Senegal at international level.

Sane found himself out of the City team at the start of the season, with coach Pep Guardiola concerned about his frame of mind after being caught in the middle of a row between his parents and his thenpregnant girlfriend.

The reigning PFA Young Player of the Year recovered from that situation and has played an important role in City's push for four trophies.

And while he has spent some more time

on the bench in the past few weeks, he returned to the starting line-up and scored one goal and set up three more against his former club Schalke in the Champions League on Tuesday night. Guardiola pointed out, however, that Sane started slowly in the last-16 clash, and suggested it might be down to a loss of confidence due to a lack of regular playing time of late.

"They are young guys," Guardiola said of Sane and his team-mate Raheem Sterling. "These ups and downs happen. I know it's not easy for Leroy, the last games he didn't play too much and the confidence always drops a little bit, I understand, but after 20 minutes he was outstanding for the goal, the assists.
