

President Edgar Lungu says people who think they can jump the gun and takeover the ruling party leadership without being loyal to him, are wasting their time.

Speaking at the Meet the President Dinner last night, President Lungu asked those who had presidential ambitions to first show their loyalty to him. "To my fellow cadres, comrades, I call upon you to remain loyalists to the party. Honorable [Stephen] Kampyongo has remained faithfully loyal and he is now Minister of Home Affairs. I can give myself as an example, it pays to be loyal otherwise I wouldn't be president today. So those of you who think you can jump the gun and think you can be president before your time comes, you are wasting your time," President Lungu said.

"The Bible teaches us in Ecclesiastes 3 that there is a season for everything, a time to laugh and a time to cry, a time to serve and a time to lead. If you can't make a good follower, then you can't make a good leader. I was a good follower to Mr Sata and here I am, I am a good leader. So if you want to be a leader, follow me. This is about discipline. If you cannot accept to be led, then don't look forward to leading others."

He also insisted that the party must welcome new members in order to grow.

"Let me take this opportunity to warn those who don't want to welcome new comers to the PF and say 'this is our party, we are founder members' what founder members? If there were things like that, we wouldn't be here today. As a Christian I can give testimony that Jesus had 12 disciples, they had no phones, no newspapers, no radio and no TV but because they went and convinced people to join them, the universal church of Christ is global. If we want to grow as a party, let us welcome new members. Even those who are against us, as long as you convince them and they

ZANU-PF salutes PF: You will die in power

Zimbabwe's ZANU PF Central Committee member and youth League secretary for land reform and resettlement Anastancia Ndhlovu, yesterday told Zambia's PF officials that "you are going to die in power" because the ruling party has a think tank that explains government policies.

And Home Affairs Minister Stephen Kampyongo has warned PF youths to manage their political ambitions.

Speaking during a meeting with the PF and ANC youth officials on the sidelines of the Meet the President Dinner yesterday, Ndhlovu who is also Zimbabwe's Deputy Minister of Tourism and Hospitality said the PF would die in power because it had a think-tank, which made sure that Zambians understood its programs.

Ndhlovu said this after PMRC executive director Bernadette Deka explained the role of her organisation, which she said was to provide an independent opinion, analysis and review of the government and party policies.

"For the party to have a think tank, I can assure you, you are going to die in power. This is very good. It makes sure that the ordinary person understands the work that government is doing in as far as moving the country forward is concerned," Ndhlovu said.

She added that the ZANU PF had learned something from the Zambian ruling party.

"Sometimes our people revolt against us because they don't understand what government is doing so we have also learnt something from you," said Ndhlovu.

And speaking as PF national youth chairman, Kampyongo said there was no catapult to

"Leadership can be at any given age depending on how you manage yourselves. But we must also make sure that we don't get carried away because ambition management must be a virtue and those that have failed to manage their ambitions have ended up down the drain. So it is always important that as much as we have to realise our potentials, we must appreciate that things must be done in a gradual process," he said.

"There is no catapult where you just spring from somewhere and you want to be at the apex. It doesn't work that way. You don't limit your potential, you compete with elders."

He said loyalty helped him ascend to higher ranks in the

"This ministry I am heading is quite a massive one. But I must say that sometimes mentorship and loyalty pays. The current President made sure that I represented him in serious engagements, which required him to be [there]. But sometimes I thought he was punishing me, I remember

assignments which I thought were to crack me down but they have helped me and so deliberately, I thought I can host you here so that as we go back, we shouldn't be saying the sky is the limit for the youth, it shouldn't be," Kampyongo said. He also advised young people to utilize social media for the advancement of progressive ideas.

"If we don't do that, believe you me, we shall continue to be arm chair critics and the next person will be the one to sort out our problems, it shouldn't be that way," said Kampyongo. Meanwhile, ANC youth Sifiso Mtsweni described President Lungu as an inspirational leader in the region.

He also commended the Patriotic Front for having a vibrant policy think tank saying its research work was extremely beneficial to the party and country as well.

In this audio, Harrison Miti who survived a police shooting incident yesterday says he cannot fail to identify a police officer in broad daylight, insisting he was shot twice in the stomach.

From his hospital bed at UTH, Miti recounts how a police officer in uniform cocked his rifle, pointed to his stomach and pulled the trigger, leaving him gasping on

I was driving from Chilenje. After I reached Kamwala clinic, I found [traffic] congestion. In front of me, there was a truck which looked like it had broken down and it was causing congestion. So I moved from my left lane and started driving in the right lane to overtake the vehicles. In front there was a Toyota Corolla coming and it stopped me," Miti explains in local Nyanja.

"I apologised to the officer and tried to plead with him, even the passangers helped me pleaded but he opened the door started beating me with a gun in his hands. Then he cocked the bullets and shot me in the stomach. When he shot me the second

time, the bullet went and shot the passenger

According to UTH records, the female passenger Janet Zimba was referred home after receiving treatment.

And Miti described how the police officer was dressed, dismissing any possibility that the police officer in question was a criminal disguised in police uniform.

Miti added that he recently moved to Lusaka from Chipata after he found a job at Flash Bus company where he has a peaceful

He begged the police command to help identify the police officer so that he could face the consequences of his actions.

Miti's bus conductor Andrew said he could not believe what he saw.

"Police aoneka enze okolewa mwamene enzokambila, but sinili sure maningi. After ashuta, bantu mu bus banayamba kulila, benangu banayamba kuthaba kuchoka mu bus (The police officer looked drunk from the way he was talking, but I cannot be so sure. After he shot, passengers in the bus started crying while others started running away," Andrew said.

He said Miti drives GOGO Flush Bus number 14 and that he had informed a representative of the Flash Bus company whom he identified as Brave.

A check at the incident scene today morning found blood spots still on the tarmac with some residents and Miti's relatives looking for empty cartridges from the gun they identified as an AK47.

Not everyone in uniform is a genuine police

Earlier today, Police spokesperson issued a statement stating that there was a possibility that the man in police uniform who shot Miti could not be a genuine police officer. In this exclusive interview, Katongo gave an example of a man who was convicted for masquerading as a police officer.

But when asked if she was advising members of the public not to consider everyone they see in police uniform as a genuine police officer, Katongo said she did not want to be implicated by answering the question.

Regulate yourselves, if you fail, we will — Lungu tells journalists

President Edgar Lungu says journalists must regulate themselves or the State will be forced to regulate them. Speaking before departure for Durban, South Africa today, President Lungu said while he did not subscribe to the idea that the state should regulate media practitioners, it will only be logical to do so if journalists failed to regulate themselves.

"Congratulations [for commemorating World Press Freedom Day], be part of the process of growth. The media is part of us. For us, we hope that you will move with us. Please don't take sides. Be neutral, tell us when we are wrong and above all, be friendly to us. For those who are with us and those who oppose us, just articulate their views and at the end of the day we will benefit but if the media becomes a channel even for issues which are going to divide us, then it won't help," President Lungu said.

"So unite us, criticize us and upload us when need be but I really think without you we can't go anywhere. So Zambia needs a free press. But also, let's talk about regulation, regulate yourselves, if you want us to regulate you, we will but I don't subscribe to the idea that the state should regulate the media but if you refuse to regulate yourselves we will. But I don't think under my watch I will regulate anybody." President Lungu also emphasized the need for him to constantly engage other Heads of State in finding solutions to some of the challenges the country was facing.

"There are a lot of things pertaining to the economy. The more we talk to each other as Africans, the more we create space for ourselves. It is a regional issue, in fact, SADC is one, if you come to Zambia and you come to South Africa we're one...for us, Zambia has been positioning itself and if the President is staying at home all the time and not speaking to our neighbors, then Zambia will sink. But I am glad that we are on course," said President Lungu.

And Archbishop Mpundu says the church is worried by the unprofessional conduct of police who are executing political orders to brutalise citizens.

In a statement today, the Archbishop of Lusaka bemoaned the breakdown of the rule of law.

"Our country is now all, except in designation, a dictatorship and if it is not yet, then we are not far from it. Our political leaders in the ruling party often issue intimidating statements that frighten people and make us fear for the immediate and future. This must be stopped and reversed henceforth... The democratic principles we have come to know have been violated left, right and centre so that instead of going forward and consolidating our still fragile democracy, we are retrogressing and not so slowly!" Archbishop Mpundu

He observed that people now feared to speak out against injustice.

"There is fear and trembling among the people shown in the way they are afraid to speak out against injustices. This is due to several actions by government which were meant to instill fear into and intimidate the masses. One does not need to belong to a political party in order for him or her to speak out on the misdeeds happening in the nation. Furthermore, we are witnesses to what transpired during the run-up to the August 2016 general elections when several media houses were harassed and finally closed. The recent happenings were not reported by several media houses because of the heavy presence of the Police," he stated.

Archbishop Mpundu said divisions in the country would not magically disappear.

"The politicians especially those in the ruling party must realise that the nation they are governing is deeply divided between those who voted for UPND and those who voted for PF in the last elections. Let the politicians of both parties

take it from us since we always have our ears close to the ground that our country now stands on the edge. It is no use playing an ostrich game by burying our heads in the sand thinking that the storm will pass away. It will not, at least not before it has done great harm to this nation," he stated. "The use of force and intimidation are not the whatsoever. solution Only genuine and sincere dialogue aimed at national reconciliation is the long-term solution. This reconciliation must be firmly rooted in the Christian values of truth, forgiveness, peace, unity, social justice and freedom. Let us learn to bury our immediate past and rise again to new life...Our nation is much larger and transcends our present and future individual or collective political fortunes."

And Archbishop Mpundu condemned police for being unprofessional and brutal on critics of the ruling party.

"It is the same story from one administration to the other and the present government is no exception, if not one of the best examples of the misdeed just mentioned! As a result of brutalising the people through the Police Service, the general public is reduced to fear so that the order of the day is corruption and misuse of public funds. Anyone who criticises the government for wrong doing is sure to have the police unleashed on him or her," he observed.

"We have always been concerned about the selective application of the Public Order Act by the Police. It is quite disgraceful that a

quarter of a century after the return to plural politics and more than half a century of political independence from Great Britain, our governments which we put into power through our votes use the Public Order Act to oppress political opponents and prevent them from organizing and assembling together political rallies and to openly express themselves instead of protecting the rights and liberties of the very people who put them into power. Paradoxically, each political party in opposition goes through the biased use of this notorious Act but once in power, they find it so useful that they do nothing to modify or repeal it. Disgraceful indeed!"

Archbishop Mpundu implored police to at least apply the Public Order Act professionally.

He also observed that the Judiciary was a letdown.

"It is an open secret that the Judiciary have let the country down by failing to stand up to political manipulation and corruption. How can one explain the failure of the Constitutional Court to hear and exhaustively conclude a presidential petition...Where is the Judiciary to call the Executive to attention?" he

The Archbishop of Lusaka also condemned the manner in which UPND leader Hakainde Hichilema was arrested, saying it had only heightened tension in the country.

Archbishop Mpundu further denounced attacks on the Law Association of Zambia, praying that moves to kill the institution would fail.

Kasonde stays: KFB withdraws impeachment motion

Kelvin Bwalya Fube has withdrawn the motion to impeach Linda Kasonde and the current LAZ executive.

This was after a majority of LAZ members debated against the impeachment motion, saying they would rather be disbanded by parliament than be cowed down by threats from politicians.

KBF then said to foster unity, he was withdrawing the motion.

Earlier LAZ members assembled at Radison Blu Hotel to vote for or against the current LAZ executive.

A motion was raised by lawyer Terrence Chabu, demanding that the LAZ executive must not chair the Extraordinary General Meeting because they may be conflicted, as they were facing a vote of no confidence.

But the floor took the view that the LAZ rules were clear that only the executive can chair such a meeting.

Lawyer Augustine Hamwela then raise a preliminary issue against the proposed vote of no confidence, arguing that the Law Association of Zambia Rules do not provide for the Law Association of Zambia executive to leave office through a vote of no confidence.

He argued that Rule 10 of the LAZ rules states that the executive stays for 2 years and that they can only vacate office on prescribed grounds including insanity and bankruptcy.

LAZ president Linda Kasonde who is chairing the meeting still allowed the motion to go ahead.

KBF, the mover of the motion then proposed that the matter is taken to arbitration.

After debates, he withdrew the motion.

A police officer Martin Musamba Chime, 43, today narrated before magistrate Malumani how UPND leader Hakainde Hichilema used words "mother fuckers", "idiots" and "ass holes" against police officers who went to arrest him.

But defence lawyers, led by Keith Mweemba asked the witness why no police officer recorded a statement from him, explaining how HH insulted him.

Below is the verbatim of court proceedings in the case of using insulting language against HH

Witness: I was at the office when we received intelligence information that there were people who were planning to go and cause confusion to the officers who had gone to arrest Mr Hakainde Hichilema, the UPND leader at his house. I was accompanied by Mr Mbita, deputy chief inspector Mulungisha and detective inspector Hamweene. We arrived at Mr Hichilema's house around 09:20 hours and entered into his premises. Whilst there, his lawyers comprising of Mr Jack Mwiimbu, Chali Muleza, Nelly Mutti, and Ms Martha Mushipe arrived after about 30 mins.

Whilst there, in the company of assistant commissioner of police Paston Mukomongo, we had a chat with Mr Hichilema's lawyers Mr Mwiimbu and Mr Muleza, and informed them why we were there. They promised that they were going to avail their client to us.

Around 11 to 11:30 hours, Mr HH and his family members came out of his house and came close to where we were standing... Where we were standing your honor. He asked who the in charge was. And before we could even answer him, he started showering insults on us the police and I quote, he said: "can you remove all these dogs from my yard! Mother fuckers, idiots, and ass holes"

Your honour, at that point, I restrained myself personally and protested to Mr Jack Mwiimbu so that they can calm down their client to stop insulting us as we were there commissioned.

Mr Jack Mwiimbu went to his client and calmed him down.

To our surprise, Mr Hichilema continued repeating the said insults, which I have mentioned. It was at that point your honour, through his lawyers, we asked him to accompany us to woodlands police station.

Witness continues: From there, Mr Hichilema and his body

guards and other people who said they were family members jumped into a Toyota cruiser and went to Woodlands police station.

There were three people who accompanied him, they were male and we told them that they were at liberty to accompany their relative and we proceeded to Woodlands Police Station. Personally, I felt very hurt by those insults because they were very provocative, injurious but I exercised restraint. From Woodlands, we proceeded to Lilayi police where Mr Hichilema was detained at Lilayi Police Post for treason.

Witness then identified Hichilema, but the defense team told him not to get too close to touch him.

During examination-in-chief, the witness said: At Lilayi HH repeated the insults and that he reported the matter to Kabwata Police, before the accused was arrested for use of insulting language.

CROSS-EXAMINATION

In cross-examination, Mweemba asked the witness if he had ever been arrested for a criminal offence, to which the state witness answered in the affirmative.

Mweemba: Have you ever been charged and prosecuted by the courts of law for a criminal offense?

Witness: Yes

Mweemba: What did you do? Witness: Your Honor, it was on a fraudulent dealing of a motor vehicle.

Mweemba: Who was in charge of the operation? [at HH's house] Witness: Mr Mokokomongo, and I was the deputy.

Mweemba: you have not produced any court warrant [that allowed you] to conduct an operation? Witness: We don't need a warrant.

Mweemba: My question is, have you produced any warrant? Witness: No ,I didn't produce a

search warrant. Mweemba: On who's instruction was the [person] incharge of the operating, according to your

knowledge? At this point, magistrate tells the witness to answer the questions

as they are asked and not what he wants. Witness: there was no superior

order on our operation. Mweemba: So you moved on

Witness: No.

Mweemba: We want to know who planned it

Witness: By the time we arrived

your own? It was a harp-hazard operation?

Mweemba: The person who you submitted the report to is he officer in charge? Witness: No. But...

Mweemba: Just that. Don't add anything more Witness: He is not officer in

charge. Mweemba: In what capacity did you address this report to Mr

Mbita? Witness: Your Honor, may I be guided...

Magistrate: The ranking system does not apply when reporting cases?

Witness: In that case, I submitted to Mr Mbita through the officer in charge

At this point, people in the courtroom burst out laughing. Mweemba: So clearly, you have told lies on oath, you have changed

Witness: I have not lied. The report was addressed to the officer in charge through Mr Mbita.

Mweemba: In who's custody is this document? Witness: As at now they are with

the state. With NPA.

Mweemba: Who in particular? Witness: The NPA is very wide. Mweemba: You have lamentably failed to produce the occurrence book as evidence to prove that you indeed went to Kabwata police to complain, not so?

Witness: It's not produced. Mweemba: Other than your oral testimony, you have not produced any video or recorded evidence? Witness: It was not recorded but we were insulted.

Mweemba: Is it your position that other than your oral evidence, there is no other evidence? Witness: That's true

Mweemba: So it will be your word against the accused's word? Witness: Yes, I am here in this court because of the insults

Mweemba: So all there is is your word against the accused? I'm asking because we don't want anyone to go and manufacture evidence. Witness: Yes

Mweemba: So apart from yourself, are you saying that the insults were directed at all the police who were at that house? Mention them.

Witness: It is not possible to mention them. Mweemba: Were you authorized

to damage property? No property Witness: damaged.

(People murmuring)

Mweemba: That's not my question, my question is were you authorized to damage property? Witness: You are diverting from the insulting

At this point people continue murmuring, prompting magistrate to obstruct the proceedings of the

The state then interjected, saying, "We object, the witness has already answered that question.

Mweemba: It means the witness has lied on oath that no property was damaged.

Magistrate Malumani: If the witness is not telling the truth and later in the evidence it shows that property was damaged, it will completely destroy the states case because it doesn't help to lie on

Mweemba: Are you aware that police stole other items? Witness: I'm not aware

State advocate: We want to object, what's the relevance of all these questions outside the offense? Magistrate Malumani: The defense is in order to ask any question they wish which can destroy the evidence of the witness... according to the authority of Muna Ndulo, the defense can ask any question under crossexamination.

Judge Nkonde stops LAZ from joining *Post* case

High Court judge Sunday Nkonde has thrown out an application by the Law Association of Zambia to join Post Newspaper liquidation case, describing the application as lacking merit.

Judge Nkonde in his ruling said the application by LAZ to join proceedings as amicus curiae might just delay the disposal of the proceedings to the prejudice of the parties. He said the nature of the proceedings required the disposal of the matter expeditiously.

Judge Nkonde also explained that the lawyers representing Post Newspapers were learned counsels with many years of experience at the bar and therefore they were very competent to represent without assistance from LAZ.

Judge Nkonde said LAZ must at all times endeavor to let its members engage in adversarial advocacy independently. "LAZ needs no reminder that is should be in the forefront of educating the public that courts have mechanisms established over a long period of time for correcting errors, imperfections and misapplication of the law in proceedings through applications, appeals etc by aggrieved parties," said judge Nkonde.

"These mechanisms if undermined quickly eat up the very fabric of the rule of law as an important component of a democratic society. The inevitable consequence is that anarchy wins."

Judge Nkonde however said he found the context of the response in the affidavit in opposition as at times very personal and unnecessary.

HH wanted to declare himself President at Kuomboka — State

The state has amended the indictment on the treason charge against Hakainde Hichilema, stating that the opposition leader wanted to declare himself President of the Republic of Zambia at the Kuomboka Ceremony in Mongu.

And HH has pleaded not guilty to the charges of obstructing the presidential motorcade and using insulting language.

Earlier, Lusaka magistrate Greenwell Malumani ruled that the state failed to state any overt act made by HH in order to overthrow the government.

Referring to the Shamwana case, Magistrate Malumani said the charge was clear and there was evidence of meetings held in planning the capture of then President Kaunda.

"In the light of the foregoing, the purported treason charge exists in a vacuum," ruled magistrate Malumani, but clarified that the charge of treason could only be tried in the High Court.

He added that the subordinate court could not quash such an indictment but open an inquiry instead.

"It is of the opinion of this court that the charge has no substance to be submitted for trail," he said.

Magistrate Malumani allowed the state submit a fresh indictment of treason against HH which would be heard in the High Court.

The State However produced the indictment accompanying other charges with an addition of overt acts committed by HH.

In Overt Act one, the state claimed that on April 5, 2017 HH together with others conspired to mobilise an advance party to ensure that he was to be accorded the status of President of the republic of Zambia at the Kuomboka Ceremony in Mongu.

In Overt Act two, the state submitted that on April 8, 2017, HH and over 60 other unknown people and being on a convoy of motor vehicles on the Mongu Limulunga Road did obstruct the presidential motorcade, an act that was likely to cause death or grievous harm to the President of the Republic of Zambia, in order to usurp the executive power of the state.

Magistrate Malumani said he could not allow the treason charge to be submitted jointly, but accepted the indictment and called for a break to study the details in chambers.

HH took advantage of the break to chat with his wife and other family members.

When the hearing resumed, the separated indictment was read out and HH pleaded not guilty to the charges of obstructing the presidential motorcade and using insulting language.

His co-accused also said they understood the charge but pleaded not guilty.

Court acquits Komboni Radio director

The Lusaka Magistrates' Court has acquitted Komboni Radio Director Lesa Kasoma of assaulting a police officer, noting that police were over enthusiastic in discharging their duties.

Lesa was accused of assaulting constable Simon Chisanga when she allegedly bit him on the arm last year when she went to have her radio station re-opened after the Independent Broadcasting Authority lifted the suspension on its

license.

When the matter came up for judgment today, magistrate Felix Kaoma ruled that Lesa acted in self defense against the police officers.

He said it was hard for him to accept Chisanga's claim that she bit him when he was apprehending her.

Magistrate Kaoma further ruled that Lesa had every right to access her premises and did not need permission from police. On October 5, 2016, about five police officers brutally beat up Lesa when they blocked her from accessing Komboni Radio premises despite the IBA lifting its broadcasting license.

Lesa suffered a black eye and body pains and she as admitted at the University Teaching Hospital for a day but police arrested and charged her with assault. However, Vice-President Inonge Wina was forced to render an apology to Lesa in Parliament following public outcry.

Hichilema trial verbatim

We received information from our police intelligence that some people were planning to go and cause problems to the officers who were assigned earlier to the same place to go and apprehend Mr Hakainde Hichilema the leader of the UPND. So we went there to assess. When we arrived around 9:30, we went straight to his residence. And we found some people there and some police officers within. Shortly, I saw Mr Jack Mwiimbu who happens to be a lawyer, Nelly mutti, Ms Mushipe who arrived at the premises. We greeted each other. Then, Mr jack Mwiimbu went inside the house of Mr Hakainde. Shortly, around 11:00 hours Mr Hakainde Hichilema came out of his house together with some relatives and he came to where we were standing. Then he uttered some words. The words he uttered where you idiots, mother fuckers, 'hass hole',

(People in court laugh, as witness tries to correct his pronunciation) Witness: It was directed at us and he was fuming. Them Mr Musamba Chime cautioned him to stop using such words. He continued then I heard Mr jack Mwiimbu and Ms Nelly Mutti telling him to calm down. myself I did nothing, I just retrained myself but I was injured because I am not a dog. We ordered him to get on a car then Mr Hichilema refused that 'no, I don't want to get on your car, you want to poison me... then he chose a car which he wanted to get on. He chose an open white land cruiser together with some of his relatives. So that's how we got him and went to woodlands police. At woodlands police, he was transferred to Lilayi where he was detained for treason. The insults were reported at Kabwata Police Station. After the report, we waited for court proceedings. State: Your Honour. That's all from

State: We are unable to proceed with the next witness who is Mr Hamweene. We have noted the courts sentiments with regards to adjournments, but we would like to note that this case was given two dates, today and tomorrow. So we would like to seek an adjournment so that we can call our remaining

Defence through Jack Mwiimbu: we reject the application by the state. All the witnesses have been outside all afternoon sitting. We

don't appreciate the difficulties the state is facing to call their witnesses this afternoon. We believe that we can conclude this afternoon and if we don't, the issues of collusion will arise because we are aware that the witnesses are confiding in each other.

Another defence lawyer: May I just add that we have a situation tomorrow because [another matter] is coming up before magistrate Simusamba for a ruling Magistrate: Counsel, your witnesses were outside. Why can't they come?

State: We are unable to proceed with Mr Hamweene because we would like Mr Mbita to come first. Magistrate: Is Mr Mbita there? State: Yes he is.

Magistrate: Tell him to come in. State: May the record indicate that we asked for an adjournment that we are not able to proceed and the court made a ruling.

Magistrate: Yes, the record will show. I wish to expedite this matter. I therefore order that the available witness come in and

testify. State: I would like to state that justice is a two way thing, on the one part, you have the complainant represented by the prosecution, on the other part, there is the accused person represented by the defense counsel and in order to meet the ends of justice, I submit that it is the courts responsibility to balance both sides in order to reach the ends of justice. Given the ruling, we apply that the matter be stood down for 30 minutes for us to liaise with the witness, as we did not intend to call Mr Mbita before Mr Hamweene.

Defence: Much as we agree that there should be balance, the state must appreciate that this is their case and they have had all the time in the world to prosecute this matter. There is no plausible ground as to why the state cannot comply with the Constitution. It is mandatory. It is always a principle of law that while balance must be stricken, but the benefit lies against the accused persons who may be in custody against the mighty state. We all know that there is no written law as regards the order of witnesses. It is just a matter of practice and preference that arresting officers choose to testify last.

The state can put their house in order in the time they have requested. We have no objection but this matter must be concluded

Magistrate: I grant them 15 minutes. I will return after 15 minutes.

THIRD WITNESS

Third state officer Mbita Mpazi, 42, is called to the witness box Witness 3: On 9th April, I was assigned to investigate three cases. Namely: treason, disobedience to lawful orders and disobeying an officer on duty in which the accused was Mr Hakainde Hichilema.

Then on 11th April around 9 hours,

I accompanied other officers to the residence of Mr Hakainde Hichilema at plot number 10747 off leopards hill in Lusaka. This was after we had received an intelligence information that a group of people were organizing themselves to go and disrupt the operation which was at the said premises which started on the 10th April in the evenings.

Upon reaching the said premises outside the gate, there were relatives for Mr Hakainde Hichilema. One of them said he was the uncle. He further said 'Mr Hichilema wants to avail himself but in the presence of his lawyers'. Then we waited for a while, I was with Mr Musamba Chime, deputy chief inspector Mulungisha and deputy inspector Hamweene.

Then the lawyers came and I was able to identify three of them which included Mr Jack Mwiimbu, madam Nelly Mutti and madam Martha Mushipe and another one who I just remember his face.

We proceeded inside the premises. We were led by the lawyers. When we reached near the house, we were told by the lawyers to wait a bit. A few minutes later, I saw Mr Hakainde Hichilema and other family members. When he came out and saw the presence of the officers, by this time we were two groups, plain clothed and uniformed police officers.

Then he charged at us police officers and he looked very upset. Then he asked who was the in charge of the police officers who were at his premises. Before we could answer him, he started insulting us whilst he was looking at those officers who were in uniform, he said "you dogs, get out from here, mother fucker, idiots, asshole"

Then my fellow officers, Mr Musamba Chime was angered and he had to approach one of the lawyers I came to know as Mr Muleza to tell his client to calm down but he continued insulting because it hurt my feelings and I had to approach the other counsel Madam Mushipe but unfortunately, he tried to beat me up. He was in a boxing position like this

(Illustrates clenched fists) (Laughter in court)

Defence then asks the witness if he was referring to female lawyer Mushipe as "he" and the witness



Central Province Permanent Secretary Chanda Kabwe says fertile land and good rainfall in the province has attracted more people to invest in the agriculture sector.

Speaking in an interview, Kabwe outlined major investment activities taking place in his Province.

"We have seen people coming on board to invest in the agricultural sector. You are aware that central province has fertile land and good rainfall pattern which has attracted people to come and invest in the agriculture sector. Plus the government's opening up

Kabwe boasts of swelling investment in C/Province

of the area by provision of the road network in areas where people are coming to farm. It is boosting the investment and investor confidence in central province, so the future of central province looks very

bright," Kabwe said. He said the putting up of

center pivots in Mkushi, Luano, and Ngabwe by some investors would create employment and business opportunities for the locals. "And all these are coming in

to benefit the locals because people who are putting up center pivots in Mkushi, Luano, and Ngabwe are creating employment opportunity for the local people. They are also creating a skill of transfer because people now know how to operate tractors, they know how to operate these center pivots and that's a skill that people will die with. And also its creating business opportunities for our people," Kabwe said.

Meanwhile Kabwe disclosed that a number of investors had shown interest to invest in the mining, tourism, and energy sectors within the province.

"Investors are investing in manganese, gold and copper. We have seen people investing in the tourism sector. Others have invested in the energy sector. We have seen itezhitezhi coming on board in partnership with Zesco and Tata, Lusemfwa hydra station in central province," he said.

"Other investors in Serenje who are putting up a wind energy in Serenje. We have another project called Pensulo in Serenje, that is powering northern and Eastern province. We have a solar farm in Kabwe which is coming and investors are on site. We have another solar farm in Mumbwa which has advanced, about 70 percent works done."

Kabwe further disclosed that some indigenous Zambians were investing in Kabwe fabrics known as Kifiko.

"We have over five mines in central province, one in chief Chamuka's area, three mines in Mkushi copper and manganese, one manganese mine in Serenje, and there are others who want to open another mine in Luano to do with gold. Remember where we are coming from, we had crises in the energy sector when the water levels were low, but now we have people who are investing with huge investment in Serenje," said Kabwe.

"We have indigenous Zambians who are investing in Kabwe fabrics known as Kifiko. We are encouraging the local people to come and invest, all these cotton farmers, commercial farmers should come on board and invest.

Zambia National Farmers Union (ZNFU) president Jarvis Zimba diversifying the economy into an agricultural-based one cannot be achieved without putting in place proper incentives.

In an interview, Zimba said this year's AGRITECH Expo (27th to 29th April), which attracted eight countries with over 40 foreign companies exhibiting was a great success.

"So [Agriculture] is the only sector that can massively create employment. The only thing we need to do correctly, especially for Zambia is let us zero rate agriculture for a couple of years, then you are going to see the development," Zimba said.

"The last time we did that, if I can remember was when (Ng'andu) Magande was Minister of Finance. It was the first time in Zambia that we started seeing the centre pivot...

This is where we need to go back again because if you put in too many taxes, the person who gets hit at the end of the day is a farmer who is very vulnerable, in terms of price. If you zero rate, then you have got the political will."

Zimba said his vision through ZNFU was to transform the country into an agricultural-based economy, "so that we can get rid of this myth within our brains that copper is the only thing".

"Let us look at other countries. Do they have mines in Malawi? It is very little but it is all about agriculture. New Zealand, what are they famous for? If you look at Netherlands itself, where is the economy based? It is purely agriculture in the Netherlands," he noted.

The ZNFU president said the main objective of AGRITECH Expo was to promote technology in the agricultural sector.

"This is an international

event. Last year, we had only two countries but this year, we have got eight countries which have come to showcase their countries; and in there we had forty foreign companies which came to exhibit. You can see that it is becoming more attractive and mind | at your back, it is a kind of | market."

prosecutors State today expressed concern that Hakainde Hichilema's lawyers were asking a witness questions pertaining to the treason case which is before a different court.

This is in a case where the UPND leader is charged with the offence of using insulting language, and the concern was raised after the defence continued to crossexamine the state witness who is also an arresting officer in the treason case.

In his ruling, magistrate Greenwell Malumni said the witness had no option but to answer all questions put to him regardless of whether they affected the treason matter because he was an arresting officer in both cases.

Below is the verbatim of the continued prosecution of HH.

CROSS-EXAMINATION CONTINUES:

Defence lawyer Keith Mweemba: We ended when you were talking about your report and investigations. According to your investigations, how was the root lining done? Who was in charge? Witness 3: I am not able to answer that for security reasons

Defence: It is there in your report. We want to determine bad faith. you have to answer and you will

Witness 3: On that position, I am unable to answer

Defence: The law binds you to answer and we are allowed to make applications if you don't. This is the last warning

Witness 3: I don't know who was in charge

Defence: Okay, how was the root lining done?

Witness 3: I don't know, I can't answer that

Magistrate: (Reads him provisions in the criminal procedure codes which allows the court to detain him for failing to answer questions)

Defence: Your job is to answer the question. How was the root lining



The job of a watchmaker is not to tell time, but to create an instrument with which you can tell what time it is. However, a watchmaker who doesn't know what time it is cannot succeed in his job without misleading others.

Our job as journalists is to provide information through which you, the public can tell the kind of times we live in. However, if as reporters we are oblivious to the state of our nation, we are bound to misinform

Every year on May 3, we journalists celebrate the fundamental principles of press freedom; we show cause why our existence in accordance with Article 19 of the 1948 Universal Declaration of Human Rights must be defended. We pay tribute to journalists who have lost lives in the line of duty, and we remind governments of their duty to respect and uphold the people's rights to freedom of expression.

But if there are any journalists in Zambia this year who are celebrating World Press Freedom Day with a view to advancing any of the above causes, then they are not any different from those who are suppressing freedom of expression.

Today, we will march like we always do; we will listen to rhetoric from our media leaders demanding the same old Access to Information Bill, and we will hear more threats from government officials sugarcoated in their commitment to protecting ETHICAL media houses. Like mourners at the funeral of a relative who succumbed to AIDS, we will regret the death of press freedom in Zambia without mentioning or condemning the killer.

But we know the truth and the truth has to be said. If there is any immunity left for journalists to report facts, then there is no better day to do so than May 3, 2017 when we join the Patriotic Front government under President Edgar Lungu as they celebrate their achievement in raping independent journalism. Like a time conscious watchmaker, we are alive to the fact that this PF government has captured private media in one way or another and is molesting it without a Vaseline - as Julius Malema put it.

From May 3, 2016 to date, iournalists have made the biggest news headlines. This has been a year in which politicians reported the news they wanted the public to hear while journalists were on the run. A year when the civil society assumed a front row sit in witnessing injustice and chose to join the Church in doing nothing about it.

At News Diggers!, we watch in awe how this government has succeeded to pit journalist against journalist, media house against another, leaving no one to report the political injustices being inflicted on political parties and individuals who dare criticise those in power.

ZNBC is trying to stifle Prime TV using digital subscription fees while Muvi TV has been torn apart with the birth of Diamond TV. The Daily Nation is still celebrating the demise of The Post Newspaper while its own editorial independence is diminishing. The damage caused to the media landscape has left an indelible mark on our democracy and the economy thereof. What is worse is that no one in government is listening. And while we are still on speaking the truth, we might as well say that our Minister of Information is empty.

We don't mind the fact that President Edgar Lungu appointed a journalists to run the Ministry of Agriculture and a musician in charge of the Ministry of Justice - it is his party in power and he can choose who to appoint. But it is also within our right, at least for today, to inform him that if it was his intention to appoint the most ignorant person about journalism, to be in charge of the ministry of Information and Broadcasting,

then he made a good choice in Honourable Kampamba Mulenga.

pity those vastly experienced journalists who work as directors under Honourable Mulenga because even though they can't say it, they know that their ministry is on standstill until a knowledgeable person, who doesn't necessarily need to be a journalist, takes over.

We say Honourable Mulenga is empty because we have interacted with her and we believe that she doesn't clearly understand the role of the media and the institutions regulate which operations.

When the International Press Institute admitted News Diggers! as a fully paid up member, and implored the PF government to respect the role of private media, our Information Minister had this to say:

"We as government, welcome News Diggers! if it is going to comply with the ethics. If

it is in compliance with the regulations stipulated under the IBA it shall be protected. News can be bad or good but, as long as it is factual."

We wondered which clause of the Independent Broadcasting Authority Act is responsible for regulating online media. A simple check on the IBA

website would have helped the minister realise that the Authority is responsible for regulating the broadcasting industry in Zambia, by granting renewing, suspending and cancelling RADIO and TELEVISION broadcast licences; not online media.

When Honourable Mulenga went to ZNBC to familiarise herself with the operations of the national broadcaster, she $told\,staff\,that\,she\,was\,impressed$ with the professional work done by Radio One, Radio Two, RADIO THREE and Radio Four. How many people in Zambia don't know that there is no RADIO THREE at Mass Media?

Even if we are to negotiate

for tolerance from the PF government on our special Day, where do we start from? Honourable Mulenga boasts that it is only her government that has managed to issue 110 radio stations licenses across the country and 67 television broadcasting licences; but is it a secret that this is the only government in Zambia's history which managed to shut down four critical private media organisations in less that six months?

Today as we commemorate World Press Freedom Day in Zambia, we must realise that we are saying goodbye to press freedom. Those of us in the private media will be conceding defeat to a ruthless regime unless we resist the paymaster and stick to ethical, credible journalism. Yes there is still hope, but we will never regain our journalistic liberty until we end the hatred between journalist and journalist, the scheming by one media house against another.

"I have no particular love for the idealized "worker" as he appears in the bourgeois Communist's mind, but when I see an actual flesh-and-blood worker in conflict with his natural enemy, the policeman, I do not have to ask myself which side I am on." George Orwell

As a Member of Parliament, Garry Nkombo is not exactly an "idealized worker" in the mind of anyone let alone a Communist, but seeing him in conflict with Constable Spider Ngoma left me in no doubt which side I am on.

Even if Nkombo "assaulted" the policeman a ludicrous claim for a "victim" who was armed with an AK-47 I would not be alone in sympathising with the honorable member and his wife. as well as the countless other victims of police harassment and brutality. Surely the Zambia Police Service must be among the public institutions least trusted by the general public, and little wonder.

A Brief History of the Police State in Zambia

The fact remains, however, that "To Serve and Protect" the general public has never been the role of police forces. Worldwide, ruling classes have instead used police to protect themselves and their property and oppress poor and working people who get uppity ever since police forces were invented.

"Before the nineteenth century, there were no police forces that we would recognize as such anywhere in the world," according to American history professor Sam Mitrani. "In the Northern United States. there was a system of elected constables and sheriffs, much more responsible to the population in a very direct way than the police are today. In the South, the closest thing to a police force was the slave patrols. Then, as Northern cities grew and filled with mostly immigrant wage workers who were physically and socially separated from the ruling class, the wealthy elite who ran the various municipal governments hired hundreds and then thousands of armed men to impose order on the new working class neighborhoods." As Industrialisation gathered pace in the US and Europe, the new working classes clashed with their bosses in riots and strike actions, according to Prof

Mitrani: "In the aftermath of these movements, the police increasingly presented

themselves as a thin blue line protecting civilization, by which they meant bourgeois civilization, from the disorder of the working class. This ideology of order that developed in the late nineteenth century echoes down to today except that today, poor black and Latino people are the main threat, rather than immigrant workers... There was a never a time when the big city police neutrally enforced "the law," or came anywhere close to that ideal (for that matter, the law itself has never been neutral)." In Africa, police forces were introduced by European colonial authorities. The British South Africa Police was the first constabulary in the region, founded by Cecil Rhodes' British South Africa Company in 1889 as a paramilitary force. The line between police and military duties was blurred

suppression of local discontent, for example during the Matebele Here in Zambia, the North-Eastern Rhodesia Constabulary was formed in 1903, and tasked with guarding government property, escorting caravans, liasing with local chiefs, as well as arresting and guarding native prisoners. This force was about 200-strong and included unarmed natives constables who could make arrests on warrant or if an offence was

Within a few decades, however, opposition to colonialism had grown and so too had the suppression of dissent by the colonial government and police. In 1960, a series of discussions with future president Kenneth Kaunda were published under the title "Black Government?" These musing of Kaunda contained the following insights:

"The demands and aspirations of the majority frighten the minority groups in power, and they react by employing various methods in order to safeguard their privileged positions. They will employ all sorts of methods to keep that power in their hands. As a result police states are created, men lose sight of the most important values and are guided by fear, suspicion and hatred... [A] police state is where the following conditions apply: 1) Overruling or short-circuiting of the Legislature or Judiciary, 2) Imposition of arbitrary laws by force, 3) Denial of the right of opposition to oppose, and 4) Drastic curtailment of freedom of expression both written and spoken."

Post-independence, African countries continued to employ colonial police tactics including laws such as the Public Order Act and Emergency powers here in Zambia rather than rewrite laws based on the inalienable rights of citizens. After all, what better way for the newly-christened African

ruling classes to control their populations than by using the old masters' techniques? So it was that Kaunda went from bemoaning colonial police states in 1960 to creating his own in the decade after Independence.

In his brilliant and penetrating memoirs, Valentine Musakanya demonstrated this persuasively:

"In many African states it is fascism [acting] against the majority blacks by the minority ruling elite... As Kaunda himself points out, 'The violence of the top-dog (rulers) is often subtle and invisible. It spans a range which takes in international economic pressures, control of the media, manipulation of the education system and psychological conditioning, as well as the more visible strong-arm methods.' These are weapons well developed and practiced by Kaunda himself." While it is up for debate whether or not we are approaching a police state in Zambia today, there is no doubt that under Kaunda there existed severe authoritarian rule enforced by the police.

Throughout his 27 years in power, Kaunda repeatedly took advantage of the "Preservation of Public Security Regulations" and the State of Emergency declared in 1964 against the "insurrection" of Alice Lenshina and the Lumpa church to mercilessly terrorise and detain his political enemies and distract the Zambian people from his economic failures.

"Detention laws are only found in primitive political systems, that is where the minority or an unpopular government is suppressing the majority in order to remain in power," wrote Musakanya while himself incarcerated under such detention powers.

Thankfully we no longer have Emergency powers in effect, nor arbitrary detention laws in this country. We also now have the civil society organizations such as the Human Rights Commission, not to mention that Internet and social media, which have proven to be highly effective in promoting freedom of expression and the free exchange of ideas and opinions as provided for by our innate human rights.

Clearly there is always room for improvement. Some 26 years after the return of democracy in Zambia and well into the globalized world of the 21st century colonial-era such as the Public Order Act still prevent Zambians from exercising their rights to freedom of assembly.

It's time we take steps to strengthen our democracy by overturning outdated colonial laws such as the POA, and crafting our own based on universal human rights and the social welfare of all Zambians. To do anything less runs the

risk of sliding backward into authoritarianism.

Mukata arrested for murder

Police Spokesperson Esther Mwaata-Katongo has confirmed the arrest of opposition UPND Chilanga member of parliament Keith Mukata for allegedly shooting a security officer.

In a statement Katongo said Mukata has been detained together with his wife Charmine Musonda.

"We received a report of murder which occurred today the 6th May 2017 at around 00:40 hours at house number 4 Alex Masala close in Rhodes Park in which male Namakau Kalila Kwenda aged 63 years old of Ngombe, a security guard employed by Men in Black security company and deployed at house number 4 Alex Masala close in Rhodes Park which

is the office of AKM Legal Practitioners, the law firm of Keith Akekelwa Mukata has been shot dead," Katongo explained. "Facts are that around 00:40 hours, patrons at Spice Restaurant which is next to AKM Legal Practitioners heard some gun shots from the premises of AKM Legal Practitioners and when they went out they shortly heard Honourable Keith Mukata shouting for help that someone has been shot and that the assailants had run away."

She said people who went to scene became suspicious and called the police. "Officers rushed to the scene where they found the deceased lying in the corner of the yard just next to the gate. The premises was searched and one empty

cartridge was picked from the scene and one pistol with 6 rounds of ammunitions. One was in the chamber while five were in the magazine which was found in a basket in the boot of a motor vehicle BMW registration number BCA 7262 Charcoal Grey in colour," said Katongo. "The pistol and empty cartridge have been picked for forensic examination and the body of the deceased has been taken to UTH Mortuary awaiting postmortem. Hon. Keith Akekelwa Mukata aged 45 years old of Kasupe in Lusaka West who is area member of parliament for Chilanga Constituency and his wife female Charmine Musonda Mukata aged 37 years old have been detained in custody for Murder."




