The European Union Parliament has moved a motion for the peaceful resolution of the ongoing political crisis in Zambia. This is contained in a motion for a resolution by the Members of the European Union Parliament (MEPs) on Zambia, particularly the case of HH yesterday.

MEPs demanded for the immediate relase of UPND leader Hakainde Hichilema noting that his arrest was politically moticvated.

"Is concerned at the continuing incarceration of Hakainde Hichilema and calls for him to be released. Notes with concern reports of political motivation in relation to the charges and therefore urges the Zambian judiciary to demonstrate

independence from political interference; Underlines that all detainees should be afforded access to legal redress, healthcare and visiting rights," read the resolutions. "Reminds the Zambian

government of their obligations to guarantee fundamental rights and the rule of law, including

access to justice and the right to a fair trial, as provided for in the African Charter, and other international and regional human rights instruments; recalls that the respect for freedom of association and assembly are fundamental to any democratic society and guaranteed by the Zambian Constitution, and that excessive force in response to peaceful protests should be avoided in all circumstances."

MEPs also noted the need for reforms in the Public Order Act, ZNBC and ECZ. "Recalls that following the 2016 general election, the EU election

noted that s detailed review of the electoral legal framework and redrafting of unclear, ambiguous and conflicting provisions should be carried out as well as the removal of overly restrictive limitations of freedom of assembly in the Public Order Act and that the transformation of ZNBC into a public service

broadcaster with full editorial independence from government, and enhanced oversight of the Electoral Commission of Zambia of the public media," read the resolutions.

MEPs expressed concern that government's openness to dialogue was conditioned by the opposition's acceptance of the 2016 elections.

"Calls on the EU to make use of all available political means, including at the highest level, to encourage and assist Zambia's commitment to make such reforms and to uphold the highest standards of human rights, the rule of law and democracy; insists on the urgent necessity of a peaceful and constructive dialogue between the Patriotic Front and the UPND in order to restore political stability and trust; welcomes, in this regard, the Human Rights Commission's call for a dialogue to tackle political violence and prevent continued violations of human rights and freedoms," read the resolutions.

"Expresses concern that the government's openness to dialogue and national reconciliation is conditioned by the acceptance by all opposition parties of the outcome of the 2016 elections; urges the Zambian President to engage in talks with its opponents without delay."

MEPs instructed their president Antonio Tajani to forward their resolutions to the Council, Commission and the Zambian government among other institutions.

"Instructs its President to forward this resolution to the Council, the Commission, the Commission Vice-President / EU High Representative of the Union for Foreign Affairs and Security Policy, the Co Presidents of the ACP-EU Joint Parliamentary Assembly, the African Union Commission and the Pan-African Parliament, the Zambian Government and the Secretary-General of the United Nations," read the resolutions.

DA rises, as Zambia 'deports' Maimane

In this audio, South African leader of opposition Democratic Alliance Mmusi Maimane explains to BBC how he was assaulted by Zambia police at Kenneth Kaunda International Airport, given a new boarding pass whilst still on the plane and ordered to fly back to his country.

And Maimane says yesterday was a low point for Africa because it was clear that dictators are rising.

Maimane also explains that his phone was confiscated and he could not seek legal help.

"First of all, what the Zambian officials did today flouts all international rules. Men and the police walked in, shit down the plane, insisted that every passenger produces their passports. They then came to me and instructed me that they would deny me entry into Zambia. i asked the question 'on what basis?' but they insisted that they would not allow me entry into Zambia, they would not allow me any reasons, simply i could not get out. Then they insisted that they confiscate all forms of communication from me, they took away my phone, they took away my ipad and I could not find any legal services while this was going on and ultimately, they said to me that they would detain me on the plane," Maimane told BBC focus on Africa vesterday.

"They issued me a new boarding pass which means that the decision was already made, whether I wanted to go to a magistrate or not whether i wanted to appeal the decision, a violation of international law, they simply said 'here is your boarding pass, you are not getting off this thing. They started to push me, they started to assault me and the gentleman who couldn't give me back my phone and then eventually we had to concede that we couldn't get in touch with any legal team all because we were there to give solidarity to another leader."


Maimane also says he will go to Zambia's High Commission to

of practice that cannot be allowed on our continent and when we reflect on Africa Day, we must remind ourselves that it is easy for democracy to be captured by dictators and I believe that the government of Zambia has acted in a manner, firstly in arresting HH in the manner that is unlawful and that is why we need to stand in solidarity with him and we will be demanding the government of South Africa to send a strong demand to the government of Zambia to demand an explanation and I would like to know what basis they denied me entry into Zambia, nobody has been able to tell me," said Maimane.

"It is a clear indicator that democracy is very fragile. We must protect the rule of law, we must protect the Constitution. When a President can act beyond the rules of the law and a government can flout international law, it is a quick way of undermining democracy. And we feel, I personally fee that today was a low point for the continent because it reminds us that dictators are rising up, they break the law and ultimately, how can we say that we celebrate Africa Day when others can be sent away without any reason? The President is just an individual, he is not above the law and when citizens choose to stand up against the President, they have the right to do so."

Meanwhile, UPND national chairperson Mutale Nalumango has described the incident as an international scandal.

"It's high time the PF spared us this drama that now borders on international relations of a very important neighbour. Mr Maimane is an MP of the South African Parliament and the leader of the biggest opposition party in South Africa and is therefore accorded the status, privileges and protocols similar to that of Government Minister of the Republic of South Africa. It goes without saying that he also enjoys diplomatic protocols in line with his duties as a legislative member of Government which include a diplomatic passport," said Nalumango in a statement. "To deny entry of Mr Maimane into Zambia breaches the Geneva convention which governs and outlines the processes of diplomatic activities of member states. We believe this is an international scandal of great magnitude and



an embarrassment to the people of Zambia and we as UPND demand an immediate explanation from the Ministry of Home Affairs."

Meanwhile, the Patriotic Front claims "sources close to the treason trial" told them that Maimane was lucky he was deported because he would have been cited for contempt. "The immigration have done him a favour. He was going to face contempt charges in the morning. We were going to apply that his passport be withheld until such a time that the contempt charges were disposed off. His consistent comments that 'we want to pressure the Courts to release Hakainde Hichilema' is highly contemptuous. Our Courts can not be pressured even by the President. The State had already applied for contempt. He wasn't going to leave Zambia for a longtime." A source close to the treason trial said," the PF quoted a sources from the state prosecution team in a statement circulated to the media.

US\$288,000 to be spent on bio latrines in Mandevu

The Water and Sanitation Association Zambia of (WASAZA) has launched a project to construct bio latrines at eight community schools in Mandevu constituency at a cost of US\$288,000. The project is being undertaken by funds which were provided by the Innovation Grant Program of the Millennium Challenge Account Zambia (MCA-Zambia). Speaking at the project launch in Lusaka yesterday, Water Development, Sanitation and Environmental Protection Minister Lloyd Kaziya, said the bio latrine project would help improve sanitation and hygiene standards at the eight selected schools which was a major challenge in most community schools. improve the hygiene standards in Chipata Compound and surrounding areas." Kaziya said. "I understand this is the second project that the Water and Sanitation Association of Zambia will be implementing with funding from the Millennium Challenge Account Zambia. In the first project, school children at two community schools in Chazanga, benefited from the bio latrines, while this second project is aimed at improving the lives of school children in eight community schools in Chipata compound and other compounds in Mandevu constituency." The Minister also commended WASAZA for exhibiting its professionalism and seriousness during the first project. "Let me therefore applaud WASAZA for scooping a second grant from the Millennium Challenge Account Zambia (MCA) through a competitive process. This shows the professional manner and seriousness that WASAZA demonstrated during the first project that led to the award of the second grant that will lead to more schools benefiting from the project," said Kaziya.

Army officer, 38 others arrested for wildlife offences

The Department of National Parks and Wildlife (DNPW) has arrested a Zambia Army officer named Sevelino Zulu and 38 other suspects in Livingstone for various wildlife offences.

Ministry of Tourism and Arts Public Relations Officer Sakabilo Kalembwe said Zulu, 40, a Warrant Officer Class II was found in illegal possession of 12 pieces of ivory weighing 66 kilogrammes concealed in a Toyota Harrier registration number ABX 2105.

The suspect appeared in the Livingstone Magistrate court and is currently on bail.

Meanwhile DNPW has recovered ivory weighing up to 141.5 kilograms, three live donkeys and five motor vehicles. The impounded vehicles, a Toyota Corolla registration number AJB 8639, Toyota Harrier registration number ABX 2105, Toyota Sprinter registration number AJD 5633, Toyota Corolla registration number 3267 and an unregistered Isuzu van.

Others items are one ox – cart, one 458 spot rifle, assorted game meat weighing up to 211 kilograms, one Leopard skin, one Cheetah skin, 71 wires-snares and one crocodile skin And DNPW has arrested three suspects for being in possession of a live pangolin at Chilanga Clinic.

The suspects are Kezias Mutamina, 24 of Mpungwe Village in Chief Mushili in Ndola, Wilson Munsaka, 23, Mudenda Village, Chief Mooya from Choma and Kingsley Mooya 37, of Chibozu Village, Chief Mwanza in Monze.

Pangolin is protected species under the Wildlife Act and its illegal possession attracts a mandatory minimum sentence of five years. Kalembwe has urge the members of the public to report anyone seen trading in the said species.

And Alliance for Community Action executive director Laura Miti says all those defending brutality and bad governance today will swallow their words once they lose their jobs.

Amos, Miti, Hakainde Hichilema's deputy press secretary Brian Mwiinga and PMRC executive director Bernadette Deka participated in a live Al Jazeera programme 'The Stream', where they exchanged views about the state of the Republic of Zambia following the arrest and detention of UPND leader.

Asked how a road-rage incident could turn into treason, Amos said he could only speculate that it was because HH put President Edgar Lungu's life in danger knock off, it is functional," said Amos. And Miti observed that all those who were supporting bad governance would speak a different language after losing their jobs like former information minister Chishimba Kambwili.

"When you listen to Amos talk about autonomy, talk about unparralled freedom, I can assure you that that is something that he can say today and then tomorrow when he is out of a job, like all these people do in the ruling party, they say one thing today and the exact opposite tomorrow. For example, the former minister of information whose job was to make journalists lives miserable and call citizens names, right now, he is busy talking about freedom and how he feels he is being harassed by operatives of the state" because I am me, and not because it is safe. I understand why most people are sacred and if I ever felt unsafe, I think this would be the time I feel most unsafe. The tension in the country makes people feel unsafe."

Meanwhile, Mwiinga seized the opportunity to grill Amos, often cutting him off to counter his arguments forcing presenters to intervene.

Mwiinga wondered why police did not clear the road before President Lungu used it.

"The question Amos should answer is why didn't the police clear this road if they knew that the President was going to use this road? A political gimmick?" asked Mwiinga.

Deka also chipped in to add her voice to the debate but had challenges "The continuous political tension that has engulfed our country after the 2016 General Elections largely exacerbated by the failure of the Constitutional Court to hear the Presidential Petition filed by the aggrieved political parties, has created the potential to risk our country's peace and stability," read the statement.

"We are here not to impose any solution to the current political stand-off, but to suggest alternatives that may be helpful to bridge the widening political divide currently obtaining in Zambia. We are convinced that Zambia's problems can be handled and resolved by Zambians themselves and if need be, by applying other African solutions such as the SADC TROIKA for politics, defence and security; the AU mechanism for conflict prevention, management and resolution; and the Zambia Center for Interparty Dialogue (ZCID)."

The freedom fighters regretted the narrowing democratic space in the country.

"We have also noted the increasing intolerance and disrespect in our society and the declining and shrinking democratic, political, civic, and media spaces in our country and hereby wish to express our resolve to speak out whenever such vices emerge because we have realised that our continued silence on such matters has actually encouraged these democratic ills," statement read.

"We have noted with great concern the political divisions, discrimination based on regions, tribal and political associations not only in the political arena but even at work places to an extent that many innocent people have been retired or fired in the national interest! We also want to express great concern on the breakdown of the rule of law, the absence of separation of powers among the three arms of state and constitutionalism in the country. This is visibly observed by the continued exhibition of impunity by some state institutions to disobey court orders as was recently the case in the Hakainde Hichilema and four others, which is currently in court. In this incident the police disobeyed the Court Order to return seized property during the raid at Mr. Hichilema's residence in Lusaka on April 10, 2017."

The freedom fighters said the recent acquittal of Hakainde Hichilema embarrassed the police service.

"It is also our considered view that the recent judgment by the magistrate court in the case of using insulting language involving Mr. Hakainde Hichilema and others, is a cause for serious soul searching among the leadership of the Zambia Police Service and the National Prosecution Authority (NPA). The judgment has clearly exposed the incompetence and unprofessional conduct of some officers from the two institutions. The judgment has further brought to the fore the inherent credibility deficiencies of some of our men and women in uniform in the discharge of their duties. This judgment has brought a ray of hope in the independence and credibility of our judiciary, which is at its lowest ebb in terms of public confidence and trust," read the statement.

"In the spirit of this national pride, we advise President Lungu, political parties and all citizens to scrupulously respect and uphold the Constitution, the Rule of Law and the Bill of Rights, if we are to maintain this national pride. To this end, we, the Eminent Persons, Senior Citizens and Freedom Fighters hereby; urge President Edgar Lungu, to be a genuine bearer of a message of unity, patriotism for the love of the country by initiating genuine, unconditional and constructive dialogue between himself and his political opponent, Mr. Hakainde Hichilema."

They said "We further urge him to release Mr Hichilema as a prelude to peace and national reconciliation, together with other political prisoners like Hon Obvious Mwaliteta among others, currently being held at various detention and other correctional facilities across the country immediately. We also appeal to President Lungu to censure divisive elements within his political party and government perpetuating tribal and political divisions in the country which are observable in their actions and utterances. We also appeal to UPND leader Mr. Hakainde Hichilema once released and other political party leaders to do the same." "Finally, we make an earnest appeal to President Lungu to honour and respect freedom fighters living and posthumously through the establishment and maintenance of Freedom Fighters' Burial Sites for all freedom fighters such as Godwin Mbikusita-Lewanika, Lawrence Katilungu, Harry Mwaanga Nkumbula, Simon Mwansa Kapwepwe, Nalumino Mundia, Arthur Wina, Munukayumbwa Sipalo, Reuben Kamanga, Elijah Mudenda, Mainza Chona, Julia Chikamoneka, Mukwae Nakatindi Nganga, Solomon Kalulu, Omelo Mumba, Lewis Changufu, Mukuka Nkoloso, Mungoni Liso, Paul Kalichini, Kapasa Makasa, Zeniah Ndhlovu, Leah Hamusonde, Mathew Nkoloma, William Nkanza, Jethro Mutti, Mama Mary Fulano, Samuel Mbilishi, Maria Nankolongo, John Mwanakatwe, Peter Matoka, Fines Bulawayo, Andrew Mutemba, among others too many to mention here."

"Why treason? I do not know why the police charged them with treason but I can speculate that whenever the life of a President is in danger, you are within the realm of treason. I don't know whether it is treason myself because the judge is about to pronounce upon that case," Amos said.

"That's why I said that whoever is around Hichilema and who ever advised him to act in that manner are spectacularly foolish."

Amos also said President Lungu was not bothered about what was happening.

"He has allowed the judiciary to take charge of this process, he is a lawyer himself, he believes in the rule of law; he is not bothered. He is relaxed, he is governing. Like I said, the Judiciary is functioning, the legislature is functioning, all democratic institutions are functioning, people go to work at 08:00 hours, they go for lunch, they Miti said.

"The problem we have is that whoever is around the president, their job is to make him feel good and I think that Mr Hichilema's biggest problem is that he is preventing the sitting president from enjoying power essentially by not acknowledging that he is President. So really, there is no law that says that people should acknowledge a sitting President...You have a government who's efforts to address the service delivery issues for which they were elected, none of us can really see what they are doing. I cannot say that the government is not working but I can say that all their efforts are being overshadowed by this sense of wanting to hold on to power so all we hear is 2021."

She also observed that most Zambians feared expressing themselves because of the tension obtaining in the country. "I do not feel any anxiety and that is

completing her thoughts.

"I think let me say something about that. Let me really say something about that. I think we are talking about Zambia and I think there is a sense of patriotism within ourselves. I think that is a falsehood to actually bring out to the world that the government is overwhelmed by an opposition leader who actually lost an election. I think us as Policy Monitoring and Research Centre have been following up policies, the government's efforts are concerted and concentrated on pushing the national agenda for the next five years which is the seventh national development plan...I talked about the autonomy of police. So is government or the presidency, auditor general, is government or the presidency for example, anti corruption commission or these other entities including the judiciary, that's where we need to separate powers," said Deka.

ZCCM-IH Chief Executive Officer Dr Pius Kasolo has sued Daily Nation Newspaper in the Lusaka High Court for insinuating that he had intentions of taking over the Patriotic Front presidency seeking damages for malicious falsehood.

In a statement of claim filed today, Dr Kasolo stated that he had suffered harassment and unnecessary question on whether or not he was contesting the PF presidency. "On the 23rd day of February 2017, the defendant published an article on page 4 of the Daily Nation Newspaper, volume 3 issue no 1594 entitled 'Team Pius Kasolo, an article which was in direct reference to and discussant of the plaintiff. The veracity or truthfulness of the said article were not verified with the plaintiff before it was published by the defendant. The article falsely stated and imputed among other things that the plaintiff had political ambitions to take over as president of the PF, a political party in Zambia and that there was a 'community of Zambians who believed that the goals and the beliefs of the PF were well embodied in him' when in fact there existed no such community and there was no factual evidence to that the Plaintiff had any political ambitions to take over the leadership of the PF as alleged," Dr Kasolo stated.

"The article further falsely and without truth stated that the Plaintiff had worked or had held positions of employment with the European Union and the Zambia Revenue Authority when in fact not. The article further falsely and

Woman stabs boyfriend to death, gets 4 years

A 24-year-old woman of Lusaka's Emmasadale area has been sentenced to four years simple imprisonment for stabbing her boyfriend to death.

High court judge Mwape Bowa convicted Wendy Kapembwa for manslaughter on Friday.

Kapembwa stabbed her boyfriend Kativia Mwanza with a knife during an argument in Lusaka's Emmasadale area on July 30, 2016.

Mwanza sustained a deep wound on his lower left side of the chest and died the following day at the University Teaching Hospital where he was rushed to.

In sentencing the convict judge Bowa said she had exercised leniency because Kapembwa did not waste the courts time by readily admitting to the charge.

However the judge Bowa sentenced Kapembwa to four years simple imprisonment saying the court had a duty to step in and send a loud message against the increasing cases of gender based violence.

Lusaka lawyer Lubinda Linyama then asked magistrate Wishimanga to allow Charmaine to continue receiving treatment in hospital until she has fully recovered before being remanded in custody which the magistrate accepted. Magistrate Wishimanga said Charmaine would only be

remanded in prison after she is discharged from hospital either on May 22 or 23 The state did not object to the application to admit her to the hospital as a doctor's report where they recommended her admission was presented to court.

The case comes up on June 2 for mention while awaiting for instructions from the DPP as the case is tried by the High Court.

The two are alleged to have murdered a security guard Namakau Kwenda who was working at Mukata's law firm on May 6, 2017.

Man in court for raping drunken woma

A 31-year-old man of Lusaka's Makeni Villa has been dragged to court for raping a woman of the same area after the match between Zambia U20 and South Korea two months ago. Johnson Kalaluka, a driver is alleged to have raped Anna Kazembe between

March 8 and 9 2017.

Details before the Lusaka Magistrates' Court are that on the material day Kazembe was uncontrollably drunk at CC night club in Chawama. Bar men allegedly tried to kick her out

CCPC seizes products worth K9,000 in Eastern Province

By Mirriam Chabala The Competition and Consumer Protection Commission (CCPC) in Eastern Province has confiscated assorted goods worth over K9,000 for failure to meet the obligations outlined in the Competition and Consumer Act.

CCPC Public Relations Officer Namukolo Kasumpa said in a statement today that the goods were confiscated during an inspection operation conducted in over 30 shops in Lundazi, Chadiza and Petauke districts. "The Competition and

Consumer Protection Commission (CCPC) in collaboration with three Local Authorities in Eastern Province has seized assorted goods worth over K9, 000 during a joint inspection operation conducted in over 30 shops in Lundazi, Chadiza, Petauke districts. The seized items did not meet the minimum required standard for them to be sold to consumers; some products were expired and others had no expiry dates while others had broken seals and insufficient labeling," Kasumpa stated.

"Further, some products were defectively packaged which contravened consumer protection provisions as outlined in the Food and Drugs Act Cap 303 of the Laws of Zambia Act as well as the Competition and Consumer Protection Act No. 24 of 2010. Amongst the products seized included Vienna sausages, meat products, agrochemicals and paints."

Kasumpa stated that the seizure of the goods which was conducted by the CCPC Executive Director Chilufya Sampa during the tour of the province was also aimed at sensitizing the consumers on their rights when purchasing goods.

"The main objective of this exercise was to inspect trading premises in selected Districts in Eastern Province with the view of ascertaining the trader compliance levels with the Competition and Consumer Protection Act (CCPA) No 24 of 2010 specifically with regards to product labeling, display of disclaimers, price display and product safety," Sampa said. Sampa also warned Lusaka distributors to avoid transporting goods whose expiration dates were close to rural areas. grow in our country. With this bumper harvest it is therefore expectant that the country will have a reduction and stable mealie meal price which have remained above K90 for a while. The JCTR also urges that FRA should buy maize from small scale farmers especially those who are in typical rural areas who fail to find easy access to the market," Posiana stated.

She also stated that JCTR was hopeful that the lifting of the maize export ban would lead to a stable kwacha exchange rate. "The immediate benefit of lifting the export ban is increased agriculture percentage contribution to GDP which has been a key objective for government. This might also promote foreign exchange inflow thereby stabilizing Kwacha exchange rate which has been performing poorly and has ranged between K9 and K10 per US dollar for some time now," stated Posiana. "Zambia's neighbouring countries are in maize deficit, this should be explored and Zambia should benefit from this by increasing its maize exports. JCTR hopes that increased production agricultural will spur value addition and ultimately economic transformation. Value addition remains a big challenge in our country as most farmers sell their crops without adding any value to them which makes our products less competitive and low priced."

In a statement issued by First Secretary for Press and Tourism at the Zambian High Commission in India Bangwe Naviley, Kapijimpanga also disclosed that Finance Minister Felix Mutati was expected in India to attend the 2017 Africa Development Bank (AfDB) annual convention to be held from 22nd to 28th May at Mahatma Mandir Convention Center in India.

Kapijimpanga said the 2017 AfDB annual convention was expected to strengthen trade ties between India and African Countries.

"This year's meeting follows a successful 2016 AfDB annual meeting held in Lusaka from May 23 to May 27, 2016," Kapijimpanga said.Kapijimpanga who is also accredited to Bangladesh, Nepal, Sri Lanka, Myanmar, Maldives and Singapore revealed that AfDB had 81 member countries of which 57 were from Africa and that India was among the 24 non regional member countries.

The 2017 AFDB annual convention meeting will be held under the Theme; 'Transforming Agriculture for wealth creation in Africa.

Meanwhile Kapijimpanga further disclosed that since 2007, Foreign Direct Investment from India into the Zambian Economy had swelled to US\$3 billion.

"Trade between India and Zambia currently stands at USD700 million. Indian exports to Zambia include pharmaceuticals, transport equipment, plastics, and chemicals while semi-precious stones, non-ferrous metals, ores (copper and cobalt), semi-precious stones and raw cotton constitute India's imports from Zambia. India and Zambia aim to increase this trade to US\$1 billion and Zambia has been seeking investments from India in its core economic sectors," said Kapijimpanga.

"The High Commissioner says this includes a US\$ 2.6 billion investment by Vedanta Resource in Konkola Copper Mines, the establishment of a US\$ 300 million manganese processing plant by Taurian Manganese, and Bharti Airtel's establishment of Airtel Zambia after its acquisition of Zain Telecom's Africa Businesses."


