### Ask court to put HH on house arrest, YALI begs Lungu

Young African Leaders Initiative (YALI) president Andrew Ntewewe has asked President Edgar Lungu to consider asking the courts to put incarcerated UPND leader Hakainde Hichilema under house arrest as a gesture that he is willing to reconcile the nation.

Speaking when he featured on Radio Christian Voice on Friday, Ntewewe said political bickering has put the country on stand still, therefore Hichilema must be put under house arrest in the spirit of reconciliation.

"Hakainde Hichilema was not an ordinary citizen but a leader of the biggest opposition party in the country hence the need to be put under house arrest. Political bickering has put the country on stand still and the President should consider asking the courts to put HH under house

arrest as a gesture that he was willing to reconcile the nation," Ntewewe said.

Ntewewe said President Lungu was the most powerful individual in the country and that he must use the powers wisely.

"What my organization is calling for is for the opposition leader to go through the due process of the law but we as a country should also be cognizant of the fact that Mr Hichilema is a leader with followers. The opposition have an agenda to ensure that the President fails in most areas of governance so that they can use his failures as a campaign tool in 2021. But it is up to him to ensure that he moves away from politicking to delivering on the promises he made during the last campaign," Ntewewe said. And Ntewewe said the President was living under the shadow of his late predecessor Michael Chilufya Sata hence failing to admit the challenges he inherited.

"President Lungu found a crippled economy destroyed under the leadership of PF

founding father Michael Sata but he has failed to tell the nation the main challenges he found because he doesn't want to upset the PF support base," observed Ntewewe.

In this audio, Home Affairs Minister Stephen Kampyongo says people should not be shocked when police pounce on a traditional leader because he has been funding unrest and shall be treated as a local terrorist.

Speaking to journalists after seeing off President Edgar Lungu at Kenneth Kaunda International Airport today, Kampyongo said police would go further by not only arresting the youths who are being sent but the master minders as well.

"I want to take this opportunity and out of respect that we have as Zambians for our traditional leaders, and in this case our royal highnesses, but there is one of our traditional leaders who unfortunately is engaged in these clandestine activities and is behind the funding of some of these terrorist activities of destabilizing our public installations. My warning to him is that no one is above the law and my warning to him, out of respect, our advise to him is to stop what he is doing because we are monitoring his activities very closely and the public should not be surprised if they hear us pouncing on one of our traditional leaders who has opted to engage in these wrong activities," he said. "But he must also know that those youths he is sponsoring to do wrong doing are not his children and he should be mindful of the consequences that those youths might get to reap from what they are doing. We are going to be aggressive and I mean aggressive because all this that has been happening can only be described as acts of terror and so we are going to treat them as local terrorists and so they should know what it means to fight terrorism."

Asked to name the traditional leader, Kampyongo said; "Because of respect, this traditional leader knows himself and those that he is dealing with, they know. But he should know that we know what he is doing and like I have said, we shall move in on him. Now we are going to go beyond the actual culprits that are sent to do these activities, we know where they are meeting and we know what they have planned but I am warning them that this time we are ahead of them and we are not going to spare them. Terrorism is fought with all the force that it deserves and that's how it is going to be, no kid gloves, no arresting and playing around with people, it is going to be aggressive."

Kampyongo also advised members of the public to avoid alcohol abuse this holiday.

### Wina defends Lungu's "I'm ready for violence" statement

Vice-President Inonge Wina yesterday told the House that President Edgar Lungu's statement that "I am ready for violence" was taken out of context.

And Vice-President Wina says could not be part of her meeting with church mother bodies because he was extremely busy at the time.

Last week, the Head of State ordered police to man the premises where he met with Copperbelt Patriotic Front officials to iron out differences saying he was ready for

### violence.

"Nali umfwa ati mwalikata ubwafya na mayor, mwali kwata ubwafya na minister, Chishimba Kambwili alikwata ubwafya, Mwenya Musenge alikwata ubwafya, mukesa njeba ku Lusaka bonse. Bakapokola mu palame mupepi in case it becomes violent because I am ready for violence myself (I have heard that you have a problem with the mayor and the minister. Chishimba Kambwili has an issue.

Mwenya Musenge has an issue,

you will come and tell me all this in Lusaka. Let us go to the meeting you tell me the truth. Police be on close by in case it becomes violent because I am ready for violence myself)," President Lungu said.

But responding to Kabompo UPND Member of Parliament Ambrose Lufuma, who wanted to know in what context the word was used, during Vice-President's question time, Wina accused him of making false insinuations.

"Mr Speaker I am surprised at the fact that the honorable member of parliament has been in the House for almost a week or so rather for the past three weeks but has not uttered a word until now. And the Honorable member has made a catalog of issues that are not factual, that are baseless, that do not reflect the state of affairs in Zambia today. We know very well that His Excellency

feeling, this idea is coming from being a representative for a party whose members are not in the House. Perhaps that is why he is carrying the message from a list of the members who should have been here," Wina said.

And responding to another question from Chipili Independent member of parliament Jewis Chabi who wanted to know why the three church mother bodies were denied an opportunity to meet President Lungu after several attempts to set an appointment, Vice-President Wina said President Lungu was busy.

"The President of this country has met several religious leaders, church leaders in the past one year or so. Including the church mother body members, and I don't know when that statement was given but when I met the church mother bodies and other religious leaders, it was explained that at the time that appointment was being sought from State House personnel, the President was extremely busy with other visitors but there are other channels through which appointments to State House can be made including going through the line ministries. And the President of the Republic of Zambia Mr Edgar Chagwa Lungu has said State House is open to all that want to see him including the leaders of churches," said Wina. About two weeks ago, three church mother bodies namely the Council of Churches in Zambia (CCZ), The Zambia Conference of Catholic Bishops (ZCCB), and the Evangelical Fellowship in Zambia (EFZ) complained that State House had denied them access to the President, hence the resolve to issue a public statement and declare the country a dictatorship. However, Wina met the church mother bodies on June 27 and told them that government was ready to listen to their counsel.

You know the existing State House was built in 1938, so once the budget is agreed upon, we will go to Parliament and if Parliament approves as recommended by the committee for transport, works supply and communication, it will be a public thing for the Zambian people. So for now anybody giving statements they are just speculating," said Chitotela.

I come from the construction industry and I understand construction and that State House has got serious cracks. If there was an earthquake, what will happen will be disastrous [because] that thing can just crumble and at the end of the day, we could be held responsible for killing the occupants of that place because it's our responsibility to make sure that the buildings are in a habitable state," Nkhuwa said.

He said the matter was an urgent one and he estimated that it would cost around \$20 million.

"But it's something that we must do now; we can't keep on postponing it because if anything happens, the people of Zambia are going to cry that what are we people doing in the Ministry of Works and Supply by allowing a building like that to collapse on the Head of State or the other occupants, indeed. So, it's a matter of urgency," said Nkhuwa.

"We didn't want to involve the President and if anything, the President was probably hearing it the first time that it came out of Parliament because we never involved him at all [because] we thought we are But in an interview with News Diggers yesterday, Chitotela said government had not started looking at the cost that will be involved in the project.

"As you may be aware, the committee of parliament just recommended to Parliament last week and government has not started to look at the budget. Even when I debated in Parliament I said we agree and we have accepted the recommendation of the committee because it was urging government to build one and I said ves it is also a concern of government," Chitotela said.

"So it will be premature for any Minister to issue a statement regarding figures or

# HH complains of a Dr. who has forcibly taken over his 'healthcare' in prison

UPND leader Hakainde Hichilema has written to the Health Professions Council of Zambia, complaining about a Dr George Msipu Phiri whom he says is colluding with others to take over his healthcare in prison by force.

According to a letter dated June 28, addressed to the Council Registrar and signed by Hichilema, the UPND leader is worried that Dr is breaching his right to privacy, and that his life is in danger.

"I hereby write to complain against one of your members Dr Msipu Phiri director of medical and health services, who is also the deputy commissioner of police for unethical conduct and professional misconduct. Dr Phiri has shown serious professional misconduct, in the manner he is colluding and conspiring with certain known people handling my life affairs. I have every reason to fear for my health and my life and my complaint is based on the following. Dr Phiri has made maneuvers to invade and breach my right to privacy anchored on doctor patient confidentiality. Dr Phiri without consulting has. accepted unlawful me instructions to be dealing with my health matters in a letter authored by a Mr Sikazwe who allegedly is equally a doctor," HH stated. "Dr Phiri is insisting on handling my medical welfare even though he has full knowledge that I have a personal physician and is also aware that there is a court order as regards to how my health aspects

should be handled. Dr Phiri has for some strange reason insisted that his involvement in my health issue is for my own good, and has told me in the presence of witnesses that he would continue taking care of me when I am taken back to Mukobeko correctional facility in Kabwe. I wonder what else Dr Phiri knows about my unjustified incarceration is being planned by the State for him to have prior knowledge that I will be taken back to Mukobeko from Lusaka Correctional Facility."

He complained that Dr Phiri is insisting to supervise his personal physician.

"Dr Phiri has engaged in professional misconduct by insisting that he will be supervising my personal doctor, the consultant physician, whenever I am being examined.

This conduct by Dr Phiri offends the medical profession in terms of professional rank as to how senior doctors and junior doctors should relate. In any case, I do not know in what capacity Dr Phiri who is from Zambia Police is getting involved in my health matters when the matter is in court and I am in custody of prison authorities. I am left wondering what Dr Phiri's true intentions are," said HH. "In view of the foregoing, I urge your humble disciplinary committee to discipline Dr Phiri. I am ready to attend the hearing with my legal representatives to substantiate my allegation. I have deliberately not included all relevant details in this letter for security purposes."



## Govt to abolish university students' unions

Higher Education Minister Professor Nkandu Luo says her Ministry will move Zambia away from the unionized leadership in colleges and universities, saying students unions "can take even your last bit of blood".

And Professor Luo says government is reviewing some higher learning institutions in the country and re-igniting their mandate, saying several of them had run away from their objectives and were making business out of education. Speaking in parliament today, Prof Luo said she does not think learning institutions need students unions.

"Even in the way that our students will be working. I don't think our institutions should have unions. Unions will take even your last bit of blood. What we need in our institutions is to introduce guild leadership. And this is some of the consultations I will be taking with the students themselves and stakeholders, and churches so that Zambia moves away from unionism in our institutions of higher learning to another level of leadership known as guild leadership. So madam speaker I think we are on course," Prof Luo said.

"Madam speaker as a result of that, we are reviewing a lot of our institutions in this country and re-igniting their mandate and I think we will see a very big change by next year on what our mandate is and what we are supposed to do. Am also very surprised that a lot of our technical schools started promoting business courses. This is again because of an issue called attitude. An issue of not knowing your mandate. Our institutions of higher learning in this country have run away from their mandate, they think they are civil servants and they also think that they can make business out of education."

The Minister advised all academicians trying to get rich out of academia to move out of the career and work in the private sector.

"Madam speaker if anybody who is an academician thinks that they will get rich from academia, they are wasting their time. If you want money! you move out of academia and go and start working in the private sector. The wealth of an academic madam speaker is spoken by your deeds," said Prof Luo.

"As I am talking here madam speaker, maybe somebody is quoting my work in the united states or they are quoting my work in Japan. That is the wealth of an academician and this is what our people in institutions of higher learning should know because they have also started running from one institution to another to teach and make more money. And I think that our universities have gone astray. And from the time I got to this Ministry, I have been bringing them back to what academia is. The people that will remain in those institutions should be such."

## **PF members demanding government contracts shouldn't inform the media, says Davies Mwila**

He said disciplinary action will be taken against the party provincial secretary Joseph Kolosa and his group because they reported their demands to the media instead of following established channels, privately.

"First and foremost they are not suppose to wash the dirty linen in public. And that matter the provincial Chairman is going to deal with that matter because they were not suppose to go to the media because that is indiscipline. And action will be taken by the provincial chairman," said Mwila.

"Disciplinary action will be taken against all those

who are involved. If they have any grievance they are suppose to follow the right procedure or channel. But for them to go to the media, then something is wrong with them and disciplinary action will be taken against them. And in future they have to refrain from going to the media because that is an internal matter, they are suppose to resolve this matter internally." On June 18, Patriotic Front officials in Eastern Province rose against senior government officers, demanding their immediate transfer because they are giving government contracts to members of opposition political parties.

"We are already poor,

so we are ready for any consequences of our demands. We joined PF so that tikazipezako pamimba. We are in the ruling party to eat but our stomachs are shrinking," Kolosa said at a highly charged gathering attended by PF supporters. "We are demanding the removal of Chanda Kasolo, Deputy PS Patrick Mwanawasa and Chipata District Commissioner, Kalunga Zulu from their respective offices. Bayende, they must go! we need to eat. As a ruling party in the province, we are pleading with massive pain and sorrow that these must go. They have not been working and supporting the party in any way. This has pained

us, we are not happy, they are not working with us, but they have continued to occupy these offices." *For audio visit diggers.news*

In an interview with News Diggers! Mwiimbu said his client hopped that there would be progress on the matter this week, considering that it should not take longer than a month for the matter to be allocated after the date of committal. "It is our hope that by next

week the date can be set but as for now we have not had

any feedback from court pertaining to the date. But the record is ready and I hope that it was sent to the High Court yesterday (Friday) to enable the court to set the date," Mwiimbu said.

Asked how long it would take for the case to be allocated from experience, Mwiimbu said; "well, it depends on the circumstances. It is supposed to take not more than a month from the date of committal. So we are confident that maybe by next week (this week) that will be done."

And Mwiimbu said HH was physically fine but it was hard to tell what was going on internally.

"The physical appearance is okay, you never know what could be the internal problem," said Mwiimbu.

## Those who are unhappy with dialogue are ranting like wild rabid dogs - Lungu

In this audio, President Edgar Lungu says those who are unhappy that he went to resolve the infighting in the PF on the Copperbelt are now ranting like wild rabid dogs, in apparent reference to Roan member of parliament Chishimba Kambwili.

Kambwili yesterday said the only way that confusion would end among PF members on the Copperbelt was if the Head of State dismissed provincial minister Bowman Lusambo.

When the President Arrived in Ndola for the 2017 Trade Fair, this afternoon, Lusambo told him that he would soon be exposing the perpetrators of confusion on the province.

"When you came you sat us down and as provincial minister, I want to thank you, I want to salute you for that. I can assure you that this province will never be the same. We know the people who were behind those issues which you came to address and very soon, we will be exposing those people to the people of Zambia, the people who want to sabotage your efforts which you are giving to this country through development and uplifting the lives of our people," said Lusambo to President Lungu at Simon Mwansa Kapwepwe International Airport.

In reaction President Lungu gave an analogy implying that some people were hopping that he could fire Lusambo so that they could take over.

"Let me emphasize that when you are divided, your enemies are very happy. When there is bickering in the family, you discover that your enemies enjoy and celebrate. When they see you uniting, they get sick. Those who are not happy as a result of the effort that we made of trying to dialogue are busy ranting like wild rabid dogs; you can tell and we can see them and you can know them. Chaba shani imwe? Abanenu balefwaya ukuteka nga imwe chinshi chashupa? Even pa ng'anda nga muleunfwana nabakashi, abengi tabatemwa. Nga mwapusana ninshi baunfwa bwino, ati limbi balamutamfya tupyaneko," President Lungu said. He said running a country was a difficult task.

"I want to make this very clear, to those of you who have never been in leadership, ala ukuteka kwalishupa pantu bengi bafwaya uku ingilapo. So ba chairman, ba provincial minister, whatever position you occupy in the province, be reminded that bengi bapafwaya. What they want is to dissolve the committees and bring new people hoping that they can plant their own people in these committees. That we know so when things are going wrong, they encourage that wrong thing. All I can say is that bane, ba provincial, ba district, ba constituency, kuno kumyensu ku Copperbelt you are under probation. We will guide you, we will advise you. Nga mwafilwa mweka pakati, you will have to go," said the President.

"But we know that when we separate, you have to be careful, the enemy within is more dangerous. Abantu abaunaula umutende abantu muikala nabo. So let me warn you that we did not come to destroy, we came to build. So there is a point beyond which I can say I cannot take this anymore but for now, the Copperbelt, we are with you." ## LAZ demands arrest of cadres involved in graveyard fight

Zambia (LAZ) has asked police to investigate and arrest the cadres who started the PF, UPND graveyard fight last week which left four badly injured.

In a statement today, LAZ President Linda Kasonde described the attack of mourners at Leopards High memorial Park during a burial procession, as evidence of the intolerance and political polarization in the country.

"The Law Association of Zambia (LAZ) is deeply saddened by reports in the

media and information circulating on social media on the clash between members of the Patriotic Front (PF) and United Party for National Development (UPND) that happened on Saturday 24 June, 2017 at Leopards Hill Memorial Park during the burial of the

late Clance Zulu," Kasonde stated.

"LAZ is disheartened that such violent activities took place at the graveyard during a solemn occasion which is supposed to be respected by all, regardless of political affiliation. Unfortunately, this violence is the latest in the string of worrisome events that evidence high levels of intolerance, disregard for the law and political polarization in our society."

Kasonde noted that the association welcomed the statement by the Minster of Home Affairs Stephen Kampyongo in which he called for the arrest of the people behind the attack.

"LAZ condemns the attack in the strongest terms and welcomes the statement by the Minister of Home Affairs to ensure the arrest of all perpetrators of this violent attack. We encourage the police to quickly investigate and bring to book culprits of this shameful act," she stated. Kasondo also appealed to political players to tame their supporters. "LAZ would also like to take this opportunity to appeal to political leaders to take strong action against their followers who are perpetrators of this violence and to take a stand against such violent actions. It is time for us as a nation to reflect on the recent events and take a stand against violence. We are Zambians before we are members of political parties or anything else. We owe it to ourselves as a nation to preserve peace and unity in the country," stated Kasonde.

### Parliament summons Antonio over MPs' salaries comment

The National Assembly of Zambia has summoned FDD Spokesperson Antonio Mwanza for allegedly giving misleading information to the public concerning parliamentarians' emoluments. This follows a point of order raised by Serenje MMD member of parliament Maxwell

Hon Member essentially alleges that your statements in the Daily Nation newspaper were misleading and unsubstantiated were essentially in the breach of the provisions of the National Assembly (powers and privilleges) Act, Cap.12 of the Laws of Zambia."

"In the point of order, the Hear' in the House: Sitting allowance: K3, 000 per sitting. Multiply that by 4 sittings per week, it comes to K12, 000 per month per MP. And if an MP sits in two committees he walks away with K9, 000 per day. So in a month, one MP gets a whooping K48, 000 in allowances alone. Add a Salary of about K31, 000 to that, plus



Kabanda on Thursday last week challenging the accuracy of Mwanza's claims in an article carried by the Daily Nation Newspaper.

In a letter signed by Doris Kapumba on behalf of the Clerk of the National Assembly, Parliament asked Mwanza to explain whether or not remarks attributed to him in a Daily Nation article were correct. "I am directed to inform you that a point of order was raised against you on the floor of the House on 22nd June, 2017 by Hon M Kabanda, Member of Parliament for Serenje Parliamentary Constituency. The point of order relates to an article attributed to you, Sir, which was published in the Daily Nation Newspaper on Thursday, 22nd June, 2017, entitled 'Suspended MPs challenge Speaker," Kapumba stated.

She advised Mwanza to state the side of his story regarding the point of order which was raised against him by Friday this week.

"The purpose of this letter is, therefore, to request you to state whether or not the statements complained of in the said article where correctly attributed to you and for you to state your side of the story. Enclosed herein is a verbatim of the point of order. It would be appreciated if your response would reach the office of the clerk of the National Assembly by Friday, 30th June, 2017," stated Kapumba.

Mwanza was quoted in the Daily Nation questioning the amount of money which MPs made per sitting saying there was a pure case of institutionalized theft.

"This is what your MPs get for dozing or shouting 'Hear Hear Accommodation allowance which is calculated at K500 per day plus upkeep allowance, plus tax free beer and food, the total amount we are spending to service one MP comes to a gigantic K100, 000 per month. Forget about the tax-free vehicle, traveling allowances, plus a staggering gratuity of about K500, 000 after five years of dozing and shouting 'Hear Hear Hear!!!" Mwanza said. "In short we are spending over K250,000,000 per annum feting our MPs. Preposterous! What about Ministers, Permanent Secretaries, Constitution Office Holders. Simply put, the poor are working for the politicians. Now check those amounts and look at the state of the constituencies these same MPs come from, look at the poverty of their people. How much does a qualified teacher, lecturer, nurse, police officer gets for

serving the community? Masese. The minimum qualification for being an MP is G12 or a certificate in knitting, photocopying and binding, plumbing etc but the minimum salary of an MP is K100, 000 per month. How? Why?," Mwanza wondered. Mwanza further charged that it was because Zambian politics

had been commercialized that people were willing to do anything to stay in power. "This commercialization of our

politics has largely contributed to the dirt in our politics. People are ready to kill, steal, fight just to be in power or to hold on to power because of the lucrative nature of our politics. Our politics is no longer about service, it's about money, deals, corruption and all sorts of negativity in man at the expense of the poor. This must change if we ever have to achieve sanity, decency and service to mankind," said Mwanza.

# PF, UPND intolerance has reached shocking levels, says Kampyongo

Home Affairs Minister Stephen Kampyongo says intolerance among Patriotic Front and United Party for National Development cadres has reached shocking levels. And Kampyongo says there was no malice on the part of police officers who are accused of murdering Zambia Air Force Flight Sergeant Mark Choongwa.

Responding to a point of order raised by Mwembeshi Independent member of parliament Machila Njamba on the persistent occurrence of violence between UPND and PF supporters yesterday, Kampyongo said intolerance between the two parties was disappointing.

"It is extremely disappointing that intolerance among some

of the supporters of the two political parties have reached shocking levels of fighting each other even on solemn occasions such as funerals and at the cemeteries. Traditionally, funerals are sacred and bring all sections of our society to mourn the departed and out of respect for beloved ones. The reported violence that occurred at the cemetery and indeed elsewhere demonstrates the breakdown of morals in our society which His Excellency the President of Zambia Mr Edgar Chagwa Lungu recently asked us to uphold and defend. Sir, we must arrest the moral decay in our midst," Kampyongo said. "It is for this reason that my government does not and shall not tolerate criminality regardless of who the

perpetrator might be. I am however delighted that His Excellency the President of the Republic of Zambia and the top leadership of the PF has condemned political violence and called on all our people to refuse to engage in all forms of violence. I cannot help but call on all political party leaders without any exemption, including religious leaders to preach only peace. Violence only begets violence and has never resolved any problem." Kampyongo condemned the clash between UPND and PF cadres at Memorial Park but blamed it on "criminal elements operating under the guise of political violence". "Mr Speaker, the clash which

"Mr Speaker, the clash which took place at Memorial Park between the suspected UPND and PF supporters is uncalled for. The clash which lasted for a short time however resulted in a number of people being injured and various items being stolen whilst an unregistered Toyota minibus was burnt down. Sir, criminal activities that unaccompanied the so-called political clashes simply suggest that criminal elements are increasingly taking advantage of criminal elements to commit crimes. The Zambia Police Service has instituted investigations into these criminal activities and shall in due course bring the criminals operating under the cover of political parties to book," he said.

And Kampyongo said the joint inquiry by his ministry and the Ministry of Defense into the death of Flight Sergeant Choongwa revealed that there was no malice on the part of the police officers involved.

"...Also not in dispute is that some police officers at Woodlands Police Station used force to get him into the police station. The force used appeared to be excessive according to one of the inmates who was in the cells at the same time. This finding or observation is however in line with the postmortem report which attributed the death of Flight Sergeant Choongwa to trauma and stress. In the words of the report, 'the trauma he suffered on his back and the stress of being in police custody triggered the chain of events which led to his sudden death on 18th March 2017'. The joint inquiry concluded that there was no malice or aforethought on the part of or any other person to murder the deceased. There was however, gross negligence on the part of the police officers in the manner they handled the whole matter up to the death of the late Flight Sergeant Choongwa," Kampyongo said. "A joint board of inquiry made three principle recommendations (i) that the police officers involved should be charged with manslaughter contrary to section 199 of chapter 87 of the laws of Zambia; (ii) that the relations between the Police service and defence forces should be harmonized and a spirit of comradeship amongst them cultivated and promoted and (iii) that the Zambia Police Service and defense forces should work together and ensure that an incident of similar nature does not ever occur in future. The government position on the findings of the joint board of inquiry, sir, my government has accepted the findings, conclusions of the joint board of inquiry into the death of Flight Sergeant Choongwa and to that end, four Zambia police officers who were involved in these sad events have since been arrested and charged with manslaughter. They are currently appearing before the courts of law."

In this video, President Edgar Lungu's spokesperson Amos Chanda says there are rampant cases of people going round private companies extorting money in his name and that of the Head of State.

And Chanda says if Zambia was not a democracy, he would have been beyond the reach of the judiciary; but because there is democracy he has been compelled to obey a court summon even when he does not know why he is wanted.

Chanda said this from the State House stand and the ongoing Zambia International Trade Fair in Ndola today.

"The practice of people extorting money from private companies is rampant. The reason why we are talking about it is because some of this extortion is in the name of State House. Some of it is in the name of the Vice-President, some of it, in the name of the First Lady. And I can tell you, in terms of abuse of the name, it's the President, the vice president, myself and the first lady," Chanda said.

He said people were using his name even more than they were using the name of Vice-President Inonge Wina.

"In that order the highest number of cases of using people in high positions it's the President, then my name is even more rampant, then the vice president, then the first lady, then there is minister Chitotela in that order. It could be much more. These companies, some of then are so scared to refuse when they hear that it's in the name of Mr Chanda. I think I will be seen on TV to say I didn't send that person," Chanda said.

He said if he wants to beg for money from private companies, he will do it himslef without asking a representative.

"So police are at liberty to investigate such cases which have already happened. But for those who are not yet victims, we are stating here that if an incident like that were to occur, I would speak to them myself. If need was to arise for me to ask for money from private companies I would speak to them, but I cannot foresee that need arising. Unless if I am a member of a cancer foundation raising money," Chanda said.

"But I am not saying the act of kindness must be curtailed, There is no law here which stops funding of political parties, so if a company has a relationship with a political party and they want to donate in a normal way, that is acceptable."

And Chanda said he does not know why he was summoned to appear in court for contempt, adding that if Zambia was not a democracy, he would have been beyond the reach of the court.

"I was in court myself; if you look at the definition of dictatorship, those in power are beyond the reach of any other system, but for us we

President Edgar Lungu says he has tolerated so much criticism without hitting back, which he would not have allowed if he was a dictator.

The Head of State was speaking at Kenneth Kaunda International Airport before departure for Ethiopia where he has gone to attend the African Union Summit.

He said although Archbishop Telesphore Mpundu rebuked him in public, he will speak to to the Catholic Bishops privately.

He bragged that he was not a dictator because he consults a lot.

"A dictator does not consult, a dictator does not take criticism. I have taken so much, I have been punched so much but I have not hit back. Obviously I can hit back and all fairness I am a human being. But I believe people should be given enough latitude to contribute, to criticise, to do checks and balances and that is what democracy calls for," said President Lungu.

And the President said some politicians and civil leaders were in the habit of insulting him so as to ride on his name to gain media coverage.

"I will not be distracted from doing my job because you are calling me a dictator, when I am not one. They are enjoying the coverage you are giving them when

they say Edgar this. I am President so when you insult the President you get coverage and freedom of the press allows that," President Lungu said. "So for me those who are thinking they will get mileage or prominence by insulting me, humiliating me, they are just setting a bad precedence for the freedom of speech and opinion. However, I will not take them on because I will be elevating them to my level, I am too dignified for that," he said.

President Lungu added that he was a very busy man to sit down for petty talk in the name of dialogue.

"..they should find more substantiative matters when dealing with me because I am a very busy man," said President Lungu.



### Accused murderers of ZAF soldier granted bail

Four people accused of murdering Flight Sergeant Mark Choongwa, a Zambia Air Force officer, have been granted K3,000 cash bail.

When the matter came up for mention today, Magistrate Nthandose Chabala granted the manslaughter-accused quarterent bail after their lawyer made an application arguing that they were of fixed aboard.

"Manslaughter is not among the non bailable offenses so I will grant you bail...Until you meet such conditions you will be remanded in custody," said magistrate Chabala

The accused include two police officers; Veronica Lucy Shawa and Mike Kapale.

Others are Lyton Mwale a driver and James Ngulube an archives clerk.

The court said Kapale, Mwale and James were required to provide three working sureties bound at K10,000 each whilst for Veronica, though bound in the like sum, it would be in their own recognizance.

The three male accused persons made their bail application through their lawyer Grace Mukulamutiyo after the court granted Shawa bail as her lawyer applied for bail last week Friday when they made the first appearance in court.

On March 17, Flight Sergent Choongwa was murdered in police custody at Woodlands Police Station where he was detained for a traffic offence.

Initially, police charged four inmates, Joseph Phiri, Andrew Kaoma a police officer from Kamfinsa mobile unit, Felix Kalube and Martin Chanda for the murder of Choongwa but these never appeared in court until the current suspects were presented to the court.

Some uniformed police officers came to follow the proceedings today.

Clement Kanyembo, 40, a soldier from Arakan Barracks has been imprisoned by magistrate Prince Mwiinga.

In his judgment, the magistrate said the prosecution had proved its case beyond

reasonable doubt that Kanyembo had intent to defraud four people whom he collected money from.

He said despite knowing the fact that there was no recruitment, Kanyembo went ahead and collected money from the victims.

According to Kanyembo, the money was to be used for medicals as a first step to recruitment.

In his lengthy mitigation, the convict asked magistrate Mwiinga to impose a suspended sentence so that his TB treatment was not

disturbed.

Kanyembo said if he was given a custodial sentence, his children would suffer.

But the court refused to heed to the issue of an illness saying it was not a mitigatory factor.

Magistrate Mwiinga said Kanyembo's pain was self inflicted and sentenced him to 18 months imprisonment with hard labour.

Those who were swindled are Lovemore Phiri, Lydia Chisempi, Roy Chilangwa and Richwell Sichinga. MPs' right to boycott proceedings of the assembly, the President's addresses were an exception.

"That the conduct of the applicants was contemptuous because by their boycott of the State of the Nation address by the President of the Republic of Zambia on Friday17th March 2017, they committed an act of intentional disrespect...we wish to state that the Speaker is (acting alone) empowered to discipline Members of the National Assembly," Sikatele stated.

She submitted that the 47 MPs were afforded an opportunity to be heard before being charged of which they replied through their advocates.

Sikatele further stated that the MPs were warned that boycotting President Lungu's address again would attract a stiffer punishment. And Sikatele availed that Namwala UPND member of parliament Moono Lubezhi was erroneously included amongst the suspended MPs because she had sought permission, forcing Speaker Matibini to remove her from the list of those suspended.

In their court action, the UPND MPs said they were exercising their democratic right to expression as such the suspension was a shock. Lusaka High Court judge Petronella Ngulube has reserved ruling to next week Thursday on whether or not grant the suspended MPs leave to apply for judicial review; which will stay the Speaker's decision or not.

## Zambia's economy benefiting rich people – World Bank

World Bank Country Manager Ina-Marlene Ruthenberg says Zambia's past decade of economic growth was not sufficiently pro-poor and the benefits have mainly benefited the richer segments of the

population in urban areas. Speaking at Southern Sun Hotel in Lusaka during the launch of a new World Bank Economic Brief titled Reaping Richer Returns from Public Expenditures in Agriculture released yesterday, Ruthenberg called for improvement of public spending in agriculture. "There remains a need to look closely at ways to improve public spending in agriculture to ensure the promotion of a non-copper economy and improved rural livelihoods. Low agriculture productivity is a key impediment to poverty reduction and has knock on effects in terms of gender disparities, land degradation and rapid deforestation," said Ruthenberg. According to the brief, growth of the economy is expected to increase to 4.1 per cent in 2017 and further to 4.5 per cent in 2018 and 4.7 per cent in 2019, from 3.4 per cent in 2016. Inflation declined to 6.5 per cent in May 2017 (from a peak of above 20 per cent in February 2016) and, together with a stable kwacha, led the central bank to ease monetary policy, thereby reversing the pressure on credit growth. The brief notes that the government has been making progress with its economic recovery plane 'Zambia Plus'.

increase because of the new and recently refurbished mines.

The report highlights that Zambia has successfully increased the production of crops (mostly maize), largely thanks to the increased size of areas under cultivation as opposed to improved yields. While public expenditures on agriculture have been increased over the past 15 years, the report urges better targeting of agriculture subsidies.

"There are four key steps to reform the FISP (Farmers Input Support Programme). First, the roll-out of the electronic voucher to all districts has long been discussed as a means of improving the quality of FISP, and remains crucial. The 2017 budget promised a full rollout for the 2017-18 season, but this based on current delivery challenges appears to be too ambitious. Instead, a realistic timeline for 2017-19 should be drawn up. Second, the targeting of the program should be enhanced to make it more efficient and to reduce the overall cost (freeing up resources for complementary agriculture expenditures)," said the report. "Third, there is need for a clear exit strategy: farmers should not receive subsides indefinitely. The program should sustainably raise productivity and incomes so that farmers can graduate from the subsidy program. Finally, there is a need to ensure that farmers can, in practice, select the inputs and the crops they grow. This is a crucial step for reversing the maize-centric status of Zambian agriculture. To improve the FRA (Food Reserve Agency), efforts are needed to ensure that the prescribed purchase limit is not exceeded. A monitoring system needs to be built to

ensure that purchases relative to the limit can be tracked accurately."

The report shows that government routinely spends 79% of the agriculture budget on FISP and the FRA. The ninth Zambia Economic Brief prepared by World Bank Senior Economist, Gregory Smith and others calls for reform of the two programmes.

"As these programs are improved, savings will be realised. These should be invested back into the sector in high-return areas such as R&D (Research and Development), extension services, irrigation, livestock development,

infrastructure and technology. A careful strategy will also be needed to guide such expenditure, while more predictable flows of resources to the sector will help ensure there is an incentive to plan," reads the report.

"... Since 2010, actual expenditure in agriculture

has averaged just 80% of what was planned in the Budget Speech. Further, the FISP and FRA often over-spend relative to their budget allocation, further depleting the actual expenditure in other important areas within the sector and often resulting in substantial expenditure arrears."

## **PF** wasted Eurobond in corruption - Milupi

Charles Milupi says he agrees with Finance Minister Felix Mutati that the country may not be able to repay the Eurobonds, saying the ruling party wasted the loans in corruption.

Addressing the media in Lusaka yesterday, Mutati said Zambia is currently facing major challenges among them; debt sustainability, domestic resource mobilization, and fiscal consolidation, adding that the country may default on the repayment of two Euro bonds it acquired at the time of their maturity "One of the issues that we are still grappling with, is the whole issue of debt sustainability. How much more can we borrow as a country without risking the fundamentals of Zambia. We have employed as you know and have in place a medium term debt sustainability strategy which primarily focuses that the first call will be for this country to focus on securing public-private partnership. The second call will be issues around grants, and the third call will be concessionary financing before you go to the last one which is basically commercial borrowing. That is the pyramid of our borrowing strategy, including the work that the PS is doing to refinance the two Euro bonds that will be maturing; ecause quiet frankly at the point of maturity, we may not have the bottom cash to deal with that," Mutati said. "Issue number two is the whole issue of domestic resource mobilization. Beyond just mere tax revenues, non tax revenues that are critically important to augment the efforts that ZRA is doing. We have had some drawbacks in terms of system implementation such as fiscal devices which should have been implemented a lot earlier including tracking airtime, the single window. These are critical system issues that were part and parcel of our budget revenue issues."

The Finance Minister disclosed that government had so far paid off K4.2 billion out of the K17.2 billion total estimated arrears.

"The third challenge that we face is fiscal consolidation. You cannot spend money that you don't have neither can you borrow beyond your capacity to repay. We have attempted to break down and bring down the arrears as much as practically simple and PS will tell you that this year alone, we have paid off K4.2 billion of the arrears that were estimated to be at K17.2 billion, I repeat K17.2 billion and that is the arrears. We continue to clear arrears not only to contractors, pensioners, litigation and various other things including fuel. That is a major challenge," said Mutati. But commenting on Mutati's fears, Milupi told News Diggers! that the PF government wasted Eurobond money on corruption. "I agree with the Minister's statement 100 per cent because I do not see what capacity was created by the Eurobond to be able to pay it back. The Eurobonds were obtained at high interest rates and they were used on roads so most of the money really just went to feed corruption. These roads were put up for political reasons so they have not created capacity within the economy to generate extra funds within the economy to be able to pay back those loans. And as a matter of fact, from the time the loans were obtained, the economy has worsened," Milupi observed. "There is no way a road in Zambia can cost over a million dollars per kilometer, but that is what we saw here. Now, when you look at the economy, we have run out of money and that is why there is desperation to borrow the \$1.6 billion from IMF to fill the gap in this year's budget."

He warned loans would not solve Zambia's financial deficits.

"Getting loans is premised on good governance, you have to have accountability by way of free press, and they have shot themselves in the foot by closing The Post, by also suppressing the opposition and so on, by incarcerating Hakainde Hichilema, they have demonstrated to the world that there is no good governance and they have put at risk their ability to get that loan from the IMF. So, in the near future, this economy will not generate sufficient funds to pay back. They are struggling now with interest but where will they find the money required to pay that debt?" asked Milupi. "This government is very irresponsible. Look at what they are doing. Instead of focusing on the issues, they are busy now inviting so many presidents. Can they tell us how much it costs to host a visiting president? And what benefit are we getting from that? And what are they coming in Zambia to do? The point I am making is that it is pure expenditure and corruption has also continued. We are seeing houses that have been built and so on. We have no ability to pay back the money and for your own information, that is commercial money... I see harsh times ahead. The only thing that can change this is to have a government in place that understands the economy."

## Why is Nawakwi hiding when Zambia needs her?
