

PF reacts to Malema: He's an Imperialist rabid dog

The Patriotic Front says there is no doubt that Julius Malema and Mmusi Maimane have one paymaster and they are nothing but puppets of those who seek to control Zambia's mineral rights through their stooges.

Yesterday, Malema, who is leader of South Africa's Economic Freedom Fighters (EFF), called President Edgar Lungu a coward.

"There is something terribly going wrong in Zambia. The opposition is suppressed in Zambia. The President of the opposition is arrested, President Lungu declared an illegal State of Emergency because he is threatened. We are saying to him, do not suppress opposition parties. Lungu you are a coward, allow the opposition to oppose you. If you are a true leader, you will defeat them properly," said Malema.

But in a statement titled 'Malema:

the imperialist's rabid lap dog running errands for his masters' today, PF media director Sunday Chanda said the party had noted the irritating and insulting remarks against President Lungu.

"We have noted the irritating and insulting remarks against His Excellency President Edgar Chagwa Lungu who is also Leader of the Patriotic Front by the 'shrunken' Economic Freedom Fighters (EFF) leader Julius Malema who attempts to project himself as the Spokesperson of the Opposition in the Region. For the record, President Lungu sought recourse to the Preservation of Public Security Act, Cap 112 of the Laws of Zambia under Article 31 of the Constitution of Zambia to address instances of fires caused by arson, and to prevent further cases of economic sabotage, which threaten public security and people's safety. Malema should be schooled that

the Preservation of Public Security Act leaves the Constitution intact. All measured actions being taken continue to be subject to the Constitutional principles and strict judicial oversight," Chanda stated. "Article 31 invoked by President Lungu and ratified by Parliament did not create a State of Emergency but deals with a Threat to Public Security or Threatened Emergency. There is no State of Emergency in Zambia. Article 31 was invoked long after Hakainde Hichilema's incarceration. Hichilema was not arrested after the invocation of Article 31. He is a criminal suspect appearing before a competent Court of jurisdiction. Malema is such a hypocrite who seeks to vilify Hendrick Verwoerd, the architect of apartheid but still go to bed with beneficiaries of Verwoerd's paymaster and the two are nothing but puppets of those who seek to control Zambia's mineral rights through their stooges."

He stated that Malema was a coward who could not come to Zambia to repeat those words.

"Malema is a coward otherwise he could have jumped on the first plane, fly into Zambia and utter those remarks on the Zambian soil and later observe reactions from Zambians immediately thereafter. Today, Malema cannot travel to a number of countries in the Region, including Botswana because he is a political sell-out who has no right to poke his nose into Zambia's business!" Chanda exclaimed.

"Malema is running around because his paymasters told him so, including falsities by UPND National Chairperson Mrs Mutale Nalumango and Douglas Siyakalima during their visit to him earlier this month. Malema and his EFF must be told that UPND leader Hakainde Hichilema was not arrested by President Edgar Lungu. Hichilema is a criminal suspect appearing before Zambia's competent Courts of jurisdiction which Malema and his minority party must respect.

minority party must respect It's a miscalculation by Malema and his EFF to politicise a criminal matter. Zambians are not docile and certainly they do not need Malema's flip flopping."

flopping." Chanda said Malema had no business in meddling in Zambia's affairs.

"Lastly, in understanding Malema, we draw reference to the description of Malema by Zimbabwe's information minister, Chris Mushohwe who described the EFF leader

described the EFF lead as a 'puny', a 'Gucci revolutionary...a shrunken, talkative joke, a charlatan who fancies himself big and cute enough to pass comment and judgment on developments elsewhere on the continent. What an embarrassment... We pity and dismiss him as an ignorant youth...' We say Cde Mushohwe was correct in his analysis of Malema! While we understand that Malema has sold out to forces of capital and paraded himself as an imperialist's rabid lap dog busy running errands for his masters, he has no business to delela Zambia by meddling in issues he's ignorant about. Let him keep his delela in Africa," stated

From front page norms of social justice, but you know, when you are acting out of hate, [you infiltrated. When you count how many are] insecure, you are ministers today in dangerous, you can do President Lungu's anything. You can even government, you find go and get a 20 pound hammer to try and kill that 20 per cent of President Lungu's a lion," he said. Kambwili Cabinet comes from MMD and 10 per

cent from nowhere then you find that the PF accounts for only less than 20 per cent or 10 per cent...we have so many educated men and women, original PF, who can get those jobs but I will tell you something for nothing, that is typical of a leader who is insecure," Kambwili said.

"When a leader is insecure, he wants to create his own team, more especially in African politics, he wants to create his own team that can just be saying 'yes sir, yes Mr President' but once a leader goes that direction, just know that that government is a failed government because nobody has the monopoly of wisdom. Now, in this Cabinet that we have, nobody can stand up to President Edgar Lungu, nobody can stand up, he is controlling them like small kids." Kambwili said a lot of people in the ruling party were not happy about his expulsion but they could

not speak up. "Because you could see even in the Central Committee when I was being expelled, people were not happy but they couldn't speak. The Vice-President [Inonge Wina] was very quiet, honorable [Ngosa] Simbyakula was quiet! And many other people, only about eight people were speaking. So you can see, you can read from their body language that they are not happy but they can't speak. And some of them have openly told me afterwards that 'honorable what has happened is unfortunate, we are not happy but you know, if we supported you, they could have said let them go with Kambwili," Kambwili said.

Kambwili said an insecure leader

was very dangerous.
"I expected him as a lawyer to abide by the provisions or the

questioned HH's treason charge. "So that is how insecure the President is. When a political

President is. When a political opponent obstructs your motorcade, which is a traffic offense, you charge them with treason, that simply shows that you are insecure, what are you scared of? What are you scared of? You just hear 'Kambwili is campaigning for 2021', 'let's expel him', that's not the way you run a country because a country is bigger than all of us so in a nutshell, we are in this situation because we have a leader who is

insecure," he said. Kambwili also said President Lungu was very short sighted.

"Some people are so short sighted that they only want to see within a radius of 0.5 meters. If they see beyond 0.5 meters, the idea of expelling others from this political party for self preservation, the consequences are too grave to contemplate. PF won by over 100,000 votes, if Chishimba Kambwili left PF today with a few members and another person, Musenge, left PF went and formed a political party with a few members, we are reducing the 100,000 margin. In the meantime, the main opposition are consolidating their membership in their strongholds. I am telling you, this is what I usually refer to 'ukushala muli mwamoneni," he said.

"But because I am a reasonable person, I am seeing beyond 2021, I want PF to be united and I am fighting this battle not for myself but for the general membership who have worked for PF but most of the members have not worked for PF, they have just joined so they don't care whether this party goes into extinction."

And Kambwili said Kaizer should have been fired a long time ago. "I have been trying to meet

Meanwhile, Kambwili insisted that Southeners would rather vote for HH if he stood against Jesus Christ.

"I call a spade a spade and not a spade a pick for the sake of impressions. You and I know that since UPND was formed in 1987, the people of Southern Province, our brothers, our fellow Zambians have been voting in a manner that is leading to regional politics... it is a fact that in Southern

Province, 90 per cent of the votes have always gone to the UPND and basically because the UPND, since its inception has been in the hands of Tonga presidents. And when Mazoka died, there was a statement that was made by some people that that party can only be led by fellow Tongas," Kambwili said.

"And in stating a fact, people have misunderstood my statement. And I gave an example of how bad the situation was that even if Jesus were to come, some region would vote for their president and not Jesus Christ. Which is a fact! And I still stand by my word even today. My stance is that we should not degenerate into tribal politics but vote for people based on their ability to perform."

But when a caller told him that his statement was divisive and wrong coming from a leader, Kambwili apologised for the example he gave but insisted that there was need to put an end to tribal politics.

"Obviously you know that Jesus cannot come and stand for elections, but it is giving the gravity of the situation...I have heard so many expressions, people condemning this statement, let me unreservedly apologise for that statement, I apologise to the people of Southern Province for that statement but I think by and large, what we need is to run away from regional or tribal voting because some tribes in Zambia are less than 5,000 people. In those tribes there are intelligent people who can be President but if we are going to vote on tribal lines, it will mean that someone from a small tribe will not be President and that will be very unfortunate for Zamnbia," said Kambwili.

TIZ acting executive director Wesley Chibamba said if the Director of Public Prosecutions was acting in public interest, she must apply the law fairly.

"Transparency International Zambia takes keen interest in cases to do with corruption and abuse of office by high ranking officials. Our stance has always been that high ranking public officials who face corruption and abuse of office charges should be made an example out of, by giving them the maximum sentences possible when convicted. This should serve as a deterrent mechanism to other public officials entrusted with power and decision making authority," Chibamba stated.

"We have noticed with interest that the DPP has appealed against the acquittal of former tourism

minister Silvia Masebo. While we welcome this move, we challenge the DPP to also appeal against the recent acquittals of Agriculture minister Dora Siliya and Maxwell Mwale. The two were facing similar charges to that of Silvia Masebo, they were acquitted a few weeks ago. We expect the DPP to also appeal these acquittals, otherwise the DPP risks the Masebo appeal to be misconstrued as political persecution, trying to fix political opponents rather genuine pursuit of justice for the Zambian people. If the DPP is acting in public interest, let this be applied to similar cases."

Chibamba observed that the office of the DPP had made some questionable decisions in the recent past.

"The office of the DPP has often contradicted itself through their actions or lack thereof when it comes to public interest. This is the same office that appealed the Constitutional Court judgment that Ministers who remained in office after dissolution of parliament did so illegally and should refund government the emoluments they enjoyed during that period. It is because of this appeal that the subject ministers have not yet paid back this tax payers money to the owners, the Zambian people," stated Chibamba.

"In our opinion, the Constitutional Court acted in public interest through that judgment, while the office of the DPP acted in the interest of a few affected ministers and the executive. We would like to urge the DPP, as a public office, to genuinely act in public interest and not political interest. We urge the DPP as part of the justice system, not to apply double standards and always be above board in the execution of their

Inspector General of Police Kakoma Kanganja says he is not the "IG" that Amos Chanda was talking to in a telephone recording that went viral three months ago in which the duo agree to deny UPND vice-president Geoffrey Bwalya Mwamba police bond among other things.

In this matter, Kanganja sued Chilufya Tayali for libel over a Facebook posting.

When the matter came up for cross examination before Lusaka magistrate Felix Kaoma yesterday, one of the recordings played before the court was the conversation between the IG and Amos.

But Kanganja said it was not him who had such a conversation with Amos adding that investigations were underway to ascertain the origin of the said recording.

"I am not the one in that recording that is why there is that investigation. I don't know the voice of the other person and I am not familiar with that voice because I am not privy to that recording... I don't talk to Amos Chanda often, I don't report to him...but I speak to him when we meet," Kanganja said.

When asked why police spokesperson Esther Mwaata Katongo did not refute the audio recording as fake when she held a press briefing to announce investigations into the matter, Kangania said he was not aware of any such press briefing.

"I am not aware of that...She usually tells me and I give her authority to do that... but things cannot be done behind my back in the service," he said.

Kanganja however warned that all those who were circulating the audio in question would be arrested.

He also admitted in cross examination led by Keith Mweemba that UPND leader Hakainde Hichilema authorized to be on the Limulunga road in Mongu before the infamous motorcade incident.

Asked if he bothered to ask any of his officers why President Edgar Lungu's window was rolled down, the police chief said he never bothered to find out.

Keith: Let's go to the indictment. The initials HH do not appear in the indictment

IG: They don't appear your honour.

Keith: so the wording of ID1 and the indictment regarding the initials and the name are different

IG: correct your honour.

Keith: And it is a fact that you are relying on ID1 to support the charge in the indictment that you have correct?

IG: your honour, I am not relying on the facts as I am not the author Keith: (repeats question)

IG: I am not relying on the framing of the indictment

Keith: I haven't asked a question about framing of the indictment... my question is that you are relying on ID1, which you brought to court on your own to support the charge in the indictment not so? IG: not so your honor

Keith: Uh, good. So if you are not relying on ID1 to support the charge why are we here?

Keith: but definitely it was not on the 13th of April?

IG: I can't recall your honour Keith: No problem, we have sufficient evidence to prove that. Okay, read the full article loudly, the one for 13th.

IG: "And the IG said those calling for his resignation should not think he was a coward who would run away from the responsibility of the recent Mongu happenings. Mr Kanganja also said him and his family have been receiving death threats from suspected UPND members over the arrest and subsequent charge of their leader Hakainde Hichilema for treason." Keith: Okay, go to page four. That's a Daily Nation Newspaper right? IG: yes

Magistrate: what date? Keith: 11th, go to page 4 IG: This is 4th April

Keith: Well, that was an error. IG: It shows 4th your honor Keith: Just relax. Yes, I agree with you it shows 4th April but go to other pages, it was an error I think. What are other pages showing? IG: they are showing 11th Keith: What's the issue number?

IG: Issue number 1634 Keith: There's a story about you there, what's the banner headline? IG: IG must resign.

Keith: These people are calling for your resignation and in your evidence in chief, you said you received numerous calls after what the accused did, people asking you to resign. What comes first? 11th or 13th April?

IG: your honor I did not say it is only from him but several others Keith: the question is very simple, what comes first? You understand my question?

IG: 11th April your honour Keith: And there was no publication of ID1 on the 11th of April?

IG: your honor, in my evidence in chief, I did not only say it was, it was part of...

Keith: you see, the court is not even writing because you are not answering the question. Answer the question please, we don't want to keep you longer, just help us. IG: I am ready to go the whole day Keith: Okay it's fine, we know you are a fit man

IG: very fit Keith: Yes we know, very fit but kindly answer my question now Magistrate: answer the questions as they come to you

IG: correct your honour Magistrate: Repeat the question Keith: It is a fact that the publication that you have said as a result of that publication people started calling for your

resignation... IG: it is not a fact

Keith: I haven't finished the question. I am saying it is a fact that the publication did not exist on the 11th of April

IG: it is not a fact your honour Keith: Okay, Mr Kanganja, witness, remember that you are on oath as you answer these questions. So you are saying this publication existed on the 11th of April 2017?

IG: No your honour

Keith: So kindly help the court reconcile the two answers.

IG: Your honour, in my examination in chief, I told the court that it wasn't only this publication but that several others, even when you read that paper there, it is referring to others. Keith: Yes, we have your evidence in chief, relax. So actually, there were many other people, who called for your resignation long before ID1 came into existence? IG: correct your honour Keith: long before the allegation in the indictment right? IG: correct your honour Keith: so your being asked to

resign had nothing to do with the accused not so?

IG: it had something to do with the accused your honour that's why we are in court today

K: but others had already spoken IG: his was so serious! Keith: That's not my question

IG: That's why we are here your Keith: you were being asked to resign before ID1 came into

existence not so? IG: correct your honour

IG: Correct Keith: (Reads part of IG's examination in chief) "there was an outcry where people asked for my resignation...even as I am standing here it is still paining me because people are still talking

about it". IG: even as I stand here your honour

Keith: yes, people are still calling you about it

IG: even as I stand here, there are family members here who are

Keith: People are still calling you about IT? The IT here refers to ID1 not so?

IG: to the people

Keith: IT, 'people are still calling you about IT', what is the IT referring to?

IG: the calling for my resignation your honour, that is what the IT is all about

Keith: Listen, these are your own words, and you are using a definite article. (Reads more of IG's examination in chief) "The article is 100 per cent libel because as I am standing here, it is still paining me because people are still calling me about it." Correct English demands that the IT here is in reference to the article not so? State prosecutor: Objection, we don't know why the counsel has chosen to take that route because the witness has already given a clarification as to what he means by IT so now I don't know what counsel is trying to achieve.

IG: "If it is proved that the police were unprofessional in the presidential motorcade fracas in Mongu involving UPND leader Hakainde Hichilema, then Police Inspector General must immediately be fired or resign on moral grounds, says governance activist David Kapoma."

Keith: Good, David Kapoma, governance activist is calling for your resignation on the 11th IG: if it is proved

Keith: No, relax, relax. Yes, if it is proved, and that's why we are here, we want to show your inefficiency. Read the next paragraph

IG: "He was quickly echoed by other stakeholders who said Mr Hichilema should either be arrested or Mr Kanganja resign on moral grounds for endangering the life of the President Edgar Lungu in Western Province."

Keith: So these stakeholders, there is Mr Kapoma on one hand, and there are other stakeholders, maybe you can name them. You can continue reading

IG: "Leading the assault on police, PF deputy Secretary General Mumbi Phiri said that unprofessionalism exhibited by Zambia Police officers was disappointing"

Keith: Mumbi Phiri is calling your service unprofessional correct?

IG: correct

Keith: read only the highlighted parts now

parts now IG: "speaking at a joint media briefing in Lusaka yesterday, Mr Chanda and Mr Musoma who were both eve witnesses, said Mr Hichilema and his Vice-President for Administration Geoffrey Bwalya Mwamba, had hired thugs from Lusaka to go and cause anarchy. Speaking during a media briefing at the PF secretariat yesterday, Ms Phiri said the Party was ready to provide security for President Edgar Lungu and would look after him better than the police. We call on the police to give us a go ahead to protect our leader if they have failed. President Lungu is not just Republican President but leader of the Patriotic Front. We have a

very strong party security, said

Keith: you agree with me that as of this date, you had not yet arrested HH and others for treason?

IG: correct

K: and Mumbi Phiri is telling you that you should arrest and charge

HH with treason not so? IG: I have just seen this publication today Keith: No, answer the question

(repeats)
IG: No your honour

Keith: oh? Because things were so straight forward, I wanted to spare you the trouble of going through. IG: I have read your honour

Keith: Okay, your worship we have the audio, we want technology since this witness is refusing. But in the meantime as they set up we will ask more questions.

So the statements that you have read. Various activists, Mumbi Phiri are giving you two options. The first option is that you must resign or you must arrest HH. Those are the options they gave you correct?

IG: They were not given to me your honour

Keith: Well at least from what you've read that's what people were saying that you must either be fired, resign on your own or arrest HH right?

IG: That's what they were saying your honour but not directly me Keith: No, Mumbi Phiri mentioned you and said IG. Who is the IG in this country?

IG: KK your honour (court laughs) Kakoma Kanganja, just to catch up with time.

Keith: so Mumbi Phiri is telling you that you should resign or arrest HH and charge him with treason?

IG: Just today that's when I am seeing that there was this. Remember in my testimony I said I am not a fan to this social media so whatever was on social media was not brought to my attention your honour.

Keith: A member of the party has given you options and she is demanding that you must arrest HH and charge him with treason. Subsequently, did you charge HH with treason?

IG: The police charged Hakainde Hichilema, HH as you are putting it yourself, with treason. But your honour, it must be put on record that I do not get directives from anyone.

Keith: Okay, you had a conversation with the press aide to the President Mr Amos Chanda over the arrest of Mr Geoffrey Bwalya Mwamba?

IG: I am not aware your honour

(Marshall informs the defense team that the audio CD he had been given to set up isn't working and defense gives him a video of Mumbi Phiri's briefing instead) Keith: There's video, except that we didn't have time to view whether it was the correct one but there is both video and audio so maybe we can give them. We wanted to put them in order. As we load the video, I will come back to the issue of directives, that you don't get directives and you have said you don't remember the issue of the conversation with Amos Chanda

IG: I don't remember your honour

Keith: Okay, but you issued a

statement to that effect that you are investigating over the same. IG: Because I didn't issue, that is why, if I had issued, why should we investigate?

Keith: You were referring to the

Keith: You were referring to the same recording, that the one who has tapped this conversation illegally we are going to investigate. IG: Investigate the circumstances Keith: So it means you were aware about that recording

IG: I am not aware Keith: Okay, no problem. Let us first view the video

(Court watches video or Mumbi Phiri calling police unprofessional) Keith: she is very categorical. What transpired in Mongu is as a result of the lapse on the part of your service right?

IG: That's not correct.

Keith: That's not what she said? IG: That's what she's saying but that is not the correct position your honour

Keith: The lowering of the window on the President's car cannot be blamed on Mr Hakainde Hichilema can it?

IG: No your honour

Keith: So your police service allowed that to happen not so? You did not do anything when the window of the President was lowered?

IG: Your honour, Zambia is a peaceful country. Had those officers reacted, we wouldn't be sitting here to even talk like this. There would have been mayhem in the country. The officers restrained themselves.

Keith: The question is very simple, do you understand it?

IG: the officers restrained themselves
Keith: You as police allowed that to

happen? IG: The officers restrained themselves

Keith: the rolling of the window IG: they acted professionally your honour

State objects: (submissions inaudible to court gallery)
Gilbert Phiri objects: No, counsel

is not testifying. He is talking about automated system, which automated system?

Magistrate: As to who opened the window, those are beyond him and me, we don't know what happened. Let us bring facts before the court IG: obliged your honour, we were not there

Keith: Your honour, in his own words, he said he receives debriefs and he is in charge of command, superintendence, direction of all police operations. And there is an operational order, that's where I am going and in fact, I am marrying this to the indictment. The indictment is very simple, 'Kanganja is just covering his inefficiency, so we want to see Magistrate: Before you go there, can you satisfy this court with evidence as to who opened the window? Who is privy to the opening of that window?

Keith: That's where security protocol comes in your honor and he is competent to answer, he is a highly trained officer, I worked in government in the security wing myself and he knows what I am talking about. He is very conversant with the security details

Magistrate: I see that the author of that statement spoke from without. Even when I am moving in my car with the window open, do you blame the police?

Keith: we need to know now whether the President or his security personnel could have opened the window. It has to come from him because he was briefed. He received briefings every morning and he is in command so obviously he is competent to answer.

Magistrate: I will urge counsel to restrict himself to matters that are within this case.

Haimbe: I think your honour, with great respect, preempting the evidence, the issues here are extremely wide ranging and what counsel is seeking is to show that in fact, the allegations in the indictment do not fall...in order to do so, he must lay a foundation in terms of the questions that are being asked regarding the role of the police service of which the witness on stand has said quite clearly on record, he is in charge, he is the number one police man so my appeal is that the issues arising from that incident and the question of the window being open is irrelevant, is premature to raise those issues. And it will become a situation where the accused person is being curtailed in his right to defend himself, to cross examine the witness on stand. As the court may be aware, these matters are wide and we are trying to prove if indeed this witness tried to kill the President and that can only be determined if the incident that occurred in Mongu is brought to the fore, the witness can answer yes or no or if he doesn't know but a foundation must be laid. So it is our humble appeal that cross examination proceeds to its humble conclusion. Magistrate: I agree with you but I will insist that you stick to relevance. Only relevant evidence is admissible before court, irrelevants are not admissible. If you allowed every irrelevants, we would spend the whole day here. IG: (chips in) I will grow old and retire

Magistrate: can counsel proceed on relevant issues

Haimbe: Perhaps also your honor, I have noticed a trend of the witness addressing the court directly, perhaps the witness should be guided. It is not in the witness' place to inform the court that he will grow old and so on or how the proceedings should go. It places the accused person in a very difficult position if the witness is seen to speak as he deems fit. We will ask the court to guide the witness appropriately

Magistrate: Alright, I think the mistake number one was made by your learned colleague who started playing traditional cousinship in court but I must emphasise that the witness must be as formal as possible and answer questions as they come to you. Counsel proceed Keith: Yes I will proceed except that I am now in a very awkward position on how to proceed because even as they had raised an objection, we are not dealing with...

Magistrate: I didn't sustain the objection, I only emphasized that we stick to relevancies.

Keith: Most obliged, according to your morning brief, who opened the window to the president's car?

Miles resurfaces with praise for Lungu

Miles Sampa says President Edgar Lungu is a loving forgiving man who is Head of State because of because of his historic loyalty, patience and discipline.

And Sampa has advised Chishimba Kambwili and Mwenya Musenge to be remorseful and seek reconciliation with the Patriotic Front and President Lungu to avoid the mistakes he made.

In a statement today, Sampa, who is former UDF president, said President Lungu is a democrat and not a dictator.

"Have had a few queries or distortions lately on my political standing and wish to clarify and make my position firmed. I am PF now but serving a 3 years suspension. This means I am collectively supportive of all decisions made by the Party and by the President. At the moment I am busy with personal errands and school as I seek my PHD (opted for non honorary). My first central committe meeting under President Lungu as chairman took over 8 hours as he allowed everyone to talk and express their opinion before taking a consesus position on a matter. My immediate impression then and still now is that he is a democrat and not a dictator. His decisions are a summation of the majority in a group of authority," Sampa

"As for me and anyone that so believed or still believes in me, let's build loyalty towards PF and President Edgar Changwa Lungu now and for however many years to come. I have also come to learn from experience that President Lungu is a

loving, forgiving man and is the President of PF and Zambia because of his historic loyalty, patience and discipline."

And Sampa advised Kambwili and Musenge to be remorseful.

"My take on the unfortunate subject of my brothers Hon Chishimba Kambwili and Hon Mwenya Musenge is that they should pause, take time and reflect. As history may have it, the two were about the most vicious advising me a few years ago to remain in PF after I had made some emotional and irrational decisions against the Party. Armed with their counseling then, I genuinely wish to reciprocate and give them similar advice. I submit to them that they be remorseful, meek and seek reconciliation with PF and President Edgar Chagwa Lungu," he stated.

"Chances are that they too may be given a 3 years leave of absence in which there is much to learn from once in isolation. The alternative routes they may wish to embark on are hardly ideal and not worth venturing into. I speak from experience and as they say 'ukushusha ilungu; kwendamo' elo 'ukwali insoke takwafwile

Sampa said in politics, everyone was equal regardless of who joined the party first.

"I have also come to learn that in politics, there is no accounting terms such FIFO (First In First Out) or LIFO (Last In, First Out) and LILO (Last In Last Out). It's the best player of the moment according to the coach that makes the team but that does not mean those on the bench or those substituted cannot play on another day," stated Sampa.

"As CK has loudly proclaimed, 'loyalty defines a man', I have come to learn further that 'patience defines a man' as well. Your loyalty and patience should be with PF and President Lungu both in your good or rough times. In short, politics at whatever level is therefore all about loyalty, patience and discipline."

Sampa, who is also a former Matero PF member of parliament, resigned from his position as Commerce deputy minister in October 2015 and from the ruling party in January, 2016 saying the current PF's conduct reminded him of the MMD of 2011 that instilled fear in the general

Student who allegedly wrote "f**k you Lungu" on Facebook denies charge

28-year-old DMI St Eugene student has pleaded not guilty to three counts of defamation of the President and one count of use of insulting language.

Edward Makayi is accused of insulting President Edgar Lungu on Facebook by saying "F**k you" and insinuating that the Head of State had multiple sexual partners including Agriculture Minister Dora Siliya and PF Deputy Secretary General Mumbi Phiri.

Makayi is also alleged to have insulted Home Affairs Minister Stephen Kampyongo.

When the matter came before magistrate Chitalu, Humphrey Makayi denied all the charges and one of his lawyers Martha Mushipe asked for bail.

14th August, 28th for mention and 3rd Nov trial. Lawyer Mushipe made application for bail.

"Accused person is of fixed abord and he is a student at DMI St Eugene University. He is able to meet reasonable bail terms as this court will grant. This is a bailable offense, our humble plea is that the court exercise liniency in setting up bail terms taking

into consideration that the accused is a student and the fact that he has been incarcerated since the 21st of July 2017 and as such over detained," said Mushipe.

She also asked the court to order the state to surrender all the properties they had seized from her client.

"We also have a second application to make...the application is for restitution of the properties that were seized from the accused person without warrant. The items that were seized are two Toshiba laptops, meant for his school, two phones, one is a Microsoft Windows Phones and the other an S Mobile duo sim phone. Two flash discs, a school bag, a CV and documents pertaining to his school attachments, some CDs," said Mushipe. In his ruling, magistrate Chitalu granted Makayi two thousand kwacha cash bail with two working surities bound at five thousand kwacha in their own recognizance.

Magistrate Chitalu however dismissed the application for the state to surrender Makayi's items saying it would disrupt the prosecutions case.

Former teacher arrested for masquerading as chief Msoro

A former teacher identified as Harrison Sichinda aged 49 years old has been arrested by police for installing himself as new Chief Msoro of the Kunda people in Eastern Province.

Eastern province Police Commissioner Alex Chilufya told News Diggers in an interview that the suspect was picked up by police when he attempted to attend a funeral of an induna and proclaimed himself as the new Chief Msoro.

"As you may be aware Chief Msoro (in picture below) of the Kunda people in Mambwe district passed away some few months ago, and this person has emerged from nowhere claiming to be the new Chief Msoro and in the process, of course he has been purporting to posses authority to carry out certain acts that only an installed chief should be able to perform. And of course this is a recipe for anarchy because this divides members of the community and can lead to violence and other undesirable consequences," Chilufya

Chilufya said that the suspect was arrested for breaching the traditional norms and procedures of choosing the new chief.

'There is also a breach of traditional norms and procedure in choosing the new chief. The hierarchy within the royal establishment that presides over such matters and they have a way of designating that chief and installing him, only then and by that authority do we have a new chief or a new Msoro. Any other acts is an abrogation of that authority and procedure and its an offense of course. So this person was picked up on sunday 16th July, 2017 because he found himself at a funeral of an induna and he was there proclaiming himself to be the new chief Msoro," said Chilufya

DPP appeals against Masebo's acquittal

The Director of Public Prosecutions appealed against the acquittal of former Minister of Tourism Sylvia Masebo.

On July 14, senior resident magistrate Ireen

Wishimanga acquitted Masebo saying she never abused the authority of her office when she ZAWA directed cancel and nullify the publication of a list of successful bidders for hunting concessions

following irregularities that marred the process. But according to a notice of appeal, the DPP has filed six grounds challenging the acquittal of Masebo.

The DPP said the trial court erred in law when it held that Masebo's action of directing ZAWA to cancel the tender process did not amount to abuse of authority of office.

It is the state's contention that the lower court misdirected itself when evidence where only the flaws and not the strengths of its case where considered.

The DPP further argued that the court also erred in law when it accepted the hearsay evidence of a defense witness.

The court also noted that Masebo did not in any way benefit from the cancellation of tenders.

Party of National Unity (PNU) president Highvie Hamududu says farmers will make huge losses in this year due to the low maize floor price announced by the Food Reserve Agency (FRA).

In an interview with News Diggers!, Hamududu observed that government was listening more to grain traders

"As Party of National Unity we are very disappointed with the marketing arrangement this year. The farmers have done their best, Zambia has improved the production of many crops maize, soya beans, sun flower, cotton but the prices are disputable. Government is listening more to the traders than to the farmers," Hamududu said.

"The government must listen to the farmers than to the traders. What is happening now is in the whole farming value chain, the trader is benefiting more than the farmer. The farmers yes are withholding to the maize but finally they will have run out of money to take their children to school. They will be forced to sell their crops at very low prices. The price of soya beans has dropped, the price of maize has dropped."

He charged that government was conniving with grain traders to disadvantage farmers.

"Government must not come out completely from this marketing of crops. Otherwise it's killing agriculture. So farmers have made serious losses yet if you go to Kasumbalema, a bag of maize is selling at K110. It means that right inside Congo, the price is too high. Government must put a marketing agency maybe working

with the private sector to make sure that the farmers are not exploited by the traders. But the traders are conniving with the government and the government is only listening to the grain traders and not listening to the farmers. Government must fairly listen to the grain traders, the farmer and to the millers. But the one who must be listened to more is the farmer because he is the producer," said Hamududu.

"The government must enhance the role of Food Reserve Agency (FRA). There must be another agency or FRA can also do the marketing of crops, buy this maize and export, buy soya beans and export. The market for these crops is not lucky, and DRC wants maize. In Kenya, traders came here but the government is listening more to grain traders than to the farmers. Farmers have been left vulnerable."

price would only benefit consumers.

"The price set by the Food Reserve Agency with regards to the purchasing of maize grain is a direct response to the prevailing market price for the commodity. This follows the depressed prices for the commodity resulting from the bumper harvest that has been recorded in most of the countries within SADC. However, the Center for Trade Police and Development (CTPD) thinks that the price that has been set will actually disadvantage most of the small scale farmers especially those that are in the far areas that have had a challenge in terms of finding buyers that would be able to buy the commodity at a price that reflects the cost that they grew the commodity," Mwaipopo said.

"We have observed recently that there has been a reduction of mealie meal prices as observed from a number of trading or retailing shops which is also a response to the supply side of the commodity. This will actually benefit the consumers but the small scale farmers that toiled and worked so hard to grow this commodity will not benefit anything."


And Mwaipopo encouraged FRA to buy more maize from small scale farmers in rural areas whom he felt would the most affected this marketing season.

"Going forward, CTPD recommends that there is actually need to ensure that even as the Food Reserve Agency is stepping into the markets to take part in the marketing season for 2017, there is need to ensure that the purchasing is mostly done in places where most of the farmers are disadvantaged. This is also in accordance with the stipulations of the FRA Act and it would actually help to alleviate the challenge that most of the small scale farmers that are living in disadvantaged areas are likely to face in the 2017 marketing season which is going to be a very tough marketing season for most of the small scale farmers," Mwaipopo said.

Meanwhile, Mwaipopo called on the Zambia Commodity Exchange to introduce sensitization programmes for farmers on alternative crops they could grow in order to diversify the agricultural sector.

"Additionally, there will be need for institutions like the Zambia Commodity Exchange to step in and begin a process of sensitizing most of the small scale farmers on alternative crops that they can be thinking of growing especially those that in the agriculture sector for business not growing commodities for consumption. This will actually go a long way to ensure that there is diversification in the crops that we are growing," said Mwaipopo.

"Secondly, as we are budgeting for there will be need for the government to consider embedding within the budget support that can go towards supporting extension service work. This will help to ensure that the extension service workers have got operational funds that would allow them to interact with the small scale farmers and provide information that would provide the small scale farmers plan better."

The case for Agro-Processing led industrialization (Part II)

In my earlier article, I argued that the conditions on the demand side are conducive for Africa and Zambia in particular to seriously consider activating the agro-processing sector to be an engine for reindustrializing Zambia and the continent as a whole. Like the rest of the continent, Zambia is a net-importer of agricultural products - a country that boasts of abundant arable land and favourable weather conditions for agricultural production. In this article, I highlight the fact that the context around natural resources has evolved and has enabled the pursuit of resourceintensive industrialization a possibility.

The basic argument is that resource-intensive industrialization anchored on

feasible and is the right policy orientation for Zambia as far as economic diversification is concerned. The world has technologically evolved and so has the context surrounding the exploitation and processing of natural resources. The information communications technology (ICT) revolution, changing market dynamics and environmental politics have significantly changed the context around the oitation and processing of natural resources from being a blessing to a "curse" and back to a blessing again. The markets have become highly segmented spanning from high-volume low price products to low-volume high price niche products, an increasingly geared innovation towards food products and the rising food prices as tastes shift from traditional foods to processed food products accompanied by heightened environmental activism to save the resources from depletion and the environment from destruction. This is indeed the time for Zambia and Africa to move the science and technology agenda from the fringes of the bookshelves marginal ministries, departments and local councils to the centre of the mainstream development strategies. It would be impossible for Zambia to "catch-up" and "leapahead" without fully placing

technology and innovation at the centre of development objectives.

However, adoption technology and innovation should be a targeted strategy in line with the development paths the country is pursuing. For example you cannot aim to compete with Singapore and other tech-giants in the manufacture of electronics components because Singapore has built capabilities that would take years for Zambia to "catchпр" and worse still to leapfrog and establish itself as the market leader. At this stage of global development where the developed countries are already inserting themselves into the fourth industrial revolution, Zambia would do well to focus the adoption and diffusion of innovations and technologies in sectors such as the agro processing industry where she has comparative advantage.

Productive industrialization is not a new phenomenon as many developed and developing countries such as Singapore and South Korea had at some point - in the early stages of their industrial revolution adopted this strategy to get to where they are now. During the late 80s when the South Korean economy began to catch up, the contribution of manufacturing (driven by the textile & electronics) to GDP was approximately thirty percent and twenty-five percent of the workforce. Today, the contribution of Zambia's manufacturing (mostly driven by agro-processing) is only six percent of GDP and 3.8 percent of the workforce. On the African continent, Ethiopia has continued to make the leather industry thrive while Mauritius and Lesotho are exploiting the textile industry.

The 2010 World Bank consumption estimates show that Zambia spends percent of the US\$4.12 billion final household consumption expenditure on food and beverages. It is one of the twelve Sub-Saharan countries whose food and beverages expenditure is below fifty percent. And by Engels law of decreasing consumer expenditure on food as incomes rise, we observe that the 49.4 percent is still too high if we are to reduce food consumption expenditure by raising incomes to levels such as that of South Africa - a middle income country whose expenditure on food and beverages stands at 15.2 percent. It also shows that people will continue to spend more on food in Africa for the foreseeable future. This is why it is critical for Zambia to lead from the front in agro-products. The lower class people of society who live on less than US\$2.97 per capita per day account for 58.1 percent of Zambia's food and beverages who survive on small scale farming in the rural parts of Zambia with low educational levels to even dream of getting a white-collar job. The 2014 Labour Force survey shows that only two percent of the people involved in agricultural activities (agriculture sector being the largest employer in Zambia) have had some form of tertiary education. Therefore, the easiest way to escape the poverty cycle is by upgrading their agricultural competencies into agro-processing. Therefore, efforts should be directed on finding innovative ways to building capabilities in these farm workers, and extension services would play a pivotal role in the successful adoption and diffusion of farm technologies. This path would not only raise the incomes of the rural people but would also have a ripple effect on the entire economy.

On the trade side, the agroprocessing sector has continued to experience trade deficits at least since 2000. Zambia has only managed to record trade surplus in the Grain Milling products and Sugar & Sugar confectioneries subsectors. This has largely been attributed to the recapitalization and expansion works at Mazabuka Sugar plantation and the coming on the market of Kafue Sugar company. On the grain Milling side, the huge investments in grain production especially maize and a considerably developed grain milling sector have been the driving factors for the trade surplus. There is need though for the Grain Milling sector to go further than just the Milling of mealie meal and invest in further value-addition activities to produce such products as pasta and cereals. The rest of the agro-processing sector has seen significant increases in imports over the same period.

The trade deficit for the & fish preparations subsector grew at a compound annual average of five percent while that of beverages, spirits & vinegar at 18.6 percent between 2000 and 2014. In 2014 alone, Zambia imported more than seventy-four percent of beverage products from South Africa (mainly alcoholic beverages). However, Zambia has done well in the exports of non-alcoholic beverages with the Democratic Republic of Congo (DRC) and Zimbabwe being the biggest markets. This is due to a growing nonalcoholic beverages sector.

In conclusion, Zambia needs to create a robust education system that speaks to the needs of the economy. Zambia's education system is flooded with business courses; trade colleges have been turned into business colleges and leading universities are at variance with national objectives.

Putin says U.S. must cut 755 diplomatic staff



President Vladimir Putin said the United States would have to cut its diplomatic staff in Russia by 755 people and that Moscow could consider additional measures against Washington as a response to new U.S. sanctions approved by Congress.

Moscow ordered the United States on Friday to cut hundreds of diplomatic staff and said it would seize two U.S. diplomatic properties



after the U.S. House of Representatives and the overwhelmingly Senate approved new sanctions on Russia. The White House said on Friday that U.S. President Donald Trump would sign the sanctions bill.

Putin said in an interview with Vesti TV released on Sunday that the United States would have to cut its diplomatic and technical staff by 755 people by Sept. 1.

"Because more than 1,000 workers - diplomats and support staff - were working and are still working in Russia, 755 must stop their activity in the Russian Federation," he said.

The new U.S. sanctions were partly a response to conclusions by U.S. intelligence agencies that Russia meddled in the 2016 U.S. presidential election, and to punish Russia further for its annexation of Crimea from Ukraine in 2014

Russia's response suggested it had set aside initial hopes of better ties with Washington under Trump, something the Republican president, before he was elected, had said he wanted to achieve.

A federal law enforcement investigation and multiple U.S. congressional probes looking into the possibility that Trump's campaign colluded with Russia have made it harder for Trump to open a new chapter with Putin. Russia denies it interfered in the election and Trump has said there was no collusion.

Moscow said on Friday that the United States had until Sept. 1 to reduce its diplomatic staff in Russia to 455 people, matching the number of Russian diplomats left in the United States after Washington expelled 35 Russians in December.

On Friday, an official at the U.S. Embassy, who did not wish to be identified, said the embassy employed about 1,100 diplomatic and support staff in Russia, including Russian and U.S. citizens. 'Uncalled-for Act'

State Department declined to comment on the exact number of embassy and consular staff in Russia. But a State Department official called Russia's action "a regrettable and uncalled-

for act." "We are assessing the impact of such a limitation and how we will respond to it," the official said on condition of

As of 2013, the U.S. mission in Russia, including the Moscow embassy and consulates in St. Petersburg, Yekaterinburg and Vladivostok, employed 1,279 staff, according to a State Department Inspector General's report that year. That included 934 "locally employed" staff and 301 U.S. "direct-hire" staff, from 35 U.S. government agencies, the report said.

That breakdown suggested the actual number of Americans forced to leave Russia would be far less than 755.

"We dont (sic) have 755 American diplomats in Russia," said Michael McFaul, a former U.S. ambassador to Russia, in a post on Twitter on Sunday.

The cuts would likely affect how quickly the United States is able to process Russian applications for U.S. visas, McFaul said.

"If these cuts are real, Russians should expect to wait weeks if not months to get visas to come to U.S.," he

Putin said Russia could take more measures against the United States, but not at the

"I am against it as of today," Putin said in the interview with Vesti TV.

He repeated that the U.S. sanctions were a step to worsening relations between the two countries.

"We were waiting for quite a long time that maybe something would change for the better, were holding out hope that the situation would change somehow. But it appears that even if it changes someday it will not change soon," Putin said.

He said Moscow and Washington were achieving results on cooperation, however, even "in this quite difficult situation." creation of the southern de-escalation zone in Syria showed a concrete result of the joint work between the two countries, Putin said. -

China hits back at Trump criticism over

China hit back on Monday after U.S. President Donald Trump tweeted he was "very disappointed" in China Pyongyang's following latest missile test, saying the problem did not arise in China and that all sides need to work for a solution.

China has become increasingly frustrated with American and Japanese criticism that it should do more to rein in Pyongyang. China is North Korea's closest ally, but Beijing is angry with its continued nuclear and missile tests.

North Korea said on Saturday it had conducted another successful test of an intercontinental ballistic missile that proved its ability to strike the U.S. mainland, drawing a sharp warning from Trump and a rebuke from China.

Japanese Prime Minister Shinzo Abe spoke with Trump on Monday and agreed on the need for more action on North Korea just hours after the U.S. Ambassador to the United Nations said Washington is "done talking about North Korea".

A White House statement after the phone call said the two leaders "agreed that North Korea poses a grave and growing direct threat to the United States, Japan, the Republic of Korea, and other countries near and far".

It said Trump "reaffirmed our ironclad commitment" to defend Japan and South Korea from any attack, "using the full range of United States capabilities".

Trump wrote on Twitter on Saturday after the missile test that he was "very disappointed" in China and that Beijing profits from U.S. trade but had done "nothing" for the United States with regards to North Korea, something he would not allow to continue.

China's Foreign Ministry, in a statement sent to Reuters responding to Trump's tweets, said the North Korean nuclear issue did not arise because of China and that everyone needed to work together to seek a resolution.

"All parties should have a correct understanding of this," it said, adding the international community widely recognized China's efforts to seek a resolution.

The essence of Sino-U.S. trade is mutual benefit and win-win, with a vast amount of facts proving the healthy development of business and trade ties is good for both countries, the ministry added.

Chinese Vice Commerce Minister Qian Keming, weighed in too, telling a news conference there was no link between the North Korea issue and China-U.S.

'We think the North Korea nuclear issue and China-US trade are issues that are in two completely different domains. They aren't related. They should not be discussed together," Qian said.

China, with which North Korea does the large majority of its trade, has repeatedly said it strictly follows U.N. resolutions on North Korea and has denounced unilateral U.S. sanctions as unhelpful.

Nikki Haley, Ambassador to the United Nations, said in a statement China must decide if it is willing to back imposing stronger U.N. sanctions on North Korea over Friday night's long-range missile test, the North's second this

Any new U.N. Security Council resolution "that does not significantly increase the international pressure on North Korea is of no value", Haley said, adding that Japan and South Korea also needed to do more.

Abe told reporters after his conversation with Trump that repeated efforts by the international community to find a peaceful solution to the North Korean issue had yet to bear fruit in the face of Pyongyang's unilateral "escalation".

"International society, including Russia and China, need to take this seriously and increase pressure," Abe said. He said Japan and the United States would take steps towards concrete action but did not give details.

Abe and Trump did not in a commentary. - Reuters

discuss military action against North Korea, nor what would constitute the crossing of a "red line" by Pyongyang, Deputy Chief Cabinet spokesman Koichi Hagiuda told reporters.

"Pyongyang is determined to develop its nuclear and missile program and does not care about military threats from the U.S. and South Korea," state-run Chinese tabloid the Global Times said on Monday.

"How could Chinese sanctions change situation?" said the paper, which is published by the ruling Communist Party's official People's Daily.

Mass Nigerian arrests for gay sex in Lagos State



More than 40 men have been arrested in Nigeria over the weekend for performing homosexual acts, police say. They are due to appear in court later.

Nigerian newspaper Punch reports that the police raided

a hotel in Lagos State on Saturday afternoon and says the hotel was cordoned off while the investigation was carried out.

Homosexual acts punishable by up to 14 years in jail in Nigeria, while gay marriage and displays of same-sex affection are also banned.

The BBC's Chris Ewokor in the capital, Abuja, reports that Nigeria has an influential Christian evangelical movement in the south and strong support for Islamic law in the north, both of which oppose homosexuality.

Same-sex relations explicitly banned in 72 countries, according to the International Lesbian, Gay, Bisexual, Trans and Intersex Association (ILGA).

The number of states criminalise sex relations is decreasing annually, though, with Belize and the Seychelles repealing such laws last year.

Nigeria is one of a small number of countries which has gone against a global trend.

The country has had a ban on gay relationships since 1901, and in 2013 also outlawed same-sex marriages, gay groups and shows of samesex public affection. - Bbc **10. Lifestyle** Monday July 31, 2017



Woman does plastic surgery to evade \$3.7M debt

A 59-year old woman from the central Chinese city of Wuhan transformed her appearance through plastic surgery in order to avoid 25 million yuan (\$3.71 million) of personal debts, state news agency Xinhua said.

In a case highlighting the challenges facing China as it tries to establish a "credit society", police officers were reported to be "astonished" after apprehending the woman, who fled to the southeastern Chinese city of Shenzhen after a court in Wuhan ordered her to pay off her debt.

"We were very surprised at the scene," the official Xinhua news agency quoted a policeman as saying. "She looked in her thirties and was different from the photos we had."

The woman, identified as Zhu Najuan, also confessed to using other people's identity cards to travel across the country by train. She financed her plastic surgery using borrowed bank cards, Xinhua said late on Friday.

Representatives from more than 300 Chinese cities released a declaration earlier in July promising to make more credit available for consumer spending, part of the country's efforts to find new sources of economic growth and reduce its dependence on heavy industry and state-driven infrastructure investment.

But as the country strives to make more credit available to individuals, it is also facing a surge in household debt, which is estimated to have reached around 50 percent of gross domestic product last year, more than doubling in less than a

As regulators try to establish a reliable nationwide credit rating system, authorities across the country are also exploring new ways to crack down on those who do not pay debts.

According to state media, one court in Jiangsu province has drawn up a blacklist of defaulters. Anyone who telephones an individual on the blacklist will first be forced to listen to a prerecorded message saying "please urge this person to fulfill their legal obligations". Xinhua said the city of Wuhan has also launched a series of crackdowns on debt defaulters, and detained a total of 186 people in the first half of the year. - **Reuters**

Three albino Chinese soft-shelled turtles were also found in the package, prosecutors said, adding that Franco on that same day mailed a box to Hong Kong with six protected turtles inside.

According to a criminal complaint filed in the case, Franco admitted during an interview with authorities that he had previously received a total of 20 king cobras in two prior shipments but that all of those snakes had died in transit.

He faces a maximum of 20 years in prison if convicted, although sentencing federal guidelines typically call for less time behind bars. According to the National Geographic website, the king cobra, also known as Ophiophagus hannah, is the longest venomous snake, reaching up to 18 feet (5.5 meters) in length. When confronted, king cobras can raise up to onethird of their bodies off the ground, flare out their hoods and emit a "bonechilling" hiss before attacking. - **Reuters**

"She left in peace, accompanied by all your prayers and well wishes for which we thank you all," he wrote. "Mami, I'm going to miss you so much!"


