It's illegal for UNZA to bar students from exams over fees - Mulusa



By Sipilisiwe Ncube National Planning and Development Minister Lucky Mulusa says it is unconstitutional for universities to send away students who are about to write exams simply because their parents have not paid school fees. Reacting to the decision by the University of Zambia's decision to bar over 850 students with outstanding balances from writing examinations next month, Mulusa said there were many ways of collecting fees without inconveniencing students. "I was shocked yesterday to read about UNZASU (University of Zambia Students Union) saying, they support blocking of students who haven't paid their school fees

from writing exams. It is unconstitutional. The Constitution has got a provision for access to education, both private and public institutions should stop sending away

students from because their parents have not paid, refusing them from writing exams because their parents have not paid.

Kambwili cannot disclose govt secrets anyhow just because he is out, warns Wynter Kabimba

By Sipilisiwe Ncube Rainbow party president Wynter Kabimba says at the rate which expelled Roan PF Member of Parliament Chishimba Kambwili is moving with his disclosure of government secrets, he risks being arrested.

In an interview with News Diggers! Kabimba warned Kambwili to be "very careful" when talking about government affairs involving information of confidential nature which he acquired when he was serving as Minister.

"The oath of office binds you to the information especially information of a confidential nature, secret nature that comes your way when you are serving as a Minister. So it binds you, you are bound by that oath even when you have been dropped or even if you resign. The idea is that the state must be protected. The idea is that you only came up with that information not in your capacity but by virtue of the fact that you were a serving public officer in a position of Minister," Kabimba said.

He said having taken Oath of Secrecy, Kambwili had the duty to protect the State by not disclosing any information that would harm or jeopardise government operations.

"So you cant just say what you want to say or disclose what you want to disclose when you are out of government. So ba Kambwili has to be very careful on what he says and in fact under the Secret of Oath Act, it is an offence, you can actually go to jail. So he has to be very careful on what he says because he may just land himself in problems. Even you yourselves that are reporting you have to be very careful, because the man at the rate he is talking, am not sure myself whether or not he is even listening to himself," said Kabimba.

"You know in the United States, they have what is called classified documents or classified data and it only expires after a period of 30 years. So after 30 years if you served as Secretary of States for example or president you can then write another book or an additional set of memos where you can talk about how you invaded Iraq... The presumption of law is that at that stage, that kind of disclosure will no longer be damaging to the State."

UNZA explains decision to bar 8000 students from exams

By Mukosha Funga University of Zambia public relations manager Damaseke Chibale says the institution is owed K58 million from 8,000 students.

In a statement yesterday, Chibale explained that the payment structure was extremely flexible.

"Generating revenue through tuition fees has been a challenging undertaking for the University despite the flexible arrangements accorded to our students. This is more pronounced with self-sponsored students and some of them who are not on 100% government sponsorship. The University is currently owed K58 million in unpaid fees from 8,000 students," Chibale said. "It should be noted that

the growing practice of non-payment of tuition

fees has affected the smooth operations of the University. Providing quality higher education services, comes with various unavoidable costs such as purchase of teaching and laboratory materials, preparing and marking examinations, and Library and information technology services. Prophet fails to raise the dead, taken to court

There was laughter in the Lusaka Magistrate's court when a 23 year old woman narrated how she was tricked by a prophet who promised to raise her husband from the dead.

This is in a matter in which prophet Angel Sakala swindled Beatrice Kasonde k10,170 on pretext that he would bring back to life her dead husband Kennedy Malawo. Beatrice told Lusaka magistrate Mary Chibanga that Sakala whom she was referring to as "Papa" demanded for money for every step he took in performing the act of bringing back her hubby whom he claimed died mysteriously. The witness said papa demanded K500 for booking him and another K500 for booking and transporting the police officers who were going to pick up Kasonde's husband when he got back to life.

She testified that after praying against the nightmares of her late husband, Papa Angel told her that he had communicated with her husband and directed him to go to Kunda in Ndola. "Papa Angel again demanded for another K1000 for transport to Ndola to pick him up, and another k500 for a the rest of the money electronically. According to Kasonde, a lady called Agatha linked her to Prophet Angel after he managed to stop her from constantly dreaming about her late husband.

She said even after Papa Angel failed to raise her husband, he called her on four occasions telling her to go and see the people he had brought back to life in Chisamba. Kasonde however told the court that after going to meet Papa Angel, she was told that the person he had raised had been taken by the relatives. The victims sister in-law Lenah Malawo said Papa Angel was a false prophet as he failed to raise her brother from the dead but kept on asking for money to perform the act. She said she had never seen anyone bring back a dead person to life despite Papa Angel claiming that he had raised a lady from the dead by the name of Florence whom she found at the prophet's house. She added that she had never seen a prophet like Papa Angel who drunk beer and insulted. Malawo said she observed the Prophet's weird behaviour when she stayed with him for over a month as the Papa asked her to be 'standing in the gap' during prayers.

He said UNZA had to change the way things had been done in the past in order to remain relevant. "More importantly, the university has a legal obligation to pay salaries for its academic and non-academic staff for them to efficiently and effectively execute their duties for the benefit of the students and society in general. Therefore, for the University of Zambia to operate efficiently and remain relevant to the new trends in higher education service delivery, it has to change the way things have been done in end-of-academic-year examinations."

He said management understood the challenges which parents and sponsors faced but they still had to honour their obligations.

"It is clear that Management takes cognisance of the challenges parents, guardians and sponsors face but there is a necessity for them to honour their obligations. Additionally, the University has also accorded some students a user friendly payment plan for those with historic tuition fee arrears which is being managed under the Academic Affairs Unit," said Chibale.

"With these friendly tuition fee payment provisions, there is no excuse for students and/ or their sponsors to default in honouring their obligations, that is, paying tuition fees, particularly if they value university education. Therefore, management would like to urge all affected students, without exception, to take advantage of the available provisions for paying tuition fees to avoid any inconveniences." He also clarified that students were still allowed to attend lectures. Recently, university management issued a Memo informing affected students that they would not be allowed to write exams this if they did not clear their arrears.

Police nab two juveniles for rape

By Mukosha Funga Two Siavonga juveniles have been arrested for allegedly raping a 16-year-old school girl.

According to a statement by Police Spokesperson Esther Mwaata Katongo today, the boys lured the girl, who was on her way back to boarding school in the company of two friends, to their parents' house where they took some alcohol.

"A girl aged 16 years who is a pupil at one of the Secondary

The male juvenile who had lured the girls to his parents home then took the 16 years old girl who was in a drunken state to his bedroom where he sexually abused her and he was joined by another boy and they are alleged to have taken turns in raping her while the other girl aged 14 years is reported to have been taken to another bedroom by another male



ZRA extends tax amnesty deadline

By Sipilisiwe Ncube Finance Minister Felix Mutati has directed the Zambia Revenue Authority (ZRA) to extend the tax amnesty deadline to 31st August from 31st July 2017.

In a statement today, Mutati however said the deadline for time-to-pay extension agreements remained 31st December 2017.

He also revealed that 40 brand new vehicles had been procured for enforcement which had commenced with immediate effect but would be accelerated after the 31st August new deadline.

"The amnesty on interest and penalties which was introduced by the Zambia Revenue Authority (ZRA) on 24th April, 2017, came to a close yesterday on 31st July 2017. During this period, taxpayers were expected to submit outstanding tax returns and pay all principal tax liabilities for tax periods prior to 1st March 2017, after which all interest and penalties accrued for the said period would be waived in full. Taxpayers were expected to pay all outstanding principal liabilities within the amnesty period," Mutati said.

"I therefore wish to direct the Zambia Revenue Authority to extend the amnesty up to 31st August, 2017. Notwithstanding this extension, the deadline for time-to-pay agreements remains 31st December, 2017 and all other rules will remain as announced by the commissioner general during the launch of the amnesty campaign on 24th April, 2017. In instances where taxpayers have not able to settle the principal liabilities before 31st July 2017, ZRA offered an opportunity of settling such tax liabilities in installments by entering into time-topay agreements (TPAS) with taxpayers to be settled before 31st December 2017."

Mutati said no applications for further extension would be entertained after the expiry of the additional 30 days.

"I wish to take this opportunity to encourage members of the public to take full advantage of this extension and not wait for the last minute to put their tax affairs in order. ZRA must ensure that all taxpayers with issues on their tax accounts are attended to before the new deadline, after which enforcement action should be instituted against all taxpayers with liabilities on their accounts," said Mutati.

"In this regard, ZRA is expected to step up its enforcement strategies in order to deal with the post-amnesty period. For example, 40 brand new vehicles have been procured for enforcement which has commenced with immediate effect but will be accelerated after the new deadline of 31st August, 2017. I am glad to note that ZRA has also recruited more officers in order to enforce its mandate of revenue collection."

Tell us real debt figures, Mumba asks Mutati

hotels, change vehicles and employ maids at government expense – a lifestyle he said was not good for him and for any other leader in a poor country like Zambia. He made sense even though everybody knew that he was bullshitting.

When resigning from the PF, the Matero MP said "My decision comes as a result of the intolerance, hate, vengeance and violent conduct towards party members; including those who supported me at the Kabwe convention in 2014. 

The causes of male infertility vary, he adds. "Lifestyle choices as well as hormonal, physical and psychological problems may result in anything from complete absence of sperm to a low sperm count, abnormal sperm shape, problems with sperm mobility or sperm that's completely immobile ... Medical disorders can also reduce male fertility." For a while, Matilda's husband refused to undergo tests to determine whether he was fertile. "He was petrified at the thought that something could be wrong with him," she told me. When he eventually agreed, the tests confirmed that he had a zero sperm count. He was diagnosed with azoospermia. The American website fertilityauthority.com defines azoospermia as a condition in which a man "produces no sperm or very little sperm in his ejaculate, giving him a zero sperm count. Azoospermia

A former boyfriend once told me he was ready to marry me – but before he made our union official, he said, we would have to get going with conception immediately. He coyly added that, as soon as I was with child, he would send his family to pay my lobola. Shocked by his arrogance, I said no. He was eager to explain his reasoning, so I heard him out. He said he had to be sure that I was able to give birth -he did not want a barren wife. I told him to take a hike. But

for the longest time afterwards, I wondered how a man could be so arrogant. I wondered if it had ever occurred to him that men, too, can be infertile. I was reminded of this incident when a friend experienced a fertility crisis. It was that time of the month and Matilda was not happy about it. She and her husband had been trying to conceive for two years, to no avail. The sight of her menses was painful for her. She was anguished and all I could do was try to comfort her.

At first, Matilda had regarded

her problems conceiving as a challenge that she would overcome in time and with dedication. She made lifestyle changes, accompanied by prayers and fasting. After months passed without the desired result, the realisation that she was unable to conceive sank in — along with a terrible sense of failure and depression. Pressure from her in-laws only made things worse. During one of our conversations, she confided in me about her shame. She described her mother-in-law looking at her

Matilda, her husband, her mother-in-law and many other people are oblivious to the fact that a man can be infertile. According to a medical professional at the Johannesburg-based Medfem Fertility Clinic, "traditionally, infertility has been thought of as a female problem, but this is far from the truth. A male can result from a problem with sperm production or sperm delivery."

Matilda's husband took the news hard, seeing it as a slight to his manhood. This was despite being told that there were treatment options available to him, such as assisted reproductive technology or having his sperm surgically extracted for artificial insemination to take place.

This raises the question: Isn't it high time that we dealt with the taboos around men and procreation? The journey to conceive should always be a shared responsibility.

Apple defends complying with China over VPNs

Apple boss Tim Cook has defended his company's decision to comply with the Chinese government's demand it remove VPN software from the App Store. Virtual Private Networks are often used to skirt censorship and surveillance in countries with tight restrictions on internet use. The company has been heavily criticised for removing several VPN apps, and was accused of "aiding Chinese censorship efforts". Apple said it disagreed with China's position but had to comply with the country's laws.

"We would obviously rather not remove the apps," Apple chief executive Tim Cook said on Tuesday.

"But like we do in other countries we follow the law wherever we do business.

Mr Cook said comparisons to a legal battle in the US last year - in which the firm refused to help the FBI unlock a dead terrorist's iPhone - were unfair.

"They're very different," he said.

"In the case of the US, the law in the US supported us. I was very clear. In the case of China, the law is also very clear there. Like we would if the US changed the law here, we'd have to abide by them in both cases." - **Bbc News**

The US government is not seeking a regime change in North Korea, the secretary of state says, amid tensions over Pyongyang's weapons programme.

"We're not your enemy," Rex Tillerson said, adding that the US wanted a dialogue at some point.

told him there would be a war with North Korea if its missile programme continued.

Pyongyang claimed its latest missile could hit the US west coast.

The second test of an intercontinental ballistic missile (ICBM) on Friday, celebrated by North Korean leader Kim Jong-un, was the latest to be conducted in defiance of a United Nations ban.

"We do not seek a regime change, we do not seek the collapse of the regime, we do not seek an accelerated reunification of the peninsula, we do not seek an excuse to send our military north of the 38th parallel," said Mr Tillerson, referring to the border between the Koreas.

respond."\ North Korea's recent longrange missile tests have deepened concern about the threat Pyongyang poses to the US mainland, and strengthened determination here to prevent any strike. That's what the president had in mind in his war talk with Senator Lindsey Graham.

The Pentagon has updated military options, but at the same time says a confrontation would be catastrophic. In light of that, Mr Tillerson repeated at length that the US wasn't seeking regime change and said the goal was dialogue, but one not based on the assumption that North Korea could keep its nuclear weapons.

Pyongyang has categorically refused such terms. The strategy, said Mr Tillerson, is a sustained campaign of peaceful but intensifying economic pressure to change its mind. But given the advances in ballistic technology demonstrated by the recent ICBM tests, there's growing doubt that denuclearisation is a realistic possibility. As always, there are no good options when it comes to North Korea, but less time to pursue them. President Trump has repeatedly criticised China, which shares a land border with North Korea and is its closest economic ally, for not doing enough to stop Pyongyang's

situation".

"But," he added, "we do believe China has a special and unique relationship, because of this significant economic activity, to influence the North Korean regime in ways that no one else can."

In a separate development, Republican Senator Lindsey Graham said that Mr Trump told him that there would be a military conflict between the two countries if Pyongyang continued with its aim to develop a missile programme with the US in its range.

"There will be a war with North Korea over their missile programme if they continue to try to hit America with an ICBM.

"He [Trump] has told me that, I believe him, and if I were China I would believe him too, and do something about it," he said in an interview with NBC's Today programme. Mr Graham added: "If there's going to be a war... it will be over there. If thousands die, they're going to die over there. They're not going to die here. And he [Trump] has told me that to my face." Despite the ongoing tests, most experts believe Pyongyang does not yet have the capability to miniaturise a nuclear warhead, fit it on to a long-range missile, and ensure it is protected until delivery to the target. They say many of North Korea's missiles cannot accurately hit targets. Others, however, believe that at the rate it is going, Pyongyang may overcome these challenges and develop a nuclear weapon within five to 10 years that could strike the US. - Bbc News



Very Good Touring, Inc., alleges that the cancellations were due to a "debilitating medical condition."

The documents state that the insurance syndicates responsible for covering the claim "have neither paid on the multimillion dollar claim nor denied the claim," more than eight months later.

"Nor have they provided anything approaching a coherent explanation about why they have not paid, or any indication if they will ever pay, or even make a coverage decision," the documents state.

According to the suit, the insurers have allegedly implied that West's "use of marijuana may provide them with a basis to deny the claim and retain the hundreds of thousands of dollars in insurance premiums paid by Very Good."

The Saint Pablo tour was originally planned for 38 shows in 2016, between Aug. 12 and Nov. 2. West performed for most of his scheduled engagements, but had to cancel two shows when his wife, Kim Kardashian, was robbed at gunpoint in her Paris hotel room on Oct. 2.

West announced that he would add extra shows to the successful tour to accommodate fans. However, during what Very Good Tours referred to as "Leg 2" of the tour, West's behavior was "strained, confused and erratic," leading to artist not being able to finish a show in Sacramento on Nov. 19.

"By the following day... Kanye's medical condition showed no sign of improvement, prompting the decision by all concerned to cancel the show scheduled at the Los Angeles Forum that evening, and to cancel the entire balance of the Tour," the documents state. "As a result of his

was not seen by insurers as sufficient grounds to cover their claim, and they proceeded to hire a lawyer. "Almost immediately after the claim was submitted, Defendants selected legal counsel to oversee the adjustment of the claim, instead of the more normal approach of retaining a non-lawyer insurance adjuster," the documents state. Immediately turning to legal counsel made it clear that Defendants' goal was to hunt for any ostensible excuse, no matter how fanciful, to deny coverage or to maneuver themselves into a position of trying to negotiate a discount on the loss payment."

The suit states that insurers forced West to prove the legitimacy of his psychological breakdown while in the hospital.

"While Kanye was still under medical care for his disabling condition, the Defendant syndicates demanded that Kanye submit to an immediate [independent medical examination," the suit states. "Kanye was made available for a purported IME by a doctor, hand-selected by the insurers' counsel, who was predisposed to look for some reason to deny the claim. Yet even Defendants' selected doctor had to admit that Kanye was disabled from being able to continue with the Tour."

"As demanded by the insurers, Kanye was also subsequently presented for an examination under oath ('EUO'), and at least 11 other persons affiliated with Kanye and Very Good were similarly presented for EUOs," the documents continued.

Despite this, they allege that the insurers have continued to stall when it comes to covering their claim, and have failed to give them an answer as to their judgement on their responsibility. However, they have allegedly "suggested they would be amendable to compromising the claim, something Very Good refuses to do." - Yahoo News
