President Edgar Lungu has declared that it is now mandatory for every Zambian seeking any medical attention to be tested for HIV/AIDS, and told the results without consent.

Speaking when he launched the HIV Testing, Counseling and Treatment Day (HTCT) today, President Lungu said even though some people in Cabinet held the view that this was not in line with Human Rights, he held the position that no one had the right to take their own life. "The HIV scourge has continued to pose

one of the biggest threats to our country's development. The Patriotic Front government under my leadership is up to the task and has embarked on a transformative shift through emphasizing HIV voluntary counseling and testing to HIV testing and treatment. Just yesterday when we sat in Cabinet, we had this subject HIV testing and treatment, I must confess that there are some colleagues who felt that this is contrary to Human Rights and

## DPP entered nolle to hide State's crimes against HH and his co-accused — Wynter

Rainbow Party president Wynter Kabimba says the Director of Public Prosecutions (DPP) Lillian Siyunyi entered a nolle prosequi in the treason case in order to shield the State's crimes committed against UPND leader Hakainde Hichilema.

He said if the DPP had not entered a nolle prosequi, Hichilema would have had the liberty to sue the state because his detention was unlawful "from the word go". "The case cant resurface, the only reason why they have entered a nolle is because if they don't enter a nolle, the whole detention would have been an unlawful detention and HH would be at liberty to sue the state. There is no case in the history of Zambia where the state has entered a nolle and they have revived that case. Not in my over 30 years of my legal practice. So they are shielding themselves against the wrongs that they have committed against HH, the breaking of his house, the unlawful detention of the man when they knew from the word go that there was no case," Kabimba said.

Kabimba said entering a nolle was abuse of the whole process and misuse of the purpose of a nolle Prosequi. "I said it from the word go when HH was arrested that there is no treason offense that had been committed in this situation. The whole situation was political, the prosecution knew very well, and am sure even President Lungu knew very well that HH had not committed any acts of treason. And this is a problem when you have the DPP who is being controlled by the executive because am sure even when that docket landed on the DPP's desk! If she was professional enough, if she had acted professionally she should have realized that there was no acts of treason that had been acted by HH and his group. So we in the Rainbow party have maintained the position that there was no


acts of treason committed by HH," Kabimba said.

"Even to enter a nolle is an abuse of the whole process of a nolle Prosequi. And it has been very common in all the governments for the executive in collaboration with the office of the DPP to abuse nolles. This is exactly what has happened now. They went and damaged the 'poor' guy's house! They have kept him in detention for the last four months when they knew very well that there was no act of treason committed. It didn't even have to take the Secretary General of the Commonwealth to intervene in this matter."

Kabimba said it was because of the colonial hangover from the government leaders that credit had to be given to interventions by outsiders like the Secretary General of the Commonwealth Patricia Scotland, when the local Catholic Bishops had already done the work.

"What is it that the Secretary General of the Commonwealth said to President Lungu which our Bishops didn't say to him? This is the problem with Africa that we want to respect outsiders in resolving our problems instead of looking inwards. What was so special about the Secretary General of the Commonwealth? How is she more special than the group of Bishops that showed respect to the President by engaging him in this matter?" Kabimba asked.

"But because of this colonial hangover, you have to wait for somebody from outside so that you give credit to outsiders and not your own people in resolving problems. The church in Zambia has had impeccable credentials and intervening in political crisis. They did in 1991 when there was tension in this country. Why should President Lungu respect an outsider against his own people? A group of respectable and eminent men in our society in the name of catholic Bishops who showed respect to



him by engaging him and say 'can we get this matter resolved domestically' it has to take Secretary General of the Commonwealth to do what they should have done

a long time ago. And Kabimba encouraged Hichilema to push for a

better Zambia.

"So I hope that now that HH is out, he will continue the struggle for a better Zambia. You cant continue at this rate, no! So I hope he is going to get more encouragement from his suppers in the UPND and sympathizers

from outside the UPND so that the struggle can continue until we get to live in a better society than this one which the PF is driving today."

"Any empowerment program for the women especially in rural areas should be supported.



# Hichilema free, as State discontinues treason case

The Director of Public Prosecutions Lillian Siyunyi has entered a nolle prosequi in Hakainde Hichilema's treason case. When the matter came up for commencement of trail this morning, the DPP informed the court that she had decided to enter a nolle.

"At this juncture I would like to inform the honorable court that I am entering a nolle prosequi in respect of all the accused persons before you, having regard to Cap 187 of the Constitution of the Republic of Zambia.

Article 180, paragraph seven of the laws of Zambia, Siyunyi said.

without giving the defense team an opportunity to respond, judge Charles Chanda said; "The DPP has decided to terminate these proceedings by virtue of her constitutional powers. Therefore, you are hereby discharged from this offense. But this is not an acquittal as at any time, you can be arrested for this [same] offense but for now you are free to go home."

At this point, HH's wife Mutinta was too overwhelmed and she broke down. Some members of the opposition UPND then got her out of the courtroom to the car where she continued crying.

Hichilema himself did not seem pleased with the outcome of his treason case, as he did not show signs of relief upon hearing the nolle prosequi pronouncement.

Meanwhile, the DPP's decision drew mixed feelings from the court attendees, some of whom were heard saying "this is nothing to be happy about, these men have suffered a lot for nothing." Hichilema and his five coaccused were then taken

back to Lusaka Central Prison for discharge formalities, as UPND supporters waited in sing and dance outside.

On April 10, 2017 police raided Hichilema's house in New Kasama, breaking furniture and other property in the process. He however remained in hiding until the following day when he gave himself

to police.

On April 12, 2017, Inspector General of police Kakoma Kanganja held a press a press briefing to announce the charges.

"I would like to inform the nation that we have jointly charged and arrested Mr Hichilema and five others; 1. Treason contrary to section 43 (1) (a) 2.Disobedience to lawful orders contrary to section 127 of the penal code. 3.Disobeying of statutory duty contrary to section 126 of the penal code of the laws of Zambia (rule No. 222 of the High Way Code) And 4. Use of insulting language contrary to section 179 of the penal code," Kanganja said.

My position was that 'no one has got a right to take his own life' therefore to make sure that we must protect life in Zambia generally and across the board. So just as we test for malaria, we don't consult you to consent whether you should be tested for malaria or not, we will do the same with HIV and AIDS," President Lungu said.

"And we will counsel you and tell you that you have got this problem, you need to embark on treatment. That is what we are going to do, that is the Zambia position. So those of you who will be seeking medical help from our health institutions, we will not be questioning you whether you have tested for HIV and AIDS. If you are in a coma, we will do what we can to resuscitate you and when we resuscitate you, we will subject you to all the tests including HIV/AIDS and if we find you somehow positive, we will put you on treatment. That is the position of Zambia and its official, no debate about it."

He also urged all Zambians to participate in the efforts of ending HIV/AIDS by going for testing even without getting sick.

"As we gather to launch the HIV Testing, Counseling, and Treatment day which was commemorated as the national voluntary counseling and Testing (VCT) day. The HIV Testing, Counseling and Treatment Day commonly known as the HTCT will be commemorated every year on the 15th day of August as a symbol of my government's resolve to end AIDS in Zambia by the year 2030. This is a very serious commitment and I hope that our cooperating partners will continue to support us just as much as we will support ourselves," President Lungu said.

"This broad decision prioritizes HIV testing and immediate commencement of retention of Anti-Retro-viral treatment to all Zambians living with HIV. We will not wait for people to fall sick before they can start life serving treatment. Let us take integrated health services by taking HIV services and treatment to all the communities in Zambia."

President Lungu further directed Health Minister Dr Chitalu Chilufya to find a way of compelling men to also go through HIV testing so that they could also know about their status. "According to the Zambian demographic health survey of 2014, only 67% of the Zambia population knew their HIV status and HIV testing rates. And HIV testing rates for men remained lower than those for women. I know that women go to the maternity clinics are upheld of this test but most men because they do not have this opportunity of maternity, they don't know their status. So Dr Chilufya, can you find a way of compelling men to also go through HIV testing so that we can also have higher percentage of our men knowing their status," said President Lungu.

The 2017 theme for the HIV Testing, Counseling and Treatment Day is 'Test and Treat, towards ending AIDS'.

Though I have been in prison, we have been sneaking in information in our cells so we know what has been going on and we thank you for your strength. I want to continue in expressing our appreciation to our party leaders across the country for having been very strong despite the circumstances.



I want to thank all of these gentlemen that when we agreed things in our cells, they respected what we agreed. And we strengthened each other, it would have been very difficult. When I was detained in Lilayi for eight days, I was in solitary confinement, it was a bit difficult because you don't speak to anybody but when we linked up, we were able to speak to each other, thank you so much, thank you to them and thank you to their families and I thank their families for the support that they rendered to the fellow detainees. I want to thank Mwaliteta group, I want to thank the Matambo group on the Copperbelt and I want to tell you that a lot of our people are in detention across the country and I have made it my responsibility, it should be

your responsibility, it should

be our responsibility to secure

the release of all our people that are in detention across the country. That is our duty. I cannot say I am free when a lot of my members are in detention, then I am not worth being a leader.

I can go on and on but I would like to also indicate my special appreciation to President Obasanjo, you know Nigeria has 200 million people so he is a great man, to lead 200 million people is not a joke. I want to thank a few friends around, Mmusi Maimane of the DA, a good friend of ours, I want to thank Julius Malema of the EFF, I want to thank Prime Minister Raila Odinga, I want to thank my good friends across the Zambezi Tendai Biti for the tremendous support and others I do not want to mention, including certain people that you many have never understood that they did something but they were doing something. So thank you to all

of these people. I say the list can go on but you have been anxious for many months, I need you to rest. And we are committed, as everybody should be in this country committed to peace, stability for development, we cannot continue living the way we are. It is uncomfortable. But I want to commit that we are committed to the principles of the Commonwealth and their values on the rule of law, on good governance, on human rights, and basic freedoms, universal freedoms, that's why we are seeking the release of all our people who are in incarceration. I want to say to you, it is also our collective duty to bring back unity in our country, we are so divided today, we cannot run a country in this manner and for us in the UPND, we must call out to our opposition colleagues to come together for a unity of purpose and bring order in our country. It is not correct for our people, for my young friend Clance Zulu to be buried the way she was buried. It is not correct. We have to do something and we are committed to do something. Just watch what we are going to do in a couple of days and months, just watch. There are many people who were saying 'oh, aza choka mu jele abeba [he will come of prison a tired man]', Hakainde, oyembela ng'ombe angabebe? [Hakainde who herds cattle can he get tired?] I want to assure you that we

are stronger now than before,

we are 10 times stronger than before we were incarcerated. But our strength will be used in a correct manner because we do not want to be as weak as others, we don't want to be as wicked as others, we want to make sure that we provide leadership in this country so that our people can benefit from good leadership. So I ask all of you to be strong. If your president can be out there for 126, 127 days, we can all be strong. That is all I ask you and I want to close by once again thanking you so much and I want to thank at the end my wife. I didn't know that she was this strong. I am lucky that I married this woman, I am very lucky. So once more, God bless Zambia, God bless all of us. We shall take leave now, going home, I know you know that there will be a lot of people coming to say hello to us but you must be patient, in the next few days, we are going to have a fully blown press briefing where we are going to address each of the fundamental issues that affect you and that affect this country because you know that the criminal justice system has broken down in our country starting from law enforcement, the police, total breakdown, to the prison, those prison cells are death chambers, people are dying in those chambers every day. We have to address the prosecution, we have to address the Judiciary side, so many things are wrong in our country but we are going to assemble and discuss those issues with you with diligence. Otherwise, once more, I look at you, I am humbled for your support. I was worried that you may be dismantled in my absence. God bless you all.

# Compulsory HIV testing is against human rights - FDD

The Forum for Democracy and Development (FDD) says President Edgar pronouncement Lungu's HIV/AIDS make testing compulsory for any Zambian seeking health care is a violation of human rights.

Responding to a press query from News Diggers!, Mwanza observed that compulsory testing for HIV would be detrimental to the Health profession because it want or not. As FDD we

was unethical.

"President Edgar Lungu has declared HIV testing mandatory or compulsory, meaning that from now on you will be forced to take an HIV test whether you

strongly oppose mandatory testing for a number of reasons: firstly, mandatory HIV testing is unethical as it violates human rights; it violates the privacy and bodily integrity of persons and is actually detrimental to public health as it is counterproductive as many people would shy away from health centres for fear of being forced into testing against their will," Mwanza

And Mwanza said forcing people to test for HIV against their will neither resulted into behavioural change nor guaranteed reduced cases of HIV/AIDS.

"Studies the world over have proved that mandatory testing does not result into reduced cases of HIV and AIDS. There is no evidence whatsoever that mandatory testing of HIV results into behavioural change. The World Health Organisation, to which Zambia is a signatory has defined five components(5-Cs) that must be respected and adhered to by all HTC services comprising of confidentiality, consent, counselling, correct test results and connection to prevention, care and treatment. The five Cs, and the key principles they entail, apply to all models of HTC services," Mwanza

"People being tested for HIV must give informed consent to be tested. They must be physically and psychologically prepared to take the test. They must be informed of the process for

HTC, the services that will be available depending on the results, and their right to refuse testing. Mandatory (coerced) testing is never appropriate, regardless of where that coercion comes from, government inclusive." Mwanza advised government to start looking into ways of combating further spread of HIV/AIDS and other related infections. "Instead of forcing people to test for HIV against their own will, government should instead focus its energies on addressing issues that would help to combat the spread of HIV such as ensuring expanded access through an ethical process for conducting HTC, including defining the purpose of the test and the risks and benefits to the person being tested. Assuring linkages between the site where the test is conducted and appropriate treatment, care, prevention, and other services, in an environment that guarantees confidentiality of all medical information," stated Mwanza.

HIV-related Reducing stigma and discrimination at all levels, including within health-care settings. Improving the health care infrastructure so quality services adhering to these principles can be sustained in the face of increased demand for testing, treatment, and related services and ensures effective monitoring and evaluation is in place."

### hinese rhino smugglers named

The three Chinese nationals who were last month arrested illegally for possessing 25 pieces of rhino horns weighing 32.2 kilogrammes at Chanida Border in Eastern Province have been named as Hung Qingzhou, He Qingmao and Wan Qin, while the two Zambians who were involved have been identified as Lovemore Kamwendo and Obert

They five have since been charged with possession of prescribed trophy and appeared before Chadiza Magistrate Fred Musaka where they pleaded not guilty.

Their lawyer Chansa Mulenga Kapatamoyo applied for bail but Magistrate Musaka could not grant it on grounds that they Chinese were a flight risk as they did not give exact addresses for their residences. The Chinese told the court that they are residents of Beira in Mozambique, while their Zambian counterparts -Kamwendo, a driver and Simwajata said they were residents of Chelston and Ngombe in Lusaka respectively. Their second court appearance was on Thursday 10th August after their lawyer applied for a review of the bail application. Magistrate Musaka again refused to grant bail on the same grounds.

## ConCourt allows inmates to vote

The Constitutional Court has passed a landmark judgement, giving inmates the right to vote.

This is in a matter in which Prisoners Care and Counselling Association (PRISCCA) petitioned the ConCourt over the prisoners' right to vote.

In his petition PRISCCA executive director Godfrey Malembeka submitted that Prisoners did not forfeit their fundamental rights upon being sentenced and as such, they should be allowed to

Malembeka argued that even though the inmates lost freedom upon being jailed that did not take away their right to participate

in elections.

Being an ex convict, Malembeka instigated the petition in a bid to champion rights of pre-trial remandees and those awaiting

bail and appeals to vote in an election within prison facilities. ConCourt judge Annie Sitali passed the verdict in favour of PRISCCA despite the state having objected to the application.

### ConCourt refuses to join Lungu to 2021 eligibility case

The Constitutional Court has dismissed an application to join President Edgar Lungu to the 2021 eligibility case saying he cannot be subjected to litigation.

But the ConCourt has joined PF Secretary General Davies Mwila to the proceedings saying he is an interested party.

This is in a matter in which some PF inclined opposition leaders asked the ConCourt to determine whether or not President Lungu was eligible to stand in 2021.

The UPND, the second interested party, had asked the court to join President Lungu to the proceedings saying the Constitution did not bar the action against him as the issues to be determined were not related to his executive functions but his own personal ambitions.

Party secretary Katuka Stephen President Lungu and his secretary general had publicly proclaimed that he qualified to stand as a presidential candidate in the general elections slated for 2021.

But ConCourt judge Professor Margaret Munalula said the President was shielded from civil litigation in order to enable him to effectively perform executive functions.

"Given the pronouncement in Article 98 (1) and (2) the application to join the 5th intended applicant had no merit and it is dismissed," said Prof Munalula.

And on joining Mwila to the case, Prof Munalula said; "I find that the Patriotic Front has sufficient interest in the matter herein to warrant their being joined."

Justice Munalula however said the action was untenable and impracticable as it is against the fundamental principle of free will attributable to persons at law.

He said although Mwila had been joined, he could choose whether or not to participate in the proceedings.

"Once the 6th intended applicant opposed joinder as an applicant, he could not be joined as the 6 the intended applicant," said Justice Munalula.

# Court orders CEC to resume electricity supply to Mopani

The Kitwe High Court has granted Mopani Copper Mines (MCM) an interim injunction restraining the Copperbelt Energy Corporation (CEC) against limiting power supply to the mining firm until the matter is determined by the court.

This is in a case in which MCM has sued CEC and Zesco as first and second defendants, respectively. CEC has been restricting power supply to MCM since Friday last week.

According to a statement of claim filed in the Kitwe High Court, MCM also wants the court to make a declaratory order that the attempt by CEC to obtain tariff increment outside the process that is clearly outlined in the Power Supply Agreement (PSA) is null, void, and unlawful.

The mining firm also wants CEC to pay damages for breach of contract arising from the manner CEC has attempted to obtain a tariff increment outside the process stipulated in the PSA entered into between the defendant and the plaintiff.

MCM is seeking interest or any sum found to be due to them in addition to costs and any other relief that the court may deem fit.

It contends that in March 2005, it entered into a PSA with CEC that subsequently underwent two amendments in 2008 and 2015, and that clause 3.3 of the power purchase agreement outlines the process that is supposed to be followed in effecting a tariff increment.

MCM argues that CEC proposed a tariff increment in January this year following proposals from the Ministry of Energy, but the plaintiff stated that needed to consult in line with the provisions of the PSA. MCM stated that no agreement has been reached between it and CEC regarding the issue of the tariff increment as negotiations have been on

MCM said by their conduct, CEC and Zesco have breached a fundamental provision of the PSA, and as a result of their action, the plaintiff has suffered loss and damage.

High Court judge Timothy Katanekwa granted MCM an injunction to restrain CEC from reducing power supply

to the mining firm pending hearing of the inter parte summons, or until further order of the court.

He further ordered Zesco not to restrict power supply to CEC until the matter is fully determined by the court.



### Fishing ban too short to allow breeding - Chilangwa

Luapula Province Minister Nixon Chilangwa says the three months fish ban period is not enough to allow breeding.

Featuring on ZNBC's Government Forum yesterday, Chilangwa said there was need to increase the ban period because it would also encourage people to resort to alternative activities for their survival.

"I don't believe that the three months fish-ban period is adequate, I believe we need a longer period and we do not have to close off all the water bodies. As you know, Luapula Province has got over 30 per cent of the water resource of this country. So we can segment to say this river or this lake and so on, we can close them for six months or we can close in some areas for a year so that the fish can regenerate and once the fish regenerates in the water bodies that we are likely to close, what we can do is to alternate the water bodies that were left open then can be closed but once we open the water bodies which were closed for a number of months or years," Chilangwa said.

"After that is done, then we can

put regulations to say where somebody goes to fish using a mosquito net, it is a crime and you can go to jail for that. We should also make it clear to say that we should not leave the water bodies in the manner that we have done, we need to have constant patrols on our rivers and lakes so that those who are doing wrong things can be brought to book."

Chilangwa also said he wanted to introduce commercial fishing methods in Luapula Province.

"We also want to bring in commercial fishing where we can bring in cages on the rivers and the lakes so that there is commercial fishing taking place in the rivers and lakes of Luapula province like we have in Siavonga and like the fish that we are getting from Zimbabwe or from China and other places where they have engaged in commercial fishing. So we want to start that kind of fishing this year and we have identified 19 sites in Luapula province on the Luapula fisheries where fish caging will be done, "Chilangwa said.

we can have people growing fish at their back yards and if

we can have many households growing fish on a family level just in the same manner people keep goats and chickens, we want it to be a tradition which we must inculcate in our people. Apparently Luapula people most of them have been fishermen from time immemorial so it is a skill that they already have."

Chilangwa noted government had failed the people of Luapula in the past.

"If we go back to our books in history, you will find that Luapula Province was the third biggest economy in this country just running after Lusaka and the Copperbelt Provinces and what was driving that economy was the fishing industry. But that has actually changed because of population explosion and bad fishing methods and due to lack of political will on our part as government. In the past and I am including the PF because where I come from they say 'Mupyanango apyana namabala, meaning that when you inherit a leopard, you also inherit its dark spots. So when you inherit governance it means you do not only inherit the good things that have been achieved in the past but also the negatives," Chilangwa said.

"So that's what we are saying that as government there are certain things we failed to put in place in the past so what happened is, because of bad fishing methods amongst ourselves as people from Luapula Province, we have over fished our rivers and our lakes and as government, we have no will to ensure that we put in measures to ensure that we implement sustainable ways of fishing. And as PF government, we have realised that if the economy of Luapula province was able to be pushed to that level during those early years, it is possible that it can also happen now. What we have to do is to put in measures that can curb the vice."

Meanwhile, Chilangwa said the only way to reduce poverty in Luapula Province was to start making efforts to improve the economy at household level so that people did not depend on handouts.

"The poverty levels in Luapula Province are very high and even though we have a lot of people helping us, I do not believe personally that hand outs can actually reduce poverty levels, my great belief is that poverty can only be reduced by economic performance. If we have economic performance at individual level, at household level, community, district and institutional level, then we are going to start making some real strides in ensuring that we start reducing poverty levels. So we have to look at the infrastructure availability in the province, what infrastructure do we have in the province and what infrastructure do we need in the province? So that we can use it as a platform for development, so we have to look at all those things to come up with a basis of what we need to do in the Province," said Chilangwa.

"It does not make sense for these firms to fail to abide by the new tariffs when domestic users are paying. Mopani is not paying, Kalumbila is not paying, Kansanshi is not paying, those mines that are not paying, we will give them the amount of power equivalent to the new tariff at 9.3 cents and it is as a result of that we have restricted, for example what I have here, Kalumbila, they are supposed to be getting 155 MegaWatts, Zesco has restricted to 110 Megawatts, Kansanshi

On Friday, Copperbelt Energy Corporation (CEC) began restricting power supply to the three mines, forcing Mopani to send home some of its employees. A court hearing to resolve the dispute is scheduled for this Thursday.

As a matter of fact, this extends to non-Zambians who go to our public hospitals. This is not a small pronouncement; it is a declaration which will have serious consequences on the country and its citizens. Therefore, we urge all Zambians and government stakeholders to take a moment to critically think about the benefits and repercussions of the declaration made by the President of the

Republic of Zambia. "The HIV scourge has continued to pose one of the biggest threats to our country's development. The Patriotic Front government under my leadership is up to the task and has embarked on a transformative shift through emphasising HIV voluntary counseling and testing to [compulsory] HIV testing and treatment. Yesterday when we sat in Cabinet, we had this subject 'HIV testing and treatment', I must confess that there are some colleagues who felt that this is contrary to Human Rights and rights to privacy. My position was that 'no one has got a right to take his own life, therefore this is to make sure that we must protect life in Zambia generally and across the board. How can President Lungu declare that there will be no debate about this issue as if he owns Zambian citizens? A President does not own citizens, not even those who voted for him. Therefore, he cannot authoritatively dictate personal and private decisions on behalf of citizens. Those who came up with the idea that HIV testing should be voluntary knew that, because of the nature and stigma that unfortunately continues to be associated with positive living citizens, a person's mind needed to be psychologically ready and prepared for the news. You cannot have a situation where someone visits a dentist for a toothache, only to be dragged on the side and told that "by the way, you also have this problem". Not everyone is ready to hear their HIV status at the same time. Other people will go to the hospital to check their BP before sitting an exam the following day, so how does President Lungu think telling such a person that they are HIV positive on that day help?

When we heard President Lungu saying the move is meant to end AIDS in Zambia by 2030, we wondered if the health minister misled the Head of State into believing that those who are on HIV treatment cannot spread it. We are shocked because anyone who has ever gone for counseling knows that AIDS is most commonly transmitted through sexual intercourse. Anyone who has ever gone for testing knows that AIDS is prevented by sleeping with one faithful partner or having protected, safe sex. What HIV/AIDS treatment does is prolong the infected person's life, not the life of the person they are going to have unsafe sex with. Therefore, the whole nation can be on HIV treatment, but for as long as people continue to have unsafe sex, the prevalence rate will not reduce at all. To end AIDS by 2030, President Lungu must find ingenious ways and means of persuading citizens to indulge in safe sex, not just getting treatment.

President Lungu said his decision was based on the Zambian demographic health survey of 2014, which showed him that only 67 per cent of the Zambian population knew their HIV status. What else does that health demographic survey say? Does it say that HIV/AIDS remains the number one killer disease in Zambia? Does that survey have the cancer mortality rate statistics? President Lungu also says refusing to know your status is like taking your own life. But is that not the case with all other diseases? Why did

President Lungu's Cabinet | pick on HIV/AIDS alone for compulsory testing? Why is government not interested in compulsory cancer screening for all men and women who seek any form of medical help?

Our opinion is that President Lungu is wrong on this issue. He must reverse the declaration before it creates a crisis, especially in the rural areas of Zambia where people don't fully understand their rights, and HIV/AIDS knowledge is limited. The President is trying to create a new law without fully agreeing with his own Cabinet, let alone Parliament. If government spent money to consult people on maintaining membership to the International Criminal Court, how can it fail to find resources for a consultative process of such a thorny

Anyway, we understand that whatever President Lungu declares never gets reversed. So we know that no matter how much the Human Rights Commission speaks, no matter how much stakeholders talk, compulsory HIV/AIDS testing is here to stay. Our plea, however, is to ask President Lungu and his Cabinet to lead the way. Since they want hospitals in Zambia to know every citizen's HIV status, let them lead by example in testing for HIV publicly, they must go a mile further by publishing their results. We need to know how healthy our health minister is, and all others who support this move. We propose this in

order to demonstrate to President Lungu how his members of Cabinet will fight to protect their rights to privacy. Our ministers know very well because the majority, if not all, of them are sexually active. They know that being minister or President does not give anyone the immunity from contracting AIDS. But if President Lungu insists, let us give him a chance to take the challenge. Let him try this at home. Let him propose to his family that everyone should know their status at any given time. Let us see if he will unite his family on this thorny issue. If President Lungu's family does not resist, Zambians will be encouraged. At that point, we will join our caring Head of State in pushing for this agenda. In fact, we will demand that not only should there be mandatory testing for HIV/AIDS, but all other killer diseases because without treatment, so many illnesses out there can kill, including achalasia.

### Can diplomatic immunity save Grace Mugabe from going to jail in S/Africa?

Protection & privileges certain extended to foreigners

What is diplomatic immunity and under which circumstances does it apply to foreign citizens visiting or working in South Africa? Professor Hennie Strydom, who holds the South African Research Chair in International Law at the University of Johannesburg, explained to Africa Check how it works.

"Diplomatic immunity refers to the protection and privileges extended to certain foreigners, such as members of diplomatic missions, consuls, ministers of foreign affairs and heads of state," he said.

> The immunity includes that people protected by it "shall enjoy immunity from the criminal jurisdiction of the receiving state", as set out by the 1961 Vienna Convention on Diplomatic Relations. Most countries in the world have ratified this convention, Strydom said.

Following ratification, local legislation has to be enacted to give effect to the convention. In South Africa, this happened through the Diplomatic Immunities and Privileges

Diplomatic protection only applies to people in the course of conducting official state business. As Mugabe was reportedly travelling in her private capacity, she may therefore be prosecuted.

director-general Deputy of the department of international relations and co-operation, Clayson Monyela, told Africa Check: "The lady [Grace Mugabe] is appearing in court. The only way that can happen is if she was arrested or turned herself in. This wouldn't have happened if she had diplomatic immunity."

The second is that the country of origin could revoke immunity. Monyela provided an example: "Say you are a South African diplomat and you are posted somewhere. Whilst you are there you commit a crime, like murder, and it comes to the attention of South Africa.

# Philippine drug war sees 'bloodiest night' of deaths

Philippine police have killed 32 people in drug raids, thought to be the highest death toll in a single day in the country's war on drugs.

The raids took place over 24 hours on Tuesday in Bulacan province, north of the capital Manila.

Police said that those killed were suspected drug offenders who were armed and resisted officers.

Thousands have been killed since President Rodrigo Duterte launched his controversial war on drugs in 2016.

The campaign, aimed at wiping out the drug trade, has attracted intense international criticism over the number of deaths. Mr Duterte has in the past sanctioned extrajudicial killings.

Tuesday's operation, which lasted from midnight to midnight, comprised dozens of raids carried out across Bulacan according to local reports. More than 100 people were arrested and officers seized illegal drugs and arms in the raids.

Handcuffed male residents are rounded up for verification after police officers conducted a large scale anti-drug raid at a slum community in Manila on 20 July 2017. Despite falling away from the international headlines, the record

number of killings is a reminder that President Duterte's war on drugs is far from over.

In a strongly worded public address last month he warned drug users that he would hound them to the "gates of hell."

I recently met a woman

who told me her son was shot and killed by masked vigilantes during a late evening "buy-and-bust" raid. She insisted her son wasn't a dealer, and had his marijuana use declared to the authorities three months before the killing.

Despite stories of extrajudicial killings like this, many in the Philippines support the war on drugs. Taxi drivers have told me that roadside bag snatching has subsided. Manila residents I've spoken to say the streets feel safer. *BBC News* 

At least 600 people are still missing following a mudslide and flooding that devastated parts of Sierra Leone's capital, Freetown, a spokesman for the president has told the BBC.

President Ernest Bai Koroma earlier pleaded for "urgent support", saying entire communities had been wiped out.

Nearly 400 people are confirmed dead after a mudslide in the Regent area and floods elsewhere in Freetown on Monday.

The Red Cross has warned it is a race against time to find survivors.

A mass burial of victims is planned on Wednesday to free up space in mortuaries.

A disaster waiting to happen?

Presidential spokesman Abdulai Baraytay told the BBC that bodies were still being pulled from the mud and rubble.

"The entire community is now in mourning. Loved ones are still missing, well over 600 people," he said. The UN said its teams in Sierra Leone had mobilised and were supporting rescue efforts.

"Contingency plans are being put in place to mitigate any potential outbreak of waterborne diseases such as cholera, typhoid and diarrhoea, UN spokesman Stephane Dujarric said.

Homes in the hilltop community of Regent were engulfed after part of Sugar Loaf mountain collapsed following heavy rain early on Monday. Many victims were asleep in bed when disaster struck.

President Koroma fought back tears as he toured Regent on Monday and said the devastation was "overwhelming us".

"Entire communities have been wiped out. We need urgent support now," he said.

He urged people to stay away from the affected areas.

"This tragedy of great magnitude has once again challenged us to come together, to stand by each other and to help one another," he said.

Flooding is not unusual in Sierra Leone, where unsafe housing in makeshift settlements can be swept away by heavy rains.

The rains often hit areas in and around Freetown, an overcrowded coastal city of more than one million people. *BBC News*

The socialite-turned-businesswoman sat down with Marie Claire for a wide-ranging interview on everything from family friend President Trump to that infamous video. Hilton, now 36, says the sex tape with then-boyfriend Rick Salomon is something she regrets.

Hilton was 18 and Salomon 33 when the tape was released without her consent. The heiress denies she participated in the video's release for fame or profit.

Hilton continues, "I wish I had never met him. That

One person who admits to watching the tape? Hilton family friend Trump. He's been close with Paris's father, Rick Hilton, for decades.

Paris was asked if it creeped her out that Trump watched the intimate video, and the Marie Claire interviewer writes that Paris "shrugs it off: It was on Howard Stern's show."

Hilton says she didn't vote for Trump — she didn't vote at all — but also dismisses his infamous "grab them by the pussy" tape.

"I've heard guys say the craziest things ever, because I'm always around guys, and I listen to them speak," she says.

As for the women who alleged that Trump sexually assaulted them, she told the magazine, "I think that they are just trying to get attention and get fame."

Still, Hilton views herself as a feminist. "I just feel it's about women's empowerment and girl power, and I'm very into that," she says.

The love is mutual between Paris and Trump, who once called the heiress "dumb like a fox." Her sister, Nicky Hilton Rothschild, also tells the magazine, "[Paris] didn't get this far by being dumb." *Yahoo News*

## Nadal passes Federer in ATP rankings

What a difference a year makes.

With the U.S. Open, the final Grand Slam of the year, set to get underway on

Aug. 28, the ATP rankings have seen some big changes in the top five due to injuries. Next week, Rafael Nadal will return to No. 1

for the first time since July 2014, leapfrogging Andy Murray and Roger Federer. Murray (hip) and Federer (back) both withdrew from

the Cincinnati Masters, prompting Nadal to move up. Novak Djokovic, who has battled injuries this

year, decided to shut down



### 'Aunt' Venus preparing for Serena's baby and US Open

Wimbledon Australian Open runner-Venus Williams is preparing this week for the US Open and to become a new aunt with sister Serena giving birth to a baby soon.

Ninth-ranked Venus advanced Tuesday the second round at the WTA Cincinnati Open by eliminating US compatriot Alison Riske 6-2, 6-0 in 66 minutes.

But off the court, she's doing some online shopping for Serena's baby, and getting some valuable advice from her mother, Oracene Price, who has raised five daughters.

"I have a lot of things in my cart that I'm about to order," Venus Williams said. "I talked to my mom yesterday. I'm like, 'Mom, what do you really, really need?' So she really gave me the low-down.

"So I'm going to get this stuff and as things progress I'll see what I need after." Serena and her fiancee, Reddit co-founder Alexis Ohanian, have said they plan to keep the sex of the baby a surprise until birth. Serena, 35, was pregnant when she beat Venus, 37, in an Australian Open final that was more all-Williams than either knew, winning a 23rd career Grand Slam singles crown, one shy of Margaret Court's all-time record.

In April, Serena revealed on social media that she was pregnant. She is expected to give birth in about another month. With Serena sidelined, seven-time Grand Slam winner Venus has picked up the family mantle and turned back the clock, making a run to the Wimbledon final last month, losing to Spain's

Garbine Muguruza in a bid for her first Slam crown since 2008.

Venus, who won five Wimbledon and two US Open titles, has been an aunt before, but not when she was old enough to do some serious spoiling and spending on the new arrival.

"This is the first time I've been an aunt as an adult," she said. "So it's a completely different experience than before when I was a child." Yahoo his season in July to fully recover from an elbow iniury. Stan Wawrinka, who has battled knee problems, also cut short his season.

It's been a big year for both Nadal and Federer after uneven results last year. At the end of 2016, Nadal was ranked No. 9, while Federer was ranked No. 16, with many wondering if the two legends may have lost a step. At the top, No. 1 Murray and No. 2 Djokovic were separated by just 630 points. Milos Raonic, who was ranked No. 3, trailed Djokovic by 6,330 points. Nadal, 31, conceded that it's been "tough to get back to No. 1." He had spent a total of 141 weeks in the top spot, with 56 consecutive weeks at No. 1 taking place between June 2010 and July

2011. The clay-court specialist showed support Federer, who described his back injury as a "tweak." The Swiss legend has enjoyed a big year, winning both the Australian Open and Wimbledon, providing additional intrigue ahead of the U.S. Open.

"Obviously, it's bad news for the (Cincinnati) event that Roger is not playing. For me personally obviously to be back to that position is something special," Nadal told reporters Monday. reaching

Australian Open final and cruising to his 10th French Open title, Nadal's comeback has been impressive after suffering through many setbacks in 2015 and 2016.

"A lot of things have happened since the last time I was in this spot. Injuries and some tough moments, of course, but I have held the passion and the love for the game, and that's why I have the chance to be back in that position again. So I'm just trying to enjoy the moment and just trying to be ready to compete well here. That's the most important thing for me now."

Oddsmakers list Federer and Nadal well ahead of the pack for the U.S. Open. Federer remains the favorite to win at Flushing Meadows with his odds listed at +110, while Nadal has the second best odds at +250. Murray is listed at +500 and Alexander Zverev is fourth at +800.


Federer has won the U.S. Open five times. Nadal has won the tournament twice.


