By Sipilisiwe Ncube Opposition UPND president Hakainde Hichilema says he will have no credibility to claim that he is different from those who brutalised him into incarceration, if he does not forgive them.

Speaking yesterday during the thanksgiving prayers for his release from prison at the Cathedral of the Holy Lusaka. Cross in Hichilema also emphasised the need for dialogue.

"I want to say to you on behalf of our colleagues that despite the injustices, despite the inhuman treatment that we endured following our brutal arrest of course and detention, we harbour no bitterness, we harbour no anger because the Bible says if you are angry all the time, you will make mistakes.

Fire guts 3000 market stands, as Ndola council rules out arson

By Sipilisiwe Ncube Fire has swept through Kapalala market in Masala township in Ndola destroying merchandise in over 3,000 shops. And the Ndola City Council has ruled out arson.

Meanwhile, police have arrested a charcoal trader in connection with the fire. The market has been reduced to ashes from an inferno that started between

01:00 and 02:00hours.

A combined team of fire fighters and the residents managed to put out the fire, but it was too late to salvage much.

According to Ndola mayor Amon Chisenga who visited the place in the early hours, over 3,000 stands have been destroyed.

The cause of the fire is yet to be established. Continues on page 4

National budget planning lacks inclusive participation – CSOs

Civil Society Organisations (CSOs) have observed that lack of inclusive participation in the planning process of the National Budget has led to slowed development in the country.

At a Civil Society for Poverty Reduction (CSPR) organised workshop yesterday, Consumer Unity and Trust Society (CUTS) International Zambia Coordinator Chenai Mukumba observed that many Zambian citizens had no idea what the National budget was.

"The lack of inclusive participation in the budget making process in this country is what has led to most people especially in rural areas to start thinking that they have no say in the decisions made by the government. Some of these people lack the knowledge of how and where government gets the money to fund all its departments on an annual basis without realising that the money actually comes from the tax that they pay through purchasing items, paying for roads and many other taxes. That is why they even think government is

doing them a favour when a road is constructed in their area or whatever development takes place where they live. But that is not the case, because 45 per cent of the money that government spends comes from its citizens through taxation," Mukumba explained.

"The Zambian government needs to account for all the money it spends because almost half of it comes from revenue collections and revenue is an important tool for the fiscal policy of the government and it is the opposite factor of government spending. Revenues earned by government are received from sources such as taxes levied on the incomes and wealth accumulation of individuals and corporations and the goods and services produced in a country as well as exports and imports. Government also has its own corporations where it gets the monies from to develop the country by fixing roads for citizens, building homes for civil servants and also constructing facilities such as schools, hospitals and also to pay its people for the services that they provide. So it is important that everyone is involved in the budgeting process in one way or the other."

Mukumba also said that government was poor with the implantation of its plans.

"We seem to be so good as a country in planning but very poor at implementing our plans. Just look at how many National Development Plans (NDPs) we have come up with over the years and nothing is being done to change anything. How are we going to achieve our vision of becoming a middle income country by the 2030 if we can't even involve key stake holders such as CSOs in the decision making process? If we don't involve the Church and the general citizenry to get views and opinions of people before making a final decision? If we continue on this path then we might as well continue spending all the country's resources and realise nothing in the end for our citizens. Good planning is very important for the development of any country," he said. Mukumba called on the media to use its various communication platforms to engage the public on the importance of their participation in the budget making process. "I have discovered from my assessments that many people do not know what a budget is and they actually don't care about whether or not they know what is contained in the national budget for a given year. I am actually not surprised that they don't know anything at all about the budget because we have not decentralized the planning process of the national budget. Everything to do with decision making in this country takes place here in Lusaka by politicians and stakeholders such as Civil Society organisations. So the best way to help our people is by actually by using the media," said Mukumba said "If we continue leaving decisions to do with budgeting to politicians, then our problems as a country will never end because politicians follow their party manifestos when implementing policies, that is why they will bring you a road when you ask them for boreholes. It's time everyone got involved in ensuring that the national budget covers the needs of every citizen because that budget affects all of us."

Mopani must pay cost reflective tariffs or leave – CSPR

By Mirriam Chabala Civil Society for Poverty Reduction (CSPR) Director Executive Patrick Nshindano says he would have already disconnected Mopani Copper Mines from electricity supply if he were the Copperbelt Corporation Energy (CEC) for refusing to pay tax.

In an interview yesterday, Nshindano said Mopani Copper mines could not be exempted from the upward adjustment electricity tariffs of because it was one of the largest consumers of the country's energy.

Nshindano further advised Mopani to leave the country if it was not ready to comply with the country's tax obligations. "Mopani Copper Mines has no basis for actually refusing to realign the tariffs as was agreed in the tariff agreements. As a country we have agreed the direction we are going to take of adjusting the tariffs mainly because they were unsustainable at the point they were, but also because of the challenges that the country has faced in generating energy and we need to ensure that we invest. So a number of reforms are going on which includes revision of tariffs and there is no way that the mining

sector can be exempted from the revision of tariffs because they are the largest consumers of energy in this country," Nshindano said.

"If that exemption is done on the mines then that means only the poor Zambian citizens will have to pay for electricity and there is no way that Zambians can be subsiding multinational big corporations like Mopani Copper Mines. So it's only inevitable that the revisions are done and undertaken. So the refusal on the part of Mopani Copper Mine to comply is illogical because any responsible corporate needs to realise that we should not only be interested in making profit. When you are investing in a country you need to get a winwin situation where there are benefits that accrue to you as well as benefits that should accrue to the nation."

Nshindano charged that Mopani was an irresponsible investor which never cared about the interests of Zambians. "Mopani is on record of having not paid corporate income tax for a very long time mainly because they were not declaring any profits but further to that, there are a number of | allegations that have been levelled against Mopani which border on issues to do with tax avoidance as well as environmental degradation. So all these are cases that are there yet to be proved. But all along, what we have been calling for as civil society organisations is that we need responsible investors in this country who have the interest of the nation as well and also those who realise that Zambia needs to come first and avoid these opec agreements that make it |

difficult for Zambia to benefit from it's natural resources. The mining sector is one of them," he said. Shindano advised the Copperbelt's Mining giant to leave the country if it did not want to comply with payment of tax. "We have continued to grapple with the mining sector in terms of taxation

and it's contribution even when you talk about job creation, the mines that are even threatening are actually the lowest employers because of |

the mechanization and continues to do that including Mopani itself. When Mopani took over the operation of the mines if you compare the number of employees it had and the number of employees it retained is actually a fraction on its own, so we need to ensure that the interests of Zambians are protected and thats why we as CSPR are putting up a call to action not only to our fellow civil society but also to the citizens to be able to rise against such injustices in our society," said Nshindano.

"It is completely unfair and uncalled for, if Mopani doesn't want to operate in Zambia let's find another equitable partner because Zambia has been mining for a very long time and as country, it's about time we realised that unless we have substantial shares in these mines, we will just remain with pits and these investors would have gone but also the generation that is yet to come will suffer."

The Patriotic Front is ruling by decree, says Habasonda

By Mirriam Chabala University of Zambia Political Science lecturer Lee Habasonda says he is concerned about the Patriotic Front's style of governance because they do not consult before formulating policies. And Habasonda says the Constitutional Court was too ambitious when it allowed prisoners to vote.

In an interview with News Diggers! Habasonda observed that Zambia was being dragged towards an authoritarian style of governance.

"Government has no business prying in the private life of its citizens. Government

should not just wake up and declare mandatory [HIV] testing for its citizens, this is a sensitive matter and therefore, they should have first taken it to Parliament and a full Parliament because the Parliament that sits now is one part of Zambia. After that, they should have created debate in the media, civil societies and in Universities and after building consensus that would given them legitimacy to pass such a law because Zambians would have agreed to say yes, this is a problem we need to address this way," Habasonda said. "But no it just looks like it's a copycat from the

Rwandan President Paul Kagame whose democratic credentials are questionable even if he gets 98 percent (votes). So Zambians are worried that the country is sliding towards authoritarian style of governance where people just wake up and impose mandatory HIV testing, they wake up and unbundle the University of Zambia without talking to the stakeholders. So these are the concerns that we have." And Habasonda wondered why the Constitutional Court allowed prisoners to vote when their rights were suspended. "I think that things like

allowing prisoners to vote may be a good thing but the law suspends the rights of individuals when they are in incarceration so I don't know whether voting rights have a special meaning if prisoners are allowed to participate. I only agree with the ruling to the extent that because they live in prisons which are determined by the State then their votes can contribute to changing the conditions in prisons but in principle I do believe that when you are a prisoner, actually some of your rights are suspended and you don't need to enjoy them by virtue of being in prison," Habasonda said.

"So with regard to the Constitutional Court, I am saying yes it is a right that must be enjoyed because it reflects on the conditions in prisons but I think that Zambians needed to debate this carefully because really what I see in our democracy is that while some ideas may be good they were not subjected before the majority of the Zambians and as a result, all the time we don't get decisions that are unanimously accepted. I think building consensus around some of those decisions is important and I am not saying that the ConCourt must go

and consult because they follow the law and from where I stand obviously I am experienced in the area of human rights and there is nothing wrong with our prisoners voting but for our situation in Zambia, I think that prisoners have not gotten to a level where they can be voting."

He said it would have made more sense for Zambians in the dispora to vote.

"So I think priority should have been given to people in the diaspora to vote. Those who have not any of their rights suspended. How do you allow a prisoner to vote and not a person who is in the diaspora? So those are the difficulties I have with the ConCourt's kind of thinking. Let's allow the diaspora people to vote then we can look at those groups whose rights are suspended because they have been imprisoned," said Habasonda.

"I am assuming that we are referring to prisoners and not detainees, so these are people who have been found guilty and have been kept in prison either Mukobeko or Mwembeshi for a long time. I think the voting is practical except that as we have said most of our institutions are politicized so the prison authorities may behave the way that police does and so again exclusive participation comes in and eventually the system doesn't work. So because of the state of democracy in Zambia the ConCourt is a little too ambitious."

Meanwhile, Kabushi member of parliament Bowman Lusambo said the market was a place for thousands of people who depended on trading for the livelihoods.

"It is with a deep sense of concern that I announce that almost the entire Masala Kapalala Market in Masala Township. Skyways Ward in Kabushi Constituency has burnt to ashes destroying merchandise belonging to hundreds of Marketeers who depend on this market for their livelihoods," Lusambo who is also Copperbelt minister said.

"Information gathered so far indicate that the fire started around 01:00 Hours. The cause of the fire has not yet been identified and the fire has since been put out by a brave team of fire fighters with the help of the local people. I would have visited the scene this morning but I am away in Lusaka attending to Cabinet duties but I wish to assure the scene later today and empathise with the victims of this devastation." Later after he visited the scene in the afternoon, Lusambo cried as the traders joined while others encouraged him to be

strong. And the Ndola City Council says the fire at Kapalala Market could have been a result of negligence on the part of some traders who spend nights there.

Ndola mayor Amon Chisenga ruled out arson but said it was up to police to investigate.

"For now, we rule out any possibility of arson. However, we leave it to the police for investigations. We want to establish if it was negligence from the traders because we hear some people sleep in the market. So we will wait for the investigations to be concluded. We are not going to speculate," said Chisenga.

"Yet again another market is gutted and it is unfortunate that we have this issue at hand. We do not want to speculate now that it could be an act of arson, especially that the state of threatened emergency is still in force. We pray that the fire was as a result of negligence of our marketer."

If we did not forgive them, we would have not credibility to claim that we are different from them," Hichilema said.

"Suffice to say this country needs dialogue, there is no alternative to dialogue, am not aware of any alternative to genuine dialogue. I yet stand here to be challenged if there is any because the opposite or absence of dialogue is not desirable in any country including our lovely country Zambia. Because of this realisation, we in the UPND have always been open to dialogue. It is in line with the word of God that we believe that is based on the truth, on fairness, and open minded, and one which leads to lasting solution. There is no value in dialoging, then after dialoging you retain to the same old habits and acts, it doesn't help. So a genuine dialogue must lead to creation of lasting solutions."

Hichilema said that his incarceration had not broken him but instead strengthened his spirit.

"Our beloved friends, we all are aware that Zambia is a Christian nation, it is therefore imperative that we love one another. The Bible in Romans 12 vs 17-18 tells us that we should not repay evil with evil. But that we should strive to live at peace with all men. Furthermore, the Bible teaches us to live at peace with one another in order to attract God's blessings," he said.

"My experience and those of my colleagues of being incarcerated has not broken us but has strengthened us in our resolve to see a better Zambia for all. All Zambians need is observants to the rule of law, adherence to fair justice, [this is] very important. We all know that God is a just God and he hates injustices. We are therefore focused to see a fully functional society where all institutions of government without exception, within the law, they must uphold the rule of law. They must dispense justice to all the citizens and residents of Zambia without exception." He said that if given an opportunity to serve Zambia, he would correct a lot of wrong things in prisons. "Brethren, we believe that God allowed our incarceration so that we can learn and know the prison life and understand

what really goes on inside there and prepare on how to humble ourselves and how to handle the prison issues including the state of our prisons, congestion, basically dehumanizing treatment that goes on in those prisons. I must tell you that if I didn't go to prison in the manner that I did, I would have never believed anybody telling me what is obtaining in those prisons. God's way.. And I think its fair to say when God gives us the opportunity to serve this country, we will do the correct things, we will make the lives of prisoners better. Therefore allow me to state that a country that is divided against itself cannot stand, it is for this reason that I urge all of you our colleagues of this country to put our differences aside and focus on the common good of our great nation Zambia," Hichilema said And Hichilema urged the

church to continue playing its mandate of mediating for the country in times of conflict.

"The above line is that the church has a divine mandate in ensuring that it mediates in times of conflict, promotes truthfulness and justice, teach peace, love and unity, and speak for the Holy space. Very important. I think thats a noble role of the church. It is our duty those who can tell the story as is, it is to commit ourselves to changing these negative ways, to create no space for these negative ways in our country. We commit our lives to unifying this country again," said Hichilema.

Don't relax, Kampyongo tells police

Minister of Home Affairs Stephen Kampyongo says police must not remain calm thinking that everything is well. Commenting on the fire that gutted Kapalala market in Ndola, Kampyongo said it was regrettable and asked police to "reactivate" themselves.

"It is indeed sad and regrettable that when we have enjoyed relative calmness and peace, we have recorded another disaster in the inferno that gutted Kapalala Market. But I want to just appeal to our people to remain calm and for our men in uniform, the Zambia Police Service, I think it is time we reactivate ourselves, there shouldn't be any time to relax and think that all is well," Kampyongo said. He also asked citizens to remain calm until as investigations into the cause of the fire were still underway.

"So mine is just to appeal to our people to remain calm and we can't start speculating now until thorough investigations are exhausted to establish what the cause of fire could have been," said Kampyongo.

The market has been reduced to ashes from an inferno that started between 01:00 and 02:00hours.

A combined team of fire fighters and the residents managed to put out the fire, but it was too late to salvage much.

According to Ndola mayor Amon Chisenga who visited the place in the early hours, over 3,000 stands have been destroyed.

Mapenzi Chibulo's father asks court to grant him damages for loss of life

By Diggers Reporter Chibulo's Mapenzi father has asked the Lusaka High Court to enter a default judgment in his favor in a case in which he is seeking damages for his daughter's death. Mapenzi, a UPND supporter, was allegedly shot dead by the police after the cancellation of the UPND rally on July 8, 2016 which was scheduled to be held in Lusaka's Chawama

township. In this matter, Douglas sued Chibulo the Attorney General over the death of his daughter, claiming damages for loss of life due to what he termed negligence by police. But the Attorney General has not vet filed a defense prompting Douglas to ask the court for a default judgement. Douglas said the Attorney General had neglected to file

defense and did not also file an application for extension in which to enter appearance and file defense as well as well as to give reasons for the delay as provided for in the order of directions issued by High Court judge Pixie Yangailo.

In a statement of claim, Douglas stated that the police carelessly, in their effort to disperse people who were peacefully parading in a match past, used live ammunition to shoot at unarmed citizens.

Chibulo further argued that his daughter was murdered in cold blood after sustaining a bullet injury in her skull adding that Mapenzi's death was caused by gross negligence of police officers as they used live ammunition on innocent citizens.

The Lusaka Magistrates' Court had sent back the case to police for further investigations after a failed inquest to ascertain the actual killer.

Former Red Cross bosses sue State for malicious prosecution

By Diggers Reporter Former Red Cross Society chief executive officer Charles Mushitu has sued the state for malicious prosecution. Mushitu, alongside Sydney Chituta, former finance а administration and manager and Kelvin Chiposwa, who was a board member at Red Cross Society are demanding K2,425,500 as special damages in legal fees.

The trio is also claiming K47,830 as damages on money spent to hire taxis to attend the criminal court trial and pre trial meetings with counsels.

Mushitu and two others also want damages for mental distress, anguish and inconvenience arising from malicious prosecution.

In a statement of claim filed in the Lusaka High Court, the trio stated that they were appearing in the Subordinate court from September 16, 2013 to May 17, 2017 for 48 times on abuse of authority of office and

destroying evidence which charges were maliciously leveled against them by the Drug Enforcement Commission. They were accused of

abusing the authority of their office when they misapplied K267,000,000 meant for orphans and vulnerable children in Sesheke and Kazungula districts when the said money was lawfully borrowed by Red Cross through its policy of inter project borrowing. They were however acquitted by magistrate Aridah Chulu on May 18, 2017.

Subcontractor sues Avic International for breach of contract

for unlawfully deducting US\$8,598.22 from the contract price.

In a statement of claim filed in the Lusaka High Court, Kaungu General Dealers Limited stated that AVIC International subcontracted it to carry out road construction and maintenance works along Chilimbulu Road and Ibex Hill in Lusaka at a cost of US\$ 12,180.56 which contract was verbally agreed upon by both parties. But AVIC allegedly breached the contract by only paying the subcontractor K 22,039.00 on grounds that the deductions were done in order for AVIC to recover the cost of flags and sign boards that had been left on the sites.

Kaungu General Dealers averred that at no time did it offer to purchase the said sign boards and the parties did not discuss the prospects of using AVIC's sign boards and flags.

The company stated that in any event the defendants prices were shockingly exaggerated and were fixed unilaterally.

Kaungu General Dealers is now claiming damages for breach of contract.

The Zambia National Association of Sawmillers wants government's decision to ban the exportation of timber to be stayed by the High Court. In June 2017, Minister of Lands Jean Kapata extended the ban on timber exports to all types of timber in the country following the ban of harvesting and exporting Mukula logs.

But the association, through its secretary general William Bwalya, said the Minister's decision to ban the exportation of timber was irregular as it would

affect the welfare of their members who depend on harvesting and exporting timber for their livelihood. Bwalya stated that before the licenses expired, the Ministry of Lands suspended the export of timber without concrete reasons.

Bwalya also submitted that most of the saw millers had been denied concessions as only 59 were given licenses.

He says despite showing concession licenses to security agents, the state had continued to seize their products.

"I want to say to you on behalf of our colleagues that despite the injustices, despite the inhuman treatment that we endured following our brutal arrest and detention, we harbour no bitterness, we harbour no anger because the Bible says if you are angry all the time, you will make mistakes. I therefore say on behalf of our colleagues; I Hakainde Hichilema, having reflected on everything that happened in light of every word of God and the love of our lord Jesus Christ, we do

hereby forgive all of those, and they are many, who were involved in our brutal arrest and subsequent detention. If we did not forgive them, we would have no credibility to claim that we are different from them," said Hichilema. We encourage Mr Hichilema to forgive, but he must not forget. If he forgets, he will not be any different from those who illegally brutalized him. We say this because forgetfulness is what has brought the PF where it is today. Those in PF who are running government have forgotten how the MMD government treated them. They have forgotten how they used to be illegally brutalised by the MMD commanded police; how teargas was illegally used to disperse Michael Sata's political assemblies. We recall that Sata's boys like Judge Ngoma were imprisoned on political charges by the MMD up to the time PF won elections in 2011.

It is very important, therefore, that Mr Hichilema forgives his aggressors with all his heart, but forgetting, he must not. What Barack Obama's record breaking Mandela tweet tells us about the world

What is it about former US President Barack Obama's record-setting tweet - it has already surpassed 1.6 million retweets and 4.5 million "likes" that has captured the imagination of the world?

In the tweet Obama quoted Nelson Mandela: "No one is born hating another person because of the color of his skin or his background or his religion ... "

Judging by the replies and comments, the tweet seems to have offered some respite to the rapid depletion in social morale in the US after the recent Charlottesville violence. White supremacists gathered in the Virginia town for a "Unite the Right" rally on August 12 to protest against plans to remove the statue of the Confederacy general, Robert E Lee. The violent extremists chanted racist and pro-Nazi slogans. One of them, James Fields (20), allegedly rammed a car into antifascist demonstrators, killing activist, Heather Heyer (32). Then came the current US President Donald Trump's press statement that effectively legitimised the racism as perpetuated by the rightwingers: We're closely following the terrible events unfolding in Charlottesville, Virginia. We condemn in the strongest possible terms this egregious display of hatred, bigotry and violence on many sides, on many sides. Why did the Mandela words resonate now?

Amid incredulous scenes of flagrant neo-Nazism incredulous, that is, in an era of progressive human rights - and the inevitable and necessary protest against the rally, the words of Nelson Mandela resounded with a gentle wisdom and a kindly warning.

It was not so much a case of Obama simply not being able to find the correct words to respond to such a loathsome occurrence. After all it's not uncommon to use someone else's words or sentiment to make a statement on social media. I too have done this In this case, Obama may have chosen these words precisely because they offered some distance from the political space in America. Had he tweeted a strong and powerful message in his own name or using his own words - which he is clearly skilled at doing - the message may have been regarded as merely playing the opposition card, or indeed, more likely, the race card. Either of these two imaginary readings would inevitably have been shut down either by political loyalists or increasingly courageous

racists.



Obama's stroke of genius

on occasion.

In this instance, however, the use of Mandela's words was calculated. Strategically speaking, it was a stroke of genius.

Articulating the poignant message as a "direct quote" tweet enabled Obama to pass on a discreet message saturated with meaning because of its content and because it was attributed to its originator.

But, as we have seen on Obama's timeline, the direct-quote tweet was given added meaning because of who had sent it, and its timing.

The Nelson Mandela Foundation sent out the same quote as a tweet on 29 July. But it enjoyed just over 1,100 "likes", 18 replies and 737 retweets. While this is obviously related to the number of followers, the point is that the overwhelming global resonance with the quote via Obama's twitter timeline, is not simply because of its content, as profound as it is.

By using Mandela's quote as a response to Charlottesville, Obama maintained sophisticated balancing act, while offering a few poignant messages of his own:

America is at risk of legitimising racial hatred in much the same way as South Africa did during apartheid:

Far-right conservative politics erodes the natural inclination of the human condition towards compassion; and

Trump's views represent irresponsible leadership, and are a veritable seedbed for social hostility.

Perhaps that is why the echoed words of Mandela caused such an outpouring of support and resonance among twitterati. It said what progressively-minded individuals wanted to say, but simply couldn't find the words.

Moral authority

I think the tweet raises another

interesting sociological point about moral authority. In a context in which there is such a deflation of morale - such as the violence in Charlottesville and the blatantly irresponsible responses from Trump - any sound-minded progressive individual might hope, or even pray, for some kind of voice of reason.

Under normal circumstances, and especially in a predominantly Christian society such as the US, this voice of reason may be

found in the Bible. But the right wing rally-goers had traded its life force for a narrative of exclusion that supported their bigotry. Invoking the words of the venerated icon Mandela, then, offered the necessary kind of gravitas or moral weight. I can't help but consider how Mandela's legacy continues to offer respite to the world, though sometimes in quite different ways. In one case, it is Obama's political wisdom that prompts him to use the words of Mandela to balance out rising social discontent, and to challenge racial hatred.

In another case, just under our noses, the African National Congress (ANC) with its dishonourable increasingly political leadership, invokes Mandela's legacy to balance out rising social discontent about its own moral bankruptcy. Perhaps Mandela too, is, tragically, a man for all seasons.

Warren Buffett becomes top shareholder in Bank of America



American billionaire Warren Buffett's Berkshire Hathaway group has officially become the top shareholder in Bank of America after exercising its right to buy 700 million shares at a discount.

Buffett had received the warrants in 2011 after investing \$5 billion in the bank, which was suffering at the time from the fallout from the global financial crisis.

Bank of America said Buffett had acquired the shares for about \$7.14 each well below their Tuesday closing price of \$23.58.

Buffett's investment is now worth \$16.51 billion, meaning he has made a capital gain of nearly \$12 billion.

"In 2011, we welcomed Berkshire Hathaway as a shareholder, and we appreciate their continued support now as our largest common shareholder," the bank's CEO Brian Moynihan said in a statement.

Buffett's other holdings include major assets in real estate and insurance. He is also the biggest shareholder in Wells Fargo. AFP

SA minister blasts African leaders' 'health tourism'

A South African minister has criticised African leaders who seek medical treatment abroad.

Aaron Motsoaledi condemned "health tourism" while speaking in Zimbabwe. President Robert Mugabe, who frequently receives treatment in Singapore, had left the meeting of health ministers when

Dr Motsoaledi made the comments.

Mr Mugabe's spokesman has said that the president's doctor "is not only Zimbabwean, he is actually black... He is very, very, very black".

George Charamba made those comments to Zimbabwe's state-run Herald newspaper in May, insisting that President Mugabe was not turning his back on Zimbabwean medical help. Nigeria's Muhammadu Buhari and Angola's José Eduardo dos Santos have also been criticised for seeking medical treatment abroad this year. At this week's conference Dr

Motsoaledi said: "We are the only continent

that has its leaders seeking medical services outside the continent, outside our territory. We must be ashamed of that."

"This is called health tourism. We must promote our own," he added.

Dr Motsoaledi also urged governments to increase funding to local facilities. He has been praised by South Africans for using public hospitals instead of private facilities.

Ghost tomato factory showcase for Nigeria's farming problems

At a state-of-the-art plant in northern Nigeria, shiny machines stand next to a conveyor belt ready to crush tomatoes to satisfy the country's insatiable demand for tomato paste.

But a lonely cleaner mopping the floor is the only sign of activity in Nigeria's biggest tomato factory, equipped with the latest Italian and German technology. There aren't enough tomatoes to run it.

It's a powerful symbol of Nigeria's uphill challenge to build up agricultural production and end costly food imports to feed its 190 million people. The West African nation imports staples from milk to wheat to tomato paste, with funds it mainly earns from exporting oil. The conglomerate of Africa's richest man, Aliko Dangote, launched the plant in March 2016, contracting Italian engineers working for months on a 350 euro-a-day allowances to set up the machines outside Kano, the main city in the north. On paper this looked like a smart move as Nigeria imports up to 400,000 tons of tomato paste annually. The tinned paste is an ingredient in Nigerian tomato stew, used as the base for a host of traditional meat stews, sauces, soups and rice dishes that are staples of Nigerian cooking. Dangote Group had thought of every technical detail, even setting up a control room linking its engineers to experts in Italy in case there was a problem.

paste. Much of the last season's output was wiped out by a pest.

The plant has been so far unable to find other supplies despite Nigeria producing some 1.5 million tons of tomatoes annually. A lack of good roads due to decades of corruption means tomatoes would perish on the way. Half of the country's output gets wasted.

Bar a few weeks, the plant has been standing idle, said its frustrated manager said A.L. Kaito, the managing director of Dangote Farms in charge of the plant. 2016, unable to import tomatoes due to a lack of hard currency as Nigeria struggles with recession. Buhari had, since his election in 2015, made it a priority to end dependency on food under the motto: "We must produce what we eat."

To encourage agriculture investments like the Dangote plant, the government has waived duties for greenhouse and processing equipment.

It is also giving subsidies to rice farmers and is considering expanding the scheme to tomato growers, a senior official in the federal ministry of agriculture said. Officials had hoped to create jobs in agriculture to fight poverty in the north where some unemployed young men have joined an eight-year insurgency by Boko Haram jihadists. But experts and farmers say, after decades of corruption holding back road and electricity projects and an obsession with producing oil, it will take time to improve the tomato output. Low quality seed and a lack of power for pumping water means tomatoes can be grown only during the dry season, which creates a glut in March. Farmers then lay out their tomatoes alongside highways hoping motorists will buy them. Anything that does not get sold within 24 hours is usually wasted due to a lack of cold storage. They also ship some to Lagos, the southern megacity 1,000 km (600 miles) south of the factory. A basket of tomatoes sells for 2,000 naira in Lagos, but only around 10 percent of that ends up in farmers' pockets as traders and truckers take their cut. "We don't have fertilizers and there is no power for cold rooms," said Sani Yadakwari, chairman of the some 10,000 tomato farmers in Kano state. "We need subsidies for our production." Reuters

But it underestimated the difficulties involved in getting tomatoes, despite signing deals with some 5,000 farmers guaranteeing them to pay more than the market price.

Lacking fertilizers and working with their bare hands, the farmers have been unable to produce the quality and quantity the plant needs to make "We are trying to weather out the storm, the cost is horrendous," said Kaito. "It's a nightmare."

Dangote spent some 4 billion naira (\$12.74 million) on the plant and now plans to set up its own tomato cultivation scheme for around ten billion naira to cover up to 70 percent of its needs, buying land and tractors. Experts from Israel, Mexico and Spain will be flown in.

PROBLEMS

The tomato plant hopes to restart work in January at just half of its capacity of 1,200 tons a day after the next season, in the meantime costing 5 million naira every month.

Dangote has kept workers sitting at home on the payroll: the Italians spent months training them on the new machines.

The investment is paltry for its owner, who is spending billions of dollars on cement plants, sugar and rice schemes across Africa. His cement business alone posted revenues worth in 615 billion naira in 2016.

But for President Muhammadu Buhari the idle plant is a major setback after another tomato factory in Lagos threw in the towel in November session, his remarks were met with silence from the other member states represented. Dr Motsoaledi admitted his position is a controversial one, but added that it needed to be said.

Taylor Swiftly breaks four YouTube and Spotify records

The scene in Taylor Swift's new video where she raids the bank vault of a music streaming company is coming true.

In just four days, the star has broken four major streaming records, beating the likes of Adele and Ed Sheeran.

Look What You Made Me Do was played a total of 10,129,087 times on Spotify last Friday, the day of its release, more than any other song has achieved in a single day.

The video also broke YouTube's one-day streaming record.

It received 43.2 million views in 24 hours, smashing the record set by Psy, whose video for Gentleman was watched 38 million times in one day in 2013. She also overtook Adele's Hello as the most-watched video on day of release.

As Swift sped ahead of Psy's tally, her director Joseph Kahn celebrated on Twitter, telling fans "you are all amazing".

Swift also set a new benchmark with the song's lyric video, which attracted 19m views on its first day - more than double the previous record-holder, Something Just Like This by The Chainsmokers and Coldplay.

And in achieving the most Spotify streams in a day, Look What You Made Me Do also beat the record for first-day streams, formerly held by her friend Ed Sheeran for Shape of You. The figures defy the polarising reviews for Swift's comeback single, a melodramatic potboiler which sees the pop queen turn on her critics



from Swift's relationship with Tom Hiddleston to her recent victory in a sexual assault case. Missing the (admittedly heavy-handed) humour, Variety magazine described the video as "so narcissistic and self-referential that one could spend 5,000 words unspooling it". Fans were more forgiving,

cheering Swift as she turned the tables on her detractors.

Variety magazine described "Iconic. Perfect. You the video as "so narcissistic destroyed the haters," and self-referential that one wrote Natalia Kozanecka, while Alex Goldschmidt said "congratulations in advance" for winning all of next year's MTV Awards. One caveat to Swift's streaming success is that, on Spotify at least, interest in her comeback single dropped over the weekend. According to publiclyavailable data, Look What You Made Me Do was streamed 5.43 million times on Saturday - a drop of 2.48 million.

By contrast, Ed Sheeran's Shape of You (which previously held the one-

day streaming record) saw its streaming tally increase in its second 24 hours on the platform.

Look What You Made Me Do precedes Swift's new album, Reputation, which is released in November. *BBC News*

Russell Brand's radio interview with Elvis impersonator breached broadcasting code

Russell Brand has landed in hot water again with broadcasting watchdog Ofcom - this time over a radio interview with an Elvis Presley tribute act. During his Sunday show on digital station Radio X, Brand asked Presley



declaring, "maybe I got mine, but you'll all get yours".

Spin magazine called the track "hard" and "cheerless", while the New York Times described the lyrics as "powerful, yet joyless". Rolling Stone was more positive, praising Swift and playing the villain and "owning her bad press instead of merely brushing it off".

The lyrics contain a barely veiled reference to Kanye West and Kim Kardashian, who tussled with Swift when she objected to the line "I made that bitch famous" in one of West's songs.

The video casts its net wider, referencing everything

The show went on to include an anecdote about the late singer and a prostitute. Ofcom ruled the material was "inappropriately scheduled" given that children could have been listening.

"The item was broadcast before lunchtime on a Sunday... with no prior warning for listeners about what was going to be discussed," it wrote in its August bulletin.

"Given the programme was pre-recorded... the licensee could have done more to limit the effect the 'adult themes' may have had on children in the audience."
