Soldiers committed to High Court for trial over RB, KZ murder plot

Police must permit UPND assemblies like they have allowed Mutati protests - Katuka

Emergency. In a statement today, Katuka observed that the countrywide anti-Mutati demonstrations by ruling party supporters was proof that police were selective in their application of the Public Order Act.

"We note with interest the seemingly countrywide demonstration by PF cadres against the Minister of Finance Felix Mutati calling for his resignation. Our interest is not on the merits or demerits of these demonstrations as that is really none of our business as we regard that as purely an internal PF and MMD led Mutati faction. But our interest is on the usual selective application of the Public Order Act in the country where PF members can easily get into the busy streets without a police 'permit' and start demonstrating," Katuka stated.

"Of interest equally is how these PF members are being allowed to demonstrate especially at a time when the country is under the [Threatened] State of Emergency where such activities are not allowed. We hope now the PF leadership that have been issuing statements against the UPND President Hakainde Hichilema on what he has been saying at various fora, including at a Press Conference in South Africa, can understand what he means that there is selective justice and application of laws in the country that favours those in the ruling party to the disadvantage of the opposition especially the UPND."

Katuka stated that he was hoping the Zambia Police Service could reflect and change from its discriminatory application of the Public Order Act. "Mr Hichilema and other UPND members have been very consistent in

their messages both home and abroad that there is suppression of the rights of those holding different views from those of the PF in the country, something that Zambian citizens and the international community must pay attention to, with a view to correct the situation so that it favours all citizens," he stated.

"We now hope the Zambia Police Service have finally reflected and have had a change of mind on the discriminatory application of the Public Order Act so that even UPND members will be allowed to freely hold both indoor and outdoor party mobilisation meetings as well as given their constitutional and democratic space to actively engage citizens and share their messages without hindrance."

And Katuka called on the police to allow his members conduct party rallies in peace just like those in ruling party were allowed to conduct theirs.

"We therefore wish to commend the Zambia Police Service for this seemingly change of heart and professional conduct and hope that from now onwards, they will also allow the UPND members who wish to hold thanksgiving rallies on the release of their party leader Mr. Hichilema to do so according to the provisions of the Public Order Act," stated Katuka. Nkombo demands lifting of Threatened State of Emergency

Mazabuka Central UPND Member of Parliament Garry Nkombo says the declaration of a Threatened State of Emergency was an act of cowardice and must be revoked immediately.

In an interview with News Diggers! yesterday, Nkombo hailed Civil Society Organisations (CSO)s for petitioning the National Assembly to revoke the Threatened State of Public Emergency saying there was no need for its continued existence.

"The CSOs could not have petitioned at a better time than now, I am saying so is because to us the invocation of that Article 31 was an act of cowardice on the part of the executive and the President himself. There is a state of mind which is called the fear of the unknown and this is what has grieved PF and why I am saying the petition by CSOs could not have come at a better time is because it is actually true that there is no need for its continued existence," Nkombo said.

"And so the CSOs are 100 per cent right that Parliament should do self introspection, they must think through themselves especially those who were there at the time when the invocation was approved by the House of representatives. Parliament is a house of laws and it should not be used to diminish the democratic space for other political players. So that invocation should be removed forthwith."

Nkombo said there was need to normalize things in the country in view of calls for

dialogue.

"That invocation has a life span which is 90 days and the 90 days will soon be up but really again it's a question of self introspection on the part of Mr Edgar Lungu and his team to say whether this country is really at threat or not but as far as I am concerned, I think that the truth has no disguise and so you cannot disguise it and it will germinate even on the hardest concrete so they must face themselves and bring this society back to normal especially that there is this desire for everyone to dialogue," he said.

And Mulenga says government will not allow President Lungu to travel with two people on his entourage in the name of austerity measures, adding that it is not a crime for the Head of State to appear in public with contractors and businessmen as long as they are not traveling on government expense.

Meanwhile, the Information Ministers says government is not aware that President Lungu's former ministerial house is still being used by his family and children.

In a telephone interview with News Diggers, Mulenga who is in South Africa on government duty said it was not true that President Lungu was building shopping malls in Petauke, Chawama and Lilayi, as alleged by Kambwili, but added that it was not illegal for the Head of State to own property.

"That is not true, like we have clearly said, Honourable Kambwili should have questioned all these things when he was in government. Can he specify that this mall and this mall are being built by President Lungu, because we are not aware of that. And also what we must realise is that the President had a life before he became President. He is a lawyer. So questioning his capabilities because he is now the President is neither here nor there. What we must realise is that before the presidency, President Lungu is a very well educated man, he was a lawyer, so it is not like President Lungu just came in a poor man, no! We know lawyers are one of the most handsomely paid professionals in Zambia," Mulenga explained.

"This is not to say that President Lungu is building [shopping] malls through tax-payers money, it is not true. But questioning the aspect of whether President Lungu can own property, yes he is a Zambian. He is a Zambian entitled under the Constitution to own property, but it does not mean that when you own property every property you own is coming from taxpayers money, it's not true. President Lungu has clearly stated even before, that he was in business. It is not true that President Lungu came into State House a poor man, he is a lawyer by professional. He had a life even before that. She said if Kambwili meant well for Zambia, he would have reported President Lungu's corruption while he was in office "because we want men an women

who can detect corruption while they are still in government".

Asked if she would tell the public if she discovered that President Lungu was involved in corruption, Mulenga said she would do so and go further and to resign.

"That is what noble people, credible people do. They don't wait to be fired to say President Lungu is corrupt. If I see that the decisions we are making in Cabinet are not going well with the Zambia people, I would resign on moral ground, I will not wait until I am fired," she said.

Explaining why President Lungu spend four days in Swaziland, Mulenga said the Head of State was invited for two events.

"The President was also invited for the National Reed Dance. There were two events taking place at once. And that invitation was a gesture from his counterpart. The Trade Fair has not even finished, it finishes next week Monday," she said.

In the interview which lasted close to an hour, Mulenga also told News Diggers! that it was disrespectful for government to allow the President to travel with few people.

"There is the presidential affair minister that accompanied him, there is a political advisor, and there is a press aide that accompanied him. So who did Honourable Kambwili want to accompany the President? Those are part of the presidential delegation and they have been from time immemorial. Every time a President travels, he travels with a delegation. There is no way... look, this is the presidency for goodness' sake. The Presidency is a big institution and we are not going to demean and undermine the institution because Honourable Kambwili says one or two people should accompany the President. Ubufuma buchindika umwine (One has to respect himself in order to be respected). So as much as there are austerity measures, this is an institution and there is no way the President will travel alone or with two people," Mulenga said. She also defended the pictures which were shared on social media of President Lungu posing with businessmen. "Honourable Kambwili has already said that Mr Valden Findlay is a businessman, do you think, in his own capacity Mr Findlay can fail to pay for his accommodation? If country in Africa to

he has that evidence that Mr Findlay used taxpayers money to get himself there, he might as well raise a query. We know that Mr Findlay owns Chrismar Hotel, he has been in business for a long time. You think he can fail to pay for his accommodation?" she wondered.

"And we also know that under the laws of Zambia, it is illegal for anyone to deal in drugs, so since Honourable Kambwili seems to have so much information, why hasn't he reported them to the law enforcers? People have accused Honourable Kambwili of so many things, but no one is guilty

until proven innocent. He knows the speculations of social media, how people are accused innocently. But in any case, what is wrong with Mr Findlay being found with the President in Swaziland? What crime has he done? How many people appear with the President in public? What crime would that be if Mr Findlay appeared in public with the President? That was a public event, even me if I had the money, I would have gone, even Honourable Kambwili if he had the money, he should have travelled to Swaziland, no body was going to question him. A public event is not restricted to an individual." Meanwhile, Mulenga said government was not aware that President Lungu's former ministerial House was still being occupied by his family.

"We are not aware of that. This is one man who says the President has so many houses, then the other moment he says he has no house, he is using the ministerial house for his family. We are not going to continue answering Kambwili because he just wants to distract government from performing," said Mulenga. "The way he wants President Lungu convicted, if Honourable Kambwili had any evidence of all allegations, he those would have submitted all that information to the law enforcers already. He knows where to take evidence. The judiciary is very independent and the President won't interfere. A man that switches his tongue is a very dangerous man. If President Lungu brought him back in government, Honourable Kambwili can switch and say, 'I was moved by evil spirits from the other side that's why I said those things."

Asked if it was true that MMD had started mobilising its members in some parts of the country as alleged in the submitted petition by PF supporters, Nakacinda said his party was obliged to reorganising itself.

"When did that become an offense in our politics? MMD is an independent political party and we are obliged to reorganise ourselves and nobody should criminalise the process of mobilisation of our political party. Politics is about numbers. The only way MMD would be of value to this working relationship with the patriotic front is when we are bringing numbers and possibly increasing numbers. Now if we don't conduct mobilisations, particularly in areas where PF is weak, surely does it need rocket science for somebody to appreciate that we need to work hand in hand to enhance the numbers that will help us secure victory in 2021?" he asked.

Nakacinda also said demands by PF supporters to have Mutati fired were being organised internally by the PF leadership.

"Those arguments can only be answered by the Patriotic Front. When we were discussing the possibility of working throughout together the elections, the MMD agreed to work together with the PF in order to achieve the 50%+1 and we campaigned collectively as a party. The end result was the victory of securing the 50%+1 votes. And after securing the victory, there was no

fact that changed in terms of Mutati remaining the leader of the party. The fact remained that Mutati remained the MMD president. Even when he was appointed Minister of Finance, he was appointed not just as an individual but he was appointed also into consideration that MMD is in a working relationship with the Patriotic Front. So those facts have not changed. So if those facts are the issues they have an issue with, the people who are supposed to respond and provide guidance to their membership is the Patriotic Front," Nakacinda said.

He said that whether the PF complained or not, his party would not be shaken.

"If MMD at this particular stage is not welcome and is not appreciated, and even the position of Mutati being in government is not appreciated by the PF, it is the PF who are suppose to deliberate that and be able to come up with a position. But for us as MMD, we supported President Edgar Chagwa Lungu and the PF in good faith and we believe that even the input and works that president Mutati has exhibited in government so far is positive, the dividends are there for everybody to see," he added.

Nakachinda added that Mutati as Finance Minister was only answerable to President Lungu as the appointing authority. "The appointing authority

is not the Patriotic Front, the appointing authority

is not even the Patriotic Front president, the appointing authority is the Republican President. He is the only one who has the prerogative as President to appoint any citizen. Mutati as

Minister of Finance is answerable to the Republican President, he is not answerable not even to MMD, not even to PF, he is answerable to the Republican President and he swears oath to the Republican President, not to the PF president or Central Committee. And if it was President Lungu as Republican President who was carrying a placard in Cairo road saying 'Mutati must go' maybe we can worry. But if its other people whether its PF or MMD, that should not worry us, they are not the ones who appointed him," said Nakachinda.

By Mirriam Chabala United Progressive People (UPP) president Saviour Chishimba has insisted that Zambia is not a monarchy and anyone who thinks "chalo cha kwa wishi" is mistaken.

Featuring on UNZA Radio's Lusaka Star programme this yesterday, Chishimba said the State's decision to arrested him and later drop defamation of the President was because charges there was no offence he committed.

"Nothing has changed on my stance against corruption and when it comes to my release, the state simply discontinued the case because there was no evidence. I did not defame anyone and to start with defamation is not a criminal offence. The problem we have in Zambia is that we are not a monarchy but we want to apply a system that is used in a monarchy. Zambia is a republic and it belongs to all of us, so anyone who thinks kwati Zambia chalo kwa wishi, that person is mistaken (anyone who thinks Zambia belongs to their father is mistaken). This is a public property for all Zambians so whenever you have an opportunity to govern at whatever level, you need to understand that this is a republic and in a republic, officers are accountable to the people,"

Chishimba said. And Chishimba said once in government, his party would reform the justice system.

"We need prison cells that meet the minimum sanitary standards, now when you look at these prison cells that we have currently, the conditions are terrible. That is not what imprisonment is intended to achieve, so we in the UPP shall reform the entire justice system. Firstly we need to change the archaic laws that we continue to apply. We have always

said that this generation of leaders has failed to achieve autonomy when it comes to the legal regime. We in the UPP will not entertain an arresting system where police officers are going to arrest someone before concluding investigations. The idea behind an arrest is that by the time the police are effecting an arrest, they must be through with all their investigations so that when they come to you and say that you arrested, they must be ready to go and present you before the

courts of law," he said. "And even these holding cells, they are not meant to keep someone their over a month as I found when I was detained, I found some people who are there for over a month and have not been taken to court. And when it comes to prison conditions themselves, time has come to reform. We would also provide for the private sector to play a role. So if we have a prison in Lusaka, that prison will be under Lusaka county and

for the private sector to also invest in setting up correctional facilities and be able to hire professionals to reform the inmates. This is the kind of system that we in UPP commit ourselves to introducing so much that when someone is leaving the prison, that person must be ready to be reintegrated in society."

Chishimba welcomed the proposed Political Parties Bill saying the move would intrigue a sense of ownership in the ordinary those counties will provide | Zambians if political parties were to be funded locally. "Zambia has always needed a bill to regulate political parties. Right now we are talking about state capture through corruption but there is also political party capture in Zambia, we have political parties that are serving the interests of foreign corporations. "We are disappointed and we note with the deep concern the inconsistency in that the government has agreed to restore the electricity supply at subsidized prices to Mopani Mines when it is increasing electricity tariffs for the average Zambians. As much as ERB has carried

out the process in a phased manner in order to attempt to mitigate the negative effects, four months is not long enough a time to allow consumers to adjust to the new tariffs. Further to this, we have failed to see accompanying measures such as the improvement of ZESCO's efficiency levels and a coherent strategy to

reduce wastage in some of its internal operational

areas," Mukumba stated. Mukumba wondered why government seemed to be more willing to negotiate with the mines than with domestic consumers.

"In May 2017, phase one of the electricity tariff hike that was approved by the Energy Regulation Board

(ERB) took effect with a 50% increase in electricity prices. Phase two will call for another increase and this time by an additional 25%. This means that the cost of electricity in Zambia would have gone up by 75% in the space of only four months. CUTS recognises that there is need for Zambia to move

towards cost reflective tariffs as there are no resources for the country to continue subsidizing electricity, further to this we acknowledge that Zambia needs to become a more attractive investment destination in order to draw investment into the sector," Mukumba stated. "However, we also believe

that some considerations need to be addressed and it is with deep concern that we have seen government at a stalemate with Mopani Mines in recent days. The mining industry consumes about 55% of the total electricity generated in Zambia whereas domestic consumers only use about 30%, yet the government seems to be more willing to negotiate with mining companies. It is imperative that mines pay cost reflective tariffs and we are urging the government to take a strong stance in these negotiations."

She commended government for expediting the completion of the cost of service study saying the study would enable citizens to know the true cost of efficiently producing electricity that was currently unknown.

"Having said this, CUTS commends the government for expediting the completion of the cost of service study that is supposed to identify the true cost of electricity in Zambia. It is expected that this study will allow us to know the true cost of efficiently producing electricity that is currently unknown. Kabwe PF explains Mutati's MMD activities

To our surprise, honourable Mutati ended up donating K15,000 to MMD members the same day" Lupupa said. It seems we were the only ones who didn't know that celebrated singer Mumba Yachi is not a Zambian citizen. Our friends in the music industry, especially those close to him, seem to have had this information for many years. They were well aware that the singer was a Congolese, illegally squatting in the country while doing his music business.

For those who don't follow Zambian music closely, Mumba Yachi is a guitarist and vocal performer who first appeared on the music scene around 2010 but never made a breakthrough. However, five years later, Yachi gained so much recognition and publicity because of his unique arrangement of Afro music. He became such a celebrated star that when he announced the launch of his "I am Lenshina" Album in May 2015, former vice-president Guy Scott, Cabinet ministers, businessmen and CEOs from various corporate companies were the first to buy tickets for the sold-out concert hosted at Joe Pilatus farm in State Lodge area. To cut the long story short, Mumba Yachi has been entertaining this country's VVIPs for years now, but apparently, he was just a foreigner with no proper records of his nationality.

Last week, the Immigration Department arrested Yachi on grounds that in May 2016, the singer entered Zambia (from a business trip) through Chirundu using a Zambian passport and green National Registration Card. He claimed to be a Zambian citizen, a statement which he later changed when he was summoned for questioning in August – admitting that he was, in fact, Congolese.

Immediately this news broke, we were flooded with comments and statements from the singer's close friends in the industry and of

course music fans. People were enraged by the Immigration Department's move and accused the authority of applying the law selectively because according to them, there were many illegal immigrants doing illegal business in the country. Others picked names of Congolese footballers they know who have adopted Zambian names and are freely playing professional soccer without being questioned by the Immigration Department. All the solidarity statements that came alluded to the fact that Mumba Yachi was a peaceful person and did not deserve to be arrested and locked up in the manner he was.

What caught our attention was the statement from the Zambia Association of Musicians (ZAM). Led by president Njoya Tembo, ZAM claimed Yachi was a fully paid up member of the association who was merely a victim of the brutally drawn colonial boundaries that separate people of the same families and communities.

"While recognising the importance of the Immigration Department to carry out its mandate, we note at the same time that it has a duty to promote a human rights based approach and culture in respect of immigration controls. without any due regard to the status of people on the ground... In a show of support, ZAM will accordingly help Mumba with legal support throughout this process," stated Tembo.

To a wider degree, this statement exposes ZAM, the people behind it and the purpose it serves. It further raises questions about the procedure followed before one can belong to this association. How much does the Zambia Association of Musicians know about its members? Do they just register anyone who has released a song before, or any person who has a recording studio? Does Mr Njoya Tembo's association demand any form of identification card before registering its members? If ZAM knew that Mumba Yachi was a foreigner without a residence permit, why did they not advise him to apply for one, or better still, a citizenship having lived in Zambia for over 10 years? What kind of friends are they to Mumba Yachi? How can they be so proud to offer legal support to a man whose predicament they knew before he was arrested, but did nothing about? We are told that the singer has already admitted faking his Zambian citizenship, so what will the ZAM lawyer be defending in court?

It is clear to us that the Zambia Association of Musicians is mostly interested in money from paid up members. They never really care where the member hails from as long as they have paid their affiliation fees. If

an Al-Shabaab brother came with a banjo claiming to be a Kalindula maestro, Njoya Tembo and his ZAM would register him without delay. And if police arrested such a brother, ZAM's position would be that "he is a fully paid up member, we stand with him".

Surely, we are concerned with this development because ZAM is a government-recognised association registered through the National Arts Council (NAC) under the Ministry of Tourism and Arts. At least, we expect the National Arts Council to take interest in knowing the members who are registered in these associations; not necessarily for purposes of knowing who is Zambian and who is a foreigner, but for good governance.

It is also of concern that after the arrest of such a highly celebrated singer as Mumba Yachi, there has been no statement from the said National Arts Council. They have no comment over the matter. NAC seems to have distanced itself from this case because the singer has committed a crime, but if Yachi had won African Idols for Zambia, they would be all over praising him. In fact, it would be the Minister of Arts Mr Charles Banda himself who would take him to State House for a luncheon before conferring him with the free man of the city status.

Anyway, our point is that even though Zambia is home to its own citizens, this is a country that has welcomed hundreds of thousands of asylum-seekers and refugees than any other in the region. Well-meaning immigrants, especially peaceful and talented ones like Mumba Yachi, are definitely welcome in Zambia. It is not a crime to desire to be Zambian if you were born in Congo, but there are several legally accepted ways of doing so, rather than faking citizenship.

health department study. The percentage of HIV-positive people who use drugs and are on ARVs may be even lower. Globally, UNAids reports that only 14% of people who use drugs and are living with the virus are on treatment. Locally, no such data exists.

Scarce data shows that South Africa, like the rest of the world, is facing concentrated HIV and hepatitis epidemics among people who use drugs, both injecting or non-injecting. A small, five-city 2013 study by the United Nations Office on Drugs and Crime showed that 14% of people who inject drugs were living with HIV. Local organisations such as Pretoria's StepUp Project say, based on anecdotal evidence, they believe there is an equally high prevalence of hepatitis C among people who use drugs. But where South Africa has succeeded in breaking taboos and adopting people-based policies to tackle HIV infection for the general population, it has failed to provide the same humane approach to people who use drugs. Criminalising the simple consumption and possession of drugs, particularly in the privacy of one's own home, causes considerable harm - people's privacy is violated and families are destroyed by subsequent arrests. And prisons become even more overcrowded. The "war on drugs" diverts law enforcement efforts away from tackling the violent crimes that

undermine the social fabric of certain communities and prevent effective development. The criminalisation of use and possession of drugs for personal consumption also fuels the HIV epidemic by pushing people who use drugs into hiding. They become unreachable and invisible, in effect preventing them preventing them de facto from accessing prevention, treatment and harm reduction services.

People arrested for simply possessing a drug — an act that potentially harms no one — are then saddled with of drugs policy. It supports the African Union's common position to address illicit drugs in a more constructive manner, moving away from repression as a primary response and towards a human rights-based approach that encompasses harm reduction and treatment measures.

At home, however, drug policy reform is still taboo.

The government and the general population do not appear to understand the extent to which ill-designed and illimplemented drug control policies can negatively affect society. This is with regard not only to the HIV response but also to equity in the criminal justice system, sustainable development and upholding the dignity of all citizens, starting with the most vulnerable.

But only when the use and possession of drugs are decriminalised will harm reduction measures be most effective. And to the critics who argue that decriminalisation will promote drug use and violence, evidence from all over the world confirms the opposite.

Portugal, In the decriminalisation of drug use resulted in a 50% decrease in arrests and incarceration for drug offences, a fourfold decrease in opioid overdoses, and an 18% per capita decrease in social costs related to drugs, according to a report in a 2016 edition of The American Journal of Drug and Alcohol Abuse. When people who use drugs face fewer health and security risks, because they are no longer driven underground but can use them in safe environments, society as a whole experiences lower public health costs and greater safety.

It also makes little sense to use the criminal justice system for people who are physically or psychologically dependent on drugs. This is a medical

condition that affects about 12% of people who use drugs, the UN Office on Drugs and Crime in its latest World Drug Report estimates. Drug dependence must be treated as a health concern, respecting the rights to which all citizens are equally entitled.

These policy choices of criminalising people are based on moral prejudices and have not been grounded in the kind of evidence that has helped South Africa to turn the tide against HIV for many. Internationally, the South African government shows a progressive understanding

To address drug-related issues, we need to review policies.

In practice, this means introducing a range of treatment and harm reduction options that can be accessed voluntarily, from rehabilitation programmes to measures aimed at minimising the harms associated with drug use, such as HIV, hepatitis infection and overdose. These treatments can include drug substitution therapies and even the medical distribution of heroin, which Switzerland initiated 25 years ago and is also practised in the Netherlands, Denmark, Canada

Evidence from other African countries — Senegal, Kenya, Morocco, Tanzania, Burkina Faso and Mauritius - shows that harm reduction initiatives are effective in curbing HIV transmission among people who use drugs and reduce the risks associated not only with drug use but also those often far greater risks associated with the illicit drug trade. HIV has changed and so too has the international discourse on drug use. More countries are recognising that illicit drug use is a public health and must address broader social and economic issues. Now it is time for South Africa to implement what it has rightly preached abroad.

Raila Odinga threatens re-run election boycott



Kenya's opposition leader Raila Odinga has said that he will not take part in the presidential election re-run slated for 17 October "without legal and constitutional guarantees".

Last week, the Supreme Court annulled August's election result saying the electoral commission (IEBC) had not followed the constitution.

Incumbent President Uhuru Kenyatta was declared the winner by the IEBC.

The court said a new election needs to be held by 31 October. Speaking to journalists, Mr Odinga said that the fresh vote must held in an environment where everything that went wrong can be corrected.

alliance went to the Supreme Court to challenge President Kenyatta's win arguing that the results had been tampered with during transmission from the polling stations.

They alleged that someone gained access to the IEBC's computer servers to tweak the results in favour of Mr Kenyatta.

The court found that, among other things, the IEBC had committed "illegalities" in the transmission of results. But as it has not released its full ruling it is still not clear exactly what went wrong.

The Supreme Court said on Friday that it would make its full ruling public within 21 days.

Mr Odinga wants the IEBC to strictly follow the constitution's guidance on conducting elections.

He also wants some of the commissioners to be sacked, alleging that they are partisan, and he is pushing for access to IEBC's electronic voting and result transmission system.

Mr Odinga criticised the IEBC for announcing the new election date saying that opposition parties had not been consulted.

Nasa sent a letter to the IEBC arguing that the date for the fresh election "should be a product of consultation with concerned parties and not a unilateral decision". The opposition leader alleged that the election date was set by the governing Jubilee Party. Mr Odinga also faulted the IEBC for saying that the new election will just be between him and Mr Kenyatta. There were eight candidates on the ballot paper in August.

"The entire election was cancelled by the Supreme Court," he said. "So it means that you do a repeat of the

presidential elections afresh." For his part, President Kenyatta said last Friday that while he respected the court's annulment of the election he disagreed with the decision. Speaking to supporters later that day, at an impromptu rally in the capital, Nairobi, he described Chief Justice David Maraga as a "crook". On Saturday he vowed to "fix" the Supreme Court if he was reelected. BBC News

Nigeria and South Africa both come out of recession

Nigeria and South Africa, two of Africa's richest countries, are no longer in recession as the economies of both grew in the last quarter. Nigeria had experienced a long period in the doldrums with five consecutive quarters when the economy shrank. But with annual GDP growth at less than 0.6%, Nigeria's emergence from recession is slow.

South Africa is still facing big

economic challenges despite recording a more healthy 2.5% growth figure.

The economic boost in South Africa can be put down to a big rise in agricultural output of 33%.

But overall, its economy still continues to struggle with unemployment remaining stubbornly high at nearly 28%, the BBC's Africa Business Report editor Matthew Davies says.

In Nigeria, the poor performance of the vital oil sector continues to be a drag on the economy. Furthermore, the country's GDP needs to grow by 3% every year just to keep up with the rise in the country's population. "It still falls far short of the growth rates the Nigerian economy should be achieving," economist Razia Khan told the Reuters news agency. BBC News


Jesus," Harvey told the publication in a new piece published Tuesday. "It was so vicious that it really threw me."
