### Move on from my sex tape, says Iris


#### By Mirriam Chabala

Oil trader Gunvor has sued the Zambian government for refusing to take the crude oil supply, which has been abandoned at sea in Dar-es-Salaam for over a year and half. And Ministry of Energy permanent Secretary Brigadier General Emeldah Chola, in the audio published on diggers.news, says the Zambian government cannot commit to paying Gunvor for the "contaminated oil" until the matter is settled in the arbitration court.

News Diggers! has visited a crude oil tanker MV Alberta, that has been abandoned at sea in Dar-es-salaam since January 2016, carrying about 100,000 metric tonnes of crude oil destined for Zambia.

A source found at the offshore location explained to this reporter in an interview that the oil tanker was accumulating about US\$20,000 per day in demurrage (a charge payable to the owner of a chartered ship on failure to load or offload within the agreed time).

"This ship docked in January 2016 but the [Zambian] government refused to take the crude saying it was contaminated. Now what usually happens is that once there is such a dispute, an independent expert is called in to conduct lab tests and verify if the claim is true or not. Meanwhile, the ship does not stay even longer that two months because keeping this here costs US\$20,000 per day in demurrage," explained the source.

# Yaluma orders KCM to reverse transfer of 4,000 employees

#### By Sipilisiwe Ncube

Mines Minister Christopher directed Yaluma has Konkola Copper Mine to reverse the transfer of 4,000 employees before conclusion of discussions between government, Mines, and the Mine Workers Union with immediate.

And Yaluma has asked mines to publish how much money in they were paying to the government for the sake of transparency.

Speaking at a press briefing in Lusaka today, Yaluma said government would only allow mines to outsource if the task was critical.

went ahead transferred 4,000 employees. So I am just trying to redirect and instruct KCM right now to (a) stop whatever transfers they have made so far, it's not holding. I am requesting them to stop so that we can talk. We have said after all that we run an open door system whereby dialogue is the main thing and we have committed as government to always discuss things with the Mines or the chamber before anything could be implemented. Now if KCM are doing something like that, they are just going against something that we have talked about," Yaluma

"We are not going to allow to see employees in the mines get back to the streets or get to work for some other contractor where job security will never be guaranteed because that contractor is going to work with those people for three years and after that it will spell a lot of people out of employment. So we would like to talk to KCM to ensure that we understand what they are trying to bring in and then we tell them what we feel as the government.

But I can guarantee the Miners that they still have the employment as it was yesterday or the years ago." Yaluma said KCM had already agreed to abide by the directive to reverse all the transfers that it had already made.

"Just this morning, I had a meeting with KCM and they have agreed not to proceed

with any transfer until we talk and agree the way forward. We are on record to say outsourcing is one source of doing busainess but you don't outsource wholesale. You outsource to critical, if we agree that it's a critical task, then we can go ahead and allow them to, but we must agree on what we are doing and protect the interest of the workers in the mining industry," Yaluma said.

"And also they have also confirmed whatever, they are reversing the number of people they transferred who were at play, its 910 which they haven't even completed but they did transfer 200 which I have told them to reverse with immediate

effect until we have concluded our discussions. So to the miners out there, it is business as usual, they have their jobs until we have concluded our discussions between the government, KCM, and the Union."

And Yaluma asked mines to publish how much money they were paying to government for the sake of transparency.

"All the mines have accepted the new tariffs except for one mine but we have concluded and they have come to acknowledge the new tariff and they are to pay off the arrears whichever they are applicable. The mining companies also must make known how much money in terms of revenues they are paying to the government for the sake of transparency,"

And asked how effective the new committee on mining sector reforms would be compared to the previous ones, Yaluma said the committee was as a result of some complaints by mines that they were operating on loss for many years.

"No the President is not putting up a new committee. That committee is coming up because of somebody [who] said he has never made a profit for the past so many years. Then he said they must be playing with us, why are they in the country? If somebody says when he met the President last week, he says they have never made profits, then why are they in the country? Something must be going on wrong, they must be hiding something. Then it's necessary that we put up a committee to look into that," said Yaluma.

Nkana PF member of Alexander parliament Chiteme says there is a "job mania" on the Copperbelt. And Chiteme says Non Governmental Organisations must praise government when things are going well in the country the same way they are quick to criticize when prices of goods and services go up. Speaking on Radio Phoenix's Chat Back programme today, Chiteme boasted that the Copperbelt was experiencing a job mania owing to the ongoing projects.

"When it comes to the welfare of the people, you are seeing the PF delivering its promises and the cardinal thing that people keep asking, 'where if the PF going, is the PF giving us jobs?' yes, the PF is giving us jobs. Copperbelt we are in a job mania now because we have projects that are running that will give us close to 5,000 jobs. For example, the Copperbelt International Airport which AVIC has started constructing now, the good news is that that land was owned by people, our own people on the Copperbelt, we negotiated with them, we compensated them, we didn't chase anyone. You would also wish to be one of those people whom we compensated because compensated them handsomely. What we did, we were just flying over the other day in a chopper and you can already see the beauty of the work that is being done. That is about half a million, \$530 million worth of a project and we are looking at 4,000 jobs right on the Copperbelt in Ndola," Chiteme said.

"PF is loved. On the Copperbelt for example, people were complaining about roads but the listening government laiunched the C400 in Chingola and the following day we started building the road. Now we are going to have a Copperbelt that looks like Lusaka because everywhere I go in Lusaka, there is a road, there is a clinic that has been developed into a level one hospital."

He also said President Edgar Lungu was in touch with the grassroots and prioritized their needs.

"If there was ever a government which looked into the poor people, it is this government which is backed by our manifesto. I am going to give you an example, unfortunately this example will hinge on the President. The President has always sorted the poor first. When our mothers didn't have capital, the President took 10 per cent of his salary and said let us give this to them under the Presidential Initiative, tell me which other President has done that? Our women have received money through the presidential empowerment. Whenever there is a cause, the President has to be there, no wonder people are even laughing at us that the president went to open Chisokone Shelter, it is because the President is in touch with the poor and the government. So when you

He also disagreed with critics who felt road projects were not a priority saying good roads reduced the cost of doing business.

## Gunvor sues govt over "contaminated" oil

"In this case, MV Alberta has accumulated over US\$10 million, and I can assure you that the owners of this ship want that money which Gunvor will not pay because they have actually sued the [Zambian] government."

The source narrated that Gunvor refused to take back the oil, insisting that it was according to the specifications requested by the Ministry of Energy.

"Gunvor has stuck to their guns, they have refused to take back the crude. They argue that the vessel contains the exact specifications which the Zambian government ordered. So they have resolved to sue the government. The last time we heard on that issue, the government surrendered the matter to the Attorney General for recommendation. But the dispute may cost government millions of dollars," said the source. When contacted for a comment, Energy Permanent Secretary Chola said government was not willing to pay for the "contaminated" crude.

"It's contaminated crude, who has said we are going to pay? That case is still with the arbitration court, so the ruling hasn't vet come out," said Chola adding that the matter was not being heard in the Zambian courts.

"The details will come out once everything has been concluded. Currently the ones who are handling it are Ministry of Justice."

An investigation has revealed that the Zambian government deliberately purchased "contaminated" crude feedstock from Gunvor, despite having been warned of the damage which the previous consignment from the same supplier did to Indeni Petroleum Refinery.

In May 2014, Indeni wrote to TAZAMA, explaining that a products sampling and analyses report had shown that the imported feedstock by Gunvor contained Organic Chlorides, which caused corrosion attacks on the refinery.

'Once again we present and demonstrate through product sampling and laboratory analyses by Intertek Testing Services that imported crude feedstock (Refinery raw material) continues to contain causes of refinery corrosion attacks namely Organic Chlorides," the letter signed by then Indeni Managing director Maybin Noole read in part.

"Shipment cargo MT Lovina that docked recently with samples taken from board/ ship's tanks before offloading had 7.0 wt ppm of Organic Chlorides, thus depositing into Dar Tazama tanks Organic Chlorides, the compound dreaded by all petroleum refineries for being major cause of refinery corrosion. The above data is evidence that Organic Chlorides came along with imported crude feedstock from either the source or ship's compartment/ tank bottoms."

The said crude was however pumped into Indeni, a move that caused further damage to the refinery as it was still contending with the effects of corrosion from the batch of feedstock that had been received from cargo ship Mt Sharp Lady, which again had a high level of Organic Chlorides amounting to 31 wt ppm.

On 6 May 2014 the Joint Operating Committee (JOC) considered the matter and resolved that TAZAMA Pipelines should write to Ministry of Energy to recommend that: "effective next shipment, quality data sheets from source/ supplier must include organic and inorganic chlorides analyses first".

The government however went ahead to procure another 80-100,000 metric tones of contaminated crude feedstock, which Indeni refused to take in.

Last year in January, Indeni wrote to TAZAMA questioning the source of the contaminant in the crude feedstock.

'We are in receipt of reports analysis from Intertek concerning latest cargo offloading at Dar by name of vessel MV Alberta.

As per data sheet attached herewith, it is evident that once again, the feedstock components contain a contaminant/poison called Organic Chlorides in excess of 4 ppm against <1.0 ppm maximum allowed," Indeni stated in a letter dated January 11, 2016.

"Our first reaction is as follows: 1. Help us understand fully where this contaminant is coming from and why it is still found in crude feedstock components as this contaminant/ poison is not naturally found in petroleum products. 2. Also send us analyses of composite (resultant) Organic Chloride in the final mixture to be blended in the proportion/composition provided by Indeni as follows: Oman Crude oil =44% Gasoil =43% and heavy Naphtha =13%. We look forward to your usual cooperation in this very important and serious feedstock supply risk."

Meanwhile, Indeni failed to process part of the earlier supplied feedstock and it quarantined the crude for disposal, amidst fears that the contaminant would cause further damage to public motor vehicles.

În a letter dated April 26, 2016, Indeni wrote to Energy Permanent Secretary Brig Gen Chola requesting to dispose 29,367m3 of feedstock that could not be processed.

"Reference is made to the above matter. Indeni has now completed analysing the feedstock. Attached is the quantitative analysis of the contaminated crude oil quarantined at the Refinery. The total quantity being held in the refinery is 29,367m3," read the letter.

"With this information, we hope the process of disposal of the said feedstock to interested parties can now commence. We also hope that the process will not be protracted as the prolonged quarantining of this feedstock in our tanks may have adverse effects on the equipment in the refinery."

they wouldn't say it, they just hide behind Facebook. So I would like to tell people who like to cyber bully that they need to stop, its not a very nice thing to do and I think that if you were in the same

situation as another person, you wouldn't like that to happen."

Iris called on Zambians to move on from her past and join her in building a better Zambia.

"I really want people to move on from the sex tape. I would like to just highlight that because my family is so affected by most of the negative comments. It was not a nice thing, I apologised and I went to prison for it, I also paid a fine and I think that many people make mistakes, so I would just like people and the nation at large to move on from that scandal and focus more on what my future is, to secure my future," she said.

"Let's work together. As a person, I have a foundation which I want to build for prisoners. I want to build a country where prisoners are recognised and where their welfare is paid attention to, I have a lot of positive things surrounding me but most of you want to just focus on my negative publicity which is not good. I would like to urge the media to practice responsible journalism because I am just a young woman only 26 years old, so please please let's just work together and make this country better," she said.

Iris said she understood that the media could make or break her.

"I called this meeting because I know that the media can either build you or destroy you and as you sit here, I am aware that you have the intention to bring a good story. Now, you are going to be writers or tellers of my story and I think that you are going to determine how we move forward as a country, you are going to determine me as a person. You as media are going to drive the motion and everything that is said about me will be determined by yourselves and I would like to urge you that you are the builders of myself, I could never be anything without you people, you have made me where I am today so don't twist stories."

Asked what she had to say about the picture of her in animal skin paintings which had been circulating on social media, Iris said the picture was intended for a project she was working on but that it was leaked before

"On the issue of the elephant in the room, I was just depicting in the culture of our country. We were not clothed before missionaries came on board and gave us clothing. We used to wear animal skin and I think that everybody here is very familiar with this history and so today I want to depict this because I feel passionate about our culture and I feel that we are slowly losing the depth of ourselves. So one point of the picture was to appreciate culture and the second thing is that women are not celebrated enough, so I feel that we live in society where when a woman wants to rise up, most people especially the women want to bring them down.

And that picture is actually intended for a project that I am working on. It's unfortunate that it was leaked before it's time. I know most of you say Iris you like to be naked, no. I can't come to this function in a bikini or naked because that's unacceptable but when I am at the beach or at the pool I have to be in my bikinis because there you can't be fully dressed up. So I would like us to see the bigger picture and I want to urge women out there that we need to partner with each other, we are not enemies and if we work together we can make a better Zambia," said Iris.

# Democracy has brought problems - Defence Minister

Defence minister Davies Chama says democracy in the country has forced the government to stop teaching street kids life skill for fear of infringing on their human rights.

And Chama, a nominated member of parliament, who is also former ruling party secretary general, says the PF government will use the defence wing to boost the country's food security. According to State House operated Smart Eagles Facebook page, the minister was speaking when he paid a courtesy call on Kitwe District Commissioner Binwell Mpundu in the company of senior Zambia National Service (ZNS) officers.

Chama regretted that when the government decides to reforms

streets kids by teaching them life skills, parents protested saying the move was infringing on their children's rights.

When asked if the ministry would take on board youths from the streets to train them in agriculture and other skills, Chama said the arrangement could only be done after consultation with stakeholders and parents of the children.

"This democracy has brought problems in our country. When government decides to take youths from the streets to train them in various skills, people will rise to say you are infringing on the rights of the children. Even parents of the child who are not seen, will come from nowhere," Chama said.

He said government was not eager to take street kids.

"This is the problem in our country, everything is politicised. So unless stakeholders including parents of the children agree, we can't take the children in the streets to train them," Chama added.

He also said the Defence wing was not all about military activities.

"The ZNS is doing a commendable job in agriculture. They are contributing significantly to the food security in the country. So I can tell you that we are moving away from being a consumer ministry and we are now becoming an economic ministry through our involvement in agriculture and food production in the country," said Chama.

### When HH becomes president, he should expect other people to chase investors like he is doing to the PF - Mwakalombe

Lusaka Province Minister Mwakalombe Japhen says when UPND leader Hakainde Hichilema becomes president, the opposition will chase investors the way he is doing to the PF.

And Mwakalombe says Lusaka Mayor Wilson Kalumba's idea of getting K10 garbage collection levy from people's phones is not yet government policy.

Speaking at a PF Interactive Forum on Sunday, Mwakalombe, who is also Chongwe PF member of parliament, asked HH to be truthful.

"Where is the loyalty to his country? Where is the loyalty to the people who voted? He has got a very big number of people who voted. We cannot have a situation where as a country we are looking for investments to come into the country and other people are chasing people away deliberately. Tomorrow, you become a president and it will be the same because what you are doing to others is what will happen to you also. So I am appealing to HH's conscience to say when you are going to engage people, engage them truthfully, speaking on something is happening," that Makalombe said.

"For instance surely we are all Zambians, have you ever seen in Zambia police go into parliament? But the person who is aspiring to be president goes to South Africa, leaves his own people that he is supposed to be talking for, he goes all the way to South Africa to go and talk about our Parliament is not independent and police go inside. Surely, even if you want to attract attention, surely, even if you want to

attract sympathy or those who are funding you, can you go to an extent of saying something which has never existed? Zambia is bigger than all of us. It is unfortunate that we want to go into political offices at all cost. Our friends in Europe, they resign as president when they lose elections, they put integrity ahead of everything that they do and that has been our culture as Zambians, we have KK, he is living there, he is not a rich money but he has a big name. How can someone at a level of HH go to South Africa and start speaking things like that? Why can't he dwell his energies on how he can organize his party? Why can't he go to the markets and go to the people who are poor and suffering? Opposition doesn't mean you have to be antagonistic or disagree with everything. In opposition, when your friend does well, you should be able to say 'this is right, when it is wrong, you say 'this is wrong', that is the only way you win." Mwakalombe also said it was unfortunate that politics had overshadowed development in Zambia.

"It is very unfortunate that

in Zambia today, politics have gone to an extent of hating each other based on Zambia, because of the political party that you belong...I felt that politics, you offer yourself to the people and people vote for you. I have never seen any person in this world that has ever fought or attempted to kill a person because he is a garden boy, I have never. As politicians we say we are servants of the people but today people hate each other with a passion, to go an extent to create a story which does not exist to paint the other player black. It is very sad.

And it is very unfortunate. Today in Zambia, politics is what attracts people's attention, we are diverting from development to politics," he said.

Mwakalombe urged Zambians not to forget about the liberation struggle.

## **Ve'll share lessons from Congress** of Constitutional Justice - Mambilima

Chief Justice Ireen Mambilima says she is looking forward to the casesexchange session at the 4th World Congress of Constitutional Justice in Lithuania so that she can learn from other countries.

Mambilima said this when she was transiting through Germany during her interaction with Zambia's Charge D' Affaires at the Embassy in Berlin, Theresa Kimena

According to a statement issued by Zambia's First Secretary for Press at the Germany Embassy Kellys Kaunda, Kimena told Chief Justice Mambilima that her decision to attend the congress signified the importance she attached to constitutional matters.

"Your attendance of this meeting sends a strong signal to the Zambian people of the importance you attach to constitutional matters. This is the same importance President Lungu attaches to constitutional development as evidenced by his assenting to a new constitution last year," Kimena told the Chief Justice, who was accompanied by constitutional judge Mulonda.

In her remarks, Chief Justice Ireen Mambilima said the congress afforded an opportunity to exchange global experiences regarding the promotion and upholding of justice based on

the constitution. "There will be an exchange of case law which we shall intend to bring back home and share with the rest of our colleagues", said Mrs. Mambilima.

The Supreme Court of Zambia is a member of the Congress that regularly holds conferences on matters of justice. The southern African presidency of the congress is currently held by Namibia but will be represented at this year's congress by Zambia. During the weeklong conference Chief Justice Mambilima is expected to chair selected sessions as well as hold discussions with her counterparts from other parts of the world.





budget projection. And the Ministry of Finance has called on government stakeholders to scrutinise the 2018-2020 "Green Paper" and make constructive recommendations.

"I am pleased to present the 2018-2020 "Green Paper" which is aimed at linking medium Government's term development goals, as tabulated in the Seventh National Development Plan. In over seven years, this is the first time that a green paper is being availed to the public for scrutiny, commentary, and refinement," the Ministry stated in a statement released today.

2018-2020 "Over the medium term, Government projects to spend a total of K210.0 billion, excluding amortisation, out of which, K65.4 billion will be spent in 2018, K69.4 billion in 2019 and K75.1 billion in 2020. As a share of GDP, this will amount to an average of 22.2 percent per annum. Out of the projected total expenditure of K210.0 billion, 80.8 percent will be financed from domestic



The upshot of that failure in civic responsibility is the crumbling of cases through which corrupt persons would otherwise have been held to account. We must therefore innovate and implement strategies which address public ignorance and apathy in order to empower citizens to proactively participate in

anti-corruption processes. Further firming up of the policy and guidelines on the role of the public in the fight against corruption is very necessary. The public needs to be made aware that they are the ultimate victims of corruption and there is need to internalise and discharge the mandatory responsibility placed on their shoulders in the efforts to fight corruption.

African governments to foster and promote ethical leadership in all sectors and more so in the public sector. It is instructive that unethical leadership remains one of the biggest governance challenges in African countries which continue to ravage their economic and social landscape. The morality and ethics of the modern public service are a product of the minds of the leaders of the organisation through the policies they establish and the behaviour they model. Leaders at all levels set the ethical tone for subordinates in their organisations and have a significant impact on how their subordinates act and perform. Indeed, leaders are often the most important source of information that subordinates look to for guidance in their behaviour.

The need for high standards of ethics and integrity for holders of leadership positions is not because the leaders have an inherent inclination to perpetuate corruption, or will necessarily do so. Rather, the nature of leadership positions requires the office holders to continually face difficult ethical dilemmas and constantly decide among competing interests hence the temptation to

engage in corruption. There is thus need for African States to establish effective and efficient mechanisms to promote the integrity and ethical conduct of those entrusted with leadership positions.

Thus was upon the realisation that while integrity is the most important quality leadership, it is also one of the great challenges of leadership. Leaders who assume public office with genuine intentions to help their people may soon find themselves faced with ethical dilemmas when their personal interests are brought to competition with their official authority and discretion. It is therefore necessary that we subject leaders to prescribed standards of conduct to help them resolve such ethical issues.

It is true that colonialism

did not bestow much to Africa but the African Leadership could not retain the little that it inherited. In fact, corrupt leaders destroyed it.

It is my greatest hope that my efforts will enhance our continental, regional and national efforts in fighting corruption and those who fight the fight. I strongly suggest that we take it upon ourselves to encourage the African States which are yet to ratify the AU Convention on Combating and Preventing corruption to do so without delay. # Mummies discovered in Egypt

Archaeologists in Egypt have discovered the tomb of a royal goldsmith containing the mummies of a woman and her two children, authorities said.

The tomb, dating back to the New Kingdom (16th to 11th Centuries BC), was found near the Nile city of Luxor, 400 miles (700km) south of Cairo.


the Among items discovered inside was a statue of the goldsmith Amenemhat, sitting beside his wife.

It is unclear whether three mummies discovered are connected to Amenemhat.

The mummies were found down a burial shaft leading off the main chamber, Ministry Egypt's Antiquities said.

According the to archaeologists, the mother died aged about 50, with tests revealing she had a bacterial bone disease. Her two sons were in their 20s and 30s and their bodies said to have been preserved in good condition.

Authorities believe the tomb of Amenemhat, who was goldsmith for the god Amun, the period's most powerful deity, could lead



them to further discoveries in the Draa Abul Naga necropolis, an area famed for its temples and burial grounds.

Minister of Antiquities Khaled al-Anani said: "We found many objects of the funerary equipment inside and outside the tomb. We found mummies, coffins, funerary combs, funerary masks, some jewellery, and

"The work did not finish yet."

Mr Anani said archaeologists had read four new names.

"What about those four new names? How about their tombs? Their tombs are not discovered yet. But I believe they are owners of the tomb," he said.

When asked if he had simply been "trolling," Kahn replied, "Yes. The world is full of stupid mother\*\*kers."

This isn't the first time Kahn has come to Swift's defense. In July 2016, he slammed the Kardashians shortly after Kim Kardashian released snippets on Snapchat of the now-infamous phone call between Kanye West and Swift.

"Ain't the first time the Kardashians supported the murder of an innocent blonde woman," he tweeted at the time, going on to praise Swift.

Kahn previously opened up to ET about Swift's creative process and involvement in her videos.

"We have a complete discussion. These are true collaborations it's not like, 'Hey Joseph, here's a song and come back and tell me what to do.' It's not like that at all," he said. #### Farrel opens up about son's rare disorder

Colin Farrell is opening up about one of the most special moments of his life.

The 41-year-old actor, who stars in the dark drama The Killing of a Sacred Deer, stopped by the PEOPLE, Entertainment Weekly and InStyle studio at the Toronto International Film Festival with costar Nicole Kidman and director Yorgos Lanthimos.

Farrell, who plays a father given a terrible choice in the movie, shared a joyful story from his real life as a dad. "When James took his first steps a couple weeks short of his fourth birthday, it was pretty amazing and humbling to see," Farrell says.

The actor's firstborn son, who turns 14 next week, has a rare genetic disorder called Angelman syndrome, which causes motor and developmental disabilities, among other symptoms..

Farrell says that while any child taking their first steps is a momentous occasion, it meant even to him knowing his son worked hard to reach that milestone.

"People talk about the children taking the first step, it's obviously a monumental moment and it's been represented in film," Farrell says. "But to be told your child may never take the first step and then see those first steps is

just kind of a different sport all together."

Farrell then jokingly tells Kidman to "beat that," but she responds that her two youngest daughters with husband Keith Urban have put a gag order on telling stories about them.

"I'm not allowed to talk right now about my children because they're becoming aware of what I say and it gets reported back to them so I've been silenced," Kidman admits. "I'm just very, very proud of them and would love to be able to discuss them, but have been told to cut it out." Yahoo News



#### Usher denies allegations against him in herpes lawsuit

Usher is firing back at the three individuals who sued him for allegedly failing to warn them of his reported STD diagnosis.

In court documents obtained by PEOPLE, the singer's legal team "denies each and every allegation" made against him by Quantasia Sharpton and two others — identified as "Jane Doe" and "John Doe"— who filed their joint lawsuit in August.

The "Confessions" singer — through his lawyers Laura Wassar and Zia Modabber — claims that if sexual contact did take place with his accusers, there

wasn't any intent to harm. "Any alleged conduct by Defendant, which is expressly denied, was unintentional," the filing says.

Usher, 38, also says that they "assumed the risk of any alleged harm" by engaging in sexual contact.

He further accuses the three individuals of "unclean hands," meaning that they've committed some sort of wrongdoing or are liable for an offense themselves, in the document.

Sharpton said in an August news conference that the singer exposed her to herpes during a sexual encounter with him after a concert on her 19th birthday. Though she did not contract the STD, Sharpton felt that her "rights were violated."

In 2012, Usher also reportedly paid a woman \$1.1 million to settle a lawsuit after she claimed to have contracted herpes from him. According to court documents filed by the celebrity stylist whom Usher settled the suit with in 2012, the "Confessions" singer was allegedly diagnosed with herpes around 2009 or 2010.

The stylist accused the star — who married his current wife Grace

Miguel in 2015 — of "consciously and purposefully" withholding his diagnosis from the woman and "continued to have unprotected sex" with her, according to papers obtained by Radar Online.

The woman was tested and diagnosed with herpes after suffering from vaginal sores, fevers and chills, according to the court papers.

California law states that it is illegal to knowingly or recklessly transmit an STD, and court papers showed the singer paid \$2,754.40 of the victim's medical bills in 2012. *Yahoo News*

## Rafael Nadal wins 2017 US Open

Rafael Nadal restored order to this eccentric US Open last night, easing to a comfortable 6-3, 6-3, 6-4 victory over giant South African Kevin Anderson on Arthur Ashe Stadium. This contest always had "blowout" written on it. Anderson came in as a first-time major finalist, and the lowest-ranked man - at No. 32 in the world - to play for the US Open trophy. No wonder Nadal had been listed at prohibitive odds to secure a 16th grand-slam title.

Like the women's final on Saturday evening, the big occasion soon dwindled away into predictability. Nadal was dominant throughout. He broke the giant Anderson serve which touched 136mph at one stage - no fewer than four times, while never giving up a break point himself.

The best hope for the underdog would have been to deliver ace after ace. Yet Anderson was landing that siege-gun of a first serve only 59 per cent of the time, his lowest figure for the whole tournament.

In all probability, the dip was caused by overpressing. Nadal was giving his opponent so little to work with - only 11 unforced errors in the match - that Anderson tried too hard for the miracle serves, and lost his rhythm as a result.

Among the women, the last couple of seasons have thrown up four new major champions. Among the men, however, the elite five-man cartel continues to monopolise the biggest titles, even if three of its members failed to sign in for this tournament because of injury.
