And Mwale says it is not accurate to say the 42 controversial fire tenders cost US\$1 million each, because there were other costs involved. Regulating campaign funds won't work because of theft in govt - Milupi

By Zondiwe Mbewe ADD president Charles Milupi says Justice Minister Given Lubinda is mistaken to think that the Political Parties Bill will control how much funds go into campaigns because the ruling party will always get money from government deals.

And Milupi has asked Lubinda to give NGOs, Civil Society Organisations and the church ample time to thoroughly debate the Political Parties Bill before it is presented to Parliament so that more views can be heard on the matter.

The Alliance for Development and Democracy president was reacting to Lubinda's interview on Hot FM's Hot Seat programme on which he said under the current Constitution, government would give more campaign funds to political parties with more members of parliament. The justice minister said political parties needed to be controlled on the amount of money to use during campaigns, adding that they will have to account for every bit of it.

But Milupi said although the intention was good, it would be difficult for the ruling party to account.

"If you are going to build political parties it must be everybody including those who are in Parliament and those who are not. If they think that by funding political parties, they will control how much money they use in campaigns, he's totally mistaken. Because of the theft that takes place in government, we find that political parties spend a lot more than any amount that can be given out through the national budget," Milupi observed.

"Look at the said PF, in 2011 when they stood for elections they hardly had any chitenge material, and the quality was

very poor including their t-shirts. ADD had a better chitenge and t-shirts when i stood as president but since they went into government, you will find that in rural areas almost everyone is wearing PF vintenges. The supply of these materials comes from people who opt to do things with government costing vast amount of money that can never be taken out of government through the support funds for political parties."

He said the PF would not afford to rely on government funds for campaigns because it would be disadvantaged.

"He is now saying because parties will be funded, no political parties will be required to raise money from anywhere else. If that's what he is saying, the party which will be more affected is the PF itself because they are raising a lot more through contractors, those looking for business and through all the corruption being seen. If Mr Lubinda says they are now going to control that, a party like ourselves will not suffer because we don't raise that much money. We wait for our members to raise for campaign materials and so on," Milupi said.

"If they are going to control the money the parties spend, how are they going to do it and how will they control the party in government which is PF when they are the ones spending a lot of money?"

And Milupi asked Lubinda to allow thorough debate on the issue.

"Mr Lubinda must allow the full process of consultation to take place and let the views expressed by the church, NGOs, Civil Society and political parties to meet before the final bill is presented to Parliament and let parliamentarians debate it thoroughly so that a law

Govt releases K10m for rehabilita

of Lusaka's National Assembly Motel

Government has released K10 million for the rehabilitation of National Assembly Motel.

According to a statement posted on the Ministry of Finance website, Minister of Finance assured Speaker of the National Assembly Dr Patrick Matibini when the duo toured the motel on Thursday that members of parliament would get conducive lodging facilities.

"K10 million has been financed by the government to facilitate the PARTIAL rehabilitation and replacement of aging infrastructure, fixtures, and fittings at the National Assembly Motel in Lusaka. This came to light when the Minister of Finance Felix Mutati briefed the Speaker of the National Assembly Dr Patrick Matibini on the measures taken by the Treasury to ensure that Members of Parliament who do not have residencies in Lusaka had conducive lodging facilities during their stay in the Capital City when on Parliamentary and other related business," read the statement.

"Dr Matibini and Mr Mutati conducted a joint inspection of the facilities last Thursday; the day before the official opening of the second session of twelfth National Assembly by President Edgar Chagwa Lungu. An initial joint inspection of the facilities by the Speaker and the Minister was conducted in June, 2017. Speaking after the tour of the motel last Thursday, Dr Matibini noted the tremendous progress made in rehabilitating the facilities 'over a short period of time, and added that, 'time has come to relook at the situation and begin

fashioning long-term improvements with the ultimate goal of rebuilding." Mutati said the release of K10 million for

the rehabilitation project at Parliament Motel was in line with government's policy and President Edgar Lungu's vision to ensure the provision of a conducive working environment for the discharge of public services.

Parliament Motel was commissioned in 1967 but has undergone negligible maintenance over the decades resulting in inadequacy and deterioration of boarding and lodging facilities such as rooms, the kitchen, and the dinning.

The Speaker was accompanied on the tour of Parliament Motel by Acting Clerk of the National Assembly, Cecilia Mbewe, while Mutati was accompanied by Accountant General Dr Dick Sichembe.

When dialogue fails, acrimony, hatred, division and disrespect persist or worsen as we have experienced," said Ndoyi.

"Finally, for dialogue to be successful and sustainable, both the UPND and PF must be committed to the process. They must be sober in their approach. There should be no politicking or subjectivity but objectivity. Each of the concerned parties should be willing to trade-off by letting go as opposed to maintaining arrogance."

Lusaka-Ndola Rd will raise K3.5bn in 17 yrs - Minister

By Sipilisiwe Ncube Housing and Infrastructure Development Minister Ronald Chitotela says government will raise at least K1.3 billion as net profit from the K3.5 billion income on the Lusaka-Ndola dual carriageway 17 years after it becomes operational.

Speaking when he featured on ZNBC's Sunday Interview, Chototela also said that the Lusaka-Ndola road project once completed will not only improve economic activities of the country but that it will also make a mark as President Edgar Lungu's signature project.

"And this road alone, we are going to raise over K300 million beginning January. This road alone has three toll plazas but with the coming one if we finish will have four, and we will be making another one as you are coming into Mpongwe because we are aware that out people will be diverting as they are going to Luanshya and then Kitwe. Our projection according to analysis that has been done by the professionals, we are investing 1.2 billion and the payment period is 17 years. Our projection is that by 17th year, this road will have raise 3.5 billion kwacha, just on this road. So if you subtract 1.2 billion out of the 3.5 billion, we will still remain with over 1.3 billion as net profit. And that many will be invested in other road projects," Chitotela said. He said that his government

would focus on delivering to

the Zambian people despite efforts by others to frustrate the project.

"I know why people are very bitter about this road, it's because this road is on the double sword, it will improve economic activities of Zambia and it is a signature project for His Excellency President Lungu. And I know people who have are bent politicking who think that they would come and rule on the misfortune that maybe this government would fail to deliver, then they would come and say they have failed. They may want to do everything possible to frustrate the project but I want to assure the Zambian people that we are determined to deliver development that is of quality and cost effective," he said. "You know a contract is a public document and anybody can go to RDA and say 'can I look at the contract.' I feel as a Minister that this is a better deal the Zambian government has gotten because we are not just making the road, we are also creating communities, we are also creating satellite cities. The road that we are building must also come with facilities that will support growth, facilities that will bring economic activities and what this road will do is it will reduce the transit time." Chitotela disclosed that the road project was negotiated by a team of three independent men who were not part of government. "I am a Minister and I can

tell you that this project was negotiated by a team of independent men who are not even part of government. Government constituted a team of three people, eminent private Zambians headed by a lawyer, an engineer and an economist, they are the ones who composed the team of negotiators, who negotiated with the contractor. And when people say 'we need to invite people to investigate this with a forensic audit...'I just said maybe the difference then and now maybe our friends then were there to enrich themselves and they are thinking the way they were doing is the way we are doing. We have come in to serve the Zambian people; ours is service above self and that's why this road is not just a road but a road that is building the community," Chitotela said. "Every successful government

Chitotela also urged Zambian contractors to take road projects as a business of creating wealth among themselves.

"Even when I was speaking about taking road projects as a business, my fellow citizens, this is an opportunity for the private entities to make money, how many people are responding? I am the vice Chairperson of the PPU council of Ministers. If we are evaluating ten projects, can all the participants in ten projects be foreigners? In an interview with News Diggers, Mwale said he was concerned with the public outcry on the matter.

"I think I issue a statement to Parliament so that it can be comprehensive. It would be good if I just gathered all the information, everything and then go to Parliament because I know in this session, parliament will not go without discussing this matter. Am avoiding giving information in bits and pieces but I know definitely that then I can address everything, what happened," Mwale said. "I understand that those who were aggrieved with the tender process had gone to the Anti Corruption to report the matter, later went to court. So there are all those things that I need to put together and give details because some of the things I also need to study as well and find out as to what happened in the past and so on."

He said it was wrong for people to deduce that because the amount involved was US\$42 million, then the each of the fire tenders cost US\$1 million.

"I am aware of those concerns which people are raising, I have seen them on social

media and so forth. That issue of the price, of one million [each]; people have just simply divided the amount by the number of fire tenders which is 42. That is why am saving that it is better to get a comprehensive statement. You see there are other things such as communication issues, the clothing, the training so you cant actually say that it has costed one million per fire tender," Mwale said. "But that is why am saying that, that can come out in a very nice comprehensive statement. After that, that is when people can now be able to ascertain what the cost of

By Mirriam Chabala NGOCC executive director Engwase Mwale says it is disappointing President Edgar that Lungu did not address how the lacunas in the Constitution would be dealt with in his address to Parliament.

In an interview News Diggers! today, Mwale also said she was disappointed that President Lungu did not address the need for a Referendum to pass the Bill of Rights which the Non Governmental Organisations Coordinating Council had been pushing for.

"NGOCC has noted pronouncements made by President Edgar Lungu during the official opening of the second session of the 12th National Assembly last week. With regard the Constitutional to process and the national referendum, we are disappointed that the President did not give a clear direction in terms of lacunas in the 2016 Amended Constitution. We are disappointed that the President did not address himself to holding the National referendum for the inclusion of the expanded bill of rights in the Constitution. This

remains a critical area of concern for the country's democratic dispensation. We have said this before and I wish to repeat that the socio-economic rights are critical for the wellbeing of women and children, we therefore urge government to prioritise the holding of the National Referendum soon," Mwale said.

Mwale however welcomed government's decision to diversify the country's economy by moving away from over dependence on copper to agricultural activities.

"Over the years, successive governments have talked about the diversification of the economy from reliance on Copper to Agriculture and the President has also reiterated the urgent need to diversify the economy, it is our expectation that government will immediately move to put in place measures that will accurate the diversification programme. The need for government to allocate adequate resources to the agriculture sector is critical for diversification to be realized and these resources must be channeled through rural areas," she said.

The Zambia Daily Mail has asked all willing employees across the board to consider leaving the company on voluntary separation basis.

According to a memo circulated to employees, Human Resource and Administration director Lutato Nyendwa said the move was meant to cut down on staff related payments, thereby enabling the State owned and government funded media house to start making profit.

"Kindly be informed that the company wishes to reduce numbers of staff working for it. The reduction of staff members if meant to reduce the cost of staff related payments from about 70 per cent to about 30 per cent of revenue in order for it to become profitable," Nyendwa stated.

"The company is therefore requesting staff who may be interested in leaving, under the current conditions of service, to apply. Please note that applications will be subject to approval by senior management. This means that senior management reserves the right to accept or reject any applications without advancing reasons."

He advised employees to apply before September 29, 2017. "All applications should be made to the director Human Resource and Administration before September 29, 2017. Until the application is approved and employee separated with, they will still be considered part of the establishment of the company," said Nyendwa.

Only 4 constituencies in N/Western have received CDF since 2015, says Kambita

Zambezi East UPND Member of Parliament Brian Kambita says only four out of 12 constituencies in North Western province have received Constituency Development Fund (CDF) since 2015.

And Kambita says the party will not substitute its leader Hakainde Hichilema because he is their most lethal striker.

Speaking when he featured on Muvi TV's The Assignment programme yesterday, Kambita lamented that even those constituencies that got CDF, did not get the full amount. "My constituency, it will be very interesting to know viewers that Zambezi East has never received Constituency Development Fund (CDF) ever since I became Member of Parliament, I have been Member of Parliament for more than a year now. We have never received a single coin since 2015 I think, CDF has never come. There are only four constituencies in North Western out of the 12 that have received Constituency Development Fund. And even those that received, they only received half of what is allocated per year. They only received K700 thousand. My constituency has never received that funding. We have a lot of projects that are still pending, some projects were financed by CDF, others were earmarked to be financed by CDF and this is making my work very difficult," Kambita said. And Kambita said HH was the party's most lethal striker.

"The perception of saying there is an overstay of the HH leadership is yours. We are a democratic party so if we choose what is best for us, I think let it stay the way it is. The reason to why you are seeing all those insinuations saying that we are not democratic and we have a president who has overstayed is because they have seen the weight of the president, that is the best we have, and we don't want to lose our best. Who substitutes a player in a football game who is the most lethal striker at the moment? HH is our best and shouldn't be replaced," he said. "The president's position has never become void ever since president Hakainde became elected into that position. And there has not been any need arising to replace him. We have had positions of a vice president which were replaced, and we have systems, it's not just the convention that ushers in members in positions, we have also got certain management committees which can sit down and probably replace a member who has left, that's a cheaper way. And through our structures as well, we do recommendations to say replace this one."

would destroy UPND, that is not the way. We would think that there was such advice looking at the vigor in which they arrested HH, and the manner in which they brutalized the people who work for him at his residence and even the comments from fellow politicians which were coming forth. We saw that people were motivated to doing harm to this individual who is a member of the UPND, he is a leader and thinking that by doing so, they would destroy the party, they wouldn't because they are many other people in the party and the party remained functioning. We believe that up to today, the Patriotic Front did not win the elections. That is the reason to why we went to court. We are now 10 times stronger," he said. Meanwhile, Kambita, who is also Chairman for the Parliamentary Committee on Delegated Legislation, said the suspension of opposition UPND MPs for a month affected the quality of bills which were passed during that period. "Out absence from parliament it didn't really affect our performance down there in as far as the people we represent are concerned, we were available to the people and we went back to the constituencies to visit the constituencies. Except of course in terms of our role in what we participate in terms of being part of the law making process, of course that affected us and there are very important bills that were passed during that period and you will agree with me that it was the time when committee reports were being presented and debates as regard to these were ongoing," Kambita said.

"Me being the seating chairman for the committee on delegated legislation, I was key actually in that area especially that we were looking at several statutory instruments. There is no statutory instrument that is passed by parliament without passing through my committee and therefore it was cardinal that I was supposed to be part of it. In as far as me performing my duties as Member of Parliament, I think it did not significantly affect me. I think government lost out in that our contributions could not be accessed on key issues. Of course our colleagues who were able to hastily pass laws in our absence and a lot of other things could have been affected." He explained that the opposition MPs had stayed away from President Lungu's addresses as a way of demonstrating their rights to protest. "The issue is not about us not knowing the consequences, the issue here is about us demonstrating our rights. We do and up to today, we still we have the right to protest and that was a show of our protest. It was nothing to do with show of disrespect or anything, the way it was taken. And up today we are still arguing it and that is the reason we had gone to court because we feel that we have the right to actually present our feelings. There were major issues that

we were protesting against and that is the reason why we boycotted the opening speech by the President on that date. So it's not really a question of walking away because of certain issues that people have taken out of it. Ours of more of a protest, there are many other issues. And especially the fact that there seems to be a trend of ignoring the issues that we presented as reasons to why we decided to stay away. Many of our supporters were incarcerated, up to today, I can attest to the fact that we have we have so

Kambita also said the state's decision to arrest HH had boomeranged.

"The incarceration of our leader has actually boosted us. We are ten times stronger than we were because we have even this sympathetic voice. I don't even know who advised the powers that be, that arresting HH many people more than 300 people, UPND members who are still incarcerated," Kambita said.

He claimed that when he attended President Lungu's address to Parliament on Friday, he was only interested in what was being presented and not who was presenting it.

"My role is to sit in parliament and listening to whoever is debating. The President is a member of parliament by virtue of his position and me sitting in there, I was of course listening to one of the Members of Parliament addressing parliament. And therefore I was listening and I am yet to read this speech in full, to comprehend it and be ready to debate it. Of course the issues that I was not interested in who is presenting it but on what is being presented because that is what is going to help our people. Of course I wouldn't say anything good about the speech because of the environment that we are living in," said Kambita.

VJ salutes Lungu for sharing smily handshake with Garry, Kambwili

By Joseph Mwenda In matters of state or political relations, a smiling handshake speaks much louder than any written words, says veteran politician Vernon Mwaanga. In a statement, the former chief government spokesperson said there was nothing new from President Edgar Lungu's speech during the opening of the second session of the 12 National Assembly, but saluted the Head of State for extending a handshake to the opposition and his critics in the House.

"This is the kind of human relations Zambia needs at this time as we try to treat and heal wounds of deep divisions caused by divisive elections and a flawed judicial system which left bitterness and tension in our country. In matters of state or political relations, a smiling handshake speaks much louder than any written words," Mwaanga said. Our political leaders must learn the humility and efficacy of talking to each other and not at each other through the media. I would have preferred to see an African dialogue process at a higher level

between President Lungu and the main opposition leader Hakainde Hichilema, but the reality is that there was no credible or serious African peace initiative on the table." After addressing the National Assembly, President Lungu greeted members of his Cabinet on the right and went further to shake hands with the UPND members of parliament on the left who shunned his previous address. The Head of State also interacted with his former information minister who has turned the heat on the ruling party with a barrage of criticisms.

And VJ said it was unfortunate that the Commonwealth negotiated dialogue was painfully slow.

"The Commonwealth moved in and negotiated a dialogue process, which led to the release from prison of UPND President Hakainde Hichilema and is now being headed by a distinguished african diplomat Prof Ibrahim Gambari who has just completed his first round of talks and inclusive consultations. From what he is reported to have said, this process will be painfully



slow and could only start in December, 2017," he observed. "There are a lot of urgent and pressing issues which require serious attention, such as police reforms; judicial reforms and reconstitution of the Constitutional Court: Reconstitution of the Electoral Commission implementation of and recommendations of the recommendations of the Electoral Reforms Technical Committee to make our electoral process more open and transparent; Further amendments to the Constitution to include additional special seats for women in the National Assembly and in local councils with a view to moving closer to gender equality; Giving autonomy to the National Assembly to elect its own presiding officers and not to rely on executive nominations."

Meanwhile VJ urged political party leaders to avoid hate speech, adding that violence had no place in a democracy. "Political leaders at all levels must refrain from making incendiary or hate speeches against others and leaders of all political parties must be seen to be punishing those who do so. The media, must also play its part by refraining from making inflammatory, irresponsible and insulting statements against other political leaders. The state print and electronic media which is owned by all taxpayers, must play an exemplary role by making sure that they don't just give publicity to ruling party and government officials, but also to those in the opposition, so

that all views are heard," said VI.

"The country must move to created conditions of zero tolerance to violence of whatever form and by whoever commits it and the police must be non partisan in dealing firmly with it. Violence has no place in a democratic society. There will always be differences of opinion on many issues, but these differences should not degenerate into violence or enmity. There will be irresponsible loud mouths in all parties, but these should be caged for the sake of building a just society for all Zambians. President Lungu and UPND leader have set the tone and their followers should now take a leaf."

CiSCA warns Judiciary against intimidating court officers

By Mirriam Chabala The Civil Society Constitutional Agenda (CiSCA) says the suspension of Livingstone Magistrate Benjamin Mwelwa and lawyer Gilbert Phiri, was meant to intimidate court officers from demanding fairness in their operations as they dispense justice.

And CiSCA has asked the opposition United Party for National Development (UPND) to emulate President Edgar Lungu's willingness to commit to the process of reconciliation and dialogue.

At a Non Governmental Organisations Coordinating Council (NGOCC) organised press briefing today, CiSCA Co-Chairperson Nicholas Phiri said the decision by the judiciary to suspend Mwelwa and Phir was against the Zambian laws and was aimed at intimidating judicial officers in dispensing justice in an impartial, competent and independent manner.

"CiSCA received the news of the suspension of Livingstone Magistrate by the Registra of the High Court, Charles Kafunda with shock. It is disturbing that the judicial officer in question was suspended for upholding the Constitution of Zambia when he appropriately referred an application for interpretation for the extent of powers of the DPP in exercise of the Nolle Prosequi. We believe that the High Court has no powers to suspend judicial officers and hence this action goes against the Zambian laws including section three of the judicial code of conduct of 1999, and 55 of the subordinate court Act, chapter 28 of the Laws of Zambia among others," Phiri said.

"CiSCA believes that there is a systematic scheme aimed at intimidating judicial officers in dispensing justice in an impartial, competent and independent manner. Not long ago, lawyer Gilbert Phiri, an officer in the justice system was suspended from appearing before any court in Zambia Law Association of Zambia disciplinary committee. Council Phiri has already been charged and sentenced by the complaint which in this case is the judiciary. One wonders what else remains to be done when his case has been determined by the complainant. Is this the new order of the rule of law in our country?"

And Phiri expressed concern over the Director of Public Prosecution (DPP) Lillian Siyunyi's discontinuation of Court cases involving those who are close to the government of the day.

"CiSCA is deeply concerned and troubled with the manner in which some Constitution office bearers such as the Director of Public Prosecutions have been discharging public functions. Not withstanding the power vested in the DPP by the Constitution to discontinue a criminal case at any stage before judgment is delivered. It is worrying that the DPP is entering nolle prosequi indiscriminately and almost exclusively with cases that involve those in power or connected to the ruling class with no regard to public interest, administration of justice and judicial integrity as provided for in the Constitution. We would like to remind the DPP that allegiance is to Constitution and not to any authority or individual because the DPP is not above the law," he said. Meanwhile, Phiri asked the



UPND to move on from their differences with the PF and embrace reconciliation.

"I think the dialogue we are talking about is between PF and UPND and for the good of the country, the two parties must put their political deferences aside and see eye to eye because they have no other option but to reconcile in the interest of moving the country forward. They have both been claiming that they have the interests of Zambians at heart and that the country is bigger than every single one of them, so they must come together and iron out the issues that has brought about this tension which has resulted in violence and hate speech," Phiri said.

"By now I want to believe that you all are aware of the root cause of what we are experiencing today. The divisions and the seemingly partisan political atmosphere in the country is clearly the 2016 general election results but also most importantly, the violence that was witnessed prior to the elections and after elections. So as a country, we need to see this dialogue taking place and not just as a political process but as a people process by embracing the divergent political adversities so that we can be able to move on as a country if we are to the Zambia that we envision."

He commended President Edgar Lungu for taking a bold step of interacting with members of the opposition parties in Parliament.

"I must state here that it was a very bold decision that President Edgar Lungu took at the opening of the second session of the 12th National Assembly in Parliament last Friday to go and shake hands

with Hon Chishimba Kambwili and other UPND members. Whether that was part of political expedience or not, at least that's just how it should be. Despite the differences that political leaders may be facing and the differences of opinion, those in power should be the first ones to reach out to those that are not in power and what the President did should be extended to other political parties like the UPND and they should also welcome that and move on as a nation, they just have to get along for the sake of this country." said Phiri.

Open Intermarket Bank without further delay, demands ZUFIAW

Financial Institutions and Allied Workers, ZUFIAW has challenged government and the Central Bank to say the truth about the status of Intermarket Bank for the sake of employees and depositors. And ZUFIAW has observed that the rate at which people default on their loan repayments was not improving because there was an information gap about the existence of the Credit Reference Bureau and its mandate.

In a statement, ZUFIAW president Ackim Mweemba wondered what was keeping Intermarket Bank closed after the numerous assurances from finance Minister Felix Mutati.

"We would like to air our concerns on the status of Intermarket Banking Corporation. Since the bank was closed in November 2016, the nation has been treated to several assurances from However, it is now close to a year since the bank closure but there are still no visible signs that these assurances are going to materialise," Mweemba observed.

"ZUFIAW has on several occasions appealed to authorities to give a definite timeframe within which the bank shall be re-opened, but to no avail. We therefore reiterate our appeal to the authorities to open the bank without delay for the good of the workers, customers and the general public. Intermarket Banking Corporation still holds money belonging to workers in form of accrued benefits and depositors. Therefore, we believe that it is their right to have the right information about the status of the institution and when they shall be able to access their funds."

And Mweemba expressed concern that commercial banks were being impacted by people's failure to service their loans.

The fire tender saga then died a natural death until it was resurrected a week ago when the government handed over the fire engines to councils. We are happy that Zambians have taken decision makers to task over this matter. They want answers. Unlike in 2015 when nobody in government bothered about what the politicians were saying, ministers this time around are jumping all over the place and throwing blame at one another. Officials at GrandView are also running out of saliva trying to explain this scandal. Those involved have realised that Zambians are angry. Not the politicians, but ordinary citizens have ganged up against them. Netizens have flooded social media with memes and mockery statements.

Adultery is always committed by two people and therefore, this alleged fire-tender corruption cannot be blamed on one side. So far we know the 'woman' who delivered, but where is the 'man' who whipped out the contract? What is their explanation?"

Bokani Soko, the owner of GrandView International - no matter how corrupt he may be labelled - did not award the contract to himself. We have heard the Minister of Local Government denying any involvement; firstly on the ground that he was Minister of Sports at the time and secondly because Cabinet ministers are not involved in tender procedures, regardless of the money involved. The minister, however, agrees that someone in government made that call, so why is this procurement officer at Local Government so difficult to name? Why are we hiding them? If they received money to award this tender, why are they not being prosecuted? If they were given instructions to award the contract, who instructed them? Why are they quiet? Who is threatening them?

We are concerned that Zambia's corruption fight lacks action. In Zambia, it is only corruption when you are not involved. When you are involved, it changes name to "pushing". "I am pushing someone I know in government to help us get this and that." Those in government would say "give us something so that we facilitate" or "for logistics". It is not corruption because you are involved.

This is a country where whistleblowers are mostly those who have been sidelined. When you have been cut off the deal, that's when it becomes corruption. That's when you rush to the media to report with all the proof documents. It suddenly becomes corruption because you will not benefit from it. Unfortunately, this is the Zambia we have built for ourselves – a country where corruption is the key to success.

We have created a society where those who embezzle public funds don't feel accountable to the people they govern. Anyway, like Pilato put it, we can only hope that the people involved in this fire tender corruption will be able to put out the fire in hell too.

Pulmonary refers to the lungs. Embolism is the process of blood clotting within the blood vessels. Simply put pulmonary embolism is a blood clot in the blood vessels located in the lungs. Depending on the site and size, most PE are fatal even in most advanced hospitals on earth.

What causes PE?

On clinical grounds, a high index of suspicion is maintained by using what is called the Virchow's triad. 1. Stasis of blood. 2. Increased tendency of blood to clot (hypercoagubility) 3. Injury to blood vessels.

predict embolism. How fatal is PE? PE accounts for about 25% of all sudden deaths. Meaning a patient can be pretty fine and the next minute they are gone! Studies have shown that there are 70-80% chance of dies from severe PE. Britain lowers threat level after second arrest over London attack

Police stepped up their investigation Monday into the bombing of a packed London Underground train during rush hour after officers made a second arrest in their probe. The bomb went off on Friday's morning in a crowded carriage and although the device is thought to have malfunctioned, it still wounded 30 people. Britain downgraded on Sunday the nation's terrorism threat from its highest level following the arrest.

It was the country's fifth terror attack in six months, a series that has claimed 35 lives.

Police said earlier Sunday that a 21-year-old man, who has not been identified, was detained late Saturday in Hounslow, on the western rim of the capital. "The Joint Terrorist Analysis Centre, which reviews the threat level that the UK is under, have decided to lower that level from critical to severe," interior minister Amber Rudd said in a televised statement.

A search was underway on Sundav in Stanwell, a few miles west of Hounslow, in connection with the 21-yearold's arrest, police said.

After taking into custody an 18-year-old man earlier on Saturday over the "bucket bomb" attack at the Parsons Green Underground station, police said they they were hunting for more suspects.

Rudd said the police were trying to find out how the first man arrested was "radicalised" The Islamic State group claimed responsibility for Friday's explosion.

The first arrest on Saturday took place at the Dover ferry terminal, a main link to Europe. A "number of items" were recovered during the operation and the man is now in custody in London, officers said.

Police also raided a home in Sunbury, a town west of London on Saturday. Local residents quoted in British media said the owners of the house were elderly foster parents. CCTV footage obtained by

Rudd had earlier dismissed as "pure speculation" US President Donald Trump's claim, made Friday on Twitter, that a "loser terrorist" behind the attack was known to Scotland Yard.

The tweet had already drawn a terse rebuke from Prime Minister Theresa May, who said: "I never think it's helpful for anybody to speculate on what is an ongoing investigation."

In another security scare on Sunday, a London-bound British Airways flight was evacuated at Paris's Charles de Gaulle airport after a false bomb alert.

The improvised device at Parsons Green, a quiet and well-off residential district, failed to detonate fully.

But the blast inflicted flash burns on passengers, and prompted dozens of others to flee in panic.
