LAZ deputy withdraws from representing Yachi

Lusaka lawyer Eddie Mwitwa has stopped representing folk musician Mumba Yachi in his immigration case.

Mwitwa, who is also Law Association of Zambia vice president, did not however file an application to formally withdraw from representing the accused, a decision which angered the court. But Mumba has explained to the court that Mwitwa had stopped

representing him due to financial constraints.

When the matter came up for trial today, a lawyer who came to Mumba's aide on probono basis applied for an adjournment saying she only received instructions on Friday last week.

Drop charges against fire tender protesters, demands NGOCC Solvezi accident kills one, injures 34 soccer fans

NGOCC says the charges against the fire tender protesters must be dropped immediately because their arrest was unwarranted and unconstitutional.

In a statement today, NGOCC board chairperson Serah Longwe stated that Alliance for Community Action executive director Laura Miti and others had a right to protest the purchase of 42 fire tenders for \$42 million which pointed to corruption.

"The Non-Governmental Organisations Coordinating Council (NGOCC) condemns in the strongest terms the arrest of the six members of the Joint Action for Accountability in Zambia that were arraigned on Friday September 29th, 2017 for peacefully protesting against corruption and Government's purchase of 42 fire truck tenders at US\$42 million. We henceforth demand that the charges against the six protesters be immediately dropped. The arrest is not only unwarranted but totally unconstitutional given that citizens have the right to protest and question the decisions of those that are in Government. Without doubt the transaction involving the 42 Fire Tenders points to corruption and must be investigated," Longwe stated. Longwe joined those calling for the Head of State to constitute an independent Commission of Inquiry on the matter.

"NGOCC in collaboration with other Civil Society Organisations are petitioning the Head of State to immediately constitute an Independent Commission of Inquiry. NGOCC and other organizations are of the view that constituting an Independent Commission of Inquiry will help to settle this matter since it was already dealt with by the Anti-Corruption Commission (ACC) and the Zambia Public Procurement Authority (ZPPA), who cleared the tender process. It is important, therefore, that an Independent Commission of Inquiry is constituted to, among others things, provide the following: 1. An independent and expert opinion over the transparency and integrity of the tender processes, 2. Comparative cost findings of the 42 Fire Tenders at \$42 million, taking into account the specifications, 3. Where wrong-doing is found, recommend prosecutions of those found wanting, 4. Any other recommendations that may

arise therefrom," she stated. "It is NGOCC's contention that any reckless expenditure of public resources and more so reports of corruption, precludes meaningful women's and girls' empowerment programs. It is also a fact that resources sipping through Government treasury into private corrupt hands are robbing the nation of the needed resources to invest in empowering social services like sexual reproductive health, curbing of gender based violence. Other critical empowerment interventions like building of educational boarding hostels for girls, broadening access to agricultural inputs for female farmers all lay in jeopardy when corruption is left to reign. Therefore, on behalf of the women's movement, we join other progressive voices in demanding for action against this particular transaction by the named suppliers and all other entities involved."

She stated that it was irresponsible to intimidate citizens with arrests.

"The Zambian people are demanding answers on this transaction and it is insensitive and irresponsible for the State to seek to intimidate citizens by arrests. The intimidation will not wash away the anger of the citizens on this indiscriminate expenditure at a critical moment when the country is expected to be implementing a stringent economic recovery plan and exercising highest levels of financial prudence. We, therefore, reiterate our call for the law enforcement agencies to exercise restraint and allow the citizenry to exercise their right to holding Government to account. As the focal point of the women's movement we expect Government to rise to the occasion and show leadership on this matter," stated Longwe.

Others who have called for an independent inquiry are Young African Leaders Initiative and NAREP leader Elias Chipimo.

He stated that the accident involved a Mitsubishi Canter that was driven by Musaka Macnel, aged 34 of Swift Construction Site.

"Whilst driving a motor vehicle Mitsubishi Canter reg contained truck reg number ADD 2674 on the said road with over 50 soccer fans on board after watching a local match, Musaka lost control causing the container to blow off forcing the said passengers to fall off the said vehicle. Due to impact, 34 male passengers sustained serious injuries and are admitted to St Dorothy awaiting to transferred to Solwezi," Daka stated. He stated that the driver would be charged with causing death by dangerous driving as one of the passengers had died.

"The accident happened when the driver was driving at high speed and lost control as he was trying to make a turn to the left and careered off road. He will be charged for causing death by dangerous driving following the death of one m/passenger Kenny Shefilundi aged 26 today 02/10/17 while 19 others still in Solwezi hospital," Daka stated.

procedure)? a charged Hichilema said.

He described Housing and Infrastructure Development Minister Ronald Chitotela as a knowledge-limited minister for defending the \$1.2 billion-dollar Ndola-Lusaka dual carriageway project.

"I think today we have contextualized this debate on how much money is being stolen from your pockets because the debt that they are acquiring, nindalama zanu (its your money). So I think we have made the point loud and clear, at minimum they are stealing \$3 million, at maximum they are stealing \$3.350 million dollars on the Lusaka-Ndola dual carriageway road project," Hichilema said. "The other day I was watching Chitotela on news and I said 'how can this guy be so limited in knowledge?' and he was arguing that what they were saying is true because they were constructing curves, now am told they are building hotels along the road between Lusaka and Ndola. Who tells you that hotels are constructed by government while doing a road? Its a private sector job, they are the ones who identify the opportunities and in the tourism business. We operate the largest tourism business in this country in case you don't know with the largest employer in the sector, single employer. We know what we are talking about. There is no business to construct a hotel between Lusaka and Ndola, it doesn't exist. There is no business along that road to justify that expenditure."

He said that his party would also conduct some peaceful demonstrations when need arise. "We shall be going to court, we are already drawing out court papers now, to stop certain things. If the Judiciary stands in our way, we will ask for those elements of the judiciary to be removed from the judiciary. If they don't get removed, we will remove them sooner or later. Because it means they are supportive of the PF corruption isn't it? We should demonstrate peacefully when we think its necessary the way Laura Miti and our other colleagues did it," Hichilema said. He further commended the 57 UPND and independent members of parliament for petitioning Speaker of the National Assembly Dr Patrick Matibini to appoint a select committee to investigate the procurement of fire. "Our Members of parliament have put a request to the speaker of the national assembly to constitute a select committee, they did this on the 29th of September. We asked them to do speaker to set up a select committee to investigate the scourge, the cancer of corruption one amongst others, on the fire tenders, and on the Lusaka, Ndola road. And we expect that the speaker will act correctly, he should act correctly," said HH.

Meanwhile People's party president Mike Mulongoti said the former Minister of Local Government [Stephen Kampyongo] escaped the fire tender deal after realizing that it was going to hurt his integrity.

of fire tenders], there must be thorough investigations. What I know is that there are indications that ACC had undertaken preliminary investigations and announced that the procedure was clean. But if there is further engagement and people have information, it is the duty for those who are alleging to furnish the security agencies with the necessary information that will bring to book the culprits and any form of corruption. Moving forward, there is a clear road map that has been pronounced by the Minister of Finance to fix the law so that we are able to put measures not only to do with fire tenders but across the board that when government is seeking for goods and services, there will be a defined way through which the goods and services will be undertaken and put a bench mark in terms of pricing," he said. Meanwhile, Nakacinda said the 2018 budget, which was presented by their president Mutati, was promising. "The 2018 budget seems to be promising now that we are going to begin a stabilization and growth program for our economy. More money has been allocated to social services, social cash transfer, agriculture, health and education. We are now getting in the direction where we are going to undertake economic activities that will be beneficial in the day to day livelihood of Zambians," said Nakacinda.

I can assure you that something went wrong in this fire tender. But along the way, you will discover that many other people have benefited from this deal. So there is a lot more that we are going to discover, lt's not panic, the matter is going very well. Am sure we will get to the bottom of this and am sure we will all be happy in the end," said Mulongoti.

Suspend Kampyongo and set up fire-tender inquiry **YALI tells President Lungu**

The Young African Leaders Initiative says President Edgar Lungu must suspend Stephen Kampyongo from Cabinet and set up an inquiry to probe the purchase of fire tenders.

In a statement issued today, YALI president Andrew Ntewewe stated that President Lungu's lukewarm approach to addressing the fraudulent transaction was worrisome.

"We urge President Lungu to take firm action now and demonstrate his willingness to take on the very real challenge posed by corruption. YALI no longer considers it sufficient for the President to refer the matter to his failing 'investigative wings'; the president himself must take the first steps by: 1. Suspending Mr Stephen Kampyongo from Cabinet. Mr Kampyongo was minister responsible for this procurement as minister of Local Government and Housing at the time; 2. Suspending the Permanent Secretary at the ministry of Local Government and Housing at the material time; 3. Suspending the CEO of the Zambia Public Procurement Authority at the time; and 4. Appoint

the Honourable Chief Justice to head a timebound Commission of Inquiry with a clear mandate to get to the bottom of this scandal

YALI will take other steps if the President fails to act," Ntewewe stated.

"YALI is challenging the President, His Excellency Edgar Chagwa Lungu, to establish the facts in the obviously corrupt procurement of 42 fire engines by the Ministry of Local Government and Housing in 2016. YALI further calls upon the President to set up a commission of inquiry to be headed by the Chief Justice since it appears that our own Anti-Corruption Commission is lacking in terms of both the will and expertise to follow the financial trail and inform the public as to who the beneficiaries were in the US\$42 million firegate scandal. It is quite obvious that the claimed purchase price of US\$1 million per truck is patently false, fraudulent and calls for those involved in this corrupt transaction, to face the law."

He stated that the ACC had left many questions unanswered.

"The revelation by Anti-Corruption Commission that it closed its investigations after they arrived at a conclusion that processes and procedures were followed in the award of the tender for the 42 fire trucks, does not answer the question as to whether the claimed purchase price was genuine, and if not, whether the Commission had financial investigators competent enough to follow the money trail and establish culpability. One doesn't need to be a rocket scientist to understand that the ACC is either incapacitated or compromised to follow the money trail in this \$42m fire trucks scandal," Ntewewe stated.

"YALI calls on President Lungu to move out of his comfort zone and show loyalty to the citizens of this country, who put him in office, instead of a few individuals to whom he may feel indebted in his position as PF party president. The President must therefore establish the facts and bring the culprits to book regardless of what they may have done for him within PF; His lukewarm attitude and approach in addressing this very serious matter, is a matter of grave concern to YALI and to all Zambians con-

Further, we remind the ACC that the president of the Forum for Democracy and Development, Madam Edith Nawakwi, as far back as 20th January 2016, raised this issue in which she accused a certain party of "pocketing US\$30m" from this transaction. The ACC took its usual lukewarm approach and the matter went unattended."

"I am encouraging my colleagues because when a lie is told, you decide to keep quiet, others will think it is true and I am glad that you asked me what was presumably said by Kambwili, I am glad that you called me and the way I am responding, it is not bragging but I want to clarify because I am not a thief so if they mention you that you stole, or you built a house and you remain quiet, it is like you are confirming but if you know you are innocent, challenge those who are telling lies," Phiri said.

Phiri, who was reacting to allegations that she built an eight bed roomed mansion within three months, said she could only speak for herself. "Those allegations [of corruption] started some time back. Have you ever heard me come and defend anybody? No. I have come because today I have been mentioned and I know myself, I cannot speak for others umutwe uwamunobe chalo cimbi (your friend's mind is another world)," she said.

"For the President, I understand he is not like Mumbi Phiri, Mumbi Phiri has no immunity, I can take you Kunda Kunda to the courts of law, there cannot be gualms about it, for the President, what surrounds the Presidency, it is difficult for him to defend himself. Even if his character is assassinated, he cannot take you as a citizen to court. 'There has been no drop in the personal income tax rate, there has been no drop in the corporate tax rates, but instead a number of few taxes have been increased. Some excise duty has increased, some custom duties have increased but I suppose that is in line with the fact that the minister announced that he would like debts to be contained and there will be less expenditure, less borrowing. I suppose he had no option than to increase the amount of taxes and not give too much tax relief to you and me," Kazilimani said. "I think as a firm, for our cli-

ents, we noted a few things that will affect a number of our clients. One is the scraping of the five-year tax holiday. So some companies that got that exemption from Zambia Development Agency will probably suffer. However, there is some capital allowances which will sort of help them. Then as a nation when you look at the issue of debts, the major pronouncement made today by the minister, is that going forward he is going to introduce legislation to repeal the existing laws and guarantees Act and introduce a legislature which will compel parliament to approve any further borrowings. This will strengthen financial managements because before any borrowing is done, it has to go through parliament. That will help the country in that, it will put a stop and more checks

and balances in terms of debt management." Kazilimani said the creation

of infrastructure development fund was key in implementing various projects in the country.

"The creation of the infrastructure development fund as announced by the minister is very key. The downside is that, in order to fund that infrastructure development fund some materials will go up. For example the minister said he is going to introduce a K2 excise duty for every 50kg bag of cement which means that the cost of construction will go up. In the long run, creating an infrastructure development fund can only be good for the country and will help support various infrastructure projects that he was talking about," he said. There are times that government security agencies may be called to arms but we maintain that violence is almost always self-defeating. It breeds more violence

from the victims. Therefore, government focus should not be use of brute force against its citizens but work towards ending poverty, and eliminating the root causes of petty crimes in that neighbourhood," Sinkamba added.

"We urge President Lungu to immediately cease fire in Chibolya. We also urge him to revoke the State of Threatened Emergency so as to end the spree of arrests and use of brute force that has characterized Chibolya and created anguish, fear and uncertainty across the township. Perpetrating atrocities under the guise of the State of Threatened Emergency and trampling people's rights is wrong and must end."

Meanwhile Mwamba who remained silent as group members reacted to his posting, resurfaced early this morning defending the POA.

"I shared a forwarded link yesterday with attached comments. The link was not mine neither were the comments. But my views on the Public Order Act is that; it's totally necessary for maintenance of law and public Order. In South Africa, you require to deposit a notice of 3-7days prior to the picket, procession or demonstration. Although our POA is a colonial legacy enacted in 1935, with amendments in 1958 and others, our POA underwent fundamental changes in the Christine Mulundika Supreme Court ruling that relegated the issue of permission to a mere Notice. But be aware that it also requires that the event be policed (by Police or Marshals or both). It also has an internal appeal process upto the Minister, a process that was not available before," High Commissioner Mwamba responded. Mwamba further charged that police did not deny Miti's request to demonstrate but they simply had no man power to manage the procession.

"In the case of Laura's procession or picket, when Police said they had no man power to manage the procession, she had options, (1) To appeal the decision, (2) To propose her own marshals, (3) Stage the picket on any other proposed day as advised by the Police. The Police DID NOT deny the request for her demo She did none of the above but her and her group chose to ignore or defy the law or instructions . (Someone even praised her that bad laws should be disobeyed quoting Nelson Mandela). The presence of the POA is not anachronistic or the absence of Freedoms, or the erosion of democracy. To my knowledge all countries have a law or regulations that maintains public order and balances freedoms with public order and responsibilities. Show me a democratic country that does NOT have a POA (by whatever name!) debated Mwamba.

"We, as the Green Party, would like to caution the Police and other security agencies involved in the on-going brutal operation in Chibolya to desist exposing innocent people of Chibolya to brute force under the guise of State of Threatened Emergency. It is now clear that the State is abusing the emergency powers. There is no situation of threatened emergency in Chibolya to warrant such abuse of human rights of residents with impunity. 15 badly injured as bus overturns in high speed traffic police chase

Over 15 people have been seriously injured after a bus which was being chased by a traffic officer on a motorbike overturned in Lusaka's Villa Elizabetha area.

Some of the victims told News Diggers! at the University Teaching hospital that the accident happened around 11:00 hours.

A victim who only wanted to be identified as Ann, said the traffic officer ran away when the accident happened.

"The small bus was coming from Villa Elizabetha with a honda for the police chasing them. So instead of giving way at a junction, the small bus ended up hitting into the big bus and over turned. The Rosa bus hit into a wall fence but at least not too many people from the big bus have serous injuries. I saw the officer just turned around and ran away very fast," Ann, a victim, narrated.

Another victim said she feared that some of the victims would not make it.

"That other man I don't know if he will make it. There was just so much blood and I am very confused. For me it's just some bruises and some pains but my sister is in bad shape. I can't even look at her, blood all over the place. She is going into theater," said another victim.

Police Spokesperson Esther Mwaata Katongo also confirmed the accident

in a statement but did not mention the traffic police officer.

"There was a serious RTA which occurred today at arround 11:30 hrs at Chishango-Nchoncho road junction involving male Ivin Phiri aged 47 yrs who sustained serious driving a Mitsubishi Rosa ALF7498. Also involved was male Emmanuel Kawelele driving a Toyota Hiace reg ALZ 235. 19 people from the two vehicles sustained various injuries," stated Katongo.

"The accident occurred when the driver of the Toyota Hiace failed to give way to the Mitsubishi Rosa which later hit into a wall fence for NGOCC damaging it partially. No one has died in the accident."

Deadliest shooting in US history leaves over 58 dead, 500 injured at Las Vegas concert



A video showed the terrifying aftermath as the injured lay on stretchers or on the ground with responders and bystanders surrounding them to give aid.

More than 58 people were killed and over 500 injured when a lone gunman opened fire from a perch high up in the Mandalay Bay Resort and Casino in Las Vegas Sunday night, police said, making it the deadliest shooting in modern U.S. history.

The "nonstop gunfire," according to one witness, sent bystanders outside the resort on the Vegas strip ducking for cover and scrambling for their lives. Tourists hid in their hotel rooms and flights headed into the McCarran International Airport were held elsewhere.

Bystanders sprang into action, caring for the wounded and at least one described someone dying in their arms. Police said a Las Vegas police officer who was off-duty attending the concert is among the dead.

One video showed the terrifying aftermath as the injured lay on stretchers or on the ground with responders and bystanders surrounding them to give aid. Bystanders made makeshift stretchers out of police barricades, plugged wounds with their hands and used their clothing to try to stanch the bleed-

gave a window into the chaos that ensued, with some thinking that fireworks were going off. The final night of the Route 91 Harvest Music Festival was taking place across the street from Mandalay Bay. Jason Aldean was the night's headliner; other performers included country stars Jake Owen, Big & Rich, Luke Combs and Dylan Scott. In the wake of the shooting, the Las Vegas Police Depart-

ment said the suspected gunman, who was believed to be a local resident, was on 32nd floor of Mandalay Bay hotel. Police responded to the scene, engaged him and he is now dead. Law enforcement officials identified the suspect as 64-year-old Stephen Paddock.

Authorities were looking for a companion of the shooter,

"We're confident -- but not 100 percent sure -- we have located the female person of interest."

"We were just at the concert there, and Jason Aldean was playing," one of the concertgoers, named Mike Cronk, 48, a retired teacher, told ABC News. "Kind of sounded like some fireworks going off. I think there was the first buddy's like, 'I just got hit, you know.' He got hit three times. Then people started diving for the ground. And it just continued.

"It was pretty much chaotic," Cronk continued. "Lots of people got hit. ... It took a while to get him out. We had to get him over the fence and hiding under the stage for a while, you know, to be safe. And, finally, we had to move him because he had three chest wounds."

Cronk said his group were finally able to track down an ambulance "and basically the one guy ended up dying in my arms because he was bleeding," he said. "And my buddy got in there. We got three more people in the ambulance. ... But I just got a message from my buddy -and he's going to be okay."

As bursts of gunfire crackled in the air, people outside of the casino ducked and screamed, according to video filmed by witnesses.

"We're going to get trampled if we don't go," a bystander could be heard saying in a dramatic video of the incident. Confusion appeared to abound as those outside fled the scene with another person saying, "it's fireworks." Michelle Leonard, who was located in a booth near the main entrance of the arena, said the shooting just "kept going nonstop." Leonard said "mass confusion" unfolded as people tried to flee the scene. She said the shooting seemed like it went on for more than a minute. "I had no idea of where it was coming from or where to run to," Leonard said. She said she injured her leg as she tried to escape. Another witness, Jake Freeman, said he was standing on the rooftop of a nearby hotel when the shooting broke out. "I had a bird's-eye view" of the shooting, Freeman said in a phone interview with ABC News. He said he saw "crowds of people running" as people "dropped to the ground."

"At the moment we didn't realize that they were being shot," he said.

Aldean, who performed at the country concert Sunday night, wrote on Instagram, "Tonight has been beyond horrific. I still dont know what to say but wanted to let everyone know that Me and my Crew are safe. My Thoughts and prayers go out to everyone involved tonight. It hurts my heart that this would happen to anyone who was just coming out to enjoy what should have been a fun night."

An official with McCarran International Airport said "an airport perimeter fence near the concert venue was breached by people fleeing the scene of the incident."

"Airport staff responded and have transported those people to the designated evacuation site," the officials said. "The fence line is once again secured."

Flights in and out of the Mc-Carran International Airport in Las Vegas were temporarily halted due to the incident. ATF agents have responded to the scene and the FBI is assisting with the investigation. The FBI is also supporting lo-

The resort said in a statement that "law enforcement requested that we put hotels in the vicinity on lockdown to ensure guest safety."

President Donald Trump tweeted, "My warmest condolences and sympathies to the victims and families of the terrible Las Vegas shooting. God bless you!" Nevada Gov. Brian Sandoval tweeted, "A tragic & heinous act of violence has shaken the

act of violence has shaken the #Nevada family. Our prayers are w/ the victims & all affected by this act of cowardice." *ABC News.*

The brutal force which our police service has continued to use in their clampdown on drugs in Lusaka's Chibolya compound is a source of concern. Yes, Chibolya is a drug haven and many youths there smoke marijuana for pleasure and whatever other Rastafarian reasons. But there are also a lot of innocent citizens who reside in Chibolya who have never smoked a joint before. They reside in Chibolya by nature of the fact that their parents and forefathers lived in that compound, and their families have not been fortunate enough to migrate to Kabulonga.

That is why we find the mechanism which our police is using to clean the township of drugs, very inconsiderate and against human rights. We have witnessed these night raids which police conduct in Chibolya and the destruction that they leave behind. The operation is done in a manner that you would expect if our security wings were ambushing a terrorist territory, and in a foreign country.

During our coverage of these joint operations, we have seen that when police arrive in Chibolya (usually in the middle of the night) they break into people's homes, shops, bars, shebeens, churches, schools, name it; and they leave unjustifiable collateral damage. During these operations, police officers use the judgment of their eyes to determine if the person they meet is suspicious looking and make a split-second decision to pounce and

Nkosi's Haven was founded by Gail Johnson, Nkosi Johnson's foster mother. Johnson revealed at a press conference with Banderas yesterday that the organisation currently offers care and support to 112 children - 81 of those are orphaned and others live with their mothers. She added that 37 are HIV-positive.

"My running costs are about R480000 a month because we believe in a nutritional diet and we send our kids to school," Johnson explained.

"We have seven different schools that the kids attend, because some have special needs. We have two kids in university. We have a resident therapist and social worker.

"So in the immediacy, any financial help we get goes towards paying off school fees. It means so much," she added.

Banderas will be launching a photographic exhibition called Women in Gold. The exhibition features a series of 22 photographs taken by the 57-year-old actor.

On Thursday night, Banderas will host a gala event in Johannesburg. Photos from Women in Gold will be auctioned off to raise funds for Nkosi's Haven.

"The inspiration behind the exhibition is what I want for my daughter - to be free and independent." Banderas is also in the country to launch a new fragrance, Secret Temptation. Asked about what he finds attractive in a woman, Banderas replied:

O.J. Simpson walks out of Nevada prison after 9 years

(Reuters) - O.J. Simpson, acquitted of the 1994 murder of his ex-wife and her friend after the "Trial of the Century," was released early on Sunday from a prison in Nevada, where he had been held since 2008 for a botched armed robbery at a Las Vegas casino hotel.

The state's Department of Corrections posted a seven-second video on Facebook showing the retired American football star and former actor being released at 12:08 a.m. local time (0708 GMT).

The midnight timing was "to ensure public safety and reduce the potential for incident," the department said in a brief statement that accompanied the video and a photo showing Simpson signing some papers. Simpson's lawyer, Malcolm LaVergne, said by text message on Sunday morning: "All information related to Simpson's whereabouts is confidential until (Monday) at the earliest."

Simpson wore a blue baseball-style cap, blue denim pants and a jacket, and white sneakers as he walked through a door to freedom after prison guard said: "Here you go. Come on out."

Simpson, 70, was granted parole in July after nine years behind bars. At the parole board hearing, there was no mention of his 1990s trial for the murder of his ex-wife Nicole Brown Simpson and a friend, Ron Goldman. Simpson was found not guilty in 1995 following the sensational, 13-month trial in Los Angeles, which was televised live daily and transfixed much of the country.

A civil court jury subsequently found him liable for the deaths and ordered him to pay \$33.5 million in damages to the victims' families, a judgment that remains largely unpaid.

N/Korea negotiations a waste of time - Trump

US President Donald Trump has told his secretary of state that he is wasting his time trying to negotiate with North Korea over its nuclear programme.

"Save your energy Rex, we'll do what has to be done!" Mr Trump tweeted, after it emerged the US had lines of communication with Pyongyang.

Rex Tillerson disclosed the development on Saturday, saying North Korea had little interest in dialogue.

The two countries have engaged in heated rhetoric in recent months.

Inside the world's most secretive country: Where is the war of words heading?

The US wants North Korea to halt its weapons programme, which has seen it perform repeated missile tests, as well as claim to have successfully tested a miniaturised hydrogen bomb which could be loaded on to a long-range missile. But attempts at dialogue seem to be at

odds with President Trump's own attitude to the issue.

On Sunday, he tweeted, in reference

to North Korean leader Kim Jong-un: "I told Rex Tillerson, our wonderful Secretary of State, that he is wasting his time trying to negotiate with Little Rocket Man..."

He did not elaborate on what he means by "we'll do what has to be done".

However a senior US official, asked for clarification later, told Reuters: "At a time when North Korea is continuing its provocations, the president does not think now is the time to negotiate with them."

The official also said the diplomatic channels were mainly used to discuss American citizens detained by Pyongyang.

'Stay tuned'

It is not the first time Donald Trump has sought to contradict top officials within his administration.

In August, he said the US military was "locked and loaded" ready to deal with North Korea, just hours after his defence secretary tried to cool tensions by saying that diplomatic efforts were succeeding.

Rocket to fly people from NY to London in 29min

People will soon be able to fly from city to city within minutes, rocket and car entrepreneur Elon Musk says. Mr Musk made the promise at the International Astronautical Congress (IAC) in Adelaide, Australia.
