NCZ to demolish over 200 Kafue nouses

Nitrogen Chemicals of Zambia has announced that it will soon demolish over 200 houses in Kafue's Flash Butt area which have allegedly been built on its land.

NCZ Chief Executive Officer Banda revealed this Zuze when UPND Kafue Member of Parliament Miriam Chonya and District Commissioner Joseph Kamana toured the fertilizer manufacturing company.

He said NCZ had on several occasions warned the developers to stop building on the land but that the waring was ignored.

Mwanza who is Forum for Democracy and Development spokesperson said this when he featured on the 'Podium' on Radio Maria (Yatsani) today.

"The dissolution of union activities at the University of Zambia is totally illegal because if you look at the university act as revised in 1992, the minister of education has no legal right whatsoever to dissolve union activities. So what the minister has done is unilateral, bilaterally, illegal and unacceptable. I'm happy that the Zambia National Students Union has taken this matter to court because there is need to put the minister in the right perspective. Last year, when 8,000 students were initially banned from writing their exams because they had not completed paying their fees, the minister's response on this issue, was that 'she is not the minister of UNZA, she is the minister of higher education," he observed. "I want to make a very passionate appeal to his excellency President Edgar Lungu that the minister of higher education is not serving her duty. If she cannot be concerned with what is going on at the University of Zambia then she doesn't deserve to be the minister of higher education because UNZA is the highest education institution in the land. She can do well to go back to Tasintha, she did a fantastic job there and that is were she belongs.

She is tired."

And Mwanza said he couldn't believe his ears when he heard the UNZA public relations manager saying the institution was not meant for poor people.

"I couldn't believe that the public relations manager for UNZA could say that the university is not for the poor. This is the guy who got educated on free education. lomba apunzila, ali nama degrees, ayenza vima motoka vikulu (he has been educated, has degrees, driving big cars) and he comes back and says we should stop this thinking that the University of Zambia is for poor people, this is the university for everyone'. He doesn't even understand why the university was built. It was not built for rich people. We have private universities and the rich people take their rich kids to those universities. UNZA is a public university. How many people in Bauleni can afford to take their child to UNZA if the fees are K40,000 per year? The numbers are very low," Mwanza observed. He said that it is unfortunate that government only listened to the plight of students when they demonstrated.

time that government responds to students plight is when they go to the road side which is very unfortunate. The students needs to be paid their meal allowances but the question is why is government failing to pay them? Are they waiting for them to demonstrate before they pay them. The students will never riot if they are paid their meal allowances. And I tell you that because I have made a lot of demonstrations at UNZA. I used to be in the fore front of the protests. We do not need riots, we want government to simply pay the

working poor? What is development if every building in Zambia is about shopping malls selling South African clothes and potatoes? When you have a family of people who are uneducated, you reduce the ability to have income generating activities therefore creating more problems for the family. So the entire generation will have uneducated people. So as we are now, we are creating a society of uneducated people which is a danger as no country has ever developed by having a majority citizens who have been denied

we have decided to erect this wall fence to prevent thefts. One other thing I want to bring to your attention is that NCZ will soon demolish all houses in this area (Flash Butt) which have been built on our land." Banda said

He added that the land where the illegal developers had built houses was classified as dangerous, as it was an area where pipes carrying hazardous chemicals to the lagoons were passing.

"By law no one should build two kilometers near a pipe carrying dangerous chemicals, and we wonder why these people were allowed to build permanent structures in such a dangerous area. Also it will be very difficult for our cranes to access the area where pipes are in case we want to work on them because people have built houses less than two

"I can tell you that riots must be condemned in the strongest form because damage of property is criminal and should not be accepted. But demonstrations at the University of Zambia is the only language that works. The only students what they owe," Mwanza said.

He said from the cost of one fire tender, government would have educated 1,000 students.

"Education cannot be a preserve of only the rich, it should be for everybody. If you get just one wheelbarrow (fire tender) which cost \$1million, as honourable [Lucky] Mulusa calls them, you will be able to sponsor not less than 1,000 students from grade one up to university level. So the money is there, the challenge is where the money is put. There is a lot of wasteful expenditure. We have the budget to which 52 percent of it will go towards administrative costs and only 48 percent will go to issues of development. In short what we have is a budget to pay salaries for people, we don't have a budget for development. What is development if the majority of the working people are classified as the education," Mwanza said.

"The quality of education at UNZA has been compromised because there is a critical shortfall of human resources. The only time lectures are paid is when they riot. We need to remove this corruption that is going on. The University of Zambia used to be a university for the 'Crème de la crème'. Those students with the best points could go to the University of Zambia. But its no longer the case. Its now 'Chipante pante'. Because the university needs the fees to operate, they are collecting almost everyone including those with 28 points as long as long as they are able to pay for themselves. We can not have the kind of arrangement were quality does not matter but quantity. Management is also siphoning money from students and parents by deliberately over enrolling students and then finding ways and means to fail as many students as possible."

Mulusa will be disciplined - Inonge

By Mukosha Funga Vice-President Inonge Wina says Minister of National Planning and Development Lucky Mulusa will be disciplined for likening the recently procured fire tenders

to wheelbarrows. And Vice-President Wina says only those who work with President Edgar Lungu everyday can appreciate how serious the Head of State is in the fight against corruption.

Vice-President Wina was responding to questions from members of parliament during Vice-President's question time in the House today.

Chimwemwe Independent member of parliament Elias Mwila wanted to know whether government was considering asking Mulusa to resign for breaching Cabinet collective responsibility.

"During the CIMA meeting in Lusaka last week, the Minister of National Planning and Development Lucky Mulusa is quoted to have disparaged the procurement of 42 fire tenders by likening them to wheelbarrows in his own words compared to the ones Liverpool city purchased at the same price. It is the belief of the people of Chimwemwe that Cabinet sat and approved this purchase which we have since welcomed and the minister is bound by the principle of collective responsibility. Now my question is, is the government considering asking the honourable minister to resign for going against the principle of collective responsibility?" asked Mwila. In response, Vice-President Wina said Mulusa's case would be considered under the ministerial code of conduct. "Madam Speaker, I regret that I was not privy to the statement that was made by honourable Mulusa but being what it is and having received some reports regarding the statement that the minister has made, there are certain channels that we use in this government and in the party to discipline our erring ministers or members of parliament. Under the

ministerial code of conduct, this matter will be considered [with] disciplinary measures that government will deem fit to apply in this particular situation, I thank you," Vice-President Wina said.

And Vice-President Wina said people were discrediting the presidency by doubting President Lungu's ability to fight graft.



know the way he is doing things, will agree with me that he is the biggest fighter of corruption. So honorable members, let us be truthful, let us not be in the House to champion causes that may not benefit us. If an individual is aggrieved simply because a contract was not fulfilled, don't agree to be used to champion the cause. We are here to fight corruption at any level. So Madam Speaker, we need to be serious about the fight against corruption. Let us not use it as a scapegoat for political acrimony and political finger pointing."

She said President Lungu had tasked the ACC to investigate the purchase of fire trucks further.

"The fight against corruption is a fight that we should not trivialize as political players. Corruption eats at the fabric of our society or any society for that matter. Corruption impoverishes the poor and benefits the rich. That's why it is very important for this country and the people of Zambia to know that fighting corruption, we should fight corruption together, all of us, whenever we see the head of corruption coming to the surface, let's fight together. As for the fire fighting tenders, the president of this country has implored the ACC to investigate the matter further so that if there are any issues, if there is any evidence that can be brought to the fore, this evidence should be brought to the fore so that it is reexamined, so that those that are found wrong, should be punished," Vice-President Wina said.

"But what we are doing is to use certain cases to target our perceived political enemies. This is trivializing the fight against corruption because if we continue on this road, it means that we are undermining the institutions of governance such as the ACC and other investigative wings of government that should probe these matters and bring the culprits to book. Again, the way we are handling this matter is as though we just want to discredit the administration, [but] that defeats the fight against corruption because when you have evidence, take it to the rightful wings of government that will investigate and prosecute the offenders."

Meanwhile, Vice-President Wina revealed that many children trekking to Zambia from the Democratic Republic of Congo were unaccompanied by their parents.

She was responding to a question from Kaputa PF member of parliament Maxas Ng'onga who wanted to know what preparations government had put in place for refugees flocking to Zambia from the DRC.

"The influx of people from DRC has been continuous. Among the asylum seekers is a large number of children who walk all the way from wherever they come from in Congo into Zambia, unaccompanied by their parents. We also have a large number of pregnant women as of last week, the total number was 192 pregnant women who have walked to Zambia to seek asylum. Madam Speaker, this trend of affairs has definitely created a humanitarian crisis in our country. But luckily, the Zambian government through its agencies has mobilised resources to tackle the problem and also the UNHCR, UNICEF, UNFPA and others, together with our Red Cross, DMMU, Ministry of Health, Home Affairs, Defence and others have come together to tackled the situation and I must say that as of now, the situation is under control," said Vice-President Wina.

Simbyakula distances himself from election violence document

Former justice minister Ngosa Simbyakula has disowned an alleged Patriotic Front document detailing how the ruling party planned to use violence, tribal division among other things to win the 2016 elections.

This is in a matter in which UPND lawyer Martha Mushipe was charged with seditious practices for being found in possession of the said document which is entitled 'Strategy of domination by the Patriotic Front against the opposition United Party for National Development 2015 to 2016 and beyond, UPND at crossroads transition or conflict, PF's use of ethnic divide and rule as a means of maintaining political control in Zambia 2015 to 2016 and beyond'.

When the matter came up before Lusaka magistrate Felix Kaoma today, Dr Simbyakula, who is listed as one of the authors of the said document, said it is fake and it was posted by unknown people

Court acquits man accused of defaming Mumbi Phiri

By Mukosha Funga The Lusaka Magistrates' Court has acquitted a 45-year-old man who was accused of defaming PF deputy secretary general Mumbi Phiri in a WhatsApp group. the mobile number for the complainant was neither taken for digital forensics nor did Chief Ins Nyama tender it in evidence. However, the court was told that the alleged defamatory message was apparently deleted from the phone while it was in the custody of Chief Ins Nyama as per her evidence in cross examination. Two mobile phones, 12A and 12B belonging to the accused were produced. However, no defamatory messages were shown to the court from the two phones neither were they subjected to digital forensics. Chief Ins Nyama told the court that the phone allegedly used is said to have been destroyed," magistrate Simaubi said.

be subjected to digital forensic analysis to determine if at all the accused had originated the message complained of and published it on the whatsapp bloc. In this regard, it was the duty of the investigating officer, in this case, Chief Ins Nyama to provide the digital devices for the accused and complainant to be subjected to digital forensic analysis as advised by Nawa. By neglecting to do so, there was a dereliction of duty. This court cannot now be used to remedy this deficiency by placing the accused on his defence so that he fills in the gaps," said magistrate Simaubi. "Therefore, it becomes apparent that investigations into the matter were incomplete in that one essential element that the accused published the matter complained of has not been proved. The consequence being that the prosecution evidence has been so discredited that I, as a reasonable tribunal properly directing myself, cannot convict on it where the accused to remain silent. Further, this court cannot attempt to remedy this failure of the prosecution by placing the accused on his defence so that he supplies what the prosecution could not provide...therefore, I find that a case is not made out against the accused person sufficiently to require him to make a defense and I dismiss the case and acquit him forthwith."

"The document is definitely fake. I didn't author the document I don't even know the names of other authors," said Dr Simbyakula.

He testified that two journalists from Bulletin and Record Magazine, Charles Mafa and David Julian Wightman, had called him over the same document but he told them that it was fake.

Dr Simbyakula said the two journalists told him that that they downloaded the document from the Zambian Watchdog.

And in cross examination, the witness insisted that the document was fake.

Asked as to whether or not what was happening during last year's general election was not collaborative with the strategy outlined in the document, Dr Simbyakula said that it might

She was responding to a question from Mafinga PF member of parliament Jacob Siwale who wanted to know her position on those making corruption allegations without providing evidence.

"The way we are handling the matter [of corruption] is that we are actually undermining the presidency itself because you seem to think that the President is not taking measure to curb some of these matters. The President is at the forefront to instigate ... " Vice-President Wina said but she was interruption by opposition MPs who shouted "Question!" Vice-President Wina continued; "You can question because you are not near him every day but some of us who work with the President and In this matter, Asher Hakantu was accused of posting defamatory words against Phiri in a WhatsApp group called "We need a better Zambia" on unknown dates but between May 6, 2017 and May 8, 2017 in Lusaka.

"With intent to defame Mumbi Phiri, unlawfully did publish a defamatory matter concerning the said person on a WhatsApp bloc namely 'We need a better Zambia', to which you wrote, 'Are you sure she didn't sacrifice the innocent boy for her to come into a political limelight, who knew this finished scrap cargo before she lost her son in Kawambwa School accident. Apusa maningi Mumbi Phiri," read the indictment.

But when the matter came up for ruling on case to answer today, magistrate Nchimunya Simaubi set Hakantu free saying the prosecution team had failed to prove a case against him.

"It is alleged that the accused published defamatory matter via a whatsapp bloc against one Josephine Chilufya Mumbi Phiri. The evidence on record shows that "PW3, Joel Nawa told the court in cross examination that his report or findings are useless without digital forensics being subjected on the sending and receiving devices. He was categoric that anyone could have made the Facebook account for Asher Hakantu and not necessarily himself."

Magistrate Simaubi said it would not be right to place Hakantu on his defence so that he could fill in the blanks for the prosecution team which conducted incomplete investigations.

"Therefore, it was critical to the prosecution for the digital devices to

have been a coincidence.

He however confirmed to the court that the two journalists had in their possession the document as they downloaded it from internet.

Dr Simbyakula said that he didn't manage to check the site where the document was as he is not a fan of online publications that propagated false stories as they could end up stressing him. He said the phenomenon of false news was a danger to society.

Dr Simbyakula also said he was not sure whether the Public Order Act was applied fairly during the last election.

Mushipe is alleged to have been in possession of seditious material between July 1, 2015 and April 11, 2016 in Lusaka jointly and whilst acting together with other unknown persons and without lawful excuse.

The document was authored by Tendai Muduli, Dr Simbyakula and Dymus Mutasa.

MP pins Mabumba on Iow fuel prices during elections

Senanga Central UPND member of parliament Mukumbuta Mulowa this morning asked Minister of Energy David Mabumba to tell the nation what magic he used to keep fuel prices low during elections.

Mabumba then struggled to address the question, going into technicalities of why subsidies were removed but Deputy Speaker of the National Assembly told him not to stress himself too much but to answer the simple question of whether there was magic involved.

"Honourable minister, I appreciate your statement. There are a number of factors attributed to the fuel adjustments whether down wards or upwards. Now Madam Speaker, through you, I have observed with deep sorrow, pain and humiliation that when we are heading towards the elections, these factors, they seem not to come at play. What magic does this government use when we are heading towards elections to reduce fuel prices which cannot come into play now when we are four years towards the elections?" Mulowa asked Mabumba after he justified the fuel increment in a ministerial statement.

In response, Mabumba began to explain why fuel subsidies were removed. "Madam Speaker, I want to refer my colleague to the same report which was submitted on the floor of this August House by your committee on estimates. The committee, Madam Speaker in the report also noted that extensive consultations and discussions were undertaken in 2012 with a review of removing the fuel subsidies, and last Madam Speaker, the decision was not made. In 2014 also, there were consultations also held unfortunately there was no decision that was taken and this is why Madam Speaker, after the elections of 2016 government took a bold decision going forward that we need to gradually migrate our pricing of our

petroleum products to costly reflectivity, which means having to adjust them within 60 days depending on the performance of our kwacha as well as the global oil market prices and Madam Speaker from my report if my honourable colleague heard I have here, on page three in my report where I showed the movement in terms of petroleum product...," Mabumba said before Namugala interrupted him. "Honourable minister you are stressing yourself unnecessarily. The question is what magic? It was very straight forward, what magic the government uses, if there is no magic say so, if there is magic, let the honourable members know," said Namugala.

Mabumba then told the

House that there was no magic involved.

"Madam Speaker, in terms of my summary there is no magic because in terms of what I have provided from last year, we have reviewed fuel by six times according to the performance of the kwacha as well as the international market of prices. Thank you Madam Speaker," said Mabumba.

"So we have invoked the Public Health Act to stop any public gathering in Kanyama for public health reasons and the Ministry of Home Affairs has been advised accordingly. Cholera is a none partisan issue, this is not a time to look at who belongs to which party. That is why we have not told the UPND that 'you are banned', ... but we are saying it is none negotiable. There shall be no mass gathering in Kanyama" When asked if he would advise Independence Day celebrations not to go ahead at the Lusaka Freedom statue considering that some members of the public would be coming from Kanyama, Chilufya said there was no cholera at the Freedom Stature.

"Let me emphasise that mass gatherings have been banned in placed that are infected with cholera and Kanyama is the epicentre, so the Freedom Statue is not part of Kanyama... we have not seen it as an immediate need to close schools. If we see any disposing factors, we are going to act accordingly. And we must distinguish a mass public rally that brings people from outside Kanyama. We must distinguish congregate meetings within Kanyama and in what quantum and we must distinguish a mass crowed that we would be expecting at a rally of that stature. We cannot put the whole country at risk," said Chilufya.

Debating the estimates of revenue and expenditure for the year 1st January, 2018 to 31st December, 2018 for State House, Kambwili said he was sick and tired of Chanda and Zulu's behaviours, noting that Zulu had become a de facto president.

"Mr Speaker, today the integrity of State House is at stake and unless we do something about it Zambia will not be taken seriously, today the integrity of State House is at stake. "I am beginning to wonder these days to whether this is the first administration since independence that we have certain positions at State House because some of the positions at State House, we never even used to hear about them because these are people that operate in the background to support the President but today, people who work at State House want to be involved in everything in the country from political rallies to procurements, mention it! I mean how would we be appropriating money to State House when a political adviser to the

President is always seen at meetings for a particular political party?...Let those people that are working in the office of the president do their job at State House. You know sometimes I tend to wonder wherever the president goes, all the advisers to the president are the ones who are even taking the front roll seats even at public rallies, I don't remember when I saw Dr [Kenneth] Kaunda's adviser. In any case, I never even knew who Dr Kaunda's political adviser was because I was a very strong UNIP general secretary for student affairs on the Copperbelt. I did not know who Dr Kaunda's political adviser was. Today the political adviser to the President has become like a de facto

Probably what we should suggest is that everybody who is appointed at State House must be declaring their assets and liabilities because it is unacceptable that people we knew as paupers as it were, today can drive all the posh vehicles that you can ever think of just after working for State House for one year. We are losing it as a country, people who we knew as nobodys driving corollas, smoke coming out as if its 'ichimbimbli chamalasha' meaning the process of making charcoal, you know the smoke of charcoal (charcoal furnace)," he said.

"Today when you go on their Facebooks, they advertise their riches, they are running 12-15 companies and when we say we suspect corruption here, we are told give us evidence, what more evidence do you want...some of us have been insulted on Facebook just by actually questioning why a person we knew as a journalist not too long ago can have five to six properties in Lusaka, expensive properties we have been insulted and we are asked to bring evidence. We can only advise that let us clean up some of these issues because these are issues that will bring the integrity of a government, the integrity of a President is at stake." Kambwili said it was unacceptable to have a press aide who wanted to overstretch his mandate by performing ministerial duties as well. "The other issue Mr Chairman is, the press aide for the president is not a minister and he should stick to his job of being a communication officer on behalf of the President, I have never seen in this country, never! Since independence where the press aid to the President can go all over on international media, on Sunday

interviews explaining the policy of government from agriculture, mining everywhere, where on earth? It's never done like that, only in Zambia. It is a duty of the Minister of Information, chief government spokesperson to undertake those errands and not the presidential aide. Why? If a civil servant commits an offence is fired, if anybody an MP commits an office is taken to privileges and is sanctioned why not those presidential aides? Have they got immunity maybe I have never read the constitution properly, I need to go and read this afternoon maybe they have immunity. We are sick and tired of their behavior, if they are not ready to serve the people of Zambia let them resign so that people with integrity can do those jobs at State House...So Mr Chairman I support the estimates of revenue and expenditure to state house but please may the issues that I have raised be dealt with."

The Constitutional Court was inconsistent in its handling of the presidential petition, says the Judicial Complaints Commission.

But the JCC says one act of inconsistency cannot amount to incompetence.

According to the full JCC ruling obtained by News Diggers! and signed by Justice Christopher Mushabati and Justice Geoffrey Simukoko, the ConCourt judges contradicted one another in their decisions.

The JCC ruled that the ConCourt never sat on weekends but counted Saturdays and Sundays when counting 14 days, thereby depriving the petitioners four days within which to be heard.

"In considering this petition the court was duty bound to look at all the provisions of these articles. Sub-Article 101(5) of the Constitution was not outside the Articles under which the petition was brought, that is, it was not a stand alone article from which the presidential election petition was based. So why should the question of filing a formal application to have sub-article 101(5) interpreted arise? We feel the court should have just invited the parties to address it on this issue and so it is our view that there was no need. In fact, the single judge on two occasions or so stated that the court would pronounce itself on the matter," the JCC observed.

"The main issue that attracted a number of complaints is on whether the weekends were to be included or excluded... the court never sat on any of the weekends that fell within

that period. These were 20th, 21st, 27th of August, 2016 thus the 14 days period was reduced by four days... the court must have settled for the first scenario where all excluded days were counted. The court did not however, sit on weekends – Saturdays and Sundays thus denying the parties four days from the time stipulated for the petition, as already observed above."

JCC also stated that the

ConCourt should have given a proper guideline on the 14 days from the very beginning to avoid abruptly ending proceedings.

"We now come to the issue of the court's failure to properly guide the parties on the time frame. The split decisions, made by the court, were rendered without hearing the parties. Admittedly, the majority ruling did state that the court had not considered the concerns raised by the Attorney-General regarding the time frame under Article 101(5) of the Constitution. One of the rules of natural justice demand that both sides must be heard before a decision is made. The parties in this case ought to have been invited to be heard on the "stand" the court had taken... Consistency in decision making is very cardinal especially by superior courts whose decisions will need to be followed by subordinate or

lower courts," the JCC stated. "The court ought to have given clear guidelines on the time frame. It did not do so despite the interpretation of the Article 101(5) of the Constitution. We have already said elsewhere that it was not necessary for a formal application to have that Article interpreted because the 14 day time line was fundamental to the hearing of the presidential petition. Further, we note that from the

"All in all on the complaint that the court had failed to interpret Article 101(5) of the Constitution, we must say that from the various pronouncements of the court on the subject the court must have done so though it did not come out clearly, in that it failed to pronounce itself formally as to when the time frame began running and when it was to end. The Judge President in her response to the complaint on the interpretation of Article 101(5) said that this was addressed in the majority ruling. The majority ruling may have addressed that issue but it is our view that this was done late in the day. It was like shutting the stable door after the horse had bolted. The court should have addressed the issue at the very beginning," the JCC stated.

But the JCC stated that one act of inconsistency did not count as incompetence.

"It shall be noted that from the rulings quoted above, the court kept on changing its own decisions. This change or reversal of decisions amounted to inconsistencies on the part of the court. It was these inconsistencies which prompted the complainant to say the Constitutional Court and the Judiciary were brought into disrepute, ridicule or contempt and that this amounted to incompetence and gross misconduct. We however wish to state that one incidence of inconsistency cannot amount to incompetence let alone an act of gross misconduct by

By Sipilisiwe Ncube Finance Minister Felix Mutati says Zambia needs to reduce its appetite for contracting debts.

And Mutati says the IMF bailout request has not failed, as negotiations were still ongoing.

Speaking in parliament on Thursday when he winded up debate on the 2018 national budget, Mutati said because of the high levels of debt, there was need to focus all the efforts on domestic resource mobilisation.

"On the issue of fiscal consolidation Mr Speaker, we have said and committed that we are going to support measures with legislation in particular. Our commitment is that the public finance Act, the Loans and guarantees Act, and the budget Act should be able to be passed by the end of 2017. We have said, Mr Speaker, that this is our determination to support fiscal consolidation which is important in dealing with the whole issue of debt. Beyond that Mr Speaker, we have also put in measures to tackle the

for borrowing - Felix Mutati debt issues. We published the medium term strategy which is basically focusing on the whole framework of debt. We must focus on finishing ongoing projects before we embark on new ones. And we must reduce our appetite to contract debt. We must also look at other innovative ways of raising finance," Mutati said. "Mr Speaker, we were quiet clear in our presentation of the budget 2018 that the debt levels have elevated and in that budget, we said the answer to

curing debt is (I) to focus our efforts on domestic resource mobilisation. In focusing on that Mr Speaker, we have said that we are going to modernise the Zambia Revenue Authority, ensuring that we improve tax collection methods. Bringing in the automation and ICT and also benchmarking them

to the very best...," Mutati said.

He said government would

create a sinking fund that would assist in dealing with maturities of the Euro Bond. "But also important Mr Speaker, we have said in 2018, we are going to commence the process of creating a sinking fund that is going to assist in parts, to deal with the maturities of the Euro bond when they do mature. We have at the Ministry of Finance, continued to increase the capacity of personnel, particularly in the debt department including raising our ability for the quality of data which is critically important for us to undertake critical debt sustainability analysis. We have said the anchor for any new debt shall be based, Mr Speaker, on debt sustainability. We do not want to lamb-debt to future generation. We think by doing those things Mr speaker, we will begin to address the

critical issue of debt. And as you do that Mr Speaker, you are also answering to the issue of fiscal deficit because they do go hand-in-hand," Mutati said. H argued that that the IMF bailout package was still in the offing.

"Mr Speaker, let me just borrow a common phrase, and this common phrase is called bailout. And let me just make it clear to this August house that this phrase called the bailout has not failed. The IMF bailout has not failed because our program has not vet been taken to the IMF board, thats number one. Number two Mr Speaker, what was taken to the board is called Article 4 surveillance. This is where the staff from IMF carryout an assessment on the economy on its performance, its financial policies, engage with government, engage with parliamentarians etc," Mutati

said.

"Its a routine exercise that is done typically every year. And the outcomes of Article 4, Mr Speaker, we re very very clear. (I) Article 4 recognised that the economic outlook for Zambia is positive; (ii) it also commended the government of Zambia that it has been able to conclude and publish the 7th NDP including the economic stabilisation and growth program; (iii) it also commended the government for taking decisive and bold decision with regard to policy and reforms in particular in agriculture and energy; it also commended (iv) that the social protection has been elevated in 2017. the sticking point was that the debt had elevated."

He said the IMF team would return to Zambia to help his ministry make a debt profile to support growth and avoid Friday October 20, 2017 shocking the economy.

"So when we engage with IMF, they said we needed to determine the new path for the debt and in order to determine a new path, we need information and data which we are working together with them (IMF) and they will be back in a few weeks time so that we can have a debt profile that is based on debt sustainability going forward. We can have a debt profile that not only supports growth but also ensures that we do not shock the economy. Once we have done that Mr Speaker, then we will be able to move forward on this particular issue. Mr Speaker, this, we are determined to do because at the end of the dividends for stability and growth, we will accrue to the ordinary person, the ordinary people of Zambia," Mutati said.

"It is within our responsibility to ensure that we keep the economy in the right direction , ensuring not only stability but growth that is inclusive. And that is why we have emphasised, Mr Speaker, that the theme for 2018 will be 'accelerating fiscal fitness'. Fiscal fitness means that we are going to focus on your domestic revenue collection, fiscal consolidation and ensuring that your fiscal deficit is in check including ensuring that we achieve debt sustainability. That is the direction that we are taking Mr Speaker and we owe it to the people of Zambia to ensure that the economy performs for them."

The Minister said that the 2018 budget credibility would be assisted by passing key legislations that would minimise misappropriation and diversion of funds.

"Mr Speaker, an issue of budget credibility has been raised. Mr Speaker, government remains concerned with the issue of budget credibility and that is why Mr Speaker we are saying in 2018, that this credibility will be assisted by passing key legislation that minimises issues around misappropriation of funds and also diversion of funds. So we will be bringing this legislation to assist us so that we are tighter and tighter in the use of public funds. Mr Speaker, this will also include the public procurement Act," said Mutati. "Mr Speaker as you know, the current Act, the public procurement Act is a compliance based law and simply put it means you have to tick the boxes (I) have you advertised? The answer is either yeas or no, you tick (ii) have people responded? You tick, (iii) have people sat and been able to make a decision? You tick. For the sake of clarity so that we don't bit about the bush, Have you advertised for fire tenders? The answer is yes or no, you tick. The change in the legislation Mr Speaker will focus on the value for money, which means that we are going to benchmark the prices for similar items so that if I buy a ream of stationary in the Ministry of Finance, it should be within 10 percent in the Ministry of Community Development. Otherwise the system rejects. And that is what is called value for money. So all these things that have taken us back will be answered in parts with the revision of the Public Procurement Act."

Wasteful govt expenditure angers CSOs

Thirteen civil society organisations today expressed disgust at the manner in which the PF government has continued to waste public resources on dubious contracts.

And the Civil Society Organisations have demanded that government publishes tender documents for all public projects starting with the fire tender and the Lusaka-Ndola dual carriageway.

Speaking at a joint press briefing today, chief executive officers and representatives ActionAid, CTPD, from Zambia, JCTR, Caritus NGOCC, TIZ, Oxfam, Alliance for Community Action, ZCSD, CSPR, CUTS, SACCORD and EAZ, said Zambia must wake up and demand accountability in the use of public resources. executive director CSPR Patrick Nshindano, who read the statement on behalf of the CSOs, observed that Zambians had remained docile, while government leaders were abusing public resources.

"The problem of rampant abuse of public resources has been worsened by the attitude of not demanding for explanations and justifications on the use of public resources exhibited by most Zambians. This has allowed many leaders to take advantage and abuse public resources," he observed. "Government has defended the purchase claiming the trucks are custom made and deserves the \$1 million per truck tag... Further to this, the construction of the 321km Lusaka-Ndola duo carriageway at the cost of \$1.2 billion has also been disputed by a cross section of society as being too costly, it is suggested that on average, a high standard bituminous road in Zambia costs up to \$1 million per kilometre which translates in \$642 million. At the announced cost of \$1.2 million, the Lusaka Ndola duo carriageway will cost on average \$2 million per kilometre, double the normal cost."

not far fetched to suggest that corruption was involved in the awarding of the two contracts. "As civil society, we believe there are two aspects to this public spending, the first aspect is whether corruption was involved or not, which of course government has dismissed as unfounded including that ACC. The second issue is whether this was the optimum way of spending public resources at a time when the country is just recovering from a very weak economic performance. We are quite convinced that public resources on the two projects have not been prudently and optimally utilised. Was the fire trucks the most priority for Zambia to allow such a huge expenditure to quench fires whose sources we do not even know yet? US\$42 million (approximately K420 million) is more than twice the allocation to Markets and Bus Station (K18 million) in the 2018 budget for the whole year," he said. Nshindano observed that the PF government had continued on a destructive path.

"As civil society we are further concerned by the fact that we never seem to learn as a country and successive governments continue on this destructive path. A similar expenditure was made on hearses and mobile hospitals against public protests. Some of these vehicles have already broken down irrevocably and yet a lot of money was spent that could possibly have been spent in a more prudent and sustainable way. Speed boats that were bought for Chavuma Districts to be used as mobile hospitals to serve communities along the Zambezi River have all broken down parked at the banks of the Zambezi River and no one even talks about them," he said. CSOs challenged The government to publish the tender documents. "We demand the publication of the tender documents for all public projects especially the ones under public outcry which include the fire tenders and the construction of the Lusaka-Ndola dual carriage way as prescribed by law

under the Public Procurement

Act, to promote transparency and accountability. If the procurement was done in public interest its within the rights of citizens to see how the institutions involved arrived at the decision and their considerations," said Nshindano. We further urge government through the ministry of finance to quicken the process of reforms meant to enhance public financial management such as the enactment of the planning and budgeting bill, the revision of the public finance act, the loans and guarantees bill, and the public procurement bill... Lastly, we demand that members of parliament to take more interest in public affairs as representatives of the citizens and provide the necessary oversight as per their mandate and avoid politicking at the expense of the Zambian people. During the question and answer session, ZCSD executive director Lewis Mwape called on Zambians to show their anger over the mismanagement of public

resources.

"The role to demand for accountability must not just be the role of civil society, I think it should be the role of all Zambian people. As civil society organisations, we are appealing to the Zambian people is not to sleep whilst the rats and the monkeys are busy feasting on our produce in the fields. So the Zambian people have a duty. It is also the duty of a citizen to hold the elected leaders accountable," said Mwape. But the comments appear to corroborate what has long been suspected - that there are intense power struggles going on behind the party's image of unity, says the BBC's Michael Bristow.

The claim comes as Mr Xi created his own political ideology, in the latest move to entrench his position in the Communist Party. The party is widely expected to rewrite its constitution to enshrine this theory before congress ends next week.

Malawi cracks down on 'vampire' lynch mobs

Police in the south-east African state of Malawi say they have arrested 140 members of lynch mobs who attacked people suspected of being vampires. At least eight people are believed to have been killed, including two men on Thursday in the second city, Blantyre.

One was set on fire and the other stoned, according to police.

Two others were arrested for threatening to suck people's blood but police say have no medical reports of any actual bloodsucking.

Vigilante mobs started attacking people suspected of drinking human blood as part of magic rituals in September.

James Kaledzera, Malawi's national police spokesperson, told BBC News that police patrols had been stepped up in areas affected.

A curfew has been imposed in parts of the south.

President Peter Mutharika has been visiting parts of the country and has

vowed to investigate the killings. Earlier this month, the UN instructed all staff in parts of the south to move to safer areas.

Many aid agencies and nongovernmental organisations work in Malawi, one of the world's poorest countries,

Educational standards are low, with belief in witchcraft widespread. Vigilante violence linked to vampire rumours also erupted there in 2002. *BBC News*

Tomorrow he should not sav we never told him because he doesn't want to meet us," Mpezeni warned.

For this reason, the paramount chief has vowed never to set foot at State House, saying he doesn't care about the leadership anymore.

"Manje sinizayendako futi. Kuchokela lomba, sinizayendako futi kusogolo kuja chifukwa chuoneka monga nunyengelela... nizao izo, neo niliye nao na nchito! Ndine okalipa maningi. (But now I have decided that I will never go there, no matter what happens because it appears as though I am going there to plead. It's their fault; I don't care about them now. I am very upset," said Mpezeni.

Obama and Bush decry deep US divisions without naming Trump



Former Presidents Barack Obama and George W Bush have voiced concern about the current political climate in the US, in comments seen as a veiled rebuke of Donald Trump's leadership.

Mr Obama urged Americans to reject the politics of "division" and "fear", while Mr Bush criticised "bullying and prejudice" in public life. They were speaking separately. Neither mentioned President Trump by name.

Mr Trump, who has been critical of his two predecessors, is yet to

comment.

Ex-presidents traditionally shy away from commenting publicly on their successors, and Mr Obama said on leaving office he would extend that courtesy for a time to Mr Trump, as George W Bush had to him.

He has broken his silence since to issue statements on Mr Trump's efforts to dismantle Obamacare, as well as his controversial "Muslim ban" and decision to abandon the Paris climate accord.

Speaking at a Democratic campaign event in Newark, themes at another event

New Jersey, Mr Obama said Americans should "send a message to the world that we are rejecting a politics of division, we are rejecting a politics of fear".

He added: "What we can't have is the same old politics of division that we have seen so many times before that dates back centuries.

"Some of the politics we see now, we thought we put that to bed. That's folks looking 50 years back. It's the 21st Century, not the 19th Century. Come on!"

He touched on similar

later in Richmond, Virginia, saying: "We've got folks who are deliberately trying to make folks angry, to demonise people who have different ideas, to get the base all riled up because it provides a short-term tactical advantage." Speaking just hours earlier

in New York, Mr Bush said: "Bigotry seems emboldened. Our politics seems more vulnerable to conspiracy theories and outright fabrication.

"At times it can seem like the forces pulling us apart are stronger than the forces binding us together.

EU rules out involvement in Catalonia crisis

European Council President Donald Tusk has explicitly ruled out any EU action over Catalonia, despite the "concerning" situation.

"There is no room, no space for any kind of mediation or international initiative or action," he said. He was speaking at a joint news conference with EU Commission President Jean-Claude Juncker. Catalans voted to secede in a 1 October referendum, which was outlawed by Spain and has prompted mass demonstrations. Mr Tusk's remarks came hours after Spain said it was beginning the process of imposing direct rule on the autonomous region. "I am of course for many reasons in permanent contact with (Spain's) Prime Minister Mariano Rajoy," Mr Tusk said. "There is no hiding that the situation in Spain is concerning, but our position... is clear." He was speaking ahead of an EU Council summit, but said the issue of Catalonia was "not in our agenda". Other European leaders, including Germany's Angela Merkel and France's

Emmanuel Macron, also threw their support behind Madrid.

Meanwhile, Russian President Vladimir Putin said the crisis exposed Western hypocrisy, which backs some separatist movements but not others

10. Lifestyle Lupita Nyong'o details Weinstein's advances toward her in Op-Ed

Lupita Nyong'o has come forward about her encounters with Harvey Weinstein in an op-ed in the New York Times, writing that not only did Weinstein attempt to ply her with alcohol when she met with him at a restaurant, but after they moved the meeting to his home to watch a film screening, tried to give her a massage. At a later meeting, the Oscar-winning actress wrote Weinstein propositioned her in a hotel restaurant.

According to Nyong'o, she met with Weinstein for the second time — after having initially met him in 2011 at an awards ceremony in Berlin while she was still in school at Yale when he asked her to attend a screening at his home after sharing lunch at a restaurant. When she arrived at the restaurant in Westport, Conn., where Weinstein lived, Nyong'o described Weinstein ordering her a vodka soda and insisting that she drink it.

"Harvey told me that I needed to drink the vodka and diet soda. I informed him that I would not," she wrote. "Why not?' I remember him asking. 'Because I don't like vodka, and I don't like diet soda, and I don't like them together,' I said. 'You are going to drink that,' he insisted. I smiled again and said that I wouldn't. He gave up and called me stubborn. I said, 'I know."

After finishing their meal, she and Weinstein relocated to his home, where Nyong'o was introduced to his domestic staff and children. Nyong'o wrote that she, Weinstein, and his children all began watching the film together. About 15 minutes into the film, however, Weinstein asked her to accompany him outside the room.

"I protested that I wanted to finish the film first, but he insisted I go with him, laying down the law as though I too was one of his children. I did not want another back-and-forth in front of his kids, so I complied and left the room with him. I explained that I really wanted to see the film. He said we'd go back shortly.

"Harvey led me into a bedroom — his bedroom — and announced that he wanted to give me a massage. I thought he was joking at first. He was not. For the first time since I met him, I felt unsafe. I panicked a little and thought quickly to offer to give him one instead: It would allow me to be in control physically, to know exactly where his hands were at all times." Nyong'o wrote that after he removed his shirt and she began giving him a massage, he asked if he could remove his pants. She said she would prefer that he didn't and that it would make her extremely uncomfortable if he did so. Despite her protests, Weinstein got up to remove them, at which point Nyong'o moved toward the door. "I opened the door and stood by the frame. He put his shirt on and again mentioned how stubborn I was," she wrote. "I agreed with an easy laugh, trying to get myself out of the situation safely. I was after all on his premises, and the members of his household, the potential

witnesses, were all (strategically, it seems to me now) in a soundproof room."

Nyong'o wrote that she "didn't quite know" how to process the massage incident, and rationalized it. "I reasoned that it had been inappropriate and uncalled-for, but not overtly sexual. I was entering into a business where the intimate is often professional and so the lines are blurred."

Nyong'o continued that after the encounter, she met up with Weinstein once more, this time accompanied by friends as well as some of Weinstein's colleagues, for dinner and a staged reading of his new Broadway show "Finding Neverland." During this meeting, Nyong'o experienced no untoward attention, and the fact that Weinstein was accompanied by other female actresses made her even more inclined to brush off the previous incident as an awkward encounter.

A couple of months later, Nyong'o wrote, Weinstein invited her to have drinks with him after a screening of "W.E." According to Nyong'o, a male assistant arranged her transportation from the reading to the Tribeca Grill, where she would meet Weinstein for drinks. Although she assumed it would be a group of people, as it had been for the reading, when she arrived at the restaurant, she was informed by a female assistant that it would just be her and Weinstein. The assistant waited with her until Weinstein appeared, at which time she left. "Again he was offended by my nonalcoholic beverage choice but he didn't fight me on it as hard," Nyong'o detailed. "Before the starters arrived, he announced: 'Let's cut to the chase. I have a private room upstairs where we can have the rest of our meal.' I was stunned. I told him I preferred to eat in the restaurant. He told me not to be so naïve. If I wanted to be an actress, then I had to be willing to do this sort of thing. He said he had dated Famous Actress X and Y and look where

that had gotten them." Nyong'o said she was silent as she tried to think of something to say, and eventually declined politely, to which he responded: "You have no idea what you are passing up." Nyong'o replied, "With all due respect, I would not be able to sleep at night if I did what you are asking, so I must pass." At that point, Weinstein's demeanor changed and he said, "Then I guess we are two ships passing in the night." Nyong'o, not having heard the phrase before, asked him what it meant. He explained, and then said, "So we are done here. You can leave." Weinstein and Nyong'o left the restaurant, and Weinstein insisted on paying her cab fare. "Before I got in, I needed to make sure that I had not awakened a beast that would go on to ruin my name and destroy my chances in the business even before I got there," she wrote. "I just want to know that we are good,' I said. 'I don't know about your career, but you'll be fine,' he said. It felt like both a threat and a reassurance at the same time; of what, I couldn't be sure."



The next time she saw him, Nyong'o said, was in 2013 at an after-party for the premiere of "12 Years a Slave." Weinstein found her and commended her for her rapid progress in the industry. "He said he couldn't believe how fast I had gotten to where I was, and that he had treated me so badly in the past. He was ashamed of his actions and he promised to respect me moving forward. I said thank you and left it at that. But I made a quiet promise to myself to never ever work with Harvey Weinstein."

Nyong'o finished by explaining that she had no idea at the time that this behavior from Weinstein was something other women were dealing with as well. The fact that he was one of the first people she'd met in

the industry also prevented her from coming forward sooner, and the fact that no one else seemed to be challenging him. "I wish I had known that there were women in the business I could have talked to. I wish I had known that there were ears to hear me. That justice could be served. There is clearly power in numbers. I thank the women who have spoken up and given me the strength to revisit this unfortunate moment in my past."

She also issued a call to action: "Now that we are speaking, let us never shut up about this kind of thing. I speak up to make certain that this is not the kind of misconduct that deserves a second chance. I speak up to contribute to the end of the conspiracy of silence." Yahoo

Obama's intimate letters to college girlfriend made public

Nine introspective letters former President Barack Obama wrote to his college girlfriend offer a closer look at the former president's formative years as he struggled with identity, loneliness and hopes for the future.

"It seems we will ever want what we cannot have," Obama wrote to Alexandra McNear during a trip to Indonesia in the summer of 1983, when he was confused about his feelings and the nature of their relationship, the New York Times reports. "That's what binds us. That's what keeps us apart." The letters were obtained by Emory University's Stuart A. Rose Manuscript, Archives, and Rare Book Library. The notes were written by Obama to McNear from 1982 to 1984, and document some of Obama's time at Columbia University, his travels to Indonesia, and the early months of his employment at Business International, according to the university Obama began dating McNear while they were both students at Occidental College in Los Angeles, and the long-distance relationship continued after Obama transferred to Columbia University in New York City as a junior. The pair continued to date after they both graduated, but the letters reveal the complexity of their bond. "Their relationship, at the point that we're reading it, is very intellectual and they're clearly struggling with each other," Andra Gillespie, an associate professor of political science at Emory University,

told the Times. "They're both trying to find themselves and they're having tough intellectual conversations with each other." For example, in one letter Obama responds point by point to a previous letter from McNear, who is sorting out complicated emotions.

"I trust you know that I miss you, that my concern for you is as wide as the air, my confidence in you as deep as the sea, my according to the AP.

In another letter, Obama admits he's a bit adrift as he sees friends pursue their paths - one college friend preparing to marry and take over the family business, while a high school pal manages a supermarket and splurges on items including TVs and new cars.

"I must admit large dollops of envy for both groups, my American friends consuming their life in the comfortable mainstream, the foreign friends in the international business world," Obama told McNear. "Caught without a class, a structure, or a tradition to support me, in a sense the choice to take a different path is made for me. "The only way to assuage my feelings of isolation are to absorb all the traditions, classes, make them mine, me theirs. Taken separately, they're unacceptable and untenable." Obama went on to marry wife Michelle in 1992. The pair share two children, Sasha, 16, and 19-year-old Malia. Rosemary Magee, director of the university's library, told the Associated Press that the 30 pages give an in-depth look at the internal battles that shaped Obama. "They tell the journey of a young man who is seeking meaning and purpose in life and direction," she said. Lonzo not backing down from task of revitalizing Lakers

Everyone had come to Staples Center for a celebrated young star in his own Hollywood fairytale, Lonzo Ball's rookie hometown debut. Ball had been tested everywhere, the hounding and physical Patrick Beverley chasing him end-toend behind an overpowering Los Angeles Clippers team.

On this night, it was Beverley limiting Ball to nine rebounds, four assists and three points on 1-of-6 shooting in 29 minutes in the Los Angeles Lakers' 108-92 season-opening loss. So Ball walked into an empty hallway inside Staples Center, cameras approaching his moment of quiet. Ball knows what's on his shoulders now. He looked up and nodded late Thursday night.

"I'll be ready," Ball told The Vertical. "I have to show it in my game, because when we win, people won't talk. But if we lose, people will think it affects me. It's wins and losses for me. We know it's a process." The Lakers' young talent was evident during the NBA Summer League in Las Vegas, an MVP award for Ball and a coming-out tournament for fellow first-round draft pick Kyle Kuzma. The team had left forward Brandon Ingram out of trade discussions in June, and Ingram's summer training showed promise for a strong second season. And yet, Ball understands: This is a process. These Lakers still must gather the team play and continuity that had become contagious in summer league, and strategically must place shooters and pick-and-roll sets around Ball.

In the weeks leading up to the NBA draft, Ball told The Vertical his utmost priorities were his midrange shots - and, most critically, his pick-androll scheming. He had worked to master his pick-and-roll game in July, and these Lakers must find ways to utilize his playmaking when the defensive stops go away and they must score in the half court.

For as much as the Lakers will target major free agents in 2017, the franchise's young core is under thorough inspection. For Lakers coach Luke Walton, the development of Ingram and Ball, Kuzma and Larry Nance Jr. must entail more flashes of brilliance than faint efforts. The Clippers are far more polished and prepared to contend in the Western Conference. Blake Griffin had 29 points, 12 rebounds and three assists and appears primed for his best season yet, without Chris Paul; DeAndre Jordan, Beverley and Milos Teodosic fill every element their roles entail: and the bench has a more confident Wesley Johnson, whom Clippers officials raved about in training camp.

Beverley had come to defend Ball for 94 feet Thursday night and vowed he made it clear to Ball postgame: We are coming. "I told him after the game, man, due to the riff raff ... he's going to get a lot of people coming at him," Beverley said. "He has to be ready for that."

For Ball's introduction to the NBA and its elite class of defenders, there is no one better suited than Beverley, who strutted his first-team All-Defense honor to Ball and to the crowd, and used his arms and legs to elevate the game's physical nature. At times, Beverley tugged on Ball. Other times, he gave him slight shoves and staredowns. Ball's calming presence never allows him to show a mentality shift, but he knows Beverley's tactics had placed his mind to the individual matchup at times. For the Lakers to flourish, they need his pinpoint management of the offense, and Ball knows it.

"I don't want to get into oneon-one battles," Ball told The Vertical. "It's five on five, not me versus him.

"He's going to do what he can, but I have to do what I can to get us wins."

Ball took a side tunnel to meet his family on the Staples Center floor late Thursday, one game down in a rookie season of outside noise and critiques. One of 81, Ball said.
