National Parks department explains implications of suspending hunting permits

By Sipilisiwe Ncube The Department of National Parks in Zambia says government is bound to lose a lot of money or risks being taken to court if it suspends hunting concessions for companies that have signed agreements.

Department Assistant Director for Commercial Services Austin Mwakifwamba also disclosed that the department raised a total of K111 million both in hunting and photographic tourism in the year 2016.

Mwakifwamba said this when he appeared before the Parliamentary Public Accounts Committee (PAC) today, with other controlling officers from the Ministry of Tourism and Arts, led by Permanent Secretary Dr Liya Mutale to respond to issues cited in the latest Auditor general's report. "We raised K111 million in total both in hunting and in photographic tourism. In particular when you look at hunting, we raised about K33 million. Hunting in Zambia takes the three forms, this

is safari hunting which is conducted by foreign clients and these clients come from outside to come and hunt in Zambia for trophy. Specifically it could be the skin, the horns or any part of the body and the charges for this trophy hunting is usually in US dollars," Mwakifwamba said.

"This is done with companies that have got concession agreements with the government where they pay for land user fees which are concession agreements as well as animal fees. So this hunting is continuing because we have got contracts with various companies in Zambia, which if we were to suspend the hunting for any other logistical reasons, we can easily be taken to court and the government is bound to lose a lot of money because we have committed the government that hunting will continue under this form of hunting."

He said hunting was the most form of raising revenue for the department because the fees were high.

"I must mention before this

house that this is the hunting that brings the highest form of revenue because the fees are charged in US dollars and they are basically in two forms. One has to do with concession fees which are user fees for rentals for these hunting blocks and the other form of fees is the animal fees which is charged per animal that is harvested depending on the value of that animal," Mwakifwamba said. Asked how many Zambian companies owned the concession companies, Mwakifwamba could not

state the number but said the companies were owned by Zambians.

"The companies that we engaged to conduct hunting are in all these areas as Zambian owned companies. What we cannot distinguish is because Zambians are of different colour and it is difficult for me chair to establish who is an indigenous Zambian but what I can state before this house is that all these companies are owned by Zambians. And the majority of the share holding of these companies are Zambians," he said.

Meanwhile Solwezi West UPND member of parliament Teddy Kasonso who is also committee member asked for a list of the concessioners so that the committee could investigate with the Patents and Companies Registration Agency (PACRA).

"Yes Chair, I don't want to be caught napping. I just want the officer from the Worldlife Authority to avail this committee with the list of the companies or the concessioneers who are involved in this hunting, trophy hunting he mentioned so that some of us can go to PACRA and investigate who are these Zambians who are involved in this trophy hunting," Kasonso asked.

In his response, Mwakifwamba requested that he and his team be given time to prepare the list which he said would be submitted to the committee the following day.

"The department of national parks is able to provide you with that list but not here, we need a bit of time to go and prepare that list," responded Mwakifwamba.

Kambwili questions ConCourt's failure to cite Mwila for contempt

Chishimba Kambwili says he is wondering why the Constitutional Court has not cited Patriotic Front Secretary General Davies Mwila for contempt after he said the court's ruling on the President's eligibility would not change the PF candidate for 2021.

And Kambwili called on other courageous Zambians to join him in exposing the evils in the PF government, saying a lone voice was not good enough as he could one day "drop dead" and leave the struggle.

Speaking when he featured on Kokoliko FM radio programme in Chingola on Monday, Kambwili who is a rebel PF member of parliament for Roan, noted that Mwila's comments on President Edgar Lungu's eligibility and the Party's decision to endorse him even though the matter was still in Court, was the worst kind of attack the judiciary. And Kambwili said it was

impossible to trust Mwila about anything because he was just a liar who thrived on lies to elevate himself.

"When you look at the Secretary General of PF, Davies Mwila. I used to work with Mwila here on Copperbelt and you all know who Mwila is, the only thing he knows is telling lies, he thrives on lies and deceit to get where he wants to go. There is absolutely no way Mwila can be Secretary General of a party, nangufye iyo party yabalume naba kanshi teti abe Secretary General (even if that political party belonged to a husband and wife, Mwila can't be Secretary General) I am even surprised that he is Secretary of the PF because Mr Sata used to tell us that Mwila is a liar," Kambwili charged. "One day we were seated in a meeting with Mr Sata and the members of parliament were convening to say 'Mr President, Mwila is always bringing confusion' but Mr Sata said 'ine nga shali intungulushi yamano, Mwila bonse imwe nga alimipwisha pantu wabufi elo necho esa mukucita ku office kumvandi nga aisa, kubepafye ubufi (If I were a foolish leader, Mwila would have divided all of you with his lies because when he comes to my office, the only thing he does is tell lies)', ask Mwila and let him to deny this."

He said Mwila attacked the judiciary with impunity.

"Surely, is that a person whom someone who is a reasonable President can appoint as a Secretary General for a Party? The President goes and says 'I am only going up to 2021' but bena ba Mwila baya ati 'no, he (President Lungu) is our sole candidate'. You see, let us even learn to respect the Courts, you can not attack the Courts like that with impunity. I am even surprised that he has not been cited for contempt because that matter of whether President Lungu qualifies to stand or not is still in Court. Now the ruling party which is the party in government goes and issues a statement saying 'whether you like it or not, Lungu is our sole candidate', you are only saying that whether the Court rules in the affirmative or otherwise, he is still our candidate and that's the worst kind of attacking the judiciary with impunity," he said.

"The Problem with Mwila is that even the level of his education is very low so when you have such people as Secretary General, you can't expect to succeed as a President."

Meanwhile, Kambwili regretted that he was the only the person so far in the political scene who was pushing government and the ruling party to work.

"When a President speaks, the whole country is supposed to feel that the President has spoken. Now, from the time Lungu became President,

when did you hear him speak firmly? Because I know Lungu very well even this issue of outsourcing at Mopani it is only after I spoke about it and castigated them in Parliament that we saw Joyce Nonde (Labour minister) and my friend [Christopher] Yaluma coming to Chingola, but if I keep quiet about it then nothing will happen because I am the only person they are scared of now. Once I talk they run but you can not depend on one voice what if I dropped dead today? We are just supposed to be doing the right thing at the right time, all of us. It can not be Chishimba Kambwili always," Kambwili said.

And Kambwili also apologised to the people of Chingola for having convinced them to vote for President Edgar Lungu in

Surveillance cameras will replace traffic police on the roads - Mushimba

Transport and Communications Minister Brian Mushimba says the concession agreement between the RTSA and Intelligent Mobility Solutions (IMS) once implemented, will bring an end to the era of traffic police officers on the roads. In a ministerial statement to Parliament yesterday, Mushimba said the project would also bring about the use of electronic number plates. "This partnership will bring about the following changes in traffic management by integrating the use of electronic number plates, sensors on our roads to detect the presence of traffic waiting at the green light, and thus reduce the time when the green signal is given to an empty road. Trucks will no longer be required to go through weigh bridges because it will be done using electronic weighin sensors. And there will be traffic cameras mounted above our roads to monitor and manage traffic, thereby doing away with traffic police officers," Mushimba said. Mushimba emphasized that the project was at no cost to the

government as the concessionaire would invest everything and later recover his investment after 17 years.

"The project is at no cost to the Government of the Republic of Zambia while the concessionaire will provide among other solutions and services, CCTV cameras on our roads, road signs, vehicle inspection centers, cross-border tolling facilities, electronic number plates, high speed weigh in motion nodes to reduce overloading, and road safety enforcement equipment. These services and infrastructure required were calculated to cost the concessionaire slightly over \$100 million that will be recovered during the 17-year concession period from value added services," he said. He said the concessionaire would also enforce road safety and collect fines from traffic offences while RTSA would retain its core mandate of regulation and collection of tax. "RTSA retains its core mandate of regulation, education and collection of road tax, driver licensing fees and carbon tax. The concessionaire, through RTSA, will enforce road

safety and collect fines from traffic offences such as overloading, over speeding and road user charges for vehicle inspection and registration. The Concessionaire will recover his costs over the course of the seventeen-year project duration through receipts of a portion pegged at 15% on the value-added services. Eighty-five (85%) percent of these collections will be remitted to the Zambian Government Treasury," Mushimba added.

On many occasions, motorists have spent long hours on queues in pursuit of services from RSTA, hence the need for a smart, integrated intelligent traffic management system,' said Mushimba. "The partnership is also intended to reduce the rising incidences of road crashes and fatalities and improve the road safety record of our country. Zambia, as we know, has in the recent past experienced some of the worst accidents that have resulted in the loss of lives of our brothers and sisters on our public roads. You may wish to note that in 2016, over 2,200 people died because of road traffic accidents on our public roads. Though these numbers have reduced by 20% this year compared to last year, the problem is far from being solved yet. These lives lost on the roads were more important to all of us and as Government we cannot sit back and watch so much lives being lost."

Mushimba said that the partnership would also help improve the performance of RTSA on its core mandate.

"Further, the partnership will help improve the performance of RTSA on its core mandate and build capacity in RTSA to use modern methods of law enforcement using electronic systems. This will result in better fine collections as all violations will be recorded and documented. An electronic fine will be processed and synchronized with RTSA and police departments, which will manage and better control all raised fines and its collection processes. Court refuses to resolve UNIP leadership wrangles Diggers Reporter

The Lusaka High Court has dismissed a case in which three expelled UNIP members were seeking a declaration that the top leadership's continued stay in office was illegal, saying the court cannot intervene in "club" matters.

Jarious Chakulunta, Charles Lubasi and Mwansa Musunte wanted the court to rule that UNIP president Tilyenji Kaunda, his vice Njekwa Anamela and secretary general Kenneth Kaira's prolonged stay in office was in violation of the party constitution.

But High Court judge Betty Mungomba refused to make

any declarations sought by the trio as there was no legal basis upon which she could grant the reliefs saying UNIP was a club governed by rules and regulated under the provisions of Societies Act.

Justice Mung'omba said the plaintiffs failed to prove their case on a balance of probability.

She dismissed all the claims for being devoid of merit. The court has also ruled that the plaintiffs had no rights and privileges to participate in

affairs of the party as they were expelled. During trial, Chakulunta testified that the party last held its general congress in 2000 where it ushered in the central committe but the Defendants had continued holding office

even after their mandate ended in 2005. Tilyenji and others contended

that their stay in office was

in line with article 152 of the UNIP constitution thereby urging the court to dismiss the matter.

The Tilyenji was elected as president in 2001 at an extra ordinary council meeting held in Kabwe.

And Zulu said his organization was disappointed with the earlier stance the Attorney General took to represent the former ministers, saying it amounted to abuse of office.

He recalled that the church and other Civil Society Organizations (CSO's) advised the former minister to leave their offices after parliament was dissolved, but they did not listen.

Meanwhile, the Civil Society for Poverty Reduction (CSPR) in Eastern province has also has expressed happiness at the ConCourt's ruling.

CSPR provincial Coordinator, Maxson Nkhoma said the ruling could not have come at a better time than when government needed money to pay farmers who supplied their maize to Food Reverse Agency (FRA). "We are glad with the judgment given by the Constitutional Court. The judgment could have not come at a better time than when government needs money to pay farmers who supplied maize to FRA," Nkhoma said. He further urged all those ministers who stayed in office illegally to respect the judgement and pay the money immediately without any delays. On Friday, the ConCourt maintained that the former ministers must pay back salaries and other emoluments which they accrued by staying in office after Parliament was dissolved before the 2016 elections.

"It is criminal that this culture of [failing to pay retirees] has been perpetuated from the MMD days to date. That retiring in this country is consigning you to the mortuary. So you cannot harvest anything positive from indiscipline. You can't harvest anything positive from factions, he has been beaten to his own game. The army had to take sides between two factions and you must realise that the Zimbabwean army is an establishment from within the ZANU-PF and the problem that they had was that when they realized that Mugabe was about to anoint his wife to take over, the army generals realized

that then we will stop eating, she is going to fire us, so there is nothing like democracy here or whatever, it is self preservation and self interest by the army which then rallied the people to pretend as if this is about Mugabe. It is about who should now be in the forefront to eat,"

Upcoming AU-EU Summit will address political challenges in Africa - Mariani

European Union Ambassador to Zambia Alessandro Mariani says he is confident that the upcoming AU-EU summit will deepen coalitions on global governance issues and address the political challenges that Africa faces.

And Ambassador Mariani time has come for says Zambia to have a clear pace for diversification of energy production by venturing into production of renewable energy. Speaking at a media breakfast ahead of the 5th AU-EU summit to be held in Ivory Coast from November 29-30 in Lusaka today, Ambassador Mariani said the upcoming summit would be built around a number of priorities such as investment, job creation, peace and security among other important matters.

"In this framework, you may have already heard and you will hear more and more about the European investment plan and this is the plan where the EU has already committed €4.1 billion which is expected to be used as a magnet to leverage more resources coming from the private sector and other investors according to the calculations of our expert, there can be a leverage of 1-10 so the €4.1 billion can have the force to attract about 44 billion EU-rentals. These will be used to finance projects either sponsored by the private sector or by the public sector in the African Continent and in the neighbourhood of European Union," Ambassador Mariani said.

the agenda of the "And upcoming summit will be built around a number of priorities such as investment, job creations and peace and security which is an important one. We all know that peace and security is a fundamental element without peace and security, there can be no development in any country so it is extremely important and it will address some of



the political challenges that the African Continent faces. Then at this particular summit which is taking place next week, we expect that our political relations will be strengthened because this dimension is extremely important and likewise, it is important to share our interests, those interests which are mutual to all of us.

Our idea is that we should find ways of helping one another to develop."

And Ambassador Mariani said renewable energy was the future.

"There is no point in discussing job creation if there is no energy supply because any job in terms of manufacturing will require and requires energy to

be available. So I don't want to generally speak in general terms here, I would want every time I make reference to open a bit of window in Zambia and you may want to know that in Zambia when we speak of energizing Africa, European Union is investing altogether, meaning the member states of European Union and European Union

institutions which is more than €550 million," Ambassador Mariani said.

"Now this comes partly from European Union institutions 244 and part to the initiatives that are sponsored by the European Union and most of these investments go into the area of renewable energy because we strongly believe in

the possibility for a country like Zambia to increase it is energy production and level of resilience by having a big diversification in the generation of energy production like hydro and several other sources. But the time has come for Zambia to have a clear pace for the diversification of energy production and the way forward is venture into production of renewable energies because that is the future of energy production globally."

JCC asks Lungu to suspend judge Nkonde

"It is true and of course this is in relation to professional misconduct in the manner he handled the liquidation of The Post. So, a few days ago, the JCC made a recommendation to the President to suspend judge Nkonde because apparently, he refused to answer to allegations that were levelled against him by the shareholders of the Post," the official who sought anonymity explained.

"One of the issues that were raised by The Post shareholders to the JCC were that judge Nkonde was biased towards the provisional liquidator of the company, to the extent that he had time to hear the lawyers representing the provisional liquidator, while he did not take time to hear the parties representing the shareholders." The official said judge Nkonde was also reported for failing to recuse himself, despite having had previous interest in seeing the closure of The Post.

"So the trouble now is that when the JCC sat, it found that the allegations raised against judge Nkonde, if substantiated, were in breach of section 3, section 4(1), section 5(1), section 6(1), and section 2(a) 9(5) and 10(a) of the judicial code of conduct Act number 13 of 1999, as amended by Act number 13 of 2006. This meant that, if proved, the allegations could warrant the removal of judge Nkonde from office.

Again, this is according to the Constitution, I think Article number 143 and Article 144 as amended by Act number 2 of 2016," explained the official. Dr Kalyalya noted that economic growth in the last ten months had been slower than the seven percent projection. "We noted that there is little economic growth to the private sector particularly the productive sectors of the economy. We see that growth is happening but not as strong as we would like it to be. There are also still some risks in the financial stability to the economy in the non-performing loans as we have been indicating still remains high although there has been in recent time some change in direction. We also took account of the fact that economic growth is quiet slow as there is some projected growth this year, nest year, and the year after but still not anywhere in the 7 percent range as seen since 2011 to 2013," Dr Kalyalya said.

And Dr Kalyalya said it was worrying to note that the average nominal lending rates for commercial banks still remained high.

"Yield rates on both Treasury bills and government bonds continued to decline, reflecting increased demand. The weighted average yield rates for Treasury bills and government bonds dropped to 10.6 percent and 17.2 percent in September 2017 from 14.1 percent and 19.9 percent in June 2017, respectively," Dr Kalyalya said.

"Average nominal lending rates for commercial banks remained high, declining only marginally to 25.4 percent Dr Kalvalva also said that deposit rates had gone down.

"Deposit rates (cost of funds) have come down, with the highest interest rates on wholesale deposits declining to 27.0 percent in September from 29.5 percent in June. The savings rate for 180-day deposits for amounts exceeding K20 000 also declined to 9.4 percent from 11.0 percent, whilst the average savings rate for amounts below K100 was virtually unchanged at 1.9 percent," he added.

Meanwhile, Dr Kalyalya, whose term comes to an end in February, said it was an honour to serve as BoZ governor. "Success is not something that one can attribute to an individual, I am just a figure-head here, there are all these colleagues, there are others who are not in the room here who contribute immensely to what you have seen eventually being presented here. So I am very honored for the opportunity to actually serve in this institution," Dr Kalyalya said.

So we will do our part and we will continue to do as our part as Central Bank. As we said, we will not shy away from scrutiny. We have embraced very strongly the issue of evidence base, we make decisions based on the information that we have. So I am proud to have been associated with the institution and the colleagues that I have served with."

Toll fees are too high - Kafue MP

By Mukosha Funga Kafue UPND member of parliament Mirriam Chonya says motorists are suffering because toll fees are too high. Contributing to the debate on the Ministry of Housing and Infrastructure Development budget for 2018 in parliament yesterday, Chonya observed that people who lived in areas where there were toll gates were still crying about the high cost of toll fees.

"Government seems very excited about this new source of funding for various programmes in government, not just road maintenance. However, the people of Kafue, and I believe others where these toll gates are, are still crying about the high cost which they have to meet to pass through these gates. Where we copied this concept from, our colleagues were looking for a longer term funding modality

of generating funds for road maintenance but in our case we seem to be in a hurry to get as much as we can from the citizens so that we are able to fund this [and that]," Chonya said.

She observed that the money which was meant for road maintenance and development was being channeled to other sectors.

"And I hear salaries last month were met partly from this toll gate money but that is just speculation Madam Speaker. In continuing on this, when the people of Kafue queried why some of this money is not going to meeting the township roads, we were told that the policy is that only roads on which the toll gates are mounted are supposed to be maintained. I would want to call for the reform of this policy if that is the case so that the people of Kafue can begin

to see the benefits of passing through these toll gates at such a high cost so that part of that money can go towards maintaining their township roads. I heard the minister here talking about the completion of the L-400 project, Kafue was nowhere in that phase and now we are learning here that phase two has started and most of it has already been implemented and Kafue is not even a priority having

not benefited from the first phase so I would really want to make this compassionate appeal, honorable Minister of Infrastructure Development, to hear the cry," she said.

Chonya also asked government to prioritise construction of houses for teachers.

"We seem to be paying a lot of attention to putting up housing units especially for our men in uniform, that is good for them, they do a good job when you need them but my appeal is that we look at other professions which are equally in need of this infrastructure. Each time the Minister of Infrastructure comes to speak, he is grappling with how to deal with the housing infrastructure for teachers because the efforts in this area are not visible or they are not tangible. So what can the ministry do to help the ministers much more? I am aware that within the ministry, there was a policy that was passed to say when a new school is built, a housing stock of 20 would be given but the schools that are now under construction are fewer than the ones that we have from the past which do not have this accommodation. Therefore, there's need to also pay attention to other people in the public service generally. This cannot be achieved overnight and I appreciate the efforts you are making to meet the private sector to help you with this. However, we must also be cautious of the kind of partners we are going to engage because if these become too expensive, it means those who are supposed to benefit will not afford," said Chonya.



You are members by virtue of the positions that you hold and many of the issues that have been discussed in that committee are to be discussed or revisited within that committee. I would like to advise you Whip that if you have any grievances, you raise them in that committee and I know that there is a scheduled meeting very soon," Namugala said.

Nkombo insisted that he wanted it to be in record that Southern Province MPs were excluded from the debates.

Lessons for Jacob Zuma in **Robert Mugabe's misfortunes**

President Robert Mugabe's endgame in Zimbabwe holds various lessons for his South African counterpart, Jacob Zuma, as the latter too, considers his prospects towards the end of his presidency. The first, obviously, is that while, from the pinnacle of power, a country's president may feel the monarch of all he can survey, it is always possible that the blade of the guillotine is just around the corner.

actions are not a coup. In turn, this has provided Mugabe with a considerable degree of wriggle room, which he has sought to exploit to the full. Indeed, it has remained his key bargaining chip, not least because the African Union does not want to be seen as party to the overthrow of a hero of African liberation. Explicit political actor

Zuma will feel confident that whereas in Zimbabwe the army leadership to visit the president and to ask him to stand down. Just ask former President Thabo Mbeki who was fired by his own ANC. If Zuma refuses to cooperate, then the ANC might turn to parliament, where enough ANC MPs might feel emboldened to vote with the opposition to dethrone him. Fighting for survival

Like Mugabe, Zuma will be battling for a dignified exit. Even more urgently, he will be fighting for survival. In previous years, Mugabe may have feared the prospect of retribution for his sins, and would have been determined to secure immunity from prosecution. Now, at 93, he is confident that once out of office he will be left in peace. He may or may not appreciate the irony that, unlike his country's last white ruler Ian Smith, he will not be able to stay in Zimbabwe after he has been forced to stand down, but he will know that he has to leave. Neither the army nor Zanu-PF will want him hanging around, fearing his ability to continue pulling strings. So off he must go, to South Africa, Dubai or Singapore (anywhere with a few decent shops for his shopaholic wife Grace). His major immediate concern then, we may presume, is safe passage and immunity for his family. We may further presume, that there is lots of money stashed away in

foreign bank accounts to keep the crocodile from the door. Zuma's tricky position

Zuma is differently placed. If he loses the Presidency he stands in all sorts of dangers, not least of which is prosecution for past financial crimes and the prospect of his ending his days in prison. In other words, he has much more to bargain for, and he will be doing so from a considerably weaker position. Not least of his problems is that he is a lot younger than Mugabe, so could spend quite a few years in jail. Zuma's major strength is that, whoever wins the party leadership, the ANC will probably want to grant him immunity and get him out of the way, as otherwise they face the prospect of their former leader facing a corruption trial during the lead up to elections in 2019. But for a start, there is no provision for presidential immunity in the constitution, and its grant would face a strong challenge in the courts. Furthermore, if the Gupta or other Zuma allies in the project of "state capture" were to be prosecuted, Zuma could face being dragged into court as a witness. In short, Zuma will realise that it will make sense to hot-foot it out of the country, preferably to a comfortably authoritarian country which will turn down requests for extradition.

What Mugabe is learning now, and it is something of which Zuma should take good note, is that the people are an ungrateful lot, and are likely to turn against you just when you most need their support. Up till a week ago, it was presumed that Mugabe retained the backing of all who mattered in Zanu-PF and that he would again be its candidate for president at the next election. the party presidency, his support base will drain away, and that he will become known as yesterday's man. Yet like Mugabe, he will take comfort from the regional body, the Southern African Development Community (SADC), for there is nothing his fellow presidents dread more than the prospect of any one of their number facing impeachment.

He will also know that, unlike Mbeki, whose stature in Africa remains high, he has no viable future as a roving ex-president. Zuma will know that if he wants to enjoy his retirement in peace, he has to leave South Africa before he gets tangled up in court proceedings. His best option will be to grab those two suitcases, make a hasty exit and move in next door to Bob and Grace in Dubai.

Accordingly, it is always prudent to keep at least two bags packed for a hasty exit: one full of suit, shirts, underwear and socks, another full of foreign currency (preferably dollars or Euros). You just never know how things might pan out, so it is best to be prepared.

Following the almost-coup, Mugabe has been in a stronger position than many African dictators before him because the African Union has in recent years become a lover of democracy and a hater of coups. It therefore now demands that changes of leadership must have at least a veneer of constitutionality. This has always been the Zimbabwean military's weak point during this past week of flirting with political power. Hence its insistence that, despite its take-over of the airwaves, State House and parliament, alongside its house-arrest of the president and his family, its

has long been deeply involved in the ruling party's internal affairs and the wider political arena, the South African National Defence Force is not an explicit political actor. He stands in no fear of a military coup (or even a Zimbabwe-style non-coup). Yet he does have to worry about what happens within his political party, the African National

Zimbabwe's former vicepresident, whose sacking led to the shock resignation of longtime leader Robert Mugabe, will be sworn in as the new president on Friday, the state broadcaster says.

Emmerson Mnangagwa, who fled to South Africa two weeks ago, would also fly home on Wednesday, it added.

His dismissal led the ruling party and the military to intervene and force an end to Mr Mugabe's 37-year long rule. The news sparked wild celebrations across the country late into the night.

The announcement that the 93-year-old was stepping down came in the form of a letter read out in parliament on Wednesday, abruptly halting impeachment proceedings against him.

In it, Mr Mugabe said he was resigning to allow a smooth and peaceful transfer of power, and that his decision was voluntary. A spokesman for the ruling Zanu-PF party said that Mr Mnangagwa, 71, would serve the remainder of Mr Mugabe's term until elections, which are due to take place by September 2018.

The state-run Zimbabwe Broadcasting Corporation (ZBC) confirmed that his swearing-in ceremony had been scheduled for Friday.

Nicknamed the "crocodile" due to his political cunning, Mr Mnangagwa issued a statement from exile calling on Zimbabweans to unite to rebuild the country.

"Together, we will ensure a peaceful transition to the consolidation of our democracy, and bring in a fresh start for all Zimbabweans and foster peace and unity," Mr Mnangagwa told Zimbabwe's NewsDay on Tuesday. His firing by Robert Mugabe

Mugabe's successor due back from exile

two weeks ago triggered an unprecedented political crisis in the country.

It had been seen by many as an attempt to clear the way for Grace Mugabe to succeed her husband as leader and riled the military leadership, who stepped in and put Mr Mugabe under house arrest.

Under the constitution, the role of successor would normally go to the serving vice-president, Phelekezela Mphoko. However, Mr Mphoko - a key ally of Grace Mugabe - is not believed to be in the country, and there are reports that he has been fired by Zanu-PF.


Some have questioned

whether the handover to Mr Mnangagwa will bring about real change in the country.

He was national security chief at a time when thousands of civilians died in postindependence conflict in the 1980s, though he denies having blood on his hands. Opposition leader Morgan Tsvangirai told the BBC he hoped that Zimbabwe was on a "new trajectory" that would include free and fair elections. He said Mr Mugabe should be allowed to "go and rest for his last days".

Prominent opposition politician David Coltart tweeted: "We have removed a tyrant but not yet a tyranny." African Union president Alpha Conde said he was "truly delighted" by the news, but expressed regret at the way Mr Mugabe's rule has ended.

"It is a shame that he is leaving through the back door and that he is forsaken by the parliament," he said. **BBC**



The slipping crown of Germany's Angela Merkel

Ask a European about strong and stable leadership and, up until this week, they'd have pointed the finger at Germany.

A country proud of its postwar record of political stability and careful consensusbuilding.

Until, that is, Angela Merkel won the dubious honour of becoming the first German Chancellor since World War Two to fail to form a government.

"What next, Germany?" is the favourite screaming front page headline of the moment here; the question ricocheting across the country from the federal parliament to queues at local bus stops and on endless TV chat shows. Germans have been rubbing their eyes, still not quite able to believe that their normally staid mainstream politicians may now be hurtling towards an unruly, unexpected snap election. But not though if Germany's president can help it. Frank-Walter Steinmeier fears a new vote will only benefit the farright. He's now ensconced himself in back-to-back meetings with individual political parties, with a hefty dose of arm-twisting and pressure exertion on the agenda. Since talks to form a new government collapsed in the early hours of Monday morning, Mr Steinmeier and the new speaker of the German Parliament - the former finance minister, Wolfgang Schauble - have peppered their speeches with talk of duty and responsibility. In tones designed, you might say, to trigger the kind of Lutheran sense of guilt the political old guard here may still be receptive to.

The two men have appealed to grandstanding political players in Germany to work towards forming a government, putting party politics aside for the good of the nation and, they've argued, for the good of Europe too. The German establishment is painfully aware that others outside the country are also rubbing their eyes in disbelief at the political crisis here. President Macron, for one, is stunned. Without Angela Merkel and the economically powerful and politically influential Germany at his side, his vision of an ambitiously reformed Europe will remain just that: a vision. Europe's elite is dismayed across the board. It was gradually regaining confidence after the shock of the Brexit vote Things had seemed to be swinging the EU's way with a stronger euro, less support for populist nationalists, plus plans for reforming the

Well, that's difficult to predict with any certainty.

A contact close to Angela Merkel told me her coalitionbuilding difficulties wouldn't affect Germany's Brexit stance. Certainly the main political parties here are of a mind when it comes to the Brexit divorce issues. But when it comes to talk of trade and transition, Angela Merkel will be missed if she loses her job or is politically distracted for months on end. Yes, she is a stickler for rules but Mrs Merkel is also a pragmatist.

She hopes for a good Brexit

deal for two main reasons: to benefit German business and also to help keep Europe stronger, by keeping the UK close as she apprehensively views Russia, Iran, North Korea and an unpredictable US under Donald Trump. The British government has called for creative, imaginative thinking, resulting in an ambitious Brexit deal but for that you need political will and political clout on the EU-

side.

No single voice is louder in EU circles than Germany's and Angela Merkel's. If she is silenced politically, that will have a knock-on effect beyond German borders. So is she finished?

There's talk here of "Merkeldaemmerung", literally 'the Merkel twilight', meaning the petering out of the Merkel era but I wouldn't write her off just yet. **BBC**

While the deceptive photo is definitely funny, the rest of the images from the series speak to more solemn times. *Yahoo*


How Kanye West got his life back on track

Rashida Jones denies that she left 'Toy Story 4' over unwanted advance from John Lasseter



Rashida Jones has denied a Hollywood Reporter article that claimed she left "Toy Story 4" as a writer, along with writing partner Will McCormack, over an unwanted advance from Pixar and Disney animation chief John Lasseter. Jones instead said they left over "philosophical differences," and asserted that their exit was over the fact that they believed women and people of color did not have "an equal creative voice." Lasseter was originally the co-director of "Toy Story 4," but stepped down in July, with Josh Cooley taking over as the sole director. In a statement first given to the New York Times, and later obtained by Variety, Jones and McCormack said, "We feel like we have been put in a position where we need to speak for ourselves. The break neck speed at which journalists have been naming the next perpetrator renders some reporting irresponsible and, in fact, counterproductive for the people who do want to tell their stories. In this instance, The Hollywood Reporter does not speak for us. We did not leave Pixar because of unwanted advances. That is untrue. That said, we are happy to see people speaking out about behavior that made them uncomfortable. As for us, we parted ways because of creative and, more importantly, philosophical differences."





Walton 'Not Concerned' With Lavar Ball Criticism After Beating Chicago Bulls


