We are rich because of the poor, President Edgar Lungu told Kalulushi resident on the Copperbelt yesterday.

And has President Lungu directed the Kitwe Mayor Christopher Kan'gombe to find a solution to land wrangles in the district.

Speaking upon arrival at Southdown Airport in Kalulushi, Copperbelt, Tuesday, President Lungu asked leaders to always act according to what was good for the poor saying they are the ones who were responsible for their riches.

Approach these issues as one in the belief that what's good for the people, the poor people especially, is good for

us too because we are living out of the poor people. We are comfortable, we are rich because of the poor people. They come to come to clean our houses from Kalingalinga, Mtendere, they are our masters. They come to cook for us. And President Lungu directed the Kan'gombe to find a solution to land wrangles in the district.

By Sipilisiwe Ncube UPND president Hakainde Hichilema says even if the memorial church service of late President Mwanawasa presented an opportunity for him and President Edgar Lungu to meet with each other, it was difficult to say hello because of the positions in which the two were seated. But Hichilema says it would have been nice if the two leaders greeted the way they had during the burial of the late Daniel Munkombwe.

"As at yesterday, what happened was that my team and I arrived early at the Cathedral. We were seated at the far left corner, and my colleague (President Edgar Lungu) came in much later and he was seated in the right hand corner. And the problem started. I think in my view, it was circumstantial and maybe it was difficult to say hello to each other, although the opportunity was there. For me when I had the opportunity to do it in Choma at the late [Daniel] Munkombwe's funeral, I walked over and greeted my colleague. I did that as a natural reaction, not that I planned to do it," Hichilema narrated. "But yesterday (Sunday), it didn't happen, for whatever reason. I greeted him in Choma [that] 'how are you? Welcome to Choma, thank you for coming to mourn the late Munkombwe? That was a short conversation in Choma. Another example that I want to give you is that we were at a graveyard one day and we were burying relatives and we happened to be at the same burial site with my colleague's wife and I found time to walk over to greet her. It was public

posture and naturally as a normal human act. Yesterday (Sunday), it didn't happen. It would have been nice if it happened, [but] it didn't happen."

Hichilema also advised Zambians not to allow corruption to take a centre stage, but rather fight it vigorously.

"It is our view that corruption must be fought vigorously because it takes away the income that will go to investment to create jobs. Therefore, it would help the youth, help the women, help those that are unemployed today because corruption has taken that money. The few leaders in PF and their associates have taken that money; they have built mansions out of this country. Money which could have been invested in these production sectors such as agriculture, tourism and agro-processing through value-addition and creating more value and more exports, more jobs, opportunities in terms of contracts because you know over 60 per cent will depend on agriculture directly or indirectly. And that is how president Mwanawasa's fight against corruption assisted the growth of the economy. Remember during his time, there was an increased production in agriculture, there was surplus production in agriculture. Indeed, Zambians must draw that the fight against corruption is critical because it saves resources that will help you to grow your sectors. Our policy in the UPND is to allow zero tolerance on corruption so that we can save that money and put it in the productive

sector," Hichilema added. He also advised government to reduce some of its expenditure and to revisit certain ways of doing things. "That is why our colleague was shamelessly asking the visiting Turkish President [Recep Tayyip Erdoğan] that, 'please help me to repay the US \$750 million Eurobond.' If they had invested that money in agriculture and in energy and created jobs, then there would have been revenues from there to service the debt. How do we reverse the 25 per cent of the budget going towards loans? We must stop the borrowing too much money now at a high cost. The little that you borrow, you must invest in revenue-generating activities. Don't buy VX, don't pay huge amounts of money on travelling. After you have said that you will stop travelling, you continue travelling. We must have a heart for the people; those who are suffering have continued suffering. So, let me alert the people of Zambia [that] where we are heading to now is at a worse situation. You will see public sector workers getting delayed payment, council workers not being paid on time, you will see companies that supply to government paying salaries of their workers late as well and some of the companies will close down," he warned. "You are going to see very soon this government will start printing money. That is what a failing government does. They print money, a piece of money they call legal tender; they print it without backing it with goods and services, without backing it with economic activities.

And then what you will see is that, more kwachas will be floating around and it will trigger the increase in prices and worsen the situation. You cannot borrow hoping that President Erdoğan will one day come and bail you out of your expensive loan. What if Erdoğan didn't visit? What if he is not capable of paying you because he has own programmes? You must plan all these things. I said it before that PF is chimbwi no plan (clueless animal) and you know that I went to jail for that. I was arrested for that, and I am repeating knowing that some people with appetite to arresting will advise him so that Zambians benefit. In PF, there is no planning, it is chimbwi no plan, it is chipante-pante." He also said that fighting corruption should focus on

Police spokesperson Esther Mwaata Katongo says officers in Sesheke have nabbed two people in connection to the murder of a female cop who has left behind a one-year-old baby.

In a statement yesterday, Katongo revealed that one of the suspects was the deceased's lover.

"Woman Constable Chembwe of Katimalilo Police Station, traffic section was reported missing two weeks ago and she left a one year old baby. An investigation was launched, and led to the apprehension of two people. After searching the house of one suspect believed to have been an intimate male friend, blood was discovered an indication that she was murdered and her phone was recovered from the same house and was identified by relatives that it belonged to the victim. Further investigations have revealed a shallow grave located 10 kilometers from sesheke in the bush where the suspect is suspected to have been buried," stated Katongo.

"Arrangements are being made to have the body exhumed. We have withheld the names of the two suspects as investigations have continued. We have two suspects in police custody."

Railway SI on bulk cargo has boosted By Abraham Kalito Zambia Railways – Mushimba Zambia Railways Limited has grown its business by

22 per cent in five months owing to the Statutory Instrument (SI) on heavy cargo, says Transport and Communications Minister Brian Mushimba. And Mushimba says Zambia Airways will conduct a test flight in October in readiness to officially launch the national carrier to the public. In January this year, through Government, the Ministry of Transport Communications, & announced the signing of Statutory Instrument (SI) No. 7 of 2018 on rail transportation to compel 30 per cent of bulk and heavy cargo to be transported by rail, making it mandatory for all transporters of bulk and heavy cargo to shift at least 30 per cent of their cargo from road to rail. Some of the heavy bulk cargo expected to be transported onto railway include: copper and cobalt concentrates, coal, cement, among other heavy goods. In an interview with News Diggers! in Lusaka, Mushimba disclosed that Zambia Railways had seen its business grow by 22 per cent and that there had been compliance from transporters of cargo since the SI was signed. "There will be government inspector of railways, there will be Ministry of Transport, there will Zambia Revenue Authority, there will be Weights and Measures Agency. All these will form a task force team of enforcement. Even in the period of these change management, those impacted by this SI have already willingly, have started complying. Zambia Railways has grown their business by 22 per cent ever since we signed the SI to put 30 per cent of heavy cargo on rail. Just within this fivemonth period. So, people are already complying. There is now a 17 per cent increase in TAZARA and some of it is because of the changes we have implemented,"

We have taken our time and it's coming to the end. It is coming to pass, and the agreements have been signed between Zambia Airways and our strategic partner Ethiopian Airlines. We have the share of the agreement that has been signed. The business

model that we want to ride under is that for the first two years, we are going to do domestic flights. Our budget airline is to do local flights to all districts in the country," said Mushimba, who also revealed during Sunday's MoU signing that the longawaited airline will only take off on January 1 next year. "We want to cultivate a new cadre of air travellers; we want to give access to Zambians to fly. And you know it's going to be a budget airline where the cost of an airline ticket compared to getting on the bus is comparable. Obviously, people now can see and say, 'if I top up on my bus fare. I can actually get there on time and quicker.' Once we have grown that new cadre of air travellers, then we can go regionally and internationally. As soon as we do our test flight around October, sooner after that, you know we should start flying."

Germany, EU aid Zambia €28.4m grant to enhance electricity access

Government has signed a €28.4 million grant agreement with the European Union (EU) and KFW of the Federal Republic of Germany to finance the sustainable access to electricity in the southern region of Zambia. And German Embassy Head of Cooperation Dr Christoph Ritz says the project is expected to make more power available for distribution to both households and businesses as well as allow feed-in additional renewable energies to the grid. Speaking at the signing in ceremony in Lusaka, Tuesday, Finance Minister Margaret Mwanakatwe said support to the energy sector is essential to ensuring access to clean safe, reliable and affordable energy at the lowest cost. "Through the signing of this grant agreement, that you have just witnessed, KFW will provide a grant of €18.0 million, or K211 million equivalent, to finance the 'sustainable access to electricity in southern division component' project and the EU, through KFW, will provide a grant of €10.4 million, or K122 million equivalent, for the implementation of the 'access component' project to be implemented by Zesco. The Zambian government has committed itself to grow and diversify the energy sector by expanding power generation

and transmission capabilities as espoused in the Seventh National Development Plan (7NDP). Support to this sector is essential to ensuring universal access to clean, safe, reliable and affordable energy at the lowest cost consistent with Zambia's national development aspirations, as well as the United Nations Sustainable Development Goals," Mwanakatwe said. She said the funds will go towards rehabilitation and of selected reinforcement power transmission and distribution infrastructure in the region because the existing infrastructure to serve the current electricity load is insufficient. "Through the *'sustainable* access to electricity in 'southern division component' project and 'access component' project, as a result of this grant agreement that we have just signed; firstly, you may wish to know that, a large part of the transmission and distribution network in this service area still dates from pre-Independence-era, the and the capacity of the existing infrastructure to serve the current load is insufficient. In this regard, these funds will [go] towards the rehabilitation and reinforcement of selected power transmission and distribution infrastructure in the southern division of Zambia,"

"Secondly, through rehabilitation the and reinforcement of the grid, the project will improve security of supply, reduce power losses and enhance energy efficiency in the system. Consequently, more power will be available for distribution and more households and productive users will be connected. Lastly, under the 'access component' project, these funds will be used to connect small businesses and households in areas currently not connected to the national grid, but are located in the vicinity of the project region." Mwanakatwe further explained how the projects will be financed. "Firstly, rehabilitation and reinforcement measures: the project will finance a selection of rehabilitation and reinforcement measures, otherwise, referred to also as R&R measures, and have been confirmed by Zesco as the highest priority investment. Further, the project will finance the R&R measures, which will include works at 12 substations ranging from 132 KV down to 11 KV and several other new transmission lines at voltage levels of 132 KV, 66 KM and 33 KV. Secondly, the project will finance contracting of a consulting engineer during implementation and construction phase. Last but

not the least, under the 'access component' the project will finance the connections to the grid or improve electricity supply to identify Rural Growth Centres (RGC) and low-cost urban areas falling within the project areas," she said. And Dr Ritz explained that KFW, his country's development bank, was the lead financier of the project. "This is expected to make more power available for distribution so that more households and businesses can be connected. It will also allow to feed-in additional renewable energies to the grid. The project is a good example of European-Zambia cooperation. The investment of 86.9 million euros is jointly-financed by France and Germany and includes a contribution from the EU focused on the implementation of an access component. Germany's development bank KFW is the lead financier. The financing contracts to be signed today covers 28.4 million euros from Germany and the EU. For the overall project, Germany provides a grant of 36.5 million via KFW and France provides a concessional loan of 40 million euros. The EU contributes a grant of 10.4 million euros via the Africa Infrastructure Trust Fund. Ensuring energy access for all will require reforms in the energy sector. Zambia's

overall debt sustainability and the financial health of Zesco are important preconditions for investment in the energy sector," Dr Ritz explained. And EU Delegation to Zambia COMESA Gianluca and Azzoni encouraged the Zambian government and Zesco to make the most out of the financial package. "The EU is contributing grant financing to this project to a tune of 10.4 million euros, which comes on top of the envelop already allocated under the bilateral EU-Zambia cooperation programme of the 11th European Development Fund (for the period 201-2020). The EU contribution comes from the EU Sustainable Energy for all window of the EU-Africa Investment facility set up to promote access to affordable, reliable and clean energy in African-partner countries in line with Sustainable Development Goal 7. I am informed that the project aims at establishing at least 12,000 new connections to households and 200 new connections to commercial/public users representing a total of more than 60,000 citizens with access to grid-connected power. I would like to encourage the Government of Zambia, and Zesco in particular, to make most use out of this financing package," said Azzoni.

He explained that US \$120 million, as part of the proceeds arising from the first US \$750 million Eurobond issued in 2012, were effectively utilised to revamp Zambia Railways. "And I want to be very clear of the Eurobond. The US \$750 million that was gotten was not for Zambia Railways all of it, and it has been mismanaged, no! Zambia Railways has simply been invested into. The money was for many things and Zambia Railways only got US \$120 million. And Zambia Railways has used that US \$120 million to remanufacture locomotives, to work on slow-speed areas,

Church shouldn't hijack dialogue process – YALI

By Mukosha Funga Young African Leaders Initiative President Andrew Ntewewe says the church must not hijack the national dialogue process because ZCID is the right organization to handle all matters regarding political parties in Zambia. And Ntewewe says the church must know that Zambia is neither in a crisis or in a war situation. In a statement, Tuesday, Ntewewe said the back and forth on who should the dialogue spearhead process was retrogressive asked the church and not to hijack the process. "We at the YALI have noted with grave concern the position taken by the Church to spearhead the

national dialogue process by themselves to the exclusion of other key stakeholders such as the Zambia Centre For Interparty Dialogue (ZCID). What is particularly perturbing is that the church seems to be oblivious and insensitive to the challenges we have recently faced to actualise this long awaited national dialogue. This back and forth in this process only serves to erode public confidence in the process and it is generally retrogressive. The position taken by the 3 church mother bodies seems to negate the strides that political parties have so far undertaken to achieve to much anticipated dialogue," Ntewewe stated. "The nation will recall that not long ago Secretary Generals of

political parties gathered and met in Siavonga to iron out this very important matter. We were all pleased at the outcome of the Siavonga deliberations were political reaffirmed their commitment to the national dialogue process were both the church and the ZCID would play but equally important roles. What has happened to this position? Are the three church mother bodies telling us that the efforts made by the political parties themselves under the auspices of ZCID useless? The 3 church mother bodies must not appear to be making attempts at hijacking the dialogue process when we all as stakeholders know that when it comes to dialogue among political parties, there exists an umbrella organisation

called ZCID. There can not be interparty dialogue therefore without ZCID. Let's capacitate ZCID by ensuring they play their role in national dialogue." And Ntewewe told church mother bodies that Zambia was not in a crisis neither was it in a war situation. "YALI would like to put it on record and remind our beloved church mother bodies that Zambia is not in a crisis, neither are we in a war situation. All the institutions of governance are intact. It's also very critical to indicate that there is no legitimacy contest, the elections of 2016 are beyond us and we have a legitimate government in place. We are of the view that the national dialogue process, must not be mistaken for a

reconciliation between and among our political leaders. This is a national dialogue, for heaven's sake. It must not leave anyone behind," he stated. "In fact, it must be understood that this process is also about reforms which will affect all the citizens of this country. It requires key expertise by different stakeholders. Hence no one single entity must bulldoze it's importance. This nation dialogue is about building a long term, sustainable peace architecture and the institution well placed to do that is the ZCID. We therefore must capacitate ZCID for this long-term process as dialogue and constant engagement is the hallmark and bedrock of a strong well functioning democracy." Ntewewe asked the church not to be derailed by by-partisan processes at the expense of tending to God's flock. "Peace building, conflict resolution mechanisms, detection and early warning signs of conflict and general by-partisan engagements will be central to the long-term national dialogue process hence the need for ZCID to be a critical partner in this process. With due respect to the Church, they can not sacrifice their prophetic calling and the demands of constantly tendering to God's flock at the expense of being engaged in these never ending by-partisan processes which will always be with us," stated Ntewewe.

Mwenye who served under president Michael Sata as Solicitor General and later Attorney General, could not resist commenting on the incident where Lusaka Province Minister Bowman Lusambo caught traffic officers allegedly taking bribes from motorists. He said while Lusambo's efforts were targeted at exposing corruption, it was important to target grand corruption among those who were taking proceeds of crime to invest in companies and assets, rather than only focussing on the weak and vulnerable. And in an interview, Changala

agreed with Mwenye, saying those involved in grand corruption often went scot free because of the power they yielded. "I conquer with the former Attorney General. He is very right. The fight against corruption is a fight against the weak in society whereas the strong and the people who are involved in grand corruption are left off the hook because they are well connected. And this is because the Anti-Corruption Commission itself is morally corrupt [and] it cannot balance the fight against corruption. It cannot equalize in terms of attacks on the root cause of this corruption. The biggest culprits in this corruption are actually in

high offices but because they cannot touch them for the fear of the unknown, they want to celebrate the downfall of the weak who are merely trying to help themselves to the tradition that has been celebrated and anchored in the corridors of power. And this corruption will never end if the Anti-Corruption Commission will not go for the big fish that are holding power," Changala said. Changala said instead of being a political party, PF had been turned into a business venture. "And those who are celebrating the arrest of those [traffic] four police officers are being naive, unfair to this country and indeed accomplices. They must mind that what happened to those four police officers must happen to the big fishes that are stealing big. For example, PF itself is an embodiment of corruption. Look at its lifestyle [or] the lifestyle of the leaders of PF, look at their expenditure, it is out of this world. And yet PF has now become a business venture and when you question them [on] the source of their monies, they will tell you that it's well wishers. Now where are these well-wishers who can't buy medicine in hospitals? Where are these well-wishers who can't support our children at higher learning institutions in terms of bursaries? So I agree with the former attorney general that this drama [which] they are trying to create by embarrassing and humiliating those who are low in society is bound to backfire one day. We need to cite the corruption starting from State House to the last man in the ministry in government," he said. He said there was need to probe PF officials for corruption starting from the Secretary General to the media director. "We need to fight corruption in PF starting from the secretary general to the media director. Where are they getting these funds when the economy has totally collapsed and when we are going through what they are telling us is austerity measures? I don't know what these austerity measures are. This does not affect PF, it only affects the man and woman in the street because their expenditure is very high and extravagant, but they will tell vou to tighten vour belt as we face the challenges ahead. There is a lot of hypocrisy and a lot of unbridled anarchy in the corridors of power," Changala said. Meanwhile, Changala said there was need to give ACC directors security of tenure so that they could discharge their duties freely. "And the Anti-Corruption Commission itself is to blame. So for Anti-Corruption Commission and its commission officers to operate, they need security of tenure. They are very vulnerable. And mind you, corrupt people are very powerful in that they are financially strong; they are able to uproot anybody to an extent of killing anybody. Now the director general of Anti-Corruption Commission must have security of power. Once appointed [and] ratified by parliament, there should be a situation where he cannot be removed by the president unless through a tribunal which he has errored or if he has committed a misdemeanour. They must have the security of power, the security which the judge enjoys, the security that the director of public prosecution enjoys. They must extend it to these institutions so that they operate freely and at an extent where they can walk to a minister and say 'I am arresting you today' without a phone call coming from State House to say 'don't arrest that gangstar, the money he is stealing is ours no," said Changala.

submission of returns and late or non-payment of tax liabilities on all domestic tax liabilities from April 24 to December 31 last year. The Tax Amnesty exercise was intended to give an opportunity to taxpayers to declare all transactions that had not been reported and to resolve their tax indebtedness arising from interest and penalties. It also offered taxpayers longer time-to-pay agreements until June 30 this year. "Results so far indicate that

many taxpayers continue to be evasive when reporting to Customs and to Domestic Tax on comparable transactions. We wish to inform taxpayers whose declarations will be flagged by the data matching system that they will receive a notification requesting them to provide an explanation for the identified variations within 14 days of the notification. Taxpayers are reminded that they are required by law to comply with this request and to provide any requested information and records,"

Chanda disclosed in a press statement released, Tuesday. cautioned He that taxpayers failing to oblige to the notifications will attract further penalties. "Should a taxpayer fail to oblige with this request for information and records, ZRA shall proceed to amend the taxpayer's tax assessments by making adjustments that may be deemed fit in accordance with the relevant provisions of the Income Tax Act, the Value Added Tax Act and the Customs and Excise

Act. Furthermore, failure to provide the information and records so requested may result in incurring of fines or penalties in accordance with the aforementioned legislation," warned Chanda. "The Authority wishes to take this opportunity to encourage taxpayers to comply voluntarily on their tax obligations. However, taxpayers who choose to evade taxes will be identified and brought to account. Tax compliance is everyone's responsibility.

Reject RTSA speed fines, Customs Clearing Association urges motorists

By Abraham Kalito The Customs Clearing and Freight Forwarding Agents' Association of Zambia (CCFFAAZ) has called on motorists to reject fines slapped on them by the Road Transport and Safety Agency (RTSA) following the installation of speed cameras on selected roads in Lusaka. In a statement issued in Lusaka, Tuesday, Association president Bruce Kaemba stated

that the introduction of speed cameras is a scheme aimed at extorting and squeezing out monies from the already overburdened tax payers. "I urge all the affected motorists to reject these fines because the whole exercise is a scheme by RTSA and Intelligent Mobility Solutions to extort and squeeze out monies from us, the already overburdened tax payers. Do you remember

the motor vehicle testing machine, which RTSA introduced sometime back at Mimosa? They are at it again though this time with the so-called speed cameras. Let us just reject this scheme with the same level of unanimity we had when opposing the introduction of the Mimosa motor vehicle test machine. Should RTSA push me to the limit in pursuit of this illegal fine, I will have no option but to seek legal redress and unless the courts of law deem it fit for me to pay the fine I will do so. That, however, should mean that RTSA should stoop so low and throw professionalism out the window to appease this company at the expense of us innocent motorists," Kaemba stated. "The fines slapped on us motorists by RTSA for allegedly excessive speeding is clearly an act of extortion and broad day light robbery. In the first place, RTSA should have informed us motorists of their intentions to put up speed cameras that's what responsible and civilised agencies do. This is not the game of hide and seek. As if to add salt to the wound, RTSA head Zindaba Soko vehemently said the agency will not waive the fines on the speed tickets, but extend the payment period by one month.

"As an affected motorist, who has accrued five tickets for excessive speeding, I am extremely reluctant to pay these fines and I believe my position is shared by many other motorists who are in a similar position as myself. In as much as the speed cameras are a welcome move to restore sanity on our roads, the manner in which these cameras were installed and the fines slapped on us motorists is all wrong and fails in many ways than one," stated Kaemba. On Monday, RTSA insisted on not waiving fines slapped on motorists speeding following the installation of speed cameras on selected roads despite mounting complaints from several motorists. According to Soko, the agency is also anticipated to beat its revenue target by 100 per cent through the use of ICTs, which include speed trap cameras.

Nkombo tells outsiders calling for HH's resignation to back off

And Chanda told News Diggers in an interview that he is tired or watching Kambwili pour insults on him, President Edgar Lungu and his daughter Tasila Lungu, every time he gets a chance to speak to the media. The President's advisor called Kambwili, who is also a rebel PF member of parliament, to give him his own measure of insults in retaliation to the constant theft accusation that the lawmaker has been unleashing on the State House officials.

Over the weekend, Chanda had described Kambwili as a stupid stinky rabid dog, whose illness was affecting the big but empty head; prompting the member of parliament to respond through an article published by News Diggers, saying he would forgive the Press Aide whom he also described as a confused boy who was looking frail, dehydrated and grey as a result of whatever he was suffering from.

This response angered Chanda further, who yesterday called Kambwili to spit out more 'unprintables'.

Below is the recorded phone conversation which has also been uploaded on the News Diggers! online Audio Channel. I have put it in court papers, what are you scared of? Kambwili: That is very good. Now I

will take you on. Amos: That miner, kapokola ku Luanshya, ulya wa umine inshimbi ulya uwalemana ulya in order to steal metals. (The police officer you hit with a metal bar in Luanshya who is now disabled).

Kambwili: I have recorded you, that's what I wanted.

Amos: I have been calling you on my phone here, I am with people here. Kambwili: That's what I wanted, now I have got you. Thank you very much. Amos: Uli imbwa fye yamuntu iwe. Wali ipaya abantu and this I will take before court, what are you saying? (You are just a dog of a human being, you have killed people).

Kambwili: That's very good, now I have got you.

Amos: Can you answer yes or no? Kambwili: I have just told you that that's the evidence I want from you. Ngumfwa kwati ba bepa fye nga ulelanda nomba nakuchita record mwaiche wandi and I will take you on, you will have to justify those things.

Amos: Straight away, even tomorrow. Kambwili: You have done very well and my lawyers will be on it this afternoon, thank you very much intelligent young man, thank you. [Phone cuts] can go there without me and for State Lodge, you can go there, there are two green houses yes, from Amiran. They are two of them, one costs \$6,000 so \$12,000...

Q: But looking at your language to Mr Kambwili, you sound like a very irritated man who has been pushed to limit. What has irritated you so much about this man for you to come out like that?

A: He is so personal against me first of all as an individual and very personal against the President and very personal against Tasila. What have these three people done to him? He is not even dealing with us as political opponents, he is so personal and he can lie because I can't lie as often as he does. I can't respond to his lies at the pace he is doing. So in the age of social media, I have suffered anguish myself at a personal level because of the lies people are putting on social media. He is at the top of those lies. Look, when you have asked me (about the properties), I have told you 'yes, we can go there', I have told you the amounts, one is \$6,000, the other one is \$6,000 there is tomato and vegetables in there but when he puts it like that, he paints a picture like those green houses are probably producing marijuana and what not. It takes a lot! I have friends who call me in the diplomatic community as you know my career is not just in politics, embassies call me, friends in foreign missions, they call me as a result of the lies that he is telling. So how can he get away with lies like that?

Q: Is there any truth in the allegations?

A: There is no truth that he is saying, he has said many times, he is going to expose me, I said 'go ahead'. He took me to court, I have said I will prove every word I have said, I am not like other people who are scared of him if you have seen. I have said myself, every single word that I have said that he has killed people, I will prove in court. That's why I sent him a text message that he has killed people when he was a metal dealer and I will tell the court these things on any given day and I have asked him to respond to that.

Even in the exchange, hasn't he answered that thing? He just says a day of reckoning will come. Who is Delcious Kashimbaya in Chingola who was murdered by Kambwili's agents? Let him answer that question. What about a police officer in Luanshya who was hit by a metal bar by Kambwili himself? That man is still alive, when Kambwili was still a metal thief, that policeman has been maimed and he is still alive. Can Kambwili say he did not hit somebody with a metal bar? Can Kambwili say he did not fire a gun in a courtroom in a magistrate (court) in Chingola in a matter of Mr Delcious Kashimbaya...so I can prove What puts me off is this is a man who I can't even sit with on the table but by circumstances of politics we got together but he wants to lie and destroy careers of other people. Q: Kambwili is also saying before going into foreign service and later State House, you were jobless with no house or car, you were surviving by a K10.000 that Mr Fred M'membe was giving you. So Amiran trusts me and they will give me goods on credit because they know I can pay. Q: It will be important to show the people those properties, to put things in context so that people can judge for themselves if those are things you can justify from your income.

A: Yes. If it is money in the bank account, you must state, how much is in the bank account? If it's a house in State Lodge, what is the estimated value, I haven't done the evaluation, I will call you tomorrow to give you the evaluation, it is a four bedroomed house on a five acre plot. The remainder of the plot is just vegetable garden, maize and what not. So when he questions the wealth, which wealth? Then remember he said 'on Saturday', I think it has been 50 Saturdays now, he has not disclosed. Remember when he said he will hold the mother of all press conferences to expose me? So this is just a despicable liar who if I had my way, the media must stop giving him platforms to malign other people. And the issue is that he has taken me to court, I have counter demanded, I am standing on every single point that he has forged a degree. A Clueless Cabinet?

It has to be said: if for some reason the world's most incompetent thinkers came together to develop policies that made absolutely no sense, they would be hard pressed to match some of the outcomes of the recent cabinet meeting in Zambia.

It is tempting to describe the goings on in our country as a circus. However, that would be giving the circus a bad name. A circus is, after all, well-intentioned, properly planned, carefully coordinated and can generally pay its own way. Some circus acts are indeed clumsy but they only act that way to entertain the audience. The Cabinet circus that is unfolding before our very eyes, is not, unfortunately, an act. Clumsy decisions (like the "WhatsApp tax") are probably a product of unconscious incompetence as is the decision to create a completely new cyber crime agency at a time when we should be reducing our public expenditure footprint in order to meet our colossal debt obligations. Cyber crime is indeed an issue but this can be dealt with in a much more cost-effective manner.

So why do these recent Cabinet decisions make no sense? First of all, since when was it government's responsibility to tax citizens on

behalf of an industry (telecoms) that is perfectly capable of raising its own revenue to build infrastructure and employ citizens? Secondly, accessing WhatsApp calls requires one to pay for data anyway, so the telecoms companies are not losing out at all. In fact, the more internet calls people make, the richer the mobile operators whose data is being used. Thirdly, as a revenue generator for mobile network operators, data has increased tremendously since the uptake of free services like WhatsApp. The technology used to offer calls over the internet is even used by the very call centres that the Zambian Cabinet seems overly eager to protect.

Finally, how exactly will WhatsApp calls be monitored? This requires very sophisticated equipment coupled with the legal authority to tap phones. Was this perhaps why the "WhatsApp tax" was announced hand in hand with the planned measures to tackle cyber crime?

Zambia has to get its act together. We are not going to do it by taxing our citizens to death and ignoring the real enemy of development: complacency. We are complacent when it comes to corruption, theft, immorality, laziness,

drunkenness and incompetence. As a result, these have become the attributes by which one can advance rapidly in public life if you grovel before the right people. We have a Cabinet that is more worried about taxing its citizens to death than addressing the serious crimes highlighted in official reports by organisation like the Financial Intelligence Centre. Surely the words of Scripture ring true in this instance: "You blind guides! You strain out a gnat but swallow a camel." (Matthew 23:24 NIV). Our Cabinet has no problems ignoring the theft and corruption and ordering expensive vehicles for officials, yet they are ready to fleece the poor citizens of the little money they make through their hard work and unsupported enterprises.

If incompetence was an author, the story of the recent PF decisions would probably not be it's masterpiece but it would sure come close. Let us just accept the fact that we have a cabinet that is in over its head. The sooner we wake up to this reality and resolve to turn the tables in 2021, the better for everyone. Elias C. vehicles will also be booked for speeding, revealing that he has also paid a fine after being caught driving at 10Km/hr above the speed limit.

Speaking when he featured on Hot FM's 'Frank on Hot' yesterday, Soko said the implementation of the ICTs-based system to deal with fines and payments would increase revenue collection and exceed the agency's target by 100 per cent.

"The way the cost sharing model is, if you understand a concession, the way it is, is that, as it starts, there is an issue of investment by the investor in these systems. So, there will be a sharing by a percentage as the project starts; a large percentage goes to the organisation investing, then after one, two years, the scenario changes. Government gets the higher percentage and the investor gets the lower percentage. Iran unveiled its first domestic fighter jet on Tuesday, with President Hassan Rouhani insisting that Tehran's military strength was only designed to deter enemies and create "lasting peace".

Images on state television showed Rouhani sitting in the cockpit of the new "Kowsar" fourth-generation fighter at the National Defence Industry exhibition in Tehran.

State media said it had "advanced avionics" and multi-purpose radar, and that it was "100-percent indigenously made" for the first time.

Footage of the Kowsar's test flights was circulated by various official media.

But live footage of the plane taxiing along a runway at the defence show was cut before it could take off.

"When I speak of our readiness to defend, it means we seek lasting peace. If we lack readiness, we welcome war," Rouhani said in a televised speech shortly after.

"Some think when we increase our military power, this means we seek war. (But) this is peace-seeking because we don't want war to happen," he added.

"If we don't have a deterrent... it gives a green light for others to enter this country." The plane was first publicly announced on Saturday by Defence Minister Amir Hatami, who had said it would be unveiled on Wednesday.

He gave few details of the project, focusing instead on Iran's efforts to upgrade its missile defences.

Hatami said the defence programme was motivated by memories of the missile attacks Iran suffered during its eight-year war with Iraq in the 1980s, and by repeated threats from Israel and the United States that "all options are on the table" in dealing with the Islamic republic. *AFP*

Intense fighting erupts in Kabul after rockets fired

Afghan security forces battled militants in Kabul's old quarter Tuesday, with military helicopters firing above a mosque to quell an assault that was launched with a rocket barrage against the capital.

It was not immediately clear who was responsible for the assault, which came as President Ashraf Ghani was making a speech marking the first day of the Islamic Eid al-Adha holiday, days after offering the Taliban a conditional three-month ceasefire.

An Afghan army helicopter swooped in low over the street near the Eidgah Mosque in a central district of the city and fired a rocket on a militant position, sending a plume of dust into the sky.

People who moments earlier had been buying livestock for the Eid feast could be seen sprinting for shelter as cars swerved in the road to flee the fighting. Blasts and gunfire could be heard as security forces cordoned off the area. The mosque is near the presidential palace where Ghani was making his speech, which was being aired live on Facebook when the attack began.

The president can be seen pausing as multiple blasts are heard in the background, some sounding nearby, before stating: "This nation is not

going to bow to these rocket attacks."

The attackers appeared to be in a building behind the mosque, which was partially destroyed in another attack several years earlier and is not believed to have been in use for Eid.

Police said the fighting began around 9:00 am, after multiple rockets struck in at least two areas of Kabul. Footage aired live on broadcaster Tolo News showed dark black smoke emanating from the area near the mosque while fire trucks and security vehicles rushed to the scene.

Kabul police spokesman Hashmat Stanikzai said police believe at least four militants are involved in the assault. "An operation has been launched to arrest or gun them down," he told AFP.

Interior ministry spokesman Najib Danish confirmed that militants had taken over a building near the mosque and fired several rockets.

"Two people have been wounded. Security forces are fighting the terrorists," he told AFP.

Danish later told Tolo that the militants were using rocket propelled grenades and mortars to target parts of the city.

"Choppers are flying over the site and the security forces are busy defusing two explosivepacked vehicles at the site that the terrorist wanted to detonate," wrote interior ministry communications chief Bahar Mehr on Facebook.

A heavy security presence could also be seen near the Kabul Stadium.

Ghani unveiled the government's latest ceasefire gambit during an Independence Day address late Sunday, saying security forces would observe the truce beginning this week -- but only if the militants reciprocated.

The truce offer was welcomed by the United States and NATO after nearly 17 years of war, though it was not clear if their forces in Afghanistan would also participate.

The Taliban did not immediately respond to Ghani's proposal, but have vowed to release "hundreds" of "enemy prisoners" to mark the Eid holiday, which began in Afghanistan on Tuesday.

It was not clear which prisoners they were referring to.

The move followed an extraordinarily violent week in Afghanistan that saw that Taliban storm the provincial capital of Ghazni -- just a two-hour drive from Kabul -- and press the fight against security forces across the country, with estimates suggesting hundreds of people may have been killed.

Analysts were mixed over Ghani's proposal, with some saying the government's move was a sign of desperation after recent heavy bloodshed, while others said the trust-building measure was integral to paving the way for negotiations. It came after an initial ceasefire in June, the first such truce since the US-led invasion in 2001 that toppled the Taliban regime. For just three days thousands of insurgents poured into cities across Afghanistan, eating ice cream and posing for selfies with security forces to celebrate. The brief respite spurred hopes that a new path was opening for possible peace talks in the country to end the nearly 17-year-old war. AFP

Madonna's odd, self-absorbed VMAs Aretha Franklin tribute angers Twitter

When it was announced Monday that Aretha Franklin, who passed away last Thursday, would be honored at Monday's MTV Video Music Awards, it seemed like only one artist slated to appear at the ceremony was suitable for the job. No, it wasn't Post Malone, or Travis Scott, or Cardi B. It seemed like only the queen of pop, Madonna — who, like, Franklin, was raised in Detroit, and whose milestone 60th birthday took place on the day Franklin died, Aug. 16 could do the Queen of Soul justice.

Standing onstage at New York's Radio City Music Hall — where Madonna notoriously opened the first VMAs ceremony in 1984, in a peek-a-boo wedding dress — Madonna started by sharing an anecdote about how "Aretha Louise Franklin changed the course of [her]

life" early in her career. She reminisced about attending an important audition and making a last-minute, risky decision to sing one of Franklin's biggest hits, "(You Make Me Feel Like a) Natural Woman," sans accompaniment, then said: "You are probably all wondering why I am telling you this story. There is a reason. Because, none of this would have happened, could have happened,

without our lady of soul. She led me to where I am today. And I know she influenced so many people in this house tonight, in this room tonight. And I want to thank you, Aretha, for empowering all of us. R-E-S-P-E-C-T. Long live the queen." The problem was, Madonna's audition anecdote comprised her entire cheeky speech. While it seemed to go over well, for the most

part, with the Radio City audience — especially with Camila Cabello, who, when Madonna presented her with the Video of the Year award a few moments later for "Havana," spent much of her own speech fangirling over Madonna — the internet was not as amused.
