### **DEC nabs Lusaka** banker for theft of over K450,000

By Mirriam Chabala The Drug Enforcement Commission (DEC) in Lusaka has arrested a 30-year-old banker and charged him with money laundering, forgery, and theft of over K450,000. And the Commission, through its Anti-Money Laundering Investigations Unit, in Northern Province has also arrested an Information Technology Programmer and a Senior Systems Analyst of Kasama District for forgery.

DEC Public Relations Officer Theresa Katongo disclosed in a statement that the Lusaka banker had been fraudulently drawing money on several accounts of unsuspecting customers using ATM cards issued to himself while generating withdrawal slips

fraudulently. "Daniel Joseph Banda, 30, a banker of house number C6, Hands-worth Court has been charged with theft by servant, money laundering and forgery, contrary to the laws of Zambia. Particulars are that the suspect, jointly and whilst acting together with other persons unknown but between 1st January, 2016 and 31st December, 2017 did steal K 452, 794.72 by fraudulently drawing money on several accounts of unsuspecting customers using ATM cards issued to himself while fraudulently withdrawal generating slips. The suspect further forged bank documents purporting to have transferred money from a customer account into the bank's investment account when in fact not, an act which resulted into money laundering. The suspect has since been released on police bond

Money Laundering Investigations Unit in Northern Province has arrested Bizeck Mbewe, 31. an Information Technology Programmer of Mulenga Hills in Kasama District and Boyd Banda, 52, a Senior Systems Analyst also of Kasama District for forgery, contrary to the laws of Zambia. The duo jointly and whilst acting together with other persons unknown on dates unknown but between 1st July, 2017 and 31st January, 2018, did forge various receipts which were later issued to customers of Kasama Municipal Council amounting to a total of K 19, 298.30. The suspects are expected to appear in court soon."

## NDC asks govt to explain Katumbi's Zambian passport

By Mirriam Chabala National Democratic Congress (NDC) Secretary General Mwenya Musenge has challenged government to explain how Congolese politician Moise Katumbi was issued with a Zambian diplomatic passport.

But Special Assistant to the President for Press and Public Relations Amos Chanda says government will not make any comment on the matter as it will not be right to engage the DRC government via social media.

In a statement yesterday, Musenge charged that the rumours surrounding the alleged issuance of a diplomatic passport

Kampyongo be fired if he has a hand in the issuance of the same passport.

"We want government to urgently clarify the alleged issuance of a diplomatic passport to Congolese politician Mr. Moise Katumbi because it has the potential to compromise national peace and security. If indeed, it is true that Mr. Katumbi is the holder of passport number... we want to know how he got the said documentation. As a party, we shall not gloss over this matter until those who issued the said passport are brought to book. As a party, we have nothing personal against Moise Katumbi as an individual but we have just commented on this matter because it raises a lot of questions that require urgent answers. Zambia should not and shall never be used as a safe haven for foreigners," Musenge stated. "If Mr. Katumbi indeed holds a Zambian passport, we wonder how many other foreigners such as Chinese have Zambian passports. If Mr. Katumbi has a Zambian passport, we demand for a clean up

arrested and prosecuted. If Home Affairs Minister Steven Kampyongo has a hand in the issuance of this passport, we demand that he be fired by the authority. appointing The NDC demands that the authenticity of this matter be clarified by the Ministry of Home Affairs immediately. We further demand for a clarification from the Ministry of Home Affairs on how Mr. Katumbi was issued a Green National Registration Card (NRC)." And Musenge appealed to the Congolese government to clarify on the issue of dual citizenship in the DRC.

"The NDC is also appealing to the Congolese Government to clarify on the issue of dual citizenship in the DRC. We further want our Congolese counterparts to assist us with information if they are aware that Mr. Katumbi actually holds Zambian citizenship. Mr. Katumbi rose to prominence in the 1990s under the Fredrick Chiluba regime under the name Moses Katumbi. Katumbi Moses also claimed to be Dr. Chiluba's relation. He went further and claimed he was a relation to one of the Royal Highnesses in Luapula Province. After Dr. Fredrick

Chiluba was arrested for corruption, Moses Katumbi unceremoniously left Zambia. He later appeared in the Congo as Moise Katumbi and became Governor for Katanga province. As a country, we may differ politically, but, we should not allow foreigners to hijack and take over our country.n We have only one Zambia and we as citizens should safeguard this country from any foreign emissaries and aggressors," stated Musenge.

But when asked to comment on the matter at a media briefing at State House yesterday, Chanda declined to give any comment but acknowledged that Katumbi had lived in Zambia for about 20 years. "I got a question as I was coming, from one International media organization about an online picture of Mr Katumbi's passport purported to be Zambian. I have said that it would be out of character for the Zambian government to engage a foreign government through social media, so on that point we have no comment. Suffice to say that we know officially that the Congolese government issued an arrest warrant against

His Excellency Mr Moise Katumbi, former governor of Katanga Province, and that warrant clearly states that it must be executed anywhere in the world, clearly against a Congolese national. That is what we can say there, is an official document saying that he is a Congolese national, we also saw another document from the government spokesperson (of Congo) saying that Mr Katumbi is an Italian, that was last month,"

said Chanda.

"I can only state here that Mr Katumbi lived here for close to 20 years, and that he is a Congolese national officially. We have dealt with him and we have seen a lot of documents signed by him as governor of Katanga Province. So we are not making any comment on that, it is against diplomatic relations with a friendly neighbor like Congo for us to engage in a social media exchange so to speak. There are elections in Congo like there were elections in Zimbabwe. We saw texts and texts of newspaper cuttings that President Mnangagwa was Zambian, so the electoral season does bring about so many things. So officially, we have no comment on that matter."

The Zambia Chamber of Mines (ZCM) has observed that the mining sector has stagnated because too much pressure has been mounted on it to service other sectors of the economy. ZCM President Nathan Chishimba observed that the mines did not seem to be contributing much to the country because Zambia's needs had grown faster than the mines were able to cope with. historical "The understanding of the value of the mining sector to the country has been as a source of revenue and this understanding has led to a situation where the industry has somewhat stagnated, it hasn't grown as much it should. Therefore, as the rest of the country's needs expand with time, it's appearing not to contribute as much as it should, when in fact what it should do is actually to be a key driver of growth in the economy. That's the role which it should be taking up presently but it's not in the growth mode presently, the growth is slower than it should be. We seem to have lost track of how mining should really be looked at. Mining is a long term business, typically it will take 10 to 20 years to prospect and develop a mining operation and we haven't had many examples of that Zambia at the moment because the industry is now mainly perceived as a source of revenue, which is contrary to the actual natural pattern of looking at a mining company," Chishimba explained. "Typically for instance you will take 10 to 20 years to prospect, you take probably another five years to develop and build a mine...this process involves several billion Dollars to try and get to an operation and then obviously the pay back can't come in two to three years, it will take typically about 20 or so years before you recover the investment that you put in a mining

operation. Now, in our country right now we have allowed a narrative where we look at mines mainly as a source of revenue and that has significantly impacted on the mining sector because there is a lot of pressure to get as much revenue as we can from these operations in a very short period of time. We haven't invested much but we hope to reap more, if you look at the President's speech when he opened the Chambishi South Hall project, he was talking about in the order of K13 billion that has gone into the mining operations in the last 10 to 15 years. Now that's a staggering amount of money that requires extended periods to get pay back from. So because of the way we look at mining in Zambia, we tend influence our policy makers who then try to put policies that are designed to maximise revenue rather than to foster the long term growth of the sector, which is unfortunate." Chishimba said it was important to realize that mining needed an intensive, detailed investment plan. "We can remedy this situation by taking a longer view. I think it's important to view mining in its correct context. The way a mine starts is not through privatisation, it starts from a very detailed and intensive level of investment which then results in the mining operations. And we have seen a situation where those countries that have encouraged this time of long term view are getting the biggest benefits from mining. I would also like to say that mining is our comparative advantage as a country. So we need to look at a very strategic way of encouraging mining to assist our efforts to diversify into the other sectors," he said. Meanwhile, Chanda admired the growth of the mining sector in the neighbouring DRC and hoped for the same in Zambia.

"Congo is a very interesting case, when you at the common headlines, Congo represents confusion and so on but they have down well in one respect, which is to manage their mining sector very strategically. The DRC actually created an environment where exploration investment was very high to the extent that they were among the top 10 destinations globally for exploration investments in the world. And then after that, they did put in place a very proactive mining fiscal regime which remained in place for over 10 years. Essentially they set in place all the ingredients that are essential for good mining investments to the extent that the top four mining companies in the world are actually in Congo running operations there and that's what we rate trying to advocate in Zambia that we need a very strategic approach and all these ingredients to come into place," said Chishimba. "Exploration investment must flow into Zambia, right now are hovering at very low levels, I think below \$10 million annually as exploration investment.

know exploration investment globally has dropped but we need to be running with the big dogs by being able to attract all those big players in the world to come to Zambia. And there is no reason why they cannot come to Zambia. So I think we need to be predictable, we need to be able tpo have a very consistent approach to mining taxation, mini g policies and all other ingredients that represent a favourable environment for the sector to grow."

### Chinese nationals bought, smelted ZNBC cables stolen by employees - Katanga

Also involved in the case, was a police officer who was implicated, also of ZNBC identified as Constable Kapela of Kitwe who was also picked and later apprehended and charged for the subject offense. The four are detained at Riverside Police and Investigations are still underway. So when they got to the Chinese, they found that the 400 Kg of cable were smelted and that K11,000, they shared and part of the money, it seems it was given to some other officer who is also implicated," said Katanga.

Charity Katanga has revealed that the ZNBC cables which were stolen by two employees with the help of outsiders were sold to Chinese nationals at K11,000. Katanga told News Diggers! in an interview that by the time the suspects led police to the buyer, a Chinese national, the cables weighing about 400kgs had been smelted. On Tuesday, Riverside police arrested two ZNBC employees, a cameramanandadriver, for all egedly stealing digital migration cables. But Katanga refused to give any further details until yesterday when she revealed that even a police officer who was stationed at ZNBC was involved. "Riverside police, Kitwe, received

which occurred between 26th August 2018 at 18:00 hours and 27th August 2018 at 08:30 at ZNBC studios in Kitwe. A report was received from Philip Ngoma, 38, an IT technician who reported on behalf of ZNBC that unknown criminals broke into the back studio and stole from therein about 20 meters of armoured power cable whose value was not ascertained. So after that, police visited the scene and instituted investigations. After thorough investigations, it led to the apprehension of two employees, who also led to the buyer of the same cables that were stolen," Katanga narrated. And ZIPAR research fellow Shebo Nalishebo says government added K1.3 billion to the total debt stock in just a six-month period between January and June this year.

Meanwhile, Ministry of Finance assistant director at the Investments and Debt Management Department Mwila Kasase-Zulu has appealed to all stakeholders to help government bring the country's debt back to sustainable levels.

In an analysis of government spending released in Lusaka yesterday, the Zambia Institute for Policy Analysis and Research (ZIPAR) shows that while government spending on debt interest payments for the first half of 2018 was much more than planned, spending on key social sectors are not receiving promised funding in line with the 2018 budget.

ZIPAR disclosed that government spent K9.1 billion on debt interest payments for the first half of 2018, which was far higher than planned, compared to the K6.2 billion budgeted for.

According to ZIPAR's data, only 27 per cent of the budget for Social Cash Transfers has been dispersed, amounting to K197 million, against the intended K411 million that should have been disbursed by the mid-year point.

Support for the 574,000 poor households who in 2018 are

intended to receive Social Cash Transfers has been dealt a huge blow due to debt interest repayments.

Speaking during a presentation of the analysis of the midyear budget performance, Nalishebo revealed that government's debt interest payments have squeezed spending on social services, and are even higher than education sector spending.

"Previously, interest payments used to be way down our ladder in terms of government spending. But now, interest payments are even higher than our spending on the education sector," Nalishebo told stakeholders at Taj Pamodzi Hotel.

He explained that government's capital expenditure continued to rise at a worryingly high pace during the half-year period under review.

"If you look in more detail at capital expenditure; we spent K12.4 billion in the first half against a projection of K7.5 billion so we went K4.9 billion overboard. So, by June (2018), 85 per cent of what we planned to spend on capital expenditure was already spent! And this is the largest source of budget overruns," Nalishebo added.

"I can't emphasize this hard enough: with the high capital expenditure from borrowed money, and increasing debt servicing costs, we don't have enough funds available for other critical spending such as social services, operations and maintenance."

He reminded all stakeholders that government's huge public debt affects everyone.

"If you are going to have cuts in recurrent departmental charges, this is the reason we have the shortage of drugs in health facilities...and even when it comes to education; lack of funds for school supplies are affected. So, most of you who think that debt is just this big figure up there, which does not affect you? You are wrong! It really goes down to the individual, and these are the effects of what debt can

do," he said.

"And because a lot of these are not being paid up, it has led to the accumulation of arrears." And Nalishebo revealed that government added K1.3 billion to the total debt stock in just a six-month period between January and June this year.

"Looking at the financing figure, Zambia has effectively added about K1.3 billion to the stock of government debt in the first half of the year because of this borrowing. Usually, this figure of around K1.3-K1.5 billion is usually what we borrow for the entire year. But this is just half-year; we have already hit K1.3 billion! Hopefully, those austerity measures will really kick-in so that this figure really slows down and we continue being in the figures that we have seen previously," he said.

"If this was a movie, it will be called 'K1.3 billion coming soon to a debt stock near you' because our deficit was K7.3 billion, and that's what we were supposed to borrow, but we ended up borrowing K13 billion instead."

He further stressed the importance of government seizing that all-important International Monetary Fund (IMF)-backed bailout package.

"Foreign grants continue to be erratic. At mid-year, we have only collected nine per cent of the planned grants for the year. We need to be realistic in terms of even how we do the projections for grants because, really, without the IMF programme, a lot of the commitments on foreign grants won't be met," Nalishebo observed.

He also advised that government should re-visit reversing the 80 per cent completion threshold for construction projects to revive economic growth.

"In the austerity measures, government mentioned that, 'anything that is below 80 per cent in terms of completion of projects, we need to cut off [funding]? What we are saying

is, we need to revisit that threshold because what if some of those of projects, which is at 50 per cent completion rate, is actually more economically or socially viable than something that is at 80 per cent. Why not prioritise a project like that, that is going to bring you the growth that you need rather than just a blanket statement of 80 per cent?" asked Nalishebo. Meanwhile, Zulu, who was the keynote speaker on behalf of the Ministry of Finance, appealed to all stakeholders to help government tackle the looming debt crisis.

"I wish to urge all stakeholders and citizens of Zambia to rally behind government as it implements the debt reform measures that will ensure that Zambia's debt is brought back to sustainable levels," said Zulu.

The ZIPAR analysis of the mid-year 2018 budget performance was held under the theme: "What does the mid-year budget performance mean for Zambia's Public Debt and Service Delivery?"

## Mwanakatwe will not wait for IMF if China offers favourable conditions – State House

Special Assistant to the President for Press and Public Relations Amos Chanda says if the International Monetary Fund (IMF) takes 50 years to come through with a balance of payment support programme for Zambia, Finance Minister Margaret Mwanakatwe will not wait, but look elsewhere for help, including China.

And Chanda says President Edgar Lungu, who left for China yesterday with a huge government and private sector delegation, will remain in that country until September 7th to enhance economic ties as well as renegotiate Chinese debt, among other activities. Speaking when he addressed journalists at State House, Chanda said all options to improve Zambia's debt sustainability were being pursued. "All options to improve Zambia's debt sustainability are available. But the trip that the President is undertaking to China today is to increase economic cooperation. If on the mutually-agreed platform, the owners of Chinese debt agree to renegotiate it, that will be done. That is what the Finance Minister is doing - to improve the terms of these loans, probably to improve

the tenor or probably increase the repayment period; to probably look at interest as well. But the broader term she is using is debt restructuring. So, what she will be doing is to renegotiate Chinese loan terms, if not on existing debt, then any debt that may come from there," Chanda responded when asked if Zambia was looking for balance of payment support from China.

"So, she (Finance Minister Margaret Mwanakatwe) has not made a specific request for balance of payment support, but if she finds the financing arrangements in China favourable, she may get because she is looking for any affordable financing from any direction." Asked if a balance of payment support deal with China would not jeopardise the on-going negotiations with the IMF, Chanda said Zambia was not going to wait for the IMF to run its economy. "The Minister of Finance runs the economy on a daily basis, so if the IMF is coming in 50 years, she will not wait, she will go to the market and seek favourable terms to negotiate. The desire to run the economy properly or the austerity measures are not dictated from above, the need to control spending

is not a condition from IMF, if it's a condition it's coincidental. It is a conscience of the Cabinet to control spending and reduce borrowing and make sure that there is no wastage in spending...if that is done without the IMF programme, so much the better; if the IMF programme works that's good also," Chanda responded.

"The IMF representative [who has been withdrawn from Zambia] a diplomat, so whatever has happened is being communicated within the diplomatic channels. What has been stated officially by the Ministry of Finance is that the IMF rep has been withdrawn for redeployment and a new representative will be sent, and the process for the programme is on-going. That is the position of the Minister. In this case, the IMF has withdrawn Dr Baldini and the reasons for the withdrawal would be undiplomatic to communicate in the media. But according to Honourable Mwanakatwe, the IMF are coming for Article 4 consultation any time soon, that tells you that the process is still on." Chanda then went ahead to outline President Lungu's agenda in China. "The President will this (Thursday) evening travel to China to attend to two major events. There is a bilateral summit between the President of China Mr Xi Jinping and President Lungu on the 1st of September. The two leaders will discuss a broad range of cooperation agreements mainly in the economic sector; but they will also be discussing the long-standing cooperation in the political sphere,' he explained.

"Then on the 2nd of September, President Lungu will address the China-Zambia Investment and Business Forum, to be hosted by CNMC, the biggest Chinese investor in Zambia who owns Chambishi Metals and other facilities such as the Airport Multi-Facility Economic Zone. The President will deliver a keynote address to those Chinese companies. He will also tour some selected companies." He said President Lungu was travelling with an unprecedented private sector delegation. "On the 3rd and 4th of September, the President will then join 45 other Heads of State from Africa who will be attending the Forum for China and Africa Cooperation, otherwise known as FOCAC. Then on the 5th and 6th , President Lungu will then move to Jiangsu Province to tour some facilities, including some copper processing plants and also to witness the signing of an

agreement between the Province of Jiangsu and Muchinga Province of Zambia. They will enter into a specific economic cooperation agreement where there will be technology transfer from China to Muchinga and vice-versa," narrated Chanda.

"I can add that a sizeable number of private sector people will be travelling alongside the President. I do not know the actual size of the private sector delegation, but what I can confirm is that government is facilitating to ensure that the difficulties that a private sector person may have when going are taken care of, otherwise they are financing themselves. It's a huge delegation in all fields, mining, fishfarming, manufacturing, tourism, road construction, technology and all other areas where the Chinese private sector is interested in. For diplomatic constraints, I cannot tell you details. ### ZNFU urges govt to pay farmers, in disarray. The Union is By Mirriam Chabala

Zambia National Farmers Union (ZNFU) president Jervis Zimba has asked the Ministry of Finance to release funds to pay farmers for crop marketing and input supply. In a statement issued Thursday, Zimba stated that it was regrettable that late paying of farmers had become a norm.

Zambia "The National Farmers' Union would like to urge Government through the Minister of Finance and the Minister of Agriculture to put priority on release of funds to pay farmers for crop marketing and input supply. We are in the middle of crop marketing and farmers are not being paid instantly by the Food Reserve Agency (FRA) for the maize supplied and some input suppliers have not been paid for inputs supplied under FISP. It is regrettable that not paying farmers on time has become the new normal way of doing business when dealing with the FRA as opposed to being an exception, why? Most farmers depend on rain-fed farming thus get one income stream in a year," Zimba stated.

Zimba observed that continued delay in paying farmers might lead to poor implementation of the FISP e-voucher.

"Therefore, delaying paying them results in a chain reaction because depositing of funds will not take place on time for the FISP E-voucher and all the good plans thrown

concerned because it is such delays that will lead to poor implementation of the FISP E-voucher again yet this is a very good programme which could emancipate the farmers and contribute towards diversification," Zimba observed.

He advised the treasury to speed up its decisions relating to farmers' concerns saying rains did not wait for anyone. "Notwithstanding all the competing demands on Government, it is time to walk the talk and avoid repeating the same mistakes every year because the cycle of crop production is known by all. Our reminder to the Treasury is that rains do not wait for anyone

### CiSCA backs Church's bid to lead dialogue

"Therefore, CiSCA supports the role of the church in spearheading national

dialogue. Those who are against the church taking lead must realise the importance of the church's role in such matters from the history of our country. We urge all Zambians to rally behind the church-led national dialogue. CiSCA will not be part of the group of citizens to frustrate the efforts of the church based on political formation but will continue to support church efforts in given that the pioneer of the said dialogue at a time when it was very unfashionable to talk about the national dialogue and when ruling elites and their sympathizers denied the existence of political tension and crisis in this country."

Therefore, we condemn the trading of insults by senior leaders and their lack of respect for the people living with HIV," said Mulenga.

## Kambwili, Mwamona Ltd sue Tayali for defamation

NDC leader Chishimba Kambwili and Mwamona Engineering and Technical Services Limited have sued Economic and Equity Party leader Chilufya Tayali in the Lusaka High Court, claiming damages for defamation of character and mental anguish.

The plaintiffs, Kambwili and Mwamona, have stated that Tayali uttered defamatory words against them at a press conference last year on October 27, when he accused the directors of Mwamona, as well as Kambwili, of fraud. Tayali had said at the press conference, among other accusations, that when Kambwili came back to Zambia from UK after PF had started gaining mileage, he had no money and was just renting a house, but today he was worth more than K50 million. He had charged that Kambwili had fraudulently acquired Mwamona and registered it in his son and wife's names to hide his corruption. "Which business can you do within seven years to have 50 million? I know how tough business is. But I will tell you how Kambwili has managed to get that 50 million... Fraudulently, Kambwili registered a company called

Mwamona...The 50 million worth of properties that I'm talking about, most of it vou won't find it in CKs name, you won't. And this is why he boasts to say 'I'm as clean as KK's handkerchief', it's because the properties that he has fraudulently or corruptly acquired are not in his name...," Tayali had charged.

But in a statement of claim filed in the Lusaka High Court, Thursday, the plaintiffs stated that the said words were false, malicious and defamatory. They disclosed that they had been severely injured and their reputation had been brought into scandal, odium and contempt in the eyes of the society as the result.

## **Policy inconsistencies have made** illicit financial flows thrive - CSPR

**Bv** Thomas Mulenga The Civil Society for Poverty Reduction (CSPR) says illicit financial flows are rampant in Zambia due to lack of consistency in government policies aimed at combating the scourge.

Speaking when he featured on an OSISA funded 'PA Bwingi Project on ending illicit financial flows' UNZA Radio program, Wednesday, CSPR executive director Patrick Nshindano said there was need for efficient political will locally and internationally in order to curb illicit financial flows.

"What the problem has been in terms of curbing illicit financial flows is partly because of inconsistency on the part of us as a country and specifically government. I think when you realize that there is a problem like we did with the mining sector where we are saying ok this is how we are going to tackle this issue of illicit financial

flows then because of the backlash, we backtrack then a few months later again you bring in another tax and so on, so that level of policy inconsistency on the part of government does affect issues to do with tackling issues to do with illicit financial flows," Nshindano said.

"But it is also a very complex issue that needs a lot of political will beyond borders of a country like Zambia. You need to have a lot of corporative corporations of tax authorities out there because money is taken out of the country so you need systems that are able to first and foremost crawl back moneys that seem to be either of illicit flows but also in certain instances illicit flows can actually be proceeds of criminal activities and this is also a dangerous part which could also be a threat to national security."

Nshindano said lack of strong investigative wings to track the illicit flow of finances had also contributed their persistence. "We are a fully liberalized country both economically and financially so what that means is that people are free to move money in and out but also our systems have not grown, they are not strong enough to be able to detect some of these issues with regards to financial flows and that's why if you are going to tackle issues to do with illicit financial flows there has to be very strong government to government corporation because it is not an issue that can tackled within the jurisdiction of Zambia alone because it is a very complex issue and a lot of money does get out of this country, and the onus is on us to be able to ensure through the revenue authority and different wings of government such as DEC, ACC work hard to end the scourge," Nshindano said.

He noted that money that was acquired through illicit means was mostly externalized and kept in official accounts, thereby denying local people an opportunity to borrow money from local banks at cheaper rates as there was no excess money in local banks. "If somebody regardless of the transaction that they do, decides instead of keeping money with ZANACO, they move money dubiously out

of the country and go and put it in Bahamas or the Virgin islands, known to be a tax haven, what that does is that it's robbing the country of the much needed capital which if it sits in a bank like ZANACO you have liquidity. But what you have is that there is no liquidity, money is being taken out of the country which pushes up interest because there is no money that even the banks don't have excess to be able to bother about the small business people but worry about the bigger ones because they know first and

foremost that there is security

and they will be able to get a higher return. But also for a country like Zambia where you have a high presence of government participation in the financial market through issuance of bonds and securities, the banks prefer to deal with government because it's a guarantee the risk there is very minimal and so the local economy tends to die out," Nshindano explained.

He added that illicit financial flows had led to loss of revenue by government through tax avoidance by multi-national corporations.

"The bottom line is that illicit financial flows leads to a loss of resources on the part of the government, and the resources are actually lost into foreign hands, through taxation. If you look at the records of the mining companies, I stand to be corrected now, but based on the past records none of the mining companies in Zambia have actually paid corporate income tax. Most of them end up just paying mineral royalty which is basically a rent and they all indicate that no either loss making positions and all these things and the question has always been if you have been loss making for the past ten years why are you still here and those are the questions that are there and to be able to tackle that, one of the things government tried to do was come up with a single tear tax system where they say it doesn't matter what you do, your profit base or whatever challenges or how you can do your calculations, what we want is basically a rent on the mining and what we are going to do is make it fixed and charge it on that but there was a lot of backlash to that effect because the fixed mineral rovalty did not take into consideration the cost burden and operational cost of a mining company," Nshindano said.

"So based on existing tax system you find that one may decide to manipulate their account and just declare the one that is giving them the lowest kind of tax burden so instead of operating at the 35 corporate income tax despite their earnings coming from that kind of amount they decide oh ok am going to pick the lower one which is an incentivized one, mainly because just a quarter of the activities is coming from that, take an example of agriculture because agriculture now is taxed at 10% so you find an entity that has a component of agriculture instead of paying the full corporate of 35, they decide to say our activities are under agriculture meanwhile that is not the case so you find that the country tends to lose a lot of resources."

Nshindano said illicit financial flows had contributed to none delivery of social services and improvement of peoples' living standards.

"Our call as civil society has always been can we ensure that we tackle the issue of illicit financial flows because even the debt burden that we are now suffering from is just as a result of that because as a country we are growing, the needs are growing every single day and government needs to ensure that it provides these services and can only do that through taxation but you only have a very few pool of people that are contributing to the coffers of the country most of the burden is placed on the agriculture sector," said Nshindano.

## **NDC warns PF to leave police** out of political battles

The National Democratic Congress (NDC) has asked the PF to stop using police in its political battles, saying opposition parties have the right to hold public meetings because Zambia is a democratic country.

The Lusaka Magistrates' Court has acquitted seven Natural Resources Development College (NRDC) students who were arrested for malicious damage to property during a riot.

The seven, Peter Tembo, 21, Peter Mwenya, 22, Benjamin Musonda, 23, Jacob Mpepo, 22, Given Nyimbili, 24, Sokoni Mahone, 20, and James Fusankolo, 21, were acquitted after the complainant, NRDC registrar Manda Sinkala decided to withdraw the case in court saying they wanted to handle the matter administratively.

It was alleged that on August 20, 2018, in Lusaka, the seven students jointly and whilst acting together, willfully and unlawfully damaged two hostel window panes and a rear window screen of a motor vehicle registration number BAD 1122, properties which belonged to the

#### institution, all valued at K13,500. When the matter came up for plea before magistrate Mwandu Sakala, Thursday, the seven students denied having committed the offence.

And addressing the court, NRDC registrar Manda Sinkala, 46, said the college had decided to withdraw the matter so that it could be handled adminstratively.

"After extensive consultation from stakeholders, we wish to withdraw the matter so that we handle the matter administratively. This is in consideration that we are dealing with students and we feel that the option of handling it administratively will be more convenient for all parties," said Sinkala.

After the application, the State applied to have the complaint withdrawn.

The defence lawyers did not object to the application.

They however added that once a

complaint was withdrawn, the next step was to acquit the accused persons in compliance with the law under the provision of section 201 of the CPC. In her ruling, Magistrate Sakala granted the state the application to withdraw the case and acquitted the seven.

"In accordance with section 201 of the CPC, I hereby grant the application by the registrar to withdraw the matter and hereby acquit all seven accused persons. They are free to go," she ruled. And speaking after the court session, one of the accused persons, Given Nyimbili, said he was grateful to God for being set free.

He urged his fellow students to avoid finding themselves in such situations. "I just thank God for everything. I urge my fellow students to avoid finding themselves in this situation and refrain from such (acts)," said Nyimbili.





## India may face sanctions if it buys Russia's S-400 missiles: US

The US cannot guarantee India will be exempt from sanctions if it purchases weapons and defense systems from Russia, a top Pentagon official said.

Randall Schriver, the Pentagon's top Asia official, called into question on Wednesday the idea that the US will protect its relationship with India and that it will be insulated from any fallout if the purchase happens.

"I would say that is a bit misleading. We would still have very significant concerns if India pursued major new platforms and systems (from Russia)," Schriver said at a think tank event according to Reuters news agency.

The US has imposed sanctions on Russia for its annexation of the Ukrainian peninsula of Crimea, which means any country that engages in defence or intelligence sharing with Russia could also be subject to sanctions. "I can't sit here and tell you that they would be exempt, that we would use that waiver, that will be the decision of the president if he is faced with a major new platform and capability that India has acquired from Russia," Shriver added.

The waivers would be possible according to a new US defence bill, which gives President Donald Trump the authority to exempt countries.

Despite Secretary of Defense James Mattis saying he is a strong proponent of granting India waivers, Schriver said that just because Trump

has the ability to apply these waivers it does not automatically mean he will. India is in the final stages of acquiring S-400 longrange surface to air missile systems from Russia, a deal worth \$6bn.

The agreement is expected to be signed by Russia later this year.

The acquisition of the S-400 system would be the latest in a long series of Indian defence purchases, as the country has previously bought combat planes, ships and submarines from Russia.

Schriver stated that the US is concerned about this planned purchase, and is willing to talk to India about potential alternatives to the Russian missile system. AL JAZEERA

## Air raid warning tech gives **Syrians life-saving minutes**

Khaled al-Idlibi was still speeding away with his brother perched on the back of his motorbike when he heard the air strike that levelled his neighbours' house in northwest Syria.

Those crucial extra minutes were thanks to a warning system that could help save civilian lives in an expected regime offensive on Idlib province, home to the last significant rebel-held area. The Sentry programme,

launched two years ago by two Americans and a Syrian coder, uses human observers and a network of sensors to compute a predicted impact location when Syrian or allied Russian warplanes take off.

The resulting estimate can then trigger air raid sirens near the target zone and send warnings to mobile phone applications, giving residents more time to take cover.

Idlibi, a 23-year-old media activist, lives in Maaret al-

Shureen, a rebel-controlled town in Idlib.

On June 10 last year, he was picking up belongings he had left behind while fleeing from an earlier air strike when his smartphone suddenly lit up. "I received an alert on

Telegram that a new warplane had taken off towards the same area," he said, recounting that he and his brother jumped on their motorbike and rode to about a kilometre from the predicted impact spot.

Idlibi said "only three children were wounded that day" and estimated that up to 15 lives may have been saved by the Sentry alert.

First launched in August 2016, the Sentry technology has become a sort of weather forecast service for many Syrians.

The system's creators say that it has proved its worth, including during the intense air campaign against the rebel stronghold of Eastern

Ghouta, earlier this year. "We saw a huge spike in use

as the campaign ramped up," John Jaeger, a co-founder of the Hala Systems firm that developed the technology used in Sentry, told AFP.

Jaeger, a former US diplomat and technologist who was looking for new ways to prevent civilian deaths in Syria, created the system with US entrepreneur Dave Levin and a Syrian coder whose identity is kept secret.

The system -- which Jaeger says is currently funded by Britain, Canada, the Netherlands and Denmark -requires a human network on the ground to monitor areas and set up sensors.

It is therefore limited in which zones it can cover. It does not, for example, provide updates on US-led coalition warplanes targeting the Islamic State group in air strikes that have also routinely killed civilians. Hala Systems estimates that its warning system is available to around two million people in Syria, most of them in Idlib. Jaeger said that, while reliable statistics were hard to come by, data analysis showed that 27 percent fewer people died in air strikes on areas where Sentry was used. Residents who get an alert via social media, local radio stations or the air raid sirens that Hala triggers remotely have an average of eight minutes to seek shelter, Jaeger said. AFP

first victory of the 2018-19 campaign when facing the Hammers last time out, with Emery relieved to collect a 3-1 success after seeing his side fall behind on derby day.

The Gunners are now up and running after taking in a testing start but Keown believes there is still plenty of work to be done, particularly at the back.

### Serena, Venus to clash for 30th time as Cornet shrugs off US Open sexism storm

Serena and Venus Williams set up a 30th career meeting on Wednesday as the US Open reeled from a sexism row sparked when a player changed her shirt on court. Six-time champion Serena eased into Friday's third round encounter against her sister with a 6-2, 6-2 win over German world number 101 Carina Witthoeft on the back of 30 winners and 13 aces.

Venus, the 2000 and 2001 champion, made the third round for the 17th time with a 6-4, 7-5 victory over Camila Giorgi of Italy.

Friday's match will be the earliest the sisters have met at a Slam since the 1998 Australian Open in what was also their first ever clash. It will be their sixth face-off in New York.

"Friday will be incredibly hard," said Serena before jokingly hitting back at Venus's claim that when they

We would have liked to have played later but it is what it is. It's not the end of the world," added Serena.

Venus, 38, and playing her 80th Slam, notched up her 775th career win by seeing off Giorgi.

However, she was reluctant to discuss Serena when asked to describe the specific challenges.

"You're beating it up now. Any other questions about anything else?" she barked. Defending champion and third seed Sloane Stephens also made the third round with a marathon 4-6, 7-5, 6-2 win over Ukraine qualifier Anhelina Kalinina.

Stephens triumphed after 2 hours and 46 minutes on Arthur Ashe Stadium and will next face two-time Australian Open champion and former world number one Victoria Azarenka. The American needed treatment on a blistered right hand in the second set as the crushing effect of the heat and humidity took its toll. However, the 10-minute heat-break between the second and third sets proved a timely boost.

"I just sat on the floor, changed my outfit, had two bites of Sushi and a slushie," said the 25-year-old Stephens after seeing off world number 134 Kalinina.

Azarenka, the 2012 and 2013 runner-up, made the third round for the first time in three years with a 6-1, 6-2 win against Australian 25th seed Daria Gavrilova.

- '10,000 times worse' --Azarenka was amongst the first players to condemn the United States Tennis Association (USTA) for handing French player Alize Cornet a code violation for changing her shirt on court on Tuesday. The incident sparked an

immediate storm over sexism. The Belarusian said the USTA displayed double standards for sanctioning

Cornet while male players routinely remove their shirts courtside when the heat and humidity bite.

"If I would say my true feelings, it would be bleeped out, because it was ridiculous," said Azarenka. The USTA admitted they were wrong to hand Cornet a warning for slipping off her shirt on court after realising she had put the garment on back-to-front during a heatbreak.

Cornet said she was stunned that the furore had caused so much controversy and was happy to accept the USTA's apology. *AFP*
