Musa Dudhia and Company, one of the largest and oldest law firms in Zambia, has sponsored an inter University Moot Court competition for law students from four Lusaka based Universities. Speaking in an interview with News Diggers! can only work if we have good lawyers who are able to interpret the law and provide the necessary skills and ensure that clients feel safe," she said. "This is part of our corporate social responsibility, there is no payment involved, we are

doing this at our own time, at our own cost. We feel these young student lawyers have the necessary knowledge but we have to give them the necessary practical aspect to what they are learning. Last year there was a cash reward

of K5000 and an internship to work with our law firm. So this year too, there will be a cash prize, the amount has not yet been set but by the time we reach the semifinals, we will know, and the internship is still available

finals, we are now going in the semi-finals. We have already picked winners from UNILUS, CAVENDISH and ZICAS, so UNZA is the last group to qualify to go to the semi-finals. The Universities will be competing against each other, today it was only UNZA against UNZA. The two Universities that will win the semifinals will compete in the finals which will be held in the Supreme Court chambers. So that's what we are aiming to do, exposing them to real Supreme Court judges and real life court," said Chiumuka. And winner of the UNZA moot court quarter finals, Mainga Simoonga, a third year Law student, said it was a privilege for him to be part of the competition. "I feel so privileged and honoured to be surrounded by so many people in the University of Zambia, particularly the school of law that are willing to support us to ensure that we get far. I am a product of so many people coming together and believing in me, I owe this success to my friends who helped me with the research because the greatest of people are those who lean on the shoulders of others," said Simmonga.

Speaking to Chingola residents yesterday when he visited Luano area, Kalaba told Zambians to rise up against the Patriotic Front government in the next election, saying the people had been robbed and taken for granted for far too long. Kalaba who is also 2021 presidential aspirant, asked residents to vote for him if they needed change in the way the affairs of the country were being handled. "Kuno kumwesu, nachisa ndeenda, namona ifyo abantu baikala nati tamwaikala bwino kuno. Batila ichalo bapata abantu, bamwena ku nkonko. So kuti mwamona ukutula kuno ukwisafye kumusebo ndeisa, nokwishiba naishiba ukuti aba abauku balibusula. Mu 2021, ndefwaya mukeme chipipya kuno nokulanda ukutula 'uno mwaka tatwamishindike, mwatulila masuku pamutwe pafula. Apa pena ni tula twabane... mu 2021 PF kuya bebele, tekwesha nokubwelela iyo (I

came to this place walking so that I can see how you are living, and I have seen that you are suffering. It is said that a country where people are not loved, can be seen even from chickens. So you can see even from a distance that you people here are not respected by your leaders. But when elections come in 2021, I want you to move in your numbers and say 'we have escorted you [to State House] enough and you have always taken what's ours but now it's enough. In 2021 PF should leave without fail,'" Kalaba said. "Just like you have heard, I used to be Foreign affairs Minister. But I resigned because I saw that there was too much suffering in this country, as you are seated here some of you don't even know what you are going to plant this year. You have no idea how your children will go back to school, this is all because you have no sources of income. So me I have just come to tell you that in 2021, even I the son of Mr Kalaba will be eying for that shoe of Presidency. Are you going to support me? (audience cheering) You are the ones holding keys to your freedom, if you just open the door [by voting for me], even the fertilizer you are crying about will always

come on time. If you just use those keys to open the right door, even the lives of your children will completely change for the better." And Kalaba regretted that the Chinese nationals were taking away the ownership of the country from Zambians while citizens watched helplessly. He further asked Zambians to stand up for their country. "You have seen that this country is no longer in our hands, this country has been auctioned to foreigners and then we the owners of the country are just admiring

from afar. Stand up with me and other well meaning Zambians so that we can repossess the ownership of our country. The people doing our roads are Chinese, the people constructing our Airports are Chinese, even schools are being constructed by the Chinese. So what then will our own Zambian contractors make? We are just admiring where our own money is going. Where I come from they say 'a community's wealth is kept together with the people you know'. Unless the SIM card in your head

is damaged, you cannot prioritise the needs of your friends child when your own child is suffering," said Kalaba. "So am asking you, when that day [for elections] comes, go in your numbers to make the right decision. Don't be scared of these [PF] people, not even a little bit. If you get scared of them then you will be neglecting your country. If you start fearing the PF, they will continue eating while you will be suffering just like you are suffering now. The only things you will be benefiting are T-shirts and

Vitenges (wrappers) because that's how they know you. They think your votes are that easy to buy, but this time you should show them that the resources of the country must be shared equitably. You have been cheated for long. You have been so consistent in voting for these people but there is nothing that you are benefiting in the end. But are you also not people? Don't you also want to eat? Don't you want fertilizer and capital you women gathered here? So me I have spoken and this is where I have ended."

Zambia can still achieve a GDP growth rate of 4.5 percent

Economist Chibamba Kanyama says Zambia can still achieve a Gross Domestic Product (GDP) growth rate of 4.5 provided inflation rate remains below the 7.6 threshold. Kanyama told News diggers in an interview that the current inflation rate of 8.1 was a source of concern for investors and that it should be arrested sooner than later. "Though not an alarming figure, it requires significant attention and response by the authorities so that inflation does not compromise the economic growth target. I am not fully aware of the reasons why inflation has breached

the 8 percent mark at the time we expected it to drop given that the maize crop for 2018 is now in the market. Maize has significant weighting in the inflation basket and the price announced by the principle buyer, FRA, is non-inflationary. However, I can only speculate that the fuel price increases made in April are beginning to have an effect in the general price level by both the transport sector and manufacturing. There is usually a lag in industry

responses to fuel price adjustments. There is also a possibility [that] residential accommodation has had an impact on inflation," he said. "The withholding tax requirements on rent income is now beginning to hit landlords, more so ZRA is understood to have appointed an agent to manage the process. Many landlords are refusing to lose an income and are, therefore, adjusting rent upwards to cushion the cost. The service industry

has generally responded aggressively to withholding tax. Remember this new approach of withholding tax at source has sealed all loopholes of tax evasion and avoidance and you will now find invoices that compute tax as a fee adjustment to the client. In a way, withholding tax for services has translated into an increase in fees. You may wish to know, as I understand, that accountants have significantly increased audit fees. This alone has

marker implications. If Zambia Breweries, Chilanga Cement, Zambia Sugar for example, are to pay twice or thrice more in audit fees than before, I do not see any reason why they will not pass on this extra cost to the consumer." He warned that failure to control inflation rate would downgrade expected real GDP growth rate. "This may have happened to some companies in the past few months in anticipation of what they will pay in audit

fees. Inflation has also been driven by scarcity in certain consumables such as tomato in April, May, June as well as Kapenta. The whole issue is that 8.1 is a move towards double inflation, something we do not want to experience after the 2015/16 economic challenges. The rate also breaches the anticipated threshold by the Bank of Zambia. Remember recently BoZ indicated we may end the year at around 7.4 inflation rate and this is within the 2018 budget projections. If we do not arrest the increase in the rate of inflation, we risk downgrading our expected real GDP growth rate, a number that is closely watched by investors and creditors to government," Kanyama said. "The rate as it stands may also tempt the BoZ to respond more aggressively through its monetary instruments to bring down inflation. What Zambia does not need at the moment is a strong handed monetary policy approach. So far, the BoZ has been pro-Economic activity, maintaining its policy rate to slow for expanded loan books by commercial banks. This has somehow yielded positive results towards productivity and all hints remaining equal such as the exchange rate remaining at less than K10/dollar and the copper price remains at above US\$6000/Tonne, Zambia can achieve a growth rate of 4.5 percent, not bad when we consider the fact that maize output was lower than last year. If BoZ intervenes in the market, it will impact on interest rates and availability of loanable funds to industry." He said any instability in the economy currently would adversely affect members of the public and make investor lose confidence in the government. "In addition, this is not the time for Zambia to experience instability in macroeconomic variables particularly inflation, exchange rates and inflation rates given the huge debt stock. We also do not want to see a response from unions for cushion-backed salary increments because it will compromise the current strategy on economic austerity. All this requires a pragmatic and strategic approach that ensures inflation does not break into the double-digit figures as we close the year a snit has potential to affect investor confidence. As things stand, inflation is arrestable and my anticipation is that it will be around 7.6 by end of October," said Kanyama.

PF can't discipline KCM because it's suppliers are top govt officials – Kalaba

The PF government cannot take action against Konkola Copper Mines (KCM) for not paying its contractors because senior government officials are the biggest suppliers for KCM, says 2021 presidential aspirant Harry Kalaba. And Kalaba says he does not need the permission of any court for him to contest the 2021 general elections because it is his constitutional right. Speaking when he featured on a special interview on iWave radio in Chingola, Kalaba charged that the PF government could not take any action against KCM because the mining giant fed government officials and gave them handouts. "The reason you are currently having problems with KCM is because your leaders are dining with the bosses at KCM... the President was here recently, who prepared for the hosting of the President? It was KCM, everything is KCM, the boardroom was for KCM. How then can KCM pay their suppliers and contractors if the government that is supposed to ask them to do that is eating their food? Can government really have the authority to instruct them to do what is right? These jokes in government must come to an end, people are suffering and dying from diseases that are not supposed to kill them all because of the selfishness of the government. KCM is the biggest employer here in Chingola, now if KCM doesn't want to pay contractors and suppliers and other workers then what will become of Chingola?" Kalaba asked. "The Minister of Mines gave



KCM a seven day ultimatum in which KCM needed to pay its workers but that seven days has elapsed and KCM is not worried about the action government would take because they know that MPs and other top leaders in PF are the biggest suppliers for KCM. So how can they end this problem? Each time they want some money for fuel or any pocket money, they just go to KCM and ask for a little something. But you can't run a country like that, takwaba, you cannot have your cake and then eat all. So this is the problem we have at hand and we want a leadership that would challenge KCM to say 'what you are doing is wrong and it cannot continue in Zambia because you are making people suffer. This behaviour by KCM will kill this town of Chingola because the way it is with contractors, once

you owe them their salary arrears then it means the suppliers will also be under pressure from the bank they borrowed money from. And they are even seated saying 'no we will talk to them and everything will be okay.'" Kalaba warned that KCM's days in Zambia were numbered. "We want our people to be saved from this suffering, KCM is having their last laugh. We have to stand up and say 'no' to this nonsense, it's too much, mwachusha abantu pafula [you have mistreated people enough] and we can't continue like this. So for me this issue of KCM, I am following it steadily because I want to see how far this story will go and how many more deaths will be recorded in the future. Why is KCM so special? KCM is not the only mining company that we have in this

country, we have Lumwana, we have Kansanshi," he said. "So why don't we hear these issues of none payment to contractors are Lumwana and these other mines? So the only thing that is special about KCM is that they are eating with leaders in the PF government, that's the only reason why they are so special. Anything else, if they were not giving our leaders any kickbacks, they would have already been dealt with. I know how my colleagues [in PF] deal with issues. So the only reason why KCM is special is that the biggest suppliers are the leaders in PF, that's the only reason why they are special. So for me I sending notice to KCM that today they can get away with it but I can tell them that days are numbered. And you know who is suffering in the end? it's the local people of Chingola. Really what

kind of selfishness is this?" Meanwhile, Kalaba said he does not need the court's permission to contest elections in 2021. "In 2021 I am also going to contest the Presidency because I am eligible to stand. And in this country, anyone can stand as President as long as you are 35 years old, that's what our constitution says. If you are 35 years old, you can stand as President. So I am eligible, I qualify to stand as President and I don't even need to consult the courts if I can stand as President or not, for me it's straight forward. So in 2021 I am standing because I am convinced that the problems we have as country require the effort of all us as citizens to be addressed. So please support me by voting for me so that we can save this country of ours," said Kalaba.

Abolishing bank charges could lead to job losses, BAZ warns

The Bank of Zambia's (BoZ) decision to abolish bank charges will only cripple the financial services industry and may result in some banking staff getting laid off, warns the Bankers Association of Zambia (BAZ). BoZ recently notified financial institutions, including commercial banks of its intention to abolish unwarranted bank charges, such as ATM charges, among others. The central bank last week announced that it has completed phase one of a review of unwarranted charges by commercial banks, which look set to be abolished. But BAZ chief executive officer Leonard Mwanza said that there was a justification as to why commercial banks slapped such charges on clients. He also warned that members of staff face getting sacked as a result of commercial banks who may choose to downsize. "So, as the central bank is proposing to reduce income on non-interest income via the fees and charges, it's very important for to ensure that we protect the stability of the banking sector from worsening because once we start having a stressed banking sector, I think the implications of the economy are much wider. We really don't want to see a tomorrow where we start seeing re-structuring processes in the banks and you know that whenever there is a hit on income, the first line, which is always looked at is staff cost. So, we don't want a future where tomorrow, banks are restructuring, we don't want to see banks laying off people. We don't want staff in banks to be laid off because of a decision that has been given on a populist demand position," Mwanza cautioned in an interview with News Diggers! He did, however, confirm that commercial banks received the BoZ notification on their intention to abolish unwarranted bank fees and charges. "I wish to confirm that the central bank has indeed given notification to all the commercial banks on what they deem to be unwarranted charges. And the only issue I need to speak to you is that at this stage the information was for notification purposes only to allow commercial banks and the central bank to discuss in detail so that banks are given an opportunity also to try and pull to the central bank that for some of those charges they highlighted where the fees are on a cost recovery basis, needs some kind of justification because there is a lot of infrastructure banks have to put in place to conduct those charges and in the process the discussion is about banks being able to

bring out their point of view in as far as the justifications to certain lines of charges. So, at this stage, what we would say is that, what the central bank did was to compare charges across the industry and where they felt a particular charge may be is not applicable to a number of banks they deemed may be unwarranted," Mwanza, a former Natsave chief executive officer, narrated. "But then, banks have different costs of structure, they have different strategies and investments that drive their businesses, so you cannot expect every bank to be at the same level. There are those

banks that are into retail and have various channels and that point of charges are to deliver some of this service. There is a justification that they need to at least recover the cost in order to ensure that, that service is continues to be provided. So, all I can say at this stage is that, there are some engagements in terms of trying to ensure that the views that are being expressed by the central bank, obviously which is maybe review of a number of people in the market who are complaining that the bank charges are relatively high, but on the other side, the banks have a reasonable

justification why certain costs and certain charges are there." He added that BAZ would liaise with the central bank to abolish just a few of the unwarranted charges. "So, I'm confident that in the very near future, a proper communication in terms of what will be the way forward in terms of what charges the central bank might agree that they should not apply and the future in terms of charges and fees in the market. So, it's all the banks through the Bankers Association of Zambia (BAZ) that will engage the central bank. And then once the common position that would

have been agreed, definitely, there will be an official communicate that will come through where the central bank will notify the public in terms of which charges are valid. But we throw caution because, for us, the interest is that these fees and charges are the ones that [are] making the banking sector to be fairly stable in terms of performance, and that's quite a big line," Mwanza added. He charged that the BoZ had neglected the interest of the commercial banks by abolishing the charges. "So, we need to ensure that we protect the business of banking in Zambia so that the current

jobs that are there in Zambia can be protected. So that the current investments that are in the market can be protected because it's very easy to say we will remove this particular line of income and everyone is happy, but what will it do to the economy if the banks at the end of the day come back and say, 'it's not profitable to deploy ATMs, it's better we don't deploy them?' We will be reverting the gains that we have made over these years. So, we should all work towards ensuring that as we made these decisions, the interest of the banking sector is taken into account," said Mwanza.

People now should be able to judge which party is violent." Phiri said she felt sorry for those who were claiming that PF was buying chancellors and defectors saying people were joining the party on their own. "And I feel sorry for those who are saying that PF are buying people like councillors and all the defectors. How much money can anybody have to buy all those people? How much money? And I can confirm, as the secretariat we are not giving anybody money. They are just coming on their own," she said. Meanwhile Phiri said the opposition political parties would have nothing to talk about come 2021 because of the developments going on. "I have always said that these opposition political parties

will have nothing to talk about come 2021. You will remember in 2021 that this is what Mumbi Phiri said. Because of the development which is there. In fact I was just coming from Monze [where] I lost my son-in-law. The village where we were was 36 kilometres from the road from Monze town. Communication towers are there, my phone was able to work through out the two days I was there, the health posts are there [so] what are they going to talk about? So let them talk and talk. The way they received me, that's the way we are supposed to live under one Zambia one nation. And I get surprised how these politics can divide us. Eastern province, my children are married. One is married from Monze, the other one is married from Katuba area. What tribe are my grandchildren? They are Zambians. Phiri warned individuals mudslinging and writing lies about her saying they would not manage to bring her down. "When I was in Turkey there was something which was circulating on social media that Mumbi Phiri has said that we should allow a Chinese to rule us. What sort of people have we become as Zambians? Lying, mudslinging, it's not right. And let me tell those people who like writing lies about me, I can assure you, you talk behind my back but God is promoting me in front of your faces," said Phiri.

ZCID must allow Church to lead dialogue, says Mumba-led MMD

Nevers Mumba-led MMD Spokesperson Dr Cephas Mukuka has urged the Zambia Centre for Inter-party Dialogue (ZCID) to swallow its pride and allow the church to lead the forthcoming national dialogue. And Dr Mukuka has wondered why ZCID invited the Felix Mutati MMD faction to the said talks and not the other faction saying Nevers Mumba was the duly elected MMD leader, while the other grouping was illegal. In an interview with News Diggers! Dr Mukuka said the church stood a better chance to lead and spearhead the said dialogue. "As MMD, we support all calls to have the church lead the pending dialogue. It's the natural role of the church to do so. The church stands better to lead, spearhead and facilitate the said dialogue. Each time the church speaks, it's from a sacred platform. This is not to say that they cannot error, but to show respect and agree

that it's their God given mandate to do so," he said. Dr Mukuka observed that it was a global trend for the church

to engage in dialogue. "Actually it's a global trend for the church to engage in such. In Zambia when late President Levy

Mwanawasa and the then opposition leader late Michael Sata had political differences, the church reconciled them

in full view of the world. In South Africa during and after Apartheid, the church played a pivotal role to end the racial discrimination. Later after independence, the truth and reconciliation commission was spearheaded by Archbishop Desmond Tutu, among other church leaders," he said. "Most recently in the DRC, where President Joseph Kabila wanted to cling on to power, the church initiated dialogue leading to amicable Presidential elections coming up this year in December." He urged ZCID to humble themselves and allow the church to lead the dialogue. And Dr Mukuka wondered why ZCID recognised the Felix Mutati-MMD led MMD faction instead of the one led by Mumba. "Examples are too many to give out. We urge ZCID, to humble themselves, swallow their pride and allow the church to lead the forthcoming national dialogue. The failure by the ZCID not to invite us to the said talks leaves

much to be desired. Why should they invite the Hon Felix Mutati led illegal grouping attend? There is a land mark Supreme Court judgement ruling, recognising Dr Nevers Mumba as duly elected president of the MMD. Actually the said ruling dismisses the Felix Mutati case with huge costs to the tune of K2.5 million. This is in the public domain," he said. "People may wish to know that upon having their case dismissed by the Supreme Court, the illegal Mutati-led MMD, has since rushed to the ConCourt. We expected the ZCID, to have engaged us for certain information before deciding to invite an illegal grouping. So our position remain unchanged, let the church lead the pending national dialogue. The dialogue is not between the PF and the UPND, as some people may think. It is involving all stakeholders and aggrieved individuals wanting to speak through their representatives," said Dr Mukuka.

Kalomo hubby trails cheating wife in the bush, murders her boyfriend

A 26-year-old Kalomo man on Saturday murdered his wife's 28-year-old lover as the duo was on its way to have sex in the bush. According to Southern Province police commissioner Bonny Kapeso, Gift Nambango trailed his wife and her lover, Japhet Chilindile, to the bush before hitting the latter with a steel bar. "A twenty-eight-year-old man has been murdered

Japhet Chilindile of Macraymond Compound of Kalomo was last night allegedly trailed and hit with a steel bar by another man when the deceased and woman were heading to a bush with a view of having sex. The husband pretended going out on a business trip for some days but came back the same day to investigate whether it was true that his wife had a sexual relationship with

the deceased. Around 21:00 hours last night, he saw the two heading towards the bush and attacked the man who sustained two deep cuts and later died in Kalomo District Hospital," stated Kapeso, Sunday. "Body of the deceased is currently in Kalomo District Hospital mortuary awaiting post mortem. The suspect, identified as Gift Nambango, 26, has already been nabbed and is currently in police custody where he will be charged with murder."

NAPSA sues Technical Management Board for late payment of workers' contributions

National Pension Scheme Authority (NAPSA) has dragged Lusaka Business and Technical Management Board to court for late payment of workers' contributions, demanding the sum K576,204, in respect of penalty arrears.

In a statement of claim filed in the Lusaka High Court, August 7, NAPSA stated that they were mandated by law to collect monthly statutory contributions from contributing employers at the end of each month. They further stated that if a contribution was not

paid within the stated timeframe, such a payment would attract a 20 percent cumulative penalty for each month. NAPSA alleged that the defendant had been remitting monthly contributions late and as a result had accumulated debt in form of penalty arrears amounting to K576,104. They stated that despite several reminders, the defendant had failed to pay the sum due. "The plaintiff will aver that the defendant has been remitting monthly contributions late and as a result, accumulated debt in form of penalty arrears amounting to K576,104.48. By letter demand dated July 26, 2017, the plaintiff demanded the settlement of the said sums owing and due. The plaintiff will aver at trial that despite several reminders and letters to ensure the defendant's mandatory compliance with the law, the defendant has failed to pay K576,104.48 now due to the plaintiff," read the statement of claim. They now claim for K576,104.48 in respect of penalty arrears as a result of late payment of contributions, interest on the claimed sum, damages, costs and other reliefs the court may deem fit.

People have accepted 30 ngwee charge, decision is final - Lungu

President Edgar Lungu has directed the Ministry of Communications to finalise the statutory instrument to effect the 30 Ngwee internet calling tariff saying people have already accepted it. And President Lungu says the move to install Highway speed cameras is also final, as the country cannot start moving backwards because of a few talkative people. Meanwhile, President Lungu says those who are bitter with government's cooperation with China want the country to remain primitive. President Lungu said this during a video call with some government officials and traditional leaders whilst at Huawei offices in China. Ministry of Communications Permanent Secretary Misheck Lungu told President Lungu that there was a hiccup with the way the 30 Ngwee tariff was announced.

"I really want to appreciate your guidance and assure you that going forward, we want to implement a broadband strategy and ensure that most of our parts have internet so that all these e-platform activities are going to be rolled out on the internet. And I think we face two hiccups in terms of the way we announce the 30 Ngwee user charge," said Misheck before President Lungu cut him off saying, "Forget about the 30 Ngwee. It's gone, it's not an issue anymore. The people have accepted it. Let's move. Don't even talk about it." And President Lungu said even the installation of the speed cameras was final. "Even the [speed] cameras, forget. The people said 'improve signage', we improved signage. We cannot be going backwards when the nation, the continent and the entire globe is moving forward just because of talkative Zambians, no, don't be cheated, people are appreciating these things. So put a close to the cameras, the 30 Ngwee put a close and

make sure that the towers are put throughout the country so that we move," he said. Meanwhile, President Lungu said those who were bitter with government's cooperation with China wanted the country to remain primitive. "You can see why some people are very bitter with our cooperation with the People's Republic of China, they want us to remain primitive, so tell them," President Lungu said, after Chief Shakumbila hailed him for improving connectivity in the rural areas. In response, Chief Shakumbila advised the Head of State to ignore detractors. "You don't have to listen to them your excellency, your job is to put Zambia where you want to put Zambia and everybody is looking forward to that.

Zambians have entrusted you with all the responsibility of doing what you think is better for Zambians. Those who talk can talk because talking never comes to an end," said Chief Shakumbila. And E-Government Permanent Secretary Dr Martine Mtonga informed President Lungu that the e-voucher system was already up and running. "Yesterday was 1st September and we opened up the e-voucher system. The system now is operational in all the districts except a few challenges in the provincial administration Copperbelt and Provincial administration Central [Province] but my team is going there tomorrow to go and sort out the challenges they are having. So the system

has started and farmers yesterday started collecting inputs where it was available in agro-dealing shops. And also, we have already popularised it to the areas where we have fertiliser in the shades. There also, we have deployed biometrics, Monday we will be meeting some banks to tell them that the system is open now and they can log in and also transmit to the farmers that have deposited. On this type of system we are using currently, we have deployed it to all the ministries except two, including your office Your Excellency, State House. But we want to encourage the honourable ministers to be using this type of system so that they can shorten the time of action," said Dr Mtonga. In response, President Lungu

said implementing the e-government system was a progressive move. "Thank you so much for going ahead and implementing the system. Most of these systems we are implementing, we found them but our predecessors were too afraid of these corruption allegations and innuendos by detractors. I am not ashamed to say these ideas are not mine, but they were somewhere in shelves gathering dust. The e-Cabinet was there, they talked about it but they couldn't implement it until I came and I said we are going to do it. So of us are scared of buttons and tabs and so on but we are all familiar now, we are working so well with the system, thumbs up, keep it up," said President Lungu.

GBM laughs at PF's desire to ban UPND from future elections

UPND Vice president Geoffrey Bwalya Mwamba says President Edgar Lungu is rambling and will continue to do so because he knows that his term of office is about to expire. And Mwamba who is popularly known as GBM charged that President Lungu is using the constitution to create a one-party state, which the UPND will not accept. GBM was reacting to President Lungu's statement that peaceful campaign in Kasenengwa were a demonstration that the UPND was a violent party, and that banning it from taking part in future elections would be one way of uniting the country. Deep in his heart he is celebrating because he has no competition in Kasenengwa, UPND is not there and he has no pressure of sending cadres to Kasenengwa, as has been the case in other by- elections like Shiwangandu where my entourage

was attacked. Violence is a tool Edgar and PF are using to intimidate voters. This is a true manifestation of hate and dangerous path which Lungu wants to take our country to, and Zambians will not allow it." He said President Lungu has been creating and encouraging tribalism in his campaign messages instead of addressing serious issues affecting Zambians. "It is so embarrassing that someone calling himself President can stand in front of stressed farmers and hungry citizens and preach hate instead of informing them the solution he has for the farmers knowing too well that the same people call him and his party 'Paya Farmer'. I advise Edgar to address issues affecting people in Kasenengwa instead of talking about UPND which is not there. We know Edgar has nothing to say because his failure to govern is seen from poverty, hunger, unemployment and the huge debt. Zambia will hold him responsible should this hate spread across the

President Edgar Lungu says Zambians have accepted the 30 ngwee internet calling tariff, and has since directed Ministry of Communications and Transport Honourable Brian Mushimba to go ahead and sign the Statutory Instrument which will put the government policy into effect.

Speaking from China where he is on a week-long working visit, President Lungu also said the move by the Road Transport and Safety Agency to install Highway speed cameras was final, in order to ensure that the country stays updated with technological advances in road safety.

We do not have a problem with the installation of speed cameras mounted on major High Ways in Lusaka, and we believe that we speak on behalf of many responsible motorists when we say this initiative should be rolled out to the rest of the country as soon as possible.

Only a fool would argue that there is no need for speed limits on the roads when death statistics from road accidents are in plain sight for all to see. In fact, we don't know of any major city out there in the developed world where there are no Highway speed cameras or where motorists are allowed to drive like racing mice in a maize field. Road safety is key to any developing nation.

We support speed cameras, but not Internet call charges

with the awarding of the contracts to the companies that won the tender to supply and install these cameras. There, we have a problem, and this problem is not unique to RTSA. There is a serious lack of transparency in the awarding of government contracts in Zambia, to the extent that kickbacks and single sourcing have become part of the procurement process.

But just like the fire tenders, the speed cameras are now here and we have no option but to make use of them, regardless of the irregularities linked to the purchase.

Of course there are challenges that RTSA needs to address urgently in order for these speed cameras to achieve their intended purpose. For example, the method

of notifying speeding motorists via SMS will bring confusion because there are many vehicles on the Zambian roads that are driven by third parties, rather than absolute owners whose phone contacts may be on the RTSA database.

And even assuming that the erring motorist is the absolute owner of the vehicle, there is no law that states that to drive a car in Zambia, you must own a cell phone, let alone, an active SIM card, to which RTSA can send the speeding ticket notification.

This, plus many more implementation technicalities need to be rectified as a matter of urgency before motorists start to get inconvenienced when going to renew their vehicle documents.

Otherwise, anyone who has witnessed the reduced speed on the major Highways in Lusaka can attest to the fact that Zambians have accepted this move.

But when President Lungu says Zambians have accepted the 30 ngwee charge on WhatsApp and Internet calling, we wonder which citizens our Head of State is referring to. Who has accepted this charge? His family and his Cabinet Ministers or the taxpayers?

What President Lungu is doing is called bullying not leading. Can the President point to a single sector in the country that has accepted this criminal policy? Cell phone subscribers have protested the move, the Chamber of Commerce and Industry has rejected

it, the Centre for Trade Policy and Development wants the move reversed, Transparency International Zambia says it's illegal; even the leadership of the state owned Policy Monitoring and Research Center has condemned the decision, not to mention the opposition political parties. So which Zambians have accepted the policy for President Lungu to say 'that case is closed and the decision is final'?

We know that the government is completely broke. We have seen that all of a sudden, they have remembered that university students owe them bursary loans and they want that money repaid with immediate effect starting this September month end. We have seen that they

are now desperately selling vehicles at a loss after buying them at staggering prices in bulk. We have seen that civil servants are being denied their rights to commute leave days, meaning that it will be impossible for those who have been retired to get their leave benefits.



The US military plans to cancel \$300 million in aid to Pakistan due to Islamabad's lack of "decisive actions" in support of American strategy in the region, the Pentagon said Saturday.

The US has been pushing Pakistan to crack down on militant safe havens in the country, and announced a freeze on aid at the beginning of the year that an official said could be worth almost \$2 billion.

The Defense Department has sought to cut aid by \$300 million "due to a lack of Pakistani decisive actions in support of the South Asia Strategy," Lieutenant Colonel Kone Faulkner said in an email to AFP.

"We continue to press Pakistan to indiscriminately target all terrorist groups," Faulkner said, adding that the latest aid cut request was pending Congressional approval.

The announcement came days before US Secretary of State Mike Pompeo is scheduled to visit Islamabad to meet new Prime Minister Imran Khan.

Pakistan has fought fierce campaigns against homegrown militant groups, and says it has lost thousands of lives and spent billions of dollars in its long war on extremism.

But US officials accuse Islamabad of ignoring or even collaborating with groups, which attack Afghanistan from safe havens along the border between the two countries.

The White House believes that Pakistan's Inter-Services Intelligence agency and other military bodies have long helped fund and arm the Taliban for ideological reasons, but also to counter rising Indian influence in Afghanistan.

It also believes that a Pakistani crackdown could be pivotal in deciding the outcome of the long-running war in Afghanistan.

US frustration has boiled over before: President Donald Trump's predecessor Barack Obama authorized drone strikes on Pakistani safe havens and sent US commandos to kill jihadist kingpin Osama bin Laden in his Abbottabad hideout.

But Trump's aggressive language has especially angered Pakistani officials.

"The United States has foolishly given Pakistan more than 33 billion dollars in aid over the last 15 years, and they have given us nothing but lies & deceit, thinking of our leaders as fools," Trump wrote on Twitter at the beginning of the year.

"They give safe haven to the terrorists we hunt in Afghanistan, with little help. No more!"

Pakistani leaders disputed the \$33 billion figure, insisting that around half of the money relates to reimbursements, and the prime minister's office accused Trump of ignoring the great sacrifices the country has made to fight extremism.

In March, a senior US official said that Pakistan has "done the bare minimum to appear responsive to our requests," and concerns over a lack of

action by Islamabad against militant groups still persist.

The announcement came weeks after Pakistan's new Prime Minister Imran Khan

took office amid concerns he would remain tolerant of terror groups including the Taliban and the notorious Haqqani network.

Khan has repeatedly blamed Pakistan's participation in the US-led anti-terror campaign for the surge in terrorism on home soil over the last decade

and has vowed to rebalance Islamabad's relationship with Washington.

He has also shown a willingness to hold talks with militant

groups and sought support from religious hardliners in the run-up to elections last July -- moves that prompted critics to christen him "Taliban Khan". Some analysts warn there may be no real way to pressure Islamabad and say a suspension in aid could see the US lose crucial influence over Pakistan which will instead look to other countries for support, particularly its longtime ally China.

Despite the provocations, the US does not want to completely rupture its relationship with Pakistan, where anti-American sentiment already runs high.

Washington's footprint in Afghanistan is much smaller than it was at the height of the war, but it needs access to Pakistan's supply lines and airspace.

Pakistan is still believed to have the strongest influence over the Taliban, making its cooperation necessary for peace talks. *AFP*

Bobi Wine: Uganda's pop star MP arrives in US for treatment

Ugandan pop star and MP Bobi Wine has arrived in the US for medical treatment following accusations he was tortured and beaten while in military custody.

The former rapper was initially prevented from leaving the country but was cleared to fly out on Friday. He, and 32 opposition politicians, were charged with treason last week over the alleged stoning of President Yoweri Museveni's convoy.

Bobi Wine was later granted bail. The army denies allegations of torture.

On Friday, police confirmed that Bobi Wine had been cleared to fly out of the country for specialised treatment after the government sent a team of nine doctors to examine him.

His lawyer, Robert Amsterdam, said the pop star had also been violently re-arrested at the airport on Thursday "even though the judge had let him have his passport because he needed to leave the country for medical reasons".

A police spokesman had confirmed on Twitter that

Bobi Wine was being given a medical examination because of the allegations of torture.

Police said that another opposition MP, Francis Zaake, who was also trying to go abroad for treatment, had been "trying to flee the country and accordingly apprehended him".

On Friday, supporters of Bobi Wine held protests in the capital, Kampala.

Pictures shared on social media showed plumes of smoke rising in the streets, with local media reporting that the protests were confined to Kamwokya slum, where the MP grew up.

On Monday Bobi Wine, whose real name is Robert Kyagulanyi, appeared on crutches during a court appearance. His allies say he was tortured by elite presidential guards during his detention.

The army have described the allegations as "rubbish".

His aides say he was later re-arrested at Uganda's main international airport where he was planning to board a plane to Washington for further medical treatment.
