# IAPRI urges govt to improve market infrastructure to tackle cholera

Cholera cannot be expected to end if Zambia does not develop a clean horticultural value chain where fruits and vegetables can be stored in a conducive environment, says the Indaba Agricultural Policy Research Institute (IAPRI). And Musika managing director Reuben Banda says the non-existence of a structured horticultural market was clearly evident during the cholera outbreak early this year. Meanwhile, Works and Minister Felix Supply Mutati says agriculture's contribution Gross to Domestic Product (GDP) is still uninspiring and a source of concern for government. during Speaking the Zambian Fresh Produce Wholesale Market Investors' meeting, jointly-organized by IAPRI and Musika in Lusaka yesterday, IAPRI executive director Chance Kabaghe suggested that cholera outbreaks cannot be expected to end if the country doesn't develop a clean fruit and vegetable market. "We have done a lot of work that is not only beneficial to this country, but the whole region. But our real main task is to make sure that, the Zambian agricultural stakeholders have proper data for them to make informed decisions. So, this country, in the last 10 years, has really been moving in the right direction because the policies that will advise the various stakeholders have the empirical evidence behind it. Ourselves, together working with Musika, we thought it was prudent that where agriculture has reached in this country, we needed to have a very modern fruit and vegetable market. Soweto, as we all know, is a

disaster! The rains are just around the corner. This, Minister and stakeholders who are here, if it's actualised quickly, we know it is going to be actualised, will be the beginning of the end of cholera in Lusaka. So, to us, it's an extremely important meeting for investors. This is really a private sector initiative to move this sector forward. Where is agriculture in Zambia today?" Kabaghe wondered. "We are self-sufficient as a country in a sustainable manner in maize production; the whole value chain of maize in this country. Maize is no longer an issue for Zambia. Even during the so-called El Niño, we still produce enough maize and export to the neighbouring region, including South Africa. Soya beans, we are now the past three, four years, we produce more than what we need for ourselves. Aquaculture is becoming very strong. We can boast today as a country that we are self-sufficient in the production of wheat. Really, if these three a country has in place, it doesn't have to worry about staple food. The next part becomes now, the horticultural part. Really, our horticultural sector has been wish washing up and down. As we are talking, farmers who have been involved in the tomato production this period, they are crying! And they are saying that, 'we will never grow tomatoes again!' When at the beginning of this season, a box of tomato was hitting K400, right now it is K5. Some are just throwing it; taking it to waste." Hesaidthetimetoinvestinthe horticulture sector was now. "Again, I'm trying to say, we have the agro-economic zone in this country that can grow literally, apart from those

very extreme fruits, such as apples, we can grow literally most of the vegetables and fruits we are talking about. So, as a country, we are ripe, we are ready to move in the horticultural sector. And you cannot move in the horticultural sector, Minister, without addressing issues of marketing. The value of chain in marketing. We thought that the time was now. Time was now to invest in the value chain, especially the marketing component, because once the marketing component is set right, production becomes much easier, people start investing in those areas. Like I said, today, when you say, 'I'm growing tomatoes, people start asking, what's wrong with you?' Why are you growing tomatoes?

So, this meeting is really called upon to address this critical position." ### **Reverse nonsensical increase of** minimum wage, Wynter Kabimba tells Simukoko By Mirriam Chabala

Labour Minister Joyce Simukoko must reverse this nonsense of increased minimum wages before it causes massive job losses among domestic workers whom she won't employ, says former justice minister Wynter Kabimba. And Kabimba, who is now Rainbow Party general secretary, says the Patriotic Front doesn't think when making national decisions. The opposition leader also added that the PF government has continued amending the Constitution just to keep itself in power, which is not right. Speaking when he featured on Hot FM's Hot Seat programme, Thursday, Kabimba agreed

with the Zambia Federation of Employers (ZFE), who have rejected the new minimum wage, describing the increment as too high, and that it has the potential to send people out of employment. He stressed that Simukoko would not achieve whatever she intended to achieve by trying to become a populist like late president Sata, warning that she would not get away with it. "That is the consequent effect! That will be the result, people will lose jobs! So, what the Zambia Federation of Employers are doing is that, they are trying to protect the welfare and the lives of the poor maids, okay? That between getting K500, which they are getting now, or

the K700 that they are getting now, and getting zero, they are saying that, 'it is better they retain the K500 or the K700.' The life in this country is just unbearable for everybody... why haven't they reduced the price of commodities? Why do they allow Shoprite to continue charging high prices for food commodities? Why is it that the income of a number of people is not rising? Why is it that, the mining companies that are making money in this country are not being taxed to the levels that they should be taxed? So, whom are you punishing? You are punishing the citizens during a period when the economy of this country is a runaway economy. Whether we like it or not, PF has

failed to manage this economy, it doesn't matter," Kabimba said. "My advice to the Labour Minister is: reverse this nonsense! That's my piece of advice to her. This is ridiculous. You won't achieve what you wanted to achieve; you are being populist like Michael Sata was, but you won't get away with it because you think Michael Sata got away with it, not at this time. So, a lot of maids will be laid off and the Minister of Labour won't employ them anyway." Asked if he though the

# Inviting Hindus, Muslims to Day of Prayer can cause confusion, guides Religious Affairs Minister

By Sipilisiwe Ncube National Guidance and Religoius Affairs Minister Godfridah Sumaili says inviting Hindus to the National Day of Prayer and Repentance cause confusion. can And Chief Government Spokesperson Dora Siliya has insisted that Zambia is not in debt distress and that there are no ongoing discussions about giving away public assets as a way of settling loans. The duo was speaking at a press briefing held at the Ministry of Informtion and Broadcasting, Wednesday. Asked why muslims were not included in the national prayers. Sumaili said there would be confusion if other religions were invited to a Christian event. "The President Announced the national day of prayer fasting and repentance [but] the only thing is that when we meet as Christians in one place and then we say 'Hindus come' I think there will be confusion, but they are free to meet on their own on this day, honour this day and pray. So that's

the only reasons. So really it's an arrangement that we want to warship God in the way that we are accustomed to," Sumaili said. Sumaili also said it was sad that some leaders could speak ill about their country abroad. "It is so sad that even some leaders will speak ill about their nation outside but there is only one Zambia and you are a child of this nation. We have to love our nation and in whatever we are doing we should do the best for our nation. So this ministry is mandated to promote those values. And I can tell you that we have rich culture values which we are losing out. And then we have these values which are in the constitutions, if we can embrace all these values, I am sure that Zambia will stand and that Zambia will be envied by other countries," Sumaili said. She advised leaders not to politicize the national day of prayer and fasting which is held on October 18th annually. "And these national prayers,

we should not politicize these prayers. 90 percent of Zambians are Christians and we need to honour our creators. God answers prayers and we have seen it happening I think in 2016 when we had a drought and all the African countries in the southern region were affected by that. As Zambia we let the prayers to pray for the rains and we saw what happened. We had the rains and we had a bumper harvest and we started feeding all these other countries surrounding us. So we cannot trivialize prayer, we cannot politicize prayer because we honour and fear God," she said. Asked what her message was on the UPND not participating in national day of prayer, Sumaili said it was unfortunate that a leader who called himself a Christian could do such a thing. "I feel that it is very unfortunate and that as a responsible leader and you call yourself a Christian, you stop people from praying. It is very unfortunate but even if the leadership has stopped

people from going to pray, people from UPND have come to pray as individuals. In fact last year we had a leader in the UPND who was part of the programme and led in one of the programmes," said Sumaili. "The national House of prayer which was in place then yes they raised some funding and some funding has gone into what is happening now. I think we are going to be quiet aggressive concerning the National House of Prayer. We need to be aggressive on this issue which is so important to the nations. And I would encourage that every family becomes part of this covenant house of prayer." And Chief Government Spokesperson Dora Siliya insisted that Zambia was not in debt distress and that there were no ongoing discussions about giving away public assets as a way of settling loans. "There continues to be an unsubstantiated debate on debt position and this has extended to a malicious rumour that we are in debt

distress as far as Chinese loans are concerned and that government is now going to offer or sale to the Chinese, public assets such as ZNBC, ZESCO and such as the Kenneth Kaunda International Airport (KKIA). I want to put it on record clearly that there is no debt crisis in Zambia and that in particular we are not in debt distress with the Chinese loans and that absolutely there is no discussion relating to the offer of indeed the give-away for public assets such as the ZNBC, ZESCO and the Kenneth International Kaunda Airport," Siliya said. Siliya said those spreading rumours about Zambia being in a debt crisis malicious. were just "These stories that are circulating nationally, locally and internationally must truly be disregarded and they are just malicious rumours by those who are determined to distract us as a government and as a people. So I want say it once and for all that these are malicious rumours. I

believe that when I featured on Sunday Interview last week or the other week, I did indicate that we must give room for the Minister of Finance to do her work. What is important is that Zambia is not in debt distress, is not in debt crisis and I believe that the Minister of Finance very soon when she will be presenting to parliament should be able to give you all the information and I do not want to pre-empty her [speech] including the president who will be giving a statement in parliament this Friday," Sumaili said. Siliya said the country had benefited a lot from Chinese loans. "Zambia has a lot of partners [such as] China, the World Bank, the IMF, bilateral relations with other countries whether it's the US, the UK and so on. It is quiet strange to me that China is being singled out especially just after His Excellency just went to China to attend the ... meeting. When we look at our relationship with China since 1964, we've benefited a lot in infrastructure development. We are attracted to this bilateral cooperation with China because these loans that government of Zambia get from China are concessional loans and even when they are commercial loans, they don't have any extraneous conditions," said Siliya.

### SA taxi drivers stone Zambian to death

**By Sipilisiwe Ncube** South African taxi and minibus drivers have stoned to death a 28-yearold Zambian national after mistaking him for their west-African enemy in a town called Klerksdorp. According to a statement issued by First Secretary for Press and Public Relations at the Zambian High Commission in South Africa Naomi Nyawali, deceased identified the Rabson Zulu was as first stabbed by a group of over 30 drivers who mistook him for another foreign national whom they accused of murder. "Rabson Zulu, holder of passport number 528427 was stabbed with a knife before being stoned to death together with four (4) other foreign nationals by a group of over 30 drivers in collaboration with the local community. According to the information made available to the Zambian High Commission in Pretoria, Mr. Zulu was murdered over the weekend in a case of alleged mistaken

identity at a tuck shop located in Pinasdorp area where he had gone to buy washing powder to clean the car for his relative who he was visiting. It is alleged that the enraged mob of taxi and minibus drivers together with local people wanted to carry out a revenge attack on an identified foreign national of West African origin for allegedly killing one of the taxi drivers who was accused of raping his employee," Nyawali stated. Nyawali revealed that after realizing that they had killed a wrong person, the mob fled the scene and no arrests had been made. "After realising that they had killed an innocent person, the mob fled the scene with no arrests made so far. Mr. Zulu's mortal remains have since been deposited at Tsepong government awaiting mortuary repatriation to Zambia. His death comes barely few weeks after another Zambian national, Kenneth Sikopo was shot dead in cold blood in Germiston in the same country," disclosed Nyawali.

The Lusaka High Court has fined a driver K2,500 or in default, serve six months simple imprisonment for causing the death of a police officer who led the convoy of United Nations World Tourism Organisation delegates last year. Dismus Ng'andu had pleaded guilty to the charge before High Court judge Gertrude Chawatama. Facts in this matter were that Ng'andu, on November 15, 2017 at around 15:00 hours, caused the death of Victor Ngoma while driving a GRZ Mercedes Benz along Haileselesie Avenue. Ng'andu and Ngoma were part of the convoy ferrying the United Nations World Tourism Organisation delegates from Kenneth Kaunda International Airport to City Airport.

Ngoma was leading the convoy, riding a GRZ motor bike but Ng'andu's failure to make a proper look out caused Ngoma to run into his motor vehicle. Ngoma sustained injuries on impact and was rushed to UTH where he was pronounced dead. In mitigation, Ng'andu, who was represented by lawyers from the Legal Aid Board, said he was remorseful for causing death of his friend. He said he had learnt a lesson and he would be more careful and safety conscious whenever he was driving on Zambian roads. Ng'andu said he would be haunted for the rest of his life knowing that he caused the death of his dear friend. He said in an attempt to save Ngoma's live, he assisted in taking him to the hospital and even reported himself to the police. Ng'andu pleaded for the court's leniency saying he was a first offender who readily pleaded guilty to the charge. He asked the court to consider a fine as opposed to custodial sentence. And delivering judgement, judge Chawatama took into consideration the mitigation but said the offence for which Ng'andu was charged was serious especially that a life was lost. She urged him to be extra careful when driving. Judge Chawatama added that the continued number of deaths being recorded on the roads were a source of concern. She therefore fined him K2,500 to be paid immediately or serve six months simple imprisonment.

I think that is unZambian, that is unbiblical and we

must desist from this mentality of viewing maids as slaves whom we we can just treat in which ever way that we want. These maids have got families, they have got children and aspirations which they want to achieve and us as PF will continue protecting them. And there will be no shocks in the economy because we have enough people in this economy who can hire maids and pay them well," Mwila said.

"We commend the government for revising the minimum wage upwards for our domestic workers, the shop workers and other categories of protected workers. Because this is in line with the Patriotic Front manifesto for 2016 to 2021. The Patriotic Front was formed as a mass movement for the poor and weak in society, the PF is a pro poor political party that strives to protect, defend and promote the interests of the poor and weak in society. Domestic workers, shop workers and protected workers fall under this category of workers that need protection, promotion and workers that need to be defended by the party. Since the revision of the minimum wage is in line with the party manifesto, it calls for us to ensure that we also uplift the lives of ordinary workers who are also facing challenges in taking care of their families."

He said government had considered a lot of factors before increasing the minimum wage.

"I want to put it very categorical that government considers a lot of factors before any policy is implemented and that proper situation analysis is done before any policy announcement is made. Therefore, to claim that government did not take into consideration the entire spectrum of economic fundamentals is not correct, as being claimed by the CSPR. It must be very clear that maids were not meant for a particular class, maids are meant for people who have to pay them because they are not slaves. The Bible is very clear that you cannot keep people as slaves by giving them wages that are below the threshold that can sustain their lives. We must protect the people and we as PF will make sure that we will continue to look at the welfare of the peasant and the domestic workers."

He vowed at his party and President Lungu would continue fighting for better conditions for maids and other domestic workers.

"In terms of civil servants for instance, government has been giving increments to civil servants over the years and it's also important to note that civil servants have got a very robust through representation which they air out their grievances, they have a system through which they communicate when negotiating increments for there salaries. They have got unions, but the maids don't have unions. The only representation that ordinary workers have is us the people whom they have given the mandate to preside over the affairs of the state. President Edgar Lungu is the number one union leader for the maids, he's the number one union leader for the domestic workers and those who are working in the shops. So it is incumbent upon President Edgar Lungu and those who are working in the shops to stand up and fight for the maids because they have no unions. And there will not be any job loses because the revisions that have been done are in line with the income hours of those that employ maids," said Mwila.



is repossessed because they have ring-fenced the cash flows of the national broadcaster for the next 25 years or so. Honourable, Dora Siliya knows very well that all business decisions at ZNBC apart from editorial policy, are under Chinese control which owns Star Times.

China, through Star Times, is in charge of the income wing at ZNBC because they have 60 per cent controlling stake in a special purpose vehicle called Top-Star, while ZNBC remains а minority shareholder. China put in their money - which by the way is embroiled in corruption, but to them it's an investment, from which they must recover profits, even before ZNBC does. already That is repossession. A normal lender gives you money to do whatever you want to do and will only wait for you to pay them back; a bank will lend you money to start a farming business and they will let you run the entity without dictating when you must start harvesting. But on this one, the Chinese are coming in to control the cash-flow at ZNBC. They have ring-fenced the cash flows; they are making the critical decisions. China has got control of the signal; they are the signal distributor and bullying anyone else who attempts to provide competition as a signal carrier. Where has it

world that a foreign company becomes a signal distributor on behalf of the national broadcaster? And they are even licensing local television stations, making them pay to carry their signal. This is a strange deal. It is complete repossession. It is happening before our own eyes, we are watching and they have taken over the broadcasting station. There is nothing that Ambassador Emmanuel Mwamba can say on SABC in South Africa that can change the reality. Your Excellency, we are under siege! This is what Africa

Confidential meant. They are warning us that what happened to ZNBC will happen to Zambia National

Airport Corporation, they are going to ring-fence the cash flows until they get their money and their profit. By the time they will give it back to us, it will have already been obsolete and Honourable Margaret Mwanakatwe's successor will be looking for more money again to reinvest.

When AVIC International helps government construct the Lusaka-Ndola dual carriageway under the so-called PPP, and takes 27 years to handover accompanying the roadside hotel facilities that Honourable Ronald Chitotela is boasting about, the Chinese company will have already milked all the life out of that road. Again, in 27 years' time, his successor will be going back to China for the same 'help'. That is a takeover of national facilities.

Government is saying ZESCO is safe, but they know that the moment a Chinese company lends money to the utility, the model we are seeing from the influential Asian nation is that they will immediately ring-fence the income for ZESCO. That is the fear Zambians have.

President Lungu, Honourable Mwanakatwe, Honourable Dora Siliya and other PF pundits should not underestimate public over sentiments this matter because the public has read between the lines. They have seen what the Chinese intention and strategy is. ZNBC is just an example to prove that, in terms of Chinese takeover of national assets, it has already started.


If this government has not seen this, then let their eyes open up and see. If government has not seen that ZESCO and all these others have been taken over, this is the time for them to wake up because it is real.

US and Somali forces who raided the family home of a former president and detained three teenagers may have been acting on misleading intelligence, according to officials in the unstable east African country.

Somali soldiers accompanied by at least one foreigner broke into the house of Aden Abdullah Osman Daar, a revered nationalist leader and former president who died in 2007, in the town of Janale, around 100km southwest of

Mogadishu late on Friday. Members of Daar's family told the Guardian they were deeply shocked by the raid, which targeted Islamic militants from the al-Qaida-linked al-Shabaab organisation.

The incident will raise further concerns about the use of special forces troops to fight extremism in Africa. Last year the deaths of four American soldiers in an ambush in Niger prompted anger and led to questions over the costs of such deployments.

Senior US officials are reported to be considering deep cuts to the special operations deployment on the continent. Three male members of the Daar family between the ages of 15 and 20 were arrested in the raid, the relatives said. The whereabouts of the detainees are currently unknown.

The troops also raided an adjacent farm belonging to Daar, who led Somalia from 1960 to 1967 and was the country's first postindependence president.

The office of Hassan Ali Khaire, the Somali prime minister, has apologised to the family.

One Somali intelligence officer with direct knowledge of the operation - which took place in a region known as a al-Shabaab stronghold - said "there was bad intelligence during and before the raid on the house of former president". "The Americans did not know the place. They relied on false intelligence gathered by local informants who are sometimes biased due to clan influence," he said.

However a source in the prime minister's office gave a different version of events.

"The target of the raid was not the house of former President Aden Abdullah. This was an operation conducted by Somali special forces with their American advisers. The forces

vicinity of Wagaante, Somalia, on the night of 4 September 2018.

"The operation targeted al-Shabaab's improvised explosive device network. US forces were in a supporting role only," he said.

Somali forces have been fighting Islamist militants from the al-Shabaab organisation for more than a decade. In recent years the US has increased its support for local troops, sending special forces to train Somali troops and accompany combat operations. The US has also conducted a growing number of airstrikes, including dozens by unmanned drones. The incident highlights the difficulty of military operations in a complex political and social environment.

Raiding the home of a prominent local family and detaining innocent individuals risks fuelling support for insurgents, experts say.

There have been frequent claims that raids, sometimes involving US forces, have caused civilian casualties. THE **GUARDIAN** 

## The pop star vs the president: Uganda's generational fight

"We used to be scared," said Josephine Katumba, a 30-vear-old hairdresser in Kamwokya, a poor suburb of Uganda's capital Kampala. "We don't have fear anymore." President Yoweri Museveni has long had police beat the defiance out of his opponents, but a 36-year-old slumboy singer turned MP has energised and emboldened Uganda's youth, worrying the government.

Black scorch marks on the potholed road outside Katumba's tiny salon mark where residents have routinely burnt tyres to protest the arrest of Bobi Wine, a local boy done good, charismatic pop star and unlikely opposition firebrand. There is "Free Bobi Wine" graffiti everywhere.

"People have wanted change for a long time," said Katumba, nimbly braiding a customer's hair. "The difference now is that Bobi is young and he speaks for the youth."

As a pop star Bobi Wine blended lyrics on social justice and poverty with catchy Afrobeat rhythms, earning him committed fans among Uganda's often poor urban youth.

He took on the nickname of "His Excellency the Ghetto President".

Under his real name Robert Kyagulanyi he won a byelection in 2017 and entered parliament, where his popularity and outspoken opposition to Uganda's longtime leader shook up the country's "Groundhog Day" politics.

In power since 1986, the

74-year-old Museveni is the only president most Ugandans have known: the country's median age is less than 16.

Museveni has had the constitution amended twice, to remove term and then age limits, clearing him to run for a sixth term in 2021.

The opposition has for two decades been similarly dominated by 62-year-old Kizza Besigye, Museveni's former friend and personal physician, who has lost four successive elections.

Besigye "has become part of an entrenched political system in which change feels impossible without fresh leadership," said Kampalabased independent analyst Anna Reuss.

Kyagulanyi has swiped the opposition mantel from Besigye and provided a voice for a youthful population fed up with old men telling them what to do.

"Besigye is there to help, but he's not from the ghetto. Bobi can come and talk to us on the streets," said Katumba.

### **South Sudan leaders** reach 'final final' de eal

South Sudan warring parties have signed a final power-sharing agreement meant to end five years of civil war.

The ceremony on Wednesday evening in the Ethiopia's capital, Addis Ababa, follows an agreement

reached last month by President Salva Kiir and rebel leader Riek Machar.

It was a "final final" deal, government spokesman Ateny Wek Ateny told the Associated Press news agency. Under the deal, President Kiir will maintain his position while Mr Machar will return to government as one of five vice-presidents to be appointed in an expanded transitional government.

But a similar peace agreement signed in 2015 collapsed months

later, throwing the country into further violence.

Tens of thousands of people have been killed and millions displaced in the conflict which broke out about two years after South Sudan's independence. BBC

### **Devastating Dembele finally showing why** Barcelona spent €145m on French star

The Frenchman young struggled horribly to replace Neymar in his first season at Camp Nou but he has started the current campaign brilliantly

Life can change in an instant and football frequently demonstrates that. Ousmane Dembele flirted with a Barcelona exit this summer and yet a month later is a crucial component of Ernesto Valverde's treble-hunting team. The coach appeared unwilling to put his faith in the French winger but after Dembele individually earned Barcelona two victories at the start of the season with his goals, he has carved out a place alongside Lionel Messi and Luis Suarez in the attack.

His Barcelona story started badly. Dembele endured a largely disastrous debut season in Spain after his €145 million move from Borussia Dortmund in 2017, arriving as the man expected to replace Neymar after his world record transfer to Paris Saint-Germain.

Before the forward had time to settle into the team he suffered a hamstring injury which sidelined him from September until January, during which time Valverde constructed a 4-4-2 system which helped opportunities. Valverde chalked Dembele's injury up to inexperience and

his frustration was exacerbated after the Frenchman returned to feature in just four games him out for a month.

before suffering another hamstring problem which kept Back again in February, Dembele's form was erratic and one step forward was

often followed by another backwards, with only a few stand-out flashes demonstrating why Barcelona bet so heavily on him.

One came against Chelsea, with a rip-roaring shot flying past Thibaut Courtois and earning Barcelona passage to the Champions League quarter-finals with a 3-0 win over the Blues at Camp Nou.

Two late goals against Villarreal proved another boost and showed he could be useful in hitting teams on the break, operating at a speed now beyond Suarez and even Messi.

Sadly it came too late to salvage the European campaign, with Valverde only giving Dembele five minutes in what has become known as 'The Roma debacle', as Barcelona threw away a 4-1 first leg lead to suffer a quarter-final knockout in April. Goal.com
