

He highlighted some of the strategic policies that other countries wishing to attain vision 2030 had put in place. "I think it is important that we hold the leadership of this country along those strategic policy measures which other countries take and assess whether we are doing the right thing in our journey to attain the vision 2030. There are ten strategic policies which countries wishing to attain the vision 2030. The first one which they do is that they pay very special attention to a rigorous attack on poverty and unemployment, with rural poverty given special

attention. And this is done through clearly targeted investment priorities. And the goal is to transform and narrow the gap between the rural and urban areas in order to improve the quality of life of all the people. Zambia ranks as one of the countries with high poverty and unemployment levels," Prof Lungwangwa said.

Prof Lungwangwa wondered what plans the PF government could have for the poverty reduction and employment creation for the youths. "What plans does the PF

government has for the poverty reduction and the creation of employment for youths? We never head that in President Lungu's speech

What the president should have done is to tell the nation how the abundant resources which are at the disposal of the PF government can be transformed to create jobs for the youth. This is what creates hope and a better future for the youth. Where are the opportunities for jobs for our youth in the presidential speech? In the same vein, the speech did not create hope for our youth in terms of poverty reduction. The social cash transfer programme does not include the majority of the youth. Growing the economy at three or four percent does not give hope as a serious onslaught on poverty and unemployment in a rising crisis of indebtedness, the indebtedness which is taking 53 per cent of our GDP," he said.

He also regretted that the president never mentioned anything about giving special attention to knowledge and skills as well as linking education and skills training to economic policies, plans or programmes.

"High debt level is in fact the surest way of developing the incapacity to meaningfully tackle poverty and unemployment. You cannot tackle poverty than unemployment when you are highly indebted like we do. The youths should have heard from the president programmes that the are being put in place to address the misery that they are in, namely poverty and unemployment. The second policy is to give special attention to knowledge and skills and linking education and skills training to economic policies, plans and programmes. We never heard this in the speech on Friday. The president should have taken time in the speech to speck to the hearts, minds, and souls of the young people and make them see what lays ahead in terms of opportunities for the better future," Prof Lungwangwa said. "The third policy strategy is to invest in education systems that emphasize the training of more learners in mathematics, science, technology and engineering. These are the knowledge bases for a strong industrialization of the economy. Nowhere in the speech did the president make any reference to the importance of mathematics, science, technology and engineering as the basis for industrialization. The fourth policy is of course placing high premium on the value of research as a basis for discovery, innovation and creativity. There is more funding given to research institutions to undertake locally grounded research which gives solutions to the problems of development. The firth strategic policy direction is to pay attention to rapid development of digital development in all sectors as a basis for the transformation of society for inclusive development." Meanwhile, Nalumango said the country was moving in reverse.

"The reality of the Friday's speech was just to deceive the public. Zambia is in reverse in many spheres, in many areas the economy, social, political. It is dununa reverse. As UPND we are saying that we want to move Zambia forward. Corruption has siphoned the resources of the country into individual pockets. 'we are economically growing because we see congestion on the roads, because we see construction of residential houses' that is why we need a financial audit. Who is constructing these houses? Whose cars are congested on the roads?" Nalumango asked.

And Nalumango charged that district commissioners had been going round buying off opposition councillors.

"President Lungu speaks about unity in the country, if only he could be serious about it because indeed the country needs that unity emanating from the shameful manner in which the 2016 elections were conducted. In their quest to appear to unite the country, their district commissioners are busy persuading young councillors to resign in exchange for money. DCs have become the buyers, DCs are not political entities and not public servants. This is a shame. Thereafter, the PF has been using public particularly resources social cash transfer in byelections to win at all cost. Their intention in buying councillors is t make it appear that there is growing national-wide acceptance of the PF. Through such sham victories, they give people social cash transfer a day before elections and tell them that 'if you don't vote for PF, we will not come again," said Nalumango.

And Fr Chikova has also asked the Church not to discriminate politicians to worship with them based on political party affiliations. In an interview, Fr Chikoya urged church leaders not to allow politics in places of worship, explaining that the Church needs to be a place of 'good news' where members are always encouraged and motivated. "Before I even talk about politicians, I would rather the Church themselves; any church leadership that allows a politician to campaign is

politics. So, we need to be sensitive also as the Church. In as much as politicians can be condemned, the church leaders, who are shepherds, are also failing in their duties when they don't control things of the political nature. Having said this, I know the Catholic

Presidential Empowerment Fund critics should shut up - Kabwe

By Sipilisiwe Ncube Presidential Empowerment Fund Initiative patron Chanda Kabwe says those fond of criticising the initiative should just shut their mouths if they have nothing alternative to offer the needy. Last week, NDC secretary Musenge general Mwenya issued a statement questioning the Presidential Empowerment Initiative Fund, alleging that it was money obtained from proceeds of crime. But Kabwe dismissed the allegation, insisting that those questioning the initiative were only greedy people who couldn't mind their own business. "The problem is people don't mind their business. What is wrong with helping somebody who is in need? So, if them they are greedy [and] they don't want to share, let them be. We cannot be talking over the same issue year in-year out. It is a revolving fund! You can start with K2 and grow the revolving fund. I don't think there is a problem if

you grow the revolving fund. And a vision attracts people. When people see that what you are doing is noble, people will come and help. Why other people are not helping is because they are greedy! So, for us, our business is not what people are saying. The business is, 'are we doing a right thing?' Are we helping to change lives? If we are helping to change lives, we will continue. If we are hurting people, [or if] we are not helping people, we will stop," Kabwe said in an interview. Kabwe, who is also Central Province Permanent Secretary, said he would not stop serving the people because of unproductive sentiments from critics. He challenged those questioning the empowerment fund to point at what they did to help people at the time they served as government officials. "So, it is about serving others. And some of these people who are speaking the loudest, they had a privilege to be in offices. Others served as ministers, let them

point at one thing, [which] they helped somebody apart from their relatives! For me as patron, I am very proud with the programme; the programme is helping people; the programme is changing lives of the people and will continue. And even if you give me a bell of Salaula (second hand clothes) to go and help people in Mporokoso or Shangombo [districts] [and] you don't want your name to be mentioned, am I going to refuse that bell of Salaula? I won't refuse. I will go and take that Salaula. So, for us it's about service and not politics. People should concentrate on productive things. Every day, it's 'Lungu, Lungu.' I think it's high time that people started thinking about productive things," Kabwe observed. invited stakeholders He with capacity to help others to join the initiative. "There is so much that we need to do as Zambians than talking all the time. You know, talking promotes laziness! It is better you spend your

energy of talking on productive things. No one has stopped anyone from helping anyone. If people can share what they have, please let them go and help. There is a saying, which says, 'there is no one who is too rich to receive and there is no one who is too poor to share.' When we started this programme in 2015, it was: 'no it's campaign' and today we are still talking about the same thing! This man (President Edgar Lungu) is helping people, and if you are [too] in a better position, please just start helping people, also. I advise them to come on board if they have the capacity, even K1 bring, we will put it to good use. Us, we are helping people. We are not using money to send youths to go and destroy things, to go and insult people or to use them as tools of violence, no! We are using the little resources that we have to change somebody's life. So, if people have nothing to say, let them keep quiet, they can shut their mouths!" exclaimed Chanda.

11,000 girls dropping out of school annually By Abraham Kalito Research by the Campaign for Female Education (Comfed) has indicated

(Camfed) has indicated that girls have continued to drop out of school at an alarming rate because of poor implementation of the re-entry policy. And Camfed has urged government to make the re-entry policy law in order to curb the huge school drop-out rates. Commenting on the research findings in Lusaka, Camfed research executive Christine Mushibwe noted that the re-entry policy was not effective enough to help girls get back to school because it was implemented differently. She disclosed that as much as 43,000 girls are dropping out of school annually, 11,000 of whom drop out due to early pregnancies. "Despite the Re-Entry Policy being in existence for the past 20 years, its implementation has attracted a lot of debate and raised a number of public concerns over its effectiveness in addressing the initial concerns of the continuation of the affected girl's education. Every year, approximately 43,000 girls drop out of school, out of which 11,000 are due to pregnancy. The factors affecting the re-entry of school girls could include; lack of understanding of the Re-Entry Policy (REP) by both teachers and pupils; ineffective implementation of the policy by administrators social stigma and associated with teenage pregnancy. Research demonstrated that many of these schools could not condone the policy, as it is believed that sex before marriage is against the Christian faith. Many Christian schools that view the policy as immoral resort to either chasing the girl from school or referring her to another

need for support. REP may not be watertight, hence allowing a non-uniform implementation in faithbased schools and the creation of non-supportive procedures by expected implementers. However, despite this expectation, there needs to be closer monitoring, explanation, dissemination and supervision of the policy in order for it to be more effective and this, unfortunately, is where the Zambian policy falls short." And Camfed urged

government to enact the re-entry policy into law to tackle escalating levels of illiteracy. "There is, therefore, need for the policy to be made into a law, in order for it to be better implemented, as well as, safeguard the interests and promote the education of the girl child. The benefits and sensitization of the policy as well as its introduction have not clearly been explained. As a result, this has adversely affected its implementation. In addition to the foregoing, in spite of the officials having a greater awareness of the policy, not everyone is completely in support of the policy. Some officials in the Ministry of General Education, whose task is to disseminate information to schools on the importance of the REP, also had different views on it. It further highlights some of the reactions of some teachers towards the REP where they do not favour the policy, arguing that the policy tends to encourage

learners to become immoral," said Mushibwe. "Thus, if teachers can openly despise the pupils who fall pregnant and return to school, the chances are that, the pregnant girls may drop out of school, and may never re-enter for fear of being dressed-down and being despised by the teachers. A teacher's strict moral approach to the problem of premarital pregnancies can, therefore, have a negative effect on the successful implementation of the policy. But if this policy is made law, there will be no impartial implementation. Every school and official will be forced to adhere to the law. Our fear is that, if girls continue dropping out of schools at this rate, then we will not achieve some of the goals that we intend to achieve by 2030. How will you, when so many girls are dropping out of school? So, this policy should be made law, it's only then that we will see change."

German Envoy calls for more citizens' engagement with constituency offices

Bv Tenson Mkhala German Ambassador to Zambia Achim Burkart says limited knowledge of citizens and lack of formalised engagement processes for constituency office staff to engage Civil Society Organisations (CSOs) in Zambia remains a major challenge. And Speaker of the National Assembly Dr Patrick Matibini says his institution recognises the important role that the local partners in the constituencies play in enhancing the of roles Parliament. Speaking during the launch of the of the partnership strategies and guidelines for constituency offices and CSOs at Parliament buildings in Lusaka, Monday, Ambassador Burkart said CSOs at the local level were potentially a strong intermediary for information flow between members of parliament and the citizenry. He, however, noted that, currently, engagement between constituency offices and CSOs were on an ad-hoc basis. "While the creation of constituency offices improving aimed at the member's [MPs]constituent relationship, there have been challenges with regards to achieving this goal. The reasons are manifold and includes: limited knowledge of citizens on the purpose of constituency offices as well as lack of formalised engagement processes for constituency office staff to engage and be engaged by **Civil Society Organisations** (CSOs) at constituency

office level. CSOs at locallevel are potentially a strong intermediary for information flow between members of parliament and the citizenry. Currently, engagement between constituency offices and CSOs are on an ad-hoc basis," Ambassador Burkart said. He said in order for the National Assembly to improve the collaboration between constituency office staff and CSOs, the German government has supported the National Assembly in the development of partnership guidelines. He further encouraged the National Assembly to strengthen constituency offices and their staff. "It is evident throughout the process that the constituency office staff does not yet have the technical capacities to run the constituency offices effectively. The lack of continuous financial support, through the National Assembly, is furthermore hampering the offices, [and] are often not fully operational. This was and will be a challenge, and [the] National Assembly is encouraged further strengthen to these offices and their staff, Ambassador Burkart added. And Dr Matibini said the National Assembly recognises the important role that local partners in constituencies play in enhancing Parliament's representative role. "While emphasis in the guidelines is placed on fostering partnerships between constituency offices and CSOs, this

does not exclude the constituency offices | from collaborating with other sectors, such as the business community, government or quasigovernment institutions with strong presence and ties to local community. The National Assembly of Zambia, as an institution,

recognises the important role that local partners in the constituency play in enhancing the roles of Parliament, especially its representative role. Hitherto, the partnership at constituency office-level have been un-coordinated and ad-hoc. Therefore, the development of these

guidelines puts in motion a process of developing and sustaining structured partnerships between the constituency offices and CSOs," said Dr Matibini, who added that the guidelines would help improve governing the partnerships once they were formed.



K5 million extra needed for

the hosting of the Central

By Abraham Kalito Chief Government Spokesperson Dora Siliya says government does not need Parliament's approval to acquire loans because the Republican Constitution contains lacunas on clearly defining the Legislature's role compared to the Executive.

And Northern Province Minister Brian Mundubile says the Northern Province Expo has already attracted investments, notably from Chinese and Indian nationals who intend to invest in a 200,000 hectares farming block.

Speaking during a Ministry of Information and Broadcasting, Central and Northern provinces jointpress briefing in Lusaka, Siliya said Parliament is not supposed to participate in the duties of the Executive, adding that there is a 'lacuna' in the Republican Constitution governing the functions of the legislative arm of government as it relates to debt contraction.

She was reacting to a question posed by Diggers! on why government did not wait for Parliament to approve the acquisition of a US \$30 million loan recently contracted by government to upgrade the Mulungushi International Conference Centre (MICC), among a series of other loans from China.

Zambia's debt arising from Chinese loans in the year 2016 rose by 350 per cent from two loans contracted in 2015.

Government also added US\$1.3 billion to the total debt stock in just a six-month period between January and June this year alone, and

has already put pressure on critical programmes, such as the Social Cash Transfer programme.

"I think that we have been going through a window where a number of issues relating to the Constitution are under discussion. And I think there is a good argument going around that, how is it possible that if the separation in government of the Executive, of the Judiciary and the Legislature; and the Executive elected by the people is expected to perform a certain job. And when they perform that job, who should then provide the oversight? It should be the Parliament. And the argument people have been giving is that, if the Parliament is going to participate in a function of the Executive, how then will they supervise the Executive? And I think these are the discussions that are going on and this is why the Minister of Justice (Given Lubinda) has led the way to provide consultation that there are still lacuna's in our Constitution, and we need to find a way to clear them," Siliya told journalists at Government Complex yesterday.

"It's not just on the issue of Parliament participating in loan procurement because the argument that other people are giving is valid. If you are going to supervise somebody, how are you going to do it if you are

going to participate in their job? So, I think that is a valid argument people have been giving, but there are also other arguments people have been giving in the Constitution about commissions that might be sitting once or twice a vear and vet they have to be paid monthly salaries and provided with other incentives, such as cars at the expense of the people of Zambia. So, to me, the Constitution is a live matter, and I think we should await for the Minister of Justice to be able to give us direction. So, well, I think that it is a lacuna and it's not the only lacuna. We also have a number of commissions that have been provided for in the Constitution that Cabinet, that government is not able to manage."

Siliya, who also doubles Information as and Broadcasting Services Minister, said there were some government commissions which were sitting and spending money without working, as a result of lacunas in the Constitution.

"For example, I think there is the Emoluments Commission that might hardly sit. Maybe, it will sit once a year or...but government and the people of Zambia are expected to pay those commissioners every month a salary and provide for their allowances and transport,

no, clearly a constitution is created by us, the people. And we should be able to get back to the table and say, 'no, no, no!' This is a lacuna, this is not possible. We are not able to manage this and one of the arguments that have been given towards this question has been, and it is in the interest of the people of Zambia, that, if Parliament was participating in loan procurement, a function of the Executive, where will be the separation of government? Then how will Parliament be able to provide the oversight?" Siliya wondered.

"Because what should happen is that the Minister of Finance, by law, is provided for to procure the loans. And she has to go to Parliament and provide statements to Parliament government on how has performed. Now, if Parliament is participating in that process, how will they then provide an oversight to themselves? And I think that is a valid argument that people have been giving that, that will dilute separation of powers." And Mundubile said the Northern Province Expo already has attracted investments, notably from Chinese and Indian

nationals, who intend to invest in a 200,000 hectares farming block.

"We have profiled a number of sectors for investment, including agriculture, mining, energy, port and harbour services and tourism. And in each of these sectors, we came up with some anchor projects. For agriculture, we are looking at the creation of a 200,000 hector farming block in the name of Kalunguswi Farming Block. In the tourism sector, we are looking at promoting Lumangwe Falls and Kasava Bay. And we are promoting the Mpulungu Harbour. We are taking our potential investors right through the province. It was only last week when one of our own investors has pledged to put in US \$12 million in a hotel in Kasama. We have two more investors in Kasava Bay; one intending to put up a hotel, another one intending to put up a golf course. We already have teams from China and India interested to invest in farming, in the Kalungwishi farming block," Mundubile narrated.

Meanwhile, Central Province Minister Sydney Mushanga said the provincial administration would succeed to raise the

Province Expo. "I think I have made it very clear that a K3 million has been raised, and I want, on behalf of provincial administration, on behalf of the people of Central Province, to thank the private sector because all this money has come from the private sector. And his Excellency, the President of the Republic of Zambia, is going to be the guest of honour. This Expo is for the Government of the Republic of Zambia. So, the efforts we have embarked on is actually to actualise the plan that we have in place as Government of the Republic of Zambia," said Mushanga.

"The government, through the Ministry of Finance, will also be putting in something to ensure that we raise the remaining K5 million towards meeting budget of K8 million, and I am very much determined as provincial administration for Central Province that, the remaining amount of money is going to be realised and actualised. There is a lot of good will from the private sector out there. I didn't want to go into the private sector; those who have contributed and those who have promised. There are so many who have promised and looking at the budget, once they meet their pledges, we have no doubt that we will be very close to K8 million."

By Simon Sakala (Guest Columnist) After choosing the work of a teacher, I had to decide how I was going to monetize the work. In other words, I had to create a job out of the work. There were two main ways I could provide my work for money. The first way was to remain in regular employment. In other words, to commit myself to work for the employer at a salary predetermined by the employer. The employer in turn sells my work to the end beneficiary at a predetermined price higher than my salary. The second way was to provide my work directly to the end beneficiaries at a price generally determined by the market. The former would give me security while the latter would afford me freedom.

I decided I was going to do both. I was going to start with being in employment and then later transition to being self-employed at the right time. It was a work place that was rather liberal, without stringent rules or code of conduct. Therefore, I used my time there to learn the ropes and sharpen my sword. I put my hand to everything I could. I tried my ideas and tested my theories. I also learned how to connect with people. I tried to learn as much as I could from other teachers and share my ideas with them. I got

discipline critical to success when you become your own boss. The attitude and habits exhibited when you are under someone's leadership are bound to be the same you exhibit when you are on your own. If you have a habit of reporting to work late and making up for the lost time by leaving early, you are only likely to get worse when you are your boss. If you are in a habit of cutting corners, pilfering office items, using time you are paid for and other resources for personal use, you are only likely to get worse when you become your own boss. In the same vein, if you report to work on time, do all the work well and leave on time because of your boss, you are likely to fall short when you become your boss. The motivation for work and discipline should be commitment to work.

Having a job is making a commitment to work. No one gets paid for the qualifications or skills that they possess. Rather people get paid for the work that the qualifications and skills enable them to do. Commitment to the work that your job requires you do to is increasingly becoming vital. This is so because we live in times when work under the same job is likely to change anytime. Certain types of work is being replaced by new types of work or ways of working. Commitment to constant improvement at your work will keep you at the top of your job. Take the work of a teacher, for instance. The teacher's

work today is a lot different from what it was say twenty years ago. At one time, the teacher and the text book were the center and limit of knowledge. Students had no way of acquiring more knowledge than that which either the teacher or the textbook provided. It is not the case anymore. Students can now have access to a plethora of knowledge on any subject at the swipe of a finger through information technology. Which means that the role of the teacher pivots into that of a guide, a cheer leader and a synthesizer of information to bring it to the level that the students can understand. The teacher then has to stay ahead of her students in order to remain relevant.

The top companies in the world today did not exist thirty years ago. Which means that the work that they provide did not exist then. Which also means the companies that will be at the top thirty years from now probably do not exist today. The work and skills that will be required then do not exist today in the same form that they will then. Changes brought about by advancement in technology are not only making certain kinds of work disappear, but they are also creating new kinds of work. For instance, ecommerce is slowly obliterating brick and mortar retail business but at the same time providing more work for the delivery service businesses. Commitment to my job while in formal employment helped me not only to remain relevant but also to increase the value of my work and pave way for my next stage, the pursuit of a career. Pastor denies defiling orphan

The Access to Information Bill is not



Massive clean-up in Hong Kong after typhoon brings trail of destruction

Hong Kong began a massive clean-up Monday after Typhoon Mangkhut raked the city, shredding trees and bringing damaging floods, in a trail of destruction that has left dozens dead in the Philippines and millions evacuated in southern China.

The death toll in the Philippines, where the main island of Luzon was mauled with fierce winds and rain, rose to 65 overnight as rescuers pulled more bodies from a huge landslide in the mountain town of Itogon.

National police spokesman Superintendent Senior Benigno Durana told AFP that 43 other people are missing, and more than 155,000 people remain in evacuation centres two days after the typhoon struck.

After tearing through Luzon and pummelling Hong Kong and Macau, the storm made landfall in mainland China late Sunday, with reported dead in two



Machines will do more tasks than humans by 2025 - WEF

Its report, The Future of Jobs 2018, foresees robots swiftly replacing humans in the accounting, client industrial, management,

postal and secretarial sectors. Jobs that require "human skills" such as sales, marketing and customer service should see demand increase

meanwhile, with along e-commerce and social media. A major challenge will be to retrain workers, who will themselves be pressed to



update skills especially in the areas of "creativity, critical thinking and persuasion", the study found.

It surveyed personnel and directors senior executives from a broad range of companies around the world that account for 70 percent of global output.

Between now and 2022, they believe the aviation, travel and tourism sectors in particular will have to retrain workers, and identified an overall trend towards lifelong learning and adaptation.

"severe and extensive" with more than 300 people injured in Mangkhut which triggered the maximum "T10" typhoon alert.

The monumental task of cleaning up the city began as residents, some in suits and ties, struggled to get back to work on roads that remained blocked by felled trees, mud and debris.

Schools were closed, along with bus services, and travel disruption saw commuters piling onto platforms trying to board infrequent trains after trees fell on overhead lines.

Landslides and severe flooding affected some areas, with over 1,500 residents seeking refuge temporary shelters in overnight.

The storm, with gusts of more than 230 kilometres per hour (142 mph), sent buildings swaying and waters surging into homes and shopping malls, with some roads waist-deep in water.

Windows in tower blocks and skyscrapers were smashed as people cowered inside.

In the neighbourhood of Heng Fa Chuen, thousands of rocks and pebbles from the sea covered parkland along the coastline which had been battered by pounding waves.

The city's main Victoria Park had become an obstacle course with hundreds of trees down and many

completely uprooted. Emergency teams were sawing apart some of the biggest trees blocking roads and pathways across the city in a clean-up operation that

Bemba to be sentenced for bribing witnesses

The former vice-president of the Democratic Republic of Congo, Jean-Pierre Bemba, is due to be sentenced later today by international judges for bribing witnesses during an earlier war crimes trial.

The International Criminal Court in The Hague acquitted the one-time rebel leader three months ago for war crimes and crimes against humanity. But a second legal case has continued to disrupt his ambition

to stand as a presidential candidate in DR Congo. He's been found guilty of bribery, corruption and of coaching 14 defence witnesses at his original trial.

In response, the Constitutional

Court in Kinshasa ruled that Bemba was ineligible to run in December's presidential poll. He has already spent a decade behind bars during his trial and is unlikely to serve any more time. BBC

'UEFA panel needs sacking!' - Bale baffled by Goal of the Season snub

The Welshman would not be drawn on whether his overhead kick was better than Cristiano Ronaldo's but he can't believe it was overlooked entirely

Gareth Bale expressed his surprise after UEFA's Goal of the Season panel overlooked his overhead kick in the Champions League final, joking that the governing body's decision makers "want to be sacked".

The goal put Real Madrid 2-1 up against Liverpool in Kiev and Bale scored again in the last 10 minutes of the game to help secure a third Champions consecutive

League trophy for his club. Despite the spectacular nature of his first strike, the panel adjudicating UEFA's Goal of the Season award for 2017-18 opted to shortlist Cristiano Ronaldo's acrobatic goal in the quarter-final victory over Juventus ahead of Bale's goal, with only one nominee from each of the main UEFA competitions allowed on the list.

Bale told the Daily Mail : "I don't know how it wasn't on that list!

"I want to know who is on the panel because they want to be sacked."

Ronaldo's strike won the vote, with Dimitri Payet's Europa League quarter-final goal for Marseille finishing second ahead of Eva Navarro's curling effort for Spain in the Under-17 Championship final.

Bale was coy on the question of whether or not his goal was superior to Ronaldo's, saying: "It's not for me to say!"



Madrid have started a new era under the guidance of coach Julen Lopetegui, and with Cristiano Ronaldo sold this summer to Juventus, it has opened the door for Bale to play a more regular role in the team.

The 29-year-old has started all of his side's La Liga matches this term and has rewarded his new boss with a return of three goals and two assists. Saturday's 1-1 draw with Athletic Bilbao was the first time this term he had failed to find the target in the Primera Division as Madrid dropped their first points of the season. goal.com
