Government to spend K6.4 million as insurance cover for 42 fire trucks

By Abraham Kalito Local Government Minister Vincent Mwale told Parliament yesterday that K154,000 was spent as annual premiums in insurance cover for one single fire truck, totalling K6,468,000 for the 42 fire tenders procured by government at US \$42 million. And Mwale says of the three fire trucks which were involved in accidents, only the Solwezi truck had been completely damaged and ZISC was working on replacing it. Mwale was responding to Chipili member of parliament Jewis Chabi, who wanted to know whether the fire tenders procured had been comprehensively insured;

what the insured amount is: how many fire tenders were involved in an accident; how many were damaged and what the causes of the accidents were. "Each fire truck has been insured for an amount of K10 million; three fire trucks have been involved in accidents namely: one for Chililabombwe; one for Solwezi and one for Chibombo. Only one was completely damaged, which is the truck for Solwezi. The insurance firm, Zambia State Insurance Company (ZSIC), is working on replacing the fire truck. The causes of the accidents are as follows: one, the Chililabombwe one was attending an incident; the

rescue team received a call for another fire incident in Kasumbalesa boarder post. On rushing to Kasumbalesa, the driver failed to negotiate a curve and the fire truck fell on one side on the rail line. Two; one for Solwezi; as the fire truck was turning out for a drowning case, other motorists failed to give way even though the siren and the beacon were on. The driver on the fire truck struggled to manoeuvre the vehicle

through the dual carriageway and hit into a car by the side and lost control hitting into stone causing the fire truck to flip," Mwale explained. "And three, the fire truck was enroute to Lusaka for service when an oncoming vehicle lost control and hit the side mirror of the fire truck. Mr Speaker, 42 fire tenders were procured for US \$42 million translating into US \$1 million each, which translates into K10 million, and that's what we have insured for.

I'm not very sure how long it should take for the fire tender to be replaced. But processes are being undertaken to ensure that the car is insured. These vehicles or trucks were insured for K10 million each, and this is the position of government. That is the amount insured. You pay less to have that insured. So, we paid less to insure it for K10 million. And that's how everything works. And the issue of the amount insured, how much was a premium and

Failure to appoint Auditor General will escalate impunity – Chipimo

By Sipilisiwe Ncube National Restoration party (NAREP) president Elias Chipimo has warned that the Auditor General's office remaining vacant for too long may only increase the levels of impunity among culprits who politically-connected. are And Chipimo says until Zambians decide to change the type of leadership in office, cases of missing evidence at court will not stop. In an interview, Chipimo expressed concern that there would be an increase in the levels of impunity to those who may be politically-connected if Auditor General's office remains vacant for too long. "One thing that may actually impact is people's perception of what they can get away with because if there is no substantive office-holder. it can increase the sense of impunity that is already there. As you know, right now, even with the identified cases of fraud, theft and abuse of office; because there are no prosecutions against those who are seen to be politicallyconnected; people feel they can get away with literally murder. And so, where you have no substantive office-holder, it just reinforces that sense of impunity," Chipimo warned. And Chipimo noted that the ability by public officials to ignore the report has been a major problem. "In theory, it doesn't matter that the office of the Auditor General remains vacant because the key issue is the release of the report. And that can be done even by an individual who is acting in that capacity. The big problem

with the Auditor Generals' office, however, has been the ability of public officials ignoring the report and the lack of specific powers on the part of the Auditor General to follow-up on the specific cases of irregularity, abuse and misapplication that are identified in the report. So, their job is just to audit and produce a report. It's the job of other organisations and state entities and, indeed, leaders to act," Chipimo observed. "So whether you have an Auditor General there in the substantive role or an acting individual playing that role, the challenge still remains that the institution beyond producing a report has no teeth to take up the specific cases of abuse and misappropriation and misapplication that are

identified in the report. It be linked in as well so that actually doesn't change the fact that the report would still be produced. It would be produced by the acting person, but even if you have the substantive positionholder, the problem with that office is that it has no teeth to bite the culprits identified." And Chipimo said there was need for Parliament to take up the mandate of prosecuting those cited in the Auditor General's report. "So, what we actually need is a follow-up process on what Parliament can take up and pursue to make sure that the individuals are prosecuted. It needs to link back to Cabinet office so that disciplinary action is taken where there is misappropriation. Law enforcement agencies should

there is actually criminal from the prosecution DPP's [Director of Public Prosecution's] office where there is illegalities and fraud that is identified. All of these things are actually identified every year, but we never see any action. So, whether there is a substantive position or not, it doesn't change anything," Chipimo added. Meanwhile, Chipimo said until Zambians decide to change the type of leadership in office, cases of missing evidence at court would not stop. He was reacting to the missing cocaine, which went missing at the Lusaka Magistrates' Court last month. "It's not the first time it has happened. These cases of missing evidence are rife. This is not new and all this does is that it really confirms that our society is now rotten to the very core. Corruption, theft, abuse of office, stealing of evidence is now such a common thing that it's almost accepted as part and parcel of how we do business in this country, which is very sad. I can assure you that very little will be done to get to the bottom of this issue. It has to first start with the leadership. We have to make sure that we put in power the leadership which cares for this country. Until you have that, I can tell you there will be very little that will change. So, we must start thinking very hard as we approach 2021 [on] what kind of leadership we really want," said Chipimo.

for what, you know, amounts we were insuring, I'm not sure that we gave a position on how that is being portrayed, but I want to give you this position that, each was insured for K10 million and I haven't said how much we paid as premium for each one as I gave this answer." He said government had paid for insurance cover for councils that could not manage to raise the money and pay. "Some councils that are doing well managed to pay for the insurance; some councils that are not, government manged to pay for their insurance cover. Mr Speaker, if you are insuring a car for K10 million, you actually don't pay K10 million. The cover is worth K10 million, but they will charge you, maybe, US \$100,000. So, that is not how it works; you don't give them 100 per cent what the car is worth. So, premium is a different amount and cover is something else. So, in this case, we are paying annual premiums per truck of K154,000, and then K10 million the whole cover period is three years, like I said. So, we are not expected to pay K30 million, which is K10 million per year to cover a K10 million worth of truck, so, we are paying only K154,000 per year to cover K10 million premium because that is how insurance works," said Mwale. When asked how come the insurance figure had changed from \$250,000 which was initially announced by officials from his ministry, Mwale said he needed to check his records to confirm if any other figure other than what he had read out had been announced.

The kwacha has depreciated against major currency convertibles to breach the K11 per dollar psychologicalbarrier for the first time since April, 2016. And FNB Zambia says there is a sense of panic in the foreign exchange market as players do not seem to know where the kwacha's resistance levels will be. According to financial market players, the kwacha has breached the K11 psychological barrier per dollar to trade above K11.00 on account of heightened demand for dollars on the local market. The local unit was seen trading at K10.99 and K11.06 by mid-morning, Wednesday, for bid and offer respectively, according to the Bank of Zambia, down from an average of K10.30 per dollar in less than one week. This depreciation of around six per cent in less than a weekalsocomesinthewakeofrevelationssurrounding the British government's announcement to suspend its aid funding to the Zambian government.

The last time the kwacha depreciated to hit the K11 per dollar barrier was April, 2016, where it traded above K11.00 per dollar by the end the first quarter of that year. And according to FNB Zambia, the kwacha has weakened significantly, depreciating to above the K11 per dollar mark, largely triggered by negative economic sentiments, amidst the usual demand-supply factors. "The local unit continues to slip against the greenback. At its climax, the mid-rate reached USD/ ZMW11.02 in vesterday's trading session - levels last seen in April 2016. As sentiment continues to dampen, the local unit has had no firm footing against a basket of currencies," FNB stated in a daily treasury newsletter released, Wednesday. "Due to these elevated levels, a sense of panic has embraced the market as the resistance level of USD/ZMW remains unknown. Tuesday's trading opened at K10.90/K10.95 and closed

at K11.00/K11.05. We are of the view that the kwacha will continue on a bearish note." And Cavmont stated in its market report that the local currency has continued on its depreciating trend owing to the continued strong demand for dollars by corporates. "The kwacha continued its movement against the US dollar on Tuesday as demand continued to outweigh supply on interbank as well as from corporate buyers. In the interim, most market participants are likely to remain cautious as they seek to determine the kwacha's next move," stated Cavmont. Meanwhile, a check around several bureaus in Lusaka found the kwacha had significantly depreciated to over the K11 per dollar mark. The kwacha traded at K11.01 and K11.05 per dollar for bid and offer respectively at Ace-FX Bureau, while the local unit was quoted at K11.02 and K11.24 per dollar at Golden Coin Bureau by lunchtime yesterday.

AFTER UK ANNOUNCED AID FREEZE TO ZAMBIA, PRESIDENT EDGAR LUNGU REACTED IN A STATEMENT BELOW:

Four months ago, I ordered an administrative inquiry into suspected misuse of the Social Cash Transfer funds, and a comprehensive report was submitted to my office on 14th September 2018.

I have therefore given Secretary to the Cabinet Dr. Roland Msiska one week to take decisive action to curb all malpractices in the administration of the Social Cash Transfer programme because malpractices hurt the poor who survive on this vital safety net.

I have further directed that the Minister of Community Development and Social Services, Hon. Emerine Kabanshi and Minister of Finance Hon. Margaret Mwanakatwe must continue with their engagements with donors to assure them of the remedial measures Government has been undertaking since suspected cases of misuse surfaced earlier this year.

Following my dissatisfaction with the pace of the ongoing administrative measures, I have directed for quicker forensic audits by the Auditor-General and other relevant Government internal audit systems.

We need to get to the bottom of this for the benefit of our people.

In the meantime, I appeal that we give investigations a chance.

Clause on Parley approval for loans not a lacuna – TIZ

Transparency International Zambia has wondered why the PF is trying to avoid getting parliamentary approval before loan contraction if it is well e d n t e n d i And TIZ has warned that there will be chaos if Zambians started categorizing any part of the constitution they did not like as a lacuna. On Monday, Chief Government Spokesperson Dora Siliya said government did not need Parliament's approval to acquire loans because the Republican Constitution contained lacunas on clearly defining the Legislature's role compared to the Executive.

She was reacting to a question posed by Diggers! on why government did not wait for Parliament to approve the acquisition of a US \$30 million loan recently contracted by government to upgrade the Mulungushi International Conference Centre (MICC), among a series of other loans from China. "I think that we have been going through a window where a number of issues relating to the Constitution are under discussion. And I think there is a good argument going around that, how is it possible that if the separation in government of the Executive, of the Judiciary and the Legislature; and the Executive elected by the people is expected to perform a certain job. And when they perform that job, who should then provide the oversight? It should be the Parliament. And the argument people have been giving is that, if the Parliament is going to participate in a function of the Executive, how then will they supervise the Executive? And I think these are the discussions that are going on and this is why the Minister of Justice (Given Lubinda) has led the way to provide consultation that there are still lacuna's in our Constitution, and we need to find a way to clear them," said Siliya. But responding to a press query, TIZ president Rueben Lifuka wondered why the PF was trying to run away from Parliamentary scrutiny if the loans well were intended. "In 2014, the PF government approved the National Planning and Budgeting Policy intended to promote a Responsive, Transparent, Accountable and Results-oriented development planning and budgeting process. One of the policy measures proposed is to strengthen National Assembly oversight over public finance. The question therefore -Is the PF government walking away from this Policy and this specific measure on the National Assembly? If these loans are well intended, why is government averse from seeking parliamentary approval? These loans are not repaid from personal finances of our leaders but from public taxes and other revenues mostly raised by the people themselves and it is simply proper that we know what our government is committing us to the near future," Lifuka stated. for

And TIZ has warned that there will be chaos if Zambians started categorizing any part of the constitution they did not like as a lacuna. "The Constitution of Zambia (Amendment) No 2 of 2016 is categorical in its provisions and Article 63(2) mandates the National Assembly, in the discharge of its oversight of the performance of executive functions, to approve public debt before it is contracted. This is what the constitution says and this is a product of the PF Government. It therefore behooves Government to abide with every provision of the constitution, regardless of what they now see as lacunas. Until such a time that amendments are proposed and passed by the National Assembly, the PF government should and must conform to the constitution. We wish to remind Hon Dora Siliya and her colleagues of Article 1(3) which indicates that the constitution shall bind ALL persons in Zambia, State organs and State institutions. It will be a sad day for our democracy if this administration is in the forefront of advocating for defiance of constitutional provisions for any reason-real or imaginedwithout following due process of bringing about resolution of whatever shortcomings the document has. We shudder to think of the chaos that may ensue if citizens who are unhappy with one or two provisions of the constitution, equally adopt the PF Government's stance to do as they please on the premise that the constitution has lacunas," Lifuka w а r n e d

"The cure of these lacunas does not lie in ignoring or defying the constitution, but through taking appropriate amendments to the National Assembly. That said, we find the argument being pursued that the approval of public debts by the National Assembly blurs the line between the roles of the executive and the legislature, unfortunate and a deliberate attempt to essentially dilute the requirement for strict checks and balances in the performance of executive functions. Zambia is a Representative democracy and instead of the people directly exercising sovereign authority, this is done by our elected representatives in the National Assembly. Therefore, transparency and accountability are key principles of good governance and since the PF government is procuring public debt on behalf of the people of Zambia, there is nothing unusual that before the Executive goes ahead and signs for loans and other forms of public debt, the people through their representatives should give the necessary approval. It is one of the functions of the National Assembly to ensure equity in the distribution of national resources amongst the people of Zambia. It is equally one of the guiding principles of public finance espoused in the constitution that the Government should ensure sustainable public borrowing to ensure inter-generational equity.

Public debt whether for infrastructure development or procurement of services, should be obtained for the sole purpose of advancing the well being of the people and this is the lens that our MPs are supposed to use in determining whether loans or public debt in general, should be procured." He noted that Siliya's arguments raised fundamental questions.

"Some of the arguments advanced by Hon Minister of Information on the role of the legislature vis-avis the executive, raise fundamental questions. For instance, is it the role of the executive arm of government to determine how the legislature should conduct its oversight functions or the people of Zambia should be the ones to determine these parameters? And why is it that the executive seemingly have no objections to some oversight functions of the legislature except for the ones relating to approval of public debts? In a few weeks' time, the Minister of Finance will table before the National Assembly, the 2019 budget -basically estimates of revenue and expenditure. The revenue side includes an indication of the external and internal borrowings that government will seek to obtain to finance the budget. According to Article 202 of the constitution – The Minister is expected to specify the maximum limits that the Government intends to borrow or lend in the next financial year. In essence, it is the Executive determining the maximum limit of borrowing and once the National Assembly approves this, the Executive are expected to work within these limits. Why should the same executive have a problem to go back to the National Assembly when it needs to borrow beyond what was approved in the national budget?" asked Lifuka. "In Article 211, the Minister of Finance is expected to present to the National Assembly a Financial Report, together with the opinion of the Auditor General, and this report which highlights the performance of the approved budget by the National Assembly, is expected to include information on revenues received by the Republic and the debt repayments made. Now, is it the suggestion of the Executive that it should be possible for them to go ahead and acquire debt/ new forms of revenue outside the approved budget and merely go back to report on it in the financial report made to the National Assembly? Government should lead by example by hiking civil servants' wages if the minimum wage increment for domestic workers is to prove effective, says the Jesuit Centre for Theological Reflection (JCTR).

And JCTR says the revised minimum wage will help to close the income gap between the rich and poor as well as to provide some relief on low-income households.

In a statement released, Wednesday

"The results of the JCTR's Basic Needs Basket, for a family of five, have shown that the cost of living has consistently been on the increase in the past 12 months. For example, the Lusaka cost of living has risen from K4,928 in August, 2017, to K5,402 in August, 2018. This increase in the cost of living has caused a lot of financial distress, especially in the low-income households. In respect of this situation, the Centre urged government to prioritize the enactment of laws in the employment and labour sector that will protect workers from being exploited by their employers. The increment in the minimum wages will, therefore, provide some relief on low-income households. More also, the revised minimum wage will help to close the income gap between the rich and poor. The JCTR has observed that despite the wide gap between the cost of living and the revised minimum wage that still exists, the increase will help mitigate domestic workers and other category of workers affordability of basic essentials, such as basic food and services (electricity, water)," stated ICTR.

JCTR urged government to first lead by example by hiking civil servants' wages first if the minimum wage increment will prove effective in its implementation. The Ministry of Labour issued Statutory Instrument no.69 (Domestic Workers) Order, 2018 earlier this month, which saw domestic workers' pay rise to a total of K993.60 from K522.40.

"The JCTR is, therefore, urging government to implement and lead public sensitisation and awareness on the revised minimum wage. Making the public aware about the revised minimum wage is key to successful implementation of the revised minimum wage law as some employers and employees do not understand what the law means and what it entitles. Further, the Centre recommends that in situations where employers could have a challenge to meet the revised minimum wage, they

minimum wage had the potential to lead to some job losses as some employers would not meet the requirements, but equally urged employers to find other means of meeting the requirements. "JCTR welcomes this development and commends government. Not too long ago, the Centre called on government to attach great importance to revising the minimum wages in view of the rising cost of living. The JCTR has, however, observed that the increment in the minimum wage may lead to loss of some jobs for some domestic workers as the new wages may be beyond the financial capacity of their employers whose salaries have not received a corresponding increment. In such a situation, the Centre urges that ways on how the minimum wage could be met should be explored between employers and employees to ensure that justice

Lack of transparency on Chinese Proper Alliance for Change (PAC) president Andyford Banda has challenged government to

challenged government to make all Chinese contracts public so that citizens can be assured that their interests are protected. And UPPZ leader Charles Chanda says China is not here to help Zambia but to make money. In an interview, Banda said lack of transparency on government's dealings with China was causing anxiety. "I think the biggest issue that is causing all these anxieties, suspicions and rumours as a result that the government has not been transparent in their dealings with China. So what we would ask for is that there should be transparency in their dealings with China. I think that's what would help. The Zambian people want to know what has been agreed in all these contracts, where are the contracts and why can't they put them on the table? Because the truth of the matter and as a position of PAC, we don't have issues dealing with China because everyone does from America, to Britain, to Russia, but the issue is that we don't know what is contained in those contracts as far as we are concerned, between Zambia and Banda China," said. Banda observed that if all Chinese contracts agreements were and public, citizens made would not cry foul if their interests were protected. "So if those contracts or whatever agreements they have cannot be put to the table, cannot be given to the public, it will be difficult for the public to conclude to say whether what they are saying is true of not, because the fact of the matter is that the PF government has lied to us for far too long. And Kalaba has attributed the ballooning of Zambia's to corruption, abuse of office and overpayment of shoddy contracts. Kalaba, who resined from government citing rampant corruption, was commenting on the freezing of donor funding on suspicions of misuse in a statement, Wednesday. He observed that President Edgar Lungu was a defender of corruption whose fight against the vice was restricted to speeches which were written for him. country's "The top leadership must be held accountable for the syndicated grand corruption and fraud as these vices are mostly of their creation. It is no coincidence that the only time our President appears to fight corruption is when he is reading a speech prepared for him. He continues to be faint hearted about corruption and continues to tolerate and embrace those with the unmistakable scent of corruption," Kalaba stated. He observed that whilst Zambia had proper systems to fight corruption, it lacked a leadership which could make use of such systems. "I urge His Excellency the President of Zambia to have a heart for Zambians for a change and to control and stop the corruption by respecting the constitution, policies and institutional frameworks that prevent,

corruption. They just give anyone and you see in the end, that money just ends up going to people's pockets. And that's the difference between the IMF and China. So the issue is that government needs to be more transparent in dealing with China. They need to be open and they actually need to give us more information. Since this is a hot issue, I would advise the government to dedicate some level of human resource to educate the people about all this Zambia-China relationship and tell us exactly all the agreements that we have," said Banda. "The only thing that I support the Western countries is that they don't give money anyhow.

I think if it's going to be easy to be getting money, corruption is going to be on the rise. When there are things attached for example, the Chinese don't care even if that money is squandered, they don't care [because] they know that there is something that they are going to get out of it. But I think I would prefer loans that have some strings attached because there is going to be proper management of the government as they will have to fight corruption, they will make sure that the cost of running governments is lessened and all that kind of things. I think I may stand on the side of the Western guys because it looks like China is giving a blank cheque."

And speaking when he featured on Joy Fm's 'The Platform' programme, Monday, Chanda said Zambians did not like the way Chinese people were conducting business with them. "The Chinese are not here to help us, they are here to make money on us. There is nothing wrong with the Chinese money, there is nothing wrong with the Chinese loans but there is everything wrong with the way China wants to conduct business with Zambia and I have no apology on that. We need to correct that as citizens. You cannot allow a situation where a Zambian contractor will not even be given to dig a foundation, a Zambian contractor will not even be given

chance to paint a house. If we are going to pay this money back, we must be in control of this money, the money should be in this country. even the foreign contractors, let no one cheat us, people are also receiving cuts there. That is why you can hear that a minister is donating K150 thousand, where will a minister get K150 thousand/ look at his salary, maybe he is getting K18 thousand, the money is coming from these same contractors. So they are also eating, the foreign contractors are also paying. That is why you can have one company doing all the contracts. That company should God allow me to become president, I am going to investigate it," said Chanda.

This Country is only short of elected leadership that has a political will to fight corruption. The tools are there but who to use them?" Kalaba asked. "With our current debt burden at almost US\$16 billion, bilateral aid may be the only available resource to lubricate the social services engine. Zambia will be required to maintain a debt service of at least US\$2.26 billion annually for the next twenty years to be anywhere near liquidating the country's indebtedness. current This represents close to 32.4% of the total annual budget. national We know that the country has already exceeded the US\$585 million in annual debt service and this figure will rise with the Chinese loans that had 4-5year moratorium (grace periods). The country's foreign exchange earnings, 70% of which are still generated by the mines, who earn north of US\$5 billion, only contribute 6% (US\$300 million) to the country's treasury in taxes and royalties. The true burden of debt servicing

is being carried by the ordinary Zambian with income that is not generated from the country's mineral wealth but from their sweat. Please Mr. President, let's not add to these miseries by toying with aid funds through weak institutional frameworks and arrogant, carefree, public servants. The litmus test to measure government's commitment to tackling our debt crisis and strengthening oversight institutions will reflect in the upcoming budget for 2019 to see to what extent the budget will bear reductions in unnecessary expenditure and funding of the Auditor General's office." Kalaba noted that the freezing of aid would affect the lives of vulnerable groups, at the expense of selfish leaders. "My heart goes to the women and children of Zambia who are at the receiving end of this sad development which has put a dent on Zambia as a country and on us collectively as a people, at a time when our people are struggling to have decent livelihoods because of insatiable greed and our leader's cold indifference concerning their plight. The vulnerable women and children who were the target beneficiaries now have had their lifeline curtailed due to gross mismanagement

of the country's wealth by those entrusted as custodians of their National wealth and resources. The freezing of the aid will further compromise the ability of the vulnerable and incapacitated households to have a decent meal a day and hence drive them into worsening abject poverty. Women and children will have difficulties to access quality health services leading to worsening mortality and morbidity of innocent souls. It is also clear that this development sluggish hurts our trajectory to enhanced human development anchored on quality education for all, universal access to health and ending poverty," he stated. Is Zambia ready for the Saudi Arabian goat and sheep export market?

Is Zambia ready for the Saudi Arabian goat and sheep export market?

Market access has a pull and push effect on livestock production. There is no doubt that the Saudi Arabian market expectation has already started pushing up the goat production in Zambia with the number of emerging farmers (middle-income earners) engaging in goat production. However, some questions still come up in farmers' minds. Among other questions are:

1. Can Zambia afford to export one million goats a month?

2. Does Zambia meet the standards of the Saudi Arabian goat market?

3. Are we free of diseases that may pose a risk to the Saudi Arabian goat trade?
4. Since more than 80% of the goat trade is informal (IAPRI, 2017), who will participate in this export market? Will it be the farmer, intermediaries or private agrofood companies? Who are we empowering? Is the Saudi Arabian export market propoor?

5. The price that has been thrown around and which has got the farmers excited is Cost, Insurance and Freight (CIF) to Saudi Arabia. Will the farmers in Zambia afford logistics?

6. Which port will Zambia use to export the live goats? Dar-salaam or Walvis Bay? Or maybe via cargo planes? Are we going to compete with countries in the horn of Africa favourably?

7. Are we negotiating for export of goat meat so that we develop our goat value chain? If so, do we understand that Saudi Arabia has a high Islamic population? Thus the biggest constraints for the market are strict quality checks and phytosanitary norms, along with Halal requirements? Processes, such as stunning and automated mechanical slaughter, do not accommodate Halal procedures, making these methods of slaughter unsuitable for the region. If Saudi Arabia was to accept this offer (which is unlikely), do we have facilities?

8. The fact that Zambia is landlocked, Is the cost of exporting to Saudi Arabia cheaper than that of the regional market? For instance, the Democratic Republic of Congo. Has the government conducted a cost-benefit analysis as they are preparing for this market?

Who will meet the transaction costs for export? These will include costs like bulking of goats from different parts of Zambia, quarantine, animal health management, transport to the port of origin, veterinary costs for the veterinarian accompanying the live goats to the port of destination, conformity assessments, insurance, etcetera. Note that, the final price of a goat at the point of destination is the total of expenses of several intermediate steps. To answer some of these questions, let us briefly understand the Saudi Arabian livestock market, the trends in the countries (major exporters) that are currently exporting goats and sheep to Saudi Arabia, what it takes to export livestock, and what Zambia should start doing in preparation for this high-value market.

and lack of natural resources necessary for livestock production, most of Saudi Arabia's edible meat is imported, to meet its domestic demand. Currently, Saudi Arabia can meet only 56% of its edible meat demand, i.e., chicken, beef, goat and sheep, with domestic supplies (Mordor Intelligence, 2017). Most of the live goat and sheep imports are from Somalia/Somaliland and Australia. High volumes of goats and sheep are imported during Eidul-Adha, or feast of sacrifice in commemoration of the prophet Abraham. During this time, almost every family slaughters a four-legged animal, mostly goat and sheep. Trends in top countries currently exporting goats and sheep to Saudi Arabia In 1990, Saudi Arabia banned the import of sheep from Australia due to a disease called scabby mouth (Orf) and quality. Orf is a viral disease which is transmissible between animals and humans. We have scabby mouth (Orf) in Zambia, and no vaccinations are currently being conducted (Simulundu et al. 2017). The ban was lifted in 2000 with strict animal health, age requirements, proper trace back and animal management system. At the same time, Australia could not meet the demanded number of goats due to a limited number in the country.

Similarly, Saudi Arabian banned the import of sheep and goats from Somali/Somaliland in 2000 due to an outbreak of a disease called Rift Valley Fever (a mosquito-borne disease which affects both animals and humans). There is the possibility of the presence of Rift Valley Fever in Zambia although there is no scientific evidence (Dautu, 2012). The import ban affected exports caused significant economic and trade loss. The ban was lifted in 2009. Since 2011, the country has gone on recovery with major improvements in infrastructure. In their quest to entirely formalise the goat and sheep value chains, the Somali government banned the slaughter anywhere apart from abattoirs in 2013. However, Saudi Arabia again banned the Somali livestock imports in September 2016 following reports of an outbreak of Rift Valley Fever in the Horn of Africa country but lifted the ban within a year.

What does it take to export livestock to a country like Saudi Arabia?

country like Saudi Arabia? Sheep and goats are collected from different parts of the country by a trader who has sourced for the export market. They are then bulked (quarantined), and all animals animals on the ship. The veterinarian from the country of destination will conduct inspections, and if the animals pose a low risk to the goat and sheep trade in the country, they are allowed. It is important to be aware that during this quarantine period, some animals die due to inanition, and the exporter will meet the cost of dead animals.

Self-assessment

During the ZNBC TV1 main news on 7th September 2018, the Minister of Fisheries and Livestock, Honourable Kampamba Mulenga revealed that President Edgar Lungu will flag off the export of goats to Saudi Arabia next month following the completion of an import needs assessment that was carried out by the Saudi Arabian Government (https://www.znbc.co.zm/eclto-flag-off-goats-export/).

Looking at the facts presented thus far, are we ready for the export? Will this be sustainable? In my opinion, certainly not, until some measures are put in place to formalise the goat market in Zambia. The additional costs of putting these measures in place might be more than the profit arising from the export market. However, until a systematic economic evaluation (partial budget analysis) is conducted on the Zambian goat enterprise, the lucrativeness of the Saudi Arabian export market remains speculative. Zambia should rather concentrate on formalising the goat and sheep value chain and exploit the lucrative regional market before embarking on this long journey. A case in point is the failed creation of disease-free zones with the view of exporting beef to the European Union market. Do we want to repeat the same mistake? There is potential in the regional market. But are we sure we have met the local demand before we export?

What should Zambia do to prepare for the Saudi Arabian export market adequately? Since the goat and sheep market is mostly informal, the government and stakeholders must start by formalising it through a cooperative market model. This can be achieved by organising farmers in cooperatives (bulking centres) just as is the case for smallholder dairy farming in Zambia. These cooperatives must be run by the farmers with the government only playing the market or value chain governance role (policy and technical guidance). The cooperatives must run as market hubs where all activities such as training in production technologies, business management, research and innovation, animal health management, extension services, feedlots, butchering, buying and selling of live goat/sheep and other small livestock etcetera will be conducted. Some of the advantages of cooperatives include risk pooling, bargaining power, easy access to finance and centre of excellence. The Ministry of Fisheries and Livestock, with the engagement of stakeholders, MUST quickly develop the livestock policy to facilitate livestock market models such as the one in the figure below. Currently, the Second National Agricultural Policy (SNAP, 2016) attempts to address the livestock aspects, but there is a need for a strategy to operationalise the objectives already set in the policy, as we develop a nexus livestock policy.

Saudi Arabia has a population of about 32 million people (World Bank, 2016). Strong economic and population growth are the major drivers of increased consumption of meat in Saudi Arabia. Due to its location are vaccinated, dewormed, and de-ticked a few weeks before export. For Saudi Arabia, the animals must be disease free and weigh between 25-40kg. The importing country (Saudi Arabia) may decide the accredited laboratory that must screen the animals against diseases and issue an international health certificate. It is a requirement that animals have to be at the port two weeks before departure and fed on feed that they will eat on the ship at least a week before they come to the port of departure, meaning that they have to be quarantined at least for 21 days. All paperwork and export requirements are done during the time that animals are in quarantine, sent to the importing country which then authorises the export once all conditions stipulated in the import permit are met. A veterinarian accompanies animals to the port of destination with maximum attention to the

Lies have short legs; **Ambassador Fergus** has outrun govt lies

through DFID was intact and still coming through. Citizens were made to believe the Minister, while condemning us, together with our Africa Confidential colleagues, as professional misfits who were bent on alarming the nation with false reports.

Dear readers and foreign diplomats accredited to this country, our government leaders have been caught pants down on their lies - not by the Africa Confidential report or by the News Diggers' story - but by the British High Commissioner. The UK Envoy has shown us that, indeed, lies have short legs. If he had opted to stay quiet on this matter, Honourable Siliya would have gotten away with a lie and there was not going to be any statement from President Edgar Lungu. Now, they are scampering in all directions like rats under a burning shrub, but there is nowhere to hide.

It only took one well-crafted tweet from the British High Commissioner to say, "Yes, this media report is correct that

we have frozen all British aid to Zambia because we do not tolerate fraud and corruption". In a fruitless attempt to put out the fire, President Lungu issued one of the most desperate press statements ever and followed it up with the dismissal of Minister Emerine Kabanshi.

"Four months ago, I ordered an administrative inquiry into suspected misuse of the Social Cash Transfer funds. I regret that a comprehensive report was only submitted to my office on 14th September, 2018. I have given Secretary to the Cabinet Dr. Roland Msiska one week to take decisive action to curb all malpractices in the administration of the Social Cash Transfer programme," said President Lungu.

"I have further directed that the Minister of Community Development and Social Services, Hon. Emerine Kabanshi, along with the Minister of Finance Hon. Margaret Mwanakatwe, must continue with their engagements with donors to assure them of the

remedial measures government has been undertaking since suspected cases of misuse surfaced earlier this year. Following my dissatisfaction with the pace of the ongoing administrative measures, I have directed for quicker forensic audits by the Auditor-General and other relevant government internal audit systems. We need to get to the bottom of this for the benefit of our people."

How can a Head of State say that, 'I have instructed the ministers to engage the donors and give them assurance that we are taking measures?' Why send ministers and not him as Head of State engaging with the donors? Clearly, this is a statement from the President confirming that he doesn't care about fighting corruption and he doesn't value donor support.

In our opinion, it is not by mistake that President Lungu is directing the Secretary to the Cabinet to take preventive measures, instead of directing the police and ACC to arrest the culprits who were named

by the Auditor General in this fraud case. The Head of State is shielding criminals because he shares common traits with them; they belong to one club. Firing Kabanshi or the Post Master does not prove anything; we want to see prosecutions in court so that the donors can know who else benefited from this theft. Don't leave us speculating why you fired these people.

And Mr Lungu, sir, the reason you are seeing that theft report now after requesting for it four months ago is because no one believes that you can fight corruption. You are in the forefront calling for evidence of theft, but whoever does so risks their job. This is what you did to the Financial Intelligence Centre, your own government institution. You lambasted the FIC boss Mary Tshuma and unleashed criminals to hound her out of office, simply for telling you how money was being stolen and stashed away. As things stand right now, we wonder if the FIC will release a trends report next year.

Doesn't it make President Lungu feel stupid to realize that the Auditor General's office reported this fraud directly to the donors a year ago, and left him in the dark until last week? He must ask himself. "why?" And the simple answer is, because of the animosity that his administration, especially State House, shows towards oversight institutions.

It is too soon for us to forget how this regime treated Auditor former General Ron Mwambwa who had to resign after suffering endless humiliation at the hands of high-ranking government officials. Mwambwa found it very difficult to do his job without interference. We recall instances where even the Solicitor General would criticize the Auditor General during parliamentary committee hearing. We recall instances when government officials and the Patriotic Front leadership would rubbish his reports as highly sensational meant to excite the public.

So, Your Excellency, sit down! There is nothing you are talking about with regards to the office of the Auditor General speeding up its audits. You don't have any respect or interest for that office. If you had, you would have already appointed a new substantive Auditor General and have him or her ratified quickly so that he/she gets down to work.

The office of the Auditor General operates with a substantial amount of donor aid because cooperating partners depend on it to know how their money is spent in Zambia. Right now, President Lungu has kept the institution headless, and he will be expressing shock when he hears that donors have frozen aid to the AG's office. Is that a President who is fighting corruption or fighting for corruption?

In our view, expecting President Lungu to fight corruption is like asking a coffin-maker to pray for a dying patient. He will do it to please the relatives, but his honest prayer will never be heard in public.

Malaysia ex-PM arrested over \$628 million linked to 1MDB, to be charged



Malaysia's toppled leader Najib Razak was arrested Wednesday and will be charged over allegations that \$628 million linked to state investment fund 1MDB ended up in his personal bank accounts, officials said.

The Malaysian Anti-Corruption Commission said in a statement that it had detained Najib as part of its investigations into the fund and "the entry of 2.6 billion ringgit (\$628 million) into his personal account".

Allegations that huge sums were looted from the investment vehicle by Najib and his cronies were a major factor in the shock defeat of his long-ruling coalition at elections in May to a reformist alliance headed by Mahathir Mohamad.

Since losing power, Najib has already been arrested and hit with seven charges related to claims he pocketed some \$10 million from a former unit of 1MDB.

However his arrest Wednesday related directly to one of the most damaging allegations in the long-running scandal -- that huge sums from the fund flowed into his bank accounts ahead of a hotly contested election in 2013. When the allegations surfaced in 2015, they dramatically ratcheted up the scandal surrounding Najib and his inner circle. The attorney-general later cleared him of any wrongdoing, saying the money was a personal donation from the Saudi royal family. AFP
