Fuel price hike sparks public by Joseph Mwenda The Energy Regulation Board (ERB) has hiked the fuel pump prices effective Tuesday, October 2nd evening, citing international market prices and the falling Kwacha.

be noted that the Saudi Arabia deal translates to about 13 days stock of petrol and about six days stock of the diesel for the Zambian market. It therefore had minimal impact on the general supply patterns and consequently the local prices of petroleum products." He noted that ERB had not increased the fuel price since February. "It should be noted that the last upward price review was on 12th February, 2018. despite subsequent cargos being assessed, there were no price adjustments on 9th April and 15th June, 2018 as the required adjustments were below the ERB set threshold of 2.5 per cent. Further, the 14th August 2018 price review could not be implemented as there was need to take into account the Saudi Arabia cargo which was to arrive separately... Further, since the last price adjustment, the Kwacha depreciated by K7.89 per cent from a monthly average of K9.89/US\$ in February to average of K10.67/US\$ in

September 20108. Due to the volatility of the Kwacha in the last two weeks of September 2018, the daily exchange rate averaged K12.50/US\$ implying a depreciation of 26.39 per cent since the last price adjustment in February 2018," stated Mpundu. And Kambwili condemned the move, saying this was what he meant when he said the PF government is composed of thieves. "When we have been saying that these people have been stealing with the Chinese, people have taken it lightly but now the effects have started showing. Do you know why the cost of fuel has gone up? It is because the Kwacha has lost value to the United States dollars. If you talk about the pound, you cannot even comprehend it. Right now we are spending a lot of forex every month to service our debt, secondly, we are spending a lot of dollars to pay Chinese contractors because all the jobs are given to the Chinese contractors and finally, these

Chinese are now doing even the small businesses like rearing chickens so a lot of money is externalised, as a result, there is no dollar on the market," he said. "Now because of this increase, all prices of commodities including food will go up and the end result is now poverty on the people. The externalisation of this money is now having a toll on the poor Zambians. This President is a failure and the end result is that every Zambian is going to suffer. Imagine a civil servant who gets about K3,000 a month, to go to work with a vehicle now is impossible because previously, one could put a K50 in the tank and it would take him to work and back maybe for two days but now, K50 is completely nothing, you can only get two litres. This is the beginning of the end of PF." He said Zambians must be careful when voting next time. "I have warned Zambians before that let's be careful the way we select Zambians

to be President because not every Jim and Jack can be President. We go and even bring a chakolwa to come and lead us, now this is the end result. But bad things are still coming. This is just the beginning because we don't have a government. It is now suffering for everybody. I feel sorry for the people in Kalingalinga, I feel sorry for the people in Chawama, I feel sorry for the people in Kanyama and for the people in Mporokoso because they are the ones who are going to feel the effect. Let me just tell the Zambians that the time for change is now and the time to put in leaders who care for the poor, leaders who know why they are in politics is now. And I can tell you that it is not long from now, I will come and wash this country, this country is too dirty and I will come and wash this country clean. Even all the chibuku and the Jamesons that will be left, I will come and clean everything so that people can breathe," said Kambwili.

Meanwhile, Chief government spokesperson Dora Siliva took a grilling as she tried to explain where the cheap Saudi Arabia oil had gone. This was after Mwebantu News Media twitted a picture of the Zambia Daily Mail newspaper headline "Cheap Saudi Oil in", to which the minister responded "For the record, the Saudi oil was only enough for 6 days". This attracted further outrage from twitter users who questioned the minister how US\$20 million worth of fuel imports could be exhausted in six days. "Yes, it was inly 10 million litres petrol and 10 million litres diesel. Consumption is about 2 million litres for each per day," explained Siliya. "Mmmm boza, US\$20 million worth of fuel consumed in just 6 days? Dora, drink some water mwaana," argued Matakala Muyoba as Miss Bwalya added: "I don't remember that 6-day supply going down to K5.50 as promised by you people."

In this matter, Tantameni is jointly charged with Felix Mkandawire а court interpreter, Francis Mphanza, a senior public prosecutor and Didie Kangwa a senior clerk of court with three counts of abuse of authority, removal of property under lawful seizure and stealing by persons in public service. In count one, it is alleged that Tantameni and Mphanza on November 8, last year,

in Lusaka being persons employed in the public service as margistrate and senior public prosecutor respectively, jointly and whilst acting together, did use the position of their respective offices to obtain property, profit or benefit for themselves or another. In count two, it is alleged that Mkandawire, Mphanza and Kangwa on November 8, last year in Lusaka, jointly and whilst acting together knowingly and with intent to hinder or defeat the process, did conceal 34.0 kilograms of ephedrine valued at K1, 870. 000. The ephedrine was taken under the process of authority of the court of Tantameni. And in the third count, it is alleged that Mkandawire,Mphanza,

Tantameni and Kangwa between November 8, 2017 and December 30, 2017 in Lusaka, being employed in the public service as court interpreter, senior public prosecutor, magistrate and senior clerk of court respectively, jointly and whilst acting together did steal 34. 0 kilograms of ephedrine. The drug was valued at K1, 870.000 the property of Government of the Republic of Zambia which came into their by virtue possession of their employment. And when the matter came up for plea before a Chisamba based magistrate Mangalashi, Susan Tuesday, Tantameni, through her lawyer Prosper Muvatwa, submitted that the Constitutional Court should render its opinion on whether the principal magistrate resident Kenneth Mulife, who is the complainant in this matter on behalf of the Judiciary, can allocate the case to magistrate Mangalashi, who is also a magistrate like her. "This honourable court has similar authority as accused number three and for this court to try A3 on matters she dwelt with during the course of her duties as a magistrate will be a gross assault to the course of justice," he said.

Muyatwa said Mangalashi was not in a position to impartially and dispense justiciably justice to try Tantameni in the state she was in. He added that it was a serious misdirection because her immunity must first be lifted, which process he said must be moved by the prosecution pursuant to the correct section of the law and the court of competent jurisdiction because immunity was Constitional а issue. "As it stands A3 is a constituted magistrate who only happens to be on suspension and Section 7 of the Sub Court Act applies to her in the sense that all magistrates exercise equal jurisdiction," he said. And Muyatwa said the case against his client should have been disposed off through a disciplinary process because it was embarrassing to prosecute a sitting magistrate. He hoped that the order to refer the case to the Constitutional Court could be granted so that the ends of justice could be secured. Meanwhile, the prosecution applied to have the case adjourned to enable them respond to the submissions. The matter has been adjourned to October 10, 2018.

ACC arrests Chirundu

The Anti-Corruption Commission (ACC) has arrested a deputy council secretary in Chirundu for corruptly employing his son to be part of the poll staff during the 2016 general election without declaring interest. According to a statement issued by ACC public relations manager Timothy Moono, the suspect has been identified as Derick Chongo, aged 53, of Mulolo Compound in Chirundu. Moono stated that the suspect, in his capacity as part of the team constituted by the Electoral Commission of Zambia (ECZ) to recruit poll staff for the general elections, failed to declare interest in writing and went ahead to employ his son. "Particulars of the offence are that in June, 2016, at Chirundu District, Southern Province of the Republic of Zambia, Mr Chongo, being a member of a panel constituted by the Electoral Commission of Zambia (ECZ) to recruit poll staff for the 2016 Referendum and General elections, did fail to declare interest in writing to the said panel and participated in the recruitment process in which his son, Cedrick Mwenya, was an applicant," stated Moono. Moono stated that the suspect has since been released on bond and the matter is scheduled to appear before court soo

Sales tax will ensure Zambians reap maximum benefits from mines – AMSC

By Abraham Kalito The Association of Mine Suppliers and Contractors (AMSC) says the 2019 budget is a progressive document which will ensure that citizens benefit from the extractive industry through policy changes pronounced. In a statement, Association president Augustine Mubanga expressed joy at the upward adjustment to the mineral royalty tax, transfer pricing and the introduction of sales tax. "We take note with happiness the changes to the mineral royalty tax by increasing 1.5% on each sliding band and the 10% rate that will trigger at \$7,500 and above. These changes will ensure that benefit in terms of tax collection is derived and ensure that the people of Zambia benefit from their resources. Most notably is the increase from 5% to 8% of Cobalt MRT, However, we think that Govt could have done more on this tax, considering the fact that cobalt MRT has not changed in a long time, a fair adjustment of 10 15% was going to ensure that maximum revenue collection is achieved. We would like to urge the Mining Houses to support this move especially that in the last 3-4years Government had ensured that the sector stabilizes from world economic stress of 2008, 2014 and 2015 By maintaining a constant tax regime. We hope that The Mine Houses will not use this increase as an excuse to denv Zambians business," he stated. further encourage "We these mine houses to even do more in supporting local suppliers and contractors to access even more opportunities. We note with great interest the intention by the Hon Minister to consider bringing the act to parliament for amendment. We have advocated for reforms in the mining sector as opposed to Nationalization. We feel that reforms such as mandatory listing of the Mines at LUSE will provide an opportunity to Zambians to own shares and participate directly into the running of the Mines, and also Govt can take advantage and increase its shareholding ZCCM IH." through He proposed that government regulates procurements in mining sector so that 40% was given to local Zambian owned supplier and contracting

companies as a measure to increase revenue collection. "We further propose that a regulated 40% of procurements in mining sector is given to local Zambian owned supplier and contracting companies. The mining sector spend between US\$3billion to US\$4.55illion annually this includes CAPEX, lf 40% is captured it will increase economic activities thereby increase contribution to

the GDP and employment. The Mines have taken advantage of this gap to procure 80-90% of goods and services from outside. The marginalization the mines embarked on, on local companies denied business to them intentionally, this behavior can be restrained by putting up strigent laws that should protect the local suppliers and contractors. The measure taken of increasing the penalty

fee for transfer pricing to K24million is a welcome and commendable move, but we must be aware of the fact that prosecuting incidences of Transfer Pricing Crimes are very difficult. The Association proposes that all selling of contracts copper should be done here in Zambia," stated Mubanga. "ZRA must be a witness to these agreements and registered with both 302

and ZRA, this can help ZRA and 302 forecast revenue well. Further all contracts of sale of Copper that have been done outside the country must still be registered locally. This can promote transparency and reduce suspicion. The association welcomes the introduction of sales Tax over VAT, this will enhance revenue collection from the Tax payer. However, as an association whose

membership deals with the Mines and the issue of VAT is very prominent, we appeal to government to give enough time for changeover. This will enable companies to upgrade their software's Manage the transition in terms of training. If the Tax payer is dealing in a variety of products that might attract different tax rates, the management of sales tax might be a challenge from the initial point."

The west using intellectuals in anti-Chinese crusade – Wynter

Bv Mirriam Chabala Rainbow Party General Secretary Wynter Kabimba says it is an exaggeration to say that the Chinese nationals are taking over Zambia. And Kabimba has charged that the West is using African intellectuals like Kenyan law Professor Patrick Lumumba in their anti-Chinese crusade. Speaking when he featured on Prime Televisions's Oxygen of Democracy programme, Monday, Kabimba said Zambians were exaggerating their concern over the presence of Chinese nationals in Zambia. "Zambia and China share a very strong bilateral relationship from way back. The Chinese did stand by us during the apartheid regime when the West had gone to bed with Boers in South Africa. But to say that China is taking over Zambia? No I think that is an exaggeration. What I do not agree with is to give preference to a Chinese over me in my country, that I do not agree with and I think that's ridiculous," Kabimba said. "But on issues of land yes I do agree. But on issues of contracts, that money is coming from China and the Chinese want that money to go to Chinese contractors. So we are a poor country, we can't decide. The Chinese government does not want their money to go to a British company. This is their money and they choose who their money should go to and we can't complain. But on the issue of land, the Chinese own more land in this country than you and I and that what's I am saying." And Kabimba charged that it was possible that Prof Lumumba was being used

by Western countries to promote the anti-China crusade because he was speaking their language. "That's why am saying I wish Lumumba had been allowed to come and deliver the lecture, we missed an opportunity, I wanted to attend myself. [But] let me tell you, it is easy for an African intellectual to be used by the West in this anti-China crusade. The guys are very clever, they select intellectuals, that's why tomorrow he's appearing on CNN, on Tuesday he will be BBC. He's speaking their language, he's running the crusade on behalf of the West. So they are in love with him...," Kabimba charged. "So I am hoping that (Wednesday) tomorrow as he appears on CNN in America, since he's a Pan African and Pan Africanism is about justice across the continent, I hope he's going to talk about black lives matter in America. How black Americans have been gunned down by white police officers in America. So I hope he's going to take on the American government about all the injustices going on there as he features on CNN. I hope he's going to condemn the American President [Donald] Trump for having referred to African countries as shit countries if he's a Pan African. If your actions or your words are going to cause anarchy or disorder in the country or to disrupt the unity then you may be labled as security risk ... and how is Lumumba our interest? He was coming into Zambia, so what? What was he bringing to Zambia that would have changed the price of oil in Zambia?"

Kabimba said he wished Lumumba had been allowed entry into Zambia so that he could debate with him "I don't know Prof Lumumba personally. I started reading and hearing about him from social media in the last three or four months. Before that, I didn't know there was a Prof Lumumba so I can't vouch for him, I can't vouch about his character, even his international reputation. I received an invitation from Eden University last week where they said 'he's a good orator, he's eloquent, he's an intellectual' and that kind accolades. So I have not met him personally, he's not like old [Professor] Ngugi wa Thiong'o whom I have met personally and I have interacted with him. I remember when I was Secretary General of the Patriotic Front we invited him here under the Policy Monitoring and Research Centre (PMRC) to come and

deliver a public lecture. So I have met Ngugi wa Thiong'o , I have not met Professor Lumumba, so am limited in what I can say about him. I wish I knew the reasons for the denial of entry by the Zambian government. I watched a clip yesterday (Sunday) evening on ZNBC and the Honourable Minister of Home Affairs Stephen Kampyongo said 'we have the right to refuse entry to anybody as a sovereign nation'. I don't think that was enough explanation, I didn't hear him talk about security aspects," said Kabimba. "So I actually do not have any facts, I wish he had been allowed to come and present the lecture. If it were the time when I was government, I would have told President Michael Sata 'allow him to come in' and we will take him on, we go and debate with him. That would be the right thing to do, you don't kill an idea! Ask the guy to

come in. Don't kill an idea by deciding not to listen to it, because sometimes you will just be promoting a guy who is going to say nothing really. You just give them credit for nothing. Just because the guv has been described as an orator, as eloquent... I wanted to come and listen to how eloquent he is because the fact that you are eloquent does not mean that you are making sense. The fact that you are an orator does not mean that you are making sense. And in fact, from the invite that I have, the guy (Professor Lumumba) was not going to come and talk about the relationship between Zambia and China. I think his topic was 'China – Africa challenge' or something like that 'and the due dynamics' so he had a very broad topic about the relationship between China and Africa, except that he was to deliver that lecture in Zambia."



Mazabuka Central UPND member of parliament Gary Nkombo says if the party had forced him to resign from his position as parliamentary whip because he was under investigation for murder, he would not be chairperson for elections. And Nkombo says Finance Minister Margaret Mwanakatwe should have told the nation how the national 2018 budget performed before presenting next year's financial plan. Speaking when he featured on a live programme on Millennium Radio, Monday, Nkombo said he was still chairperson for elections because he was in good books with the party. He was responding to a question on whether he retired as parliamentary whip because he was by police. summoned "I made the appeal to the (party) president [Hakainde Hichilema] three months ago and said to him: 'sir, I

think that I'm overloaded, I need to concentrate on elections, I would like you to find somebody' and in that same three months, a lot of consultation was being made and it was a collective decision that we settled on Dr [Situmbeko] Musokotwane. And so, the announcement just coincided with the [police] call-out and if that be the case that there is a bearing on the matter, I'm still the elections chairman. Why did they not then ask me to leave the portfolio of elections chairman? I'm still the elections chairman in as far as I'm concerned. The police call-out to me I'd like to look at it as a normal line of duty of police. Should it have any political undertones or inclinations, we will get to cross the bridge when we get there because don't forget that a subject like this, if they find any evidence, it has to be presented before a (court of) law of competent jurisdiction. And so there is no

connection," Nkombo said. And Nkombo lamented that Mwanakatwe failed to articulate the 2018 budget's performance as she presented next year's budget. "When Mwanakatwe came to read this budget, she should have told the nation that 'last year's budget was K71.6 billion, of this K71.6 billion, our estimated revenues were so much and the programmes that were drawn were so much, and this is what we delivered.' There was nothing she said about how the performance of last year's budget was," Nkombo said. He further observed that there were no tangible deliveries in the announced budget. "You can read a flamboyant budget like the President [Edgar] Lungu I heard him say [that] 'the budget was sparka' whatever that sparka means. Sparka must translate

into real tangible deliverables. If I were to be more critical, I am inviting Zambians to say last year there was a budget, which was K71 point something billion. It had to get the component of revenue in expenditure. This is what I'm talking about that the execution of a budget is of prime importance to the person, the citizen who is sitting down there," he said. He criticised the huge allocation to the Ministry of Defence when the country is not at war. "Government must make sure that the infrastructure that supports education should be put in place. In health, they have done poorly; in education...We have what we call the Maputo Declaration, which was done in 2008. This is a document, which was done by African Heads of States, to make sure

that agriculture budgeting must comprise at least 10 per cent of the national budget because agriculture is food, and food is life. I want you to know that when I looked at the component of what they have put in agriculture and Farmer Input Support Programme (FISP) and also strategic food reserves, which is not even agriculture because the market of grain can be done even without FRA, that we should know. You asked me about the Public Order Act; why put K6 billion [Actual: K5.1 billion]? Are we at war? Because the budget here that I am reading is saying that they have put K2 billion in Public Order Act and I think K5 billion in defence. Defending what? This money should come to health, it should come to education because there is no war here," said Nkombo.

He said whilst Zambians were wasting time gossiping on social media, the Chinese were working and making money, therefore it was useless to complain that foreigners were taking over everything. "When you are talking about Pamela why, the Rwandese busy organizing are themselves to sell in shops. While you are talking about Zed farmer, the Rwandese and the Chinese are busy working. So if you want to spend your life gossiping about sex, gossiping about who is sleeping with who, gossiping about Pamela, you will continue to complain. That's why the President was saying that we should run away from this culture of complaining about everything. There is no country which has been built on complaints. Countries have been built hard work, on solidarity, on patriotism, on commitment and if you want to use social media as a platform to complain, you can continue but there are enough Zambians, the majority of us who are working everyday to improve the lives of the people. By Sipilisiwe Ncube UPND leader Hakainde Hichilema yesterday got pissed off when he featured on Radio Phoenix's 'Let the people talk' programme after one of the callers repeatedly accused him of selling the Mines. And Hichilema has warned PF media director Sunday Chanda that he will run away from his own country once PF gets voted out of government because he has taken up "the job of insulting HH everyday". Meanwhile, Hichilema says some businesses will shut down due to PF's attempt to entertain administrative changes on the collection of Value Added Tax (VAT) systems. The opposition leader got emotional when a caller called Elvis accused him of privatising the mines. "Elvis keeps on playing this broken record that HH sold the Mines. Hey my friend Elvis, I was only 30 years old when the

MMD government privatised the Mines and I never worked for government. I have said this several times, over and over. And people like you have no capacity to hear things that are said over and over. It's just a level of hatred. You can see the venom that he comes out [with and] probably he doesn't even like to hear that there is a human being, a Zambian citizen called HH. He says I have shares in Anglo America, if I wasn't busy, I would take this guy to court because this is recorded, to prove that I have shares in Anglo America. I have no shares in Anglo America. So but to spare him with the anguish, he is already suffering, Elvis is already suffering and to spare him the anguish, I will not take him to court because the poor fellow will just be in court and get convicted for nothing. You must see what vou say about human beings. I never sold any Mine, not even

a single one," Hichilema said. And responding to a question from Sunday Chanda who asked why his reaction on the budget was contradicting with that of his party spokesperson, Hichilema described Chanda as a coward. "Chanda, PF said they will grow by seven per cent and they are growing by three per cent. PF said that they will borrow less, PF said that they will maintain four months import cover [and] today the import cover is two months. Chanda, your friends have failed and you even know it but you don't want to accept it. We have suffered enough. You are enjoying, others are suffering. I am impressed that Sunday Chanda has courage to ask me questions. I am very impressed with his Dutch courage. In English Dutch courage means you give yourself courage which you don't even have. You are in essence a coward. If you see

how he insults me every single week, Sunday Chanda's job is to insult HH. That is what I call cowardice," said Hichilema. "Sunday Chanda you are a coward. Confront me, meet me, talk to me, tell me facts, let's debate. You know that you cannot even stand one minute debating facts with me, you even know it. You were in MMD and today he is saying PF has constructed more infrastructure than UNIP and MMD put together, what a lie. You are working on Kaunda's infrastructure. Sunday Chanda is really a young man who is messing himself up in a manner that when PF is out of office, he will probably run away from this country, running away from his own shadows because of the way he is carrying himself." He says some businesses would shut down due to PF's attempt to entertain administrative changes on the collection of Value Added Tax (VAT) systems.

"The PF will try and entertain what is called administrative changes on a selective basis. In agriculture they will put measures maybe to support one or two companies, in industries they will do that to support one or two companies. Mostly you can speculate which companies will receive those favours, it will be foreign companies from a particular country. So in doing that, you create distortions, you create inequity in the eyes of the tax payer and therefore you create that opportunity of administrative intervention. Even ZRA has systems that will capture VAT easily at the ZRA and at a trading place at the point of sale," Hichilema said. "The cost of collecting this revenue will be high because you already have a VAT system both at the revenue collector (ZRA) and at the traders point. And now you have to completely start all over to do away with that system and bring a new system which means buying a new software, installing a new software [and] everybody will pay a lot of money. Not just government [but] even companies. When you increase the cost like that, you are now creating difficulties for businesses to survive. Some businesses will shut down. They were saying that HH is just bitter [but] today, no one can say that HH is bitter because the country is in a debt crisis. Today let me tell the people of Zambia that businesses will shut down and if businesses shuts down, you know that jobs are lost." And Hichilema said it

is ignorant to think that government will save a lot of money through VAT refunds. "This is the most ignorant comment I have ever heard in this argument of VAT refunds. It doesn't matter who said it [but] it is the most ignorant statement I have ever heard, that government will save a billion kwacha in VAT refunds. Who owns that VAT, it is the money that is owned by businesses including Zambian individuals. And then ignorantly someone argues that government will save money, save whose money? That money never belonged to government. It belonged to businesses. It is better in the hands of businesses because they will re-invest and create more jobs for the unemployed youth and women. And if someone went to school and argues like that, then my next question will be which school did you go to? You went to Russia [or] you went where? Which school did you go to where you start claiming what does not belong to you? And when you fail to pay back the money you start saying 'no I am going to save a lot of money. It was never your money" said Hichilema

Lungu urges Zambians to venture into fish farming

By Mirriam Chabala President Edgar Lungu has advised farmers to start investing in fish farming, saying Zambia could stop importing fish from other countries if citizens diversified their farming practices. And Economics Association of Zambia (EAZ) president Lubinda Haabazoka Dr says the agricultural sector would become the country's biggest employer if only citizens using government's good policies could diversify their agricultural practices. Speaking when a delegation of government officials from various institutions toured fish ponds at State House, Tuesdav, President Lungu said farmers cultivating maize and soya beans would no longer complain about non-availability of market for their produce because more people had started engaging in fish farming. "The production of fish has been intensified because of the number of people who are in fish farming now, and I think there is need for more soya beans, more maize. So, then, people should not say, 'there is not market for maize or there is no market for soya beans.' We need more soya beans so that we can feed into this fish farming industry, which is coming up. We are hoping that in years to come, we will not be importing fish. I think the figures are there to tell at

the Ministry of Fisheries and Livestock that in the past few years we have done very well. So, we will have to scale it up by demanding that Mr [Amos] Chanda is not alone [in this business]. We want all you to engage in fish farming, produce some chickens in the backyard and that way you will save a bit of money. 'More money in your pockets' means that you are saving some [resources]; you are not spending everything," President Lungu. said

And Dr Haabazoka called on more Zambians to diversify their agricultural practices by embracing fish farming, away from maize and soya beans. "I think we have always, as an association, advocated for economic diversification. And when you look at our agriculture sector, it's the major employer. But unfortunately, the sector itself was not diversified. But it's very good that for the past three years, government has continued to announce

measures in the national budget that are aimed at putting more land under irrigation to ensure that we grow existing farmers [from] subsistent to commercial farmers, and also measures have been put in place to ensure that more people come on board and do fish farming," said Dr Haabazoka. "We cannot have a situation where Zambia is importing fish from outside the country, given the rivers, waters that we have. And it's very good that government has identified this area as a source of not only income, but also to help reduce stunted growth, poverty... because fish is food with a high source of protein. I think that if every village had fish ponds at its farms then we are going to see that we are going to drastically [reduce] our poverty and we are going to also export to our neighbouring countries that, unfortunately, are lagging behind as compared to Zambia."

restart honey exports

Ministry of Commerce, Trade and Industry Permanent Secretary Kayula Siame says government is currently in talks with South African authorities to restart exporting honey to that country following an export ban on the commodity. South Africa had imposed a ban on the export of organic honey from Zambia after a consignment of the commodity was allegedly found with American foulbrood disease also known as Peanibacillus larvae. Zambia's High Commissioner to South Africa Emmanuel Mwamba protested the ban in the immediate aftermath, saying it was done outside procedure and was against trade regulations. But in an interview, Kayula said that government had examined the commodity, sent samples to South Africa and was currently waiting for that country to respond. "We have examined the honey that was said to be contaminated. It was sent to laboratories and it was carefully examined. We have the results, which I cannot tell you right now. We have communicated with our exporters on the results," Siame told News Diggers! in an interview in Lusaka. "And right now, we are in constant touch with our South African counterparts to see what they will have to say about the findings that we sent to them. What I can tell you is that everything that we needed

to do to ensure that we restart the export of honey to that country, we have done it. We have done our research, we have done our homework. And we have sent the results to that country (South Africa), and we are waiting for them to say what they have to say about what we have found here in Zambia. That is the only thing stopping (Zambia) right now from exporting honey to South Africa. Hopefully, they will look at the results quickly and say whatever they have to say about it. We are keeping our fingers crossed and we hope that we will soon start exporting honey to that country again. That's all I have to say." **BUILDING WITH KASONDE**

It is not just about how nice they look. Non-slip porcelain tiles are a good option as they are very durable and easy to clean. For places like living room, bedrooms, tv rooms; carpets and ceramic tiles are ideal. Ceramic tiles are easy to clean, carry more beautify decorations and their texture is warm although they are mostly less durable and expensive compared to most porcelain tiles. In very high traffic places like, verandas, hallways, churches, passages, supermarkets; clay tiles or masonry (stone) slates are ideal as they are both highly durable, easy to clean, not slippery, relatively affordable and have high resistance to weather elements. When all is said and done, it is important to take time and learn about things you are about to use when building. Most materials and finishes from genuine sources carry usage instructions. Like medicines, materials and finishes are specific and they should be used according to the function they were made to serve if they are to work well.

"Who is this Professor Patrick Lumumba? In Kenya the way they know him, this is somebody who stole Wachira Maina's work and pretended that it was his work. Wachira Maina went to court last year. And the consequence of that, people will lose confidence in the Judiciary, they will lose confidence in the police, they will lose confidence National in the Prosecutions Authority and we will become an empty society," Kabimba warned. Well said, but that is not what caught our attention. His concern about Zambia's failure to institute judicial reforms is what got us thinking. Particularly, we were able to relate to his displeasure of the trend in Zambia where government programmes are abandoned every time there is a change of public office bearers. "There was a judicial reforms and legal commission, which was set up during the time I was Minister of Justice by the President,


by former headed Supreme Court judge Honorable Mr Justice Fredrick Chomba. The idea of that commission of inquiry was to recommend reforms in the Judiciary, the prisons service and the police because these three institutions work in tandem. We saw all these problems and we set up a commission of inquiry where people could come and reveal that, 'this is what is going on," Kabimba remembered. "I am saddened to note that since Ι dismissed from was government, since the demise of Michael Sata on the 28th of October 2014, I have hardly heard about that commission of inquiry. The problem in our country is that government programmes are attached to an individual that initiated

them without looking at the underlying principle or benefit that such a programme would bring about." Comrade Kabimba was spot on! Even us who are outside government can vividly see that there is a trend of abandoned programmes when an individual who initiated them is moved, or worse, fired. For example, a change of Minister of Finance went with the IMF bailout programme. We won't hear much of it now because that was Felix Mutati's pregnancy; his successor has aborted it and turned to China to conceive her own. Another example is when there was a change of minister at Agriculture. We saw government abandoning the traditional implementation of the Fertilizer Input Support Programmes. But

already, Dora Siliya's methods have gone with her transfer, leaving her successor giving the e-Voucher a red card. This is the trend in all the ministries where there is a change of office bearers. It is this mess that Comrade Kabimba was talking about. The reason these programmes are abandoned is not that they are bad, but because the pioneer is either not in good standing with the system or mere jealousy by the successor. Governance is not supposed to be like that. What is good is good, and must be implemented and cherished for the sake of the country, regardless of who initiated it. The former justice minister is right. Zambia desperately needed judicial reforms, and had that Justice Chombaof led Commission

Inquiry been allowed to operate, we were not going to be seeing such an escalation of thefts and corruption within the arm of government that is charged with the responsibility of dispensing iustice. How did we get to a point where the State's position on high profile cases changes depending on the person holding the office of Director of Public Prosecutions. Only in Zambia can we have a DPP U-turning on a conviction achieved by the previous office bearer. How can a DPP win a case in the High Court, and a new DPP goes to the Supreme Court to say, "I don't support conviction?" that Where on earth? Fellow Zambians, our Judiciary has been reduced to a casino today, where nothing else matters more than money. The more you have, the more you win. It is money that caused the cocaine exhibit to grow legs and disappear. But again, we must not be surprised that this trend doesn't seem to worry the people who are supposed to revive the Justice Chomba Commission of Inquiry, because the Executive itself big is another casino being run by individuals with impeccable gambling



Tobacco and reforms boost Zimbabwe economy

After years of sluggish growth, Zimbabwe's economy is showing signs of recovering and will grow faster than expected according to the central bank's latest statement. The highest ever tobacco sales and economic reforms are just some of the reasons the central bank says this economy could be one of the continent's best performers this year.

Initial projections of 4.5% have been revised upwards to just over 6%, but its not without challenges and risks.

Many had hoped the monetary policy statement would tackle the crippling foreign currency shortages and to an extent it did.

Among the measures are special accounts for foreign currency earners. Foreign truckers will now be forced to pay for fuel in hard currency.

The government will reduce its overdraft with the central bank, but authorities still face their biggest hurdle - raising public confidence that was lost under the previous government.

Most Zimbabweans are reluctant to keep their money in banks and this has contributed to cash shortages. BBC

India police fire tear gas, water cannon to stop farmers' march

Clashes have broken out on the outskirts of India's capital New Delhi as police used water cannon and tear gas to stop thousands of protesting farmers entering the city. The farmers, reeling from high fuel prices, were pressing for government help on Tuesday, including higher support prices for agricultural

sugarcane dues and waivers on farm loans ahead of elections due in 2019.

Marching from adjoining northern states, the farmers blocked one of the highways into Delhi and used tractors to try and break through a police barrier, television pictures showed.

Some reportedly threw stones

The protestors reached the Delhi outer limits on foot, in buses and on tractor trailers under the banner of Bhartiya Kisan Union (Indian Farmers Union), a farmers group critical of Prime Minister Narendra Modi's government. Dharmendra Malik, a member of the union told Al Jazeera that police fired

unarmed farmers". He claimed 50 people were injured.

The police could not be reached for comment immediately.

Deputy But earlier Commissioner of Police (East) Pankaj Singh defended the police decision to stop farmers from entering the national capital, saying it would create Elections are due in India next year and as votes approach unions representing farmers and other groups have staged protests in an effort to secure sweeteners in exchange for support at the ballot box.

The farmers demonstrating on Tuesday were mostly from Uttar Pradesh (UP), India's most populous state with more than 200 million people and its most electorally important. Abhimanyu Kohar, a farmer, condemned the police's actions against protesters, and said farmers will continue their demonstration until their demands are met. "There should be dialogue within a democracy. But this government is in a denial mode, they are unwilling to accept that there is a farm crisis. They will pay heavily in the upcoming elections for what they have done today," he told Al Jazeera. Namibia pledges land reforms to boost black ownership

Namibia's president has called for a change to the country's constitution to allow the government to expropriate land and re-distribute it to the majority black population.

"The willing-buyer willing-seller principle has not delivered results. Careful consideration should be given to expropriation," President Hage Geingob said on Monday at the opening of the Second National Land Conference in capital, Windhoek.

The willing-buyer willing-seller policy depends on

commercial farmers offering to sell their land to the government.

However, many farmers are reluctant to sell and those who were willing often inflated the prices, making it difficult for the government to acquire adequate land for resettlement purposes.

In a proposal that echoes the fierce political issue in neighbouring South Africa, Namibia now wants to transfer 43 percent, or 15 million hectares (58,000 square miles) of its arable agricultural land, to

previously disadvantaged blacks by 2020. Namibia, which was ruled by colonial Germany and then apartheid South Africa until 1990, has large swathes of agricultural land, as well as major diamond and platinum mining industries. Statistics issued by the Namibian Statistics Agency last month showed that white Namibians owned 70 percent of agricultural land and blacks 16 percent. Out of some 250 farms under foreign ownership, most were held by Germans, it showed. AL JAZEERA

Halep sidelined indefinitely with back injury



Women's world number one Simona Halep, who retired during her first-round match in Beijing over the weekend, said on Tuesday she has a herniated disc.

"I had an MRI on my back and found out that I have a herniated disc," the 27-year-old Romanian wrote on social media. "I will consult doctors in the coming days and will keep you informed."

"I hope to be back quickly," she said, without offering any timescale.

On Sunday, Halep said she was "worried now" when a persistent back problem forced her out of the China Open after just 31 miserable minutes.

The Romanian never looked comfortable against Tunisian qualifier Ons Jabeur, losing the opening set of their firstround match 6-1 before calling it quits.

She said at the time she thought it was a different back problem from the one that contributed to her early loss in Wuhan a week earlier.

"I knew that there is pain, but I thought if I warm up during the match, it's going to be better, but it wasn't," she said.

The Romanian has been struggling with injuries over the later stages of the season. She dropped out of the New Haven tournament at the end of August with an Achilles problem and then lost in the first round of the US Open a week later.

Ronaldo denies 'fake news' rape claim as police reopen investigation

Police said Monday they had reopened an investigation into a rape accusation made by a former model who says soccer star Cristiano Ronaldo attacked her in his Las Vegas hotel penthouse suite in 2009.

Ronaldo, who now plays for Juventus in Italy's Serie A, rejected the charges as "fake news" during a live chat on Instagram.

"What they said today, fake -- fake news," the 33-yearold star of the Portuguese national team said in a post that was later deleted.

Kathryn Mayorga, 34, of Las Vegas, accused Ronaldo, in a 32-page complaint filed last month with a district court in Nevada, of raping her on June 13, 2009. The Las Vegas Metropolitan Police Department confirmed in a statement that didn't name the superstar it had responded to a call of a sexual assault on that date.

"At the time the report was taken, the victim did not provide detectives with the location of the incident or suspect description. A medical exam was conducted,"

it said.

"As of September 2018, the case has been reopened and our detectives are following up on information being provided by the victim."

Mayorga alleges in the lawsuit that she was pressured into signing a nondisclosure agreement to keep the alleged rape secret and is seeking no less than \$200,000 in penalties and damages.

The complaint was first reported by the German magazine Der Spiegel. Lawyers for Ronaldo have reportedly threatened to sue the magazine over the story.

In the suit, Mayorga said she met Ronaldo, who was then 24 years old, on the evening of June 12, 2009 at the Rain Nightclub in the Palms Hotel and Casino in Las Vegas.

It said she accepted an invitation to join Ronaldo and others in his penthouse suite to "enjoy the view of the Las Vegas strip."

She was invited to join guests in a hot tub but she declined because she did not have a bathing suit, the

complaint said.

Ronaldo offered her clothing and then followed her into a bathroom where she was going to change clothes, it said.

After she refused his demand to perform oral sex and said she wanted to leave, Ronaldo pulled her into a bedroom and anally raped her while she screamed "no, no, no," the complaint said.

"When Cristiano Ronaldo completed the sexual assault of the plaintiff, he allowed her to leave the bedroom stating he was sorry, he was usually a gentleman," it said.

The lawsuit said Mayorga reported the alleged assault to the Las Vegas police the same day and underwent an examination at a local hospital.

It said the assault had left her with "severe emotional and bodily injuries including but not limited to anal contusions, posttraumatic stress disorder and major depression."

She developed an alcohol problem and was suicidal, according to court documents. AFP

By Alex Chilumbwe FIFA has ordered FAZ to immediately sort the problems that have engulfed City of Lusaka FC. In a press statement availed to the media in Lusaka yesterday, the World Soccer body further directed FAZ to prepare a report addressing

complaints of interference by third parties in the affairs of City of Lusaka FC and submit to FIFA by October 8, 2018. According to letter dated September 28, 2018 addressed to FAZ Secretary General Adrian Kashala and copied to City of Lusaka FC, obtained by ZANIS, FIFA Secretary General Fatma Samoura indicated any problem City of Lusaka faced had to be addressed by the country mother body, FAZ. "FIFA recognizes that the situation of City of Lusaka FC is an internal matter, it is incumbent upon the national mother body to assess the problem and protect the welfare of its members using applicable FAZ regulations," Samoura wrote. Samoura reminded FAZ that according to article 14, paragraph 1 letter I and article 19, paragraph 1 of the FIFA statutes, member associations are obliged to manage their affairs independently and without undue influence third from parties. "We bring to your attention that article 17, paragraph 1 of the FAZ statutes in our files of March 2017, also establishes that each member shall manage its affairs independently and with no influence from third parties," said Samoura as she quoted the FAZ constitution. City of Lusaka FC Secretary General, Christopher Chilongo had written to FIFA in a letter dated September 14, 2018, complaining about interference in the running of its affairs, claiming that FAZ had allegedly taken a passive role in ensuring that the interests of City of Lusaka FC were protected. FAZ Secretary General, Adrian Kashala could not comment on the matter as he was in Cairo Egypt, attending a Confederation of African Football (CAF) meeting.

Be optimistic, Pochettino urges depleted Spurs ahead of Barca clash

Tottenham Hotspur will be without five key players for at least two weeks due to injury, but manager Mauricio Pochettino was in upbeat mood ahead of the Champions League clash with Barcelona on Wednesday. Dele Alli (hamstring), Serge Aurier (thigh), Mousa Dembele (thigh), Christian Eriksen (abdomen) and Jan Vertonghen (hamstring) will all be out until after this month's international break. Spurs conceded two late goals to lose 2-1 to Inter Milan in their first Group B match, but Pochettino demanded a positive approach against the La Liga champions. "It is a period when we are not in good luck with injuries... We are not victims, though. We must feel strong," Pochettino told a news conference on Tuesday. "Every player must feel they can win and achieve what we want. It's about enjoying the game tomorrow and the best player in the world in (Lionel) Messi. Football is not a drama but always it's about being focussed, competitive and enjoying playing against the best player in the world." REUTERS
