Big thieves can't be caught, they bathe in charms - CK

National Democratic Congress (NDC) leader Chishimba Kambwili says the real plunderers of public funds cannot be fired or arrested because they bath in charms day and night to cover up their offences.

And Kambwili says last week's arrest of members of the clergy along with Centre for Trade Policy and Development (CTPD) officials in Ndola is an indication from God that the Church should wake up and mobilise its members to challenge government.

Commenting on the ongoing dismissals of civil servants for theft of public resources, Kambwili, the former chief government spokesperson, argued that it did not make any difference if government fired junior officers because the biggest thieves were still in the system.

He alleged that they bathe themselves in charms to cover up their crimes.

"The Financial Intelligence Centre (FIC) has mentioned ministers who have been involved in corrupt activities, and anybody is able to see that these ministers have become rich within the last two years that they have been in government. Even some people at State House have become very rich! Owning properties that are not commensurate with their earnings, but none of them has been fired. So, the fight against corruption should not be targeted at junior officers; we want the big fishes to be booted out! It's hypocrisy of the worst kind to try and show that you are fighting corruption when you are leaving yourselves, who are

the major plunderers. We know the people who are the real plunderers in this nation. So, they should not pretend by taking action against civil servants who have done misapplication or misappropriation of funds. In any case, misapplication or misappropriation is just using funds for purposes, which they are not intended for," Kambwili told News Diggers! in an interview.

"But politicians are becoming stinking rich! And the President knows about it. Some of these politicians we know that they use juju so that they cannot be fired. They carry juju on their bodies. Nga mwabanunsha banukafye ifimuti, ifimishila.

imishila! (Some of these Ministers bathe in charms every day, every time they bath in roots so that they are not caught for stealing!) They are plunderers who cannot be arrested, plunderers who are openly boasting that they are so rich and that now they can rule the country because of their riches. They are left out and they just want to be dealing with junior officers. But the day for reckoning will come. How can the Ministry honestly lose money without the Permanent Secretary knowing? Because Permanent Secretaries are controlling officers. So, if that's the case, then the Permanent Secretaries are incompetent!"

He wondered why National Development Planning Minister Alexander Chiteme was giving government's position on the matter when he was not the designated Chief Government Spokesperson.

"Is Chiteme the Government Spokesperson? What has planning got to do with resources? That's why this government is a 'Chipantepante' government. We want a statement from the Minister of Finance or the Chief Government Spokesperson. Why should it be the Minster of Planning to talk about theft of public funds? We want an official statement from the Minister of Finance or the Minister of Finance or the Minister

of Information. It's not just anybody who should be talking in this government. The real thieves are walking the streets! Those real thieves, if they are taken to court today in the morning, by midday they will be convicted. So, why are we wasting time on small fish when the big fish are walking the streets freely? What has happened to the people who bought fire engines at US \$1 million each? Nothing! We want them to deal with the theft in the purchase of fire engines. We want to see the arrest of people that received vehicles as gratification. Why are you avoiding to arrest them? We want people who have built property around Lusaka [and]

all over the world, which they all know, but they are not being arrested. When they went into government, when they went into State House, they were poor people," he said.

Kambwili Meanwhile, appealed to the Church to organise itself and rise against the PF government for the injustice they were suffering. "Now, we have started arresting pastors and civil society for just analysing the budget? I want to tell Mrs Katanga, the Copperbelt Police Chief, that you are being used. But God will punish you. And when the hour of reckoning comes, don't cry foul," warned

Luxury jet belongs to Zambians, not Lungu, says Antonio Mwanza

PF deputy Media Director Antonio Mwanza says the luxury jet which was purchased by the Zambia Air Force is not for President Edgar Lungu, but for the people of Zambia.

And Mwanza says UPND vice-president Geoffrey Bwalya Mwamba advertises his ignorance every time he opens his mouth.

Meanwhile, Mwanza has backed Minister of National Development Planning Alexander Chiteme's claim that none of the civil servants dismissed from government for plunder of

public resources belong to the ruling party.

Speaking at a PF interactive forum, Tuesday, Mwanza said nothing which was bought for President Lungu during his time as Head of State belonged to him.

"And this story about a jet, even when the Ministry of Defense has given an elaborate statement, through the permanent secretary Mr Sturdy Mwale that government, through ZAF is procuring some military software and hardware, they have continued to say that there is a jet which has been bought and people are able

to cook t-bone in the jet. The level of propaganda and desperation in the UPND is alarming. People must know that there is no jet that has been procured for President Edgar Lungu. ZAF has been given the mandate through the act and the procurement laws to procure military software for the people of Zambia and not for Mr Edgar Chagwa Lungu. So whatever is purchased, it is purchased for the people of Zambia and not for President Edgar Lungu. When President Lungu leaves office, he will go and leave everything he has been using including the

towels and the bed sheets he has been using at State House. He will leave them for the next President," Mwanza said.

"So it is wrong for people to maliciously paint a picture that the president is enjoying life. People must know that the presidency is an institution. I don't think they want the President to be moving in a Corolla and the Presiden to be moving unsecured. If anything happened to the President, this country will be on fire. So the cost of protecting the presidency must be secured and we must remove politics from issues of national secutiry.

And Mwanza said GBM advertised his ignorance every time he opened his mouth.

"When I read that statement in News Diggers and The Mast about Mr Geoffrey Bwalya Mwamba asking the Speaker of the National Assembly to bring back the motion. I realized why Mr Hakainde Hichilema is at pains to have that man as his vice-president. He is at pains but he just doesn't know what to do because every time Mr Bwalya Mwamba opens his mouth, he advertises his ignorance on issues of national importance. It is clear that he doesn't even understand how Parliament works or what the impeachment law states," he said.

Meanwhile, speaking when he featured on UNZA radio's Lusaka Star programme earlier, Mwanza encouraged Zambians to demand for stronger penalties against the thieving civil servants who were tarnishing government's image.

"If you look at all these thefts going on in the civil service, it's not theft by PF. There hasn't been a PF official who has been involved in this. [The people who are stealing] are civil servants, our very own children who we sponsored to study her at the University of Zambia. The government gave them jobs and paid bursaries for them while in school and then government even gave them jobs. But when they get into these offices, they are the ones who are stealing from the government that has given them jobs. They are the ones that are stealing from the government that has sponsored them to school, they are the ones that are stealing from the people of Zambia that have given them an opportunity to work. These civil servants must be put in check and the people of Zambia must demand for stronger penalties against these civil servants that are stealing from the people and making government and the Patriotic Front party look bad," said Mwansa.

Fighting in Parley is normal because it is not heaven, says Mumbi Phiri

Patriotic Front (PF) deputy Secretary General Mumbi Phiri says there is nothing sinister about physical fights in Parliament because the National Assembly is not a sacred place like heaven.

On October 16, Presidential Affairs Minister Freedom Sikazwe attacked Roan PF member of parliament Chishimba Kambwili in the House after he was called a witch by the former Information Minster.

And the former deputy Speaker who is now UPND Chairperson, Mutale Nalumango condemned the behaviour of the two lawmakers but hastened to mention that she understood the reason for their aggression because opposition members of parliament had no space outside Parliament to express themselves

Mumbi however said fighting in Parliament was not something new because the National Assembly was not a sacred place like heaven.

"You are talking to a person who fought in Parliament before. Parliament is not Heaven, it's a normal home. At that time when I fought in Parliament, I was provoked and I couldn't hold the provocation that's why I became physical. So people shouldn't pretend like Parliament is in another world. These things have been happening from time immemorial. In fact for honourable Chishimba Kamwbili, this is not the first time. He fought with [Charles] Chimumbwa in the House when we were in the opposition. He fought inside the Chamber when Nalumango honourable was still deputy Speaker, why didn't she politic then? In UNIP my late President Michael Sata also had a fight with somebody," said Phiri. "So these things have been happening and people shouldn't politic because when provocation goes beyond what you can handle, you can find yourself in such a situation like what happened between honourable Sikazwe and Kambwili. Herself honourable Nalumango sent Chishimba Kambwili to the

on record. So as leaders we should be sincere, not every time politicking."

Phiri said it was unfortunate that the former deputy Speaker was politicising and defending Kambwili's character when she was also a victim of his abusive language during her time in the House.

"Honourable Nalumango was deputy Speaker of the National Assembly. You know, we shouldn't be politicking over bad things. Honourable Nalumango was a victim of honourable Kambwili's abuse. Honourable Nalumango shouldn't even politick over the unfortunate situation which happened between Honourable Sikazwe and Honourable Chishimba Kambwili. Deep down her heart, she knows that when she was deputy Speaker, she was a victim of Chishimba Kambwili's abusive language herself. The insults which were poured on Honourable Nalumango by Chishimba Kambwili, in our Bemba

language we say 'abatukile insele isha Mumishingo' (he poured intense insults on her). And for a Bemba when you say 'insele isha Mumishingo', they will understand what I am talking about. It's very surprising that she (Nalumango) can start politicking over that unfortunate situation," Phiri said.

"I was even surprised that Mr Lifuka blamed Freedom Sikazwe in your [newspaper] editions. Honourable Sikazwe was a victim of Chishimba Kamwbili's abusive language. I was very surprised, because if you follow what happened, no matter what, we are adults and we should choose words to use. And I if I were Honourable Freedom Sikazwe, I would take Honourable Kamwbili to court to prove his allegations because he was saying that Honourable Sikazwe is a witch. And you know that you can't say such a thing to a person in public... and you know when Chishimba . Kambwili was talking, honourable Sikazwe was laughing [because] he didn't know that it's him Kambwili was referring to, until when he was told that he was the one that Kamwbili was talking about."

And Phiri said Kambwili's apology was a mockery to God.

"A sin which you know you are committing deliberately is just like mockery to God. For example I know that the Bible says 'you shouldn't kill, you shouldn't commit adultery, you shouldn't steal' but deliberately I go and do those things then I ask for forgiveness, that's mocking God! But what has surprised me is for Honourable Nalumango to start politicking over that when she has been abused by Kambwili herself. It's very unfortunate. Kambwili should even count himself lucky because if it was me he called a witch, I was going to take him to court. Even if he said 'let us go and reconcile because we are Catholics let's go to the Priest', I wouldn't agree. I would tell him to prove, because now this is what people are now doing, they will accuse someone falsely and then run to the Church afterwards for forgiveness; it's not fair," said Mumbi.

Drop charges against pastors, CTPD officials, CSOs demand

A consortium of civil society organisations say last week's arrest of clergymen and staff of the Centre for Trade Policy and Development (CTPD) in Ndola for convening a meeting about next year's national budget is a sign of growing tyranny. And the CSOs have argued that it is unacceptable for Ndola Police to try to regulate and prevent them from freely engaging with citizens on critical civic matters.

In statement issued by Alliance for Community Action (ACA) executive director Laura Miti on behalf of Action Aid Zambia; Caritas Zambia; Centre for Trade and Policy Development; CiSCA; Council of Churches in Zambia; Gears Zambia and Transparency International Zambia, the CSOs demanded that government enforces laws that prevent the police from harassing citizens for simply enjoying their civic rights.

They noted that the increasing tendency by police to confront unarmed civilians in full riot gear is alarming.

"We, the undersigned civil society organisations, would like to register

our extreme shock, concern and dismay at the recent police action to prevent citizens from exercising their basic and constitutional human rights to gather and express themselves. Our consternation arises from the occurrences of Friday 19th October, 2018, in Ndola. That day, the Centre for Trade and Policy Development (CTPD) held a training workshop at the Ndola Baptist Church, whose aim was to breakdown the 2019 national budget, the national debt and illicit financial flows, for faith leaders. As the workshop was being conducted, police arrived in full riot gear and demanded that the workshop end before ultimately arresting three CTPD staff and five pastors. The eight organisers and participants to the workshop were charged with unlawful assembly and kept in police cells overnight. The arrested CTPD staff and clergy were only released on police bond when they presented working sureties. Civil society is extremely concerned that government is now trying to prevent CSOs from carrying out their core work," Miti stated.

"It is unfathomable that a routine

workshop, the kind of which civil society runs every day across the country in multiple venues, would result in members of staff and participants to workshops spending a night in police cells. Demanding that CSOs should notify the police every time they conduct a meeting to discuss public documents such as the national budget, the Auditor General's Report, or indeed issues of critical public interest, such as debt and accountability, is an attempt by government to prevent CSOs from operating. Conducting trainings and discussions is CSOs' core business. It is unacceptable that citizens would go to work and fail to return home to panicked families at the whim of the police. We are of the view that police action to regulate CSO operations is a sign of a growing tyranny in which government is using the police to prevent civil society and citizens from engaging on critical civic matters. It is further alarming that there is an increasing tendency by police to confront unarmed civilians in full riot gear, even when such workshops are held in a church, as seen in this case."

The CSOs also challenged Minister of National Guidance and Religious Affairs Reverend Godfridah Sumaili to openly come out and condemn Copperbelt Police Commissioner Charity Katanga's decision to harass the pastors.

"We call on the Ministry of Religious Affairs to pronounce on this practice in which church gatherings are being rendered criminal in a country that considers itself a Christian nation. We, the undersigned organisations, therefore, demand that the Ministry of Home Affairs, and especially the Police High Command, never again harass citizens for simply enjoying their civic rights. More centrally, we demand that the Public Order Act that has been used over and over to prevent citizens from exercising their right to assemble be immediately amended so that arbitrary discretion of police over public gatherings is removed. We also demand that other legislation that would facilitate CSO work and citizens' right to hold government to account, which legislation has long been awaited like the Freedom of Information Act, be passed," appealed Miti.

"Our Independence president, founder and father of the nation, Dr Kenneth Kaunda, is being underutilised by our leaders. It's exactly 54 years after Independence and our nation is still crawling on its knees. The 1990-91 multiparty elections saw the coming in of a new regime. Our regime took no time to learn from Kaunda. They equally refused to embrace him, this opened doors of both political and economic destruction," Dr Mukuka stated.

"Dr Kaunda suffered humiliation from the then overzealous young politicians instead of learning the political walk from him. Sooner than later, all parastatal firms were gone through privatisation; we never fully understood. Strategically, Kaunda had put in place a fine and powerful economic system. Each economic sector had a corresponding firm, which, of course, was parastatal." And Dr Mukuka, who is

also the Dr Nevers Mumbaled MMD spokesperson, charged that young politicians were bent to erase anything to do with Dr Kaunda that they ended up producing crooks, thieves, plunderers and insensitive leaders in the nation.

"Our young politicians were hell-bent to erase anything to do with Kaunda. We ended up producing crooks, thieves, plunderers and heartless and insensitive leaders in our nation. During the UNIP and Kaunda era, the produce of our main export, copper could be seen across Zambia through so many capital projects. This is not to sav Dr Kaunda is a saint, not at all. The truth of the matter is that Kaunda and his team had a heart for their nation." he recalled.

Dr Mukuka stated that Zambia today was facing economic decay where national assets were being sold out in crooked ways, adding that leaders were no longer inspiring.

"Our nation, today, is facing serious economic doldrums and no one seems to care. We have a situation of economic decay, where national assets are being sold out in crooked ways. Attention has been moved to political thefts, thuggery, corruption, violence, bribery and other related vices. Our leaders are no longer inspiring. A lot has happened and no proper governance direction has since emerged," he argued. Dr Mukuka urged the current leadership to seek counsel from Dr Kaunda as opposed to parading him

during State functions. "When you heard Kaunda speak on a press conference, the nation would be glued to the media to hear the outcome of the said conference because it was serious business. We are being led by people with very dangerous political skeletons. It's not enough to just parade Kaunda during State functions minus seeking counsel from him. If a president cannot speak when innocent people are killed, or when fuel is hiked, when will they talk?" wondered Dr Mukuka.

"Serious thefts in government Ministries and departments have gone without a comment from senior government officials, then we are in trouble. I seriously emphasize that Kaunda should be engaged and not paraded during State functions."

The Zambia Revenue Authority says the letter sent to the Ministry of Finance purported to have been written by employees, alleging that the institution has been reporting false tax collections using VAT refunds to prop up its position is misleading and should be ignored.

In a statement issued yesterday, ZRA Corporate Communications Manager Topsy Sikalinda explained that the Authority had refunded a total of K7 billion between January and October, 2018, adding that over 80 per cent of the amount was paid to mining companies.

This was in reaction to a story published by News Diggers! in its Tuesday edition which a whistle-blower letter that was received at the Ministry of Finance on October 17, 2018, addressed to Finance Minister Margaret Mwanakatwe, revealed that the Authority allegedly been diverting money meant for VAT refunds, and reporting the same as revenue collected for the purposes of meeting the institution's monthly targets. Zambia Revenue Authority (ZRA) has refunded a total of K7 billion from January, 2018, to October, 2018. Over 80 per cent of the said amount was refunded to the mining sector. This is amidst public misconceptions and allegations that the Authority is overstating its collections by not reporting the figures for the refunds," Sikalinda stated.

"It is in ZRA's interest to inform the public that almost 90 per cent of the collections are done via electronic

payments, meaning that most collections are done through the bank and the money is sent directly to Bank of Zambia. It is also important for the public to know that all refunds are funded by the Ministry of Finance. ZRA initiates the

request for funds from the Ministry of Finance which undergoes a strict scrutiny process by the Ministry of Finance."

Sikalinda added that the ZRA endeavours to continue to execute its mandate with transparency in the reporting

of its revenue figures.

"The Authority exists by its core values of transparency to the public who are the stakeholders and will never report fake revenue figures as alleged by some sections of society. Once revenue has been collected, it is

remitted to the government for financing of various government day-to-day operations such as health, education, agriculture, among others," stated Sikalinda.

"The Authority is appealing to the public to work with it

in its execution of its mandate in order to enhance revenue collection as emphasized in the Finance Minister's 2019 national budget and other government policy pronouncements."

However, sources within the ZRA had challenged the Authority to disclose its revenue collections for the period April, 2017, to-date, and to reveal what it owes to the mining sector in VAT refunds.

woke up from the nightmare of colonialism and found itself living the dream of democracy. The nightmare had been a prolonged period of apartheid, in a country run by a privileged white elite where Africans were second-class citizens. By contrast, Independence brought the dream of equality of opportunity, not only to employment, but also to political power. This ideal was to be achieved largely by the principle of equality of access to education and to all the other services made available by the State; a government of the people, by the people, for the people. In a number of ways, we, as a nation, made some positive slides over the years to inculcate a democratic culture in our country and deliver unto ourselves a better Zambia. A land of work and joy, where women and men can stand and sing, freely and proudly," read the statement.

"But gradually, over a period

of 54 years, the dream has slipped away and the nightmare has gradually returned. But not entirely in the same form; instead of a ruling white elite, we now have a ruling African elite. Instead of an imposed colonial dictatorship, we instead have a locally-grown autocracy. Otherwise, the similarities with the colonial system of government are quite startling: a government of the elite, by the elite, for the elite. Some of the essential features of our present nightmare are as follows; 1. Erosion of Equality of Opportunity. In the early days of Independence, people ascended to positions of power and influence mainly on the basis of selection by merit, especially as measured by educational achievement. But nowadays, the elite class is largely self-perpetuating from one generation to the next, with the elite purchase of expensive education, and with the intraelite selection for employment

and promotion. Elite class membership now supersedes educational level."

"2. Lack of separation of powers can especially be seen between the Executive and Parliament, where the ruling party typically has an overwhelming majority so that Parliament becomes a rubber stamp for Executive decisions, and has virtually abdicated its primary role of holding power to account. Whereas the Mung'omba Constitutional Review Commission and the Technical Committee on the Drafting of the Zambian Constitution established that people wanted a separation of powers by having ministers appointed from outside Parliament, Parliament itself quashed this popular demand as part of its wholesale 'amending' of the Draft Constitution in 2016," Mwitwa narrated.

And Mwitwa added that Zambians now must struggle to regain the country's independence and economic freedom.

"And wealth, unlike whiteness, has to be constantly maintained. But wealth is not merely a matter of social prestige, it is also necessary for maintaining a system of patrimony, especially a corrupt system of maintaining the political support of big business by giving contracts, favours and concessions. Perhaps even more expensive is the cost of buying votes during election time, involving both the cost of bribing voters and the cost of various forms of election rigging. All of these three aspects of ruling class maintenance involve massive theft from the public purse," stated Mwitwa.

"All the above seven aspects of the nightmare point to different aspects of our long 54-year slippage from Independence and freedom into dependence and dictatorship. By the same token, all of these seven aspects of the nightmare point to different aspects of our slippage from constitutional government and the rule of law into the repression of a police state. We broke free from a colonial white elite, but have instead gradually fallen into the hands of a local ruling elite that has imposed a similar system of oppression and dictatorship. We call upon all citizens, including politicians, members of parliament, the Judiciary, civil servants and the Church to wake up and recognize the nightmare. The momentous task at hand is the struggle to regain our independence."

Mwitwa further stated that Zambia's current debt burden has seriously eroded the economic and political independence and taken away the country's sovereignty, with poverty levels as high as they were back in colonial days.

The communique was signed by Law Association of Zambia (LAZ) president Eddie Mwitwa, Council of Churches General Secretary Fr Emmanuel Chikoya, NGOCC chairperson Sara Longwe and Zambia Council for Catholic Bishops Secretary-General Cleophas Lungu.

Mabumba explains leakages, cancellation of G9 exams to Parley

General Education Minister David Mabumba says suspending the grade seven, nine and 12 exams was the best option taken by government to pave way for investigations and to safeguard the interest of the pupils. Earlier on Tuesday, Mabumba announced during a press briefing that government had suspended examinations following a leakage of the grade nine mathematics paper 2 exam which was to be written on 23 October 2018.

However, Speaking when he presented a ministerial statement on the floor of the House in Lusaka, Tuesday, Mabumba said government was investigating the matter and that as such, suspending the exams was the best option.

"Honourable speaker the 2018 grade nine examination papers were received and distributed by the Examinations Council of Zambia as per schedule as in line with the

guidelines. Further, the Ministry of General Education received notification on the evening of 22 October 2018 that the grade nine mathematics paper two examination was posted on online media in particular the Zambian watchdog. Immediately management at the council took the following steps; The council informed the officers at the office of the President, and the permanent secretary administration in the ministry of general education and all other key stakeholders. Examinations Council arranged to verify the authenticity of the circulated material. The verification process took place at the Examination Council of Zambia offices in the presence of two Zambian police officers," he explained.

"Honourable Speaker there were two option, one of the options was to continue administering the examinations while the verification is going on. The other one was to postpone this examination. And looking at the two-option honourable speaker, when we looked at it in great depth, it was concluded that the option of postponing and suspending this examination was the best option because like I have said honourable speaker, we don't know the amount of infiltration. Upon comparing the circulated material, with that in the ECZ storage, it was noted that indeed the 2018 mathematics paper 2 for the grade nine exams was leaked and circulated on online media. Mr Speaker arising from the findings of the verification, the following actions have been taken. In line with the Examination Council of Zambia act cap 137 of the laws of Zambia section 22 (1), the director of the Examination Council of Zambia through the Ministry of General Education has nullified the mathematics paper

2 grade nine examination which should have been written today the 23 of October 2018 in the morning at 8 hours. I have further instruction management at the Council to print another paper to be administered at a later date to be advised before the end of the examination session."

Mabumba said he instructed the Examination Council of Zambia to issue a new exam time-table while investigations are being conducted. The Council management and the Ministry have been instructed to take remedial measures to mitigate the situation and thoroughly investigate the matter and bring the perpetrators to book. While the measures above are being administered, honourable speaker, I have further suspended the conduct of the examinations until further notice. I decided to suspended these examinations so that we are able to find where this infiltration is," Mabumba said.

Drug trafficking accused court officials want matter referred to High Court

Defence lawyers representing seven court officials and two businessmen charged with trafficking in narcotic drugs have asked the Lusaka Magistrates' Court to refer the matter to the High Court to determine the constitutionality of the proceedings.

And the lawyers have applied for a Constitutional bail in the High Court, saying the move was necessitated by the conduct of state authorities when they rearrested the accused persons, detained them at unknown place and held them incommunicado without the knowledge of their lawyers.

This is the matter in which businessmen Eric Chipango, Emmanuel Chimba and court officials Emmanuel Chirwa, Bearvan Mengo, Mathews Mukanda, Victor Nzaila, Florence Mushoka, O'Brian Muyunda and Didie Kangwa, a senior clerk of court, are facing four counts of trafficking in narcotic drugs and two counts of theft by servant.

Last week, the Director of Public Prosecutions entered a nolle prosequi in a case in which the court officials and two businessmen were facing three counts of drug trafficking in relation to the disappearance of 24 kilogram of cocaine, which drugs are subject of criminal proceedings before another court.

However, upon their release, the accused persons were again re-arrested.

When the matter came up for plea before a Siavonga based magistrate Victoria Chitulangoma sitting in Lusaka, Tuesday, the State made an application to amend the indictment from count one to four, proposing that the term 'psychotropic substances' in the particulars of the offence was amended to read 'narcotic drugs'.

The application was granted after the defence lawyers comprising; Keith Mweemba, Jonas Zimba, Nicholas Chanda, Zevyanji Sinkala, S Mbewe, P Muya, I M Kunda and Makondo Simubali said they had no objection.

But before plea could be taken, Mweemba raised some preliminary issues as regards the irregularity of the proceedings.

He observed that when the matter was before a Kafue based magistrate kawama Mwamfuli, the State entered a nolle prosequi at the time when they were supposed to reexamine their first witness. He observed that procedurally whenever there was an application by another party, the other party should be given an opportunity to respond.

Mweemba argued that in this case, the State entered a nolle and the court discharged the accused persons without the defence lawyers being given an opportunity to be heard.

Mweemba said the State disregarded article 18, clause 2 paragraph A of the Constitution which stated that an 'accused was innocent until proven guilty' and treated the accused like criminals.

"Immediately the accused were discharged, hardly had the court exited that door, than the State authorities swung into full action effecting a purported rearrest on the

accused persons, causing one accused person to collapse. They were taken to unknown place of detention without the knowledge of their lawyers and were held incommunicado. The state ought to have known that the accused have legal representatives," he said.

And Mweemba said the defence had filed an application for Constitutional bail in the High Court last week, which was necessitated by the conduct of state authorities.

"This application is to invite this court to refer this matter to the High court, for the High court to determine the constitutionality of these proceedings. The High court will be invited to answer the questions on; the total consideration of the record before honourable

Kawama Mwamfuli, are these proceedings in compliance with article 18 of the Constitution? Going by the conduct of state authorities as can be established from the record, are the previous and these proceedings in compliance with articles 13, 15, 17, 22 of the Constitution?" he asked.

He further questioned whether the entry of a nolle prosequi in the previous matter by an advocate from NPA was authorised by the DPP and whether it was Constitutional. "This court has power to inquire as to whether the entry of the nolle prosequi is done in good faith and is Constitutional. From the records, this nolle prosequi was entered by Ms Grescillia Mulenga. Where did the DPP authorise the advocate here in writing? Especially that the reason for adjourning the matter that afternoon, the State had asked the court to go for lunch and come and reexamine the witness after lunch but only to be shocked with a nolle," he said.

Mweemba said another reason why they were questioning the irregularity of the proceedings was that there was no warn and caution statement entered from the accused after their rearrest, which was mandatory

Another defence lawyer Jonas Zimba argued that article 18 of the Constitution had been breached.

He prayed that the matter would be referred to the High Court to determine whether in breach of article 18, the accused would receive a fair hearing.

And defence lawyer Nicholas Chanda said since the accused were not warned and cautioned, they were wrongly in court hence they should be set at liberty.

The State advocates however could not respond saying they needed more time to engage Law Enforcement Agencies to allow them effectively respond to all issues raised.

The matter was adjourned to November 12, 2018.

Changala questions Lungu's business with corruption convict Olmert of Israel

Civil rights activist Brian Changala says it's a mockery to the people of Zambia for President Edgar Lungu to invite former Israeli Prime Minister Ehud Olmert who is a corruption convict, and flaunt him around to citizens when the country is bleeding from systematic corruption.

And Changala says, just like Olmert, President Lungu will be the first Zambian President to serve a prison sentence for corruption.

Olmert is an Israeli politician and lawyer who served as the 12th Prime Minister of Israel from 2006 to 2009 and before that as a cabinet minister from 1988 to 1992 and from 2003 to 2006. Between his first and second stints as a cabinet member, he served as mayor of Jerusalem from 1993 to 2003. After serving as PM he was sentenced to serve a prison term over convictions for accepting bribes and for obstruction of justice during his terms as mayor of Jerusalem and as trade minister.

On Saturday, State House released pictures of President Lungu on a morning routine road run with Olmert and a horde of auxiliary staff.

Commenting on the development, Changala said Zambians deserved to know what business the former Israeli Prime Minister was doing in the country with President Lungu, especially in light of the questionable transactions that Zambia is conducting with the Middle

Eastern Country.

"First and foremost, it's very strange that the President of the Republic of Zambia does not find any shame or restraint in the way he conducts state affairs. The visiting former Israeli Prime Minister is a convict of corruption. And at the moment, the elephant in this room in this country is corruption. Corruption which is from head to toe. From State House to a cleaner in government and quasi government institutions, and yet the President has this courage, the audacity to bring in the country a convict of corruption from Israel as his guest. Even to launder him by appearing with him publicly without any regret, remorse or indeed shame, and bringing the name of the country into ridicule," Changala said.

"President Edgar Lungu owes this country a full explanation, it's not business as usual. Why is it that it has become his style of governance to associate and mingle with people of questionable character and background. This is not a private issue, He is the President of the Republic of Zambia and we need to know because there is a saying 'show me your friends and I will tell you who you are'. President Edgar Chagwa Lungu's association with questionable characters is a source of worry. And he is presiding over a corrupt government, he could be the most corrupt in the history of this country by any standard.

And he doesn't seem to restrain himself or indeed show any commitment to fight the scourge of corruption, instead, it is corruption that is uniting him with the corruption convict." Changala wondered when President Lungu became friends with Olmert.

"One of the answers that the President must give the people of Zambia is; are they friends? If they are friends, when did they become friends? Because President Lungu has a historical background which does not make him an international figure before he became President. he is not a Vernon Mwaanga, who started politics and mixing with the George Bush's of this world at a tender age of 19, no! Bwana Edgar Lungu has coined friendships with people using the Presidency. So because he is using the Presidency, he owes the people of Zambia answers over what type of friends he has created during this period that he has been privileged to run and govern this country? What is the former Israeli Prime Minister doing in this country? That is very very cardinal, and we are having a situation where Africa Confidential is talking about shoddy deals in Israel. Is the former Prime Minister an agent of such deals? Did he just fly in from Israel to come and jog with the President of the Republic of Zambia or there is anything more behind the scenes? We need answers," said Changala. "If Lungu is not careful, he

will end up in jail just like the man visiting him at State House. Olmert was the first Prime Minister of Israel to actually serve a prison sentence and President Lungu will end up the same way, he will be first former President of Zambia to actually enter prison. That is why it's very important that we know who is confusing our President, because he's in a confused state. Is the former Israeli

Prime Minister one of those who have messed up our President and the Presidency? These are legitimate questions that demand to be answered. Why is our President always in wrong company, why? Please help me to get answers from Bwana Edgar Chagwa Lungu. I think we are getting fed up with this king of behaviour. We need a President who inspires the nation. We need a President who will conduct business in the most transparent and credible manner. We need a President who moves in a league of eminent, prominent and distinguished citizens of the world."

The 73-year-old Olmert was convicted in March 2014 for taking bribes and was released from prison in July 2017 after serving 16 months behind bars. Describing his fall as "painful and strange," Olmert became the first former Israeli prime minister to enter prison and acknowledged that he had "made mistakes."

Lungu frees 300 inmates as Zambia turns 54

President Edagr Lungu has pardoned 300 inmates countrywide on the occasion of the 54th Independence Day celebrations.

Minister of Home Affairs Stephen Kampyongo disclosed this at a media briefing in Lusaka, explaining that seven of the 300 pardoned inmates were old-aged people.

"To commemorate the 54th independence anniversary, the President of the Republic of Zambia and Commander-IN-Chief of the Armed Forces, His Excellency Mr Edgar Chagwa Lungu has today the Eve of the 24th of October, 2018, exercised his prerogative of mercy on 300 inmates based in various correctional facilities throughout the Republic of Zambia. Seven are old aged inmates out of the 300. This is in accordance with Article 97 of the Constitution of Zambia, which provides for the Presidential pardon and substitution of severe punishment

imposed on convicted persons," said Kampyongo.

"The Ministry of Home Affairs, staff of the Zambia Correctional Service and inmates of the correctional facilities throughout the country are indeed grateful to His Excellency the President, for exercising his prerogative of mercy at the time when the correctional facilities are extremely congested. The details of the breakdown will be given when the gazette has been signed at government printers."



Deception, quality and 'uubomba Mwibala'

'I need five more pockets boss?' ba Sonjela interrupted his boss as he was about to drive out of the building premises.

'Hahaha! All those, for what? What happened, you mean five pockets?' Mr. Njobvu answered as he pushed his hand out of the car and dropped a K50 note onto his bricklayers open palms.

'I know a good tailor near Chilenje Market, he will stitch your pockets back', Mr. Njobvu added thinking his employee was just making an excuse to get some little extra money. 'No boss, this is not enough. I meant pockets of cement for the lintels. Stock ran out yesterday so we need to buy five more'. Ba Sonjela the Bricklayer rectified.

As Mr. Njobvu finally drove out leavening behind the money he was supposed to buy his wife a wig, he wondered to himself how people around him have managed to build houses if building is as expensive as he was beginning to realize. Ever since he started building last year, money never stays in his wallet. There is always something which is finished needing to be bought at the building site whenever he went there.

Being a very orderly and experienced professional, Mr. Njobvu is a kind of man whose knowledge about many things is simply astonishing. Although he is an accountant, his building knowledge is enviable even to building experts no wonder he had decided to build and supervise the building of his Safari lodge in Samfya.

Aside all the respect and accolades he has been receiving over his new building project, Mr. Njobvu is not oblivious to the facts on the ground. His building project is doing badly, it has overshot the budget and the works are behind schedule. He has been working hard, bought all that needed to be bought according to the Bill of Quantities but still things are not adding up.

His first concern is that although only two blocks are complete, the buildings on the drawing looks more beautiful than the built ones. His second worry is how two identical blocks cost so different to build. On the first one he spent K52, 541. 00 yet on another identical block he has spent K73, 112. 30. The difference in cost was K20, 572. 30! If it had not been for his diligence with numbers, he would have not even noticed the difference.

He had done everything right but where was the problem of quality and cost coming from? It was a tough mystery to understand until one Sunday morning when Mr. Njobvu went to the building site without announcing.

On that particular day, the building site was strangely quiet, nobody he knew including ba Sonjela and his caretaker nephew was around. Instead there were four strangers plastering the walls. When he inquired about the whereabouts of ba Sonjela and the caretaker, one man responded and informed that they were out finalizing some works on one of their other projects in Kafue.

It was at that moment that Mr. Njobvu understood why the works were of poor quality. In his absence, ba Sonjela who is an excellent and qualified bricklayer was subcontracting the building work to some amateur bricklayers from Chibolya compound whom he was paying cheaply so that he pockets the bigger sum he was receiving for labour. It was only when ba Sonjela knew that his boss was visiting the building site when he was doing the work himself.

Frustrated, Mr. Njobvu decided leave but saw something in the garden. There was a large pumpkin in the garden outside which his wife had planted and he decided to pick it before it was gone. As he lifted the pumpkin he noticed that the ground nearby looked disturbed so he decided to dig and see what was beneath. To his shock he found twenty pockets of cement buried beneath the soil. It was part of the cement he had bought but was told had finished. The workers he so trusted were either stealing from him or it was the other crew they had brought on site which was stealing. The rest is history yet Mr. Njobvu now understands that just knowing how to build and having enough money is not a guarantee to an

effectively building project.

One cardinal principle Mr Njobvu now understands is that for one to produce a quality building within a reasonable budget, he/she has to ensure that the building project is properly supervised and monitored. There should be proper accounting of material and this should be done regularly. Material and building tools get stolen a lot by workers and helpers or those just passing through. It is also important to ensure that people accessing the building site is tightly restricted. Restricting access is also cardinal for preventing accidents apart from pilferage.

Summary of items to note before the project kicks off and during the building process concerning building work:

- 1. Provide a secure Storage room for materials, tools, equipment and plant.
- 2. Create a list of all materials bought and indicate who picks and indicated when used or returned.
- 3. Quality control is important and for it to be adhered to, there must be a person on the project who will supervise continuously so that quality is uniform and consistent. Project supervision is not a luxury, it is cardinal if the project is to come out as planned.
- 4. It is cheaper to buy materials in bulk because transport cost is reduced. Buy quality material from the same source so that quality is uniformly maintained.
- 5. Don't be too trusting, be a bit unpredictable at times so that you are not taken for granted and schemed up for deception.
- 6. Take good care of your workers. They need to eat so if you are not paying them well, they definitely will steal from you.
 As much as possible, everyone needs to report to someone. It is not good to do things in isolation. Even if you trust your workers, let them be supervised. You too need to be supervised by someone.

Building is great investment, do it right. Wherever we want to go; our feet shall take us there.

Complaints about the way our country is being government continued to pour in from almost all sectors of society. Lawyers, doctors, teachers, farmers, pastors, traditional leaders, everyone students; is complaining, not to mention the civil society and political groups. From the look of things, Zambia is under a very dark cloud, save for a privileged few who have the means of flying over it.


In our view, no



President Chinese Jinping has opened a new bridge between Hong Kong and the Chinese mainland the longest sea crossing in the world.

The 34-mile (55km) bridge has been under construction for the past nine years, costs about £15bn and includes two artificial islands.

Some 6.7km of the crossing runs through a tunnel underneath the sea to allow traffic through the busy shipping lane above.

Mr Xi did not make a speech, simply declaring the bridge open at a ceremony in Zhuhai, on the Chinese side. Other top officials including Liu He, Mr Xi's economic adviser, were present.

The Chinese president entered the ceremony side by side with Carrie Lam, the chief executive of Hong Kong.

Some commentators have the multibillionpound bridge as a means for Beijing to bring Hong Kong under even tighter control. The bridge has economic as well as political goals. Beijing wants to create a Bay Area cluster, linking Hong Kong, Shenzhen, Zhuhai and Macau into

a supercluster of 11 cities with a population of 68 million - an innovation hub to compete with America's bay area, Silicon Valley.

China also has plans for other megaclusters centred on Beijing and Shanghai, each with a population of more than 100 million.

Before he opened the bridge, Mr Xi toured hitech businesses in Zhuhai a highly symbolic move. Zhuhai was one of the first special economic zones created as part China's economic reform and opening up 40 years ago this year, set up as the mainland,

communist counterpart to the capitalist Portuguese colony of Macau directly opposite.

In the late 1990s, Chinese leader Deng Xiaoping made a famous southern tour to the region, to reaffirm China's commitment to opening up. It supercharged China's economic rise to the present day.

Mr Xi is making a similar visit at an uncertain time for China's prospects, though. The country has been surprised by a trade war with the US, and GDP figures released last week missed targets and showed than expected weaker growth.

Madagascar pre-trial detainees face 'life-threatening conditions' At least 52 people died in

Madagascar's prisons last year while awaiting trial due to "appalling prison conditions", according to Amnesty International.

In a report published on Tuesday, the global rights group also said that thousands of people who have not been found guilty of any crime were subject to "life-threatening prison conditions", including severe overcrowding and poor hygiene as well as lack of food and medical care.

The main causes of death was respiratory problems cardiovascular diseases, Amnesty said, citing prison authorities. The report was based on visits to nine prisons where more than 11,000 people had been placed in pretrial detention, the group

"Many of those being help, are those who suffer

held for extended periods without trial were accused petty, nonviolent crimes," said Deprose Muchena, Amnesty International's regional director for southern Africa.

"The poorest, including women and children, with the least recourse to legal the most," she added. Such "unjustified, excessive prolonged pretrial detention" violates international and domestic law, and amounts to cruel, inhuman and degrading treatment, Amnesty said. Madagascar's Ministry of Justice, in a September letter to Amnesty, said it was aware of the problem.

ministry blamed "population growth and an increase in crime rates" for severe overcrowding and said it has "stepped up its efforts" with new laws and policies to improve conditions.

Under Madagascar's national laws, adults can be held for up to five years and six months without trial and children up to 33 months.

Amnesty said Madagascar's prisons hold more people who have not been tried than those found guilty. As of October 2017, 55 percent of the total prison population were pre-trial detainees, the report said. One man said he has been in pre-trial custody for three and a half years because he was accused of stealing a cow.

Describing conditions at a prison in Maintirano, west Madagascar, he told Amnesty: "Forty-two of us sleep in the same room but there is no room to sleep, I sleep on the floor. A lot of people get sick. Some cough, some shiver, some get very cold.

"And people fight about food because there isn't enough... I really want a trial because I really suffer here."

Women and children were disproportionately affected by some of the prison conditions, the report said. AL JAZEERA

South Africa shocked by live rape trial of Timothy Omotoso

A televised rape trial in South Africa has prompted a furious public backlash after a witness - who says she was raped by her pastor from the age of 14 - was subjected to a lengthy and, at times, aggressively intimate cross-examination by the lawyer representing a 60-year-old Nigerian televangelist, Timothy Omotoso, who denies the allegation.

Over the weekend, Mr Omotoso's church, in the coastal city of Port Elizabeth, was forced to

shut its door after angry crowds besieged the building, while a Sunday newspaper reported that the woman who gave evidence against him - Cheryl Zondi, now a 22-year-old student - had received death threats ahead of the trial. The trial - the first prominent rape case to be broadcast live in a country where more than 100 rapes are reported to the police each day has attracted huge interest, and raised difficult questions about victims' rights, impartiality and whether justice is best served by having television cameras in courtrooms.

Anti-apartheid icon Nelson Mandela's granddaughter, Ndileka Mandela - who said in 2017 that she had been raped by a former boyfriend - is one of many South African women who have voiced support for Ms Zondi, linking her experience to the global #MeToo movement.

Ms Mandela argued that the student's treatment during three days in the witness box helped explain why so many rape victims stay silent in a nation with notoriously high levels of sexual violence. BBC

Ghana university closed after 'jamboree' riots

Ghana's Kwame Nkrumah University of Science and Technology (Knust) has been shut down and students ordered to leave the institution following violent protests on Monday.

Students have been given up to 12.00 GMT on Tuesday to vacate the campus.

Only foreign students have been exempted from the decision - the authorities say they will be given security protection in their hostels.

Ashanti Regional Minister Simon Osei Mensah, who announced the decision, maintains the shutdown is necessary in view of the extent of the damages.

19-year-old Bartell attended Swift's 1989 tour concert in Nashville and also described the toll her mom's health has taken on her. "I'm happy to help take care of her and I'm happy to provide for my family but I am nineteen and everything is really hard right now. I feel like I've reached by breaking point."

After Swift made the very generous contribution, Bartell posted about it on Facebook and what the donation meant to her. "Everyone who knows me knows that Taylor Swift is my whole entire life. Mayweather rematch closer as Manny Pacquiao signs to face 'top PBC fighters'

A potential blockbuster rematch between Manny Pacquiao and Floyd Mayweather moved a step closer as the Filipino icon confirmed he has signed with Al Haymon's Premier Boxing Champions (PBC).

Eight-weight champion Pacquiao said he would close out his storied career by facing "top PBC fighters" in announcing late Monday the tie-up with influential Mayweather 1 adviser Haymon's

"My team will work closely with Al Haymon for the remainder of my career to deliver the most anticipated fights with the top PBC fighters," Pacquiao said in a statement.

"Those are the fights the fans want to see and the ones I want to have to close out my career," he added.

Pacquiao said last week that he was "90 percent" sure a bout with former fourdivision world champion Adrien Broner would happen in January, possibly in Las Vegas.

"Pacquiao's first defense of the World Boxing welterweight Association world title will kick off the new partnership," Haymon's PBC said in a statement without giving further details.

"The new alliance will have team Pacquiao and Haymon work together to navigate the remainder of his illustrious career," it added.


The deal could pave the way for a Pacquiao-Mayweather rematch of the 2015 megafight which generated a record 4.6 million payper-view buys earning \$600 million and ended with the American winning on points. Unbeaten Mayweather, who hasn't fought since knocking out mixed martial artist Conor McGregor last year, said in September he would come out of retirement to face Pacquiao later this year. The American, 41, has since hinted at taking a warm-up fight first, talking on social media of a "huge boxing event" in Tokyo and then last week said he would be willing to accept a challenge to fight against McGregor's MMA conqueror Khabib Nurmagomedov.

The deal with Haymon represents a new chapter for the 39-year-old Pacquiao, who has been promoted for the majority of his 20year professional career by Bob Arum's Top Rank organisation.

"I wish him the best of luck, a tremendous warrior, and whatever he's doing in the future, he deserves," Arum said of Pacquiao on Fighthub TV in Las Vegas at the weekend.

Pacquiao pumped new life into his storied career in July when he delivered his first knockout in nine years against Lucas Matthysse of Argentina.

Ahead of the fight against big-punching Matthysse, Pacquiao said he considered himself the "underdog", but he rolled back the years to register a 60th win and take the Argentine's WBA welterweight belt. AFP
