Police nab Kanene for indecent assau

By Sipilisiwe Ncube Police in Lusaka have arrested musician Clifford Dimba alias General Kanene for touching a woman's breast without her consent.

In a statement, Thursday, Police Spokesperson Esther Mwaata Katongo disclosed that the incident happened around 20:00 hours on October 16.

"We received a report of Indecent Assault from a 26 year old female of old Kanyama Compound in Lusaka that she was indecently assaulted by Clifford Dimba popularly known as general Kanene. This is reported to have happened at a bar in Makeni Villa on 16th October, 2018 around 20:00 hours. It is alleged that the suspect repeatedly touched the victims breasts against her will as she was waiting for her food. The suspect was arrested yesterday and is detained in Police custody," stated Katongo.

Kanene, 32 of Misisi Compound, is notorious for perpetrating gender based violence. In 2015, President Edgar Lungu appointed him ambassador against the vice, sparking outrage from both International and local bodies. In 2016, the Head of State yielded to public outcry and revoked Kanene's appointment.

Lungu is a tyrant, maybe that's a slim trait slim people have - Kambwili

By Sipilisiwe Ncube President Edgar Lungu is a tyrant, I don't know if that's how heartless slim people are because that is how Pau] Kagame is, says Former Chief Government Chishimba Spokesperson Kambwili.

Speaking on Live Issues programme on Live radio, Thursday, Kambwili observed that the PF was blocking the opposition holding from public meetings.

He charged that the Head of State was a tyrant.

"Today this government doesn't give permits to the opposition or anybody to have meetings, they are misusing the Public Order Act (POA) with impunity. For instance I am a member of parliament for Roan, for the past one year, police have refused me to have meetings in my constituency. Every time I tell them that I am having meetings in my constituency, they will tell me 'no, we have to find out from the commissioner of

police in Ndola' and the answer that we get [is that] 'no he cannot go ahead for security reasons.' Now I don't know what security reasons they talk about [because] in the meantime, my colleague from Luanshya constituency Steve Chungu gets permits to hold meetings in my constituency. For him it's not for security reasons. So democracy under Lungu is not as it was under Sata. Lungu is a tyrant. I don't know if that's how heartless slim people are because that is how [Paul] Kagame is and Lungu is imitating what Kagame is doing," Kambwili charged.

And Kambwili said it was important for the media to recognize government's good works.

"The second caller says 'you called The Post as always being negative against government' yes I did. Even up to now, I am calling the Daily Nation as being negative towards the opposition. You see, I am a very straight forward person, what I meant was [that] as much as The Post can criticize the government, you cannot write headlines on one individual for six months in the negative. I remember that time The Post as a newspaper were writing negatives about Lungu from the time he became president to about six months and I condemned it on principle just like I am condemning the Daily Nation that every day, they are just writing negative things about the opposition and those who are not in good books with the PF government. That is a mistake [and] even in my grave, I will say that it was a mistake because what we expect from the newspaper is to balance. When the government does something good, you say 'well done' [and] when they do something wrong, you say 'this is wrong.' You cannot carry one headline two years over an individual," said Kambwili. "But when you say I went on

to close the newspaper, you are lying. I never closed The Post newspaper. The Post newspaper was closed by the PF government through ZRA and you know that when The Post newspaper was closed, the court had ruled that ministers must

be out of office, and that's the time when the ZRA pounced on The Post. I was not Minister of Information [then]. And even if I was Minister of Information, I did not close The Post. You know decisions that are made are not made by an individual. Look at the way [News] Diggers carry their reporting, they are so balanced. If I make a mistake as Chishimba Kambwili, they write about me that 'no, that is not right' and they condemn me [and] if the government does good, they say the government has done a very good job. That is what reporting should be."

among those arrested include 50 people who were apprehended in a cleanup operation in Lusaka's Chibolya, Matero, Chelston, Ngombe, Makeni, Lilanda and Waterfalls areas.

This according to a issued statement by Department of Immigration public relations officer Namati Nshinka yesterday. "The Department of Immigration between October 22 and 24, 2018, arrested 63 persons for various immigration offences countrywide, including 50 (who were) apprehended in a cleanoperation conducted up by the Lusaka Regional Immigration Office on October 22 and 23, 2018. The operation covered selected parts of Lusaka, including Chibolya, Matero, Chelston, Ngombe, Makeni, Lilanda and Waterfalls," Nshinka stated.

He stated that those nabbed during the in operation Lusaka included; 18 Tanzanians, eight Congolese, seven Chinese, six Rwandese, five Burundese, two Zimbabweans and one Indian.

He added that three others claiming Zambian citizenship were also apprehended in the operation after they failed to produce proof of citizenship. Nshinka stated that the 50 were currently in detention pending further screening and possible prosecution. Meanwhile, Nshinka stated that nine Congolese in

Cops, Chinese nationals in court for abduction **By Zondiwe Mbewe**

Two police officers and two Chinese nationals have been dragged to court for allegedly abducting a Chinese national with intent to confine him. But appearing in the Lusaka Magistrates' Court yesterday, were only one police officer and two Chinese nationals when the matter came up for plea as the first

accused was reportedly sick. The four are expected to take plea before Magistrate Silvia Munyinya, Friday.

In this matter, Lufwendo Bataba, a 45-year-old police officer of Bauleni; Malulu Christopher Chanda, a 40-yearold police officer of Kalingalinga; Zhuang Youjun, 32-year-old translator and Wang Qighai, a 50-year-old businessman are charged with one count of abducting with intent to confine a person contrary to section 256 of the penal code chapter 87 of the laws of Zambia.

Particulars of the offence allege that the accused persons on August 30, 2018, in Lusaka jointly and whilst acting together did abduct Wang Shunxue with intent to secretly and wrongfully confine him.

When the matter came up for plea before Magistrate Munyinya, Thursday, the defence lawyer Phil Muya asked for an adjournment, saying accused number one, Lufwendo Bataba, was not present in court as they were only informed about the matter in the morning.

He added that the accused was also unwell.

Bataba's sureties were also not present in court.

"I expected the sureties to be here because the accused is not here. For today, I will take it that the accused is absent and the sureties are absent," Magistrate Munyinya said.

The matter comes up, Friday, for plea. Meanwhile, a 26-year-old bricklayer of Chawama has been dragged to court for stealing four goats and two sheep valued at K2,900.

In this matter, Martin Mwachi is charged with stock theft contrary to section 275 (1) of the penal code chapter 87 of the laws of Zambia. It is alleged that Mwachi on September

20, 2018, in Lusaka stole four goats and two sheep valued at K2,900 belonging to Fresh Farm.

The matter has since been allocated to Magistrate Felix Kaoma and is scheduled to take plea.

"I do have ambitions [to] lead the party, yes, and [to] even lead the country. If you have no ambitions as a man, then what are you living for? There is nothing wrong with ambition. Let's get this out of the way. Some people think that when you speak of your personal ambition, then it means [that] you don't like the current leadership, no. When ba Kaunda and his people came into power, they kicked out the colonial masters, their [ambition] was to fight for our independence. They led us up to a certain point, but we began lining up for cooking oil, for matches, for candles. Their economic policies couldn't tie up with the way the economy was running [and] their time was up."

Ignore politicians spreading lies, Siliya tells Zambians

Information and Broadcasting Services Minister Dora Siliya has asked Zambians to ignore politicians who are misleading the country by purporting that institutions like the Zambia National Broadcasting Corporation (ZNBC) have been sold.

Siliya said ZNBC, Star Times had not become one company but were merely collaborating in a joint venture which had resulted in the creation of Topstar.

"Indeed ZNBC has got shares in DSTV and also in GoTV, as well as Topstar now. For the record, ZNBC is a statutory body which was created by this House and any change of shareholding in that institution would have to be made by this House. So it's not possible that any other institution can have shares in ZNBC because ZNBC belongs 100 per cent to the people of Zambia. ZNBC as an institution can do business and acquire shares in other interests but nobody can acquire shares in ZNBC because it was created through an Act of Parliament and under Cap 154 of the laws of Zamnbia. So unless we in this House decided to change that status, it is not possible that anyone else can have shares in ZNBC. And for the record, Topstar has no shares in ZNBC, but ZNBC has got 40 per cent shares in Topstar and in Star times ZNBC has got 60 per cent. So this misinformation is merely smear campaign against the people of Zambia because ZNBC is owned by Zambians and it was created by the representatives of the people of Zambia in this House. So any move away from that position is an affront from the people Zambia," Siliya explained.

And responding to Monze UPND member of parliament Jack Mwiimbu, who in his question insisted that the minister had confirmed the sell of ZNBC by admitting that the public broadcaster had merged with Star Times to come up with Topstar, Silya expressed displeasure and questioned his understanding of the law.

"Clearly, law is not an exact science because if it was, we would not be having this debate. ZNBC is a statutory body. None of it's shares have been given to anybody because it was created by an Act of Parliament. If the member of parliament pays attention, he would avoid being misled. ZNBC has not merged with Topstar. But what has happened is that ZNBC through a company called Star Times created a new entity called Topstar. And I am sure in legal language that is very clear. So in this case, ZNBC remains 100 per cent an independent entity but it has interests as provided... the CPCC law, that 'it's interests can merge with interest of another institution and they can create a new body called Topstar' and this is under the company's Act.

ZNBC remains as a whole as a statutory body under Cap 154 of the laws of Zambia. I am sure it's very clear now Mr Speaker," she explained.

Meanwhile, in apparent reference to the opposition MPs, Siliya cautioned Zambians not to listen to politicians who were spreading falsehoods.

"As government, we're telling the Zambians to be careful what they read online because for some people what they read online is taken as Gospel truth and they want to bring it to this House. As citizens, we have to be careful that we can be misled. This is why we are providing for laws so that we bring to book those that want to mislead the citizens. It may be on a simple thing today but tomorrow it will be on something big we can see that even internationally. Many governments are challenged with fake news, propaganda and as citizens, we have to refute the information," said Siliya.

"So as citizens, we all have to be aware that sometimes as citizens, we all have to be aware of people are posturing with passion and want to make us believe that they are telling the truth but sometimes they are just posturing and they could be trying to mislead this country. And the ZNBC case was classic example where even members of parliament who should know the law where the ones in the forefront telling citizens that ZNBC has been sold. So we have to call out those people who like to posture in this House, that those are bad politics and citizens should see them for who they are, that they are just people who like to posture and they are not decent politicians."

By Mirriam Chabala The opposition UPND and NDC will not participate in the dialogue process led by a committee of local eminent persons that has been constituted by the Zambia Centre for Inter-party Dialogue (ZCID).

The two parties confirmed this in separate interviews, they were saying uncomfortable with the people that sat on the board of ZCID and that the Centre had no mandate to spearhead the dialogue process.

But the ruling Patriotic Front (PF), has welcomed the appointment of eminent persons to lead the process. Last week, ZCID established a committee of local eminent persons comprised of: House of Chiefs Chairperson Chief Ngabwe; Senior Chief Madzimawe of the Ngoni people of Chipata; Zambian politician and businessman Akashambatwa Mbikusita-Lewanika and former FDD vice-president Chifumu Banda to chair the national political dialogue.

But UPND, through its spokesperson Charles Kakoma, said his party would not participate in any dialogue process associated with ZCID.

"First of all, no one gave the mandate to the Zambia Centre for Inter-party Dialogue to spearhead the dialogue process. They are doing that on their own, or it's a secret deal with PF, because the stakeholders that met in Siavonga two months ago only chose the three Church mother bodies to spearhead the dialogue process. So, they cannot spring up from nowhere start spearheading to the dialogue process and appointing eminent persons to chair the process. Certainly, they are wrong and they do not mean well," Kakoma said.

"What they are doing is to try to divert attention from the agreed roadmap, where the Church is spearheading the process, by creating a parallel dialogue process. And we cannot have two dialogue processes taking place at the same time to talk about similar issues. So, we should only speak to one dialogue process and

Church, not the ZCID one. The issue is that we have not, as UPND, recognised ZCID to lead the process. So, we cannot participate in a process that is being led by an organisation, which has not been mandated or recognised to spearhead the process."

The National Democratic Congress (NDC), through acting spokesperson Misheck Moyo cited skepticism about ZCID's capacity to appoint an impartial committee to chair the national dialogue as its reason for shunning the

"To be honest with you, we are not comfortable with people who sit on the ZCID board. We believe that most of them side themselves with the governing party, the PF. And in this regard, NDC is a member of the ZCID. But when picking Dr Lewanika, they didn't consult anyone. Who did they consult? So, this entire process bleeds [with] suspicion. What we are insisting on, therefore, is that the Church, who are independent, impartial and credible, should lead this process. The men of God, who do not have any particular political influence. should lead the process. We all know where Dr Lewanika is coming from. He cannot be an independent and impartial person to lead this process, so we have certain reservations," said Moyo. "We are not comfortable

with Dr Lewanika and we are challenging the ZCID board to inform the nation how they picked on that single name because a lot of people in this country have done conflict resolution and disputes, but to pick on Dr Lewanika without consulting raises a lot of suspicions. And we also want to ask the PF government, why are they are not comfortable with the Church leading the process? Why are they insisting on ZCID? If you look at the funding of the ZCID, it's funded by the donors; they receive funding through the Ministry of Justice. So, their independence, therefore, is highly questionable. Then we just don't want to draw the traditional leadership into politicking and we've got our own reasons. We are insisting on the Church, credible Church bodies, not these Church bodies, which are affiliated to political

groupings because their intelligence is questionable." Meanwhile, PF media director Sunday Chanda said the party had welcomed the appointment of the eminent

persons. "Patriotic Front Secretary General Hon Davies Mwila has says that the ruling Party has welcomed the constituted four (4) man committee of eminent persons consisting of Chief Ngabwe, Senior Chief Madzimawe, Hon Akashambatwa Mbikusita Lewanika and Mr Chifumu Banda SC to lead the dialogue process. Hon Mwila has also mentioned that political parties affiliated to ZCID made a collective decision to bring on board a Committee of eminent Zambians and the names announced by ZCID are those of credible persons with vast experience in their respective fields," stated Chanda.

Thieving civil servants, govt officials are mostly from Eastern, Luapula - GBM

Today we have criminals in the government because they have a Head of State who is also a criminal, says United Party for National Development (UPND) vicepresident Geoffrey Bwalya Mwamba.

And GBM says most thieving civil servants and government officials are from Eastern and Luapula provinces.

Last week, Minister of Development National Planning Alexander Chiteme charged that thieving civil servants were sponsored by the opposition, a remark which was reiterated by PF deputy media director Antonio Mwanza.

But in an interview, GBM said government workers and PF officials were not feeling guilty about stealing because President Lungu had already given them permission by saying "Uubomba mwibala alya mwibala" which suggests that one must eat from where he works.

It means that he was the one actually who was telling them to steal. So what we are seeing today, in terms of levels of stealing and corruption in PF, it's something which has been orchestrated by the Head of State. So I think what they are saying is just an excuse that we are so powerful and we can do that." And GBM said most

By Mirriam Chabala The Centre for Trade Policy and Development (CTPD) has asked the International Monetary Fund (IMF) to give a clear position about its negotiations with Zambia for a bailout package to enable the country move forward.

And CTPD has predicted that the country will face a lot of challenges when time to repay all its loans finally comes because there is clearly no reasonable investment where all the acquired loans have been committed to.

Speaking on Hot FM's Hot Seat programme where he featured alongside Zambia Tax Platform coordinator Ibrahim Kamara, Thursday, CTPD executive director Isaac Mwaipopo said the IMF's failure to give its position on the bailout package that Zambia had been seeking from the Fund for years had stranded the country.

In July, the IMF revealed that talks on Zambia's

economic bailout package, widely expected to be around US \$1.3 billion, have been suspended owing to concerns surrounding the country's debt sustainability. The Fund, through its communications director Gerry Rice disclosed that it had suspended discussions on a possible economic bailout programme because the Zambian government's borrowing plans had compromised the country's debt sustainability, which in-turn, will undermine Zambia's macroeconomic stability.

"Zambia still needs the bailout package. And as the International Monetary Fund will be visiting this country; it is our hope from the Centre for Trade Policy and Development that the International Monetary

Fund would be able to give a clear picture in terms of where we are going with these negotiations. The negotiations have been going on for quite a long time and they are actually affecting the ability for this country to move forward. So, it will be good if they can give a clear indication with regards to their position on the bailout package that Zambia has been seeking. On the question whether we need it (the IMF package), yes, Zambia needs the IMF bailout package. It can help to improve the balance of payments," Mwaipopo said. And he said Zambia will face a lot of challenges when time to repay its loans comes because there has not been any reasonable investment from all the loans. "One of the challenges we are

faced with is that there was a huge delay in setting up a Sinking Fund. There was a proposed plan to set up a Sinking Fund that was going to ensure that we put aside some resources to prepare for the time when we need to pay back the loans. As of this year, we've heard that there is some movement to put aside some resources to prepare for that, but the other thing is that there is a growing conversation around the need to look out to countries like China as well as other people that we owe some money to begin conversations around possibly restructuring the debt that we owe. So, if this conversation is gaining momentum, it also gives you an indication that we are foreseeing ourselves having a challenge to pay

back some of the debt that we owe when they are due. So, one of the things we are trying to do is to buy-off some time, reorganise and rearrange the period under which this debt is to be paid or find an alternative route to manage that," said Mwaipopo.

"But as for whether or not we will manage to pay back, that is yet to be determined, but at the rate at which we are moving, we think we might have a challenge to pay. Not necessarily defaulting, but there are several options, which you can pursue, one of them is restructuring the debt. Defaulting is something we need to avoid at all costs. However, debt is something to worry about really. Debt in itself is not bad, but it is something that you are in the position to pay back. I think the big question that we should be asking ourselves is: are we in a position to pay back when this debt matures or are we in a position to clearly point in terms of where we have invested the resources that we had acquired? If we are in the position, well and

good, if we are not in the position, then it would call for concern and worry."

Meanwhile, Kamara said much as Zambia needed the IMF package, the country could realise a lot of revenue if it invested in valueaddition industries.

"In as much as we might need the bailout package, I also believe that the nation has so much potential to generate revenue from different sectors. The mine is one such sector, which can generate massive revenues into the government, diversification into the agricultural sector, and I think on the other thing we've lagged on is the industrial base in the nation. I think with regards to that, even the copper that the nation is producing, it's exported in its raw form. But you can imagine if there was so much value added to copper, if there were industries, which were able to add value to certain things before we export them, those would become industries, which can be taxed and revenues can increased for the nation. So, I believe the nation has potential, but right now, we might be heading to a situation where we do in fact need the IMF bailout package, looking at the current debt stock for the nation," said Kamara.

Inflation rises to 8.3%

The annual rate of inflation has leaped to 8.3 per cent, up from 7.9 per cent recorded in September, the highest on record this year so far, according to Central Statistical Office data.

Announcing Zambia's annual rate of inflation for the month of October, CSO acting director of census and statistics Goodson Sinyenga said the rise in inflation this month was largely attributable to price movements in fuel, lubricants and motor vehicles.

"The year-on-year inflation rate as measured by the all items Consumer Price Index (CPI) for October, 2018, increased to 8.3 per cent from 7.9 per cent recorded in September, 2018. This means that on average, prices of goods and services increased by 8.3 per cent between October, 2017, and October, 2018," Sinyenga told journalists in Lusaka, Thursday.

"The increase in the annual rate of inflation is mainly attributed to purchase of vehicles, fuels and lubricants (diesel and petrol), passenger transport by air (Lusaka/ London via Dubai) and liquid fuels such as kerosene.

According to Sinyenga, food and non-alcoholic beverages accounted for 4.3 percentage points, while non-food items accounted for a total of 4.0 percentage points.

CSO data reveals that Zambia's annual rate of inflation of 8.3 per cent recorded this month is the highest on record since November, 2016, when inflation was at 8.8 per cent from 12.5 per cent in October, 2016, before it dropped to close 2016 at 7.5 per cent.

Zambia's annual rate of inflation has again exceeded the Bank of Zambia's targeted corridor of 6-8 per cent forecast for the short-to-medium term for the second time this year following the 8.1 per cent recorded in August, 2018.

The True Cost of Maize

It is yet again that time of year when those employed in the agriculture sector are determining what they will plant at the start of the rainy season. Farmers are paying a lot of attention to weather conditions in particular – the dream being that we will receive adequate rainfall for a sufficient harvest.

For many farmers in Zambia, maize is still the number one crop of choice. If that's your plan, it is time to think of maize seeds, fertilizers, and chemicals against the fall army worms, among others. These are some of the main costs associated with maize production, but are these the true costs and how can we ensure that we're producing sustainably?

The current reality of maize floor price and production

We've seen determined stakeholders calling for the 2017/2018 maize floor price to be proportionate to the cost of the product. These stakeholders were expecting the government to take the high cost of production into account before arriving at the price of the farm produce.

These high costs are especially important in light of the recent decline in maize production. In the 2017/2018 season we saw the national average yield rate for maize decline from 2.19 metric tonnes per hectare in the previous season to only 1.72 metric tonnes per hectare. Small and medium scale farmers recorded an average maize yield rate of 1.68 metric tonnes per hectare, whilst large scale farmers recorded an average maize yield rate of 3.18 metric tonnes per hectare.

The government largely attributed this reduction to the prolonged dry spells that we experienced between November 2017 and January 2018. Another reason for such a decline is a reduction in production area, which dropped by 15.3 percent from 1,644,741 hectares in the previous season to a mere 1,392,546 hectares in 2017/2018 season.

In this context, Hivos commissioned Soil & More Impacts BV (SMI) to conduct a comparative true cost assessment of traditional maize production in Zambia's Central Province, compared to alternative maize production systems using sustainable practices. This report provides an insight into the real costs of an agricultural system that focuses on maize as the only crop, and offers concrete solutions to lessen these costs. It concludes that the actual costs of production in Zambia's current maize cultivation systems are on average 2.5 times higher than what is calculated in market prices. This finding is line with other true cost accounting studies.

What can we do?

We recognize that in order to adequately tackle today's and tomorrow's food security challenges, unsustainable agricultural practices must change. Furthermore, market prices need to reflect the real costs. If, and at what price, agricultural goods will be available in the future is determined by the agricultural practices used today. If we want to secure a sustainable future food supply, the agricultural system needs to shift towards more sustainable practices.

Sustainable production practices do exist Sustainable farming practices do exist and are important to counter the effects of climate change. Examples include natural fertilization (using crop residues for composting), reducing tillage (agricultural preparation of soil), and using cover crops (plants grown primarily for the benefit of the soil rather than the crop yield). These practices reduce carbon emissions from the soil by about one third and even sequester additional CO2. Carbon sequestration, combined with compost application and crop residue management, also builds up soil, making better use of water and nutrients and reducing the risk of increasing production costs and crop failures.

Who needs to push this forward?

Governments must help accelerate the shift towards sustainable food systems that increase access, availability and affordability of diverse and nutritious foods. This entails investing in research and extension services, working with the private sector, and supporting smallholder famers to adopt sustainable practices.

Farmers and agribusiness for their part need to invest more in the quality and health of soils their main production asset - both to secure future profits and a sustainable supply of food.

The many benefits of sustainable practices An increasing number of stakeholders in different sectors have been calling for policy frameworks that use accounting models to evaluate the external environmental costs mentioned above and integrate them into market prices. If we promote and incentivize a farming system that reduces risk for farmers by using sustainable practices, we can reduce the dramatic volatility of food prices, make the food system more resilient to climate change, and ultimately create environmental benefits.

At this stage, we now have every reason to believe that President Edgar Lungu is drunk with power; and we are genuinely concerned that this drunkenness has led him to lose sensitivity to what the people who put him in office are looking for. This power has corrupted him and Mr Lungu is no longer the man that he was when PF offered him the Presidency.

In order for our analogy to be understood in the right context, let's talk about how a drunken person behaves. We have all seen them. When someone is drunk on alcohol or any other intoxicating substance, they lose common inhibitions. The things that embarrass a sober person do not embarrass them at all. This is one of the many downsides of drunkenness. A drunken person can urinate in public without feeling embarrassed, insult and do all sorts of insensitive things without shame.

This is what we are seeing with our Head of State. He is drunk with power. And just like a person who is drunk on happy juice, an experience which President Lungu is very familiar with, he has lost the ability to feel embarrassed by the kind of public scandals that would embarrass many other leaders. It seems our President has reached a stage where he does not mind undressing in public, and we will give examples of what we mean here, as we get to the point.

We have observed that there are now very few informed people in this country who are still not concerned about the direction that Zambia is taking. Even the most conservative public figures, who would ordinarily not criticize the government openly, are now opening up Twitter or Facebook accounts to speak out for Zambia. The litany of scandals is just getting so long that we are even failing to keep up. Even the people closest to President Lungu

in this government are looking genuinely concerned. They can't believe some of the things that are being done by him or in his name.

This is why it is not uncommon in the recent past for different wings of the government to contradict themselves. The Chief Government Spokesperson is saying one thing; State House is saying the opposite. And then you have a Permanent Secretary somewhere also having his own say. There seems to be no clear strategy on how to run government. The only thing that is consistent is that someone who is close to power is eating at every turn. But President Lungu, who is supposed to intervene, is also drunk with his own power and does not seem concerned.

It is no wonder factions are even emerging in the PF. It seems some heads in the PF are thinking that this has to be stopped. They have observed that State House is running the government like Somali warlords with no coherent strategy except for personal enrichment, and they are concerned that if this is not corrected, they will lose power. These concerned people

being worried. In the last few weeks, we have been treated to the shocking stories of donor funds going missing, acknowledged by government, and then miraculously 'found'. Before that scandal even settles down, we have learnt of the government buying luxurious aircrafts, which we, as a nation, can ill-afford. At a time when government is struggling to pay civil servants' salaries on time, President Lungu and his inner circle are not ashamed to go and purchase one of the most expensive executive jets on the market today.

We understand that this American-built Gulfstream 650 ER, which the Zambian government is buying for President Lungu from Israel, can take him from Lusaka to New York non-stop. That is rather convenient we must admit, but at what cost? Then we are told of two Italian C27J transport aircrafts from Leonardo Aerospace Company, all for a country that is looking to heaven for economic solutions.

We are further told that this aircraft is coming fully equipped with all kinds of science fiction gadgets that would make even US President Donald Trump jealous. Now, it is outside our liberty to talk about the necessity of the socalled MUSIC system installed on this Gulfstream 650 to shoot down missiles aimed at Mr Lungu's aircraft, but we are wondering why an African President in a peaceful country like Zambia desperately needs this priority sorted above all the devastating national demands that are screaming in the President's face.

Given the simmering scandals between Zambia and Israel, it would have been in our wildest imagination that one would see President Lungu exposing his private links to Israel. China vows to defend Taiwan, South China Sea 'at any price'

China vowed it will never give up an inch of its territory - whether it's the self-ruled island of Taiwan it claims as its own or in the disputed waters of the South China Sea.

China's Defence Minister Wei Fenghe made the remarks on Thursday at the opening of the Xiangshan Forum in Beijing, which China styles as its answer to the annual Shangri-La Dialogue security forum in the wealthy city-state of Singapore.

"If someone tries to separate Taiwan from China, the Chinese armed forces will take action at any price," Wei warned.

China's military ties with the United States are important and sensitive, he said, adding Taiwan is a "core" interest and Beijing opposes displays of strength by "outside forces" in the South China Sea.

Beijing has been infuriated by recent US sanctions on its military, one of a growing number of flashpoints in ties with Washington that include a bitter trade war, Washington's backing of Taiwan, and the US' military posture in the South China Sea.

"The islands in the South China Sea have long been China's territory. They're the legacy of our ancestors and we can't afford to lose a single inch of them," said Wei.

The world's two largest economies need to deepen high-level ties to navigate tension and rein in the risk of inadvertent conflict, US defence chief James Mattis told his Chinese counterpart last week.

A former US military commander warned on Wednesday it's likely the United States will be at war with China in 15 years.

Retired Lieutenant-General Ben Hodges said the US will need to focus more attention on defending its interests in the Pacific.

"I think in 15 years - it's not inevitable - but it is a very strong likelihood that we will be at war with China," Hodges told military and political experts.

"The United States does not have the capacity to do everything it has to do in Europe and in the Pacific to deal with the Chinese threat," Hodges said.

"So you're going to see us ... permanently assign forces for the eventuality that in 10 or 15 years we're going to be having to fight in the Pacific." *AL JAZEERA*

Russian President Vladimir Putin says Russia will respond in kind if the US withdraws from the Intermediate-range Nuclear Forces Treaty. Putin's warning followed US President Donald Trump's

announcement

weekend

that he intends to opt out of the landmark 1987 nuclear arms control pact - which rid Europe of land-based nuclear missiles - over alleged Russian violations. "If the United States does withdraw from the INF treaty, the main question

is what they will do with these newly available missiles. If they will deliver them to Europe, naturally our response will have to mirror this," Putin told reporters in Moscow on Wednesday. Trump said the treaty was ineffective because it does not include China, which has intermediate-range missile capability.

Negotiated by then US President Ronald Reagan and Soviet leader Mikhail Gorbachev and ratified by the US Senate, the



the end of the Cold War from Thursday, to remind Russia the Alliance stands united despite seeds of doubt planted by US President Donald Trump. Some 50,000 soldiers, 10,000 vehicles, 65 ships and 250 aircraft from 31 countries are taking part in Trident Juncture 18, which is aimed at training the Atlantic Alliance to defend a member state after an aggression.

"In recent years, Europe's security environment has significantly deteriorated," NATO Secretary General Jens Stoltenberg, of

Norway, said. "Trident Juncture sends a clear message to our nations and to any potential adversary. NATO does not seek confrontation but we stand ready to defend all Allies against any threat," he told reporters on Wednesday. While the "potential adversary" has not been officially identified, Russia is on everybody's minds. The country, which shares a 198-kilometre (123-mile) border with Norway in the Far North, has repeatedly flaunted its military strength in recent

vears.

The Russian army has annexed Crimea, helped destabilise eastern Ukraine, beefed up its military capabilities in the Arctic, and conducted its biggest ever exercises in the Far East in September. The Russian embassy in Oslo said it considered Trident Juncture an "anti-Russian" exercise.

"Such activity ... comes

across as provocative, even if you try to justify it as being of a purely defensive nature," it said.

For months, Moscow has been annoyed by the growing Western military presence in the region. The United States and Britain have been increasing their deployments in Norway to accustom their troops to cold weather combat. *AFP* INF treaty eliminated the medium-range missile arsenals of the world's two biggest nuclear powers and reduced their ability to launch a nuclear strike at short notice.

American Cruise and Pershing missiles deployed in Britain and West Germany were removed as a result while the Soviet Union pulled back its SS-20s out of European range. But since 2014, the US has accused Russia of breaching the INF by developing the SSC-8, a land-based, intermediaterange Cruise missile which also has the name of Novator 9M729.

On Wednesday, Putin again rejected Trump's claim that Russia breached the INF, saying a collapse of the pact would lead to a new arms race, a situation which he described as "extremely dangerous".

He alleged it was the US that violated the agreement. *AL JAZEERA*

Khashoggi murder: **CIA Director Gina** Haspel 'heard Khashoggi audio'

CIA director Gina Haspel has heard audio recordings that are believed to capture the killing of Saudi journalist Jamal Khashoggi, media reports say.

They say Ms Haspel was allowed to listen to the audio during a visit to Turkey earlier this week.

Khashoggi, a US-based critic of the Saudi government, was killed during a visit to its consulate in Istanbul.

Saudi Arabia has blamed the killing on "rogue agents". The case has strained relations with the US and other allies. Soon after the murder on 2 October, Turkish media quoted officials as saying they had audio recordings of Khashoggi's interrogation and death, but gave no details about the contents or how the audio had been obtained. Ms Haspel travelled to Turkey on Monday. On Wednesday Turkey's Sabah newspaper said she had listened to the recordings.

Now, sources cited by the Washington Post and Reuters news agency have backed up the reports. **BBC**

President Donald Trump continues to make calls via cell phone despite intelligence that China and Russia listen in, The New York Times reported Wednesday.

The Times report, citing current and former officials, said Chinese spies have listened to Trump's iPhone calls and that the President's aides had told him Russian spies were listening regularly.

Trump's cell phone use has been noted throughout his tenure, and security experts have raised concerns in the past. CNN noted in April that after John Kelly became chief of staff, Trump made more calls through the White House switchboard, but by the time of the April report, the President had begun to make more calls through his cell.

The New York Times report said the officials raising an alarm about Trump's refusal to stop making unsecured calls were doing so out of frustration.

Those officials told the Times that China was seeking to use its findings on Trump to help the country in its trade dispute with the US and that the Chinese had noted Trump's conversations with Stephen Schwarzman, head of The Blackstone Group, and Steve Wynn, a Las Vegas figure who established major investments in Macau, a gambling hub in China. Wynn stepped down as finance chair for the Republican National Committee last January following allegations of sexual misconduct, which he denied.

A former top diplomat, Zewde has served as both the special representative of the United Nations' secretary-general and the head of the UN office to the African Union.

She will replace Mulatu Teshome in the largely ceremonial role, serving under Prime Minister Abiy Ahmed, who holds the country's highest executive powers, including responsibility for the armed forces.



During her diplomatic career, Zewde was also head of the UN office to Kenya and has acted as Ethiopia's ambassador to several

"The way that I came up, it was never about dissing nobody, and I still feel like I don't need to diss anybody for nothing. My music was never about that. I have a short temper, so that's like doing things that I don't stand for," the "I Like It" rapper explained. "I don't like when people be subbing me. So, why would I subbing you on music? Any problem I have, I always address people face-

to-face."

Cardi B made similar comments when she called out the Barbz on Instagram Live. "They claim they hate me, but they really love me," she said, "because they be on my page before my fans."

Minaj has not responded to Cardi B's latest gripes.

After releasing her Invasion of Privacy album in April, Cardi B plans to share a collection of bonus tracks. "The plan was always to drop a, like, bonus. But I just didn't [think] I was going to be so busy doing back-and-forth, back-and-forth things after I gave birth. It's like, 'Oh my, God. Like, my schedule is so flooded.' Sofia Vergara: Modern Family actress is bestpaid star on US TV by far

Modern Family star Sofia Vergara is the best-paid actor on US TV, earning \$16m (£12.4m) more than her nearest rival, according to Forbes magazine.

Vergara earned \$42.5m (£33m) in 2017-18, Forbes said far ahead of the top-earning man, The Big Bang Theory's Jim Parsons, who is on \$26.5m (£20.5m).

Overall, the top 10 men still earned more than the top 10 women, but the gap has closed since last year.

The Big Bang Theory and Modern Family actors make up 13 of the 20 names.

Five of the six next best-paid on-screen stars behind Vergara are in The Big Bang Theory.

As well as Parsons, who plays Sheldon in the CBS sitcom, there is Johnny Galecki, who plays Leonard, Kaley Cuoco (Penny), Kunal Nayyar (Raj) and Simon Helberg (Howard), who earned between \$23.5m (£18.2m) and \$25m (£19.4m) each.

But their pay has dropped since last year's list after they reportedly took pay cuts in order to give co-stars Mayim Bialik (Amy) and Melissa Rauch (Bernadette) pay rises.

As a result, that pair are now on the list of the 10 best-paid actresses for the first time, on \$12m (£9.3m)each. However all those bumper pay packets won't last for much

longer - The Big Bang Theory will end next year. Grey's Anatomy star Ellen Pompeo was also near the top,

on \$23.5m (£18.2m) - a rise of \$10m since last year after she reportedly signed a new contract with ABC.
