#### Lungu to visit Russia "at Putin's invitation"

This is in a case in which UPND leader Hakainde Hichilema and his Vice Geoffrey Bwalya Mwamba have asked the High Court to determine whether their right to be heard in a Presidential election petition was violated when the Constitutional Court dismissed it on September 5, 2016, for want of prosecution. When the matter came up, Thursday, before High Court Judge Mwila Chitabo, Mwansa

raised preliminary issues on whether the High Court could interpret otherwise, in respect to the timeframe in which a Presidential petition election should be heard and whether the determination of the petition was a civil right as to bring it under Article 18 of the Constitution.

And Mwansa urged Judge Chitabo to dismiss Hichilema's petition with costs, saying it was misconceived at law as the High Court had no jurisdiction to hear such an application.

argued that the Constitutional Court had the original and final power to hear a matter relating to the interpretation of the Constitution and not the High Court, adding that according to the provisions of the law, the interpretation or reviewing of the Constitution was based in the Constitutional Court and not the High Court.

Mwansa said determination of any matter before Constitutional Court or any other court would not constitute or give rise to the existence of any violation of civil rights or obligation.

He submitted that had the Presidential petition election been heard by a lower court, the petitioners could have been entitled to the right to appeal to a superior court, adding that since it was heard by ConCourt, which was of final jurisdiction, it was not appealable hence the same judgement could not be reviewed by the lower court. "If the matter was being determined by the lower court, the petitioners could have been entitled to a right to appeal to a superior court. However, the petitioners' matter was determined by Constitutional Court exercising its final jurisdiction. judgement delivered on September 5, 2016, by ConCourt is not appealable and the same judgement cannot be reviewed by this court," Mwansa insisted.

"The proceedings before emanate from the majority judgement from the Constitutional Court dismissing the petitioners' for election want prosecution. And these proceedings have nothing to do with the determination of any civil rights or obligations, or indeed, the violation of any of the articles, 11 to 26 inclusive. The proceedings

with the violation of part three of the Constitution."

He said petitioners should abide by court rules in order to ensure that matters like the Presidential election petition were heard within the stipulated period of 14 days.

But in his submissions, Sangwa said they were not asking the High Court to reopen the decision of the Constitutional Court in the Presidential petition, but simply wanted the lower court to look at what the ConCourt did and whether it was in line with article 18(9) of the Constitution.

He said it was only the High Court, which had the authority to determine whether or not the Bill of Rights had been violated by any court.

He said the High Court had powers to control the three arms of government and that nobody was above the Constitution.

"We are not asking this court to reopen the decision of the Constitutional Court; it has done its work. We are not asking for review (either) because the Constitutional Court is facto officio. But we want it to determine whether what the Constitutional Court did was consistent with Article 18(9) of the Constitution," said Sangwa.

The matter has been adjourned to November 5, 2018.

This matter was sent back to the High Court following the Supreme Court's decision to dismiss with costs an appeal by the petitioners in which they wanted Judge Chitabo to recuse himself from handling the matter on account of perceived bias

### **Chongwe Municipal Council stops** construction of Chinese cemetery

The Chongwe Municipal Council has ordered an immediate stop to the construction of a Chinese run cemetery in Silverest

In a press statement issued and signed by Council assistant public relations manager Musonda Mino, the council has also instructed the site contractor Messr China Civil Engineering Construction Corporation Zambia Limited to restore the land to its original state. Mino stated that the developer had been stopped from continuing with the works because he did not follow the procedure as the land in question was designated for agricultural purposes and not for cemetery.

He stated that the named construction company was sub-contracted by the Chinese Embassy in Zambia to construct a cemetery.

"Chongwe Municipal Council has with immediate effect ordered the developer of the Chinese Martyr's Memorial facility, Messr China Civil Engineering Construction Corporation Zambia Limited to stop all construction activities at Silverest area of Chongwe District. This move comes the developer's failure to follow procedure before commencing with activities. development The council has further instructed the developer to restore the land to its original state. Matters at hand are that Messr China Civil Engineering Construction Corporation Zambia Limited, by the time of construction, did not obtain planning permission for Change of use of Land

and Planning Permission for Development provided for under the Urban and Regional Planning Act No. 3 of 2015 from the Local Authority. According to records at the council, Plot LN-4034/1 is designated for agricultural use and not as a cemetery," stated Mino.

"As a council, we are very much aware that the land in question is private property and also on title but will not allow any development at

the site before the developer Developmental acquires Permission from Local Authority. Chongwe Municipal Council has since advised the developer to follow the right procedure by applying for planning permission and change of land use. Furthermore, it is our desire as a Council facilitate various infrastructure development in numerous categories throughout the district. Therefore, in doing so, there are requirements as provided by the laws of Zambia that developers must adhere to before commencing any development. Civil Society Constitution Agenda (CiSCA) says discussing politics is not a crime to warrant people getting arrested for it.

And CiSCA has maintained its stance that the Church must lead the dialogue and reconciliation process.

At a press briefing held at the Zambia Civic Education Association yesterday, CiSCA president Bishop John Mambo observed that those in government had continued abusing the Public Order Act.

"It has been some time since President Edgar Lungu mentioned the need to review the Public Order Act, undoubtedly one of the most draconian pieces of legislation in our statute books, which is also one of the most abused. While we appreciate the recent announcement by the Ministry of Justice on the roll out of public provincial consultation on the review of the Public Order Act, we ask, what is the status of the of the review of the Public Order Act? In the meantime, while the President and government continue to give lip service about this important assignment, the Public Order Act continues to be used as a weapon to silence any dissenting voices including that of NGOs, as it happened in Ndola where NGO representatives and pastors were arrested on account that they wanted to discuss a political topic. When did discussing politics become outlawed in Zambia?" Bishop Mambo asked.

"Further this call for the review of the Public Order Act will be meaningless if the Constitution remains unattended to. So let government give us the refined draft constitution before heading to the review of the Public Order Act, as starting with the review of the Act may suggest revisiting the Act once the constitution is finally enacted."

And CiSCA insisted that unlike ZCID, the church had a track record for brokering

"On national dialogue and reconciliation, we reiterate our earlier suggestion and call that all stakeholders must allow the Church to handle this key national process. We are surprised that the Church's leadership in this processes is being contested and yet, just a few weeks ago, the country was observing the day of national prayers, fasting and reconciliation led not by the ZCID but by the Church and attended by political party leaders. This puts the Church on an advantage to facilitate, lead and chair the entire processes like it did during the day of prayer, fasting and reconciliation. Therefore, we call on the ZCID and those supporting them to allow the Church to play its prophetic role and realise that the church is best positioned to handle such a process as its track record does show," said Bishop

"We respect all the eminent people who have been chosen by ZCID to lead the dialogue process, one of them is my lawyer, representing me in the Supreme Court case, Chifumu Banda, we respect all of them, there are also

identified as Ishmael Manda aged 25 of John Laing Compound also a teacher at Islamic Orphanage Secondary School in Makeni. He was found with copies of grade nine Mathematics, English, Religious Education, Art and Design and Business Science examination papers on his mobile phone. Christopher Sampa aged 43 who is Director at CS Christian Private School

in Chipata Compound in Lusaka, Alphate Kabamba aged 29, a businessman of Kabanana Compound who was found with hard copies of Art and Design, Religious Education and Social Studies, Alphonso Milambo aged 40, a teacher at Ellensdale Primary School and Angela Mumba Mulenga who was in charge of the strong room at Ellensdale School in Ngwerere," she stated.

"Further investigations at Ellensdale Strong room revealed that Examination papers for Art and Design, Religious Education and Social Studies were tempered with."

And Katongo stated that three people were arrested on the Copperbelt, aged 33, 25 and 22 years-old.

"Investigations conducted on the Copperbelt led to the arrest of three people identified as Humphrey Kamfwa Tembo aged 33 who was found with grade nine Mathematics paper one and two, Collins Solochi aged 25 who was found with Social studies Paper one and two and a paper for Business Studies and also Andrew Banda aged 22 who was found in possession of English paper two for grade 12 and a hard copy of answers for Mathematics

paper," she stated.

Katongo further stated that in Mazabuka, Southern Province, a 24 year-old woman was arrested and further investigations led to the arrest of an 18 year-old grade nine pupil of Ndeke School.

She stated that two other grade nine pupils at Maneila Open Community School were also arrested in Mazabuka district.

"In Mazabuka of Southern Province, Police arrested Given Kanyeleti aged 24 of Nakambala Compound who was found photocopying a handwritten leaked Science paper two for grade nine. Further investigations led to the arrest of a grade nine pupil of Ndeke School aged 18 of Nakambala Compound. Others arrested in Mazabuka are two grade nine pupils at Maneila Open Community School who were found with grade nine Computer Studies paper one and two, Integrated Science Practical and both paper one and two, English Language papers paper one and two for grade nine and Social Studies examination papers," she stated.

Meanwhile, Katongo stated that investigations conducted in Mazabuka further revealed that examination paper packs at Namaila Primary School had been tempered with and copies of Mathematics paper two, Social studies and Chitonga were missing.

She added that four teachers, among them a head teacher of that school, were arrested. "Investigations conducted in Mazabuka further revealed that examination paper packs at Namaila Primary School had been tempered with and copies of Mathematics paper two, Social studies and Chitonga were missing. Four teachers namely; Augustine Musenga aged 46 who is a Head Teacher at Namaila Primary School, Hedson Machila aged 42, Simon Sikombe aged 40 and Oliver Hauma aged 42 all teachers at the above mentioned school were arrested and investigations in the matter have continued," stated Katongo.

Katongo revealed that the suspects had been charged with unauthorized possession of examination paper or information.

She added that police had continued with investigations and members of the public would be updated on any new development.

### Zambian student dies in India

A Zambian Student has died while another is in a critical condition after a road traffic accident in India.

This is according to a statement issued by First Secretary Press and Tourism at the Zambian Mission in New Delhi, India, Bangwe Naviley.

"The Mission in New Delhi, India, has received with deep sorrow the demise of a Zambian national, Peter Mwamba, a 3rd year Civil Engineering Student, in a tragic road traffic accident. The High Commissioner said the deceased was in the the company of his colleague, Dennis Musukwa, a 3rd yr Pharmacy Student, who is in a critical condition," Zambia's High Commissioner to India Judith Kapijimpanga said.

"The two students are all from Parul University in Vadodara, Gujarat State, India."

She said the accident occurred around 19:00 hours Indian time (15:30 hours Zambian time) on October 31, 2018

"Information shows that they were hit by a truck in a hit and run tragedy as they were on a motorcycle," The High Commissioner said.

Kapijimpanga said a good Samaritan by the name of Ishy took the accident victims to the hospital.

"I have dispatched an officer from the Embassy to get more information in Gujarat State, about 1087 kilometres away from the Indian capital New Delhi, and help in anyway necessary," said Kapijimpanga.

Kapijimpanga said the Zambian Mission in New Delhi and the students populace in India were deeply saddened by the untimely accident and urged the families to remain strong in the trying moment of difficulty as the students were promising.

### **Lungu to visit Russia in 2019**

Zambia's Ambassador to Russia Shadreck Luwita has revealed that President Edgar Lungu is expected to make an official state visit to Russia in 2019.

The state visit is at the invitation of Russian President Vladimir Putin and will happen as soon as all the details of his trip are harmonized.

Ambassador Luwita said this in an interview with Russian news agency Sputnik following the Southern African Development Community (SADC) Investment Forum in Moscow.

"[The visit's organization] is now incumbent upon the technocrats in the Ministry of Foreign Affairs of the Russian Federation as well as the Ministry of Foreign Affairs of Zambia, [they] started working on the modalities to concretize when President Lungu can

undertake the state visit to Russia," Ambassador Luwita said.

"We are working flat out to ensure that this is realized as quickly as possible. The year is already almost ending so definitely we anticipate that in the course of next year, as early as possible, this state visit should be realized."

He said Russia was a great friend of Africa, adding that the countries of the continent were interested in developing relations for the benefit of their economies.

"There is enormous potential in this country in terms of technology, there are enormous resources, which, once partnered with the African continent in various economic sectors, will transform into the development of the African continent so that Africa is no longer dependent on aid," Ambassador Luwita indicated.

The Zambian envoy to Russia welcomed the signing of the memorandum of understanding between the SADC and Russia that took place within the forum's framework on Tuesday.

"This has come at an optimal time... It is a panacea to opening up investment opportunities in the SADC countries. As you are aware, it has been the considered view of the heads of state of the African continent on the need of the Russian government, on one hand, and indeed of Russian investors... to transform these excellent political relations into economic which benefits, going to benefit both the African people as well as the Russian people," said Ambassador Luwita.

In July, Mr. Putin invited President Lungu to visit Russia during a bilateral meeting that was held on the sidelines of the BRICS Summit in South Africa.

## Shakas breaks silence, lambasts loyalty-seeking rotten regime

Former Katuba UPND member of parliament Jonas Shakafuswa says he can never idolize people who count their power by stealing from the poor.

In an uncharacteristic Facebook posting, Wednesday, Shakafuswa said his loyalty was with the nation. "I love my self. I don't idolize men. Because they tend to succumb to human greed and selfishness. I have only fear of the Lord. So for these semi Gods just know that I will show that in fact you are the wrong Chaps. People count their power by stealing from the poor and want us to idolize them. Rubbish. Teshi chishi cha Ba manyina wanu. They want Loyalty when they are rotten Corrupt! Not from me. I owe it to the nation," Shakafuswa, who defected to the PF in 2016, stated. His posting sparked an interesting discourse, with some of his followers

congratulating him for being blunt

to which he responded; "There has

to be a time when we call a spade a

spade. We can't be cowed by thugs

and you say we have a Nation. Thugs place in in Prison."

Among those who supported his posting were former Sinda MMD member of parliament Levy Ngoma, who is now UPND chairman for agriculture.

"Jonas my friend. That's the original you!! Fearless Zambian!! Let's work together to redeem mother land! Well spoken!!" wrote Ngoma.

However, Martin Chikondi attacked Ngoma saying, "yes, but you Levy are just as bad as those PF thugs. May God never allow you back into Parliament," to which Shakafuswa responded, "Martin Chikondi are you sure you can decide my fate? No you can't. People earn Loyalty and respect. I left UPND because leader wanted to be treated like a God. What do you call morality. Supporting something you don't believe in."

Another follower, Melvin Banda, however, charged that Shakafuswa was politically unstable and could therefore not be trusted.

"Shaka, you are not somebody

anybody can trust, even yourself you know that, as you are right now you can't proudly associate with the PF and even the UPND because you are considered rotten in both camps, teshi chish chabanyinawabo just like you, be honest, realistic and stable politically," Banda charged.

In response, Shakafuswa lamented that politics had become about tribe in Zambia.

"Experience is the best teacher. Are you sure I need a political Party for a platform. I have no political ambition. But talk for Zambia I will. And for your information, I have a big Constituency in Zambia. Zambian Politics has no Ideological orientation. It is anchored on tribe. This is what has killed the Nation. A tribe in power wanting to keep power over other tribes. Opposition wanting power to replace a certain tribe. You call that politics? You say I thought I could swim in money for supporting PF. No. If I wanted I could. There are so many opportunities. I wasn't raised that way. I am very comfortable as I am.

I supported PF because I believe at that time HH was not ripe enough to be President. Not the money. But what [if] I took a chance, HH could have won. But I took my support base to ECL," Shakafuswa wrote.

Meanwhile, a UPND sympathizer Enock Seith warned Shakafuswa not to return to the opposition party.

"Dance to their tune becos you have no morality where politics is concerned. You are no different from a headless chicken. Dont even try to come to upnd becos judas' can never trusted at all," wrote Seith.

But Shakafuswa told him that he did not believe UPND was the solution. "Enock Seith you think UPND is the solution . No I don't need to be soiled by tribal division. Zambia will find a voice. Not through tribal politics but Zambian solution. Don't subscribe to Politics which align itself with tribe. Talk of pay. Don't you think I could have been idolizing someone? Not me. Most political leaders want to be treated like Gods. No they are human," wrote Shakafuswa.

## Don't be selfish, increase salaries for public service workers - CK

NDC leader Chishimba Kambwili says government should stop being selfish and have mercy on the suffering masses by giving public service workers salaries that they can survive on.

And Kambwili says there is too much corruption in the employment of teachers as people are paying as much as K10,000 to get employed.

Meanwhile, Choma UPND member of parliament Cornelius Mweetwa has observed that PF cadres have become stronger than civil servants.

Debating Head 27 – Public Service Management Division (PSMD) in Parliament, Wednesday, Kambwili noted that PSMD was responsible for negotiating salaries for public service workers.

He however questioned whether PSMD and government were being fair to civil servants and public workers by giving them meagre salaries.

"It is interesting to note that this department we are discussing today is responsible for negotiating salaries for public service workers. And the question I would ask all those in that department and our colleagues on the right, 'are you really being fair to the salaries being paid to the civil servants and public workers?' And if by some coincidence, your salaries were changed,

you start earning a salary of a teacher and a teacher earning salaries, how would you feel? As you have come here, you are with drivers who are driving you, are you worried whether they are able to manage three meals per day? And some of you are so bad hearted that you don't even invite your drivers for lunch and yet you know that these are human beings that also deserve to live better," Kambwili said.

Kambwili urged government to think of public workers come 2019 saying leadership was about uplifting the living standards of the people, not caring about one's pockets.

"Leadership is about uplifting the living standards of our people, not caring about your pockets. Please, 2019 think of the public workers. I know that you can do it and it can be done but mufulo fye mwakwata (you are just sadists). You are doing it deliberately," he said.

Kambwili urged government to give public service workers salaries that they could survive on. "It has been done before, from K700 lowest by the late President Micheal Sata to K3,000 lowest. But what we have seen of late, five percent increment, 6.2 percent, come on! Even those who are negotiating, you must have a heart for the people. As you go for the 2019, look at the salaries of the public service workers in view of the fact that this government has brought in so many taxes to the extent that all the money that President Micheal Sata the late gave the civil servants has been diluted. Today its like the civil servants are earning K0. Please lets have mercy, lets feel pity for the suffering masses and not to be selfish and only advance our personal gains," he said.

And Kambwili observed that there was too much corruption in the employment of teachers as people were paying as much as K10,000 to get employed.

"I'm told, this department (PSMD) facilitates employment and redeployment in the civil service. There is too much corruption in the employment, particularly teachers. People are paying as much as K10,000 to

be employed as a teacher and let us not pretend that we don't know these things. My nephew came to me and said that 'I need K10,000 for employment', I told him 'you can go to hell because I will not do that'. But how many of the people are paying K10,000 to be employed as teachers? So can we sort out this corruption in the employment of teachers," he said.

Debating the same Head, Choma UPND member of parliament Cornelius Mweetwa observed that PF cadres had become stronger than civil servants.

"Not too long ago, a Permanent Secretary for Northern Province (Elias Kamanga) purportedly disciplined his deputy and recordings are in public domain where calls where being made to the Permanent Secretary PSMD to apologise to PF cadres so that they can push in a word. This is a civil service we now have under PF where cadres have become stronger than professionals. PF cadres have become stronger than civil servants under PF, no wonder sometimes certain decisions are made which are bad," he said.

Meanwhile, Mweetwa charged that PF was no longer a credible government one could look up to deliver through PSMD and the civil service as they were a group of political con men who wanted to continue to hold on to power at all costs.

"PF is mismanaging the civil service, not because they are deliberate but because they lack capacity. In fact they are no longer in the true sense, a credible government one should look up to deliver through PSMD and the civil service, they are just a group of political con men who want to continue to hold on to power at all costs," he said before he was guided to withdraw the word 'con men'.

He added that PSMD should know that they had a greater task than "the incompetent, inept and incapable PF which was an accident to the people of Zambia."

## Poor management controls encouraging theft among civil servants, says Sacika

Former Secretary to the Cabinet Dr Sketchley Sachika says there is a breakdown of management controls and systems in government which he says have created many opportunities for civil servants to abuse and misappropriate public funds.

And Sachika says the Patriotic Front style of management is like a person who has never driven a car but in given the keys to learn while on the High Way.

Reacting to the continuously increase in abuse of funds in government ministries as revealed in the auditor generals report, Sachika said there were many unqualified individuals in charge of government departments who were failing to deliver services as expected.

"The problem as I see it is that there is a breakdown of management controls and systems

in government. This breakdown has created many opportunities for civil servants to misuse resources and it's all because they think they can get away with it. The problem of breakdown of management controls is that unqualified people are appointed to manage your ministries, your departments parastatal organisations among other departments. When you appoint people, who are not qualified to management positions, you cannot expect them to deliver services to the expectations of the public. Most of these appointments, wrong appointments are made for political reasons. You have people occupy positions as government secretaries who are not qualified for those positions in terms management capabilities. But they nevertheless occupy those positions as government secretaries because they are party

members and they are friends with those who are in power," he said. And Sachika said PF was like an inexperienced driver learning on the road

"And in the current regime, we are in a situation which is similar to a situation where someone gives car keys to an individual who is not trained as a driver, does not know how to drive, has never driven before and you say here is the car can you drive. What do you expect will happen? Do you expect that person to drive properly or normally? No! They will only wreck your car. That is an analogy of the life today and that is what is happening today. We have unqualified individuals who are running ministries and people expect them to deliver services to the expected standards. And because these people are not qualified they cannot manage an institution or a ministry. Lastly the problem is not only about misuse [of public resources as revealed in the auditor generals report] or stealing of public funds, the problem goes beyond that," said Sachika.

"Our ministries or government departments are not functioning. They are not functioning, they are not providing the services that we expect them to provide. There is a breakdown of government institutions like the Local government for example. You have parastatal organisations that have stopped functioning because they are not being properly managed. So, you have a problem that is at two levels; abuse and misuse of public funds and breakdown or the disfunction of government institutions and department. So, for me I think that is why there is an increase in abuse of resources as reported in the auditor generals report."

In this verbatim, Lusaka Mayor Miles Sampa says he refused to pay the bill after eating lunch at a restaurant because the waitress took so long to bring him a takeaway pack in which to carry what he left over.

Sampa insists that he had money in the pocket but refused to pay for a bad service, adding that other restaurant owners must watch out for him.

He also says his mental faculties are on top of the game and those alleging that he is now running mad are attacking him from a point of ignorance.

Below is the interview:

Question: we have seen a complaint that you went to a restaurant, ate food worth K700 and refused to pay, what happened?

Answer: That happened at the Restaurant called Roan and Sable. I have been going there for months, that is my hangout place for lunch or dinner for the last one year. So I have seen service go down just like it happens to many other restaurants, they come up with good service, they attract customers and after a while when there are too many customers, service goes down. So one of the things that attracted me there was the service other than that I live a stone throw from there. But I have seen service go down there. Sometimes you sit for ten minutes before you are attended to, even when you make an order it

takes longer. I have verbally complained to the manager before but the service hasn't been improved.

So that particular day actually I was having lunch with my uncle Frank Mutubila, my driver and my ADC. Then I had an emergency and I had to leave and I wanted them to pack the rest of the food, but the waiter was nowhere to be seen. And that has happened many times and so that is when I left that note. Let me make it clear that as mayor, I am not looking for popularity, I am looking to have work done and change the culture in Lusaka because when you go to a restaurant, you are paying for the service. So if the service is not good, there is nothing to pay for. I have gone to many restaurants around the world and one of the most prestigious jobs is being a waiter or waitress, people should enjoy their work. You even feel obliged to give them a tip. But in Lusaka it's like they are doing you a favour and then afterwards they bring you a huge bill. So if nobody has ever complained, as long as I am Mayor, I am going to change that attitude.

Q: But don't you have a task force at the council that is supposed to handle such cases, where people can complain and they go to investigate, rather than you implementing when you have personal interest in the

matter? A: I am not going to be a mayor of a theorist in the office, I am going to be on the ground. Where Lusaka residents are complaining, I will be there and get involved. It is me that they saved badly and as an individual I have the right to complain. We have rights as consumers, so the complaint there was more as a consumer not having a good service. I didn't refuse to pay but I am bringing it to the attention that for the service that we pay for, the service has to be there. So I have told them that I will pay after a month and if anything I will even add interest calculated at my bank which is Barclays Bank. But the waiter who service me, I will not pay him a tip. So I am happy that it has received the attention that it has so that the other restaurant owners know that I am watching and as long as I am the Mayor I will ensure that service

is good to customers. It's different if I go to each nsima at the market or or Matebeto. That that is why the prices are cheap there because there is no good service. YI can eat lunch for K200, but there it was K700 you expect a service.

Q: But why did you eat the food if the service was bad. Why not protest by refusing to eat the food and also not paying?

A: Remember I didn't say the food was bad, the food was good, it was the service that was bad. The service is from the point that you arrive at a restaurant, how you are welcomed, how the workers treat you during the time of the meal and how they treat you afterwards. My complaint is about the service not about the food. So the bad service was towards the end of the food and after I had finished eating. If anything I was trying to get a package for take away and the service was nowhere to be seen. They were elsewhere lost. So it ought to be a quick service. It's not the food that I am complaining about, I even ate the food and it was

a restaurant is not good they must eat the food and refuse to pay the bill, just as their Mayor has led by example? A: No really. If they refuse to pay, the restaurant owners will report them to the police. So they should pay but they should report the restaurant for bad service.

Q: But you didn't pay, and not everyone is privileged to be Mayor to get away without paying a bill.

A: If they want the restaurant owners can also report me to the police. But remember that I have not refused to pay, I am saying I will only pay after a month. I had the money in my pocket. Even now I have the K700 in the pocket, but I refused to pay because of the bad service. So I can report them and they can also report me. But in this case, I didn't report them, I acted myself because I am the Mayor and it happened to me.

Q: You have suddenly become a controversial Mayor, Your Worship, people are wondering what is happening to you because something seems to have changed.

Nothing has changed [with

me will actually tell that I am action oriented and I want things to be done. So I want people to be efficient and effective. So everywhere whether it's within the council or everywhere, I just want action. I am not a theorist and I don't condone output that is below standard. I am not here for popularity in this job. If I wanted popularity I was going to be making ice cream and distributing to people because that is what everyone seems to like, but I am not here to please people. But remember, in any job, there are those who are happy [that] you got the job and those who are not happy. There are those among the 35 [in the PF] that wanted this position who think they are better than me, but I can't help it. It's posterity that will

judge me.

A: If trying to get word done is being mad, maybe I am. But I am just trying to get efficient work done. I am not going to open my ears to negativity otherwise, I won't work. So now I am closing my ears to all negatives. I have people who advise me that I respect and if I am wrong, they do tell me and I listen to them.

Q: On the National Day of Prayer you were wearing a very wrinkled suit, and people were making fun of you saying your were now so confused in the head that you could not even take a suit to the laundry. There is even a circulating picture that I can send you on WhatsApp. What is going on? Are you okay Your Worship?

A: I have remembered the suit that you are talking about. That was a pure cotton suit, and pure cotton suit anyone who knows will tell you that it is crisp in nature. You can actually fold it like a paper, so when you sit it folds like a paper until you take it to the laundry. That's is just the way it is, it's part of fashion. So if someone doesn't know that type of suit, how can I defend myself if they are attacking me from a point of ignorance?

### Deputy Speaker chases Kambwili from Parley over digital migration comment

Second Deputy Speaker of the National Assembly Mwimba Malama yesterday chased Roan PF member of parliament Chishimba Kambwili from the House after the latter warned that all those who were involved in the digital migration scandal would go to jail. Debating Head 26 on the Ministry of Information and Broadcasting services, Kambwili, who is also NDC leader, observed that Information Minister Dora Siliya and ZNBC board chairperson Mulenga Kapwepwe were not being sincere on the digital migration

When asked for a comment over what transpired in Parliament, Kambwili expressed hesitance to talk, saying he did not want the House to accuse him of falsifying the record.

"What you say in Parliament, it's good you have a verbatim because they can take advantage and say that I went to tell lies...but basically, what I was saying was that Dora and Mulenga Kapwepwe are telling lies on the digital migration that it was not single sourced and that there were 12 competitors. And also that StarTimes have brought in extra money to do the studios and that the government program was to end within the line of rail and that StarTimes brought in extra money, that's why they made that joint venture. She actually even said that the money was lent to the joint venture and not the government, so I was telling her that the money was lent to the Republic of Zambia and not the joint venture. And they have been changing stories because this is a scandal and they will never run away from the fact

that to migrate four provinces, we spent US\$9 million but to migrate six, they got a loan of \$273 million, what mathematics did they use?" Kambwili asked, in an interview after being chased from the House. "I also told them that how can you bring in StarTimes as a contractor, they deliver the project and you pay them \$273 million, then they come to you and say we want to run this program by us having 60 per cent and you 40 per cent...How can you pay someone and then allow them to get 60 per cent (shares)? That is corruption. At least if you didn't pay them anything and you want them to recover their money for construction...above all, the Zambian people are paying TV levy and then in that bouquet, you are only giving the Zambians two free channels, the rest they have to pay

that this is a scandal. I told them

so why should Zambians continue paying TV levy and pay monthly subscription to this joint venture?" Kambwili said he was chased for stating the truth.

"I told them that if they wanted this thing to end, they should call for an inquiry into this matter and I will be the first witness because I know all the details. Then I ended by saying 'otherwise, mukaya ku jele, mukaya ku chi fungo'. And I sat down then the Speaker told me to withdraw the statement 'mukaya ku jele', I said no, I cannot withdraw it, I can only translate it, it means 'you will go to jail'. Then he insisted that I should withdraw but I refused because it's not unparliamentary. That's when he told me that 'go out of the House'. I said 'thank you very much. I was chased for stating the fact on Topstar deal," said Kambwili.



#### Busoli Royal Establishment petition Wanchinga to stop Kingsland City Project

Busoli Royal Establishment and Chalimbana River Headwater Conservation Trust have petitioned Water Development Minister Dennis Wanchinga to stop all illegal developments in Lusaka East's local forest reserve.

The group of Busoli Royal
Establishment Senior
indunas were accompanied
by Her Royal Highness
Senior Chieftainess
Nkomeshya Mukamambo
II's daughter Princess
Ncholwe and her principal
advisor John Luputa.

Speaking on behalf of Senior Chieftainess Nkomeshya Mukamambo II, Princess Ncholwe asked the Minister to order the Zambia Environmental Management Agency (ZEMA) to enforce the stop order on Kingsland City Project in the forest.

"We are crying with what is happening in forestry 27. Chalimbana River, as you know, is the source of our water, our livelihood and so, we are here to cry in regards this concern that is affecting our people; not just in the water they drink, but in being there. Minister, we are asking you, as we plead with you that, you hear with your heart our cry! That our people are dying out of what is happening because of what man-made issues have created. The discharge going into our water, the pollution and the fecal matter are a health hazard to the lives of many people in the area. We, therefore, ask you, Minister to order ZEMA to enforce the stop order on Kingsland City Project in the forest because it seems it is being ignored through the issuance of title deeds in the said forest reserve," Princess Ncholwe pleaded.

The Princess said allowing the development to go ahead would mean a lot of lives will be lost due to diseases that would breakout due to pollution and contaminated drinking water.

"If we let those developments go ahead, it will mean a lot of our people will die from diseases caused by pollution and contaminated drinking water. It's not only the Royal Establishment that will be affected, but almost every person in Lusaka. We are, therefore, appealing to you, Minister, to ensure that you critically look into this issue as soon as possible and ensure that you act now before many lives are lost," she appealed.

And Chalimbana River Headwater Conservation Trust board chairperson Robert Chimambo added that the Trust was deeply concerned with the illegal development taking place in Forest Reserve 27.

"We are deeply concerned that the portion of land in the area has been degazetted without following procedures. All we want know is to see how you, as the Minister, together with other line Ministry, can protect the Forest 27, which has currently been given out. We want you to stop and place a moratorium on the issuance of title deeds in the said forest reserve in order to stop speculative land exchanges now taking place," Chimambo said.

Wanchinga

Meanwhile,

said his Ministry would engage Ministries of Health, Defence, Local Government in a bid to resolve the issue. "I know that the pressure on land is very high because of the population growth. So, we have a responsibility to ensure that we strike a very good balance between accommodating this growing population and also preserving our environment. That is where us, as a Ministry and our technical people, we have a responsibility to ensure that we put in place laws and regulations that are aimed at striking this balance because without rivers, there will be no people. It's not just about drinking water, but also we want to make sure that the water people drink is clean. So, I will be meeting with the Ministry of Local Government, Ministry of Health, Ministry of Defence and all the institutions that we have under our Ministry, which is ZEMA, WEMA, Lusaka Water and Sewerage Company and share our thoughts on this issue," pledged Wanchinga.

The Ministry further thanked the Busoli Royal Establishment and Chalimbana River Headwater Conservation Trust for handling the matter with care.

Among the indunas present were senior headman Maoma, senior headman Nkomesha, Headwoman Kasolo, and Headwoman Nashinangwa.

Others were Headwoman Chikonkote, Headwoman Lumbansa, Headwoman Kabeleka and Kakubo.

### Law firm sues Kazonga over K380,000 debt

A Lusaka law firm, Central Chambers, has sued former Vubwi MMD member of parliament Eustarckio Kazonga in the Lusaka High Court for failing to settle over K300,000 in legal fees.

Dr Kazonga allegedly instructed the law firm in September, 2011, to represent him in an election petition, but has so far only paid K70,000 of the fees, leaving a balance of K380,000.

In a statement of claim filed in Lusaka High Court, Central Chambers stated that in or about September, 2011, Dr Kazonga instructed the firm to represent him in an election petition in which his election as MP for the said Vubwi Constituency was being challenged.

The firm stated that upon receipt of the instructions, the parties proceeded to agree on the fee scale to be applicable and he was represented in the High Court and Supreme Court where the matter was eventually disposed of.

They stated that Dr Kazonga was rendered a bill amounting to K450,000, but that he had only paid K70,000, leaving an outstanding balance of K380,000. The law firm stated that Dr Kazonga had ignored all reminders to pay the remaining amount.

"Despite several written reminders requesting him to liquidate his indebtedness to the plaintiff, the defendant has ignored, neglected or failed to and still continues to ignore, neglect or fail to pay the said sum," read the statement of claim.

They stated that the firm had suffered loss and damage as a result.

The firm is now claiming payment of K380,000 being money due and payable to them as legal fees for the services rendered to Dr Kazonga at his own request and insistence.

They are further claiming for interest on the sum at the short-term bank deposit rate from the date of writ of summons to date of judgement and, thereafter, at the long-term lending rate until final settlement, costs and any other relief that the court may deem fit.

So, make sure that they push his face onto the ballot, no matter what it takes.

It is for this reason that we encourage those in the PF who have presidential ambitions to come out as soon as







## One black box from the crashed Lion Air jet has been recovered, the head of Indonesia's National Transportation Safety Committee said Thursday, which could be critical to establishing why the brand new plane fell out of the sky.

The devices record information about the speed, altitude and direction of the plane as well as flight crew conversations and could hold vital clues to the cause of the deadly accident.

"We found one of the black boxes," Soerjanto Tjahjono told AFP.

It was not clear whether it was the flight data recorder or cockpit voice recorder.

The Boeing-737 MAX 8, which went into service just a few months ago, plunged into the Java Sea off Indonesia's northern coast on Monday, killing 189 people, just 12 minutes after taking off from the capital Jakarta en route to Pangkal Pinang city.

device into a plastic tub. Despite the name, black boxes are in fact bright orange with reflective stripes, and all commercial planes are obliged to have them on board.

They're built to survive at vast depths and in extreme heat, and are fitted with a

beacon which can emit a signal for one month. Black box data help explain nearly 90 percent of all crashes, according to aviation experts.

"Data from the plane -- the engine, all the instruments -- are recorded there," aviation analyst Dudi

Sudibyo told AFP.

"If there is an anomaly, some technical problem, it is recorded there too."

Dozens of divers are taking part in the massive recovery effort along with helicopters and ships, but authorities have all but ruled out finding any survivors.

Searchers are still looking for the plane's fuselage and only body parts have been found so far, possibly from passengers seated in parts of the jet that were decimated on impact.

"I assume that there will be a lot of bodies still strapped into the seats," Sudibyo said.

On a Jakarta dockside, Boeing and US National Transportation Safety Board officials joined the Indonesian team in sifting through twisted metal plane parts and a pile of personal effects plucked from the sea, from torn clothing and shoes to wallets and mobile phones. *AFP*

## S. Korean court allows conscientious South Korea's supreme court ruled Thursday that moral and religious beliefs are valid reasons to refuse Objection to military service

South Korea's supreme court ruled Thursday that moral and religious beliefs are valid reasons to refuse the country's mandatory military service, in a case that has implications for hundreds of conscientious objectors.

Some 65 years after the end of the Korean War, nearly every able-bodied South Korean male between the ages of 18 and 35 must still complete around two years of military service.

Anyone refusing the callup has usually ended up in prison for 18 months, and more than 19,000 conscientious objectors have been jailed since 1950, most of them Jehovah's Witnesses. But the Supreme Court overturned the conviction of a conscientious objector on Thursday, months after a landmark constitutional court ruling that authorities had to provide an alternative to joining the military.

At the centre of Thursday's case is Jehovah's Witness Oh Seung-hun, who was called up in 2013 but refused, was found guilty, and lost an initial appeal to the high

"It is the majority opinion of the supreme court that conscientious objection is... a valid reason (to refuse conscription)," said Supreme Court chief justice Kim Myeong-su.

Punishing conscientious objectors "for refusing conscription on grounds of religious faith, in other words, freedom of conscience, is deemed an excessive constraint to an individual's freedom of conscience, he added.

The decision, by a majority of nine votes to four, overturned a previous Supreme Court ruling 14 years ago.

Oh, 34, said he had refused to join the military as doing so went against biblical teaching.

"The bible says that everyone

who uses a sword will be killed by a sword," Oh told

"I expected to suffer for objecting to conscription but I thought the pain I would feel by not listening to my inner voice would be far worse," he added.

Jehovah's Witnesses welcomed the ruling, calling it a "huge step forward in ending this policy of imprisoning our fellow

believers".

"Today the Supreme Court has brought South Korea more in line with international norms," said spokesman Paul Gillies.

According to the Jehovah's

Witnesses, more than 900 similar cases are pending in the South Korean justice system, with another 96 people currently serving prison terms for not fulfilling their duties. *AFP* 

## Body of missing Nigeria general found in well

The body of a retired Nigerian army general, who mysteriously disappeared on 3 September, has been found in a well.

Gen Idris Alkali went missing while travelling alone from the capital, Abuja, to his hometown in Bauchi state. His car was found a month ago in an abandoned mining pit on the outskirts of the central city of Jos.

Last week the army discovered a shallow grave where the body of the general had been buried before being moved. A military spokesperson said that on Wednesday, one of the people who moved the body led them to an abandoned well south of Jos, where they were able to recover the general's remains.

Gen Alkali was the Nigerian army's former chief of administration.

He had just retired after 35 years of service when he disappeared.

In previous statements, the army said it believed the general was killed by local youth, protesting a recent attack by gunmen in their community. **BBC**

A breakthrough treatment involving electrical stimulation of the spine has enabled paralysed patients to walk again, apparently reactivating nerve connections and providing hope for people even years after accidents.

team neurosurgeons engineers used targeted pulses electrical achieve the results, triggering individual muscles in a sequence, the way the brain would. The pulses are produced by an implant placed over the spine in careful alignment with areas that control the muscles in the lower body.

And so far, the results are promising.

"This clinical trial has given me hope," said Gert-Jan Oskam, 35, who was told he would never walk again after a traffic accident in 2011. After five months of treatment, he can now walk short distances even without the help of electrical stimulation.

It's the culmination of "more than a decade of careful research,"

Gregoire Courtine, a neuroscientist at the Swiss Federal Institute of Technology who helped lead the research,

told AFP.
Previous trials have used so-called continuous electrical stimulation of the spine, which worked well in rats, but produced less impressive results in

humans.

After several months of training with the targeted pulses however, "our three participants were able to activate their previously paralysed muscles without electrical stimulation," said Courtine.

"The result was completely unexpected,"

he added, in a video released with the publication of the research in the journal Nature Thursday.

"They could even take a few steps overground without any support, hands-free. For me seeing this recovery was amazing."

Footage from the study

shows clearly the way the targeted stimulation differs from the continuous pulses.

With the targeted stimulation, a patient walks in an almost ordinary fashion, his feet rolling down and up as he steps.

The continuous stimulation, by

contrast, produces jerkier movement, with his feet dragging and unbalancing him.

And the targeted pulsing, combined with a programme of extensive physiotherapy, was apparently able to reactivate nerve connections that became dormant when patients were injured.

David Mzee, 28, suffered full paralysis of his left leg after an accident in 2010, but after the five-month programme, he can walk for up to two hours with a walker using electrical stimulation, or take steps over shorter distances by himself.

The stimulation begins with a pulse directed at a muscle to prompt the patient to begin movement, for example a step.

Sensors at the feet detect the movement as the initial phase of a step and send additional targeted pulses to trigger the muscle movements required to complete the step, and repeat it.

At the same time, patients think about moving those muscles and stepping.

Because the neurons in the brain fire at almost the exact same time as the electrical pulses stimulate the muscles, the technique appears to eventually "reconnect" the brain and the muscles.

Patients can then command the muscle movement even without the electrical triggers.. *AFP*

## Woman elected head of Ethiopia's top court

Prominent Ethiopian human rights lawyer Meaza Ashenafi has been elected as the first woman to head the country's federal supreme court.

Her name was put forward by Prime Minister Abiy Ahmed and MPs unanimously approved the appointment.

It's the latest in a series of appointments in Ethiopia that has seen the promotion of women to top jobs.

Last week, Sahle-Work Zewde became the country's first president - a ceremonial position. The week before, Prime Minister Abiy appointed a cabinet with half the posts taken up by women.

Ms Meaza founded the Ethiopian Women's Lawyers Association in

1995. Before that she was a judge at the high court and helped advise the team drawing up the new constitution in the early 1990s.

She has also worked at the UN Economic Commission for Africa and helped develop the country's first bank for women, state-affiliated Fana Broadcasting



Netflix Inc will debut three of its upcoming theaters on Dec. 14. original films in a limited number of theaters | At the end of September, Netflix had 137 million | group, said in a statement. before the movies appear on the streaming service, the company said on Wednesday.

The move for "Roma," "Bird Box" and "The Ballad of Buster Scruggs" is a change from the company's traditional practice of releasing movies in theaters and on Netflix on the same day.

### 'Mummy' film poster, expected to fetch record, fails to sell at auction

A rare, original poster from the Boris Karloff horror classic "The Mummy" that was predicted to set a record price for a film poster at auction went unsold on Wednesday when no one bid the \$950,000 minimum in the online sale.

Sotheby's had predicted that the work, one of only three known surviving examples of the original lithographic poster from the 1932 film, would fetch up to \$1.5 million.

"Unfortunately, the work did not find a buyer in our online auction that concluded today, but that does not in any way detract from its importance," Sotheby's said in a statement.

The auction house described the piece as "one of the rarest and most celebrated film posters in existence, and a seminal example of the graphic design pioneered by Hollywood studios during their 'Golden Age of Horror.'"

The poster set a record more than 20 years ago when it fetched \$453,500, a price exceeded last year when a poster from "Dracula," the 1931 horror film starring Karloff rival Bela Lugosi, sold for \$525,800 at auction. *REUTERS*

She has continued to back DAA, including funding for that school's permanent site on West Outer Drive. She also gave teachers 50 front-row

Detroit Prep serves students from kindergarten to third grade, with plans to expand to eighth grade. Like DAA, the school follows the Expeditionary Learning model, which emphasizes principles such as self-discovery, collaboration and

diversity.

Detroit Prep, co-founded by DAA's Kyle Smitley, purchased the abandoned Joyce Elementary School this summer. It has launched a \$2 million capital campaign to rehabilitate the three-story, 44,000-square-foot facility, which has sat unused for about a decade. *USATODAY* 

## Oprah to shine star power on Democrat Abrams in Georgia governor's race

Oprah Winfrey is lending her star power on Thursday to Georgia Democrat Stacey Abrams, who is vying to become the first female black governor in the United States.

A representative for Winfrey, 64, declined to comment further on Wednesday.

Winfrey endorsed Democrat Barack Obama before his 2008 White House run, and campaigned for the two-term president.

The contentious gubernatorial race between Abrams, a former leader in the state House of Representatives, and

her Republican opponent, Georgia Secretary of State Brian Kemp, has been marred by accusations of voter suppression. Last month, former voting rights advocacy groups sued Kemp, whose role makes him Georgia's top election official, accusing the Republican of placing voter registrations on hold to boost his campaign.

Former U.S. President and Georgia Governor Jimmy Carter asked Kemp to resign his position as Georgia's secretary of state, saying his role in state government imperilled popular confidence in the election. *REUTERS*

The petition, initiated by La Liga North America, reads: "Imagine watching Luis Suarez, Philippe Coutinho, Cristhian Stuani, Portu, and others competing right here at home. A real league match, with points on the line...There's only one problem.

"Some of the key decision makers are falsely claiming it won't be good for the game in the US. So we, the fans, need to fight for this match by telling them: It's good for the fans. It's good for the game.

"Are you in? The more support we have, the harder we'll be to ignore."

The targeted fixture is scheduled as a home game for Girona at their Estadi Montilivi, where theoretically they would hold a greater advantage.

Fans have been offered a compensation package, including free flights to the match, but even one game abroad would arguably disturb the balance and integrity of the competition. RFEF president Luis Rubiales has been vocal in his opposition to the idea while the Spanish players' association (AFE) has maintained players will have the final say.

La Liga must be granted permission by the RFEF and US Soccer Federation, as well as UEFA and CONCACAF, the governing bodies in charge of European and North American football respectively.

FIFA's approval is not mandatory but its president Gianni Infantino said last week that world football's governing body would forbid the proposal.

"FIFA will not authorise the playing of a match either in the United States or in any other location that isn't the stadium of Girona," Infantino said.

"As FIFA president, I announce that the organisation is against La

Liga's idea and will forbid Girona-Barca to be held in the United States or any other country that isn't Spain." *AFP*

### Nadal pulls out of Paris, Djokovic takes world number one spot

Rafael Nadal pulled out of the Paris Masters on Wednesday guaranteeing Novak Djokovic's return to the world number one spot. Announcing his withdrawal at a hastily arranged press conference Nadal said: "My abdominal muscles haven't felt good for the past few days, especially on serve, doctors recommended that I didn't play.'

Djokovic arrived in Paris knowing that he would regain the top spot he relinquished two years ago if he bettered the Spaniard's performance at the indoor event he has won four times.

The Wimbledon and US Open champion becomes the first player to start the season outside the top 20 and end up top of the ATP rankings since Marat Safin in 2000.

The 14-time Grand Slam champion had begun his pursuit of the top spot in encouraging fashion with a 7-5, 6-1 defeat of Joao Sousa on Tuesday, his 19th consecutive win.

For Nadal it means delaying his long awaited comeback from injury which has kept him sidelined since the US Open.

Nadal was forced to withdraw from his US Open semi-final against Juan Martin del Potro in early September with a knee injury.

The problem also sidelined him for Spain's Davis Cup semi-final against France, and also from tournaments in Beijing and Shanghai.

"It's been a difficult year for me in terms of injuries, and so I'd prefer to avoid doing anything drastic," he told the media minutes before his intended match against compatriot Fernando Verdasco who instead faced -- and lost to -- Tunisian lucky loser Malek Jaziri.

"It wouldn't have been good for me nor anyone to return to the court knowing that I wouldn't be able to play my best

During his enforced time out Nadal joined in the clean-up operation after flash floods killed 12 people on the Spanish holiday island of Majorca where he lives

After Paris the ATP tour's eight top-ranked players congregate in London from November 11 for the season's Finals.

The 32-year-old Nadal has enjoyed a successful year, clinching his 17th Grand Slam title by winning an 11th French Open in June, after triumphs in Monte Carlo, Barcelona and Rome. *AFP*
