
Ndola - Kitwe Toll Plaza an insult to Sata, says Kambwili

NDC consultant Chishimba Kambwili says it is an insult to name a toll plaza after late President Michael Sata because the man never wanted citizens to be subjected to so many levies.

And Kambwili says it is not possible that the newlycommissioned Kitwe-Ndola toll plaza would cost US\$4.3 million instead of about K7 million.

By Sipilisiwe Ncube General Education Minister David Mabumba has advised Kafue parents, whose children had missing Religious Education results on their GCE transcripts, to complain to ECZ.

Last week, the parents complained that their children's results were marked 'mal-practice case' and that efforts to rectify the problem with school managements had proved futile.

"The problem was that the school discovered that almost everyone who wrote RE, no one has received the results! The [statement of results] were just written 'mal-practice case' now we don't know, almost everyone who wrote RE. In Kafue, there are about three schools and at Nangogwe,

Kafue Day and another one in Chiyawa; and we were there on Monday although we were told that we should give chance to the school so that they can know what to do and maybe try to follow up [the matter]," the parents said.

But when contacted, Mabumba said it could be possible that Kafue district was part of the over 500 GCE mal-practice cases that were recorded.

"What I am only aware is that there were 500 plus mal-practice cases that were recorded around GCE exams. So maybe that could be one of them [and] maybe that is why they (results) have shown like that. The only thing which parents should encourage their children is to go to the Examination Council of Zambia so that they are given the details of the levels of mal-practice. But you know when I read the statement is this number in terms of percentage and so forth. But maybe since I have spoken to you and if you have an opportunity to speak to them, they need to understand other than just being given a statement which is saying 'mal-practice', they need to go and say 'what sort of mal-practice was this?" Mabumba asked.

He advised the affected parents to follow-up the matter with the Examination Council of Zambia.

"If I were them as parents I think nothing stops them from going to the centre to inquire because you see exams are written on an individual basis. And therefore if you have got a son or a daughter whose



results will be showing mal-practice, what I am supposed to do as a parent

is to go to the Examination Council of Zambia and establish the level of those mal-practices. And I am sure the Examination Council of Zambia will be generous enough to tell those particular parents the level of mal-practice. What type of mal-practice was it? Was the candidate found to have leakage when writing exams? Or was a candidate caught with a leaked paper? Unfortunately I don't have the statement with me now but they were about 500 plus cases that were reported when I issued the statement on the GCE. Then of course if we have a report like that, it could be that Kafue was part of that," said Mabumba.

Ş4.3m Kitwe-Ndola toll plaza an insult to Sata - CK

And Kambwili says it is not possible that the newlycommissioned Kitwe-Ndola toll plaza would cost US\$4.3 million instead of about K7 million.

On Sunday, President Edgar Lungu commissioned the Kitwe-Ndola toll plaza saying the newly-built facilities were not meant to over-burden road users, but to create a sustainable goal. "It is not done to overburden the road users, but to create a sustainable goal. It is a global norm of financing and maintenance of road Infrastructure. So, when you hear these, just ignore and join the development agenda of this government. If we run short of money we shall responsibly borrow to improve the lives of the country. I must make it clear that, there is no country that does not borrow. When you borrow, we borrow to use and not to eat! We are not ashamed to say that," said President Lungu.

"US \$4.3 million has been spent on this project. This project, which has been named after the founding father of the PF, our father, could not come at a great time after we put to rest our mother (mama Kankasa). It is our prayer that his legacy can be protected and grown. I am saying this because there are people saying that,

'Lungu has lost Mr Sata's vision, no Lungu this, Lungu that.' If we carry on the vision of Mr Sata and someone says, 'we have forgotten,' then we say, 'tawaliko iwe!' (you were not there), you don't know what Mr Sata stood for." But in a statement, Kambwili argued that the toll plaza in question was an insult to the late Head of State because he never stood for more taxes to burden the poor citizenry. "It is irregular for the PF government to come and name the Ndola-Kitwe toll gate as 'Michael Chilufya Sata toll gate? President Michael Sata was against too much taxes [but] today, there is going to be more than six toll-gates from Lusaka to Chililabombwe, meaning, therefore, [that] if somebody is travelling from Lusaka to Chililabombwe, he has to have K260 for toll gates only as a levy! I don't think president Michael Sata wanted to subject the Zambian people to that kind of levies. And it would be wrong for him to be associated with these taxes that are being unfair on the general citizenry more, especially the poor. To travel from Luanshva to Ndola. one would need K40 per day and you know that Luanshya has got no jobs, and most of the people in Luanshya now, are working in Ndola. All the wholesalers are in Ndola meaning, therefore, [that] the cost of doing business in Luanshya is going to go up by the installation of this toll plaza," Kambwili cautioned. He argued that the facility

looked too simple to cost as

high as US\$4.3 million. "And surely, there are too many things that the President can do other than coming to officially open a toll gate, which is going to be unfair to the general citizenry. This is what we call proper 'Chipante-pante.' And I want to challenge the government to tell us what has made this toll gate cost US \$4.3 million? I think Zambians are being taken for a ride! There is no way that toll plaza can cost US \$4.3 million. This is corruption of the worst kind! If you look at the FRA sheds that were built all over Zambia, those sheds cost K5 million. We erected those sheds under Michael Sata. Go and look at [the] computation of that shed and go and look at the simplicity in that toll gate, you will see that this government is a thieving government! They have stolen the money, and let's call for a forensic audit to find out what material was used for that toll plaza to cost US \$4.3 million. This is daylight robbery against the people of Zambia," charged Kambwili. "That toll gate, to be fair, can

only cost K6 million to K7 million. Look at the Michael Sata Hospital in Mpika and all these other hospitals, do you know the cost? It's K12 million. Where is US \$4.3 million on that toll plaza? With only one permanent building [which is] the office block. But I challenge them on a serious note to tell us where the US \$4.3 million has been spent on that toll plaza? And Lungu should have some shame when stealing. And all the infrastructure that is built on deals, he is always the one coming to commission them. Why? If the President is going to be officiating at the commission of a toll plaza, what are the ministers going to be doing? It's because the man is not busy. He just wants to come and see that 'here we have stolen and it has been delivered and now we have to get our commission."

Millennials need to adopt spirit of sacrifice - Vernon

Veteran politician Vernon Johnson Mwaanga has stressed the need to rekindle the spirit of hard work, selflessness and sacrifice in the millennials as espoused by Zambia's founding fathers.

Reflecting on Mama Chibesa Kankasa's life, Mwaanga observed that young people were too preoccupied with self aggrandisement. He told News Diggers in an interview that millennials had failed to emulate the spirit of selflessness, sacrifice and hard work which made it possible to defeat colonialism.

"In many of our neighbouring countries and elsewhere, they have found ways of looking after those who fought for their independence and sacrificed so much. Why has this not been done in Zambia? Our young people are much too preoccupied with self aggrandisement; me, myself and I. The levels of commitment and sacrifice which was the hallmark of a great many of our freedom fighters is no longer being emulated by this new generation. Surely, there must be a way of rekindling that spirit of hard work, selflessness and sacrifice, which made it possible to defeat colonialism," VJ said.

He regretted that majority of the freedom fighters died desperately poor because of governments failure to look after them.

"Our generation of freedom fighters has slowly but surely been disappearing as they are called to be with their creator. Sadly, the young generation has no idea of the selfless sacrifices they made, and the risk they took for Zambia to be free from the yoke of colonialism. Very little has been written by historians about that era. Many of them have gone to their graves desperately poor, apart from those who have been looked after by their families and friends," said Mwaanga.

Lukasha independent MP explains why he has 'gone PF'

Lukasha Independent parliament member of Munkonge says Mwenya some of the developments that his area has gotten are as a result of him being pro-PF. Speaking when he featured on the People's Debate programme on Pan-African Radio, Monday, Munkonge said he decided to be a pro-PF MP in order to take the much needed development to his people.

"I have had benefits coming through being a pro- PF MP. Only yesterday, we were in Kasama during some ground breaking work with the Minister of Health and we were doing ground breaking for two mini-hospitals in my constituency in Munkonge area and in Chiba area. And clearly, I cannot lie to myself because some of these benefits I am getting is from the result of being pro-PF," Munkonge said.

"I know that it's not an official position of government to only help pro-PF, in fact some of the things we get shocked like we are still working on our health posts, health centres and we find that in some areas which are held by the opposition, they have already gotten their health centres, but we then don't fight based on political patronage. We fight the fight of the need for some of these services and it's a cry of every MP regardless of whether opposition or [ruling]. Your task as MP is to try and bring as much development into your area. And my personal decision was to say 'look, how do I help my people? And therefore I have made a deliberate decision that I should be pro-PF because even some of their developmental agendas which I have listened to, appeal to me."

And Munkonge said it was time for Zambia to stop

relying on foreign aid. "I would like to think [that] sometime in the future, we should do away with foreign aid. We should be able to sustain ourselves. We cannot live the life of a beggar. That's like saying 'no, I will be begging until I die, no.' Foreign aid has got its pros and cons and if we use it properly, it should be used to plan for a future where we don't need it. Yes foreign aid is needed now but we should be strategising to do away with it. We can justify borrowing for activities that are profitable. Borrow if you are going to have an activity that will enable you to pay back what you have borrowed and remain with a profit at the end of the day, 'go ahead [and] borrow.' But for a country we must be talking about in the future, building up reserves that will protect your exchange rate, building up developments that will reduce your need on foreign aid," Munkonge said.

Meanwhile, Munkonge said only a minority were involved in theft of public resources.

"I think we have to understand [that] a thief is a thief, he will not be targeting whether it's a shirt worn by Seizer (host) or a shirt worn...if he has seen an opportunity to steal, he will steal. So even trying to link it (corruption) to donor funding, generally if a person will be stealing, they will be stealing from the government, they will be stealing from donor funding. They will steal because they are thieves. The fight we have is in trying to upgrade the system to make it less so that it's not easily manipulated by these sorts of individuals. And they are in the minority. The majority of us would not want to steal. But you see, it doesn't need the majority to make a bad smell that affects the majority," said Munkonge.

Regular tariff changes is because of fluctuating production cost - Zesco

Zesco has dispelled claims by the Zambia Chamber of Commerce suggesting that the utility company is not transparent in the setting of electricity tariffs.

Last week, ZCM president Nathan Chishimba addressed journalists at a CEC organised workshop where he alleged that Zesco lacked transparency in the way it formulated tariffs and and warned that this was scaring away investors.

"There is a complete lack of transparency about tariffs in Zambia. It's basically a black horse, we don't know how tariffs are arrived at. They will just tell you 'you will pay 10.3 cents', they will even convince politicians that 'we need 10.3 cents to survive' and that's what you will be charged. We don't have a formal basis for which we can determine that electricity actually does cost 10.3 cents. Zesco will just announce a number and all the politicians will be singing that number without verifying whether it's an objective number or if it conforms to global standards and that is what our problem is, said Chishimba. But reacting to Chishimba's remarks

But reacting to Chishimba's remarks in an interview, Zesco Spokesperson Henry Kapata said Chishimba's accusations were not true.

"The first thing is that we do what is call cost and income model. Our tariff setting is based on what we envisage our cost to be over time and then that's what drives what we call a pricing model. So Zesco will assess the projects that it needs to engage in for us to deliver a certain service and all those costs are compiled and then we make an application to ERB. Now, the application to ERB looks at three things. It's a simple formula that determines tariffs, it's required revenue, then it also takes into account a return on asset. A return on asset that is determined by the regulator. If fact, it's called RR; Required Revenue. So Required Revenue is equal to allowable cost plus a return on asset. But the return is determined by the regulator and the allowable cost are also determined by the regulator. So there are certain costs that the regulator does not allow us to pass

on to consumers," Kapata said.

"And when people speak about [lack of] transparency, that's not true. Because when Zesco makes an application to the ERB, before the ERB could approve the tariff which should be implemented, it goes through a series of hearings with Zesco. So it invites several people from everywhere and Zesco stakeholders and we go round the country as Zesco sensitizing people, holding meetings and they ask questions, and we answer them, we justify our core structure in the hearing and on that basis then ERB makes a decision. So transparency is there when it comes to tariff setting, it's not a unilateral decision."

Kapata explained that Zesco was regularly adjusting tariffs because cost of producing electricity was changing everyday, depending on the economic indicators.

"As Zesco, we don't just jump from a Mango tree and start increasing prices. There is a process involved. And collectively after the hearings, ERB picks up everything and issues a statement. So let's take that approach than attacking one another as institutions. Yes they have the right to say what they said but Zesco's position is what we have explained. We try by all means to engage the people so that they understand why we have to do this. We cite a lot of things like operational cost. For example in 2016, Zesco's operation cost was somewhere around K2.4 billion and were at the same level buying electricity at 15 ngwee per kilo watt hour. So can we survive just a small company? We would fall," said Kapata.

"So we try to explain the cost of a raw material and production. When we explain those things, people will be understand that this is the reason why we write to ERB for tariff adjustment. A transformer that was bought four years ago at K40 thousand, today 2018, do you expect that machine to be at the same price? Not at all! If anything this should be an annual thing, every year we should be able to put something, because the cost of production changes depending on economic indicators."

HH should have walked over to Lungu for a handshake at church - Dr Chanda

Bv Mirriam Chabala Bwana Mkubwa PF member of parliament Dr Jonas Chanda says President Edgar Lungu cannot always look out to greet Hakainde Hichilema whenever they are in the same vicinity because he has protocols to follow.

And Dr Chanda has cautioned Zambian voters not to allow people like vice-president UPND Geoffrey Bwalya Mwamba anywhere near the echelons of power, saying the former Defense Minister's allegations against people from Eastern and Luapula Provinces whom he branded as thieves, disqualifies him for national leadership.

Speaking when he featured on UNZA Radio's Lusaka Star programme, Monday, Dr Chanda asked UPND leader Hakainde Hichilema to stop overrating his worth. "The President is the President, so if Mr HH really wants to greet President Lungu, does he expect the President to leave all the protocols and the security to start looking for HH in the Church somewhere? It can't happen! Why can't HH walk to the President? We only

have one President in the country, just in case people don't know. There can only be one President, and like President Sata used to say 'on a toilet seat there's only one person who sits there at a given time'. So leave the President to govern and recognise him. It is these same people who don't recognise the President who expect to be greeted by him. But why not walk over to the president? You think the President will say no to a greeting?" Dr Chanda asked when a caller wondered why the two rivals did not greet each other at Mama Chibesakunda Kankasa's requiem mass.

"And I remember at St Ignatius about two years ago during President Sata's memorial, we saw pictures of President Lungu greeting HH. So these are the petty politics we are talking about of who didn't greet who. Let us measure ourselves according to our true worth. The President greets everyone, including the cadres and all of us. But if you think you are more important than the president and that he has to look for you [to greet you], those are delusions of granger, you are deceiving yourself."

Dr Chanda also wondered why the UPND had started to love late President Michael Sata so much after his death.

"It surprises me that UPND now is praising late President Michael Sata. When President Sata was alive, who insulted him the most? It's the same people, they called him a dictator and insulted him to the grave. Now today the same stones that they threw at President Sata, they are putting now on his tombstone, they are the Chief mourners today. But President Sata is not hearing your praises, he should have heard them when he was alive. That is why some of us who worked with him closely appreciated him when he was still alive. So don't try make him a saint now or show that you love him more than us. We don't want that kind of hypocrisy," he said. Meanwhile, Dr Chanda

warned that GBM would divide the country if his party was given a mandate to run Zambia one day. "I don't know if Mr GBM has done a scientific analysis. But what he said is an example of irresponsibility because once you start dividing people by tribe, then you are just dividing the country. Corruption knows no race, it knows no colour, it knows no tribe. Yes there may be a few bad elements in Eastern and Luapula Provinces but there is nothing like collective guilty. If 100,000 Naziz kill 600 Jews, ou cannot say 'all Germans are devils'. There are good Germans and there are also bad ones called Naziz. So I don't believe in that kind

of generalisation because if one Bemba does something wrong you cannot blame all the Bembas or if one Tonga person does something then you say 'all Tongas are like that'. So that collective guilty is irresponsibility of the highest order and we don't expect that careless talk from a national leader like GBM or any other national leaders by the way," he said "If Mr GBM and his party are aspiring the rule the country one day but already insulting the people of Eastern and Luapula then how are they going to govern? What are they going to tell them? I think he owes the people of Eastern and Luapula apology. He can provide evidence if he has the people from Eastern or Luapula or anywhere who are corrupt, he can take the evidence to ACC or wherever he has to take it. But to insult all the Easterners and those from Luapula is mark that he (GBM) is already disqualified for national leadership. He is coming to divide the country with

we should not allow such leaders near the echelons of power because they will come and destroy the country."

Meanwhile, Dr Chanda asked Mazabuka member of parliament Gary Nkombo and his Kafue counterpart Mirriam Chonya to openly say what they think about the Kafue – Mazabuka road, now that government has started working on it.

Even honourable Mwiimbu used to say that 'we the people of Southern province feel segregated'. But the PF doesn't segregate. We look at the country as one, we are not dividing the people at

Climate Change will affect water quality, quantity - NWASCO

National Water Supply and Sanitation Council (NWASCO) director Kelvin Chitumbo says climate change is likely to severely impact the quality and quantity of water.

Chitumbo said this in a statement issued issued by his Public Relations and Communications Manager Mpunga Simukwai to highlight the rising impacts of climate change and climate variability that has affected the country and the region. Chitumbo said NWASCO had developed a Climate Risks Screening (CRS) Guideline for the Water Supply and Sanitation Sub-Sector.

He said climate change would eventually lead to adverse impacts on the economic and social wellbeing of the communities if adaptive measures were not put in place.

He added that the CRS guideline would provide the framework on systematic steps which practitioners

could take to identify climate hazards and extenuating measures as they designed and implemented water service projects.

Speaking when he held talks with the contractor at Dag Hammarskjöld area, off the Ndola - Kitwe dual carriageway yesterday, President Lungu said it would be wise if local contractors were empowered with skills which they could use even after the end the project.

"We would like get the skills that are necessary for maintaining the Airport after completion passed on our people because we won't have to come to China everyday when we have a problem. So in this respect, we expect that you cooperate with the ministry, the technical staff from the National Council

of Construction. Make sure that Zambians are brought on board to work under the 20 per cent contract policy. We don't think [that] you can only give them drainage jobs or wall fence construction. We know they don't have the skills, [but] supervise them closely so that by the end of the project, they will be able to utilize those skills and turn them into their own and be able to utilize them in our industries," President Lungu said.

"I am saying this because you may be worried that they don't have the competence, they don't have experience. But if they don't have experience and the competence, then what can you do? Can't you give it to them? So you have to make sure that you collaborate closely with our local contractors. Whether they are not competent, work with them and see to it that the work which comes out is up to the standard which you promised us. We will not take it if you come and tell us 'this project has failed because of the 20 per cent' because the 20 per cent is the one we have made for ourselves and we have agreed. So work with them, give them the skills. All defects should be cured on your side to ensure that the blame games to say 'no it's because of the 20 per cent that we are doing shoddy works. I believe that want to be ambassadors after this project we will talk to other African countries about the quality of the works that you are able to do. So we don't have now to compromise on the quality of works that you will be undertaking in the name of the 20 per cent, we will not take that."

The President also demanded that the contractor looks into the working conditions of service for locals, who were usually being exploited.

"I am being told that the workers are being ill-treated, they don't have protective wear and that they are below standard wages. They have seen me and they expect me to talk to you about their welfare and about everything else that goes with staff issues and motivation to do the job. We don't want sabotage on account of being disgruntled. So the whole reason of us being here was simply to have an appreciation of where we are ... we will be talking to banks involved in China to give the remaining monies as soon as possible that we continue without any disruptions on account of the China Exim Bank not giving you the money," said President Lungu.

So the impression I have is that we are on the ball and like I said, we don't want to continue listening to noise from outside. This is what we want, agriculture, tourism development, manufacturing... we promise the people of Zambia a lot and we are grateful that our partners, whether Chinese or American or Europeans, they are all doing what they've told us," said President Lungu.

the contractor's And representative, who disclosed that about 800 workers so far had been engaged to carry out various types of works, promised President Lungu that the local contractors would be empowered with skills.

"We are ready, and we promise you that. We are ready to sub contract 15 per cent people to do \$6 million works to the local sub contractors and material suppliers. With the remaining period of construction, we will have ideas of how many more local contractors we need. We have awarded three local contractors who are working at the site. Total sub contracting works will reach \$4.5 million this year," said the representative.

Amos Chanda orders police to storm radio stations to stop provocative programmes what it was," he said.

By Mukosha Funga Special Assistant to the President for Press and Public Relations Amos Chanda says police must start being proactive by storming radio stations to stop provocative interviews which he says have started incite xenophobic attacks in Zambia.

Last week, Lufwanyama police fought running battles with ZAFFICO workers following reports that the institution had been sold to the Chinese. And when President Edgar Lungu arrived in the province for the two-day working visit, Sunday, provincial minister Japhen Mwakalombe told him that UPND leader Hakainde Hichilema had told lies that ZAFFICO had been sold to the Chinese when he featured on Sun FM radio earlier last week.

But the Head of State said he would ignore such detractors. However, Kitwe's Kawama, Chimwemwe, Buchi and Kwacha residents yesterday joined in a riot ignited by saw millers demanding that government tells the truth regarding the alleged sale of ZAFFICO to the Chinese.

Residents denounced government through antiregime slogans, expressing displeasure on the Chinese influence as they burnt tyres and blocked roads.

They charged that since 2016, government had been making wrong decisions which had affected their livelihoods.

Some residents were badly injured during the crash with anti-riot police, in protests that lasted over an hour.

And speaking to journalists after President Lungu concluded his visit, Chanda

ordered police to start stopping provocative radio programmes featuring government critics.

'There is an outbreak of malice and propaganda which is resulting in near incidents of xenophobic reactions among the population...when you politic in a manner where you incite people, that ceases to be politics but criminal activities. There is a failure of common sense. You can't anticipate that someone is going to lie that this one is a criminal. So I can't wake up in the morning and say Bwali is not a criminal, then you say I am proactive. So the listing of ZAFFICO was actually announced proactively by the President last year, but someone has turned it in a xenophobic manner to target a certain nationality. That's why we are saying that we can't apply pressure on the police but I think they have the responsibility, when there is a real threat to the breakdown of social order, we must be telling the

police to be proactive. If they must go to a radio station to stop a propagandist who is inciting xenophobia, it is not a violation of media freedom, police must go into the studio and stop that nonsense because if they don't, it will turn out in riots and probably loss of life. So maybe that's the proactivity [that we can have]. Maybe the state, at the level of the police, must be more proactive and stop messages of incitement that are resulting in these unnecessary tensions," Chanda said.

He said Ministers must not get tired explaining the ZAFFICO decision even if people don't understand.

"Somebody says you can't wash a pig. If you wash a pig and think that it will remain clean, you are mistaken, it will go back in the mud. The least you can do is emphasis, maybe I take this opportunity to announce here that ministers are under instructions, particularly Honorable Chitotela, Honorable Mwanakatwe, to issue ministerial statements on these matters. Particularly on ZAFFICO, maybe we should be talking about these things every morning. If this is what it will take, we will, there is a public broadcaster. We can make ZAFFICO a national anthem if you please...even IDC will issue a statement." He also urged journalists to curtail their interviewees if

they became provocative. "If you are interviewing someone on Radio and they go that far, you stop them, because there is a public responsibility, a higher call to duty by the media is to stop this information from going out. It is not just because I have a mouth I can say it, just because I have a hand to punch I can, no! They were supposed to stop that irresponsible leader, whoever it was who gave that statement and tell them, there was a public statement and this is

Govt owes K5.2bn to people who won cases against it – Lubinda

Justice Minister Given Lubinda says government owes K5.2 billion to individuals and institutions that won court cases against it.

And Lubinda says of the K5.2 billion, only K200 million has been provided for in the 2019 budget.

Speaking in Parliament Friday when he contributed to the debate on his ministry's budget for next year, Lubinda also warned that any public officer who aids or causes government to lose revenue shall be brought to book.

"I regret to inform you, the House and the nation that a total of K5,241,878,000.89 is owed to individuals and institutions who won cases against government. [That] is what the compensation and awards fund is owing individuals and institutions who won court cases against government. Of this amount, K200 million has been provided in the 2019

budget. The ministry and government generally is deeply concerned with the escalation and the huge amounts the government has to pay towards the compensation and awards fund as this is crowding out funding to other even more important government programmes," Lubinda said.

Lubinda said his ministry had issued a memo to all ministries, provinces and other government spending agencies to submit debts owed by government.


"The Ministry of Justice will streamline and strengthen its debt collection unit to enhance efficiency and effectiveness. As part of this process, the ministry has issued a circular through cabinet office requesting all ministries, provinces and other spending agencies to submit debts owed to government. This will be enhanced by recruitment of more specialised state advocates to assist in debt collection," he said.

He warned that any public officer who aided or caused government to lose money would be brought to book.

"To address this challenge, the ministry will continue to engage the treasury to facilitate recruitment and retention of state advocates for placement in ministries, provinces and other spending agencies to ensure that timely provision of legal advice to government, and particularly to ministry of justice. Government is implementing the Public Finance Management Act 01of 2018 which has strengthened accountability, oversight, management and control of public funds in the Public Finance Management Framework. As the house is aware, that piece of legislation puts responsibility on any public officers who aids and causes government to lose revenue. And going forward we shall ensure that such public officers are brought to the book," warned Lubinda.

Zambia's Mounting Debt, UPND's Concerns

By Situmbeko Musokotwane "Speak up for those who cannot speak for themselves, for the rights of all who are destitute. Speak up and judge fairly; defend the rights of the poor and needy" – Proverbs 31:8-9 We can all clearly see that the debt situation is very bad and getting worse every day. The debt burden is truly becoming heavy on most of us ordinary Zambians. According to the experts, public debt has reached 60% of GDP, putting the country at high risk of debt distress, which simply means that we will soon fail to meet our obligations.

As a result of this mounting debt, between January and September 2018, interest payments on debt were 125% of the three quarters' budget; this was 25% over-budget. In contrast, social programmes like Pension Fund and Social Cash Transfer received only 56% and 36%, respectively, while Food Security Pack for poor families and women and youth Empowerment Funds received nothing (0%). Some PF commentators will claim that this poor prioritization was because "the opposition infiltrated the public systems". We must not be fooled or detracted by such ridiculous propaganda when the statistical facts about the failed economic management are laid bare for all to see. They will claim that UPND is against investment in infrastructure. What we are against is to disguise corruption in unplanned infrastructure development projects. Why should our roads cost more than three times to construct than the regional average? Why should our fire engines cost a million dollars when international reference prices are about a quarter of that? Why should the Lusaka Ndola Dual carriage cost billions of dollars? What is the motivation of undertaking these projects? Judging from the Auditor General's 2017 Report, we are inclined to think they are conduits to steal public funds. This is what the UPND and the Zambian people are against. Countrymen and women, we believe that with the right leadership and political will, Zambia can do many things differently to remedy the situation.Here are two things, for example, that

together we can do.

Stop the excessive borrowing: In 2017, the Government developed the Economic Stabilization and Growth Programme (ESGP) and convinced us of their seriousness to tackle the economic crises. The Government assured us that it would undertake fiscal consolidation measures to reduce the Government deficit and accumulation of debt stock by (a) reducing overall expenditure from 27.7% of GDP in 2017 to 22.8% in 2019, and (b) reducing fiscal deficit from 7% of GDP in 2017 to 4.1% by 2019.

What has happened? Fiscal deficit in 2018 will be larger at 7.4% of GDP and not 5.1% of GDP as per the ESGP. In the 2019 Budget, deficit is increasing to ZMW28.8 billion (9.6% of GDP) against the ESGP target of ZMW 16.6 billion (4.1% of GDP).

While we are not surprised – for after all, this was the policy meaning behind "dununa reverse" - we are rightly worried that this will further weaken our fiscal and debt positions. It will affect our ability to attract the much needed investment that creates jobs for our youths that are graduating and roaming the streets without jobs. It compromises our real investment efforts, not the PF type investment strategy which aims to line their pockets through malpractices in procurements. It compromises poverty reduction efforts and scares away investors and cooperating partners as we have seen in the education and social cash transfer, where even the money meant for the poor has been abused, and the cooperating partners have frozen their support. And yet the PF are always singing and championing that they are a party for the poor! Fellow Zambians, we cannot borrow our way out of debt; we must simply find the political will to apply prudent fiscal policies that stem further debt accrual. Thus, we should simply go back to ESGP and stop playing "chidunune" and "chipante-pante" with our economy. Let us demand our MPs to ask the Government to go back to the fiscal consolidation Plan in the ESGP and develop a new fiscal framework

that represents a more ambitious fiscal consolidation effort for the medium term. Share decision-making responsibilities honestly and fairly: Article 114 of the Zambian Constitution (2016) provides for the National Assembly to approve all loans and guarantees to be contracted by the State. This means the Executive has a constitutional obligation to have all loans and guarantees approved by Parliament. We need to start implementing this legal prescription so as to establish the right checks and balances in debt contraction. We need the Planning and Budget Act, the amendments to the Procurement Act and the Loans and Guarantees (Authorization) Act that ensure more transparency and oversight in the management of public resources. This is what the ESGP promised in 2017 and this is what we should do.

We are now entering 2019 and the above pieces of legislation have not yet been presented to Parliament. What other reasons would one think of apart from the PF's fear that this will expose them in their corruption? Are the delays meant to give space to the Executive to secretly and unilaterally negotiate and finalize unplanned and unbudgeted debt deals with China, Turkey and others without parliamentary oversight? Is this not immoral, illegal and unfair to the Zambian people? Can't we, as Zambians, hold the Government accountable and demand that the PF simply does the right thing for once and petition our MPs to ensure these laws are tabled in Parliament this year?

We want to assure Zambians, that we are available and ready to join forces with every like-minded countryman and woman, to demand, for and on behalf of the Zambian people, credible, accountable and dedicated policy leadership that will take us out of the current economic mess; respect and account for public funds; and bring us back on track to realizing our long term vision, the Vision 2030.

Establishing rate of return - Cash flow

I have met many people who are willing to commit huge sums of money just to meet their business dreams. Unfortunately, many lack the means of computing the real return for the investment they are making. Someone somewhere may have told them that a given business runs very fast. And just for this, they will borrow money from a bank or other source. A few years along the line, the business fails. There are generally two types of businesses we are familiar with. There are those that start informally. Others start formally with proper processes of project evaluation.

If you are in a hurry to succeed, please, ignore the formal approach. But if your value is to start a business that gives you profits, you will need to consult a professional to work out the business plan. The key element of the business plan is investment evaluation that focuses not only on net present values but the quality of cash flows that will support the business. The term 'net present value' is generally used by accountants but it is really associated with entrepreneurs. It will be defined a little later but it is important to know that anyone who goes into any kind of business will

Responding to Chiengi FDD member of parliament Given Katuta who wanted to know during the Vice-President's questioned time, Friday, why government

have to know, before hand, whether what is projected to be earned over a period of time makes business sense when all the costs to be incurred are taken account of today. The key factor that helps an entrepreneur decide whether or not the business makes sense before it even starts is the issue of cash flow; or money you expect to earn and spend during the course of the business. All this has to be done on paper before you make a final decision as to whether or not to go into the business. Cash flow can be looked at as the lifeblood of any business. The business should, therefore, generate more money, than what is anticipated to go out of the business. You need to capture the relevant cash flow and then adjust them for tax, interest payments and inflation. This is because as your business earns money, part of that money will have lost value due to devaluation, inflation and interest payments. An entrepreneur should be able to work out these costs, and then sit down to count the real value of the business, if you were to start it. If you do this part well, you will be able to ascertain prospects well before you commit your money. It is then you will assess whether or not to proceed with the idea altogether.

Most investors do not do this because they fear to lose time. Others believe evaluations are unrealistic and irrelevant to the business. As a result, they commit huge sums of money and only realize years later that they are actually not earning as much as they had thought because they did not take account of some factors that would reduce the value of the earnings. Had they known things would come out that way, they would have not gone ahead to invest; or perhaps, been a little bit cautious about the prospects.

One gentleman went into the business with a great expectation that he would earn more than a 100 percent return after three years. But when the internal rate of return or the net real earnings of the business was calculated by his business colleagues, they found that the cash flow he anticipated would only give him a four percent return after three years. The opportunity cost in this case was that going ahead with the project at four percent would cost him the advantage of earning over 30 percent in the stock market. Wina claims all Permanent Secretaries are well qualified

had not extended the verification of qualifications to Permanent Secretaries, Friday, Wina claimed all PSs were trained and had requisite qualifications.

She however challenged Katuta to take information regarding PS's without qualifications to the Secretary to the Cabinet.

"A Permanent Secretary in any ministry is at the apex of the governance system. Before PSs are appointed, they are scrutinised by the various security wings of government and their qualifications are ascertained at that time. As for the honourable member for Chiengi, if she can bring this information to the Secretary to the Cabinet regarding Permanent Secretaries who do not have qualifications, I think this will be very welcome. But for now, I know that all PS's in the line ministries are trained and have the requisite qualifications for the job they are holding," Vice-President Wina claimed. But a News Diggers! investigation in April revealed that Bishop Chomba has fake qualifications.

"We have been asked about Mr Chomba's credentials on previous occasions. We have no record of his ever having been registered as a student at Trinity College, Oxford. I am copying this reply to my colleagues at the University's Research Degrees Office, who will be able to confirm whether he has been awarded any doctoral degree from the University. The College does not hold this information. The digitised College records that have been checked go back to the 1930s," The Oxford University, Trinity College responded to a News Diggers press query in April.

Despite the report, no action was taken against Bishop Chomba.

And when asked by the leader of opposition Jack Mwiimbu what they were doing regarding District Commissioners who were campaigning for PF in Mangango district using government resources, Vice-President Wina said that information was false.

"The comment by the leader of the opposition is an assumption. Because DCs have not been allowed by the central committee to participate in the campaigns in Mangango. I do know that there are no government vehicles that are being used in that campaign. I think the honourable member must have been given untruthful reports because all the campaign vehicles in Mangango have been secured from Lusaka. We can go there to Mangango to verify whether government vehicles are being used in the campaign," she said.

Asked a follow up question by Gwembe UPND member of parliament Attractor Chisangano who wanted to know what to do to DCs who were found using government vehicles to campaign, Vice-President Wina said the idea of concentrating on DCs would not win UPND a seat in Mangango.

"As a political activist, your job is to concentrate on the campaign. You are not going to Mangango to hunt for DCs and vehicles. If the purpose of going to Mangango is just to confiscate vehicles simply because you suspect this vehicle belongs to a DC, I think the law will take care of that. It's not DCs who win campaigns. We have our own party structures on the grounds and these are the people leading the campaign in Mangango. So the idea of concentrating on DCs will not win UPND a seat in Mangango because our people are there campaigning. If there is even one DC in Mangango, he can leave but we are still going to win Mangango," she said.

Meanwhile, Vice-President Wina acknowledged that the country's reserves had gone down adding that government was taking different measures to increase them.

"I do realise that our reserves have gone down from \$2.something million to \$1.8 million. Of course that is acknowledged. But government has not just sat to mourn over this situation. Government is taking measures to ensure that we increase our reserves by taking many interventions including the austerity measures that we have taken which will help us to be able to contain excess expenditures unnecessarily," she said.

Vice-President Wina also said NRDC College management was still investigating the causes of riots at the institution.

"The riots at NRDC were prompted by students who were in the first or second year and wanted to get into the next academic level without passing the required subjects. I'm yet to see a university or college where a student can aspire to go to the next level when they have not passed all the required subjects. However, as of now, the college has been reopened. Of course management is looking into the causes of the riots," said Vice-President Wina.

who are trying to survive through private sector entrepreneurship have failed to pull through because their business opportunities keep getting trampled upon by State agents who have followed them in their retirement. Most of these victims feel going to court is a sheer waste of time because they know that there is no justice they can get as long as their oppressors remain in power.

These victims are extremely mad at President Lungu for allowing criminal elements to abuse State power in fighting personal battles. They want the Head of State to know how aggrieved they are, but they have no platform on which to engage him. Their letters of complaints can't even go

past the gates of State House. The few that get delivered end up in the very hostile hands of the aggressors who then make the situation worse for the victims.

All these devastated people would like to take a bite at the President because they can't handle their frustrations any more. They have tried to endure, but they can't stomach it further. The edge for vengeance is getting the most out of them, but since they have nothing to fight back with, some have started giving government leaders a piece of their mind.

Insulting the President will only make the situation worse for the victim who may have had a very good reason for being angry at the State. As we speak, police have arrested Mr Chikonde, and anyone who has seen that video wonders how he will get out of that self-inflicted problem.


Don't get us wrong. Zambia is a democratic country, therefore, citizens are free to illustrate where President Lungu is going wrong and telling it in his face that he is a failed leader (like we are repeatedly doing). They can call him a dictator if that is what they think he is - that is not an insult. They can go further and publicly mobilise citizens to vote him out at the next elections. Those with legislative power have an extra privilege of removing him from office before the next election using an impeachment process, as long as the law supports their grounds.

But we are totally against the growing trend of showering insults at the leadership of this country. In countries like the United States, what Mr Chikonde was saying is not a big deal. We see Americans insult President Donald Trump on live television and they call it freedom of speech. But that is not, and must not, be allowed in Zambia. Let us not copy other people's negative cultures and make them our own because it will cause a huge governance problem for generations to come.

Those who are individually aggrieved by this government must carefully manage their frustrations. We would like to encourage those who are seeking solace from the Church to continue getting spiritual counselling. There are also other support civil society organisations that take up such matters of State victimization and these institutions are ready to help. Reach out to them and let them hear your case.

Insulting President Lungu is not a solution at all. It's just like cursing at a stone which you hit into; it may give you some shortlived satisfaction, but it can't stop the bleeding. After all, a stone has no ears.

The Khartoum government has unilaterally maintained a ceasefire with rebels in Darfur, Blue Nile and South Kordofan since 2015, and extended it in July.

Saudi Arabia told the United Nations on Monday it would prosecute those responsible for the killing of journalist Jamal Khashoggi at its Istanbul consulate, as Western states pressed it for a credible investigation.

Bandar Al Aiban, the head of the Saudi government delegation at the first U.N. review of the kingdom's record in five years, heard calls from more than 40 nations, including the United States, for a thorough inquiry and a string of rights reforms.

Pope condemns anti-Semitism amid increase in attacks on Jews

Pope Francis called on Monday for the eradication of anti-Semitism following an increase in attacks and hate crimes against Jews in several countries and said it was vital to preserve the memory of the Holocaust.

In the worst attack ever against U.S. Jews, a gunman yelling "All Jews must die" stormed a Pittsburgh synagogue on Oct. 27, killing 11 worshippers and wounding six other people including four police officers, before he was arrested.

"We are called to commit ourselves to ensure anti-Semitism is banned from the human community," Francis said during a meeting with rabbis from the World Congress of Mountain Jews.

Mountain Jews are the descendants of Jews who left ancient Persia and settled in the Caucasus. said the Francis Holocaust, in which the Nazis murdered six million Jews around


