PAC grills PS Sipanje as he apologises for theft in Lusaka

By Sipilisiwe Ncube Lusaka Province Permanent Secretary Charles Sipanje yesterday, through the parliamentary Public Accounts Committee (PAC), apologised to tax payers for the theft and wastage of public funds under his administration.

Sipanje, who appeared before the Committee to resubmit his responses to the audit queries cited in the Auditor General's Report for the financial year ended December 31, 2017, also angered the Committee members after it was discovered that his deputy and four other accounting officers had made several irregular withdrawals in his absence and concealed the information.

Solwezi West UPND member of parliament Teddy Kasonso was the first one to express disappointment, saying Lusaka Province was the worst provincial administration in terms of public finance management.

"Before I even go to specifics, I want to say that this sitting for Lusaka Province, for me, is the worst so far. My question is, is there capacity at Lusaka Province in terms of financial Everything management? here is as if there is no PS, there are no accountants! PS, have you got the capacity? I am being very specific? Things have broken down! This is the worst ever since we started sitting," Kasonso observed.

Milenge constituency PF member of parliament Mwansa Mbulakulima echoed Kasonso's query and equally added his disappointment.

"I want to follow what honourable Kasonso has said, [and] even the people who have accompanied you, controlling officer, who are very highly educated and you don't have to wait for the public accounts to remind you of this or public accounts to get annoyed! In your earlier submission, you had given us that the releases by Ministry of Finance; this is the column and on your own, you have submitted that this is what you had released to various departments giving us the variances. And that is the reason why you are saying this under-funding must be explained," Mbulakulima

"Now, on your own, you have brought another schedule, which changes everything. Acting financial director, you know from accounting point of it the importance of materiality. Now with this shift, surely, do you think you can go to any conference or any meeting and then you survive, you expect people to just clap for you? What will stop us thinking that you are now just window dressing? You are just trying to coverup. I feel very disappointed!"

Sipanje in his response conceded the irregularities under his administration and detailed them.

"Obviously, I do have the capacity, but as I had indicated earlier on, chair, things at Lusaka Provincial Administration went terribly wrong, why? This is an institution, which if you know the structure of the province, the Permanency Secretary is assisted by senior officers and very key, the deputy Permanent Secretary, who also chairs the finance committee, and also the principal accountant. Now, if you have the same people who are supposed to be assisting the CEO of the institution; officers who are also signatory to all the accounts and they are the ones in the forefront to do wrong things, a lot of information was concealed," narrated.

He said having served as PS for seven years, this provincial report was the worst ever among all his reports.

"When these anomalies were discovered, I was also shocked and if I show you the schedule, with your permission, the way monies had been withdrawn during the period I had taken leave; as you might be aware I am entitled to 42 working days and there is a requirement that we all take leave. There is no commutation of days because of austerity measures. With your permission, I will show you the schedule on how money was withdrawn when I was on leave and how money was signed for by the deputy Permanent Secretary and the principal accountant. Because these are two officers who had done wrong things, they had to conceal a lot of things. But, yes, I agree [that] wrong things were done and that is why four accounting officers have already been dismissed and one senior DPS (deputy Permanent Secretary is under suspension pending his further determination of his case," Sipanje explained as he displayed a schedule of withdrawals amounting to over K2.2 million.

"Having been Permanent Secretary for seven years, this has also been one of my worst reports, I can confirm. Through you, chair, we, as provincial administration, would also like to say: 'sorry' to the tax payers," Sipanje submitted.

But Mbulakulima told the sorrowful PS to stop handing public funds as if it were "his father's petty cash."

"We are not going to gloss over this matter, it is one of those issues that we should stand firm on and ensure that justice prevails. Public funds must be recovered. You cannot be playing with money like it's your father's petty cash! So, we call upon the law enforcement agencies

because sometimes also they relax a lot. Issues of this nature must be taken seriously and at a faster rate, [but] of course, without a miscarriage of justice and that way we are going to restore confidence on the Zambian people," Mbulakulima said. In sending off the controlling

officer, Committee chairperson Howard Kunda asked Sipanje to put in better control measures to avoid facing the same problem.

"And you have conceded here that this has been your worst report on the matters that I have referred to, and that is to talk about poor record-keeping and you have conceded here that poor record-keeping is the reason why some of the queries have come about because some people have opted not to give the auditors the information that they require when they are there. Of course, you have referred that there were some officers, who were just doing theft, just stealing government resources and, therefore, they were hiding the information because they didn't want to be caught at that time. So, it is very important that systems are put in place to ensure that these records are kept properly. We don't want in fact to see you here, PS, to come and appear before this Committee to be asked about these issues," said Kunda.

Marrying off children won't bring you riches, only problems, Sinda DC warns parents

Sinda district commissioner Paradious Sakala says marrying off children brings more problems than good and parents must instead focus on educating their offspring.

Speaking when he handed over a renovated classroom block worth K70,000 to the community in Sinda constituency, Tuesday, Sakala said education was the only weapon which could be used to eradicate poverty.

"School is the weapon that can redeem us from poverty and other devastating issues that we might face but it's sad that education is not valued by some of you parents because all you see in the beauty of your children is money. We love money so much thinking marrying off our beautiful children especially girls will make us rich yet you attract more problems. Let's not sell our children to marriage because their

beauty is not for money but bright

"Look some of you are not educated, you can't read, you can't write and you still want to go somewhere for someone to read a letter for you? Educate your own child so that he or she can write and read for you. We are living in a computer generation such that without education you won't enjoy anything, the messages even in our phones it's mostly in English and you want children to remain uneducated! no we can't go like that. Today we are handing over the block and it needs children to be there but if you marry them off who will utilize the block."

He challenged teachers to inculcate good morals in pupils seeing that they spent more time with them than with parents.

"Teach children good morals, teach them things that can benefit them now and in future but not songs and dances ati two by two catappilar! That way you are fueling HIV/AIDS in some way but teach them things that will inculcate good discipline in them," said Sakala

And PTA chairperson Innocent Ngoma thanked government for the block saying the school had a lot of pupils but lacked classroom space.

"We would like to thank government for the block. Truly we have a lot of pupils here and the challenge is classes and I am pretty sure this one will take us a step ahead and for that, we say thank you and when resources are available keep assisting us," said Ngoma.

Meanwhile, village headmen Seya Abasi Phiri, who spoke on behalf of all traditional leaders, appealed for help from government saying their subjects survived on mangoes.

"Bwana DC we are dying here with hunger because these people you see survive on mangoes and soon the fruits will finish how are we going to survive? So we appeal to government to help us with relief maize and we believe you the commissioner will speak for us to the rightful offices," said Phiri.

He also lamented that evoucher had brought so much confusion and asked government to quickly intervene because a lot of names had been removed from the system without any reason, a situation which worried a lot of farmers.

Meanwhile Kasangazi area councillor Jonathan Phiri thanked government, communities and their subjects for the cooperation shown during the renovation of the block and urged them to keep the cooperation intact.

The block was first built in 1963 and in 2012, it became a danger to the teachers and pupils a situation which made government to intervene by funding it in 2017.

Drop contempt charges against Chifire, demands **Amnesty International**

International's Amnesty Regional Director for Southern Africa Deprose Muchena says the contempt of court charges against SANAC executive director Gregory Chifire should be dropped immediately because they are a total fabrication and make a mockery of justice.

In a statement issued by International Amnesty Southern media manager Robert Shivambu, Wednesday, the institution stated that Chifire's contempt case was designed to silence his activism work.

Muchena said Chifire's trial was an affront to the right to freedom of expression, adding that his only crime had been to ask the Zambian judiciary to ensure accountability within its ranks.

"A Zambian human rights activist is facing jail simply for accusing the country's judiciary of corruption. This trial is an affront to the right to freedom of expression. Gregory Chifire's only 'crime' has been to ask the Zambian judiciary to ensure accountability within its ranks. The contempt of court charges against Chifire are a total fabrication. They make a mockery of justice and must be dropped immediately," said Muchena.

"The Zambian authorities should be supporting the free exercise of the right to freedom of expression, not supressing it. Gregory's case smacks of censorship and victimisation, designed to silence his activism work." Chifire's verdict and sentencing will be delivered on Friday, November 23, following a trial on four contempt of court charges. The four contempt of

charges Chifire, emanate from his questioning of a Supreme Court judgement handed down in March 2018 involving two large corporations.

The case involved a local bank, Stanbic, referring a local company, Savenda, to a credit bureau for blacklisting on allegations that it defaulted on a loan repayment.

In a letter to the chief justice, Chifire described the judgment as having "omitted very crucial evidence" that formed the basis for the awarding of damages to Savenda and asked for the judges suspected to be responsible to be investigated.

He was summoned to appear in court on July 17 and later faced trial.

The hearing of his case was concluded on September 19, this year.

CCZ admonishes Sumaili over 'Jesus is in the boat remarks'

Council of Churches in Zambia (CCZ) General Secretary Fr Emmanuel Chikoya has admonished Religious Affairs Minister Reverend Godfridah Sumaili for saying Jesus is in the PF boat.

Addressing a rally in Kaoma last Sunday, Rev Sumaili said Jesus Christ is the PF boat and that voting for newly elected Mangango member of parliament Godwin Putu was like voting for Jesus. "Jesus ali mu bwato. If Jesus is not there, there is no security, there is no peace. That's why we want a government that honors Jesus. Jesus is in the boat so when we vote for Putu, we are voting for Jesus... Hallelujah, Amen. So on the 20th of November, we are choosing Putu, on the boat and we are selecting for Jesus. God bless you," said Reverend Sumaili before asking the crowd

to flash the PF symbol. But in an interview, Fr Chikoya cautioned Reverend Sumaili and other leaders to desist from likening Jesus Christ to any human for any purpose, explaining that Jesus could never share his glory with anyone on earth.

Fr Chikoya said the approach taken by the Minister of National Guidance and Religious Affairs was tantamount to blasphemy.

"I think we need to be careful how we do our campaign as politicians and things of that sort. At no time should we equate Jesus to any individual. When such happen, things important for people to correct themselves. And as a Church, we believe that any person who understands Christianity would not subscribe to such kind of an approach.

We would just encourage the politicians to humble themselves, to do their campaigns, do their best, pray just like the others also pray. But let Jesus be Jesus, he shares his glory with nobody," said Fr Chikoya. "That is actually bordering

on blasphemy and my advice to the politicians would be, let us be careful in our utterances, in our political engagements and all these other things, we need to be careful because there are Christians from different political persuasions and there can't be Jesus just for a political party, that is not right. God is omnipotent, his presence is available to everybody and so we can't compartmentalize God by our own fear of operations. God is for all, he doesn't need permission to be anywhere. He will go wherever he wants to go and he will interact with whoever he wants to interact with. So let's keep away from such kind of approaches as politicians, it is not good."

Chuumbwe denies making tribal remarks

The Media Institute of Southern Africa (MISA) in Zambia says the issuance of a search warrant on Prime Television by Police in Lusaka is unnecessary and aimed at intimidating the broadcasting house.

According to the search warrant served on Prime TV, Tuesday, police want to search the station's computers for footage of a rally which occurred in Bweengwa on October 30 at which Bweengwa member of parliament Kasautu Michelo and Choma central member of parliament Cornelius Mweetwa allegedly defamed President Edgar Lungu.

"The said video footage was shown on Prime TV main news on 30/10/18 at 19:30 hours. The video footage is kept or stored in computers at Prime TV premises. You

commanded in the name of the President with proper assistance, to enter the Prime TV station of Lusaka aforesaid (in the daytime), and there diligently search for the said goods, and if the same or any thereof found in the search, to bring the goods so found and also the said before this court to be dealt with, read the warrant. The other footage police require is a news story which aired on November 18 in which Prime TV reported

been given police uniforms on the Copperbelt.

But in a statement, MISA Zambia vice chairperson Hyde Haguta condemned the route taken by police, emphasising that it was unnecessary.

Haguta appealed to authorities to reconsider the search warrant and simply request Prime Television to give the police required evidence.

"MISA Zambia has learnt with disappointment that Police have obtained a search warrant to search computers and servers of Prime Television limited for footage aired which they alleged boarder on defamation of the President. We are shocked that according to the search warrant, police want to access a story quoting members of parliament for Bweengwa and Choma Central in which they are alleged to have issued remarks at a rally that PF cadres have been given police uniforms to use on the Copperbelt, in apparent reference to UPND President Hakainde at police in Ndola which took place on Tuesday. While we do respect the due process of the law and the route the police have taken, we however take strong exception to this level of intimidation to a media house doing its work of informing the public on a matter of public interest. There is no need to search servers for a libel matter. At best and as usual, request the Television station for footage required!" Haguta stated.

'We further are disturbed that police did not only block journalists from the private media who turned up to cover the questioning of the UPND leader by police at Ndola Central police over the ZAFFICO issue, but also detained a ZANIS journalist who was filming the blockade police had mounted ahead of Mr Hichilema's arrival. This coincidence is too careless and too much and therefore abuse of power on the part of police. We are suspicious that police have for the first time had to obtain a search warrant to obtain footage which they have in the past easily requested for through written correspondence. What other motive would police have to search the Television Company for footage they can ask for than intimidation? This conduct is smelly of abuse of their powers and process to instill a chilling effect in the knees of journalists in the country and is undemocratic!"

Haguta argued that the media should not be gagged, harassed, manipulated or intimidated in such a manner.

"We know that a search warrant allows police officers to ransack the files of a broadcast house and takes not only hours but disrupts the smooth production process of the news and current affairs department. It also breeds and fear uncertainty among our members. We don't want it! This is unnecessary and aimed at intimidating our members and as MISA Zambia, we strongly condemn the route taken even if it is on firm legal procedure, it is unnecessary! This is surely an intimidation to the operating environment of the television to operate and


as a result, it will encourage self-censorship by the media and the consequences of it will work against the interest of the public and democracy. The media should not be gagged, harassed, manipulated and intimidated in such a manner as this is a violation of media rights and freedoms," Haguta stated.

freedoms," Haguta stated. Haguta further appealed to Inspector General of Police Kakoma Kanganja to instruct his officers to halt the intended search at Prime Television and simply ask for the information that his office requires.

"Prime Television is a messenger only conveying information to the public should therefore not be gagged. Since police have identified the members of parliament who allegedly issued defamatory remarks against the President, why not go after the parliamentarians than resorting to acts of intimidating the media? In any case police should have been more grateful to Prime Television for reporting a crime as good citizens and therefore must be commended and not harassed. We appeal to the Inspector General of Police Kakoma Kanganja to halt the intended search and ask for information his office requires. The matter has not even been submitted for prosecution before the courts of law to warrant such an apparent heavy handed action on a noble institution doing its work," stated Haguta.

Meanwhile, MacDonald Chipenzi through his GEARS Initiative said that police must allow the independent media to operate freely in Zambia.

"The continued suppressing of civic, political and media spaces in Zambia must be of concern to all democracy lovers. The warrants being issued by police against Prime TV is pure act of harassment and intimidation and suppression of independent media in Zambia. The police must allow the media to operate free and use legal channels of complaint against any media house that is perceived to have erred unlike this directionless approaches being used," stated Chipenzi.

Police in Chadiza district of Eastern Province have arrested a 28-year-old man for defiling a 13-year-old juvenile.

Lynn Phiri, a teacher at Mwangazi primary school in Chief Mwangala's area in Chadiza district is said to have defiled a younger sister of his fellow teacher on the evening of November 17, 2018.

Eastern Province Police Commissioner Luckson Phiri disclosed this to journalists at his office in Chipata, explaining that the matter was reported to Chadiza police by the victim's elder brother on November 20th, 2018.

"I want to confirm that Chadiza police station is in receipt of a report of defilement which was

reported on the 20th of November, 2018 at about 15:00 hours by male Francis Zulu aged 30 years, who is a senior teacher at Mwangazi primary school in Chief Mwangala, Chadiza district. That his younger sister, a female juvenile aged 13 years of the same address and a grade seven pupil at the same mentioned school was defiled by male Lynn Phiri aged 28 years, a teacher at the same school. This occurred on 17th of November 2018, at about 19:00 hours at the House of the same reporter. The brief facts are that on the material date, the reporter had gone to Vubwi and at about 19:00 hours, the suspect now went to the house of the reporter, knocked on the window and the younger sister to the reporter came out of the house through the window, they went to the toilet where he had canal knowledge with the same victim," Commissioner

narrated.

Commissioner Sakala said the suspect had been arrested and would appear

in court soon.

"Fortunately, one of the neigbours within the compound saw the victim when she was actually jumping out of the window, going to the toilet together with the suspect and also at the same time after finishing whatever they were doing, when the victim got back into the house through the

window. So having actually seen that, she immediately went and reported to the wife to the owner of the house that this is what she had seen and when the victim was called and questioned, she narrated the whole ordeal about what had actually transpired," said Commissioner Sakala. "When they further questioned her, she even produced a Chitenge material which they had used whilst in the toilet which actually had some dry semen. That was the time now when the owner of the house came back from Vubwi. After getting all the details of what had transpired, he went to Chadiza police station where he had the matter reported. Acting on the report, police actually visited the scene of defilement and after that, the suspect was picked, he has been arrested and he will appear in court soon."

PAC chases away Health PS over unverified documents

The parliamentary Public Accounts Committee (PAC) on Tuesday sent back officials from the Ministry of Heath for submitting supporting documentation that was not easily verifiable. This was when Health Permanent Secretary Dr Kennedy Malama and his team appeared before the Committee to respond to audit queries cited in the Auditor General's Report for the financial year ended December 31, 2017.

During the deliberations, the Committee, which was chaired by deputy chairperson Brenda Tambatamba, raised the issue of health officers in Mumbwa District who had remained in the service despite having irregularly paid salaries that were not entitled to them.

"Contrary to terms and conditions of service for the public service number 60 (a) and (b), which states that an officer who absents himself or herself from duty for a period of 10 days or more without official leave, must be separated from the service and shall not get a salary for the period he or she is absent from duty, two officers, who were absent from duty for periods ranging from four to six months at Mumbwa DHO had not been separated from service, and were irregularly salaries totalling K62,622. As at August 31, 2018, the anomaly had not been corrected," queried the AG Report.

In his response, Dr Malama said the cited officers had been dismissed and that documents to prove that action were attached to the response when in fact not.

"One of the officers in question proceeded on study leave, but failed to return to the station upon completion of studies. The other one deserted from Namgoma Mission Hospital without notifying the district office. The two officers have since been dismissed from the public service and paid salaries recovered from their terminal benefits. The District Health Director for Mumbwa has also been charged for poor supervision and given a recorded warning in line with the disciplinary code for handling offenses in the public service. The Ministry has embarked on an exercise to re-orient management from provincial and district health office on human payroll resource and management to avoid re-

occurrence. Supporting documents including dismissal and charge letters for the district health director Mumbwa and recoveries from the terminal benefits are available for verification in appendix 3," Dr Malama responded.

The Committee then noticed the omission of the documents of action taken against the officers and queried again.

Dr Malama insisted that the document was there, but maybe in another folder, which he had submitted earlier.

Then Tambatamba guided that the Committee would not proceed if the documents in question were not first submitted to the office of the Auditor General for verification before coming to the Committee as

per rule.

"It would appear that the document that you are referring to in the big folder, which is there, has not been accepted by the Committee if it's this one you are referring to because this is supposed to go to the Auditor General for verification. So, only then after they have gone through that office will they end up arriving here [and] if they have not gone there, they cannot land here. So, I don't know how many references are pointing to this and if the rest of the references are pointing to this in this meeting, [then] we will not be able to deal with those matters that point to this particular folder," she said. But the controlling officer insisted by saying: "Some of the evidence may be in the bigger folders and some

of it may be in the folders that we've presented to the Committee."

On another issue regarding health officials from the Copperbelt and Central provinces, respectively, the same action documents problem arose, and Tambatamba was the first one to notice it.

"PS, in your submission here, you are saying that: 'supporting documents, such as charge letters such as...' so the members here are looking for supporting documents, such recoveries from terminal benefits for those staff. That is what they are looking for; to verify, to understand, even as they provide guidance and oversight to you," Tambatamba said.

Dr Malama responded again by saying: "The charge

letters and provincial health staff for all these queries, what we did [was that] provincial health directors were charged for various issues, which arose in the audit report and those letters are there."

Another issue that arose was that the stated action taken was done on September 20, 2018, after the Auditor General's Report had been concluded.

In resolving the identified lapses, Tambatamba asked the PS and his team to go back and put their house in order and attach the reference documents in their correct order to allow easy flow of the deliberations.

The PS was asked to resubmit on Wednesday December 5, 2018, at 11:30 hours.



State has breached court's orders, must be rebuked, says Mutembo

The State says it will not make any sense to respond to former Director of Public Prosecutions Mutembo Nchito's application to summon witnesses when his petition may be dismissed.

But Mutembo says the State has breached the court's orders and deserves rebuke from the court.

However, the ConCourt has opted to hear the state's motion to dismiss the petition before Mutembo's application to summon former chief justices Ngulube and Sakala.

This is the matter in which Mutembo has petitioned the Constitutional Court over his removal from the office of DPP, saying it was unlawful, illegal and should therefore be declared null and void.

Earlier this month, the State filed a notice to raise preliminary issues in court on November 15 on whether the decision by the President to remove Mutembo as DPP can be reviewed and whether he can be reinstated.

However, when the matter came up for hearing before Constitutional Court judges Mungeni Mulenga, Enock Mulembe, Palani Mulonda, Margaret Munalula and Martin Musaluke, Wednesday, Mutembo said he could not respond to the State's notice because he was of the view that his application to summon witnessess should be heard first.

He said he expected a response from the State on October 25 but it never came, instead the state filed another motion on 2nd November and allocated a date to itself. Mutembo complained that the last time he did not file documents, the court rebuked him meanwhile the State had breached the orders.

Take issue with this conduct because what is good for me as a petitioner, should be good for the State as the respondent. The State complained last time about following court directives and the court rebuked me," Mutembo said.

Mutembo said in his opinion, the matter was coming up for his application which was scheduled for November 15 and the State should not give itself a date to hear it's application. It is the Court that should control the process, he argued.

In response, Solicitor General Abraham Mwansa said they could not file any response to his application because they were of the view that the notice of motion that they filed earlier this month was the appropriate step to take.

He added that it would not make any sense responding to his application because it could be disposed off in its entirety.

"An application pursuant to order 14A of the white book takes precedence over all other applications because it goes to the root of the cause of action. It would therefore not make any sense on our part to respond to the petitioners application because the matter maybe disposed off in its entirety," he said.

"We would however be obliged to file responses if any, in the event that our motion is dismissed. It was for the reason that applications pursuant to order 14A take precedence over other applications that we infact inscribed November 15, 2018, the date to which the hearing of this matter was adjourned."

In reply, Mutembo said Mwansa's choice of words was unfortunate, reiterating that the State ought to have responded to his application. "The choice of words by the Solicitor General is unfortunate. Because if I heard him correct, he said it would not make sense to respond to the petitioners application where they had raised order 14A issue. My point is, the State ought to have responded. They can't decide when to respond when the matter is being heard before court. They are now applying to set aside the originating process when the court has ruled on the same issue," he said.

Mutembo asked the court whether there were any consequences for breaching court's orders.

"For me, the problem I have is what procedure are we following? I would like to be guided. As far as I know my application is the application of the day. Is there any consequence for breach of directions?" he asked.

However, the court guided that the order in which applications could be heard was at their discretion.

They directed that they would first hear the notice of motion to dismiss, then the application for the subpoenas would be dealt at a later date. "We have heard the parties and we wish to guide that the issue of the order in which applications will be heard by the court is solely the discretion of the court. It does not always follow that once an application has been made first, that is the first application to be heard. The rules are clear that where there's an application that goes to the root of an action, then that application takes precedence in terms of the order in which they are heard," the court said. "Currently before us we have

two applications pending. That is the application for the subpoenas and also the other motion to dismiss the action, as well as, the main action itself."

Regarding Mutembo's sentiments that the respondent did not file any response within the dates given by the court, the court said that issue would be appropriately dealt with at the right time in terms of what sanctions to follow.

The matter has been adjourned to Friday, November 23, at 11:00 hours.

Lungu launches \$300m Chinese MFEZ project in Chibombo

President Edgar Lungu has launched construction of the first ever Multi Facility Economic Zone (MFEZ) in Central Province with the aim of fostering industrialisation and value addition to locally produced goods.

The US\$300 million project being constructed by China Jiangxi United Industrial Investment is located opposite Farm Store along the Great North Road in Chibombo and it is envisaged to accommodate various industries including Motor Vehicle and Generator Assembling Plants.

The investment park has become the first major investment since the Central Province Investment Forum and Expo which attracted more than 2,000 delegates, was held in Kabwe.

President Lungu noted that the setting up of an industrial park in Chibombo district by the government of China was an indication of the importance that the People's Republic of China attaches to its bilateral cooperation with Zambia.

"Let me take this opportunity to express

my sincere gratitude to the Provincial administration of Guangxi Province for participating in the business forum in Guangxi on the sidelines of FOCAC. I am particularly happy that this investment is coming immediately after the Central Province Investment Forum and Expo, where the province showcased its diverse investment opportunities. In this regard, I want to applaud the Ministry of Commerce and the Central Province Provincial Administration for working tirelessly to ensure that the Expo bears fruit, as we are witnessing today. These developments indeed tell a deep rooted relationship which exists between Zambia and China," President Lungu said.

"Our friendship with China dates back to the pre independence era and Zambia was in fact the first Southern African country to forge diplomatic ties with China. We should therefore endeavour to cherish the bilateral and mutual relationships between the two countries. I wish to reiterate my government's commitment to creating a conducive environment for business and growth through continuous implementation of business reforms. We shall continue to make efforts aimed at reducing the cost of doing business... our efforts are not mere rhetoric but this is evidenced by our huge investment into the modernisation and upgrading of our infrastructure such as roads, airports, rails and boarder points among others, thereby turning our country into a construction site."

The President pledged government's continued support to those wishing to invest in the Multi Facility Economic Zones.

"The government will continue to encourage the development of Multi Facility Zones, industrial parks and farm blocks to foster industrialisation and value addition. It is for this reason that the Ministry of Commerce, Trade and Industry has developed the national industrial policy, national monitoring strategy and the national investment promotion strategy, all aimed at creating a platform for continued development and growth," said President Lungu.

Reserves drop to \$1.6bn on heightened debt

Debt servicing has continued to pose challenges to Zambia's international reserves, which have dipped to less than US \$1.7 billion, says Bank of Zambia (BoZ) Governor Dr Denny Kalyalya.

And Dr Kalyalya has remained optimistic that the country's inflation outlook will be within single digits over the forecast period despite upside risks posed by scarce availability of food and rising commodity prices.

Meanwhile, Dr Kalyalya argued that the kwacha's volatility on the foreign exchange market experienced in September this year was mainly triggered by negative market sentiment.

Addressing questions following the BoZ Monetary Policy Rate (MPR) announcement in Lusaka yesterday, Dr Kalyalya said the country's escalating debt is posing challenges to the international reserves position.

Zambia's gross international reserves have plummeted to a 2018-low of US \$1.63 billion as at end of September, 2018, representing 1.9 months of import cover, from US \$1.82 billion, around 2.2 months of import cover by June 30, 2018, triggered by the need to finance the country's debt servicing payments.

The country's external debt stock as at close of the third quarter climbed to US \$9.51 billion from US \$9.37 billion at end of the second quarter of 2018, while the stock of domestic debt, mainly government securities, as at end of third quarter 2018 amounted to K54.6 billion from K51.9 billion at the end of second quarter 2018.

"...The other use is what we buy for projects and all that, but they don't amount to huge amounts. But the predominant draw comes from the debt service. We have also had situations where pressures arising from the oil imports," Dr Kalyalya told journalists at the central bank. He, however, added that the BoZ is addressing the dipping reserves by foreign exchange purchases, among other key measures.

"Is that something we are concerned about? Of course, we are. To build international reserves, the BoZ continued to purchase foreign exchange directly from the market and through the Mineral Royalty Tax receipts. Cumulatively, the purchases amounted to US \$345 million in the year to September, 2018," Dr Kalyalya added.

"We are also making efforts to include in our holdings of reserves in gold, the bullion; we are in discussions with those who produce gold so that we can add it to our menu of reserves. So, there are all these efforts going on, but the challenge is that debt service has been elevated; that's the number one drawdown in the reserves."

And asked whether the central bank foresaw double digit inflation given the commodity price fluctuations and availability in consumer goods, such as maize, BoZ officials remained optimistic it would still be in single digits over the forecast period.

Zambia's annual rate of inflation hit 8.3 per cent last month, the highest on record since November, 2016.

"We expect inflation to still be in single digits in this remaining part of the year. But the upside risks are quite strong; if they materialize, it could reach close to nine [per cent] or thereabout. But from where we sit, unless something really drastic happens, we don't see it really going into double digits just yet; but shocks can happen," Dr Kalyalya responded.

Meanwhile, he argued that the kwacha's volatility on the foreign exchange market experienced in September this year was mainly triggered by negative market sentiment, among others.

The kwacha lost value by nearly 20 per cent alone on the back low dollar supply and at least two credit rating downgrades.

It traded at K11.81 and K12.04

by the end of September for bid and offer, down from an average of K10.99 and K11.06 per dollar earlier that same month.

"That shift in September was a source of concern. But then, you have to look at the factors. A lot of them had to do with negative sentiments; yes, we did expect the kwacha to come under pressure by the fact that the dollar will be strengthened, but it was magnified by these other factors. So, if we control on those factors, we should see relative stability in the exchange rate," he said.

Earlier, Dr Kalyalya announced that the BoZ's Monetary Policy Committee (MPC) decided to maintain the Monetary Policy Rate (MPR) at 9.75 per cent, while also keeping the Statutory Reserve Ratio (SRR) at five per cent, in a bid to induce lower interest rates and continue supporting economic growth. According to Dr Kalyalya, commercial banks' nominal average lending rates have only marginally reduced to around 23 per cent in the third quarter from 24.3 per cent in June.

"Lending rates have come down, but the concern we have is that, but at that level, is it not too high to stimulate economic growth? So, these high rates also have implications on those who have borrowed. So, we are happy that it is coming down, but we want it to come down a lot faster," said Dr Kalyalya.

I'm bound to meet Lungu for talks after UPND, says Nevers

Movement for Multi-Party Democracy (MMD) president Nevers Mumba says since disengaging from the UPND, he has not yet met President Edgar Lungu, but adds that the meeting is bound to happen soon.

And Mumba said Zambians have failed themselves and everyone is to blame for the influx of the Chinese people in the county.

Speaking during the 'people debate program' on Pan African Radio in Lusaka, Wednesday, the former vice-president who is a faction leader of the MMD said it he would soon be meeting President Lungu to discuss politics, which is their common interest.

Asked if it was true that he had been snooping around State House trying to get

audience with President Lungu, in the aftermath of the dismissal from Cabinet of another MMD faction leader Felix Mutati, Mumba said there was nothing wrong with meeting the Head of State.

"It will always be the case in Zambian politics. First of all the rumour that go out in politics have never changed from the beginning. You will always hear that this one is snooping here, this one is snooping there. But I think those are very unnecessary things I have not met President Edgar Lungu myself, ever since we disengaged from UPND. But I have also heard those things that have been said. And I also have to be very, very clear that look, meeting President Lungu is not something that someone

should fight against," Mumba said.

"We should be able to meet each other and that is why I hope we are going to come to the issue of dialogue. I mean HH met President Lungu on Monday, what's wrong with that? And I think that we should all be encouraged to meet one another, that's what you should be doing as a media person. You should be happy if you heard that Nevers met with President Lungu. You should be happy if you heard that Nevers met with HH, you should be happy if you heard that Nevers met with Kambwili because these are the players that we are going to shape the country with."

He said he was looking forward to meeting President Lungu just like businessmen meet to discuss deals.

is yes, I have not yet met the President, but I do know that as we move forward, because we are in the same field we are going to meet and discuss just like businessmen when they meet and talk about their deals and transactions and the market. Because they are in the same industry. I'm in the same industry with President Edgar Lungu, the same industry with HH, so we are going to at some point sit down and say how do we proceed and how do we make the lives of our people better," he said.

And Mumba said the influx of the Chinese people in Zambia and the subsequent ownership of local assets implies that the government together with its citizens have failed to manage country.

"Zambia China relations, there is a lot of talk when you go on the streets. There is a lot of talk internationally. lately off course Zambia is being called a Chinese colony. Zambia is being called every name as having handed over her sovereignty. Zambia is being called that it has borrowed so much from China that it cannot pay the debt to China in this lifetime or in the lifetime to come. You see nation have always traded with each other and they will continue to do so until the end of time. The problem is not necessarily our trading partners, whether US, Europe or China in our case. If there is any failure in equitable trade in Zambia, it will be local failure not investors failure," he said.

"We as Zambians are actually expected to make rules which favour the Zambian person in every deal that we do that's what leadership is there for. So, to fight the Chinese in the streets is a show of our failure to manage ourselves. We ourselves should make the rules not the Chinese. The foreigners have to abide by the rules that we make," he said.

And Dr Mumba advised President Edgar Lungu and his UPND rival Hakainde Hichilema to humble themselves during the dialogue process to ensure a smooth procedure. "The main root cause for the

suffering of our people is the

lack of dialogue amongst us as leaders. Its really the main cause for pain that we are going through as a nation. Once you cannot talk, you cannot make economic progress, your security as a nation is compromised, the foreigner becomes stronger in your nation because the foreigner takes advantage of your division," said Mumba. "Dialogue demands from us leaders a spirit of humility. Why? Because there are a number of things that have brought us where we are and this issue of dialogue is not a new issue. Some people feel they are so educated that they cannot dialogue with people they consider illiterate, they think that they are better than the others, they think that they are more enlightened than the others, they think that others are just a street people who cannot be a challenge to them intellectually. But dialogue has nothing to do with a University degree. It has nothing to do with

intellectual, it has something

to do with humility.

PF disagrees with Chibamba on Copper deposits under ZAFFICO land

PF deputy media director Antonio Mwanza says it is not correct insinuate that people who would buy shares in the ZAFFiCO Industries once it is listed on the Lusaka Stock exchange would be eyeing the copper deposits underneath. During the Bloomberg Media Business Innovators conference in Livingstone, Tuesday, economist Chibamba Kanyama said the politics around the ZAFFIC land was because of the value of the copper underground.

But Mwanza disagreed with the Bridges Limited Chief Executive, saying no one would touch the mineral deposits under the ZAFFICO land without a special mining license.

"The government has been very clear

that ZAFFICO has not been sold and that the government will consider floating the shares. And that when they do so, the shares shall go to the Zambian people, to empower the Zambian people one, and to improve capital injection in ZAFFICO and three, to improve management and administration of ZAFFICO to make it viable," Mwansa debated.

"This is the same way that government has floated other companies such as ZANACO, such as Chilanga Cement, such as Zambian Breweries all those were floated out and private hands, investors own shares and those companies are viable, they are sustainable, they are making profits."

He said all minerals underground

belong to the State, and as such, there would be no way that any person who buys shares in ZAFFICO would think they equally own whatever Copper deposits may be underneath.

"And Mr Chibamba Kanyama must know that you cannot buy a bare piece of land and then claim that the minerals under that land are yours. Because the land exploration act and the minerals act is very clear. When you buy a piece of land you have to buy the rights to the minerals under that land. Those minerals belong to the state. You need to apply for a separate license given to you first of all to explore those minerals and secondly to be given a license now to start mining those minerals," said

Cameroon army frees kidnapped students

Cameroon's security forces have rescued kidnapped students and one teacher after a raid on a camp of separatist fighters in the South-West region.

The group of nine, not 20 as first reported, was taken from a school in the city of Kumba, on Tuesday.

Four attackers were shot dead in the operation but one was captured, a senior official told the BBC.

Cameroon's North-West and South-West regions have been hit by a separatist rebellion since last year.

Armed groups in the two English-speaking regions have called on local residents to boycott schools until a referendum on independence is held.

Protests against marginalisation by the country's French-speaking majority have been met with a crackdown.

Gunmen entered the Lords Bilingual School on Tuesday afternoon causing panic. Many of the students jumped over the school fence walls to avoid being taken.

In the confusion, earlier reports had suggested that a higher number of students had been taken, journalist Peter Tah, who has been covering the conflict in the region, says.

Three students were released on Tuesday night after two gunmen were shot dead in a shootout with security forces who raided their camp. In addition, one gunman captured, Nto'ou Ndong Chamberlin, Senior Divisional Officer for Meme district, in the South-West region, told the BBC. **BBC**

ConCourt judgment a step forward for activists, but Joburg still has 'protest fees'

The debate on whether or not protests fees must be charged is happening in two places in the world: on the steps of the White House and in the City of Johannesburg.

For the last five years, the Right2Know (R2K) campaign has challenged the implementation of a city by-law for special events that has seen organisations being charged a fee to protest.

A Constitutional Court judgment may set a precedent in the fight against so-called protest fees. The judgment ruled that the failure to give notice of a protest should not be made a criminal offence.

The fees, JMPD spokesperson Tessa Adams told News 24, are a compulsory part of the policies. municipality's explained that they form part of a tariff policy based on the number of police officers needed during a protest.

On Friday, the R2K handed a memorandum of demands at the office of the mayor to address this issue. It addressed the demands to Mayor Herman Mashaba, speaker of the Johannesburg city council Vasco da Gama and Joburg metro police chief David Tembe.

In the memorandum, R2K requested the city to address the application of the "special event costing" in the Public Open Spaces by-laws to gatherings convened in terms of the Regulation of Gatherings Acts, and address the JMPD's gathering procedures.

The mayor's office has promised to respond within two weeks.

In order to hold Friday's protest, the campaign's spokesperson Murray Hunter said the Joburg metro wanted R2K to pay R446 for "planning costs".

The fact that organisations have to pay to protest in Johannesburg, Hunter says, is a "major violation of free speech."

On the other side of the Atlantic, President Trump's administration drafted a policy in August that would not only close 6m of the more than 7m wide pavements surrounding the White House but charge "event management" costs for demonstrations, the Guardian reported.

The charges include payment for additional law enforcement, repair and maintenance for the general surroundings and the cost of erecting barriers for the demonstration.

The American Civil Liberties Union (ACLU), a civil liberties activist group, has said that the proposal could make demonstrations — such as Martin Luther King Jr's 1963 march on Washington where he gave the "I had a dream speech" — costly, preventing demonstrations from happening.

ConCourt ruling precedent on protests

In South Africa, the unanimous ConCourt ruling found section 12(1)(a) of the Regulation of Gatherings Act unconstitutional. The Act regulates protests, stipulating that municipalities must be given a week's notice before the protest.

Section 12(1)(a) of the act had also required that organisers of gatherings of more than 15 people have to give notice of their protest, without this notice, a peaceful protest could be deemed a criminal offence.

The court has left the decision to amend the Act to Parliament.

In a statement released on Monday, Social Justice Coalition said this section of the Act was a "disproportionate punishment" and in conflict with section 27 of the Constitution, the right to freedom of assembly.

"Ordinarily, a lack of resources or an increase in costs on its own cannot justify a limitation of a constitutional right. The reason for attaching less weight to a lack of resources as a purpose for limiting rights is beyond question," the ruling read.

"Respecting, promoting, and fulfilling human rights comes at a cost, and that cost is the price the Constitution mandates the State to bear." mg.co.za






Kashala who is also Zambia police Sports Director further voiced out on Zambia's top FIFA referee's suspension, Janny Sikazwe.



Nasri was originally banned for six months after he received a drip treatment at a Los Angeles clinic in 2016 while on loan at Sevilla, which UEFA said contravened rules laid down by the World Anti-Doping Agency (WADA).

An appeal against the initial sanction by UEFA's ethics and disciplinary inspector resulted in an extended suspension in August, which was backdated to July 1 2017, meaning that he was unable to train with a professional club until the start of November. *Goal.com*
