My nomination came as a shocker - Nakacinda

By Mirriam Chabala Raphael Nakacinda says his nomination to the National Assembly as member of parliament by President Edgar Lungu was such a shocker because he never imagined he could have that privilege.

Nakacinda, who is dismissed Felix Mutati's MMD national secretary has, however, vowed to continue organising his party in readiness for the 2021 general election, saying it is his responsibility to coordinate the party as chief executive officer.

Speaking when he featured on Diamond Television's Costa show, Sunday, Nakacinda thanked President Lungu for the boldness he had expressed in identifying him for the task ahead.

"First of all, I never ever imagined, it never even crossed my mind that this privilege would be

accorded to me. Those who have worked with me do know that I have a philosophy that I operate with, and that is a philosophy of value addition. I never pursue positions, I believe that positions are just a means to the end, and to that effect, wherever you are, you can use your gifts, talents and be able to add value and impact the lives of those that you seek to save. So, it was really a surprise, if not a shocker, that there was such a consideration," Nakacinda narrated.

"I want to take this opportunity to thank the President of the Republic of Zambia for the boldness he has expressed in his desire to identify talent in me, it was a surprise! It came speedily, but we are able to manage ourselves in terms of considering this responsibility and what it would do to the country and what it would do to the party. Going on all options, we felt there is a time for which we can put subordinate, either partisan or individual interest, to national interest."

Nakacinda, however, conceded that forming an alliance with a ruling party as the opposition was not easy.

"To have two political parties come together in national interest is not an easy fit, especially that it's the first time we are having a situation where a former ruling party coming to work with a party that beat them in an election because there is always that competitive attitude between the two political parties and it requires a lot of patience, a lot of skill and very focused leadership. If the principles that you are basing this relationship are fundamental, you have to work around the feeling and attitude of members, who may not fully understand and see the bigger picture in terms of this working relationship. It's not just the Patriotic Front, for your own information, MMD members have also expressed discomfort in many ways," Nakacinda lamented.

Asked why the MMD was still in the relationship if they were not very comfortable, he said the alliance was inevitable.

"Every development that brings about the paradigm shift in the way things are done from the traditional mode will always create some kind of resistance, but it is inevitable. With the 50+1 threshold for political parties to work together, for us as MMD, we try to communicate the importance of this

alliance and the fact that it is inevitable for us to work with other political parties and when we look at the options that we have, Patriotic Front, even when we competed in 2011, I think were favoured by the Movement for Multiparty Democracy because most of the people that are in the Patriotic Front, including their first president, Michael Sata are products of the MMD," he explained.

Meanwhile, Nakachinda said there was no ulterior motive behind his appointment, and as such, he would continue mobilising his party ahead of 2021.

"MMD is an independent political party, just like the Patriotic Front are an independent political party. Our relevance lies in our programmes of mobilising ourselves and the numbers, as it is

usually said that politics is about numbers. It is my responsibility as national secretary to continue organising our party. At the time when President Lungu was indicating that he had decided to nominate me, he said: 'we do not want to compromise your position as national secretary of the MMD. We are an alliance partner and we would want that the Patriotic Front is strong, the MMD is strong and the spirit of this alliance would want that we also have some kind of a voice in Parliament and we think that you can help and serve the Zambian people in that particular role'. So, it's not a nomination that comes with ulterior [motives], at least I didn't sense that ulterior motive," he added. Asked how the party had received his appointment after the dismissal of Felix Mutati, Nakacinda declined to comment.

"I will not be able to answer to speculations because the reasons for which the President revoked the appointment of honourable Mutati as Minister (as Works and Supply) have not been given. So, I will not be able to speak authoritatively around that issue. As for how the party will treat this appointment, we need to sit as a party and discuss because we have not met since honourable Mutati was dismissed from his position," replied Nakacinda.

England's Prince Harry to buy hundreds of elephants for Zambia

By Mirriam Chabala Prince Harry has offered to acquire hundreds of elephants from Botswana for the Kafue National Park in a quest to double the number of tourists to Zambia by 2030.

Speaking to journalists shortly after President Edgar Lungu's private meeting with Prince Harry, Monday, State House press aide Amos Chanda disclosed that the British royal had offered to help Zambia in wildlife conservation.

"His Royal Highness, Prince Harry has been holding private talks with the President. Within those discussions, they touched on a wide range of issues, particularly the most important is the passion between the two leaders. Prince Harry has offered to assist Zambia with the conservation of wildlife, particularly in Kafue National Park where he has given the offer to assist Zambia acquire hundreds of elephants from Botswana and they would move into the Kafue National Park under the auspices of African Parks, an organization where he is Chairperson. So the President has given

full support to African Parks, as you know they are the ones who operate the Liuwa National Par, where there an incredible crop of animal population from the time he took over and also where they are operating," said Chanda. "The two leaders have also

agreed on the mechanism where the Minister of Tourism of Zambia went into a Memorandum of Understanding with Africa Parks, and African Parks is delivering documents guiding this Memorandum of Understanding and then that process

of transporting large numbers of elephants from Botswana into Kafue National Park and by so doing, improving other conservation methods. So the Prince is here to ensure that tourist numbers could double within between now and 2030, with the introduction of elephant population, boosting up the elephant population and also conserving what is the focus of this initiative, which is to emphasize that it would add considerable to youth empowerment and job creation within the conservation areas."

Witness narrates how ZAFFICO rioters looted shops in Kitwe

A 21-year-old man of Chamboli Township has told the Kitwe Magistrates' Court that the ZAFFICO rioters looted a Chinese Supermarket, King Mei, and stole plasma TVs and cooking pots.

Kelvin Bwalya, Boyd Kasuba, Peter Chitabula, Fabian Chengo, Steven Kalunga, Kelvin Sikatali, Dabwitso Njobvu, Bruce Chitalu, Richard Mphande, Harison Mumba, Steven Mambwe, Bornface Kunda, Alex Kamanga and Langanani Nkhata are charged with two counts of rioting and injuring of building contrary to the laws of Zambia. Allegations are that on November

5, this year, in Kitwe, jointly and whilst acting together took part in a riot by breaching the peace to the

terror of the public.

In count two,allegations are that on November 5 this year in Kitwe, being riotiously assembled, damaged King Mei supermarket, the property of Guy Kalumba.

Appearing before Chief Resident Magistrate Yvonne Nalomba for commencement of trial, Victor Mwindula told court that on the material day he received a phone call from his boss that they would not open the supermarket as there was confusion at Nakadoli market. Mwindula said his boss also instructed to go and man the shop incase the rioters decided to break into the supermarket.

He said on his way to the shop, he found an angry mob that had blocked government road in Chimwemwe Township with burning tires and that they were sending away every oncoming vehicle.

He narrated that as he reached the shop, he found four of his coworkers keeping vigil.

He said shortly after police had dispersed the rioters from the road, they re-mobilised themselves and walked towards the shop.

He recalled that he heard one of the people in the mob say they break down the shop and get some goods. He said they later started throwing

stones at the windows and doors of King Mei supermarket and opened it and got away with goods such as mattresses, pots and dishes.

He told court that he and his fellow

workers could not stop the mob from looting the shop as they were too many.

He said he later decided to call his boss and inform him that his shop had been looted and that there were no police officers to help disperse the group of people.

"The rioters threw stones at the supermarket's windows and doors and when they managed to enter the shop, they got away with DVDs, Bicycles and plasma TVs. We could not do anything about it as they were a lot so we decided to call our boss and tell him about what had happened to his shop."he said.

Magistrate Nalomba has since adjorned the matter to December 10 and 11 for continued trial.

of parliament Given Katuta has called for disbandment of the Human Rights the Commission (HRC), saying the Commission does nothing to protect the rights of Zambians. And Kabwe member of parliament Tutwa Ngulube is proposing that the HRC must in fact have a structure similar to that at Legal Aid, where the Commission would have its own prosecutors and begin to prosecute people that violate other people's rights.

Debating the 2019 budgetary allocation to the Human Rights, Zambia Police and Zambia Corrections Service Commissions in Parliament on Friday last week, Katuta refused to support the budgetary allocation specifically for the HRC, saying the Commission was moribund.

"If we can only have the Human Rights Commission based in Lusaka, how are they are going to reach out to the people in rural areas like Chiengi where there are so many cases of abuse of human rights? There are so many cases which we can talk about, the right to education, right to have clean and good drinking water, sanitation, right to so many things but how does this Commission help the Zambian people? This is where we expect them to come out in full force to be the voice of the voiceless. If you go to Chiengi, the children are learning in classrooms which have grass thatched roofs, they sit on the floor. So already, a human right of that child is being violated and where is the Human Rights Commission? In clinics, women give birth on the floor and the woman's right is being violated and poor people in our areas do not even know who to approach to say 'our rights are being violated," Katuta said

"If the Human Rights Commission was doing it's part, it would be sensitising the people of Zambia, especially those in the rural areas to say 'look, your rights are being violated'. Unfortunately maybe it's because they

Honestly I feel like I shouldn't even support the budget because I have always cried that the Human Rights are mute on so many incidences. I have never heard that the human rights are now in court, they have taken this person to court... there is nothing. The Human Rights Commission is not doing much, no wonder they are not well funded. It cannot be funded if even Zambians don't even know what they are supposed to be doing. We hear of Human Rights yes, but this is the Commission we expect to work with even the NGOs and departments other and all political parties regardless. But here we see that opposition politicians are mistreated in this country. Their rights are stamped on but the Human Rights is quiet. So Madam Chair, I really have difficulties in supporting this particular budget. Last year I supported but I feel that for the time being, this Human Rights Commission should be squashed off until we see that we have a Human Rights Commission which will not be bias."

And Ngulube who castigated the Human Rights Commission for its lack of performance, suggested that the Commission be given powers to prosecute. 'We are aware that the Human Rights Service Commission has several difficulties. It's my proposal that in fact, the Human Rights Service Commission must have a structure similar to that at Legal Aid or MPA, they should have prosecutors. The Human Rights Commission must begin to prosecute some of these people that violate people's rights. Right now, I don't

know if they have any lawyers. Yes they may have lawyers around but I don't know how many lawyers go to court. We want to see a Human Rights Commission that has teeth to bite. We do mot just want to hear that 'at such and such a place, there was such and such a violation of human rights. We want to see the Human Rights Commission dragging people to court and prosecuting them. The Constitution is very clear, 'people must get compensation if their rights are violated," said Ngulube.

"We have heard a lot of complaints about the Human Rights some Commission, the Human people Rights Commission is a bad one. This a government institution that entirely depends on government for their funding and for everything. A lot of people in places like Lundazi, Mushindamo don't even know about the human rights, the only time they hear about it is when they hear it on Radio or read about it in the Newspaper. So we want the Human Rights Commission to being to take up circuits. You need to move, don't just sit in Lusaka and cry about the establishment. Let us collaborate with Zambia police, they have a lot of transport. The judiciary has a lot of transport, you can go there and ask for some transport to move your officers to go to Mushindamo district to do some operations and come back. You cannot continue crying, as a Human Rights Commission you must be a watchdog to ensure that the rights of our people are protected." Meanwhile, Ngulube also condemned the

nepotism, tribalism and favouritism in the promotion of officers at the Zambia Police and Correctional Service Commissions.

Meanwhile, Nshindano says the crowding out effect of Zambia's debt on social spending due to high interest repayments has devastating impact and undermines efforts to reduce poverty beyond the point of failure.

In an interview with News Diggers! Saturday, Nshindano said the budget rates for social protection had recorded a sharper decline in 2018 compared to 2017 with the lowest being at

42 per cent.

"The Civil Society for Poverty Reduction has noted with concern the continued low disbursements to key social sector programmes, including the Constituency Development Fund, undermining both poverty reduction efforts and the effective implementation of the 7NDP plan. We have observed that the national budgets have failed to ensure that they effectively address the high poverty levels due to low budget credibility

and under-spending, especially on social sectors. CSPR analysis of actual expenditure has continued to record significant underspending. Under-spending of the budget of over 10 per cent is indicative of a violation of the obligation to dedicate maximum available resources to the realization of the set programme objectives and indeed a violation of the right to education, healthcare, water and sanitation, social protection etc," Nshindano

said. "Social sector budgets in the five poorest provinces monitored by CSPR which included Western, Northwestern, Luapula, Southern and Eastern Provinces indicated an average of 64 per cent budget execution for the period 2018. Social protection (48 per cent) and Water supply and sanitation (42 per cent) had the lowest budget execution rates. Unlike other sectors, budget execution rates for social protection have recorded a sharper decline in 2018 compared to 2017."

And Nshindano said the country's high debt and related repayments were undermining poverty reduction efforts.

"We further note that the countries current debt position continues to be a major risk on social sector expenditure. The crowding out effect of debt on social spending due to high interest repayments has devastating impact as it undermines efforts to reduce poverty beyond the point of failure to implement pro-poor programmes to the extent of facilitating for more citizens to actually fall into the poverty trap due to high level of vulnerability of the poor to economic shocks with little or no coping mechanisms, coupled with weak social protection programs that ideally should provide the necessary cover," said Nshindano.

"This is even made worse as the little resources meant for the poor are delayed in terms of disbursements and become increasingly erratic, including cash transfers subjecting the poor and vulnerable to unbearable living conditions. To this regard, despite the current economic challenges faced by the country, we expected the government to ensure timely and adequate disbursements are made to pro-poor sectors. Poverty reduction is best served through general public expenditure investment and management processes and thereby strengthen public service provision."

Keeping Monetary Policy Rate at 9.75% best decision – Chibamba

By Abraham Kalito Chibamba Kanyama has said the Bank of Zambia's decision to retain the Monetary Policy Rate at 9.75 per cent in November is the best decision meant to encourage economic growth amidst rising inflationary pressures.

And Kanyama, an economic analyst, says an increase in the Monetary Policy Rate (MPR) would have hurt the agriculture sector further as farmers are currently seeking funding from financial institutions.

The Bank of Zambia's Policy Monetary Committee last week announced that it had decided to maintain the policy rate at 9.75 per cent. In an interview with News Diggers in Lusaka, Saturday, Kanyama said maintaining the MPR this month was the best decision, saying it would help the country recover further from an economic crisis of two years ago.

"The decision by the Bank of Zambia to maintain the Monetary Policy Rate is well calculated to maintain momentum of investment at a time when any upward adjustment would stall investments and economic growth. Remember that the economy has not fully recovered from the 2015/16 economic crisis

brought about by low copper prices, electricity outages, low food production and expenditures related to the elections. It takes a long time for an economy that once enjoyed an average growth rate of 6.9 per cent over ten years to pick up from the current low rate of growth without improving the liquidity position of the country," Kanyama said.

"A higher policy rate has a direct impact on commercial lending rates on two fronts: first, the policy rate determines the level at which government borrows from the market auctions through of government securities. The higher the rate, the more attracted commercial banks get to invest resources in government paper away from the open market. This is what we call crowding out the private sector in the credit market. The second implication is that the commercial banks will raise interest rates. This is what the Bank wants to avoid. The market had expected a raise in the monetary policy rate given the current rate of inflation. However, the Bank of Zambia chose to maintain the current momentum of encouraging economic activity. The expectation is that higher investment due to reasonably stable interest rates will induce production and cure inflation."

He further said with the El-Nino weather conditions expected in Zambia, an increase in the MPR during the planting season would have had an immediate impact on farmers who had already started borrowing

from banks in readiness for the season.

"The timing is also perfect – you do not raise a policy rate during the planting season when farmers are already negotiating funding options with commercial banks at the known rate. This would have had an immediate impact on agricultural investments. It is an El Nino year when we ought to have farmers capitalise on a shortened rainy season. If it was not for high inflation levels, the Bank of Zambia would actually have lowered the policy rate further to improve market liquidity, but the regulator has been caught in a Catch 22 situation. In short, the decision is the best under the circumstances and I encourage the market to fully leverage the opportunity," said Kanyama.

Housing and Infrastructure Development Permanent Secretary Charles Mushota on Friday told the Parliamentary Public Accounts Committee (PAC) that there is system failure as it came to light that the two officers dismissed from his ministry for allegedly stealing money were actually transferred there from another ministry where they committed similar offences. Meanwhile, Mushota got a warning from PAC instead of praise after he pleaded for commendation for recommending dismissal of officers accused of theft at the ministry.

Committee Chairperson Howard Kunda told Mushota that the committee would recommend his surcharge if he continued appearing in

the Auditor General's report to retire money amounting for not adhering to the Public Finance Management

Act. Mushota had appeared before the PAC to respond to audit queries cited in the Auditor General's report for the financial year ended 31st December, 2017.

He told the committee that the three dismissed officers at the Ministry of Housing and Infrastructure Development had earlier been transferred from other ministries after committing similar offences. The three dismissed officers had committed three different offences of failure to K346, 516; failure to retire paid meal allowances amounting to K32, 300, and failure to avail receipt books used in receipting funds amounting to K505, 250. Responding to questions from committee members, Mushota explained that one of the officers was dismissed after losing receipt books after which he obtained a suspicious police report when he was compelled to do so.

"The custodian of the receipt books is the officer who has been dismissed. The officer was told to

get a police report to that effect. and also the way it was just done. Now the officer has been dismissed [and so] it becomes very difficult for us to make further follow-ups in terms of knowing exactly where these receipt books are and how it happened that they went missing," Mushota explained. "The two cashiers whom we

understand the motive

had were the custodians of these documents because they were the ones who were receiving the monies and receipting. But before the audits, we discovered some malpractices by the two officers. So we took action as management before the audit started. So when the audits started, we tried to see whether we can get any information as to the whereabouts of these receipts [and] by this time, the two officers had been suspended. So it was very difficult. And the two officers have been dismissed. And the law enforcement agencies are investigating this matter."

He then wondered why the erring officers were moved to his ministry after committing similar offences at another ministry.

"The officers who have been dismissed really put us in a very awkward position despite that as management [or] as a ministry, we really meant well to serve the people of Zambia. Yes, we have a system failure chair. Why do I say so? It is because the two cashiers who have been dismissed were with another ministry where similar activities had happened and they were transferred to my ministry. The principal accountant had been involved in two previous cases of similar nature and he was transferred to my department," Mushotaa said. Kunda then asked Mushota why he was not following the rules that had been put in place to ensure that financial management was guaranteed.

In response, Mushota begged for commendation for dismissing officers who were "a problem" in the governance system.

"Chair I think you should commend me. What I am trying to say is that at least we managed as a ministry to deal with these officers who could not be dealt with elsewhere. You know charging an officer, you need

to have proper evidence; otherwise it becomes difficult to charge an officer. And therefore for the chief accountant, I would say that there was an under performance [because] I could not get the reports which I needed and I badly needed these reports," Mushota pleaded.

However, Kunda differed with Mushota and told him that he would not have appeared in the audit report if he was doing a good job.

"No, we are not here to commend you if you are cited there and you are submitting these anomalies with corrections, then it means that you have done something wrong and that is why you are there. So PS, we are not here to pat you on the back. We want these issues to be corrected," he told Mushota.

In winding up the hearing, Kunda said he was disappointed that the value of the queries for Mushota's ministry had escalated to over K5 million.

He further warned Mushota that the committee had all the powers to recommend his surcharge if he failed to perform his duties effectively.

"Looking at 2017 queries, the value of these queries has gone to K5, 416, 516. It is very important that PS, this issue of procurement [is dealt with] because that is what is carrying the larger amount that needs to be addressed and it is in connection with the new systems. Putting systems together that will work for you and not what you will work for those systems. Now coming to this document (the Public Finance Management Act), you need to read [and] understand it because it has provisions that will help you. And also, if you do not do your duties, you are also liable and this committee will not hesitate to recommend for surcharge because you will have failed to adhere to the provisions of this act. So based on the fact that we have referred to the issue of an accountant whom you have said did wrong [and] for you to surrender somebody who was not doing their work and no charge was made on that officer, it shows that you did not do your duties if we follow the laid down rules that are in this act," warned

Capacitating communities through holistic decentralisation: The UPND way

In 1993, Government approved the Public Service Reform Programme (PSRP) and National Capacity Building Programme for good governance. These programmes were aimed at enhancing improvements in development and service delivery in the Public Sector. It is worth noting that during the submissions to Mwanakatwe Constitutional Review Commission (CRC) of 1996, Zambians emphatically submitted in support of decentralisation through devolution.

In pursuit of actualising the constitutional provisions on decentralisation, the MMD Government launched the National Decentralisation Policy (NDP) in 2002 to respond to both the constitution and PSRP pillar four (4) which sought to decentralise some functions to Local Authorities. The implementation timelines for implementation of this policy was ten (10) years.

There is need to mention that nine (9) years into implementation of this policy, MMD did not do work commensurate with the agreed timelines.

When PF came into power, people were hopeful that they would accelerate implementation of the National Decentralisation Policy (NDP). However, PF changed the trajectory and adopted a populist stance by creating a litany of districts and styled it "bringing services closer to the people".

After they were done creating districts in areas of their interest, they changed the rules- no area with a population of less than 100,000 shall be given a district status. In the meantime, the newly declared districts do not have that population size.

It's now evident that PF government is not willing to enable people to participate in making choices for development and service delivery. In the last seven years of the PF administration, decentralisation programme has been severely slowed down in key areas that facilitate the actual transfer of authority, power and resources to the Local Authorities (LAs).

It's now our considered view that the PF has greater difficulties in respecting the will of the people by giving them functions with corresponding resources to local authorities , that is why they are procrastinating on implementation of of the NDP.

As UPND, when we take over government in 2021, we shall;

1) Ensure that people's aspirations for localised self_ determination through participation in development and service delivery is not only upheld but delivered to them.

2) Ensure that we facilitate the transfer of power, authority, functions and corresponding resources through legal means to local authorities in accordance with the principle of devolution.

3) Ensure that, in accordance with our enduring motto- People power, Our power, Our land, harmonise all relevant legislation among them, the Local Government Act, Planning and Budgeting Bill, Executive Functions Act, Ward Development Bill, and various regulations within twelve months. This is to ensure that decentralisation is strengthened and legally anchored. This approach leads to truly empowering our people through legal means to decide and confront issues that challenge them in pursuit of good living standards.

4) Ensure that we strengthen substructures such as ward Development committees

by capacitating areas of community mobilisation, planning and budgeting, project management to ensure effective execution of community projects. This will in turn lead to efficient and effective utilisation of public resources.

5) Ensure we provide leadership in devising mechanisms to enhance Local Economic Development (LED) through development of cottage industries to enable local authorities broaden their revenue base,

6) Ensure that all revenue sources that are earmarked for local authorities either by the constitution, subordinate legislation or recommendations from consultancy studies are reverted to local authorities with minimum delays,

7) Ensure that the central government truly plays it's appropriate role in a decentralised environment, which is policy promulgation, standard setting, monitoring and evaluation.

We believe that at this level of world order and the thrust with which world leaders are pushing for good governance, it is imperative that development choices are no longer in the hands of the higher level elected leaders but with the Local people themselves through their local authorities.

The central government's role should be that of providing policy guidance, monitoring, and evaluation of policy implementation to ensure adherence to national goals and international protocols.

Goal driver Business-Setting objectives

Before you consider financing your business, ensure that both your personal and business goals are clearly defined. Even in putting up a business plan that will guide the growth path and process for the business, an entrepreneur will need to establish personal goals. In short, everyone must know what they ought to achieve at every stage in life. The business in turn should assist you achieve the desired goals. Entrepreneurs do not work for the business; in real terms, the business works for them. It is a vehicle towards the achievement of the set objectives.

It is actually inappropriate to subsidize a company's operations as owner. Good businesspeople hardly use personal vehicles to carry out company work unless the company pays for it. It is the business that should instead subsidize your operations because that is why it exists - to support your personal goals. Owners who plough capital into a troubled company do so with the expectation that they will be paid a high return after a period of time. Besides personal goals, an entrepreneur will need to be clear about business goals. These precede the financing decision and they determine the growth pattern of vour business. It must be clear from the outset what your business is all about you and what you want to achieve from it. One couple started a service station but without understanding what it was all about. They went on to invest all their earnings into property in the quest for rapid expansion. They forgot that the service station needed a lot of liquid cash as many oil marketing companies such as Bp, Total or Caltex will have limited liquidity

provisions. They want cash. The consequences were disastrous. All their properties that existed prior to this business have been taken over by banks that helped finance the purchase of daily stocks of fuel. You can never have a realistic business plan without getting together sound information on your business. Successful entrepreneurs avoid plunging resources or expanding rapidly into investments they know very little about.

First, the main objective of a business is to produce goods and services. This point needs to be emphasized because most of us

set up businesses for the primary purposes of reaping off people. We seek to be rewarded before we have produced a good or service that fully satisfies the customer. An example is of a gentleman who set up a company selling computers and software. He was awarded a contract by the government to deliver a number of computers. He received a down-payment but failed to deliver. He later fled the country. Unless you are sure you will deliver goods and services for which you should be paid, you are simply defrauding others. Second, your business objective is to succeed. Entrepreneurs never plan to fail. A good business plan should fully support this function of success. Remember that from the

moment you set up your business, society and contemporaries watch you. Some will not bother about whether you make profits or not. The fact that you are functioning triggers some expectations of goodwill from them. Some sentiments may be negative and others positive. Success in this case can be measured by the fact that the business has finally established the dream of producing goods and services. It is about being in the right business.

Third, your business goal should be about making profits. You are starting a business for positive reasons - you saw an opportunityyour business plan should, therefore, project profitability otherwise no one will fund it. A business is an investment and by definition, an investment is the creation of money through the use of capital. In other words, your business should earn a reasonable return. Once again, as discussed in the previous chapter, you are in business to make money. Fourth, your business goal is to grow. It takes courage to start a business but it takes much more to keep it going successfully. Some businesses have been well established and operate profitably but they have been producing the same quantity for the past ten years. Growth is measured by actual geographical expansion, product volume, number of employees, profitability, and levels of assets and to some great extent, social responsibility. The bigger you become, the more responsibilities to the community you may have! But this expansion should be incremental otherwise it will be recipe for disaster. continue We can't Mansa crying over Batteries, Kapiri Glass manufacturing, Mwinilunga Pineapple cannery, Chipata Bicycle Plant or Mulungushi Textiles, as if our national leaders don't have brains any more. If investors don't want to pour money into those fossil companies and revamp them, showcase something else. Open up the rest of the provinces and let the local people partner with the foreigners in opening up value-addition businesses in the agriculture sector, tourism and what have you.

However, to maximize national benefits from these Provincial Expos, government will have to do more than just "creating a conducive environment" for investment. A conducive environment could mean simply facilitating for the quick processing of operating licenses, or frankly, keeping an opendoor policy to corrupt investors and calling that 'the ease of doing business in Zambia.'

We want government to do things differently under this initiative. We need government to first of all, guard Zambia's interests jealously and put citizens first! Let there be a system that follows through to ensure that the local people are partnering with those who are seeking to invest in these regions. This must not be about creating more casual labour for Zambians. Our people have the brains, they have the business ideas, they must be empowered with land and other necessary requisites so that they can have meaningful leveraging power as they partner with those who are coming into the country.

When we hear that the Chinese are opening up a US \$300 million private multi-economic facility zone in Ngabwe District, we also want to hear the names of the Zambian partners in this massive investment. The Central Province Investment Expo was not a conduit for more shady deals and giving land to foreigners, it was about getting Zambians involved in the industrialization initiative.

We want to admit that the PF has got the tools under this undertaking to fulfil just one campaign promise, at least for the people out there. Yes, they have built and continue to build road infrastructure – leading to these provincial centres where investors are being enticed, but if they mishandle the undertaking, it will become a source of further pain for the suffering Zambians! The start looks sensible, but we are worried about poor finishing.

very long time, that should unleash women potentials and women contribution to national development. I have seen and read where Mizinga Meru was saying 'it is extremely difficult for a woman to rise to the top? Yes it is difficult for a woman to rise to the top in decision making ranking and also in politics and the reason why it is so difficult is that men and women have not worked together to try and eliminate challenges inhibiting women progress, with men being the major culprits in making it difficult for women to progress especially in politics," said Mweetwa.

LAZ's support for punitive verdict on Chifire shocks ACA She said LAZ's position on the censure

Alliance for Community Action (ACA) executive director Laura Miti says she is surprised that the Law Association of Zambia has welcomed a punitive judgment slapped on Gregory Chifire for contempt of court.

Chifire, the director for Southern Africa Network Against Corruption (SANAC), was last week sentenced to six years imprisonment after he was cited for contempt of court for his remarks against Chief Justice Irene Mambilima and the judiciary following the disposal of the Stanbic Bank Vs Savenda Case.

Chifire was charged with four counts of contempt of court until his sentencing last week which was presided over by deputy Chief Justice Marvin Mwanamwambwa, Supreme Court judges Evans Hamaundu,

Mumba Malila and Rhoda Kaoma. Following the judgment, the Law Association of Zambia (LAZ), through its president Eddie Mwitwa, welcomed the sentencing and explained that it would send a warning to Zambians who were in the habit of launching "unwarranted attacks" that tarnished the image of the judiciary.

But in an interview with News Diggers, Miti said it was worrisome that LAZ could support such a "harsh judgment" by the courts against Chifire.

"I was surprised at the position that LAZ took, especially that they did not

first of all unpack the full judgment before the public. They just gave a wholesale prey for the judgment, which is not enough. And then also I am surprised that they would welcome such a punitive judgment when LAZ used to prioritise ensuring that people do not speak up around matters rather than looking at what is just," Miti said. "I think it's a bit worrying, I would have liked them to interrogate the questions, for example, of whether this law is a kind of law we want on our statutes or the whole procedure where the judges that are aggrieved are the ones who then sit to try and then also make judgment. This is something that I would have liked to hear from the Law Association of Zambia."

and yet the potential that is here is too massive. If only we can place emphasis on cotton growing here it will have the price, and it will be what this country would expected to be," Kalaba said. The Democratic Party 2021 aspiring presidential candidate wondered why cotton growers have been discouraged when the province has fertile land.

"The soils are favourable and yet we are discouraging cotton growers because the rice is just too low. We need to begin insisting where it really matters, and for me, the only way for this country to be what it should be is by placing emphasis like I said on agriculture. We have to start using hands like the Chinese did in 1980s to get ourselves out of it," said Kalaba, the former Foreign Affairs Minister.

"Agriculture can create jobs and Dr Kaunda in the 60s, 70s and 80s insisted on agriculture. The Chinese that we are talking about today, in 1980, it was the Chinese revolution that changed that country. So, for us, if at all we want to get out of this doldrums, we will need to be doing agriculture."

Kalaba also promised that once voted into power in August, 2021, he will ensure he develops all parts of the country.

Earlier, Kalaba paid a courtesy call on chief Chanje of the Chewa speaking people.

And farmers in Lumezi, Mwase and Lundazi towns have assured Kalaba of a vote in the 2021 presidential election.

Meanwhile, Kalaba asked Christians of Luangani District to pray for him as he pursues the 2021 presidential race when he visited the area, Sunday.

Kalaba who attended Church service the at Chimphinga's New Apostolic in Chief Saila's area, said he was touched to see how people in Luangani were suffering.

"I have come to congregate with you because as you are praying, you should also remember me in your prayers that Harry Kalaba came and left his position so that we should work together. I have seen how people here are suffering and I am so touched. I prav to God that he should touch your hearts so that you should vote for me in that year so that together we can change this country," said Kalaba.

"From 1960, 1970 and 1980 when Kaunda was a leader in this country, you saw that agriculture here was on top but today farmers have sold their maize and government has not yet paid them and this is the time they are getting fertilizers. The poverty levels in our houses is

getting high. Our children are failing to go to school because you parents have no money. And this government has not paid you. So let's work together so that we end this problem. Look at the roads. They are in a bad state and no transporter can come her to buy your commodities."

And Elias Sakala, a warden at St Johns Anglican Church in the same area, said the Church would continue to pray for Kalaba so that once voted into office in 2021, he may redeem them.

"We will continue praying for you so that your works would redeem us. As a church, we shall remember you in prayers so that God may make you a good leader. As you have seen for yourself that we here are facing a lot of challenges. The church cannot do anything to help in because

there is no money. As a church we have a lot church projects which have stopped due to lack of money. We have old people who cannot but the church have failed to help them," said Sakala.

Meanwhile, village representative Joseph Chirwa said divisions in the PF were a source of worry to them.

"The truth is that PF lacks truthfulness. Look there is confusion. We have MP Charles Zulu who won on the same ticket but other PF members are coming to claim that they are also MPs and they are putting people in positions. Would you call that as being open to the people? So the

truth is this man ' Kalaba' was a Minister but because he saw that this party is not truthful to the people, he resigned. We are suffering here because of luck of truthful by the government leaders," said Zulu.

Reject Lungu like Easterners have done, Mucheleka tells Northerners

UPND deputy secretary general Patrick Mucheleka says Northern Province must reject President Edgar Lungu the way Easterners have done. On Saturday, President Lungu said he felt rejected by his own people from Petauke after a UPND candidate beat PF in Lusinde ward.

"It is always heartwarming to be here in Northern Province, especially that this is the stronghold for PF. PF is a political party I belong to, and that's where I am President, so when I am here I feel very much at home, unlike Petauke District. Of course Petauke, that's where my mother and father come from, but they don't seem to agree with us, they are voting against us," President Lungu said, much to the laughter of the Investment Expo delegates.

"What people want is that once their own farming activity becomes profitable, then they will have money in their pockets, which Lungu has denied them. So, even when the people of Petauke reject him, we are not surprised because they are sending a clear message. This is why for me; I can make a passionate appeal to our people in Northern Province, who are being hoodwinked to emulate their cousins in Petauke, who have out-rightly rejected Lungu and PF, even if he claims he comes from there. People want to eat, they want their own money. It is not about giving them chitenge, T-shirts, or when he's passing he buys them Chibuku, no! People want sustainable means of creating their own income, something which Lungu has killed," Mucheleka

"Can the PF and President Lungu tell me what they have done in Northern Province from the time he took over? Not even a single project, he hasn't built even a single toilet in Northern Province. The only thing that you find there are the projects that were initiated by the late president Sata. In Kasama, for example, they promised that they were going to build a university, but up to now, they have not started building. They promised to build a state-of-theart modern stadium, but they have not done that; they promised to do the airport, but they have not done that. The only section of the airport that they have dealt with is where they were holding the so-called Northern Province Investment Expo. There is nothing to show that Lungu feels at home in Northern Province."

He said President Lungu was being hypocritical because he had done nothing for northerners.

"President Lungu should not mock the people of Northern Province by pretending that he feels at home there than in his own area, Petauke. He is just being hypocritical, what has he done from the time he took over from late president Sata? If there is one province that overwhelmingly supported him, it was Northern Province, and I know for sure that, Chishimba Kambwili, Felix Mutati, KBF (Kelvin Fube Bwalya) and many others from Northern Province went out of their way to support him wholeheartedly, even when some of us knew that he was not going to appreciate what they were doing for him. And you have seen what he has done to Mutati, you've seen what he has done to Kambwili, you have seen what he has done to KBF, you have seen what he has done to so many people from Northern Province. has completely squeezed all those who worked so hard in PF under late president Sata out of PF," Mucheleka said.

As if that is not enough, in Petauke, from the time he took over, he started building a very big hospital using tax payers' money. But people in Petauke are small-holder farmers and if you want to look after them, the best you can do is to support wholeheartedly the agricultural sector because that is where they get their livelihood. But Lungu has killed the agricultural sector! Farmers everywhere have not been paid and this is why people in Petauke have sent a very clear message to Lungu and his cohorts in PF that they will not eat the big hospital that he's building in Petauke! Mucheleka charged that President Lungu was creating a pool of nonentities who he knew could challenge him in Northern Province.

Barcelona set new wage record as football salaries continue to climb

As wages and transfer fees continue to rise in football, Barcelona have set a new mark by becoming the first team with an average firstteam pay in excess of £10 million (\$12.81 million) a year, according to the latest Global Sports Salary Survey. This season, the Spanish giants will pay the 23-man first-team squad an average of £10.45 million (\$13.39 million) before bonuses with

that figure rising by 33 per cent since 2017-18.

Lionel Messi's new contract helped boost that number, as did the signings of Philippe Coutinho, Arthur, Malcom and Arturo Vidal, each of whom helped lift the club's wage budget.

New contracts for familiar faces also add up with Gerard Pique, Sergi Roberto, Samuel Umtiti and Sergio Busquets all signing new deals in 2018. In second place behind their rivals are Real Madrid, whose players earn an average of £8.1 million (\$10.38 million) a year, while the next six spots are all filled by teams from the NBA with the Golden State Warriors and Oklahoma City Thunder leading the charge in third and fourth with salary averages of £7.85 million (\$10.06 million) and £7.82 million (\$10.02 million) respectively.

The NBA remains the highest-paid league in the world with average salaries of £5.9 million (\$7.56 million) this season.

Manchester United are the highest Premier League club on the list in 10th place with £6.53 million (\$8.37 million) while Juventus jumped from 32nd in the world to ninth following the summer signing of Cristiano Ronaldo. Manchester City (£5.93 million/ \$7.6 million) are the next highest English club in 20th, with Chelsea, Arsenal and Liverpool all occupying spots in the top 40. Goal.com

'We'll be there until the end!' - Liverpool star Shaqiri issues title warning to Manchester City

Shaqiri has Xherdan warned Manchester City that Liverpool "will be there until the end" in the Premier League title race. The Reds kept up the pressure at the top of the table with a hard-fought 3-0 victory at Watford on Saturday, their 10th from 13 league games so far this season.

Jurgen Klopp's men remain just two points behind City, although Pep Guardiola's champions have shown little sign of feeling the heat of late, winning 4-0 at West Ham while Liverpool were grafting at Vicarage Road. Still it promises, at the very least, to be a tighter chase than last season, with the Reds looking better-equipped to last the course than for many a year. Their clean sheet on Saturday means they have now made their best ever start to a league season defensively, with just five goals conceded from 13 matches.

Shaqiri was all smiles when stopping to speak to reporters after the Watford game. The Swiss star, clearly, is enjoying his football following his £13million (€14.7m/\$16.7m) summer switch from Stoke.

And he had a message for City.

"We're going to be there until the end!" he grinned. "We don't have to look to Man City, we just have to look to ourselves and try to give our good performance on the pitch and win games, that's the most important thing.

"Every game has its own history and we have to look game to game and not look where we're staying at the end of the season. When you win games like this, we're going to fight to the end for a lot of things so I think we just have to keep going, keep working hard and win games." Shaqiri's own form has seen him play his way into Klopp's first team, the 27-yearold starting six games in recent weeks, including Liverpool's last two in the Premier League. During the international break, he starred for Switzerland as they qualified for next summer's UEFA Nations

League finals.

"I'm feeling good, I'm fit and that's important for me," he said. "I think you can see that also on the pitch, that I'm settling in well with the team.

"I think you saw that also [against Watford]. First half, I tried to give them some good passes. I'm feeling good, it was important to win and it was a good win." Klopp has described the coming weeks as "the most intense period of the season", with Watford the first in a run of 11 games in less than six weeks.

Next up for the Reds is a Champions League trip to Paris Saint-Germain on Wednesday, with a Merseyside derby against Everton to follow at Anfield on Sunday.

Shaqiri is already looking

Hamilton and Vette swap helmets

In a rarely-seen showing of competitive camaraderie, Lewis Hamilton and Sebastian Vettel swapped crash helmets to demonstrate the mutual respect between them after Sunday's Abu Dhabi Grand Prix.

The five-time champion Briton, of Mercedes, and four-time champion German, of Ferrari, finished first and second in Sunday's race and have won eight of the last nine drivers' championship titles.

"The ultimate respect between racing drivers," said Mercedes on Monday in a comment on Twitter alongside a short video clip of the pair exchanging their head-wear.

The duo have scrapped for the last two world titles with Hamilton coming out on top both times, but their rivalry has been characterised by a fair sporting relationship.

Hamilton said the exchange of their helmets was an honorary gesture that was comparable to players shirts swapping after football matches.

"This is kind of an honorary thing that drivers do, so this is the highest regard of respect that we can have as drivers," he said in the video post. "This is like our jerseys. So here's one of mine... AFP
