### Most mining licences issued to people with no capacity to operate, says JCTR

Diggers in Lusaka, Tuesday, Chongo said the legislation for the awarding of mining licenses would help in reducing the number of

dormant mines around the country.

"Only three out of 200 registered mining companies are operating

in Lufwanyama district. Among the 200 registered mining companies most are Zambian firms that are not operating because of

lack of capital. We need to be transparent and collect more tax revenues for the growth of our economy. So, we can clearly see that a lot of people rush to go and get mining licenses which they either rarely use, or they do not have enough finances to see to it that they run a certain mine which they registered under their name. and its government jobs to ensure that activities are regulated because there are other people who are well able to get licences and run mines," he said.

Earlier, Chongo stressed the need for mining companies to contribute to children's rights and development.

He was speaking when he presented findings on a case study on the role of mining companies in Lufwanyama District, in promoting children's right to education, health and sanitation.

"The council is not collecting enough property

tax from mines because the mining area in Lufwanyama District needs to be surveyed so that the numbering can be completed as quickly as possible. There is also need for enhanced security in the restricted mining areas and introduce stringent measures to deter illegal mining activities, as well as encroachments into the mining area. The mining companies working in Lufwanyama District were contributing to the promotion of children's rights to education, health and water and sanitation. Community members

however feel that this contribution has been limited and it was felt that there was need for a more systematic approach effective contribution towards enhancing the access to children's rights to education, health and water and sanitation," said Chongo.

#### Expect no fuel price reduction, we're using old stock - Siliya was going to do about the

Government has immediate plans of reducing fuel prices despite falling oil prices on the international market because it is still using old stock, says Chief Government Spokesperson Dora Siliya.

And Siliya says Home Affairs Minister Stephen Kampyongo and NDC leader Chishimba Kambwili were speaking as colleagues who have known each other for a long time in the recorded conversation that went viral, Tuesday.

Addressing a press briefing at her office in Lusaka, Wednesday, Siliya said it was not possible for government to reduce fuel prices drastically just because the price of oil on the international market had fallen.

"Even though international oil prices have come down, what is currently being consumed in the country in terms of stock is stock that was bought at a time when the oil prices were high. And using the cost plus model, what the Ministry of Energy does through ERB in terms of procurement is basically look at the cost of fuel at that time, but also much importantly, the value of the Kwacha vis-a-vis the Dollar at that time and these are the two issues that affect the

cost of fuel. A lot of citizens have been expressing concerns and rightly so that the international prices for fuel are down to about USD\$54 or so. [So they are asking] 'why haven't the prices of fuel come down in Zambia?' We will circulate that statement from the ERB, from the Ministry of Energy," Siliya said.

"But the input of that statement is basically that the current stock being consumed was bought at a different time when the price of fuel internationally was high and the rate of the Kwacha to the Dollar was high. So using their basic cost plus model, they have to meet the cost of the actual procurement of the oil every time it comes into the country. So I though I should respond to that because it's a question I have been getting the last two days. It's been an online discussion for quite a while."

Meanwhile, Siliya said Roan member of parliament Chishimba Kamwbili should have nothing to fear as he reports himself at Luanshya police station if he has not done anything wrong.

"Am not so sure that every time somebody is asked to appear before the police or whatever authorities [then] it must be an issue for discussion that 'it's because of this person or that person'. I am not so sure that that's the wav we should be looking at it. I think that when the authorities call each one of us to appear before them... and in this country no body has ever been exempted. Presidents have appeared before, ministers have appeared before police, politicians have been called to the police, ordinary citizens have been called to the police... so am not so sure that it should become an issue when somebody has been called to appear before the police. I think that when one has done nothing wrong, there is nothing to fear. I believe that sometimes police need to be allowed to do their work so that they can tell us what their findings are. That's why they are there, they investigate, they follow up on issues. We must give the police time to do their work," she said. Asked what government

recent incident where Home Affairs Minister Stephen Kampyongo and Kambwili exchanged bitter words in a phone conversation, Siliya said the two were talking as people who have known each other for some time.

"I think there are two things here. I think we must must separate two colleagues, two mates, two people who've known each other for a long time and talking to each

other as colleagues. I think we really have to separate discussions of a personal nature by two people who have a long history from official discussions and positions of government. You are the media and you don't live in a vacuum, you live in this country with all of us and you have to understand the complexion of certain discussions, especially these we see online," said Siliya.

### **Intra party elections dividing PF** in Kitwe, says losing candidate

Patriotic Front members in Kitwe have complained that the party is currently experiencing a lot of divisions among political leaders.

In an interview yesterday PF losing ward secretary Michael Mulenga said that the PF in Kitwe has been divided into two camps, one for Foreign Affairs Minister Joseph Malanji who is also PF member of parliament for Kwacha and another camp for Christopher Kang'ombe who is PF Kitwe District Chairman.

He said Malanji was refusing to work with some PF members accusing them of being Kang'ombes followers.

Mulenga said PF members were calling for the nullification of the intra-party election results in Kwacha constituency on grounds that they were not free and fair.

He added that the aggrieved members had written to President Edgar Lungu and party Secretary General Davies Mwila, but that they had not received any feed back.

"We were told by the PF leadership that we were free to contest any position in these elections, but when we formed a group for all those who wanted to stand, we were accused of being rebels. Were accused of going against the party and that we were having secret meetings," Mulenga complained.

"We have written a letter to the SG and the President demanding that the elections are nullified because the returning officer and the councillor who were chairing the elections were found in the same meeting were petitioned were being heard. And

during elections Malaji had dished out some money in his constituency even when leaders where warned not to be found taking part in the elections."

But Copperbelt Provincial PF chairman Stephen Kainga said there was no division in the party.

He said it was normal for people to form groupings during elections and incline themselves to a particular candidate, and that did not mean the party was divided.

"We did all the sittings and every thing has been communicated to the District through the constituency, so as we speak there is no petition that is still pending because if there were still issues we wouldn't have started the constituency elections in Chingola and Chililabombwe districts," said

"I would want to start by saying that the budget line on agriculture is very low. We are even failing to meet the protocols that we've signed on this very important aspect of our life. The reduction of the budget of agriculture

shows the lack of political will towards this important ministry. If we cannot put our money into agriculture as a nation then I don't know where else. The Minister of Agriculture spoke about having only bought a 100,000 metric tonnes this year when actually FRA was supposed to have bought 500,000 metric tonnes. That has an indication of what is going to happen next year. If the weather this year does not go in our favour and we have failed to meet the expectation of this year, it's a sure sign that we are expecting people to be hungry next year,"

Mwashingwele said.

"If FRA cannot even meet their target, what are they there for? If they cannot protect the security of the food of this country, what are FRA there for? Why should we go hungry because they didn't do the due diligence? The farmers did their part, they grew the maize. But it is because of giving them a raw deal that the farmers chose to sell elsewhere. When we look at this, it gives us a very insecure 2019. We pray that the weather will be for us but in the event that the weather is not for us, it means FRA will have to take responsibility for what may befall the country next year. I don't think I have heard anything in the minister's policy statement saying 'FRA didn't have the money'. They had the money but the farmers refused to sell to them. These are the consequences of lacking political will. Farmers are already out there in the field, they are toiling but if you look at FISP, it has gone through so many phases that sometimes even me as a member of parliament I don't even understand how it's working this year."

Mwashingwele blamed human resource in the Ministry of Agriculture for some of the mistakes in the sector and called for some reshuffles.

"We have farmers in Katuba who've deposited money for the past three years but the government has not done the due diligence for them. They haven't put in their part, and this farming season, we've come up with a new method, I don't know whether there are three types of Farmer Input Support Programme that the farmer is going to encounter. Before farmers could understand what the FISP programme was all about, people were talking about Smart Zambia. Before they can even understand basics, there is a change, but to whose advantage are these changes happening? Sometimes we should be specific, the human resource in the Ministry of Agriculture, I think some of them have over stayed in particular stations and as a result, these are the ones who are giving us problems. Honourable minister, I think it's time some of these people should be moved, especially in Chibombo district. You would find irregularities Mr Chairman happening every year," said Mwashingwele.

"They are paying the people that don't even deserve to receive the support. We are paying people that don't even exist, they only exist on paper. But when you go on the ground, you don't find them. I don't know if the Ministry of Agriculture is following this up. We have institutions like **IAPRI** who've research on agriculture and they have given us valuable information. But as a country, we are not following what the experts are saying, we are doing things on our own. This FISP thing if we don't know how to handle it, let us go and support Nitrogen Chemicals of Zambia. Can we support production. So unless we change, otherwise it is folly to expect a new result when we are doing the wrong thing all over again and expect that we will have a different result."

Meanwhile, Siliya said there was need to invest in none rainfall dependent equipment to turn agriculture into a viable business.

"We have to separate maize from just being the food in the country and expand the food basket... if we are going to look at agriculture as a business in this country, then we have to invest and investment is beyond FISP. It means that we have to invest in electricity for irrigation. So that we are not here talking about rain-fed agriculture. It means that we have to invest in deep tanks so that we can support the livestock sector which is part and parcel of the crop agriculture. We also need to separate vulnerable and retired farmers from those who want to be business men and women in this sector. We have to invest in research, we need to have evidence based agriculture, and we on this side are trying to ensure that while we support the vulnerable farmers we all need a a whole new mindset," said Siliya.

In winding up debate, Agriculture Minister Michael Katambo highlighted some of the initiatives that his ministry had embarked on to improve the sector.

"We realise that we may be faced with a lot of challenges as a ministry of agriculture and a lot of opportunities can grow the sector sustainable and efficiently. It is important to underline the importance of various crop production for agriculture, especially in the rural communities and our big commercial farmers. Mr Chairman, on the issue of climate change, the ministry is formulating a project that is aimed at addressing the effects of climate change by promoting interventions that strengthen the farmer resilience in climate change, especially in areas where we experience adverse effects of weather. These interventions will respond to the issue of irrigation and promotion of dam construction and drought torrent crops that can uplift the livelihood of our citizens," said Katambo.

## By Sipilisiwe Ncube Ministry of Higher Education Permanent Secretary Mabvuto Sakala says the there is no possibility of having ghost students at the University of Zambia (UNZA) or Copperbelt University

(CBU).

And Sakala told the parliamentary Public Accounts Committee (PAC) Wednesday that his ministry will enforce recoveries of accommodation allowances which were paid to accommodated students.

Sakala said this when he and his team appeared before the said committee to respond to audit queries cited in the Auditor General's report for the Financial year ended December 31, 2017.

"A comparison of the CBU GRZ sponsored students to the Bursaries committee sponsored students revealed that there were 1,988 who were appearing on the bursaries database GRZ sponsored students but were not found on the CBU overall GRZ sponsored students. Consequently, it was not clear how bursaries were supporting students who were not on CBU database," the AG report revealed.

The report further revealed another K655,000 in accommodation allowances which were paid to accommodated

tudents.

"Accommodation refunds in amounts totalling to K655, 000 were paid to 754 students despite appearing on the list of students accommodated by the universities and appropriately amounts totalling K1, 979, 500 were invoiced in respect of accommodation to the said students. As of 31st August 2018, the amounts paid to the students had not been recovered. [Further], accommodation and tuition fees in amounts totalling K5, 432, 88.42 were invoiced by CBU for 210 students who were not on the applauded schedules. No evidence was availed to ascertain whether the students were authorised or approved to be among the students supported by government," the report revealed.

In defence, Sakala said the Loans Board was in the process of effecting recoveries of the said funds from the undeserving students.

"The Higher Education Loans and Scholarships Board is in the process of recovering the overpaid funds, we acknowledge and from the continuing students by withholding their subsequent payments while recoveries from students who have since graduated will be added to the loan repayment amounts. A letter has been written to CBU notifying management to inform the affected students about the pending recovery. All the 210 students were part of the 8, 173 students [on] provisional list that was used by CBU when billing the Loans Board, provided the students had registered. However, the students needed to be screened by the Bursaries before being put on the bursaries database. Therefore, CBU invoiced correctly as all the 210 students were part of the students awarded with loans by the Bursaries Committee," Sakala responded.

In another query, it was revealed 3,782 students at UNZA who were not on the university bill were paid meal allowances amounting to K8, 428, 113. The audit report revealed a further K71, 082, 937 which was irregularly paid to 3, 568 students who were appearing on the UNZA invoice but not on the bursaries list of GRZ supported students.

In responding to the above query, Sakala said the matter had already been reconciled.

Milenge PF member of parliament Mwansa Mbulakulima then said it was shocking that the controlling officer was giving technical responses which were difficult to verify before the committee.

He said from the presentation, it was clear that the ministry under

review needed serious help as it had so many problems. "The system of recovering from [them], if we cannot recover from those who have honestly completed [because] up to now we are still looking from them, how are you going to recover from these people over this excess payment? There are many components here. We can ask questions here but this is not going to be exhausted [because] this is technical. The next page chairperson [on] 'failure to lock down the default administrator account system' what do you want us to ask? It's technical. We can take two days," Mbulakulima

observed.
"The next page is 'failure to patch the MSQL database' [and] look at the answer, it is also technical. That is why there is no need colleagues to even start asking questions from those files, we have to find a way as a nation. This is

where they have to tell us [that] they need help. And beyond this chair, they have said 'available for verification' [again and again but] but it's only the auditors who can verify whether this is correct or not correct but even the AG's office is handcuffed today. How can they comment on something which they haven't even seen? So it is really a total confusion [because] we believe that a lot of money has been going to our institutions but not accounted for. So for me really, it is a national disaster which needs concerted efforts and there is no need to be defensive." It was at this point that Sakala ruled out the existence of ghost students in the named public institutions.

"Going forward chair, we can avail the extraction of these students to the committee. The possibility of ghost students does not arise. What may arise is that when a student registers, for example, and they fail to meet the threshold to move to the next year, they are removed from the list of the beneficiaries of the bursaries or the loan scheme until they meet the criteria for re-entry but we will still maintain them on the database and that is where there is one of the discrepancies. When they meet the threshold to be readmitted into the university, then we reactivate their loans. But in terms of ghost students, it's not possible to have them chair because we have a situation where the universities will give us the list and then we compare with the list on the bursaries," Sakala said. Committee Howard said it

And Committee Chairperson Howard Kunda said it was worrying that the ministry responsible for imparting skills to learners could have so much confusion surrounding its departments.

"[You know] this ministry has been there and we look at this ministry to be a ministry that should be out at the apex because this is what gives us the manpower that is needed for this country. You teach these students so that they can come out and give the best to this country, but if there are these confusions that we have seen and highlighted in discussions here, it gives us an indication that we need to be worried with what is happening," said Kunda.

National Democratic Congress (NDC) leader Chishimba Kambwili has dared Police to arrest him saying he is now fit and ready to face police cells or prison, unlike earlier this year when he was sick and fainted upon being arrested.

But the Roan member of parliament says he will be unable to report Luanshya Police investigations until next week because he has a court case tomorrow, Friday.

Meanwhile Kambwili says he is consulting lawyers to consider pressing charges relating to threats issued by Home Affairs Minister Stephen Kampyongo towards him.

On Monday, the NDC leader confronted Kampyongo via a phone call informing him that he was aware of governments scheme to charge him with treason, a conversation where the Home Affairs Minister subsequently responded that he intended to teach him a lesson.

This was followed by a police call out, summoning Kambwili to appear for questioning

Addressing the Press in Lusaka, Wednesday, Kambwili said he was consulting lawyers on constitutional issues to raise against the abuse of Authority exhibited by Kampyongo.


"I think by and large we are consulting with our lawyers we want to raise constitutional and the issue of abuse of authority against the

minister. Because there police cell or prison as is no way that a Minister was the case earlier this can be directing the year when he was sick Police to arrest innocent "This is what we chose citizens, to make matters

to speak on behalf of the people. And I will not be intimidated. And if they think I am scared of going to Police cells or going to prison, I am not scared. Let them not think of the first time that I was sick, and they think that, that's my nature. If they want to arrest me, let them arrest me when I appear before them. Obviously, they want to intimidate me to shut me up for speaking on behalf of the people of Zambia but me I was born to speak on behalf of the people of Zambia. I am a Member of Parliament; my job is to speak on behalf of the poor and I will continue doing that."

And Kambwili says he would be unable to report to Luanshya Police for interviews tomorrow.

"We are supposed to go to the Police on Thursday, now we will not be able to go there on Thursday because we have a court case of Friday before Magistrate Mikalile. And its not easy to go to Luanshya on Thursday and start coming back for a court case. So, my lawyers will communicate to them when we will be able to go there, which should be next week. So that's the position. We are aware that government has been trying for a long time to have me arrested on trumped up charges and detained. And we are reliably informed that they have issued instructions that I should be arrested and detained, but I want to tell them that I am ready for them. I am not scared of them," said Kambwili.

The summoning of Dr. Kambwili by Luanshya Police has not come as a surprise to the NDC. We saw it coming and we know the people behind this plot.

Dr. Kambwili is being persecuted politically for merely pointing out at the wrongs that the PF regime has been perpetuating.

It is an open secret that comrade Kambwili is now a threat to the system.

The system knows that Dr. Kambwili is not just an ordinary political figure. Comrade Kambwili enjoys massive following from a number of Zambians.

# **act:onaid**The untold story of the mining communities – Zambia

Africa extractive industries are controlled by the Trans-National Corporations whose interest is to explore natural resources as part of business but with recorded violation of human rights. Zambia is not spared from this exploitation and local communities are experiencing untold suffering due to various forms of unfair business activities. TNCs are saying its business but who is benefitting and to whose expense?

The stories from the mining communities of Copperbelt and North-Western provinces provide with a testimony that nothing is good from the mining companies. Some communities' in Zambia, mining is synonymous to disrupted livelihoods, environmental degradation, absence of or unfair compensation and pollution.

#### Tsopano community – living in dangerous houses

Tsopano community also known as Njanji has suffered negative consequences due to the mining operations of Konkola Copper Mines plc (KCM), one of Africa's largest integrated copper producers, a subsidiary of London-listed Vedanta Resources Plc. Tsopano is a small community with a population of about 2500 people. It is located in the district of Chingola in Copperbelt Province of Zambia

The community raised concerns about air pollution from Sulphur acid emissions which come from the local mine. Also houses have cracked due to blasting operations by the mine from its Nchanga open pit. The houses have been cracking since 2001 due to the blasting being done by KCM. About 109 houses were affected in 2011, but only 20 households were relocated to a different area of which the houses are not big enough for accommodate all family members. KCM has been taking the relocation as part of social responsibility yet their mining activities are impacting negatively to the local people. ActionAid has been working with Catholic Diocese of Ndola to ensure the mining company respects the human rights of the local community.

"We have been here for so many years and tried to engage KCM, the council, Zambia Environmental Management Agency and other relevant stakeholders in trying to find the way forward for the rest of the 89 households and what come out are just promises. Unfortunately, the mining company is taking the compensation on relocation as a humanitarian intervention yet the houses are cracking due to their mining activities," said Langton Banda (not real name) in his cracked house

#### Water not fit for human consumption due to mining activities – Musele Community

"Rivers and streams are largely polluted with poisonous chemicals flowing from the mine downstream due to the First Quantum Minerals Ltd (FQM) mining activities (a Canadian based mining and metals company). The boreholes for domestic use have become reservoirs for contaminated water. Graves are over flooded with water believed to be resurfacing from the Musangezhi and Chisola dams which were constructed by the mining company to be source of water for their mining activities. The surrounding villages of Kawelanga, Kankozhi and Musele have no alternatives to clean and safe water but risk to drink the contaminated

water running over the graves and also the same villages have nowhere to bury the dead. This is the first time to have such ever experience since the Musele community inhabited the area," said Lawrence Mwanangombe of Musele Community. FQM began a borehole drilling project as part of their own corporate social responsibility to easy the water challenges where sources of water for the local community had become a challenge. ActionAid Zambia has been working with Musele Nkisu Task Force (a community based organisation) to challenge the corporate's unfair business practices so as to respect the rights of the local communities. The taskforce with support from AAZ advocated for water tests which the mining company was not interested. Government through Zambia Environmental Management Agency (ZEMA) and water resource management collected samples of water for testing. Also FQM environmental department collected water samples for testing in Kitwe. The water tests proved that the water was contaminated. Previously other CSOs drilled boreholes but water tests proved that Musele groundwater was fit for human consumption. This means that the contamination of water is a result of the mining activities. Due to community voices expressing anger to the mining company, FQM then made a decision to suspend the borehole drilling project violating the right to access to clean and safe water for the local communities.

The main challenges from the two stories are that the communities are not consulted by the mining companies when it comes to business yet they are the custodians of the natural heritage and local resources, their resources are being extracted with no benefits, pollution (noise, air, water) is rampant, violation of cultural and social rights, the so called

compensation is more of a social contract as part of mine's corporate social responsibility, Traditional Chiefs are being asked to sign contracts which they do not understand and sometimes they are corrupted, litigation is a mountain task as there is no treaty that bind the operation of TNCs, and many other violation of human rights.

The coming in of international legally binding instrument (still a draft) to regulate the activities of transnational corporations (TNCs) and other business enterprises with respect to human rights will go a long way to find a lasting solution to the challenges being faced by the host mining communities. For example, Article 5.1 (Jurisdiction) state that "Where a claim is submitted on behalf of an individual or group of individuals, this shall be with their consent unless the claimant can justify acting on their behalf without consent," Article 8 (Rights of Victims) section 1 state that "Victims shall have the right to fair, effective and prompt access to justice and remedies in accordance with international law."

The state of Zambia did not manage to attend the 4th session of the legal binding treaty. As AAZ is in full support of the treaty, as a way forward to the 5th session, will hold feedback meetings with the Ministries of Foreign Affairs, Ministry of Mines as well as Parliamentary Portfolio Committee on National Economy, Trade and Labour Matters, Committee on Legal Affairs, Human Rights, National Guidance, Gender Matters and Governance. Also will engage CSOs and advocate through Zambia Alternative Mining Indaba, Extractive Industries Transparent Initiative Multi-Sectoral Working Group where AAZ is a member as well as engaging COMESA and SADC officials in Zambia to ensure the government support the legal binding treaty.



#### KCM to resettle blast victims

KONKOLA Copper Mines (KCM) has offered to resettle 86 families whose houses have developed cracks due to blasting at its Nchanga open pit in Chingola.

Nchanga Member of Parliament Chali Chilombo said in an interview that KCM's gesture to resettle the affected families is on humanitarian grounds because the problem was inherited from the previous mine investor, Anglo American.

"This situation affecting families in Nyanji township in Nchanga constituency has dragged for the last 15 years now," Mr Chilombo said.

He said KCM has already written to Chingola Municipal Council requesting for land on which the houses will be built for the affected families.

Mr Chilombo said costing for each house has been concluded but that a detailed account of the report has not yet been submitted to his office.

The affected houses were sold to sitting tenants after the privatisation of Nchanga Mine. **ZANIS**



#### I'll be by Kambwili's side in Luanshya – HH

UPND leader Hakainde Hichilema has assured NDC leader Chishimba Kambwili that he will be by his side to offer solidarity as he appears at Luanshya Central Police because there is need to demonstrate unity of purpose.

On Tuesday, police in summoned Luanshya Kambwili to appear for interviews today. But the Roan PF member of parliament has since deferred his appearance to next week saying he has a court appearance on Friday. Speaking at Lusaka Magistrates' Court where he had gone to offer solidarity

to his supporters who were charged with being in possession of offensive weapons, Hichilema vowed to be by Kambwili's side.

"There's a call out for our colleague Chishimba Kambwili in Luanshya. I will be in Luanshya tomorrow. I will be by his side because that's the way it should be. At this stage, we need to demonstrate unity of purpose. We need to make sure that we bring our country together. Our country is too divided and therefore we are digressing from issues of importance, serving our people first before we serve ourselves. Whatever charge they give him, he's got out solidarity," Hichilema said.

And when asked whether he would forgive EEP president Chilufya Tayali following his apology, Hichilema said he didn't want to be contemptuous because the matter between the two was still in court.

"We are working on that. We have heard what he has said. We will get back to him very soon. As you know, the matters with me and him are in court, we don't want to be contemptuous. We want to make sure that we do things properly, in a sensible way so that we don't offend the court, we don't offend anybody along the way," Hichilema said.

Meanwhile, on SANAC executive director Gregory Chifire's six year sentence for committing contempt of court, Hichilema said the party was studying the matter to see how they could help.

"We are looking at that matter as well. We have been sitting with our lawyers to look at it carefully because personally I didn't follow that case. And when the ruling was made I was shocked. We have asked the lawyers to now follow through the matter, how we will proceed, how we can help in any way," he said.

Hichilema also said after

his meeting with President Edgar Lungu recently, people should expect dialogue to commence.

"You should expect dialogue to commence in earnest. It's in public domain that that meeting was about dialogue so that we can bring our country back to normal," he said.

Meanwhile, his president Geoffrey Bwalya Mwamba expressed concern over delay by the judiciary in determining matters.

He urged the judiciary to find a way of executing their matters in good time.

"I came for my matter, the throat matter. But it has been adjourned to May 24, next year because the prosecutor prosecuting this matter is unwell. Even that same matter, I don't want to say much, I don't think it's going anywhere because in as far as I'm concerned, I didn't commit any offence," said Mwamba.

"It's the matter of concern. We don't know what the judiciary can do to step up these matters. Justice delayed is justice denied. Why should you be coming to court over one simple matter for six years? That's not fair to the person who is the accused because he's traumatised in a way. To be on police bond for so many years, that means you are not free. The judiciary should find a way of executing their matters in good time."

## Continued rhetoric against Chinese may lead to xenophobia, warns SACCORD

Southern African Centre for Constructive Resolution of Disputes (SACCORD) executive director Boniface Chembe says the on-going political rhetoric intolerance against Chinese nationals may erupt in xenophobic attacks if not curtailed.

Chembe said in an interview, Tuesday, that continuous negative sentiments against Chinese nationals would

dehumanising individuals of that race, and ultimately lead to attacks against them.

"As SACCORD, we believe that from time immemorial, no country has been an island. And if you study the trend of world developments, and how countries have been able to move from a low l to a high level, in more cases than not, you will find traces of involvement of other nationals. Other individuals

not belong to a particular ethnic group or race where development is taking place. So, you cannot run away from the fact that, whether you are in Zambia or any other country around the world, that you may need external expertise to contribute to the developmental process; either in investments or other kinds that are paramount to development. So, we believe that Chinese involvement

from any other involvement of foreign involvement that the country has experienced over the years or from the time the country gained independence. So, yes, if we are not careful with the kind of rhetoric that is going on, it is likely to whip up sentiments that may increasingly have Zambians react negatively towards the Chinese because of the belief that they may be engaging in things that may

country. And, yes, this may lead to xenophobic attacks," Chembe cautioned.

"Now, let us contextualise this from a peace-building point of view; when you start a process of scapegoating a country's problems on a particular people, history has shown that, that becomes a source of conflict. Genocides that have happened around the world, whether it be the Jews in Europe, for example,

So, when you scapegoat somebody, you start a process of dehumanising them. When you start a process of dehumanising a human being, over a long period of time, society begins to develop a negative sentiment, a negative energy towards them. It reaches a point where society begins to view such a group not as human, but as animals that need to be gotten rid of. And when society reaches that point, you have xenophobic attacks; you have genocides, you have all kind of evil things. So, we must be incredibly careful in terms of scapegoating. We shouldn't be scapegoating. We must simply be constructive in engaging with all global nationals whether it's the Chinese, the Europeans, the Americans; we must always be constructive in our engagements."

He encouraged Zambians to interact more with foreigners understand their undertakings and embrace

"Zambia requires help from different nationalities. What is key nonetheless is to listen to the desires of the people. If people are demanding that, fine let's have a greater understanding between you and certain nationalities, then we must be in a position to engage, we must be in a position to give information, but most importantly in our view, we must increase people-to-people exchange so that more Zambians get to understand the undertakings of certain nationalities, including the Chinese and that nationality equally understands the undertakings or workings of Zambians. When you increase peopleto-people interactions, you reduce the extent to which tension, perceptions and misperceptions, mistrust, scapegoating prevails in a society," observed Chembe.

## **Court acquits 4 UPND cadres of** possessing offensive weapons

Lusaka Magistrates' Court has acquitted four UPND supporters of charges unlawful possession of offensive weapons and materials.

The four who include; Remmy Mukoba, Kelvin Mupulisa, Fabian Lubona and Martin Muchindu, were accused of being in possession of one plastic bottle of glycerin, two plastic bottles of potassium Pamanganette, one bow and three arrows, which were found in their vehicle, but had pleaded not guilty to the charges.

The four were arrested last year when their leader, Hakainde Hichilema, was incarcerated on charges of treason at Lusaka Correctional Facility.

Mukoba had given his evidence on oath, while the rest of the accused had opted to remain silent and did not call any

And when the matter came up for judgement yesterday, magistrate Silvia Munyinya acquitted all four suspects on both counts, on grounds that the offence of possession of offensive weapons and materials was not proved beyond reasonable doubt.

In the first count where the accused were charged with the possession of offensive material; potassium Pamanganette and glycerin, magistrate Munyinya said PW6 did not identify the samples which were analysed by the Lab and did not identify what he had identified as glycerin and potassium Pamanganette in court.

She added that it was therefore not clear that what the State alleged to be glycerin was glycerin, and potassium Pamanganette, potassium Pamanganette.

Magistrate Munyinya said it was not safe to conclude that glycerin and potassium Pamanganette were offensive

She consequently acquitted the accused of count one upon finding that the offence was not proved beyond reasonable

"Therefore it cannot be said that the accused were in possession of offensive materials even if these items were found in the vehicle. For the foregoing, I find the offence for the possession of offensive materials not proved



beyond reasonable doubt. Consequently, I find the accused persons not guilty and I acquit them of count one," she ruled.

And in the second count where the accused were alleged to be in possession of a bow and arrow, magistrate Munyinya said it was clear that a bow and arrow were found in the

She however said looking at where the bows and arrows were found in the vehicle, accused number two, three and four, who were not owners of the vehicle, could not be expected to have knowledge that there were such weapons in the vehicle.

Magistrate Munyinya further said the prosecution had not provided evidence to show that accused number two, three and four had knowledge and control of the said weapons.

She added that it could not be said that the accused persons were in possession of the bow and arrows.

Magistrate Munyinya therefore found that the offence of possession of offensive weapons was not proved beyond reasonable doubt. She consequently ruled that the

accused persons not guilty and acquitted them of count two. And speaking shortly after judgement, Hichilema who was in attendance with other

party officials said he was pleased with the outcome of the case.

He, however, appealed to the judiciary to ensure that cases were quickly disposed off saying justice delayed was justice denied.

"We are pleased our young men have being discharged. Its taken long, but we appreciate the outcome of this process. We just hope that going forward, our judicial processes can be quicker. Justice delayed is justice denied. Otherwise its good that the acquittal has come through," said Hichilema who encouraged the four supporters to remain strong and rebuild their lives.

## China scientist defends geneediting babies as trial paused

The Chinese scientist who claims to have created the world's first geneticallyedited babies defended the highly controversial procedure Wednesday, but announced a halt to the trial following an international outcry.

Iiankui told packed Hong Kong biomedical conference he was "proud" to have successfully altered the DNA of twin girls born to an HIV-positive father, an apparent medical breakthrough.

But details of the experiment, which has not been independently verified, triggered an immediate backlash, with experts denouncing He's work as an ethical "mess". "The clinical trial was paused due to the current situation," said He. "For this specific case, I feel proud, actually, I feel proudest."

The university professor said the twin girls, born a few weeks ago, had their DNA altered to prevent them from contracting HIV. Eight volunteer couples -- HIV-positive fathers and HIV-negative mothers -- signed up to the trial, with one dropping out before it was paused.

He said there had been potential a second couple, but when questioned further agreed it had been a chemical pregnancy -- a term referring to a very early miscarriage.

The experiment has prompted heated debate among scientists over risks the involved. Editing human embryos can create unintended mutations in other areas -- so-called "off-target effects" -- which can have an impact through the lifetime, experts warned. "The volunteers were informed of the risk posed by the existence of one

potential off-target and they decided to implant," He said Wednesday, as he was bombarded with questions about the trial. He also said he had personally paid for most of the patients' medical expenses, and that his university in the southern Chinese city of Shenzhen had been "unaware of the study's conduct."

Southern University of Science and Technology distanced itself from He, saying he had been on unpaid leave since February and had "seriously violated academic ethics". AFP



#### New Zealand is latest country to bar Huawei

New Zealand has become the latest country to block a proposal to use telecoms equipment made by China's Huawei because of national security concerns.

Spark New Zealand wanted to use Huawei equipment in its 5G mobile network.

However, government security agency said the deal would bring significant risks to national security. The move is part of a growing push against the involvement of Chinese technology firms on security grounds.

5G networks are being built in several countries and will form the next significant wave of mobile infrastructure.

Huawei, the world's biggest producer of telecoms equipment, has faced resistance from foreign governments over the risk that its technology could be used for espionage.

Telecoms firm Spark New Zealand planned to use equipment from the Chinese firm in its 5G network.

The head of NZ's

Government Communications

Security Bureau (GCSB) told Spark the proposal "would, if implemented, raise significant national risks", security company said.

Intelligence services minister Andrew Little said Spark could work with the agency to reduce that risk.

"As the GCSB has noted, this is an ongoing process. We will actively address any concerns and work together to find a way forward," Huawei said. What other countries have concerns?

The move follows a decision by Australia to block Huaewi and Chinese firm ZTE from providing 5G technology for the country's wireless networks on national security grounds.

The US and UK have raised concerns with Huawei, and the firm has been scrutinised in Germany, Japan and

Last week the Wall Street Journal reported that the US government has been trying to persuade wireless providers to avoid using equipment from Huawei.

In the UK, a security committee report in July warned that it had "only limited assurance" that Huawei's telecoms gear posed no threat to national security.

One country is standing by Huawei: Papua New Guinea said this week it would go ahead with an agreement for Huawei to build its internet infrastructure.

The Pacific nation has seen a surge in investment from China over the past decade.

What are the fears? say

Experts foreign governments are increasingly worried about the risk of espionage by China, given the close ties between companies and the state.

Tom Uren, visiting fellow the International Cyber Policy Centre at Australia's Strategic Policy Institute, said the Chinese government had "clearly demonstrated intent over many years to steal information".

"The Chinese state has engaged in a lot of cyber and other espionage and intellectual property theft," he said.

Links between firms and the government have fuelled concerns that China may attempt to "leverage state-linked companies to be able to enable their espionage operations", Mr Uren

Those concerns were exacerbated by new laws introduced last year that required Chinese organisations assist in national intelligence efforts.

The laws enable the Chinese state to compel people and possibly companies to assist if they needed it, Mr Uren

The combination of new rules and a history of espionage have increased the perceived danger using companies like Huawei and ZTE critical national infrastructure.

"It's hard to argue that they don't represent an elevated risk," Mr Uren added. **BBC** 

### Irish woman jailed for criminal damage to crisps

A woman has been jailed by the Irish courts for causing criminal damage to a €1.50 (£1.30) packet of

Kathleen McDonagh, aged 25, opened some Pringles in a Tesco in the city of Cork before she had paid for them.

The woman had been banned from the store, and told the court she opened the crisps so that security would be forced to let her pay for it. Instead, she was sentenced to two months in prison for damaging the product, which could no longer be sold.

The judge was told that McDonagh had a series of previous convictions, including a number for theft or criminal damage.

The crisp damage in question took place nearly two years ago, on 27 December 2016, at the Mahon Point shopping centre in Cork, near McDonagh's home.

In court, police said McDonagh had been banned from the store and was known to its staff when she took the tin of Pringles and headed to the self-checkout area.

Security staff approached her to order her to leave the store when she popped the Pringles top and opened the foil seal.

An inspector told the court that she said: "I opened it so you have to leave me pay for it".

"It was not fit for resale with a loss

of €1.50," the officer told the judge, adding that although the woman wanted to buy the crisps, "she had no permission to be in the store."

McDonagh's legal representation asked for leniency from the court, explaining that she was recently married and several months pregnant, and had entered a guilty plea.

The judge, however, decided to impose a four-month prison sentence with two months suspended, noting that the accused had deliberately opened the product when asked to leave by security.

He said that is was difficult to see her actions as anything but "smart Alec behaviour". BBC

Robert De Niro has broken his silence on reports that he's separating from Grace Hightower after more than 20 years of marriage.



## Arsenal match switched to Kiev amid Ukraine security concerns

Arsenal's Europa League clash with Ukranian side FC Vorskla was switched to Kiev from the city of Poltava by UEFA on Tuesday after the adoption of martial law in some areas of the country due to escalating political tension with Russia.

The match will now take place in the Ukrainian capital, more than 300 kilometres west of Poltava, at the original scheduled time of 1755 GMT on Thursday.

"UEFA's Emergency Panel has today taken the decision to relocate FC Vorskla's UEFA Europa League group stage match against Arsenal FC from the city of Poltava, following the introduction of martial law into certain regions in Ukraine," UEFA said in a statement. "The match will now take place at the Olimpiyskiy Stadium in Kyiv on Thursday 29 November at 18.55CET."

European football's governing body said future games in the Ukraine, which hosted last season's Champions League final, could also be relocated.

"UEFA will continue to monitor and assess the security situation in Ukraine in the coming days before making any decision on potentially relocating other matches," the statement added.

Ukrainian President Petro Poroshenko on Tuesday warned of the threat of "full-scale war" and said Russia had sharply increased its military presence on their shared border as tensions escalate between the ex-Soviet neighbours. *AFP*

"Today, after 23 wonderful years, I am formally announcing my retirement as a professional footballer," Keane said in a statement.

"From Crumlin United around the world to the likes of Milan, London and Los Angeles, I could never have imagined the path my football life would take.

"It has exceeded all the hopes I had as a football-mad boy growing up in Dublin."

Keane, unlike his near namesake, enjoyed good relations with McCarthy in the latter's first spell in charge of the national side.

He was one of their stars at the 2002 World Cup -- which infamously saw their one world class player Roy Keane sent home after launching a tirade of abuse at McCarthy -- where the Irish went out on penalties in the last 16 to Spain.

Keane also enjoyed a highly successful, if peripatetic, club career which ended with a period as player/manager at Indian outfit ATK, in the season that finished in March.

In all, Keane scored 126 goals in 349 Premier League matches, 91 of them for Tottenham Hotspur, although he also had spells with Coventry, Leeds United and Liverpool in the elite league. *AFP*
