Zambia's Embassy in Kenya has no courtesy for traveling citizens - Nkombo

By Mirriam Chabala Mazabuka UPND member of parliament Gary Nkombo has expressed displeasure with the manner in which some diplomats accredited to various missions abroad treat Zambian citizens when they visit the embassies.

And Cornelius Mweetwa wondered has why Patriotic Front the government has not sent replacements to missions where representatives have been recalled, saying the situation is illogical because the country is experiencing a job deficit.

Debating the 2019 budgetary allocation to the Ministry of Foreign Affairs last week, Nkombo said it was disheartening to see Zambians being mistreated by their own people serving in the embassies abroad.

"I would like to share with yourself, honourable minister. the below character attitude that most of your staff have in the foreign missions have. We traveled out at one time with the Committee on Privileges, Absences and Support Services to the Republic of Kenya, and the usual thing that parliamentary delegations do when they go to visit is to pay a courtesy call

on the mission. I would like you to know that what we found there was extremely disheartening, the reception we received as members of parliament at the Kenvan mission... we were very unimpressed with the manner in which your staff treated us at the Nairobi mission. No courtesy whatsoever. This is a none partisan comment because as you want to know, committees of parliament are co-mingled. We had members of PF, we had members from the MMD, independent; but what we saw there was very unimpressive," lamented

Nkombo. "I think if our secretarial staff did its work, they may have included that reception in the report for your attention so that you can assist the people who you have recruited to work abroad to not only treat members of government but even the Zambian who is at the bottom of our society, because that's one of the mandate that you have as Ministry of Foreign Affairs; to look at the welfare of the Zambians who are living abroad. When a Zambian for instance falls very ill away from home, it is your ministry that is responsible to provide the minimum affordable medical care for the particular Zambian, because it goes without saying that if they die in foreign land, again it becomes your responsibility to repatriate the remains of those individuals to come back home."

Meanwhile, Mweetwa, who is the UPND member of parliament for Choma Constituency challenged the government to explain why it was not sending new staff to missions whose representatives have been recalled.

"Ever since PF came into office, there have been unprecedented numerous recalls of citizens of Zambia who were accredited, sent to work in missions abroad. You will discover that these recalls leave a lot to be desired. We have a lot of people who have been recalled by this PF government and those who were on contract have been recalled [but] they have not been paid their money after being recalled. Those who were civil servants who were in the foreign mission, they have been recalled but they have not been placed in the civil service to continue work, since they are civil servants. That's the evils of this PF. Where do you want to take these people? Is it another way of



having them thrown out of the civil service? These are the issues you need to begin to address your minds to. Meanwhile, you have citizens looking for jobs," Mweetwa observed.

"I can give you an example of Nigeria where you just have two people at a mission. Iust the Ambassador and the Accountant, what about all these other positions? And when the minister talks about economic diplomacy, how will that be realised? This ministry is supposed to be an image

builder for Zambia. This is the advertisement platform for this country abroad." Mweetwa then used the opportunity to castigate the PF government for the brutal arrest and detention of NDC leader Chishimba Kambwili last week.

But charity begins at home. The things we do here, they reflect out there in the international community. What image is Zambia sending to the international community in terms of governance? Zambia's image under PF has been destroyed. The international community has moved on, they are no longer just interested natural resource in endowment of a country, they are also concerned about democracy and the respect for human rights. How can we have a country, 54 years after independence where you have a member of parliament being bundled by police officers, thrown into a Toyota Land Cruiser and driven to Luanshya in Zambia, why? Why should we create a country of tyranny? Why should we create a country of fear where citizens are being intimidated that 'I will sort you out, why?" wondered Mweetwa.

"These are the things that destroy Zambia's image abroad, [but] later on you come to this House and say 'Hakainde Hichilema is badmouthing Zambia outside', it's your activities! You have a responsibility beyond yourselves, you have a responsibility beyond PF. You have a responsibility to Zambia, so come down and use normal sense like everybody else. We have a beautiful country, you should provide sensible leadership. This is not a country for PF! This is a country for all of us, you can't turn this country backwards because of your 'Dununa Reverse' [slogan]. You want to take this country backwards into tyranny, into dictatorship... but we are saying no to you. Zambia can't turn into a Police State, we can't turn Zambia into a place where those who are in positions of leadership begin to behave like police officers," said Mweetwa.

It is stupid to stigmatize people with HIV/AIDS - Foote By Mukosha Funga pass the virus on," said Ambassador

United States Ambassador to Zambia Daniel Foote says it is stupid to stigmatize people living with HIV/AIDS because when they take their ARVs, they become virally suppressed and unable to transmit the virus.

And President Edgar Lungu has urged citizens to get tested because ignoring their status will make them vulnerable to the virus.

Speaking during World AIDS commemorations Villa at Grounds in Livingstone, Saturday, Ambassador Foote stressed that it was time to remove stigma.

"I have met with many HIV-positive young people ages 12-24, almost all of whom were born with the virus. Not only are they exceptionally brave, they are the most dedicated advocates to HIV/AIDS elimination I've seen. Why do we stigmatize them, or anyone with the virus? Stigma against any HIV positive person is stupid at this point, because

if they take their ARVs, they'll become virally suppressed, and cannot transmit the virus. Remove the stigma!" Ambassador Foote said. "Why? Here's a reason: Of those on regular, sustained treatment, 89 percent have the HIV virus under control with the antiretroviral drugs, and this number should approach 100 percent, as we ensure every HIV-positive person takes their medicines correctly and religiously. Speaking of religion: religious leaders, please pray that suffering is eased, pray in thanksgiving that ARV treatment works, and ensure your congregations get tested, take, and stay on their medicines. I would never presume to speak for The Almighty, but I am certain that my merciful God wants us to prevent further transmission, save lives, and eliminate HIV/AIDS." He highlighted good habits which

could help the world control HIV/ AIDS.

"I mentioned how far you have

already run. We are on the brink of controlling HIV/AIDS, but now it is critically urgent that we all fully commit to make the daily effort to ensure success. Here's the important part, and it's not complicated! We each must do a few things to win this battle: 1. Get tested. Know your status. Make sure everyone you love gets tested. Take your children to get tested. Make our young people get tested. We only know the HIV status of 50% of your children under age 14, and only 45% of young women aged 15-24. 2. If we test positive, we must all seek, and remain on, treatment for the rest of our lives, or until we find the cure. If you or a loved one tests positive, accept the challenge, love yourself and your family, and take your medicine. 3. If you are on treatment, always stay on treatment and do your viralsuppression testing. With patience and discipline, the virus in your body will become controlled, and you'll live a wonderful life and never

Foote.

"People with HIV/AIDS must live with it every single day of the year, and many continue to transmit it, and die unnecessarily. We mark World AIDS Day each December 1st, but we must work every day of the year to achieve an AIDS free Zambia, and indeed, world."

And in a speech read on his behalf by Minister of Health Dr Chitalu Chilufya, President Lungu encouraged citizens to get tested.

"I call upon every Zambian to know their status and especially men who are among groups with low HIV testing and treatment coverage. In order for Zambia to seize the opportunity of this unprecedented moment, each person should make the decision to know their status and start treatment immediately. Ignoring your status will not change your status. It will only make you and your loved ones vulnerable to the virus," said President Lungu.

PUBLIC DEBT INDABA - ADDRESSING ZAMBIA'S ECONOMIC CHALLENGES FOR A STRONGER FUTURE

The Public Debt Indaba bought together key communities in Zambia from business, the church, civil society, youth organisations and think tank sector. All are united in their view that Zambia's debt levels are highly concerning but that there is still time to act to manage the impacts of this.

The Indaba welcomed the participation of the Government of Zambia and looks forward to constructive and collaborative approach to addressing Zambia's debt challenge and supporting the country's development.

The Indaba highlighted the risks of failing to act on Zambia's growing debt for ordinary Zambians and called for greater transparency over Zambia's debt as well as a clear plan for dealing with unaffordable repayment levels.

On Thursday 15 November 2018, the Civil Society for Poverty Reduction (CSPR), Zambia Association of Manufacturers (ZAM) and Policy Monitoring and Research Centre (PMRC) hosted the Public Debt Indaba in collaboration with the Consumer Unity Trust Society (CUTS), Centre for Trade Policy and Development (CTPD), Jesuit Centre for Theological Reflection (JCTR), Development Finance Associates and the Ministry of Finance. The Indaba was also supported by a number of eminent persons who included Dr Caleb Fundanga, Mr Chibamba Kanyama and Honourable Members of Parliament, among others, with over 150 citizens in attendance. In the words of PS Budget Dr Pamu, at the Indaba, "participants have turned out in numbers and there can be no better demonstration of your patriotism and commitment to national development".

The broad coalition from across Zambian society present at the Indaba agreed with this sentiment, and as patriotic Zambians, used the Indaba as a platform to call for action to address the country's debt situation and deliver inclusive economic growth to build a better Zambia for all citizens. The participants were united in their view that if action is not taken, it will be ordinary Zambians who suffer from squeezed public spending, rising inflation and low levels of job creation.

The Indaba set out ways to: achieve the Seventh National Development Plan (7NDP) in light of

growing debt servicing costs; create an enabling environment for private sector-led growth; and develop technical solutions to address the debt challenge. Following these discussions, we the undersigned signatories would like to:

Thank the Government for participating in the Indaba and for sharing the latest debt position with the hope that the Indaba marks the start of a consultative and collaborative approach necessary to address the debt challenge and maintain Zambia's development;

Recognise concerns raised by participants about the level of debt in Zambia, and that, without careful management, such debt levels risk curtailing private sector led-growth, squeezing Zambia's citizens - particularly the poorest - and undermining the Government's ability to deliver on the aspirations of the 7NDP; and,

Re-iterate our commitment to continued engagement with the Government of the Republic of Zambia to work toward a stronger economic future.

Building on the informative and open discussion at the Indaba, going forward there was a clear desire from participants for greater action and responsiveness to citizens' concerns from the Government. So, we are calling on the Government to take the following steps:

1. Continue to engage with stakeholders across Zambian society to communicate clearly on the issue of debt in Zambia and provide regular and detailed updates on the level of debt in Zambia. To this extent we welcome the recent quarterly updates on the level of debt, but would like to see greater information, including on the pipeline of debt. We further need to define clear parameters for reporting debt figures in Zambia to enhance clarity of what is under consideration.

Recognise that the impact of Zambia's debt is 2. being felt by its citizens. We would like to move away from a debate about whether the debt is sustainable and instead prioritise mitigating the impacts of debt on ordinary Zambians. This means pursuing private sector-led growth, dismantling arrears and protecting spending that supports the poorest in Zambia. As

participants of the Indaba highlighted, regardless of the level of debt, the consequences of debt are being felt today, and arguably the benefits are yet to be realised especially with regards to infrastructure investments.

3. Build collaborative plans to tackle Zambia's rising debt, with a focus on negotiating an IMF deal that enables Zambia to protect key spending areas and manage debt repayments. As participants at the Indaba highlighted, we believe the chief challenge of Zambia's debt is affordability: debt service costs (including amortisation) are around 45% of revenue. These payments risk crowding-out spending on vital services and pro-growth policies. We would like to engage with the Government on spending plans but more importantly call on the Government to continue its engagement with the IMF with a view to securing balance of payment support and building momentum and confidence to adequately resolve payment of the Eurobonds.

Continue to consult with stakeholders to 4. build strong plans to support growth. We applaud the transparent and consultative process of the 7NDP, but all parties need to recognise that as the economic situation evolves so must development plans. We would like to engage with Government to continue to develop policies and spending plans that will support private sector-led growth, create jobs and help reduce Zambia's high poverty levels.

Zambia has not yet edged into a debt crisis - there is still time to act - but we need to act cooperatively in the same patriotic spirit as the Jubilee Debt Campaign to ensure Zambia does not slide into a debt crisis.

employment. High Court judge Edward Musona ruled that Siame's dismissal was unfair and unlawful because no hearing was held, adding that when IDC terminated his employment without hearing him, they acted in breach of the rules of natural justice.

In this matter, Siame was claiming for a declaration that his contract of employment

IDC loses unlawfully dismissal case to Siame

was unlawfully terminated, a declaration that he was unlawfully dismissed, damages, payment of all accrued benefits and contractual entitlements, interest on all sums found due, costs and reliefs. He claimed that although he was

charged with insubordination, there was no disciplinary hearing for his case. Siame further claimed that it was illegal for the IDC shareholders, who were the Minister of Finance and Secretary to the Treasury, to terminate his contract, when it was the IDC board which hired and signed his employment contract.

IDC was represented by Lubinda Linyama of Eric Silwamba and Company while Siame was represented by former Attorney General, Musa Mwenye of Mwenye and Mwitwa Advocates. The IDC shareholders who were second respondents in the matter, were represented by Salome Chomba Sakala.

And in a judgement delivered, Friday, judge Musona said the facts of the case showed that

the dismissal of Siame was unfair because he wasn't given a hearing.

"Unfair dismissal is a dismissal where an employee is not given a hearing or where the hearing process was unfair. I have found that the complainant's dismissal was unfair because no hearing was held. What this means is that when the respondents terminated the employment of the complainant, they acted in breach of the rules of natural justice and it is this breach which made the termination of his employment unfair," he said. Judge Musona further said, a scrutiny of Siame's letter of termination of employment revealed that no reason was given for terminating his employment. He therefore declared that

He therefore declared that Siame's termination of employment was unfair and unlawful.

"This also made the termination of the complainant's employment unlawful. To dismiss an employee without according him an opportunity to be heard, as the respondents did in this case, is a blatant breach of the rules of natural justice and violates the principle of audi alteram partem. I declare that the complainant's termination of employment was unfair and unlawful," ruled judge Musona.

He ordered a block award of three months salary for Siame's unlawful and unfair dismissal.

"I have looked at the circumstances of this case and I am satisfied that a block award of three months salary for unlawful and unfair dismissal shall suffice," judge Musona ordered.

He however, dismissed Siame's claim for damages for mental distress and inconvenience, saying no evidence was shown to prove the degree of mental distress and inconvenience suffered, if any.

On Siame's claim for payment of all accrued benefits and contractual entitlements, judge Musona referred the item to the Registrar for assessment of what was due to him as terminal benefits.

"The complainant's main complaint is that when he was paid his terminal benefits the computations were wrongly done. I shall refer this item to the Registrar for assessment of what is due to the complainant as terminal benefits. The computation shall include all the contractual entitlements due to the complainant such as fuel allowance, talk-time allowance and the alike," he ruled.

"If after assessment it shall be found that the complainant was paid less than what was due to him, then, he shall be paid the difference. If, on the other hand, it shall be found that he was inadvertently paid more than what was due to him, there shall be no refund to the respondents because the computations were done by the respondents themselves and the complainant was not privy to it. Also, because the employer has a deeper pocket, it is not the interest of this division to burden workers with orders for payment of money to their former employers."

He said Siame's successful claims shall attract interest at the Bank of Zambia short term rate from the date the complaint was filed up to judgment date, and therefore, at the current Bank of Zambia lending rate. Judge Musona further ordered costs in favour of Siame. He granted leave to appeal.

By Sipilisiwe Ncube Supply Works and Secretary Permanent Agnes Musunga has told the parliamentary Public Accounts Committee (PAC) that some cabinet ministers and their former counterparts owe government amounts totalling K253,993.79 for furniture which they bought on offer in 2016 and 2017. And National Road Fund Agency (NRFA) chief executive officer Wallace Mumba says reports that government wants to contract a different company to collect toll fees on behalf of the agency are false.

This was revealed on Friday when the controlling officer and her team from NRFA, RDA, and Government Printers appeared before PAC to respond to audit queries cited in the Auditor General's Report for the ended 31st Financial December, 2017.

Those owing include Home Affairs Minister Stephen Kampyongo, Former Community Development minister Emerine Kabanshi. Minister Commerce Cristopher Yaluma, Former Defence minister Richwell Siamunene and his former Christopher deputy Mulenga, North Western Province Minister Nathaniel Mubukwanu and Muchinga Province Minister Malozo Sichone.

Others Former are Transport deputy minister Andrew Mwali, Dorothy Kazungu, former Chililabombwe MP Esther Banda, Former chiefs and traditional affairs minister Susani Kawandami, and Mkushi South PF MP

Some Cabinet, former ministers owe the government K253,993 Davies Chisopa.

"In 2016 and 2017, the Secretary to the Cabinet granted authority to thirty one senior officers to purchase furniture costing K455,834 from their official residences. However, as at 31st July 2018, only 18 officers had paid for the furniture while 13 officers still owed amounts totalling K253,994," the Auditor

General's report read. In response, Musunga said the owing ministers had been reminded to clear the balance.

"I wish to acknowledge the audit findings regarding the above matter the balance of the 13 transactions amounting to K253,994. 00 is still not collected. You may wish to take cognizant that the affected officers are either serving or are former leaders. Enquiries were made to National Assembly and the Ministry of Finance to check if amounts in question were recovered from gratuities. The findings were that this was never done. With authorization from Secretary to the Cabinet, the Ministry wrote to the affected officers payment," demanding Musunga responded.

Chavuma UPND member of parliament Victor Lumayi then asked what the recovery plan was for those who were no longer serving.

"On the issue of failure to collect revenue from the same government furniture, law must be adhered by every citizen and yes, this furniture was sold to government officers and I may want to know whether the Secretary to the Cabinet had sanctioned the sold furniture to serving leaders on credit or it was cash basis? I also want to know from you the recovery plan knowing that you have given us a schedule [but] I will not mention all the people involved here but they are all honourable members. For example, have Honourable we Malozo [Sichone with] a bill of K37,000, we have Honourable [Davies] Chisopa with] K14,000, we have Susan Kawandami MP [and] her bill is K7,800, we have honourable Esther Banda K14,000, we have Honourable Siamunene K12,000, others K25,000 [and] the list goes on and this money has not been paid from 2016. Most are

the times when we are pushing civil servants to pay, we are recovering from their payslips but when we look at the prominent leaders who are here who got this furniture, some have not even paid a single ngwee from the date they got this furniture. So what is your recovery plan now when others are no longer serving MPs and ministers?" Lumayi asked.

In response, Musunga said the delays in recovering the funds was due to

lack of reconciliation as some officers thought the deductions for the furniture they got were made on their salaries when in fact not.

She said some of them had already started coming forward to pay in cash.

Committee Meanwhile, Chairperson Howard Kunda asked the Ministry of Works and Supply officers to clarify whether or not it was true that NRFA was in the process of contracting a company to be collecting toll fees on its behalf.

"I have a question for you CEO, there has been an outcry in the public that people are overhearing. I don't know where but these are things that are in the public and it's being discussed that you are trying to give the collection of these funds (toll fees) from the toll gates to a different company when you have all the facilities that are there, and also in connection with the government (the Ministry of Finance). You have all the systems that are there to collect on behalf of the Zambian people. Would be in a position to confirm whether that is the true reflection of what the people are saying or not?" asked Kunda.

Speaking when commemorating world AIDS day at Kasamba primary school, Friday, under the theme "Run the last mile, leaving no one behind", Dr Chimungu challenged the communities to ensure that they got tested instead of putting the entire community at risk.

"This disease we are here for is not a joke but a serious challenge that we need to address. For your own information as the district we have about 11,000 plus persons who tested HIV positive and the rule is to enrol them on ART, but unfortunately out of this 11,000 people only 6000 are on ART according to our records. Meaning that 5000 are within our communities living with an untreated virus, a situation which risks everyone of us because HIV

can kill all of us if we don't join hands," he explained.

He also expressed sadness that some communities were discouraging their children from getting HIV drugs, a situation which he said was killing the innocent souls. Speaking earlier, Kasamba health

officer Grenda Sianatowe told the gathering that communities shunned drugs once tested positive.

"Indeed AIDS is a condition which is affecting each and every one of us in one way or the other. Guest of Honor, it's quiet saddening that even with free ART provision which is readily available, we are still experiencing death related cases to AIDS in our communities. Ee have babies who are denied the treatment by their caretakers not forgetting poor adherence to treatment by some people while others even stop taking the lifelong drugs, a situation which challenge the goal of the ministry to have zero new infections by 2030," she said.

Meanwhile, the district commissioner

Paradious Sakala, expressed sadness that some communities believed that traditional healers would cure HIV/ AIDS.

"It makes a sad reading that we still have people who cant accept the condition they are found in. It's sad that we are still taking our relatives to Witchdoctors who have in turn continued to destroy and bring confusions in our families and communities, when health services are really available," he narrated

He challenged people to know their statuses and to start ART when found to be living with the virus.

And Neighbourhood Health centre chairperson Frank Banda told government to realise that community volunteers do a great job which needed to be supported.

"Am asking government to remember and think of community volunteers who are doing a great job because the district can't have data without volunteers. The province can't have quality data without a volunteer so we appeal to government to remember and support us and reduce the challenges we are facing such as transport and other needs for quality operation," said Banda.

Meanwhile, Chile chief Mbangombe who was represented by induna Million Vincent Sakala called on government to supply more drugs to rural health centres which were closer to the people.

He also called on government to see to it that agricultural programs were monitored effectively to avoid hunger next year.

"It's good to have such platforms and we appeal to you the government to provide enough drugs to these clinics because if drugs are not enough of whichever illness then success won't be achieved. And we appeal to your government to see to it that agricultural activities are well monitored because mostly army worms hit us a lot but your interventions will help us as communities," said Mbangombe's representative.

ACHIEVEMENTS OF PF IN SEVEN YEARS: FROM THE PERSPECTIVE OF 7NDP AND VISION 2030 Part 1

INTRODUCTION

This is the first in a series of articles highlighting the performance of the Patriotic Front (PF) Government based on the 7NDP and its core components. 7NDP is underpinned by five strategic pillars namely:

1. Economic Diversification and Job Creation

- 2. Poverty and Vulnerability Reduction
- 3. Enhancing Human Development

4. Environment For A Diversified And Inclusive Economy

5. Reducing Developmental Inequalities This particular article discusses the PF fortification of the first pillar. Subsequent articles shall highlight the performance of the PF Government under the ensuing strategic areas in chronological order.

However, because column space is likely to be constrained by the overwhelming exploits of the PF Government in its execution of 7NDP, we may at times be compelled to stagger the achievements gained under a strategic pillar over multiple articles.

As we begin, it is important to go through a brief review of where the PF is coming from in order to appreciate our passion for the development of our nation. The PF came into office in 2011 under the capable leadership of its founding father and 5th Republican President, the late Mr. Michael Chilufya Sata (MHSRIP). In the aftermath of the unfortunate and untimely passing President Michael Chilufya Sata; the "baton of responsibility" to lead the PF as well as the reins to continue steering the nation towards actualizing Vision 2030 were given to His Excellency President Edgar

Chagwa Lungu, by the Zambians. During both epochs – under the late President Mr. Michael Sata (MHSRIP) and currently under His Excellency President Edgar Chagwa Lungu – the national development agenda of the Patriotic Front (PF) has always been guided by three (03) strategic documents, namely:

- 1. The Patriotic Front Manifesto(s);
- The National Development Plans (NDPs)
 The Vision 2030.

For the PF, the aforementioned three documents are not mutually exclusive, that is; the effective implementation of one does not preclude the effective implementation of the other(s). For this reason, the PF continues to measure its "promises and intentions" (the Manifesto), against the "building block or stairway" (the 7NDP) to attaining the Vision 2030 goals.

THE PF MANIFESTO

The Patriotic Front (PF) Party Manifesto is centered on the people, the ordinary Zambians; and it stresses ways in which the PF intends to uplift the wellbeing of all Zambians.

For the PF, improving the lives of Zambians means, among other things, a Zambia that is: free from hunger and poverty; has a low disease burden and low mortality rate; a nation that is peaceful, tolerant, resilient and cohesive; without slums (shantytowns); a thriving democracy, and a culturally diverse, friendly people who are well-integrated into the African and international

community.

This is the Zambia we all want. This is the Vision 2030 where Zambia becomes a "prosperous middle-income country by 2030" and it is the Zambia the PF intends to bequeath to Zambians by the year 2030. The effective implementation of the PF Manifesto is a indeed a robust stairway to Zambia becoming a "prosperous middle-income country by 2030".

VISION 2030

The Vision 2030 is a long-term plan that expresses the aspirations of the Zambian people to live in a strong and dynamic, middle income industrial nation that provides opportunities for improving the wellbeing of all. It embodies values of socio-economic justice underpinned by the principles of: Gender-responsive, sustainable development; Democracy; Respect for human rights; Good traditional and family values; Positive attitude towards work; Peaceful co-existence; and Public-private partnerships (PPPs). A Zambia with stable social and cultural systems that support human capital formation. (The 7th National Development Plan, page 48).

THE SEVENTH NATIONAL DEVELOPMENT PLAN (7NDP)

The Seventh National Development Plan (7NDP) for the period 2017-2021 is asequel to the Revised Sixth National Development Plan, 2013-2016 (R-SNDP) following the latter's expiry in December 2016.

7NDP, like the three national development plans (NDPs) that preceded it, is aimed at attaining the long-term objectives of Vision 2030.

It builds on the achievements and lessons learnt during the implementation of the previous NDPs. As a result, 7NDP departs from sectoral-based planning to an integrated (multi-sectoral) development approach under the theme "Accelerating development efforts towards the Vision 2030 without leaving anyone behind". The7NDP is thus a building block formulated to meet the goals contained in the Vision 2030.

HOW ARE WE DOING SO FAR? (THE ACHIEVEMENTS OF THE PF GOVERNMENT IN 7 YEARS2011 – 2018)

As the Patriotic Front (PF) Government continues to work towards actualizing the Vision 2030 goals; it is imperative that its performance over seven (07) years [2011-2018] should be assessed against the "stairway or building block" to the Vision 2030 goal. It cannot be overemphasized that the stairway or chief corner stone to Vision 2030 is the 7NDP.

As highlighted in the introduction, the 7NDP for the period 2017- 2021 and its attendant development outcomes are underpinned by five (05) strategic pillars: Economic Diversification and Job Creation; Poverty And Vulnerability Reduction; Enhancing Human Development; Environment for A Diversified And Inclusive Economy; Reducing Developmental Inequalities.

ECONOMIC DIVERSIFICATION AND JOB CREATION The first development outcome based on this strategic pillar is:

A Diversified and Export-Oriented Agriculture Sector leveraged on Improving Production and Productivity from

Farm to Agro-Processing and Manufacturing The PF Government is delivering "a diversified and export-oriented agriculture sector" as espoused in the 7NDP.

As a result, the Production and Productivity of multiple crops has significantly improved through intensified agricultural mechanization as well as increased land area under cultivation. The number of farmers participating in production has also increased significantly. (Central Statistics Office, Zambia in Figures 2018, page 16). Further to that, various programmes aimed at significantly improving production and productivity from farm to agroprocessing and manufacturing at sector and enterprise level are being implemented. These include the following: **The Farm Power and Mechanisation Enhancement Programme**

Under this programme, the PF Government is currently establishing a US\$ 100 million tractor assembly plant in the Lusaka South Multi Facility Zone with the aim of helping farmers to access cheaper equipment in order to improve mechanization for all farmers countrywide. **The Irrigation Development Programme**

The PF Government is currently implementing the irrigation development programme through the Irrigation Development and Support Project (IDSP). The objective is to inter-alia increase yields per hectare

as well as the value of diverse products marketed by smallholders benefitting from investments in irrigation in selected sites served by the project.

There are four components to this project including: (a) irrigated agricultural support services; (b) public infrastructure; (c) private and cooperate investment, and (d) management and coordination [cited from: www. agriculture.gov.zm].

The PF Government is also delivering several large-scale irrigation development and support services countrywide. Prime examples include the following:

The Mwomboshi Dam ProjectinChisamba; A US Dollar 28.3 million Project funded by the World Bank. The Project will have the capacity to hold up to 65 million cubic litres of water, making it Zambia's largest irrigation dam. The Kafulafuta Dam Project on the Copperbelt; A US Dollar 450 million project. The dam project is being funded through a loan secured from Exim Bank of China; one of the outcomes will be the provision of clean and safe water in Masaiti, Mpongwe, and Ndola and Luanshya districts.

CONCLUSION

In the next article, we shall continue highlighting the achievements of the PF Government through the lenses of the 7NDP. We will in this regard discuss some of the numerous success stories such as the Aquaculture Development Programme and others including Research and Development Promotion Programme (crops, livestock and fisheries). We will also discuss how the PF Government is aggressively Enhancing Agriculture Value Chains under the first pillar of 7NDP "Economic Diversification and Job Creation"

NAREP has also identified a major opportunity in 'mass recycling' and 'green energy' industries. This will be spearheaded through a Zambia Sustainability Plan to be implemented over the next 20 years," Chipimo stated.

He stated that to create the qualified workforce to meet the demands of the new economy, NAREP would establish mass recruitment centres.

One example of how this would work is in the downstream processing of mineral concentrates out of the DR Congo. Zambia can lead the way as a centre for mining excellence in promoting innovative technologies for improved efficiency in the mining and mineral processing sectors," stated Chipimo.

Zambia has leadership deficiency - HK

Bahati PF member of parliament Harry Kalaba says Zambians are suffering because of a leadership deficiency.

Speaking when he visited Sitaka Holy Spirit Parish in Lukulu district, Saturday, Kalaba who is also Democratic Party 2021 aspiring presidential candidate, said Zambians lacked proper leadership.

"What people are lacking is not that they do not have good soil, it's not that they do not have enough rains. It's not that they do not have human capital. People have all these but the people are lacking leadership. We have leadership deficiency in this country and the biggest challenge again is, there is a disconnect between those that should be leading the people and those that are leading and because of this disconnect, poverty levels keeps on

swelling and as they say swell, they say when two elephants are fighting, it is the grass that suffers. So our people are suffering and we need to do something," Kalaba said. Kalaba wondered why government had failed to work on the Lukulu - Katuda raod which he termed an economic road. "Lukulu – Katunda – Watopa, this is an economic road. This is the road which connects from Western Province to North Western Province. Imagine if the two provinces were

connected, it would be easy for our people to trade from Western Province into North Western Province and vice versa and if this road is improved, even the traveling modalities will be easy for our people meaning trade also will be easy. The produce which is being grown from Lukulu coming to the town will be easier, but the way things are, this is really sad. It is extremely sad and I am happy that I have walked on this road that is why I am running for office of President because we need to correct these anomalies. We are all citizens of this country and there can't be an explanation on why the

Lukulu-Katunda road has not been done. This has to be corrected, honestly, and we cannot continue like this," he said.

And Kalaba said he was running for presidency in 2021 because he wanted to improve the welfare of citizens in rural areas.

"That is why I am running for president. It is because the rural populace has been neglected. People living in the rural Zambia are like they do not exist and for me, I want to insist on the rural areas because our wealth lies precisely in the rural areas. Because here in Lukulu, you have not only fertile soil but Lukulu has a lot of timba. Lukulu here grows a lot of rice. Lukulu here has a lot of fish but how come the people here are still living below poverty lines? So for me, it's a question of leadership. You fix that, you fix everything," said Kalaba.

"Farmers are not receiving their fertilizer on time, they are not receiving their farming inputs on time. The FISP program has collapsed and what has happened now is that our people are surviving on the mercies of God. And there comes in the Church because it now continues to play a prophetic role to give hope where there is no hope and we want to encourage them so that they may know that not all hope is lost."

And in welcoming Kalaba, Father Peter Sianga said the role of the Church was to welcome and give advice to everyone, including politicians.

"The church gives advice to everyone, including politicians hence the need to welcome everyone regardless of his or her status in the society. We are there to welcome everyone and give counsel to all who may need it," said Fr Sianga.

Kalaba is in Western Province to understand the challenges people face.

would-be offenders. We are shocked that Honourable Phiri has welcomed this proposal.

This gender based violence debate is very broad and we wish the minister had been more sensitive in responding to this demand. Anyone can propose any silly idea that comes to their mind, but before a person in Honourable Phiri's position offers any solidarity to such calls, it is always advisable to exercise caution. It would have been very prudent for the minister to critically think of the implications of such a law and whom it may affect.

Castrating sex offenders sounds like a brilliant idea that would spell how serious government is in curbing the vice, but when you critically look at it,

vou find that it has a one sided view. This proposal was definitely conceived by a mind that assumes that all sex offenders are men. Otherwise, can the minister explain what equivalent punishment her government would mete out on female sex offenders? We ask this because justice must not be selective.

And let's assume that Honourable Phiri is granted powers to castrate a male sex offender, and this culprit then repents or reforms, what does that man become after his set has been tampered with by the law?

Fellow countrymen, even as we observe the 16 Days of Gender Activism, we need to be very fair when dealing with matters which affect men, women and children. We must would come back to haunt our very society, especially since we claim to be a Christian nation. We have seen that in this country, our female leaders have so much pressure to impress, and we can't blame them for trying to prove that they actually make better leaders; but our long held view has been that gender based violence and gender equality can not be won by women alone.

Those who defend Zambia's position on gender equality always start by recognising the fact that the country's key institutions are in the hands of women. This is, no doubt, a perfect picture painted by a country that means business in appointing women into key decisionmaking positions. But the question we always want to ask those who are very proud about this record is; how much has changed in terms protecting women of and girls; in terms of giving equal employment opportunities to both men and women in the recruitment process of the civil service; in terms of promoting women entrepreneurship? How much influence have women, listed imposed on government to change this ugly picture of our sisters and mothers out

we say this with all due respect to the females who have been privileged to serve in senior government positions, the real influence that these appointees have is over their own status society. Society in respects them but it ends there. Having a female Vice-President has not changed the fate of the poor girls in Nalolo Constituency where madam Inonge Wina comes from, let alone in Chadiza District. Church is involved in politics, not partisan politics, says Telesphore

said archbishop Mpundu. "Quality education, not education up to basic, basic, what is basic education? That is a political issue. When you say more food on people's tables, that is a political issue. We want meaningful development, it is political, everything is political and the church is interested in whatever affects the people not as partisan politicians." And UPND leader Hakainde

Hitchilema, who was in high spirits, noted that the party had survived numerous storms, including possible extinction.

"Since its establishment 20 years ago, UPND has withstood various storms among them possible extinction," he said.

"However, due to the nation's faith in us, the party continues to thrive and this we owe to you, our people and the nation at large," Hichilema said. Abuse of state institutions to intimidate political opponents clearly shows the weaknesses of those in power; the more they create victims, the deeper they dig their ditch says PAC president Andyford Banda.

And Banda has appealed to the PF government to focus on Zambians and not the opposition, saying their insecurity on what will befall them once they leave government, is another reason they don't want to give their opponents a chance.

Meanwhile, Banda says when PAC forms government, they will tolerate those with different opinions, be; the opposition, activists, media and others.

In their weekly newsletter to News Diggers! Banda observed that Zambia's political system seemed to accept that opposition politicians could be arrested on fake charges and then released.

"Our political system seems to accept that it's okay for the ruling government to instruct police to stop opposition political parties from freely meeting with citizens to discuss what plans they have for the country, without due regard that they are stamping on the rights of the political parties and citizens," he stated.

during Banda observed that colonial times, freedom fighters

were intimidated and sent to jail for fighting for people's rights.

He added that the only reason why white minority rulers sent freedom fighters to jail on trumped-up charges , was for them to advance their hold on power.

"The only reason why white minority rulers sent freedom fighters to jail on trumped-up charges was for them to advance their hold on power, in order to continue abusing resources that belonged to the indigenous people. For example, during apartheid, the white minority rulers even created laws that legalised the abuse of the black majority," Banda stated.

He stated that Zambia had recently witnessed the happenings of the colonial times, citing an example of when UPND leader Hakainde Hichilema and Chishimba Kambwili were summoned by the police.

In our country we have noticed all these happenings when recently, UPND leader Hakainde Hichilima was summoned in Ndola last week and this week, NDC Consultant Chishimba Kambwili was also summoned in Luanshya. As you may have guessed it, next week we have no idea who might be summoned and we don't know where. The point is these levels of intolerance must not be accepted in our democratic dispensation," he stated.

And Banda observed that most

governments that focused on intimidating their opponents, failed to deliver their promises.

"It's also a fact that opposition political parties do not have the freedom to have meetings without being disrupted by the police. Most governments that focus more on intimidating opponents actually fail to deliver promises made to the people and in fact abuse various institutions, from police to Judiciary, to state resources. They put their energies on fixing enemies as a strategy to hold on to power and a warning to other political opponents that this is the fate that awaits them should they continue speaking against those in authority." he observed.

"Clearly what we are seeing from all these political intimidations is the panic and weaknesses of the perpetrators. The abuse of state institutions such as the police to intimidate political opponents just clearly shows the weaknesses of those who found comfort and security in machinery which is temporal and clearly not theirs. Since most perpetrators are blinded by power and money, they can't see that the more they create victims, the deeper they are digging their ditch."

Banda stated that Zambia should not accept such politics, adding that PF's insecurity on what would befall them when they leave government, was why they didn't want to give their opponents a chance.

"As a country, we must not accept this kind of politics. We must know that any government that perpetrates this governance style must be given a straight red card. Insecurity on what may befall them should they leave government, is another reason why they don't want to give their opponents a chance. Because they know a number of illegalities that they have committed and what may befall them should there be change of government," he stated.

Meanwhile, Banda stated when PAC forms government, it would ensure an independent police service.

"A PAC government will ensure an independent police service fully equipped to maintain law and order, as opposed to being used as a unit of intimidating political opponents. African Union warns Burundi after ex-President Buyoya arrest warrant

The African Union (AU) has warned Burundi against moves to jeopardise peace efforts after an international arrest warrant was issued for ex-leader Pierre Buyoya and 16 other officials.

They are accused of being behind the 1993 assassination of the country's first elected Hutu president.

The killing of Melchior Ndadaye triggered a brutal ethnic civil war.

There are fears that targeting Mr Buyoya, an ethnic Tutsi based in Mali, could reignite tensions.

More than 300,000 people died in a 12-year civil war between the minority Tutsi-dominated army and mainly Hutu rebel groups.

Mr Buyoya - who has seized power twice in the last three decades with the backing of the army - is respected diplomatic

figure on the continent. In the past he has reacted angrily to a suggestion that he may have been connected to Mr Ndadaye's assassination, which took place four months after the country's first democratic election. He has never issued a formal denial as he had not faced legal charges.

The 69-year-old was involved in the peace process that ended the civil war and saw the election in 2005 of former Hutu rebel leader Pierre Nkurunziza as president. The current peace negotiations surround the political unrest sparked by Mr Nkurunziza's decision to run for a third term in office in 2015. He was ultimately

successful, but amid violent opposition protests and a failed coup attempt, hundreds of people died and many of the 400,000 who fled their homes remain in neighbouring countries. Ahead of a regional summit about the crisis on 27 December 2018, the African Union says that all sides should "refrain from any measures, including political and/or judicial, which may complicate the search for a consensual solution". **BBC**

Vibrations offer new way to track elephants

Researchers have come up with a new way of tracking elephants, via the vibrations that the animals make.

Scientists Dr Beth Mortimer and Prof Tarje Nissen-Meyer discovered that elephants generate vibrations through their normal movements and through vocalisations, known as "rumbles".

These can be measured by techniques usually used for studying earthquakes.

The Oxford academics spoke about their research at the TEDWomen conference currently under way in California. They explained how they measured the seismic waves that could travel nearly four miles through the ground.

They recorded the vibrations generated by wild elephants in Kenya while walking and calling, using instruments known as geophones.

Seismological modelling software that incorporates the local geological information was combined with computer algorithms to produce accurate estimates of the seismic waves produced by elephants.

They filmed the animals during recordings and later synchronised the two to allow them to visually

confirm that the vibrations originated from elephants.

They found that other noise and soil type affected their ability to distinguish the patterns over long distances. Vibrations travel farther through sand than through hard rock and also when little other noise is present to interfere.

Finding out what elephants are doing, even when they are some distance away, could help fight poaching in real time as well as offering insights into their behaviour, they said.

Their findings were published in a paper for journal Current Biology earlier this year. Save The Elephants' chief executive, Frank Pope said of the research: "Legends and folklore have long spoken about the way elephants cannot only communicate across long distances, but also detect other events that shake the ground like far-off thunder.

"This study marks a new phase in trying to understand the nature of the vibrations elephants produce and how they might be used by elephants themselves.

"Along the way it is opening our eyes to the challenges posed by human-generated noise in an increasingly crowded landscape." *BBC* Israeli police have recommended indicting Prime Minister Benjamin Netanyahu and his wife Sara for alleged fraud and bribery. They are suspected of awarding regulatory favours to the Bezeq telecom firm in return for positive media coverage of the couple.

Mr Netanyahu rejected the allegations in what is known as Case 4000.

The Israeli attorney-general will now have to decide whether to bring charges in the case.

What are the latest allegations? On Sunday, the Israeli police and the Israel Securities Authorities said there was sufficient evidence for bribery, fraud and breach-of-trust charges to be brought against Mr Netanyahu and his wife.

They are suspected of interfering in regulatory decisions that favoured Bezeq and its majority shareholder Shaul Elovitch.

In return, the couple are alleged to have been given more positive coverage on Walla! news website, owned by Bezeq.

The police also said there was sufficient evidence to indict Mr Elovitch for giving bribes. Responding to the latest allegations, Mr Netanyahu tweeted: "These recommendations were determined and leaked even before the investigations began.

"I'm sure that in this case the relevant authorities, after examining the issue, will reach the same conclusion: that there was nothing because there is nothing."

Mr Elovitch has so far made no public comments on the issue. **BBC**

A number of people gathered in Missouri to mourn the death of a woman named Brittany Johnson-Webster, only to find out she is still alive.

The funeral, allegedly planned by Brittany's mother, was held at the Ferguson Heights Church of Christ on Nov. 10, according to WTSP. Like most funerals, Brittany's consisted of a sermon, speeches and a repast.

Making the situation all the more awkward, Brittany told the news station that she found out about her "death" when she saw her photo on an obituary.

"They had pictures of me blown up into posters that said 'Rest in peace Brittany,' and my aunt eventually had obtained one of the obituaries and sent pictures," Brittany said. According to the obituary, "Brittany finished her story on October 27, 2018. She was called to meet all the loving animal babies on the other side of the rainbow."

"I was kind of stunned. It was a whole rush of emotions," Brittany told WTSP.

by her grandparents, also feels her mother's stunt has also brought her bad luck. "She claimed I died in a car accident and the next day someone had pulled out in front of me and I slammed on my brake and spun out three times, and all I could think was 'I'm going to die, my mom's speaking my death into existence,'" Brittany told the outlet.

As for why Brittany's mom faked her death, she believes it was all for money.

"I apologize for her actions. It's messed up, but she ended up scamming you guys out of some money, you know just trying to make you feel bad."

At this time, Brittany's mother's identity and whereabouts are unknown.

Wilder still hopes for Joshua fight as Fury eyes rematch

Deontay Wilder still hopes to face Anthony Joshua in a heavyweight unification bout but is happy to hand rival Tyson Fury a rematch following their epic draw.

Wilder retained his WBC heavyweight title belt on Saturday after a thrilling 12-round battle ended in a split decision draw at the Staples Center.

The result means Wilder is still in a position to achieve his dream of unifying the heavyweight division against Fury's fellow Briton, Joshua, who holds the WBA, IBF and WBO versions of the title.

But Saturday's thriller in Los Angeles, and the inconclusive

result, means that Wilder may have to wait before climbing into a ring with Joshua. The clamour for a rematch with Fury may well prove to be irresistible.

Asked which fight Wilder would prefer -- Joshua or Fury -- the 33-year-old replied: "I would love to go for the other titles."

"I've always spoken that there should be one champion, one face, one name. I always wanted to unify the division," Wilder said.

"I'll be satisfied with (either Fury or Joshua), to be honest. Me and Fury put on a hell of a performance. I'd love to go back to a rematch or I'd love to fight Joshua. I'm in a winwin situation."

Wilder's handlers however are adamant that they believe a return with Fury, who came back from a devastating 12th round knockdown to hold on for a draw, is the more attractive fight.

"I believe the fight with Tyson Fury is the stronger fight," said comanager Shelly Finkel. "Probably more logical to have that. He dropped the guy twice.

"Deontay will fight anyone. Deontay knows he would be better in the next fight. I don't think Fury can be better."

Wilder's promoter Lou DiBella agreed that the Fury rematch should

take priority, making the case that Wilder and Fury are the two best heavyweights in the division.

"This fight has energised the division," DiBella said. "We've got an American heavyweight champion that Americans can be proud of. And there's two guys in Great Britain that are great champions.

"I'm not denigrating anybody but I think the two guys tonight would beat the third guy (Joshua)." - 'We want the fight' -

Fury's veteran promoter Frank Warren is also keen for a rematch, calling for an open-air duel in Britain sometime in 2019. *AFP* Chances came and went before Arsenal got the crucial fifth goal 17 minutes from time, when Ramsey robbed Juan Foyth and Lacazette's strike spun in off Dier's shin.

Torreira's first for the club followed three minutes later when he slotted past Lloris and celebrated with gusto.

Vertonghen was dismissed in the closing stages to compound a miserable day for the visitors.

The Gabon striker made it 10 goals from 10 shots on target in a row in the Premier League with his second in the derby. He then assisted Torreira's clincher.

Vertonghen loses his cool Vertonghen's handball was a bizarre moment from the experienced defender, and a poor outing was compounded when a studs-up challenge on Lacazette in the 85th minute earned him a second yellow card.

By Alex Chilumbwe Former Zambia National team defender Hichani Himoonde says the national team players have a task to improve Zambia's FIFA ranking saying their loss to Mozambique in both home and away fixtures in the AfCON qualifiers to contributed the downward mobility in ranking.

Himoonde also said that to successfully improve Zambia's ranking, players must not hold on to past failures and successes but work extra hard to make the new records for the country, as well as better ranking.

In an interview with Goal Diggers! the former Power Dynamos defender noted that football comparisons only created rivalry as opposed to finding solutions in instances that the national team was not doing well.

"It is the national team's duty to improve the country's football ranking. They are the ones playing and I am positive that they understand this. This does not mean that they should be miserable although the ranking dropped because of their home and away losses to Mozambique in AfCON qualifiers. Meanwhile, Mozambique who beat Zambia in both AfCON qualifier encounters benefitted from their win and notably ascended on FIFA ranking and moved five places up the table.

Mancini 'relieved' with Italy's Euro 2020 draw

Italy coach Roberto Mancini ch expressed his relief on fav Sunday after the former for

champions were given a favourable qualifying group for Euro 2020.



Mancini took over earlier this year after the four-time winners failed to qualify for the World Cup in Russia. "The goal was to avoid Germany and it went well," said Mancini after Italy -- who won their only European title 50 years ago -- were drawn in Group J against Bosnia, Finland, Greece, Armenia and Liechtenstein.

"(It's) good, but you have to win on the pitch," continued the 54-year-old former Italy international who was present at the draw in Dublin along with the FIGC president Gabriele Gravina. "Bosnia are an excellent team, with players we know and it will not be an easy game, but all the games must be played and won - on paper it is a good group, then it will depend on us.

"We have to qualify and remember all games must be played and won so we climb the FIFA ranking and go into the next World Cup draw in a stronger position."

"Italy deserves to be on the top where it has always been. "It might take a little while, but we are improving. The lads are playing well and on the right track.

"Having given enthusiasm back to the fans means that we are doing well and bodes well for the future."

Italy have won three matches, drawn four and lost two since Mancini took over in May, but have been knocked out of the Nations League.

The Italian capital Rome will host quarter-final matches for Euro 2020 which will be played across 12 countries in Europe.

"We hope it can revive the enthusiasm of the whole football movement," said Gravina, adding that Italy were hoping to host Euro 2028. *AFP*
