My husband used to sleep in chicken run, Livingstone woman tells court

A woman of Livingstone's Maramba area has told the local court that her husband used to spend nights in the chicken run, leaving her alone in the bedroom.

This is the matter in which Maliambi Shimungalu had sued Mumba Mukuta for divorce.

The Court has since dissolved the couple's 10-year-old marriage on grounds that the two have lost affection for each other.

When the matter came up before Senior Local Court Magistrate Essau Daka and presiding Local Court Magistrate Ruth Liato, recently, Maliambi told the court that the two got married in 2008 and K3,600 was paid as dowry, representing six cows at K600 each.

She said they had three children; a 10-year-old, a six-year-old and a six-month-old baby.

Maliambi said before they got married, her husband, Mumba, had children from a previous marriage.

She said problems in their marriage started when Mumba started drinking too much beer and stopped buying food at home.

Maliambi told the Court that Mumba suggested

that they shift to the house left by his late brother to avoid paying rent, but whilst at his late brother's house, his behaviour got worse and he started spending nights in the chicken run, leaving her alone in the bedroom.

She said she reported the matter to the elders in the family, but there was no change, eventually Mumba started coming home late, between 22:00 hours and 23:00 hours. Maliambi disclosed that the worst part was that his girlfriends could go to their home and boast of how they enjoyed Mumba's money and how a big buyer he was, yet he was failing to provide food or pay the children's school fees.

She further said her husband was violent and used abusive language against her.

But in his response, Mumba denied all the allegations against him, arguing that he was actually a good man. He explained that the problem was with his wife who had no respect for him, adding that he drank to avoid having high blood pressure. Mumba claimed that at one time, his wife went

somewhere for a month without his consent, and after she returned, she told him that the money he paid had finished.

He said this compelled him to finish the balance. Meanwhile, a witness, Irene Mangwato of Kasenga village, Namwala, said Mumba was a problem who could not take heed to advice.

In their findings, the found Court that Mumba denied the claim, saying he still loved his wife, yet in his submissions he said he was ready to divorce her. They further found that the parties had lost affection for each other and that their marriage broken down had irretrievably.

They granted the couple divorce and ordered Mumba to be supporting his children with K1,000 payments.

They granted Maliambi custody of the children. "Based above on findings, divorce is granted. Plaintiff (Maliambi) to have the custody of the three children forthwith. Defendant to be supporting his children with K1,000. The parties should share property equally," ruled the Court.

Lungu warns contractors fond of abandoning projects

By Mirriam Chabala President Edgar Lungu has warned contractors working on various projects across the country to stop the tendency of abandoning works, saying the trend is costly to government's quest to foster national development. Speaking when he commissioned the newly constructed

constructed US\$28.3 Million Mwomboshi Dam in Chisamba district, the President hailed Anhui Foreign Economic Construction Company (AFECC) for finishing works way ahead of schedule and called on other contractors to emulate their commitment.

The construction of the Mwomboshi Dam was funded by the World Bank under the irrigation Development and Support Project under the Ministry of Agriculture and has the capacity to hold up to 65 million cubic liters of water as well as a 6,000 hectares capacity to irrigate.

The dam is expected to store water for irrigation by small-scale, emergent and commercial farmers and that close to 6,000 households are expected to benefit from Mwomboshi dam, which has been constructed in Chief Chamuka's area.

"I am delighted to be associated with this remarkable project, which is the fulfillment of the Patriotic Front manifesto of increasing management and utilisation of water resources for agricultural development. This will be achieved by a number of things, constructing at least one large scale dam in each Province such as Mwomboshi to create massive water sources for irrigation ... This project is also demonstration а of our country turning a new page in the way we practice agriculture

in Zambia. The project is a stamp of the PF government's significant strides in initiating infrastructure projects which is aimed at enhancing tangible development," President Lungu said.

"This is the suspicious and ultra modern example of the main projects that we intend to role out in our infrastructure development across the country. Mwomboshi dam is a game changer, not only in the irrigation system of the agriculture sector but also in particular Central Province As government, we envisage to roll out power water irrigation infrastructure projects like the one we are witnessing here throughout the country." The President also encouraged other contractors operating in Zambia to emulate AFECC's work culture.

"This achievement is a challenge and a wake up call to all contractors in all sectors of our economy, who have a tendency of abandoning works and failure to finish projects within the stipulated contract time frame. This is uncalled for and it's costly for us in our quest to foster national development. The culture of not just completing works ahead of schedule but also of contrasting a dam which has a world class standard," said President Lungu.

In their weekly newsletter to News Diggers! Banda observed that corruption seemed to be an acceptable practice in politics around the world.

He, however, noted that the practice had heavily affected whose leaders Africa, portrayed "special skills" for greediness.

developed "In many countries, political leaders who abused public offices during their tenure are prosecuted, while in Africa many go scot-free, causing future leaders to continue on the same path of looting. Corruption has caused many challenges for governments around the world, including

Zambia. There just seem to be no care whatsoever, the consequences of such acts from heartless political leaders and their business associates. They don't care that people are dying in

hospitals because of lack of medicines and equipment; they don't care that children fail to learn in proper environments due to lack of facilities. Farmers fail to get their adequate supply due to the corrupt system," Banda noted.

He stated that the fight against corruption was PAC's first priority, adding that a very significant portion of Zambia's problems could be



eliminated once they clamp down on corruption.

"The PAC believes that a very significant portion of the problems we face today could be eliminated once we clamp down on corruption. The fight against corruption is PAC's priority number one. Corruption has been a cancer in so many ways. Services are either delayed or not delivered at all, due to corruption. Government's supply chain has had to purchase goods and services at overly inflated prices due to corruption. The wrong people have been awarded tenders, even when it is clear that they don't deliver or deliver poor quality goods and services. All this is the fruit of corruption. Corruption is a cancer," Banda observed.

He stated that PAC would restructure systems and come up with new and modern ways to fight corruption, adding that that they would introduce fast track anti-corruption court. "We need to ensure that the Judiciary is reformed for speed delivery of prosecution and judgements. Just as we have a small claims court, and the RTSA fast-track courts, PAC will introduce fast track anti-corruption court. We must also set precedence to prevent future leaders from committing the same crimes. Once PAC forms government, forensic audits will be conducted in the activities of previous governments, and all found wanting will be punished to set a good example for those who may want to contemplate getting involved in corruption. All properties acquired from abuse of public funds will be repossessed under PAC," he pledged.

Banda added that they would also implement an electronic procurement system that boosts competition and transparency in the procurement of goods and services.

"We have to place in systems that will make it easy to trail corruption. We need to implement electronic systems to improve transparency in the operations of government, especially in the supply chain. PAC will implement an electronic procurement system that boosts competition and transparency in procurement and the outsourcing of various goods and service.

Meanwhile, Banda stated that PAC would ensure that the system that had long supported the people close to the corridors of power was stamped out by restructuring the existing Anti-Corruption Commission (ACC).

He added that they would ensure that the ACC takes an interest in the Auditor General's reports, adding that government officials who did not execute their duties professionally would either be dismissed or be recommended for prosecution, should elements of corruption be cited.

"The PAC will ensure that the system that has long supported the people close to the corridors of power is stamped out. This will only be possible by restructuring Anti-Corruption the Commission. It must be an autonomous body in order to ensure that the ACC is able to prosecute even highlevel individuals, such as Ministers, without having to ask permission from the President. The PAC will introduce stiffer punishment for individuals who will be caught in corrupt deals," stated Banda.

PF's poor leadership can't resolve water shortages, says Mutelo

Mitete UPND member of parliament Misheck Mutelo says Zambia lacks the good leadership required to resolve the country's water shortages and alleviate people's suffering.

Speaking in Parliament, Wednesday, when he debated on the budget for the Ministry of Water Development, Mutelo said availability of water was not a problem given the numerous water bodies in the country, but argued that the problem was with poor leadership.

He even suggested that this year's delayed rainfall was because God was annoyed with the current administration.

"The PF has failed to manage the water situation in Zambia as given by God. If it was for prayers, we would pray to say: 'as much as we have received the water [bodies], we need to get the wisdom from God as to how the water situation must be managed. Nationwide, even here in Lusaka, you also have dry taps. Water just comes for hours and mostly during night time. No water, but we have all the surface water and ground water. The only mistake that we have for now is not water, but the people who are managing the country for now, PF. They would sometimes when they are reminded to say: 'you are going' they would say: 'where are we going?' Where UNIP has gone, where MMD has gone, the next in line to go where these two political parties have gone is PF,"

Mutelo said. He told the House that it was sad that the PF would mismanage monies budgeted for improving water supply every time there is such a provision. "Madam chairperson, let's manage [the water problem]. I am tempted to support the National Day of Prayer; they (PF) should be praying for wisdom to be using these natural resources. We will also pray to God to do us good by removing these people out of power to bring fresh minds, which will be able to manage the water situation in Zambia. Yes, not recycled, but fresh brains, fresh management, people who will be working handin-hand in harmony, who will be using the resources from our cooperating partners in a good way and not the PF who when they are given the monies, they mismanage. We were told monies have been borrowed for Western Province [but], again, todate, nothing has taken off. Go to Mitete, not even a single borehole has been drilled or maintained. So, where is this money? The money which we were promised of here by the Minister then Dr John Phiri? Where has it gone?"

Mutelo asked.

He claimed that the rains had delayed because God was annoyed with what was happening.

"Thank God [that] Zambia is a unitary state, how I wish it was not like that. How I wish Barotse remained Barotse; it's my wish [but] that Zambia is a unitary state, but out of this being a unitary state, we are suffering. No wonder for this year, 2018, and 2019 season, to some extent God is annoved, no water now, no rains! Let's pray hard for God to have mercies upon us and God will hear us. We still have those who have clean

hands. PF, you are the ones who are there today, let's see to it that we utilize our underground water and our surface water if at all you can, if you can't, try," said Mutelo.

And in winding up debate, acting Water Development Minister Richard Musukwa urged members of parliament to partner with government in ensuring that the provision of water supply became a reality.

Musukwa observed that water was a critical issue, which required levelheadedness in terms of addressing the problem, rather than politicking.

Kapalu then pushed her on the bed and defiled her.

"He closed the door to the house and started looking for the money. He pushed me to the bed. He undressed himself and defiled me," she added.

She testified that later on, her mother and father arrived and found her and the accused in the house.

The victim said when her parents arrived, Kapalu tried to push her under the bed.

She said her father then called for the neighbours to come and see what Kapalu had done to her, adding that it was at this point that she ran to her auntie's house for fear of being beaten by her parents.

Three days later, she was taken to the clinic.

And Magistrate Walusiku said she had found that a prima facie case had been established against the accused and put him on his defence.

The matter comes up on December 19, this year.

Govt single sources IMS to take over toll plazas

Government has single sourced the private company that is installing speed cameras for RTSA to also take over the management and collection of revenues from toll plazas dotted on the road network around the country.

According to a News Diggers investigation, Intelligent Mobility Solutions (IMS), which is a joint venture between Lebanese plastic manufacturer "Lamise Trading" and an Australian company "Kapsch" submitted an unsolicited proposal for what they called "an integrated tolling solution".

Under the unsolicited proposed concession, IMS offered to invest US\$38.3 million over a period of 17 years, to take over control of the existing toll plazas, upgrade, enhance and expand, as well as construct more plazas, in order to arrive at a total of 25 tolling facilities under the deal.

Currently, government the through Road Development Agency (RDA) has contracted the National Road Fund Agency (NRFA) to manage and collect revenue from toll plazas, but last Friday when Parliamentary Public Accounts Committee (PAC) chairperson Howard Kunda asked NRFA chief executive officer Wallace Mumba to clarify if it was true, and why government was considering entering into a concession with a private company to collect toll fees, the agency boss denied having any such plans.

"Chair, I would like to mention that as management of NRFA and including the board of NRFA, we do not have that kind of intention in place. Essentially as an agency, we have continued collecting the revenues," responded Mumba. THE DEAL

However, an investigation has revealed that in fact, the deal was made through a single sourced procedure, and against the Road Development Agency's proposal to subject the tender to competitive bidding.

received "RDA an unsolicited proposal from Messrs Lamise Trading Limited in association with Kapsch on August 21, 2017 for a Public Private Partnership (PPP) for an Advanced Road Safety Management and Tolling Solution and Related Following a Services. preliminary review of the proposal, RDA sought authority from the PPP Council to invite competing



proposals as required under Clause 42 (6) of the PPP Act No. 14 of 2009," read part of the negotiation agreement obtained by News Diggers! Single sourcing was allowed on grounds that the company that sought to takeover the running of toll plazas needed to also be in charge of the vehicle registration under another concession with the Road Transport and Safety Agency (RTSA).

"It was, however, determined by the PPP Unit that no competing proposals would be invited as required under Clause 42 (6) of the Public-Private Partnership Act No. 14 of 2009 (hereinafter referred to as the "PPP Act") as the services that the proponent was proposing were specialised and could only be fully realised if the proponent was managing the vehicle registration under the Road Transport and Safety Agency, while at the same time also in charge of the toll collection system under RDA. The said unsolicited proposal was approved by the 7th Special Meeting of the Public Private Partnership Council held on 17th August 2018, pursuant to section 7 (b) of the PPP Act; and procured without competitive procedures, pursuant to section 35 (d) of the PPP Act," the agreement read.

"An inter-sectoral team comprising members from RDA, NRFA, PPP Zambia Revenue Unit, Authority (ZRA) and Zambia Development Agency (ZDA) engaged Lamise/Kapsch in good faith discussions in line with the provision of Clause 42 section 10 (c) of the PPP Act No. 14 of 2009 to get a full appreciation of the proposal prior to making a recommendation to the PPP Technical Committee. The PPP Council approved the negotiated Concession Agreement at its 8th Special Meeting held on October 5, 2018 for implementation. The Concession Agreement was subsequently submitted

to the Office of the Attorney General for clearance prior to signature as prescribed by law."

Further, the agreement was to the effect that once implemented, government would get 70 per cent revenue from the toll plazas in the first seven years while the investor would reclaim 30 percent; in year-eight to 12, government would get 72.5 leaving IMS with 27.4; and 75 to 25 respectively in the 13th to 17th year of the concession.

IMS DICTATING TERMS When the approved agreement was circulated among stakeholders, technocrats raised concerns that the period was long and that the proposed investment was not in tandem with the status of existing tolling infrastructure.

The stakeholders further directed RDA to re-negotiate with IMS so that the number of toll plazas covered under the concession should be reduced from 25 to 11, which would have a combined average daily traffic record of 21, 795 vehicles per day. "As directed, RDA reengaged IMS on the above stated issues from 29th to 31st October 2018. IMS was informed of guidance to RDA to limit the concession period to a shorter Concession Period such as 7 years. In order to achieve a shorter concession period, RDA optimized the project scope with a view of limiting the required investment. Under the optimized scope of work, 14 toll sites in remote areas were removed from the scope of the project. The remaining eleven (11) sites have a combined ADT 5 of 21,795 vehicles per day which represents 87.2% of the traffic and thus the removal of the fourteen (14) sites does not compromise the commercial viability of the project," read the negotiation agreement.

"The 11 toll plazas are Katuba, Manyumbi, Mumbwa, Kafulafuta, Chiwoko, Kamiza, Mkushi, Chilonga, Choma, ZimbaLivingstone and Kyabankaka (Solwezi Mutanda). Based on the assumptions reached in 2(a), the following matters were further clarified as follows: (1) The above stated 11 toll plazas have been constructed and only require technological enhancements. The total capital investment required to be made by the concessionaire was estimated at US\$ 14 million. (2) Based on the above considerations, RDA determined that the concessionaire would break even within 6 years and therefore; a concession period of less than eight years was feasible. (3) Revenue Share -The revenue under the above consideration was determined to be 95 per cent to GRZ and 5 per cent to IMS."

However, IMS rejected the counter proposal, saying it was not viable.

"Messrs IMS rejected the proposal by RDA to limit the scope of work to the eleven (11) toll plazas on grounds that the US\$ 12 million investment required was too little and, therefore, unattractive. Further, they indicated that the harmonization and full integration that was envisaged under the project would not be achieved under the proposed limited scope and hence the benefits would diminish significantly. IMS contended that a concession period of Seven years was not feasible taking into account the investment amount and how long it would take to recoup it. According to Messrs. IMS's determination, the minimum concession period that could be considered was 15 years. Messrs IMS further determined that reducing the concession period from 17 to 15 years profoundly reduced their return on investment from 13 per cent to around 9.5 per cent, which is the minimum return they were willing to accept on their investment," read the negotiation agreement.

GOVT CONTRADICTION

IMS and RDA have since agreed on all the terms in the "Integrated Tolling Solutions concession", apart from the concession period and the investment amount. But this is contrary to the Ministry of Housing and Infrastructure Development position that the constructed toll plazas already have integrated data servers which are linked to the NRFA headquarters in Lusaka.

On November 5, 2018 when he was asked on the ZNBC Government Forum to explain why the Michael Chilufya Sata Toll Plaza cost US\$4.3 million, Minister Ronald Chitotela said "is not just a toll plaza, it is coming with a back control, a system engagement, a back control room where everything that is happening on all our toll plazas now are linked to the main server at National

Road Fund Agency." According to records at the Patents and Companies Registration Agency (PACRA), IMS was registered on June 22, 2017, situated in Makeni. Its directors include two South African nationals: Douglas Graham Davey, holder of passport number M00093122 and Coenaraad Johannes, holder of passport number M00122928. Other directors are Lebanese Walid El Nahas, passport number RL0001100 and Ziad El Nahas of passport number RL3776058.

NRFA SOURCES EXPLAIN

IMPLICATIONS A source within NRFA told

News Diggers! that express "go ahead" instructions on the said concession were coming from State House.

"This is another example of a transactions, where the Zambian Government, is selling off strategic assets or handing over control of strategic assets using concession agreements and Private public partnership. The source explained that once implemented IMS would not spend anything in essence because the company would be taking over existing income generating toll facilities.

"So far 10 Toll Plazas have already been constructed at great cost with another 19 currently under construction at various stages. These plazas are already revenue generating with GRZ reporting that all tolls (inland and borders) generated K670 million in 2017 when only three key plazas were operational; and they estimated to make over K1 billion in 2018. So we can roughly estimate that the Toll Plazas are going to be generating US\$100 million a year in 2019 and keep growing based on the current infrastructure and the addition of more plazas," explained sources.

"As things stand, GRZ receives 100 per cent of the toll revenue at over US\$100 million a year, though 10 per cent is plowed back into administration and operations., But from the already existing toll plazas, IMS will receive at least US\$90 million over three years, yet they are only required to invest US\$38.3 million over three years for a 30 per cent share of the revenue over 17 years. How? In short they don't have to spend \$1 of their own money, and even if they do, their return on investment will be absurd, just from the fact they are taking over plazas with an existing revenue stream."

Govt permits three firms to import GMOs

The National Biosafety Authority (NBA) has granted three distributors permits to import products that may contain genetically modified organisms (GMOs). The three companies are Cold Chain, Horizon and Innscor who were among 12 retailers, wholesalers and distributors that applied for new and renewal permits.

At a media briefing, Thursday, NBA chief executive officer Lackson Tonga said the decision was arrived at after a risk assessment was conducted by the scientific advisory committee.

He said the committee recommended to the board for permits and assured citizens that the various products were safe for humans, animals and the environment. He explained that of the permits granted, a named distributor would import about 80 percent of the products that they initially applied for, while the other 20 percent had been rejected.

Tonga said this was because they may contain genetically modified soyabean product, which is believed to have been made through newly developed technologies which are not covered by the Biosafety Act.

He said the authority had continued its spot and compliance checks and during the operations one distributor and four retailers have been asked to remove all the Genetically modified products from the shelves.

But in a statement on Wednesday, Zambia National Farmers' Union president Jervis Zimba condemned ongoing manoeuvres by some quasi-government institutions to re-introduce GMOs into the country. Zimba revealed that the Union was aware of the manoeuvres being propagated by some quasigovernment institutions, but warned against reintroducing the GMOs as it will have devastating consequences on the local market.

"ZNFU is aware of manoeuvres by certain quasigovernment authorities that are trying to propagate the importation of Genetically Engineered Foods into the country. These authorities are trying to scheme ways of legitimising Genetically Modified Foods in the country at the expense of what we have safeguarded for years," stated Zimba.

Matibini's failure to declare Roan seat vacant illegal, says PF SG

By Zondiwe Mbewe PF Secretary General Davies Mwila says Speaker of the National Assembly Dr Patrick Matibini's decision to refuse to declare the Roan Constituency seat vacant, is illegal as it violates Article 72 of the Constitution.

And Mwila says Dr Matibini's refusal to declare the seat vacant on the basis that he wanted to give the Courts freedom to deal with Chishimba Kambwili's appeals conclusively, is unreasonable, illegal and amounts to use of discretion that the Speaker does not possess.

Mwila is therefore seeking an order, directing the Speaker to declare Kambwili's Roan Constituency seat, vacant.

In an affidavit in support of application for leave to commence judicial review filed in the Lusaka High Court, Wednesday, Mwila who is an applicant in this matter and Attorney General as a respondent, stated that on July 22, 2017, the PF Central Committee resolved to expel Chishimba Kambwili from the party.

He stated that the decision was communicated to Kambwili by a letter dated July 24, 2017.

Mwila stated that by a letter dated July 26, 2017, the Speaker was informed of the decision to expel Kambwili and requested that he declared the Roan Constituency seat vacant.

He stated that in the same month, Kambwili challenged his expulsion in the Lusaka High Court, saying the due process was not followed by the Central Committee when the decision was made to expel him, but consequently, an application was made to dismiss his matter for want of prosecution, and it was dismissed in a ruling dated October 25, 2018.



Mwila further stated that he wrote another letter to the Speaker on October 26, 2018, requesting that the Roan seat be declared vacant since there was no matter pending determination before the High Court in respect of the decision to expel Kambwili from the party. He disclosed that by a letter dated October 31, 2018, authored by Dorothy Kapumbu on behalf of the Speaker, Dr Matibini, citing Article 72(5) of the Constitution, refused to declare the seat vacant, "This was on the basis that: (a) the Court has not pronounced itself on the merits of the case to confirm the expulsion or otherwise; and (b) in any case there was an appeal against the dismissal of the case pending before the Court of Appeal," read the affidavit in part. Mwila further disclosed that in

Minia further disclosed that in response, he wrote another letter to the Speaker, reiterating his request to have the seat declared vacant and pointed out that the appeal pending before the Court of Appeal was in respect of the dismissal of the case and not the expulsion, but his request was again rejected.

"The Speaker writing through Dorothy Kapumbu refused to declare the seat vacant and reiterated that the matter had not been determined on the merits. And that since Kambwili may succeed in his appeals, the seat cannot be declared vacant in order to 'give the Courts latitude to deal with the matters conclusively," read the affidavit further.

Mwila stated that he believed that the dismissal of Kambwili's matter entailed that there was no challenge currently pending before the Courts.

"I am advised and do verily believe that the route honourable Kambwili has chosen to appeal the dismissal rather than commence a fresh action entails that his seat is liable to be declared vacant," read the affidavit.

Mwila is seeking the following reliefs: a declaration that there is no suit on the part of Kambwili for Roan Constituency pending before the High Court to challenge his expulsion; an order of certiorari, removing the decision of the Speaker to declare the Roan seat vacant; and costs.

The grounds on which Mwila is seeking the relief are that; the decision of the Speaker to refuse to declare the Roan seat vacant is illegal as it is in contravention of Article 27 of the Constitution and; that the decision of the Speaker to refuse to declare the seat vacant in order to give the Courts latitude to deal with the matters conclusively, is unreasonable and illegal as it amounts to use of discretion that the Speaker does not possess.

US-China trade wars will slow down Africa's economic growth - Rupiah

By Abraham Kalito The on-going trade wars between the Western countries and China meant to impose barriers on trade will ultimately have major implications on Africa's economic growth, says former republican president Rupiah Banda.

Speaking during 135th Trade and Development Bank (TDB) Board of Directors meeting Addis Ababa, in Ethiopia, Banda said Africa, including the global economy, would experience sluggish trade, which he projected to further contract due to the ongoing Sino-US trade wars.

China and the US are currently locked in a fullscale trade war as both sides are entangled in trade tariff disputes on various goods flowing from either direction.

In July this year, US President Donald Trump's administration released a list of proposed tariffs on US \$200 billion worth of goods, ranging from auto parts to construction material.

The White House on July 6 imposed a 25 per cent tariff on US \$34 billion of imports from China, especially manufacturing components, which Beijing promptly matched with tariffs of its own,

including on U.S. soya beans.

In a statement issued by First Secretary at the Zambia Embassy in Ethiopia Inutu Mwanza, Banda observed that tariff dispute will have adverse effects on African economic growth as most economies on the continent are commoditydependent.

He observed that there was need for African reduce countries to dependence on exports of primary products, but to instead add value to products and improve the diversification of economies.

"Zambia's fourth president, His Excellency, Mr. Rupiah Bwezani Banda, says the ongoing trade wars between the Western countries and China meant to impose barriers on trade have major implications on Africa's economic growth. Speaking during a special High-Level Stakeholders Appreciation and Engagement dinner on the occasion of the 135th Trade and Development Bank (TDB) Board of Directors meeting in Addis Ababa, Ethiopia, the former president said the global economy, too, is likely to experience a period of sluggish trade, with risks of further slowing down as a

result of the trade wars. Prominent among the people who attended the dinner were former Ethiopian Prime Minister Desalegn Haile Mariam; Ethiopian Minister of Finance and Economy, Ahmed Shide; Ethiopia's female first Chief Justice Meaza Ashenafi; National Bank of Ethiopia Governor, Abdallah Hamdok and Abdallah Hamdok, a member of the TDB eminent panel of experts. Mr. Banda cochairs the Eminent Panel of Experts on the TDB board with the President of Sevchelles, Mr. Danny Faure," read Mwanza's statement.

"The former president emphasised the need for African countries to reduce its dependence on exports of primary products, but add value to products and improve the diversification of its economies. Mr. Banda said faster integration of African economies focused on inter-African trade, removing barriers

to mobility of persons and capital investing in infrastructure was one sure way of guaranteeing the continent's economic growth. He urged African Union member-states to embrace the Continental Free Trade area (CFTA), the Tripartite Agreement COMESA, between SADC and EAC, which is expected to trade from Cape Town to Cairo. The former president further urged African countries to come up with exportprocessing zones like the

Lusaka Multi-Facility Economic Zone (MFEZ), which was focused on producing clean energy, while at the same time promoting tourism through a national game reserve linked to the facility."

Banda added that the Trade and Development Bank was actively engaged in intra-African trade and currently had an asset base amounting to US \$ 5.4 million.

"On the Trade and Development Bank, Mr. Banda said the bank was actively engaged in the African trade space with the total asset base amounting to US \$ 5.4 million as of 30th December, 2017. And Mr. Banda commended the government of the Federal Democratic Republic of Ethiopia for the young and dynamic leadership that has embraced gender parity. Putin threatens to develop nuclear missiles banned by US-Russia treaty

A defiant Vladimir Putin on Wednesday threatened develop to nuclear missiles banned under a treaty with the United States after Washington gave Moscow a deadline to comply with the key arms control agreement. The latest spike in tensions came a day after US Secretary of State Mike Pompeo said Washington would withdraw from a major Cold War treaty limiting mid-range nuclear arms within 60 days if Russia does not dismantle missiles that the US claims breach the deal.

Putin dismissed Pompeo's statement as a smokescreen, saying Washington had already decided to ditch the Intermediate-Range Nuclear Forces treaty (INF).

"They thought we would not notice," the Kremlin chief said, claiming the Pentagon has already earmarked an amount for the development of missiles banned by the treaty.

"We are against the destruction of this treaty. But if this happens, we will react accordingly."

Putin said about a dozen countries were now producing mid-range missiles of the type banned by the INF treaty. "Apparently now American partners believe the situation has changed so much that the

changed so much that the United States should also have such weapons. "What will be our answer?

A simple one: we will also do this," Putin said.

- 'Head off arms race' -

In Brussels, EU diplomatic chief Federica Mogherini urged Russia and the US to save the treaty, warning that Europe did not want to become a battlefield for global powers once again, as it had been during the Cold War.

"The INF has guaranteed peace and security in European territory for 30 years now," Mogherini said as she arrived for talks with NATO foreign ministers.

In October, President Donald Trump sparked



concern globally by declaring the United States would pull out of the deal and build up America's nuclear stockpile "until people come to their senses". Putin at the time warned that abandoning the treaty and failure to extend another key arms control agreement known as the New START, would unleash a new arms race and put Europe in danger. On Monday, the US leader said he wants talks with Putin and his Chinese counterpart Xi Jinping "to head off a major and uncontrollable arms race". Valery Gerasimov, head of Russia's General Staff, said that Moscow would increase the capabilities of its ground-based strategic nuclear arms. "One of the main destructive factors complicating the international situation is how the US is acting as it attempts to retain its dominant role in the world," he said in comments released by the defence ministry.

"It is for these purposes that Washington and its allies are taking comprehensive, concerted measures to contain Russia and discredit its role in international affairs."

- 'Ballistic missiles' -Signed in 1987 by then US president Ronald Reagan and Mikhail Gorbachev, the last Soviet leader, the INF resolved a crisis over Soviet nuclear-tipped ballistic missiles targeting Western capitals. But it was a bilateral treaty

between the US and the then Soviet Union, so it puts no restrictions on other major military actors like China.

Pompeo said at a meeting with fellow NATO foreign ministers on Tuesday that there was no reason why the US "should continue to cede this crucial military advantage" to rival powers.

NATO said it was now "up to Russia" to save the treaty.

The Trump administration has complained of Moscow's deployment of Novator 9M729 missiles, which Washington says fall under the treaty's ban on missiles that can travel distances of up to 5,500 kilometres (3,400 miles)

The nuclear-capable Russian cruise missiles are mobile and hard to detect and can hit cities in Europe with little or no warning, according to NATO, dramatically changing the security situation on the continent. US-Russia ties are under deep strain over a number of crises including accusations Moscow meddled in the 2016 US presidential election.

The two Cold War enemies are also at odds over Russian support for Bashar al-Assad's regime in Syria's civil war, and the conflict in Ukraine.

Washington on Tuesday promised Russia more "pain" if Moscow did not release three Ukrainian vessels and 24 sailors captured off Crimea last last month. *AFP*

Malaysia torches 2.8 tonnes of African pangolin scales



Malaysia on Thursday torched nearly three tonnes of seized scales of endangered pangolins worth \$9 million in a bid to deter illegal wildlife trafficking from Africa.

The Southeast Asian nation is battling to clamp down on rife trafficking through its borders of the anteating mammals, whose scales are highly valued in traditional Chinese medicine.

"Such a huge seizure and torching of it is definitely a blow to smuggling syndicates," Abdul Kadir Abu Hashim, the director-general of the Wildlife and National Parks Department told AFP.

Some 3,000 pangolins would have been killed to obtain the 2.8 tonnes (2,800 kilograms) of scales, Abdul Kadir estimated.

The scales were confiscated by customs officials at Malaysia's Port Klang between May and September 2017. The animal parts arrived in three

different shipments from Ghana and Cameroon, and had false local addresses, officials said.

"Forensic examination of the scales showed that it is from the African species," said Abdul Kadir.

The scales were incinerated at a private waste disposal plant in Port Dickson, Negeri Sembilan, south of the capital Kuala Lumpur.

Seized pangolin scales are usually meant for foreign markets including China and Vietnam, where raw pangolin scales are sold for large profits in traditional Chinese medicine.

Last year Malaysia torched eight tonnes of pangolin scales, Abdul Kadir said, adding that wild pangolins in Malaysia have become a rare sight due to rampant hunting and deforestation. Pangolins are also heavily poached for their meat which is considered a delicacy while products obtained from the animal are thought to increase blood circulation and lactation. *AFP*

Fellow Argentine Maradona is considered to be one of the best ever, while iconic figures from Germany and the Netherlands are also held in the highest regard.

Pele added: "As far as I'm concerned, Maradona was one of the best players ever. If you ask me, 'Was he better than Messi?' Yes, he was. Much better. "[Franz] Beckenbauer,

[Johan] Cruyff were also

excellent players." While Pele may not be Messi's biggest fan, there is no questioning his achievements since bursting onto the scene at

Barca. A remarkable tally of 567 club goals have been recorded in 653 appearances, with another 65 netted in 128 outings for his country. Messi has also won five Golden Balls, nine La Liga titles, four Champions League crowns and three Club World Cups. International honours have proved elusive, though, having suffered final heartache at the World Cup and Copa America. *Goal.com*

Leicester City crash helicopter rotor pedals failed

Disconnected cockpit pedals caused the helicopter crash that killed the Thai billionaire owner of Leicester City football club and four others on October 28, a British investigation found on Thursday.

The death of Vichai Srivaddhanaprabha shocked global sport and left the small central English city in mourning two years after the club's improbable first and only top-level championship title.

The helicopter, decorated in the blue and white colours of the team, spun out of control on takeoff moments after it cleared the stadium's roof.

Vichai attended most Leicester home matches, landing and taking off from the centre of the pitch. *AFP*
