Lusambo rejects Mayor Chanda for C/belt chair



The Lusaka Magistrates' Court has sentenced a 28-year-old man of Chipata Overspill to six months' simple imprisonment for trafficking and unlawful marijuana. of This was after the accused, John Frazer Mwamba, informed the court that he didn't see anything wrong smoking marijuana as it was for medicinal purposes, adding that if he can't be handled in Zambia, it was best to send him to a country like Jamaica where he can be allowed to smoke. In this matter, Mwamba was facing two counts of trafficking and unlawful marijuana. of It was alleged in the first count that on December 8, this year in Lusaka, Mwamba did traffic in psychotropic substances

of marijuana, a herbal product of cannabis sativa without lawful authority. In the second count, it was alleged that on the same day, Mwamba did use 0.9 grammes of marijuana without lawful authority. Mwamba was allegedly taken to the police by his mother after he became unruly, threatening his members of the family that he will beat them. And when the matter came up for plea before Magistrate K Sakwanda, he admitted the charges. Facts of the matter are

DEC officers received information that there was an accused person in custody at North Gate Police Post who was found dealing in suspected drugs. officers proceeded to the said place where Mwamba was handed over with the said exhibits and he admitted ownership. The suspected drugs were taken to UTH Food and Drug control Laboratory where the Public Analyst identified and confirmed the drugs to be marijuana. The accused gave a free and voluntary reply admitting the charge and was formally charged and arrested for the subject offence.

Asked by the court whether the facts where correct, Mwamba replied affirmative. the He, however, added that much as he had pleaded guilty, he did not see anything wrong in smoking the drugs because he was using them as medicine. When the court interjected, asking him whether he was aware that it was an offence marijuana, smoke Mwamba said, "If you can't handle me here, it's better

you send me to a region where I'm allowed to smoke, a country like Jamaica. When I smoke, I manage to find my way home. If I don't smoke, I have stomach pains," Mwamba In her ruling, Magistrate Sakwanda noted she gave Mwamba an opportunity to mitigate, but he had nothing to say. She added that although she had put into consideration the fact that the accused was the first offender, what he did was wrong and he was not remorseful.

Magistrate Sakwanda, therefore, sentenced him to

six months imprisonment. "You have not shown any remorse for your actions. Whatever type of medication you use, you need a prescription from the doctors. The drugs you used as medication are not allowed in Zambia. Just to show that what you did was wrong and to deter you from committing the same offence; I sentence you to six months simple imprisonment in count one and four weeks simple imprisonment in count two. The sentences are to run concurrently," ruled Magistrate Sakwanda.

UPND won't tolerate foreigners owning land in Zambia - Bauleni

UPND chairman for lands Adrian Bauleni says under a UPND government, the current happenings where foreigners are grabbing land across the country will cease ownership because will exclusively be Zambians. for And Bauleni says the UPND shall not foreigners tolerate coming into the country mine precious uncontrollably. In the UPND's weekly newsletter to Diggers! Bauleni stated that UPND was aware of the importance of land anywhere in the world, adding that it would be preferable to remain poorer than have the land taken away by foreigners. "Land is the greatest natural asset to mankind. Therefore, without land, it inevitably constitutes the dead-end for any nation and could easily lead to extinction of any human race. Therefore, it would be preferable to remain poorer rather than the land being taken away by the foreigners, the way it is currently obtaining in our country, Zambia. In our local situation, we might not be feeling the impact of the seemingly Chinese slow pace of land alienation. But the real gravity of it would be felt by the future generations of our people in no

distant future," he stated

Bauleni stated that in order to tackle land regime dispensation in Zambia, the UPND would government that ensure land became ownership exclusively for locals without exception. He added that whatever was obtaining currently where foreigners, mainly the Chinese, had the upperhand in grabbing land across the country would immediately cease. And Bauleni stated that UPND would stand by traditional rulers as partners in land governance, adding that the party's overall land policy was to support and consolidate the authority of traditional leaders management customary land. "They are the custodians our land collaborator with the government, even during the colonial days. Why should they be marginalized this time around and yet they were respected by the colonialists? The UPND government, therefore, pledges to stand by the traditional rulers as partners in the land governance in our country," Bauleni added. "The UPND government will, however, endeavour to enhance the authority on the customary land of the traditional rulers redefining putting in place systems and procedures in the collaborative process in

relation to the central government and other agencies that would be directly and indirectly linked to customary land administration. The consultations mutual would be the order of the day between the central government and the traditional authority over the customary land." Bauleni further stated that the UPND government would not tolerate the displacement of citizens from their ancestral land. "This has been ongoing under the PF government to displace and evict the citizens from their ancestral land, usually in preference to the foreigners. This is abominable, and will not be tolerated any further by UPND, especially in the circumstances of the abundance of land in the country. As a UPND government, we will endeavour to end the trend in order to keep the overall citizenry at peace and avert the story of recurrent displacement and evictions of our citizens," he pledged. Bauleni Meanwhile, stated that the UPND shall ensure equal distribution of land among Zambians, particularly women and the youth, as they constitute the majority of poverty-stricken citizens. He stated that the party would further carry out a land audit in order to know how much land constitutes Zambia.

Bauleni stated the party shall further review the Presidential powers over "The UPND government shall review the executive powers of the President over land in Zambia. The clause that stipulates that all land is vested in the President on behalf of the people of Zambia be reviewed critically. Unfortunately, the clause has been abused by the sitting presidents instead of engaging the traditional rulers and the affected citizens in certain parts of the country, the executive powers have been excessively used to secure land anywhere in the country. This is particularly common on the issues involving investors," he stated. Bauleni noted with UPND in power, it shall endeavour to get to the root cause of the failure to resolve the boundary disputes among chiefdoms. He further pledged that a UPND administration not tolerate foreigners who came the country mine precious stones uncontrollably. Bauleni stated that to strengthen the Office of Land Commission and the Lands Tribunal, the UPND would appoint a special committee to

study what goes on in the two offices.

"There is imperative to critically analyse the Office of the Commission of Lands and to strengthen the operations of the Land Tribunal. The two offices should be seen to operate independent of the external forces within the government circles. In order, therefore, to ensure smooth work culture by the two offices, there will be need to appoint a special committee for the purpose of studying what goes on in those offices. There is suspicion that there is corruption in the Ministry of Lands," stated Bauleni.

Chipata court jails three for unlawful possession of ivory

The High Court, sitting in Chipata, has jailed two men to seven years' imprisonment with hard labour for illegal possession of eight kilogrammes of ivory and leopard skin. In a press release, Wednesday, Ministry of Tourism and Arts public relations officer Sakabilo Kalembwe stated that another man was sentenced to six years' imprisonment with hard labour for illegal possession of ivory weighing up to two Kgs.

"The three men were tried and convicted by the Lundazi Subordinate Court and committed to the High Court for sentencing. The High Court, sitting in Chipata, sentenced Oscar Nyirongo, aged 38, to seven years' imprisonment with hard labour for the eight kilogrammes of ivory, contrary

No. 14 of 2015," Kalembwe stated. He further explained that, similarly, the Court sentenced Gabriel Nkhoma to seven years' imprisonment with hard labour for unlawful possession of prescribed trophy, namely one leopard skin, contrary to section 130 (2) (a) of the ZWA No. 14 of 2015.

And Morgan Ngulube was also sentenced to six years' imprisonment with hard labour for ivory weighing two Kgs contrary to section 130 (2) (a) of the ZWA No. 14 of 2015. The illegal possession of prescribed trophies, such as ivory, rhino horn, lion, cheetah and leopard skins are serious crimes in Zambia and attract penalties of up to 10 years imprisonment with no option of a fine, according to Kalembwe.

Democratic National Congress (NDC) has urged the Economics Association of Zambia (EAZ) to seriously introspect the new Council members to avoid a situation where the professional institution is rendered a PF surrogate. And the NDC say State House's launching of an inquiry into the privatization of public enterprises under the MMD regime is unnecessary and untimely. In a statement issued, Wednesday, general NDC secretary Mwenya Musenge warned the EAZ not to render itself a Patriotic Front (PF) surrogate by pushing a pro-PF agenda. "As NDC, we are not amazed that State House is now using professional bodies, such as the Economics Association of Zambia (EAZ), to discuss the privatization of former State assets. As NDC, we have fears that the EAZ will soon lose its relevance and respect if they do not thread cautiously," Musenge warned. "We call upon genuine members of the EAZ to seriously have an introspection of the new EAZ council. We foresee a situation where the EAZ will soon be a surrogate of the PF looking at the partisan lines some of its executive members are tolling." And Musenge said that State House's launching of an inquiry into the privatization of public enterprises under the MMD regime is unnecessary and untimely. On Tuesday, President Edgar Lungu's Special Assistant for Press and Public Relations Amos Chanda called for a

public and judge-led inquiry privatization of companies where an opposition politician was implicated. But Musenge said that government was better off spending resources on more pressing matters as opposed to wasting public funds on the inquiry . "As NDC, we feel the probe into the sale of state parastatals will not yield any results. Such an inquiry into the matter will merely be an academic excise and a waste of public resources. Colossal sums of money that could be spent on such an inquiry could be diverted to needy areas such as the health and educational sectors," Musenge argued. "Moreover, we feel most of the documents in the privatization of state firms cannot be traced. It's now almost 20 years after the MMD government concluded the said excise. Worse still, most of the people behind the sale of former government firms have either died or relocated from Zambia." Musenge charged that State House has ulterior motives for making the inquiry and intends on denting the image of the opposition. "We feel State House deliberately wants to dent the image and reputation of certain persons linked to the privatization of government assets. All this is

meant to disparage the image of a well-known opposition political figure," Musenge stressed. "This witch-hunt being promoted by State House is petty and extremely preposterous! It is unfortunate that such cheap talk is coming from the Presidency, undoubtedly, the highest office in the land. Zambia has a lot of urgent matters to resolve. State House could do well, for instance, to discuss the plight of starving villagers in Lumezi District living on raw mangoes." He also pointed out how President Lungu can focus on fighting corruption in his Cabinet and utilize the FIC Trends Report where most Cabinet Ministers were cited. "The Presidency can go further to discuss how President Lungu is fighting corruption in his Cabinet. Zambians want to know, for instance, what Mr. Lungu is doing about the latest Financial Intelligence Report handed over to him by the FIC. Several Cabinet Ministers are cited in this dossier," he narrated. "The country may also want to know how far the probe into the infamous procurement of the fire tenders has reached. The Anti Corruption Commission (ACC) has been investigating some named Minister over

wealth suspiciously acquired. We want to know if President Lungu has received and studied the file presumably handed over to him from the ACC. The Presidential handlers should use this period to organize a meeting with the Zambia Chambers of Mines to discuss the pending job cuts in the extractive sector." Meanwhile, Musenge, a former PF Copperbelt Province Minister, also warned Chanda not to get involved in politics, which should be left to politicians instead. "We want to caution the Presidential Spokesperson Amos Chanda NOT to use his office to fight proxy political battles. Mr. Chanda should leave political battles to politicians and he should be above partisan politics," cautioned Musenge. "The people of Zambia are not interested to know, for instance, how President Lungu used the monies he got from the sale of Zambia Cold storage. We believe that Mr. Lungu and others in the privatization team of state enterprises did a professional job in whatever undertakings and decisions they made. If those in the privatization team were involved in illicit acts, previous administrations could have probed those linked to the sale of parastatals."

Failed alliances create worst enemies, warns Nason Msoni

All People's Congress (APC) president Nason Msoni has warned political parties forming alliances to always bear in mind that their next most bitter enemies are those that fallout from a failed alliance. In a statement, Msoni noted that any reckless premature endorsements are a sure death nail of any progressive alliance. "Political alliances are formed for various political reasons but fundamentally they're formed to help leverage the political equation and ultimately takeover power. Ideally political alliances are a product of introspection after recognising the structural weaknesses in the constituent individual political parties and ultimately deciding to come together to fix and mend the deficit and become stronger to challenge the opponent. Political alliances are exceptionally sensitive to the environment in which they exist and therefore require

more reasonableness, maximum restraint and sensitivity relative to the other partners in the alliance," Msoni stated. "Political parties going into political alliances should always bear in mind that their next most bitter enemies are those that fallout from a failed political alliance than possibly even the opponent they have been scheming to remove from power. This happens when the much anticipated political alliance goes horribly wrong. Reckless premature endorsements are a sure death nail of any progressive alliance and this is precisely what has suffocated most promising political alliances in Zambia in the past leading to the assertion that political alliances don't work in Zambia." observed He that alliances affect the recruitment of other partner's alliance members. Msoni advised that political alliances must be built on the premise of

a genuine spirit of give and take. "Political endorsements in political alliances of individual political leaders tend to undermine the collective effort of other political leaders giving the impression that the formation has become a conveyer belt rather than a mutual front of leaders determined to fix the wrongs. Political alliances must be built on the premise of a genuine spirit of give and take. Political alliances do not offer an easy opportunity for recruitment of other alliance partner's members that effectively kills off the trust. Political alliance partner members ought to avoid making political statements that suggest that they're pursuing a double agenda whilst still in a subsisting political alliance. The PF and MMD faction alliance has run into trouble because of mistrust. The MMD faction has gone into a veiled attack on their political Partner and ally PF because they feel used, cheated and short changed," stated Msoni.

Ndola indecent assault victim goes missing

By Daniel Chansa The complainant in a case where five Ndola women inserted a bottle of beer in her vagina as punishment for allegedly going out with a married man has gone missing. It is alleged that on December 1, 2018, Precious Kapambwe 25 , Bridget Chisha 21, Magrette Mwansa 25, Catherine Banda 29 and Maureen Mutale 29, jointly and while acting together did abduct the victim in order to put her in danger of being subjected to grievously bodily harm. In count two, the five are charged with indecent When the matter came up for trial before Ndola Chief Resident Magistrate John Mbuzi, the state informed the court that the complainant had gone missing and demanded that the arresting officer explains her whereabouts. When arresting officer Francis Banda took the stand, he told the court that he had received a call from the victim, using a strange number, who informed him that she was in Lusaka and planned on never returning to Ndola. But her father, Sheikh Mwanakambwila, told the court that he was unaware of his daughter's whereabouts. "I did receive the summons for the witnesses and only managed to find one witness, the father complainant who indicated that the Complainant left home and he is not aware of her whereabouts. However, I managed to inform the father to be before court, as at now, I am not in the position to know where the Complainant is. Some few days, I received a strange number who called on my line and I spoke to the Complainant who indicated to me that she is in Lusaka and that she was not willing to appear or attend court, [for] reasons best known by her self. She further indicated that she is in Lusaka and will never come back in Ndola," the arresting officer, Francis Banda, told the court. But the state insisted that the witness interfered with. "We are convinced that the witness was interfered with. There is no any

other way, apart from interference," the state said. At this point, the state applied that the father, who was before court, explains the whereabouts his daughter. However, the defence team tried to object to the application but Magistrate Mbuzi ruled that the father, despite being a main witness, should explain only about where the victim is. "I don't know where my daughter is. I don't know where she is and am still looking for her. She left home on December 7. That is the last time I saw her," Sheikh Mwanakambwila, who is a tomato trader at Main Masala, said. The state insisted that the witness was interfered with and applied that the bail given to the three accused be revoked. In his ruling, Magistrate Mbuzi said if the witness would not be present at the next hearing, he would compel the state to proceed without her. "I will grant two conditions, one to issue summons to the witness, or two will compel the state to proceed without the witness. I will grant one adjournment. This matter will come up on January 7, 2019 for trial. The three will have their bail extended while the two will remain in custody," said Magistrate Mbuzi. It is alleged that on the material day, in Ndola's New Mushili township, the victim was having drinks at Star Point bar at Masala main market with Harrison Mwanza, the husband to Kapambwe. Whilst at the drinking place, Kapambwe showed up in the company of her other four friends. alleged upon seeing his wife, husband ran leaving victim alone. Kapambwe then picked the victim by force and took her to home where she was allegedly forced to undress. In the video that went viral on social media, the women are seen holding the victim's hands and legs while others are placing a bottle of castle beer in her vagina. The women are also heard warning her to stay away from married men as another captures the ordeal on her phone.

Skin me alive before you abolish meal allowances, CK tells Luo

Nkandu Luo should come and skin me alive first before she abolishes meal allowances, NDC leader Chishimba Kambwili has dared.

In an interview, Kambwili condemned Higher Education Minister

Professor Luo, who recently told a CBU student of her plans to stop paying students meal allowances effective January 2019.

effective January 2019.

Kambwili charged that President Edgar Lungu was allowing such alien decisions under the influence of alcohol.

"The problem that my sister, Nkandu Luo, has is that she wants to do things alone without consulting and I feel sorry for President Edgar Lungu, who is easily convinced. But I know how they convince him, they go to tell him some of these things when he's taking his wine, and when you are under the influence of alcohol, you don't think straight. There is just no way a reasonable President can accept that meal allowances for students should be scrapped off. Do you know where some of those students come from? Some of those, their parents cannot even raise a K10 per month. All they do is to farm, they grow maize, which they pound to make mealie-meal and grow vegetables in the yard, and that's what they feed on. So, where do you expect them to get the money to feed the children at the university? Come on, Nkandu Luo! Put a sock in it! But I will tell Nkandu Luo, she should come and skin me alive first before she removes meal allowances," Kambwili dares.

He asked Prof Luo to resign on moral grounds.

"Nkandu Luo should resign on moral grounds! Meal allowances in universities are paid all over the world for those who are on bursary. And this time, we have changed; it's on longer bursary, it's actually a loan, which will be paid back. So, that is just inefficiency of this government because they have over-borrowed

and the government is broke! They should not hide into the fracas that the students cause as a result of delayed meal allowances. Nkandu Luo will go down in history as the worst Minister of Education this country has ever seen! She should know that the beginning of the fall of government is arrogance, and my sister, on this one, awe baya sana! (She has gone too far!) She should not think that she can hold Zambia to ransom, her children are educated, she's educated and she was educated through the same bursary and she used to receive meal allowances. So, why would she want other children not to receive meal allowance?" Kambwili asked.

"But I will forgive Nkandu Luo because she has a President who agrees with everything. I am sure they went to tell him [about this when he was having his wine, and when he's having his wine, he agrees with everything! Ask Edgar Lungu how was he educated himself? He was at the University of Zambia, he was on bursary, he was being paid meal allowances and he should not forget that when there was noise for meal allowances, he also participated in those demonstrations so that they are paid. So, what is good for the goose should be good for the gander. Parliament will not allow the abolition of meal allowances for students. We are going to fight tooth

and nail and I want to warn

Nkandu Luo that they will see demonstrations that they have never seen in this country if they go ahead and remove meal allowances for the children."

Kambwili urged government to ensure that it was meeting its social obligations even as it was paying off the country's huge debt.

"It is not about

demonstrations by students, the truth of the matter is that this government has got no money! And I have warned people, and I want to say this again: very soon you will see teachers will not be paid for one or two months under this administration. The government is just broke...in next year's (2019) budget, they have provided K23 billion to pay debts! This is more than the total budget for the health sector. but they have provided for it to pay debts and they are going to borrow K28 billion. Meaning, therefore, that they are borrowing to pay debt! So, Nkandu Luo must not use the demonstrations to abolish meal allowances because demonstrating is a human right to express your anger, and she cannot sit on the rights of those students. The most unfortunate part is that students go to the extent of stoning innocent vehicles, and that I do not support. But to do a peaceful demonstration to show that their meal allowances have been delayed is a human right, it happens all over the world," said Kambwili, who is also the Roan PF member of parliament.

Govt terminates contract with contractor hired to build health posts in Muchinga

Ministry of Health has terminated a with a contractor who was engaged to construct 51 health posts in Muchinga on reasons that he had challenges with the host government.

Speaking at a ground breaking ceremony to signal the commencement of the construction of a first level hospital in Shiwangandu, Wednesday, Health Minister Dr Chitalu Chilufya also revealed

that government is constructing a state of the art second level hospital in Chinsali.

"The honourable minister did mention the issue of health posts, yes [but] unfortunately the contractor who we had mandated to build 51 health posts in Muchinga had a challenge with the host government and we had to terminate the contract on mutual agreement. So the health posts have not been completed in

Muchinga Province and in Shiwangandu only two have been done. I want to assure you honourable minister and through you the people of Muchinga that come December 28th this Friday, the contractor who has been assigned to continue building health posts will be in Northern Province and Muchinga to just ensure that everything is in place and map the programme so start constructing within January," Dr Chilufya He said providing health services under his ministry would not only be based on infrastructure expansion but also on taking the services closer to the people.

"We are determined as a government to ensure that all Zambians access health services across the ...We will therefore ensure that Muchinga Province has enough infrastructure for people to access health services closer to where they are. Health service will not only be based on infrastructure expansion, there must be services closer to where the people live, the quality must be very high, it must be affordable it must not result in financial catastrophe. So we are building health posts, we are building hospitals and mini hospital centres, we are building big hospitals," Dr Chilufya said.

He further said that the new Chinsali second level hospital will also be a training facility for nurses and medical degree doctors.

"The roadmap building health centres in Muchinga is crystal clear. We are building a state of the art second level hospital in Chinsali. That facility will be a referral facility for the whole province and surrounding areas closer to the province. If you have all the specialties that you hears of in the big general hospitals, it will be a training centre too, therefore you will be training nurses both public health nurses and clinical nurses. You will also be training specialist doctors. In the re-engineered approach human capital improvement, there is the first ever medical university in the country and that's a legacy of His Excellency President Edgar Lungu. You will be training medical degree doctors right here in Chinsali. We will ensure

that we deploy medical staff," he said.

And Shiwangandu PF member of parliament Stephen Kampyongo said he was grateful that government had decided to reactivate the construction of health posts project which had stalled for too long.

"In terms of the health facilities that you are bringing, you will be saving lives. It's the same with Kanchibiya where we have got areas which are cut-off sometimes during the rainy season and the facilities which are there are just not good enough and the population is growing. And so we are grateful that within the strategic plan of your ministry, you have factored in Muchinga Province out of the ten provinces. We are looking forward and we shall corporate with you to make sure that the projects that are being undertaken are done on time and that the contractors you are giving us are monitored because we have been disappointed in some cases. We of course know that the 650 [health posts] which we have been crying for, it was circumstances beyond the ministry's control. So we are grateful that you have reactivated that project so that those few which remained can also be completed," said

Kampyongo.

Christmas accidents drop in 2018

The Zambia Police Service has recorded a total of 125 road traffic accidents during this year's Christmas period, from December 24-26, 2018, compared to 234 road traffic accidents recorded over the same period last year, a reduction of 109.

In a press statement issued, Wednesday, Zambia Police Public Relations Officer Esther Mwaata Katongo stated that out of 125 road traffic accidents recorded during the Christmas period this year, 12 were fatal road traffic accidents in which 13 persons were killed; 15 were serious road traffic accidents in which 22 persons were seriously injured; 26 were slight road traffic accidents in which 31 persons were slightly injured, while 72 were damages only road traffic accidents. She explained that the reduced numbers in road accidents was mainly attributed to improved compliance of motorists to road safety due to increased presence of road traffic officers during this

year's festive season.

"There was a great improvement in compliance levels by motorists and other road users due to increased presence of traffic police officers and Road Transport and Safety Agency (RTSA) officers on major roads. These joint operations have continued. In 2017, during Christmas period, there were 164 casualties compared to 66 casualties in this year's Christmas holiday," Katongo disclosed.

She narrated that there was also a corresponding decline in the number of fatal accidents during the period under review compared to last year.

"In 2017, during the same period, 18 fatal road traffic accidents were recorded in which 22 persons died showing a decrease in persons killed by 9; 32 were serious road traffic accidents in which 52 persons were seriously injured last year showing a decrease in seriously injured persons by 30," Katongo stated.

"116 were damages only road traffic accidents in 2017 compared 72

damages only road traffic accidents recorded during this year's Christmas period."

She further stated that 68 were slight road traffic accidents recorded in 2017 with 90 persons sustaining slight injuries compared to 26 slight road traffic accidents recorded in 2018, with 31 persons sustaining slight injuries, showing a decrease by 42 slight road traffic accidents and a further decrease in people slightly injured by 64.

On reported criminal activities, Katongo revealed that this year's Christmas period was generally peaceful, however, 70 cases of assault occasioning bodily harm (OABH) were recorded; 18 cases of theft recorded; 11 related to malicious damage to property; eight cases of breaking into a building and committing a felony therein, while seven cases of threatening violence were recorded; six for burglary and theft; five for house breaking and theft and another five cases recorded for unlawful wounding.

for the Judiciary from members of the public.

We are afraid, and it appears to us that, the judges who felt personally insulted by Editor Sinjela appear to have used their powerful positions in the Judiciary to punish an individual for offending them.

We are not lawyers, but surely there is something very troubling about this issue. One of the principles we know that govern the way courts operate is that no one should be a judge in his or her own case. If you are the aggrieved person, there is no way you can be expected to be fair when judging your aggressor.

Anyone who observed proceedings that resulted in the imprisonment of Editor Sinjela will have to agree that the judges were very angry. They seemed to have taken personal

offence, maybe rightly so, against the accused. But the trouble is that it became obvious that they were going to use the stick in their hands to teach someone a lesson.

Well, clearly, they have taught Editor Sinjela a lesson. But one has to wonder how helpful this is to increasing respect for our courts. Yes, people may fear, but that is not the same thing as respect. Fear may be used to subdue people's behaviour, but it cannot change perception; if anything, it only adds to the mistrust.

This is what the courts should be concerned about. It is not whether or not people fear the courts or judges; it is whether they respect the courts and what they do. How this will be achieved is to ensure that our people view the work of the

Judiciary as work in their interest.

If the judges conduct themselves in such a way that the public believe them to be acting in the best interest of the nation, the courts will not have to imprison anyone. It is the public that is going to protect the Judiciary. The public will not accept the unfair criticism of the Judiciary because they will view such criticism as at attack on their interest.

Comparing the courts to parents is not the best way to illustrate the point, but it might well be helpful. If children start insulting a parent, a wise parent will not rush to whip the child without first interrogating what is going on. Could it be that the parent has, over time, failed to conduct himself or herself in a manner that should engender respect from a

child? Why would a child insult a parent who treats them well and provide for them? The point is: why would citizens insult judges, or lose respect for the Judiciary if it is serving them well? Where is the problem?

Sending Mr Sinjela to prison will not change the perception there is something very rotten about our judicial system. Something needs to be done to restore the respect and confident of the public in our Judiciary. The judges need to look at themselves and be very honest. Have they themselves, conducted generally, in a manner that would command respect from the public? Are they carrying out their duties with dignity and the independence that would inspire public confidence? How are they relating to the powers


that be? When there are suspicions of corruption, how are they being dealt with by the Judiciary itself?

These are the questions that our colleague Editor Sinjela was trying to ask, in his own words. These are legitimate questions that have to be faced. There are no two ways about it. Making an example of Editor Sinjela will not do anything, to help our Judiciary become a better tool for fighting injustice.

Our judges must fight to restore the lost public confidence by changing their moral conduct, showing their teeth to corruption and resisting interference from the Executive; rather than targeting critics. That journalist they have jailed 18 months won't change what citizens think about the conduct of some judges.

Maybe our judges don't know how it pains when you take a matter to court and you hear that it has been allocated to judge X or judge Y. Not only do you feel like withdrawing the case, but you also feel like crying from hopelessness. That is how bad it is with some judges, such loss of integrity can't be regained through imprisoning contemnors like Editor Sinjela.

Anyway, we can only encourage Editor Sinjela to be strong and always remember that there is a Judge above all those judges who agreed to send him to prison. That Judge knows who is guilty and who is innocent; prisons have no permanent tenants, but they also don't have permanent landlords.

Russian **Minister** sees oil prices stabilising in 2019

Russian Energy Minister Alexander Novak said on Tuesday that oil prices, which fell by more than a third this quarter, would become more stable in the first half of 2019. The Organization of the Exporting Petroleum Countries (OPEC) and other large oil producers led by Russia agreed earlier this month to cut their combined crude output by 1.2 million barrels per day from January in order to stem the fall in oil

"I think that during the first half, due to joint efforts, which were confirmed by the OPEC and non-OPEC countries this December, the situation will be more stable, more balanced," Novak said in an interview on Rossiya-24

Novak also said there were no proposals for an extraordinary meeting with OPEC, and he attributed the fall in oil prices to macroeconomic factors.

"Those are the fundamental factors: the decrease of demand in winter and, of course, the macro economy as we've been witnessing a decline in global economic activity at the end of the year and a fall on the stock market," he said. REUTERS

Nigerian army says 14 personnel killed in Boko Haram ambush

Security forces were on escort duty when they were attacked in Yobe state in the north of the country, army says.

As many as 14 Nigerian and military police personnel have been killed in an ambush by armed Boko Haram group, the army said in a statement.

According to the army statement issued Tuesday, security forces were on escort duty when they were attacked on Monday just outside Damaturu town in Yobe state in the north of Nigeria.

The statement signed by army spokesman Colonel Nwachukwu Onvema said efforts to pursue and "eliminate" the Boko Haram group are ongoing. READ MORE

Since the group launched its campaign in 2009, Boko Haram has killed more than 20,000 people and forced two million others to flee their homes in northeast Nigeria.

Nigeria's military has been fighting the group since then and despite the government's insistence that it is near defeat, northern Nigeria is still beleaguered by heavy fighting.

3 die in China university lab explosion

Three students were killed in a laboratory blast at a Beijing a courtyard, with trees and ground covered in firefighting university on Wednesday, the city's fire department said, in an accident that blew out windows and left the building a blackened shell.

"There was an explosion at the experimental site during a scientific research experiment" on wastewater treatment in the Environmental Engineering Laboratory, the Beijing Fire Department said.

"The accident caused the death of three students," it added in a statement posted on its social media account.

The incident happened just after 9:30am (0130 GMT) at the Beijing Jiaotong University in the western part of the city. Some 30 fire engines were sent to the scene, and it took nearly an hour to get the blaze under control. Local authorities have launched an investigation into the cause of the incident.

A video posted by the state-run People's Daily newspaper showed blown-out windows and blackened buildings around

foam.

Images on social media showed plumes of dark smoke billowing from low-rise buildings as firefighters fought to contain the blaze.

Students could be seen wearing face masks and complaining of an acrid smell.

Industrial accidents are common in China, where safety regulations are often poorly enforced.

Last month, a gas leak caused the explosion of a truck carrying combustible chemicals near the entrance of a chemical factory in the northern Chinese of Zhangjiakou, killing 23 and injuring 22 others.

In July, a blast at a chemical plant in southwest Sichuan province left 19 dead and 12 injured. The company had undertaken illegal construction that had not passed safety checks, according to local authorities. AFP

Riot police in the capital, Sudanese Khartoum, used live ammunition and tear gas in an attempt to disperse protesters marching towards the presidential palace.

Videos posted online appeared to show crowds of several hundred people heading towards the palace on Tuesday, which is located on the bank of the river Blue Nile in the heart of Khartoum.

The demonstrators could be heard singing patriotic songs and chanting, peaceful "Peaceful, against the thieves" and "The people want to bring down the regime" before police began firing into the crowds.

Jazeera's Morgan, reporting from Khartoum, said calls for the president to step down were growing louder with people turning up in significant numbers for the protest, which had been planned for a number of days.

agree they want to see live ammunition to change and the police disperse the crowd," had to use tear gas and

Morgan said.

"Unfortunately, for the police that is, people they want the 'regime' continued [marching].

We've heard people say to go, they want to see a new 'regime."

"Even with the tear gas being fired at them, some people have been using headscarves and went on to proceed against the riot police with their demands that the president must leave."

Tuesday's protest was organised by Sudanese Professionals Association, an umbrella coalition for professional unions, and supported by the National Umma Party, one of the country's top opposition parties.

They said they planned on marching to the palace and hand the presidency a memo calling for him to step down immediately.

Sudan's embattled President Omar al-Bashir has vowed to introduce "real reforms" since anti-government protests began in Atbara city seven days ago, but has also warned the protesters to not respond to attempts "at sowing discord" in the country. AL JAZEERA

Bench role worries promoted young Buffaloes players

Following their splendid secondplace finish in the 2018 Barclays Cup tournament and outdoing their senior counterparts, five Young Green Buffaloes (YGBFC) players have been promoted to the senior team in management's attempt to boost the senior squad.

Some of the promoted players however have shown reluctance to join their senior counterparts saying they fear being benched and not having game time. They are also cognizant of the disadvantages that come with not having reasonable game time in football and Goal Diggers! caught up with them.

"Most of us are very junior to almost all the players in the senior team and

we technically have little to no say over any decision made. It feels good to be promoted to the senior team but are we going to have adequate game time? When one is always benched, it becomes hard to know if you are improving or not," lamented one player.

Another one noted that it would have been better for them to be scouted by other clubs that are not under military management.

"If we were scouted by other clubs that are not under military management, it would have been better because we would be free enough to share our concerns with management," he said. Meanwhile, YGBFC coach Josphat Mulenga was all smiles knowing well that he had grilled players that

can compete favourably in the super league.

"I have trained them well and I still train with these that have gone to the senior team. It gives me happiness to see that I have made good players out of them," said Mulenga.

The boosting of Buffaloes senior team can be misplaced as most of the promoted players are either defensive midfielders or defenders. Senior team coach Biltone Musonda disclosed that he needed two strikers before the start of 2018/2019 continental games. He said that big spending clubs prevented him from acquiring his target strikers. Tunisian side SC SFaxien eliminated the combatants in the CAF Confederations League with an aggregate of 3-1.

Mauricio Pochettino has offered a cryptic response to questions about Christian Eriksen's future, with the Tottenham midfielder yet to sign a new contract.

The Denmark international is one of few senior stars yet to pen a long-term extension to his current deal, and unsurprisingly rumours have arisen regarding his future. As one of the most productive creative influences in the Premier League, a number of leading sides across Europe are keeping a close eye on his situation in north London. La Liga giants Barcelona and Real Madrid would welcome the opportunity to snap up a player of Eriksen's pedigree, and the transfer door may swing open at some stage.

Pochettino has been unable to close it, and when quizzed on his efforts to tie the key man down a long-term contract, he said: "Football is so dynamic. It changes every day, every season.

"It depends not only on your decision, but it is always a player's decision.

"Now is a moment to enjoy our present.

"Of course, it is a person that the club wants for the future, but now we need to be focused - a player like him is focused and tries to deliver a great performance in the way that we need.

"A decision is going to happen at the end of the season or [maybe] a decision will happen in the next few days, in January.


"Football is so dynamic - it is decision, decision, decision." I hope we are going to take the best decision for the club and hope the player can take the best decision for them and for the club - it is about negotiation and many things that happen.

"Football is so dynamic, always you need to move on." So, Pochettino has suggested that an agreement could be reached in January.

He has also conceded that Spurs may need to "move on". With little clarity being offered by those at Tottenham, it remains to be seen what the future has in store for a man who has delivered four goals and seven assists this season. *Goal.com*
