### Zambians should rise up and take their country back -Andyford

PAC president Andyford Banda has urged Zambians to ensure that the national dialogue process takes place this year, saying the ideal of getting independence under threat. And Banda says citizens should stand up and remind those in leadership that they are just caretakers at their mercy. In PAC's weekly newsletter to News Diggers! Banda wished all Zambians a happy New Year and a prosperous 2019. He hoped that citizens gather enough could courage to ensure that Zambia gets back on track. "Every person understand that challenges we are facing, collectively, as a country must to a large extent be blamed on those we have temporarily given authority to manage our resources, but must also be blamed on us as we fail to hold them accountable. That said, may the year 2019 be the year you

stand up to remind those in leadership that, actually, as citizens and shareholders of this country, you are the boss, not them. They are just caretakers and they are at your mercy," Banda stated. He confidently noted that the Church could be trusted to lead the dialogue process and that Zambians should do what it takes to support the process. "Having attended the meeting with the three Church mother bodies, I can confidently confirm that we can trust the Church to lead the dialogue process. I can confidently affirm that the three Church mother bodies are doing this purely for the good of our country and not anyone's interest. We need to look at the dialogue process as an opportunity that will help reset our country to the ideals that our forefathers stood for when they fought for Independence and the ideals that the MMD fought for in 1991," he stated. Independence was to ensure that this country is controlled by its citizens, and that the resources should equally be shared for the prosperity of the citizens as opposed to the white minority. The freedom fighters did not envision that 54 years after Independence, the freedom they fought for would be taken away by fellow citizens. Their vision was that Zambia would prosper." He insisted that citizens should ensure the muchhyped national dialogue this happens year. Banda added that citizens

## Don't discuss ConCourt outcome or you'll be jailed, YALI warns Opposition Alliance

Young African Leaders Initiative (YALI) executive director Andrew Ntewewe has advised pioneers of the recently-formed opposition alliance to stop discussing the Constitutional Court judgement on President Edgar Lungu's eligibility case or risk going to jail. In an interview, Ntewewe said the continued bickering over President Lungu's eligibility to contest elections in 2021 by members of the opposition parties was not adding any value to the country's political discourse. He, however, urged the 10-member opposition party alliance to clearly define the purpose of their unity and not simply to come together for the core purpose of removing President Lungu and the PF from office. "First of all, we think that the opposition parties that have come together in that alliance must define why they have come together. It would be naive to just form an alliance to try and remove President Edgar Lungu and PF out of government because once they do that, ultimately, what it shows is that what moves their agenda is personal glory, greed and selfishness. That they simply want to remove the party, which

is power, the person who is in State House, and they want to form government themselves. Now, the Zambian people do not want something like that, what they want is a political leadership that will be there for purposes of improving the livelihoods of the people. It is not supposed to be about improving the livelihoods of few individuals who form an alliance and then they want to form government," Ntewewe said. "The basis of an alliance should not be about removing a government. It should be moved by meeting the aspirations of the Zambian people. So, listening to the alliance and listening to what they are talking about, it does not inspire confidence. Because, for instance, the Constitutional Court judgement, we are all aware that the ConCourt is the court of final jurisdiction and when it makes a decision, that is final, it cannot be overturned by anyone. In essence, as YALI, our advice has been even prior to the judgement, that we should respect the judgement that comes out of the courts. If people want to criticize the judgement, yes, they can criticize it, but they are not supposed to scandalize the courts. When you begin to tell people that:

'can you rise against the ConCourt judgement', that is contempt! What you are doing is that you are now trying to take the law into your own hands. What you are doing is that you are not respecting the integrity and sanctity of the courts." Ntewewe added that scandalizing the courts was unacceptable. "From YALI's point of view, we have been very clear that anyone who scandalizes, we will be the first to push for contempt proceedings to be taken against them. So, the background of the opposition alliance, insofar as it relates to the ConCourt judgement, is misplaced and we want to advise the opposition that the best thing they can do is to sit down, try and think about what is it that they are offering the Zambian people because from a person on the sidelines outside politics, looking at what the opposition are doing, it seems they have run out of ideas because one expects them to talk about tangible issues. The Zambian people are concerned about having access to education. They want more secondary schools so that everyone can [have] access to education. That's the debate that we expect the opposition to begin to tell us. What is it that the PF have

done, which themselves they can do better?" wondered Ntewewe. "In 2019, government is going to introduce the Sales Tax and remove VAT; what is the position of the opposition in terms of how the mining sector can grow to create wealth and in the process move our economy to the other level? Unfortunately, these issues are not being debated. So, our call to the opposition is, let them sit down, let them not be moved by envy and jealousy that there is someone in State House who they think should not be there and it's them that are supposed to be there. That's not the case, the debate should be about, what is it that you want to do for the Zambian people, which the PF are not doing and you can do better? That is the debate we are supposed to be having. We are supposed to have a development driven debate. We are supposed to fight intellectually on development discourse. So, debates about the ConCourt ruling should neither be here nor there because it's final, and if they are not careful, they might end up going to jail for contempt. The best thing they are supposed to do is that let us debate intellectually on the development discourse."

cent pass rate, whereas grade nine, we recorded poor results and we still don't know the grade 12, and even tertiary [level] how they will fair...The other challenge is that, when parents are called to attend the PTA meetings, you find they don't go yet these meetings are very important because it's the moment you analyse the

academic issues. But you find parents don't go there, and among the few who attend, they go there to attack and accuse the school authorities of misusing the monies they pay. Even at home, they can't sit a child down to find ways and means of checking his or her performance, but we wait for government to do something. So, I urge parents to be concerned with the education of their children," he urged.

Mwanza also urged the General Ministry of Education to build more schools within communities so that pupils do not have to walk long distances to get an education.

And commenting the high rate of teenage pregnancies in some parts of Eastern Province where Chipata recorded 5,000 teenage pregnancies in a quarter, while neighbouring Chadiza District recorded 4,000 teenage pregnancies, Mwanza expressed shock at the alarming high rate despite concerted efforts to tackle the vice.

"The high rate of teenage

pregnancies in Eastern is a shock to me as yesterday or the other day, I was listening on the news that Chadiza has about 4,000 teenage pregnancies; this just shows that our children are highly sexually active such that what to do is not known as everyone is busy fighting the vice, but we still record a high rate? It seems our fight is in vain," he said.

He has since called for greater discipline among children saying their illicit activities will affect their entire lives.

"Pregnancies occur whether we put barriers or not. As long these children don't listen to their parents, we will continue talking and holding our heads in the sand these pregnancies will occur. The onus is not on us, but on our young people, the boys and girls, that the future lies in their hands. They mess up this time, the whole future will be a disaster! It's very shocking to see the percentages of these teenage pregnancies and everyone wonders where the world is going," said Mwanza.

## **We don't need police permit to campaign** during elections, UPND tells Kampyongo

Charles Kakoma says there is

no law that requires political parties to get permission from police to conduct campaigns during elections. Reacting to the directive made by Home Affairs Minister Steven Kampyongo to Western Province Police command that all political parties participating in Sesheke by-election must be included on the police schedule for them to conduct campaigns, Kakoma said his party would not adhere to that directive. "All elections, including byelections, are managed by the Electoral Commission of Zambia (ECZ), and they are managed in accordance with electoral laws. And during the time of elections, we don't have to get permission from the police under the Public Order Act or whatever other Act that Kampyongo is relying on; we just follow the Electoral law. And ECZ usually calls all stakeholders, all political parties participating in the by-elections to brief them on how to conduct their campaigns and draw up a timetable, which is agreed to by other political parties to be followed. And that is the programme we are going to stick to, not Kampyongo's programme," Kakoma said. He explained that only the ECZ had the mandate come up with a campaign programme for all political parties during election campaigns "Those things are agreed to at a meeting that will be called by ECZ, where all stakeholders, including the police, they will be in attendance, and when that programme is agreed to, all political parties will be given that programme, including the police, they will be given the programme, and that's the programme that will be followed, not instructions Kampyongo from how we should conduct campaigns!" Kakoma added.

And Kakoma said the PF

party during by-elections. He said there was nothing for Kampyongo to boast about with the past Mangango by-election as the PF broke the law to disadvantage the opposition. "But even during the Mangango by-election, there was nothing to boast about because when we had our campaigns, we were told to stop campaigning because Vice-President Inonge Wina was going there, after that, they said Lungu was going there, hence all opposition political parties must stop campaigning. They are the ones who are breaking the law and not the opposition; they broke the law in Mangango and disadvantaged us, there was nothing to boast about in Mangango," Kakoma said. He also alleged that the PF want to arrest the UPND candidate for Sesheke by-election

he refused to be bought. Kakoma, however, advised that Kampyongo should tell the police not to arrest the UPND candidate as doing so would trigger conflict. "We are geared for the Sesheke by-election, we already selected our candidate. The candidate we selected is a very popular candidate; he has been on the ground for a long time and hence the PF are scared that they are going

to lose and they have been intimidating our candidate; they have also tried to buy him and when he refused, they are threatening him with arrest! It is Kampyongo to tell his police not to arrest our candidate because that's what causes conflict. When you arrest the candidate, it will provoke his supporters and they will react! That's what causes conflict and not what he is talking about," cautioned Kakoma.

## Zambia's public service now a criminal enterprise, says Sacika

Zambia's public service has now descended into a criminal enterprise because of the rampant theft of public funds by Ministers, civil servants and other officials who have rapidly built properties from unearned income, says former Secretary to the Cabinet Dr Sketchley Sacika. And Dr Sacika has charged that the current crop of Permanent Secretaries in the PF administration are currently not in control of anything as evidenced by the huge number of public officers stealing funds without punishment. In an interview, Dr Sacika expressed shock that Zambia's public service had rapidly deteriorated to a criminal enterprise given the rampant theft of public resources that has gone unpunished. He wondered why public officers, who had frequently been cited for theft of public funds, had gone unpunished for their and urged President Edgar Lungu to arrest the plunder without any further delay. "Asking Zambians to pay more taxes when the proceeds are likely to go into the pockets of ministers and civil servants and end up being misused, is not a proper way to be running the affairs of the country. The government must first of all examine whether taxes it collects are being put to good use. I find it strange that we can have such rampant theft of public funds and the President is doing nothing about it. Why is he there? Is Mr Lungu there? We expect him to run the affairs of our country in a proper way. But he's not doing so. We must have an audit of the lifestyle of ministers, civil servants to ensure that those that have stolen money or have engaged in acts of corruption, can be brought to book. That's what Zambians want to see," Dr. Sacika said. "How can we have public officers building houses, lodges without mortgages from building

society or the bank? Who is giving them money to build the houses they are building? This is unacceptable! Our public service has become a criminal enterprise where those employed in the public service, where the concern of those involved in the public service is to use their positions to steal money or to engage in acts of corruption and that is unacceptable! The popularity of the PF government is compromised because of what is happening. And what is happening is that Zambia runs the risk of becoming a failed state like the Democratic Republic of Congo. We don't want to go that way." And Dr Sacika charged that the current crop of Permanent Secretaries in the PF administration were not in control of anything. "Our Constitution has defined the role of a Minister and that of a Permanent Secretary. The role of a Minister is to determine policy and to give the Ministry a strategic direction. That of a Permanent Secretary is to manage the institution and ensure that the policies of government are being implemented. But our Permanent Secretaries are not managing their ministries according to what the Constitution says, and that's why we have rampant theft of public funds because they are not in control of anything. Why do we have Permanent Secretaries who are incapable of managing their ministries? The performance of the Permanent Secretaries at the Public Accounts Committee (PAC) meetings leaves much to be desired and many people are wondering how such men and women could be allowed to hold such high office in our public service. Our system of government is dysfunctional because Permanent Secretaries love imaginations and managerial skills. Our entire public service system is operating without proper management! So, people are stealing money and engaging in acts of corruption because there is no proper management and control," he observed. Meanwhile, Dr Sacika endorsed Transparency InternationalZambia's (TIZ) callforanurgentaudit into the lifestyles of the thieving public officials. "I fully endorse the stance that Transparency International [Zambia] has taken over this matter, to institute a lifestyle audit for all government ministers. Why are ministers, civil servants, who have stolen money and are living the lifestyle, which is far in excess of their earned income, not being investigated and prosecuted? Why do we have the intelligence service? One of the functions of the intelligence service is precisely to monitor the lifestyles of people in the public service, and if they discover that you are living a lifestyle, which is beyond your earned income, they should take steps to prosecute you! The revelation by the Treasury Secretary (Fredsor Yamba) that last year, civil servants stole K31 million, while other equally huge amounts of money were misused by ministers and civil servants, shows the extent to which our system of government has collapsed," said Dr Sacika. "How can ministers and civil servants steal or misuse tax payer's money to that extent and nobody is penalized or held accountable? It's incredible! How can people steal such large sums of money and nobody has been held accountable? Our system of government lacks purpose, government is failing to solve the problems on what people experience on a daily basis. The delivery of public services and implementation of government programmes is very poor. The local government system has collapsed and various State organizations are under-performing. But you have the ministers and civil servants who are busy stealing money. How do you reconcile that?"

"Since PF came into office, we've seen a lot of economic milestones, especially in the last few years. People have been very pleased, especially with the infrastructure development and they can

try and transfer some of the national wealth to the people of Zambia. For those in the construction industry, we have seen that a lot of Zambians have been able to create wealth from the construction industry. Also in the mining sector, the PF administration has really gone out of its way to try and ensure that there is wealth transfer to a lot of citizens. This has been the call for Zambians on the Copperbelt for many years, that we have seen these mines existing, but we can't see transfer of wealth. What has resulted into the wealth of the Copperbelt is because of the force of the PF administration that business must go to Zambians, and that we must see this wealth created. So, we must not underestimate the strength of the PF. If you go around Zambia, there are

remote areas, but you will still find good roads, good schools, good hospitals," Siliya said.

'The ambition to begin to create new districts so that we accelerate development, people are taking pride in that, too. Just last year, we had seven districts declared. People take pride because they start to see massive construction of houses, administration blocks, district hospitals and new schools. People take pride to say: 'we are now a part of Zambia and we belong to this country as well.' So, there are a lot of milestones that the PF has achieved to continue to guarantee its popularity. We are not saying that there are no other things that we could have improved upon. We know that we continue to have challenges with agriculture and the President has said to the Minister of Agriculture: I want these issues sorted out. We must truly transform agriculture from just being maize-centred to truly the business of agriculture, where people become wealthy, and it's not just a way of life; it's the same thing with the mines, that we cannot continue to talk about the mines as a cash cow. We want to see it truly contribute to the coffers of this country so that that revenue is leveraged for us to continue investing in other sectors."

Siliya also said the PF's foreign policy under President Lungu's administration had resulted into a number of visits by some of the world's prominent people.

"In terms of foreign policy; look how the country was positioned this year by the PF administration, we ended up with massive visits to this country by very notable people, including the Duke of Sussex, Prince Harry. We had the President of Turkey, President of Congo, President of South Africa and many others. They came here because they value our friendship. Our President has made a lot of international visits and number one is economic diplomacy, resulting in Turkish Airlines coming to Zambia, resulting in support to the University of Zambia from Japan. But also, the President in 2018 committed to going to visit the people of Zambia. He has made so many trips within the country because he wanted to hear from them first-hand. He does not sit in State House isolated. He wants to know what's going on in the country and when he comes back, he's always saying: 'Minister, this is what I found.' It's amazing when you are in Cabinet with the President, he always says:

'this is what I found when I travelled to this place; this town' and so on, because he wants to be on the ground and share with the people their successes and frustrations," Siliya explained.

And Siliya said government would not allow Zambians to continue not benefiting anything from the mining sector.

"When the Minister of Finance presented her (national) budget, one issue that was truly commended by the citizens and many economists was the fact that she was going to do something new in the mining sector and that, on its own, is an indication that the people have confidence in the budget provisions, which were accepted by Parliament, and even some opposition members of parliament in their debate truly welcomed this. What is clear is that the status quo can't continue and the Ministry of Finance was saying: 'we might not have all wisdom as government, but we are willing to discuss, but what we are not willing is to maintain the status quo.' If there are other better solutions away from what she has suggested, then she's willing to meet the mines and discuss with them, but the status quo won't stay; we know that the mines are indeed a cash cow for this country, but we also want to know that the revenue government gets from there is commensurate with the kind of investment we are seeing there. We want to see more employment in the mines, not the levels that are there. Zambians own the mines and they have begun a dialogue about what is really the best

"I did receive the summons for the witnesses and only managed to find one witness, the father to the complainant who indicated that the Complainant left home and he is not aware of her whereabouts. However, I managed to inform the father to be before court, as at now, I am not in the position to know where the Complainant is. Some few days, I received a strange number who called

on my line and I spoke to the Complainant who indicated to me that she is in Lusaka and that she was not willing to appear or attend court, [for] reasons best known by her self. She further indicated that she is in Lusaka and will never come back in Ndola," the arresting officer, Francis Banda, told the court.

Ndola Chief Resident Magistrate John Mbuzi had adjourned the case but when the matter came up, Monday, the state informed the court that the complainant was still not before court.

"The accused are before court. The complainant is still at large. I have an application to make. Our application is that a bench warrant is issued against the complainant. Which should be returnable on 19 January 2019. On this day we will proceed with other witnesses who will be around. On this day if the complainant will not be around (father of complainant and arresting officer)," the state applied.

Magistrate Mbuzi granted the application.

# Kabwe man gets 25 years for defiling his step daughter

The Kabwe High court has sentenced a 42-year-old man of Luano district to 25 years imprisonment with hard labour for defiling his step daughter.

In this case, Simon Munkombwe was alleged to have had unlawful carnal knowledge of his step daughter aged 15 on May 13, 2018 while his wife was away, contrary to Section 138 of the Penal Code. When the matter came up for sentencing Monday, Justice Kelvin Limbani said the offender, Simon Munkombwe, deserved

to be punished to send a strong signal to members of the public to stay away from committing such offences.

"Cases of defilement, especially by relatives, who are trusted by the victims are on the increase. This calls for stiffer punishment to send a clear signal to the public on the need to protect girls in society. You deserve to be locked away to protect girl children and help you reform while in prison as well as reflect on your actions," Justice Limbani said.

Justice Limbani wondered what sort of

enjoyment the Munkombwe wanted to get by defiling his step daughter which his wife could not give him.

"I have gone through the records from the trial court. You grabbed your step daughter, threw her on the bed and forced yourself on her while your wife was away. I wonder what sort of enjoyment you wanted which your wife could not give you. You pleaded not guilty during trial but the trial court found you guilty. I agree with the trial court and consequently, sentence you to 25 years with hard labour," said Justice Limbani.

The Centre for Trade Policy and Development (CTPD) has urged mining companies to respect the integrity of Zambian workers and desist from using them as a means to influence government policies.

And CTPD says mining companies must transparent in telling the government what the actual costs of production are instead of referring to their staff workers.

In a statement, CTPD executive director Isaac Mwaipopo appealed to mining companies not to use local workers to bargain with government over the ongoing 2019 mining fiscal regime impasse.

Mining conglomerate First Quantum Minerals (FQM) has commenced the process of laying off staff this quarter following the implementation of the 2019 mining fiscal regime, which took effect from January 1.

Konkola Copper Mines (KCM) Plc has also followed suit by opting to downsize its Nchanga Smelter operations due to low availability of concentrates.

Part of what the 2019 mining fiscal regime has introduced are import duties of five per cent on copper and cobalt, while also hiking export duty on precious stones and gemstones to a rate of 15 per cent.

"The mining companies must stop using Zambian mine workers as tools for bargaining in negotiations on the proposed tax changes; this is manipulative and government should not condone such behaviour. CTPD has observed with great concern that every time there is a standoff between mining companies and government, the mining companies are quick in

times using the Zambian workers as 'sacrificial lambs' in the bargaining process. This is wrong and must end. While we understand that there could be some concerns from the mining companies with regards to the proposed tax changes, it is imperative that dialogue is prioritized over manipulative and arm twisting tactics," Mwaipopo argued.

"One thing the mining companies must never forget is that the minerals they are extracting and exploiting belong to the Zambian people, and Zambians have every right to participate and benefit from its natural employment is one of the ways through which this is achieved."

And while Mwaipopo mining observed that companies raised plausible concerns over the new changes, such as the Mining Royalty Tax (MRT), he urged mining companies to be open about challenges in their cost of production instead of instigating Zambian workers as a liability.

"We note that among the most notable proposed changes, the new mining tax regime proposes to make Mineral Royalty Tax (MRT) non-deductible from income tax and increases MRT by

the sliding scale depending on the international copper prices. Government has also proposed to abolish VAT and replace it with Sales Tax effective April 1, 2019," he observed.

"These proposed measures and other tax changes have infuriated the mining sector in Zambia and resulted into threats to lay-off close to 21,000 workers. The mining sector believes that the imposed new tax changes will affect production and expansion projects across on the sector."

He also doubted that the new fiscal regime should merit such huge layoffs.

number of concerns raised by the mining companies, CTPD would like to urge the mining companies to be a lot more open and sincere on their production costs, we do not think that the proposed tax changes could warrant such high number of job losses and backlash, unless they tell us that the Zambian work force is a burden they have always wished to get rid of," Mwaipopo added.

He further pointed out that most mining companies were performing well, according to financial reports.

"It is sad that mining companies have continued to project a picture that they are operating under tough conditions and that it's difficult for them to trade profitably, while publiclyavailable information continues to show that this may not simply be true. For example, in 2017 alone, it was reported by Bloomberg that profits for Glencore, Mopani's parent company, grew 400 per cent, from US \$1.38 billion in 2016 to US \$5.78 billion in 2017. Owing to this, Glencore paid US \$2.9 billion in dividends to shareholders! We urge the mining companies to explore other ways of cutting down on costs, this is something that can be worked in consultation with government and other key stakeholders. It will also be helpful if they can publish a detailed cost of production so that many can get to know what exactly goes in extracting minerals," stated Mwaipopo.

## ECZ will cause civil strife if elections aren't handled well, warns Hichilema

UPND president Hakainde Hichilema has warned that the Electoral Commission of Zambia will cause civil strife if they fail to handle elections properly like the case was in

And Hichilema has charged that PF is using police to harass UPND candidate in the Sesheke by-election Romeo Kangombe for refusing to stand on the ruling party ticket.

Meanwhile, Hichilema has warned that the Electoral Commission of Zambia will cause civil strife if they fail to properly manage elections by allowing civil servants to campaign for PF using public resources.

Hichilema was speaking to journalists, Monday, after holding a meeting with Electoral Commission of Zambia officials to raise concerns over irregularities in the electoral process.

Hichilema, who accompanied by his vice Geoffrey Bwalya Mwamba (GBM), UPND national chairperson Mutale Nalumango, Secretary General Steven Katuka, and other party officials, held a closed door meeting that lasted for more than two hours at the Electoral House. He said if ECZ failed to heed to his warning, Zambia would have civil strife like the case was in Congo DR.

"So you come through, in an election, through violence, through abuse of the electoral process, through using civil servants and state resources, then you say you have won an election, that's not true. So we have said to the electoral commission that we cannot continue having elections as though there is no problem. The ECZ must step in if they are to maintain their relevance, otherwise they will be irrelevant. Elections that are not managed poorly can bring civil strife in a country, we are seeing what's happening in Congo, just next door to us, they can't announce election results. You can see there is some manipulation going on and we don't want that to spill over here. In fact maybe, following what happened in 2016, we exported this hooliganism into Congo, ourselves as Zambia," Hichilema said.

Hichilema asked ECZ to stop civil servants who were campaigning for PF using public resources.

"We have reminded them of the involvement of civil servants in the elections, which is wrong. As it were in Mangango, there were a lot of District Commissioners, including a permanent secretary from State House was campaigning for PF, yet they are civil servants, the law doesn't allow them to campaign in by elections or general elections, because they work for the people through being civil servants. But this is not being addressed, it was in Mangango and we have seen the same happening in Sesheske already, even before nominations. That is what we have come to alert the ECZ that it is their duty to ensure that electoral laws and other laws that restrict civil servants from abusing public resources, motor vehicles, fuel, even when they remove number plates, is illegal and the ECZ cannot stand by and watch the situation," he said. "We brought to their attention

the violence that is being orchestrated before, during and after elections. The examples to Vwanganai ward in Solwezi, in the last round of by elections, it was bloodshed all over. And we cannot go into another election without the ECZ addressing these issues of violence. Elections should not be used as time to make people bleed blood, No! They are supposed to be happy moments for us to choose leaders that we believe these corrupt people that are coming through."

And Hichilema charged that PF was using police to harass Kangombe.

"We came here to have a meeting with the Electoral Commission of Zambia on matters relating to the fairness of the electoral process, the electoral environment before elections as it is now because there are by-elections coming, and during elections and after elections. Because it is clear from our point of view that the ECZ is not taking the matters relating to the electoral ground being unfair. Let's start with Sesheke, our candidate was been enticed to stand on their ticket, when he refused to do that, the PF are using the police to harass our candidate. And that constitutes interference with the electoral process, that's what we came here to alert the electoral commission. Because the issues on the ground in Sesheke have not been resolved and we cannot abuse the police, we cannot abuse institutions of the people to work against the democratic environment in the country, we made them

"We expect our candidate to file in nominations on the 10th January without being abused by the PF using the Police, and the ECZ is sitting, watching."

aware of that," he said.

And when asked if the party got an assurance from ECZ that the issues raised would be handled, Hichilema said it was not a matter of assurance, but duty.

"It is not a matter of assurance, it their duty, they receive salaries from tax payers, you pay them salaries to do what we have asked them to do. But we also know that they are being abused by the PF, we all know that. It is not a matter of them assuring us, it is to do their duty," said Hichilema.

## **Govt spent K1.5bn on debt** repayments in December

Debt servicing payments gobbled K1.5 billion in December, 2018, the highest single disbursement for an official government function last month. according to Ministry of Finance data.

And Minister of Finance Margaret Mwanakatwe says the 2019 national budget has commenced implementation. In a 2018 budget brief issued from the Ministry of Finance, Monday, government paid K1.5 billion last month in debt servicing commitments out of a total of K4.3 billion that was released to fund various government operations.

Government's debt servicing was the highest in terms of the total amount spent, even surpassing personal emoluments for public sector workers that swallowed up K1.3 billion.

The K1.5 billion in debt servicing payments represented around 35 per cent of government's total expenditure during last month from the 2018 national budget. "Of the K4.3 billion total funding, K1.5 billion was allocated to service both domestic and external debt; K437 million was spent on financing grant-aided-

operations, and a further K1.1 billion went to various government programmes, projects and public service delivery. In addition, K1.3 billion funded the wage bill (personal emoluments) for various public service workers including teaching, medical and security personnel," the statement read.

"To continue reducing the country's indebtedness and to ensure fiscal sustainability as charted in the Economic Stabilisation and Growth Programme (ESGP) and the Medium Term Debt Strategy (MTDS), the government released a sum of K1.5 billion in December, 2018. These funds went towards both domestic and external debt obligations. A further K81.4 million was released to liquidate outstanding liabilities related to the consumption of goods and services by various Ministries, Provinces and other controlling bodies."

And Mwanakatwe announced that this year's national budget has commenced implementation.

"The Ministry of Finance has commenced the implementation of the 2019 national budget. As we progress with

the implementation of revenue and expenditure measures for the current fiscal year, we are cognisant of the interest by rating agencies, analysts, investors and other players in the economy to take our activities into account in their assessment

"This year, the Treasury will continue to pay special attention to arrears dismantling in sectors that will significantly reduce Non-Performing Loans (NPLs) and release liquidity to the private sector. To promote fiscal consolidation, we will maintain a close watch on activity implementation in Ministries Provinces and Controlling Bodies so that there is strict adherence to programmed domestic financing for the year," stated Mwanakatwe.

"We will also continue to strongly observe the Presidential directive on constant assessment of the quality of expenditure in the public sector in order to allow the government to take remedial measures as unnecessary expenditures manifest."

### REFLECTIONS ON 2018 AND EXPECTATIONS FOR 2019 AS A YEAR OF ACTIVISM

government itself has imposed an employment freeze,

The year 2018 just like any other year under the reign of the Patriotic Front was miserable for most Zambians regardless of status in society. The levels of poverty in both rural and urban areas continued to skyrocket unabated. The cost of living for many people shot up. The cost of the food basket went beyond 5,000 Kwacha per month for an average family of six. Many people's incomes are well below K5,000 per month. Some estimates indicate that many people survive on less than \$2 per day. Food has become very expensive. Some people go to the market to buy animal skin instead of steak to feed their families. Chicken heads and legs, nyama soya are the closest to a smell of beef or chicken on the table in urban areas. In rural areas, some people are reported to be surviving on mangoes and wild fruits. There is serious hunger in the country. At one time, the country was shocked to receive embarrassing reports by an international institution that classified Zambia as the hungriest country in the world. Amidst all this poverty, the Apamwambas are living in luxury; increasing their salaries, flying all over the world and buying jets. This is despite the average salaries for most workers in the formal sector such as civil servants being scandalously low and strained by a wage freeze for a long time.

The Patriotic Front has continued on its trajectory of poor policies and planning resulting in the collapse in socio economic service delivery. Sectors such as Education, Health, Agriculture, manufacturing and Tourism have continued to receive visionless attention under the PF government leading to a decline in economic growth. When the PF took over government in 2011, the economy was growing at 6 to 7 percent per annum. It has shrunk to 3.5 percent. Some analysts even think growth is below 3%. This, as UPND argues, is not enough for a nation striving to attain a prosperous middle income status by 2030. UPND's vision is to grow the economy by not less than 10 percent per annum in the long run.

#### SOCIAL ECONOMIC SECTOR

The PF has failed to arrest the high levels of unemployment in the country resulting in most of the qualified labour force mainly youths to engage in illicit activities as a means of survival. In 2018, for example, 27,000 graduate teachers applied for deployment in the civil service but only 2,000 were recruited by the government, throwing more than 25,000 graduate teachers back on the streets with the private sector not strong enough to absorb such a huge number. This is against the backdrop of a national teacher shortage of 30,000 as of June 2018. Has anyone taken time to find out what has happened to the 25,000 graduates that were not successfully absorbed into the public sector despite paying affiliation fees to the Teaching Service Commission.

The Health sector is reeling under a nurse shortfall of 20,000 as of November 2018 despite the hundreds of graduate nurses that are churned out onto the labour market by the several tertiary institutions annually. The PF promised to employ 30,000 nurses by 2030 which means an average of 3,000 per year. They can hardly employ even 500 per year. Such pronouncements are not anything new with the PF. Promises of 1 million jobs to be created between 2015 and 2021 are yet to be fulfilled but what the nation has seen is a myriad of retrenchments especially in the mining sector. The

except for essential services and filling vacant positions. The year 2018 under the PF also saw more than 56 thousand youths applying for recruitment in the police service but only a paltry 1,000 were recruited, throwing another chunk of 55,000 youths on the streets without any tangible survival prospects. The agriculture sector has continued to register dismal performance with the infamous Farmers Input Support Programme (FISP) becoming a complete failure. The national maize annual output has been declining over the years due to poor policies . Late delivery of farming inputs, a discredited e-voucher system and late payment for the crops bought from the farmers has compounded the poor tonnage yield thus affecting national food security. A bag of mealie meal today is selling between 90 and 100 kwacha in some parts of the country, which many people cannot afford. Most farmers have given up on government initiated programs opting for private driven programs. A classic example is Gwembe district where the Food Reserve Agency only managed to buy fifty two (52) bags of maize in the 2018 crop marketing season with most farmers opting to trade with the private sector which offers a higher purchase price and paid upon delivery. This lack of confidence in the government crop marketing system by the farmers shows that the PF's performance in the year 2018 has continued to be dismal leading to a failed social economic sector. The PF government has failed to protect the poor and vulnerable people in society. Large sums of social cash transfer funds meant for the poor have been stolen or mismanaged. Corruption has taken centre stage in society. Government is in the forefront promoting corruption by awarding contracts to friends, relatives, PF cadres and Chinese nationals without following tender procedures. Ubomba mwibala alya mwibala has been institutionalised as a normal PF government policy. People complained about fire tender, ambulances, road contracts, toll gates and many

shoddy deals but government closed its ears.

The year 2018 started and ended with the country heavily sliding into dictatorship. The nation continued in 2018 to witness some of the worst human rights atrocities with shrinking political space. We have had political players summoned and arrested by police on flimsy charges such as unlawful assembly, conduct likely to cause the breach of the peace through the use of the infamous Public order Act. Police wantonly used live ammunition and other brutal means in stopping peaceful demonstrations resulting into the death of one UNZA fourth year student from tear gas suffocation. The police had in 2018 stopped and arrested members of the clergy assembled in a church on a charge of illegal assembly on the Copperbelt. The UPND President Hakainde Hichilema was summoned to appear before Ndola police on fake allegations. Both the civil society and political movements have continued to have their space invaded by both police and political players while the media continued to operate under threat with a number of community radio stations invaded and threatened with closure for hosting opposition political players. A media practitioner is currently serving a jail sentence for publishing an article questioning a judicial judgement.

Some opposition political players were pursued into cemeteries and beaten while ruling party cadres have continued to reign terror in bus stations and markets contrary to national statutes. A trajectory of lawlessness continued to characterize the PF rule in 2018 while efforts by the church to spearhead a process of national dialogue and reconciliation have been met by stiff resistance from the PF and its surrogates who stand to lose out.

#### THE UPND IN 2019

As the country's major political party, the UPND under the leadership of President Hakainde Hichilema will step up its role as the political watchdog and provide hope for a people that have lost hope for tomorrow owing to the poor governance levels under the PF. The UPND expects the PF government to solve the problem of unemployment especially among the young people. This should be the number one priority. If the PF government fails to seriously tackle unemployment, they should leave office because they are incompetent and time wasters.

We equally expect the PF government to solve hunger and poverty in the country. They cannot continue to wine and dine while the people are wallowing in poverty.

In 2019, we expect the PF government to put to an end the wanton looting of national resources through corruption. If PF is allowed to continue to embrace corruption, there will be no country to talk about come

The party through its vibrant legislative and civic leaders will continue providing checks and balances on the PF government and its corrupt, extravagant and dictatorial leadership. The UPND has declared 2019 as a year of activism and calls on all Zambians to join in the movement against dictatorship, corruption, economic malaise, exorbitant spending by government as well as break down in the rule of law. The UPND wishes to assure the nation that it shall without conditions participate in the church driven National Dialogue Process as we believe it is the only sure way of restoring national confidence and pride among Zambians. The nation is bleeding from the ills of tribalism, nepotism, regionalism, corruption and mismanagement. We however remain optimistic that together as a people, we are strong enough to overcome and the UPND is ready to lead that crusade in the year 2019.Better days are coming ahead. We shall be bruised but our resolve is much stronger going forward.

## Inspire your staff in 2019

I have this feeling 2019 should be a great year for entrepreneurs across the country. However, in order to win, the management ought to inspire their staff to do more, win more and innovate more. There are many employees who went through a tough time in 2018. The news has been about hundreds not being paid salaries for months because circumstances were tough. You cannot properly deliver to your company when you are not sure about whether your job is valid. The mining companies closed the year with internal op-eds about how they plan to lay off some of the staff on account of a difficult operating environment. This is a huge dent on

I personally believe that despite the anticipated challenges to our economy, some of them expected to be realised, I have confidence that if managers turn the clock, focus on staff and their levels of motivation, businesses can still win. In any case, businesses that will consider the global market will beat the internal economic hiccups. My own business is extending its business influence to the region, opening up new frontiers because there will always be economies that do

Even here in Zambia, a number of businesses are expected to perform beyond expectation this year provided they hook well into the many other opportunities opening up. The key word is inspiring our employees to be innovative, efficient, effective and able to turn on their entrepreneurial mind-set.

I started the year by helping a number of businesses to unlock the existing productive potential among their staff members and looks like the magic is already working for some of them. Within two weeks of training managers of a certain company about how to win through their own people, feedback has been excellent, 'Mr. Kanyama, it has never happened that our staff can win contracts even before end of the Christmas break.

That lecture was miraculous,' said the Chief Executive Officer. But how do we inspire our staff?

**PRAGMATISM**: I have told my own staff, 'we have marketed enough but marketing without cheques is not business. Let us roll up our sleeves and I am first to go.' Pragmatism is more than being efficient, it's about delivery. The boss should go first. As the overall manager of the business, demonstrate hard work, duty of care, frugality in the management of resources, and at times, doing the work yourself.

I advised one CEO, 'One of these days, do the insurance underwriting yourself at the front desk. Spend the

MENTOR: I am one of those few managers who delegated less in 2018 because I feared the quality of work would be compromised if I entrusted subordinates to do it. I was burnt out. The rest of the staff watched in horror how I nearly collapsed for trying to do everything myself: drafting tenders, visiting clients, conducting training sessions, at times ten days continuously. By the close of the year, I was left torn apart emotionally and physically. Worse still, the administrative part of the business (finances) were in disarray, prompting auditors to charge us twice more.

Are you willing to make a performance transition this year by mentoring your staff to carry out tasks they have never done before? You have a team of professionals in your organisation whom you pay huge salaries and these individuals want to be entrusted with challenging tasks. I have raised this issue because in our own survey during training programmes of executives in 2018, we discovered that many managers tend to do the work themselves. You have no choice but to equip your people through training programmes, well designed internal mentorship initiatives and assigning them to new assignments.

**MOTIVATE**: Motivation is a direct way of inspiring staff. This time, they do not just observe you from afar about how you manage the business. You can also inspire them by communicating positively about succeeding against all odds. Your company should be about demonstrating a culture of achievement, from the sweeper to the directors. Identify the good side of your people, the business, the customers and let everyone's attention be drawn towards exceeding expectations. You are at the helm, live the life of success, affirm it loudly and show everyone the business can win.

Home Affairs Minister Stephen Kampyongo says government shall by the end of this year add 3,000 extra bed spaces to the current 11,100 in correctional

And Kampyongo says there's need to provide for sentences that can be served within one's community in order to reduce congestion in prisons.

Meanwhile, Chief Justice Irene Mambilima has noted that the Judiciary has reduced on the backlog of cases.

The duo were speaking at the ceremonial opening of the Lusaka High Court criminal sessions for 2019 held under the theme, "restoring dignity for the incarcerated", Monday.

Kampyongo announced that government shall add additional 3,000 bed spaces to the current 11,100 in prisons, by the end of this year.

He said that these improvements would come through, two ultra modern correctional facilities being constructed at Mwembeshi in which the developers shall in return take possession of Lusaka Central and Kamwala Correctional facilities.

"My government has since 2012 increased the capacity of correctional centers from 8,250 in 2011 and to 11,100 by the

"There are some short term measures that we must work together on to reduce congestion in the correctional facilities such as providing for sentences that could be served within one's community, especially for non-

Technologies to monitor offenders left in communities now exist and the offenders incarcerated within the confines of their homes for example, cannot pose any threats to society. We must therefore take advantage of these technologies and make serving sentences within communities," he said.

Meanwhile, Justice Mambilima said the ceremony was always an important event on their Annual Judicial Calendar because it gave them an opportunity to selfintrospect and plan for the year ahead.

She said in 2018, the Judiciary continued to vigorously address the problems of backlog and delayed judgments.

"In my official opening speech for the Ceremonial Opening of the 2018 High Court Sessions, I stated that the biggest challenge that was afflicting the Judiciary was the backlog of cases and delays in the disposal of cases and the delivery of judgments. I am glad to disclose that in 2018 the Judiciary continued to vigorously address the plaguing problems of backlog and delayed judgments, she said.

"I must mention that in the last three years, the judiciary mounted an aggressive policy against backlog in both criminal and civil matters. This was in reaction to a public outcry for the speedy delivery of justice and the need to fulfill our constitutional mandate to ensure access to justice to all and speedy dispensation of justice. To this end we have drastically reduced on the time an accused person spends in the criminal justice

She commended stakeholders for their support, adding that their aggressive fight against backlog was intensified last year. "This was achieved with the help of other stakeholders like the Director of Public Prosecutions' Chambers, Legal Aid Board,

Prisons and Police Services and the Law Association of Zambia. I wish to commend the stakeholders and urge them to continue supporting us. Also of importance, is the support rendered by the Treasury by making extra funds available for the extra court sessions. As a result of all of this, the High Court is now current in that it is dealing with criminal matters filed in 2018," she said.

And Justice Mambilima said out of 532 criminal matters filed in the Lusaka High Court last year, 294 cases were disposed of while only 112 cases were pending trial or judgement and the other 112, were pending cause-listing.

She said the significant disposal rate of cases had brought about a significant reduction in the backlog of cases.

Justice Mambilima added that their mission this year was to ensure that there was no backlog of cases again.

"Our mission this year is to

ensure that backlog does not rear its ugly head again at Lusaka. We will also send the task force on backlog to Kitwe and Livingstone in the first quarter of this year to dismantle backlog at those two stations," she said. She announced that the judiciary had reached an advanced stage in the process of coming up with High Court rules which would help in fast tracking of cases and assist Judges in case management.

Justice Mambilima added that the rules made provision for time within which a judgment should be delivered.

"The Rules make provision for time within which a judgment must be delivered. This innovation is a reaction to the public outcry for the need to have predictability in terms of disposal of matters. We will soon submit the draft Rules to the Ministry of Justice for further legislative procedures," said justice Mambilima.

In his political discourse published column in News Diggers! on Monday, University of Zambia lecturer Dr Sishuwa Sishuwa named National Democratic Congress (NDC) party Chishimba leader Kambwili on his list of Zambian heroes who inspired the nation in 2018.


In the same vein, making a mockery out of



## 2 Gabon Coup plotters killed

Two soldiers who took part in Monday's attempted coup in Gabon have been killed, the president's office says.

They were shot dead after security officers stormed the national radio building which they had taken over. Three others are under arrest.

The junior officers claimed they seized power "to restore democracy" in oilrich Gabon, where the ailing leader's family has ruled for 50 years.

"The situation is under control," the presidency statement said.

Coup leader Lt Kelly Ondo Obiang, was on the run for a brief period, before being found hiding under a bed, reports Radio France Internationale (RFI).

"The situation is calm. The gendarmes who are often stationed there have taken control of the entire area around the radio and TV headquarters, so everything is back to normal", said Guy-Bertrand Mapangou, a spokesman for the government of the west African country.

Mr Mapangou said that the army generals, civil society and opposition leaders mentioned in the rebels' statement as potential supporters would be investigated.

The spokesman for Gabon's main opposition party has however denied any knowledge of a link with the rebel soldiers.

Claye Martial Obame Akué said that he wasn't aware of any link between the soldiers and Jean Ping the leader of the Coalition for the New Republic, RFI reports.

Current leader Ali Bongo, who has been out of the country for two months, succeeded his father Omar Bongo as president in 2009. He narrowly won reelection in 2016 in a poll marred by violence and accusations of fraud.

expires at the end of this season and he appeared to say goodbye after Saturday's 2-0 FA Cup win over Nottingham Forest, where he applauded all sides of Stamford Bridge.

The Blues boss said

Fabregas had a "free day" on Sunday, refusing to confirm or deny reports the playmaker had travelled to France to meet with Monaco, but demanded that the Blues supply him with reinforcements should

he join his former Arsenal teammate Henry in Ligue 1. "If Cesc will go, of course we need a replacement," Sarri said to reporters ahead of Tuesday's League Cup semi-final first leg against Tottenham at Wembley.

"Now, with the midfielders we are in trouble, I think. Without Cesc we have only five, so we are in trouble. We need a replacement."

With Chelsea offering oneyear contracts for players aged over 30, Sarri added that Fabregas, whose opportunities have been limited this season, should accept a two-year deal on the table from Monaco for the good of his career.

"In my opinion, he needs to go," said Sarri.

"You know very well the situation. You know very well in this club there is a rule -- the renewal of players over 30 is usually one year. "He has an offer for two years. I don't want a very important player as Cesc unhappy." *AFP*

Aubameyang of Arsenal.

Consistent scorer Salah has already won the 2018 BBC African Footballer of the Year prize and it would be a shock if he did not add to his collection of individual honours in Dakar.

Should he be confirmed as the best footballer in Africa once again, Salah will become the first player from the north of the continent to claim back-to-back titles.

Ivorian Yaya Toure, Samuel Eto'o from Cameroon and Senegalese El Hadji Diouf achieved the feat in a competition first staged 48 years ago with Malian Salif Keita voted number one.

Manchester City midfielder Toure, the younger brother of former Arsenal defender Kolo, went on to finish first four times in a row from 2011.

Eto'o and Ghanaian Abedi 'Pele' Ayew are also four-time Player of the Year winners, but not in consecutive years.

Paris-based France Football magazine organised the



annual award until the mid-1990s when the Confederation of African Football (CAF) took over.

Votes from national team and selected club coaches, CAF officials and unnamed 'experts' count toward deciding who lifts the trophy.

Salah scored 44 goals in all competitions for Liverpool last season, his first at Anfield after moving from Italian Serie A outfit Roma.

- Slow start -

After a slow start to the 2018/2019 campaign, the right-side attacker has

netted 13 goals, one less than Aubameyang and Tottenham Hotspur and England star Harry Kane.

The Egyptian also scored the winning goal against Napoli at Anfield last month that took Liverpool to the knockout phase of the Champions

League at the expense of the Italian club.

Salah had less success with Egypt last year as injury ruled him out of the loss to Uruguay at the start of the World Cup in Russia.

He did score against both Russia and Saudi Arabia,

but the north Africans were beaten in both matches and exited without securing even one point.

Later in the year, Salah scored twice but failed to convert two penalties as the Pharaohs ran riot at home to Niger in a 2019 Africa Cup of Nations qualifier, winning 6-0.

Aubameyang, the son of former Gabon star Pierre, has made the top three for the fifth successive year, finishing second in 2014, then first, second and third.

Mane was third behind Algerian Riyad Mahrez and Aubameyang in 2016 and second last year, 118 points adrift of Salah.

Madagascar and Mauritania, first-time qualifiers for the Cup of Nations, will compete with Uganda for the national team of the year award.

Asisat Oshoala from reigning African champions Nigeria is seeking a third straight victory in the Women's Footballer of the Year category.

Her rivals are compatriot Francisca Ordega, and Chrestinah Kgatlana from South Africa, runners-up to Nigeria in the 2018 Africa Women's Cup of Nations. *AFP*
