I won't allow LCC to harass vendors - Kamba

By Sipilisiwe Ncube Aspiring PF Lusaka Chairman Provincial Kennedy Kamba says he will not allow the Lusaka City Council (LCC) to turn street vendors into enemies of the PF government by harassing them. Kamba And says complaining about him in the media will not unite the party, but encouraged aggrieved those follow the right to communication channel. In an interview, Kamba vowed not to allow LCC to turn vendors against PF. "I have just seen that the Lusaka City Council were destroying the mobile money booths in the Central Business [District] of Lusaka, why? Based on that they don't have a license! Honestly, how do we go that far when the unemployment levels in Lusaka are very high? The best the Lusaka City Council should have done is to engage those mobile money service providers. And that permit [which] they are talking about is K100. That is not fair and those are the people who voted for us in Lusaka District. When we are ushered in as chairman of Lusaka, we are going to look into that. We are going to harmonize, including the street vendors. We have to bring them on the table so that they also provide what they have on the table [and] we will also provide what we have on the table [so that] at the end of the day,

we agree," Kamba said. He said he would not allow street vendors to be turned into enemies of government resulting from mistreating them and confiscating their goods. "What I don't want is to be treating the traders and the street vendors as enemies of this government. I am not going to allow that because those are the people who voted for Edgar Chagwa Lungu, and this party belongs to the poor. When we talk about the poor people, those are the people who are selling groundnuts, the women who are selling Chikanda. Honestly, somebody has got a capital of K50, he buys Chikanda and starts going in the streets [selling and] when you find that person, and you arrest her and take him to the fast-track court and charge him K1,000 failure to that you jail him for two months? How many people are going to be jailed? So, that policy which the Lusaka City Council has come about with is not going well with me because I strongly feel that those are the poor Zambians who voted for the party, who voted for this government and we need to engage them," Kamba added. Kamba also said that street vendors are running to trade along public roads because they know that the roads are public properties. "Have you seen any street vendors at Levy Park? The answer is no.



Have you seen any street vendor at Manda Hill Shopping Mall? Have you seen any street vendor at Arcades or East Park Mall? The answer is no. They are going through Lumumba Road; they are going through Cairo Road; they are going through Cha Cha Cha Road because they know that those roads belong to the Zambian government, they are not [on] private properties. So, hence we need to engage them because the tendency of the Zambian people [is that] we have been brought up as people who easily buy from the vendors. Someone cannot drive just Cabinet office all the way to Soweto Market just to go and buy tomato for K10. There are others who are providing tomatoes on the doorstep," Kamba narrated.

"What we need to do is to bring them on board, if we need to license them we start licensing them, if we can give them a few days per week so that they can also earn something out of street vending, and if we can give them days to clean the street, those are the issues we need to put on the table, and they also have got a lot of issues to put on the table. Taking people to court over their K50 worth merchandize will de-campaign the party. Yes, the city should be clean and this is why we need to bring them on the table and look at them as people who voted us into office." And asked how he survived the pressure from those against his adoption, Kamba said it was important to air such

grievances using the right

communication channel.

"Don't mix structures and bloggers. We have got our colleagues who are on the social media 24/7 and we've got our party officials. Most of those people in the blogs, some of them don't have party positions. And we are not saying that we don't need our friends on social media. But what is important for those colleagues is to follow the right channel of the party if they have any grievances," said Kamba. "If Kennedy Kamba has erred, I am human, I can error; I am not God, [but] there are channels, which they should follow if they want to air their

grievances against me who has erred. They have to see the Secretary General of the party; they have to go through the National Youth Chairperson of the party; they have to see the National Women Chairperson of the party unlike washing dirty linen in the media; that is not going to unite us, and that is what the opposition is looking at. They really want this party to be divided so that it becomes easier for them to mobilize the party in Lusaka, which I am not going to allow when I am ushered into office. I am going to make sure that I unite the party in Lusaka."

Army worms attack C/Belt fields

The notorious army worms have invaded six districts on the Copperbelt, posing a serious challenge to farmers. Copperbelt Provincial Agriculture Coordinator Obvious Kabinda has, however, stated that measures are being put in place to address the spread of the pests. He stated that out of the 10 districts on the Copperbelt, six had confirmed cases of army worms. "As Copperbelt, we have recorded six districts with army worms. The six are Ndola with 9 camps affected, Kalulushi with 7, Chililabombwe with 3, Masaiti 1, Kitwe 8 and Chingola with 11 camps affected," Dr Kabinda disclosed. disclosed that Copperbelt had He 156 camps of which 39 had been affected. "What has happened is that early November, we trained some staff to help identify the army worms. So we are getting weekly reports. As government, we have started the procurement process to have the chemicals to fight the army worms, and by next week, we will receive the chemicals. We will start with the most areas at risk," said Kabinda. Last farming seasons, army worms destroyed thousands of hectares of maize.

In an interview, Dr welcomed Malembeka government's intention to decongest correctional facilities by creating more bed spaces and introducing community sentences for selected offences, but said government still needed to do more to reduce the backlog of cases. "PRISCCA participated in that policy review or should I say the newly Zambia introduced Correctional Service sentencing community guidelines which was the Zambia led by Development Law Commission. PRISCCA was invited to sit in that committee as one of the technical members. So I want to agree with the minister [of Justice] and what he's saying is commendable. But what

to go and finish the remaining part of it in their community and that is what the minister was alluding to," Dr Malembeka explained. "So we are very happy with that ourselves, that's why we participated because that will work very well with the non custodial options iudiciarv conducts judiciary because will continue giving suspended sentences, community sentences and fines. Now that is the way to go because the use of non custodial options in Zambia has been too low, very very low. So what we need is to improve to make the use of non custodial options in Zambia more effective. If you look at the larger portion of the cases that those incarcerated people are

facing, they are all minor, petty offences. So such people should actually institutionalized, be meaning, let them go back in the community and then they will be supervised by officers." Dr Malembeka asked government find to resources and recruit more state lawyers, saying they were a lot cheaper and could be found in districts where other legal practitioners had no presence. "On creating and introducing new space, we don't doubt this government. They've already proved because they've finished four new correctional facilities and they have done a lot more for example in commuting the death penalty and also pardoning thousands, that we don't doubt. So

it's a welcome move. But that weight needs complimentary effort. We need the judiciary and the Ministry of Justice to compliment also what minister (Stephen Kampyongo) was saying. What we need is not only to create space and put up all these places, the idea is good and we support that but what we want is to reduce the backlog of cases. So we want government to find resources and recruit more government lawyers because they are cheaper and they are found in districts where LAZ lawyers are not found," said Dr Malembeka. "The other thing we want to see is actually LAZ itself. LAZ should find mechanisms and ways of motivating its members... private law firms must make the pro bono, free legal representation effective in Zambia. Legal representation in Zambia is very expensive. If I am to give you approximate statistics, Zambia still has about 3,500 to 4,000 people awaiting trial. These are remandees, they are innocent until proven guilty. We don't need that. We need to reduce that backlog to about 1,000. then we will be talking about decongesting. We need to keep convicts in our correctional facilities and very few remandees, like they have done in Malawi. That is what is required. If we approach this congestion issue from two perceptions, the one that the Minister spoke and the one that I am telling, reducing the backlog, then we shall be winning the wars."

She additionally said that government needs ensure all school to requirements are met enhance learning. to "The reduction is alarming and should be a wake up call for the government improve to learning infrastructure. There is need to ensure that schools have conducive rooms and up to standard learning materials. Pupils also need to get into a habit of seriously researching, studying and revising as much as possible, otherwise their performance Will not improve," she observed. Williey also cautioned pupils to desist from social media abuse and focus on their studies instead. "Pupils need to value education and reduce the time spent on social media and other forms of entertainment, it's important that they give education its own share of time. Zambia's attainment of universal primary and secondary education depends on our ability to educate our young ones. We also need to keep our teaching staff motivated unlike the current scenario where teachers remain unmotivated," stated Williey. Since 2011 when the Patriot Front formed government, there has been a decline in the budgetary allocation to the education sector. Resources allocated to the education sector rose from 17.5 per cent of the total budget to 20.2 per cent between 2012 and 2015, but this has since dropped from 17.2 per cent to 15.3 per cent of the total budget between 2016 and 2019.

Kwacha set to depreciate further - financial analyst

By Milimo Namangala Financial market analyst Hamaundu Mambo says the kwacha is likely to depreciate further following the slowdown China's economy in that will demand less of Zambia's copper exports. And Hamaundu says sustained pressure from Zambia's mounting debts public will contribute to the kwacha's depreciation as 2019 ends. China's slowed economic growth comes in part from tariff sanctions imposed by the US government under President Donald Trump's administration. China, being one of Zambia's five major export destinations, is reducing on its imports in an effort to stabilize its economy. When asked if the kwacha would be affected by China's sluggish economy, Hamaundu said the kwacha's performance will inevitably be negatively impacted, triggered by China's reduced copper demand. "The Chinese slowdown in the economy can only affect the Zambian economy to the extent that their slowdown also slows down the procurement of copper. I think what is truly the link, China is one of the biggest consumers or buyers of copper on the stock market, they, therefore, have an effect on the demand for cooper and they drive the price upwards," Hamaundu told News Diggers! in an interview in Lusaka. "Now, if a slowdown means that they'll no longer be [in] a position to procure or to buy cooper, then definitely, it affects us as a country from an export perspective because a significant portion of our exports is made up of copper and, therefore, if

our biggest consumer or buyer is out of the market, then it will definitely affect us. And, of course, an argument can be put to say that, when you check on the figures in terms of who buys, you'd find that their other countries buy, but the ultimate destination is China." And he also argued that the kwacha's performance, though unpredictable, would equally come under pressure by the country's mounting public debt. "It is difficult to just put a figure and say this is how high it will go, but I think that the general direction might be that of depreciation. I say so because the kwacha will be receiving a lot of pressure from the issues related to debt," observed Hamaundu. "Our country is highly indebted and we need quite a lot of money to service our debt, so that aspect of servicing our debt on its own constitutes a significant demand of foreign exchange whereas the supply side is not really increasing or there are no new suppliers who are coming on [to the foreign exchange market]. So, because of that, the direction is expected to be that of depreciation of the kwacha as opposed appreciation. But to with our debt structure, chances are we'll have a weaker currency at the end of the year." The kwacha depreciated to breach the K12 psychological barrier per dollar twice last year, while Zambia's external public debt maintained an upward trajectory to hit US \$9.51 billion by September 30 last year from US \$8.7 billion by the end of December, 2017.

"When you compare with the person that is in office today, above the threshold of 50 per cent plus one, the gentleman in State House is sitting in that

office on account of 13,022 votes. And when you just look at now, who constitutes the 100 per cent of the votes in this country? UPND and PF share 98 per cent plus of the total national vote. The rest of the parties that are participating are sharing less than two per cent." He argued that not being in office did not mean that the UPND did not win elections. "I don't think we can even take time to illustrate that UPND has grown, UPND is resilient, UPND is now institutionalised. And that's what you need in the organisation of a political party. It doesn't appear during elections only and then disappear after that; I am talking about general elections, I think it's important for us to understand the strength and the future of our democracy. So, UPND has contributed substantively on democracy. The fact that we are not in office does not mean that we do not win an election, and I think that goes without say," he said. And Hichilema said he is now ready to govern this country because he has gained a lot of experience. "The party is now ready to govern this country. We have gathered a lot of experience, I know the things that work. And I want to give credit to the founding father of this party. He did a lot of work. He is a soldier who died on duty, but he died at the front of the party to grow democracy. And we carry on that torch, the seed [which] he planted has not only germinated, but has grown deep roots. said the President had not powers to stop mining firms from retrenching workers. "I noticed three days ago, I saw on TV the Association of Zambian Women Gemstone miners, they were at State House greeting the President. I was very interested in that clip and the conversation between the President and the women. And I listened to them very carefully. One, they said 'can you help us with listing arrangement where we can list equipment to maximize our production, two, they were crying for finance capital to capitalize their small scale companies. I was interested in the response from the President which was very vague. Instead of just saying we don't have the capacity and we don't have those institutions in place, he was promising them something. There is no Zambian owned bank that can extend finance capital to those women. The President has no authority to order any of the existing banks today to give those women money, he doesn't have that power just like he has no power to order any mining company not to retrench," Kabimba said.

"He has made those pronouncements before but retrenchments have gone on. Even today, KCM is retrenching some of its workers from its underground pit. Barely a week before, the President had said 'we are not going to accept any retrenchment but the miners ignored him, showing him that he has no power." And Kabimba mocked Chishimba Kambwili saying, evil had paid him after being expelled from PF because he celebrated the misfortunes of others who were forced out of the ruling party.

"Let me get to this statement that 'people celebrated when you were fired' I have heard this story before. Ba Kafula (caller) I can tell you my brother who was paying those people that were celebrating. I can tell you the people who were in PF, they are no longer in PF today, they are crying because Edgar has thrown them out and I can tell you how they were spending money to pay the people who were celebrating. Everybody knows this even in PF. I have met people that have confessed that 'X and Y paid me to demonstrate'. Comrade Chikwelete is seated with me, he can tell you who was giving him money to manufacture those coffins, he can tell you. He can tell you the events that took place," he said. Surely if that is what you want, you can ask the Ministry of Finance to give a ministerial statement in parliament because privatization was undertaken and superintended upon by the Ministry of Finance. So they have all the records. ZPA was under the ministry of Finance," he said. Meanwhile Kabimba said he had not joined the opposition alliance because he had not been invited. "At the consummation of this alliance, we were not invited. The first time when I came to learn about the alliance was when we were being asked to sign a notification to the police for a peaceful demonstration on the increment for salaries for ministers. So we have not understood clearly the agenda for this alliance. And [those saying that] 'we didn't ask you to join the alliance because you are defending PF' we don't want to join the alliance. You can keep the alliance and God bless the alliance. We are not defending the PF [and] we have never defended the PF at any time, we stand by the truth. You want to glorify leaders who stand by telling lies [and] I don't want that," said Kabimba.

ZABS halts 'sexual booster' drink consumption

The Zambia Bureau of Standards (ZABS) has warned the public not to consume the Natural Power "SX Energy" Drink until results of the ongoing investigations are out later this week. In an interview, Tuesday, ZABS Marketing and Public Relations officer Nzali Chella confirmed that the institution was carrying out investigations into the high energy drink, which is believed to contain substances that treat erectile dysfunctional men, and that the outcome would soon be made public. "Yes, we are carrying out investigations on the allegations, and because of that I cannot give you any information until we jointly make a statement again to read

out the results of the tests," Chella said. In a joint statement released, Monday, the Zambia Medicines Regulatory Authority (ZAMRA), the Ndola City Council and ZABS informed the general public that investigations have been instituted on the natural power high energy drink, which is alleged to contain sildenafil citrate following social media reports emanating from Uganda that the energy drink Natural Power SX may contain this substance, which is used for the treatment of erectile dysfunction in men. "We wish to inform the public that the three institutions are working together to ascertain the claims made about the product. Officers from the three institutions are on the ground to collect samples of the

raw materials and of the finished product for analytical tests that will determine if there is any truth to the claims being made. The outcome of this investigation will be communicated to the public as soon as results are released," the statement read. In view of the foregoing, the three institutions have urged the public to immediately desist from consuming the drink until conclusive results are released that either confirm or dismiss the all egations. "The manufacturers of the product, Revin Zambia Limited based in Ndola, have been ordered to halt the production and distribution of the energy drink until all investigations have been concluded and appropriate action taken," read the statement

AGRICULTURAL SECTOR PLANS AND REFORMS

There have been no significant developments in Zambia s agricultural policy since the 1970 s. It is therefore very important to redefine the agriculture by way of tailoring the education system to teach and lecture conservation farming techniques coupled with good farming methods and deployment of technology, whilst encouraging diversification and increase in both agriculture production and allocation of resources towards the sector. When we take a look at the distribution of the agricultural budget in the recent past; it is noticeable that little emphasis has been placed on broad-based public investments. The emphasis on agricultural subsidy packages alone has also proved to be less effective in fostering agricultural growth. NDC cannot overlook the reality that investments in research extension, roads and strategic public infrastructure, is vital in supporting a robust agriculture system.

Additionally, heavy spending on FISP and FRA only has left few resources to invest in other recognized drivers of agricultural growth and stifled diversification as the country policies are maize-centric which is a low value crop. another hindrance is the continuous late budget releases to the Ministry of Agriculture, fisheries and Livestock. Late budget releases to support extension officers and field operational funds affect operations and execution of other agricultural programs hence affecting service delivery.

Therefore, in order to counterbalance the challenges and bottle necks in the agricultural sector, The NDC will do the following:

We will balance government funding to support other key drivers of agricultural growth which are essential.

We will increase spending in public infrastructure which will incorporate the following issues: irrigation development as a way to lessen drought and improve productivity; crop, soil, and livestock scientific research and development and deploy the use of latest technologies in this area; we will also focus on extension and educational programs for effective and efficient utilization of inputs, We will also ensure continuous infrastructure development and improve timing for budget releases. As NDC we will develop an effective monitoring tools intended to increase budgeting transparency and accountability in the sector. cooperatives are formed and will accesses loans from the agricultural and development bank in the conversion of agricultural produce to finished products.

diversify our agriculture sector,

Sustainable diversified agricultural sector that supports the significant reduction of poverty entails a significant investment in other sectors such as horticulture, livestock and fisheries, and treat it as core equals to other sectors of development.

NDC will revamp agriculture cooperatives and diversify them for bulk input supply and marketing services for the production of specific commodities other than Maize, rice and soya.

We shall facilitate the development of agro processing industries in all the districts for purposes of value addition and job creation, especially for the youth and women.

Every district will have an industry tailored to that districts agricultural produce and comparative advantage

We will anchor our agricultural sector on the the principal of comparative advantage. We will ensure that each district in Zambia only focus on a crop that it is best suited to be grown in that area.

HORTICULTURE PRODUCTION

An increase in urban populations and a varying of consumption trends has generated key opportunities and prospects for local farmers by a rise in domestic and regional demand for horticultural crops; fruits and vegetables. Horticulture provides a substantial value addition in terms of slicing, packaging, canning, and dicing, and production of juice, sauces, preservatives. The processing of horticulture products creates significant jobs in both urban and rural areas. This sector has been deserted by government due to the tendency of prioritizing the maize sector which has very low potential in reducing rural poverty and urban unemployment. Since the involvement of commercial banks in the small and medium scale agricultural sector remains negligible; NDC government will introduce a bank called AGRICULTURAL INDUSTRIAL BANK" in collaboration with the private sector that will give loans to businesses ventures that have cooperated to convert agricultural produce to finished products hence creating linkages between agricultural sector and industrial sector.

We will ensure that youth and women

We will make a deliberate effort to support smallholder horticultural production by allocating public funding towards infrastructure and entrepreneur activities that will support slicing, packaging, canning, and dicing, and production of juice, sauces, preservatives.

Foster private-public partnerships with tax incentives in the area of processing horticulture products to finished produce.

We will also support horticulture research and technologies to advance suitable horticultural production

We will also investment in horticulture trading markets locally and abroad and use Zambian missions abroad. regulations.

To undo these challenges and enable a thriving fishing industry; NDC will implement the following; we will reorganize the fisheries department into Capture Fisheries and Aquaculture and ensure that each is funded separately and adequately.

we will introduce an Aquaculture and Fisheries Fund for fish production for small and medium scale sector, especially for youth and women. This will multiply fish production from aquaculture ; especially by small and medium business hence creating employment and reducing poverty amongst the youth and women

We will also enforce fishing regulations that avoid depletion of fish stocks in water bodies but the same time promote other fish producing activities that boost reproduction of fish stocks.

These proposed measures will ensure a thriving agricultural sector.

Sata was but basic in all spheres. President Sata inspired and gave hope to the poor and those in need of a better tomorrow. Yes, indeed, Michael was not a saint, like myself, Sata was a perpetual sinner," Changala recalled.

He argued that the PF shouldn't have continued in power after Sata's demise because it has now clearly proven to be a curse on Zambians.

"With hindsight, I strongly believe that, PF as a political party should not have continued in power after the death of its founder leader, president Sata. There are many reasons one can fairly advance on the PF's unfitness to hold on to State power. The pro-poor PF vision of president Sata died the day he died. Right or wrong on my part, PF as a governing party and its leadership are but a curse to Zambia and

our collective aspirations in pursuit of human rights, rule of law, equal and fair opportunities," he stated. Changala noted that making money was President Lungu's number one political agenda.

"Education standards and health institutions have fallen apart. Clinics and hospitals have no drugs and clinical equipment. The new PF of President Edgar Chagwa Lungu is a direct opposite of president Sata's PF. President Lungu's PF is of 'Hollywood stars.' Making-money and dancing 'dununa reverse' is their number one political agenda. Service to humanity is last," he added.

"The new PF of President

Lungu has impoverished our countrymen and women through high unemployment, taxes, dictatorship and has empowered the Chinese in all sectors of our lives. Yes! PF of President Lungu is a curse now. No one talks now in Zambia; Chinese money talks for us through PF. What can we do? Police officers are sleeping in Chinese houses dreaming about and China. ZAF officers and army officers are sleeping in Chinese houses and dreaming about China. Our entire Cabinet sleeps in China half of the year. God, please, help us." Meanwhile, Changala

pointed out some reforms which needed to be conducted in Zambia. "My personal demands from Zambians are that: Appointments to the High Court and Supreme Court Bench must be truly transparent and on merit; we need 90 days of LAZ and public scrutiny; the Judiciary should be adequately and independently funded; Human Rights the Commission must have powers to release those incarcerated for exercising their fundamental; Public Protector must be adequately funded independent of the executive of government; arm Drug Enforcement Commissioner must be a constitutional Officer with security of tenure, so that he/she can investigate without fear or favour and should not serve on contract," stated Changala. "Anti-Corruption

Commission Director General and directors must be constitutional officers if they have to corruption investigate without fear or favour and must appointed on merit. A President or the Vice President violating the Law or the Constitution must be impeached. A President or Vice President who has no regard for a court order must be impeached. Public media must be accessed by both side of the political divide as they don't belong to the ruling party, but to the tax payer."

NAREP asks Zambians to pray for Lungu's quick recovery

By Stuart Lisulo NAREP have asked President Edgar Lungu to urgently improve healthcare facilities in Zambia to ensure tax payers' money is not wasted on his routine medical check-ups.

And NAREP has asked Zambians to pray for the Head of State's health to improve.

Meanwhile, the opposition political party has commended State House for being transparent on the President's whereabouts, but have argued that transparency should remain the standard when dealing with his affairs. Commenting on the sudden evacuation of President Lungu to South Africa on Tuesday afternoon, NAREP secretary-general Ezra Ngulube asked the Head of State to urgently improve healthcare facilities in Zambia to ensure tax payers' money is not wasted on his "routine" medical health check-ups.

"It is really important; as Head of State; he should actually lay a foundation so that we can go back to our drawing board where we used to see in the First Republic, our first Republican president Dr Kenneth Kaunda used to frequent UTH (University Teaching Hospital) for his medical check-ups. So, as NAREP, it is our praver that, under the Edgar Lungu leadership, we want to see that there is improved health facilities in Zambia so that, as a country, we could stop spending colossal sums of money having to see our leaders going to a neighbouring country," Ngulube told News Diggers! in an interview, Wednesday. "If that trend continues, I can assure that, the people in leadership won't pay much attention to improve medical facilities within Zambia because for them, whenever they fall sick, they will go and seek medical treatment in the neighbouring country. They believe that accessing UTH is suicidal! So, it is important we make UTH habitable for all classes of society, including the President."

Ngulube challenged the Head of State to prove that he had confidence in Zambia's health policies by accessing medical facilities. "I would love to see President Lungu go to UTH. And I want to make an appeal to President Lungu; we would like to see him have confidence in his health policies to make sure that...let him spearhead to go into UTH; let the Ministers go to UTH for routine check-ups! It is actually an insult to Zambians to see the Head of State whenever he suffers anything...or whenever he wants to go for a medical check-up, he has to go and fly to South Africa! Even sneezing, he has to go to South Africa to be attended to, whilst you and I, who are paying for the Head of State to go to South Africa, we are going to UTH only to be given a prescription. It is very unfair!" he argued.

"As important as it is for the Head of State to be in good health, it is important that each and every Zambian is good health."

And Ngulube asked Zambians to pray for the Head of State's health to improve.

"The Bible declares that we should pray for our leaders so that God can give them good health. It is important that we pray that our Head of State is in good health so that we can maintain stability," Ngulube said. While commending State House for the announcement, he argued that being transparent relating to President Lungu's foreign travels was in order. "Citizens have a right to be told this is the reason why the President has left the country and this is what he has gone to do. When information is made available to citizens. State House is not doing us a favour; it is actually their responsibility," said Ngulube.

Sewerage overflow caused water

Colliannianon, says in viagoo

The National Water Supply and Sanitation Council (NWASCO says water contamination in some parts of Lusaka is suspected to have been caused by Sewerage overflow that was reported from a housing block in close proximity to the NAPSA Housing Complex. And NWASCO has ordered LWSC to exempt affected households from paying water bills for the month of January.

At a press briefing, Wednesday, NWASCO assistant director engineering Peter Mutale confirmed that preliminary findings from the ongoing investigations show that, microbial contamination was recorded in two boreholes in the periphery of the NAPSA Housing Complex.

"Contamination is suspected to have been

caused by Sewerage overflow that was reported from a housing block in the close proximity to the boreholes and also the storm water from the complex which is discharged near the borehole site," Mutale said, adding that sewerage overflow was believed to have occurred between December 29 and 31, 2018. Mutale also confirmed that sporadic cases of sewerage overflows were reported in Nyumba Yanga in the period preceding the start of the New Year that potentially propelled water contamination.

And Mutale directed LWSC to take stock of all households affected by water contamination In Nyumba Yanga, NAPSA Complex, Matala and parts of Ibex Hill and exempt them from paying bills for the month of January, 2019. He also directed LWSC to flush two boreholes and system where contamination occurred until the source and network was safe. "Super Chlorination should continue as earlier directed until NWASCO is certain that the situation is under control," he said. Mutale further directed LWSC to attend to all sewer blockages immediately when they occur and not within 24 hours as stipulated in the Service Level Guarantees.

He has assured the general public that NWASCO would continue monitoring the situation until the issue was satisfactorily resolved.

Mutale has also warned the public to take precaution and ensure water for household use is disinfected or boiled, further advising the public to observe good personal hygiene as well as good environmental practices. We have read with keen interest the rules of the January 18 National Dialogue which at all political parties have been invited to participate. We are told that organisers have given each registered political party three slots of representatives to attend. This is a very simple straightforward and coordination directive, but those with degrees manufacturing in confusion have already jumped on board to bring trouble.

For some strange ruling the reason, Patriotic Front is clinging on to an agenda that National Democratic Congress (NDC) leader Chishimba Kambwili must not be allowed to attend this event. Their argument is that the scheduled national dialogue gathering will strictly be for political party presidents and their respective secretary generals.

Ex-Mozambique finance minister and **17 others face charges** over \$2bn loan fraud

At least 18 people, including a former finance minister, have been charged for fraud involving \$2bn in loans to state-owned companies in Mozambique, the Attorney General's Office (AGO) has said, in a scandal that has ensnared two major international banks.

"Mozambique AGO is indicting 18 defendants, (ranging) from public workers and other citizens, on charges of abuse of power, abuse of trust, swindling and money laundering," it said in a statement on Monday.

The indictment came days after three ex-Credit Suisse bankers were charged in the United States with fraud over their role in Mozambique's deal in 2013 to borrow money from international investors to fund projects that included a state tuna fishery.

Former Mozambique Finance Minister Manuel Chang, 63, is one of the 18 indictees. He was arrested in neighbouring South Africa last week as part of the same case. He has denied wrongdoing.

The attorney general's office also said it would seek to have those charged in the US and elsewhere face charges in Mozambique, one of the most indebted countries in the world.

Apart from Credit Suisse, Russian lender VTB also arranged financing for Mozambique's state-owned companies.

The southern African state admitted in 2016 to undisclosed lending, prompting the International Monetary Fund and foreign donors to cut off support, triggering a currency collapse and a default on Mozambique's sovereign debt. It is still struggling to overcome the resultant debt crisis. AL JAZEERA



As protests across Sudan approach their third week, President Omar al-Bashir remains defiant amid fears of further unrest and violence in the country.

Protests, which initially appeared to be tied to an increase in the price of bread and other economic hardships, quickly morphed into growing anti-government rallies demanding Bashir's resignation.

Bashir, who has been at the helm since 1989, has refused to step down, while security forces continue to crack down on activists and protesters. AL JAZEERA

52 'Major' irregularities observed in **DR Congo vote count says SYMOCEL**

An observer mission to of Congo's presidential the Democratic Republic | election said it had |

witnessed 52 "major" irregularities in the 101 vote-counting centres it observed, including people tampering with results.

There are 179 counting centres currently tallying the vote across the DRC. The report released on Tuesday by Congobased SYMOCEL said 16 percent of vote counting centres it had observed relied on tallies transmitted by voting machines instead of hand-counted tallies as required by law.

It also said 92 percent of the vote-counting centres it had observed did not post vote tally sheets outside as required by law Meanwhile, an opposition party said its leader was the "presumed winner" of the December

30 poll adding that Felix

could be delaying the announcement of the December 30 election results in a bid to manipulate the outcome. The electoral commission on Sunday delayed it indefinitely.

A spokesman for the ruling coalition rejected the accusation, asking "Why would we have to steal?".

Meanwhile, the Zambian presidency said in a statement on Tuesday President Edgar Lungu is travelling to South Africa on Tuesday for an "urgent consultative meeting" with President Cyril Ramaphosa about DR Congo's presidential election.

South Africa blame 'politics' for humiliating loss to Egypt

As South Africa reeled Wednesday after a humiliating defeat by Egypt in a contest to decide the new 2019 Africa Cup of Nations hosts, the blame game began.

South African football officials said the 16-1 vote in favour of Egypt in Senegal Tuesday was "political" without offering insight. Confederation of African Football (CAF) president Ahmad Ahmad said Egypt politicians were more enthusiastic than their South African counterparts about the June 15-July 13 event.

A CAF insider told AFP that South Africa have not been forgiven for backing the winning Canada/ Mexico/United States 2026 World Cup bid instead of sole rivals Morocco.

Acting South African Football Association chief executive Russell Paul said: "Technically, there is no country in Africa better suited to host the Cup of Nations than South Africa. "We do not have a fight with Egypt, we have a fight with the way the process unfolded," he added, referring to the vote being brought forward 24 hours without an explanation.

"A delegation had been prepared for a Wednesday presentation only to find that the Egyptians had been there for a while, with government representatives, ready to present their case."

Speaking in Dakar, Ahmad said the two candidates had equally good infrastructure and the greater political enthusiasm of Egypt was the key factor.

"Our audit firm said the infrastructure was equal so we assessed the political commitment in the two out on top. "Members of the (CAF) executive committee did not feel any real support from the South African government to carry the project forward."

- Security concerns -Malagasy Ahmed acknowledged that there were security concerns regarding Egypt, with three Vietnamese tourists killed in a recent terror attack there.

"Before the 2018 World Cup, people were worried about the security situation in Russia, but they worked hard and there were no incidents," he said.

South Africa have had cool political relations with Morocco because the republic backs the Sahrawi Arab Democratic Republic, who are contesting land occupied by the Moroccans. government On instructions. South Arica backed the American/ Canadian/Mexican 2026 bid, which comfortably outvoted the Moroccans. This decision reportedly infuriated Ahmad, leading to South African media speculation that he encouraged CAF executives to support Egypt.

"South Africa voting for the USA, especially after president Donald Trump had publicly criticised the people of the continent, was seen as anti-African," the CAF insider said.

"The feeling ahead of the vote in Senegal was that Egypt were favourites, but no one expected such a landslide victory."

The contest between Egypt and South Africa was necessitated after CAF dropped original hosts Cameroon last November because of delays in preparations and security

Under an Ahmad plan still to be finalised, Cameroon will now host the 2021 Cup of Nations with the Ivory Coast (2023) and Guinea (2025) staging the following two editions. From this year, the

tournament moves from January/February to June/ July to avoid club-versuscountry dilemmas for Africans based in Europe, and the number of qualifiers has been expanded from 16 to 24. *AFP*

Tottenham know what I want - Eriksen



Christian Eriksen offered a cryptic answer in response to the latest questions surrounding his contract situation at Tottenham, amid talk of interest from Real Madrid.

Reports have claimed that Madrid have been advised they will need to pay a mega £225 million (287m) fee if they are to land the Dane from Spurs.

The 26-year-old is under contract at the north London club until 2020, with Spurs keen to tie him to a new deal to follow the likes of Harry Kane and Dele Alli in committing his future to the Premier League side.

Madrid have been mooted as a potentially interested party, though, with Eriksen telling TV3 Sport that Spurs "know what I want" in relation to the talks over a new deal.

He said: "[The future is] not something I'm thinking of. I focus on playing football, and there are many battles you have to think about which must be won."

Responding specifically to Madrid's apparent interest, he added: "It is not the first time that there have been rumours, and when the newspapers write something, it is not something we are masters of. If there is nothing concrete,



Iniesta apologises over blackface photo

Barcelona legend Andres Iniesta has apologised after posting a photo on social media with two people in blackface as part of Epiphany celebrations.

The 34-year-old superstar who currently plays at Japan's Vissel Kobe had no intention "to upset anyone by displaying that photo," according to a statement by his agency sent to AFP on Wednesday. "He would like to apologise to those people who may have felt offended," the statement said.

Iniesta's picture on Twitter and Instagram posted on Sunday showed his family and a group of people in costumes, taking part in the Three Kings Day celebration also known as Epiphany, which is widely celebrated in Spain.

The midfielder, who lifted 32 major trophies and made 674 appearances for Catalan giants Barca, joined Vissel Kobe in May, calling his J-League move an "important career challenge". The Spain icon's decision to choose

The Spain icon's decision to choose Vissel arguably represents Japanese football's biggest transfer coup, with many top players now moving to cashrich Chinese clubs in the twilight of their careers.

It also came as a timely boost to

the J-League, which used to attract luminaries such as Brazilian great Zico and former England star Gary Lineker when it began in 1993, but has struggled to attract marquee players in recent years.

Iniesta -- who famously scored Spain's winning goal against the Netherlands in the 2010 World Cup final -- had been top of the wishlist of Vissel owner Hiroshi Mikitani.

The billionaire businessman is also the founder and CEO of Rakuten, Barcelona's main sponsor, and was heavily involved in the deal that brought Iniesta to Japan. *AFP* then I just comment on rumours.
