FALSE AND MISLEADING ARTICLE ON ABDUCTION OF RUSSIAN

Gemcanton wishes to categorically refute allegations made in an article published in the **Daily Nation**'s publication titled Russian abduction, dated Monday, January 14, 2019, that Gemcanton abducted and deported one of its employees, Mr Sergey Kuznetsov.

We wish to put the record straight that Gemcanton reserves the right to employ and terminate the contract of any employee who goes into conflict with the laid down Company regulations and Mr Kuznetsov is no exception in this regard.

Gemcanton followed the normal procedure of termination of contract for Mr Kuznetsov and as an expartriate his work permit was withdrawn as per laid down company procedure. All Company properties under his custody were all withdrawn and this includes the much highlighted laptop.

Contrary to assertions that he was abducted and then subsequently deported we would like to state that, following his conditions of service he was provided with a plane ticket, back to his home country Russia after termination of contract. It is false and misleading to report that Mr Kuznetsov was abducted and deported because his services were terminated on 7th January 2019 and only left the country on the 11th January 2019.

The following was the main reason that led to the termination of Mr Kuznetsov's employment contract: Mr Kuznetsov failed to account for the loss of 4,869 grammes of gemstones valued at \$ 317,095.36 during the gemstone auction sale held at intercontinental on 15th December 2018 which was under his charge. Earlier in August 2018, Mr Kuznetsov under-priced a certain parcel that was sent to a customer known to him and the company lost \$13,485. Insurers' claim pay-outs dropped to K116m in 2018 says PIA

The Pensions and Insurance Authority (PIA) says there was a decline in the total amount paid by general insurers in claims and benefits to K116 million by end of the third quarter of 2018, down from K131 million in the prior corresponding period. In a statement, PIA communications manager Doreen Silungwe stated that general insurers paid a total of K116 million in claims and benefits by September 30, 2018, compared to K131 million paid out in 2017 during the same period. She, however, added that the industry continued to register steady growth with a total of 342 players licensed by the Authority by September 30 last year. "On the insurance side, the industry also continued to register a steady growth. The industry had a total of 342 players licensed by the Authority as at September 30, 2018. The Gross Written Premium (GWP) for the industry as at September 30, 2018 was K739.36 million compared to K696.09 million recorded in 2017 during the same period," Silungwe added. "For 2019 outlook, the Authority is optimistic that the industry will continue to register steady growth. However, the Authority is concerned with the continued complaints arising in the insurance industry relating to claims management." And in terms of long-term insurance market share, Sanlam had the largest share in terms of GWP with 24 per cent, followed by ZSIC Life with 16 per cent, SES with 15 per cent, Madison Life and Prudential Life with 14 per cent each, with Liberty Life and Barclays Life sharing 6 per cent each, according to PIA data. As at September 30, 2018, pensions net assets stood at K7.02 billion compared to K6.43 billion of the same period in 2017, according to the statement.

pre-instructed in the morning. However, Haimbe said the defence's application for an adjournment was shocking because the accused was given a benefit of doubt at last week's hearing. He objected to the application, observing that Tayali quite evidently did not follow the directives of the court and only engaged a lawyer in the morning. In reply, the defence lawyers said they were on industrial break and only received full instructions that day, adding that they needed more time to be familiar with the case. Although Magistrate Munyinya noted in her ruling that Tayali was given enough time to engage a counsel, she again granted the application for an adjournment. At this point, Haimbe informed the court that he had been advised by the complainant, Sichali, that Tayali had taken to social media once again and was running commentaries on the matter in court as well as other matters. He warned Tayali to desist from running commentaries or they would be forced to ask the court to order Tayali to show cause why he should not be held to account for such commentaries. 'The commentaries include

allegations that various persons, magistrates and others have been paid in relation to this matter. The accused person should desist from running the commentaries or else we shall be constrained to ask the Court to order the accused person to come before court to show cause why he should not be held to account for such commentaries. We are ready to provide the necessary evidence of his behaviour to this court," Haimbe said. Magistrate Munyinya urged Tayali to do the right thing for the sake of progress. "Accused, I'm not saying you did that because I don't have evidence. For the sake of progress, let's just do the right thing. We have limited time, so I don't have time to be listening to these complaints! So, let's just do the right thing," Magistrate Munyinya said. She then adjourned the matter to February 15 for commencement of trial. But once outside Court, Tayali told off the complainant's lawyers that he had the right to speak because that was his job as a politician. "I have the right to talk. I'm doing my job as a politician!" insisted Tayali.

Talks on who will represent parties at dialogue unnecessary - Church

Zambia Conference of Catholic Bishops secretary Fr Cleophas general Lungu says talks on who can or cannot represent a political party during dialogue are unnecessary. And Fr Lungu says President Edgar Lungu has confirmed attendance to the January 18 launch of the dialogue process. In an interview, Fr Lungu highlighted the major issues which were expected to be discussed during the process, saying that was more important than questions on whether or not NDC leader Kambwili Chishimba can attend the meeting. "Since June last year, we have met different stakeholders, not just ZCID, we have been meeting event people from government and we have been receiving submissions on what will be important to discuss. We met with the leaders of the national trade unions, we met with the CSOs, we received submissions even from some individuals and the women, the youths, so we have concerns from different sectors and that is what is going to form the agenda. Generally speaking, we are talking of four categories of issues, the first and the most important, it is an overwhelming voice coming through that we need to address issues of governance and how we do our politics in terms of constitutional and electoral reforms, being civil and increasing levels of tolerance, in terms of making the institutions of governance more independent and professional in their operations. We are talking

of how to address things media like freedoms and things like that," Lungu Fr explained. second category "The is economic and social issues, there we are talking how can we bridge the gap between the rich and the poor, how can we reduce the levels of unemployment, how can we reduce poverty, how can we empower Zambians to be more innovative? How do we address the issue of the debt? Corruption? And if one denies that there are issues there, just go to TIZ who submitted to us a number of issues. How do we address the issue of misapplication of public resources as we read in the Auditor General's report year in year out?" He said tribalism was also on the agenda. "Then the third sector will be cultural issues and like we saw in 2016, issues of tribalism, issues of where I come from is important, there are insinuations that tribe and region now is becoming a big factor in terms of you accessing power, in terms of you accessing jobs, but we are saying our motto is One Zambia, One Nation, why is this becoming important now? Are we going forward or backwards? And also the role of traditional leaders, for example, they shouldn't be partisan, they should be the custodians of unity and how they administer resources like land, which controversial is very right now," he said. "Then the fourth category are religious issues. We are saying, yes, as church, we are not saying that we are angels, because there are certain members of the church, individual leaders, pastors, priests, bishops, name them who behave and conduct themselves at variance with our Christian or religious values. Sometimes the church, if it is not careful, it can lose its campus, it can lose its authority. Sometimes politicians are going to abuse the church if it is not careful and so we are saying we have issues amongst ourselves as religious leaders, is it right for a church for example to be promoting people to stop taking ARVs, to say 'just pray', you know,

"We are also quite amazed that way before time, people are already talking about who should attend and who should not attend. In our view, we have not issued any statements on who shall attend and who shall not attend... So unlike our friends, who are focussing on certain individuals, we are not targeting anyone, we are not [dictating] 'this one must attend, this one must not attend'. That is not our interest. Our interest is building an all inclusive Zambia." And Fr Lungu said President Lungu had confirmed attendance to the January 18 meeting. "I would like to believe that what led to His Excellency the President of Zambia not attend is not the church,

State discontinues juveniles' By Zondiwe Mbewe indecent dressing case The State has discontinued a matter in which a 16-yearold juvenile was in court for walking passed a police while 'skimpily station

dressed'. This was the matter in which the juvenile and her 28-yearold aunt, Mirriam Mwanza, were jointly charged with the offence of idle and disorderly persons.

It was alleged that on December 22, 2018, the juvenile in the company of her auntie, publicly conducted themselves in a manner likely to cause the breach of peace.

It was alleged that on the material day, the juvenile wore a short skirt and as she passed by Kamanga Police Station in the company of her auntie, an officer asked her why she was wearing mini skirt.

Her auntie challenged the officer for allowing another person who was dressed in a similar manner to pass through earlier, her reaction to the police's question allegedly led to the apprehension of the two. The two had pleaded not guilty.

And when the matter came up for commencement of trial before magistrate Nsunge Chanda, Monday, a State prosecutor informed the court that the State was not ready to proceed with trial because they had

received instructions from the DPP chambers to have the matter discontinued.

But before magistrate Chanda could discharge the accused, she warned them to behave themselves, saying that women were supposed to conduct themselves with respect and integrity.

She added that the two should not find themselves in prison or police again.

Lungu still under medical review, explains Mwamba

Zambia's High Commissioner to South Africa Emmanuel Mwamba says President Edgar Lungu is still under medical review in South Africa, adding that speculations of him being flown to the United States of America are false.

On Monday last week, State announced House that President Lungu was going for his scheduled annual medical review in South Africa, where he would also hold consultative talks with his counterpart Cyril Ramaphosa on the Congo election situation.

Photographs were released of the Head of State's meeting with President Ramaphosa on arrival in that country, but the Zambian Head of State has gone under radar since then, fuelling speculation over his condition and whereabouts.

When news broke that First Lady Esther Lungu was heading to the United States of America carrying a 25-member presidentiallike security delegation, some government sources said it was likely that she was eventually going to join the President who was believed to have been flown from South Africa to that country.

The speculation was further escalated on Sunday after a statement purported to have

by the Zambian press aid Amos Chanda, bearing a State House letterhead.

News Diggers! contacted Chanda to get an explanation on the President's whereabouts, but he said he did not want to preempt what he was going to discuss with the rest of the press on Sunday afternoon.

"If the President authorises, I will be speaking on that sometime this afternoon. The President feels those who want to believe anything else than the statement I issued can do, but I will be speaking about that," said Chanda.

Asked why he returned from South Africa leaving the President behind, Chanda said President Lungu asked him to come and coordinate, as well as monitor the Congo DR situation from Zambia.

News Diggers! then turned to Mwamba, the High Commissioner for Zambia based in Pretoria, to get the latest on President Lungu's situation.

Question: We have noticed that Mr Chanda has returned from South Africa leaving the President behind. Popular belief was that the Head of State was going to be in South Africa for maybe three days, since it was just a routine medical check up. So the delay is causing growing speculation on the whereabouts of the President. We thought of getting in touch with you to find out where he is.

Answer: Okay. I think we stand by the earlier statement issued by Mr Chanda that the President will have bilateral engagements in South Africa and will undertake medical review.

Question: How is his condition and has he managed to do that medical review?

Answer: Medical review is a process. He is still doing medical review. It's just ... like what Mr Chanda said; he will do his annual medicals, the scheduled annual medicals after his bilateral official

engagements in South Africa. Question: You need to understand the Zambian people's concern because Mr Chanda is not there, Presidential Affairs Minister Freedom Sikazwe is not there. even the First Lady is not there, so who is with the President? Answer: He is with the Minister of Foreign Affairs, they are working. He is with the Minister of Foreign Affairs and he is with the Zambian Ambassador here, we are working. You have seen the engagements from the statement that was issued this morning. The continued engagement is underway.

Yesterday, Foreign Affairs Minister Joe Malanji issued another statement on behalf of President Lungu, watering down the Sunday statement which called for a Government of National Unity in Congo DR, but the Zambian Head of State was still not personally involved in the SADC correspondence.

"Before I make my order, you are 27 years meaning you are old so you are supposed to help the child. Already I have been given the facts, the way vou behave is very important because you committed an offence. You have to change. You behave," she said.

"You juvenile, how long have you stayed in prison? It's not a good place. So whatever you did on that particular day, you know yourselves, you should not find yourselves in prison or police again. Women are supposed to conduct themselves with respect and integrity."

Magistrate Chanda then discharged the matter and set the accused at liberty.

Speaking after court. Mwanza, while shedding tears of joy, expressed gratitude to God with the case's outcome.

She recounted what occurred on the material day.

"On December, 22, I had gone paka Tower. My niece came to call me, saying that we should go and see the children at home. When we passed by the police station, the officers called her (the niece). She asked whether they were calling her and they accepted. That's when she entered the police premises and they told her that 'you are wearing a short dress get in the cells and remove your shoes'. That's when I entered and asked what was happening. They told me that she was wearing a short dress. I told them to check out the dress that another woman was wearing. They said I should just be quiet," she said. Mwanza charged that the officers who arrested them indecently assaulted the juvenile by touching her breasts.

She added that the officers also assaulted them.

"I was just behind the cells which were open. Nina bwela nagwela muma cells. Bana bwela bakomako no nimanga mantambo ku manja na kumendo no manga uyu (niece) manja ku mbuyo na mendo. Benangu benzo mu gwila na maziba...(I fell in cells and the officers closed the cell doors and tied my hands and legs with a rope. They equally tied my niece. Some where even touching her breast)," she narrated before the two were taken away as they are still facing another charge of malicious damage to property in

another court. Meanwhile, former NGOCC chairperson Sara Longwe, who had also gone to show solidarity to the two, said Zambians were Constitutionally protected to wear anything they please.

"There was no case to start with. Because there is no dress code in Zambia. We have freedom of expression, we are Constitutionally protected. Everybody can wear anything. Miniskirt is not indecent. If we look at our tradition, our forefathers and mothers not less than 60 years ago, where dressed less than we were. And they didn't consider themselves being naked. This is shameful for Zambia that we should always be talking about dressing. It's a pity they didn't say what exactly they did wrong, we will get to the bottom of it and it must stop. We are a free Zambia and we must enjoy our freedom," said Longwe.

Lusaka pastor in court for assault, unnatural offence

A 28-year-old pastor of Lusaka's Meanwood Phase One area has been dragged to court for assault and unlawful carnal knowledge of a woman against the order of nature.

In this matter, Francis Mukuwa is charged with unnatural offences contrary to section 155 (a) of the Penal Code Chapter

87 of the laws of Zambia.

It is alleged that between December 1, 2018, and January 2, 2019, the accused had unlawful carnal knowledge of a woman against the order of nature. And in count two, Mukuwa is charged with assault occasioning actual bodily harm contrary to section 248 of the Penal Code Chapter 87 of the laws of Zambia.

It is alleged that on January 2, 2019, Mukuwa assaulted the woman and occasioned her actual bodily harm. However, when the matter came up before Lusaka Magistrate Faides Hamaundu, Mukuwa could not take plea as he was not present in court.

Lungu u-turns on call for Govt of National Unity in Congo DR

By Mukosha Funga President Edgar Lungu, through Foreign Affairs Minister Joseph Malanji, has u-turned on his call for a government of national unity in Congo DR.

President Lungu has instead called for dialogue amongst political players which he says could result in an inclusive government.

In a statement on Sunday, Special Assistant for Press and Public Relations Amos Chanda announced that President Lungu, in his capacity as chairperson of the SADC organ on politics, Defense and Security, was calling for a government of national unity in Congo DR, saying it would create some stability.

"His Excellency Mr. Edgar _I Chagwa Lungu, President of the Republic of Zambia says given the strong objections to the provisional results of the presidential elections in the Democratic Republic of Congo (DRC), the Southern African Development Community (SADC) has called on all political leaders to consider a negotiated political settlement for an all-inclusive government. And SADC encourages all stakeholders in the DRC to pursue a negotiated political settlement for a government of national unity," Chanda stated. Chanda stated that President Lungu felt a government of national unity was the best way to go for that country.

"SADC draws the attention

of the Congolese politicians to similar arrangements that were very successful in South Africa, Zimbabwe and Kenya where governments of national unity created the necessary stability for durable peace," Chanda quoted President Lungu as saying.

"SADC therefore encourages all parties to enter into a apolitical process towards a government of national unity in order to enhance public confidence, build bridges and reinforce democratic institutions of government and electoral process for a better Congo."

Chanda stated that SADC had urged DRC authorities to swiftly resolve all elements of doubt that could undermine the fairly successive general

elections and pose a danger to the peace and stability of the country and that SADC had taken note of the strong doubts cast on the poll outcomes by the Roman Catholic Church in the DRC which deployed 40,000 monitors, the opposition 'Lamuka coalition, and the observers and therefore, feels a recount would provide the necessary re-assurance to both winners and losers.

Corruption in Zambia; Stolen Fortunes of a Wealthy Country

"When the righteous are in authority, the people rejoice: but when the wicked beareth rule, the people mourn" Proverbs 29:2 (KJV)

Hardly a day passes without headlines on corruption: overpriced fire tenders; stolen ARVs; overpriced ambulances; misappropriated social cash transfer funds...the list is endless.

The current levels of corruption are so entrenched that state institutions are on the verge of being captured in a web of deeply entrenched corruption. This calls for concerted efforts from all Zambians. Zambians from all walks of life are bemoaning the scourge and debilitating social, economic and political impact of corruption.

As UPND, we are as concerned as all patriotic Zambians about corruption in our country; we urge fellow compatriots to join forces with us to fight this abhorrent scourge that has been planted and nurtured by the PF Government.

Because of corruption, Cooperating Partners froze SCT disbursements and the Government ran out of resources to continue paying SCT beneficiaries; out of a budgetary allocation of ZMW540,885 for January to September 2018, the PF Government only released ZMW197,094 or 36% to the poor and vulnerable, but at the same time released 133% of the budget for PF Government officials to attend Public Affairs and Summit Meetings.

Corruption leads to wasteful use of public resources. Resources are not allocated to priority sectors and programmes. The Auditor General's report for 2017 revealed that Zambia lost a total of ZMW193.3 million in 2017 and ZMW538.2 million in 2016 to financial irregularities like failure to follow procurement procedures, undelivered materials, wasteful expenditure, overpayments and so on.

Examples of non-priority allocations include the unjustified increase from ZMW 3.5 billion in 2018 (4.9 % of the Budget) to ZMW 5.1 billion in 2019 (5.8 % of Budget) for the Ministry of Defence; the country has further contracted a loan from the Exim Bank of India for Lusaka roads. In the midst of the debt crisis, these are not priorities; they are just a conduit for corruption, since the commission for such projects tends to be high. state capture; the story of a foreign firm winning all ZESCO contracts either directly or indirectly, through its' agents points to this unfortunate reality. What is even more disturbing is that officers who resisted this corruption at ZESCO lost their jobs.

The ZESCO example is a microcosm of a national malaise that has beset our country since 2011. Several hundreds of morally upright Zambians who have resisted corruption have ended up being fired from their public positions and are languishing. We are worried that the most corrupt and despicable person in our society are being flaunted as epitomes of success and role models for the young. The virtues of hard work, discipline, frugality, and patience are not as appreciated as before. The widely publicized Presidential clip of ubomba mwilaba alya mwibala, has not helped matters; it is a blatant endorsement of corruption.

Dear country men and women, we must join hands and stand up and be counted in the fight against corruption. Let us join hands and empower institutions that are mandated to fight corruption. Key institutions in this crusade such as ACC, FICA, and the AG should be given enhanced powers and enough operational space to execute their functions. Mobile money companies have introduced a very interesting concept of receiving and sending money through the popular tagline of 'Zangena'. Zangena (or 'account credited' in banking terms) depicts the excitement associated with receiving money instantly from a sender.

Mobile money has significantly changed the landscape of financial transactions in the country, with hundreds of millions of Kwachas being transacted to various recipients every day. Kenya, which is among the first African countries to use mobile money platforms, once reported about the significant business transformation that took place among micro and medium enterprises that did not fall under the formal banking system.

In Zambia, traders in Nakonde can easily engage and transact with counterparts they have never seen in Kalabo for the supply of products. This medium of financial transaction has surely transformed small businesses. However, this ease of doing business has introduced another mindset that promotes a culture of receiving payment without offering a service. I want to share a few things for those businesses I consider to have the mindset of Zangena, or prioritising payment ahead of contract fulfilment.

First, genuine businesses are not focused on earning money. They are interested in providing a service or product to a willing customer. Every day, an entrepreneur works up and thinks of what to offer the market; what gap or opportunity exists that should be narrowed through the provision of a product. Like it or not, there are gaps everywhere requiring an entrepreneur to respond. If you consider the definition of an entrepreneur, you will realise that there is an initial sacrifice being made before money is counted: 'Enterprising is the willingness to forego immediate satisfaction for future gain, a degree of thrift, the desire to succeed and the capacity for hard and continuing work'.

In other words, as explained by various scholars, an entrepreneur perceives production opportunities, gains control over other factors of production, organizes production facilities, manages the continuing operation of the productive unit and restricts entrepreneurship to the industrial sector of the economy. In the Sam Chipungu edited book

'Enterprising is the willingness to forego immediate satisfaction for future gain, a degree of thrift, the desire to succeed and the capacity for hard and continuing work'.

'Guardians in their Time', Yona Saleti says, 'The Entrepreneur has the ability to assemble or reassemble a new kind of activity from what is available and has the ability to reinterpret the meaning of things and fit them together in new ways.

I have gone this length to show my readers that before

there is 'Zangena', there is a lot of hard work that is required of you. Learn to produce something first before you can think of money. Zangena businesses think that you just make a phone call, arrange some kind of deal and then run to the next payment line for your cheque. It never works that way in the real world of enterprise. There is no sweet without sweat! The second issue about Zangena businesses is that they never think of the impact of their product or service to the client. If you are the hit-and-run type of entrepreneur, who never thinks of repeat clients, you will not survive for very long. We have a lot of entrepreneurs who have made money by corrupting their way to the bank. They have earned a bad reputation in the market place but they do not care. As long as they have made money, they have acquired a license to command the market, bulldoze everyone, let alone destroying their opponents. As long as you have earned this money unscrupulously, the money source will dry at some point.

Always ensure your transactions are above board whatever the cost. Your integrity is the license that sustains your enterprise. This is very important in Zambia because there are many people who have earned lucrative tenders, received the money and rushed for the latest car in the market without fulfilling the contract. One highly promising enterprise in Zambia, FOCUS, has had most of its operations grounded because they discounted invoices based on trust but counterparties let them down. Insulate your enterprise from the Zangena mentality. Value and invest in your product; be proud of your product and only earn money when you have truly satisfied the market. I personally have a policy of receiving nor more than 40 percent downpayment for any contract my company enters into. Our philosophy is that we should only be fully paid after the client has certified and signed off the contract. When the final payment is made, we know there is a very happy client with us.

How can our President call for a Government of National Unity before the petitioners go to court to present their evidence of a rigged election? Where is President Lungu rushing to? Suppose the courts of law in Congo declare that, in fact, Tshisekedi was dulyelected and is not guilty of electoral malpractice, where will that leave the Zambian position announced by the State House Press Aide to Mr Lungu?

The Zambian people still remember that in 2016, President Lungu narrowly passed the 50% plus 1 vote threshold, and only beat his closest rival by about 13,000 votes. The election results were strongly objected and evidence of malpractice

Unconvinced that they had lost the election to the PF, UPND filed a petition in court and called for intervention from the same SADC and the African Union - among other bodies - highlighting how President Lungu had abrogated the Republican Constitution during the elections. It is this same President Lungu who issued a very strong warning for SADC and all international bodies to stay away from Zambia's sovereign affairs. What has changed today for President Lungu to make such a premature intervention in the Congo election situation? Why is he in a hurry to disregard the sovereignty of the Democratic Republic of Congo?

Our suspicion is that President Lungu and the Patriotic Front regime has an interest in one of the losing candidates of the Congo elections. They would have loved him to win the elections so that they can do governmentsupported private deals with Congo. That is why they want this candidate to be part of a coalition government, which would still give them room to transact.





The "black box" voice recorder from a Lion Air flight which crashed off the coast of Jakarta in October has been recovered, said officials on Monday.

All 189 people on board died when Flight JT610 fell into the sea shortly after taking off for the short journey to Pangkal Pinang.

The pilot had asked air traffic control for permission to turn back to the airport but then contact was lost.

Investigators say the plane had encountered technical problems.

The aircraft - a new Boeing 737 Max - broke into many pieces when it hit the water at high speed. The plane should not have been flying on the day it went down as it was not airworthy, Indonesian investigators have said.

The bright orange voice recorder was found at least 50m (165ft) from where the first black box - the plane's flight data recorder - was found last November.

The recorder voice was found on Monday morning but was "broken into two pieces".

"Hopefully it's still useful [to investigators]," Haryo Satmiko, deputy head of Indonesia's transport safety committee (KNKT) told Agence France-Presse.

Indonesia's Navy spokesman Agung Nugroho told Reuters that the recorder was found 8m deep, under mud on the sea floor.

Mr Nugroho said that weak signal from а

conversations between the pilots and ground control on the CVR should help investigators finish piecing together what went wrong in the short flight.

Flight JT610 took off from Jakarta at 06:20 on Monday (23:30 GMT on Sunday).

It crashed minutes after the pilot asked for permission to turn back to the airport.

Findings by Indonesia's transport safety committee (KNKT) suggest that Lion Air had put the plane back into service despite it having had problems on earlier flights.

The pilots appeared to struggle with an automated system designed to keep the plane from stalling - a new feature of the Boeing 737 Max.

The anti-stalling system repeatedly forced the plane's nose down, despite efforts by pilots to correct this, the findings suggest. Investigators have now said that the plane was not airworthy and should have been grounded.

In December Mr Trump announced that the US would pull out all troops from Syria because the Islamic State militant group had been "defeated".

The sudden move shocked allies and led to criticism. Several senior US military officials resigned shortly afterwards.

There were also fears that Kurds in the Syrian Democratic Forces (SDF), which had partnered with the US, would be attacked by Turkey once the US withdrew.

Mr Trump tweeted on Sunday that the withdrawal from Syria had begun, and that the US would "devastate Turkey economically if they hit the Kurds".

He also said any remaining IS fighters could be attacked from the air, and that a 20mile (32km) "safe zone" could be established.

His tweet could be seen as a response to criticism that his decision to withdraw troops will hurt the US's regional allies.

Mr Trump offered no specifics on how the US could hurt Turkey's economy, and his announcement appeared to catch his advisers by surprise.

Secretary of State Mike Pompeo, who is currently touring the Middle East, responded to questions about Mr Trump's threat with: "You'll have to ask the president... We have applied economic sanctions in many places, I assume he is speaking about those kinds of things."

Meanwhile, Turkey's foreign minister Mevlut Cavusoglu described Mr Trump's tweet as a "domestic policy message" to critics.

Mr Cavusoglu has rejected Mr Trump's threats, saying: "We have said multiple times that we will not fear or be deterred by any threat."

He also criticised Mr Trump's methods, saying: "Strategic alliances should not be discussed over Twitter or social media." However, US sanctions have had an impact on Turkey's economy before. The Trump administration imposed sanctions and trade tariffs in August, amid a row over a detained US pastor contributing to a sharp drop in the value of the Turkish lira. Pastor Andrew Brunson was released in October. Meanwhile, Turkish President Recep Tayyip Erdogan's spokesman, Ibrahim Kalin, said Turkey expected the US to "honour our strategic partnership". "Terrorists can't be your partners and allies," he said. **BBC**

'What's Ozil done for Arsenal? Absolutely zero!" - Ex-Gunners star baffled by business

Mesut Ozil has offered "absolutely zero" to Arsenal since signing a lucrative new contract with the club, claims former Gunners star Paul Mariner.

Back in February 2018, a long-running saga regarding the German playmaker's future was brought to a close as he penned fresh terms.

That agreement was considered to be a triumph for those at Emirates Stadium, as another prized asset was prevented from heading for the exits.

Ouestions have, however, continued to be asked of Ozil's contribution in the wake of that extension, with Unai Emery having taken to overlooking him on a regular basis since inheriting the reins.

Mariner believes that is because the 30-yearold is doing little to justify a regular role or his new deal, telling the ESPN FC podcast of some baffling business: "I'm dumbfounded why Arsenal would let [Alexis] Sanchez go. Sanchez, when I used to go to Arsenal to watch him play, he was phenomenal. "It didn't pan out so much for United but they let Sanchez go, they're letting [Aaron] Ramsey go for nothing! What's going on? "And with Ozil, there's something going on with Ozil that we don't know about.

"Arsenal decided to put all their eggs in one basket with Ozil, right? But what's Ozil done for the club? Absolutely zero! Zero.

"Yes, he's a fantastic player, but he's got to get fit. He's never fit! There's something going on with this kid that we don't know about?

The Gunners lacked creativity without the World Cup winner, but Emery sought to defend his selection afterwards by claiming that he had enough quality within his side to cope without one player.

The Spaniard said of Ozil: "He's working this week normally. Like I said we win with him and lose with him. Today the decision is to come with these players.

"But, like I have said, we have won with him and lost with him, and today I chose the players who finish. Goal.com

Battling Murray crashes out as Federer, Nadal fight on

A battling Andy Murray bowed out of the Australian Open at the first hurdle Monday, but it was business as usual for ruthless Roger Federer and Rafael Nadal who joined Caroline Wozniacki in round two.

The Scottish five-time Melbourne Park finalist gave it everything he had and showed glimpses of the form that won him three Grand Slams, but his ailing body let him down during a gutsy 6-4, 6-4, 6-7 (5/7), 6-7 (4/7) defeat to 22nd seed Roberto Bautista Agut.

Murray tearfully revealed before the tournament that he was in constant agony from a hip injury and planned to retire this year.

The 31-year-old hopes to end his career at Wimbledon, but has admitted the Australian Open could be his last event, unless he has a late change of heart.

"Amazing. That was incredible, thank you so, so much to everyone that came out tonight," he said after being given a rapturous send-off. While his tournament ended in despair, Swiss master Federer, six years older than Murray, continued his march towards a record seventh



vowed to give his all to make it three in a row.

"I'm going to try everything possible (to win again) and leave it all on the court," said the world number three. His long-time rival Nadal,

who cut short his 2018 season to have surgery on a foot injury, showed no mercy to Australian wildcard James Duckworth in his opening round clash.

"Benatia got hurt with a groin inflammation


in the warm-up, so he won't take part," Allegri was quoted by Football Italia. "We're already without Andrea Barzagli,
