Goverment has only paid K23m out of K101m debt to lecturers – UNZALARU

University of Zambia Lecturers and Researchers Union (UNZALARU) secretary general Dr Kelvin Mambwe says government only paid K23 million out of the K101 million that was budgeted for in the 2018 national budget to settle pension and gratuities debt owed to lecturers and researchers at the institution. In an interview, Dr Mambwe government was said not committed to liquidating the debt that it owed to lecturers. "There is no big problem with salaries at the moment, the main issue is concerning pensions and gratuities. Last year, government had budgeted about K101 million for the University of Zambia, but out of that amount,

only K23 million has been released. And they have not explained where the rest of the money which they budgeted for has gone. That has caused serious anxieties amongst our members and has potential for continued industrial disputes, we will, however, go ahead with work as schools open. We are supposed to meet the Permanent Secretary this coming month in order to understand why government only released K23 million out of the K101 million that was budgeted for in last year's budget," Dr Mambwe said. "Also if you look at this year's (2019) budget, we were told that Cabinet had approved a financing strategy that required that this year's budget reflects about K500 million, but if you look at the actual figures in the 2019 budget, there is only K69 million, so we don't understand how government is going to liquidate the debt owed to our members." He said this would continue being a recipe for strikes by lecturers. "In fact, I would say that there is no commitment on the part of government. Because if on one hand they say they are going to give K500 million, but what comes in the budget is less than that, then where is the commitment? In fact, that in itself is a recipe for continued strikes at the University of Zambia. So, you will still see some serious challenges as the year begins, such as work stoppages and the like, not until government comes to terms with their commitment," cautioned Dr Mambwe.

increase in mineral royalty rates by 1.5 percentage points at all levels of the sliding scale. It also introduced import duties of five per cent on copper and cobalt, while also hiking export duty on precious stones and gemstones to a rate of 15 per cent, a situation that had prompted mining companies to threaten job cuts, while compelling KCM to downsize its Nchanga Smelter operations due to low availability of concentrates. But KCM acting chief executive officer Venkatesan Giridhar informed a highlevel government delegation during a consultative meeting in Lusaka, which included Ministry of Finance, Mines and Labour officials, that the Vedanta-owned mining firm will not be effecting any job cuts at any of its operations on the Copperbelt. "I wish to confirm, therefore, that THERE WILL BE NO LOSS OF JOBS AT OUR SITES as a result of the new tax regime," Giridhar announced, when he presented a paper on the impact of the 2019 mining fiscal regime on KCM mining operations and its future undertakings at the Ministry of Finance in Lusaka. "As KCM, we undertake to constructively engage key stakeholders, such as the government, trade unions, the media, local communities, and our shareholders, in a respectful manner to ensure that we contribute to the growth of the economy

on a sustained basis." And Giridhar emphasised that KCM was renewing its focus on Konkola Deep Mine in Chililabombwe and would ensure further investment in the short to medium-term, according to the statement. "...Our actions are designed to sustain and create jobs, grow the economy, and contribute more to the country's treasury while effectively implementing and liability our asset management programme," read the statement. Meanwhile, Finance Minister Margaret Mwanakatwe hailed KCM for choosing the path of dialogue and for the proactive approach in reviewing mine operations and sustaining job creation, among others. She also insisted that the impending Sales Tax will soon come into effect as planned. "Let us walk the journey together so that by April 1, 2019, we can implement the Goods and Services Tax (GST)," stated Mwanakatwe, adding that the GST will be a hybrid of Value Added Tax and Sales Tax, with all the attendant incentives and exemptions for manufacturers, exporters, and other eligible sectors of the economy. Other pressing matters covered in the consultative and information exchange meeting were KCM smelter business strategy, the deficit of concentrates in the country, among others.

He said Lusambo was being mischievous and untruthful, arguing that government would have already taken legal action against the UPND leader if he really stole anything in the 1990s. "Those are just last kicks of a dying horse! I am sure you will recall that not so long ago, Mr Lusambo was crying that the PF elections on the Copperbelt were a sham! So, it tells you exactly who they are as PF and this is something that we as UPND do not want to waste time on. We have a programme and our programme is to liberate this country from the malaise that the PF has led us into. So, those are just time wasting statements and also very strange that a government minister can waste his time to go on radio to go and spend his precious time when he's supposed to be doing government

work, to go on radio just to malign a private citizen and say something, which is not factual," Belemu said. "In a civilized government, when a minister speaks, it's policy and it's also informed by a research and facts. Just misinforming, lying or not telling the truth calls for resignation of a minister or indeed that government. So, they cannot continue to use false statements as government. They have all the institutions of government that can help them, including ZCCM, the police and all the other investigative wings so that when they are talking, it must come out of facts, as opposed to just yapping and talking in the manner that they are doing." Belemu challenged the PF to take the privatization issue to the dialogue table so that it could be resolved rather than making "baseless" statements on radio programmes. "As a party, by now I am sure they know who we are and we have demonstrated time and again that we are above such kind of shallowness and



childish arguments. They have also known who our president is and we continue to tell the Zambian people the truth about who PF is because we have experienced, some of us who are in Parliament with them. We also have experience of being in the UPND and I am sure Zambians by now are able

to make an informed decision of who is who in our political level. Instead of going to a radio station to talk, why didn't they go to the meeting that was organised by the Church? If their contention is about HH having participated in privatization, why didn't they go to the national dialogue table instead of running away and they want to run to radio stations...real men, real leaders had a platform to go and talk those issues. Inspector General of Police Kakoma Kanganja says police are still studying the Human Rights Commission report which found that the service is responsible for Vespers Shimunzhila's death. Kanganja told journalists, Wednesday, that the police command would only the HRC on comment report after consultation with appropriate authorities. "We are still studying the report and will respond at an opportune time after consultation with appropriate authorities. As you are aware matter is yet to be subjected to an inquest," said Kanganja. On Tuesday, HRC released an eight-paged summary statement on their findings on the students' protest and the Zambia Police Service operation at the University of Zambia (UNZA) Great East Road Campus which took place on 4th and 5th October 2018, HRC revealed that after interviewing UNZA Security, UNZA Management, UNZA Lecturers and Researchers Union (UNZALARU), UNZA Clinic Management, University Teaching Hospital (UTH)

Management as well as the Zambia Police Service, they concluded that police officers acted in a brutal manner and caused Shimunzhila's death. "The Police were seen driving into UNZA Premises around midnight on 4th October 2018 and officers were seen jumping off a Green Nissan Police Vehicle and two other Land Cruisers, one of them labelled, "Simon Mwansa Kapwepwe Police Station". According to witnesses, gunshots were heard in UNZA Campus and police officers were seen throwing suspected hand held-grenades and firing tear gas canisters into students' rooms through windows. A total of six (6) students' rooms where tear gas canisters were fired into

were gutted by fire. The HRC heard that as the fire in October Hostel 2 Room 21 was being quenched by some students, some police officers repeatedly tear gassed the students who were quenching the fire and also rescuing their colleagues that were trapped in the rooms, causing October Hostel 2 Room 3, to also catch fire," HRC stated. "October Hostel 2, Room 25, which was occupied by eight (8) female students, was heavily affected by flames and fumes from Room 21 which was on fire. Some of the eight (8) female students escaped by climbing down through the window while the 23-year-old Everntyn Choongo, jumped from the room, which is on the third

level of the building and suffered multiple fractures, including a broken lower spine. Another student, Trudie Kalimbwe, who was the last to leave room 25 alive, suffered burns on her hands and hair before escaping through the door. Regrettably, Vespers Shimuzhila, could not escape and was found unconscious by fellow students who braved the reported continued tear gassing. She was rushed to UNZA Clinic where she was pronounced as brought in dead and her body was transferred to Levy Mwanawasa Hospital before being transferred to UTH Mortuary." HRC revealed that tear gas cannisters were found in all the rooms that caught fire. HRC concluded that police

officers caused Shimunzila's death and recommended that they be given criminal charges. "It is therefore beyond any reasonable doubt that Vespers Shimuzhila did not die from a natural cause. Further, from all the evidence submitted by a wide range of witnesses during investigations, it can be concluded that the invasion of the UNZA Campus Premises and subsequent throwing of suspected hand grenades and firing of tear gas canisters into students rooms by the Zambia Police Service, caused the death of Vespers, the injury of other students as well as the loss of, and damage to University and Students' Property. The Commission considers the firing of tear gas canisters in students' rooms extremely unprofessional, an act of excessive use of force which resulted into a grave violation of the right to life, destruction and loss of property and undermining the right to education of the affected students whose education materials and equipment were either lost or damaged during the police night operation," read the statement. "It is clear from the totality of the evidence obtained that the police acted in an extremely brutal manner depicting a combative warfare situation against unarmed students who at that time no longer posed any real danger or violence to the police officers or to any other member of the public property...Therefore, or appropriate criminal charges should be preferred against all the police officers (including the senior police officers who were in-charge of the operation) for the ensuing loss of life, body injuries to several students and damage to property." HRC also advised Shimunzhila's family to sue the state and secure appropriate compensation for loss of life.



Low number of cases being reported shows loss of confidence in ACC - Wynter Kabimba

By Mirriam Chabala Rainbow Party general secretary Wynter Kabimba says the confession by Anti-Corruption the Commission (ACC) that it is does not understand why Zambians have stopped reporting cases before it calls for introspection within Commission itself. the And Kabimba has challenged the ACC to come out in the open and say if the people involved in corruption are those working within government whom they think are too big and cannot be probed. Commenting on the revelation by Acting ACC Director-General Rosemary Khuzwayo during the launch

of the TIZ 2018 Corruption in the past, people from Perceptions Index (CPI) on Tuesday, Kabimba told News Diggers! in an interview that he was glad that the ACC had finally confessed the loss of confidence in the institution by Zambians. He said Khuzwayo's confession was a great indictment on the ACC as an institution, and that the Commission must find out why Zambians had stopped reporting cases of corruption before it. "Firstly, most of the corruption that Zambian people complain about is corruption, which is taking place in public institutions and in government. Secondly, they have seen

government, from public institutions being charged with corruption and it's either those cases are discontinued under a nolle or people get acquitted because of lack of competence in terms of ACC prosecuting those cases. So, if that confession has come from ACC, it is a great indictment on them as an institution and they must find out why Zambians have stopped going to them to report cases of corruption. One obvious answer is that the Zambian people have lost confidence in the Anti-Corruption Commission. They don't see ACC as an organisation that can help the country fight corruption. You have heard many times Zambians complaining that ACC is dealing with cases of corruption of the 'small fish,' not the big fish! So, that is the only answer," Kabimba said. "I am glad that that observation is coming from ACC itself and if I were them, I would seriously sit down and interrogate that perception by the public of an institution, which is supposed to win the confidence of the Zambian people. Zambian people no longer believe that it is worth it to go and report cases of corruption. How many times have we heard President (Edgar) Lungu say to them: 'can you investigate the reported cases of

corruption as reflected in the Auditor General's Report?' And yet we have heard nothing in terms of proactive action from ACC in that area. So, if they are failing to investigate glaring reported cases because the cases that are reported by the Auditor General's office, all that they need as evidence is for them to go to the Auditor General's office to go and get the evidence and then they can get to the culprits. But they have failed to do that! So, all those are things that have made the Zambian people lose faith and trust in the ACC." Kabimba, a former Justice Minister, challenged the ACC to tell Zambians if

the people involved in corruption were the very ones within government who were pretending to champion the fight against the scourge. "ACC is a cornerstone of national development, it's supposed to protect public financial resources. But unfortunately, it is not doing that. So, we want to see a competent Anti-Corruption Commission, we want to see an effective Anti-Corruption Commission, especially on matters that are reported by the Auditor General's office. If you've been following the cases that have been going before the parliamentary Public Accounts Committee (PAC), you still find glaring cases there; of misappropriation of funds and corruption. But nothing happens. it's two years now, President Lungu has been saying to ACC: 'can you follow up these matters', even about three days ago, I remember him saying that. But if they are not doing their job well because the same politicians that are saying 'investigate these matters' are behind the cases telling them: 'don't investigate', ACC must let us know. If not, then the buck stops at them, they are the ones who are not doing their job," said Kabimba.

ZCCM-IH hopes 2019 fiscal regime won't hurt profitability

ZCCM-IH the savs uncertainty in the 2019 mining fiscal regime may affect its profitability and dividends payable to government. And ZCCM-IH has increased its shareholding in Copperbelt Energy Corporation (CEC) to 24 per cent from 20 per cent. Speaking during ZCCM-IH's annual report presentation for the year ending March 31, 2018, in Lusaka, ZCCM-IH chief executive officer Dr Pious Kasolo expressed concern on the uncertainty created by the 2019 mining fiscal regime, which had unsettled mining firms on long-term growth prospects. The 2019 mining fiscal regime, which took effect January 1, 2019, has seen an increase in mineral royalty rates by 1.5 percentage points at all levels of the sliding scale. It also introduced import duties of five per cent on copper and cobalt, while also hiking export duty on precious

stones and gemstones to a rate of 15 per cent, a situation that had prompted mining companies to threaten job cuts, while compelling KCM to downsize its Nchanga Smelter operations due to low availability of concentrates. When asked to what extent the 2019 mining fiscal regime had affected ZCCM-IH's profit projections in view of some mining companies' move to downsize operations on account of the higher taxes, Dr Kasolo said accurate projections were not known at this stage, but expressed concern on ZCCM-IH's long-term profitability and dividends payable to government. "At the moment, we can't say how it's going to affect ZCCM-IH because most of these taxes haven't come to fruition. But by projecting some of our investee companies, what we've looked at and discussed with them...I can give an example

of Lubambe (Copper Mine). The funding to develop that mine has become a bit difficult because the banks have become quite tight with their money because they are not sure about the tax regime in Zambia, when it's going to change. So, Lubambe is finding it difficult to raise capital," Dr. Kasolo told journalists at Southern Sun Hotel, Monday. "So, in hindsight, what will happen is that if this are not mitigated, then ZCCM-IH is going to be affected because we get our dividends from these companies. So, I hope the tax debacle is going to be resolved without affecting production in development of these mines." And Dr Kasolo announced that ZCCM-IH increased its shareholding in Copperbelt Energy Corporation (CEC) to 24 per cent from 20 per cent. "...With CEC, we've increased our shareholding from 20 per cent to 24 per cent and

we hope to go up to about 34.9 per cent, hopefully," disclosed Dr Kasolo. posted ZCCM-IH an increased profit after tax of K975 million during its financial year ending March 31, 2018, from K729 million in the previous corresponding

period, triggered by

high copper prices. On the other hand, total dividends paid out last year amounted to K98 million down from K135 million during its financial year ending March 31, 2017, according to company data.



I stole bicycle to buy school shoes, youth tells court

Because of the so much corruption in administering the debts that we are getting for projects, where when you get the funding for the projects, they are overpriced and the money is ending up into pockets of individuals,

especially the pockets of those in government and the ministers, State House officials and the President himself. Such in itself is making the issue of doing business in Zambia difficult and it is also taking away valuable funds that can be used for the development of this country and that's making people suffer. Then also because we have over borrowed to the extent that we are not even seeing where the money has been spent, we are meant to repay those debts at very exorbitant interests, taking into account the conditions of the loans plus the exchange rate coupled with the inflation Kambwili levels," said. "I have always said that this is the only government where a minister can go into a constituency and donate over K600,000 when his annual salary is K250,000. This is the only country where a minister can build churches and donate in the constituency, fully furnished, and the President is watching. This is the situation we have in this country and some people take it so lightly when we talk about corruption but the end result is that donors will lose confidence and stop funding our projects...If the status quo continues, then funders will pull out. Investors will stop coming to Zambia. Those are the indicators in a country where leaders do not want to fight corruption because they see nothing wrong with it." And Kambwili said President Lungu could not fire Sichalwe because circulating porn was normal to him. "For this government, their game is corruption and for them, corruption is very normal. They will go and arrest an official from the Ministry of Education who has stolen K2 million and they will leave a minister who has been mentioned in the Financial Intelligence Centre (FIC) report that has money in his account and he externalized money which has unexplained sources. Where is the fairness? This is a government where a teacher who forges a certificate is fired but a PS who forges a certificate is kept. This is a government were an ordinary citizen on the street who is found with pornography is sent to court and jailed but when a minister circulates pornography, he's not arrested and he's not questioned. So everybody around the world looks at you as being abnormal. But for President Edgar Lungu, all those things are very normal with him as long as it's committed by people who are close to him, people he does things with, he will not take any action," said Kabwili.

(News Diggers), you have been writing bad things about us, but we appreciate because you cover us, whether bad or good, you cover us. That's why I am even able to respond to you, we appreciate, because whatever we say, whether you twist it, but vou have covered us, you get my point? And that's the more reason we appreciate you." He said he had called Prime TV more than 16 times to cover his briefings but they had never covered. "But imagine a situation whereby you call them (Prime TV), I have called them more than 16 times for my press briefing, they have never covered. Ask them if Hakainde Hichilema pays for the programs, he doesn't pay but they ask us to pay. So we are saying that they are biased and I don't need them anyway," Mwila said. And Mwila said Zulu's suspension had the blessings of the party's central committee, even though it was executed by the grassroots. "The Party starts from the grassroots and the decision of the grassroots stands. He was suspended and given time for him to exculpate himself. So he must respond to the Party in the Constituency, so that's the explanation I have. He has been asked to exculpate himself, of which he has not

responded to the letter from the constituency," Mwila said. Meanwhile, the PF chief executive said all PF members of parliament who have been secretly supporting Kalaba's presidential bid are cowards. On Tuesday, Kalaba announced that he would not challenge his expulsion from the ruling party and boasted that there were a lot of PF members of parliament who are supporting his State House ambitions. "We have welcomed his decision and (Kalaba's) what we have said is that he cannot resign because he is no longer our member so his resignation cannot hold water,

that's what we have said. He should have resigned before that, a long time ago. We also expelled the Councillor who said she resigned the same day. The central committee made a decision based on the recommendation that came from the provincial committee. We have always been ready, we are the defending champions, so we are ever ready," Mwila said. "If there are MPs who are encouraging Kalaba, they are cowards! Why can't they come out [of the party]? Kalaba has said I am going, he is courageous enough to say I am going, why can't they also go if they are there?"


Court sends juvenile to rehab for stealing

The matter was then reported at Chilenie Police Station. Asked whether he understood the facts, the juvenile offender replied in the affirmative. In mitigation, the 17-year-old asked for forgiveness from the complainant, his family and the court, saying he would never engage in such acts again. The juvenile also asked for maximum leniency, saying he just got his Grade 12 results and wanted to read law. He said when he was in custody, he went through a lot. "God spoke to me and was trying to tell me that if I don't change my ways, that's the type of life that I would live, in prison," the juvenile said. His father also asked the Court to exercise maximum leniency, saying even though he committed that offence, he was a good boy at home

and had grown up very responsible. In her ruling, Magistrate Chanda noted that the offence that the juvenile had if he was able to steal that big TV, it meant that he was used to stealing. She warned the juvenile to stop his criminal ways. "The circumstances of the crime, where you are able to go and take a big TV like this one, this shows me that you have been stealing! Because if this was the first time, you can't steal a big TV like this one, meaning you are used. So, can you change," Magistrate Chanda said. 'Your father is saying that you have been raised as a good child, it takes some courage for someone to enter someone's house and steal a TV and then later, book a taxi. It can't be for the first time. That criminal mind should stop! If he comes back, he has to go and serve." Magistrate Chanda ordered that he goes for counselling and rehabilitation at Prison Care and Counselling Association (PRISCCA) for six months.

rehabilitation for six months after stealing a 65-inch Samsung Plasma TV worth K21,000 from his neighbour's house. In this matter, the juvenile was facing one count of house-breaking and theft. It was alleged that on January 15, 2019, the juvenile broke and entered into a dwelling house of Alexander Mwale and stole a Plasma TV valued at K21,000, property of Mwale. Saving Wakanda from Creeping Dictatorship'

Wakanda is a fictional East African paradise made famous by the 2018 blockbuster film 'Black Panther'. It is a well-developed, high-tech, highly functional country inhabited by warriors who possess mystical powers through a special substance only found in Wakanda called vibranium. Wakanda is a powerful and well-governed country. It is a proud nation which has its own official African language. As a result, it has garnered the respect of countries far outside of its borders. Back on the real African continent, one struggles to find a country that matches the description of Wakanda in all respects. If anything, there is a growing instability around the continent that is unsettling. What we see is the spread of populism and authoritarianism and what appears to be contempt for democracy, human rights and the rule of law. Unfortunately, the East African nation of Tanzania, a country which like Wakanda has a proud political, cultural and linguistic heritage, typifies this. Like Zambia, neighbouring Tanzania has long been seen to be a peaceful and stable nation. It has a proud history of having liberated many other nations on the African continent under the great "Mwalimu", Julius Nyerere. Just as in Zambia, this narrative is under threat. The current government of President John Magufuli, once hailed

as the "bulldozer" for his apparent efficiency in dealing with corruption, is fast becoming a dictatorship where fear reigns. It is becoming an inhospitable environment for those who wish to speak truth to power.

A recent example of the changing character of Tanzania's democracy is the victimisation of the Tanzanian organisation 'Twaweza' whose name means 'we can make it happen' in Swahili. Twaweza did the unthinkable by publishing the results of a local poll on 5th July 2018 showing that President Magufuli's popularity was falling. Twaweza's Executive Director, Aidan Eyakuze, has subsequently had his nationality questioned and his passport confiscated. Twaweza recently joined a coalition of civil society groups to campaign against the enactment of a Political Parties Bill which will have the effect of giving the Registrar of Political Parties sweeping discretionary powers to control political parties' activities and statements with little or no recourse. Such legislation might lead the country once more down the path of a one party "democracy". There is trouble in "Wakanda". Even more worrying are reports by opposition leader and former Law Society of Tanganyika President, Tundu Lissu, of enforced disappearances and unexplained killings. Lissu himself survived an attack in which unknown

assailants shot at his vehicle 38 times hitting his body 16 times. At the time of the attack, Lissu was facing several criminal charges which he says are politically motivated. The office of the lawyers defending him was also mysteriously bombed. Lissu is alive but has had to endure several corrective surgeries.

Zambia is surrounded by eight neighbours including Congo DRC, Angola, Mozambique, Namibia, Malawi, Zimbabwe, Botswana and Tanzania. It is fair to say that Zambia, experiencing an apparent wave of populism, corruption and impunity, fits into its neighbourhood quite nicely albeit as the smiley, friendly, neighbour. Looking around this neighbourhood, there are no credible champions of democracy, constitutionalism and the rule of law. So, when the citizens of any of the countries are under siege by their governments, there is nowhere to turn. Regional bodies made up of the Continent's political leaders appear to be toothless and are plagued by cronyism. We citizens have no choice but to save ourselves. That is what makes the work of Twaweza so admirable; it is made up of citizens standing up for their country. We must all do our part to make sure that our countries are places that we want to live in: peaceful, democratic, prosperous and liberating. "Twaweza", we can make it happen.

Police fight running battles in Zambezi after death of suspect

Police in Zambezi District of North-Western Province on Tuesday fought running battles with residents who ran amok destroying properties and setting ablaze a police vehicle after news broke out that a suspect had died in police custody.

And Deputy Inspector General of Police in charge of Administration Eugene Sibote has confirmed that the protests arose after the death of the suspect, who had been in custody for allegedly being in possession of an illegal firearm.

In a statement, Sibote explained that the residents started protesting after they were made to believe that the suspect died in police custody as a result of torture.

The situation in Zambezi arose from the death of an individual who was detained at a correctional facility as police were following information regarding suspected possession of an illegal firearm. Arising from the death, members of the public suspected that he could have been subjected to torture leading to his death. The people, thereafter, ran amok and consequently damaged several properties, which include the burning of the Zambezi Police Station Toyota Land Cruiser, among other things," Sibote narrated. He stated that police reinforcements had been sent to Zambezi to calm the situation. "So far, reinforcement has been sent to Zambezi to ensure there is peace in the district and the situation is currently reported calm. The traditional authority in Zambezi has also been engaged over the matter and we have been assured of cooperation pending investigations. A team of police officers and a pathologist will be sent to conduct a postmortem and an inquiry. We, therefore, appeal to the people of Zambezi to remain calm whilst the matter is being addressed," stated Sibote.

ACC nabs Livingstone MP for illegally allocating plots

ACC spokesperson Timothy Moono revealed in a statement that Jere, between 1st August, 2013 and 31st October, 2014, whilst serving as a councilor, jointly and whilst acting together with other persons unknown, illegally allocated plots to himself and his friends. "Honourable Mathews Jere aged 45, of house number 231 Highlands, Livingstone, has been charged with one count of Abuse of Authority of Office contrary to Section 21 (l)(a) of the Anti-Corruption Act No. 3 of the Laws of Zambia. Particulars of the offence are that on dates unknown but between 1st August, 2013 and 31st October, 2014, Mathews Jere, whilst he was serving as a Councilor for Mwalibona Ward in the Livingstone City Council, jointly and whilst acting together with other persons unknown, did abuse authority of his office by allocating plots of land to themselves on property number LIV/4051 a matter or transaction concerning the Livingstone City Council, a public body," stated Moono. heartbreaking and it raised a moral debate as to why government should honour former vice presidents with State funerals after neglecting them when they were still alive. "Without disturbing the spirit of mourning, I wish to raise a pivotal issue, which relates to the plight of former vice presidents in Zambia. Although vice presidents actually act as President and play a significant role in the management of the nation, the occupants of that office have zero sustainable benefits once they leave office. The only sure retirement benefit has been a State funeral at death. Hon. Lupando's death becomes an opportunity to raise this matter in the hope that government can ensure that those who serve the nation faithfully are taken care of after leaving office," Mumba, who is also a former Vice President himself, observed. "Those of us who knew and walked with the late Lupando Mwape remain heartbroken by the life he was subjected to. His case must raise a moral debate as to why a man who did not even have a place to lay his head should be given an expensive State funeral. In life, he suffered from lack, in death, he is treated as a king. This is not to belittle the honour of the State funeral, but to challenge Cabinet Office as to the

morality of this status quo." Mumba bitterly complained that other public office holders and service chiefs their had retirement packages, but that the vice president had none, relegating them to destitution leaving after office .. "Former President, the Chief Justice, the Speaker of the National Assembly, Service Chiefs and civil servants have packages once they retire, but a former vice president has none. I, however, need to place a disclaimer that I do not raise this matter to benefit myself-having held this office, but to highlight a matter that has embarrassed Zambia for years, both at home and abroad. In most nations, a vice president leaves office with sustainable benefits. In Zambia, they leave office with debt arising from whatever loan they could have contracted. Everything is withdrawn: the security, staff, vehicles, diplomatic passport and are thrown onto the streets with no monthly stipend to help in paying off the loan they could have contracted while in office," Mumba stated. He said the sidelining of former vice presidents from retirement packages was historical, dating back to the UNIP administration. Mumba, however, hoped that the PF government urgently corrected the situation. "This problem of the nation's

number two comes from the UNIP days. Vice presidents Simon Mwansa Kapwepwe, Secretary General of UNIP, Grey Zulu, prime ministers Malimba Masheke, Kebby Musokotwane, Nalumino Mundia, Mainza Chona. I believe, as MMD, we failed to secure these freedom fighters financially to give them a dignified life. Some have gone to the grave in great poverty. I am reminded of the immeasurable hardships the late former vice president General Christon Tembo went through in trying to pay for medical bills until we lost him. He was, however, given an elaborate State funeral. As MMD, we approved former Presidents' package, but left out those who laboured side by side with them. I hope the PF can see the value of correcting this national anomaly," he said. Mumba, however, thanked government for having evacuated the late vice president Mwape. "At the height of his public service, he remains as one of the few vice presidents who acted as President for a prolonged period of time when the late President Levy Mwanawasa was hospitlised in London. It was, therefore, befitting for the government to have evacuated him to South Africa for specialised treatment. We commend government for the gesture," said Mumba.

The Anti-Corruption Commission of Zambia says there has been a drop in the number of people reporting corruption cases to the institution. Acting ACC Director-General Rosemary Khuzwayo told а gathering at the launch of the 2018 Corruption Perceptions Index that she does not understand why people have stopped reporting corruption cases nowadays.

"There is a drop in the number of reports that we are getting from members of the public. We do not understand why there is a drop, but there is a significant drop in the number of corruption cases that are being reported. People are not really reporting corruption," on madam complained Rosemary.

"Then evidence also shows that in Zambia, huge amounts of monies are lost through kick-backs compared to other corruption avenues such as abuse of office. Another area of major concern for the ACC includes procurement; the manner in which contracts are awarded for roads and buildings."

We find this to be the most embarrassing statement to have ever come from the Anti-Corruption Commission. We say this because, to our ears, this is a clear admission of incompetence and declaration of

redundancy at the same time. We don't know how the acting Director-General could not see what her remarks implied, because the answer to her question was embedded right in her own statement.

Why is the Anti-Corruption Commission boss shocked with the drop in the number of corruption cases reported to her institution, but she is not surprised with her institution's failure to prosecute those few cases that are reported? How can Madam Rosemary her and management at ACC fail to identify the link between the political influence under which they operate, and the loss in public confidence? Isn't that too obvious?

For example, if we reported a State House

official engaged in corruption today, and take the evidence to the ACC office, who will have the balls at that institution to pick the phone and call the accused person for interrogations? Who, at ACC, can arrest a sitting Cabinet minister for corruption? No one! So, what's the point in corruption reporting if nothing would be done about it at the end of the day? Why should members of the public risk their lives, reporting big criminals and only end up alone facing the wrath of those in power, while the ACC is watching from a safe distance?

When News Diggers! launched its print edition on December 17, 2017, the first lead story we published was from an interview with the Anti-Corruption Commission, in which

we asked how the institution deals with involving corruption State House officials. The ACC spokesperson was frank enough to tell us that regardless of how much evidence one can avail to the Commission, if the corruption is connected to the sitting Head of State, an investigation cannot be done. Again we ask; why is the ACC Director-General surprised that people have stopped reporting corruption cases lately? Why should people

go ahead and provide evidence of corruption, which will end up in the trash bin?

Madam Rosemary, corruption reporting is not a hobby that someone is expected to do for their own pleasure. It is a huge risk to report corruption that would never be prosecuted because there is actually а likelihood that the same investigators may report you to the accused.

The point is that, those people whom the ACC is afraid of prosecuting are the real culprits of real corruption. Yes, the police traffic department may rank highest in terms of corruption prevalence rates government among institutions, but the fact is that the total of amount monies involved from all traffic corruption cases per year can be equal to


only one corruption deal involving a State House official or the President himself! At Permanent Secretary level, Ministerial level, State House level and presidential level, corruption deals are transacted in millions of dollars - not the K50 that is denting the image of the police.

If those big guys at the top remain untouched, then members of the public have no reason getting involved in the fight against corruption; unless the ACC is waiting for a trader at Chilenje market to report a section chairman for receiving

a bribe to allocate a market stand to someone. If that is the corruption that madam Rosemary wants to fight, then she might as well shift her office to a mobile money-like booth, because fighting that type of corruption doesn't deserve the budget, infrastructure magnitude and human resource that ACC has.

In fact, while madam Rosemary was looking at the amount of money that government wastes corruption through in procurement, road construction and infrastructure building, we could not help but add the ACC to the list. The Anti-Corruption Commission wastes millions of taxpayers' investigating money cases that end up abandoned because their employers iťs involved!



Former deputy prime minister of Zimbabwe, Professor Arthur Mutambara, whose country is in an economic meltdown, has told a British audience that the mooted "ever closer African Union" was "despicable" and instead suggested that a "United States of Africa" would be more beneficial to Africans.

Speaking at the Oxford Union Debate Society, University of Oxford in the UK, Mutambara said: "I stand before you in unequivocal and vicious opposition to the proposition that says: "This House would embrace an ever closer African Union."

"For a start, we need the United States of Africa – a country – and not a union of sovereign states. We need to abolish national sovereignty and embrace continental sovereignty.

"We must pull our individual national sovereignties into one indivisible and all-inclusive Pan-African sovereignty. In order to leverage Africa's 1.2 billion people, massive natural resource base and potential \$2.3 trillion GDP we need to operate as one country and not a union of sovereign states."

Mutambara made his remarks amid mounting international criticism of Zimbabwe's government which used the amy to put down protests sparked by astronomical fuel hikes.

At least 12 people were killed in the violent and brutal clampdown that left many others injured.Doctors in that country said they treated 68 people for gunshot wounds.

More than 1 000 people have been arrested in the the aftermath of the protests, as the Zimbabwe government moves to silence critical voices.

one legislature and one Judiciary system. China, India and the US are doing just fine with one national leader (President or PM)," surmised Mutambara. "We surely do not need 55 Heads of State in Africa. As a minimum, we should have a federation of all the African states with devolved authority but driven by one strong and overarching central government where all sovereignty is reposed, as is the

case with the United States of America."

The robotics professor said even more appealing and effective was the possibility of transforming the entire continent into a unitary state as is the case with China and India. He said an ever closer AU will deliver neither the federated arrangement nor the unitary entity.

"You cannot expect the 55 African leaders to commit political suicide and legislate themselves out of existence. Each one of them wants to be a President or Prime Minister even it means presiding over starving and disempowered people," argued Mutambara, who was deputy prime minister of Zimbabwe's unity government from 2009 to 2013.

"President Cyril Ramaphosa is not prepared to be a State Governor or Minister of Agriculture of the United States of Africa. President Paul Kagame is not prepared to be a State Governor or a Minister of Home Affairs for the continent. Neither does President Yoweri Museveni want to be reduced to a State Governor or Minister of Transport," said the professor.

"They all want to be presidents of sovereign nations at the expense of the socio-political and economic advancement of ordinary Africans. An ever closer African Union will continue to accommodate these perverted and delusional ambitions of our African leaders.

"Under an ever closer AU, African leaders and governments pay lip service to continental economic integration and African unity.

Mutambara concluded by saying: "We must unshackle ourselves from paralysis by analysis. No guts, no glory. As Africans, we reject an ever closer AU and embrace the United States of Africa. Such a framework will enable us to advance our socio-political and economic aspirations across the continent dramatically". *African News Agency*

Screen time 'may harm toddlers'

Letting a toddler spend lots of time using screens may delay their development of skills such as language and sociability, according to a large Canadian study.

The research, which tracked nearly 2,500 two-year-olds, is the latest piece of evidence in the debate about how much screen time is safe for kids. In Canada and the US, experts

say children should not use screens before they are at least 18 months old.

But UK guidelines set no such limit.

The Royal College of Paediatrics and Child Health says there is not enough evidence, even when you include this new study, for a "direct toxic effect". Mums were surveyed (between 2011 and 2016) about screen use, and filled out questionnaires about their child's skills and development at ages two, three and five. Screen time included watching TV programmes, films or videos, gaming, and using a computer, tablet, phone or any other screen-based device.

At the age of two, the children were clocking up around 17 hours of screen time per week. This increased to around 25 hours a week by the age of three but dropped to around 11 hours a week at the age of five, when the children started primary school.

The findings, published in the JAMA Paediatrics, suggest increased viewing begins before any delay in development can be seen, rather than children with poor developmental performance then going on to have more screen time.

But it is not clear whether screen time - including how much or what type - is directly to blame. Screen use might just go handin-hand with other things linked to delayed development, such as upbringing and how a child's remaining leisure time is spent.

When young children are observing screens, they may be missing important opportunities to practise and master other important skills. In theory, it could get in the way of social interactions and may limit how much time



young children spend running, climbing and practising other physical skills - although they may still eventually catch up

Even without solid proof of harm, Dr Sheri Madigan and colleagues say it still makes sense to moderate children's screen time and make sure it doesn't interfere with "faceto-face interactions or family time".

They also said that, with hindsight, perhaps they should have followed the children from an even younger age because it is becoming increasingly common for 12-month-old babies to be watching and using screens.

The new study does not make any recommendation about how much is too much. Some of the two-year-olds were getting more than four hours a day or 28 hours a week of screen use, according to their mums.

The American Association of Paediatrics' (AAP) guidelines on screen time say:

For children younger than 18 months, avoid use of screen media other than videochatting

Parents of children 18 to 24 months of age who want to introduce digital media should choose high-quality programming, and watch it with their children to help them understand what they are seeing

For children ages two to five years, limit screen use to one hour per day of high-quality programmes. Again, parents should be watching it with their children.

For children ages six and older, place consistent limits, making sure screen time does not get in the way of sleep and physical activity.

The Canadian Paediatric Society goes further, saying screen time for children younger than two is not recommended. *BBC*

Facebook paid teenagers to mine device data

Facebook has been conducting research that gathers highly personal data from paid volunteers, a report has revealed. TechCrunch said participants - including those aged 13-

- including those aged 13-17 - have been paid up to \$20-a-month to open up their phone to deep analysis.

Facebook is said to have created an app that the report said could be in contradiction of Apple's policies. "Key facts about this market research program are being ignored," a spokeswoman said via email.

"Despite early reports, there was nothing 'secret' about this; it was literally called the Facebook Research App. It wasn't 'spying' as all of the people who signed up to participate went through a clear on-boarding process people who chose to participate in this market research program were teens. All of them with signed parental consent forms." When asked by the BBC how exactly the parental consent was obtained, Facebook said it was handled by a third-party and did not elaborate.

Apple has not yet commented on whether it felt Facebook

report explains Facebook had previously conducted market research using an app called Onavo, which it acquired in 2013.

But in August last year, Facebook removed the app from the App Store after Apple complained about the data it was collecting on users.



Neymar will miss both legs of Paris Saint-Germain's upcoming Champions League last-16 tie against Manchester United after the French club confirmed on Wednesday that the world's most expensive player would be out for 10 weeks with a metatarsal injury.

However, Neymar will not undergo an operation, with PSG saying the 26-year-old Brazilian had instead agreed on "a conservative treatment" that could see him return in time for the Champions League quarter-finals in April should they qualify.

"After detailed analysis by specialists, a consensus was reached of a conservative treatment of Neymar's injury to the fifth right metatarsal," the French champions said.

"Informed of this recommendation, Paris Saint-Germain's Brazilian international striker agreed with this protocol. As a result, Neymar is expected to return to the field within 10 weeks.'

Neymar suffered the injury in PSG's 2-0 French Cup win against Strasbourg last week, and his coach Thomas Tuchel had already all but ruled the 222-million-euro forward out of the first leg against United at Old Trafford on February 12.

The second leg of that tie is scheduled for March 6, and the timeline announced by the club means he could just make it back in time for a quarter-final first leg, due to be played on April 9 and 10. The second legs are set for the following week.

"Paris Saint-Germain sends its strongest support and encouragement to Neymar Jr. to overcome this injury, with the courage and determination that the player has always shown," the club added.

While Neymar will now sit out a crucial period in PSG's season, there has also been concern in Brazil, which will host the Copa America in June and July.

An operation would have put Neymar's participation in that tournament at risk, as well as effectively ending his club season. Brazil coach Tite and national team doctor Rodrigo Lasmar have been in Paris this week to visit Neymar, who suffered a fracture to the same right foot at the end of February last year. AFP

He told Goal Diggers in an interview


