PF's transport infrastructure upgrades will intensify regional trade links - Mwila

PF's transport infrastructure upgrades will intensify regional trade links - Mwila

By Zondiwe Mbewe Patriotic Front Secretary General Davies Mwila says infrastructure projects undertaken by the PF government such as the Kazungula Bridge have repositioned Zambia to a regional economic hub that will intensify existing trade links. Highlighting PF's achievements in their weekly newsletter to News Diggers! Mwila noted that the Seventh National Development Plan (7NDP) had identified "improving access to domestic, regional and international markets" as one of several development outcomes which needed to be achieved to bring about economic diversification. He observed that to improve access to domestic, regional and international markets, government had successfully implemented various programmes such as 'improved trade through facilitation transport infrastructure development programme with projects such as the completed soon-to-be Kazungula Bridge'. "In order to 'improve access to domestic, regional and international markets' as well as effectively implement the National Industrial and the National Trade Policies towards the attainment of Vision 2030, the PF government has successfully implemented various programmes and recorded notable successes. In line with the 7NDP, the PF government is improving facilitation by trade implementing the transport infrastructure development programme, with projects such as the soon-to-be Kazungula completed Bridge," Mwila explained. "The Kazungula Bridge is a key road and rail bridge crossing over the Zambezi River along the North-South Corridor, a key trade route linking the port of Durban and revitalizing the Tanzania-Zambia Railway Authority (TAZARA) with the aim of increasing operational efficiencies and reducing the cost of freight, among others. "Furthermore, the PF government is implementing the transport infrastructure development programme for improved trade facilitation by constructing Chipata-Petaukethe Serenje Railway Line, which when commissioned, will complete the link from the Port of Nacala to the existing railway lines across Zambia. In addition, the PF government has identified several strategic railway routes for development, some of which include the following: the Chingola to Jimbe (Border with Angola) route linking the existing line in Chingola through Solwezi to the border town of Jimbe," Mwila added. "The Kafue to Zawi (Zimbabwe) route will link Zambia Railway lines to Ziwa in Zimbabwe, as the shortest route to the Port of Beira in Mozambique; TAZARA Nseluka to Mpulungu Port to link Mpulungu Port to the TAZARA line at Nseluka to facilitate imports and exports from the Great Lakes region to the sea ports on the Indian Ocean; and lastly, a railway link between Zambia and Namibia (Livingstone to Sesheke), which involves the partial rehabilitation of the Mulobezi line as

well as feasibility studies for construction of a spur Livingstone between and Katima Mulilo via Kazungula that connects the Namibian Railway system as part of the Walvis Bay-Livingstone-Lusaka-Ndola-Lubumbashi Corridor." Mwila added that to further improve trade facilitation through transport infrastructure development, government was also upgrading strategic airports at Livingstone and Mfuwe as well as secondary

airports at Chipata and Kitwe, among others. He explained that by doing so, the PF government was increasingly enhancing the capacity of strategic and secondary airports to handle higher volumes of traffic; both passengers and cargo. Meanwhile, Mwila stated that government was also implementing the International Airport Upgrading and Construction Programme for improved trade facilitation. He stated that this would

significantly lower costs of doing business enhanced regional integration and trade and would increase Foreign Direct Investment (FDI) flows to Zambia. "The full implementation of the International Airport Upgrading and Construction Programme will improve trade facilitation due to the resultant: significantly lower costs of doing business enhanced regional integration and trade, and increased FDI flows to Zambia. In this regard,

the PF government is constructing the soon-to-be completed Kenneth Kaunda International Airport and the Copperbelt Airport. Collectively, these two international airports shall enable Zambia to strengthen its economic integration and competitiveness at domestic, regional and global levels. This shall in-turn lead to economic diversification, employment creation. and acceleration of the achievement of Vision 2030," stated Mwila.

Tantameni convicted me over the same drugs she is accused of stealing, woman tells court

A 42-year-old businesswoman has identified Lusaka-based Magistrate Maggie Tantameni as the person who sentenced her to two years' imprisonment for trafficking in the ephedrine that the latter is accused of stealing. Beatrice Saili, who resides in Lusaka West, further told the Court that her trial was conducted in a library at the Lusaka Magistrates' Court. This is the matter in which Magistrate Tantameni 18 jointly-charged with Felix Mkandawire, a court interpreter; Francis Mphanza, a senior public prosecutor and Didie Kangwa a senior clerk of court with three counts of abuse of authority, removal of property under lawful seizure and stealing by persons in public service. In count one, it is alleged that Tantameni and Mphanza on November 8, 2017, Lusaka, being persons employed in the public service as magistrate and senior public prosecutor respectively, jointly and whilst acting together, did use the position of their respective offices to obtain property, profit or benefit for themselves or another. In count two, it is alleged that Mkandawire, Mphanza and Kangwa on the same day, jointly and whilst acting together knowingly and with intent to hinder or defeat the process, did conceal 34.0 kilogrammes of ephedrine valued at K1,870,000. The ephedrine was taken under the process of authority of the court of Tantameni. And in the third count, it is alleged that the four between November 8, 2017, and December 30,

2017, in Lusaka, jointly and whilst acting together did steal 34.0 kilogrammes of ephedrine, property of Government of the Republic of Zambia, which came into their possession by virtue of their employment. And when the matter came up for continued trial before Magistrate Susan Mangalashi, Wednesday, Saili told the Court that she was in the business of buying clothes from South Africa for resale in Zambia. She further told the Court that she was convicted in 2017 for trafficking in nedrine, but was pardoned last vear Saili said before her arrest in 2017, she went to India where she ordered the said ephedrine. She said upon arriving at Kenneth Kaunda International Airport on November 2, 2017, with two bags containing 34 tins of ephedrine weighing 68Kg, she was apprehended by some Drug Enforcement Commission (DEC) officers. "DEC officers started searching me. They found the bags containing ephedrine. They apprehended me and got the bags and took me to their office. They got two phones, a passport and US \$300 from me," Saili narrated. She said she was taken to court five days later, but her matter was not heard because the records were not yet there. "On November 7, 2017, I was brought to Court three at the Magistrates' Court by DEC officers. The matter wasn't heard because I was told that the record was not yet here," she explained. Sailisaid the following day, she was taken to the library upstairs, which was a small room containing books. Shesaidoncethere, shewas asked whether the bags and their contents belonged to her, to which she admitted. Saili added that after the judge (Magistrate Tantameni) then read the charge for her, pleaded guilty and was sentenced she two years' imprisonment thereafter. to She said she was later taken to Lusaka female correctional facility, but was, however, pardoned a year later, on December 25, 2018. "After the judge (magistrate) had left [the om, the drugs remained there, However, when the court rose to identify the said library, the witness was unable to show the Court the room in which she was taken. She said that it was upstairs but did not remember where it was exactly. In cross examination, the witness who had earlier identified Magistrate Tantameni, the interpreter and prosecutor as the people who were present during her trial, said she only met the trio the very day she was sentenced. The defence, however, wondered why she had failed to identify the library when she was able to identify the accused persons. response, Saili said she could In fail to identify the people. not She further said when she went to buy the ephedrine in India, she went with the K1,870,000 cash in a suitcase and managed to pass through the airport without encountering any problems. "Yes. I carried it in a suitcase," said Saili. Trial continues.

UPND president Hakainde Hichilema has condemned violence in Lundazi and Sisheke districts, advising police to be impartial in executing their duties. And Hichilema has pledged to drill a borehole in Nchidwale ward in Katete District, whether or not UPND wins the ward in the upcoming by-election. Meanwhile, Hichilema on Wednesday asked some police officers who were trailing him whilst greeting some people in Nyimba if he needed a passport to visit Eastern Province. Speaking when he featured on a live radio program on Mphangwe FM in Katete district of Eastern Province, Wednesday, Hichilema said there was no reason for people to axe each other during elections. "Firstly, I want to say violence should not be allowed because when people start fighting, then there is lack of thinking. Violence is not good because this is a

peaceful country and so, we don't want violence. I strongly condemn this violence. What is happening in Mukombwa Ward in Lundazi and Sesheke district and even here in Katete is something which should not be accepted. Today here in Katete, if UPND youths did not behave, we were going to have violence today, here in Chindwale Ward because some known PF cadres almost attacked our youths. I want to appeal to the police to do their job and arrest those PF cadres who are spearheading violence because they are known. Imagine, UPND

have their campaign camp in Nchidwale in Chief Katumba where our candidate stays and the next thing we saw was the PF also coming to camp just near to ours. What is that? That is trying to start violence. When people start pushing and pulling each other in one direction to the other, then the people, including the police, will start reporting that the UPND is a violent party. The correct thing the PF should do is to leave our camp because there is enough place where, they can go and put up their camp. Why do they want to put their camp

on our place? PF is behaving like a party that do not want peace. If UPND was the one who did that, then we could say UPND are the ones who started the violence but now because it's the PF who followed us, the police are quite and can't arrest Hichilema anyone," said. Hichilema pledged And to drill a borehole for the people of Nchidwale ward, whether or not his party won the upcoming by-election. "The PF government has failed to put up a borehole in Nchidwale ward so that people in the area

can drink clean water. The people are drinking dirty water which animals drink also. One of our priorities, which is a small thing for me as HH, let me now tell you that, with or without winning that ward, I shall take at least one borehole to Nchindwale. With or without winning that ward, we shall put up a borehole so that people can have clean drinking water," Hichilema promised. "This is what we are going to do like we wanted to do in Lusinde ward where the PF, upon hearing that HH will put up the borehole, they blocked us. They sent police office so that they should stop us to

provide clean water to the people of Lusinde ward. We want to act even before we are in government. People of Nchindwale listen, you cannot be drinking water where animals drink from. Me HH, I am donating one borehole. I will dig alone using my own machine and put up my own pump to show you just an example of what is waiting for you under the UPND government." Hichilema said the agriculture sector had collapsed due to PF's failure to think. "UPND wants to form government so that it brings development and improve the agriculture sector

which has collapsed in this country. We shall ensure that every farmer is well taken care of. We want to create jobs through agriculture. PF have failed in this sector. Schools have collapsed and orphans cannot afford to find K1,600 for school fees. As UPND, we shall take every poor child to school and people always ask me that, 'now HH where will the money come from?' We shall do away with the corruption that this government is enjoying. We shall exploit the mines here in Eastern Province and we shall give the license to the locals. I know this place has diamond and I am wondering why this government is failing to exploit it and generate money for our children to go to School. As UPND, we shall do that because we know what we are saying," Hichilema said. Meanwhile, Hichilema on Wednesday asked some police officers who were trailing him whilst greeting some people in Nyimba if he needed a passport to visit Eastern Province. Three uniformed police officers asked Hichilema's security for details of the gathering but the UPND leader approached them and asked them if he needed to have a passport for him to visit Eastern Province. "What is the problem officer? I am just greeting these people and so stop harassing these people. You want me to be obtaining a passport for me to visit this area? Please don't harass these people because I have heard that you officers do harass them," Hichilema told the officers.

ACC is toothless - NDC youths

NDC national youth chairman Charles Kabwita says it is not surprising that people have stopped reporting cases of corruption to the Anti-Corruption Commission (ACC) because the institution has become moribund under PF. In a statement, Thursday, Kabwita noted that the Anti-Corruption Commission had failed to execute its mandate diligently as provided for by the law because of political interference. "Youth in the Natinal Democratic Congress have received the concerns raised by the Anti-Corruption Commission, that citizens have stopped lodging complaints of corruption, with a sense of disappointment and worry. They say that even though it is very worrisome, it is expected because people know that reporting corruption in this current regime amounts to nothing as corrupt officers are protected by the State. The NDC is on record to have lodged a complaint against ministers concerning corruption and up to now nothing has come up. The complaint was lodged over a year ago, against Ministers

from Luapula namely; Nixon Chilanwga, Ronald Chitotela, [then] Emerine Kabanshi and Dr Chitalu Chilufya at the Anti-Corruption Commission office in Kitwe. In a country where corruption is at its peak, we expected the Commission to be swift and vigilant, but due to selective application of investigation by the Commission, this has led to citizens' loss of confidence and credibility in the institution," Kabwita stated. Kabwita regretted that the ACC under the PF administration had become compromised due to influence from politicians hidden agendas. with "The Commission, under the Patriotic Front government, has

become toothless and a laughing stock. During the late President Levy Patrick Mwanawasa S.C, corrupt men and women were brought to book and the law took its course regardless of one's political affiliation. But that is not the case in this PF government. The Commission is failing to execute its required mandate diligently as provided for by an act of Parliament due to political interference by those in power. So how can people continue to report when the cases will not go anywhere," stated Kabwita. "We, therefore, appeal to the powers that be, to disconnect themselves and allow the Commission to conduct its work professionally and independently.

By Mirriam Chabala Former Secretary to the Cabinet Dr Sketchley Sacika has observed that the constituency based system of holding Parliamentary elections is less democratic, unrepresentative of political opinion and too expensive to run. And Dr Sacika has called for the abolishment of the Constituency Development Fund (CDF) because it was initially meant to be a bribe to members of parliament and it has been highly politicized. In an interview, Dr Sacika noted that the system of holding by-elections whenever there is a vacancy in Parliament is an unnecessary drain on the country's meagre resources. Dr Sacika said Zambia needed to do away with certain systems that were initiated during the British colonial rule and adopt something more democratic and financially viable. "Our system of electing members of parliament is too expensive for nothing. Holding by-elections whenever there is a vacancy in Parliament is an unnecessary drain on the meagre resources available to the State. Zambia must grow and do away with certain systems that were given to us by the British. The constituency based Parliamentary system is not only too expensive to run but it is also less democratic and unrepresentative of a political opinion in Parliament," Dr Sacika said. "Imagine a member of parliament who is elected from a constituency with only 20 per cent of the votes cast, how can such a person claim to represent a constituency where 80 per cent of the constituency did not vote for him? My very strong appeal is that we must move away from the constituency based system of electing members of parliament and adopt a system of proportional representation, which has proved to be more democratic, successful and less expensive to run in countries where the system is in operation." Dr Sacika said the proportional representation system of electing members of parliament could do well for Zambia because it's less costly. "Under this system, there will be no need for Parliamentary byelections because the filling of

by nomination. Moreover, small political parties under the system of proportional representation will be able to send people to Parliament if they reach a certain threshold of political support in the country and this will enhance our democracy. Zambians should not be spending huge sums of money, like we are doing right now on a system of electing members of parliament which is very expensive. If Zambia adopted a system of proportional representation, we would cut

expenditure on elections by more than 50% and that money could go to maintaining our education and health sectors. Why are we spending K2 billion to run one parliamentary by-election? It's not making sense at all," Dr Sacika said. "So my appeal is that let us move away from the present system, let us embrace a system which is less expensive to run. The British gave us this system we are using now, but it is not the best system at all. Let us try the

other system which the German's and other people have using and let's see how it works for us." And Dr Sacika called for the abolishment of CDF. "In the ongoing Parliamentary by-elections in Sesheke, candidates are promising all sorts of things as a way of wooing the voters to vote for them. But all their promises are lies that will never be implemented, and unfortunately, even ministers have joined the queue of making promises they know they cannot fulfill. It is time we put an end to this issue by changing the system of electing our members of parliament. Politics is not about telling lies and Zambians must know this, the politicians must tell the truth. If we reduce politics to telling lies then we are finished as a people. The job description for members of parliament is clearly stated in the constitution. Members of parliament are law makers and not supervisors of local projects in their constituencies," said Dr Sacika.

"The role of seeing to it that the roads are paved, boreholes are sunk and social amenities are provided in constituencies belongs to local councils where the voters are represented by local councilors. But what is the role of ward councilors if members of parliament are the ones attending to local projects in constituencies? The Constituency Development Fund (CDF) was meant to be a bribe to members of parliament and the fund has not worked well because it has been highly politicized. The Constituency Development Fund should therefore be abolished, instead the central government should increase its statutory grant to district councils for their development projects."

It's difficult for opposition MPs to work amidst police intimidation, says Muchima

MPs to develop their various constituencies because the PF used the police to harass them. On Monday, Housing and Development Infrastructure Minister Ronald Chitotela told the Zambia Daily Mail that opposition MPs had crafted a plov of deliberately not developing their constituencies using CDF so that the electorate can shift the blame on government underdevelopment. for But Muchima told News Diggers! in an interview that developing the country was the duty of government, Treasury. through the "Who is in charge of taking development to a constituency? Is it not the responsibility of the government? It is the government that has got the Treasury, development is associated with the Treasury. What they are doing is all the monies to the Treasury, they have kept it to themselves. They want people to start begging and yet the taxes come from everywhere, especially like in North-Western (Province), we

are the most contributors to the Treasury. Now, this PF does not even understand democracy. Democracy is taking into account different views, the opposition and the ruling, they should take a leaf from the administration of late president Mwanawasa. He never looked at a place [to say] 'no they didn't vote for me, they should vote for me,' but they are looking at that and using it to blindfold people that 'we can only take money to an area [where] unless you voted for them," Muchima said. "What development can I even take [to my constituency] if they have kept the money to themselves? I have been a minister in MMD and were giving CDF without begging. This CDF here is through begging and you heard that we have been threatening them, even with other PF MPs and ourselves, that we will not pass the budget [and] that is why they released it. It is not even flowing like the way it used to flow in MMD. [Since] PF election, how many times have they released CDF? One thing they should be reminded is that it's not their money, they are supposed to distribute it



equally. They are selfish people!" Muchima said government expected opposition members of parliament to be begging for resources. "They want us to be begging for things, which are obvious, we can't

beg for things, which are from the Treasury, that is not governance. I think even developed countries are even laughing at them, that is why this government is broke because of poor policies, poor governance issues. Otherwise,

they are behaving as if we are in the stone age. And then if that is the case, why can't they only be collecting taxes from the areas where they were voted for? Because that is theft, they are stealing money from us, that money from North-Western is supposed to be in North-Western if that is the case. That is unacceptable! Any useful leader is not supposed to look at which is what. A good leader is supposed to spread tentacles from all areas of the country. But if you want to only concentrate from your constituency, then ask for a vote from your constituency. It's very unfortunate the way PF has taken issues in this country," he said. Muchima said it was hard to deliver, as an opposition member of parliament, amidst police intimidation. "And even for us MPs to go to our constituencies, they are using the police to arrest us! All that is barbaric, it is unacceptable, it is the leadership that is rotten, completely rotten leadership that can be using the police who are spending tax payers' money to be intimidating everyone. That is not how democracy is, they should learn from other countries, just because of the primitivity that has surrounded the PF, that is the way they are applying law only to their satisfaction. But I am telling you they will have a rude shock in 2021," said Muchima.

Zambia has recorded a marginal increase in its copper production for 2018 to around 861,946 metric tonnes from 799,329 tonnes recorded in 2017, boosted by First Quantum Minerals' (FQM) operations in Kalumbila District. But last year's increased copper output still means that Zambia remains Africa's second biggest producer of the red metal, with the Democratic Republic of Congo (DRC) expected to hit over 1.2 million metric tonnes. According to official Ministry of Mines data, Zambia's total copper production last year marginally rose to an estimated 861,946 tonnes from 799,329 tonnes recorded in 2017. The total copper production included all of the country's 10 large scale mining operations as well as small-scale mining operations, which accounted for at least

10,859 metric tonnes from the total tonnage. Data reveals that although FQM's KansanshiMining Plc recorded a marginal drop of 249,532 tonnes last year from 250,803 tonnes in 2017, its output in 2018 was the highest among all 10 mining companies in the country for a third successive year. Additionally, Ministry of Mines Permanent Secretary Paul Chanda explained that FQM's Sentinel Copper Mine in Kalumbila District produced record output of 223,655 metric tonnes, which helped contribute to Zambia's overall copper production increase. "The performance of the sector was better in 2018 relative to 2017. The increase in copper production is attributed to: i. The ramp up in production at Kalumbila; ii. Improved plant availability and utilization at the Tailings Leach Plant at KCM coupled with higher grades; iii. Commissioning of the Synclinorium Shaft at Mopani in Kitwe has increased volume of ore being hoisted," Chanda explained in a statement released, Wednesday. Both Kansanshi and the Sentinel's copper output last year constitute for 473,187 tonnes out of the country's total production or nearly 55 per cent from just two operations. And 6 other mining companies equally recorded upward copper production output last vear. These included: Mopani Copper Mines, whose output hit 62,191 metric tonnes from 44,860 tonnes in 2017; Konkola Copper Mines (KCM), whose output rose to 93,165 tonnes last year from 84,436 tonnes in 2017; Chibuluma Mines, who recorded 11,258 tonnes in 2018 from 10,194 tonnes in 2017; CNMC Luanshya, whose output increased to 50,363 tonnes last year from 43,206 tonnes in 2017 and Sino Metals, who recorded 9,312 tonnes from 7,100 tonnes, while Lubambe's copper production hit 22,074 tonnes from 18,037 tonnes during the period under review respectively. On the other hand, Barrick Gold's Lumwana Copper Mine saw its output fall to 101,890 tonnes last year from 116,170 tonnes in 2017, while NFCA recorded 27,644 tonnes down from 27,706 tonnes during the period under review respectively. But Zambia's increased 2018 copper production still means that the country remains Africa's second biggest producer of the red metal, with the DRC expected to hit over 1.2 million metric tonnes. The DRC first managed to surpass Zambia as the continent's biggest copper producer after that country managed to produce over 900,000 metric tonnes of copper in 2013, registering a sharp rise and surpassing Zambia's 754,916 tonnes produced that year.

Siblings sue Trymore Mwenda for fraud

Two siblings have dragged Southern Province PF publicity secretary Trymore Mwenda to court for allegedly selling his newly-built house to someone else despite collecting a down payment of over K300,000 from them. Dickson Kapuka, who is currently residing in Australia and Marcia Kapuka, are seeking a declaration that the oral contract entered between the parties is void, as well as, a sum of K320,000 which they allegedly paid to Mwenda. In a statement of claim filed in the Lusaka High Court, Tuesday, the plaintiffs stated that Dickson wanted to purchase a house in Lusaka and he discussed his desire with his sister. "Dickson was desirous of purchasing a house in Lusaka. In view of this, he did discuss this desire with his sister, Marcia. Due to the fact that Dickson does not reside in Zambia, he asked his sister to look out for viable property on the market for him to purchase," read the statement. The plaintiffs further stated that Marcia came across an advert on Facebook of a three-bedroomed newly-built house for sale, with an

asking purchase price of K850,000. The duo stated that on inquiries made by Marcia, it was discovered that the owner was Trymore Mwenda. They stated that they entered into an oral agreement for the purchase of the house and it was agreed that in order for the title deeds to be changed into Dickson's names, Mwenda required a sum of K800,000. The plaintiffs stated that as a starting point, Dickson, through his sister in June last year, deposited some monies in the sum of K128,000 into Mwenda's bank account, while the other monies were given in cash. They stated that between June, 2018, and August, 2018, Mwenda received a total sum of K320,000 from them under an oral contract for the purchase of the house. The duo disclosed that in August last year, Marcia discovered through Facebook that Mwenda had continued to advertise the same house for sale despite Dickson already paying monies for its purchase. "Marcia immediately alerted the person advertising to take down the advert considering that Dickson had already paid monies for its purchase," read the statement of claim.

They lamented that despite their requests, the adverts were not removed, which led to them questioning Mwenda's honesty and the authenticity of their agreement. The plaintiffs stated that these doubts led them to write to Mwenda on August 18, last year, to terminate the transaction and requesting him to return the K320,000 that they had paid him. They added that they had now discovered that Mwenda had sometime in September, 2018, sold the property to someone else shortly after being advised that they would not be purchasing the property. The duo stated that they had still not received the K320,000 to-date. "The plaintiffs have given the defendant ample opportunity to resolve this matter and pay back the K320,000, but the defendant has refused or been negligent in resolving the matter and paying back the sum," read the statement of claim. They are now seeking a declaration that the oral contract entered into between the parties is void for non-compliance with the statute of frauds, the sum of K320,000 paid to Mwenda, damages for loss of use of funds, interest, costs and any other relief.

UPND govt will implement rural development policy to reduce poverty, says Mucheleka

Bv Zondiwe Mbewe UPND deputy secretary general for politics Patrick Mucheleka savs once in government, the UPND will implement a rural development policy to combat rural-poverty in Zambia. And Mucheleka says the UPND government will give defined incentives for those who may wish to invest in rural areas in order to enhance the rural economy. In UPND's weekly newsletter to News Diggers! Mucheleka

stated that the party was aware that poverty in Zambia remained a profound challenge. "In Zambia, poverty is more pronounced in the rural parts of the country. Poverty in Zambia, especially in rural areas, has the face of women and the youths who are the most afflicted, compared to men despite both living in poverty. Poverty in Zambia is, therefore, a rural phenomenon. According to the Central Statistics Office Zambia in

Figures Report published in July, 2018, the incidence of poverty was more pronounced in rural areas where 76.6 per cent of the population is classified as poor compared to 23.4 per cent of urban poverty," Mucheleka narrated. He observed that rural areas in Zambia had lagged behind in terms of development, mainly due to institutional and structural failures and lack of a rural development policy. "This situation calls for

serious reflection by all concerned stakeholders. We must all agree that successive governments have lamentably failed to implement meaningful policies, practical programmes and strategies in the sectors, which are propoor and rural-based. Any previous interventions in the rural sector have not had a very positive impact in as far as rural poverty reduction is concerned. Rural poverty levels still continue to be stubbornly high," Mucheleka observed. He explained that UPND would demonstrate political will towards the formulation and implementation rural development of policies whose objective would be to significantly reduce rural poverty. "A UPND alternative policy approach to combating rural poverty needs to be put in place in order to help lift out of poverty the majority of our people in the rural sector. The objective of the policy will be to positively transform the livelihoods of the rural people and reduce poverty significantly. The UPND in government will, therefore, turn round things by specifically designing

and implementing specific rural development policy," he explained. "Zambia in the safe hands of the UPND will bounce back and use implementing tools, such as the manifesto, clearly aligned development plans supported by welldefined strategies, robust monitoring and evaluation tools underpinned by our party's mission to 'accelerate national development through prudent use and management of resources for the well-being of all citizens,' including those in the rural areas of Zambia." He stated that the UPND government would demonstrate practical will to address the plight of the rural population who still continued to wallow in abject poverty. Mucheleka added that rural poverty reduction meaningfully would take place once the rural development policies were formulated and implemented. "Rural development and poverty reduction policy implementation will be supported by increased budget allocation and timely disbursement of financial resources. Policy implementation will be backed

by strengthened institutional and structural capacity at all levels, including the wards and districts. This would also need to be backed by the implementation of the national decentralization policy, which apparently, was adopted in 2002 by the late president Mwanawasa's MMD but was never implemented due to lack of political will," he stated. And Mucheleka stated that the UPND government would give defined incentives for those who would wish to invest in the rural areas with a view of enhancing the rural economy. "A UPND clearly defined rural development policy will create conditions and investment necessary for creating alternative livelihood opportunities for not only the rural people, but also other players, including the private sector who will wish to invest in rural areas. The UPND in government will certainly give defined incentives for those who will wish to invest in the rural areas with a view of enhancing the rural economy. The transfer of terms of trade to the rural sector will eventually uplift the livelihoods of the rural people," stated Mucheleka.

Inflation remains at 7.9%

The annual rate of inflation has remained at 7.9 per cent for January, 2019, with food and nonalcoholic beverages accounting for 4.3 per cent, according to Central Statistical Office (CSO) data. Announcing Zambia's annual rate of inflation for the month of January, CSO acting director of census and statistics Daniel Daka said food items and non-alcoholic beverages accounted for 4.3 per cent, while non-food items accounted for 3.6 per cent. Daka noted that there was, however, a sharp increase in transportation in terms of the year-on-year comparison between January, 2018, and January, 2019. "The year-on-year inflation rate as measured by the all items Consumer

Price Index (CPI) for January, 2019, was recorded at 7.9 per cent. This means that This means that on average, prices of goods and services increased by 7.9 per cent between January, 2018, and January, 2019," Daka told journalists in Lusaka, Thursday. "Of the total 7.9 per cent annual inflation rate recorded in January, 2019, food and non-alcoholic beverages accounted for 4.3 percentage points, while non-food items accounted for a total of 3.6 percentage points. Of the 3.6 percentage points, transport contributed the highest at 1.1 percentage point followed by housing, water, electricity, gas and other fuels that contributed 0.8. Health; communication and; restaurant and hotels accounted for the least at 0.0 percentage points each."

Empowerment for ALL!

By Andyford Mayele Banda From the Sunday of 10th January 2016 at Hotel Intercontinental Lusaka where the People's Alliance for Change (PAC) was launched and the subsequent interviews we have had ever since to this day on various forums, the words empowerment and employment do not depart from our mouths. Our purpose and mission is beyond just ascending to the helm of the ladder of power. We endeavor to demonstrate that selfless and dedicated leadership can achieve a lot not just for our generation but also for generations to come. There should be one persistent question that should always beg an answer from all those seeking leadership; and that question is, "How can I contribute to the transformation of people's lives especially the most disadvantaged in my community or country?"

We have seen people sweating during elections campaigning for any of the strong political parties not because they believe in the ideologies of that party but because they want to monopolize contracts once their preferred candidate or party wins elections. This is so because there is no system that fairly allocates opportunities from the government to the people of Zambia. Once this is sorted, our politics will change because no one individual will be able to take advantage of the system and in the end they will start supporting a political party based on the ideologies not based on what is in it for them.

Owing to the lack of systems or a will to empower our own, we have seen simple projects such as building of a school being contracted to foreignbased companies when we have skills that can deliver once they are structured as per the new CEEC under PAC. Our bricklayers have built mansions in Chalala, Silverest, New Kasama, Lilavi and yet cannot be entrusted to build a simple block of class rooms. Our carpenters have made various sophisticated home and office furniture and yet cannot be entrusted to make simple desks for a school for pupils to sit on. Our welders, or fabricators- as they like to refer to themselves, have fabricated complicated metal sculptures and yet cannot be trusted to make traces and roof a simple school. Our people are suffering while working for foreigners and making blocks and yet have not been entrusted or empowered to make blocks for our schools.

article, a Joint Citizen Company or abbreviated as JCC, is an organisation where citizens with various skill-sets and diverse professional backgrounds come together to form a company to pursue a particular opportunity and effectively run a business. It is an organisation that is exclusively run by its shareholders. This means that all employees/workers of a JCC are the owners. The idea behind a JCC is to come up with a structured organisation that will have different skills necessarily to run a business and also to deliver goods and services in the same manner as any other company.

As we go, we shall keep reminding our followers the key role of a restructured CEEC under PAC. Under the PAC government as already alluded to in earlier discourses, the new CEEC will focus more on ensuring that businesses grow through:

1. Structuring of start-ups and restructuring of existing SMEs wanting loans.

2. Providing basic business administration training tailored to the needs of various sectors.

3. Creating opportunities through various partners from government and private sector.

4. Facilitating financing opportunities for the opportunities created from partner banks and financial institutions.

5. Monitoring of businesses under CEEC. "

In this example, we are talking about empowering a group of people to be contracted to build schools for the government. Hence the CEEC will structure the JCCs and ensure that needed skills are placed on those structures such as accountants, human resource, welders, bricklayers, project managers, store men, plumbers, carpenters, electricians, architects etc. Through a competitive process and as per the CEEC's mandate to structure ICCs, it will ensure that deserving individuals are selected to run the businesses with various skill-sets and various experiences. Training will be conducted by CEEC to provide rules of engagement, targets and basic business administration skills to everyone. The CEEC will be a broker for opportunities between the JCCs and the government. The CEEC will also facilitate necessary financing and support accessed from various partners including banks. Once everything is set up, the CEEC will keep monitoring to ensure the business is running as per set standards.

As PAC, our firm belief as already alluded to in our earlier article titled 'Zambia needs an ENTREPRENEURIAL GOVERNMENT', a government led by people with diverse ideas working in unison is what the country needs. This is in contrast to the current style of fire-fighting leadership that is void of planning and implementation. PAC is poised to deliver unprecedented results through the introduction of an ENTREPRENEURIAL GOVERNMENT driven by a fresh crop of new generation politicians. We believe this can only be achieved through an entrepreneurial ecosystem that has a solid support base supported by current thinking, policy and goodwill.

We have emphasized time and again that all nonspecial skill government contracts will be exclusively shared among numerous Zambians. The idea behind this is to ensure money circulates within and among our people.

Theft of Social Cash Transfer report ready, says Mvunga

Deputy Secretary to the Cabinet in charge of finance and economic affairs Christopher Mvunga has revealed that the forensic report on the alleged abuse of the Social Cash Transfer by the Ministry of Community Development has been finalized. And State House Spokesperson Amos Chanda says those who are still waiting for the national dialogue process to take place from a "cozy room" in some expensive tower must know that the process is currently ongoing and all citizens are being engaged. Speaking to journalists at State House, Thursday, Mvunga disclosed that the forensic report on the administrative inquiry had been submitted to Cabinet Office and Secretary to the Treasury, and that the two offices were in the process of studying it to fully understand its contents. Mvunga said stakeholders, who

had been funding the Social Cash Transfer scheme, would be engaged later on after the report is studied to discuss the way forward. "I think we've been inundated with queries around what's happening around the forensic audit for the Social Cash Transfer on Zampost and Ministry of Community Development. Where we are, currently, is that the forensic report has been finalized; it was submitted to Cabinet Office and Secretary to the Treasury on 29th of January. We are now in the process of studying that report so that we fully understand what the implications are. After we finish studying that report, as vou are aware, we have got cooperating partners who are key stakeholders in this whole process of funding this whole Social Cash Transfer," Mvunga explained.

"So, we will be arranging a meting with cooperating partners in mid-February to avail them the report, we will go through the report with them, hand over the report to them and then discuss with them the way forward with regards to continuing running the programme. So, that's where we are at the moment. The report has been concluded, so there is no more speculation that there is further work happening." And Chanda said people should no longer wait for a dialogue process to take place at some expensive boardroom because the process was currently ongoing. "The President met senior citizens, led by senior citizen Sikota Wina. They came to have an open conversation with him,

particularly on key national themes of the economy, the need for unity of the country, the mining sector processes and particularly the new mining tax regime. They are in full support of government's bold steps to reform the mine tax systems and they are urging the President to ensure that the Zambian people benefit from the mining sector, using the expertise of Mr Francis Kaunda, one of the best and brightest in that area. He outlined the difficulties that the mining sector has faced, precolonial, colonial period, up to now and he has offered himself to government from the President down to give some insights about how the tax reform can move forward, how Zambia can maximise its benefits from the mining sector," Chanda narrated. "Mr Sikota Wina insisted that no one has the right to undermine national coercion and politics can be practised within the civil bounds of dictates of a democracy. So, he's encouraging the President and thanking him for the efforts he has undertaken since he assumed Office of the President to run the country; he has called for stability across the board. In short, Mr Sikota is calling for continuous dialogue between and among political players. Intra-party dialogue and inter-party dialogue and the focus for him is patriotism. He says the tribalism that nearly destroyed the country during their time must not be allowed to come and

undermine national cohesion." Meanwhile, Chanda insisted that the national dialogue process was currently ongoing. 'The President made a response that this is the kind of dialogue he wants. When you talk about national dialogue, they don't see it in the specks of opposition party X. The national dialogue cascades across all trade unions, student movements, senior citizens like them. So, the President continues with national dialogue. So, if you are waiting for national dialogue on a high board store, in high court towers, you must know that dialogue is taking place. We are talking to students, we are talking to citizens, this is the type of national dialogue across the board," insisted Chanda

Chambishi man gets 10yrs for punching wife to death

Musonda Chongo was charged with Manslaughter Contrary the laws of Zambia. to Allegations were that on June 14,2018 in Chambishi District, Chongo unlawfully caused the death of his wife, Yvone Kampamba, by punching her on the forehead, following a domestic dispute, thereby leading her to her death. Appearing for plea before judge Timothy Katanekwa, the accused person pleaded guilty to the offence of Manslaughter.

Judge Katanekwa said in sentencing him that the accused person was supposed to be the wife's protector and was expected to show love to her and not beating her. The judge said it was unfortunate that GBV cases were still on rise, adding that there was need to impose sentences that would deter would be offenders. He Katanekwa said upon the the accused person's own admission of the offence and facts being true and correct he had found him guilty of the offence and was convicting him accordingly. In mitigation, the accused person begged for the courts leniency, saying he had learnt his lesson. But the judge went ahead to mete out a 10-year sentence.

I can let someone else be running mate - GBM

UPND vice-president Geoffrey Bwalya Mwamba (GBM) says he is ready to let someone else from the Opposition Alliance become running mate as long as that person helps the alliance win the 2021 general election. And GBM says the Opposition Alliance will formally reach out to Democratic Party (DP) president Harry Kalaba with an invitation to join the pact. GBM said this in an interview when he was asked if he would be okay with someone else standing as UPND leader Hakainde Hichilema's running mate in 2021. My dear, let me tell you, with time, if that is the situation that would prevail at that particular time, we'll do that, as long as that person will be able to see us win and form government so that we oust these criminals, these PF criminals. I am ready to support," GBM said. "I wouldn't like to spend more time talking about the alliance, but what I can tell you is that the friendship that we are enjoying with other political parties is very solid and it will be a waste of time to comment on something that I think is water under the bridge, and we have moved on I think, that issue has already been buried." And GBM said the Opposition Alliance would reach out to Kalaba and formally invite him to join the alliance. "As far as I am concerned as GBM, in my personal view, I think

that's the right decision that Hon Kalaba has made (not to challenge his expulsion from PF), so that he can concentrate on mobilizing his party, we wish him all the best. With our alliance partners, we will reach out to him because we want to bring more opposition political parties on board because we mean well; we are not trying to be selfish as some people have accused us that UPND is selfish. We are convinced as opposition political parties that we have to unite in order to fight the ills of the PF and ensure that we secure space for ourselves to conduct our political activities freely, ensure that the playing field for elections is levelled, that the law such as the Public Order Act is applied fairly and that human rights are respected in our country," GBM explained. He said only the opposition could rescue Zambians extreme from poverty. "The high levels of poverty, which the PF led government itself does not seem to have an answer to. the Zambian people should only have hope in the UPND; we are the only saviour and we shall be the only saviour for this country because we are men of integrity, majority of us in the UPND are men and women of integrity. We will not go into government and start to milk money that belongs to Zambians. Look at how Zambians are suffering, has Edgar come up with any solution?

Has he disclosed any game plan that 'countrymen and women, sooner than later we'll come out of these economic problems?' He has never done that because he is a 'Chimbwi no plan!" GBM said. "The entire government I will tell you, they do not even know whether they are going backwards or forward, they don't know! They don't even understand what governance is. Now some of us tend to agree with what Edgar himself said that he has no vision and it's true, it has come to pass and people have come to realise that what he said

was true. He was only forced by a few selfish men and women who were at that time who said: 'no boss, just go for it' because they wanted to use him to amass wealth, which they have done, but I hope they will enjoy it. Because people are suffering and they are complaining and when people are complaining, you won't have the blessings of the Almighty." GBM, the former Kasama Central PF member of parliament and defence minister, also said the Zambia Centre for Inter Party Dialogue (ZCID) needed to be abolished. "I think the dialogue process will succeed because the Church has the full backing of the alliance. And let me tell you, ZCID does not mean well to the Zambian people. ZCID is here to bring confusion or even to prolong the dialogue process. So, I think Zambians should not trust ZCID whatsoever! The Church has succeeded in bringing unity in the country on so many occasions, the Church has actually singlehandedly managed to deal with similar processes in facilitating dialogue and reconciliation without the involvement of ZCID, how then can ZCID say the Church cannot succeed in bringing unity in this country? ZCID, I will tell you, is up to no good. If I had a way, as GBM, I would do away with ZCID. In fact, I would not even want ZCID to even interfere in what the Church is doing. My dear young man, when you have a problem in a home, where do you run to? I run to the Church, now if somebody can say that the Church is not the right place, is not the right 'Shibukombe' then what kind of thinking is that? That's foolish and stupid!" said GBM.

Copperbelt has been experiencing heavy rains in the past five days, leaving a trail of destruction. NdolaDistrictCommissionerGeorgeChisulo said 57 other houses are badly damaged. Chisulo who visited the affected families yesterday said quick action has been taken by government to help mitigate the crisis. "It is sad that 57 houses of kafubu ward in

masala that have been greatly affected by the heavy rains. However, let me say that though bad the situation, it is known to government and quick action was underway. So fifteen small houses were swept away due to the heavy rains," Chisulo said. He has since assured the residents of Masala that government would look into the matter soon. Kazembe has asked government to

work on the stream as soon as possible in order for the problem to be solved. Meanwhile, seven houses in Luanshya have collapsed due to heavy rains. Luanshya Mayor Nathan Chanda who visited the affected families described the situation as a disaster. "This is a disaster and as your Mayor and Servant I will do my best to see that you our people are helped. So I will help with cement, and bricks so that we help you come up with temporary shelter. This is a disaster! Its a serious disaster. Our people need help," said Chanda.

Lusaka Province Minister Lusambo Bowman says he will pay the fine slapped on former Football Association of Zambia (FAZ) president Kalusha Bwalya, who was found guilty by FIFA of accepting a bribe. This, he says, he will do because he is a devoted soccer fan and he wants the celebrated football legend to get over the trouble and focus on the game.

To be clear to those who have not followed this matter, Mr Kalusha was found guilty of receiving about US \$80,000 bribe from an Asian businessman who wanted to be voted FIFA president. As punishment, the Zambian soccer icon was ordered to pay about US \$100, 000 and was further handed a restraining order from all football activities. Upon hearing his appeal, FIFA has upheld the conviction, but reduced the ban from about two years to nine months, and also reduced the fine to about US\$10,000.

This is what has excited Honourable Lusambo to the extent that he is willing to part away with K120 million (old currency) just to demonstrate his happiness - even when he knows that Great Kalu is expected to have, several times, more money than him.

"To demonstrate my happiness, I pledge to pay the 10,000 Swiss Franc (K120,000) fine that the FIFA Appeals Committee has imposed on Kalusha. The gesture does not in any way seek to cast aspersions on Kalusha's ability to pay the fine, but it is a small attempt at thanking Kalusha for the many





Social media companies should have a legal "duty of care" to children, the UK Parliament's Science and Technology Committee has recommended. The group's report said social media had helped facilitate bullying and online grooming of children.

It called for a regulator to be established to take "enforcement action" if apps broke the law.

A number of privacy and data scandals have led to calls for social media companies to be regulated.

Facebook's new vice-president Sir Nick Clegg has already pledged to do "whatever it takes" to make the company's platforms safer for young people.

Sir Nick was responding to the case of 14-year-old Molly Russell, who took her own life after viewing distressing selfharm images on Instagram in 2017.

Her father said he believed Facebook-owned Instagram was partly responsible for his daughter's death.

The committee has been looking at the effect of social media and so-called screen time on the health of children. During its inquiry, it surveyed more than 3,000 young people. It said social media had positive attributes, but also led to:

- damaged sleep patterns
- body image issues
- bullying
- online grooming
- sexting

Regulate social media to protect children, UK MPs urge



making sure rules and policies are consistent across video-sharing sites, social networks and search engines a new partnership between the government, tech companies and law enforcement to tackle child exploitation online Despite the Cambridge Analytica data scandal, in which a university researcher gave the Facebook data of millions of people to a political consultancy, the report

also said social networks should share more data with researchers.

It argued that this could help websites identify those at risk and improve safety measures. The government is expected to publish a White Paper about online harms in the coming months, and the committee urged it to use this as an opportunity to act. The Royal Society for Public Health (RSPH) said it "welcomed" the report. Its director of external affairs, Duncan Stephenson, gave evidence to the committee.

He said in a statement: "We fully support the select committee calls to help researchers and others to better understand the long-term effects.... to our wellbeing."

On Wednesday, England's Children's Commissioner, Anne Longfield, published her own open letter calling on social media firms to take more responsibility for protecting children from disturbing content.

She urged them to back a legal duty of care obligation, and finance a digital ombudsman to act as an independent party between young people and the tech giants.

Andy Burrows, from the children's charity NSPCC, said in a statement: "For far too long social networks have been allowed to operate in a Wild West environment and put children at unacceptable risk.

"The government now has a crucial opportunity to set out a comprehensive plan to protect children online.

"This must include an independent statutory regulator with enforcement powers, that can impose strong sanctions on platforms that fail to keep children safe." **BBC**

'Cocktail' approach offers early hope for new male contraceptive

The report, titled Impact of Social Media and Screen-Use on Young People's Health, was released on Thursday.

It was produced by a cross-party group of MPs including Liberal Democrat Norman Lamb, Conservative Damien Moore, Labour's Liz Kendall and the SNP's Carol Monaghan.

The report said social media companies should have a formal legal duty of care to their users.

It suggested:

establishing a regulator to minimise the harms of social media and take enforcement action The research is in its early days, but Chinese scientists say they're using bartenders' tricks to stir up a new, reversible male contraceptive.

In experiments with rats, the method successfully kept sexually active males from impregnating females for more than two months.

"The two most widely used male contraceptives are condom and vasectomy," noted a team led by Xiaolei Wang, of Nanchang University. "A reliable and reversible medium-term [2 to 20 weeks] contraceptive method between the one-off condom and permanent contraception is urgently needed."

Their potential solution was inspired by the colourful layered cocktails often concocted by bartenders. In these mixes, liquids form distinct layers in a glass. But when stirred or heated, the layers combine into a uniform liquid. Promising, but a long way to go So, Wang's group developed a form of male contraception in which layers of materials are injected into the vas deferens - the duct through which sperm travels from the testicle to the urethra - to block it.

The blockage continues until heat applied to the blocked area causes the layers to mix, breaking them down and thereby unplugging the vas deferens.

The Chinese group say they tested this method in male rats by injecting four layers of materials into the vas deferens. In sequence, the injected layers were: a hydrogel that forms a physical barrier to sperm; gold nanoparticles that heat up when irradiated with near-infrared light; ethylenediaminetetraacetic acid (EDTA), a chemical that breaks down the hydrogel and also kills sperm; and one more layer of gold nanoparticles. While in place, the liquid layers in the vas deferens prevented the male rats from impregnating females for more than 2 months, Wang's team reported Jan 30 in the journal ACS Nano.

But when the researchers shone a near-infrared lamp on the male rats for a few minutes, the layers mixed and dissolved, and the male rats were once again able to impregnate females. This offers "an effective and reversible manner to fill the gap of current medium-term contraceptive strategy" for men, the team said. But, "though our method is promising, there is still a long way to go for practical practice," the Chinese team said. "More animal experiments are needed to verify the safety of materials," they said, and results in animals often fail to pan out in people. One fertility expert in the United States agreed that much more study is needed.

"This study is a very preliminary look at injectable male contraception," said Dr Mary Rausch, of Northwell Health Fertility in Manhasset, New York. "Though this has a long way to go before it would be ready for trial or certainly use in humans, it would be a medical breakthrough if it did come to fruition. *NEWS24*

Antonio Conte has denied reports he is on the verge of returning to management after being spotted at the meeting of two of his former clubs Atalanta and Juventus on Wednesday night.

The 49-year-old has been linked with both AC Milan and Inter in recent weeks,

and was also rumoured to be Real Madrid's No.1 target to succeed Julen Lopetegui earlier this campaign.

However, Conte claimed he is unlikely to return the management arena anytime soon, having left his post at Chelsea last summer.

"I miss the pitch," he admitted to Sky Italia, "but I decided to take the rest of this year off and I'm looking forward to a new destination, which of course we do not know.

"I came from London to

Milan to watch the Juventus match, but I have not received any offers from Italy."

The latest news could be taken as a sign that Conte is still interested in the Real Madrid job. But the suggestion that his arrival would end Chelsea's goal drought was always missing the point, since what the club lack is the structural elasticity needed to create opportunities for a central striker. Higuain doesn't stand a chance while the midfield remains a case of square pegs in round holes. GOAL

"It was great opportunity to go seven points clear, but we've added another point.

"It's only January and teams, including Liverpool and Manchester City, will drop more points. We're not going to have another situation like last year where City went so far ahead of everybody else and didn't drop points. GOAL

Sevilla hammering shows Barca want to win all three titles - Messi

Lionel Messi believes Barcelona showed their appetite for the Copa del Rey by blowing away Sevilla 6-1 on Thursday to pull off a brilliant comeback and book their place in the semi-finals.

Sevilla had won the first leg 2-0 but their lead was wiped out within 31 minutes at the Camp Nou, after Philippe Coutinho scored a penalty, deferred to him by Messi, before Ivan Rakitic poked in a second. Ever Banega had squandered the chance to level for Sevilla by missing his own spot-kick and Barca ran riot in the second

half.

Coutinho headed in his second and Sergi Roberto added a fourth, only for Guilherme Arana to give Sevilla brief hope. Luis Suarez and Messi wrapped up an emphatic victory late on, the latter after a superb counter-attacking move. Some had suggested Barcelona would be relieved to exit the Copa del Rey to focus fully on La Liga and the Champions League but Messi said their display had silenced the doubters.

"It was said that we had given up in the

cup, that we didn't want it," Messi said afterwards. "But in no way is this the case. This team wants to fight for all three titles, as is the obligation of Barca every year." Coutinho's form has wavered in recent weeks but his double could do wonders for confidence.

Barcelona, meanwhile, are no strangers to these sort of revivals but against Sevilla, who sit fourth in La Liga and have been one of their closest challengers this season, it was particularly impressive. AFP

Spanish authorities have re-opened a probe into ex-Barcelona player Eric Abidal's 2012 liver transplant after confirming that new evidence suggested a trafficked organ was used, according to a legal decision seen by AFP on Wednesday.

The courts have previously looked into Abidal's transplant because of doubts about the identity of the donor.

Seven years ago Abidal, playing at the time for Barcelona and France, had received a transplant as he battled liver cancer.

In the decision, seen by AFP on Wednesday, a Barcelona judge found "it had been proved that there was new evidence against those investigated, so that the case can be reopened."

The Spanish prosecutor initially reopened investigations after Spanish media published tapes of the former Barca president, Sandro Rosell, suggesting that the club had illegally bought a liver for their defender.

Abidal, who is now Barcelona's sporting director, says his cousin Gerard Armand, who lives in France, was the donor. The latter said he had not received anything, "not a centime", in exchange. AFP
