In an interview, Nkombo said whilst the UPND was confident of winning the seat, the party was concerned about a private meeting which an Electoral Commission of Zambia (ECZ) returning officer had with State House officials last Friday.

Meanwhile, Chisunka said the term of office for NEC members, as well as provincial, district, constituency and branch committee members, was five vears.

He added no conventions were held every five years as they were either held before or after five years.

"So, when a term expires, it's for all party organs. When the term of office ends after five years, the incumbent leadership starting from the branch is the outgoing leadership that will organise the elections. The same happens at all organs. If the term of office ends and then the leadership runs away and it becomes free for all, that is anarchy, total confusion and it's not allowed anywhere!" he said.

"We have never as a party held conventions every five years, never. The first was in 1991 where Dr [Fredrick] Chiluba was elected; 1993 we had an extraordinary convention where we looked at the performance of the party; 1995 we had the national convention. The next was 2001; then 2005; 2011 and the last one was in 2012."

Chisunka, therefore, asked the court to nullify all the decisions, directives and resolutions, which were made at the 'illegal' convention.

He further asked the court to restore the original names of MMD officials headed by Nevers Mumba.

After he was asked by a lawyer representing the Mutati-led MMD Jonas Zimba in crossexamination whether it was his position that the four defendants summoned the 2016 convention, Chisunka changed his earlier position and said it was Mbulakulima who convened it while the rest only participated.

"These defendants participated in the convention, but the convener was Mbulakulima. So, they became part of the act," he said.

Chisunka further said that the term of office for the National Executive Committee where he was currently serving was supposed to expire two years ago, in 2017. Trial continues.

## Cyber Crime Crack Squad designed to spy on Zambian citizens - Msoni

By Sipilisiwe Ncube All People's Congress (APC) leader leader Nason Msoni says Zambia desperately needs a poverty Crack Squad, not a Cyber Crack Squad which is only meant to snoop, spy and curtail personal freedoms.

personal freedoms. Reacting to government's decision to establish a Special Joint Cyber Crime Crack Squad aimed at mitigating abuse and illegal use of the internet, Msoni stated that the move breached fundamental freedoms as enshrined by the Republican Constitution.

He feared that the establishment of the unorthodox squad would result in a cyber monster that would end up consuming online publications and block legitimate news websites, resulting in restricting citizens' access to information.

"What Zambia desperately needs is a poverty Crack Squad and not an eavesdropping Cyber Crack Squad meant only to snoop and spy on Zambians exercising their fundamental freedoms of expression. It is clearly deceitful and a blue lie for government to claim that it has specifically been formed to deal with the growing trend in cyberspace crimes. Government has formed a special branch called the Special Joint Cyber Crime Crack Squad (SJCCS). Clearly, this creation is inimical to public good and on the enjoyment fundamental of freedoms enshrined in the Constitution. Clearly, government intentions with the creation of this evil squad is in breach of the fundamental freedoms guaranteed by the as Republican Constitution," Msoni stated.

He stated that it was also possible that the architects of the idea were looking ahead to the 2021 general elections to blackout the internet, such as what obtained in neighbouring countries. "Delegated legislation cannot override the Constitution to create monsters out to haunt citizens from enjoying their rights and freedoms. We should all be weary and suspicious of such unorthodox creation and which we think is not a priority amongst so many competing needs. This thing will turn out into a cyber monster consuming online publications and blocking news websites.

There is also an obvious danger that the architects of this thing are looking ahead to the 2021 elections to blackout the Internet like in the neighbouring countries where the elections were stolen and failed the true winners.

It would be a dangerous underestimation to buy into what the Transport and Communications Minister, Engineer Brian Mushimba, is asserting that the exponential growth in the information and communication technology

sector has necessitated the creation of such a squad," he stated.

Msoni stated that Zambia only needed viable squads to fight and minimise escalating poverty levels and suffering among Zambians. "Arguably, the only viable squads we need are those that work towards fighting and minimising poverty and suffering amongst our people. Mr Mushimba's assertion that the wider and increased availability of the digital platforms, such as the Internet and mobile

technology, has led to some individuals using ICTs to propagate illegal vices. This statement alone is a clear tell-tale sign that the regime is now intent on muzzling the press and the free flow of information between citizens," argued Msoni.

## ACC arrests Chitotela

The Anti Corruption Commission has moved to arrest Infrastructure Development Minister Ronald Chitotela for corruption.

In a statement, ACC assistant public relations manager Dorothy Mwanza said the minister has since been charged with two counts of concealing property suspected to be proceeds of crime.

"The Anti-Corruption Commission has today arrested the Minister of Infrastructure and Housing Honourable Ronald Chitotela. Honourable Ronald Chitotela aged 47 has been charged with two counts of concealing property suspected of being proceeds of crime contrary to Section 71 subsection(1) of the Forfeiture of Proceeds of Crime Act Number 19 of 2010," Mwanza stated.

"Details in the first count are that on unknown dates but between the 1st day of July, 2016 and the 30th day of October 2018 in Lusaka District, Honorable Chitotela did conceal a property namely lot number 148 of farm 50A situated in Makeni, Lusaka disguised in the names of Diris Mukange, property reasonably suspected of being proceeds of crime." Mwanza stated that the minister also concealed property in Ibex Hill under the same name.

"Details in the second count are that on dates unknown but between the 1st day of July, 2016 and the 30th day of October 2018 in Lusaka District Honorable Chitotela did conceal a property namely the remaining extent of Subdivision A of lot 22183/M situated in Ibex Hill Lusaka, disguised in the name of Diris Mukange, property reasonably suspected of being proceeds of crime. He has since been released on Bond and will appear in court soon," stated Mwanza.

## New mine tax regime may negatively affect mining houses - FQM boss

First Quantum Minerals (FQM) director Philip Pascal has expressed concern that the mining industry will be adversely affected by the recent tax changes because of unique circumstances such as the gold export tax.

But Minister of Mines and Minerals Development Richard Musukwa has asked mining companies to submit their concerns about the new tax changes to government, saying government would accept proposals regarding the recent changes to the mine tax regime. Musukwa who is currently in South Africa to attend the 25th Africa Mining Indaba being held at the Capetown international Convention Centre, met with FQM directors whom he advised that particular concerns should be brought to the attention of government.

And according to a statement issued by the Zambian Mission in Pretoria, Musukwa stressed that government had a duty to develop the country from there resources that were available. Meanwhile, FQM's Pascal said the mining company would submit concerns regarding the new tax changes, but expressed concern that Kansanshi as well as other Mines in North Western would particularly be adversely affected by the recent tax changes because of the unique circumstances such as the gold export tax. He disclosed that FQM had invested about \$5billion in the mines at Kansanshi and Lumwana in North Western Province in the last 20 years, and that over the years, FQM had paid over \$3.5 billion in taxes.

## ActionAid identifies snags in sales tax implementation

ActionAid Zambia says it may not be possible to implement the newly introduced Sales Tax to replace the Value Added Tax because there seems to be no resources for it in the 2019 budget. Making a submission before a parliamentary committee, Monday, ActionAid country director Nalucha Ziba wondered whether the sales tax regulations would be considered on the floor of the House in readiness for implementation in April, 2019. ActionAid noted that even though the Minister of Finance, in the her 2019 budget presentation was quoted saying the new tax changes would be implemented in April, 2019, there seemed to be no resources in the 2019 budget for the development of requisite infrastructure that would support the administration of this tax.

"A rather surprising tax measure proposed in the 2019 budget is the abolishment of the Value Added Tax (VAT) system, which is to be replaced by Sales Tax. The main objective according to the honourable Minister of Finance is to enhance the contribution of consumption taxes to government revenue. However, the budget address does not specify the rate at which the sales tax will be introduced, nor does it tell us what the administrative regime will be, who will charge sales tax on their goods and services, if there will be any goods to be exempt and how the ultimate users will be determined. Further, there are no estimated revenues to be raised from this sales tax. The

resources being estimated in the budget are for VAT," ActionAid observed.

"As at now, there will no bill to introduce although the Hon. Minister of Finance is quoted as having said it will be introduced in April, 2019. ActionAid doubts the regulations for this tax type will be read for consideration in Parliament in readiness for implementation in April, 2019. In addition, there seem to be no resources in the 2019 budget for the development of requisite infrastructure that will support the administration of this tax. This move is somewhat inconsistent with the general global trend whereby most countries across the globe have moved from sales tax to VAT. We know that during times as sales tax, many countries attempted to implement national retail sales taxes or variations such as wholesale-level taxes or 'ring' taxes but this was not for long. We also know that by 1995, almost all the countries had converted to Value Added Tax (VATs) that collect revenue at each stage of production. Almost all developing countries have also largely abandoned retail sales in favour of VATs."

Ziba highlighted some of the reasons why most developing countries abandoned the sales tax.

"One of the reasons was cascading. Cascading which occurs when taxed inputs are used to produce taxed outputs, [Tax on Tax] so that the total tax on the goods compounds beyond what was intended. However, we know that this effect can be avoided by exempting all business purchases from taxation but separating business purchases from consumer is difficult. Moving to VAT solves the problem since businesses receive credits for the taxes paid on their input purchases. The second is evasion, which actually is higher under a retail sales tax than a VAT for several reasons. First, the retail level is the weakest link in the enforcement chain, because there is no cross reporting; the government has no record of the transaction and the retailer responsible for sending the check to the government for the tax they collect knows this. As a result, compliance rates can be low," Ziba said. "In VAT, the chain of crediting creates a natural audit trail.

In a transaction between two businesses, the seller knows the buyer is reporting the transaction to claim a credit. So the seller has more incentive to report the transaction and pay tax. There's no similar incentive under a retail sales tax. In fact, most countries have found that, as a practical matter, retail sales tax rates of 10 per cent or higher aren't enforceable - buyers have greater incentives to avoid the tax and retailers have greater incentive not to send in the revenues. Not coincidentally, all state sales tax rates are below 10 per cent for countries still implementing sales tax. Then if a retailer evades sales tax, the full tax on the sale is lost. But with a VAT, successful evasion by retailers only costs the government the tax on the retailer's value added'; and thirdly, with sales taxes, there is no paper trail that enforcers can easily follow. It is our belief that the government will take these challenges on board as they design the sales tax that is envisaged to be implemented in April 2019."

Ziba said there were a number of challenges in the collection of revenue and recommended that a full tax reform programme was undertaken to redesign both the tax policy and administration with a view to increasing domestic revenues to about 25 % of GDP.

"The ultimate objective of a mining taxation regime is to maximize the benefits that a country receives from the mineral resources. In this regard, ActionAid recommends that the government undertakes a major tax policy and adminstration reform that will bring various stakeholders on board to design a good tax policy and administration system with broad policy consideration and that will stand the best of time. These broad policy considerations sometimes referred to as principles of taxation include; neutrality, meaning tax must be neutral and equitable between reforms of business activities; Certainty, where tax rules should clearly specify when and how a tax is to be paid and how the amount will be determined. Effectiveness and Fairness, meaning that taxation should produce the right amount of tax at the right time, while avoiding both double taxation and unintentional non-taxation," said Ziba.

"The PF government has successfully secured new markets for various Zambian products. For example, in 2018, the PF Government created a taskforce comprising of Ministries of Livestock and Fisheries, Agriculture, Commerce, Trade and Industry as well as representatives from the private sector. The aim of the taskforce was to develop a roadmap that will help expedite the process of goat and sheep commercialization in Zambia for export to Saudi Arabia, among other markets. Under this agreement facilitated by the PF government, Saudi Arabia shall be importing one million (1,000,000) goats and fresh vegetables on a monthly basis from Zambia," Mwila stated. "In addition, the PF Government has also secured a new market for the export of Organic Honey to China. Currently, Zambia's annual honey production stands at 2,500 tonnes whereas the country currently exports only 1,000 tonnes to the European and African markets, which leaves a surplus of 1,500 tonnes. However, the new market to China secured by the PF Government has the export potential in excess of 3,000 tonnes of Organic Honey."

According to Bloomberg, the Canadian miner, which already owns 80 per cent of the Solwezi-based Kansanshi Mine, submitted a business proposal last year that included US\$300 million to \$400 million in cash, and an equal amount in special royalties over more than 10 years. "The proposal, which was submitted last year, includes

US \$300 million to US \$400 million in cash, and an equal amount in special royalties, over more than 10 years, said the people, who asked not to be identified because they're not authorized to comment. First Quantum spokesman John Gladston declined to comment," Bloomberg reported in a story published, Monday. "Amos Chanda, Zambian President Edgar Lungu's spokesman, didn't immediately respond to a call and message seeking comment, and neither did a spokeswoman for ZCCM-IH. The deal would also include ZCCM-IH

dropping a US\$1.4 billion legal claim against First Quantum over a loan the company received from Kansanshi, the people said. The government is still considering the proposal, according to one of the people." Ministry of Finance spokesperson Chileshe Kandeta elaborated more on the proposed transaction in an SMS, Tuesday: "There are multiple unsolicited offers on the table, including from FQM, which are based on preferential share conversions," Kandeta stated. "The offers relate to the Ministry's 17 per cent holding in ZCCM-IH and a sale would

be subject to Cabinet approval." FQM hit a record-breaking 605,853 metric tonnes in copper production last year, mainly boosted by two of its Zambian subsidiaries in Kansanshi and the Sentinel Copper Mine in Kalumbila District. According to official Ministry of Mines data, FQM's Kansanshi recorded 249,532 metric tonnes last year in copper output making it the highest among all 10 mining companies in the country for a third successive year. Kansanshi is FQM's biggest mine, and accounted for more than half the company's revenue in 2017.

## **Avondale mob attacks witchdoctor** for killing two family members

that around 20:00 hoursnon Monday, an angry mob descended on the 68-year-old witch doctor identified as Peter Siame after he was accused of being responsible for the death of two family members. Hamoonga also reported that the same witchdoctor had been paid K2,500 by a named woman of the same community so that he could kill her husband and his family members, something which incensed members of the public.

"Facts of the matter are that around November, 2018, The witchdoctor (Peter Siame 68years) was approached by the wife to a Mr Chisanga a local business man to kill him, his family and eight others. According to the list that was given to the witchdoctor, two members of the same family died within a week and the story came to light which incensed the public who apprehended Mrs Chisanga and thev wanted to kill her but was rescued by the Police, at this moment the Witch Doctor escaped and ran away to Chongwe where he stays," Hamoonga stated.

Hamoonga further stated that the incensed residents tied the witch ]doctor and put tyres around him so that they could burn him to death but he was rescued by police.

"However, Mrs Chisanga was kept in custody for her safety and the family for the deceased persons were advised to take a civil suit. The case came up for a hearing on 4th February, 2019 at Chelston local court where the Witch Doctor also attended. After the court case, they went to Chainda with the Witch Doctor where he apologized and revealed to have been paid K2,500 to kill the two persons, while the other person is nursing a swollen leg (a niece to the other two deceased persons). It was at this point that one of the family members informed the neighbours that the witch doctor was in the house and that was how they descended on him. Quick action by police rescued him and was taken to Levy Mwanawasa Teaching Hospital where he is currently admitted. He sustained a broken Jaws and is not able to talk. We are appealing to the general public to desist from taking the law in their own hands but rather let the due process of the law to take its full course," stated Hamoonga.

## **Court dismisses Heritage Coin's** application for bail pending appeal

**Bv** Zondiwe Mbewe The Lusaka Magistrates' Court has thrown out an application for bail pending appeal in a case where three directors of Heritage Coin Resources were recently Limited sentenced to two years' simple imprisonment for money laundering offences involving over K28 million.

month, Magistrate Last Humphrey Chitalu jailed Hilda Agnes Raubenheimer, 35, a businesswoman of Salama Park; Orient Rio Zekko, 29, a secretary of Ibex Hill and Tapiwa Chirwa, 40, a managing director of Avondale, after they pleaded guilty to six counts of obtaining money by false pretences, money laundering, amongst other offences. The court had further fined the company, Heritage Coin Resources Limited, K150,000 for providing financial services without a license. It also granted an application by the State for restitution to the affected depositors. The court ordered that the K15,312,182,40, which was seized by the Drug Enforcement Commission (DEC) should superintend the payment process. However, the three directors, through their lawyer, appealed against the court's judgement. The trio also applied for bail pending appeal on grounds that their appeal in the higher court was likely to succeed. They had submitted that if they were kept in jail, the restitution order maybe thrown in jeopardy.

The trio added that by the time the High Court ruled over their appeal, they would have served a substantial part of their jail term since the appeal cases took long to be heard. However, in his ruling, Magistrate Chitalu threw out the application, saying the reasons raised were not

In the second count, Chirwa, Raubenheimer and Zekko were accused of conducting banking business without a licence.

It was alleged that June 1 and October 15 last year, the trio, with intent to deceive and defraud, obtained K28,346,800 from members of the public by falsely pretending that the money was cryptocurrencies trade when in fact not.

"The applicants have not disclosed exceptional circumstances to warrant bail pending appeal," Magistrate Chitalu ruled.

He further said it was misconceived and absurd for the applicants to claim that their continued incarceration may render the restitution order and partial repayment of stakeholders a nullity.

In a statement issued by Ministry of Tourism and Arts Public Relations Officer, Sakabilo Kalembwe, the court sentenced Lubinda Lay, 43, to six years imprisonment with hard labour for unlawful possession of three pairs of Ivory, and Moses Nyirongo, 36, to six months imprisonment with hard labour for illegal possession of a firearm. "The Lundazi Subordinate Court has jailed two wildlife offenders for being in illegal possession of prescribed Trophy and an unlicensed fire arm. The Court has convicted and sentenced Lubinda Lay,43year old man to six years imprisonment

with hard labour for unlawful possession of three pairs of ivory, contrary to section 130 (a) of the Zambia Wildlife Act No.14 of 2015," Kalembwe stated.

"The suspect, a mid-level ivory illegal dealer, middleman between poachers and kingpins who has been on the Department of National Parks and Wildlife's wanted list, was finally apprehended with the contraband in Phikamalaza's area. In another case, the court convicted and sentenced Moses Nyirongo, 36, to six months imprisonment with hard labour for unlawful possession of a firearm contrary to Section 10 of the Firearms Act. Chapter 110 of the Laws of Zambia." Kalembwe stated that continued poaching was leading to the extinction of some animal species and that the scourge was denying the country economic

#### development.

"Illegal wildlife activities especially poaching according to the International Union for Conservation of Nature is pushing many species to the brink of extinction. According to recent surveys conducted by the Department of National Parks and Wildlife (DNPW) with the Support of World Wide Fund for Nature (WWF) and International Crane Foundation (ICF), species like the Kafue Lechwe population that stood at 28,711 in 2015, now stands at 23,306 animals," stated Kalembwe.

"The indiscriminate poaching of elephants and other wildlife in a threat to the environment and to Zambia's economic development as it denies the country maximum benefits from sustainable tourism."

Yesterday, we disagreed with Pastor Nevers Mumba's argument that former vice-presidents deserve retirement benefits that should sustain their lives until they die. He made a comparison, saying Presidents, "former Chief Justices, Speaker of the National Assembly, Service Chiefs and several other government officials get sustainable packages once they retire but a former vicepresident has none.

In our argument, we tried to illustrate that, with the kind of privileges and benefits that a sitting vice-president gets, there is no need for anyone to steal in order to live comfortable for the rest of your life. But we want to thank Pastor Mumba once again for raising this issue because his personal problem is just a pointer to the real scandal. Today, we would like to talk about people who get retirement packages without contributing anything to the pension scheme. Who pays for those packages? We need to find out. But first, let's talk about those who get retirement benefits outside the law.

In Zambia, we have a situation where some government office bearers take home sustenance packages, retirement without any law backing such benefits. All it takes is the President writing a letter and adding those entitlements to the contract of a person holding a particular office of interest. In other words, a head of a government institution strong who has a connection with the Head of State can negotiate

## Judges disregarding law on contributing to pension schemes

with the President to give him or her such retirement benefits where they get a percentage of the incumbents salary, for life.

This has been happening, but no one is talking about it. For example, of the three substantive Auditor Generals that have served Zambia in the past, only one was privileged enough to get such an offer from the President, to retire with a percentage of the incumbent's salary until they die. The other two did not retire with such conditions because the entitlement is not provided for in the law. Is that normal for a country like Zambia which is surviving on loans?

We can understand the need for service chiefs, top intelligence officers and other senior security personnel of government, to retire with such benefits because of the sensitive nature of their jobs. It can be justified why government would want to specifically ensure that these individuals don't become destitute retirees. But for these other office holders, the only justification is that they make a lot of enemies in their line of duty. The whole logic doesn't just make sense.

But our point is that a President cannot just decide to give someone a pension without a pension scheme attached to it. That is illegal and unfair. If people are being given pensions without a pension scheme, then who is paying for those packages? A worker is supposed to make contributions to a pension scheme during the time of their employment before they can go and claim those benefits from the Pensions Fund; simple and straight forward.

But there is an even bigger scandal. We don't know how many Zambians are aware that today, when eligible judges retire, they continue to get 80 per cent of the salary of the incumbent judge until death. And that is not all; when that particular judge dies, the widow, or spouse continues to get 50 per cent of the incumbent judge's salary until she also dies.

That is the kind of money that Zambians pay to the households of judges. Now, we don't have the statistics of how many judges have retired in Zambia and are still

living with their spouses; we will leave that to the imagination of you, our readers. And while we are at it, our readers may also want to imagine the kind of money those retired judges get when they are reappointed to head institutions such as the Electoral Commission of Zambia.

Ridiculous as that retirement package may sound for a country like Zambia, where more than half the population is in abject poverty, it is not illegal. Since these people already get huge salaries per month, and considering that they are constitutional office holders who cannot be fired unless they do wrong, one would expect that they don't need such staggering retirement benefits, but the laws of Zambia say

they are entitled.

But the scandal gets worse. The same law that allows them to get that kind of money also says they should contribute to a pension scheme, but they have never contributed. Why are the judges breaching the law with impunity?

Chapter 277 of the laws of Zambia under the Judges Conditions of Service Act, section (10) states: "A Judge shall contribute towards the cost of the pension scheme described in this Act at the rate of seven and one quarter per centum of his pensionable emoluments or at such other rate as the Minister may fix by statutory order in consultation with the institution designated by section nine."

Our judges who are eligible to that retirement package cannot claim that there is a deduction from their salaries, which goes to a pension scheme. So, they get that money from the Treasury, paid by other taxpayers, to live on for life after they retire. How fair is that?

The judges' conditions of service Act is being disregarded by the very learned judges who must be upholding the Republican Constitution. This is the much bigger problem that Pastor Nevers Mumba has pointed us to, which Zambians should take interest in. We would like to hear what governance stakeholders, the Law Association of Zambia and academicians have to say about this. In our view, Zambians are being robbed by those who must be jailing robbers.

## UN warns of 'massive' impact of tariff hike

A UN trade official has warned a US plan to raise tariffs on Chinese goods next month would have "massive" implications for the global economy.

The US plans to increase tariffs on Chinese goods if the two sides fail to make progress on a trade deal by 1 March.

The comments followed a report by a UN trade agency on the impact of the US-China trade war.

It said Asian countries are likely to suffer most from protectionism.

The US and China are locked in a damaging trade dispute that has seen both sides levy tariffs on billions of dollars worth of one another's goods.

In December, both countries agreed to hold off on new tariffs for 90 days to allow for talks.

The US and China have a deadline of 1 March to strike a deal, or the US has said it will increase tariff rates on \$200bn (£152bn) worth of Chinese goods from 10% to 25%. The UN Conference on Trade and Development (Unctad) has warned that there will be huge costs if the trade war escalates.

"The implications are going to be massive," Pamela Coke-Hamilton, Unctad's head of international trade, said at a news conference. "The implications for the entire international trading system will be significantly

negative." Smaller and poorer countries would struggle

to cope with the external shocks, she said. The higher cost of US-

China trade would prompt companies to shift away from current east Asian supply chains.

Unctad's report estimates that east Asian producers will be hit the hardest, with a projected \$160bn contraction in the region's exports.

But it warns the effects could be felt everywhere. "There'll be currency wars and devaluation, stagflation leading to job losses and higher unemployment and more importantly, the possibility of a contagion effect, or what we call a reactionary effect, leading to a cascade of other trade distortionary measures," Ms Coke-Hamilton said.

The higher cost of US-China trade would prompt companies to shift away from current east Asian supply chains, but report suggests it's unlikely that US firms would pick up that business.

The study found that US firms will only pick up 6% of the \$250bn in Chinese exports that are subject to US tariffs.

Of the approximately \$85bn in US exports that are subject to China's tariffs, only about 5% will be taken up by Chinese firms, the UN research shows.

The study found that European exports will grow by \$70bn, while Japan, Canada and Mexico will see exports increase by more than \$20bn each.

Other countries that could benefit include Australia, Brazil, India, the Philippines and Vietnam, the report said. **BBC**

### Premature to Say Social Media Use Leads to Depression

Use of social media does not necessarily cause depressive symptoms later in adolescents and young adults, according to a recent research.

The study, however, showed that relatively higher depressive symptoms resulted due to more social media use later only among adolescent girls.

use later only among adolescent girls.

The latest study stands in contrast to recent claims that suggests teenagers' use of social media could lead depressive symptoms later among adolescents or college undergraduates; rather, greater depressive symptoms predicted more social media use over time, but only among adolescent girls.

"This finding contrasts with the idea that people who use a lot of social media become more depressed over time. Instead, adolescent girls who are feeling down may turn to social media to try and make themselves feel better," said Heffer. addition, different In groups of people use social media for different reasons including making social comparisons or while feeling down. While another group of people may use it for more positive reasons, such as keeping in contact with friends, according to the study. Examining the role that these differences play will help clarify the ways in which social media interacts with mental health, with implications for parents, policymakers, and healthcare professionals alike, the study noted. # Man 'to sue his parents for giving birth to him'

A 27-year-old man plans to sue his parents because they did not ask for his consent to bring him into the world, it is reported. Raphael Samuel, from Mumbai, India, is reportedly part of a socalled 'child-free' advocate who believes children shouldn't be made to suffer life.

He has been described as an 'anti-natalist' who

### French dedicate a weekend to women in sport

Women's sport will be the focus of attention in national media and on the playing fields of France this weekend as part of an annual event called "Women's sports always."

The country's broadcasting commission on Tuesday presented a schedule that will include live network broadcasts of the women's Six Nations game against England and France's Fed Cup match with Belgium.

In addition, clubs across France are organising women's matches or open days over the weekend.

France is hosting the women's football World

Cup from June 7 to July 7. On TV, women's competitions peaked at 16-20 percent of sports broadcast time in France in 2016, up from 14 percent in 2014 and seven percent in 2012, according to commission. In 2017, a non-Olympic year, it fell to 14-18.5 percent.

Female participation in organised sport in France has been increasing. Between 2012 and 2017, the percentage of registered competitors who are women rose from 37 percent to 38.3 percent of the total to 471,010, according to figures from the Ministry of Sports. Women, who mostly practise walking, swimming and fitness,

remain underrepresented in team sports, making up only 17 percent of those participants in 2017. *AFP*  frustrated by the same scoreline on their most recent outing against West Ham.

Two disappointing stalemates mean that Jurgen Klopp's side have allowed the chasing pack to close in, with it possible that Manchester City could knock them from top spot on Wednesday. Fabinho insists that is no cause for alarm at Anfield, but admits that Liverpool have to find a way of breaking down stubborn opposition if they are to ultimately emerge as title winners.

"We want to play better every day and unfortunately it is not happening," Fabinho said.

## Mourinho accepts **12-month** sentence

Jose Mourinho has accepted a 12-month prison sentence and a fine of close to  $\notin 2.2$ million after admitting to tax fraud in Madrid - but will not serve time in jail.

The 56-year-old was accused of evading paying in the region of €3.3m in taxes on image rights while he was head coach of Real Madrid.

The Portuguese will not spend any time in prison as the sentence is for less than two years.

2016, Mourinho's In representatives Gestifute released a statement insisting he was "fully compliant with tax obligations" after allegations of tax evasion first came to light via the whistleblowing platform 'Football Leaks'

However, he struck a deal with Spanish prosecutors last year, which was ratified at a court on Tuesday.

Mourinho was in charge of Madrid from 2010 until the end of the 2012-13 season. The offences were alleged to have been committed between 2011 and 2012.

It was reported last September that he had agreed to accept a one-year prison sentence and
