Gemcanton drags *Daily Nation* to court over alleged false stories

By Zondiwe Mbewe Wolle Mining Limited has dragged Daily Nation Newspaper, its Editor-In-Chief and four reporters to court, for allegedly publishing several false and malicious articles against Gemcanton Investment Holdings Limited. Wolle Mining has jointly sued the defendants with Gemcanton Investment Holdings chairperson Abdoulaye Ndiaye and the chief executive officer Abdoul Ba, claiming general and aggravated damages for the libel contained in seven different articles published in the Daily Nation Newspaper between December, 2018, and February this year. The four reporters include; Silumesi sued Malumo, Rogers Katero, Chiyanzo Aaron and Bennie Mundando. In a statement of claim filed in the Ndola High Court, Friday, the plaintiffs stated that Wolle Mining Limited were a 50 per cent shareholder in Gemcanton Holdings, Investment

and that its core business was mining and trading in emerald gemstones. The trio stated that the defendants had caused to be published, several false and malicious newspaper articles injuring the reputation, credit and interests of Gemcanton. "The said articles consist of false and malicious stories or statements that are damaging to the reputation or goodwill of both Gemcanton as a business entity, and the chairman and CEO as businessmen who have been dealing in the trade of emerald stones for quite a long time with a good name," read the statement of claim. The plaintiffs noted that on December 6, last year, the defendants "falsely" published an article titled '\$50M emeralds smuggled' which was stating that '...more that US \$50 million worth of Zambian emeralds have been smuggled and illegally sold with the proceeds banked in Switzerland to avoid taxes, court papers have revealed'. They lamented that as the result of the said words, their character had been brought into public odium, ridicule, contempt and had been understood not to be good businessmen who should be trusted. The trio further stated that on January 12 this year, the Daily Nation "falsely and maliciously" published an article titled 'Russian deported' stating that ' ... Ndiaye has since failed to refund the \$50 million and his partners also claim that despite him having received the money in Switzerland for the Zambian emeralds, he did not pay taxes in Zambia as required by the law ...? The plaintiffs stated that the publication of the said statements falsely painted Ndiaye as a businessman who maliciously avoided paying tax from the sale of emeralds. They further stated that the Daily Nation falsely published five other articles titled 'emeralds scandal deepens', 'Gemcanton Emerald

Mine scandal deepenstwo Israelis deported', 'I was abducted', 'Gemcanton deportation shocker' and finally: 'Immigration itself distances from Gemcanton deportation. The trio lamented that as a result of those news stories, they had been injured in their credit, reputation, good will, business and had suffered loss and damage. They claimed that the defendants intended if not restrained, to falsely

and maliciously continue with the publication of the same or similar kind of words against them. They are now seeking general and aggravated damage for libel contained in the seven articles published between December last year and February this year, an injunction to restrain defendants the from making publication of false statements or stories against them, costs and any other reliefs.

innocence until proven guilty by the courts. As far as we know, Changala is not a court of law much as he desires to convict and discharge whosoever he wishes. It's fashionable for politically-damaged goods like him to accuse Republican President Edgar Chagwa Lungu of corruption because all his allies in the opposition are singing from that same hymn book!" Chanda charged. "My intention in this response is not to demean Mr Changala as he always alleges, but to render a free law lecture on the law of suspending persons who are facing corruption charges since he appears to be in dire want of legal counsel to give him sound advice before he could open his mouth to the public. China contributed highest number of jobs to Zambia in 2017 – BoZ

China was the highest contributor to employment among all the Majority Owned Foreign Affiliates in Zambia (MOFAs) by the end of 2017, Bank of Zambia (BoZ) data shows. And the central bank has stressed that Chinese contribution to the Zambian economy through employment, value addition, taxes, and salaries is significant. In an updated BoZ submission to the Committee on National Economy, Trade and Labour Matters on China-Zambia Relations vis-à-vis trade and investment, data showed that China was the highest single contributor to job creation among all the MOFAs as at December 31, 2017, beating four other industrialised economies. MOFAs are enterprises with 50 per cent and above of share capital attributable to foreign investors. "Several advantages accrue to the Zambian economy as a result of significant FDI flows from China. Relative to other major source countries, Chinese companies contribute significantly to the Zambian economy in terms of employment, value addition, taxes and salaries. The assessment below is based on a survey of 193 MOFAs," BoZ stated. "In 2017, China was the highest contributor to employment among all the MOFAs surveyed. MOFAs from China contributed 21.7 per cent (18,525) of the total number of employees by MOFAs." According to the BoZ's survey,

the Chinese MOFAs beat four other industrialised economies such as Britain, whose MOFAs only contributed 18 per cent of the total employment; Canada at 13.6 per cent; Switzerland at 8.4 per cent and South Africa, whose contribution amounted to only 8.2 per cent of the total employment. In terms of taxes on income, MOFAs from China were however, fourth, contributing just 8.5 per cent (US \$57.4 million) of the total taxes remitted by the surveyed MOFAs in 2017 (US \$675.5 million). And in terms of contribution to salaries drawn by workers

who worked for Chinese companies in 2017, the overall contribution accounted for only 6.6 per cent of the total salaries, rendering China in fifth position behind Canada, Switzerland, Britain and South Africa. "Chinese MOFAs were among the top-five contributors to salaries drawn by workers who worked for these companies in 2017. Companies from China accounted for 6.6 per cent (US \$72.2 million) of total salaries drawn by workers in MOFAs (US \$1,089.7)," it stated. But the central bank concluded that Chinese FDI investments remained significant in Zambia.

"All in all, FDI investments from China have contributed to the Zambian economy through employment, value addition, taxes, and salaries. Relative to other major source countries of FDI inflows into Zambia, China's contribution is significant. This contribution can be said to be the practical advantages of Chinese investments in Zambia. To maximize these benefits, it is important that the country institutes measures to attract more FDI into the country, whether from China or elsewhere. And monitor closely so that real benefits can accrue

to the citizens," stated BoZ. The working paper was an addendum that augmented a submission made by the BoZ on December 21, 2018, in response to the request by the Parliamentary Committee on National Economy, Trade and Labour Matters. The Committee asked BoZ to address a range of issues including: the adequacy of the policy and legal framework governing FDI in Zambia; the advantages of China's foreign trade and investment in Zambia and China's investment contribution to the major sectors of the national economy, among several other pertinent questions.

Lungu was acting within the law by not firing Chitotela when he was still serving as Minister. "President Lungu is alive to the provision of Section 47(1) of the Anti-Corruption Act No. 3 of 2012 which reads: '47. (1) Subject to the applicable legal and administrative procedures relating to the right to justice and a fair hearing applicable to public officers under their conditions of service, a public officer who

of service, a public officer who is charged with corruption shall be suspended, at half pay, with effect from the date of the charge.' For Mr. Changala to allege that President Lungu is a suspect, a friend and accomplice of criminal and corrupt elements is not only absurd, but shows the greatest ignorance of the existing law. However, Mr Changala needs to be lectured that Section 47(1) is not a standalone provision to determine whether it is applicable to ministers, but is subject to many other provisions within the Act itself and the Constitution as a Supreme law," stated Chanda. "As an expired civil rights activist, let's draw Mr Changala to Section 47(4) of the ACC Act which reads: '47(4) This section does not apply with respect to an office in respect of which the Constitution limits or provides for the grounds upon which a holder of the office may be removed or the circumstances in which the office shall be vacate.' To make it simple for Mr Changala, this Section does not apply to certain offices on three grounds: 1. Where the Constitution limits removal of a holder from office; 2. Where the Constitution provides for grounds upon which office holder may be removed; 3. Constitution provides for circumstances under which the office shall be vacated. Without doubt, Mr Changala must know that the Constitution of Zambia, in Article 116(3), provides circumstances under which the [Minister's] office shall be vacated.' In short, Section 47 of the ACC Act cannot apply to a Minister, who is serving in government. We, therefore, advise Mr Changala to leave the stage while a few are still clapping for him. He's better off producing chalk!"

DfID-PEP Zambia dungles K61m for SMEs in 2019

By Claver Mutinta in Solwezi The Department for International Development (DfID) flagship on business programme, Private Enterprise Programme (PEP), says over K61 million has been set aside to facilitate and enhance local private enterprises' capacities to create jobs and wealth in 2019. And an indigenous online business opportunities portal, Zambia Business-to-Business (ZamB2B), has been launched with a view to increasing trade and linking big corporate institutions to small and medium enterprises. PEP Zambia head of mining section Eric Miller said in an interview after the launch of an

online platform ZamB2B that job and wealth creation was the only way to end poverty in Zambia. "We're talking about this current year spending over K61 million available to make [local content] strategy happen. We're talking of quite a lot of money where we can facilitate companies and support them to get results, which are to create jobs and ending poverty," Miller said. He said PEP existed to alleviate poverty through job creation, adding that it would stimulate permanent enterprises, SMEs and build capacity so that they could create more jobs and end poverty in communities. And North-Western Chamber of Commerce and Industry

Kafuta president Mukumbi said the Chamber sought a strengthened relationship with PEP Zambia to strengthen the local content implementation strategy. "We believe that to sustain growth rates, create wealth, and reduce poverty, Zambia has to transform the current structure of its economic policies and regulatory framework to implement the integration primary of locally-available resources, goods and services in production processes," Kafuta said. During the launch of ZamB2B in Solwezi, Thursday evening, Kafuta explained that mining firms, chain stores and markets should be able to buy from Zambian companies, hence

the need to champion local content development and market linkages. The Chamber was constantly building a business community across sector interests and to foster a robust Public-Private Partnership (PPP) to ensure economic emancipation. Kafuta explained that PEP Zambia could not have come at a better time than when interventions to help actualise government's development objectives were being put in place. He said the Chamber realised that formulation of effective economic policies and regulatory frameworks, which supported local businesses, was key to creating sustainable economic growth and cut poverty -Story courtesy of SUMA SYSTEMS.

Magistrate rebukes teenagers for smoking weed

By Zondiwe Mbewe Lusaka magistrate Chanda has Nsunge reprimanded 11 juveniles smoking weed, for warning that cannabis could destroy their lives before they grew older. And magistrate Chanda has ordered the juvenile offenders

to undergo a diversion months program at the Drug Enforcement Commission (DEC) for counseling and rehabilitation for three months. But Magistrate Chanda has sentenced a 20 yearold grade 12 pupil who was jointly charged with the juveniles, to three

imprisonment hard with labour. In this matter, the 11 iuvenile offenders aged 14 to 17 and 20 year-old Lukas Daka, all from Lusaka's George Compound, were facing two counts of trafficking and unlawful usage of Marijuana. The 12, who all pleaded

guilty, had taken turns explaining to the Court how marijuana, among other things; gave them appetite, strength to lift weights and carry out house chores quickly, skills play to good football and controlling their etc. tempers The matter came up,

Tuesday, for facts sentencing. and Facts in this matter were that on January 16, this year, DEC officers information received that a male person was dealing in suspected drugs in George Compound. Officers proceeded to the said place where the

accused were found in an unfinished building, smoking cannabis. The accused were then picked and the suspected drugs were seized. When magistrate Chanda asked whether the facts were correct, the accused responded in the affirmative. In mitigation, the juvenile offenders asked for forgiveness saying they had learnt a lesson and would never smoke cannabis again. The juvenile offenders added that they wanted to continue with their education. Before magistrate Chanda sentence could the accused, she reprimanded the juvenile offenders for smoking cannabis saying weed was bad. "Cannabis are not good substances. If the parliamentarians have made a law that 'trafficking in cannabis is not bailable' then you have to know that it's a serious offence. Drugs are not good because they will destroy your life. Unless you choose that you want to be mad. Because when you smoke these drugs as young as you are, by the time you grow up you won't be in a normal state. This is the last time you should step here. Control yourselves, it's for your own good," scolded Chanda.

"Lies have caught up with them, that's why they have now resorted to witchcraft and we have heard from a chief who supports them, he has told ammunition was fired at a crowd, you about. There is no need for all this us that they sleep at the grave yard. When HH was incarcerated, we heard that they went to Congo, they said it themselves. And if you have vehicles that block the road of the security detail for the Head of

State and there is a threat, it happens with everyone who has a weapon, you can fire in the air to scare away any threat, it's allowed. But if you say live would have had casualties and deaths! So, if live ammunition was fired at the crowd, how come our colleagues are not showing us the evidence of fatalities? Or even any of their vehicles that was hit at by bullets? 'Tatuli baiche!' (We are not kids!). Talk about teargas canisters, yes, those are used for crowd control, but if you say live ammunition was used, how?" Chanda wondered. And he claimed that UPND cadres provoked the police by blocking the road that President Lungu was supposed to use and later marched to where the Head of State was lodging. "Our colleagues are not being candid enough on this issue; the President was going to use that road, they were told you cannot hold your meeting today, and from what we have gathered, they held a meeting very close to the holding residence for the Head of State in Sesheke. And from what we

heard, they started marching towards the holding residence of the Head of State in a clear act of provocation that led to that clash that we heard drama, if only our colleagues could show maturity and if Mr Hichilema could tone down on his desperation and arrogance," said Chanda. "There is a lot of evidence of violence and misconduct by the UPND, talk about all the blockages of the road. Suspected PF cadres attacked and beat up Chipata's Breeze FM reporter Grace Lungu in Lundazi, Tuesday morning, where she was assigned to cover the ongoing Mkomba ward by-election. Narrating the ordeal to News Diggers! in an interview, Lungu explained that she had hired a taxi to take her to the ward, but was attacked by unknown PF cadres who mistook her and her driver of being members of the opposition UPND. Lungu narrated that the cadres started by beating her taxi driver and later on turned to the back of the taxi where she was seated, dragged her from her seat, while beating her. She said the cadres also grabbed her purse and handbags and got away with and undisclosed sum of money.

PF cadres attack Breeze FM reporter covering Lundazi by-election

She said she could not proceed to go and cover her assignment as she had sustained injuries on her lip and her nose from the beating, adding that the matter was reported to the Lundazi Police Station, where a medical report was issued before she and was later taken to the hospital. "It happened somewhere around 08:20 hours. So, what happened is [that] I booked a tax because I wanted to be at the polling station early. So got a taxi early and we started off. As we approached the Islamic School, off Lundazi Road to Mkomba, we met a white van, which was full of people; we didn't even know who they were. Yes, they looked like thugs, but we didn't know they were PF cadres. So, we passed them and they waved at the driver and the driver waved back. But according to them, they thought the driver was UPND because he didn't flash the PF party symbol. So, they shouted for him to stop, but he didn't stop, he just continued driving," Lungu narrated. "After they noticed that he wasn't stopping, they turned and drove passed us, stopped their van in front of the taxi I was in and that's [how] my driver also stopped the

car. They came and opened the doors and started beating up the driver. I was sitting in the back seat and they didn't know I was also in the car, but after one of them saw me, they were like 'so you are also here, why are you hiding?' Before I could do anything, they grabbed me as well and started beating me as well. Then one of them grabbed my purse and asked what was inside. They opened my purse and started getting my money. One of them first got a K50 and then when I tried to ask why they were beating me, another one grabbed my handbag and someone else hit

me very hard on my right cheek ... " She narrated that as the beating continued, she started bleeding from the nose, but the assailants did not stop. "Before I could see who hit me on the right cheek, someone else slapped me on the left cheek and I started bleeding. When I started wiping blood from the nose, someone else slapped me and that's how I even sustained an injury on my lower lip. I started bleeding from the lip, too. Then they got more money from my purse and drove off and they just left my bag and purse scattered. So, I just

a U-turn and went to the police station in Lundazi. So, I went to the police first and gave a statement and I was given a form then proceeded to do a medical statement. Right now (around 10:15 hours), I am doing the final statement, I am at the police right now in Lundazi. But I am hurt, my lower lip is hurting and I am bleeding from my mouth and nose," explained Lungu. Lungu travelled from Chipata to Lundazi on Monday and spent a night in Lundazi to cover the Mkomba Ward by-election. Meanwhile, Eastern Province Police Commissioner Luckson Sakala said he had not vet received the report. The development comes amidst sporadic political violence, which occurred in Sesheke, Southern Province, where a parliamentary by-election took place, Tuesday.

Civil Society for Poverty Reduction (CSPR) executive director Patrick Nshindano says parliamentarians should throw away their political patronages when debating critical Bills in Parliament this sitting.

In an interview, Nshindano said as Parliament resumed sitting, Tuesday, he expected progress on the enhancement of important Bills like the Public Finance Management and the Planning and Budgeting Bills.

"As Civil Society for Poverty Reduction, we are quite expectant for the next sitting of Parliament, and this is because there are quite a number of Bills that remained hanging from the last sitting, especially those to do with enhancing Public Finance Management. Issues to do with Public Financial Management in this country have become very topical, and we have a lot of allegations both in the public sector and also from official information in terms of the AG's Report and information from the FIC (Financial Intelligence Centre) that highlights misapplication of public funds by government officials. And we are asking for progress with regards to reforms in that direction, specifically for Public Finance Management Act," Nshindano said.

"But there are equally other critical pieces of legislation that

need to be passed that includes issues to do with (the) Planning and Budgeting Bill that we hope this time around will be passed; issues to do with Access to Information Act. These will bring about transparency and

accountability." He said it is also expected of Parliament to review the Loans and Guarantees Act and harmonize it in accordance with constitutional provisions. "And also, one of the major challenges that the country has faced is that of debt. As you know, Zambia has become known to be one of those countries with high debt burden, currently, which is impacting negatively on our national budget and also on our ability to be able to provide descent services, such as health, education and so on where we have even noted a reduction in terms of allocation to the these sectors. So, one of the things that we expect from Parliament is the review of the Loans and Guarantees (Act) for it to be well-harmonized according to the constitutional provisions because the constitutional provision in its current form does provide for parliamentary

oversight of government in terms of loans acquisition," Nshindano said.

"And we hope that with the revision of the Loans and Guarantees, those can be able to be harmonized, because currently, the Loans and Guarantees basically provides for the Minister of Finance to be able to do that on behalf of the nation. And that is very critical because we cannot

place that mandate solely to an individual or a single Ministry because you are basically incurring debt on behalf of the citizens and the citizens have to have a right on the nature of debt in which you are incurring and what you are going to be using that debt for." And Nshindano urged all members of parliament to be objective when debating about the named Bills to benefit of all

"Of course, there are a number of other (pieces of) legislation that we will be keeping our eyes on the ground as you know, there is a process of constitutional reforms that basically hinges on the wellbeing of our country in terms of our legislative framework including Public Order Act. Thieves blow off Chipata Diocese treasury, steal **US\$3,000, K18,000**

Unkown robbers yesterday broke into the Catholic Diocese of Chipata in Eastern Province where they blew off the Church Treasury with unknown explosives and got away with USD\$3000 and K18,000.

Eastern Province Police Commissioner Luckson Sakala confirmed this to News Diggers in an interview, explaining that the incidence happened in the early hours of Tuesday and that police had already launched investigations into the matter but that no arrests had been made yet.

Meanwhile, in a separate interview, Chipata Diocesan Chancellor Fr Denis Phiri gave News Diggers a brief narration of what transpired.

"Yes, we recorded a robbery at the Catholic Diocese of Chipata in the early hours of today. Some unknown people broke into

the office of the Treasurer General, where they collected monies amounting to USD \$300 and K18,000," Fr Phiri explained. "They blew the Safe in the Treasure General's office using unknown excessive explosives and because this happened very early in the morning just at about 01:00 hours, no one saw the robbers; we didn't see them and we don't know if they were armed. All we know is that they searched a number of offices within the Diocese before they finally got away with the money they took away from the Treasure General's office." He said police only came to the scene after the robbers had

already fled.

"However, some alert security guards who were guarding buildings next to the Church heard noises and they quickly alerted the police who later came and inspected the scene," explained Fr Phiri.

Last year, 10 armed robbers broke into the residence of Chipata Diocese Bishop George Lungu where they stole his laptop and two mobile phones.

Eastern Province police commissioner said the robbers were armed with a fire arm suspected to be a pistol and some machetes.

Many a time, we Africans complain that the Western world always thinks negatively about us. Our government leaders bitterly lament that Western media enjoys portraying Africa in bad light, ignoring the success governance stories. That is true, but the other truth is that, it is all in the type of news that we feed them.

So instinctively, journalists look out for the negative where the positive is supposed to happen and vice versa.

A few days ago, The UK Times published a story with a Headline "Zambia's president Edgar Lungu tries to kill Hakainde Hichilema". This story came in the aftermath of a police operation conducted in Sesheke where the opposition UPND leader and his supporters were forced to abandon their campaign meeting by weapon-firing police officers. Mr Hichilema claimed that President Lungu sent police to assassinate him that day, and the British media carried the story as narrated to them.

We do not think that it is true that police were instructed to shoot down Mr Hichilema. We don't think that, even if President Lungu desired to see Mr Hichilema dead, he would order an assassination in that fashion. But unfortunately, this UPND claim can easily

Environment in multiple crises - Report

Politicians and policymakers have failed to grasp the gravity of the environmental crisis facing the Earth, a report claims.

The think-tank IPPR says human impacts have reached a critical stage and threaten to destabilise society and the global economy.

Scientists warn of a potentially deadly combination of factors. These include climate change, mass loss of species, topsoil erosion, forest felling and acidifying oceans.

The report from the centreleft Institute for Public Policy Research says these factors are "driving a complex, dynamic process of environmental destabilisation that has reached critical levels.

"This destabilisation is occurring at speeds

unprecedented in human history and, in some cases, over billions of years."

So what is needed? The IPPR warns that the window of opportunity to

avoid catastrophic outcomes is rapidly closing. The authors urge three shifts in

political understanding: on the scale and pace of environmental breakdown; the implications for societies; and the subsequent need for transformative change. They say since 2005, the number of floods across the world has increased by 15 times, extreme temperature events by 20 times, and wildfires seven-fold.

At least climate change features in policy discussions, they say - but other vitally important impacts barely figure.

What issues are being underplayed?

Topsoil is being lost 10 to 40 times faster than it is being replenished by natural processes Since the mid-20th Century, 30% of the world's arable land has become unproductive due to erosion

95% of the Earth's land areas could become degraded by 2050 These matters are close to home for British politicians, the authors argue, with the average population sizes of the most threatened species in the UK having decreased by two-thirds since 1970.

The UK is described as one of the most nature-depleted countries in the world

Some 2.2 million tonnes of UK topsoil is eroded annually, and over 17% of arable land shows signs of erosion.

Nearly 85% of fertile peat topsoil in East Anglia has



been lost since 1850, with the remainder at risk of being lost over next 30-60 years.

The IPPR says many scientists believe we have entered a new era of rapid environmental

change.

The report warns: "We define this as the 'age of environmental breakdown' to better highlight the severity of the scale, pace and implications of environmental destabilisation resulting from aggregate human activity."

Will society take the solutions on offer?

Simon Lewis, Professor of Global Change Science at University College London, told BBC News: "IPPR are right to say that environmental change is happening ever-faster and threatens to destabilise society. "Future problems with food supplies could cause price spikes that drive civil unrest,

while increases in levels of migration can strain societies.

"Both together could overload political institutions and global networks of trade.

"This century will be marked by rapid social and environmental change - that is certain. What is less clear is if societies can make wise political choices to avoid disaster in the future."

Harriet Bulkeley, a geography professor at Durham University, told BBC News that the IPPR paper was a good interpretation of the current evidence, but she said it raised the question of how firm evidence of environmental threats had to be to prompt government action. BBC

Dairy foods help burn fat, speed weight loss

Stocking the refrigerator with milk, cheese, and yogurt may make it easier to lose those extra pounds and burn fat without cutting back drastically on calories, according to new research.

Although calories still count, the study showed that obese adults who ate a high-dairy diet lost significantly more weight and fat than those who ate a low-dairy diet containing the same number of calories

"If you compare a dairy-rich versus a dairy-poor diet you can nearly double the rate of weight and fat loss with the same level of calorie restriction," says researcher Michael Zemel, PhD, professor of nutrition and medicine at the University of Tennessee in Knoxville.

Zemel says the study also showed that eating three to four servings of dairy products a day is more effective at enhancing



weight loss efforts than calcium supplementation alone with pills or calcium-fortified foods. The study appears in the April issue of Obesity Research and was supported by the National Dairy Council, a WebMD sponsor. Previous studies have already shown that dieters who eat a calcium-rich diet are more successful at losing weight, but this study indicates that it's more

than just the calcium in dairy products that helps shed pounds. "Calcium is a critical factor in controlling what your body does with calories, and dairy is an even more critical factor," says Zemel. "Without changing how many calories we take away, we can alter how much weight and fat you lose."

Dairy Products Beat Calcium for Weight Loss

'This Is America' makes

Grammys history

Childish Gambino has made Grammy Awards history by winning both song and record of the year for This Is America. It's the first time a rap song has won both categories although Gambino did not attend or perform at the event. He was the first artist to be absent from collecting one of the "big four" Grammys since Amy Winehouse in 2008. Gambino Glover - beat competition from Drake, Lady Gaga and Bradley Cooper in both categories. Kendrick Lamar and SZA's All The Stars, Brandi Carlile's The Joke and The Middle by Zedd, Maren Morris and Grey were also up for both awards. This Is America, which was accompanied by a symbolic music video, sparked debate when it was released in May. It looked at the representation been defended by its director, of black people in America and the prejudices they faced. While record of the year recognises everyone involved in a song, including the artist, producers and engineers, song of the year is awarded to the writer. This Is America co-writer

Ludwig Goransson collected the awards on Gambino's behalf.

He said he did not know why Gambino had declined to attend but explained how important recognising rap and hip-hop artists at the Grammys was.

"I think if you listen to the radio or if you just watch our culture, if you look at the most downloaded, streamed artists... you see what people are getting inspired by," said Goransson backstage. "It's about time that something like this happened with the Grammys. They're getting the same kind of senses as the people." In addition to song of the year and record of the year, This Is America won awards for best music video and best rap/sung collaboration. Rapper 21 Savage, one of the collaborators on the track, was unable to attend the ceremony because he is being detained by US officials over an expired visa.

Channel 4 rejects Michael Jackson estate complaint over documentary

Channel 4 is to air controversial documentary about Michael Jackson, despite receiving a letter of complaint from the late singer's estate. Leaving Neverland focuses on two men who claim the pop superstar abused them when they were children.

The family of the late singer have asked the broadcaster not to show it, saying the filmmakers did not ask them for a response to the allegations. In a statement, Channel 4 said it had followed the right response procedure. "Channel 4 viewers will make their own judgement about the testimony of the two victims interviewed in the film," it said. In the letter, which was released to the Associated Press, the Jackson estate claimed the documentary's makers broke programming guidelines by failing to get a response from the singer's family and friends. "I think we can all agree that the false allegations being made in your 'documentary' are 'significant allegations," the letter said.

Gordon Banks. **England World Cup-winning** goalie, dies at 81



England's 1966 World Cup-winning goalkeeper Gordon Banks has passed away at the age of 81.

The veteran shot-stopper, who played for Stoke City and Leicester City among a storied career, died peacefully in his sleep overnight, his family confirmed.

Banks was a two-time League Cup winner with the Potters and the Foxes but is best remembered for his contributions on the international stage, where he won 73 caps for his country. He started every game for his country during the 1966 tournament and played in the 4-2 victory over West Germany in the final.

Four years later, he was a member of the England squad which reached the quarter-finals in Mexico, where he made a legendary save against Brazilian striker Pele in the group stages. Goal.com
