Patriotic Front Secretary General Davies Mwila says the ruling party will petition the "violenceinduced election results" of Sesheke parliamentary the by-election, which elected UPND's Romeo Kang'ombe. And Mwila has demanded answers from the Zambia Police Service on why PF members were butchered like criminals at the hands of the police. In a statement issued, Wednesday morning, Mwila argued that PF lost Tuesday's Sesheke by-election not because its development agenda did not sell, but because enemies of democracy and "violent merchants of death" disturbed the peace and turned the constituency into a blood bath. "The Patriotic Front hates violence. In light of the foregoing, let it, therefore, be made clear that we will petition the violenceinduced results of the Sesheke by-election. We also look forward to the Bahati constituency byelection, which we shall adequately be prepared for," Mwila stated. He accused the opposition UPND of having shattered the peace in Sesheke, which led to the PF's loss of the seat.

offer presented to him, and instead rushed to report the matter to the police, who immediately moved in and apprehended the couple. "There is a couple, which killed their neighbour's son in Kabanga area. The couple's names are Bonaventure Mwewa and Esnart Mwewa. They even removed his heart, which they went to sell to a local businessman Patrick Mwansa. They told him that they needed money. But Mr Mwansa expressed shock that he doesn't deal in ritual dealings and reported the matter to the police. Police quickly moved in and arrested the couple last night (Monday night). The body and heart of the boy, who was only three years old, are lying in the hospital mortuary at Samfya District Hospital," narrated the source. Police Spokesperson Esther Katongo confirmed the arrest in a statement but could not name the suspects, apart from stating that the couple was aged 27 and 22 respectively and both from Kabanga village in Chief Kasoma Bangweulu's area. "It was reported that on Sunday, 10th February 2019, around 12:00 hours, the deceased went missing from his home and his uncle aged 47, made a report at Samfya police station. After intensive investigations, the two suspects led the police to the scene of murder where they found the body of the child bundled in a sack and hidden in the bush. Police also recovered a suspected human heart, which was concealed in a lunchbox, believed to have been removed from the deceased," explained katongo.

The Human Rights Commission (HRC) has called on political stakeholders to seriously commit to the national dialogue and set the agenda for reconciliation, peace and unity, saying there is need for national healing before the crucial 2021 general election. In a statement issued, Tuesday, HRC spokesperson Mweelwa Muleva condemned the spate of violence that characterised the Sesheke parliamentary by-election campaigns in Western Province, and called for serious commitment to the national dialogue process to prevent future occurrences of violence. The Commission, who were on the ground during the whole election campaign time monitoring proceedings in Sesheke, also condemned the

continued application of excessive force by the Zambia Police Service to respond to perceived or actual threat to the breach of peace. "The Commission condemns the excessive political pressure and threats against police officers, which has resulted in unlawful and unprofessional conduct of the men and women in uniform for fear of political victimisation, such as being transferred to seemingly unfavourable places or position, or being retired in the 'national interest' if they disobeyed political orders. The violence and the suppression of the right to freedom of assembly that were witnessed during the campaigns for the on-going by-elections underline the imperative need for an immediate solution. To this effect, the Commission calls upon all stakeholders to immediately resolve differences over the national dialogue and set the national tone and agenda for national reconciliation, peace and unity," Muleya appealed. "There is need for national healing before the 2021 presidential and general elections. It is extremely disheartening that the country should continue witnessing and experiencing its own citizens trying to exercise their democratic rights and freedoms being injured, and in some cases, losing lives when such regrettable violations could easily be prevented through political leaders talking to each other and preaching peace and love for each other." Muleya further called for the independence of the Electoral Commission of Zambia (ECZ), saying the Commission must be allowed to conduct their work professionally and legally

without any influence from politicians. "The Commission (HRC) is confident that the ECZ will continue to handle the electoral process, including the counting, transportation and collation of results of the on-going by-elections, with utmost transparency and sensitive to avoid misunderstanding and suspicion. The Commission also appeals to the leaders of the participating political parties to refrain their supporters from engaging in acts of violence and other unlawful acts, which have potential to undermine the integrity and legitimacy of the election outcome. The ECZ must be allowed to professionally and legally conduct their work without undue influence in order to uphold and protect the free expression of the will of the electorate in voting for candidates of their own choice," insisted Muleya.

### UPND councillor appeals 18 month jail sentence

UPND Kanyama Ward 10 Councillor Brighton Bilumba has appealed against his one year six months sentenced slapped on him by Magistrate Felix Kaoma on Monday for theft involving K53,600. And Bilumba has asked the Magistrates' Court Lusaka to grant him bail pending his appeal in the Lusaka High Court. Magistrate Kaoma convicted and sentenced Bilumba to 18 months' imprisonment with hard labour for stealing the said money from the Lusaka City Council (LCC). Bilumba was facing one count of theft by servant contrary to section 272 and 277 of the penal code chapter 87 of the laws of Zambia and had pleaded not guilty in April last year. Particulars of the offence were that Bilumba, 39, between December, 2017, and January, 2018, in Lusaka, being a person employed by the local government as a civic leader stole K53,600 cash, the property of the Government of the Republic of Zambia. In his ground of appeal, Bilumba stated that his conviction was unsafe and againstthe weight and totality of evidence. Arising from this, he has asked the Lusaka Magistrates' Court to grant him bail, pending his appeal in the

Lusaka High Court, saying his appeal has a higher chance of success. In an affidavit in support of summons for bail pending appeal filed in Lusaka Magistrates' Court criminal registry, Monday, Bilumbaclaimed that his appeal would not be prejudicial in any way to the State if the court granted him bail. He added that if the High Court was to uphold the sentence, he would serve the sentence imposed on him by the High Court. Bilumba observed that the State would not be able to compensate him for serving the sentence imposed on him if the High Court was to allow the appeal. He also argued that he was not a flight risk because his family resides in Lusaka, adding that he was ready to meet the bail conditions that the Court may impose. "I am ready to furnish sureties to the satisfaction of the Court and I believe that this Court can grant me bail pending appeal with reasonable conditions seeing the circumstances of the case that no loss to government was occasioned for which I can fail to attend court. I reasonably believe that my appeal has higher prospects of success and considering the time that appeals take to dispose," stated Bilumba. The matter will come up on February 15, 2019, for hearing of the bail pending appeal.

### Bushemi Clinic drags HPCZ to court over forced closure

By Zondiwe Mbewe Bushemi Clinic has dragged the Health Professionals Council of Zambia (HPCZ) to court for allegedly closing down the health facility and fining it K540,000 on grounds of dispensing expired drugs. In this matter, Bushemi Clinic (Hands of Divine Blessings Limited) has applied for judicial review in the Lusaka High Court seeking, among others reliefs, a declaration that HPCZ has no

It is further seeking an order to compel HPCZ to reopen the health facility to the general public. In a notice of application for leave to apply for judicial review filed in the Lusaka High Court, Monday, Bushemi Clinic stated that on December 5, 2018, HPCZ inspectors entered its premises and conducted an impromptu inspection of the health facility. It stated that by a letter dated December 5, 2018, HPCZ ordered for the closure of the health facility, adding that it was also fined K540,000 to be paid within 14 days for breach of the provisions of the Health Professions Act. "By a letter dated December 5, 2018, the respondent ordered for the closure of the applicant's health facility anchored on the findings contained in the inspection report generated by the inspectors of the respondent and furnished to the applicant on January 11, 2019. The

inspection report generated by the respondent revealed that the applicant had been dispensing expired drugs and medical supplies to the general public in contravention to the act," read part of the court documents. Bushemi Clinic argued that only a court of competent jurisdiction could fine it after finding it guilty for offending the provisions of the Act and that the fine could only be paid after trial. It now wants the Court to quash the decision of the Council and make a declaration that the HPCZ had no power to fine it for breach of the Health Professionals Act No 24 of 2009, and that the alleged fine imposed on it was illegal. It also wants an order of mandamus to compel HPCZ to reopen the clinic to the general public and also pay damages for loss of business caused. Bushemi Clinic requested for a hearing of the application for judicial review before a judge pursuant to Rule 3 (3) of order 53 of the rules of the Supreme Court.

National Development and Planning Minister Alexander Chiteme says there are still inherent weaknesses in the agricultural statistical information system in Zambia.

And Chiteme has disclosed that Zambia still lacks contemporary data on the country's forestry subsector.

Meanwhile, the African Development Bank (AfDB) says it places agriculture as one of its key priorities areas in meeting the challenge of inclusive African development in the country.

Delivering a speech on behalf of Chiteme at the dissemination meeting of the Zambia Strategic Plan for Agriculture

Zambia lacks data on forestry sub-sector – Chiteme and Statistics Rural Dissemination in Lusaka, Permanent Wednesday, Secretary Chola Chabala explained that despite the important role agriculture played in Zambia's rural economy, there are still inherent weaknesses in the agricultural statistical information systems being given out.

"Agriculture is the back bone of Zambia's rural economy and this sector contributes on average at least 10 per cent to the Gross Domestic Product (GDP), which absorbs about 67 per cent of the labour force and supports livelihoods of more than 70 per cent of the population. Therefore, the strategic role of

agriculture and rural sector to the national economy cannot be underplayed. I should admit that there have been weaknesses in the agricultural statistical information system despite the important role agriculture plays in the rural economy of this nation," Chiteme noted. He said the Strategic Plan for agriculture and rural statistics for Zambia would provide the country with

an opportunity to improve statistics for food security, sustainable agriculture and rural development. And Chiteme said that although basic statistics on crops, livestock and fisheries production are

contemporary

available,

statistics on the forestry subsector remained a major challenge in Zambia.

"Forestry statistics are especially important given the impact of climate change on our (African) continent and the role that forestry development can play in mitigating this. Let me also state here that, although basic statistics on crops, livestock and fisheries production are available, availability of statistics on forestry is a major challenge in our country," Chiteme said. Meanwhile, AfDB senior private investment officer

Mdaniso Sakala said the bank placed agriculture as one of its key priorities areas in meeting the

challenge of inclusive African development in the country.

"Agriculture plays a central and strategic role in the development of the country as it is the key to economic growth, increased income, improved living standards, eradication of poverty and improved food and nutrition security. As the bank, we have formulated the Feed Africa Strategy in addressing issues of agriculture as one of its key priorities areas in meeting the challenge of inclusive African development in the country. These include: Light Up and Power Africa; Industrialized Africa, Integrating Africa and Improving the quality of



life of the people of Africa," said Sakala.

The Strategic Plan launch for agriculture and rural statistics is aimed at improving the quality and availability of agricultural statistics in the country.

# We will send Lungu, Kampyongo to ICC for crimes against Humanity - UPND

By Thomas Mulenga UPND deputy secretary general Patrick Mucheleka says his party's victory Tuesday's Sesheke in parliamentary by-election shows that people are ready for change despite the hostile political environment created by the ruling party.

In an interview, Wednesday, Mucheleka also warned that President Edgar Lungu and Home Affairs Minister Kampyongo Stephen would be extradited to the Criminal International Court (ICC) for the crimes committed by the police in Sesheke once the UPND formed government.

"The people of Sesheke have spoken loud and clear and they have demonstrated that when it comes to the will of the people, no amount of intimidation, no amount of gun firing, teargassing can stop the will of the people! The people of Sesheke did not fear the guns that President Lungu

and Kampyongo imported into Sesheke as a means of intimidating them and creating fear so that a few PF cohorts could go and cast a vote for them because even in Sesheke, there are a few individuals who eat with PF and those are the few who voted for them! But the reasonable majority of people of Sesheke put fear aside and voted for the UPND," Mucheleka said.

"The people of Sesheke have demonstrated that when time comes, they cannot fear guns or any form of intimidation, and sooner than later that will spread out to the rest of the country. People are ready for change, people are saying 'enough is enough!' These are fellows in PF, ministers who are looting, robbing the people of Zambia, daylight robbery! The people of Chitotela, and he is not the only one, it starts from the highest. And this is why they are so desperate and ready to kill! But as they endanger other peoples' lives, they must know that their own lives will also be in danger because people will not sit back and allow Lungu to think that he will always use the police to cause mayhem." And Mucheleka warned that President Lungu and Kampyongo would be extradited to the ICC for crimes against humanity once the UPND forms government. "In Africa, we have examples of dictators who have ended up very badly, even Lungu's godfather Robert Mugabe himself,

next door in Zimbabwe, it not General was Chiwenga himself who turned against Mugabe? People are not happy, the police are not happy, people in the (civil) service are not happy. Yes, he may have (Inspector-General Kakoma) Kanganja, but the body language of the police as shown yesterday, must tell you something. Those same police officers will turn against Lungu, against Kampyongo and we shall use the same police officers at the right time to arrest Lungu and Kampyongo for crimes against humanity! These are people who are likely to end up at the Criminal International Court in the Hague for crimes against humanity because they committed crimes against humanity. They may get away with it now, but time will come for them to be held accountable for these atrocities. The good part is that people are ready to defend themselves. people are ready to defend democracy as the case was in Sesheke," Mucheleka said. "Wherever they go, they instil fear through the use of violence. They carried thugs from Intercity (Bus Terminus), Kulima Tower and other places in Lusaka to go and cause violence in Sesheke; you saw what they were doing and the police reacted, you saw how they were butchered! I want to ask President Lungu and Kampyongo, let them, for once, read a book by George Orwell called 'Animal Farm,' which talks about how a particular pig

trained dogs and used them to cause violence on other animals. What happened later on was that the same dogs later on turned against the pig that trained them to be inflicting pain on other animals! It is a clear message on President Lungu and Kampyongo: those PF thugs they are sending to attack innocent people, tomorrow will turn against them! We have seen that before. You saw the police reaction on PF thugs, it was not a good sign, Lungu and Kampyongo must worry."

And Mucheleka insisted that Kampyongo was ignorant to suggest that the UPND could not hold rallies where President Lungu was also campaigning in Sesheke, arguing that there is no such a law in the Republican Constitution.

"You saw the PF thugs with offensive weapons and how they caused mayhem during the campaigns because they are so dull and shallow they don't even know the law! Listen, what a Minister of Home Affairs was saying that 'the law will visit you,' because for him, when President Lungu is in Sesheke for campaigns, you don't have to be there as opposition political parties, which law says that? And that was coming from a Minister of Home Affairs? What a shame! How can you have a Minister of Home Affairs who has no iota of even any form of common sense or little intelligence to understand the Constitution? It's such a shame to have such people, thugs masquerading as leaders," said Mucheleka.

### South Africa deports **25 Zambians**

About 25 Zambians have been deported from South Africa back to the country for various immigration offences. And Zambia's High Commissioner to South Africa Emmanuel

Mwamba has called on Zambians travelling to South Africa to follow the right procedure to avoid inconveniences.

According to a statement issued by the First Secretary for Press and Public Relations at the Zambian High Commission in South Africa Naomi Nyawali, Wednesday, the 25 were deported back to Zambia following a round-up operation conducted by South Africa's Ministry of Home Affairs.

"The 25 were deported back to Zambia following a round-up operation, which was conducted by that country's Ministry of Home Affairs and were detained at Lindela Holding facilities in Krugersdorp West, Gauteng Province," Nyawali disclosed.

She stated that the deported Zambians were found with offences like overstaying in South Africa, others had no immigration permits that allowed them to stay or work in South Africa, while others had finished serving their jail terms for criminal offences.

She added that 14 people had since been repatriated to Zambia, whilst 11 were given a grace period for self-repatriation.

"According to the information made available to the Zambia High Commission in Pretoria, the deported Zambians were found with offences of overstaying in that country. Others were found with no immigration permits that allow them to stay or work in South Africa, while others had finished serving their jail terms for criminal offences. 14 people have since been repatriated to Zambia by the South African government, whilst 11 were given a grace period for self-repatriation," Nyawali stated.

"South African authorities observed that Zambia was among the countries with the lowest number of her nationals that had offended immigration laws as compared to other countries." And High Commissioner Mwamba appealed to Zambians travelling to South Africa to follow the right procedure when

travelling to avoid being inconvenienced. He further said the Mission issued 28 gratis travel documents to

some Zambians that needed help from the High Commission. Mwamba added that the Mission issued about 983 travel documents in 2018 to Zambian nationals that lost their passports or had overstayed.

He noted that the Mission was closely monitoring the welfare of its citizens to ensure that they do not come into conflict with that country's laws.

### DEC arrests former ZAF commander, Chimese for theft

The Drug Enforcement (DEC) has Commission arrested former Zambia Air Force (ZAF) Commander Lt General Eric Chimese for various criminal offences and has since ceased his properties suspected to be proceeds of crime.

the level of responsibility and power that a minister has, it is our considered view as LAZ that it is not appropriate for honourable Chitotela to continue serving as Minister whilst facing criminal charges and appearing in court pending the determination of the matter. We also hold the view that prosecution of a sitting minister in the courts of law cannot be effective. We therefore call upon honorable Chitotela to seriously reflect on his abilities to effectively and in good conscience run the affairs of his ministry at the same time defend himself in court. We firmly believe that under the current circumstances, the minister ought to resign from public service." On 5th February, 2019, The Anti-Corruption Commission (ACC) arrested and charged Chitotela with two counts of concealing property suspected to be proceeds of crime, contrary to Section 71 (1) of the Forfeiture of Proceeds of Crime Act, Number 19 of 2010.

Chitotela, saying keeping the minster in office while facing corruption charges defeats morality, integrity and the fight against corruption. But LAZ has also observed that there is no law in Zambia that makes it mandatory for the President to fire ministers who are arrested or charged with corruption. Responding to a News Diggers press query, the Council of the Law Association of Zambia, LAZ argued that having Chitotela continue serving as minister would make it almost impossible for the prosecution to take a course of fair justice. LAZ explained that the proposal to have Chitotela suspended or dismissed was not meant to punish him but to ensure that the investigations and prosecution

"It is our considered view that the rule of law and the national values and principles of good governance and integrity in the discharge of public functions enshrined in our constitution are not and cannot be enhanced by letting a minister to continue serving when he is subject of prosecution. It is for this reason that a number of provisions applicable to public officers require an officer subject of prosecution to be placed on suspension. The purpose of the suspension is not to discipline or impose a penalty on the accused but to ensure sound and proper administration, good governance and above all public interest," stated the Council." "It is also to ensure that the investigations and prosecution proceed unhindered and without

Further, dismissing a sitting minister facing prosecution does not offend the constitutionally recognized right of presumption of innocence. It is therefore the position of LAZ that the President should indeed consider relieving honourable Chitotela of his duties as not doing so does not support the fight against corruption, which the President has on numerous occasions publicly supported." LAZ, however said the President was not mandated by law to fire Chitotela. "Following the arrest and charging of Hon Chitotela, certain sections of society called for the dismissal of the minister by the President. However, the President refused to dismiss the minister and in aid of his decision cited Article 18 of the Republican constitution, which

However, the said section 18 further provides that nothing stops or limits the right of a minister to resign as Minister. The move to petition the court followed Mnangagwa's announcement of new fuel prices on January 12 2019, making the commodity the most expensive in the world.

"This is an application seeking a provisional order and then a final order to set aside all recently ordered fuel price rises on the grounds of being patently illegal and also unconstitutional and of irreparable harm to us and others," Majongwe said in his founding affidavit.

his proclamation, Mnangagwa pegged the price of petrol at \$3,36 from \$1,32 and diesel from \$1,24 to \$3,11. The fuel increase however, led to violent protests, which resulted in extensive damage to property and looting. A brutal military crackdown, which ensued, resulted in the death of 17 people, torture and arrest of thousands.

"These increases made our fuel the most expensive in the world by a long way overnight, as can easily be confirmed from globalpetrolprices.com. We later found that the Presidential statement on fuel prices was not binding in law, but merely set as a policy. We have also found out that for all law-abiding citizens our fuel prices before the increases were already higher than the fuel prices for all of our neighbours," Majongwe said.

"We also later found out that two Statutory Instruments (SI) were published in an extraordinary Government Gazette on the same day as the President's statement. The two SIs were apparently meant to give legal effect to the President's Press announcement, with the Minister of Finance increasing duty on petroleum products, while the Minister of Energy prescribed new pricing formulae for these."**BBC** 

### Katy Perry 'saddened' by blackface claims about her shoe range

Katy Perry has removed two items from her shoe range after complaints that one of the designs was racist.

Katy says she is "saddened" that her design - blue eyes and red lips on black leather - was compared with "painful images" of blackface by critics online.

The shoes have reportedly also been taken off shelves at US retailers.

Katy says the shoes, The Rue and The Ora, were "envisioned as a nod to modern art and surrealism". Blackface is a centuries-old practice rooted in depicting a negative stereotype of black



people in Europe and the US. White actors would paint their faces black and play

caricatures of black people. "I was saddened when it was brought to my attention that it was being compared to painful images reminiscent of blackface," Katy says in a statement.

"Our intention was never to inflict any pain. We have immediately removed them." The shoes that offended some people were part of a Katy Perry Collection launched last summer which was sold in US stores such as Dillard's and Walmart.

They were also available in blue, gold, graphite, lead, nude, pink, red and silver, according to a statement by Global, the company Katy Perry is in partnership with. In the UK they're available through Amazon, but neither The Rue or The Ora are on sale. Last week, Gucci was forced to pull a jumper from its new collection after similar accusations about blackface. Fashion designer Suril Patel thinks that fashion companies and houses are creating products "on purpose just to spark the controversy".

## Lovers, comrades! Forbidden love in North Korea finds a way in Vietnam

It was 31 years after Pham Ngoc Canh, 69, took that first photo of Ri Yong Hui, before the two were finally allowed to get married in 2002 when North Korea took the rare step of allowing one of its citizens to marry a foreigner.

"From the moment I saw him, I was so sad because I felt it would be a love that could never be realized," said Ri, 70, speaking from the small Soviet-era apartment she and Canh share in the Vietnamese capital, Hanoi. Now enjoying freedoms in Vietnam that would be impossible in North Korea, Canh and Ri are hoping the upcoming summit between U.S. President Donald Trump and North Korean leader Kim Jong Un in Hanoi will help end hostilities with Pyongyang. "If you're a North Korean, you want to see this resolved. But politics is complicated," Ri said. "When people first heard Kim Jong Un decided to meet Trump, they expected reunification to happen soon. But that's hard to realize in just one or two days. I hope things work out well." Today one of Asia's fastest growing economies and integrated into the international community, Vietnam has been touted as a model for isolated and impoverished North Korea to follow. Back in 1967, as Vietnam and the United States were locked in war. Canh was one

of 200 Vietnamese students sent to North Korea to gain the skills the state needed to rebuild itself once the war was over.

Several years later, during a chemical engineering apprenticeship at a fertilizer factory on North Korea's east coast, Canh

spotted Ri working in a laboratory. "I thought to myself, 'I must marry that girl," said Canh, who eventually plucked up the courage to approach Ri and ask her for her address. Ri obliged: Her friends had told her one of the "Viet Cong" working at the factory looked just like her, and she was curious. "As soon as I saw him, I knew it was him," said Ri. "He looked so gorgeous". "Until then, when I had seen so-called handsome guys I hadn't felt anything, but when he opened the door, my heart just melted".

repeated monthly until he returned to Vietnam in 1973.

"I went to her house secretly, just like a guerrilla," said Canh.

Upon his return to Hanoi, Canh felt disillusioned. The son of a high-ranking cadre, Canh refused to join the Communist Party, forgoing the bright future the state had planned for him

"My mother was crying while caring for me," said Ri. "I think she knew that I was lovesick."

In 1992, Canh again managed to get himself on a trip to North Korea as a translator with a Vietnamese sporting delegation, but couldn't meet Ri. When he returned to Hanoi, Canh found Ri had sent him a letter. She still loved him

But there were challenges. Until this day in North Korea, and in Vietnam at the time, relationships with foreigners are strictly forbidden.

After the couple exchanged several letters, Ri agreed to let Canh visit her at home. He had to be careful. A Vietnamese comrade had been beaten when he had been found with a local girl.

Dressed in North Korean clothes, Canh embarked on the three-hour bus journey and two km walk to Ri's home - a trip he

"I just couldn't agree with a socialism that stops people from loving each other," Canh said.

Five years later, in 1978, the Vietnamese chemical engineering institute Canh was attached to organized a trip to North Korea. He asked to join, and managed to meet Ri. But every time they saw each other, Ri said, she became more heartbroken at the thought that they might never meet again. He had brought with him a letter he had written to the North Korean leadership, begging for permission for them to marry. "When she saw the letter, she asked: 'Comrade, do you intend to persuade my government?", said Canh, who never sent the letter and instead asked Ri to wait for him.

Later that year, Vietnam invaded Cambodia, triggering a border war with China. With North Korea on the side of Beijing and Phnom Penh, the couple stopped writing.

In the late 1990s, North Korea was gripped by a devastating famine and a desperate delegation from Pyongyang visited Hanoi to ask for rice. Vietnam, which by then had undertaken major economic and political reforms and re-engaged with the West, refused.

Canh was so concerned for Ri and her people that he raised seven tonnes of rice in donations from friends to send to North Korea.

It was an act of generosity which finally paved the way for he and Ri to reunite: The North Koreans learned of Canh's act and agreed he could marry Ri and live in either country - provided Ri maintained her North Korean citizenship.

In 2002, the two finally married in the Vietnamese embassy in Pyongyang, and settled into their new life together in Hanoi, where they still live today.

"In the end, love beat socialism," said Canh. Reuters

Former Arsenal manager Arsene Wenger has backed Ole Gunnar Solskjaer's decision to bench his former player Alexis Sanchez, with the Frenchman suggesting Anthony Martial has made the left-wing position his own at the club.

Martial has blossomed this season, scoring nine goals in 20 Premier League appearances so far, while he has managed to hit the net three times in all competitions since Solskjaer's appointment as interim boss.

Chile international Sanchez, meanwhile, has struggled to force his way into Solskjaer's plans, with an injury at the start of the Norwegian's tenure not helping matters, coupled with the improvement in



form of his team-mates. Indeed, Sanchez has not shown his best since swapping Arsenal for United in January 2018 and has scored just five times in all competitions for the club since then. And the 30-year-old again found himself on the end of criticism for his latest display after replacing Martial at halftime in United's 2-0 home defeat against Paris Saint-Germain, with the game scoreless at the break.

Despite signing Alexis for Arsenal back in 2014 from Barcelona, Wenger believes Solskjaer's decision to leave him out is completely
