


# Investors will be the only foreigners owning land under new policy - Kapata

By Zondiwe Mbewe Minister of Lands and Natural Resources Jean Kapata says the proposal in the new draft National Land Policy is that no chief in Zambia will be allowed to give out land without having signatures from 50 per cent of their sub-chiefs. And Kapata says once the land policy is in place, the only foreigners that will own land in the country are investors. was speaking in She Parliament, Friday, during the questions for oral answer. Asked by Bwana Mkubwa PF member of parliament Dr Jonas Chanda whether the Chiefs' Indaba on the draft National Land Policy submitted had officially its recommendations to government; and when the Policy would be finalised, Kapata said the Chiefs' Indaba officially submitted its recommendation government on to 28, last August year. She said her ministry considered the comments and recommendations which

were made by the Chiefs' Indaba and that the response had since been submitted to the House of Chiefs. And Kapata added that her ministry anticipated to finalise the National Land Policy in the third quarter of this year. "The incorporation of the recommendation into the draft National Land Policy will only be done following further dialogue with the House of Chiefs. My ministry anticipates to finalise the National Land Policy in the third quarter of 2019. In order to achieve this, the ministry will reconstitute the technical committee which will finalise editing of the document and will provide the guidance on the decision points that will be agreed upon for inclusion into the revision of the draft National Land Policy," she said. Kapata said once the Land Policy was put in place, most of the land problems would be dealt it. Asked by Kanchibiya PF member of parliament Martin Malama whether there were

considerations in the draft National Land Policy to ensure that land was not sold rampantly to foreigners, Kapata said once the land policy was in place, the only foreigners that would own land in Zambia were investors. "In the draft policy, yes there is a clause which restricts land to be owned by foreigners. The foreigners that are going to own land when the policy is in place are those that are coming in as investors. When we talk about investment, these are the people that we will see that their investment is viable and land will be given for 25 years. If the business that they are doing is viable, then it can renewed," she said. Choma Central UPND member of parliament Cornelius Mweetwa then asked, "Most of the land that these chiefs superintend in many areas of the country has already been alienated to private individuals. We now have chiefs on paper who have no land because they have sold it off. Are you not

considering to reintroduce the promotion of farming blocks which will provide an organised way of making land available for those who want go into commercial farming, to access land which they can be able to use and own on title unlike going on customary land and get title dubiously?" In response, Kapata said the proposal in the new draft policy was that no chief would be allowed to give out land without 50 percent signatures from sub-chiefs. "First of all, the proposal in the new draft policy is that no chief will be allowed to give out land without 50 percent signatures of the sub-chiefs. Because in the past, it has been the chief that gives land without consultation with other sub-chiefs. Yes we have two types of title, we have the one that we give at the Ministry of Lands which is about 99 years tenure, also we are going to have one that is going to issued by traditional leaders which will also go on for 99 years," she said.

Further asked by Mazabuka Central UPND member of parliament Garry Nkombo when her ministry would finally close the process of drafting the National Land Policy, Kapata said when her ministry meets the House of Chiefs this time around, it would be a final meeting.

"This time around when we meet the House of Chiefs, it will be a final meeting amongst ourselves and themselves because we have done enough consultation and whatever they have brought on board, we have actually taken most of them on board," said Kapata.

### Garbage collector in court for stealing fire extinguisher from lodge

ballot papers locally, after all the pronouncements and commitments made. "The President may not tolerate me if I fail to print ballot papers [locally] in 2021, because he himself understands very clearly how much it costs the country to take delegations abroad for purposes of accessing the printing systems there and then going to verify all of those things, transportations of ballot papers and above that, the actual purchase cost. The President wants government to cut that cost substantially so that we get gains from the process. Now, I am on record to say that we are not ready now to print pilot ballot papers but in due course, we will be able to do that. So if

we have an opportunity for a by-election, we are ready [to do the pilot ballot paper printing], which I think won't be late from now given what we are doing. But from where we stand now, we are not ready to do that because we haven't done what is necessary for us to be able to do that. But give us a few months, we should be able to develop

"And just in case we are not able to do the pilot because there may be no byelections at the time when we will get ready, we will do demonstrations and will invite the media, we will invite all stakeholders to come and see how we would have developed that capacity and to come and gain confidence from the Zambian public. I don't want to put a time line to that but in the mid of this year or towards the end of this year, I will be coming with more definite information and I think I will be inviting stakeholders to come and see the progress would have made." Kafwaya meanwhile, regretted that public officers had continued abusing government vehicles. "Many people have been cited in the Auditor General's report, some of the people

taken to court and jailed for corruption but corruption still continues. So abuse of government motor vehicles is just like corruption, it's undesirable, nobody wants it. But no matter how much you publicise it, there is going to be people who are just attuned to doing the wrong things. Every time we have gone out to monitor, we have found some people abusing government vehicles, it is a big problem. My message has always been very clear. I have always said, these resources are not for us as public servants, they are resources for the Zambian people, they are the ones who pay the taxes that we use to buy these resources in order for us to use them in serving the Zambians people. So they are not for self service, and this is why we are not saying this is the Director so let them go, no! If you are a Director, you are directing public service and not self service," said Kafwaya. The Minister who is ruling PF's representative for the Lunte Parliamentary constituency disclosed that most government buildings were not well maintained due to lack of adequate financial resources.

## **PF has gone too far,** *Prime TV* **'closure' spells dictatorship - Kalala**

administration, Jack Kalala, says the Patriotic Front has gone too far with its autocratic governance. of way And NDC leader Chishimba Kambwili says he will engage his alliance partners to mobilise a marching protest against the government's decision to suspend the broadcasting licence for Prime TV. Independent The Broadcasting Authority (IBA) yesterday announced 30-day suspension а of the private stations' licence for unprofessional conduct, causing an instant public outrage. Commenting on the development, Kalala said it was regrettable President Lungu's that government was only tolerating media that sings praises. "This is not the kind of leadership that we had during our time in State House. We allowed the Newspapers [or] the media to operate freely. For your own information, President Mwanawasa preferred to read The Post newspaper which was critical of government than Daily Mail and Times [of Zambia] because it's from the criticism that we learnt were we were going

wrong to be able to correct and do the right thing. But these people want to be praised all the time, it's not right for the country." "Leave Prime TV alone. IBA should not be dancing to the tune of Davies Mwila, PF is a political party. This prime TV is an independent institution, it's a company on its own and the people who have formed that company have got the right to operate as they want, of course within the law. You can not accuse them of being biased, what about ZNBC? We pay levies to ZNBC but they don't cover the opposition, but have they suspended ZNBC? Not at all. Times of Zambia, have they suspended their licence? What about Daily Mail? They have seen that people are not listening to ZNBC and they are not reading the Times of Zambia and Daily mail. So PF wants to take over control of all the media in Zambia which is not fair to the people of Zambia." Kalala said the PF had gone too far with its dictatorship, warning those in government to

remember that they would not stay in power for ever. "The PF have gone too far. They closed down The Post because they did not like what it was publishing, which is wrong. And now they want also to close Prime TV and close every other media that is not towing their line. That is wrong. It's paining us. When I was in State House I did not like everything that The Post published, but I would write a response which they would publish, we never saw the need to close The Post. It's the same with Prime TV, those in State House cannot use IBA to close down media that they don't like. This is total autocracy, it is unacceptable," he said. "It is not for PF to insist that they should remain in power no, they should let the people decide on their own and the only way they can let the people decide is by allowing other political players to freely operate. And the media is key to that process. ZNBC should cover all the political parties both the opposition and the ruling

party equally like they do in UK. In Zambia we pay levy, the people who belong to the opposition pay levy to ZNBC, and so they are entitled to be covered. So what the PF should do is to be democratic. Being democratic means accepting that they are not going to be in power forever." He regretted helping the PF to form government in 2011, saying the party has turned Zambia into a dictatorship. "We didn't expect MMD to remain forever in power. In fact, I even helped to campaign for PF in 2011. George Chellah can confirm, I received Mr Sata in Lufwanyama. [This] is not the same PF that I helped to get to power, It's totally different. It has become autocratic and it is wrong. They want to be the only party to rule, no. Sometimes we even feel guilty that we removed UNIP [from power]? because today President Lungu wouldn't have been in power. Why should he not allow other people to become presidents?" asked Kalala. "If Rupiah Banda had behaved the way Lungu is behaving, I don't think PF would have won the elections in 2011. They wouldn't have formed government. But he allowed [and] gave freedom to the political parties to operate the way they wanted."

Meanwhile Kambwili said the opposition alliance would soon be applying for a permit to conduct a demonstration against the suspension of Prime TV licence. "This will not be allowed and it will be met with maximum resistance. I will be talking to the alliance partners so that we can apply for a permit to demonstrate against the closure of Prime TV. So we are asking the Independence Broadcasting Authority and, of course, the government to rescind their decision of suspending the license for Prime TV. And if you have followed the chronological order in which these things have been happening, look at the ZNBC coverage, it has been so biased to the extent that there has been a lot of misleading statements that come from ZNBC on both national issues and on issues concerning the opposition. IBA has never taken any action against ZNBC, when you watch ZNBC from beginning to end, it's all either government officials or PF cadres. Whenever the opposition has a rally, ZNBC will never cover them," Kambwili said. He warned PF to stop intimidating and interfering with operations of private media. "Mwila first and foremost chased the Prime TV

journalists but where was IBA to defend Prime TV journalists? PF must stop interfering with these professional institutions because this is clearly an indication that from the anger that Mwila showed against the Prime TV, they were only waiting for an opportunity where they could actually pounce on Prime TV and what has happened is unfortunate. If President Edgar Lungu means well and he is a leader of this country who wants to leave a legacy, let him direct the ministry of Information and IBA to immediately lift the suspension of Prime TV. The media is a fourth estate and the citizens of this country are entitled to information of what is happening in the country," said Kambwili. "Intimidating the media in that way is retrogressive. Those should be politics of the 70s. So we stand with Prime TV and we are going to do everything within our means to try and help Prime TV have their license ban lifted. And I think the best way is to have a peaceful demonstration from town all the way up to Mass Media complex and present a petition to the IBA managing director. And the PF government must be ashamed for this decision that they have taken," said Kambwili.

### Abolishing meal allowances will deprive many their right to education - JCTR

**By Sipilisiwe Ncube** The Jesuit Centre for Theological Reflection (JCTR) savs government should enhance recovery of student loans in order to scale up instead of meal In a statement, JCTR stated that the removal of meal allowances for university students may deprive beneficiaries of affording the basic necessities which could in turn infringe on their right to a dignified life. "The fact that student bursaries have been turned into loans to students negates the need to abolish meal allowances as they are subject to recovery. What Government needs to do is to enhance recovery of student loans/bursaries in order to allow for scaling up of bursaries and increase the scheme beneficiaries. While JCTR agrees to the need to scale up bursaries to other public universities, we object to abolishing meal allowances which essentially is denying some students an opportunity

to receive tertiary education. This move is not progressive because it promotes inequality in our society as students from poor families are not allowed to receive tertiary education which is key to addressing the malaise of inequality. The removal of meal allowances may deprive students of affording the basic necessities and may infringe on their right to a dignified life," JCTR stated. JCTR urged government to improve the bursary management system so that deserving and vulnerable students benefitted from the loan scheme. "ICTR urges the government to improve the bursary management system so that only deserving and vulnerable students are the ones to benefit from the loan scheme. As a country we should be talking about increasing meal allowances for our students to enable them meet the high cost of living. Further, JCTR urges the Government to cut down on unnecessary spending in other areas such as foreign

travel of government officials and move those resources to education instead. ICTR also decries the abrupt and unilateral manner in which the decision to abolish meal allowances was made. We therefore call for transparent and consultative process to precede such announcements," stated JCTR. "With the high cost of education, bursaries provide an opportunity for many people to earn an education. Without assistance from an outside source, students may have trouble paying for the degree they need in order to enter the workforce and become a contributing member of society. Provision and enhancing access to education is an investment and not a cost, this has been proved by countries like Japan and China that have educated their citizenry into prosperity. This provides enough evidence that education improves the economy as educated people are more productive and less dependent on provision of public goods."

## Former Miss Zambia loses job over criminal proceedings

**By Zondiwe Mbewe** Former Miss Zambia Cynthia Chikwanda's lawyer James Mataliro has told the Lusaka Magistrates' Court that his client has lost her job at a named company due to the current proceedings. court

In the second count, Chikwanda is charged with destroying evidence contrary to section 111 of the penal code chapter 87 of the Laws of Zambia. Particulars of the offence allege that between January 23 and 24, this year, Chikwanda knowingly and willfully destroyed assorted parts of a motor vehicle registration number ALJ 8125, which were to be required in evidence in court. The duo is also appearing in two other courts similar charges. on Chikwanda is on bail while her co-accused is still in police custody due to failure to comply with bail conditions. And when the matter came up for commencement of trial before magistrate Kate Sakwanda, Monday, the State applied for an adjournment

the saying second Chitunhu, accused, and the witnesses were not before court. However, defence lawyer, Mataliro, strongly objected to the application for an adjournment as the State didn't give reasons as to why the accused was not brought to court. Mataliro said his clients freedoms had been curtailed, adding that Chikwanda had already lost her job. He further said that failure by the State to bring the second accused person to court was contemptuous because the court had previously ordered that the accused persons should appear at 09:00 hours on Monday. He urged the court to frown upon such conduct. Mataliro prayed that if the State was unable to bring the accused to court, then the court should discharge

the accused persons as it was clear that the State was not ready to proceed. "We strongly object the application for an adjournment and pray that this court orders the State to bring A2 before this court today. If they are unable to do that, we pray that this court discharges the accused persons. If the State organises themselves and become ready to prosecute their offences they can do, as for now it's clear that the State is not ready," he said. In reply, the State insisted that the court should adjourn the matter, saying adjournments were a discretion of the court. In her ruling, magistrate Sakwanda adjourned the matter to April 18, 2019 for possible commencement of trial. She further advised the accused lawyer to talk to the State to consolidate

### Kampyongo implores police to go for cyber criminals

**By Mirriam Chabala** Home Affairs Minister Stephen Kampyongo has asked the Zambia Police Service to enhance their efforts in curbing crimes associated with abuse of Information and Communication Technologies such as social media. And Inspector General of Police Kakoma Kanganja says the Police Command is workingtowardsrepositioning the Zambia Police Service to make it more responsive for enhanced public order and safety, in line with the service's many national aspirations. Speaking when he officiated at the Zambia Police Day commemorations in Lusaka, Monday, Kampyongo noted that it had become order of the day for people to concoct stories which were a threat to national security. Kampyongo expressed worry that institutions of governance were threatened and said it was important for the Ministry of Home Affairs to team up with the Ministry of Transport and Communications in ensuring that citizens were protected from cyber criminals. "While my government is working tirelessly to support the law enforcement officers, as minister responsible for internal security, I would like more effort being devoted to curbing crimes associated to abuse of the Information and Communication Technologies, including social media and organised crime. It has become order of the day that people without reasoning and with all the impunity can wake up and concoct stories which are a threat to national security. The institutions of governance are threatened and so it's important that we team up as we have with the Ministry of transport Communications in and ensuring that we protect our citizens from these cyber criminals," Kampyongo said. The minister also implored officers to observe the professionalism at all times.

"Inspector of General of Police, I wish to urge you to ensure that even in our quest to protect constitutional order and national security, discipline and professionalism are enhanced in the service. ### Govt shuts down Prime TV for "unprofessional conduct"

By Sipilisiwe Ncube The Independence Broadcasting Authority (IBA) has with immediate effect suspended broadcasting license for Prime Television and Valley Fm in Nyimba for 30 days and 60 days respectively. IBA director general Josphine Mapoma announced the suspension at a media briefing in Lusaka, Monday. She said Prime TV's licence had been suspended for 30 days for exhibiting unprofessional elements in its broadcasting through unbalanced coverage, opinionated news, materials likely to incite violence, and use of derogatory language. "The other station that has been suspended is Prime Television. The suspension is for 30 days. The Board found that the station has exhibited unprofessional elements in its broadcasting through unbalanced coverage, opinionated news, materials likely to incite violence and use of derogatory language. The station was not only in breach of the IBA Act, but also of their own guidelines that include; (a) Duty to remain balanced, fair and impartial in their coverage; (b) Strive to give equal access

by not discriminating against any political party before, during and after elections; (c) Ensure factual and accurate reporting of all news coverage; (d) Endeavour to be responsible and avoid reports that will incite violence; (e) Not hesitate to correct erroneous reports; (f) Promptly provide for the right to reply and; (g) Avoid inclusion of opinions and emotions in their news stories," she said. And Mapoma said the Authority suspended the licence for Vallev FM in Nvimba district of Eastern Province for 60 days for unprofessional conduct. "The Board has suspended two stations. Valley fm of Nyimba has been suspended for 60 days due to unprofessional conduct. The unprofessionalism was manifested by their failure to moderate and balance a discussion programme. During the suspension, the station is expected to develop an Editorial policy and recruit trained journalists. The station should also conduct training for the Board, Management and staff on Corporate Governance and ethical broadcasting. In addition, Valley FM should air a public apology to Chief Ndake for the embarrassment suffered due to the station's broadcast, which featured an impersonator that misguided listeners. The station must also develop complaints procedures for receiving and addressing complaints," Mapoma said. Mapoma said during the suspension, the affected TV station was expected to conduct in-house training on basic journalism ethics and news script writing. "During the suspension period, Prime Television is expected to conduct in-house training on basic journalism ethics and news script writing. You may wish to know that both Valley FM and Prime television were given an opportunity to be heard and their suspensions are pursuant to Section 29 (1) (k) of the IBA Amendment Act (2010) which provides, 'The Board may suspend a broadcast licence if it consider it appropriate in the circumstances of the case to do so.' In the case of Prime TV, the suspension is also pursuant to Section 29 (1) (i) of the IBA amendment Act which provides 'The Board may suspend the licence if the broadcasting licensee has failed in spite of

written notice to comply with the conditions of the broadcasting licence'. Prime TV was in April 2018 strongly reprimanded by the Authority over similar type of broadcast," Mapoma said. And IBA has revoked the licences for Ngoma radio of Luanshya and Kafue radio for non-payment of the initial licence fees as well as subsequent operating annual fees. Meanwhile asked if the decision to suspend the two licences was politically motivated, Information and Broadcasting Services Permanent Secretary Chanda Kasolo said he would have resigned if that was the case. "May I just also clarify that the complaints can also be against the national carrier ZNBC, the don't escape that. So don't think that you can only complain against Prime TV alone, no. ZNBC too you can complain [about it] both radio and television. For instance if I had pressure from the ruling party, I would resign. For us it's a professional operation. I can assure you the public who or what anyone alleges we do business in accordance with the mandate we are given," Kasolo said. And Kasolo said the crimes committed against the IBA Act by the two affected broadcasters were sufficient enough for their licences to be withdrawn. He explained that the Authority did not rush to permanently withdrawing the licences because it wanted to give them chance to correct their mistakes. "And I can tell you that for the two whose licenses have been suspended, we could have withdrawn the licences but we just sat and consulted the general public to find out how far we should go. We even included Royal Highnesses in this. So we have been very reasonable in what we have done. The crimes committed against the IBA act was sufficient for us to withdraw the license permanent for those two [but] we haven't, we gave them chance because we are here to build a diversified media fraternity and we will stick to that. And this exercise that has been there for that past two to three months that I have been the chairman for the IBA, it will teach a lot of our friends in the media fraternity that we are going to be very strict and follow the IBA Act. And for me it is nothing to do with politics. Please forget about the political angle," said Kasolo.

## UNPD Will Give the Public Media Back to the People – Part I

ON SATURDAY 23rd February 2019 the whole of Africa, and perhaps other parts of the world, witnessed the national launch of the manifesto of the Democratic Alliance, the main opposition political party of South Africa. This was made possible courtesy of live radio and television (TV) coverage by the South African Broadcasting Corporation (SABC), the national broadcaster, which is funded by the public, the same way our own Zambia National Broadcasting Corporation ZNBC) is funded and organized.

The Democratic Alliance's (DA) manifesto launch was not the only such activity of the opposition party in South Africa covered by the SABC in this manner. On 2nd February 2019, the national broadcaster covered the launch of the manifesto of another opposition political, the Economic Freedom Front (EFF). Both of these activities were covered live for the entire duration of the programme – two and half hours in the case of the DA's launch last Saturday. The other smaller parties who could not be covered live were nonetheless reported about through news clips on both television and radio. Yet these were not the only activities of the opposition that the SABC has covered of the opposition and certainly not because it is an election year and the date of the elections – 8th May 2019 - was announced by State President Cyril Ramaphosa during his state of the nation address in Parliament on 7th February 2019. The SABC has covered the opposition and other interest groups on other occasions outside of the campaign period. For instance, the EFF was again given full live coverage when they were celebrating their 5th Anniversary on 28th July 2018. The Communist Party enjoyed full coverage also when they were conducting their policy conference on 7th July 2018.

interest groups covered by SABC are the fiercest critics of the Government of the day. On each of these occasions they took turns to condemn the ruling African National Congress (ANC) from all angles, especially on corruption. In the times of former President Jacob Zuma they would use the SABC platform to denounce his alleged involvement in corruption under the infamous 'state capture' antics and would fiercely call for his resignation. And today, thanks to all the sustained coverage of national issues and all the players equally by the SABC and the other media, the South African nation is rooting out corruption through a range of measures, not least the Zondo Commission of Inquiry on State Capture. As we write, a number of individuals and institutions connected to the plumber of national resources have been brought to account and resources recovered during the cleaning up exercise. This is success for the media and the nation at large! It is what all media, including ZNBC and other publicly-funded media, should strive for. This is what is truly NATIONAL INTEREST.

So, why and how has the SABC, as should ZNBC, been giving equal coverage and prominence to the opposition and other interest groups? The reasons can be categorized into two: 1. National (constitutional) responsibility; and, 2. Professional standards. Under the first reason, SABC, like ZNBC ought to, is practicing the ethos or principles of Public Service Broadcasting (PSB), which all Southern African Development Community (SADC) Member States and national broadcasters signed up to under the famous Windhoek Declaration in 2002 and the African Charter of Broadcasting, organized under the auspices of the African Union (AU). The PSB principles are 'domesticated' and outlined - in broad terms – in national constitutions. These principles are further customized during elections – under the Electoral Act (nationally) and the SADC and AU protocols - specifically on how media

should cover elections in a manner that is accepted by all parties as being free, fair, equal, objective, balanced, inclusive, etc. Under the second reason, SABC, as ZNBC ought to, is practicing the basic principles of journalism – fairness, objectivity, balance, impartiality, truthfulness, giving a voice to all citizens and protection of the public or national interest (not just the interest of a few elites, whether ruling or otherwise). These are basic principles taught in any journalism school and the standards by which the media are judged world-wide.

So, why does ZNBC and other Zambian public media fail to live up to the above principles? The answers are common knowledge: lack of political will and PF's political interference in the affairs of these institutions, done conveniently to suit their interests. The PF would not like to see a vibrant public media that is capable of investigating and highlighting their corrupt deeds and failures or indeed a media that gives voices to every citizen to speak out on these vices. Unfortunately, the media too have succumbed to these machinations at the expense their professional obligations. Yet their South African colleagues have been able to stand shoulder to shoulder with the masses to provide 'public interest' coverage. They have fought back against any attempts by the ruling party to control them. The UPND in government will give ZNBC and other pubic media back to the owners - the PEOPLE OF ZAMBIA WHO FUND IT. It will amend the ZNBC Act and the Independent Broadcasting Authority Act of 2010 and revert to their original (2002) versions as signed by the gallant corruption fighter – Levy Patrick Mwanawasa. It will also bring the Freedom of Information Bill to Parliament for immediate rectification within the first 100 days. ## Cultivate strategic alliances

Nowadays, businesses also develop by developing strategic alliances. The best befitting analogy about the importance of strategic alliances in business is best summed up through a figurative story of my colleague who stirred her shortcomings to attain a life personal dream. The young lady was not endowed with natural beauty. At the prime of her age in the mid 1990's, she attracted no suitor locally, not even the worst drunkard in town. Men generally have an idea of beauty. Some want a complete picture of a woman possessing the right height, fair complexion, geologically structured body, an African waist and to some extent, the right intellect. The lady was grossly deficient in these features, except for the intellect. She was the complete opposite of what has been described above. I was generally comfortable with her because she aroused no speculative thoughts by the public. In fact, even my pastor would not adjust his sermon if he saw me with her. Most of my colleagues actually took her as a fellow man. Some years later, the lady developed an effective personal strategy to get a man of her dream. She befriended a visiting white man from German. Though there was possibly no intimate relationship between the two, she gave a signal that the two were having an affair. She changed her dress style, developed a new level of confidence, and made sure she was in close company with this new found fellow at all functions. Men's perception about this lady suddenly changed. We all wondered what it was that this white man could see which we

#### had not seen.

As soon as this German fellow went back to his country, a number of men crashed over her. The interest in her was induced by a superior design of strategy that raised greater interest by those who had a low opinion of her. Today, my "ugly" friend is happily married with two beautiful children and I am sure that the husband keeps discovering new beautiful features about her. In stock market terms, her behaviour is called the "signalling effect." It simply means developing strategic alliances that would change market perception so that the share price can rise.

I have participated in many business strategy workshops in which a number of questions were asked about how one of the companies I had worked for turned its image from the most hopeless government owned entity to one which even large international companies wanted to associate with. "As far as we are concerned, that company was dead and buried," some managers would say and ask, "we saw the institution as one without a future and hope for survival. Suddenly, we see it doing extremely well and regaining the market share. What was your strategy?" The transformation of the company is a well documented story. It can be summed up in the two words, "strategic alliances." We knew that by 2002, the company had very few clients, most of them hanging on with the anticipation that the future would change. It was literally impossible to market the

corporation given that it was a state-owned enterprise in an environment where potential clients wanted to associate with one of their kind.

But there was something that the corporation had which the other competitors did not have in abundance; the assets and resources. In using the SWOT analysis, we were able to focus on our strengths and used these to remarket the company. We decided to use the little resources to boost the image by first settling outstanding liabilities. Every such debt liquidation gesture was made public. We then realised that while many blue-chip companies did not want to do business with the corporation by virtue of it being a parastatal enterprise, they still wanted to access our pension funds for investment. We stood still and decided that this would be an opportunity to win back the most potential clients. If we financed a business, we expected some reciprocal gesture. There is no law that prohibits this kind of arrangement.

We used the resources in our hands to develop the most effective strategic alliances that would help us build our business. Four years later, we had developed strong alliances with the big companies in the country. The internal restructuring processes were aimed at repositioning the company in a very dynamic market. We strongly believed that within a few years, the company would attain the highest levels of efficiency in the market. (This is an extract for my book, Business Values for Our Time).

Given that a. by-elections precipitate a great deal of political violence and also cost the government and opposition coffers significant expenditure, I recommend that we change the Constitution to stop by-elections altogether at both the national and local levels. Instead of by-elections, parties can pick replacement officials as is the system in other countries including in the United States.





## Turtles and tortoises found wrapped in tape

Philippine police have seized more than 1,500 live turtles and tortoises found wrapped in duct tape at Manila airport. The reptiles, found in four unclaimed pieces of luggage, could have sold for more than 4.5 million pesos (£60,000; \$86,631).

Police believe the bags were abandoned after the carrier found out about the harsh penalties for illegal wildlife trafficking. If caught, they could face two years in jail and a fine of up to 200,000 pesos.

A total of 1,529 turtles and tortoises of different species were found in four pieces of unclaimed luggage in the arrivals area of Ninoy Aquino International Airport on Sunday.

Some of the animals were of the Sulcata Tortoise species - which are recognised as vulnerable on the IUCN's Red list of Threatened species. The Red-eared Slider turtle was also among the reptiles found. The Bureau of Customs said the reptiles were left behind by a Filipino passenger who was onboard a Philippine Airlines flight from Hong Kong.

It said the passenger could have abandoned the luggage after they were "informed of the vigilance... against illegal wildlife trade and its penalties". The animals have now been handed over to the Wildlife Traffic Monitoring Unit.

Turtles and tortoises are often kept as exotic pets, but are sometimes also used as a form of traditional medicine or served as a delicacy across

#### parts of Asia.

Their meat is considered by some to be an aphrodisiac, while the bones are powdered for use in medicine. Tortoises are land animals while turtles can be aquatic or terrestrial.

Last week, 3,300 pig-nosed turtles were smuggled into Malaysia by boat - though this attempt was intercepted by Malaysia's maritime agency. *BBC* 



## Amazon withdraws painted children's drinking tumblers

Amazon has withdrawn from sale a set of painted Disney character children's drinking glasses amid safety fears

The paint used contains the toxic metal cadmium which is associated with a risk of damage to kidneys and bones and may lead to cancer, according to the NHS.

However, provided safety standards are met, the use of paint containing cadmium is permitted on glassware. In the withdrawn Amazon glasses cadmium was found close to the rim where the risk of ingesting it was highest.

Dr Andrew Turner of the University of Plymouth analysed the decorated children's tumblers and said he would personally not wish to use them on a long term basis.

Amazon said in a statement that "all sellers must follow our selling guidelines and those who don't will be subject to action including potential removal of their account".

The Amazon glasses were produced under license from Disney by a company called Half Moon Bay which said it was "investigating this product and its manufacture in light of the reported findings of Plymouth University".

Dr Turner said: "I would refrain from giving these to young children and I think I would refrain from using them myself as well."

Other glasses sold by Tesco and Plymouth-based The Range were found to have paint containing lead and

cadmium, but the paint was further away from the rim, where the risk was deemed to be lower.

Dr Turner, who has tested a wide range of painted glasses, said: "We get these two chemicals in most of the glassware that we test."

Tesco said all of its drinking glasses complied with EU and UK safety standards and those examined by Dr Turner had also been independently tested "to show compliance" with a voluntary standard on lead and cadmium.

Neither of these substances are banned from being used in paint on glassware.

Rayware, which supplies the glasses tested from The Range, said the glasses passed EU and UK safety standards.

The Range said it had removed the product from sale as a precaution while further investigations were carried out.

Expert Dr Caroline Taylor from the University of Bristol said ingesting lead could lead to behavioural problems and lower IQs in children.

"I feel that there's no need for this kind of paint to be on glasses so why are we taking unnecessary risks," she said.

The FSA said in a statement that anyone who suspected "something deficient with their glassware" could report it to Trading Standards at their local authority or Citizen's Advice.

Trading Standards would then investigate and report any concerns to the FSA.**BBC**

### Huawei sues Canada authorities over arrest



The chief financial officer of China's tech giant Huawei is suing Canada over her arrest at the request of the US.

Meng Wanzhou was held in December at Vancouver airport on suspicion of fraud and breaching US sanctions on Iran.On Friday Ms Meng filed a civil claim against Canada's government, border agency and police for "serious breaches" of her civil rights.

It came on the same day that Canada officially launched Meng Wanzhou's extradition process to for the US.

China has attacked Ms Meng's arrest and the extradition process as a "political incident". She denies all the charges against her. What does Ms Meng's lawsuit say? Ms Meng's claim - filed in British Columbia's Supreme Court on Friday - seeks damages against the Royal Canadian Mounted Police (RCMP), Canadian Border Services Agency (CBSA) and the federal government for allegedly breaching her civil rights under Canada's Charter of Rights and Freedoms.

She says CBSA officers held, searched and questioned her at the airport under false pretences before she was arrested by the for years.

1 December: Ms Meng, the daughter of Huawei's founder, is arrested while changing planes at Vancouver airport

7 December: Ms Meng first appears in court in Vancouver, where it is revealed she is accused of breaking US sanctions on Iran. China demands her release

10 December: Canadian citizens Michael Kovrig and Michael Spavor are arrested in China

11 December: Ms Meng is released on bail

28 January: US formally charges Ms Meng with fraud and Huawei with circumventing US sanctions on Iran and stealing technology from T Mobile

2 March: Canada says Ms Meng's extradition can move forward but the process is expected to be long The arrest has seriously strained relations between China, and the US and Canada. Beijing says it is an "abuse of the bilateral extradition treaty" between Canada and the US, and has expressed its "resolute opposition" and "strong dissatisfaction" with the proceedings. China also says the accusations against Huawei, the world's second biggest smartphone maker by volume, are a "witchhunt". Two Canadian citizens are thought to have been detained in China in retaliation for the arrest. China and the US are also engaged in tough trade negotiations to end a major tariff dispute.**BBC** 

## story Rafiki wins award

Africa's largest film festival has awarded a Kenyan actress for her depiction of a lesbian character in a film that is banned in her own country.

Fespaco film festival in Burkina Faso gave Samantha Mugatsia the best actress award for her lead role in the film Rafiki. The Kenya Film Classification Board (KFCB) banned the film last year for

"promoting lesbianism".

Homosexuality is illegal in Kenya - a legacy of British colonial-era rule.

Gay sex is punishable by 14 years in Kenya but the country's High Court is due to rule on whether to strike down the ban in May.

KFCB had previously warned that anyone found in possession of the film would be in breach of the law.

Rafiki, which means "friend" in Swahili, traces a coming-of-age love story between two young women who meet and fall in love. Their romance unfolds against a backdrop of homophobia and despite their families being on opposing sides of the political divide.

The film is based on Jambula Tree, a prizewinning short story by Ugandan writer Monica Arac de Nyeko.

Reacting to the lead actress's win, the film's director Wanuri Kahiu tweeted: The oldest

African film festival acknowledged a queer character... So proud! Queerness cannot be silenced!"

The best actor award went to Marc Zinga for his part in The Mercy of the Jungle, in which he plays a soldier lost in the jungle in wartime Democratic Republic of Congo. The director of that film, Rwandan Joel Karekezi, won the top prize of the film festival, known as the golden stallion of

Yennenga.

### I wasn't fired, I resigned, Zambian football too political - Sven

*By Abraham Kalito* Outgoing National team coach Sven Vendenbroeck says he had resigned as national team coach prior to the announcement by the Football Association of Zambia that his contract would not be renewed.

And Vendenbroeck says the football fraternity in the country is too political, divided and with numerous irresponsible individuals who are only interested in protecting their jobs.

Speaking in an exclusive interview with BBC's Kennedy Gondwe, Vendenbroeck said he decided to resign in December and informed FAZ about the decision adding that he was thus surprised and disappointed when the association announced that they would not 'renew' his contract.

"Well the intention was already spread out in December two weeks after the Mozambique game. And indeed, I said before new year that my intention was to extend, I think also the president spread out his words in media towards myself that the intention was to continue but, after two months and you don't have an official feedback, that's one. The second problem was my assistant is not paid from day one until now, so making my bench for the future was also a problem we also could not agree on who could be the local assistant. Yes, and that's the disagreement that we have. But you could feel that the environment proposed different people than what I would have loved to have. So, I would have loved a full time assistant not linked to a club, and I preferred to keep the one I had from the start. So, all these small things, you feel like maybe my ambition and their ambition is not running parallel," he said.

"And that's why I already clearly communicated to the president, I think ten days before they made the press release that it was better to not continue and extend the contract. I said it even on February 14 that I would resign. That the situation was not running parallel, so it was better to stop immediately. Their answer came that because the president was outside the country that we would have a formal meeting were we could deal with my issues and I think three, four days later after the weekend when he came back from duties abroad we had a formal meeting and we agreed as adults to continue until the end of the contract to deal with the Namibia game as good as possible. So, I was surprised and a bit disappointed when the press release of the federation came saying that they would not renew my contract. It's a bit upside down. I had resigned. I take responsibility but I think not everything was done in a good way as much as possible to allow us to operate better and deliver results."

And Vendenbroeck says the football fraternity in the country is too political, divided and with numerous irresponsible individuals who are only interested in protecting their jobs.

"For me it was positive. I have to admit that the country is good. The lifestyle is all good. The roads and the facilities are much better than the average on the continent. I would have loved to travel and explore the country, but I didn't have time for that. So maybe I will do so after my work is done. I can have a few days. On the football side it was tough especially because the landscape and the environment is quite divided. Well it's a delicate situation. It's very political, it's based on status, on self-protection. People Not too much on responsibilities. So yeah, I hope you just have to manage a lot of things, and not to make too much noise and still manage to get what you want. Yeah, it's a very tough situation, where as a couch it was tough to find me way through, to find balance in doing my job," he said.

"Many questions that I asked to the federation were not answered and i think it was because if they say no it can come back to them so job protection sometimes. I understand these people, it's a had economical situation so you want to survive yourself, but it stops development in football. Development in football stops. I think it was not starting to get wrong during my period. I think also the results of the qualification of the world cup Russia hid a bit of issue that were already popping up in football. When you come in you don't have any notice of what is going on so." He said the problems in Zambia's football started before he arrived on the scene and was unfortunate to have inherited a malfunctioning system.

"After a while, after a week maybe month you discover what is underneath. And I don't want to use it as an excuse to not qualify because the target was obvious, and we didn't deliver the qualification. But many thins and I think the Chinese have a very good expression, whether always drops from above to down, that the influence from outside had an impact on what was happening on the field." from 2010 to 2013. Over the weekend he was a guest pundit on Qatar-based beIN Sport where he analysed Real's latest loss to Barcelona. "Return to a club that I have been before?" said Mourinho, who had two stints at Chelsea and was fired by Manchester United in December.
