#### By Mukosha Funga PF SECRETARY General Davies Mwila has urged the party leadership in Western Province to take advantage of the wrangles in UPND to turn that area into a ruling party stronghold. But the UPND has accused PF of bribing voters with mealie-meal in the just ended ward by-elections in

Western Province. Speaking to journalists, Wednesday, Mwila described the recent victories in Mongu as "sweet" saying it was an indication of people's confidence in the PF's developmental agenda.

The PF scooped both the Nakato Ward and Imalyo Ward by-elections in Mongu District Western Province.

In the Imalyo Ward by election, Musole Kamocha of the PF polled 615 votes UPND's Simasiku Poice got 494 votes, while Namasiku Namasiku of NAREP got 111 Votes.

In Nakato ward byelection, PF's Mukuti Mubiana got 584 votes while UPND's Simataa Nosiku polled 283 votes.

And in Bulilo local government by-election in Chilubi district of Northern Province, PF Candidate, Wilson Kunda polled 854 votes while his closest rival, Evans Ngosa of the UPND got 446 votes. John Mwela of the Movement of Change and Equity, party (M4CE) secured 189 votes in the three-man contest.

"I want to say this is a sweet victory to the party. The people of Zambia, the people in Western Province, the people in Northern Province voted for the PF because of the developmental agenda that is being spearheaded by President Edgar Chagwa Lungu and the people of Zambia have spoken loudly and development can only be brought by the PF government which was given the mandate to run this country up to next year," Mwila said.

"I can assure you that we'll have more by-elections coming, like 10 more wards, and we expect to win all of them. I want to appeal to the leadership in Western Province that the UPND in the state in which it is as at now in Western Province, because there are too many wrangles, too many infighting and as a ruling party, we will take advantage and ensure that we take over the whole Western Province, come next year, Western Province will be our stronghold." And Mwila instructed Eastern Province PF chairperson Andrew Lubusha to discipline any party member causing wrangles in that area. A video had circulated where PF youths in Eastern Province were calling on President Lungu to remove Lubusha as province chairperson saying it was in the best interests of the party.

said Mwila. Meanwhile, Western Province Minister Richard Kapita boasted that the victories were proof that Western Province had turned into a PF stronghold. Well, this is not the only win, you know we have about seven seats since I have been there. People have been telling us they are tired of the UPND and they are going to show us by doing exactly what they did last night (Tuesday). I go to these places so I know what I am talking about. I am encouraging you to go to North Western Province as well because these are the provinces that UPND used to claim that they were their strongholds. The situation has changed totally! So it's like that everywhere else North Western Province, Western Province people are simply saying we are tired of UPND it will not take us anywhere, it has no agenda, we would rather follow PF and the developmental agenda is exciting everybody," said Kapita.

"I can assure you that in 2021 election, I would be surprised if UPND will have five seats in either Western or North-Western Province, mark my words. Complaints about rigging, they have done that for a long time, composing songs that you can't be in a party that is forever crying foul when they lose. The arithmetic is simple unless UPND can get seats in Luapula, Northern Province, Copperbelt, Central, they will never win, they will never go to State House that is the fact. You cannot claim that the election has been stolen if you have 90 per cent of votes from one province and unless he extends his tentacles to other provinces, it will not be possible for UPND to win 2021."

But Mongu Central UPND member of parliament Dr Mwilola Imakando said the electoral atmosphere during the Mongu ward by elections was unfair as the PF bribed electorates with mealie meal and other foodstuffs.

"First of all, let me say that the ground was not fair in that government resources were being used. They were using vehicles belonging to DCs to ferry people, in particular, the vehicle for DC Nalolo, we saw it. They were going in with projects for food for work, they were making people to clear grounds and then pay them. In the process of paying them, they were asking for their voter's cards and registration cards. In that sense, the ground was not fair," Dr Imakando lamented.

"We saw in Kalugwana, they were distributing relief food. You cannot distribute relief food during elections. So as far as we are concerned, the ground was not fair. In addition, the people that received mealie meal were being followed in their homes and were being identified and being told that you received mealie meal from us you have to vote for us. The final one is where they were voting for people. All those who received mealie meal were being told that someone has to vote for you, that is the only way we can guarantee that you will vote for us because of mealie meal. So the election has been won because of mealie meal, it is not the will of the people, it's a mealie meal issue. Finally, people were being given K20. So as far as we are concerned, we put in a fair fight but unfortunately, our friends abused the electoral rules."

He said it was disappointing that the PF were using hunger as a campaign tool.

"The minister knew very well that there was hunger in Western Province but he refused to support our efforts to declare a hunger situation so that we can get help. So because of this hunger, they created a strategy to go and distribute mealie-meal and go and register people and record them and tamper with their votes. As far as I am concerned, it is not their bedroom, it is a place they have taken advantage of because of hunger. Otherwise why are they taking mealie? Why are they using mealie meal as a weapon? In fact, this time, they have even started distributing village chickens," lamented Dr Imakando.



Kampyongo should allow

YOUTHS planning to protest against various governance issues have appealed to Home Affairs Minister Stephen Kampyongo to allow them to exercise their right to express themselves. In an interview, Nawa Sitali who spoke on behalf of his fellow youths seeking to protest, hoped that Kampyongo would overrule the police.

"The police told us that the protest should not go on because the security situation in the country does not allow for the protests to go on. We were advised to appeal as per Public Order Act to the Minister of Home Affairs on the protest because we are trying to negotiate for an alternative date. It is our constitutional right to protest and we are going to appeal to the minister. If the minister denies, which we hope he won't, we hope he is going to reason and allow the young people to air their grievances. But if the Minister denies, we will sit down and see how we can proceed. But as indication is now is that we must go ahead and protest because it is the only way our voices will be heard," Sitali said.

"We are hopeful that they will act in the right manner. And this thing they are saying 'the protest will turn violent' we don't know where it is coming from, it is going to be peaceful. We are appealing to him as per procedure, even if we are aware of the remarks that he made that 'they will be dealt with' we are working on his conscious because he said that 'those who want to take to the streets illegally', we are following procedure and we are doing it legally. If he denies to give us our right to protest, he will be acting illegally himself. We are appealing to him and understand that he will act within the confines of the law, if he doesn't, we will inform the nation about the next step but we are hopeful the remarks he made was just political rhetoric and he will act in the best interest of the office that he holds."

Sitali said the youths were not moved by threats which had been made.

"When it comes to the threats that were peddled, I think the most difficult one was the one that was issued by the deputy chief whip of the Patriotic Front honorable Tutwa Ngulube where he told the police that 'when you find them, break their bones.' It was disturbing for us and the President also warned us. But look, we understand that sometimes it is very difficult for our elected officials to allow people to exercise their right to be heard. This is a protest for the Zambian young people and all of them are angry and this is what we communicated to the police that by not allowing this protest to go ahead, they will not stop the grievances that the young people have. It is better to allow us to go on the streets and the threats are not going to work on us," said Sitali.

The youths had planned a protest for June 22 but police denied them a permit, citing security concerns.

# CSPR proposes tax reductions to cushion citizens against high cost of living

poverty levels and also escalated the poor living standards," Nachibinga said. "The other strategy that we would want to recommend to government is investing in all social protection programs that would go a long way; and also investing in the agriculture sector, so that agriculture becomes self reliant and people are able to produce one or two things. So it calls for even increasing the prices of maize as it is now so that the farmers can be empowered in one way or the other. The long term strategy we can recommend is that government think of investing in shock responsive social protection programs. This calls for them to come up with specific sinking funds for money that will be channeled towards social protection programs." He added that government should also widen safety nets in terms of social cash transfers in order to cushion the burden on the vulnerable people in society." He lamented that more people were slipping into the poverty line.

disposable income for the people has remained as static. It has not increased actually it has decreased to a situation which is unbearable and most of the people have actually dropped into the poverty line. So, government should widen the safety nets in terms of the cash transfers themselves. Government should scale up in terms of the beneficiaries because there are a number of people that have actually fallen into poverty. So, if they scale in terms of beneficiaries and also ensure that they disperse the money at the right time , so that the beneficiaries can appreciate the values of that money, it will try and cushion the cost of living," he said. Nachibinga said there was need for government to prioritise economic growth programs like social protection programs and forego infrastructure development projects for the time being.

At this particular point in time I think government should be looking at the priority areas which are the priority areas that they are supposed to invest in. When we look at our economic growth from 2012, ever since we started investing in agriculture heavily especially the roads our economic growth has been shrinking, now we are talking about a negative growth," said Nachibinga. "So it is a wake up call to government to ensure resources are channeled to priority areas that can stimulate economic growth. We are not saying that roads are bad but let us look at what are the priority areas. So, the same resources that are remaining after the debt payment and so on have been put aside we can channel those resources to priority areas that can stimulate the economy; and one of those areas is the social protection programs, agriculture and other sectors that can stimulate the economy."

"There are reports of wrangles in Eastern Province. I want to say that the PF will maintain discipline, it is a disciplined social protection programs to cushion Zambians against the escalating cost of living.

CSPR programs coordinator Chimuka Nachibinga said reducing the tax burden would increase disposable income, which would cushion the cost of living that has soared to K7,195.60, according to the Jesuit Centre for Theological Reflection.

"I think government needs to lessen the tax burden on the citizens meaning that they have to reconsider reducing or reconsider increasing the non taxable threshold, maybe to about K4 000, so that people can have more disposable income on their hands. The same day, the Government of the Republic of Zambia issued Statutory Instrument No. 57 of 2020 declaring CEC transmission and distribution infrastructure as "Common Carrier" to enable ZESCO distribute or wheel power through the CEC infrastructure to supply KCM. Subsequently, on 31 May 2020, the Energy Regulation Board set a wheeling tariff equivalent to about 30% of CEC's current network tariff.

The combination of these developments, and as the deliberations around the settlement of KCM's debt and the review of the contractual arrangements in respect of KCM continue, may have a material effect on the price of the Company's securities and shareholders are advised to expect a more comprehensive announcement to be issued and are hereby advised to exercise caution when dealing in the Company's securities until further information is published.

# **Mines Ministry makes** changes to export mineral sampling procedure

THE Ministry of Mines and Mineral Resources has announced that the ministry will now be sending officials to mine sites and warehouses to collect samples for export as opposed to relying on samples availed by traders in a bid to protect revenue.

Currently, every client who wishes to apply for a mineral export permit submits a sample of the export consignment to the chemistry laboratory of the Ministry and based on the sample analysis results from the laboratory, a Mineral Valuation Certificate of the entire mineral export consignment is prepared.

After the applicant has obtained a mineral royalty clearance certificate from the Zambia Revenue Authority (ZRA), the Ministry issues a mineral export permit to the applicant.

But in a statement, Wednesday, ministry permanent secretary Barnaby Mulenga said the old system provided an opportunity for exporters to submit low grade minerals and resulted in undervaluing exports leading to loss to revenue for the country.

"The Ministry of Mines and Minerals Development wishes to inform all exporters of metals and other mineral products that, with effect from 1st July, 2020, the Ministry will no longer accept samples submitted by exporters to the Chemistry Laboratory at the Geological Survey Department in Lusaka to facilitate the issuance of export permits. Unfortunately, this practice has opened a window of opportunity for some mineral exporters to deliberately submit low-grade samples to the chemistry laboratory. This has resulted in undervaluing of mineral exports and consequently, loss of revenue earned by the government through mineral royalty tax payment. The loss of revenue could amount to hundreds of thousands or even millions of dollars per export, depending on the amount of discrepancy in mineral grade between the submitted sample and the consignment being exported," Mulenga stated.

"In view of the above, the Ministry wishes to put an end to the current arrangement so that Officers from the Ministry will be going to the mine sites and traders' warehouses to collect the required samples instead of relying on samples submitted by exporters. This decision was arrived at in order to: Earn government a lot of revenue which is currently being lost through some exporters' submission of low grade samples to the ministry's chemistry laboratory; Eliminate the inconvenience of requiring our clients to travel to Lusaka to submit samples each time they apply for a mineral export permit; and Achieve orderliness in the processing of mineral export permit applications as opposed to the randomness currently prevailing; Verify the location of the mineral samples and their Mine origin."

He stated that it was government's wish that the ministry gained full oversight of mineral supply and value chain to effectively monitor mineral production and exports.

"In conclusion, it is the desire of the government that the ministry gains full oversight of the mineral supply and value chain in order to ensure effective monitoring of mineral production and exports. Therefore, in order to facilitate the smooth transition from the current scenario to the new one, all exporters are requested to ensure that their applications for export permits are received by the Ministry at least one week before the officers' sampling visit to each region. The applications should state clearly where the export consignments to be sampled will be located, with the applicants' physical address and other contact details," stated Mulenga.

Missionpharma has been involved in rural health kits in the continent of Africa and they are very experienced and we have never experienced shortages. We are now going to have problems because the people they have given that responsibility do not have the capacity and they are not experienced in that and I get this information from the ministry but when I talk, people think they are allegations, I am well informed," Kambwili said. "The minister (Dr Chitalu

Chilufva) is involved and his permanent secretary and people at the ministry are not happy with what they are doing. ACC, DEC must move in immediately and find out how a company that did not exist in 2019 can be given a contract to supply drugs. I am reliably informed that that company was for a sole trader

but they put limited on it and when you go to PACRA, you will find that company did not exist. People have made money from procuring of drugs and we have seen the property that they are owning, the porsche cars that they are driving and they lives they lead. But they are being shielded from being arrested. When it comes to the Constitution Amendment Bill 10, they recover because they need numbers in Parliament. Ba DEC, ba ACC ikateni aba bantu twapapata aya ma criminals yachilamo (DEC, ACC please we beg arrest these criminals it is too much of them)."

He wondered how a sole trader could win a US\$ 17 million contract.

"And even when they say 'we are investigating these people' for property suspected to be proceeds of crime, those are small cases. Those people must be arrested for money laundering. We are talking about US\$ 17 million and

Missionpharma was owed US\$ 11 million. How can a sole trader get a contract for that huge amount? All those involved in the procuring of drugs at the ministry should be investigated and face the consequences of their actions. It is deep rooted, it is a syndicate, a lot of people are involved, big names," he said.

Kambwili warned that the country would experience a shortage of drugs.

"Right now, I am informed that we have a problem in rural areas. Today as I am speaking, health centers don't have insulin, it is Missionpharma who used to supply this medicine. I don't know how people will survive because a bottle of insulin is K275 and that lasts a week or so. Now for a poor man in Mongu, Mporokoso, Chadiza, how can they afford that? There are more of shortages to come. Missionpharma left because of frustrations of not paying them so that they could use their friends. Stop the rot! Reinstate Missionpharma so that the poor people don't suffer," said Kambwili.

# Go ahead and sue us, *Diggers* tells Zingman

"Our client informs us that your Mr Daniel Delnero has had contact with our client's Managing Director Mr Joseph Mwenda in which he has continually demanded that News Diggers should retract a story that allegedly identifies Mr Zingman as an Arms Dealer. What has not been been made clear is which words identify Mr Zingman as an arms dealer. The foregoing lack of clarity notwithstanding, your Mr Delnero went on to allege in one of the numerous messages he sent to Mr Mwenda that 'Vitale Fishman is the individual behind the allegations against Mr. Zingman. Mr Fishman is an actual arms dealer, who has been implicated in multiple international scandals.' Mr Delnero did not explain how Mr Fishman was connected to the article Mr Zingman was complaining about nor did he explain how Mr Zingman is connected to Mr Fishman. This confusion is emblematic of the whole demand." News Diggers maintained that Zingman was involved in the Russian Sukhoi aircraft deals.

Your Mr Delnero responded by saying ; 'On number three, I can confirm that Mr Zingman has never been a party to any aircraft supply deals with Zambia, including the one you mentioned.' Although Mr Delnero appears to have been instructed to say that Mr Zingman was not involved in the Zambian Sukhoi deal, our client maintains on good authority that he was. Your client also refused to confirm that his relationship with Mr Valden Findlay was only social and did not extend to commercial

An investigation revealed that government, through the Ministry of Health last year awarded a US\$17 million contract for the supply of health centre kits to a company called Honey Bee Pharmacy Limited, which did not exist.

Research at the Ministry of Health shows that Missionpharma, a Danish company with a subsidiary in Lusaka had an active contract to supply and deliver drugs to Zambia for several years and was a key government partner for supplying health centre kits. However, owing to an US\$11 million drug supply debt, the company stopped supplying in December 2018, demanding that the government first settles its debt; a move that forced the Ministry of Health to find a replacement. According to an evaluation report for tender number MoH/SP/032/19 the Ministry of Health made a decision in July to procure 50, 000 health centre kits through a limited bidding process. Records at the ministry show that a solicitation document for the tender was issued on October 7, 2019 and the evaluation of bids was done on October 22, 2019, while the contract between Honey Bee Pharmacy Limited and Ministry of Health was signed on November 22, 2019.

Shortly after the publication, Zingman's UK-based lawyers wrote to News Diggers Media Limited, requesting it to confirm where or whom it obtained photographs of their client and to further remove the article and photographs from the website.

According to a letter of demand addressed to News Diggers editorin-chief Joseph Mwenda and reporter Sipilisiwe Ncube, Zingman, through his United Kindgom bases lawyer Daniel Delnero of Squire Patton Boggs, was demanding that News Diggers should within two working days of receiving the letter, remove the Article, including the e-Paper version from the website and provide an apology for publishing the same.

They stated that should News Diggers fail to comply with the said requirements, Zingman reserved the

News Diggers through its lawyers further stated that it was disappointed that although in a letter of May 28, 2020, Zingman's lawyers indicated that they had attached a Pre-action Protocol for Media and Communications Claims to their letter of demand, the same was not attached.

"It is unfortunate that even after our client brought this issue to your attention, you neglected to supply them a copy of the document despite having earlier undertaken to do so. Assuming that the protocol you are referring to is the United Kingdom's Ministry of Justice Preaction Protocol for Media and Communications Claims, we should not be surprised that you have not supplied it as you are required to, because it is not helpful to the posture that you have taken on your client's case which may explain why you have

It added that Zingman's refusal to answer some questions was unfortunate and could not support his claim that he had been defamed.

"Our client did try to clear the issues by asking simple but pointed questions. One of the questions was

Your client also refused to discuss the important question of whether he received any commissions on Zambian transactions and if he shared the same with any Zambian persons or entities. As far as our client is concerned, these are fair questions on matters of fundamental public interest here in Zambia. Your client's refusal to answer these questions is unfortunate and cannot support his claim that he has been defamed."

In an interview, Dr Mujajati said with the expected rise in Coronavirus cases, there was need to increase surveillance to counter the further spread of the disease.

## We're unaware of artists intending By Natasha Sakala to protest, says NAC

NATIONAL Arts Council chairperson Patrick Samwimbila says the organization is not aware of any artists that are planning protests to air out their grievances against the government.

And Samwimbila has warned individuals and interest groups to stop hiding behind artists in championing their agendas.

Meanwhile, Samwimbila has urged social media bloggers and influencers to stop judging and demeaning artists who meet with government officials because they are Zambian and have the freedom to walk into any office, including State House.

During a press briefing in Lusaka, Wednesday, Samwimbila said artists could not engage in any protests as they believed in discussing and sorting out matters amicably.

"We are not aware of any artists that would want to protest because these artists have aired their views and they are willing to sit down and discuss. So our model here as a Council, the way we resolve our matters, I think of late, you have heard even some issues concerning artists in the media, even those that have quarreled, the way we resolve our matters is to sit down on a round table and discuss amicably, we don't resort to protests," Samwimbila said. "We feel there is no need for anyone to engage in unnecessary antagonism because there are sufficient platforms for our artists to be heard. With this in mind, we therefore wish to call upon individuals, political parties, civil society organisations or indeed any other interest groups who plan to hold demonstrations for their own agendas, and I emphasize, all those that want to demonstrate or those that plan any gatherings, they have agendas to drive and we call upon them to stop hiding in

the well-intended concerns that our artists have recently aired through their channels or on their platforms, on their pages. They have aired their concerns on issues they have seen happening or not happening well in the country and they have been heard. So these individuals that plan illegal protests should not hide in the statements that these artists aired, in short we are saying please don't involve the artists."

He further said the same way artists are celebrated when they air out their views is the same way they should be celebrated when they meet with leaders to air out their grievances.

"I also want to address one other issue; I want also to appeal to social media bloggers and social media commentators to desist from judging and demeaning any artist or artists who decide to meet with any government officials to air out their views. The same way these artists are celebrated when they air out their views and people shout 'we stand with you, we stand with you', that is the same way we expect social media commentators to stand with the artists when they also decide to take other channels like meeting their leaders. Artists are Zambians, and the leadership, the government that is there is for all Zambians so everyone must have the freedom to walk in any office, to walk in any ministry and even to go to State House to go and air out their views or to have a dialogue with the leadership," said Samwimbila.

"But then, when artists do that, people take on to social media to say they were paid or they were given this. I mean if that's the Zambia we want to build that whenever two of you are seen chatting, then there is somebody who has paid someone just there, I think that type of culture must come to an end." Chengo and other unknown people, claims the respondents have continued to obstruct and deny him access to the land despite reporting the matter to the Police and engaging them on several occasions.

He is now seeking an order of the court for the eviction of the said respondents and their agents from the land and an order restraining them from carrying out any activities, entering and being in occupation of the land covering Stand No. LUSAK/930060, Lusaka held under Certificate of Title No. 30846.

Yaluma also wants costs and any other relief the court may deem fit.

In his affidavit in support of originating summons filed in the Lusaka High Court, June 8, Yaluma explained that in 2016, he applied through the Lusaka City Council to be allocated a piece of land, now known as Stand No. Lusaka/930060, Lusaka.

"On or about March 24, 2017 a Certificate Of Title was duly issued in my name under Certificate of Title No. 30846 relating to Stand No. LUSAK/930060. To the best of my knowledge and belief, this is the only Certificate of Title that has ever been issued by the Ministry of Lands and Natural Resources relating to the physical parcel of land known as Stand No. LUSAK/930060," he stated.

Yaluma stated that following the issuance of the said Certificate of Title, he proceeded to put the said physical parcel of land in a wall fence enclosure.

He, however, stated that unknown to him, the only known respondent, Chengo and others unknown, brought down the wall fence and proceeded to erect shops, a car wash and other structures on the said physical parcel of land and started carrying on their businesses without any lawful cause or obtaining any consent to do so from him.

"That despite reporting the matter to the Police through Matero Police Station and engaging the respondents on several occasions to stop being illegally in occupation and carrying out their business on the said physical parcel of land, the respondents have contumeliously disregarded my rights as the lawful owner of the physical parcel of land known as Stand No. LUSAK/930060, held under a Certificate of Title No. 30846 held by me, and have continued being in occupation of the same without my consent or licence," read the affidavit.

"The respondents have continued to obstruct and deny me access and entry into the physical parcel of land covered by the Certificate of Title No. 30846 for Stand No. Lusak/930060, Lusaka without any lawful cause and have continued being in occupation of the unexhausted improvements erected thereon."

Yaluma stated that the respondents, being squatters and having no lawful claim to the physical parcel of land had further obstructed him from entering and gaining access to the site to enjoy quiet enjoyment of the land.

He added that in the premises, he seeks the indulgence of the Court to grant him the reliefs as prayed for. to be. Expect the number of COVID to increase and one of the things I expect to see happen is that people are now freely interacting. He also stressed the need to increase sensitization on COVID-19.



# Lukuku reports Simusamba to ACC

By Julia Malunga REPUBLICAN Progressive Party (RPP) leader James Lukuku has written to the Anti-Corruption Commission on Principal Resident magistrate David Simusamba's failure to report his allegations that NDC leader Chishimba Kambwili tried to bribe him. In a letter dated June 10, 2020, Lukuku stated that Simusamba failed to report the matter within the stipulated time.

"I write to bring to your attention a corruption incident that occurred, that magistrate Simusamba in his capacity as a public officer failed to report to the office of the Anti-Corruption Commission, contrary to the Anti-Corruption Act No 3 of 2012, section 39 clause 1, under 'public officers' duty to report. Magistrate David Simusamba reported a corruption claim to the Chief Justice of our Republic, to the effect that the National Democratic Congress leader Chishimba Kambwili tried to bribe him from as way back as 2018 when a case before him begun. However, magistrate David Simusamba did not bring forth his corruption report to the Anti-Corruption Commission in accordance with what is expected of a public officer in the Act No 3 of 2012," wrote Lukuku.

"The law says 'a public officer to whom any gratification is corruptly given, promised or offered shall make a full report of the circumstances of the case to an officer of the commission or a police officer within twenty-four hours of the occurrence of the event, and if the public officer fails to do so without reasonable cause, the public officer commits an offence and is liable for conviction.' Magistrate David Simusamba did not follow the law but gave a report to the Chief Justice more than one year after the twenty –four constitutional provision elapsed. I pray that this matter be investigated by the Anti-Corruption Commission to help the nation understand the truth, as to why magistrate David Simusamba did not follow the law if this corruption incidence indeed take place."

# ECONOMIC VISION AND JOB CREATION PLAN

AXIMIZING economic growth in Zambia has never been more paramount than now. Especially with the population explosion as more people need a share of the national cake. As NDC we believe that growth alone without economic development cannot solve all the problems of unemployment, poverty or inequality, but accelerated economic growth is essential for creating sustainable jobs and as a precursor for economic development. Zambia's moderate growth rate for the past 10 - 15 years has not been sufficient to catch up to constant rise in the number of unemployed persons. As NDC we believe that for our country to achieve the levels of employment needed and to reduce poverty, the economy needs to grow at a minimum of 9% per annum.

The NDC does not advocate for a form of capitalist system associated with the absence of state involvement. State involvement should be minimal to the level of regulation through independent institutions that report to select committees in parliament. In a bid to create a welfare state, we do not advocate for state interventions that unreasonably limit the growth potential of the private sector and entrepreneur growth to create jobs. Raising capital in Zambia is very difficult for new entrants into the economy and we need to remedy this if we are to promote entrepreneurship. This is because agriculture and manufacturing have a higher job potential. In order to create a vibrant economy, the NDC when elected shall embark on the following:

critical for the development and survival of small and medium size businesses and this as NDC shall be priority in the economic sector. High Interest rates are a challenge to the development of small and medium size business.

□ As NDC we shall motivate the SMEs and cooperatives sector and focus on developing them into large companies that can create jobs and effectively participate in stock exchange markets, especially for the women and youth.

ii. increase tax revenue, government should be able to collect various taxes through pay roll and various taxes to provide service.

iii. promote supply chain industries

our FDI policies will enable the creation value chain addition to our final products. This should be a requirement for investors to illustrate on how their investment will promote other sectors of the economy

iv. Improve Balance of payments.

Our FDI will also improve the balance of payment and improve liquidity, reduce the cost of borrowing money and financial out flow, through companies that establish industries that produce the most goods and services that we import as a nation.

We shall revise the five-

□ We shall create capacity and business opportunities by putting in place a policy to compel government ministries, spending agencies and government Parastatals to strictly buy and contract not less than fifty per cent (50%) of its goods and services that are manufactured within the country from empowered groups.

Zesco's agreement with KCM a sign of vindictiveness – Milupi

By Natasha Sakala ALLIANCE for Democracy and Development (ADD) president Charles Milupi says the move by Zesco to sign a long term power supply agreement with Konkola Copper Mines Plc (KCM was done out of vindictiveness and only meant to supply free power to the mine.

In an interview, Milupi noted that it doesn't make business sense for Zesco to go and sign a contract with "a customer of its customer" even after the said mine has gone rogue by failing to meet its obligations.

"I think that statement indicates clearly that this whole move for CEC, KCM, Zesco [and] government comes out of vindictiveness because for them to say CEC had a monopoly on the Copperbelt, it doesn't even sound like a proper business statement. The point I am making is this, I am a farmer, I grow tomatoes. Natasha buys my tomatoes wholesale and then goes to sell them at Soweto market but that bothers me who is a farmer who sells them at wholesale because I can say Natasha has

a monopoly when Natasha is selling my tomatoes? If there is any monopoly, monopoly belongs to Zesco and CEC with respect to the supply of electricity to the mines on the Copperbelt. It doesn't just belong to CEC but it belongs to whoever benefits from that and as it happens, whatever money CEC makes out of the mines, two thirds goes to Zesco, one third remains with CEC. So how can Zesco then be talking about monopoly of this particular company?" Milupi asked.

"If you are a trader and you buy things from me or you are selling to people, when they are not paying you so that you can pay me, then I knock you out of business and then I go direct to them to supply, am I normal? This is why I am saying this is not behaviour of a business venture, there is something behind the scenes, it's not normal. So these are the people who are all going to be sorted out. It does not make sense for PF, it does not make sense as a business undertaking for Zesco to take on a customer that was being supplied by a customer who

turned out to be a rogue for not paying you take them on and you think they will pay. Within a short time, you will come back to us."

He said despite the action, over US\$100 million of the US\$144 million which KCM owed CEC belonged to Zesco, adding that Zesco did not have the capacity to collect debt from the mine.

"And because CEC is a private company, they have capacity to collect, Zesco have no capacity to collect from a rogue customer for example like KCM. That US\$144 million that you are hearing that they are owing CEC, over US\$100 million of that is Zesco money. When Zesco now takes this, can anyone in their right mind imagine that Zesco will now be able to collect from KCM? When you have this liquidator who is playing PF roles, playing government role, is it true that they will collect that money? They will not be able to collect it, they will continue supplying power to KCM for free. When they are supplying that power for free about fat sums of money, on the accounts books of Zesco, there will be a shortfall which was supposed to be sealed by this KCM money because of the shortfall, there will be need for someone to find, who is that good person going to be? The way this PF government works, it is the consumers of electricity wherever they are, they may be in Nakonde, they may be in Chadiza whether there is electricity, the electricity tariffs will go up,"

said Milupi. "Then they will say if we don't do this, [if] we don't raise [money], Zesco will not be viable because now they will have a customer not paying. When CEC was supplying, because it's a commercial arrangement, they made sure, that is why you had this correction or limitation of power. It is not undertaken lightly. The people who are going to pay the bills of KCM will be the ordinary Zambian, you will be paying more to cater for KCM who are not paying."

is social distance. I can give you an example where they were defectors in Mufulira, people have been guided to follow the regulations," Phiri said.

"When people are having meetings, they should call the council, they have a department of health and then you go to the police you are have police permit. 

# We won't give in to threats from **Mr Zingman and his agents**



## Cameroonian conflict 'world's most-neglected crisis'

CAMEROON'S conflict with English-speaking separatists has been rated as the most-neglected crisis in the world for the second year running by the Norwegian Refugee Council.

The African nation's Anglophone minority are fighting for autonomy after what they term as decades of marginalisation by the central government and the French-speaking majority.

Some of the separatists have declared autonomy over two regions - a move rejected by President Paul Biya.

Cameroon has also been hit by a refugee crisis from the neighbouring Central African Republic (CAR) and continuous attacks in the north from the Islamist militant group Boko Haram.

The annual list of neglected crises is based on three criteria: lack of funding, lack of media attention, and political and diplomatic neglect.

There are nine African nations in the list of 10, with Venezuela being the only non-African this year.

The report also highlighted the ongoing armed conflict in the Sahel region, that includes Mali, Burkina Faso and Niger, which has resulted in the deployment of military forces from a host of European nations.

Niger and Burkina Faso appeared on the list for the first time.

Humanitarian crises in all countries mentioned in this year's list are expected to worsen throughout 2020, compounded by the global coronavirus pandemic.**BBC**

Britain's economy is likely to slump by 11.5% in 2020, outstripping falls in other developed economics of Germany, France, Spain and Italy, it said.

If there were a second peak in the pandemic, the UK economy could contract by 14%.

The Organisation for Economic Co-operation and Development described the impact as "dire" everywhere.

In its latest assessment, the OECD found that the trade, tourism, and hospitality sectors, which make up large parts of the UK's servicebased economy, have suffered under lockdown restrictions introduced by the government. Coronavirus crisis

The Paris-based organisation says that five years or more of income growth could be lost in many countries

#### as a result of the pandemic. The OECD has looked at two scenarios for how the pandemic might unfold.

In the more severe case, the global economy could shrink by 7.6% over this year.

Although the report says that the pandemic has started to recede in many countries, and activity has begun to pick up, it does not expect a convincing recovery. It sees the outlook for public health as extremely uncertain and that is reflected in the decision to assess two alternative scenarios.

In the more moderate scenario, the virus continues to gradually recede. In the alternative, there is a second

#### wave of contagion which erupts later in 2020.

The report describes both outlooks as sobering. In neither can economic activity return to normal within the period the OECD considers. The deep recession now underway will be followed by a slow recovery.

In the gloomier of the two possibilities, the decline this year could be very severe.

In that scenario two countries - France and Spain - would suffer even deeper declines in economic activity than the UK this year

That 7.6% global forecast is significantly worse than what was foreseen by other agencies such as the International Monetary Fund and the World Bank - who have warned about the high level of uncertainty attached to their forecasts.

By the end of 2021, the report says that five or more years of income growth could be lost in many countries. It says the impact on livelihoods will be especially severe among the most vulnerable groups.

The OECD also says the pandemic has accelerated the shift from what it calls "great integration" to "great fragmentation". That is essentially a setback for globalisation, reflected in additional trade and investment restrictions and many borders that are closed at least while the health crisis persists.BBC

# Malawi has no coronavirus - ex-President Banda

MALAWI'S former President Joyce Banda has told a campaign rally that the country has no coronavirus cases and accused the government of "faking" numbers, local media reports.

Politicians are campaigning ahead of a presidential re-run on 23 June after President Peter Mutharika's re-election last year was nullified by the courts

Huge political rallies have defied coronavirus prevention measures like social distancing and wearing of face masks.

A recently conducted poll showed that 81% of Malawians are not afraid of coronavirus and are more concerned about hunger.

ʻWe therefore are demanding all the funds which have been pumped into Malawi in the name of Covid-19 to the rightful owners and be used for development projects," the privately owned Malawi 24 website quotes Ms Banda as saying to supporters in Nkhatabay on Tuesday.

Three months ago, she had accused the government of hiding coronavirus cases.

The former president endorsed opposition presidential candidate Lazarus Chakwera.

Malawi has so far confirmed 455 coronavirus cases and there have been four deaths and 55 recoveries.**BBC** 

African swine fever 'decimating Nigerian pigs'

AN outbreak of African swine fever in Nigeria's largest pig farm co-operative in the south-west of the country has been confirmed.

It is the first time in 12 years that the highly contagious haemorrhagic viral disease affecting domestic and wild pigs has hit the West African country.

Although it is harmless to humans, the disease can kill pigs within a few days, and the fatality rate can be up to 100%, according to the World Organisation for Animal Health (OIE)

One farmer told the BBC it had killed more than 300,000 pigs since the outbreak began a few months ago.

operative settlement managed by the Lagos State government, is regarded as one of the biggest pig farms in West Africa.

## SAs business confidence hits record low as lockdown batters economy - survey

SOUTH **Africa's** business confidence hit a record low in the second quarter, a survey showed on Wednesday, as a coronavirus-led lockdown stalled an economy that was reeling from a recession even before the COVID-19 pandemic.

The Rand Merchant Bank (RMB) business confidence index (BCI), compiled by the Bureau for Economic Research, was at 5 points

for the second quarter, the lowest level since the first survey in 1975 and down from 18 points for the first quarter.

Africa's most industrialised economy, which entered its second recession in two years in 2019, has been largely shut down since late March, when the government imposed severe restrictions to stem the spread of the novel coronavirus.

The country began phased easing of the lockdown in May.

"COVID-19 has drastically changed the already-weak economic landscape and perhaps, in some cases, permanently," RMB chief economist Ettienne le Roux said

"We are likely only beginning to fully appreciate the complexity of the economic impacts of this

pandemic."

Firms will likely continue to face an income squeeze as costs rise, while weak demand weighs on prices, and many will have to find new ways of doing business, according to the survey.

It also said that the BCI plunge to five was consistent with a "never seen before" contraction in economic growth.

South Africa's central bank expects the economy to shrink 7% this year, but economists expect an even deeper recession as well as deep job losses.

The survey showed that business confidence declined across all sectors, but retail confidence held up relative to the other sectors because of the sale of essential goods.Reuters

Talks between the two clubs reached an advanced stage last week, but a final deal has yet to be agreed with City reportedly holding out for a fee in the region of €70 million (£62m/\$79m) for a prized asset.

Should the Germany international indeed complete a move to Allianz Arena when the market reopens, he will be expected to slot into Hansi Flick's line-up on the left wing. However, Coman has occupied that role for the majority of the 2019-20 campaign, and isn't worried about losing his place after competing with a whole host of world-class players for regular minutes throughout his time at Bayern. ### Federer out of tennis until 2021 after knee surgery

TWENTY-time Grand Slam singles champion Roger Federer said Wednesday he will be sidelined until 2021 after undergoing his second knee operation in a matter of months.

The 38-year-old Swiss said he underwent follow-up arthroscopic surgery "a few weeks ago" after undergoing a similar keyhole procedure in February.

Federer, whose last Grand Slam win was the 2018 Australian Open, said he "experienced a setback during (his) initial rehabilitation".

"I plan to take the necessary time to be 100 percent ready to play at my highest level," he said in a statement on Twitter.

"I will be missing my fans and the tour dearly but I will look forward to seeing everyone back on tour at the start of the 2021 season."

The announcement is likely to renew speculation about retirement for Federer, who holds the record for men's Grand Slam singles titles and last month topped Forbes' list of the world's highest earning athletes.

Federer, who won his first major trophy in 2003, lies just ahead of his longtime rivals Rafael Nadal (19) and Novak Djokovic (17) on the all-time list.

The biggest title he has yet to win is an Olympic singles gold medal.

The Tokyo Games -- seen as Federer's final opportunity to complete a career "golden" Grand Slam -- have been postponed until next year because of the pandemic, and Federer will turn 40 on the day of the closing ceremony.

After the initial operation, Federer had originally planned to return for the now cancelled grass-court season this month. His last tournament match was on January 30 in the Australian Open semifinals, where he lost to eventual champion Djokovic. AFP
