THE complaint against the registration and directors of Mwamona Engineering and Technical Services is malicious and politically motivated, NDC leader Chishimba Kambwili has told the Lusaka Magistrates' Court.

Kambwili, who denied forging a "no change return" (companies form 71), also told the court that Mwamona Engineering and Technical Services was registered by his wife in 2001, before he was either a member of parliament or minister, contrary to EEP leader Chilufya Tayali's claims that it was registered in 2013.

And Principal Resident Magistrate David Simusamba has censured Tavali, who is the complainant in the matter, against posting opinions relating to the ongoing proceedings on social media but to report on facts as they turn out in court.

Meanwhile, Kambwili has re-engaged his former lawyers in the case, Keith Mweemba, Gilbert Phiri and Christopher Mundia to continue acting for him

The three defence lawyers will be representing the accused alongside former Attorney General Musa Mwenye State Counsel.

In this matter, Kambwili is charged with three counts of forgery, uttering a false document and giving false information to a public officer in relation to the registration of Mwamona Engineering and Technical Services.

On November 28, last year, magistrate Simusamba found Kambwili with a case to answer in the matter and consequently placed him on his defence.

Kambwili describes forgery complaint as malicious, politically motivated

But in February this year, Kambwili's defence lawyers Mweemba, Phiri and Mundia excused themselves from representing the accused in the matter.

Kamwbili consequently retained Mwenye as his lawyer in the case.

The accused who had not commenced defence yet, was only able to do so yesterday when the matter came up before magistrate Simusamba.

Opening his defence, Kambwili, 51, told the court that Mwamona Engineering and Technical Services was incorporated by his wife Carol Chansa in 2001, adding that the complaint against its registration and directors was malicious and politically motivated.

"This is in view of the fact that prior to Mr Tayali reporting this matter to the police, he held a press briefing where he made allegations and I quote 'honourable Chishimba Kambwili had registered a company with a fictitious name with a view that he can be getting company contracts as a minister without being depicted that he was involved in that company'. During that briefing he stated that the company was registered in 2013 when I was Minister of Youth and Sport in government. To the contrary Mwamona was registered in August 2001, way before I was either an MP or a

minister in government," he said. Kambwili said the Genesis of the registration of Mwamona was that his wife, his sister Daisy Kambwili and himself were running a company called "CK Scrap Metal Merchants and General Contractors Limited".

He said he was also running a company called CK Technical Services Limited whose directors were himself, his wife and another.

Kambwili said when he got involved in politics, the two businesses started having problems due to political interference by the then MMD government.

"There were instructions given to mining companies who were principal customers not to deal with any companies where Chishimba Kambwili was a director," he said.

He said consequently, his wife decided that she needed to register a company with their son, Mwamba Chishimba Kambwili, and his younger sister Sampa Kambwili.

Kambwili also produced Mwamba's birth record, which he tendered in as part of his

He said the only directors in Mwamona were his son and wife as they later on decided not to

And Kambwili said the signature he was alleged to have forged in the first charge belonged to him.

He said he had never forged a document in his life and that he was a law abiding citizen.

"This charge is laughable. This is my signature and I signed it. How do I forge my own signature? I had the power of Attorney from my son to sign on his behalf. I have never forged any document in my life. I am a law abiding citizen," Kambwili said.

Meanwhile, magistrate Simusamba censured the complainant, Tayali, against posting opinions relating to the ongoing proceedings on social media but to report on facts as they turn out in court.

This was after Tayali posted on his Facebook page a post stating "Production of forged documents in court is a very serious offence, must I complain on this one too? #Birthcertificate". He said he had been unable

THE Patriotic Front has applied to be joined as an interested party to a matter where a Livingstone magistrate is seeking an order that the Registrar of Societies deregisters all political parties which have not practiced democracy

PF has submitted to the Constitutional Court that being a ruling party, it has sufficient interest to be joined to the proceedings as any order or declaration that may emanate from the petition may have a bearing on it.

In this matter, Benjamin Mwelwa, an Advocate of the High Court, has petitioned the Court, seeking an order and declaration that any political party which was registered and in existence as of January 5, 2016 and which has not promoted and practiced democracy through regular, free and fair elections, within its political party, has breached article 60(2)(d) of the Constitution (Amendment) Act no. 2 of 2016 and therefore such a political party ceased to exist as a political party in Zambia on January 4, 2017.

He wants an order that the Registrar of Societies deregisters all political parties for having ceased to exist as political parties in Zambia on January 4, 2017 and since violated article 60(2)(d) of the Constitution of Zambia

joined UPND as an interested party to the matter.

This was after Stephen Katuka in his capacity as Secretary General of the UPND, applied to join the case as an interested party, saying the petition targets all political parties in Zambia, of which UPND was the main opposition party.

And now, Mwila has also applied to join the case as an interested party.

According to an affidavit in support of summons for joinder as an interested party, Mwila stated that the PF as the ruling party would be affected by any order or declaration that may emanate from the petition.

"The petition seeks declarations affecting all political parties in Zambia. The Patriotic Front is the current ruling party and any order or declaration that may emanate from the petition may have a bearing on it. In light of the above, the Patriotic Front as a political party has sufficient interest to be joined to these proceedings," read the document.

Falling kwacha has robbed Zambia chances to benefit from low oil prices - Chikwanda

ENERGY Institute of Zambia (EIZ) chairperson Johnston Chikwanda says the kwacha's depreciation against convertible currencies has cast a dark cloud on the country's chances of benefiting from low oil prices on the international market.

Chikwanda, however, says despite the steep exchange rate, the government should find a way of passing on the benefit of the low prices to consumers.

In an interview, Chikwanda said Zambia has been robbed of the opportunity to benefit from low international fuel prices due to the state of the kwacha.

"You know we have a very awkward situation as a country and also as a continent in the sense that the prices on the international market have really tumbled...and they will remain low for the rest of this year according to forecasts and only countries with better performing currency index are benefitting from this opportunity and so as a continent and as a country, we have been robbed of the opportunity to benefit from low international prices, by and large because of the deteriorated state of the local currency. The exchange rate is casting a dark cloud over our prospects of a better pump price, it's casting a dark cloud, at K18 and it's very steep, it's very, very steep...but surely, we have to find a better way of maybe seeing how, I don't know, even if it's a one percent or a five percent benefit to the people, hopefully it can be squeezed out as we come to this price," Chikwanda said.

"What happens is that you have to check how far the price has fallen on the international market and how far the exchange rate has also performed; how far has it fallen or how far has it gone up? So that gap between the two fundamentals, that is what is used to determine whether the price should be increased or the price should be reduced or maintained, so we are keeping our fingers crossed and we are hoping that this time around, the potential to pass the benefit to the people could be tenable because what was procured, was procured at a price that was quite compared to even where the price is now."

He, however, noted there is need to review whether there is still need for customs duty waivers for importers of fuel because prices in the region have gone down.

"And so it's a very difficult situation that we are in but what I could maybe advise is at the moment, the refinery is down and the crude oil is not coming in so we have got a number of oil companies that are bringing fuel into the country who have been given a waiver on import. A number of them are bringing in from the region, so the region where they are bringing from, the prices are quite low so we need to verify the customs duty which we waived, whether it is still valid to waive or it shouldn't be waived so that we can test whether what we are buying from the region can still land at an affordable price even without further incentivizing them," said Chikwanda.

'TI-Z makes an urgent call to the Ministry of Health to immediately halt this procurement process whether retrospectively or otherwise in order to allow for a comprehensive investigation to be carried out. Further, we call upon and challenge the Ministry to immediately provide the Zambian public with full information on this matter in order to clarify the circumstances under which what appears to be a gigantic procurement anomaly was allowed to happen. Further, we want to call for a forensic audit of all public procurement at the Ministry of Health from 2011 to date. It is possible that this award of a contract could just be one of several other scandals at the Ministry of Health," he stated

Nyambe stated that it was unacceptable that a contract of that value and magnitude could be awarded in such a circumstance. "Given the foregoing, TI-Z

finds it not just astonishing but unacceptable that a contract of the value and magnitude as has been reported could be awarded in such circumstances to a company that was not in existence at the time of award of the contract. There is absolutely no justification for such action, particularly that Zambia has a number of well-established pharmaceutical companies with a track record

in the drugs and healthcare supply chain. This unfortunate action is symptomatic of glaring weaknesses in the procurement systems at the Ministry of Health, and a blatant and shameless disregard of procurement systems and procedures as outlined in the Public Procurement Act," he said

Nyambe said he was concerned that government entities had continued to treat procurement processes that costed huge sums of money with negligence.

"The unfortunate fact that there is precedence when it comes to such matters at the Ministry of Health is not lost on TI-Z. We recall that in November 2017, the Zambia Pharmaceuticals Business Forum (ZPBF) raised a red flag and wrote to the Zambia Public Procurement Authority (ZPPA) over concerns that the Ministry of Health was deviating from the Public Procurement Act restricting the award of tenders for the supply of drugs to selected companies, pharmaceutical a tender that was worth an estimated US\$80million. TI-Z is concerned that government entities have continued to treat such procurement processes that cost huge sums of money with a laxity that gives a sense of trepidation about what else is going on," he observed.

Nyambe appealed to the office of the Auditor General to take interest in the procurement processes at government ministries to stop apparent abuse.

"The Ministry of Health has in the last couple of years continued to make headlines for all manner of wrong doings particularly where public procurement is concerned and it is time that action is taken to clean up house and put a stop to the apparent rot. In the same vein, we would like to appeal to both the Office of the Auditor General and the ZPPA to take particular interest in procurement processes at government Ministries in order to put a stop to the apparent abuse and disregard of the provisions of the Public Procurement Act in these entities," stated Nyambe.

The demise of President Peirre Nkurunzinza is a tragedy. recall that President Nkurunzinza played а significant role in successfully ushering Burundi into the East African Community Economic Bloc in November 2006," posted President Lungu.

"He will also be remembered for having aided the reformation of the economic community of the Great Lakes Countries, the trade organization that comprised Burundi, the Republic Democratic of Congo and Rwanda in April 2007. Further, he will be remembered for spearheading infrastructure projects aimed at making water and electricity more accessible to the people of Burundi. On behalf of the government of the Republic of Zambia, the people and indeed my own behalf I wish to convey sincere and deepest condolences to your Excellency to the government of the Republic of Burundi and the bereaved family on the death of outgoing President of the Republic of Burundi Mr Peirre Nkurunzinza. May the Almighty God comfort the bereaved family and the entire nation. As we join the rest of the world in commiserating with the people of Burundi, please accept your Excellency the assurances of my highest consideration."

leader, who was a dictator, to die.

"Remember him just as government alone, not including the people, there is nothing good to remember about [a] dictator. Us the people are just waiting on whose next," wrote Mcdonald.

Another follower, Clement

Sikazwe, said the 'angel's' mission had not yet been accomplished.

"Very sad indeed, it's good that the angel is still roaming in Africa. The mission hasn't been accomplished yet," said Sikazwe.

Innocent Kangwa said God was blessing other countries.

"See what God is doing for other countries," posted Kangwa.

Meanwhile, Keith Moono likened Nkurunzinza to President Lungu for trying to run for a third term. "Nkurunzinza was

а dictator who manipulated his country's constitution to run

for a third term just like the way to impose Bill 10 on us," said Moono.

President Lungu's handlers were forced to delete the post. This is the second post to be deleted in a space of a week. The first post which was deleted was a video in which the Head of State ordered

police to sort out youths who were planning to protests against various governance issues.

Nkurunzinza was President of Burundi since August 2005. He died three weeks after the election of his successor, Évariste Ndayishimiye.

By Ulande Nkomesha UPND president Hakainde Hichilema says there is growing tension in the country because government is giving more business opportunities to foreigners than Zambians. Meanwhile, Hichilema says like George Floyd, a lot of Zambians had died at the hands of police.

Speaking on SABC News, Wednesday evening, Hichilema said the failure by government to take into account the importance of offering jobs to Zambians rather than foreigners has spurred friction among youths.

"There is definitely tension in the country. There is a feeling amongst citizens that opportunities are being given to the Chinese more than the local people are. What are these opportunities? Access to land, mining licences, trader's licences, contracts in the road sector. The citizens are seeing this trend as one which is favoring foreigners in particular China at the expense of local people, at the expense of jobs for the local people. You will find that a company, a road construction company run by the Chinese, the basics of jobs are being done by the Chinese while Zambians remain unemployed. So I think this is the issue here and any government must take into account the importance of offering opportunities for jobs, for business, for contracts to its citizens as well. Otherwise you create this friction, that is what is happening in Zambia," Hichilema said

Hichilema also said government illegally deprived locals from undertaking gold exploration by giving access to a Karma mining, a Sudanese company.

"We all understand the importance of investment in a country to grow the economy, to create jobs but what is happening in our country is that the issuance of all opportunities in the mining sector to entities, in this particular case we are talking about the Sudanese group of people that they have been given access to the gold resources. Resources that a number of Zambians already had licences over and this government is trying to take away the mining rights, the mining opportunities, processing opportunities and granting them to Sudanese in a dubious manner without actually making a competitive permit along the way. So that marks of corruption, that is what citizens are complaining

about," he said.

And Hichilema said government was using police to suppress youth voices on various matters.

"The youths were voicing their concerns with regards to employment, to lack of opportunities and indeed many other difficulties that the population in Zambia is having. The youth in particular, even the issues of schools, colleges, are a problem long before the coronavirus arrived here, already, our population was in distress. The youths had been voicing their views and dissatisfaction and one Minister in Lusaka threatened to brutalize the youths using the police and using their political party thugs," he said.

"The President, instead of actually moderating his Minister, he encouraged his Ministers that they should actually use the police with the Minister of Home Affairs to actually brutalise the youths, including the musicians who voiced their dissatisfaction on the living conditions of the country, this is unacceptable.

I have encouraged the youths continue respecting their freedoms, their rights especially the freedoms of expression because that is a legal entitlement, that is the natural justice, it cannot be taken by anybody."

Hichilema said it had become a pattern for the PF government to use the police to suppress citizens. "Nobody needs to be

incited by anybody, these are adults, the youths have entered adulthood, they understand the provisions in the constitution, they understand that these provisions are universal, they don't need my encouragement or indeed anybody else's encouragement. So, they are doing what is right, anybody that stands in their way, anybody that tries to silence them is actually breaking the constitution, is breaking the law. So there is no issue of inciting anybody, it is within the legal limits. So, nobody should be uncomfortable unless a leadership that is confirming that it is brutal and

it is oppressing citizens. We don't want anyone to oppress citizens' rights," Hichilema said.

Meanhile, Hichilema said like George Floyd, a lot of Zambians had died at the hands of police.

"I must tell you that In our country, we have George Floyd, a number of George Floyd in Zambia. A student was killed at the University of Zambia by the police while she was sitting in her room, the police discharged tear gas canisters in her room and she died out of suffocation. Under the police, another youth killed and brutality executed by the police when she was exercising her right of freedom of assembly. All these are in the public domain. So these are the pattern by the party in office except that the region seems not to be aware of these negative issues happening, this is an affront to democracy in our country. We should not tolerate this, no leadership calling itself democratic and constitutional should actually act in the manner the Zambian government should act in. No one is being incited and no one needs to be incited. People must speak!" said Hichilema.

LUNDAZI Central member of parliament Lawrence Nyirenda is in parliament illegally because he does not hold a full Grade 12 certificate or equivalent qualifications, losing independent candidate Colonel Bizwayo Nkunika has argued.

Col Nkunika, 71, has told the Constitutional Court that he, on the other hand, has a full Grade 12 certificate, among other qualifications.

Nvirenda to contest the election.

"By practice in Zambia, when we say a person must have a grade 12 certificate, it means a full certificate comprising at least five subjects," Col Nkunika said.

But Ngulube argued that it was not Col Nkunika to determine who had the requisite qualifications, as it was the preserve of the Examinations Council of Zambia and Zambia Qualifications

has petitioned the Constitutional Court to declare the Lundazi Central parliamentary seat vacant, alleging that the current member does not hold a full Grade 12 certificate.

Col Nkunika cited Nyirenda and the Electoral Commission of Zambia (ECZ) as first and second respondents, stating that ECZ contravened Articles 70 and 72 of the Constitution when it allowed Nyirenda to contest the Lundazi Central seat without meeting the minimum qualifications.

He wants the court to declare the seat vacant and that ECZ should thereafter hold elections within 90 days.

When the matter came up for hearing before Constitutional Court president Hilda Chibomba who sat with four other judges, Wednesday, Col Nkunika told the court that there was a contravention of the Constitution when ECZ allowed

Asked in cross examination by Nyirenda's lawyer, Tutwa Ngulube, to confirm whether he had brought the matter to court because he lost the election to Nyirenda, the former High Commissioner to the United Kingdom said he was in court because the Lundazi member of parliament was in parliament illegally as he did not hold a full Grade 12 certificate or its equivalent.

He added that Nvirenda did not hold those qualifications at the time of nominations, elections or when the matter was brought to court.

"He has never held any rank under the Zambia National Service nor has he undergone military training under the Zambia National Service at his former institution. I do not allege forgery but my complaint is that Mr Nyirenda does not have necessary qualifications to be in parliament," Col Nkunika said.

Authority that were mandated to determine the qualifications a person holds.

The lawyer further argued that Nyirenda held a grade 12 certificate, diploma in secondary school teaching and equivalent qualifications.

And asked by Ngulube which clause was breached by allowing Nyirenda to take part in the election, Col Nkunika said he did not know the specific clause but that Articles 70 and 72 of the Constitution were breached.

Further asked whether the Constitution stopped an elected member of parliament from upgrading their qualifications, Col Nkunika said Nyirenda obtained the upgraded qualifications after the petition over the full grade 12 certificate was also already in court.

The matter comes up on Monday for continued cross examination.

CSPR SOCIAL PROTECTION BUDGET TRACKING & SERVICE DELIVERY SURVEY KEY FINDINGS(Case of Nchelenge & Samfya Districts)

1.0 INTRODUCTION

Social Protection plays a critical role in realizing human rights for all, reducing poverty and inequality, and supporting inclusive growth by boosting human capital and productivity, supporting domestic demand and facilitating structural transformation of national economies (ILO.2019). Public expenditure on social sectors is critical for the development of any nation. This is because social services such as health care provision and education would be undersupplied without government intervention. Moreover, Government intervention in the social sectors is justified on the grounds of positive externalities and market failures (United Nations University, 2019).

Against the above, the Civil Society for Poverty Reduction (CSPR), has been monitoring allocations and disbursement of government expenditure towards social protection programs and other social sectors in general. This has been achieved through detailed budget tracking and service delivery monitoring exercises in social protection as well as health, education, water and sanitation, and agriculture. However, for this report, the budget tracking and service delivery monitoring concentrated on social protection program only despite a small section of the review of budget allocation toward the social sector from 2012-2018. Budget tracking in this paper concentrated on the three pillars of social protection which are Social Assistance, Livelihoods and Empowerment and Protection. The Social Assistance Pillar, concentrates on the protective interventions that seek to shield targeted populations from the consequences of economic and social shocks, poverty and destitution in particular and some of the programs that were assessed included social cash transfer etc. Further, the Livelihood and Empowerment Pillar looks at dimensions that strengthens livelihood capacities through initiatives to empower segments of the population that are poor but have productive capacity



to propel them out of poverty. Initiatives under this pillar covered output -enhancing actions, including agricultural input programs, economic empowerment programs and the **Protection Pillar** which concentrates on interventions that involve the use of policy legal and regulatory instruments for enhancing the welfare of the population,

changing structural causes such as social norms or power imbalances, which are at the origin of poverty and vulnerability.

1.1 2018 BUDGET EXPENDITURE PERFORMANCE IN RELATION TO SOCIAL **PROTECTION PROGRAMS.**

1.1.1 National Budget Disbursement towards Social Protection 2018.

On average the three social protection programs which include food security, pension funds and social cash transfer under performed on allocations versus disbursements by central government. On the other hand, the farmer input support programme performed well in 2018. Disbursement under FSP was only 35.7% of the approved, Pension funds 48.2% and Social Cash Transfer's disbursement was only up to 63% of the approved allocation by the central government.

Only FISP performed well which saw the disbursement go up to 93.8% in the 2018 national budget. The low execution of the social protection Budget has a negative effect on public service delivery especially for the poor and vulnerable rural population. 1.2 2018 LUAPULA PROVINCIAL ALLOCATION.

In Luapula Province, at provincial level, the funding for implementation of departmental programs has been poor with inadequate or no funding at all, with this prevalence being

among programs planned under provincial administration as compared to programs planned by Headquarters do receive fair attention though not adequately funded. There are two programs that were centrally budgeted atK332,640.00 and were allocated K419,397.00. K253,077.00 was disbursed and only K113,602.00 was spent which saw the implementation of programs such as Agriculture Support and Skills Training.

However, funds for the other provincial planned programs which were budgeted for and allocated were not disbursed. The affected programmes include Micro Credit to Women, Non-Formal Education and Skills Training and Procurement and distribution of adult literacy materials. Figure 2 shows the aggregated allocation and disbursement of social protection funds in Luanula Province

from poor areas such as Kilwa Island were excluded from the list of beneficiaries. **1.2.1.1 Community Development.**

Under community development, the total amount disbursed was K172, 249,20 which was more than what was allocated due to the fact that an extra amount of K52,666.33 was also released for Non-Formal and Skills Training Program. Despite the funds for skills training being disbursed by Headquarters, proper guidelines have not been availed on the usage of funds. CSPR observed that the system of centrally budgeting by headquarters in Lusaka, pose a challenge in terms of proper tracking of the funds. The study established that it is the discretion of the headquarters to determine how much funds to disburse to the districts and not necessarily according to district needs. 1.2.1.2 Social Welfare.

On social cash transfer, the total amount budgeted was K12.971.320.00, by the District and allocated was K3.987.560.00 by the central dovernment: Thus, the budgeted amount

2.0 SOCIAL PROTECTION EXPENDITURE AND REVIEW.

Social Protection Expenditure includes releases on services and transfers provided to individuals and households and releases on services provided on a collective basis.



increased from K656 million in 2012 to K2.3 billion in 2018.

The Social Protection (SP) budget has decreased nominally by 15% from the K2.7 billion in 2017 to K2.3 billion in the 2018 Budget. The decline is on account of the reduction in the allocation to the Public Service Pension Fund (PSPF) which has been reduced by 33%. However, the PSPF still accounts for a dominant share of the SP budget at 46% compared to the Social Cash Transfer (SCT) at 31% and other interventions at 17% (ZIPAR &

Government expenditure towards the Pension Fund was K 511,427,000 in 2018 while that on the Social Cash Transfer was at K454,094,000. The expenditure on the Food Security Pack was K 50,000,000 and Farmer Input Support Program was K 1,674,872,000. In terms of expenditure rates, the FISP has the highest percentage expenditure at 93.83%, followed by SCT at 62.9%, Pension Fund at 48.22% and FSP at 35.71% respectively.

Figure 5: 2018 Budget expenditure towards social protection program. 3.0 SUMMARY FINDINGS ON SERVICE DELIVERY MONITORING IN NCHELENGE AND

This section presents the survey findings on the effectiveness and efficiency of public service delivery specifically towards social protection programmes in Nchelenge and Samfya districts of Luapula province. The findings are presented in simple descriptive statistics. A total of 30 Focus Group Discussions (FGDs) with 360 respondents were held in six different wards of Nchelenge and Samfya. These focus group discussions were divided

into groups of youths, women and men. Further to that, semi-structured interviews were held with traditional leaders, government workers and some representative of communitybased organizations.

The survey covered different villages in Nchelenge District namely Mukombwe, Kabuta, Shanyemba, Kanyembo, Chishima and Mulanga. In Samfya district survey covered different villages too namely Mufimba, Luka Mumba, Joseph Lulembo, Kafweni, Fwaka Kunda and Mabo among others. The score card was administered in groups and the leading responses have then been used to make a conclusion and an in-depth analysis 3.1.1 Social Assistance.

In summary, there is limited social assistance in both Nchelenge and Samfya districts as evidenced by the small number of vulnerable people receiving social cash transfer, lack of timeliness in the disbursement of Social Cash Transfer to beneficiaries, inadequate inclusion of vulnerable persons with disabilities on SCT and insufficient support provided through the Food Security Pack program. Additionally, the support given to the most vulnerable people in the community through the public welfare assistance programme is insufficient and there is limited access to social welfare funds and education support.

3.1.2 Livelihood and Empowerment. Regarding Livelihoods and economic empowerment, it was concluded that majority of the women do not have access to grant support. There is limited support towards the provision of equipment to women clubs, inadequate support system to community self-help activities, on-formal and skills training, women development activities, inadequate funds towards village banking, literacy survival skills and non-timely disbursement of funds towards village banking. Despite government efforts in implementing food security packs in certain areas of Luapula Province, food insecurity is at a rise in Samfya and Nchelenge districts due to limited and inconsistent delivery of food security pack (FSP), limited number of early childhood education (ECE) and primary school learners on feeding programmes and communities benefiting from FISP. Further, low capacity households are not provided with agricultural inputs while there is inadequate transparency in the selection of beneficiaries of FISP

3.1.3 Protection.

The protection situation in both Nchelenge and Samfya district has remained poor as evidenced from the responses that have been provided regarding gender-based violence and the total absence of reformatory homes, anti-human trafficking services and the lack of effectiveness of police officers to act on the GBV related cases. 4.0 Conclusion

The study has established the Social Protection budget performance at both central government and district levels. It has also documented the state of Social Protection service delivery in the 2 districts as planned under each pillar of the National Social Protection Policy. In terms of child protection, there is poor staffing of child protection officers in the 2 districts, a situation that has led to failure to prevent the violation of children's rights including the worst forms such as Sexual Gender Based Violence, with high prevalence of child marriages. Government support towards social welfare is inadequate given the huge number of poor people who need it in the districts. Community Development programmes equally suffer from poor funding which include untimely and inconsistent disbursements. Social welfare situation in both Nchelenge and Samfya district has remained poor and the economic livelihood activities in these two districts have remained static, hence, negatively affecting the living standards of majority people. 5.0 Recommendations.

1) Government should ensure timeliness, adequate uptake, financing and coordination of funding and disbursement of social protection funds in all the districts.

2) Government should decentralize the procurement of farming inputs under the Farmers Input Support Program to enhance the distribution process. 3) Government should enhance the needs assessment exercise before embarking on the

distribution of Food Security Pack. 4) Government should ensure that there is adequate support, timeliness, access and transparency in the Social Protection programs.

5) Government should ensure the enhancement of the integrated framework system on Social Protection programs, make Social Cash Transfer predictable, regular and reconsider the value.

6) The Ministry of Community Development and Social Services should be allowed to use Electoral Commission of Zambia, Zambia Army, Zambia National Services transport (trucks) to distribute subsidies such as FISP and FSP.

Burundi cabinet meets on way forward after president's death



Burundi is mourning the death of President Pierre Nkurunziza who died on Monday after 15 years in power

BURUNDI held an extraordinary cabinet meeting Thursday to discuss a way forward after the sudden death of long-serving ruler Pierre Nkurunziza left many anxious over the future of the troubled country.

Nkurunziza, who died on Monday aged 55, had been the government is expected to give an official statement on its outcome later in the day.

"The two vice presidents and cabinet ministers have already approached the constitutional court to declare the presidency vacant," a presidential advisor told AFP on condition of anonymity. ultimately be decided by a "crisis committee" answering to the president's office, a ministerial source told AFP on condition of anonymity.

This group comprises powerful generals like Nkurunziza, who emerged from the ethnic Hutu rebellion during Burundi's long civil say his death could provoke a tussle for power in the upper echelons of government.

Nkurunziza had wanted Nyabenda to succeed him, but the generals opted for Ndayishimiye who won the May 20 election.

May 20 election. While also a general, Ndavishimiye is not a regime from discussing, debating or otherwise making any innuendos in relation to the matters subject of the pending ruling aforementioned."

He added that the continued comments by Lubinda that Bill 10 debate proceedings would continue once Parliament resumes were prejudicial to the proceedings of Parliament.

"It has thus come to me with a sense of deep concern that the Honourable Minister, Mr Lubinda, has issued and continues to issue running commentary on the continued debate of Bill 10 which he claims will continue once the House resumes sitting notwithstanding the pending ruling," Nkombo added.

"I note in particular comments attributed to the Honourable Minister in the News Diggers! Newspaper edition No 681 of 7th May, 2020, also enclosed herewith, in which he was quoted as saying debate on the bill will continue once the sitting of the House resumes, thereby preempting and undermining your ruling on the issue. In my considered view, the utterances by Honourable Lubinda, if correctly reported by the said newspaper, are prejudicial to the proceedings

of the House and are intentionally disrespectful of you, Mr Speaker, given the aforementioned circumstances. To this end, I write to seek redress against Hon Lubinda pursuant to sections 10 and 28 of the National Assembly (powers and Privileges) Act Chapter 12 of the Laws of Zambia as amended by the Act No. 13 of 2016. "

He further asked Dr Matibini to direct members of parliaments to desist from making running commentaries on the process of enactment of Bill 10.

"I further seek indulgence, sir, that you direct all other persons, be they members of parliament or otherwise, to desist from making running commentaries on the process of enactment of Bill 10 pending delivery of your ruling on the point of order raised as allowing them to do so has the potential to demean the processes of this august House. I look forward to your further guidance on the subject matter of this letter and indeed on the point of order raised once parliament resumes sitting on 9th June, 2020 as announced by the Clerk of the National Assembly recently," stated Nkombo.

Europe to reopen borders but world virus toll mounts

BRUSSELS set out plans to reopen the EU's internal borders on Thursday, even as the global coronavirus outbreak hit worrying new landmarks in the United States, Latin America and Russia.

The European Commission recommended that the 27 EU members fully reopen their frontiers with each other on June 15 and with the western Balkans from July 1.

Europe's borders with the world beyond will open more gradually after that -- and only to countries where the pandemic is seen as under control.

The United States, which has the world's highest number of deaths and infections, marked a grim new milestone as

The ruling party declared him a "visionary" and "supreme guide for patriotism", and some officials likened his death to a catastrophe.

But he did not wield power alone, and analysts hardliner and Nkurunziza had been expected to continue to play a significant role in the background.

His 2015 run for a third term in office sparked protests and a failed coup, with violence leaving at least 1,200 people dead while some 400,000 fled the country.

A climate of fear marked by a crackdown on the opposition and media settled over Burundi in the years after. Rumours swirled on social media about his death, with some suspecting he had been infected by coronavirus.

His wife, first lady Denise Bucumi, who was recovering from the coronavirus in a Nairobi hospital, flew back to Bujumbura late Tuesday. *AFP*

Russia meanwhile passed the symbolic milestone of 500,000 confirmed cases, and Iran said 180,000 have been infected there.

And the death toll in Latin America passed 70,000 fatalities on Wednesday, according to an AFP tally of official figures.

In all, the novel coronavirus has killed at least 416,000 people and infected more than 7.3 million since the outbreak emerged in China last December, according to an AFP tally of official sources.

The epidemic, along with economic and social lockdowns imposed by governments to contain its spread, has also left economic devastation in its wake.

The Organisation for Economic Cooperation and Development revealed Thursday that in the first three months of 2020, the G20 major economies shrank by 3.4 percent.

This is the largest decline since records began in 1998, with the steepest decline in China, where the economy shrank by 9.8 percent. *AFP*

By Abraham Kalito SOCCER administrator Simataa Simataa has backed calls by England-based former footballer Howard Gayle to have Godfrey Ucar Chitalu honoured and his name added into the Hall of Fame as one of Africa's best strikers to ever grace the game of soccer.

Simataa, however, says the former footballer is only supporting a cause that was established years ago by the local authorities to acknowledge what Chitalu accomplished during his playing career.

"One, it's to lay information at the doors of FIFA, CAF and FAZ. Secondly, some people some time ago, I think led by Jerry or other people, did go to FAZ and say 'here are the facts', I think under Kalusha's administration. And an answer came forward where FIFA said they did not believe those records. I think that year, Maradona was being honour Godfrey Chitalu claimed to be the highest scoring player at national team level. So, this person (Howard Gayle) is only supporting the cause, there has been a cause and maybe him being from Europe, they might listen. He has done well. The only thing I see is that there is an element of bias and it borders on racism, that I can say. I have heard a stupid comment from an official from FIFA that if it were true that Chitalu scored those goals, then the defense were weak,"

Simataa said. He charged that officials from FIFA have refused to honour Chitalu because "he is a black man from Africa".

"Some FIFA people came to check that record. Firstly, I think our record keeping is poor. But when someone researches and brings you the evidence, you cannot deny that evidence on the basis of reading. You must do a similar research and come up with a different result. Jerry did a research, he compiled where each goal was scored against who and it amounted to more goals than the 107. But those are the ones that FAZ recognised. The year before and a couple of years after, he still scored more than 80 goals in a season. And in fact, we are doing injustice to the man by focusing on one season. And we had



He said FIFA should at least give Chitalu a qualified recognition instead of ignoring the empirical evidence presented by local officials on the former Chipolopolo's feat.
