### We've not donated any bicycles to Zambia Police – Japanese Embassy

THE Japanese Embassy says it has not made any bicycle donations to the Government of the Republic of Zambia or to the Zambia Police.

The Embassy told News Diggers that the Ministry of Home Affairs might have made a mistake to allege that the bicycle donation came from Japan, saying "maybe it was another country".

Following a trending social media image of an officer posing on a police branded bicycle, citizens demanded to know how the bicycles would be used and the cost for procuring them.

It was alleged that the bicycles were procured at a cost of US\$700, 000, a claim which both the Ministry and the Zambia Police dismissed.

"We wish to warn individuals and cliques with the habit of posting false and malicious articles on social media to desist from the practice as the act amounts to criminality. Furthermore, we wish to advise members of the public to disregard the information with the contempt it deserves."

The following day, Inspector General of Police Kakoma Kanganja issued a statement to the effect that some of the bicycles were bought, while the rest were donated to the service and meant for use by officers under the Victim Support Unit (VSU) and the Community Services Division (CSD).

"This will enable the officers to respond to complaints in areas that are difficult to access by use of motor vehicles. Additionally, we have received donations of bicycles from various stakeholders which are meant for effective policing. I therefore urge members of the public to support the work that the Government is doing for the men and women in uniform and avoid dragging the Zambia Police Service into politics," said Kanganja. But the Japanese Embassy distanced itself from the donation.

"The 100 bicycles were donated and nine have been distributed to each province. Don't believe what you see on social media that is the work of the opposition and their propagandist teams. That information is stale we don't repeat the same things. Things that were there last week, we don't repeat them this week. People will be laughing at you. Why should you be repeating things that are already in public domain? That is not news anymore," Chifuta said.

Asked if there was a handover ceremony where the Japanese Embassy made the donation, Chifuta responded in the affirmative, adding that the donation was made directly to the Zambia Police.

"The donation was made to Police service not to the ministry. I don't fall under the police service I fall under the Ministry of Home Affairs. And of course you see, whenever there is a donation, how does it get over to an institution if there is no handover ceremony? It is a must it was there, obviously the handover ceremony was there. How does the police get hold of the bicycles without a handover ceremony from the Japanese government? The handover was done between the police service and the donating institution. You need to understand that other institutions like you, there are some that wish to be publicise when they are donating, and others want to do it silently. But I am not saying that, that is how it was, no." said Chifuta.

"Abashilefwaya ukuichindika bafume munshila (Those who want to misbehave should get out of our way.) Inchito twakwata (the job we have) is to bring members to the party. Who is causing that? I have to know...I have come here because the

Central Committee made a decision that no one is allowed to campaign now until such a time when the Central Committee will give a go ahead. And I want to find out who is in the forefront and I want to categorically tell you that my job is to protect the incumbent members of Parliament, including Cabinet Ministers," Mwila said.

"Anyone who is trying to undermine these three, including a Cabinet Minister, my job is to deal with them. That is why I am there. A Cabinet Minister cannot be harassed by a constituency official; it is only here in Mufulira. A presidential appointee? I have never seen where area members of Parliament are being kicked like I don't know. Yes, we are there in positions to work for the party but we have to protect the people who are in these offices. These issues have not started today, they have been going on and all of you are aware. But above all, we need to unite and move forward."

Responding to the allegation, Ministry of Home Affairs public relations officer, Nephas Chifuta said the 1,000 bicycles in question were donated by the government of Japan through the Embassy in Lusaka.

"The Ministry of Home Affairs wishes to refute media speculations that government has bought one thousand bicycles at a cost of US\$ 700,000 breaking the cost of one bicycle to US\$700,00 which is equivalent to K700.00, as fictions, malicious and meant to mislead by Zambians. The accurate information is that these bicycles were a donation by the Government of Japan to the Zambia Police Service to facilitate policing in places that cannot be accessed using motor vehicles. The Inspector General of Police Kakoma Kanganja after the donation directed that the bicycles be distributed to all provinces under the community services directorate to enable Victim Support Unit officers and other specialised units to carry out sensitisation programs," stated Chifuta.

Responding to a press query, the Embassy clarified that at no point did they ever donate bicycles to the government of Zambia.

"It seems like the press release from the Ministry of Home Affairs is mistaken. The Government of Japan has not rendered any bicycle to the government of Zambia. It could be some other country, but kindly refer to the Ministry of Home Affairs for details." stated the Embassy.

News Diggers reverted to Ministry of Home Affairs Spokesperson to ascertain if there was a mix up on fact on the donation from the Embassy, but Chifuta insisted that the bicycles were a donation from the Japanese Government.

Asked to state the date that the donation was made, Chifuta said he could not recall, but insisted that the handover ceremony took place where the Embassy made the donation. Home Affairs Minister Stephen Kampyongo said he was not available for a comment as he was at State House at the time.

# The consequences of 'expropriating' CEC's assetson tax revenue and capital investment

IN January 2008, the Copperbelt Energy Corporation (CEC) became the first privately owned power utility company to list on the Lusaka Stock Exchange (LUSE) in an attempt to boost appetite for local investment and increase ownership by Zambians. Within a short time after this move, a number of local companies successfully bought a stake in CEC. Among these were the ZCCM-IH, Public Service Pension Fund, National Pension Scheme Authority, Kwacha Pension, Workers Compensation, Co-operatives, and some Faith-Based Institutions. Besides, there are at least 4, 400 ordinary Zambians who have bought a stake in CEC, leading to a combined shareholding by Zambians of 52.1%. This mark CEC as a truly indigenous and Zambian majority-owned power utility company. However, the recent stalled negotiations between CEC and ZESCO over the Bulk Supply Agreement (BSA) haveadversely affected CEC's market capitalization value on the Lusaka Stock Exchange in addition to heightening concerns regarding the firm's ability to continue "operating as a going concern". What does the prolonged impasse over the Bulk Supply Agreement (BSA) entail for Zambia's Tax Revenue Base and the appetite to invest in the capital market?

By far, CEC is one of the major tax payers in Zambia. There is clear evidence that CEC has significantly contributed to the growth of the tax revenue base and overall economic growth in Zambia. As a successful indigenous financial entity, CEC has contributed in the past five years an approximate total of USD112 million, USD32 million, USD8 million, and USD103 million in Corporate taxes, Pay As You Earn (PAYE), Customs duty, and Value Added Taxes (VAT) respectively to the Zambia Revenue Authority (ZRA). These are official figures of CEC's contribution to the government. In addition, a total of USD1.5 million was disbursed to the local authority in the form of council rates. With such a track record, one wonders why it is not in the best interest for the country that CEC stays afloat and continues to operate profitably. While ZESCO Limited is within its rights to advance the argument that it has the capacity to power the mines, it doesn't explain how it will efficiently provide the forgone tax revenues or fill the tax revenue gap that will result in the evident that CEC ceases to operate after the expropriation of its assets.

guaranteed the sustained payout of pensions to an enlarged set of beneficiaries. Moreover, CEC has massively contributed to Zambia's development agenda through its disbursements to ZCCM-IH. At the micro level, CEC has disbursed an approximate total of USD7.5 million to over 4, 400 individual shareholders and thus supplementing government's efforts of improving household incomes. All the aforementioned benefits associated with the existence of CEC are at the brink of extinction, and potentially drift into the abyss if a new beneficial power supply agreement is not reached. As such, it is an optical illusion to think that the expropriation of CEC's assets will not affect CEC's massive contribution to tax revenues and the cash flow incomes of shareholders, the majority of whom are indigenous Zambians.

It is important that the CEC-ZESCO standoff is maturely handled and an amicable solution is reached. Despite the many documented positive contributions of CEC, one would expect ZESCO Limited to immediately strike a new beneficial deal with CEC. Besides, it is public knowledge that the foreign owned mines have ripped off the Zambian economy through capital flight and tax avoidance, yet ZESCO chooses to side with a mining company that will eventually be sold to a foreign entity, at the expense of CEC's financial stability and maximum tax revenue collections for the national coffers. We should not kill local investment this way. The ongoing constructive nationalisation of CEC should be halted because it has the potential to adversely undermine the promotion of local investment, especially when one considers the State's previous decisions to fatally kneel on the necks of other local companies like The Post newspapers and Prime TV.

Expropriations that are selfishly and hurriedly implemented are likely to disadvantage ordinary shareholders, who stand to lose out due to the loss of market value as has been the case for CEC. Moreover, the apparent nationalization of CEC's power infrastructure will dangerously affect local investors' appetite to invest in Zambia's capital market, and subsequently reduce the liquidity levels that locallisted companies can tap into for expansion purposes. To this end, the move by ZESCO to expropriate CEC's assets has the potential to negatively affect the growth of the Lusaka Stock Market and create unnecessary bottlenecks associated with the lack of capital injections as a result of the loss of investor confidence. Although ZESCO Limited can potentially buy off the stocks in the event that CEC is delisted on the Lusaka Stock Exchange, such a move would further reduce its liquidity levels and deny the sector the much needed investment. Therefore, stock buybacks may have dire consequences and drain ZESCO's treasury coffers, undercut essential investment, considerably weaken ZESCO's credit position and affect its ability to efficiently support the energy sector.

It is also disturbing that positive externalities such as social investments in education and primary healthcare that associated with CEC are on the verge of being wiped out. By all indications, CEC has positively supplemented governments efforts and one wonders how this imminent vacuum will be filled by ZESCO's move to expropriate CEC's assets. ZESCO's shortsightedness will surely choke CEC's ability to operate profitably, and in the long term adversely affect Zambia's tax revenues, cash flow incomes of shareholders and the growth of the capital market, all of which will combine to stifle Zambia's economic prosperity. As an adult in the energy sector, ZESCO should rise above its narrow, non-commercial and non-investment related interests and put the country first by returning to the negotiating table for a new beneficial power supply agreement that not only benefits ZESCO but also ensures that CEC retains its position as a buoyant and successful indigenous majority owned Zambian company. Hello ZESCO; hello government, is anyone listening? Over to you...

CEC has also immensely contributed to the cash flow incomes and capital investments for a number of businesses and institutions, and the move by ZESCO to enter into a long term agreement with Konkola Copper Mines (KCM) is regrettable because it jeopardizes the finance gap of these institutions. # A PROPOSAL OF ZAMBIA'S GOLD GAME PLAN

N LAST week's article, we looked at the recent developments in the mining industry. At the heart of that discussion was the Gold sub-sector. It was underscored that the country will need a national game plan to transform Gold into a strategic mineral. This week's article will focus on the details of thenational game plan we are proposing. Before jumping into the plan we will give a synopsis of the recent undertakings by the Government of the Republic of Zambia (GRZ) in the sector.

Recent undertakings by GRZ in the Gold mining sector

The recent undertakings by GRZ in the Gold mining sector seem to be undertaken in a noncoordinated fashion. This has merited the call on Government to crafta robust formidable plan. The plan proposed in this article advocates for a twopronged approach of exploiting the Gold resource as a strategic mineral. Firstly, it is advanced that the Gold should be channeled to the Bank of Zambia (BoZ) to induce macroeconomic stability but at the same time, it must alleviate poverty levels through the vehicle of Artisanal and Small-scale Gold Mining (ASGM) cooperatives. Before the plan can be explicated let us unveil the recent undertakings by GRZ in the sector. The following are some of them:

(i) GRZ seems to be undertaking exploration works in Kasenselithrough Zambia Consolidated Copper Mines Investment Holdings (ZCCM-IH) Ltd for its benefit, there are no deliberate actions to gravitate this information to the ASGM operators in communities hosting the gold resource.

(ii) GRZ through ZCCM-IH has partnered with Karma Mining Services and Rural Development (KMSRD) at the mineral processing stage in Rufunsa and Mumbwa. This has been achieved through a special purpose vehicle called the Consolidated Gold Company Zambia (CGCZ) Limited. Under this joint venture partnership, Karma and ZCCM-IH hold 55% and 45% stake respectively.

(iii) CGCZ Ltd has entered into a joint venture partnership with Array metals in a revenue split structure of 65% and 35%, respectively. Through this partnership, Array metals is to provide gold ore to CGCZ Ltd.

(iv) ZCCM-IH Gold company has been formed in which the Ministry of Finance and ZCCM-IH hold a stake of 49% and 51%, respectively. The mandate of ZCCM-IH gold company is to harness the gold sector ASGM operators (i.e., a technical person is attached to aid miners with mining and processing)

The above developments in the sector although important seem not to be undertaken in a coordinated fashion. To this extent, a national GzZZZold game plan has been proposed. If implemented the plan has the potential to organise the above activities in a manner that allows the exploitation of gold for the maximum benefit of all Zambians.

Description of the proposed ASGM plan

The main players in the ASGM plan include the Geological Survey Department (GSD), Ministry of Commerce Trade and Industry (MCTI), Ministry of Mines and Minerals Development (MMMD), BoZ, University of Zambia (UNZA), Copperbelt University (CBU) and ZCCM-IH. The following steps explicate the proposed plan.

Step 1 – GRZ through MMMD to obtain a social license to operate

The first step of the ASGM plan is for GRZ through MMMD to obtain a social license to operate in communities hosting gold resources. This license should precede any exploration works to be undertaken in these communities. The process of GRZ obtaining the license should involve community engagements with various local stakeholders to uncover the government's plan for the sector. The government should demonstrate how it intends to use gold as a strategic mineral resource.

Step 2 – GSD to undertake geological mapping and exploration

After obtaining the social license to operate, GRZ through GSD needs to move into mining areas to undertake geological mapping and exploration. This exercise should be done to quantify gold resources both in tonnage and quality. This geological information is important because it leads to informed decision making. The government cannot begin to contemplate using gold as a strategic social-economic mineral if the reserves are not known both in tonnage and quality. Being cognizant that GSD is poorly resourced, the plan advances that 10% of monthly mineral royalty should accrue into its coffers as a bear minimum.

Step 3 – Developing efficient gold exploitation techniques by Universities

Once the reserves are quantified both in tonnage and quality, GRZ needs to engage UNZA, School of Mines and CBU, School of Mines and Mineral Sciences to undertake Research and Development (R&D) that aims at uncovering efficient mining and mineral processing techniques that lead to the economic exploitation of gold resources. The techniques to be applied in the ASGM sector should exhibit high technical efficiency and must be environmentally benign. cooperatives

The fourth stage of the plan is for host communities to form mining cooperatives. The cooperatives should integrate and organise community members into mining groups having the same social-economic interest. Once the cooperatives are formed, UNZA, School of Mines and CBU, School of Mines and Mineral Sciences can begin to offer technical and business training to these cooperatives in pursuit of building capacity. It is proposed that technical colleges offer education to mining cooperatives inform of craft training such as maintenance and operation of mine equipment. It is important to be cognizant of the fact that formalisation cannot exist without education. This is because uneducated ASM operators even when formalised will continue to use inefficient mining and mineral processing techniques resulting in widespread land degradation, pollution, and significant health impacts.

Step 5 – Establishment of Trade Hubs by MCTI in remote mining areas

Thefifth step in the plan is for MCTI to establish trade hubs in remote mining areas. These trade hubs are to facilitate the buying and selling of gold between cooperatives and ZCCM-IH. The main objective of MCTI will be to facilitate the buying and selling of gold between the cooperatives and ZCCM-IH.

Step 6 – Cooperatives selling gold to ZCCM-IH The production exploited by cooperatives should be sold to ZCCM-IH through established trade hubs by MCTI. The production can also be sold to the external market at competitive prices, this should only happen if ZCCM-IH cannot buy.

It is proposed that the exploited production by the mining company should be sold to BoZ to act as a strategic reserve. The BoZ should be given the first refusal rights in the trading process. The production should only be sold to the external market at competitive pricesif BoZ is not in a position to buy.

# Youths we are in this Together !

HE youth are a formidable force. The youth are the future of the nation. The youths are future leaders. The youth.....there are many 'politically correct' statements made about the youth by our politicians vet there is little truth or meaning in these hollow statements. On 25th April 2019, Professor Nkandu Luo, at the 'Together We Remember' vigil, held in honour of Vespers Shimuzhila, who died when Zambia Police officers stormed University of Zambia Main Campus in October 2018, said she hoped that President Edgar Chagwa Lungu would decide to reopen CBU. We were at this point confused. The Honourable Minister of Higher Education needs to ask the President, who appointed her to oversee Higher Education, to consider reopening of the Copperbelt University? So perhaps then all this hype and accusation of students being behind the closure of the institution is all just hot air because the only reason the institution was closed was because on 3rd April 2019, in broad daylight, His Excellency, the President

- the Emperor that has cloaked us in a coat of debt – ordered that CBU be closed. That is the only reason why Professor Nkandu Luo, notwithstanding her personal incompetence, cannot make a decision to reopen CBU!

We will not go further than those two incidents in highlighting the PF

ZESCO Limited says it was losing over US\$200 million annually to the "unfair and onesided" nature of the Bulk Supply Agreement with Copperbelt Energy Corporation (CEC) that expired on March 31, 2020.

And Zesco says CEC is the one that rejected the bid to renew the BSA as they did not agree to pay a higher tariff to Zesco for off-taking power.

In an interview, Zesco director of Strategy and Corporate Services Patrick Mwila further accused CEC of not being transparent in its metering process, hence benefitting an additional 50 to 100 megawatts (MW) that was not accounted for, leading to losses on Zesco revenues amounting to US\$67.2 million annually.

"As operators of its infrastructure, CEC did not grant or provide access to its meters or metering data to show the true consumption by the mines that showed the true peak on the ZESCO system. As such, CEC enjoyed the additional benefit from what is known as simultaneous maximum demand. This is a situation which occurs as a result of the mining companies reaching their maximum demand consumption at different times to the Maximum Demand readings at the ZESCO CEC bulk supply points. This then results in CEC's summation of its capacity sales to the mines exceeding the actual capacity delivered by ZESCO at the bulk supply points. CEC derives this benefit singularly with no benefit to ZESCO and led to a difference of power readings between 50-100MW in any

### Zesco claims \$200m annual loss from BSA with CEC guys didn't have the mandat so who said no deal? It's no

given month. This meant that ZESCO was losing revenues on unaccounted for power ranging from 50-100MW monthly. This amounted to approximately US\$2.3m to US\$5.6m monthly or up to US\$67.2million annually," Mwila said.

"There were many onerous terms and conditions that ZESCO had to simply endure during the more than twenty (20) years that the BSA ran. These onerous terms included the following issues: In 2017, a joint agreement between the Government, ZESCO and the mines agreed that the mines would pay an effective tariff of US\$9.3c/kWh. However, given the BSA, a challenge still existed on the final tariff that the mining companies paid to CEC. In recognizing the CEC asset on the Copperbelt, ZESCO agreed to charge CEC an effective tariff of US\$8.11c/ kWh which was effected in two parts, a Capacity Charge and an Energy Charge. However, due to the use of an unrealistic Load Factor in determining the two-part tariff, the cash flow tariff to ZESCO was US\$6.8c/ kWh, resulting in a further loss of approximately \$2.5million per month (or \$30million annually). Meanwhile, during this same time, ZESCO was purchasing expensive power to supply all consumers, including the mines from various IPPs (Independent Power

Producers) at prices ranging from US\$8c/kWh to US\$13.5c/ kWh (Average of US\$11c/kWh) representing a subsidy of up to US\$6.7c to both CEC and the mines on every unit supplied."

He added that the company was losing about US\$120 million annually due to the mismatch in price paid by CEC and the actual cost of producing electricity that was being sold to CEC.

"The largest beneficiaries to the Agreements by ZESCO and IPPs have been the mines as is evident through the drought seasons of 2014/15 and 2019/20. Mines have continued receiving a significant amount of power for their operations from ZESCO and the majority of the power in a drought season from IPPs. The average cost of power from IPPs is US\$11c/ kWh against a selling price to CEC of US\$6.8c/kWh. The price to CEC does not represent ZESCO's true cost of providing the power at the points where ZESCO delivers the power to CEC. If ZESCO was to add the cost of wheeling to the supply of power to the mines on the Copperbelt, it would cost in excess of US\$ 13.0c/kWh. The loss in monetary terms due to mismatch between the CEC price paid to ZESCO and the actual cost of supply (paid to IPPs by ZESCO) amounts to approximately US\$10m per month or \$120 million annually. This situation is completely unsustainable going forward," Mwila said.

He said Zesco stuck to the agreement despite the mismatch but will not allow itself to enter into a similar arrangement.

### used to just surrender because they were so scared that if this guy lays off people, I will become unpopular. So mines have been playing that game, blackmailing of the government by corporate entities, that's what's been going on. So Zesco has to stand by the public, we are not going to allow that... We have respected the law, there was a contract which ran for 23 years. Because there was a contract, contracts are laws, we repeated the law, we stuck with government, we stuck with CEC, we said well, it was a done deal, we need to respect this but once that contract is over, people should have plan

B," Mwila said. "...So they will select, it's called cherry picking. It meant that CEC had the right to cherry pick then Zesco has to find money to supply the entire country and supply CEC at a loss. So how do you get out of this, if you are smart, it's a Catch-22, you are caught in an agreement which is lose, lose, lose. Are you going to sign it again and renew it?...I think when they were signing, they thought they were signing something good, they didn't know that the people they were signing with are cruel, these mines and all their friends, they are cruel."

He further wondered why CEC, through the board chairperson, wrote a letter two days to the expiry date of the BSA that the people Zesco was negotiating with, including the chief executive officer, did not have the mandate of the company.

"I mean the guy I was sitting with across the table was their CEO...and their board comes and says last minute that these

### Zambia isn't a theocracy, church can't lead constitution making process – Lubinda

JUSTICE Minister Given Lubinda says the church cannot be at the helm of the constitution making process because Zambia is not a theocracy.

And Lubinda says Mazabuka UPND member of parliament Gary Nkombo's complaint that he is breaching parliamentary privilege by debating Bill 10 on various media platforms is flimsy.

Meanwhile, Lubinda says government decided to gazette amendments to Bill 10 as a show of goodwill that it has no intentions of dribbling citizens as some stakeholders were insinuating.

Speaking when he featured on Diamond TV's Diamond Live program, Friday, Lubinda said it was not in order for the church to lead the constitution making process.

"There is nowhere in the world today where there is a theocracy. Zambia is not a theocracy where the church must come up with laws, no. It is Parliament that comes up with laws, not the church. It can't be done by the church and it also can't be led by the church. You want Parliament to be governed by the church? The legislative power of Zambia derives from the people and is exercised by Parliament. The church are participants but they cannot be expected to legislate, no it's not their role. The legislative function, according to the Constitution is exercised by Parliament, no one else, except the executive," Lubinda said. *Story Continues on P10*

to run for a third term just like the way [you want] to impose Bill 10 on us."

State House aides could not handle these seemingly hateful messages from the Zambian citizens; they were forced to delete President Lungu's condolence message for the late Burundian counterpart. We feel State House aides misunderstood the message from Zambians. It may appear that the citizens who commented on the President's Facebook posting were wishing our Head of State dead as soon as possible. Indeed, the messages were suggesting so, and they were very hateful, but in our opinion, the people of Zambia were merely expressing their deepest dislike for his governance and continued stay in

### office.

There is a good reason for this. Like we have stated in our previous editorial opinions, Zambia has gone through some of the most heartbreaking experiences ever. Look at what happened during the gassing incidences! What started as almost nonsensical acts of criminality in Chingola spiraled into a national crisis that is not common in Zambia. What came to be known as gassing crimes covered a huge chunk of the country. And those reckless acts of criminal vandalism and terror soon changed the behaviour of our usually civil, peace-loving and law abiding citizens into angry mobs that we could not recoanise.

We have stated previously that Zambia

has never before had the callous instant justice mobs burning fellow citizens on mere suspicion of crime. This is something that should make every Zambian, especially the President, to wonder. This is not who we are. We have our differences, but we are not blood-thirsty, we have never been! Zambians hate the sight of blood. There is nothing we value more than the life of a fellow human being. This is why when someone dies, communities normally join in collective grief, even the deceased person's enemies turn up to mourn and wish they had made up before that person died. This is how we are! This is who we are! This is nothing to be ashamed of. Zambians are good people.

President Lungu and his handlers must

therefore not get the wrong message from the reaction to the Facebook posting on Nkurunziza's death. No one is wishing the Head of State dead. What the people want is for the President to leave office in August, 2021 so that someone else can lead the country. That is all they are asking for. Unfortunately, this is the wish within the Patriotic Front too. It's just that members are afraid to speak their minds, but the truth is that they do not want this particular President to stay in office up to 2026.

What is causing people to wish President Lungu gone is the very fact that he is imposing himself on the citizens. They have rejected his third term bid, together with its Bill 10, but the Head of State insists that he is standing again in 2021. This is why people are reminding President Lungu that the President of Burundi manipulated the Constitution, using similar amendments like the Bill 10, to stay in power longer than necessary.

We don't think that there is anyone who would take to the streets to celebrate the demise of President Lungu, no matter how deep the dissent for his governance may be. Will you shoot them?

Get the message President Lungu, people don't wish you dead. They just want you out of office at the earliest possible time. They want you to leave honourably. A wise actor knows that it is good to leave the stage while people are still clapping. On you, President Lungu, people stopped clapping a long time ago, they are now pelting objects at you. Just leave and retain some dignity!

LUSAKA Province PF Youth chairperson Daniel Kalembe says youths planning to protest against various governance issues will be met head on by ruling party youths.

Speaking at a press briefing, Sunday, Kalembe said the PF youths would also protest.

"We know that Zambia does not only belong to Facebook bloggers. Zambia belongs to every Zambian youth. He wondered why the Zambia Council for Catholic Bishops (ZCCB) was crying foul when they did not make submissions both to the National Dialogue Forum

to this program, come and explain and I refuse and then you misquote me, will I have any reason to complain? No. you will say but I gave you the platform," he said.

"Again, I want to ask you, is it consensus only when your view takes prominence, that's when it's consensus? When your view is not accepted it's not consensus? Is that your interpretation of consensus? No, that's a very thin way of defining consensus. People went to the NDF, was ZCCB invited? Yes, they were, did they come, no they didn't, and were they stopped from going, no they were not." And Lubinda said nothing stopped him from debating Bill 10. "Mr Gary Nkombo can knock all sorts of allegations but this particular one is totally flimsy. There is nothing whatsoever that stops me or any other person or any member of parliament from debating a matter because it is in parliament, nothing whatsoever. There is no law in this country that says because this bill is before parliament, don't debate it outside. Secondly, the issue of Mr Gary Nkombo going to

parliament on the 17th of March and raising a point of order and referring to a matter that was in court and asking Mr Speaker whether or not parliament should continue to debate Bill 10 is not an issue because Mr Speaker reserved his ruling. He didn't make a ruling and because he did not make a ruling, I am not compelled to assume that Mr Gary Nkombo's point of order is valid, no, what is valid is the fact that parliament had already started debating Bill 10 and nobody pronounced the curtailment of that process," he said. Meanwhile, Lubinda said government only had good intentions on Bill 10. "Today again, I decided to do an unprecedented act, I did this because I don't want anyone to say I didn't follow, I didn't know what was happening. Never in the history of Zambia has a Minister of Justice gazetted amendments, never. Why am I doing it, it is because I don't want to leave anyone behind, anybody saying 'they are going to manipulate', I want them presented to parliament, I said I am committed to these amendments,

they say no you will manipulate. Today I say alright, I am going to show you not only the blood on my palm, I will also show you the blood in my heart, I am going to gazette this thing so that you can hold me accountable, again they are saying, no he is going to manipulate. So let me make this clear, Constitution making is not about unanimity, no, it is about consensus, not unison," said Lubinda. "And I can say here as an honest and sincere person, when I went through the gazette, I noticed they were some errors. And I want to make it very clear here, they were some errors, if people see that there is a retention of 14 days for the petition of the president, that's an error. What I meant to put in is 30 days, that's what the Nakacinda report says. That's how sincere I am, that is an error, we made a mistake, people who were preparing that document made that mistake.
