### Home of investigative journalism in Zambia

*By Ulande Nkomesha* SPEAKER of the National Assembly Dr Patrick Matibini has failed to find UPND secretary general Stephen Katuka with a case to answer in a complaint where he was accused of threatening two UPND MPs against performing their duties in Parliament.

Dr Matibini was ruling on a point of order raised by Kanchibiya PF member parliament Martin of Malama on December 5, 2019, who wanted to find out whether Katuka parliamentary breached privileges when he was quoted in the Zambia Daily Mail newspaper warning two UPND MPs that the would deal with party them because they did not walk out of Parliament as expected when Constitution Amendment Bill Number 10 of 2019 was tabled.

Dr Matibini said he failed to find Katuka with a case to answer as there was no substantial evidence that he uttered those remarks.

"Honourable members may wish to note that the point of order is based on an article that was published in the Zambia Daily Mail newspaper on Thursday, December 5, 2019, under the caption I quote: 'MP dares UPND to discipline him? Thus, in line with parliamentary procedure and in accordance with natural justice, the Office of the Clerk of the National Assembly wrote to both Mr S. Katuka and the Zambia Daily Mail newspaper requesting them to confirm whether or not the statements alleged to have been made by Mr S. Katuka in the article were correctly attributed to him. The managing director of the Zambia Daily Mail newspaper

confirmed that the alleged statement was correctly attributed by Mr S. Katuka as reported by Mr Steven Mvula, senior reporter, who talked to Mr Katuka in a telephone interview on the 4th December, 2019," Dr Matibini said.

"In his response, Mr Katuka indicated that his party had a clear position about not interfering with the manner in which its members conducted themselves during parliamentary business. He further submitted that the party had also a clear position regarding certain Bills presented to Parliament without usurping the powers of Parliament. He also noted that he was a former senior parliamentarian, who had served the Zambian Parliament for the period of 10 years. Mr S. Katuka concluded by saying that the article in the Zambia Daily Mail was a misinterpretation of his interview with the newspaper."

Dr Matibini stated that the failure for the Zambia Daily Mail newspaper to provide the recording of the interview constrained him from holding Katuka culpable of threatening the members of parliament.

"Honorable members, it is self-evident from the foregoing that the responses by the Zambia Daily Mail newspaper and Mr Katuka are conflicted. In order to resolve these conflicts of versions, the Officer of the Clerk wrote to the Zambia Daily Mail newspaper requesting for the copy of the recording of the interview with Mr Katuka. In response, the Zambia Daily Mail newspaper informed the National Assembly, through the Office of the Clerk that the recording had been inadvertently deleted, but still maintained that the article was factual. Honourable members, Since the point of order was based on a statement allegedly made by Mr Katuka, which the newspaper alleges was obtained through an interview and the said interview cannot be accessed, in order to verify whether or not the statement was correctly attributed to Mr Katuka," said Dr Matibini.

"It was difficult to arrive at a firm conclusion that the article was accurately attributed to Mr Katuka. Moreover, Mr Katuka alleged that the article was a misinterpretation of his interview with the newspaper. The recording

of the interview, whether audio or video, would have certainly supplied conclusive evidence, not only that Mr Katuka was interviewed by the Daily Mail newspaper, but would have also established the context of the interview. In the absence of such independent and cogent evidence proving that, indeed, Mr Katuka made the statement, I am constrained in holding Mr Katuka culpable of threatening the honourable members as alleged. Consequently, I am unable also to conclude that Mr Katuka breached the members privilege."

# Chitalu endorses Lungu for 2021 on first appearance in corruption case

*By Zondiwe Mbewe* CORRUPTION-ACCUSED Health Minister Dr Chitalu Chilufya yesterday failed to take plea in a case he is facing charges of possession of properties suspected to be proceeds of crime due to confusion caused by a horde of PF cadres.

Chief Resident Magistrate Lameck Mwale adjourned the matter to July 16 after the PF cadres attempted to force their way into the courtroom where the proceedings were to take place.

After his case was called when the matter came up before magistrate Mwale around 09:00 hours, Thursday, Dr Chilufya went into the accused dock.

However, before any progress was made, there was commotion as PF cadres tried to force themselves into the courtroom, defying the COVID-19 guidelines which allow only a few people at a time in the courtroom. The cadres managed to overpower judiciary security officers and a few police officers who were trying to enforce order. This made it difficult for

This made it difficult for magistrate Mwale to continue with the matter, prompting him to invite the State prosecutors and the defence team to meet him in chambers where the matter was adjourned to July 16, this year for possible plea, to allow for tightening up of security.

After the case was adjourned, some cadres started chanting slogans after Dr Chilufya, his lawyers and sympathisers walked out of the courtroom.

Dr Chitalu was accompanied by his wife, Dr Mutinta Mudenda, members of parliament and other senior PF officials.

Outside the courtroom, Dr Chilufya pointed at a banner endorsing President Lungu's 2021 candidature and nodded in agreement.

Some traditional leaders were also at court to give solidarity to the minister.

Dr Chilufya has been charged with four charges of possession of property suspected to be proceeds of crime contrary to section 71(1) of the forfeiture of proceeds of Crime Act no. 19 of the 2010 of the Laws of Zambia.

In the first count, it is alleged that Dr Chilufya on a date unknown but between December 1, 2016 and December 31, 2017 in Lusaka possessed US\$200,000 which was used to purchase 6,000 shares in Samfya Marines and Tourism Services Limited from Den Daas Investment Zambia Limited, property suspected to be proceeds of crime.

In the second count, it is alleged that Dr Chilufya on a date unknown but between January 1, 2017 and December 31, 2017 in Lusaka possessed K270,000 cash which was used to purchase 2,000 shares in Samfya Marines and and Tourism Services Limited from Leo Jonas Ngosa Investment Limited, property suspected of being proceeds of crime.

In the third count, it is alleged that Dr Chilufya on an unknown date but between January 1, 2018 and December 30, 2019 possessed K3,000,000 which was used to purchase Lot No. 365/366 also known as Spark Guest House situated in Mansa district of Luapula Property, property reasonably suspected to be proceeds of crime.

In the last count, it is alleged that Dr Chilufya on a date unknown but between January 1, 2017 and December 31, 2017 in Lusaka possessed US\$52,000 which was used to purchase a passenger boat also known as Transport 32 from Smart Own FZE of Dubai in the United Arab Emirates, property reasonably suspected to be proceeds of crime.

It is not a criminal offence. If someone cannot have an audience with the President, and the only way they can attract his attention is to boo him, they will boo him! Take note that the people that booed him are not UPND, it is

### **Ministry of Tourism staffer catches COVID-19**

In a statement availed by Tourism Ministry Public Relations Officer Sakabilo Kalembwe, Thursday, Dr Ponga called on all members of staff to exercise maximum vigilance following the discovery of one COVID-19 positive case at the Ministry.

"Dr Auxilia Ponga has called on members of staff at the Ministry to strictly adhere to health guidelines stipulated by the Ministry of Health following a case of COVID-19 recorded at the Ministry. In view of the case that was confirmed yesterday (Wednesday), the PS has asked members of staff that had been working closely with the victim to stay home for self-quarantine and ensure that they wear face masks, hand sanitize and observe social distance. Currently, the Ministry is working with the Ministry of Health to fumigate Kwacha House and ensure that all members of staff are safe from COVID-19 as they return for work," revealed Kalembwe.

"The COVID-19 pandemic has changed the world from business as usual to

what is now being called the 'New Normal.' The velocity with which the Coronavirus spread and its impact has been severe and has caught most governments, businesses and communities by surprise."

Zambia has recorded 324 new COVID-19 cases and 18 deaths in the last 11 days, bringing the total number of cumulative deaths to 42, while there has been a total of 1,412 recoveries from the time the pandemic started, according to official Ministry of Health data.

From inception, Zambia has recorded a total of 1,895 cases, a total of 42 deaths and 1,412 recoveries, while 153 people recovered in the last 11 days.

Speaking on a Millenium Radio programme dubbed "Law and the People", Thursday, Kapeso described PF cadres' conduct at the Lusaka Magistrates' Court as rubbish.

He warned that he would personally break their legs the next time that case is called.

"I shudder to think really, do these cadres want to be police officers? Us we should go in the villages where we came from? Some of us came from the villages, do they want me to go to the village where I should become a DIG or do they want me to be in Zambia, Lusaka to direct operations? Do they want the Inspector General of Police to go back to Mwinilunga and then start working from there and then they take over the country as party police officers? This is rubbish! I don't think we should entertain this kind of a sense. It is unacceptable, it brings problems and that is why I am saying if exactly that is the way they will think that police officers are powerless, 2021, Zambia will be ungovernable," Kapeso said.

"Next adjournment, I will be there as DIG operations, let me see any political cadre come nkaba fumya amolu (I break their legs). Loud and clear, without fear! I will be there personally as DIG operations. We'll need to bring sanity in this country. There is no one

who is above the law. There is no where where the law savs 'yes, cadres must do whatever they want', no my friend, I am paid to arrest. Even if I disable you, I will be paid for disabling you. I will follow it up with Nelson Phiri, Commissioner in charge of Lusaka when that case is coming up again [and] I will be there with my team, [the] crack squad."

He said the cadres were de-campaigning the ruling party.

"I can assure [you] that, the way we have started, there is nothing that stops us from inviting the leadership of the PF. The way they are saying that at court, I am aware I read the story on social media when honourable Dr Chilufya went to court but I didn't know the circumstances that even the court proceedings could not go ahead because of caderism I mean, what nonsense is that? Who is in charge of security?

Let them apply to go to Lilayi Paramilitary if they want to wear our uniforms. That is why I am saying there is nothing that stops us from calling the leadership of the PF because if they begin to send a message like that, what about their colleagues in the opposition?" Kapeso asked.

"We have to treat people in the same way, not differently. If a cadre from PF misbehaves, he or she must be arrested! If it is to whip them, we must whip them in the knees. If they don't accept, they must be arrested. I have heard the President mention this, challenging the police, 'me I am the President of the Republic of Zambia, do you expect me to come and tell you when to arrest and where to arrest?' This is a lesson we know that if they have behaved like this, are we going to continue to allow them to behave like this? In fact, they are de-campaigning themselves as a political party because they have no respect for the police."

Kapeso said Dr Chilufya had been given a chance to exonerate himself and there was no need to cause commotion at court.

"How do they want Dr Chilufya to be exonerated? How do you want your candidate to be exonerated? Because this is the opportunity that he has been given so that both for and against stories can be given, the evidence can be given in court. He is given a chance to say what he has and inside the courts, it is like a mortuary, they 'say silence in court'. Maybe some of the boys that the PF are using are simply brainless because you can't go to the court and ensure that the magistrate sitting trying to see the case against your client, against your Minister, against your candidate, they want to say 'yes sir we want to hear

what happened and what did not happen, then you say 'no no' in a court of law, making noise," he said.

And Kapeso said the country will be ungovernable if politicians continue to threaten people not to move to certain parts of the country.

"If we allowed that language to infiltrate the entire country, Zambia will be ungovernable. If we allowed that political language to be the order of the day, that people would not allow politicians in their own spectrums, in their own colours, in their own shades, they can't go to one particular place, my challenge is that I want to throw this to their leadership, how do they want their people to behave? You shouldn't leave this to the police, police cannot regulate the political conduct of party cadres because these party cadres have someone who they look up to," Kapeso said.

Meanwhile, Kapeso warned that next time UPND cadres booed the President, police would take action because authority needs to be respected. "Don't ever equate the

PARLIAMENT has adopted the report of the Select Committee appointed to scrutinise the Presidential appointment of Reverend Agnes Chongo to serve as a Commissioner of the Human Rights Commission (HRC).

And leader of the opposition in the House Jack Mwiimbu, who is also Monze central UPND member of parliament, has advised the would-be Commissioner to take note of the grievances coming from people as a result of the state failing to give them a listening ear.

Debating the motion to adopt the select Committee report which was moved by Chinsali PF member of parliament Kalalwe Mukosa and seconded by his Chiengi Counterpart Given Katuta, Wednesday, Mwiimbu noted that many Zambians were aggrieved currently due to the unfair application of the law in the country.

He also said the national broadcaster, ZNBC, was being used by those in government as an instrument to spread hate speech, warning that this could cause strife in the country.

"Mr Speaker, I would like to confess that I have had no interaction with the nominee and I will therefore not comment much on her qualifications pertaining to this particular appointment. However, I would like to comment on the role she will play when the house ratifies her as Commissioner for the Human Rights Commission. Mr Speaker, of late, as a country, we have witnessed gross violation of the rights of individuals in this country and members of the public have been complaining to the authorities to ensure that the rights of individuals are protected," Mwiimbu said. "Mr Speaker, I would like to implore the Commissioner who is going to be appointed or ratified to take note of the following: members of the

public in Zambia have been complaining that the rights of individuals to associate have been violated by those in government. Even in situations where members of the public have complied with Public Order Act by duly notifying the police pertaining to their right to demonstrate or speak freely in public, these rights have been denied."

He said appeals to the Minister of Home Affairs over the denial of rights to free assembly and association have never been responded to.

have "The appeals been falling on deaf ears. It therefore follows that the rights of these individuals, Mr Speaker, who follow the due processes have been violated with impunity by those in authority. Mr Speaker, in Monze, the members of the public have been notifying the police to demonstrate but they have been denied permission to do so. And when they are denied their rights to demonstrate, all that they have to do is to exercise other democratic rights of booing those who do not confer them the right, that's what happens. When you do not accord members of the public their rights, they resort to extreme measures, that's what happens," Mwiimbu said. He emphasized that Rev Chongo needed to take note of the complaints that were coming from members of the public and ensure that they were acted upon. "Members of the public are aggrieved that those who follow the law wanting to demonstrate and air their grievances are being denied the right to demonstrate. But on the other hand, members of the PF who do not follow the laid down procedures are allowed to demonstrate, take to the streetsat any time they want. Journalists in this country are complaining that their right to broadcast freely and air programmes on radio without fear are being frustrated. Would

be Commissioner, please take note that occasions and incidences that are unprecedented in this country have occurred in the last one month where unruly cadres go and attack a radio station and attack the broadcasters and attack a voice [of HH]. They continued attacking the voice in Muchinga, Chipata, Mwinilunga. Cadres have been attacking and damaging these radio stations contrary to what is obtaining under the laws and the protection of human rights under the Bill of Rights. As she assumes this responsibility, please take note of the complaints of the public," Mwiimbu said.

He further said the PF government was using ZNBC to promote hate speech in the country.

"Please take note that ZNBC of late has become an instrument that is being used to promote hate speech in this country. If we are not careful, as we respect human rights, we shall cause strife in this country by irresponsible behaviour of certain journalists and those who are in authority. The rights of individuals in this country, Mr Speaker, should be protected, that is why we have the Bill of Rights. We call upon her and her colleagues to stand firm and protect the rights of every Zambian irrespective of where they hail from, irrespective of tribe or ethnicity. We all look forward to the Human Rights Commission to protect us, but unfortunately, it has no teeth to bite and that is why we have always been urging that the Human Rights Commission be given powers to prosecute those who are offending the Bill of Rights," said Mwiimbu. Contributing to the debate, Justice Minister Given Lubinda expressed confidence that Reverend Chongo would

ensure that people's freedoms of speech were guaranteed within the confines of the law.

"Sir, I would like to join the leader of opposition in talking about what is expected of Commissioner Chongo Phiri when she is ratified by the house to serve as a Commissioner for the Human Rights Commission. Having interacted with the nominee for a number of years and having worked closely with her, I want to say the following about her and her contribution to Human Rights Commission: I want to assure the house that the nominee whom I have interacted with on many occasions promised the appointing authority that she will continue to appeal to Zambians to support the enhancement of the Bill of Rights. She will also continue to be among the men and women of Zambia who will foster debate on national issues using the right fora, that is what she will do at the Human Rights Commission," said Lubinda.

"She will encourage citizens to speak when the right fora is provided to them and discourage those who use other avenues to debate national issues. Sir, I want to assure the House that Reverend Chongo is going to an institution which will call to order [and] encourage free progressive intellectual discourse and discourage hypocrisy and inconsistencies where they only see their argument and not the views of others. She will call such people to order at the Human Rights Commission, knowing that this is the call of everybody who wants to promote human rights."

signed by the central committee which I think has no jurisdiction to expel me, they have no power to do what they did. And doing what they did, they are basically breaking the PF constitution and they are breaking the law as it were. The PF constitution is very clear as to how someone becomes a member of the central committee; a member of the central committee is elected at the general conference. The last time we had a general conference was in 2011 when the late President Sata was alive. From that time, we've never had a general conference. So the central committee doesn't have a mandate to expel me. There is no central committee in the PF technically," KBF said.

KBF said he was giving PF time to think before he could take action, threatening that he would destroy the party if that's what the members wanted.

"Going to court is going to be more embarrassing for the party, so I have been giving them time to think. Have you ever seen an ordinary member being served an expulsion letter by the secretary general of the party? She (Mumbi Phiri) calls me a nonentity but she dares to come to my office to serve me a letter. She knows who I am in this party. She knows what I am capable of doing. So she mustn't play, she knows exactly what I can do. I don't want a fight, I want us to think and resolve this matter properly. I am giving them time to think, I am giving them time to reason...I have been putting money in this party, I have been putting energy and time into this party, do they pay me? They don't! What have I gained from PF? Not one government contract, not one piece of corruption, not one appointment I can say is worth naming. So as far as I am concerned, I have been building something for them. But they don't seem to understand that this party has got a foundation and if they've failed to lead, they should leave. I love this party a lot. But if they want us to destroy the party, we can destroy it, not because I want to but because they don't want us to reason," KBF said.

KBF insisted that the reason he was vying for the PF presidency was because there was a vacancy in the party for that position.

"I don't need to be a delegate to stand as president of the PF. Anyone in the party can stand. And the reason we put this is because we knew we would have people like the current administration who would want to confuse things, we are trying to avoid that. They think they've got things under control; my name is KBF...I am saying that as far as I am concerned, I am a [presidential] candidate, I don't need to be a delegate to be a candidate, that's the law. But I know the reason why there is acrimony towards me is because I stand by the party constitution, I stand by the truth and I cannot be easily corrupted, I am principled. When I was announcing my intention to run for Presidency in April last year, I was announcing because there was a vacancy in the party for the presidential position. People ask me 'but why are you challenging ba Lungu', there is

no challenge, there is a vacancy.

How do you challenge when there is a vacancy? I am vying for that position because there is a vacancy and I want to bring a different brand of leaders to the party. Leadership change is inevitable and no one is challenging ba Lungu because he's not eligible. Ba Lungu to me is not a factor to me, why do you keep on talking about him? I don't even understand that," KBF said.

"I am running for President! I don't need permission from anybody to stand. It is my democratic right, I am going to exercise it and I shall fight to exercise it. Nobody has the right to stop me from standing in this country. I have made Presidents, what can stop me from myself a President?"

Meanwhile, KBF said PF was overreacting to the Monze booing incident.

"Booing the President is an expression of your will, you are trying to show that you are not happy about something. Booing by itself is not an insult, but it is trying to convey a message to somebody that I am not happy about something. I remember I saw a clip of honourable Jack Mwiimbu and Gary Nkombo, they were complaining about certain acts that were done in their so-called strongholds before the presidential visit, the pulling down of UPND flags, defacing of some of their campaign regalia and so on. So you don't expect when you annoy people like that to go in and they begin clapping for you, no. They were reacting because they were angered by something. And for me, I expected the President to go in there, commission the houses for the police and come out and be Presidential about it. All this talk of HH cannot go to this part of the country, we are overreacting. We are one Zambia one nation. So my advice both to the UPND and PF cadres is calm down, this country belongs to every Zambian and every Zambian has got the right to speak his mind, conduct his business without you interfering with his space," KBF said

Asked by callers if he was willing to work with UPND leader Hakainde Hichilema, KBF dismissed that possibility.

"HH is my brother, we were together at the University, I know the guy and I know how he thinks. But here is history, he had Canisius Banda as his vice-president, where is he? He had GBM as his vice-president, he's now talking to my brother Chishimba Kambwili, I don't know what they've agreed. We even had a pact when president Sata was alive but the problem with HH is that he doesn't like anyone to be on top of him. But for me, whoever wants to rule me must prove that he is better than me. Those people who have left HH and those he chased, I have spoken to them and they have told me why. Those who want to work with HH should start from the position of zero, he's been president of that party for almost 15 years and I salute him. But that doesn't mean he's better than some of us in thinking. The only thing I can salute HH for is that he has more money than me. But money is not leadership, leadership is about character and the ability you have to serve a nation," said KBF.

or those of us with school age children, the COVID-19 pandemic has reminded us of the amazing and skilful work done by teachers. Many of my colleagues and a huge number of people in Zambia have had to combine day jobs with looking after children and trying to help them learn, even away from school. It's certainly been a challenge.

But this leads me to a wider point. Even before we'd ever heard of the coronavirus disease; mothers, fathers and other care givers were always children's first "teachers". That's because children are learning and developing even while in the womb, and the first three years of life are the period in life where unrepeated levels of brain development take place. Recent advances in neuroscience provide new evidence about a baby's brain development during this time: We now know that in their earliest years, babies' brains form new connections at an astounding rate - more than 1 million every single second – a pace never again repeated.

Around the world, parents and care givers often still make the distinction between 'learning' and 'play' as if they are very different things. And yet the science is very clear: play helps children become collaborative, creative and curious – essential abilities for life and work in the 21st century. ikula empanga' (Bemba), 'Ng'ombe ni matole' (Nyanja) and 'Mabiya afwida kumubumbi' (Tonga) that highlight the importance of investing in the early years of our children.

Children are intrinsically motivated to play, which makes it fertile ground for learning and developing new skills. During play, children can take charge, making choices about what they do and how. Play can be a highly social activity, allowing for opportunities to learn from and about others. Thus, play can

In the brain-building process, neural connections are shaped by both genes (nature) and life experiences (nurture). This combination of nature and nurture establishes the foundation of a child's future. Yet too many children are still missing out on the 'eat, play, and love' their brains need to develop. Put simply, we don't care for children's brains the way we care for their bodies.

Globally there are an estimated 15.5 million 3-4-year-olds with whom an adult does not engage in any cognitive or socio-emotional caregiving activities, such as reading books, telling stories, singing songs or playing with the child. This all goes to show why parenting is the most important job in the world.

Parents and caregivers combine the roles

To underline this point, in June one of our United Nations agencies, the United Nations Children's Fund

(UNICEF), supported the Government of Zambia to launch a new parenting campaign entitled 'I play, I

learn, I thrive', with the backing of the LEGO Foundation. With government ministries and NGO partners working on early childhood development, we want to get the word out there that stimulation and play are incredibly beneficial to our children, boosting children's cognitive, physical, social, creative and emotional development.

As adults, there's no shame in getting involved. We can create a safe environment for play, and also join in with simple games, baby talk, singing, cuddling, tickling and other such things.

And if we want to give them the best start in life, let's give them the nutrition, protection and stimulation that they need to have healthy and powerful brains. Because when children play, they learn, and they thrive. Much recently it was reposted on 2nd July 2020 by the same page IBAN in a public group called University Of Guyana Faculty of Agriculture & Forestry as an advert to advertise fish farming consultancy.( Apparently these guys also used the exact picture from Israel which we had earlier investigated)

# Two want UPND deregisteredBy Zondiwe MbewePROSPECT Tech Limitedover K400,000 debt

Siame, have dragged UPND | leader Hakainde Hichilema and other party members to court for allegedly failing to pay K400,000 for tickets printed for the party during its national card renewal exercise in 2017.

Siame and Prospect Tech Limited want an order for payment of K400,000 plus 30 percent interest, bringing the total due to K520,000 and, further, an order that UPND be declared bankrupt for failing to pay its debts and that the party be dissolved and deregistered.

They have sued Hichilema, Steven Katuka in his capacity as UPND secretary general, Miriam Masando (organising committee chairperson for the card renewal) and UPND Registered Trustees.

The plaintiffs are further seeking damages for breach of contract and an order that the defendants pays all the costs for the collection and all charges incidental and connected to the suit. gratuitous terms known as mbasela.

The plaintiffs stated that the defendants pegged the tickets for sale at K1000, K50 and K30 respectively.

"The plaintiffs shall aver that according to the information supplied together with the request, the third defendant (Hichilema) was supposed to be the guest of honour at the said event," read the claim.

The plaintiffs claimed that despite delivering the said tickets within the agreed period, the defendants had not paid the money despite asking for more time in which to pay.

"Despite the several follow ups to the defendants at their secretariat, the defendants have neglected to honour the agreement to pay. Despite several assurances that they will settle the indebtedness, the defendants have lamentably failed to honor the payment," read the claim further.

## **Everyone has power to interpret the Constitution – Lubinda**

JUSTICE Minister Given Lubinda says government has no intention of pushing an amendment to Article 128 because it is not the source of conflict between the Speaker of the National Assembly and the Constitutional Court.

And Lubinda says he does not want to talk about calls for the full withdrawal or a referendum to test Bill 10's popularity because they are a "dead issue" which may end up giving him maggots.

Reacting to calls from his predecessor Wynter Kabimba that the Executive should push the amendment of Article 128 of the 2016 Constitution as it remained a source of conflict between the Speaker and the ConCourt, Lubinda said Article 128 did not state that only the Constitutional Court could interpret interpretation? It is to the Constitutional Court. It does not say that, 'you are not allowed to interpret the Constitution.' Everyone has the power to interpret and we can interpret it differently," Lubinda said.

"For example, the national values and principles, you will read that article and you interpret it in the way you understand it. I will read it and interpret it in the manner that I understand it. If there is a conflict between you and me on the interpretation, where will we go for us to arrive at an amicable position? We will go to the Constitutional Court. So, there is no problem at all with Article 128 paragraph (a), there is nothing. Paragraph (a) of Article 128 is very clear that a matter of interpretation should be addressed by the Constitutional Court. that the Speaker has over-stepped.' There is nothing whatsoever which is a contradiction in Article 128 as far as I am concerned," he argued.

And Lubinda insisted that widespread calls for the full withdrawal or a referendum on Bill 10 were a "dead issue".

"That is a very tired argument! That argument is very tired. It is just an argument, which is reaching rigor mortis. It is just a dead argument, we shouldn't go back to that. We already made it clear that, number one, there is no basis on which to withdraw Bill 10. Number two, there is no provision within the Constitution that says that, 'if you want to amend the Constitution, you have to go to the referendum,' it is not there anywhere! The reason why we did not address the Bill of Rights is because that is the one that requires a referendum. So, that is a dead story, it is in the mortuary. Don't resurrect dead issues, that is a dead issue, bring in new issues," Lubinda said. "The opposition that are trying to cling to a dead corpse shows that they have nothing to talk about, they are also exhausted! Even a tick can see that a cow is dead, it moves on to fresh blood, not to clotted blood. That matter is in the mortuary, leave it there. The issue of withdrawing, the issue of referendum that is dead! Let us wait for the ruling of the Court on Jack Mwiimbu's petition to the Court for judicial review, let us wait for what the Court will say. They went to court, the Court said, 'you have no right to ask the Court to stop Parliament.' So, isn't that dead? So, don't take me to a dead issue, I may end up getting magots! I don't want to get maggots, I want to continue with fresh and clean hands."

He said in fact, everyone had powers to interpret the constitution but that only the ConCourt could make final, binding decisions whenever disputes arose.

"This is a non-issue, it is totally a non-issue! You don't have to be a constitutional lawyer to understand what Article 128 is talking about. Article 128 does not say that, 'no one else in the country, no one in the world can interpret the Constitution except the Constitutional Court', it doesn't say that. If that was the case, will people have copies of the Constitution? It will mean that nobody is allowed to even read the Constitution. What Article 128 sub-Article (1) says is that, 'when there is a matter of conflict on interpretation, then the Constitutional Court will be the final one. If there is a difference in opinion between you and me on what a particular article says, where we will go for final It does not say, 'for anyone to interpret this Constitution, they must go to the Constitutional Court."

He added that no stakeholders, including the Judiciary, proposed an amendment to the said article in their submissions.

"This is all the reason why all those who made the submissions, including the Judiciary to the refinement of the Constitution, none of them brought the issue of (Article) 128 because Article 128 is very clear. There is no dispute. I don't understand why anyone could think there is a dispute. You must also understand the reference that was made by the Constitutional Court was done, by the way, that was not the main finding. It was not that the Constitutional Court said, 'the Speaker must not interpret,' they didn't say, 'the Speaker must not.' If you read their judgement, they just said, 'by the way, it appears as though . . . . . . . . . . . . . .

There are a few politicians who have decided to erode the whole country in terms of eroding their confidence in institutions of governance," said Siliya.

Meanwhile, Siliya said the time for people to make submissions on Bill 10 has elapsed as it was now the turn for parliamentarians to make their own input.

### Court sets July 14 for hearing in Bill 10 debate case

Facts, however, reveal that this picture which was put on President Edgar Chagwa Lungu's page on 4th July, 2020 was again merely downloaded from the Internet by his media team. The image originated from Israel and it first surfaced on the Internet on December 26, 2010. It was first posted by an American online magazine focused on technological and scientific advances made by Israeli researchers.

On Tuesday this week, President Lungu posted photographs of road rehabilitation works, claiming they were new images of ongoing road works on the Kafue-Mazabuka Road in Southern Province. "I am impressed with the progress report on the Kafue-Mazabuka Road earmarked

for completion by October 2020. My Government was called all sorts of names because this road had been in a deplorable state for the many years. We listened and committed to work on it," President Lungu stated. But the photo President Lungu was referring to was an old reused image which had been published by various publications in Nigeria, Malawi and the United States of America from as far back as 2017.

The President's media team recognised that publishing the false road construction photo amounted to deceit and they openly apologised, saying it was erroneously attached. What about the other pictures from India, China and Israel which they have been posting? Was that also an attachment error? Come on people. this is the presidency we are talking about! It's not a personal private page that can publish anything

a person feels like. When Facebook gave the Edgar Chagwa Lungu page an authentication badge, it was on the satisfaction that the person behind it was the verified Head of State for a country called Zambia. So it is embarrassing that the President's verified page is publishing fake news.

And people should not say those questioning the pictures are being petty. It's a very big issue. The President of Nigeria cannot post pictures of Levy Mwanawasa Hospital and claim to his people that he has been delivering development. # CK seeks judicial review against Simusamba's refusal to recuse himself in forgery case

By Zondiwe Mbewe CHISHIMBA Kambwili has applied for leave commence judicial to review proceedings in the Lusaka High Court against Magistrate David Simusamba's refusal to recuse himself from presiding over a case where the former is charged with forgery, uttering a false document and giving false information to a public officer.

Kambwili, who has cited the Attorney General as respondent and ex-parte the Principle Resident Magistrate, David Simusamba, stated that it has been difficult for his lawyers to perform their duties effectively as the court room is always poisoned with outbursts of anger and threats from the presiding Magistrate towards him and his lawyers.

He now wants a declaration that the decision of the presiding Magistrate to refuse to recuse himself from presiding over the said case before him is unlawful and irrational.

Kambwili also wants an order of prohibition, prohibiting the presiding Magistrate from continuing to preside upon his case and an order of mandamus directing Magistrate Simusamba to recuse himself forthwith and to surrender the case record to the Chief Resident Magistrate for re-allocation to another magistrate.

He wants, if leave is

granted, a direction that such grant should operate as a stay of Magistrate Simusamba's decisions and the proceedings until determination of the application or until the Court orders otherwise.

In his affidavit verifying facts filed in the Lusaka High Court, Wednesday, Kambwili explained that he was currently facing criminal charges in the Lusaka Magistrate Court for the alleged offences of forgery, uttering false documents and giving false information to a public officer.

He added that the said matter was being presided over by Magistrate Simusamba.

Kambwili stated that on March 20, this year, he made an application asking the presiding magistrate to recuse himself by way of Notice of Motion and its accompanying Affidavit in Support. He stated that his application was premised on the facts that on December 17, 2019, he wrote to the Chief Justice, Irene Mambilima, complaining of the manner in which Magistrate Simusamba was handling the matter, i.e. his attitude towards him and his lawyers and attempts by the Magistrate to extort money from him in exchange for an acquittal.

He stated that before responding to him, the

Chief Justice asked the presiding magistrate to tell his side of the story.

"Among other things, the presiding magistrate, in his letter to the Honourable Chief Justice, stated that it was in fact myself, who had been offering to bribe him from the time the matter was commenced in the year, 2018, and that at some point I had offered to buy him a car so as to influence his decision in the matter," Kambwili stated. "The presiding magistrate's accusations came to me with a sense of shock and I commenced an action for defamation in the High Court against the presiding magistrate and this matter is still active. At the same time, I wrote to the Anti-Corruption Commission complaining against the presiding magistrate."

Kambwili further stated that in his ruling on the application for recusal, Magistrate Simusamba acknowledged the existence of his (Kambwili's) complaint against him to the Chief Justice.

He added that despite having acknowledged the existence of the said facts, Magistrate Simusamba declined to recuse himself asserting that Kambwili had created circumstances, which necessitated the application for recusal.

"He ruled, therefore, that I could not use the circumstances allegedly created by myself to ask the Honourable Court to recuse itself as the same issues were already before competent authorities," Kambwili stated.

He stated that in view of Magistrate Simusamba's ruling on his application for recusal, he (Kambwili) made an application asking the presiding magistrate to refer the matter to the High Court for determination of whether his constitutional right to a fair trial before an independent and impartial court was not being infringed.

Kambwili added that in declining the application, the presiding magistrate ruled that there was no constitutional issue in the proceedings before him.

He further stated that the matter had since proceeded before Magistrate Simusamba and that he had forced him to

internal settlement of football disputes without using the courts of law.

FAZ, through lawyers Messrs Mando and Pasi, wrote the duo's lawyers Lewis Nathan Advocates on July 8, asking them to withdraw the matters in the Zambian courts of law as their concerns will be addressed by world soccer governing body FIFA.

In response, Lewis Nathan Advocates, in a letter dated July 8 addressed to Messrs Mando and Pasi, notified the football body of the decision to discontinue the matter.

"Kindly find attached herewith by way of service upon yourselves a Notice of Discontinuance of the proceedings and Appeal. Please acknowledge safe receipt bu signing a copy of this letter," stated the letter from Lewis Nathan Advocates.

The latest decision could mark the beginning of the end of the disputes surrounding FAZ.

FIFA gave the local football association 10 days,

which end today, in which to normalise all disputes and that all matters before the courts of law must be withdrawn.

"As can clearly be noted from the attached correspondence, FIFA is categorical that any football related dispute involving our Client and any affiliate or official should not be taken to the courts of law and that such disputes must be settled in accordance with the FIFA Statutes and FAZ Constitution. This is our Client's position on the matter hence our Client's application that the matter be referred to arbitration in accordance with the FAZ Constitution and as is required under FIFA Statutes," the lawyers representing FAZ and Kashala earlier wrote in a letter to Lewis Nathan Advocates.

"We further remind you that by commencing this matter in the courts of law instead of arbitration, your clients are in breach of Articles 10 and 63 of the FAZ Constitution which

may be the basis for further charges and sanctions by FIFA and/or FAZ under Article 59 (3) of the FIFA Statutes. We are therefore of the view that your clients' grievances will be addressed by FIFA in the same meeting. Thus, our Client is of the view that your clients should discontinue this matter to allow for an amicable settlement of your clients' grievances with FAZ and to prevent any FIFA sanctions against your clients, FAZ or Zambia as a whole. We hereby request on behalf of our Client that this matter be discontinued by consent of all parties. May we kindly have your clients' position on the matter as soon as possible."

VINICIUS Junior has been forced to sit out training at Real Madrid after "errors" in a Covid-19 test, Zinedine Zidane has revealed, with the club taking precautionary action with their Brazilian forward.

With La Liga action back underway amid the coronavirus pandemic, those involved in competitive action are having to undergo rigorous rounds of testing.

Zidane says the latest of those have "gone badly" at Santiago Bernabeu, with Vinicius temporarily ruled out of his plans as a result.

There has been no indication that the 19-year-old is carrying the disease, but he has not been given the all clear either.

Madrid boss Zidane told reporters ahead of a meeting with Alaves on Friday: "It's not negative or positive. Sometimes there are errors. When that happens, both we and La Liga decide that the player can't train.

"We'll see how it goes. He'll have the results of the retaken test later this afternoon and I hope he'll be with us tomorrow."

Real are already without the services of Luka Jovic, with the Serbian striker - who broke movement restrictions during lockdown and returned to Spain nursing an injury - back in isolation after coming into contact with a friend who tested positive for Covid-19.
