

But according to Mwika in an alleged contempt of court, Sampa had neglected to comply with the Court's order.

She, therefore, applied that Sampa be cited for contempt of court.

But Judge Phiri in her ruling, said leave for an order for committal against Sampa should not be readily granted particularly in aid of a civil remedy where there were other available avenues.

She said it was clear that at the time of filing the application for an order for committal against Sampa on June 25, 2019, Mwika's counsel had filed an earlier application for attachment of earnings, which was granted on July 19, 2019, several weeks before this application was heard before her.

Judge Phiri said it was also clear that Sampa had also filed an application for variation of the said maintenance order, which was the subject of this application.

"For the foregoing reason, I do find that this application is academic in nature and has been overtaken by events in view of the attachment of earnings order issued by the deputy registrar against him (Sampa) on the 19th July, 2019. Applications of this nature should not be taken lightly and brought in aid of a civil debt where there are other remedies for enforcing the debt," Judge

Phiri ruled.

"The applicant should have obtained satisfaction from the said order rendering these proceedings herein academic. In view of the above, the application is dismissed accordingly."

The history of this matter is that Sampa and Mwika were a married couple, but subsequently divorced by the Lusaka High Court through a judgement delivered on June 14, 2018.

Following the judgement for the dissolution of marriage, Mwika applied for an order for maintenance of the child of the family against Sampa before the deputy registrar of the High Court, who rendered a ruling in the said matter on April 23, 2019. Sampa was ordered to

pay the outstanding balance of US \$13,000 school fees at

the American International School in Lusaka and pay a monthly sum of K7,000 towards the expenses of the said child of the family on

or before the 6th of every day of the month. It was **Mwika's** deposition that despite having served the said

ruling, Sampa had failed to pay maintenance of the child of the family for the months of May and June, 2019, as directed by the deputy registrar.



My Bill 10 petition not constitutional in nature, Mwiimbu tells court By Zondiwe Mbewe

LEADER of the Opposition in Parliament Jack Mwiimbu has argued that the case where he is challenging Speaker of the National Assembly Dr Patrick Matibini's decision to allow continued consideration of Bill 10 despite it lasping does not raise any Constitutional issues.

Mwiimbu has submitted that the case is not in any way constitutional in nature as it is anchored on the established practice and procedure of the National Assembly, adding that therefore, the Constitutional Court does not have any jurisdiction to hear and determine the matters in contention.

Mwiimbu, who is also Monze UPND Central

member of parliament, adds that the Speaker in making his decision to allow continued Bill 10 proceedings, was discharging a public function which is amenable to review by the Lusaka High Court.

In this matter, Mwiimbu has applied for leave in the Lusaka High Court to commence judicial review proceedings against Dr Matibini's decision to allow the restoration to the order paper for consideration of Constitutional (Amendment) No.10 of 2019, Bill consequently to allow its continued debate and allow the deferment of proceedings relating to the Bill to a yet to be advised date.

Mwiimbu who is represented by Lusaka lawyer Mulambo Haimbe of Malambo & Company has cited Attorney General Likando Kalaluka as a respondent, arguing that since the lapse of time, the Bill ceased to exist.

The State had, however, asked the court to dismiss the matter for want of jurisdiction.

Cecilia Sikatele, a deputy clerk of the National Assembly argued that the issues raised by Mwiimbu and the subsequent reliefs sought were wrongly

before the Lusaka High Court because they raised matters of a Constitutional nature, which the High Court was incompetent to hear and determine.

She added that "I verily believe that the Constitutional Court is the proper court to be seized with this matter."

But according to an Affidavit in reply filed in the Lusaka High Court recently, Mwiimbu submitted that the State's argument that after deliberations, the standing orders' committee resolved to extend the life of the Bill to a date not later than the last day of the current meeting, exposed the illegality of the Speaker's decision to allow the continued consideration, debate or other proceedings relating to Bill 10 in so far as the State confirms that the standing orders committee purported to extend the life of the Bill on March 24, 2020.

Mwiimbu further argued that the standing orders do not give the standing orders' committee any power to act in the manner that it purported to do contrary to what was deposed by the State.

"Contrary to what is stated by the State, this matter does not raise any Constitutional issues and therefore the Constitutional Court does not have any jurisdiction to hear and determine the matters in contention herein. Rather, it is the decision of the Speaker of the National Assembly to allow continued proceedings relating to the Bill despite it having lapsed that is in contention," he submitted. 'The National Assembly is a public institution and that the Speaker in making his decision was discharging a public function which is amenable to review by this court." Meanwhile, High Court Judge Sharon Newa has reserved ruling after hearing arguments on both sides when the case came up in chambers yesterday.

Debt relief schemes could lead to credit rating downgrades, warns Absa CEO

ABSA Group Limited chief executive officer Daniel Mminele has warned African countries to be wary of participation in debt relief schemes as this could lead to them being downgraded and restrict their participation in the financial markets post-COVID-19.

And Mminele says the financial market position will continue to tighten sharply and affect liquidity conditions across some key markets in Africa following the negative economic outlook amid the COVID-19 pandemic.

fiscal space to allow countries to respond to these challenges, we have seen some multilateral and bilateral agreements in the sovereign space for the lower income countries resulting in some payment holidays and even debt relief in some. I know that there have been calls made for the private sector creditors to join in and, of course, in that vein, we have noted some comments from major rating agencies that imply that participation in various debt relief schemes could lead to adverse action i.e. some rating downgrades could ensue and that could end up restricting market access entered this crisis with already significantly weakened balance sheets limiting some of the effects that we've seen in terms of monetary policy wasting or financial sector policies that were meant to offset part of this tightening and financial conditions. Speaking during the same discussion, Ecobank group chief executive officer Ade Adeyemi reiterated the need for countries to be wary of their debt restructuring options as this would have a longterm negative effect on their access to

Speaking during an online Boston discussion moderated bv Consulting Group managing director and senior partner Adam Ikdal, last week, under the theme: "Africa's economist headwinds: How are the continents business leaders responding", Mminele cautioned that African countries needed to be careful by ensuring that their decisions did not affect their ability to participate in the financial markets in the long-term.

"I think it also worth noting that while private sector appetite may have softened on the back of a worsening macroeconomic backdrop, and many emerging market countries, of course, have received emergency funding for the likes of the IMF (International Monetary Fund) and the World Bank to ramp up the humanitarian response and stand the economic fall-out. But apart from creating this

for some countries and constrain the much-needed post-COVID finance. And I guess why some of the proposals may, indeed, create this fiscal space temporarily to fight the pandemic, they just need to be considered very carefully so as not to inadvertently lead to challenges down the line," Mminele said.

He added that the current negative economic outlook had also seen sub-Saharan African economies face a Balance of Payments (BoP) risk as the deteriorating global sentiment contributed to falling commodity prices.

"As a result of this negative economic outlook, we are seeing financial market conditions tighten quite sharply and affecting liquidity conditions across some of our key markets. And, of course, as has been said before, many African countries

faces a Balance of Payments risk as the deteriorating global sentiment overall would have contributed to falling commodity prices," said Mminele.

"With the (Coronavirus) virus not having been brought under control across, certainly all the markets that we operate in, the outlook remains uncertain and down-side risks still quite considerable. With that said, we are expecting to see growth hold up reasonably well in countries, such as Ghana, Kenya, Uganda and Tanzania with expectations for more pronounced slowdowns when it comes to Botswana. Mauritius, Zambia and the Seychelles and, of course, with markets that rely heavily on sectors, such as tourism and leisure and commodity exports bearing the most of the brunt. In our largest market in South Africa, our most recent forecast, for instance, is for a contraction of 9.7 per cent in GDP.

"Every debt that is lent in the private sector is the savings of somebody else, and every time there is a default in terms of debt, it means that for the long-term you can no longer approach that market to be able to get money. It is difficult to scale-up donations to begin to create wealth to our continent. INFECTIOUS BURSAL DISEASE "GUMBORO" IN CHICKENS

THE poultry industry in Zambia has been one of the fastestgrowing subsectors of the livestock sector that produces a variety of protein-containing foods like chicken, eggs and many others. This subsector is said to contribute around 5% to agricultural gross domestic product and that 50% of consumed meat in Zambia is of chicken origin.

The current poultry production system allows farmers to rear large numbers of chickens in a relatively small space and thus be able to control certain environmental conditions within the chicken houses. With this production system, however, allows for the rapid spread of infectious diseases within a flock and to other flocks leading to significant economic losses.

Viral diseases are the most challenging to manage once broilers or layers are infected as there are usually no effective antiviral treatments available.

What Is Gumboro?

Gumboro is an acute, highly contagious (spreads easily) viral infection affecting young chickens, causing the suppression of the immune system. The name "Gumboro" comes from the area it was first recognized, Gumboro district, Delaware, USA. Chickens are the only hosts to develop clinical disease following exposure to the virus but other poultry like; turkeys, ducks, guinea fowl etc. can serve as a source of the virus if kept with chickens.

How does it develop?

The oral ingestion of contaminated organic material or faeces is the most likely route of infection. Once the virus is ingested, it travels, through the bloodstream, to the Bursa of Fabricius (immune system organ) and starts multiplying within the immature immune cells (B-lymphocytes).Once the immature immune cells are destroyed, the Bursa of Fabricius will not be capable of programming sufficient numbers of lymphocytes, and the chickens will become immunosuppressed.

What are the predisposing factors?

Poor to no vaccination program: Unvaccinated or poorly vaccinated flocks are highly susceptible to contracting gumboro with severe clinical manifestation as compared to vaccinated flocks.


Multispecies farm: Other poultry like ducks, quails, turkeys etc. are hosts for the virus and if rear alonaside broilers or layers will serve as a source of gumboro disease into the flock.

Absence of poultry biosecurity: lack of any form or level of biosecurity possess a major risk to the production as the flocks will be greatly exposed to all kinds of disease-causing organisms, including gumboro.Biosecurity is defined as all measures put in place to prevent the introduction of disease-causing organisms into your flock as well as controlling the spread, to other flocks, once the infection occurs. These measures include; isolation, traffic control and proper sanitation.

Age (Between 3 – 6 weeks old): During this period (3-6weeks) the Bursa of Fabricius is at its maximum rate of development and filled with immature immune cells (immature B-lymphocytes) in which the gumboro virus rapidly multiplies.

How can you identify the disease?

Birds have ruffled feathers, reluctant to move (looking as though "wearing a jacket") with a tendency to



sit.

Whitish watery or mucoid diarrhoea with a spike in mortality

Mortality pattern may range from 5% - 25% in broilers and 35% - 80% in layers

On postmortem:

Petechial haemorrhages on skeletal muscles (breast and thigh muscles)

Bursa of Fabricius is enlarged, filled with a mucoid substanceor small and hemorrhagic.

Increase in kidney urates and mucous in the intestines

Swollen necrotic spleen

How can one manage an infected flock? There is no effective treatment for gumboro once

it enters a flock. However, the following measures may lessen the overall severity of the disease. Isolate chickens showing clinical signs.

Spray a poultry disinfectant on the litter at least once a day for 5-7days, disinfect bell drinkers, feeders and any other equipment to reduce the viral load within the poultry house.

Assign individuals specifically to manage the affected flock only. They need not come into contact with un-affected flock.

• Administer multivitamins to boost the immune system of the chickens

Administer antibiotics if a secondary bacterial infection is suspected.

How can you prevent the disease?

Vaccination: This is the most effective preventive method, and therefore, it is of great importance that it is done correctly. The following are recommendations for Gumboro vaccine handling, storage and administration.

Vaccine Handling and Storage: Always transport the gumboro vaccine in insulated cooler container (away from direct sunlight) with ice packs. It must be stored at temperatures of between 2-82 (store in a refrigeratorbut NEVERin the deep freezer compartment).

Vaccine Administration b.

Step 1: Remove/withdraw all medication, disinfectants and chlorine from the drinking water 48 hours before vaccination. Water tanks must be clean and free of biofilm.

Restrict drinking water for 1hr – 1hr 30min, depending on weather conditions, to ensure all birds are thirsty and ready to drink once the vaccine is administered.

Step 2: Calculate the volume of water to be used for vaccination. Add a vaccine stabilizer (blue dye) or skimmed milk into the calculated volume of water, wait for 20 - 30min.

Open vaccine vials into the water containing the blue dye. Use a graduated plastic bucket or prepare the vaccine directly in the water tank.

Step 4:Dim lights to minimize stress on birds and then pour the reconstituted vaccine into the drinkers, or open the valve of the water tank.

Ensuresufficient drinker space to allow free access to the vaccine solution.

Step 6:Walk through the house after one hour to encourage more bird activity at the drinkers.

Always administer drinking water vaccine during the coldest periods of the day (early in the morning or evening) and keep records of vaccine information.

Sanitation: 2.

Wheel dips, sprayers, foot dips, hand sanitizers/ soaps and clean on-farm working clothes.

Thorough disinfection of farm between flock cycles and allow adequate downtime between cycles.

All Equipment be thoroughly washed and disinfected before being used.

Isolation 3.

Ensure no contact between broilers or layers with other poultry species, wild animals or rodents.

Maintain "all-in all-out" system per production site

Traffic Control

Restrict access into your flocks to only individuals managing the chickens

Feed delivery vehicles are thoroughly disinfected before entry into your farms

On Saturday last week, Banda who remains on the run, mobilised armed PF cadres and stormed Lusaka Central Police where they beat up some unsuspecting officers on duty and got away with an undisclosed amount of money, belonging to one of the officers.

Sources say the incident happened after the C5 antirobbery squad shot and killed a suspect earlier, who happens to be a relative to Banda. The suspected robber died after sustaining four bullet wounds.

This infuriated the PF official who demanded to meet the officers involved in the shooting incident. However, the officers did not comply, prompting Banda to mobilise cadres and besiege the provincial police headquarters, with at least one visible firearm.

Noting the arrival of Banda, armed with a gun, some officers scampered into hiding while one of the officers, Ian Mbewe who is charge of anti-

motor vehicle theft unit, fell victim to a thorough beating.

Banda and his gang then left the police station and went on the run, before officers could mobilise to take him on.

Our loan recovery rate is very strong in the developing world: we started off at 21 per cent in

the COVID-19 Fund to operationalize the industrial yards, projected to create 125,000 jobs by next year.

"The money for the infrastructure was from the AfDB and now that that's done, the Ministry of Finance will come in. So, we are looking to leverage the COVID-19 funding to operationalize the industrial yards and to expand them...what backs that is the development of industrial yards so far in seven provinces. We've finished five already, Mongu is complete; Solwezi is complete; Kasama is complete; Ndola is complete; Chipata is complete. What that means is that we've now created the infrastructure where we are going to promote light manufacturing among citizens. The lines are going to be metal fabrication where we will be working with steel, we'll be processing our timber, some of these products we've been importing from China made out of timber will be made by our own young people. We are investing in automotive and mechanics; there is no reason why we should be importing air filters, oil filters, fuel filters. Those things we can manufacture in Zambia and then, of course, there is agro-processing, which is very huge," Mukumbuta said. "When you look at industrial yards that we are promoting that are under skills development projects for supporting women and youth, more than 50 per cent of those workshops are actually going to go to young people. In the cassava commercialization, we are creating 17,000 jobs, more than 50 per cent of those jobs are going to young people under the COVID-19 initiative that we've laid out. We are going to be creating 125,000 jobs between this year and next year, 50 per cent of those jobs are going to young people. Now, that is what counts, if you look at our portfolio, currently, we've

So, the kind of people that are going to occupy them are going to be mostly women and youth because the project itself that has sponsored the yards is supported by the AfDB for supporting women and youth," said Mukumbuta.

"So, looking forward, we are very confident that we've embraced the right strategies. Zambia is next month going to open the largest starch manufacturing plant in southern Africa owned by a Zambian from cassava. The import substitution for the mines in terms of the starch that they use for their copper refining is actually going to start being achieved through that operation. Through that operation, in Kalumbila alone, we are going to create about 30,000 jobs in the cassava value chain. Now, those are the kinds of strategies that speak to the change that we are looking for, that embraces the women, the youth backed by a strategy for transforming our economy from being a primary sector economy where we are now into an industrial base."

Japan grants Zambia \$24m for upgrading of health centres

JAPAN has signed a grant of US\$24 million to Zambia for the upgrading of health centers in Mushili in Ndola and Chamboli in Kitwe to district hospital level.

This is the third phase of the project which commenced in 2015. Under phase one and phase two of this project, Japan supported the upgrading of some of Lusaka's health centres to district hospitals, at a total cost of approximately K980 million or US\$53 million which saw health centres in Matero, Chilenje, Kanyama, Chawama and Chipata townships of Lusaka upgraded and modernised to district hospital level.

During the signing ceremony, Finance Minister Dr Bwalya Ng'andu said apart from what has been donated, government still needs support to undertake programs such as infrastructure, equipment and transport improvement among others. "Through the signing of these notes and agreement, japan will provide a grant of approximately US\$24 million or K436 million for upgrading the two health centres, in Mushili (Ndola) and Chamboli (Kitwe) on the Copperbelt province. This project will also enhance health care provision and human development performance in the targeted locations and their surroundings. Your Excellency, this is a commendable step as it will complement the government's efforts in reducing the infrastructure gap in the health sector. This commitment is evident in Zambia's 7th national development plan goal that aims to facilitate the building of a countrywide health system that provides equitable access to essential medical products, vaccines, and technologies of assured quality, safety, efficacy and cost-effectiveness. To attain this goal, we

still need support from development partners such as yourselves to undertake programmes including: Infrastructure, equipment and transport improvement; Medical commodities supply improvement; Health care financing improvement; and Health service delivery enhancement," said Dr Ng'andu.

And Japanese Ambassador to Zambia Mizuuchi Ryuta expressed hope that Dr Ng'andu's efforts towards achieving debt sustainability for the country would bear fruit.

"It is our sincere hope that Finance Minister Ng'andu's effort towards achieving debt sustainability will bear fruit. I am totally behind him, as he pursues his goal. At a time, H.E. President Dr. Edgar Chagwa Lungu in his statement of June 25 characterised the COVID-19 as "real", we are still at half-way in our joint endeavour. Let us hope, however, that both of us will prevail in the end," said Ambassador Ryuta. The project will provide facilities and equipment to the existing two health centres such as; outpatient wards, emergency wards, examination rooms, x-ray rooms, laboratory rooms, pharmacies, admission wards, delivery rooms, and operation and surgical rooms, will all be upgraded, modernised, and some of them constructed, at the two health centres. A POLICE officer has testified before the Lusaka Magistrates' Court how an 11-year-old girl narrated to him that her aunt, a Zambia Air Force (ZAF) soldier, allegedly used to inflict pain on her using hot spoons and knives.

This is in a matter where Mildred Luwaile, a 33-year-old Zambia Air Force lieutenant, is charged with assault on a child.

It is alleged that on March 25, last year, Luwaile of ZAF Twin Palm, assaulted a child under the age of 16, who was under her care, thereby

occasioning her Actual Bodily Harm (ABH).

When the matter came up for continued trial before Lusaka Magistrate Nthandose Chabala, Tuesday, Constable Frank Wakumelo testified that on April 12, last year, he was given a docket of assault on a child.

He said acting on the

docket, he followed the victim to ZAF Hospital in Twin Palm where she was admitted and nursing multiple injuries all over her body.

"The victim narrated to me that the accused used to inflict pain on her on several occasions. The medical report also showed that the actions leading to the wounds were not natural or accidental," Wakumelo said.

He said the victim further told him that Luwaile also used to boil water in a kettle and pour it on her in the bath tab and further ordered her not to inform anyone about her injuries.

Wakumelo said the school only knew about the incident when the victim's friend alerted them after spotting the multiple wounds on the child's body.

He said he later arrested Luwaile in connection with the offence and charged her since he had gathered overwhelming evidence against her.

Last year, the 11-year-old

her auntie tortured her by heating spoons and knives and pressed them on her skin after accusing her of having stolen a slice of bread. The juvenile told the Court

that she tried to explain to Luwaile that she did consume the bread as it was eaten by her cousin who was left under her care.

She said Luwaile perpetually abused and inflicted pain on her body by heating a knife on the stove and when it got hot she would tie her hands behind and burn her with the hot object.

The victim said Luwaile once poured hot water on her as revenge for burning her child accidentally.

She further said the accused forced her to be spending nights in the garage, claiming that she used to bedwet.

cross-examination, In the 11-year-old denied being taken to a pastor by her auntie for counselling on assertions that her behaviour was strange.

She said she was sent to the pastor for other errands and not counselling.

Meanwhile, the Court set August 25, this year, for a ruling on case or no case to answer in the matter after the State closed its case.

Tutwa refutes public apology: "LAZ wrote it"

By Sipilisiwe Ncube LUSAKA lawyer Tutwa Ngulube has distanced himself from a public apology attributed to him about his regret for accusing the Law Association of Zambia (LAZ) for illegally staying in office early this year, claiming the legal body itself wrote it.

Meanwhile, the Legal Disciplinary Committee has found Ngulube guilty and ordered him to issue a public apology, failure to which, his practicing license will be suspended.

According to the apology, which was published in some daily newspapers, Ngulube admitted to misleading the public and apologized for his actions.

"On 12th April, 2020, I issued a statement where I accused the executive of the Law Association of Zambia of occupying their office illegally. I made that statement without properly looking at the provision of the law and ended up misleading the public. I would, therefore, like to apologize to the president of the Law Association of Zambia Mr Eddie Mwitwa and his executive for that statement and to the entire legal profession for bringing it into disrepute. I would also like to apologize to the members of the public for misleading them with my statement," the apology read.

But in an interview, Ngulube claimed he had nothing to say because he did not draft the apology as it was the work of the LAZ Council.

"That matter was with the Legal Practitioners Committee, who drafted that apology. I have nothing to say about it because I may be accused of insulting public statement of apology to the president of the Law Association of Zambia and the entire membership within six days of this decision to be published in the daily newspapers at the Respondent's cost, failing which his practicing certificate will be suspended, which statement should be approved before publication. The matter is in the meantime referred to the Disciplinary Committee for further action," read the ruling.

Disruption of court cases by cadres signifies total anarchy in Zambia – Kalaba

DEMOCRATIC Party leader Harry Kalaba says there is anarchy in Zambia as evidenced by the multitude of cadres that caused confusion when Health Minister Dr Chitalu Chilufya appeared in court last week.

Last week, corruption-charged Dr Chilufya failed to take plea in a case where he is alleged to be in possession of properties suspected to be proceeds of crime due to confusion caused by a horde of PF cadres, who besieged the Magistrates' Court premises.

In an interview, Kalaba wondered how cadres could overpower the Judiciary, lamenting that there was complete anarchy in the country

"There is total anarchy in the country! How can court cases fail to take place because of cadres? We are not going anywhere with this, we are wasting our time. If the Court can be intimidated, what about the rest of the people? If the Judiciary can experience such things, then you know we are in trouble. We are playing to the gallery; it is all politics," said Kalaba.

Dr Chilufya has been charged with four charges of possession of property suspected to be proceeds of crime to section 71 (1) of the Forfeiture of Proceeds of Crime Act No. 19 of the 2010 of the laws of Zambia.

In the first count, it is alleged that Dr Chilufya on a date unknown, but between December 1, 2016, and December 31, 2017, in Lusaka possessed US \$200,000, which was used to purchase 6,000 shares in Samfya Marines and Tourism Services Limited, property suspected to be proceeds of crime.

In the second count, it is alleged that Dr Chilufya on a date unknown, but between January 1, 2017, and December 31, 2017, in Lusaka possessed K270,000 cash, which was used to purchase 2,000 shares in Samfya Marines and Tourism Services Limited from Leo Jonas Ngosa Investment Limited, property suspected of being proceeds if crime.

In the third count, it is alleged that Dr Chilufya on an unknown date, but between January 1, 2018, and December 30, 2019, possessed K3,000,000, which was used to purchase Plot No. 365/366 also known as Spark Guest House situated in Mansa District of Luapula Property, property reasonably suspected to be proceeds of crime.

In the last count, it is alleged that Dr Chilufya on a date unknown, but between January 1, 2017, and December 31, 2017, in Lusaka possessed US \$52,000, which was used to purchase a passenger boat also known as Transport 32 from Smart Own FZE of Dubai in the United Arab Emirates, property reasonably suspected to be proceeds of crime.

-MONEY IN YOUR ACCOUNT -MONEY MULTIPLICATION MINISTER of Finance Dr Bwalya Ng'andu has announced an increase in the country's budget deficit to K17.2 billion from K14.8 billion announced in April.

And Dr Ng'andu says K6.8 billion has so far been raised from the K8 billion Covid bond that was recently issued by the Bank of Zambia.

Meanwhile, Dr Ng'andu says 23 percent of the approved K3,875.6 from the K10 billion medium term refinancing facility has so far been disbursed.

Speaking when he а rendered ministerial statement in Parliament, Tuesday, the Dr Ng'andu attributed the widening budget deficit to a reduction in economic activity.

"Mr Speaker, it is estimated that the budgeted 2020 resource envelope will fall short of target by approximately K17.2 billion of the approved 2020 budget. The budgetary shortfall will be on account of the following; a revenue reduction of K12.8 billion arising mainly from the loss of exceptional revenue which was anticipated, Covid related tax relief measures and the general reduction in economic activity; and External Financing of K4.35 billion no longer expected to materialize. In this regard Mr. Speaker, domestic revenues in 2020 are projected to be 17.8 percent below the budget target. Tax revenues are now projected at K47.0 billion against a budget target of 53.9 billion representing a decline of 12.7 percent. The Non-Tax Revenue category is now projected to outperform the budget target of K11.3 billion by 7.3 percent at K12.1 billion. This performance is largely attributed to receipts from dividends and on-lending activities," he said.

He said that external debt service was expected to increase by K2.2 billion this year due to the depreciation of the kwacha.

"Mr Speaker, Government spending in 2020 is expected to increase by an estimated K9.7 billion. This is due to increased Government spending on Covid-19 related interventions and increased external debt payments and other foreign currency

expenditures denominated affected by the depreciation of the kwacha. External debt service is expected to increase by K2.2 billion. Mr. Speaker, the decline in revenues and the increase in expenditures is expected to create a financing gap of K26.9 billion, due to: A loss of resources amounting to K17.2 billion; and An increase in expenditures amounting to K9.7 billion. To close the financing gap, expenditure cuts will have to be introduced because raising financing from the domestic securities market will be constrained by the economic environment and borrowing from external sources is not sustainable as it poses further foreign exchange risks on our future earnings," he said.

"Mr. Speaker, the prudent management of our financing has even become more important in view of the resource requirements to fight the Covid-19 pandemic. We need to give priority to the effective management of our resources to meet our urgent health risks. To this end, Government has engaged the services of an internationally renowned financial institution to provide financial advisory services to the Government in relation to the liability management of its debt portfolio. This exercise, once completed should result in an amicable agreement with creditors and bond holders on the level of debt service payments in the medium term and provide Government the necessary relief to address the immediate risk and challenges. In view of the fact that revenues have declined while expenditures have increased, we are in the process of revising

foreign expenditures would be made using the Covid bond as it was issued to finance domestic expenditures.

Budget deficit grows to K17.2bn

"Mr. Speaker, I wish to report that the Ministry has progressed with the modalities of setting up of an SME Fund that was directed by his Excellency the President. The funds to be used will be allocated from the Covid-19 Mitigation Bond. The Bond is targeting to raise up to K8 billion in tranches from the Banking sector and Pension Funds. Mr. Speaker, I wish to report that so far, Government has managed to raise K6.8 billion. The bond proceeds will solely target to finance domestic expenditures as it is supposed to be applied to boost the economy. No foreign related expenditures will be covered as this will defeat the objective of improving liquidity in the market and negatively impacting the exchange rate of the Kwacha against major tradable currencies," he said.

Meanwhile, Dr Ng'andu announced that 9,762 beneficiaries had so far recieved their funds from the K10 billion facility.

"Mr. Speaker, the financial sector's liquidity challenges have further been eased

through the Bank of Zambia's K10 Billion Medium-Term Refinancing Facility. This Facility is available eligible commercial banks and nonbank financial institutions to access in order to restructure, refinance or extend credit to businesses and households impacted by Covid-19 on more favourable terms. I wish to report that the uptake of the facility commenced with applications from the Banking Sector and Non-Bank Financial Sector being processed and approved by the Bank of Zambia. As at 13th July 2020, we have had eleven (11) banks and twelve (12) non-bank financial institutions submitting applications for financing worth a total of K4,821,2 million, out of which K3,875.6 million has been approved. This represents 80 percent approval of total financing requested and of which twenty three percent (23%) has already been disbursed to 9.762 beneficiaries. Sir, I should emphasize that these funds are meant for relief on the part of business and are offered at relatively lower interest rates. It is expected that financial service providers will pass this benefit to their customers," said Dr Ng'andu.

This is a story we wish could have been fake news. What is even more heartbreaking is that the party in power has remained unmoved over the development, and sees no need to condemn or announce measures that will be taken to deal with the culprit. This attack happened last Saturday, but to this day, the PF has said nothing about the police raid which was orchestrated by the party's Provincial Youth Chairman.

We will talk about President Lungu a little later, but why is the PF silent? Is it because they find nothing wrong with this behaviour? In previous governments, cadres used to have fear. Even under Michael Sata's PF, there was an extent to which cadres and party officials could go with their mischief. It would never get as far as raiding a police station to beat up officers. This is anarchy of the highest order. Surely, Zambia is in a state of unimaginable lawlessness.

Who would dare attack the police at their station, in their offices? How can a civilian gather the courage to stage an armed ambush on the provincial headquarters of the police force? The biggest police station in the country. In a normal country, only a person who is tired of life and is exploring adventurous ways of dying would dare the police in that manner. will be after you until you are severely dealt with. Even hard core criminals, murderers, know never to touch a police officer. They don't kill cops because they know the consequences are unbearable. Now here in Zambia, if cadres and ruling party officials don't fear the police who are they going to fear? If they don't respect the law enforcement officer, how will they respect the law?

Even assuming that this PF official had a legitimate complaint against the police, he has no right to ambush their station with guns and beat up officers. We have laws in the country. Police officers who do something wrong are not available for physical discipline from members of the public, they have their own internal disciplinary procedures. They can be suspended, indicted and prosecuted where need be, before they are discharged from the service. If that procedure does not mete out justice to the satisfaction of the public. there is a Police Public Complaints Commission. No citizen has the right to attack the police.

What we are seeing under this government is very scary. The level to which the police have been reduced is dangerous for the country. Police scampering to safety upon seeing an armed PF official with cadres storm their station is something that is incomprehensible? How can a government allow its law enforcers to be subjected to such impotency? If the police cannot protect themselves, who can they protect?

Now, we must say that this ordeal reflects very badly on the Republican President who is running this country. If ruling party officials can have the courage to raid the provincial police headquarters with guns and beat up officers, what stops them from coming to beat you up in State House when you do something they don't like? We ask because State House is manned by police, and if cadres have such superior power over police officers, how safe are you?

When this attack was happening at Lusaka Central Police, President Lungu was out there condemning violence from the opposition. His own party official was staging what we would call a terrorist attack in Lusaka, and to this day, he has not said anything about it. Why? Our readers may be interested to know that this fugitive called Emmanuel Jay Banda is not a first time offender. Banda is the same PF official who urinated in the mouth of then Post Newspaper reporter Peter Sukwa in December 2015 during the presidential by-election campaigns in Vubwi. He was fined K14, 000 for assault after being found guilty by the Vubwi Magistrates' Court, and he has not reformed.

In February last year, Banda was expelled from the party by Provincial **Chairman Andrew** Lubusha, on grounds that he had breached the PF constitution, but President Edgar Lungu expressly nullified the expulsion, saying Banda, who was

a Petauke District official then, had not been granted an opportunity to be heard. A few months later, Banda was elevated to the rank of Provincial Youth Chairman, a post he currently occupies. And he has continued to cause havoc in the country.

Banda is the PF official who, in February this year, led a group of cadres to go and disrupt a Law Association of Zambia-organised public discussion on Bill 10 held at Intercontinental Hotel. Nobody condemned him from the party, and he has since continued to cause havoc. Why is President Lungu doing this to a country which he claims to love?



THE UK's mobile providers are being banned from buying new Huawei 5G equipment after 31 December, and they must also remove all the Chinese firm's 5G kit from their networks by 2027.

Digital Secretary Oliver Dowden told the House of Commons of the decision.

It follows sanctions imposed by Washington, which claims the firm poses a national security threat something Huawei denies.

Mr Dowden said the move would delay the country's 5G rollout by a year.

He added that the cumulative cost of this, and earlier restrictions announced against Huawei earlier in the year, would be up to £2bn.

"This has not been an easy decision, but it is the right one for the UK telecoms networks, for our national security and our economy, both now and indeed in the long run," he said.

Because the US sanctions only affect future equipment, the government has been advised there is no security justification for removing 2G, 3G and 4G equipment supplied by Huawei.

However, when swapping out the company's masts, networks are likely to switch to a different vendor to

provide the earlier-generation services.

Huawei said the move was: "Bad news for anyone in the UK with a mobile phone" and threatened to "move Britain into the digital slow lane, push up bills and deepen the digital divide."

New restrictions are also being applied to use of the company's broadband kit.

The government has also been advised operators should "transition away" from purchasing new Huawei equipment for use in the fullfibre network, ideally within the next two years.

Mr Dowden said the government would "embark a short technical on consultation" with operators about this.

He explained that the UK needed to avoid becoming dependent on Nokia as the single supplier of some equipment, and he wanted to avoid "unnecessary delays" to the government's gigabit-forall by 2025 pledge.

The action, however, does not affect Huawei's ability to sell its smartphones to consumers or how they will run.

Chip concerns

The UK last reviewed Huawei's role in its telecoms infrastructure in January, when it was decided to let the firm remain a supplier but introduced a cap on its market share.

But in May the US introduced new sanctions designed to disrupt Huawei's ability to get its own chips manufactured.

This led security officials to conclude they could no longer assure the security of its products if the company had to start sourcing chips from third-parties for use in its equipment.

The minister cited a review carried out by GCHQ's National Cyber Security Centre as being the motivation for the changes.

Chairman resigns

Huawei says it employs about 1,600 people in the UK and claims to be one of Britain's largest sources of investment from China.

The firm - whose shares are not publicly traded - does not

provide a regional breakdown of its earnings. But on Monday, it announced a 13% rise in sales for the first half of 2020 compared to the same period in 2019, totalling 454bn yuan (\$64.8bn; £51.3bn).

The UK will have accounted for a fraction of that. The firm's UK chief recently noted that Huawei had only deployed a total of 20,000 base stations in the UK so far, but by contrast expects to deliver a total of 500,000 globally this year.

Even so, what the firm fears and Washington hopes is that other countries will now follow Westminster's lead with bans of their own.

Despite there seeming little chance of a U-turn, Huawei said it was still urging UK ministers to reconsider.

"We will conduct a detailed review of what today's announcement means for our business here and will work with the UK government to explain how we can continue to contribute to a better connected Britain," spokesman Ed Brewster said.

Shortly before the announcement Sky News revealed that Lord Browne, Huawei's UK chairman and the ex-chief executive of BP, would be leaving the Chinese company before his term had expired. It said he had given his notice a few days ago and would formally step down in September.BBC

Congo gives mines month to release confined workers

THE Democratic Republic of Congo has given copper and cobalt mining companies a month to stop confining workers on site away from their families to stop the spread of coronavirus, the labour minister said in an open letter.

civil society organisations said last month, citing miners and union representatives and demanding an end to the practice.

"All mining companies that have confined workers to the operating site are granted a one-month moratorium to return to normal operation," Labour Minister Nene Ilunga Nkula said in the letter, dated

July 13, which she shared on Twitter on Tuesday.

Mining companies must provide healthcare for workers and their families, as well as decent housing and a healthy diet for confined workers, Nkula said.

Companies mining in Congo's southern copper belt include Glencore subsidiary Katanga Mining, China Molybdenum's Tenke Fungurume, MMG, and Chemaf, while Ivanhoe is developing two copper mines there.

Six workers at Glencore's Kamoto Copper Company (KCC) mine in Lualaba province tested positive for the coronavirus, KCC said a week ago.

Companies in Lualaba have a month from July 2 to prepare sanitation measures and release all workers confined for more than a month. In Haut-Katanga the period runs from July 6, the letter said. Congo is Africa's top producer of copper and the world's main source of cobalt, accounting for two-thirds of global supplies of the metal used in smartphones and electric car batteries. Mines minister Willy Samsoni Kitobo has warned that full mine shutdowns would trigger a "catastrophic" economic and social crisis in the country, with the industry contributing 32% of its GDP and 95% of export revenue in 2018.Reuters

"However, failure to progress as a nation is not an option. And what matters the most here is the capacity and the capability that the UAE gained out of this mission, and the knowledge it brought into the country." **BBC**




Quizzed on the decision at a press conference to preview his side's trip to Arsenal, Klopp told reporters: "I don't know if I can answer it. It's a serious subject.
