# Zambia hits 5,000 Covid cases, with 142 deaths

Health MINISTRY of Permanent Secretary in charge of Technical Services says hydroxychloroquine should not be used to treat COVID-19 patients unless under authorized medical prescription.

By Mirriam Chabala THE Auditor General's Report on the Provision of Special Education in Primary Schools has revealed a lack of specialisation among teachers handling pupils with unique education needs in Zambia.

In the performance audit on the Provision of Special Education in Zambian Primary Schools for the period 2014 to 2018, the Auditor General noted that special education in Zambia was not disability-specific.

The report explained that there was no specialisation among teachers and that students did not learn subjects in languages of the deaf nor the blind.

The Auditor General also observed that many trained teachers with diplomas in special education were not fluent in reading and writing Braille because the current special education training was too general.

"According to ZAMISE (Zambia Institute of Special Education), up until 2004, primary school teachers received mandatory basic specialised training in special education as part of primary school teaching in-service training. After 2004, in addition to primary school teaching, all teachers were now trained in teaching all disabilities. However, the institute indicated that this was not effective as some teachers struggled to grasp all the concepts and were not effective to handle all disabilities. The institute indicated that they received feedback from their students, which revealed that special education provision was not adequately integrated in most schools by the school managers," the report revealed.

"Teachers had pointed out that there was inadequacy, especially in the areas of sign language and Braille in the colleges and universities. Many trained teachers with diplomas in special education were not fluent in reading and writing Braille. This could be so because the current special education training is too general. It is not disability-specific, that is, there is no specialisation. In addition, students do not learn subjects in the languages of the deaf nor the blind. For instance, if a student is to be teaching mathematics, she/he should be exposed to learning the subject in Braille or sign language. Though students graduate may with distinctions in special education, they normally lack sufficient language of the learners they were to handle." The report also revealed visually-impaired that teachers were being deployed to teach pupils with visual impairments even though they had no qualifications in special education. "Interviews with management at Ndola Lions School for the Blind and Sefula School for the Visually Impaired revealed that teachers with visual impairments, who were not trained in special education were posted to these schools. Interviews with Curriculum Development revealed that this was because they were

Interviews revealed that there was no in-service or preservice institution training teachers in inclusive teaching methodologies. However, there were six schools that were piloting inclusive learning in Southern Province, and teachers in those particular schools had been trained with the support of a Community Based Rehabilitation Zambia Support Programme," the report revealed.

"Pre-service training for primary school special education teachers was conducted by lecturers, who had no experience in primary school teaching and methodologies as most of them were secondary school teachers, who had become lecturers at ZAMISE. This limited their ability to impart the practical skills and knowledge to the trainee teachers, which impacted on their performance. There has not been enough sensitisation provided to stakeholders on the implementation guidelines on special and inclusive learning. Special education activities were not sufficiently planned for as there were no key indicators in annual work plans on which performance could then be assessed. Further, a review of reports indicated that the number of teachers was not enough in many units and individualised teaching was not taking place. The reports also stated that the shortage of teachers also limited the implementation Schooling of Inclusive (INSPRO) programme activities. However, statistics on the required number of special education teachers and current SE teachers was not available from the Ministry for the period 2014 to 2017."

Meanwhile, the Auditor General regretted that some pupils with special education needs were unable to go to school because of the long distances they were required to cover to attend school.

"The Ministry of General Education has continued to increase the number of special primary schools and units to cater for learners with special education needs in the country. In 2014, there were 208 units available, which have increased to 250 in 2018. The number of schools also increased marginally from 24 in 2014 to 27 in 2018. This also saw an increase of learners with special education needs enrolled from 89,134 in 2014 to 103,218 in 2016 and to 110,320 in 2017. However, there were instances of learners with special education needs, who were not able to access education due to the distances to the available schools," narrated the report. "For example, DEBS (District Education Board Secretary) officials in Zimba and Kazungula, and school

# We were arrested for holding elections in the bush – Beyani





UPND chairperson for policy and research Dr Choolwe Beyani and five others have finally been granted bond after being arrested and charged with unlawful assembly for holding intra party elections in the bush on Saturday.

Recounting the ordeal, Dr Beyani said UPND was not intimidated by schemes to derail the party's growth on the Copperbelt.

"What happened was that as the commissioner, I arrived, I was manning two elections; in Chingola and Chililabombwe. So we agreed that we shall hold the Chililabombwe first in the morning. So when we met with our people, they made it very clear that they have never gotten permission of any kind to hold a meeting. So I told them that that's not a big problem because



and elsewhere, you don't need a police permit as long as you are within your premises, you only need a permit if you are outside your office. So we went into the party office to hold the elections and as we were there, we began to conduct the election process, people began to vote. Then we began to see hordes of PF cadres outside on the perimeter of the offices. And there was one particular cadre who was holding catapults or malegeni... We didn't want a situation where someone would say there was a fight between UPND and PF. So we decided to halt it and move out of site," Dr Beyani narrated. "We were aware too that if we move into a house of anybody, it will be called unlawful assembly so we went

the way it happens in Lusaka

into the bush where there was no one and it was in the bush where we managed to almost conclude, we had only three voters left when police and PF cadres arrived on the scene and began to discharge live ammunition, one police officer and two officers discharged live ammunition, many of our people scampered and ran off. So us, the leaders stayed back and confronted the officers and wondered what the problem was there and one of the officers, I would call him the arresting officer, Mubanga, was very excited and accused us of holding an illegal meeting. So I asked him, I said 'how can we hold an illegal meeting in the bush where we are not talking to anybody and meeting anybody except ourselves?'. So anyway, there was no conversation, we were bundled, they told us to get the ballot boxes in the car, get to the police station and we got to the police station. That's how eventually, we were charged with a charge of unlawful assembly but that first night we were not charged, we refused to say anything without our lawyer."

He explained that even after the lawyer came to the station, there was political interference in the handling of the case.

"So Sunday, our lawyer came from Ndola and he advised us not to say anything but to accept that we should be charged but deny the charges. This was done and we actually thought we would be given bond shortly after the intervention of counsel but there was immediate political interference, we hear that they were calling, Ndola was calling and even Lusaka was communicated with and they were told that they even needed a docket, and the PF cadres were in and out of the police station. Even the commissioner for the area was in the police station. So they told our lawyers to come back at 15:00 hours to see how we could proceed with the matter which they did. But then they arrested another fellow, one of our members, whom they claimed corrupted a police officer and we believe this report was done by PF cadres and this is one of our members who was not at the meeting. So it seems that the PF had a bone to chew with him because he was part of what you may call foot soldiers in the campaign and in the politics of the party. So it looks like they wanted to get revenge and have him arrested," Dr Beyani said.

"So he was arrested in the evening and he was interviewed and asked if he corrupted any officer, and he said no and we said if they want evidence, let them come to us because we were the ones on the fight and we didn't see him so that complicated the matter and when the lawyer came, they said 'well, we need to finish investigations with the young member of the party who was being accused of corrupting a police officer' and then their hands were tied and that's how eventually they interrogated him for three hours but the funny part is they never asked us whether he was present or not because as far as I knew as a commissioner, he was not present at the elections, he didn't come. But he is a party member but he never came. So I don't know how a party member who was not part of the meeting can be accused of corrupting a police officer when he was not on site. So that's how the district commissioner even came to be part of the interviews which makes you wonder what the district commissioner was doing in the interview and what exactly PF cadres were doing also in the police offices."

He said the presence of the DC in an interrogation room was a clear indication that the police in the area were working under difficult conditions.

"It became clear to us that the police command in Chililabombwe is working under difficult conditions. The police officers are always influenced, to some degree under the watchful eye of cadres who report them to anybody that they feel so and it's our understanding that the Minister of Mines, who is resident in Chililabombwe is a coordinator of these cadre activities. So, that is the difficulty that the police in Chililabombwe has," he said.

He said PF was panicking because it had lost support on the Copperbelt.

"So my view, in the end is that this reflects the kicks of a dying horse and I was able to gather from Chililabombwe that PF support in the area has completely collapsed. So they are in a panic mode and will do anything to block UPND from doing any activity in support of the party. The elections on the Copperbelt on the material day took place successfully except in Chililabombwe, there was no interference anywhere except here. So it's an interesting dimension that Chililabombwe appears to have a unique problem of cadres in the police station commanded possibly by a minister who is resident here, a situation that we didn't find in the rest of the Copperbelt. Not that there are no cadres but there was no interference of our elections in the manner that we saw in Chililabombwe. So I think it was basically meant to be an intimidation but it should be put on record that UPND cannot be intimidated," said Dr Beyani.

THE Auditor General has revealed that the Luapula Water and Sewerage Company (LpWSC) delayed the implementation of the Integrated Small Towns Water Supply and Sanitation (ISTWSS) project despite funding worth US \$33,453,611 being readily available.

According to the Auditor General's report on the accounts of water and sanitation companies for the financial year ending December 31, 2019, interest of US\$1,003,608 had accrued on the money and works had not commenced over two years since the signing of the financing agreement.

"On 17th February, 2017, government and Luapula Water and Sewerage Company (LpWSC) signed a financing agreement of US\$33,453,611 for the purpose of financing components 1 and 2 of the Integrated Small Towns Water Supply and Sanitation (ISTWSS) project. The following were the terms and conditions of the loan embrace change of mindset especially where quality assurance is concerned and consistent supply of the target product. In this regard, I wish to implore the relevant Agencies specifically the Zambia Development Agency (ZDA) and Zambia Bureau of Standards (ZABS) to work closely with our local suppliers to improve business linkages and enhance product quality respectively," he said.

He added that at no time did he rent an apartment as alleged by Okpara in the petition and further stated that Okpara's allegations were malicious and not tantamount to adultery, which was the main issue in the petition.

Mwanawasa urged the court not to award Okpara damages and costs as it would amount to unfair and unjust entrenchment.

He stated that Mulenga was an adult and no one would take peculiar advantage of her as a married woman.

And in her answer to the petition, Mulenga had admitted that her marriage with Okpara had broken down irretrievably, but added that the reasons for the breakdown were none of the allegations by her husband.

She strongly denied committing adultery with Simwinga and Mwanawasa, stating that Mwanawasa was a friend, who was at the time working in Eastern Province.

Mulenga added that she simply went to pay him a visit as friends normally would when he was in town and used the rented duplex apartment to hold meetings.

Mulenga also denied having an intimate relationship with Simwinga and maintained that the relationship between them had always been plutonic.

### Luapula Water failed to implement sanitation project despite available \$33.4m, reveals audit at 31st December, 2019, the Municipal Billing Module

"Procurement of Software – Wasteful Expenditure On 18th August, 2016, a payment of K24,900 was made to GSM Micro Technology for the implementation of Municipal Billing Module in Pastel (K15,900) and provision of training to users (K9,000). It was, however, observed that as

at 31st December, 2019, the Municipal Billing Module in pastel and the associated training had not been implemented rendering the expenditure wasteful," the report read.

The Auditor General further revealed that the water utility only managed to hit a service target of 45 per cent, while sanitation services reached 31.9 per cent against a benchmark of 80 per cent.

"Water service coverage is the population serviced by domestic connections only through individual household connections, kiosks, public stand posts and shared taps. During the period under review, LpWSC did not reach its strategic goal and sector benchmark of 80 per cent as the water service coverage ranged from 30 per cent to 45 per cent. Consequently, a large proportion of the community in the province was not covered by the Commercial Utility (CU)

And Nkombo has insisted that Bill 10 lapsed last month and will never see the light of the day.

In an interview, Nkombo argued that Lubinda had continued with his treachery on Bill 10.

"Honourable Minister of Justice, in my view, has continued with his words of treachery. Any country must be governed by procedures and laws. There is no Bill that has a life for more than two years after Second Reading. There is nothing. The Freedom of Information Bill is one Bill that has been put on the shelf for a very long time and because it has not reached of Justice when he presents that Bill and the argument is now stale," Nkombo said.

"We should not even waste energy on an argument, which is stale, because we have now known that there is an Article, which Honourable (Brian) Mundubile spoke about, which is their survival plan. That is the only survival plan that they have on Article 52, I think. And if you go back to the...you will observe that even the Speaker of the National Assembly at the time when the Bill was presented, he made a repetition that a Bill has got a lifetime and that he was going to make it come on the Order Paper basically for the last time."

And Nkombo stressed that Bill 10 died on June 4 and would never see the light of the day.

"Now, on 4th June, as far as we are

and it shall never see the light of the day! So, we are waiting to see what miracle Honourable Lubinda is going to perform to actually bring that Bill before the House," Nkombo added. # Suspension of LCC, Kitwe Council illegal, says Chapter One

CHAPTER One Foundation has asked Local Government Minister Dr Charles Banda to reverse his decision to suspend the operations of the Lusaka and Kitwe City Councils because his action is in contravention of Article 152 (2) of the Constitution.

In a statement, Tuesday, Foundation the stated that Dr Banda's action was unconstitutional and illegal.

The Foundation insisted that there was need for government to review the provisions of the Local Government Act as well as other relevant pieces legislation containing of provisions that directly depart from the requirements of the Constitution.

"Chapter One Foundation strongly urges the Minister of Local Government to revise his decision to suspend the functions of the two Councils in order to ensure his actions do not continue to run contrary to the requirements of the Constitution. We call on the State to review the provisions in the Local Government Act as well as other legislation containing provisions that directly depart from the requirements of the Constitution to ensure that all leaders and citizens alike, continue to uphold our constitutional values and responsibilities at all levels of society, for posterity, protecting the state from any potential forms of anarchy," the statement, which was signed by the foundations executive director Linda Kasonde, read. The Foundation argued that Article 52 of the Constitution protected local authorities from central and provincial administrations and was actually in direct conflict with sections 56 and 57 of the Local Government Act.

derived his purportedly powers to suspend the Lusaka and Kitwe Councils from sections 56 and 57 of the Local Government Act 2 of 2019, which state as follows: 56. The Minister may, by reason of the refusal, failure or inability of a council to adequately perform all or any of its functions, by statutory order — (a) appoint a public officer to be the Local Government Administrator for that council; and (b) suspend all councillors of the council from performing all of their functions as councillors and empower the Local Government Administrator to discharge all the functions of the Council. 57. (1) An order made by the Minister under section 56 shall, unless revoked, expire after 90 days of the date of making the order, except that the Minister may, in the interest of local administration, extend the order for further periods of ninety days at a time," stated the Foundation.

"Sections 56 and 57 of the Local Government Act are in direct conflict with provisions contained in the Constitution, specifically Article 152 (2) and, thus, the Minister's decision is unconstitutional and should be reversed immediately. Article 152 (2) of the Constitution states as follows: 'The national government and the provincial administration shall not interfere with or compromise a local authority's ability or right to perform its functions.' We believe that Article 152 (2) was created to protect the rights and functions of local authorities from any interference from central and provincial administrations as a means to ensure functional efficiency, transparency and effectivity at the local-level. Given that the Constitution is the supreme law of the land, its provisions supersede any other legislation that is in conflict with its values and principles."

to masking and physical distancing wherever we are. And this includes on public transport and other congregate settings. We now have evidence in the country, in the region and globally, that if we don't do things differently, the numbers we are seeing today can quadruple and it will mean catastrophic consequences to our people and economy," warned Dr Malama.

Meanwhile, speaking when he paid a courtesy call on chief Puta in Chiengi, Tuesday, Health Minister Dr Chitalu Chilufva conceded that COVID-19 had taken a toll on medical supplies.

"COVID-19 has taken a toll on the human capital and medical supplies on the health sector. To assure resilience, the government has been putting more human capital and mobilizing more resources for medical supplies to ensure that there are provisional health services routinely for our patients and to ensure that while we do this, we do not have lapses in the COVID-19 response. We are going to work with our partners to unshackle the supply chain," said Dr Chilufya.

# Only 11 suspected COVID-19 cases have been reported in schools – Mabumba

GENERAL Education Minister David Mabumba says only 11 suspected cases of COVID-19 have been recorded in schools so far.

And Mabumba says it is logistically impossible to test all the 1.1 million pupils who are currently attending examination classes.

Speaking during a live COVID-19 information dissemination programme which was hosted by Chief Government Spokesperson Dora Siliya on ZNBC TV1, Tuesday, Mabumba said the 11 suspected cases had been reported to the Ministry of Health.

it to the Zambian people to make a judgement whether our reopening has been successful or not. For us as government, 1.1 million children against 11 cases reported and all of them have been handled. And those schools where these cases have been reported have gone back to normal. As far as we are concerned, there is no Coronavirus in the schools. Coronavirus can only come from the communities into the school system because the children are living in the communities. So the notion that there is COVID in our schools is a wrong notion because our schools as far that we are able to protect the other 3.7 million children who have remained out of the school system," Mabumba said.

And asked why the 1.1 million pupils in examination classes had not been tested for the virus, Mabumba said it is logistically impossible.

"Minister, that is the argument from the Zambian people but you and I, for example, is it logistically possible that you can go and test everybody? When I have got COVID-19 in my body, I am going to have the symptoms obviously. I cannot live with it for two or three weeks, I should have the symptoms. And this is why we are saying that as much as the parents might want us to test everybody, I think our strategy at the moment, given the logistics, we shall do testing exceptionally. But from those schools where those 11 cases have been reported, all the children and teachers have been tested," he said. And Mabumba said all schools must ensure that they have hand washing soap and sanitizers for their learners. "There are standards that should be followed. We have developed the COVID-19 guidelines which provide the measures that must be followed and one of them is masking up. Every school as hand washing facilities, every school is supposed to have soap and hand-sanitizer. So, if there is a school of that particular nature, I wish you could have given us the name so that we send our standard officers to go and check the compliance levels," said Mabumba.

"From the time we opened the schools on 1st June, it's just to thank the President for the leadership. You know, many of the countries haven't been able to make this decision given that there is so much fear around COVID-19. And from June, the number of cases in the context of COVID that have been reported are very minimal, around 11. These are the cases that have been reported. And as part of our protocol of managing the risk of COVID in our schools, once there are identified cases, we report them to the Ministry of Health. # CONSTITUTIONAL MAKING IN ZAMBIA: A MYTH OR REALITY? PART ONE

### JOSEPH CHIRWA 1.0 INTRODUCTION

ANY scholars have written or attempted to write on the constitution-making process in Zambia. In most law schools, the choice of a topic of research on constitution-making has become tired. In one of the research classes, His Lordship, Mr. Justice Mumba Malila, SC used the word 'tired' to signify that most people have either researched or written on the subject matter that virtually no new issue could be raised as all issues surrounding the scope of that topic have been exhausted.

As a scholar, I tend to disagree that a topic can become tired. It will be true to say that scholars and the audience have become tired but topics of a legal nature never become tired as the law continues to evolve and the trajectory surrounding many so-called tired legal issues keep changing. One of those tired issues that have been awakened is "constitutional-making" in Zambia. The awakening of this issue from the grave is as a result of the debate surrounding the Constitution of Zambia (Amendment) Bill No. 10 of 2019 famously called "Bill 10".

### 1.2 GENESIS OF BILL 10

Protagonists of Bill 10, chief of which are members of the ruling Patriotic Front (PF), claim that the Siavonga Resolutions of 2018 culminated into what has become of one of the most contentious laws in the history of Zambia slightly behind the introduction of the One-Party Constitution in 1973. For avoidance of doubt, the Siavonga Resolutions were as a result of a meeting of political party Secretaries General, General Secretaries and National Secretaries collectively known as Chief Executive Officers (CEOs) of various recognized and registered political parties. The meeting was held under the auspice of the Zambia Centre for Interparty Dialogue, a not-so Non-Governmental Organization (NGO) which is an umbrella body for political reconciliation. The legitimacy of the ZCID as an independent arbiter of peace has been questioned by various political players since its inception.

After the ZCID-brokered meeting in Siavonga District, the National Dialogue Forum was born out of the National Dialogue (Constitution, Electoral Process, Public Order and Political Parties). As the name of the Act suggests, its main focus was to garner a multi-partisan reforms in the constitution, electoral process, public order and political parties.

The preamble of the Act provided that:

An Act to facilitate the implementation of the Siavonga resolutions of political parties relating to constitutional and institutional reforms, separation of powers and judicial independence, tolerance, freedom of assembly and civility in politics and electoral reforms; provide for a national dialogue process to facilitate the Constitution refinement process and regulation of political parties, public order and electoral process reforms; establish the National Dialogue Forum and provide for its functions; and provide for matters connected with, or incidental to, the foregoing. [Emphasis supplied] Section 4 of the same Act provided that: based on submissions from various stakeholders. [Emphasis Supplied]

Attendance to the National Dialogue Forum (NDF) was extended to a wider range of stakeholders but the Executive remained as the nominating authority. All political parties were to be represented and Members of Parliament (MPs) were required to attend under the pain of imprisonment for failure to do so. This created the perception of inclusiveness which will be dispelled in the text that follows.

It must be noted from the underlined words that the "refinement" of the Constitution of Zambia (Amendment) Act No. 2 of 2016 was to be done "subject to the constitution" and by being "accountable to the people of Zambia" and through "confidence building, engendering trust and developing a national consensus for the review process."

The NDF was hardly accountable to the people of Zambia because the representatives at the forum only represented factional and sectional interests as opposed to national and public interest. The best way to attain national interest is to ensure that all Zambians participate in the process through a national referendum. In that regard, all persons of age may be called upon to have a say on what is to be "refined" in the constitution as opposed to leaving the process to interested as well as warring parties.

### 1.3 REFERENDUM: THE ANSWER TO A DURABLE CONSTITUTION?

The making and remaking of Constitutions in Zambia has largely been based on the discrediting of the process adopted to make a particular constitution. This is so because the process is tightly related to the participation of the governed in the constitutional-making process. As a democracy, process and participation are key to having a constitution which invokes a sense of ownership as well as one that may stand a test of time.

The most preferred way of constitutionalmaking is a referendum. A referendum is a vote in which all the people in a country or an area are asked to give their opinion about or decide an important political or social question. If a country holds a referendum on a particular policy, they ask the people to vote on the policy and show whether or not they agree with it.

The gist of a referendum is that an issue of national importance and one that hinges on the freedoms, liberties and rights of citizens must be subjected to the people as a whole and not to a faction or section of people such as Parliament. Parliament has the inherent right to make laws but these laws are subject to the constitution which is the grund norm that is made by and for the people. Parliaments are made up of political cadres whose aim is to channel a political interest which is usually partisan rather than national in character. These party cadres have their loyalty, first, to the party; second to themselves for selfpreservation; and third, may be to the general will. This means that party cadres, in the name of MPs. are likely for vote on party lines as directed by the various party Whips for fear of being expelled or suspended for going against party orders. This was seen in the United Kingdom when the British Conservative Party withdrew the whip from 21 of its MPs who voted against Prime Minister Boris Johnson Brexit proposals and in the United States of America when Senator Willard Mitt Romney of Utah was vilified for voting to impeach President Donald Trump.

and 2016 all fail due to cries by stakeholders as to lack of inclusivity and disregard of the widely accepted process. The 2016 amendment to the 1991 Constitution has seen it being attacked center, left and right due to the same reasons.

1.4 WE, THE PEOPLE OF ZAMBIA: IS THERE SUCH A THING AS WILL OF THE PEOPLE?

There is no general consensus on what the 'will of the people' is discerned and on how it is measured. However, in a democratic society like Zambia, the will of the people is usually expressed through the right of suffrage and defined by its elected representatives. Generally, it is taken to mean a decision by simple majority, or half-plusone wins the vote. This definition brings about two implications. The first is that the will of the people can be settled by the people's elected representatives, this case MPs, by a majority of fifty per cent plus 1 or second by the majority of the general populace by the same margin of fifty per cent plus 1.

Thus, regardless of the mode adopted, the will of the people will only be carried if a simple majority of fifty per cent plus is met. Thus, Parliament may only represent the will of the will of the people if there is a simple majority and this is also true of a referendum. It is thus submitted that even if the Parliament of Zambia, the National Assembly plus the President, are allowed to carry the day, the threshold of fifty per cent plus one must be met if we are to make a constitution or any amendment to it that represents the "will of the people."

However, it must be noted that Zambia is a constitutional democracy and hence the constitution reigns supreme. In light of the doctrine of constitution supremacy that has been upheld in a plethora of court decisions, the preamble of the constitution settles the question as to what is the "will of the people." It states that: **"WE, THE PEOPLE OF ZAMBIA.....DO HEREBY SOLEMNLY ADOPT AND GIVE TO OURSELVES THIS CONSTITUTION:"** 

If the people give to themselves a constitution, it only makes sense that "the people" must make that constitution. It follows, as this authors submission, that the duty, mandate and role of constitutional-making is a preserve of "the people" and may not be delegated or usurped by anyone as doing so makes that constitution one that is not for the people because it is not by the people.

### 1.5 THE ESTABLISHMENT OF THE CONSTITUTIONAL COURT: HAS BEEN AN ANSWER TO CONSTITUTIONAL LITIGATION?

Many scholars have suggested that the United States Constitution adopted in 1787by delegates to the Constitutional Convention in Philadelphia has lasted over 233 years due to the role played by both State and Federal Courts in upholding it and giving it life to meet the current social and economic phenomena. The law must evolve with changing times as the paramount role of the law is to promote good governance, the rule of law and protect human rights. Jurisprudential studies from Hart to Austin have been consistent is educating us that the law is what judges say it is. It is important to appreciate to appreciate the role that judges play in breathing life to the constitution. The law, without any pronouncement on its implications by a court of competent jurisdiction, is impotent. In the words of US Supreme Court Justice Charles Evans Hughes: We are under a Constitution, but the Constitution is what the judges say it is, and the judiciary is the safeguard of our liberty and of our property under the Constitution.

(1) There is established the National Dialogue Forum which, subject to the Constitution, is a forum for the implementation and enhancement of the Siavonga resolutions for proposals to—

(a) alter the Constitution, based on the draft amendments proposed to the Constitution based on submissions from the stakeholders specified in the Schedule, following the enactment of the Constitution of Zambia (Amendment) Act, 2016, and additional submissions from the church; and

(b) reform the law on the electoral process, public order and regulation of political parties

History in Zambia has shown that constitutions keep changing and remodeled because many feel the previous law was made to preserve self as opposed to national interest. The Country has seen constitutional regimes in 1973, 1991, 1996

# **PF embraces corruption, l've** more to reveal to ACC – Kaziya

# Mopani will maintain operations beyond July, but talks continue – Mines PS

By Natasha Sakala MOPANI Copper Mines Plc has agreed to maintain operations beyond this Friday, July 31, 2020, the date it was originally set to place its operations on care and maintenance, says Ministry of Mines Permanent Secretary Barnaby Mulenga.

In an interview, Mulenga said, however, that talks would continue on the way forward since Mopani had appealed this decision.

"We agreed, as you heard, even from the statement they issued to that effect. So, there've been discussions with them, which have concluded that they are not proceeding on care and maintenance, so operations will proceed beyond the 31st of July, but what will, however, happen is that they might continue because they've appealed that position and we are engaged in more talks to see how we can solve this in the light of that

### appeal," said Mulenga.

Last week, Mopani revealed in a statement that it was going to appeal government's decision to reject their proposal to place the mine's operations on care and maintenance, citing operational challenges.

"At the beginning of May, 2020, Mopani Copper Mines Plc notified the government of its intention to place the mining operations on care and maintenance after 90 days. Mopani has been notified by the Mines Development Department that it has rejected its proposal to suspend the operations pursuant to Section 37 (2) of the Mines and Minerals Development Act (2015) (MMDA) and place them on Care and Maintenance (C&M). Mopani remains of the belief that the only way to protect the company's value and preserve the option to deliver its growth projects when conditions further improve is to transition the business. the operations to C&M.

In addition, the miner cited the impact of a-then rapid decline in copper prices and the critical disruptions to international mobility, transportation and supply chains arising from COVID-19, such that a number of projects that had been earmarked for commissioning, the company said, had to be placed on hold until key personnel were able to travel to site.

Government, however, reacted swiftly to thwart those plans and accused Mopani of acting outside the law.

Following some heavyhanded action, including the prevention of the mines' chief executive officer, Nathan Bullock, from leaving the country on April 15, Mopani said it would stay its decision and remain open, subject to agreeing certain undisclosed conditions with government proposals, indicating the decision would be revisited after three months.

And as a party, they have fought me, meaning that they embrace corruption, meaning that they embrace illegalities because it's not the first time I am exposing such things," he added.

And Kaziya said the suspension of the two councils was an embarrassment to both the ruling party and President Lungu.

"So, this is quite embarrassing on the part of

on my part, it's embarrassing to the President because how, then, are we going to explain to the people in 2021? That we mean well? When we have allowed our cadres to do whatever they want to do, when we have allowed the cadres to harass people in the markets? A poor marketeer, who is selling tomatoes earning a K10 each day, then you go and grab a K5 from that person, in the name of the party? What does that do to the community? A trader wakes up at 04:00 hours to order tomatoes at Soweto Market and goes to sell at the market, then during the day, a cadre goes round to collect a K5 from her when she has only sold a K20. Who is that trader working for? Cadres who are seated in their offices only waiting to go and collect money in the evening? Is this what we stand for when we talk about pro-poor?" he wondered.

Kaziya stressed that he had been restraining himself from speaking out despite his dismissal as Water Development, Sanitation and Environmental Protection minister two years ago to protect the image of the ruling party.

"So, sometimes when some of us remain quiet, it doesn't mean that we don't want to talk about the injustices that are happening in the community. We are just trying to protect our image as a party. If I wanted, I would have been ranting a long time ago. I mean, how long have I been fired as a minister? From 14th February, 2018, but have I been ranting like my colleagues? No. I have respected my President, I have respected the party. I have never wanted to embarrass them in the manner the recording was done," said Kaziya.

there is a sharp spike in the COVID-19 positivity rate and many cases in the communities are only being picked up now. As at vesterday, Zambia recorded 450 new COVID-19 cases, including 11 health workers. Every day that passes, we have people on oxygen, some in critical condition with little chance of survival. Health Minister Dr Chitalu Chilufya says we are now at an alarming stage and citizens must be concerned about this.

"When you look at the positivity rate in Zambia, we are seeing a sharp spike. If you look at the week beginning 1st June, we were at about 1.8 per cent positivity and when you look at the way we are proceeding, we are now at 25.4 per cent. This is a very steep rise in our positivity. It means that there are many more cases in the community that are picking up. And every week, we are seeing a rise in positivity and this needs to be stopped. The rate at which we are moving is alarming," says Dr Chilufya.

major world economies are struggling to save lives, we should be very worried about what will happen here in Zambia in the next month or two.







LUSAKA Province Minister Bowman Lusambo says he is worried about the huge meetings he held on the Copperbelt in light of his COVID-19 positive status.

And Lusambo has expressed concern over the behavior of Lusaka residents who take COVID-19 lightly.

In an interview, Lusambo insisted that the gatherings on the Copperbelt were not planned for as people decided to follow him on their own.

When asked if he was worried that those who followed him may have been infected, Lusambo responded in the affirmative.

"Yes, I am worried as well. Not only that, I am scared for Lusaka people because the levels of compliance have gone down. COVID-19 is now everywhere. This behavior which is in Lusaka, COVID-19 will wipe us [out]. For me, as a government official, this thing which I have passed through has been a well educative process both as a patient and a government official. When I

"I am a government worker. And my job is to protect the people. We will continue protecting the people of Zambia. And I can assure person who is going to work. Prof Mwaba, who is also a former Ministry of Health Permanent Secretary, urged people to stop travelling to various locations for funerals to curb spreading the disease. "And I would not

recommend somebody travelling from one town to another just to go and attend a funeral because even if you travel, are you going to

And Lusambo said he had helped health officials to trace all the people he had come in contact with.

"I am doing very well, I had symptoms of COVID-19. I have also helped with contact tracing. All my workers at the Ndola house were tested. All my brothers and sisters were tested. Here in Lusaka, the entire workforce at my house was tested. When you are moving from your house, you know that there is COVID-19 and what you are supposed to do. You are supposed to put on a face mask, carry hand sanitizer and practice social distance. No one should police your life. You have to protect your life. You can't invest your life in me that 'Bowman is going to protect my life, no,"

Meanwhile, Lusambo commended the health workers and the Ministry of Health for their tremendous job in treating COVID-19 patients.

### died? So, the low areas where we have recorded these cases must be protected so that we don't export this virus to other areas. There is a lot of external transmission within our country from one place to another for various reasons," he said.

And Prof Mwaba said hospitals must be treated as dangerous places to visit amid a spike in COVID-19 cases.

"People must know that hospitals are dangerous places. They are not places where you just visit and go there anyhow. Even pre-COVID, there are

other pathogens that abide in the hospitals. So, the hospital is not a place where you go in large numbers the way we have been doing before COVID. But now that there is COVID, it's even worse," Prof Mwaba cautioned.

He stressed that there was need to break the transmission chain by self-isolation.

"If you look at the longterm effects of wearing these masks, basically you are recycling your own air because when you are wearing your mask, you are breathing out carbon dioxide and part of it again you are inhaling. So, even the masks themselves are not the safest gadgets to have. The most important thing is that we should break the transmission chain so that we go back to normal," said Prof Mwaba.

# Judiciary paid over K2m in salaries to workers who were fired, resigned – Report

By Ulande Nkomesha THE Judiciary paid over K2 million in form of salaries and allowances to 74 employees who were no longer working for the institution, says the latest Auditor General's Report.

According to the Auditor General's Report on the Accounts of Parastatal Bodies and other statutory institutions for the financial year ended December 31, 2018, this payment was contrary to terms and conditions of service for the public sector which

irregularly paid amounts had not been recovered leading to possible loss of public funds," read the report.

"Contrary to Public Service Management Division Circular No. B21 of 2018, Section 5, allowances in amounts totalling K1,172,300 were paid to 115 retirees during the financial year ended 31st December, 2018, who were retained on government payroll. # PF members must know where Jay Jay is hiding – Kapeso

DEPUTY Inspector General of Police in charge of operations Bonny Kapeso says the service will not allow any more nonsense from political party cadres to dare the police in their own bedroom.

Speaking when he featured on UNZA Radio's programme dubbed Lusaka Star, Tuesday, Kapeso said the ruling party must know where Patriotic Front Eastern Province Youth Chairperson Emmanuel J Banda, commonly known as Jay Jay was hiding. "The storming of the police station was highly calculated. When they stormed the police station at Lusaka Central, it was a Sunday and remember that Sunday is a day of prayer and most of the police officers were not at the police station. It was probably a skeleton staff that was around and I think they took advantage of that. But we are not going to allow any more nonsense from any cadre to come and dare the police in our bedroom," Kapeso said. "If they will be ten maybe two will survive. If ever they dare the police station and come and confront the police station in our bedroom this time, I think they will regret the fact that they went to dare the police. And it doesn't even make any sense for a civilian to gather that courage which I describe as very outrageous to go and dare the police officers in their own bedroom,"

Kapeso said Jay Jay must report himself to the police.

"And we are saying Jay Jay must own up if he has senses. That Jay Jay Banda, the one who is the youth chairperson in Eastern Province. And I think all the members of PF must know where he is. If he has girlfriends, brothers and sisters who are listening to this programme they must tell him. Even if he is in Mozambique, even if he is in Malawi even if he's hiding let him own up. Because the longer he stays in hiding, I think the more the situation will be more volatile once we see him." said Kapeso.

"A review of personal files and other documents revealed that 74 officers in various stations, who had either resigned or dismissed and whose contracts were terminated, were paid basic salaries and other allowances in amounts totalling K2,120,330 as at 31st December, 2018. This was contrary to terms and conditions of service the public service, for which requires that such employees are terminated from the payroll with effect from the date of resignation, dismissal or discharge. As at 31st December, 2019, the

The Report also revealed that the Judiciary paid 73 officers amounts totalling K447,693 in terms of hardship allowances, which they were not entitled to.

"Contrary to Public Service Management Division Circular No. B2 of 2010 and the Public Service Terms and Conditions of Service, 73 officers were paid remote and rural hardship allowances in amounts totalling K447,693 despite not being entitled to the allowances. This resulted in loss of funds to government by paying allowances to officers who were not entitled," read the Report.

It equally revealed that the Judiciary further processed 77 payment vouchers in amounts totalling K230,584, which were infrastructure deficit of 510 court rooms and 1,781 judges' chambers.

"According to the establishment, the Judiciary was supposed to have 1,157 court rooms and 3,505 judges' chambers countrywide. However, it was observed that the Judiciary only had a total of 647 court rooms and 1,724 judges' chambers, resulting in a total deficit of 510 and 1,781 court rooms and judges' chambers, respectively," read the report.

"During the period under review, the Judiciary had a total of 529 local courts across the country out of which 123 were not operational as they were either dilapidated or lacked water reticulation or sanitation."

Police in Lusaka are on a manhunt for Jav Jay who is facing aggravated robbery charges. Earlier this month, Banda mobilised PF cadres and stormed Lusaka Central Police where they beat up some unsuspecting officers on duty and got away with about K4,000 belonging to one of the officers.

REAL Madrid have confirmed that Mariano Diaz has tested positive for Covid-19 and is now selfisolating at home.

# Micho is a tourist - Siwale

SOCCER administrator Blackwell Siwale does not think the acquisition of the services of Serbian trainer Milutin Sredojevic 'Micho' will pay off for the country.

Meanwhile Siwale is of the view that world soccer governing body FIFA has been biased towards

Arthur moved to Camp Nou from Gremio in a €40 million (£35m/\$47m) deal in 2018. He has made 72 appearances in all His absence could pose problems for coach Setien, who will already be without Sergio Busquets and Arturo Vidal for the match against Napoli due to suspension.

While Arthur will head to Juventus in time for next season, Bosnia-Herzegovina international midfielder Miralem Pjanic will move in the opposite direction in a  $\notin$ 60m (£55m/\$67m) deal. **GOAL**
