THE Ministry of Health has announced that the country has recorded 162 new cases of COVID-19 and one suspicious death in the last 24 hours, with 83 patients admitted at Levy Mwanawasa isolation centre.

And the Ministry says the country is ready for vaccine trials as it has the capacity to monitor the safety and efficacy of any vaccine.

Speaking during the daily update, Thursday, Minister of Health Dr Chitalu Chilufya said the Ministry had decided to open dedicated COVID-19

facilities in Solwezi and the Copperbelt following the increasing number of cases on the two areas.

"Today, we have 83 patients admitted to the levy Mwanawasa covid facility, 32 of whom require oxygen support, five are in critical condition and are admitted to the intensive care unit. Another 33 patients are admitted in various parts of the country and reflecting on what we said yesterday on the Copperbelt and North Western, we have in Solwezi, seven patients who are critically ... By Ulande Nkomesha YOUTH, Sport and Child Development Minister Emmanuel Mulenga says President Edgar Lungu is set to launch another youth empowerment programme on the Copperbelt this Saturday.

Speaking during a briefing, Thursday, Mulenga said government targeted to empower not less than 160,000 youths before December 2020.

"This coming Saturday the 15th of August 2020 His Excellency the President of Zambia will be launching a good substantial amount of money. It is going to carter for the youths and this money is actually sitting in our Ministry. This will be done on the Copperbelt on Saturday. So all youths are encouraged to follow the proceedings wherever they will be so that they know and appreciate how they are going to have access to that youth empowerment. Our target as a Ministry is to empower not less 160,000 youths before December this year," Mulenga said

"Since the funds will be launched by His Excellency I would rather live it to His Excellency to announce the funds which will be put on the table for the youths to access. We are not looking at a specific sector or a particular kind of business which the youths should engage themselves into. Remember, we have done some empowerment before and after doing a review and

the report was issued in 2018, 2019; the report indicated that we just impose as a ministry, projects and business ideas on the youths. So we have left it up to the youths to come up with business proposals. We need to understand that business is something that you like doing, something you enjoy doing."

He said his ministry had engaged ZAFFICO to empower youths with timber logs which were going to be used in the production of desks for sale to the Ministry of General Education.

"The other thing we have negotiated under the value added chain, we have spoken with ZAFFICO. You know that timber has become a scarce product, it is not so much available on the market and many millers are having a challenge to get timber. If youths want to get into the production of desks, it is becoming expensive for them to produce desks and during the last opening of Parliament His Excellency President of Zambia directed Minister of General Education to start buying desks from youth owned enterprises; but the youths have been failing to produce a desk at a competitive price because the cost of timber has actually escalated," he said.

"So, what we have done is that we have agreed with ZAFFICO, they are going to give certain cubes of logs. At the moment, they have given 4,800 cubes which we are going to give to the youths. The youths are going to start harvesting these logs, that is the set of youths. Another set of youths are going to be producing timber from these logs and they are going to supply another group of youths who are going to produce desks. We have agreed with the Ministry of General Education to be buying desks from these youths. So, the market has been created already. So we are creating that environment making sure they thrive and they pay back."

Mulenga also said his ministry would sign another agreement with the Zambia National Service to empower youths with business skills and ideas.

"We have an agreement that is going to be signed on that day with Zambia National Service. Zambia National Service will take youths on board inclusive of youths who are on the streets without any skill. Zambia National Service is actually going to take them on board and teach them skills and business ideas on how to run any business into a profitable business. We have also agreed with financial institutions. We have brought on board banks and other financial institutions which are going to teach these youths financial principles which they are supposed to implement in their business," said Mulenga.

# Kalaba, KBF, Mutati alliance tribal - Moonga

PATRIOTIC Front Lusaka Province chairman Paul Moonga says a plan to form an alliance by Democratic Party leader Harry Kalaba, former finance minister Felix Mutati and Lusaka lawyer Kelvin Bwalya Fube is a danger to society because it is founded on tribal lines.

On Wednesday, Kalaba had disclosed that the trio were planning to form an alliance for next year's general election.

But speaking when he called News Diggers, Thursday, Moonga said the planned alliance should be condemned as it exposed its tribal characteristics, with all minister of finance, renowned lawyer Bwalya Fube [and] Harry Kalaba, former minister of foreign affairs...Surely, if people form parties on tribal lines, not on ideologies, it is dangerous for our nation," Moonga argued.

"So, this alliance of tribalism will destroy our nation and must be condemned from inception. And I am very disappointed that the whole Fube, a lawyer as they call him, clever and intelligent, would go and join a political party or form an alliance on tribal lines, it is very dangerous! And for Kalaba, I would say when he was in an accident, sometimes, he tends not to be thinking properly. Maybe he should some medical attention to check whether his mental status is normal or not." When asked why he was concerned about the alliance. Moonga insisted that he was concerned about tribalism, which reflected in how the three Bemba-speaking former Cabinet ministers assembled. "I am not concerned about the three, I am concerned about tribalism. You can't form a whole Tonga three men forming one political party, that is nonsense! When three men come together to form a political party, that is stupid! I have no problem with it, but the combination. I am condemning tribal party politics. I have said time and again the UPND have condemned me because I

am not part of them. They think by being Tonga I should belong to the UPND. I have always said that I am not going to join a political party because of tribe," he responded.

And when further asked how it was a problem that the trio planned to work together, Moonga maintained that tribal politics should not be entertained.

"I am speaking from a psychological point of view and I am not a baby. Maybe they can cheat you, they can't cheat me. So, from the word go, they must be advised. We don't want tribal politics in Zambia. We want political parties, which have a national character because at the end of the day, we will be bringing tribalism in the country and I am scared tribalism will tear us down, mind you, it can bring wars in the country. We should at all times not entertain tribal politics in our 'one Zambia, one nation' country. I wouldn't mind if one is from there, but the three of them, this is dangerous for the nation," he replied. When reminded that the PF secretary general Davies Mwila and his deputy Mumbi Phiri came from one region, Moonga said that the party hierarchy was ethnically diverse.

# LCC shuts illegal wine factory at Evelyn Hone College

THE Lusaka City Council (LCC) has closed an illegal wine factory at Evelyn Hone College following a complaint from the institution's administration after it noticed a fermentation smell coming from the school canteen.

And the Council has warned all persons involved in illegal brewing and distribution of uncertified wines to stop operations before packaged the wine into bottles without any protective equipment and no measures were in place to allow for safe food handling. The factory was making wines labeled Zikomo, Chibe Pakapaka, Natotela, Zambezi, Sansamukeni and Banana Wine."

Sichimba stated that at the time of inspection, the owner of the factory was unable to produce any permits that allowed them to manufacture and distribute the wine, which was contrary to Liquor Licensing Act No 20 of 2011, Public Health Act Cap 295 and Food, Drug Safety Act No. 7 of 2019 of the laws of Zambia.

He disclosed that the factory was making wines with labels: Zikomo, Chibe Pakapaka, Natotela, Zambezi, Sansamukeni and Banana Wine.

"Lusaka City Council has closed an illegal wine factory at Evelyn Hone College. This follows a complaint from the institution administration after it noticed a fermentation smell coming from the school canteen. Acting on the tip, a team of LCC public health inspectors moved to the scene and found a wine factory running and all processes involved in the making and packaging of the product was being done in one place," Sichimba narrated.

He added that the LCC had since seized all goods that were in the factory until investigations were concluded.

"LCC has since seized on the premise all goods that were in the factory until investigations are concluded. Thus, members of the public should be on the lookout for these products that look as innocent soft drinks, but have unknown alcohol/chemical contents in them. The local authority is, therefore, advising all institutions to take keen interest in reporting all suspicious business activities/premises to the relevant authorities," stated Sichimba, who also warned all persons involved in illegal brewing and distribution of uncertified wines to stop operations before they were visited by the local authority.

# The constitutionality of the suspension of the Lusaka and Kitwe City Councils

1. Conceptual Foundation Local government simply means governance at the local level and local authority means a council and its secretariat consisting of persons appointed by the Local Government Service Commission as provided for by Article 266 of the Constitution of Zambia, Chapter 1 of the Laws of Zambia as amended by Act No. 2 of 2016 (hereinafter referred to as "the Constitution"). When we talk of local government or local authorities we usually refer to councils. The law in Zambia, under the same provision, simply states that a council includes a city, municipal or town council. Previously, a council was defined as to mean a city council, municipal council, or district council as defined under section 2 of the Local Government Act, Chapter 288 of the Laws of Zambia which stands repealed by Act No. 2 of 2019 (hereinafter referred to as the "LGA"). And Article 152 (3) of the Constitution states that there shall be a council for each local authority.

2. Historical perspective of suspension powers

The power of the Executive branch, through the Minister responsible for local government, to suspend and indeed dissolve councils has always been on our statute books. The rationale behind this power, which is practiced in most Commonwealth jurisdictions, is premised on the fact that the Executive is charged with the general power to 'execute' government policy and the need to make policies made at 'local level' by local authorities be in tandem with the overall national policy.

For avoidance of doubt Article 91 (2) of the Constitution provides that the executive authority of the State vests in the President and, subject to this Constitution, shall be exercised directly by the President or through public officers or other persons appointed by the President. By virtue of these powers and those under Article 116 the President may appoint a Member of Parliament as a Minister who is responsible, under the direction of the President, for the policy and strategic direction of a Ministry, department or other State institution, as assigned by the President. This is the genesis of ministerial power and in this regard, that of the Minister responsible for local government to discharge policy under his or her ministry.

Pre-2016 suspension powers The power to suspend and dissolve councils prior to 2016 was found under section 88 of the Local Government Act, Chapter 288 of the Laws of Zambia (hereinafter referred to as the "repealed Act"). This provision gave power to the Minister to suspend or dissolve a council due to "refusal, failure or inability of a council adequately to discharge all or any of its functions" and "the Minister considers it necessary or expedient in the interest of local administration to do so". Thus, it may be noted that prior to 2016, the Minister had discretion to suspend or dissolve councils if he or she considers it necessary or expedient in the interest of local government administration but of course guided by the "refusal, failure or inability" of a council to adequately discharge all or any of its functions. In this regard, it is settled that the Minister had power to suspend or dissolve a council as the case maybe during the period 1995 to 2016.

amended by Act No. 18 of 1996 (hereinafter referred to as the "1996 Constitution") were vague and simply recognised the existence of local government system and left everything to be prescribed by an Act of Parliament. Thus, the repealed Act was enacted specifically to give life to Article 109 of the 1996 Constitution. Thus, the possibilities of Chapter 288 being in conflict with the Constitution which is the supreme law of the land were practically impossible as the 1996 constitution left everything in the hands of Parliament.

Enter 2016; an amendment to the Constitution was made by Act No. 2 of 2016 which, unlike the 1996 Constitution had comprehensive provisions on local government. Part XI of the Constitution radically changed the context of local government in Zambia in that most provisions relating to the administration of local authorities and councils in Zambia. It did so, in my view in two major ways namely: the calling for progressive devolution of councils and prohibiting interference from central government in local government operations. The other radical changes were the election of the Mayor by direct adult suffrage and the clear-cut separation of what functions of local authorities are as well as those for the national government.

This said, the LGA still maintained the powers of the Minister to suspend or dissolve councils as the case may be. Section 56 and 57 of the LGA provides for these powers and states that: 56. The Minister may, by reason of the refusal, failure or inability of a council to adequately perform all or any of its functions, by statutory order—

(a) appoint a public officer to be the Local
Government Administrator for that council; and
(b) suspend all councillors of the council from
performing all of their functions as councillors and
empower the Local GovernmentAdministrator to
discharge all the functions of the council.

(2) Any functions of the council discharged by a Local Government Administrator under subsection (1) shall be deemed to have been discharged by the council in accordance with thisAct.

(3) TheLocalGovernmentAdministrator shall relinquish office on the lifting of the suspension.

57. (1) An order made by the Minister under section 56 shall, unless revoked, expire after ninety days of the date of making the order, except that the Minister may, in the interest of local administration, extend the order for further periods of ninety days at a time.

3. Misconceptions that sections 56 and 57 are unconstitutional

There has been a widely held misconception that the provisions of the LGA under sections 56 and 57 are unconstitutional. To repeat what has been said above, the law is the law and must be respected unless declared unconstitutional by the Constitutional Court exercising its exclusive jurisdiction under Articles 1 (5), 67 and 128 of the Constitution. It is only when a competent court pronounces on the constitutionality or otherwise of a law that it can be called unconstitutional.

But is section 56 in conflict with Article 152 (2) of the Constitution? No, and the answer is no. Why so? Article 152 (2) provides that "the national Government and the provincial administration shall not interfere with or compromise a local authority's ability or right to perform its functions". The operative word in this provision is "interfere". Can it be said that suspending a council for illegal land allocation and other maladministration amounts to "interference"? Interference in this sense means interruption as the framers of the constitution could not have possibly intended to allow councils to loot national resources without any checks and balances from the Executive branch which is charged with the overall national policy. Thus, the action taken by the Minister amounts to "intervention" aimed at fostering good governance in local authorities. Thus, section 56 is not in conflict with Article 152 (2) as it interventionist in nature to enhance good local governance practices. It is unthinkable to suggest that the framers of the constitution would have wanted total independence by putting councils above scrutiny. In fact, section 56 acts as a safeguard against impunity and corruption within local authorities by giving powers to the Minister to intervene when he or she considers it necessary or expedient in the interest of local government administration but of course guided by the "refusal, failure or inability" of a council to adequately discharge all or any of its functions.

#### 4. By way of conclusion

Critics of the move by the Minister to suspend the Lusaka and Kitwe City Councils must always remember to read the law and critically analyse the historical perspective, rationale as well as discern the intention of Parliament when enacting a particular law. The intention of Parliament may be discovered by examining the mischief with which that law was intended to cure among others. It cannot be said that local government, which is funded and operates within the national policies promulgated by the Executive, may operate outside the control and direction of the Executive. Decentralisation and devolution does not entail impunity and lack of accountability as well as checks and balances. Positive interference and intervention on institutions of governance is always a characteristic of democracy and good governance. To suggest that erring councils must be left alone is the opposite of those principles.

b. Post-2016 suspension powers It must be noted that the provisions relating to local government under the Constitution of Zambia, Chapter 1 of the Laws of Zambia as (2) Where the Minister revokes the order appointing the Local Government Administrator made under section 56, of the Local Government Administrator shall cease to perform the functions of the council, and the functions shall be vested and performed by the council that is constituted underArticle 153(2) of the Constitution.

The above said, unless there is a pronouncement by the Constitutional Court on the constitutionality of the above sections the law is crystal clear and the failure by the Minister to apply it amounts to dereliction of duty and the President may have to remove him from office and the National Assembly may move a motion to censure that Minister in line with Article 87 of the Constitution. That said, in the absence of such court pronouncement, the Minister retains the power to suspend councils as the law provides. And Dr Mujajati says there is need to increase private health facilities' participation in testing for COVID-19 to enhance the fight against the virus as it is evident that government's limited capacity has been overwhelmed.

In an interview, Dr Mujajati urged the National Assembly to consider rescheduling next month's re-opening to October or ensure that all proceedings were conducted virtually.

"For me, if they are going to meet like they way they were meeting last time, I would advise that they proceed with a lot of caution. If, indeed, Parliament must open and that it is inevitable to open and there is no other way, then let them consider meeting virtually. Let them consider a virtual meeting and I want to believe that Zambia would Smart have a solution to that. I want to believe that if they engage Smart Zambia, and I want to believe that Smart Zambia has the capacity and probably expertise to be able to make that possible that Parliament

can convene in a virtual way. I feel very strongly that if it is a must and it can't not be avoided, it cannot be postponed then let them consider a virtual meeting. Especially looking at what happened within Parliament not so long ago where you had a lot of people testing positive, we also had some deaths. I would strongly advise that they proceed with caution, especially that the meeting cannot be postponed," Dr Mujajati urged.

"If it can be postponed, I would suggest that they probably wait and observe and see how the month of September will go in terms of numbers and probably convene in October. If the law does not allow, and it's something that cannot change, it's cast in stone and it is inevitable that it must happen and that Parliament cannot reschedule, let them look at the possibility of meeting virtually, because we are under very extenuating circumstances and I want to believe that there should be some provision that would allow Parliament to meet virtually. I strongly recommend

extraordinary measures. You can see COVID-19 is really spreading and for Parliament to open if it can't be avoided, let them meet virtuality; if it can be avoided, let them reschedule or postpone."

And Dr Mujajati said there was need to increase private testing facilities to help in the testing of COVID-19, as evidenced by how government health facilities were overwhelmed.

"The cases are on the rise, deaths are on the rise, hospital admissions are on the rise and the capacity to test for the Ministry (of Health) and government in general is not very strong. Remember, they told us that they have a backlog of more than 2,000 tests that are not yet tested. It tells you that we are overstretched! That is why I was advocating for private sector participation in testing, let us allow more private sector facilities to participate in testing because a backlog of 2,000 tests is too much because the question you should

National Guidance and Religious Affairs Minister Reverend Godfridah Sumaili has called on the Church to play a role in ensuring peace and unity during next year's elections.

In a speech on her behalf by permanent secretary Howard Sikwela during the church and religious bodies state dialogue platform in Lusaka, Thursday, Rev Sumaili said the church should be an anchor of peace and unity in the nation rather than cause divisions in the name of freedom of expression or association.

"We need to have more private sector facilities participating in testing and the reason I am advocating is that people have argued that the private sector is expensive; the reason it is expensive is that you have only allowed two facilities to do it. If you increase the number of facilities that are testing, it would really help in reducing the price. It is simple economics: the demand is high, the supply is less, the prices will stay up. Clearly, government is overstretched, having a backlog of 2,000 is too much,

that is why I am saying, allow more private facilities to participate, allow more private labs to participate. All they need to do is to work out the guidelines and they have capacity among regulators to work out those guidelines. In terms of testing, we need to really ramp up our capacity. Leaving it to government is not a very good strategy, resources are limited government because are needed resources elsewhere. Health is not the only thing government looks after, even if we are under COVID-19, resources are limited."

Last week Mopani Copper Mines demolished over 600 houses in Luyando community in Mindolo which were built illegally on the mine's land.

The affected families have being spending nights in the cold over the past weeks.

Speaking when Mwakalombe

and Nkana Member of Parliament Alexander Chiteme visited the area, Wednesday, Siabula lamented that since the houses were demolished, people had suffered, coupled with a bad economic situation in the country."

"Yes, our people have erred by building here, but we expected Mopani Copper Mines to engage us the leaders. This decision is so harsh despite our people doing the wrong thing of building here. The Mopani came with a lot of police officers in the night of demolition, and there was some confusion. People started stoning the police and the ballifs. Ba minister, we thank you for coming here. These our people are suffering. You see the economy is bad and people here have suffered," said Siabula before she was cut short by Mwakalombe who told her that the economy was actually okay.

"Ba Chairlady, the economy is okay. It is doing very good. Look at the infrastructure development on the Copperbelt! Copperbelt has received a share of the national development, so the economy is doing well," said Mwakalombe.

And Chiteme said as soon as he recovered from COVID-19, he had to attend to the people of Luyando community.

"I had covid but after hearing what had happened here, I asked the doctors that I should come here despite having covid. If it was possible, I could be sleeping with you people here. This has made me upset. This is unfair. Mopani Copper Mines are inhuman," said Chiteme. Chiteme then donated K15,000 cash to help the affected families.

"I am told our Chairman (Copperbelt PF Nathan Chanda) donated K15,000 just a few days, but I am told only some few (party) individuals abused the money. Surely, even when you see people are suffering you go ahead and abuse the little?" asked Chiteme.

Later, Chiteme and Mwakalombe distributed some DMMU mealie meal, beans and Kapenta to the affected families.

DMMU has also supplied tents and food stuffs to the affected people. Meanwhile, Rev Sumaili said government valued the support and counsel which the church was offering.

"The government of President Edgar Lungu values your support and counsel in all matters of governance. It is for this reason that we are gathered to share our thoughts and discuss the best we can collectively serve the people of Zambia. By Natasha Sakala MINISTER of Transport Communications and Mutotwe Kafwaya says PF is able to win ward by-elections in Western Province because voters appreciate the development that the ruling party has taken to the area.

I even wondered because

those are structures, which gave UPND all the MPs they have and he has put a new structure, which has lost how many wards at once?" Kafwaya wondered.

"They have lost five wards out of six, so is he also going to remove them? Listen, when we went to elections, Nalolo (constituency) here we had an independent; in Sioma, we had an independent, but all others it was UPND. Those are the structures, which gave him all those MPs, but they lost a ward in Sesheke he removes them and says, 'no, these are not performing.' But now, the ones he has put have lost five out of six, I wonder what is going to happen. But we are dealing with UPND, when it comes to these issues, unpredictable UPND."

He further wondered why Choma Central UPND member of parliament Cornelius Mweetwa could call Vice-President Inonge Wina as shallow when he did not do the same for Hichilema, who he said spreads lies all the time.

"It is in UPND where you find an MP, who is of my age telling the Vice-President, 72-year-old woman, that she is shallow, a 72-year-old woman, who is your grandmother, who is the mother of the nation, you go and say, she is shallow, 'this is a shallow woman' and the Speaker even takes the liberty to say, 'come and apologise' and my friend says, 'I can't apologise.' So, I tend to wonder, is this the same thing, is it similar to the Sakwiba Sikota story because you can't tell such an old woman that you are shallow no matter how wrong she may be. And I even wonder, that MP is from Choma Central; if HH, who always tells lies, HH cheats all the time and we say that in Lusaka, he went to a road, which he was saying, 'this road

costs K1.2 billion when the road actually just cost K1 million, can he stand up and say, 'HH is shallow,' he can't! But how attractive can it become for anyone of my age, honestly, to tell Her Honour, the Vice-President, that you are shallow?" Kafwaya asked.

And Kafwaya, who is also Lunte PF member of announced parliament, that he had ordered ZICTA to expedite the process for a fourth mobile operator to be identified and penetrate the ICT sector.

"There is need for a fourth mobile service provider, I think so without a shadow of doubt in my mind because as I said earlier, the fourth mobile provider will bring competition and when you have more competition, you have players racing

So, when you do that, it benefits the customers, it doesn't necessarily benefit you because to improve your appearance, it's a cost, you have to spend some money on yourself to improve quality of service, these mobile network providers have to spend a little more money and that spending is for the benefit of the Zambian people. So, I personally think that this must be done, and in fact when UZZI pulled out after they failed to meet the conditions we had set when we extended the licence, I directed ZICTA to advertise so that players can compete and we get a suitable player to come and be given a licence to become the fourth mobile operator," said Kafwaya.

# Mumbi must be truthful, I don't own land in Forest 27 – Mulyata

RUFUNSA UPND member of parliament Sheal Mulyata has refuted PF deputy secretary general Mumbi Phiri's claims that she owns land in Forest Reserve Number 27.

On Tuesday, Phiri urged UPND leader Hakainde Hichilema to take action against Monze UPND member of parliament Jack Mwiimbu and Mulyata for owning land in Forest 27.

But in an interview, Mulyata challenged Phiri to avail evidence that she owned any land in the Forest

So, this is very disappointing coming from a sister who is Catholic like me and she wears that cross of Jesus, which should lead her to tell the truth," said Mulyata.

"She must tell me where that title deed is that is showing that I have land at Forest 27. You can go to the Ministry of Lands and you will not find records that show that I own something there. I am very disappointed! I would like to advise her, she is a mature politician who must learn to tell the truth. Because when you wake up and tell the nation such things, you can bring a lot of problems. I urge her to clarify her information. She must learn to be peaceful so that we build Zambia. Let us not be telling lies over people who are innocent. These things are damaging and it's not nice to do that."

#### Kalengwa Mineral Processing opposes Moxico Resources' application to set aside title dispute case

**By Zondiwe Mbewe** KALENGWA Mineral Processing Limited has opposed an application by Moxico Resources Zambia Limited to have the case against the latter and Euro Africa Kalengwa Mines Limited set aside for irregularity and abuse of court process. In this matter, Kalengwa Mineral Processing Limited has dragged Moxico Resources Zambia Limited and Euro Africa Kalengwa Mines Limited to the Lusaka High Court, seeking an order that it is the title holder and vested with the surface rights to its properties known as Farm No. 31477, Farm No. 31478 and Farm No. 31479, situated in Mufumbwe District. Moxico Zambia Resources Limited director Davies Mwanamoya had, however, asked the Court to set aside Kalengwa Mineral's writ of summons and

multiplicity and an abuse of court process.

But according to an affidavit

statement of claim for being a in both matters are different as one seeks to address the tort of trespass, while the other relates to ownership and certificates of title as well as

Gama stated that the issue of surface rights was not one of the issues to be determined in both matters, but that the subject matter

in opposition to the affidavit in support of summons to set aside the writ of summons and statement of claim, Brenda Gama, a shareholder in Kalengwa Mineral Processing, argued that there were two different matters, bearing two different subject matters.

She stated that even assuming that the same was true (multiplicity of actions), the name Kalengwa Processing Zone Limited was not the plaintiff as it was a different entity with a different legal existence.

"This can be seen from the documents that the parties in this matter and the matter referred to by Mwanamoya in the affidavit in support of summons to set aside the writ of summons and statement of claim are different. The claims the aspect of being a bona fide purchaser," Gama stated.

She stated that the said certificates of title relate to three properties being; Farm No. 31477, Farm No. 31478 and Farm No. 31479, whereas the matter under cause number 2019/HN/186 relates to a portion known as Kalengwa area, which portion was clearly not Farm No. 31477, 31478 or 31479.

Gama further stated that there was no numbered property, which was the subject of litigation under cause number 2019/HN/186.

She stated that this matter further seeks to preserve property that sits on the surface, which property was well set out in the said process and the order of preservation granted by the court on January 27, 2020.

"That be it as it may, the subject matter relates to two distinct pieces of land, one being three farm lands and the other being an area called Kalengwa area. The fact that the shareholders are similar in no way means that the company is the same, and as such, the plaintiff in this matter is not the plaintiff under cause number 2019/HN/186. Further, the plaintiff and Moxico Resources are not parties in the said action," read the affidavit.

"Essentially, these are two different matters and bearing two different subject matters. The fact that shareholders may be the same does not make the parties the same."



# LICENSING FOREIGN OWNED BUSINESSES

**By Andyford Mayele Banda** few weeks ago, Lusaka Mayor Miles Sampa did indicate that he was going to propose to the suspended Lusaka City Council to ensure some businesses are preserved for locally owned individuals. This is a song we have been sing-ing like forever. While we don't believe restaurant businesses must be pre-served for locals because this will be against international norms. There are a number of sectors that have been grabbed by foreigners which should be preserved for local people.

We are not sure in addition to other cartels Miles Sampa may have stepped his foot on, if this could have been one of the reasons that prompted the sus-pension of the council to pave way for investigations on land issues. Yes, we know that we have very powerful foreign nationals in this country that have put a lot of government officials in their pockets so that they can carry out running businesses which can be preserved for local people. EPUTY Inspector General of Police Bonny Kapeso says police officers should act professionally when giving out permits to political parties that want to hold events. He also says police officers who are charged with the responsibility of ensuring that they receive notifications from political parties, should be truthful to conveners and sit them down to explain what is permissible and what is not, giving clear reasons for the decision.

"It is common knowledge that everybody talks about the Public Order Act. But again, within the description of the POA, certain systems are already established by which somebody should follow in order to ensure that the POA is adhered to. People expect police officers to guide them, and that is why the POA is there. It clearly establishes the kind of procedures that we have to adopt in order for you to have a meeting. The selective application of the POA is just a general perception," Mr Kapeso said.

We agree with Mr Kapeso when he says officers are supposed to act professionally when giving permits to political parties. We also agree with him that there is a need for law and order when political parties hold meetings.

No one can argue today that policing in this country has become a big political issue because of the way the police have been behaving. We are trying to build a democracy in this country, but any progress we make is taken away by the undemocratic modus operandi of our police service. Anyone who says that the police have been professional in their application of the POA in this country gives us an idea about his political inclination.

Everybody knows that the powers that the police are given offer great temptations for abuse on behalf of the authorities

controlling them. We say this because law enforcement requires a delicate balancing act. The conflicts between liberty and enforcing order receive their purest expression in considerations of democratic policing.

What Zambia needs is a police service that is subject to the rule of law, embodying values respectful of human dignity, rather than the wishes of the President and his political party. We also need a police service that can intervene in the lives of citizens only under limited and carefully controlled circumstances and is publicly accountable. These conditions must be inherent to police in a country that wants to be seen as a democracy. Police are an important factor in building a democracy. And its importance increases with the

diversity and size of a society.

It is ironic that police are both a major support system and a major threat to democratic society. When police operate under the rule of law, they can protect democracy by their own example of respect for the law and by suppressing crime. Police must be moral, as well as legal, actors.

We are concerned that the powers vested in the police regarding the application of the POA are slowly building towards the rise of a dictatorial and tyrannical regime. Powerful interest groups are riding on the police to abuse the POA for their own selfish interests. In collusion with the political elites, these people are turning political dissent into a crime. Today, ruling

party cadres seem to be part of the police while the police chief himself is seen to be a cadre of the ruling party through his conduct.

Police powers cannot be subverted in this way; they cannot be used in this way. Police powers should be used according to the rule of law and not according to the whims of the President or the Inspector General of Police. The police, as the arm of the state's power, must be used in a restrained fashion and proportional to the problem at hand. We want to return to a time when citizens would accept police authority out of respect rather than out of intimidation. A professional police service is defined by both its means and its ends. Some means are simply too abhorrent and must be prohibited under any circumstances.

We should never allow our police to be a law unto themselves. In spite of strong pressures and temptations to the contrary, they should never be allowed to act in an explicitly political fashion such as disrupting the activities of groups they disagree with or failing to enforce the law against groups they support.

Mr Kapeso is trying to sound professional when he talks about the actions of his men and women in uniform, but he knows himself that he is not being honest. He knows that there is no fairness in the manner police handle political cases in this country. If we may ask him today, if someone went to report to the police that a group of PF supporters were holding a meeting at a named farm in the outskirts of Lusaka, and they were televising their meeting on Facebook, what would be his directives? Would he send officers to go and arrest the group? Would he even tolerate such a report? Zambians may be docile, but they are not foolish!

# **Findlay asks NAPSA to buy Chrismar Hotel for \$18m**

#### By Mukosha Funga

LUSAKA Businessman Valden Findlay has offered Chrismar Hotel for sale to the National Pension Scheme Authority NAPSA, expecting a purchase price as high as US\$18 million, when the deal is approved.

NAPSA confirmed to News Diggers that it received an offer for the sale of the property which is located at Plot number 6892 Los Angeles Boulevard in Lusaka, but said the decision to go ahead with the investment had not been made, as at Thursday August 13.

Impeccable sources revealed that Findlay who is a close associate of President Edgar Lungu was in the process of liquidating some of his assets,

including Chrismar Hotel at inflated valuations.

"What we know is that three valuations were done on Chrismar Hotel, claiming that the property is worth US\$10 million, US\$11 million and US\$18 million respectively. So the general feeling is that it has been too overpriced, but there is pressure for NAPSA to buy the hotel. There seems to be too much pressure coming from the government even when the value that has been attached just doesn't make sense," sources said.

On Wednesday, August 12, NAPSA issued a statement, rubbishing rumours that the Pensions Authority had bought the hotel, saying the report was

fake news.

"The National Pension Scheme Authority (NAPSAI is aware of a story circulating in some circles purporting that NAPSA has purchased Chrismar Hotel. The Authority wishes to categorically state that it has not purchased the named firm. Therefore, the story must be discarded as fake news," stated head of corporate affairs Cephas Sinyangwe. But News Diggers wrote

a detailed query asking: What procedure NAPSA follows before making investments; if NAPSA had done a cost benefit analysis before making a consideration to procure the property; if it was true that three overpriced valuations

were done on the property, placing the value at US\$10 million, US\$11 million and US\$18 million; what NAPSA intended to use the property for; if the board was under external pressure to make the procurement decision; and if it was of concern to NAPSA that the property in question belonged to Findlay, a close friend of President Lungu, and that the values being discussed had no relationship with commercial sense.

In response to the News Diggers query, NAPSA confirmed receiving the offer of sale for Chrismar Hotel, adding that the offer was among hundreds of others, which came as a result of a call for proposals

made last year.

"In July 2019, the National Pension Scheme Authority advertised a call for investment proposals (NAPSACIP/DI//1). (Refer to attached document).

The aim of the call was to give both public and private sector players an equal opportunity to present viable investment

proposals to the Authority. Hundreds of proposals were received. The proposal referred to in your query came through the same process," stated Sinyangwe.

"All the proposals that were received were processed in accordance with the Authority's Investments and operational guidelines, asset allocation,

Statement of Investment Policy and Investment Strategy 2018 to 2021. I would like to state that the proposal referred to has not been approved."

But sources insisted that the purchase had reached a negotiation stage.

"That matter is at negotiation stage. We are all surprised that they are even refuting the story as fake news because it is a fact. If you engage the Director General or anyone on the board, they will be able to confirm if they are honest, that it's an ongoing negotiation. The money involved is just too much when you look at it," said the sources.

"The other problem is that viability of the business. NAPSA is saying they invited public and private players to present viable investment proposals, but can they say Chrismar Hotel is a viable business? What business is there that can be worth US\$18 million, or even US\$10 million? That cannot be a good deal, and it takes us to the case of IDC (Industrial Development Corporation) where they have been buying loss making entities just because they are owned by people who are close to State House. So, if this Chrismar deal goes ahead, Zambia will lose a great deal of money and NAPSA will not be able to recover its investment. But you must remember that this is people's money that they are playing with."

## Trends **Report will** be released on August 31 – FIC

THE FINANCIAL Intelligence Centre (FIC) says the 2019 Trends Report will be released by Monday, August 31.

In June, FIC director general Mary Chirwa had said the internal report was ready, but was awaiting approvals from the board.

In a brief update, FIC acting director general Clement Kapalu said the Centre was still finalising the report.

"Nothing has changed. It will be out this month of August and we are just finalising it. So, there is no change from our earlier statement. Let's say by month-end. It could be earlier, but definitely, by the 31st, it will be done," announced Kapalu. The FIC last revealed a 33 per cent increase in the amount of money Zambia lost to financial crimes from K4.5 billion in 2017 to K6.1 billion in 2018, according to their 2018 Money Laundering/Terrorist Financing Trends Report, which exposed unprecedented levels of corruption cases ranked the highest, with an estimated loss of K4.9 billion of the total amount. Tax evasion ranked second with an estimated loss of K1 billion, while theft ranked third at K110 million.

#### Cyber crime has worsened during **COVID-19 pandemic – Dora** By Ulande Nkomesha Government

CHIEF Spokesperson Dora Siliya says government is concerned with the increased number of cyber crimes amid the COVID-19 outbreak.

And Siliya says the fight against COVID-19 should not be taken as a government responsibility, but as a personal responsibility.

Speaking during a media briefing in Lusaka, Thursday, Siliya said government had observed an increase in cyber crimes during the COVID-19 outbreak because unprecedented numbers of citizens were working from home.

"There is something that is happening that is concerning government a lot and that is cyber crime. We have seen an increase in cyber crime and some of our experts are saying it is that a lot of people are staying at home and are on the phone; banks are complaining, citizens are complaining, including high profile citizens because of cyber crime," Siliya said.

"The message from government is very clear: cyber crime is detrimental to our economy and to our social fabric. The ills of cyber crime, which is money fraud, which is abuse of children, which is abuse of women, which is just defrauding citizens. I think the police have been very clear on behalf of government that they are going to be following up all these crimes to ensure that we bring the perpetrators to book."

She warned that gover

from going to funerals, weddings, going to Chilaga mulilos, going to birthday parties. We are trying to encourage people to stay at home and now with Corona in other places, think twice before you decide to go to another town because Corona does not move, it's people who move the virus. For me, it is good that we can protect ourselves, basically, in terms of masks from any piece of cloth at this point in time and I encourage all media organisations where they are able to, they should be able to support their staff. But I think each one of us as, a citizen, must be able to take responsibility and ensure that we have our mouths and our nose covered," replied Siliya. "I know how expensives masks are, sometimes I don't have surgical masks, I have to wear cloth masks because we have all been assured that we can wear cloth masks and because it is cheaper and they are reusable. So, I think that we all have to learn to use our bandanas, our scarfs and whatever else we can, especially media personnel because vou are quite exposed and it will be a shame to hear that one of you has lost their lives from COVID."

Ronaldo's Juventus were denied a place in the last eight of the Champions League by lowly Lyon, while Madrid were beaten with embarrassing ease by Manchester City.

Two years after their surprise divorce, Ronaldo and Real are still struggling to prove that they are better off apart.

It was the Portuguese, of course, who initially took full responsibility for the split.

In an open letter to Madrid's fans, he asked for understanding, explaining that in spite of all of the
